# A SIMONS' TYPE FORMULA FOR CMC SURFACES IN HOMOGENEOUS 3-MANIFOLDS

#### Abstract

In this paper, we give a Simons' type formula for the cmc surfaces in homogeneous 3 -manifolds $E(\kappa, \tau), \tau \neq 0$. As an application, we give a rigidity result in the case of $\kappa>4 \tau^{2}$ for the cmc surfaces under a pinching assumption of the second fundamental form.


## 1. Introduction

It is well known that the simply connected 3-dimensional homogeneous Riemannian manifolds have the isometry groups of dimension 3,4 and 6 . When the dimension of the isometry group is 6 , then we have a space form. When the dimension of the isometry group is 3 , then the manifold has the geometry of the Lie group $\mathrm{Sol}_{3}$. We denote $E(\kappa, \tau), \kappa \neq 4 \tau^{2}$, as the homogeneous 3 -manifolds whose isometry groups are of dimension 4 , which are fibrations over 2-dimensional simply connected space forms $\mathbb{M}^{2}(\kappa)$ of constant curvature $\kappa$. In other words, there exists a Riemannian submersion $\Pi: E(\kappa, \tau) \rightarrow \mathbb{M}^{2}(\kappa)$, where the constant number $\tau$ is the bundle curvature. The fibers are geodesics and there exists a one-parameter family of translations along the fibers, generated by a unit Killing vector field $\xi$. When $\tau=0$, we get a product manifold $\mathbb{M}^{2}(\kappa) \times \mathbb{R}$. When $\tau \neq 0$, the manifolds are of three types: the Berger sphere $\mathbb{S}_{\kappa, \tau}^{3}(\kappa>0)$, the Heisenberg Group $N i l_{3}(\kappa=0)$ and $\widetilde{P_{S}}(\kappa<0)$. The so called Hopf cylinder is defined as the preimage $\Pi^{-1}(\gamma)$ of a regular closed curve $\gamma$ in $\mathbb{M}^{2}(\kappa)$. When considering $\mathbb{S}_{\kappa, \tau}^{3}$ and $P \widetilde{S L_{2}}$ (the fibers are circles), the corresponding Hopf cylinder is also called the Hopf torus. For more details on $E(\kappa, \tau)$, we refer to [10]. The surface with constant mean curvature $H$ is called the cmc $H$-surface. There are a lot of researches on the geometry of $E(\kappa, \tau)$, for instance ( 1 , [2], 4], [5], [9-11], [13], [17-21]), among others. A study on the cmc $H$-surfaces in more general spaces can be found in 14 .

In this paper we focus on $E(\kappa, \tau), \tau \neq 0$, and we get a Simons' type formula for cmc $H$-surfaces which can be stated as follows. Notice that the method used in this paper is elementary.

Theorem 1.1. Let $f: M \rightarrow E(\kappa, \tau)(\tau \neq 0)$ be an immersion of a compact cmc $H$-surface. Denote $\Phi:=A-H I$ and the angle function by $C:=\langle\xi, N\rangle$, where $N$ is a unit normal vector field on $M$ and $A$ is the second fundamental form. Then it holds the Simons' type formula
(1) $\int_{M}\left\{|\Phi|^{4}-\left[2\left(H^{2}+\tau^{2}\right)+\left(\kappa-4 \tau^{2}\right)\left(5 C^{2}-1\right)\right]|\Phi|^{2}+2\left(\kappa-4 \tau^{2}\right)\left(H^{2}+\tau^{2}\right)\left(3 C^{2}-1\right)\right\} d \sigma \geq 0$, where the equality holds if and only of $f$ is of parallel second fundamental form, and in this case $M$ is a Hopf cylinder with $|A|^{2}=2\left(2 H^{2}+\tau^{2}\right)$.

[^0]Remark 1.2. It is well known that the compact minimal immersed surface $M$ in the unit sphere $\mathbb{S}^{3}$ satisfies the Simons' integral inequality

$$
\int_{M}|A|^{2}\left(|A|^{2}-2\right) d \sigma \geq 0
$$

where the equality holds if and only of $M$ is the great 2-sphere or the Clifford torus ([7]).
Remark 1.3. For the minimal surface in $E(\kappa, \tau)(\tau \neq 0), H=0$, the corresponding Simons' type formula was recently given in 13.

## 2. Preliminaries

For an immersed surface $M$ in $E(\kappa, \tau)$, define the contact angle $\beta(p)$ at $p \in M$ by the angle between the vector $\xi(p)$ and the tangent space $T_{p} M$. By definition, the contact function $C=\sin \beta$. Since the distribution $\langle\xi\rangle^{\perp}$ in $E(\kappa, \tau)$ is not integrable (see [3]), we consider the set $\mathcal{W}=\{p \in$ $\left.M: \beta(p) \neq \pm \frac{\pi}{2}\right\} \subset M$, whose complementary $\mathcal{W}^{C}=\left\{p \in M: \beta(p)= \pm \frac{\pi}{2}\right\}$ has empty interior by Frobenius Theorem. In this paper we will work by making use of the method of moving frames on $\mathcal{W}$ and then extend the formulas to the whole surface by the continuity.
2.1. Adapted frame. In this section we introduce the method of choosing an appropriate orthonomal frame $\left\{e_{1}, e_{2}, e_{3}\right\}$ on $\mathcal{W} \subset M$ to study its geometry. It is well known that $E(\kappa, \tau)$ admits an orthonormal frame $\left\{f_{1}, f_{2}, f_{3}\right\}$ with $f_{3}=\xi$, satisfying (see [10])

\left[f_{1}, f_{2}\right]=-2 \tau f_{3}, \quad\left[f_{2}, f_{3}\right]=-\kappa /(2 \tau) f_{1} \quad \text { and } \quad\left[f_{3}, f_{1}\right]=-\kappa /(2 \tau) f_{2}
$$

It is straightforward to verify that the coframe $\left\{w^{1}, w^{2}, w^{3}\right\}$ of $\left\{f_{1}, f_{2}, f_{3}\right\}$ satisfies

d w^{1}=\kappa /(2 \tau) w^{2} \wedge w^{3}, \quad d w^{2}=\kappa /(2 \tau) w^{3} \wedge w^{1} \quad \text { and } \quad d w^{3}=2 \tau w^{1} \wedge w^{2}
$$

and the Levi-Civita connection 1-forms are given by

$$
w_{2}^{1}=(\kappa / \tau-\tau) w^{3}, \quad w_{3}^{1}=-\tau w^{2} \quad \text { and } \quad w_{3}^{2}=\tau w^{1}
$$

An interesting observation (see Lemma 1 in [8]) is that, if one rotates $f_{1}$ and $f_{2}$ but leaves $f_{3}$ fixed, the relation of $w_{3}^{1}$ and $w_{3}^{2}$ will not change ( $w_{2}^{1}$ may change). Thus, the connection 1 -forms can be summarized as

\begin{equation*}
w_{2}^{1}, \quad w_{3}^{1}=-\tau w^{2} \quad \text { and } \quad w_{3}^{2}=\tau w^{1} \tag{2}
\end{equation*}
$$

If one studies a surface $M$ isometrically immersed in $E(\kappa, \tau)$ one can firstly choose $\left\{f_{1}, f_{2}, f_{3}\right\}$ by rotating $f_{1}, f_{2}$ and leaving $f_{3}$ fixed at $p \in \mathcal{W}$ such that $f_{1} \in T_{p} M$, and then choose the local orthonormal frame $\left\{e_{1}, e_{2}, e_{3}\right\}$, called the adapted frame, where

$$
\begin{equation*}
e_{1}=f_{1}, \quad e_{2}=\sin \beta f_{2}+\cos \beta f_{3} \quad \text { and } \quad e_{3}=-\cos \beta f_{2}+\sin \beta f_{3} \tag{3}
\end{equation*}
$$

so that $e_{1}$ and $e_{2}$ are tangent to the surface. This frame was firstly introduced for $\mathbb{S}^{3}$ in [12] and for $E(\kappa, \tau)$ in [8].
2.2. Structure equations. In this section we study the structure equations under the adapted frame in the open set $\mathcal{W} \subset M$ in $E(\kappa, \tau)$. The corresponding coframe $\left\{\theta^{1}, \theta^{2}, \theta^{3}\right\}$ is given by

\begin{equation*}
\theta^{1}=w^{1}, \quad \theta^{2}=\sin \beta w^{2}+\cos \beta w^{3} \quad \text { and } \quad \theta^{3}=-\cos \beta w^{2}+\sin \beta w^{3} . \tag{4}
\end{equation*}
$$

The structure equations of $E(\kappa, \tau)$ are given by

$$
\bar{\Omega}_{B}^{A}=d \theta_{B}^{A}+\theta_{C}^{A} \wedge \theta_{B}^{C} \quad \text { and } \quad d \theta^{A}=-\theta_{B}^{A} \wedge \theta^{B}, \quad \text { with } \quad \theta_{B}^{A}+\theta_{A}^{B}=0
$$

Here and from now on, we assume $1 \leq A, B, \ldots \leq 3,1 \leq i, j, \ldots \leq 2$ and we will use the Einstein summation convention. Since, when restricted to $M, \theta^{3}=0$ we get that $\theta_{i}^{3} \wedge \theta^{i}=0$. The Cartan's lemma thus implies $\theta_{i}^{3}=h_{i j} \theta^{j}$ with smooth functions $h_{i j}=h_{j i}$. We now immediately deduce the structure equations of $M$

$$
\begin{equation*}
d \theta^{i}=-\theta_{j}^{i} \wedge \theta^{j}, \quad \text { with } \theta_{j}^{i}+\theta_{i}^{j}=0 \text { and } \Omega_{j}^{i}:=d \theta_{j}^{i}+\theta_{k}^{i} \wedge \theta_{j}^{k}=\bar{\Omega}_{j}^{i}-\theta_{3}^{i} \wedge \theta_{j}^{3} \tag{5}
\end{equation*}
$$

where the last equation is called the Gauss equation. For $A=3$ and $B=i$ one gets the Codazzi equations:

\bar{\Omega}_{i}^{3}=d \theta_{i}^{3}+\theta_{k}^{3} \wedge \theta_{i}^{k}=d\left(h_{i j} \theta^{j}\right)+h_{k j} \theta^{j} \wedge \theta_{i}^{k}=h_{i j \mid k} \theta^{k} \wedge \theta^{j} \tag{6}
\end{equation*}
$$

where

$$
\begin{equation*}
h_{i j \mid k} \theta^{k}:=d h_{i j}-h_{k j} \theta_{i}^{k}-h_{i k} \theta_{j}^{k} \tag{7}
\end{equation*}
$$

By using the classical notation $\bar{\Omega}_{B}^{A}=\frac{1}{2} \bar{R}_{B C D}^{A} \theta^{C} \wedge \theta^{D}$ and $\Omega_{j}^{i}=\frac{1}{2} R_{j k l}^{i} \theta^{k} \wedge \theta^{l}$ we get that the Gauss equation (5) and Codazzi equation (6) are respectively given by

R_{j k l}^{i}=\bar{R}_{j k l}^{i}+h_{i k} h_{j l}-h_{i j} h_{k l} \\
h_{i j \mid k}-h_{i k \mid j}=-\bar{R}_{i j k}^{3}
\end{gathered}
$$

Throughout this paper, for simplicity of notation we denote $\beta_{i}=e_{i}(\beta), \beta_{i j}=e_{j} e_{i}(\beta)$ and $\beta_{i j k}=e_{k} e_{j} e_{i}(\beta)$. The following lemma was actually proved in [8, that gives us the Levi-Civita connection on the surface $M$ and the second fundamental form under the adapted frame. For the readers' convenience we give a proof here.
Lemma 2.1. ([8]) Let $\nabla$ be the Levi-Civita connection on $M$. Then

\begin{array}{ll}
\nabla_{e_{1}} e_{1}=-\left(2 H+\beta_{2}\right) \tan \beta e_{2}, & \nabla_{e_{2}} e_{2}=-\left(2 \tau+\beta_{1}\right) \tan \beta e_{1} \\
\nabla_{e_{2}} e_{1}=\left(\beta_{1}+2 \tau\right) \tan \beta e_{2} & \text { and } \tag{8}
\end{array} \quad \nabla_{e_{1}} e_{2}=\left(2 H+\beta_{2}\right) \tan \beta e_{1}
$$

where $H:=\left(h_{11}+h_{22}\right) / 2$ is the mean curvature. Moreover, the coefficients of the second fundamental form of $M$ are given by

$$
\begin{equation*}
h_{11}=2 H+\beta_{2}, \quad h_{12}=h_{21}=-\tau-\beta_{1} \quad \text { and } \quad h_{22}=-\beta_{2} . \tag{9}
\end{equation*}
$$

Also, we have the relation

$$
\begin{equation*}
\cos \beta w_{2}^{1}\left(e_{1}\right)=2 H+\beta_{2} \tag{10}
\end{equation*}
$$

Proof. Since $\theta^{3}=0$ on $M$ we have

$$
\cos \beta w^{2}=\sin \beta w^{3}
$$

which together with the expression (4) for $\theta^{2}$ gives us

$$
\begin{equation*}
\theta^{1}=w^{1}, \quad \cos \beta \theta^{2}=w^{3} \quad \text { and } \quad \sin \beta \theta^{2}=w^{2} \tag{11}
\end{equation*}
$$

So, from equations (2) and (4) we have

\begin{aligned}
d \theta^{1} & =d w^{1}=-w_{2}^{1} \wedge w^{2}-w_{3}^{1} \wedge w^{3}=-\sin \beta w_{2}^{1} \wedge \theta^{2} \\
d \theta^{2} & =\sin \beta d w^{2}+\cos \beta d w^{3}=\sin \beta\left(w_{2}^{1}-\tau \cos \beta \theta^{2}\right) \wedge \theta^{1} \\
d \theta^{3} & =d \beta \wedge \theta^{2}-\cos \beta d w^{2}+\sin \beta d w^{3}=d \beta \wedge \theta^{2}+\cos \beta w_{1}^{2} \wedge \theta^{1}+\tau\left(1+\sin ^{2} \beta\right) \theta^{1} \wedge \theta^{2}
\end{aligned}
$$

We thus obtain

$$
\begin{equation*}
\theta_{2}^{1}=\sin \beta\left(w_{2}^{1}-\tau \cos \beta \theta^{2}\right), \quad \cos \beta w_{2}^{1}\left(e_{2}\right)=-\beta_{1}-\tau\left(1+\sin ^{2} \beta\right) \tag{12}
\end{equation*}
$$

and thus

$$
\begin{gather*}
\nabla_{e_{1}} e_{1}=\theta_{1}^{2}\left(e_{1}\right) e_{2}=-\sin \beta w_{2}^{1}\left(e_{1}\right) e_{2}, \quad \nabla_{e_{2}} e_{2}=\theta_{2}^{1}\left(e_{2}\right) e_{1}=-\left(2 \tau+\beta_{1}\right) \tan \beta e_{1}, \\
\nabla_{e_{2}} e_{1}=\theta_{1}^{2}\left(e_{2}\right) e_{2}=\left(2 \tau+\beta_{1}\right) \tan \beta e_{2} \quad \text { and } \quad \nabla_{e_{1}} e_{2}=\theta_{2}^{1}\left(e_{1}\right) e_{1}=\sin \beta w_{2}^{1}\left(e_{1}\right) e_{1} \tag{13}
\end{gather*}
$$

Now, using equations (21), (3) and (11) we compute

$$
\begin{aligned}
\bar{D} e_{3} & =\bar{D}\left(-\cos \beta f_{2}+\sin \beta f_{3}\right) \\
& =\sin \beta d \beta f_{2}-\cos \beta\left(w_{2}^{1} f_{1}+w_{2}^{3} f_{3}\right)+\cos \beta d \beta f_{3}+\sin \beta\left(w_{3}^{1} f_{1}+w_{3}^{2} f_{2}\right) \\
& =\left(-\cos \beta w_{2}^{1}-\tau \sin ^{2} \beta \theta^{2}\right) e_{1}+\left(d \beta+\tau \theta^{1}\right) e_{2}
\end{aligned}
$$

where $\bar{D}$ is the Levi-Civita connection on $E(\kappa, \tau)$. On the other hand, $\bar{D} e_{3}=\theta_{3}^{1} e_{1}+\theta_{3}^{2} e_{2}$, whence

$$
\theta_{3}^{1}=-\cos \beta w_{2}^{1}-\tau \sin ^{2} \beta \theta^{2} \quad \text { and } \quad \theta_{3}^{2}=d \beta+\tau \theta^{1}
$$

Hence, from the second equation of (12) and $\theta_{i}^{3}=h_{i j} \theta^{j}$, we get

$$
\begin{equation*}
h_{11}=\cos \beta w_{2}^{1}\left(e_{1}\right), \quad h_{12}=\cos \beta w_{2}^{1}\left(e_{2}\right)+\tau \sin ^{2} \beta=-\tau-\beta_{1} \quad \text { and } \quad h_{22}=-\beta_{2} . \tag{14}
\end{equation*}
$$

Since by the definition $2 H=h_{11}+h_{22}$, we get (10) and then (8) and (9) follow from (10), (13) and (14) immediately.

By using the formula of the Riemannian curvature tensor in [10], one can obtain the Codazzi equations under the adapted frame. See the proof in [8].
Lemma 2.2. ([8]) The Codazzi equations under the adapted frame are given by

\beta_{1} w_{2}^{1}\left(e_{1}\right) \cos \beta=\beta_{2}\left(2 \tau+\beta_{1}\right) \tag{15}
\end{equation*}
$$

and

$$
\begin{align*}
0= & \cos \beta e_{2}\left(w_{2}^{1}\left(e_{1}\right)\right)+\sin \beta \cos \beta\left(w_{2}^{1}\left(e_{1}\right)\right)^{2}+\beta_{11}+2\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan \beta \\
& +\left(\kappa-4 \tau^{2}\right) \sin \beta \cos \beta \tag{16}
\end{align*}
$$

At the end of this section, we shall derive some identities which will be useful in the next section. From (10) and (15), we have $\beta_{1}\left(2 H+\beta_{2}\right)=\beta_{2}\left(2 \tau+\beta_{1}\right)$, that is

\tau \beta_{2}=H \beta_{1} \tag{17}
\end{equation*}
$$

According to Lemma 2.1, we observe that

$$
\begin{aligned}
\beta_{12} & =e_{2} e_{1} \beta=\left[e_{2}, e_{1}\right] \beta+\beta_{21}=\nabla_{e_{2}} e_{1} \beta-\nabla_{e_{1}} e_{2} \beta+\beta_{21} \\
& =\left(2 \tau+\beta_{1}\right) \tan \beta \beta_{2}-\left(2 H+\beta_{2}\right) \tan \beta \beta_{1}+\beta_{21}=\beta_{21}
\end{aligned}
$$

By (17), if $H$ is a constant, we have $\tau \beta_{21}=H \beta_{11}$ and $\beta_{1} \beta_{21}=\beta_{2} \beta_{11}$. Then a similar way shows that

\beta_{112}=e_{2} e_{1}\left(\beta_{1}\right)=\left[e_{2}, e_{1}\right] \beta_{1}+\beta_{121}=\nabla_{e_{2}} e_{1} \beta_{1}-\nabla_{e_{1}} e_{2} \beta_{1}+\beta_{121}=\beta_{121}
$$

Thus by (17) again, for the later use, we deduce that

\begin{equation*}
\beta_{12}=\beta_{21}=(H / \tau) \beta_{11}, \quad \beta_{22}=(H / \tau) \beta_{12}=(H / \tau) \beta_{21}=(H / \tau)^{2} \beta_{11} \tag{18}
\end{equation*}
$$

and

$$
\begin{equation*}
\beta_{122}=(H / \tau) \beta_{112}=(H / \tau) \beta_{121}=(H / \tau)^{2} \beta_{111} \tag{19}
\end{equation*}
$$

## 3. Simons' type formula for CmC Surafces

In this section we consider the tensor $\Phi:=A-H I$ with constant $H$. By Lemma 2.1 and (17), we have

$$
\begin{align*}
|\Phi|^{2} & =|A|^{2}-2 H^{2}=\left(2 H+\beta_{2}\right)^{2}+2\left(\tau+\beta_{1}\right)^{2}+\beta_{2}^{2}-2 H^{2} \\
& =2\left(\tau+\beta_{1}\right)^{2}+2\left(H+\beta_{2}\right)^{2}=2\left[1+(H / \tau)^{2}\right]\left(\tau+\beta_{1}\right)^{2} \tag{20}
\end{align*}
$$

We now start to compute the Laplacian of $|\Phi|^{2}$. By using (17), (18) and (19), we compute that

\begin{align*}
\Delta|\Phi|^{2}= & e_{1} e_{1}\left(|\Phi|^{2}\right)+e_{2} e_{2}\left(|\Phi|^{2}\right)-\nabla_{e_{1}} e_{1}|\Phi|^{2}-\nabla_{e_{2}} e_{2}|\Phi|^{2} \\
= & 4\left[1+(H / \tau)^{2}\right]\left[\beta_{11}^{2}+\left(\tau+\beta_{1}\right) \beta_{111}+\beta_{12}^{2}+\left(\tau+\beta_{1}\right) \beta_{122}\right. \\
& \left.+\left(2 H+\beta_{2}\right)\left(\tau+\beta_{1}\right) \tan \beta \beta_{12}+\left(2 \tau+\beta_{1}\right)\left(\tau+\beta_{1}\right) \tan \beta \beta_{11}\right] \\
= & 4\left[1+(H / \tau)^{2}\right]^{2}\left[\beta_{11}^{2}+\left(\tau+\beta_{1}\right) \beta_{111}+\left(2 \tau+\beta_{1}\right)\left(\tau+\beta_{1}\right) \tan \beta \beta_{11}\right] . \tag{21}
\end{align*}
$$

Next, we shall express $\beta_{11}$ and $\beta_{111}$ to the expressions involving in $\beta_{1}$. First, by Lemma 2.1 we have $2 H+\beta_{2}=\cos \beta w_{2}^{1}\left(e_{1}\right)$ and thus we get

$$
\beta_{22}=-\tan \beta \beta_{2}\left(2 H+\beta_{2}\right)+\cos \beta e_{2}\left(w_{2}^{1}\left(e_{1}\right)\right)
$$

So, the Codazzi equation (16) becomes

$$
\begin{align*}
\beta_{11}+\beta_{22}= & -\tan \beta\left[\left(2 H+\beta_{2}\right) \beta_{2}+\left(2 H+\beta_{2}\right)^{2}+2\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right)\right] \\
& -\left(\kappa-4 \tau^{2}\right) \sin \beta \cos \beta \tag{22}
\end{align*}
$$

Again, by using (17) and (19), the equation (22) becomes

$$
\begin{equation*}
\left[1+(H / \tau)^{2}\right] \beta_{11}=-2\left[1+(H / \tau)^{2}\right]\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan \beta-\left(\kappa-4 \tau^{2}\right) \sin \beta \cos \beta \tag{23}
\end{equation*}
$$

and taking the derivative by $e_{1}$ gives us

$$
\begin{align*}
{\left[1+(H / \tau)^{2}\right] \beta_{111}=} & -2\left[1+(H / \tau)^{2}\right]\left[\left(3 \tau+2 \beta_{1}\right) \beta_{11} \tan \beta+\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \sec ^{2} \beta \beta_{1}\right] \\
& -\left(\kappa-4 \tau^{2}\right) \cos (2 \beta) \beta_{1} \\
= & 4\left[1+(H / \tau)^{2}\right]\left(3 \tau+2 \beta_{1}\right)\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan ^{2} \beta+2\left(\kappa-4 \tau^{2}\right)\left(3 \tau+2 \beta_{1}\right) \sin ^{2} \beta \\
& -2\left[1+(H / \tau)^{2}\right]\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \sec ^{2} \beta \beta_{1}-\left(\kappa-4 \tau^{2}\right) \cos (2 \beta) \beta_{1} \tag{24}
\end{align*}
$$ (24) into (21), by a straightforward computation we have

$$
\begin{align*}
\Delta|\Phi|^{2}= & 4\left[1+(H / \tau)^{2}\right]^{2}\left\{\beta_{11}^{2}+2\left(\tau+\beta_{1}\right)^{2}\left(2 \tau+\beta_{1}\right)\left[2\left(2 \tau+\beta_{1}\right) \tan ^{2} \beta-\beta_{1}\right]\right\} \\
& +4\left[1+(H / \tau)^{2}\right]\left(\kappa-4 \tau^{2}\right)\left(\tau+\beta_{1}\right)\left[4\left(\tau+\beta_{1}\right) \sin ^{2} \beta-\beta_{1} \cos ^{2} \beta\right] \tag{25}
\end{align*}
$$

$$
|\nabla A|^{2}=2\left[1+(H / \tau)^{2}\right]^{2}\left[\beta_{11}^{2}+4\left(\tau+\beta_{1}\right)^{2}\left(2 \tau+\beta_{1}\right)^{2} \tan ^{2} \beta\right]
$$

Proof. By (7), (18) and Lemma 2.1 we compute that

$$
\begin{aligned}
h_{11 \mid 1} & =e_{1}\left(2 H+\beta_{2}\right)-h_{21} \theta_{1}^{2}\left(e_{1}\right)-h_{12} \theta_{1}^{2}\left(e_{1}\right) \\
& =\beta_{21}-2\left(\tau+\beta_{1}\right)\left(2 H+\beta_{2}\right) \tan \beta \\
& =(H / \tau)\left[\beta_{11}-2\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan \beta\right] .
\end{aligned}
$$

A similar computation yields

$$
h_{11 \mid 2}=(H / \tau)^{2} \beta_{11}+2\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan \beta, \quad h_{12 \mid 1}=-\beta_{11}-2(H / \tau)^{2}\left(\tau+\beta_{1}\right)\left(2 \tau+\beta_{1}\right) \tan \beta
$$

and the following identities hold true:

$$
h_{12 \mid 2}=-h_{11 \mid 1}=-h_{22 \mid 1} \quad \text { and } \quad h_{12 \mid 1}=-h_{22 \mid 2}
$$

Thus by definition,

$$
|\nabla A|^{2}=h_{11 \mid 1}^{2}+h_{11 \mid 2}^{2}+h_{22 \mid 1}^{2}+h_{22 \mid 2}^{2}+2\left(h_{12 \mid 1}^{2}+h_{12 \mid 2}^{2}\right)=2\left(2 h_{11 \mid 1}^{2}+h_{11 \mid 2}^{2}+h_{12 \mid 1}^{2}\right)
$$

and Eq. (26) follows by a straightforward computation.
By (20), (25), (26) and $|\nabla \Phi|^{2}=|\nabla A|^{2}$, we have

$$
\begin{align*}
\frac{1}{2} \Delta|\Phi|^{2}= & |\nabla \Phi|^{2}-|\Phi|^{2}\left[|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right] \\
& +\left(\kappa-4 \tau^{2}\right)\left\{4|\Phi|^{2} \sin ^{2} \beta-2\left[1+(H / \tau)^{2}\right]\left(2 \tau+\beta_{1}\right) \beta_{1} \cos ^{2} \beta\right\} \\
& +2\left(\kappa-4 \tau^{2}\right)\left[1+(H / \tau)^{2}\right] \tau \beta_{1} \cos ^{2} \beta \\
= & |\nabla \Phi|^{2}-|\Phi|^{2}\left[|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right] \\
& +\left(\kappa-4 \tau^{2}\right)\left[4|\Phi|^{2} \sin ^{2} \beta-\left(|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right) \cos ^{2} \beta\right] \\
& +2\left(\kappa-4 \tau^{2}\right)\left[1+(H / \tau)^{2}\right] \tau \beta_{1} \cos ^{2} \beta \tag{27}
\end{align*}
$$

We now deal with the last term in (27). Inspired by the computations in [13] and [18], we prove the following lemma.

Lemma 3.2. Let $T:=f_{3}-\left\langle f_{3}, N\right\rangle N$ be the projection of the vertical vector field $f_{3}=\xi$ on $\mathcal{W} \subset M$. Then

$$
\begin{equation*}
\frac{1}{2} \Delta|T|^{2}-\operatorname{div}\left(\nabla_{T} T\right)=2 \tau\left(\beta_{1} \cos ^{2} \beta+2 \tau \sin ^{2} \beta\right) \tag{28}
\end{equation*}
$$

Proof. By (3), we can express $T=f_{3}-\sin \beta e_{3}=\cos \beta e_{2}$. Then we compute

$$
\nabla_{T} T=\cos \beta \nabla_{e_{2}}\left(\cos \beta e_{2}\right)=-\sin \beta \cos \beta\left[\beta_{2} e_{2}+\left(2 \tau+\beta_{1}\right) e_{1}\right]=-(1 / 2) \sin (2 \beta)\left(\nabla \beta+2 \tau e_{1}\right)
$$

Noticing that

$$
\frac{1}{2} \Delta|T|^{2}=\frac{1}{2} \Delta\left(\cos ^{2} \beta\right)=-\cos (2 \beta)|\nabla \beta|^{2}-\sin \beta \cos \beta \Delta \beta
$$

we get

$$
\begin{aligned}
\operatorname{div}\left(\nabla_{T} T\right) & =\left\langle\nabla_{e_{i}} \nabla_{T} T, e_{i}\right\rangle=-\cos (2 \beta)\left(|\nabla \beta|^{2}+2 \tau \beta_{1}\right)-\sin \beta \cos \beta\left(\Delta \beta+2 \tau\left\langle\nabla_{e_{i}} e_{1}, e_{i}\right\rangle\right) \\
& =\frac{1}{2} \Delta|T|^{2}-2 \tau\left(\beta_{1} \cos ^{2} \beta+2 \tau \sin ^{2} \beta\right)
\end{aligned}
$$

which proves (28).

By (27), (28) and noticing that the contact function is $C=\sin \beta$, we have

$$
\begin{align*}
& \frac{1}{2} \Delta|\Phi|^{2}-\left(\kappa-4 \tau^{2}\right)\left[1+(H / \tau)^{2}\right]\left(\frac{1}{2} \Delta|T|^{2}-\operatorname{div}\left(\nabla_{T} T\right)\right) \\
= & |\nabla \Phi|^{2}-|\Phi|^{2}\left[|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right] \\
& +\left(\kappa-4 \tau^{2}\right)\left[4|\Phi|^{2} \sin ^{2} \beta-\left(|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right) \cos ^{2} \beta\right] \\
& -4\left(\kappa-4 \tau^{2}\right)\left(H^{2}+\tau^{2}\right) \sin ^{2} \beta \\
= & |\nabla \Phi|^{2}-|\Phi|^{2}\left[|\Phi|^{2}-2\left(H^{2}+\tau^{2}\right)\right] \\
& +\left(\kappa-4 \tau^{2}\right)\left[|\Phi|^{2}\left(5 C^{2}-1\right)-2\left(H^{2}+\tau^{2}\right)\left(3 C^{2}-1\right)\right] . \tag{29}
\end{align*}
$$

Although the above formula is derived on $\mathcal{W} \subset M$, it can be extended to the whole $M$ since the complimentary $\mathcal{W}^{C}$ has empty interior.

Remark 3.3. The Berger sphere is the unit sphere $\mathbb{S}^{3}$ endowed with the metric

$$
\langle X, Y\rangle=\frac{4}{\kappa}\left[\langle X, Y\rangle_{\mathbb{S}^{3}}+\left(\frac{4 \tau^{2}}{\kappa}-1\right)\langle X, \xi\rangle_{\mathbb{S}^{3}}\langle Y, \xi\rangle_{\mathbb{S}^{3}}\right],
$$

where $\langle,\rangle_{\mathbb{S}^{3}}$ stands for the standard metric on $\mathbb{S}^{3}, \kappa>0$ and $\tau \neq 0$. Although in this paper we assume $\kappa \neq 4 \tau^{2}$, the formula (29) still holds for $\kappa=4 \tau^{2}$. By taking $\kappa=4 \tau^{2}=4 c>0$, the sphere is the Riemannian space form $\mathbb{S}^{3}(c)$ with constant sectional curvature $c$. In this case, (29) reduces to

$$
\frac{1}{2} \Delta|\Phi|^{2}=|\nabla \Phi|^{2}-|\Phi|^{2}\left[|\Phi|^{2}-2\left(H^{2}+c\right)\right]
$$

which is the well known formula in [15] by observing that $\operatorname{tr} \Phi^{3}=0$ for surfaces.
Proof of Theorem 1.1 The Simons' type formula (11) is a direct consequence by integrating (29) on $M$, no matter whether $M$ is orientable or not. The equality holds if and only if $|\nabla A|=|\nabla \Phi|=0$, and this implies that $\sin \beta=0$ from (23) and (26). Therefore, the vertical Killing vector field of the fibration $\Pi: E(\kappa, \tau) \rightarrow \mathbb{M}^{2}(\kappa)$ is tangent to $M$, so $\Pi(M)$ is a closed curve $\gamma$ in $S^{2}$ and then $M=\Pi^{-1}(\gamma)$ is the Hopf cylinder in $E(\kappa, \tau)$. In this case, $|A|^{2}=2\left(2 H^{2}+\tau^{2}\right)$ follows from (20) immediately.
Remark 3.4. The authors in [6] proved that the Hopf cylinder is the only surface in $E(\kappa, \tau)(\tau \neq 0)$ with parallel second fundamental form. This fact can be used to prove the case of the equality in Theorem 1.1 instead of using Eqs. (23) and (26).

As an application, we shall use Theorem 1.1 to give a pinching result of the second fundamental form. Observe that in the case of $\kappa>4 \tau^{2}$, the equation

$$
x^{2}-\left[2\left(H^{2}+\tau^{2}\right)+\left(\kappa-4 \tau^{2}\right)\left(5 C^{2}-1\right)\right] x+2\left(\kappa-4 \tau^{2}\right)\left(H^{2}+\tau^{2}\right)\left(3 C^{2}-1\right)=0
$$

has two distinct real solutions:

$$
x_{1}=a(\kappa, \tau, H, C):=\left[2\left(H^{2}+\tau^{2}\right)+\left(\kappa-4 \tau^{2}\right)\left(5 C^{2}-1\right)-\sqrt{\rho}\right] / 2
$$

and

$$
x_{2}=b(\kappa, \tau, H, C):=\left[2\left(H^{2}+\tau^{2}\right)+\left(\kappa-4 \tau^{2}\right)\left(5 C^{2}-1\right)+\sqrt{\rho}\right] / 2
$$

where

$$
\rho=4\left(H^{2}+\tau^{2}\right)^{2}+4\left(H^{2}+\tau^{2}\right)\left(\kappa-4 \tau^{2}\right)\left(1-C^{2}\right)+\left(\kappa-4 \tau^{2}\right)^{2}\left(5 C^{2}-1\right)^{2}
$$

Obviously, it holds the relation $a(\kappa, \tau, H, C) \leq H^{2}+\tau^{2}<2\left(H^{2}+\tau^{2}\right) \leq b(\kappa, \tau, H, C)$. By Theorem 1.1 and the identity $|\Phi|^{2}=|A|^{2}-2 H^{2}$, we get immediately

Corollary 3.5. Let $f: M \rightarrow E(\kappa, \tau)\left(\kappa>4 \tau^{2}\right.$ and $\left.\tau \neq 0\right)$ be an immersion of a compact cmc $H$-surface. If $a(\kappa, \tau, H, C)+2 H^{2} \leq|A|^{2} \leq b(\kappa, \tau, H, C)+2 H^{2}$, then $M$ is a Hopf cylinder with $|A|^{2}=2\left(2 H^{2}+\tau^{2}\right)$. In particular, if $3 H^{2}+\tau^{2} \leq|A|^{2} \leq 2\left(2 H^{2}+\tau^{2}\right)$, then $M$ is a Hopf cylinder with $|A|^{2}=2\left(2 H^{2}+\tau^{2}\right)$.

Remark 3.6. When $H=0$, in the case of $\kappa>4 \tau^{2}$, the authors in [13] obtained that $M$ is a Clifford torus in the Berger sphere under the assumption that $a(\kappa, \tau, 0, C) \leq|A|^{2} \leq b(\kappa, \tau, 0, C)$, by observing the fact that the Clifford torus is the only minimal Hopf torus in the Berger sphere (see [4] or [16]). We also mention that there exist cmc (even minimal) tori which are not Hopf tori in the Berger sphere (see [19]).
Remark 3.7. Similar to the Remark 4.8 in [13, the case of $\kappa<4 \tau^{2}$ for Corollary 3.5 is still open.
