# The Probabilities of Large Deviations for the Chi-square and Log-likelihood Ratio Statistics

#### Abstract

A new large deviation results for the Pearson's chi-square and Log-likelihood ratio statistics are obtained. Here attention is focused on the case when the number of groups increases to infinity and the probabilities of groups' decreases to zero, as the sample size tends to infinity.


1. Introduction. Let $\eta=\left(\eta_{1}, \ldots, \eta_{N}\right)$ be a random vector having a multinomial distribution $M\left(n, p_{1}, \ldots, p_{N}\right)$, where $p_{1}+\ldots+p_{N}=1, p_{m}>0, m=1, \ldots, N$ and $\eta_{1}+\ldots+\eta_{N}=n$. Many tests of goodness-of-fit can be reduced to testing a hypothesis about the parameters $p_{1}, \ldots, p_{N}$. Most notably test statistics for this kind of testing problem are Pearson's chi-square ( $\chi^{2}$ ) statistic

and the log-likelihood ratio (LR) statistic:

In the present paper we study $P\left\{T_{N} \geq x_{N}\right\}$, where $T_{N}$ is standardized version of the $\chi_{N}^{2}$ or $\Lambda_{N}$ statistics and $x_{N} \rightarrow \infty$, in the situation when max $p_{m} \rightarrow 0, N \rightarrow \infty$ as $n \rightarrow \infty$.

Similar problems have been considered in the literature. We refer to Kallenberg (1985), in particularly his results for the Cramer's zone, viz. $x_{N}=o(\sqrt{N})$, proposes that $N \min p_{m} \geq c>0$ and additionally $N=o(\sqrt{n}), \sqrt{n} N^{-3 / 2} x_{N} \rightarrow \infty$ for the $\chi_{N}^{2}$ case. We refer also to Sirajdinov et al (1989) and Ivchenko and Mirakhmedov (1995). In these papers the large deviation problem in Cramér's zone has been studied for the class of statistics $h_{1}\left(\eta_{1}\right)+\ldots+h_{N}\left(\eta_{N}\right)$, where $h_{m}(u)$ is a Borel function defined on the non-negative axis and satisfying the Cramer condition: $\max _{1 \leq k \leq N} E \exp \left\{H\left|h_{k}(\xi)\right|\right\}<\infty, \exists$ $H>0$, here $\xi \sim \operatorname{Poi}(\lambda)$, the Poisson distribution with expectation $\lambda=\lim _{n \rightarrow \infty}(n / N) \in(0, \infty)$. The Cramér's condition is fulfilled for the $\Lambda_{N}$, but for the $\chi_{N}^{2}$ does not

The assertions of the present paper corresponds to the case $x_{N}=o\left(N^{1 / 6}\right)$, nevertheless they covers the situations which does not covered by aforementioned papers. Our results, together with corresponding results of Kallenberg (1985), allowed to explore the intermediate asymptotic relative efficiency due to Inglot (1999) of the $\chi^{2}$ and LR goodness of fit tests; the results are object of separate paper Mirakhmedov (2016). Also our proofs are based on the technique different from those aforementioned authors. Core part of our technique is that we reduce the cumulants of statistics of type $R_{N}$ to the cumulants of a sum of independent random variables (r.v.), next we use a modified variant of Lemma 2.3 of Saulis and Statulevicius (1991).

The rest of the paper is organized as follows. The main results are presented in Section 2; in Section 3 the proofs are given; for the reader's convenience, the auxiliary Assertions are collected in Appendix. In what follows $C_{k}$ is an universal positive constant; all asymptotic statements are considered as $n \rightarrow \infty ; \varsigma \sim F$ stands for "r.v $\varsigma$ has the distribution $F$ ".

## 2. Results

Let $p_{\text {max }}=\max _{1 \leq k \leq N} p_{k}, p_{\text {min }}=\min _{1 \leq k \leq N} p_{k}, \lambda_{n}=n / N$ and $\Phi(u)$ be the standard normal distribution function.
2.1. Chi-square statistic. Set $\nabla_{n}=\max \left(1,\left(n p_{\text {min }}\right)^{-1}\right)$,

Theorem 2.1. Let $p_{\max }=o(1)$. Then for all $x_{N}$ such that $0 \leq x_{N}=o\left(\min \left(\left(\sigma_{N}^{3} / \tilde{\sigma}_{N}^{2} \nabla_{n}\right)^{1 / 3}, n^{1 / 6}, p_{\max }^{-1 / 4}\right)\right)$ it holds

Corollary 2.1. Let $\lambda_{n} \geq C_{0}>1 / 2$ and

then for all $x_{N}$ such that $0 \leq x_{N}=o\left(N^{1 / 6}\right)$ the relations (2.2) and (2.3) are valid.
Corollary 2.2. Let $p_{m}=N^{-1}\left(1+\delta(n) d_{m, n}\right), m=1, \ldots, N$, where $\delta(n) \rightarrow 0$ and

Then for arbitrary $\lambda_{n}$ and $x_{N}$ such that $0 \leq x_{N}=o\left(N^{1 / 6} \min \left(1, \lambda_{n}^{2 / 3}\right)\right)$ the relations (2.2) and (2.3) are valid.

Remarks 2.1. For $x_{N} \rightarrow \infty$ the relation (2.2) can be written in the form $\log P\left\{\chi_{N}^{2}>x_{N} \sigma_{N}+N\right\}$ $=-x_{N}^{2} / 2(1+o(1))$. From Kallenberg (1985, Eq. (2.17)) such kind relation follows if $\log N=o\left(x_{N}^{2}\right)$, $x_{N}=o\left(N^{1 / 6}\right)$ and $N=o\left(n^{3 / 8}\right)$. Last condition excludes the case recommended by Mann and Wald (1942) who obtained the relation $N \sim c n^{2 / 5}$ concerning the optimal choice of the number of groups in chi-square goodness of fit test.
2.2. Likelihood ratio statistic $\Lambda_{N}$. Here we restrict our attention to the case $\lambda_{n} \rightarrow \infty$; the corresponding results for the case $\lambda_{n} \rightarrow \lambda \in(0, \infty)$ follows from Sirajdinov et al (1987).

Theorem 2.2. Let $\lambda_{n} \rightarrow \infty$ and

Then for all $x_{N}$ such that $0 \leq x_{N}=o\left(\min \left(N^{1 / 6}, p_{\max }^{-1 / 4}\right)\right)$ it holds

Corollary 2.3. Let $\lambda_{n} \rightarrow \infty$ and $p_{m}=N^{-1}(1+o(1)), m=1, \ldots, N$, then for all $x_{N}$ such that $0 \leq x_{N}=o\left(N^{1 / 6}\right)$ the relations (2.6) and (2.7) are valid.

Remarks 2.2. Let $\lambda_{n} \rightarrow \infty, N p_{\max }=O\left(\min \left(N^{1 / 3}, \lambda_{n}^{3}\right)\right), x_{N} \rightarrow \infty$ and $x_{N}=o\left(N^{1 / 6}\right)$. Then from (2.6) it follows that $\log P\left\{\Lambda_{N}>x_{N} \sqrt{2 N}+N\right\}=-x_{N}^{2} / 2(1+o(1))$. From Kallenberg (1985, Eq. (2.13)) such relation follows under additionally conditions $N=o\left(n^{3 / 7}\right)$ and $\log N=o\left(x_{n}^{2}\right)$.

## 3. Proofs

In what follows $\xi_{1}, \ldots, \xi_{N}$ are independent r.v.s with $\xi_{m} \sim \operatorname{Poi}\left(n p_{m}\right), \xi \sim \operatorname{Poi}\left(\lambda_{n}\right)$ and $\mathcal{C}_{k}(\zeta)$ is a cumulant of the $k$ th order of the r.v. $\zeta$,

where $\left(\eta_{1}, \ldots, \eta_{N}\right)$ is a multinomial r.vec. as in introduction, $h_{m}(x), m=1, \ldots, N$ are Borel functions defined on the non-negative axis.

Proof. It is well known that $\mathcal{L}\left(\left(\eta_{1}, \ldots, \eta_{N}\right)\right)=\mathcal{L}\left(\left(\xi_{1}, \ldots, \xi_{N}\right) / S_{N}=0\right)$, where $\mathcal{L}(X)$ stands for the distribution of a random vector $X, S_{N}=\sum_{m=1}^{N}\left(\xi_{m}-n p_{m}\right)$. Hence $E R_{N}^{k}=E\left(T_{N}^{k} \mid S_{N}=0\right)$. On the other hand $E\left(T_{N}^{k} e^{i \tau S_{N}}\right)=E\left\{e^{i \tau S_{N}} E\left(T_{N}^{k} \mid S_{N}\right)\right\}$. Now Lemma 3.1 follows by Fourier inversion. Notice that Eq. (3.7) follows due to fact that $S_{N}+n \sim \operatorname{Poi}(n)$ and Stirling's formula.

Let $k$ be as in (3.4) and (3.5). Use Lemma 3.1 to write

Set $S_{l, N}=\sum_{i=1}^{l}\left(\xi_{j_{i}}-n p_{j_{i}}\right), d_{l, N}=\sum_{i=1}^{l} p_{j_{i}}, l=1, \ldots, k$ and write

In order to get an upper bound for the $\left|J_{1}\right|$ we first write the integral $J_{1}$ as the sum of two integrals, $J_{1}^{\prime}$ and $J_{1}^{\prime \prime}$ say, over intervals $|\tau| \leq \pi \sqrt{n} / 2$ and $\pi \sqrt{n} / 2 \leq|\tau| \leq \pi \sqrt{n}$ respectively. Next, noting that $S_{N}-S_{l, N}$ is the sum of independent r.v.s $\xi_{m}-n p_{m}$ over the set of indexes $(1, \ldots, N)$ except $\left(j_{1}, \ldots, j_{l}\right)$ we use to $E \exp \left\{i \tau\left(S_{N}-S_{l, N}\right) / \sqrt{n}\right\}$ in the $J_{1}^{\prime}$ and $J_{1}^{\prime \prime}$ the equation (3.10) and inequality (3.11) respectively. Then quite clear algebra gives

\end{equation*}

since the condition (3.4). Now apply (3.12), (3.13) and (3.14) in the (3.9) to get

& =\sqrt{2 \pi}(1+o(1)) E\left(\left(h_{j_{1}}\left(\xi_{j_{1}}\right)\right)^{k_{1}} \cdot \ldots \cdot\left(h_{j_{l}}\left(\xi_{j_{l}}\right)\right)^{k_{l}}\right) \tag{3.15}
\end{align*}

Remark that in (3.13) and (3.14), and hence in (3.15), the $o(1)$ is uniform in all $l$-tuples ( $k_{j_{1}}, \ldots, k_{j_{l}}$ ) and $k$ satisfying the condition (3.5). The relations (3.7), (3.8) and (3.15) imply

Let the condition (3.3) is fulfilled with $a_{1}, b_{1}$ for all $m \in \mathbb{N} \subset(1,2, \ldots, N)$ and with $a_{2}, b_{2}$ for all $m \in(1,2, \ldots, N) \backslash \mathbb{N}$, then Eq. (3.6) is valid for every integer $k$ such that $3 \leq k=o\left(\min \left(K_{n}\left(a_{1}, b_{1}\right), K_{n}\left(a_{2}, b_{2}\right)\right)\right.$ instead of (3.5).

Let $\lfloor x\rfloor$ stand for the integer part of $x, \xi \sim \operatorname{Poi}(\lambda)$ and $\mu_{v}(\lambda)=E(\xi-\lambda)^{v}$.

for all $k$ satisfying $3 \leq k=o\left(\min \left(p_{\max }^{-1 / 2}, n^{1 / 3}\right)\right)$. Theorem 2.1 follows from this and Assertion 2 with $\Delta=2^{13} \nabla_{n} \tilde{\sigma}_{N}^{2} / \sigma_{N}^{3}$ and $\tilde{k}=\min \left(p_{\max }^{-1 / 2}, n^{1 / 3}\right)$.

& \sigma_{N}^{2}=\sum_{m=1}^{N} \operatorname{Varg}_{m}\left(\xi_{m}\right)=\frac{N}{2}-\frac{1}{6} \sum_{m=1}^{N} \frac{1}{n p_{m}}\left(1+O\left(\frac{1}{n p_{m}}\right)\right)=\frac{N}{2}\left(1+O\left(\frac{1}{\lambda_{n}}\right)\right) . \tag{3.31}

Then for all $x$ such that $0 \leq x \leq 12^{-1} \min \left(\sqrt{\tilde{k}}, \Delta^{1 / 3}\right)$ there exist a constant $c$ such that $P(\xi>x)=(1-\Phi(x))\left(1+C(x+1) \Delta^{-1 / 3}\right)$ and $P(\xi<-x)=\Phi(-x)\left(1+C(x+1) \Delta^{-1 / 3}\right)$.

In the book of Saulis and Statulevicius (1991) no assertion in the form of Assertion 2 is given. However, Assertion 2 can be proved by reasoning alike to those presented by Saulis and

Statulevicius (1991) at page 35, in course of proof of Lemma 2.3, see relations (2.62), (2.65) and (2.66) and Lemma 2.2 of the book.

here $\sum$ is summation over all non-negative integer $m_{1}, m_{2}, \ldots, m_{k}$ such that $m_{1}+2 m_{2}+\ldots+k m_{k}=k$
