# EFFICIENT MULTIVARIATE ENTROPY ESTIMATION VIA $K$-NEAREST NEIGHBOUR DISTANCES

Many statistical procedures, including goodness-of-fit tests and methods for independent component analysis, rely critically on the estimation of the entropy of a distribution. In this paper, we seek entropy estimators that are efficient and achieve the local asymptotic minimax lower bound with respect to squared error loss. To this end, we study weighted averages of the estimators originally proposed by Kozachenko and Leonenko (1987), based on the $k$-nearest neighbour distances of a sample of $n$ independent and identically distributed random vectors in $\mathbb{R}^{d}$. A careful choice of weights enables us to obtain an efficient estimator in arbitrary dimensions, given sufficient smoothness, while the original unweighted estimator is typically only efficient when $d \leq 3$. In addition to the new estimator proposed and theoretical understanding provided, our results facilitate the construction of asymptotically valid confidence intervals for the entropy of asymptotically minimal width.

1. Introduction. The concept of entropy plays a central role in information theory, and has found a wide array of uses in other disciplines, including statistics, probability and combinatorics. The (differential) entropy of a random vector $X$ with density function $f$ is defined as

$$
H=H(X)=H(f):=-\mathbb{E}\{\log f(X)\}=-\int_{\mathcal{X}} f(x) \log f(x) d x
$$

where $\mathcal{X}:=\{x: f(x)>0\}$. It represents the average information content of an observation, and is usually thought of as a measure of unpredictability.

[^0]In statistical contexts, it is often the estimation of entropy that is of primary interest, for instance in goodness-of-fit tests of normality (Vasicek, 1976) or uniformity (Cressie, 1976), tests of independence (Goria et al., 2005), independent component analysis (Miller and Fisher, 2003) and feature selection in classification (Kwak and Choi, 2002). See, for example, Beirlant et al. (1997) and Paninski (2003) for other applications and an overview of nonparametric techniques, which include methods based on sample spacings in the univariate case (e.g. El Haje Hussein and Golubev, 2009), histograms (Hall and Morton, 1993) and kernel density estimates (Paninski and Yajima, 2008; Sricharan, Wei and Hero, 2013), among others. The estimator of Kozachenko and Leonenko (1987) is particularly attractive as a starting point, both because it generalises easily to multivariate cases, and because, since it only relies on the evaluation of $k$ th-nearest neighbour distances, it is straightforward to compute.

To introduce this estimator, for $n \geq 2$, let $X_{1}, \ldots, X_{n}$ be independent random vectors with density $f$ on $\mathbb{R}^{d}$. Write $\|\cdot\|$ for the Euclidean norm on $\mathbb{R}^{d}$, and for $i=1, \ldots, n$, let $X_{(1), i}, \ldots, X_{(n-1), i}$ denote a permutation of $\left\{X_{1}, \ldots, X_{n}\right\} \backslash\left\{X_{i}\right\}$ such that $\left\|X_{(1), i}-X_{i}\right\| \leq \ldots \leq\left\|X_{(n-1), i}-X_{i}\right\|$. For conciseness, we let

$$
\rho_{(k), i}:=\left\|X_{(k), i}-X_{i}\right\|
$$

denote the distance between $X_{i}$ and the $k$ th nearest neighbour of $X_{i}$. The Kozachenko-Leonenko estimator of the entropy $H$ is given by

$$
\begin{equation*}
\hat{H}_{n}=\hat{H}_{n}\left(X_{1}, \ldots, X_{n}\right):=\frac{1}{n} \sum_{i=1}^{n} \log \left(\frac{\rho_{(k), i}^{d} V_{d}(n-1)}{e^{\Psi(k)}}\right) \tag{1}
\end{equation*}
$$

where $V_{d}:=\pi^{d / 2} / \Gamma(1+d / 2)$ denotes the volume of the unit $d$-dimensional Euclidean ball and where $\Psi$ denotes the digamma function. In fact, this is a generalisation of the estimator originally proposed by Kozachenko and Leonenko (1987), which was defined for $k=1$. For integers $k$ we have $\Psi(k)=$ $-\gamma+\sum_{j=1}^{k-1} 1 / j$ where $\gamma:=0.577216 \ldots$ is the Euler-Mascheroni constant, so that $e^{\Psi(k)} / k \rightarrow 1$ as $k \rightarrow \infty$. This estimator can be regarded as an attempt to mimic the 'oracle' estimator $H_{n}^{*}:=-n^{-1} \sum_{i=1}^{n} \log f\left(X_{i}\right)$, based on a $k$-nearest neighbour density estimate that relies on the approximation

$$
\frac{k}{n-1} \approx V_{d} \rho_{(k), 1}^{d} f\left(X_{1}\right)
$$

It turns out that, when $d \leq 3$ and other regularity conditions hold, the estimator $\hat{H}_{n}$ in (1) has the same asymptotic behaviour as $H_{n}^{*}$, in that

n^{1 / 2}\left(\hat{H}_{n}-H\right) \xrightarrow{d} N\left(0, \operatorname{Var} \log f\left(X_{1}\right)\right)
$$

We will see that in such settings, this estimator is asymptotically efficient, in the sense of, e.g., van der Vaart (1998, p. 367). However, when $d \geq$ 4, a non-trivial bias typically precludes its efficiency. Our main object of interest, therefore, will be a generalisation of the estimator (1), formed as a weighted average of Kozachenko-Leonenko estimators for different values of $k$, where the weights are chosen to try to cancel the dominant bias terms. More precisely, for a weight vector $w=\left(w_{1}, \ldots, w_{k}\right)^{T} \in \mathbb{R}^{k}$ with $\sum_{j=1}^{k} w_{j}=$ 1 , we consider the estimator

$$
\hat{H}_{n}^{w}:=\frac{1}{n} \sum_{i=1}^{n} \sum_{j=1}^{k} w_{j} \log \xi_{(j), i},
$$

where $\xi_{(j), i}:=e^{-\Psi(j)} V_{d}(n-1) \rho_{(j), i}^{d}$. Weighted estimators of this general type have been considered recently (e.g. Sricharan, Wei and Hero, 2013; Moon et al., 2016), though our construction of the weights and our analysis is new. In particular, we show that under stronger smoothness assumptions, and with a suitable choice of weights, the weighted Kozachenko-Leonenko estimator is efficient in arbitrary dimensions.

There have been several previous studies of the (unweighted) KozachenkoLeonenko estimator, but results on the rate of convergence have until now confined either to the case $k=1$ or (very recently) the case where $k$ is fixed as $n$ diverges. The original Kozachenko and Leonenko (1987) paper proved consistency of the estimator under mild conditions in the case $k=1$. Tsybakov and Van der Meulen (1996) proved that the mean squared error of a truncated version of the estimator is $O\left(n^{-1}\right)$ when $k=1$ and $d=1$ under a condition that is almost equivalent to an exponential tail; Biau and Devroye (2015) showed that the bias vanishes asymptotically while the variance is $O\left(n^{-1}\right)$ when $k=1$ and $f$ is compactly supported and bounded away from zero on its support. Very recently, in independent work and under regularity conditions, Delattre and Fournier (2017) derived the asymptotic normality of the estimator when $k=1$, confirming the suboptimal asymptotic variance in this case. Previous works on the general $k$ case include Singh et al. (2003), where heuristic arguments were presented to suggest the estimator is consistent for general $d$ and general fixed $k$ and has variance $O\left(n^{-1}\right)$ for $d=1$ and general fixed $k$. Gao, Oh and Viswanath (2016) obtain a mean squared error bound of $O\left(n^{-1}\right)$ up to polylogarithmic factors for fixed $k$ and $d \leq 2$, though the only densities which the authors can show satisfy their tail condition have bounded support. Singh and Póczos (2016) obtain a similar bound (without the polylogarithmic factors, but explicitly assuming bounded support) for fixed $k$ and $d \leq 4$. Mnatsakanov et al. (2008) allow $k$ to diverge with $n$, and show that the estimator is consistent for general $d$.

Plug-in kernel methods are also popular for entropy estimation. Paninski and Yajima (2008), for example, show that a smaller bandwidth than would be required for a consistent density estimator can still yield a consistent entropy estimator. A $k$-nearest neighbour density estimate can be regarded as a kernel estimator with a bandwidth that depends both on the data and on the point at which the estimate is required. Sricharan, Wei and Hero (2013) obtain the parametric rate of convergence for a plug-in kernel method, assuming bounded support and at least $d$ derivatives in the interior of the support.

Importantly, the class of densities considered in our results allows the support of the density to be unbounded; for instance, it may be the whole of $\mathbb{R}^{d}$. Such settings present significant new challenges and lead to different behaviour compared with more commonly-studied situations where the underlying density is compactly supported and bounded away from zero on its support. To gain intuition, consider the following second-order Taylor expansion of $H(f)$ around a density estimator $\hat{f}$ :

$$
H(f) \approx-\int_{\mathbb{R}^{d}} f(x) \log \hat{f}(x) d x-\frac{1}{2}\left(\int_{\mathbb{R}^{d}} \frac{f^{2}(x)}{\hat{f}(x)} d x-1\right)
$$

When $f$ is bounded away from zero on its support, one can estimate the (smaller order) second term on the right-hand side, thereby obtaining efficient estimators of entropy in higher dimensions (Laurent, 1996); however, when $f$ is not bounded away from zero on its support such procedures are no longer effective. To the best of our knowledge, therefore, this is the first time that a nonparametric entropy estimator has been shown to be efficient in multivariate settings for densities having unbounded support. (We remark that when $d=1$, the histogram estimator of Hall and Morton (1993) is known to be efficient under fairly strong tail conditions.)

The outline of the rest of the paper is as follows. In Section 2, we give our main results on the mean squared error and asymptotic normality of weighted Kozachenko-Leonenko estimators, and discuss confidence interval construction. These main results arise from asymptotic expansions for the bias and variance, which are stated in Section 3. Here, we also give examples to illustrate densities satisfying our conditions, discuss how they may be weakened, and address the fixed $k$ case. Corresponding lower bounds are presented in Section 4. Proofs of main results are presented in Section 5 with auxiliary material and detailed bounds for various error terms deferred to the Appendix, which appears as the supplementary material Berrett, Samworth and Yuan (2017).

We conclude the introduction with some notation used throughout the pa-
per. For $x \in \mathbb{R}^{d}$ and $r>0$, let $B_{x}(r)$ be the closed Euclidean ball of radius $r$ about $x$, and let $B_{x}^{\circ}(r):=B_{x}(r) \backslash\{x\}$ denote the corresponding punctured ball. We write $\|A\|_{\mathrm{op}}$ and $|A|$ for the operator norm and determinant, respectively, of $A \in \mathbb{R}^{d \times d}$, and let $\|A\|$ denote the vectorised Euclidean norm of a vector, matrix or array. For a smooth function $f: \mathbb{R}^{d} \rightarrow[0, \infty)$, we write $\dot{f}(x), \ddot{f}(x)$ and $f^{(m)}(x)$ respectively for the gradient vector of $f$ at $x$, Hessian matrix of $f$ at $x$ and the array with $\left(j_{1}, \ldots, j_{m}\right)$ th entry $\frac{\partial^{m} f(x)}{\partial x_{j_{1}} \ldots \partial x_{j_{m}}}$. We also write $\Delta f(x):=\sum_{j=1}^{d} \frac{\partial^{2} f}{\partial x_{j}^{2}}(x)$ for its Laplacian, and $\|f\|_{\infty}:=\sup _{x \in \mathbb{R}^{d}} f(x)$ for its uniform norm.
2. Main results. We begin by introducing the class of densities over which our results will hold. Let $\mathcal{F}_{d}$ denote the class of all density functions with respect to Lebesgue measure on $\mathbb{R}^{d}$. For $f \in \mathcal{F}_{d}$ and $\alpha>0$, let

$$
\mu_{\alpha}(f):=\int_{\mathbb{R}^{d}}\|x\|^{\alpha} f(x) d x
$$

Now let $\mathcal{A}$ denote the class of decreasing functions $a:(0, \infty) \rightarrow[1, \infty)$ satisfying $a(\delta)=o\left(\delta^{-\epsilon}\right)$ as $\delta \searrow 0$, for every $\epsilon>0$. If $a \in \mathcal{A}, \beta>0$ and $f \in \mathcal{F}_{d}$ is $m:=\lceil\beta\rceil$-1-times differentiable and $x \in \mathcal{X}$, we define $r_{a}(x):=\left\{8 d^{1 / 2} a(f(x))\right\}^{-1 /(\beta \wedge 1)}$ and

$$
M_{f, a, \beta}(x):=\max \left\{\max _{t=1, \ldots, m} \frac{\left\|f^{(t)}(x)\right\|}{f(x)}, \sup _{y \in B_{x}^{\circ}\left(r_{a}(x)\right)} \frac{\left\|f^{(m)}(y)-f^{(m)}(x)\right\|}{f(x)\|y-x\|^{\beta-m}}\right\} .
$$

The quantity $M_{f, a, \beta}(x)$ measures the smoothness of derivatives of $f$ in neighbourhoods of $x$, relative to $f(x)$ itself. Note that these neighbourhoods of $x$ are allowed to become smaller when $f(x)$ is small. Finally, for $\Theta:=(0, \infty)^{4} \times \mathcal{A}$, and $\theta=(\alpha, \beta, \nu, \gamma, a) \in \Theta$, let

$$
\mathcal{F}_{d, \theta}:=\left\{f \in \mathcal{F}_{d}: \mu_{\alpha}(f) \leq \nu,\|f\|_{\infty} \leq \gamma, \sup _{x: f(x) \geq \delta} M_{f, a, \beta}(x) \leq a(\delta) \forall \delta>0\right\} .
$$

We note here that Lemma 12 in the online supplement can be used to derive a nestedness property of the classes with respect to the smoothness parameter, namely that if $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta, \beta^{\prime} \in(0, \beta)$ and $a^{\prime}(\delta)=15 d^{\lceil\beta\rceil / 2} a(\delta)$, then $\mathcal{F}_{d, \theta} \subseteq \mathcal{F}_{d, \theta^{\prime}}$, where $\theta^{\prime}=\left(\alpha, \beta^{\prime}, \gamma, \nu, a^{\prime}\right) \in \Theta$. In Section 3.2 below, we discuss the requirements of the class $\mathcal{F}_{d, \theta}$ in greater detail, and give several examples, including Gaussian and multivariate- $t$ densities, which belong to $\mathcal{F}_{d, \theta}$ for suitable $\theta$.

We now introduce the class of weights $w=\left(w_{1}, \ldots, w_{k}\right)^{T}$ that we consider. For $k \in \mathbb{N}$, let

$$
\begin{align*}
\mathcal{W}^{(k)}:=\left\{w \in \mathbb{R}^{k}:\right. & \sum_{j=1}^{k} w_{j} \frac{\Gamma(j+2 \ell / d)}{\Gamma(j)}=0 \quad \text { for } \ell=1, \ldots,\lfloor d / 4\rfloor \\
2) & \left.\sum_{j=1}^{k} w_{j}=1 \text { and } w_{j}=0 \text { if } j \notin\{\lfloor k / d\rfloor,\lfloor 2 k / d\rfloor, \ldots, k\}\right\} . \tag{2}
\end{align*}
$$

Our main result below shows that for appropriately chosen weight vectors in $\mathcal{W}^{(k)}$, the normalised risk of the weighted Kozachenko-Leonenko estimator $\hat{H}_{n}^{w}$ converges in a uniform sense to that of the oracle estimator $H_{n}^{*}:=$ $-n^{-1} \sum_{i=1}^{n} \log f\left(X_{i}\right)$. Theorem 8 in Section 4 shows that this limiting risk is optimal.

Theorem 1. Fix $d \in \mathbb{N}$ and $\theta=(\alpha, \beta, \nu, \gamma, a) \in \Theta$ with $\alpha>d$ and with $\beta>d / 2$. Let $k_{0}^{*}=k_{0, n}^{*}$ and $k_{1}^{*}=k_{1, n}^{*}$ denote any two deterministic sequences of positive integers with $k_{0}^{*} \leq k_{1}^{*}$, with $k_{0}^{*} / \log ^{5} n \rightarrow \infty$ and with $k_{1}^{*}=O\left(n^{\tau_{1}}\right)$ and $k_{1}^{*}=o\left(n^{\tau_{2}}\right)$, where

$$
\tau_{1}<\min \left(\frac{2 \alpha}{5 \alpha+3 d}, \frac{\alpha-d}{2 \alpha}, \frac{4 \beta^{*}}{4 \beta^{*}+3 d}\right), \tau_{2}:=\min \left(1-\frac{d / 4}{1+\lfloor d / 4\rfloor}, 1-\frac{d}{2 \beta}\right)
$$

and $\beta^{*}:=\beta \wedge 1$. There exists $k_{d} \in \mathbb{N}$, depending only on $d$, such that for each $k \geq k_{d}$, we can find $w=w^{(k)} \in \mathcal{W}^{(k)}$ with $\sup _{k \geq k_{d}}\left\|w^{(k)}\right\|<\infty$. For such $w$,

$$
\begin{equation*}
\sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}} n \mathbb{E}_{f}\left\{\left(\hat{H}_{n}^{w}-H_{n}^{*}\right)^{2}\right\} \rightarrow 0 \tag{3}
\end{equation*}
$$

as $n \rightarrow \infty$. In particular,

$$
\sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}}\left|n \mathbb{E}_{f}\left\{\left(\hat{H}_{n}^{w}-H(f)\right)^{2}\right\}-V(f)\right| \rightarrow 0
$$

where $V(f):=\operatorname{Var}_{f} \log f\left(X_{1}\right)=\int_{\mathcal{X}} f \log ^{2} f-H(f)^{2}$.
We remark that the level of smoothness we require for efficiency in Theorem 1 , namely $\beta>d / 2$ is more than is needed for the two-stage estimator of Laurent (1996) in the case where $f$ is compactly supported and bounded away from zero on its support, where $\beta>d / 4$ suffices. As alluded to in the introduction, the fact that the function $x \mapsto-x \log x$ is non-differentiable at $x=0$ means that the entropy functional is no longer smooth when $f$ has
full support, so the arguments of Laurent (1996) can no longer be applied and very different behaviour may occur (Lepski, Nemirovski and Spokoiny, 1999; Cai and Low, 2011).

It is also useful, e.g. for the purposes of constructing confidence intervals for the entropy, to understand the asymptotic normality of the estimator. To this end, let $\mathcal{H}$ denote the class of functions $h: \mathbb{R} \rightarrow \mathbb{R}$ with $\|h\|_{\infty} \leq 1$ and $|h(x)-h(y)| \leq|x-y|$ for all $x, y \in \mathbb{R}$. For probability measures $P, Q$ on $\mathbb{R}$, we write

$$
d_{\mathrm{BL}}(P, Q):=\sup _{h \in \mathcal{H}}\left|\int_{-\infty}^{\infty} h d(P-Q)\right|
$$

for the bounded Lipschitz distance between $P$ and $Q$. Recall that $d_{\mathrm{BL}}$ metrises weak convergence. The asymptotic variance $V(f)$ can be estimated analogously to $H(f)$ by $\hat{V}_{n}^{w}:=\max \left(\tilde{V}_{n}^{w}, 0\right)$, where

$$
\tilde{V}_{n}^{w}:=\frac{1}{n} \sum_{i=1}^{n} \sum_{j=1}^{k} w_{j} \log ^{2} \xi_{(j), i}-\left(\hat{H}_{n}^{w}\right)^{2} .
$$

Fixing $q \in(0,1)$, this suggests that a natural asymptotic $(1-q)$-level confidence interval for $H(f)$ is given by

$$
I_{n, q}:=\left[\hat{H}_{n}^{w}-n^{-1 / 2} z_{q / 2}\left(\hat{V}_{n}^{w}\right)^{1 / 2}, \hat{H}_{n}^{w}+n^{-1 / 2} z_{q / 2}\left(\hat{V}_{n}^{w}\right)^{1 / 2}\right],
$$

where $z_{q}$ is the $(1-q)$ th quantile of the standard normal distribution; see also Delattre and Fournier (2017). Write $\mathcal{L}(Z)$ for the distribution of a random variable $Z$.

Theorem 2. Under the conditions of Theorem 1, we have

$$
\sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}} d_{\mathrm{BL}}\left(\mathcal{L}\left(n^{1 / 2}\left(\hat{H}_{n}^{w}-H(f)\right)\right), N(0, V(f))\right) \rightarrow 0
$$

as $n \rightarrow \infty$. Consequently,

$$
\sup _{q \in(0,1)} \sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}}\left|\mathbb{P}_{f}\left(I_{n, q} \ni H(f)\right)-(1-q)\right| \rightarrow 0 .
$$

We remark that the choice $k=k_{n}=\left\lceil\log ^{6} n\right\rceil$ with $w=w^{(k)} \in \mathcal{W}^{(k)}$ satisfying $\sup _{k \geq k_{d}}\left\|w^{(k)}\right\|<\infty$ for the weighted Kozachenko-Leonenko estimator satisfies the conditions for efficiency in Theorem 1 whenever $f \in \mathcal{F}_{d, \theta}$ with $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta$ satisfying $\alpha>d$ and $\beta>d / 2$; knowledge of the precise values of $\alpha$ and $\beta$ is not required. Moreover, the uniformity of the asymptotics in $k$ means that if $\hat{k}_{n}=\hat{k}_{n}\left(X_{1}, \ldots, X_{n}\right)$ is a datadriven choice of $k$, the conclusions Theorem 2 remain valid provided that $\mathbb{P}\left(\hat{k}_{n}<k_{0}^{*}\right)+\mathbb{P}\left(\hat{k}_{n}>k_{1}^{*}\right) \rightarrow 0$.

## 3. Bias and variance expansions for Kozachenko-Leonenko estimators.

3.1. Bias. The proof of (3) is derived from separate expansions for the bias and variance of the weighted Kozachenko-Leonenko estimator, and we treat the bias in this subsection. To gain intuition, we initially focus for simplicity of exposition on the unweighted estimator

$$
\hat{H}_{n}=\frac{1}{n} \sum_{i=1}^{n} \log \xi_{i}
$$

where we have written $\xi_{i}$ as shorthand for $\xi_{(k), i}$. For $x \in \mathbb{R}^{d}$ and $u \in[0, \infty)$, we introduce the sequence of distribution functions

$$
F_{n, x}(u):=\mathbb{P}\left(\xi_{i} \leq u \mid X_{i}=x\right)=\sum_{j=k}^{n-1}\binom{n-1}{j} p_{n, x, u}^{j}\left(1-p_{n, x, u}\right)^{n-1-j}
$$

where

$$
p_{n, x, u}:=\int_{B_{x}\left(r_{n, u}\right)} f(y) d y \quad \text { and } \quad r_{n, u}:=\left\{\frac{e^{\Psi(k)} u}{V_{d}(n-1)}\right\}^{1 / d}
$$

Further, for $u \in[0, \infty)$, define the limiting (Gamma) distribution function

$$
F_{x}(u):=\exp \left\{-u f(x) e^{\Psi(k)}\right\} \sum_{j=k}^{\infty} \frac{1}{j!}\left\{u f(x) e^{\Psi(k)}\right\}^{j}=e^{-\lambda_{x, u}} \sum_{j=k}^{\infty} \frac{\lambda_{x, u}^{j}}{j!}
$$

where $\lambda_{x, u}:=u f(x) e^{\Psi(k)}$. That this is the limit distribution for each fixed $k$ follows from a Poisson approximation to the Binomial distribution and the Lebesgue differentiation theorem. We therefore expect that

$$
\begin{aligned}
\mathbb{E}\left(\hat{H}_{n}\right) & =\int_{\mathcal{X}} f(x) \int_{0}^{\infty} \log u d F_{n, x}(u) d x \approx \int_{\mathcal{X}} f(x) \int_{0}^{\infty} \log u d F_{x}(u) d x \\
& =\int_{\mathcal{X}} f(x) \int_{0}^{\infty} \log \left(\frac{t e^{-\Psi(k)}}{f(x)}\right) e^{-t} \frac{t^{k-1}}{(k-1)!} d t d x=H
\end{aligned}
$$

Although we do not explicitly use this approximation in our asymptotic analysis of the bias, it motivates much of our development. It also explains the reason for using $e^{\Psi(k)}$ in the definition of $\xi_{(k), i}$, rather than simply $k$. Lemma 3 below gives an expression for the asymptotic bias of the unweighted Kozachenko-Leonenko estimator.

Lemma 3. Fix $d \in \mathbb{N}$ and $\theta=(\alpha, \beta, \nu, \gamma, a) \in \Theta$. Let $k^{*}=k_{n}^{*}$ denote any deterministic sequence of positive integers with $k^{*}=O\left(n^{1-\epsilon}\right)$ as $n \rightarrow \infty$ for some $\epsilon>0$. Then there exist $\lambda_{1}, \ldots, \lambda_{\lceil\beta / 2\rceil-1} \in \mathbb{R}$, depending only on $f$ and $d$, such that $\sup _{f \in \mathcal{F}_{d, \theta}} \max _{l=1, \ldots,\lceil\beta / 2\rceil-1}\left|\lambda_{l}\right|<\infty$ and for each $\epsilon>0$,

$$
\sup _{f \in \mathcal{F}_{d, \theta}}\left|\mathbb{E}_{f}\left(\hat{H}_{n}\right)-H-\sum_{l=1}^{\lceil\beta / 2\rceil-1} \frac{\Gamma(k+2 l / d) \Gamma(n)}{\Gamma(k) \Gamma(n+2 l / d)} \lambda_{l}\right|=O\left(\max \left\{\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}, \frac{k^{\frac{\beta}{d}}}{n^{\frac{\beta}{d}}}\right\}\right)
$$

as $n \rightarrow \infty$, uniformly for $k \in\left\{1, \ldots, k^{*}\right\}$, where $\lambda_{l}=0$ if $2 l \geq d \alpha /(\alpha+d)$.
When $d \geq 3, \alpha>2 d /(d-2)$ and $\beta>2$, we have

$$
\lambda_{1}=-\frac{1}{2(d+2) V_{d}^{2 / d}} \int_{\mathcal{X}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x
$$

which is finite under these assumptions; cf. the second part of Proposition 9 in Section 5.1. Moreover, since, for each $l>0$, we have $\frac{\Gamma(n)}{\Gamma(n+2 l / d)}=n^{-2 l / d}\{1+$ $\left.O\left(n^{-1}\right)\right\}$, we deduce from Lemma 3 that in this setting,

$$
\sup _{f \in \mathcal{F}_{d, \theta}}\left|\mathbb{E}_{f}\left(\hat{H}_{n}\right)-H+\frac{\Gamma(k+2 / d)}{2(d+2) V_{d}^{2 / d} \Gamma(k) n^{2 / d}} \int_{\mathcal{X}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x\right|=o\left(\frac{k^{2 / d}}{n^{2 / d}}\right) .
$$

In particular, when $d \geq 4$ and $\int_{\mathcal{X}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x \neq 0$, the bias of the unweighted Kozachenko-Leonenko estimator precludes its efficiency.

On the other hand, Lemma 3 motivates the definition of the class of weight vectors $\mathcal{W}^{(k)}$ in (2), and facilitates the expansion for the bias of the weighted Kozachenko-Leonenko estimator in Corollary 4 below. In particular, since $2(\lfloor d / 4\rfloor+1) / d>1 / 2$, we see that this result provides conditions under which the bias is $o\left(n^{-1 / 2}\right)$ for suitably chosen $k$. This explains why we let $\ell$ take values in the range $\{1, \ldots,\lfloor d / 4\rfloor\}$ in (2).

Corollary 4. Assume the conditions of Lemma 3. If $w=w^{(k)} \in \mathcal{W}^{(k)}$ for $k \geq k_{d}$ and $\sup _{k \geq k_{d}}\left\|w^{(k)}\right\|<\infty$, then for every $\epsilon>0$,

$$
\sup _{f \in \mathcal{F}_{d, \theta}}\left|\mathbb{E}_{f}\left(\hat{H}_{n}^{w}\right)-H(f)\right|=O\left(\max \left\{\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}, \frac{k^{\frac{2(\lfloor d / 4\rfloor+1)}{d}}}{n^{\frac{2(\lfloor d / 4\rfloor+1)}{d}}}, \frac{k^{\frac{\beta}{d}}}{n^{\frac{\beta}{d}}}\right\}\right)
$$

uniformly for $k \in\left\{1, \ldots, k^{*}\right\}$.

The proof of Lemma 3 is given in Section 5.1, but we present here some of the main ideas that are particularly relevant for the case $d \geq 3, \alpha>$ $2 d /(d-2)$ and $\beta \in(2,4]$. First, note that

$$
\begin{equation*}
\frac{d F_{n, x}(u)}{d u}=\mathrm{B}_{k, n-k}\left(p_{n, x, u}\right) \frac{\partial p_{n, x, u}}{\partial u} \tag{4}
\end{equation*}
$$

where $\mathrm{B}_{a, b}(s):=\mathrm{B}_{a, b}^{-1} s^{a-1}(1-s)^{b-1}$ denotes the density of a $\operatorname{Beta}(a, b)$ random variable at $s \in(0,1)$, with $\mathrm{B}_{a, b}:=\Gamma(a) \Gamma(b) / \Gamma(a+b)$. For $x \in \mathcal{X}$ and $r>0$, define $h_{x}(r):=\int_{B_{x}(r)} f(y) d y$. Since $h_{x}(r)$ is a continuous, nondecreasing function of $r$, we can define a left-continuous inverse for $s \in(0,1)$ by

$$
\begin{equation*}
h_{x}^{-1}(s):=\inf \left\{r>0: h_{x}(r) \geq s\right\}=\inf \left\{r>0: h_{x}(r)=s\right\}, \tag{5}
\end{equation*}
$$

so that $h_{x}(r) \geq s$ if and only if $r \geq h_{x}^{-1}(s)$. We use the approximation

$$
V_{d} f(x) h_{x}^{-1}(s)^{d} \approx s-\frac{s^{1+2 / d} \Delta f(x)}{2(d+2) V_{d}^{2 / d} f(x)^{1+2 / d}}
$$

for small $s>0$, which is formalised in Lemma 10(ii) in Section 5.1. In the case $d \geq 3, \alpha>2 d /(d-2)$ and $\beta \in(2,4]$, the proof of Lemma 3 can be seen as justifying the use of the above approximation in the following:

$$
\begin{aligned}
\mathbb{E}\left(\hat{H}_{n}\right) & =\int_{\mathcal{X}} f(x) \int_{0}^{\infty} \log u d F_{n, x}(u) d x \\
& =\int_{\mathcal{X}} f(x) \int_{0}^{1} \log \left(\frac{V_{d}(n-1) h_{x}^{-1}(s)^{d}}{e^{\Psi(k)}}\right) \mathrm{B}_{k, n-k}(s) d s d x \\
& \approx \int_{\mathcal{X}} f(x) \int_{0}^{1}\left\{\log \left(\frac{(n-1) s}{e^{\Psi(k)} f(x)}\right)-\frac{V_{d}^{-2 / d} s^{2 / d} \Delta f(x)}{2(d+2) f(x)^{1+2 / d}}\right\} \mathrm{B}_{k, n-k}(s) d s d x \\
& =\log (n-1)-\Psi(n)+H-\frac{V_{d}^{-2 / d} \Gamma(k+2 / d) \Gamma(n)}{2(d+2) \Gamma(k) \Gamma(n+2 / d)} \int_{\mathcal{X}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x
\end{aligned}
$$

Note that $\log (n-1)-\Psi(n)=-1 /(2 n)+o(1 / n)$, which leads to the given bias expression. The proof in other cases proceeds along similar lines. These heuristics make clear that the function $h_{x}^{-1}(\cdot)$ plays a key role in understanding the bias. This function is in general complicated, though some understanding can be gained from the following uniform density example, where it can be evaluated explicitly. This leads to an exact expression for the bias, even though the discontinuities mean that the density does not belong to $\mathcal{F}_{1, \theta}$ for any $\theta \in \Theta$.

Example 1. Consider the uniform distribution, $U[0,1]$. For $x \leq 1 / 2$, we have

$$
h_{x}^{-1}(s)= \begin{cases}s / 2, & \text { if } s \leq 2 x \\ s-x, & \text { if } 2 x<s \leq 1\end{cases}
$$

It therefore follows that

$$
\begin{aligned}
& \mathbb{E}\left(\hat{H}_{n}\right)-H=2 \int_{0}^{1 / 2} \int_{0}^{\infty} \log u d F_{n, x}(u) d x \\
& =2 \int_{0}^{1 / 2} \int_{0}^{1} \log \left(\frac{2(n-1) h_{x}^{-1}(s)}{e^{\Psi(k)}}\right) \mathrm{B}_{k, n-k}(s) d s d x \\
& =2 \int_{0}^{1} \mathrm{~B}_{k, n-k}(s)\left\{\int_{0}^{s / 2} \log (2(s-x)) d x+\int_{s / 2}^{1 / 2} \log s d x\right\} d s+\log \left(\frac{n-1}{e^{\Psi(k)}}\right) \\
& =\frac{k}{n}(\log 4-1)+\log (n-1)-\Psi(n) .
\end{aligned}
$$

3.2. Discussion of conditions and weakening of conditions. Recall the definitions of the quantity $M_{f, a, \beta}(x)$ and $\mathcal{A}$ from Section 2. In addition to standard moment and boundedness assumptions, the condition $f \in \mathcal{F}_{d, \theta}$ requires that

$$
\begin{equation*}
\sup _{x: f(x) \geq \delta} M_{f, a, \beta}(x) \leq a(\delta) \quad \text { for all } \delta>0 \text { and some } a \in \mathcal{A} . \tag{6}
\end{equation*}
$$

In this subsection, we explore the condition (6) further, with the aid of several examples.

The condition (6) is reminiscent of more standard Hölder smoothness assumptions, though we also require that the partial derivatives of the density vary less where $f$ is small. On the other hand, we also allow the neighbourhoods of $x$ in the definition of $M_{f, a, \beta}(x)$ to shrink where $f(x)$ is small. Roughly speaking, the condition requires that the partial derivatives of the density decay nearly as fast as the density itself in the tails of the distribution. As a simple stability property, if (6) holds for a density $f_{0}$, then it also holds for any density from the location-scale family:
$\left\{f_{\Sigma}(\cdot)=|\Sigma|^{-1 / 2} f_{0}\left(\Sigma^{-1 / 2}(\cdot-\mu)\right): \mu \in \mathbb{R}^{d}, \Sigma=\Sigma^{T} \in \mathbb{R}^{d \times d}\right.$ positive definite $\}$.
This observation allows us to consider canonical representatives of locationscale families in the examples below.

Proposition 5. For each of the following densities $f$, and for each $d \in \mathbb{N}$, there exists $\theta \in \Theta$ such that $f \in \mathcal{F}_{d, \theta}$ :
(i) $f(x)=f\left(x_{1}, \ldots, x_{d}\right)=(2 \pi)^{-d / 2} e^{-\|x\|^{2} / 2}$, the standard normal density;
(ii) $f(x)=f\left(x_{1}, \ldots, x_{d}\right) \propto\left(1+\|x\|^{2} / \rho\right)^{-\frac{d+\rho}{2}}$, the multivariate- $t$ distribution with $\rho>0$ degrees of freedom.
Moreover, the following univariate density $f$ also belongs to $\mathcal{F}_{1, \theta}$ for suitable $\theta \in \Theta$ :

$$
f(x) \propto \exp \left(-\frac{1}{1-x^{2}}\right) \mathbb{1}_{\{x \in(-1,1)\}} .
$$

The final part of Proposition 5 is included because it provides an example of a density $f$ that belongs to $\mathcal{F}_{1, \theta}$ for suitable $\theta \in \Theta$, even though there exist points $x_{0} \in \mathbb{R}$ with $f\left(x_{0}\right)=0$.

On the other hand, there are also examples, such as Example 2 below, where the behaviour of $f$ near a point $x_{0}$ with $f\left(x_{0}\right)=0$ precludes $f$ belonging to $\mathcal{F}_{d, \theta}$ for any $\theta \in \Theta$. To provide some guarantees in such settings, we now give a very general condition under which our approach to studying the bias can be applied.

Proposition 6. Assume that $f$ is bounded, that $\mu_{\alpha}(f)<\infty$ for some $\alpha>0$, and let $k^{*}$ be as in Lemma 3. Let $a_{n}:=3(k+1) \log (n-1)$, let $r_{x}:=\left\{\frac{2 a_{n}}{V_{d}(n-1) f(x)}\right\}^{1 / d}$, and assume further that there exists $\beta>0$ such that the function on $\mathcal{X}$ given by

$$
C_{n, \beta}(x):= \begin{cases}\sup _{y \in B_{x}^{\circ}\left(r_{x}\right)}|f(y)-f(x)| /\|y-x\|^{\beta} & \text { if } \beta \leq 1 \\ \left.\sup _{y \in B_{x}^{\circ}\left(r_{x}\right)}\right)\|\dot{f}(y)-\dot{f}(x)\| /\|y-x\|^{\beta-1} & \text { if } \beta>1\end{cases}
$$

is real-valued. Suppose that $\mathcal{X}_{n} \subseteq \mathcal{X}$ is such that

$$
\begin{equation*}
\sup _{x \in \mathcal{X}_{n}}\left(\frac{a_{n}}{n-1}\right)^{\tilde{\beta} / d} \frac{C_{n, \tilde{\beta}}(x)}{f(x)^{1+\tilde{\beta} / d}} \rightarrow 0 \tag{7}
\end{equation*}
$$

as $n \rightarrow \infty$, where $\tilde{\beta}:=\beta \wedge 2$. Then writing $q_{n}:=\int_{\mathcal{X}_{n}^{c}} f$, we have for every $\epsilon>0$ that

$$
\begin{equation*}
\mathbb{E}_{f}\left(\hat{H}_{n}\right)-H=O\left(\max \left\{\frac{k^{\tilde{\beta} / d}}{n^{\tilde{\beta} / d}} \int_{\mathcal{X}_{n}} \frac{C_{n, \tilde{\beta}}(x)}{f(x)^{\tilde{\beta} / d}} d x, q_{n}^{1-\epsilon}, q_{n} \log n, \frac{1}{n}\right\}\right) \tag{8}
\end{equation*}
$$

uniformly for $k \in\left\{1, \ldots, k^{*}\right\}$.
To aid interpretation of Proposition 6, we first remark that if $f \in \mathcal{F}_{d, \theta}$ for some $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta$, then (7) holds, with $\mathcal{X}_{n}:=\left\{x \in \mathcal{X}: f(x) \geq \delta_{n}\right\}$, where $\delta_{n}$ is defined in (12) below. On the other hand, if $f \notin \mathcal{F}_{d, \theta}$, we may still be able to obtain explicit bounds on the terms in (8) on a case-by-case basis, as in the following example.

Example 2. For $a>1$, consider $f(x)=\Gamma(a)^{-1} x^{a-1} e^{-x} \mathbb{1}_{\{x>0\}}$, the density of the $\Gamma(a, 1)$ distribution. Then for any $\tau \in(0,1)$ small enough, we may take

$$
\mathcal{X}_{n}=\left[\left(\frac{k}{n}\right)^{\frac{1}{a}-\tau},(1-\tau) \log \frac{n}{k}\right]
$$

to deduce from Proposition 6 that for every $\epsilon>0$,

$$
\mathbb{E}_{f}\left(\hat{H}_{n}\right)-H=o\left(\frac{k^{1-\epsilon}}{n^{1-\epsilon}}\right)
$$

uniformly for $k \in\left\{1, \ldots, k^{*}\right\}$.
Similar calculations show that the bias is of the same order for $\operatorname{Beta}(a, b)$ distributions with $a, b>1$.
3.3. Asymptotic variance and normality. We now study the asymptotic variance of Kozachenko-Leonenko estimators under the assumption that the tuning parameter $k$ is diverging with $n$; the fixed $k$ case is deferred to the next subsection.

Lemma 7. Let $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta$ with $\alpha>d$ and $\beta>0$. Let $k_{0}^{*}=k_{0, n}^{*}$ and $k_{1}^{*}=k_{1, n}^{*}$ denote any two deterministic sequences of positive integers with $k_{0}^{*} \leq k_{1}^{*}$, with $k_{0}^{*} / \log ^{5} n \rightarrow \infty$ and with $k_{1}^{*}=O\left(n^{\tau_{1}}\right)$, where $\tau_{1}$ satisfies the condition in Theorem 1. Then for any $w=w^{(k)} \in \mathcal{W}^{(k)}$ with $\sup _{k \geq k_{d}}\left\|w^{(k)}\right\|<\infty$, we have

$$
\sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}}\left|n \operatorname{Var}_{f} \hat{H}_{n}^{w}-V(f)\right| \rightarrow 0
$$

as $n \rightarrow \infty$.
The proof of this lemma is lengthy, and involves many delicate error bounds, so we outline the main ideas in the unweighted case here. First, we argue that

$$
\begin{aligned}
\operatorname{Var} \hat{H}_{n} & =n^{-1} \operatorname{Var} \log \xi_{1}+\left(1-n^{-1}\right) \operatorname{Cov}\left(\log \xi_{1}, \log \xi_{2}\right) \\
& =n^{-1} V(f)+\operatorname{Cov}\left(\log \left(\xi_{1} f\left(X_{1}\right)\right), \log \left(\xi_{2} f\left(X_{2}\right)\right)\right)+o\left(n^{-1}\right)
\end{aligned}
$$

where we hope to exploit the fact that $\xi_{1} f\left(X_{1}\right) \xrightarrow{p} 1$. The main difficulties in the argument are caused by the fact that handling the covariance above requires us to study the joint distribution of $\left(\xi_{1}, \xi_{2}\right)$, and this is complicated by the fact that $X_{2}$ may be one of the $k$ nearest neighbours of $X_{1}$ or vice
versa, and more generally, $X_{1}$ and $X_{2}$ may have some of their $k$ nearest neighbours in common. Dealing carefully with the different possible events requires us to consider separately the cases where $f\left(X_{1}\right)$ is small and large, as well as the proximity of $X_{2}$ to $X_{1}$. Finally, however, we can apply a normal approximation to the relevant multinomial distribution (which requires that $k \rightarrow \infty)$ to deduce the result. We remark that under stronger conditions on $k$, it should also be possible to derive the same conclusion about the asymptotic variance of $\hat{H}_{n}$ while only assuming similar conditions on the density to those required in Proposition 6, but we do not pursue this here.
3.4. Fixed $k$. A crucial step in the proof of Lemma 7 is the normal approximation to a certain multinomial distribution (cf. the bound on the term $W_{4}$ ). This normal approximation is only valid when $k \rightarrow \infty$ as $n \rightarrow \infty$. In this subsection, we present evidence to suggest that, when $k$ is fixed (i.e. not depending on $n$ ), then Kozachenko-Leonenko estimators are inefficient. For simplicity, we focus on the unweighted version of estimator.

Define the functions

$$
\alpha_{r}(s, t):=\frac{1}{V_{d}} \mu_{d}\left(B_{0}\left(s^{1 / d}\right) \cap B_{r^{1 / d} e_{1}}\left(t^{1 / d}\right)\right)
$$

where $e_{1}=(1,0, \ldots, 0)$ is the first element of the standard basis for $\mathbb{R}^{d}$ and $\mu_{d}$ denotes Lebesgue measure on $\mathbb{R}^{d}$. Also define the functions $T_{k}$ on $[0, \infty)^{3}$ by

$$
\begin{aligned}
& T_{k}(r, s, t):=e^{\alpha_{r}(s, t)} \sum_{\ell=0}^{L(r, s, t)} \sum_{i=0}^{I(r, s)-\ell J(r, t)-\ell} \sum_{j=0} \frac{\left\{s-\alpha_{r}(s, t)\right\}^{i}\left\{t-\alpha_{r}(s, t)\right\}^{j} \alpha_{r}^{\ell}(s, t)}{i!j!\ell!} \\
&-\sum_{i=0}^{I(r, s)} \sum_{j=0}^{J(r, t)} \frac{s^{i} t^{j}}{i!j!},
\end{aligned}
$$

where $L(r, s, t):=k-1-\mathbb{1}_{\{r<\max (s, t)\}}, I(r, s):=k-1-\mathbb{1}_{\{r<s\}}, J(r, t):=$ $k-1-\mathbb{1}_{\{r<t\}}$.

In the case $k=1$, this function appears in Delattre and Fournier (2017), where the authors show that, under certain regularity conditions,
$\lim _{n \rightarrow \infty} n \operatorname{Var} \hat{H}_{n}-V(f)=\Psi^{\prime}(1)+\int_{[0, \infty)^{3}} e^{-s-t} \frac{T_{1}(r, s, t)}{s t} d r d s d t-1+2 \log 2$.
More generally, Poisson approximation to the same multinomial distribution mentioned above, together with analysis similar to the proof of Lemma 7,

suggests that for (fixed) $k \geq 2$,

$$
\begin{align*}
& \lim _{n \rightarrow \infty} n \operatorname{Var} \hat{H}_{n}-V(f)=\Psi^{\prime}(k)+\int_{[0, \infty)^{3}} e^{-s-t} \frac{T_{k}(r, s, t)}{s t} d r d s d t-1 \\
& \quad+2^{-(2 k-2)}\binom{2 k-2}{k-1}\{\Psi(2 k-1)-\Psi(k)-\log 2\} \\
& \text { (9) }  \tag{9}\\
& \quad+\frac{1}{k-1} \sum_{j=0}^{k-2} 2^{-k-j}\binom{k+j-1}{j}[1-(k-j)\{\Psi(k+j)-\log 2-\Psi(k)\}] .
\end{align*}
$$

Here, the $\Psi^{\prime}(k)$ term arises as in (18), the integral term arises from the Poisson approximation, the -1 arises as in (27), and the remaining terms come from the fact that $X_{1}$ can be one of the $k$ nearest neighbours of $X_{2}$, or vice-versa, which induces a singular component into the joint distribution function $F_{n, x, y}$ of $\left(\xi_{1}, \xi_{2}\right)$ given $\left(X_{1}, X_{2}\right)=(x, y)$. It is interesting to observe that this asymptotic inflation of the variance is distribution-free; in Table 1, we tabulate numerical values for (9) for a few values of $d$ and $k$. These agree with those obtained by Delattre and Fournier (2017) for the case $k=1$.
4. Lower bounds. In this section, we address the optimality in a local asymptotic minimax sense of the limiting normalised risk $V(f)$ given in Theorem 1 using ideas of semiparametric efficiency (e.g. van der Vaart, 1998, Chapter 25). For $f \in \mathcal{F}_{d, \theta}, t \geq 0$ and a Borel measurable function $g: \mathbb{R}^{d} \rightarrow$ $\mathbb{R}$, define $f_{t, g}: \mathbb{R}^{d} \rightarrow[0, \infty)$ by

$$
\begin{equation*}
f_{t, g}(x):=\frac{2 c(t)}{1+e^{-2 t g(x)}} f(x), \tag{10}
\end{equation*}
$$

where $c(t):=\left(\int_{\mathbb{R}^{d}} \frac{2}{1+e^{-2 t g(x)}} f(x) d x\right)^{-1}$. This definition ensures that $\left\{f_{t, g}\right.$ : $t \geq 0\}$ is differentiable in quadratic mean at $t=0$ with score function $g$ (e.g. van der Vaart, 1998, Example 25.16). We say $\left(\tilde{H}_{n}\right)$ is an estimator sequence if $\tilde{H}_{n}:\left(\mathbb{R}^{d}\right)^{\times n} \rightarrow \mathbb{R}$ is a measurable function for each $n \in \mathbb{N}$.

Theorem 8. Fix $d \in \mathbb{N}, \theta=(\alpha, \beta, \gamma, \mu, a) \in \Theta$ and $f \in \mathcal{F}_{d, \theta}$. For $\lambda \in \mathbb{R}$, let $g_{\lambda}:=\lambda\{\log f+H(f)\}$. Then, writing $\mathcal{I}$ for the set of finite subsets of $\mathbb{R}$, we have for any estimator sequence $\left(\tilde{H}_{n}\right)$ that

$$
\begin{equation*}
\sup _{I \in \mathcal{I}} \liminf _{n \rightarrow \infty} \max _{\lambda \in I} n \mathbb{E}_{f_{n^{-1 / 2}, g_{\lambda}}}\left[\left\{\tilde{H}_{n}-H\left(f_{n^{-1 / 2}, g_{\lambda}}\right)\right\}^{2}\right] \geq V(f) . \tag{11}
\end{equation*}
$$

Moreover, whenever $t|\lambda| \leq \min \left(1,\{144 V(f)\}^{-1 / 2}\right)$, we have $f_{t, g_{\lambda}} \in \mathcal{F}_{d, \tilde{\theta}}$, where $\tilde{\theta}:=(\alpha, \beta, 4 \gamma, 4 \mu, \tilde{a}) \in \Theta$, and $\tilde{a} \in \mathcal{A}$ is defined in (90) in the online supplement.

The proof of Theorem 8 reveals that, at every $f \in \mathcal{F}_{d, \theta}$, the entropy functional $H$ is differentiable relative to the tangent set $\left\{g_{\lambda}: \lambda \in \mathbb{R}\right\}$ with efficient influence function

$$
\tilde{\psi}_{f}:=-\log f-H(f)
$$

This observation, together with Theorem 1, confirms that under the assumptions on $\theta, w$ and $k$ in that result, the weighted Kozachenko-Leonenko estimator $\hat{H}_{n}^{w}$ is (asymptotically) efficient at $f \in \mathcal{F}_{d, \theta}$ in the sense that

$$
n^{1 / 2}\left\{\hat{H}_{n}^{w}-H(f)\right\}=\frac{1}{n^{1 / 2}} \sum_{i=1}^{n} \tilde{\psi}_{f}\left(X_{i}\right)+o_{p}(1)
$$

(cf. van der Vaart, 1998, p. 367). Moreover, the second part of Theorem 8 and Theorem 1 imply in particular that, under these same conditions on $\theta, w$ and $k$, the estimator $\hat{H}_{n}^{w}$ attains the local asymptotic minimax lower bound, in the sense that

$$
\sup _{I \in \mathcal{I}} \lim _{n \rightarrow \infty} \max _{\lambda \in I} n \mathbb{E}_{f_{n^{-1 / 2}, g_{\lambda}}}\left[\left\{\hat{H}_{n}^{w}-H\left(f_{n^{-1 / 2}, g_{\lambda}}\right)\right\}^{2}\right]=V(f)
$$

## 5. Proofs of main results.

5.1. Auxiliary results and proofs of Lemma 3 and Corollary 4. Throughout the proofs, we write $a \lesssim b$ to mean that there exists $C>0$, depending only on $d \in \mathbb{N}$ and $\theta \in \Theta$, such that $a \leq C b$. The proof of Lemma 3 relies on the following two auxiliary results, whose proofs are given in Appendix A.4.

Proposition 9. Let $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta, d \in \mathbb{N}$ and $\tau \in\left(\frac{d}{\alpha+d}, 1\right]$. Then

$$
\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\{x: f(x)<\delta\}} a(f(x)) f(x)^{\tau} d x \rightarrow 0
$$

as $\delta \searrow 0$. Moreover, for every $\rho>0$,

$$
\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}} a(f(x))^{\rho} f(x)^{\tau}<\infty .
$$

Recall the definition of $h_{x}^{-1}(\cdot)$ in (5). The first part of Lemma 10 below provides crude but general bounds; the second gives much sharper bounds in a more restricted region.

Lemma 10. (i) Let $f \in \mathcal{F}_{d}$ and let $\alpha>0$. Then for every $s \in(0,1)$ and $x \in \mathbb{R}^{d}$,

$$
\left(\frac{s}{V_{d}\|f\|_{\infty}}\right)^{1 / d} \leq h_{x}^{-1}(s) \leq\|x\|+\left(\frac{\mu_{\alpha}(f)}{1-s}\right)^{1 / \alpha} .
$$

(ii) Fix $\theta=(\alpha, \beta, \gamma, \nu, a) \in \Theta$, and let $\mathcal{S}_{n} \subseteq(0,1), \mathcal{X}_{n} \subseteq \mathbb{R}^{d}$ be such that

$$
C_{n}:=\sup _{f \in \mathcal{F}_{d, \theta}} \sup _{s \in \mathcal{S}_{n}} \sup _{x \in \mathcal{X}_{n}} \frac{a(f(x))^{d /(1 \wedge \beta)} s}{f(x)} \rightarrow 0 .
$$

Then there exists $n_{*}=n_{*}(d, \theta) \in \mathbb{N}$ such that for all $n \geq n_{*}, s \in \mathcal{S}_{n}$, $x \in \mathcal{X}_{n}$ and $f \in \mathcal{F}_{d, \theta}$, we have

$$
\left|V_{d} f(x) h_{x}^{-1}(s)^{d}-\sum_{l=0}^{\lceil\beta / 2\rceil-1} b_{l}(x) s^{1+2 l / d}\right| \lesssim s\left\{\frac{a(f(x))^{d /(2 \wedge \beta)} s}{f(x)}\right\}^{\beta / d},
$$

where $b_{0}(x)=1$ and $\left|b_{l}(x)\right| \lesssim a(f(x))^{l} f(x)^{-2 l / d}$ for $l \geq 1$. Moreover, if $\beta>2$, then

$$
b_{1}(x)=-\frac{\Delta f(x)}{2(d+2) V_{d}^{2 / d} f(x)^{1+2 / d}} .
$$

We are now in a position to prove Lemma 3 .
Proof of Lemma 3. (i) We initially prove the result in the case $d \geq 3$, $\alpha>2 d /(d-2)$ and $\beta \in(2,4]$, where it suffices to show that

$$
\begin{array}{r}
\sup _{f \in \mathcal{F}_{d, \theta}}\left|\mathbb{E}_{f}\left(\hat{H}_{n}\right)-H+\frac{\Gamma(k+2 / d) \Gamma(n)}{2(d+2) V_{d}^{2 / d} \Gamma(k) \Gamma(n+2 / d)} \int_{\mathcal{X}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x\right| \\
=O\left(\max \left\{\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}, \frac{k^{\frac{\beta}{d}}}{n^{\frac{\beta}{d}}}\right\}\right)
\end{array}
$$

as $n \rightarrow \infty$, uniformly for $k \in\left\{1, \ldots, k^{*}\right\}$. Fix $f \in \mathcal{F}_{d, \theta}$. Define $c_{n}:=a(k /(n-$ 1) $)^{1 /(1 \wedge \beta)}$, let

$$
\begin{equation*}
\delta_{n}:=k c_{n}^{d} \log ^{2}(n-1) /(n-1) \tag{12}
\end{equation*}
$$

and let $\mathcal{X}_{n}:=\left\{x: f(x) \geq \delta_{n}\right\}$. Recall that $a_{n}:=3(k+1) \log (n-1)$ and let

$$
u_{x, s}:=\frac{V_{d}(n-1) h_{x}^{-1}(s)^{d}}{e^{\Psi(k)}}
$$

The proof is based on (4) and Lemma 10(ii), which allow us to make the transformation $s=p_{n, x, u}=h_{x}\left(r_{n, u}\right)$. Writing $R_{i}, i=1, \ldots, 5$ for remainder terms to be bounded at the end of the proof, we can write

$$
\begin{aligned}
& \mathbb{E}\left(\hat{H}_{n}\right)=\int_{\mathcal{X}} f(x) \int_{0}^{\infty} \log u d F_{n, x}(u) d x \\
& =\int_{\mathcal{X}_{n}} f(x) \int_{0}^{1} \mathrm{~B}_{k, n-k}(s) \log u_{x, s} d s d x+R_{1} \\
& =\int_{\mathcal{X}_{n}} f(x) \int_{0}^{\frac{a_{n}}{n-1}} \mathrm{~B}_{k, n-k}(s) \log u_{x, s} d s d x+R_{1}+R_{2} \\
& =\int_{\mathcal{X}_{n}} f(x) \int_{0}^{\frac{a_{n}}{n-1}}\left\{\log \left(\frac{(n-1) s}{e^{\Psi(k)} f(x)}\right)\right. \\
& \left.\quad-\frac{V_{d}^{-2 / d} s^{2 / d} \Delta f(x)}{2(d+2) f(x)^{1+2 / d}}\right\} \mathrm{B}_{k, n-k}(s) d s d x+\sum_{i=1}^{3} R_{i}
\end{aligned} \quad \begin{array}{r}
=\int_{\mathcal{X}_{n}} f(x)\left\{\log \left(\frac{n-1}{f(x)}\right)-\Psi(n)-\frac{V_{d}^{-2 / d} \mathrm{~B}_{k+2 / d, n-k} \Delta f(x)}{\left.2(d+2) \mathrm{B}_{k, n-k} f(x)^{1+2 / d}\right\} d x+\sum_{i=1}^{4} R_{i}}\right. \\
=H+\log (n-1)-\Psi(n)-\frac{V_{d}^{-2 / d} \Gamma(k+2 / d) \Gamma(n)}{2(d+2) \Gamma(k) \Gamma(n+2 / d)} \int_{\mathcal{X}_{n}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x+\sum_{i=1}^{5} R_{i} .
\end{array}
$$

After multiplying the integrand by an appropriate positive power of $\delta_{n} / f(x)$, the first part of Proposition 9 tells us that for every $\epsilon>0$,

$$
\sup _{k \in\left\{1, \ldots, k^{*}\right\}} \frac{k^{2 / d}}{n^{2 / d}} \sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}_{n}^{c}} \frac{\Delta f(x)}{f(x)^{2 / d}} d x=O\left(\frac{k^{\frac{\alpha}{\alpha+-}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}\right)
$$

as $n \rightarrow \infty$. Since $\log (n-1)-\Psi(n)=O(1 / n)$, it now remains to bound $R_{1}, \ldots, R_{5}$. Henceforth, to save repetition, we adopt without further mention the convention that whenever an error term inside $O(\cdot)$ or $o(\cdot)$ depends on $k$, this error is uniform for $k \in\left\{1, \ldots, k^{*}\right\}$; thus $g(n, k)=h(n, k)+o(1)$ as $n \rightarrow \infty$ means $\sup _{k \in\left\{1, \ldots, k^{*}\right\}}|g(n, k)-h(n, k)| \rightarrow 0$ as $n \rightarrow \infty$.

To bound $R_{1}$. By Lemma 10(i), we have $V_{d}^{\alpha} \mu_{\alpha}(f)^{d}\|f\|_{\infty}^{\alpha} \geq \alpha^{\alpha} d^{d} /(\alpha+$ $d)^{\alpha+d}$. Hence

$$
\begin{align*}
& \begin{array}{r}
\left|\log u_{x, s}\right| \leq \log (n-1)+|\Psi(k)|-\log s+\left|\log \|f\|_{\infty}\right|+\left|\log V_{d}\right| \\
\quad+\frac{d}{\alpha}\left|\log \mu_{\alpha}(f)\right|-\frac{d}{\alpha} \log (1-s)+d \log \left(1+\frac{\|x\|}{\mu_{\alpha}^{1 / \alpha}(f)}\right)
\end{array} \\
& \leq \log (n-1)+|\Psi(k)|-\log s+\max \left\{\log \gamma, \frac{1}{\alpha} \log \left(\frac{V_{d}^{\alpha} \nu^{d}(\alpha+d)^{\alpha+d}}{\alpha^{\alpha} d^{d}}\right)\right\} \\
& +\left|\log V_{d}\right|+\frac{d}{\alpha} \max \left\{\log \nu, \frac{1}{d} \log \left(\frac{V_{d}^{\alpha} \gamma^{\alpha}(\alpha+d)^{\alpha+d}}{\alpha^{\alpha} d^{d}}\right)\right\}-\frac{d}{\alpha} \log (1-s) \\
& (13) \\
& +d \log \left(1+\frac{\|x\|(\alpha+d)^{\frac{1}{\alpha}+\frac{1}{d} V_{d}^{1 / d} \gamma^{1 / d}}}{\alpha^{1 / d} d^{1 / \alpha}}\right) . \tag{13}
\end{align*}
$$

Moreover, for any $C_{0}, C_{1} \geq 0, \epsilon \in(0, \alpha)$ and $\epsilon^{\prime} \in(0, \epsilon)$, we have by Hölder's inequality that

$$
\begin{aligned}
\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}_{n}^{c}} f(x) & \left\{C_{0}+\log \left(1+C_{1}\|x\|\right)\right\} d x \\
& \leq \delta_{n}^{\frac{\alpha-\epsilon^{\prime}}{\alpha+d}} \sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}} f(x)^{\frac{d+\epsilon^{\prime}}{\alpha+d}}\left\{C_{0}+\log \left(1+C_{1}\|x\|\right)\right\} d x \\
& \leq \delta_{n}^{\frac{\alpha-\epsilon^{\prime}}{\alpha+d}}(1+\nu)^{\frac{d+\epsilon^{\prime}}{\alpha+d}}\left[\int_{\mathbb{R}^{d}} \frac{\left\{C_{0}+\log \left(1+C_{1}\|x\|\right)\right\}^{\frac{\alpha+d}{\alpha-\epsilon^{\prime}}}}{\left(1+\|x\|^{\alpha}\right)^{\frac{d+\epsilon^{\prime}}{\alpha-\epsilon}}} d x\right]^{\frac{\alpha-\epsilon^{\prime}}{\alpha+d}} \\
& =o\left(\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}\right) .
\end{aligned}
$$

Since $|\mathbb{E}(\log \mathrm{B})|=\Psi(a+b)-\Psi(a)$ when $\mathrm{B} \sim \operatorname{Beta}(a, b)$, we deduce that for each $\epsilon>0$,

$$
R_{1}=\int_{\mathcal{X}_{n}^{c}} f(x) \int_{0}^{1} \mathrm{~B}_{k, n-k}(s) \log u_{x, s} d s d x=o\left(\frac{k^{\frac{\alpha}{\alpha+\alpha}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}\right)
$$

as $n \rightarrow \infty$, uniformly for $f \in \mathcal{F}_{d, \theta}$.
To bound $R_{2}$. For random variables $\mathrm{B}_{1} \sim \operatorname{Beta}(k, n-k)$ and $B_{2} \sim \operatorname{Bin}(n-$ $\left.1, a_{n} /(n-1)\right)$ we have that for every $\epsilon>0$,
$\mathbb{P}\left(\mathrm{B}_{1} \geq a_{n} /(n-1)\right)=\mathbb{P}\left(B_{2} \leq k-1\right) \leq \exp \left(-\frac{\left(a_{n}-k+1\right)^{2}}{2 a_{n}}\right)=o\left(n^{-(3-\epsilon)}\right)$,
where the inequality follows from standard bounds on the left-hand tail of the binomial distribution (see, e.g. Shorack and Wellner (2009), Equation (6), page 440). Now, for any $C_{1}>0$, we have $\alpha \log \left(1+C_{1}\|x\|\right) \leq$ $\left(1+C_{1}\|x\|\right)^{\alpha}-1$, so that $\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}} f(x) \log \left(1+C_{1}\|x\|\right) d x<\infty$. Moreover,

$$
-\int_{\frac{a_{n}}{n-1}}^{1} \log (1-s) \mathrm{B}_{k, n-k}(s) d s \leq \frac{n-1}{n-k-1} \int_{\frac{n_{n}}{n-1}}^{1} \mathrm{~B}_{k, n-k-1}(s) d s=o\left(n^{-(3-\epsilon)}\right),
$$

for every $\epsilon>0$, by a virtually identical argument to (14). We therefore deduce from these facts and (13) that for each $\epsilon>0$,

R_{2}=\int_{\mathcal{X}_{n}} f(x) \int_{\frac{a_{n}}{n-1}}^{1} \mathrm{~B}_{k, n-k}(s) \log u_{x, s} d s d x=o\left(n^{-(3-\epsilon)}\right) \tag{15}
\end{equation*}
$$

which again holds uniformly in $f \in \mathcal{F}_{d, \theta}$.
To bound $R_{3}$. We can write

$$
\begin{aligned}
R_{3}= & \int_{\mathcal{X}_{n}^{\prime}} f(x) \int_{0}^{\frac{a_{n}}{n-1}}\left[\left\{\log \left(\frac{V_{d} f(x) h_{x}^{-1}(s)^{d}}{s}\right)-\frac{V_{d} f(x) h_{x}^{-1}(s)^{d}-s}{s}\right\}\right. \\
& +\left\{\frac{V_{d} f(x) h_{x}^{-1}(s)^{d}-s}{s}+\frac{V_{d}^{-2 / d} s^{2 / d} \Delta f(x)}{\left.2(d+2) f(x)^{1+2 / d}\right\}}\right] \mathrm{B}_{k, n-k}(s) d s d x \\
= & R_{31}+R_{32},
\end{aligned}
$$

say. Now, note that

$$
\sup _{k \in\left\{1, \ldots, k^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}} \sup _{s \in\left(0, a_{n} /(n-1)\right]} \sup _{x \in \mathcal{X}_{n}} \frac{a(f(x))^{d} s}{f(x)} \leq \frac{6}{\log (n-1)} \rightarrow 0 .
$$

It follows by Lemma 10(ii) that there exist a constant $C=C(d, \theta)>0$ and $n_{1}=n_{1}(d, \theta) \in \mathbb{N}$ such that for $n \geq n_{1}, k \in\left\{1, \ldots, k^{*}\right\}, s \leq a_{n} /(n-1)$ and $x \in \mathcal{X}_{n}$,

$$
\left|\frac{V_{d} f(x) h_{x}^{-1}(s)^{d}-s}{s}+\frac{s^{2 / d} \Delta f(x)}{2(d+2) V_{d}^{2 / d} f(x)^{1+2 / d}}\right| \leq C\left\{\frac{s a(f(x))^{d / 2}}{f(x)}\right\}^{\beta / d}
$$

and

$$
\left|\frac{V_{d} f(x) h_{x}^{-1}(s)^{d}-s}{s}\right| \leq \frac{d^{1 / 2} V_{d}^{-2 / d} s^{2 / d} a(f(x))}{2(d+2) f(x)^{2 / d}}+C\left\{\frac{s a(f(x))^{d / 2}}{f(x)}\right\}^{\beta / d} \leq \frac{1}{2} .
$$

Thus, for $n \geq n_{1}$ and $k \in\left\{1, \ldots, k^{*}\right\}$, using the fact that $|\log (1+z)-z| \leq z^{2}$ for $|z| \leq 1 / 2$,

$$
\begin{aligned}
&\left|R_{31}\right| \leq 2 \int_{\mathcal{X}_{n}} f(x) \int_{0}^{1}\left[\left\{\frac{d V_{d}^{-4 / d} s^{4 / d} a(f(x))^{2}}{4(d+2)^{2} f(x)^{4 / d}}\right.\right. \\
&\left.\quad+C^{2}\left\{\frac{s a(f(x))^{d / 2}}{f(x)}\right\}^{2 \beta / d}\right] \mathrm{B}_{k, n-k}(s) d s d x \\
& \leq \frac{d V_{d}^{-4 / d} \Gamma(k+4 / d) \Gamma(n)}{2(d+2)^{2} \Gamma(k) \Gamma(n+4 / d)} \int_{\mathcal{X}_{n}} a(f(x))^{2} f(x)^{1-4 / d} d x \\
& \quad+\frac{2 C^{2} \Gamma(k+2 \beta / d) \Gamma(n)}{\Gamma(k) \Gamma(n+2 \beta / d)} \int_{\mathcal{X}_{n}} a(f(x))^{\beta} f(x)^{1-2 \beta / d} d x .
\end{aligned}
$$

On the other hand, we also have for $n \geq n_{1}$ and $k \in\left\{1, \ldots, k^{*}\right\}$ that

$$
\begin{aligned}
\left|R_{32}\right| & \leq C \int_{\mathcal{X}_{n}} f(x) \int_{0}^{1}\left\{\frac{s a(f(x))^{d / 2}}{f(x)}\right\}^{\beta / d} \mathrm{~B}_{k, n-k}(s) d s d x \\
& \leq \frac{C \Gamma(k+\beta / d) \Gamma(n)}{\Gamma(k) \Gamma(n+\beta / d)} \int_{\mathcal{X}_{n}} a(f(x))^{\beta / 2} f(x)^{1-\beta / d} d x
\end{aligned}
$$

Multiplying each of the integrals by $f(x) / \delta_{n}$ to an appropriate positive power if necessary and by the second part of Proposition 9 , for every $\epsilon>0$,

$$
\max \left(\left|R_{31}\right|,\left|R_{32}\right|\right)=O\left(\max \left\{\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}, \frac{k^{\frac{\beta}{d}}}{n^{\frac{\beta}{d}}}\right\}\right)
$$

uniformly for $f \in \mathcal{F}_{d, \theta}$.
To bound $R_{4}$. We have

$$
R_{4}=\int_{\mathcal{X}_{n}} f(x) \int_{\frac{a_{n}}{n-1}}^{1}\left\{\log \left(\frac{(n-1) s}{e^{\Psi(k)} f(x)}\right)-\frac{V_{d}^{-2 / d} s^{2 / d} \Delta f(x)}{2(d+2) f(x)^{1+2 / d}}\right\} \mathrm{B}_{k, n-k}(s) d s d x .
$$

Consider the random variable $\mathrm{B}_{1} \sim \operatorname{Beta}(k, n-k)$. Then, using (14) and the fact that $(n-1) s / e^{\Psi(k)} \geq 1$ for $s \geq a_{n} /(n-1)$ and $n \geq 3$, we conclude that for every $\epsilon>0$ and $n \geq 3$,

$$
\begin{aligned}

& =o\left(n^{-(3-\epsilon)}\right),
\end{aligned}
$$

uniformly for $f \in \mathcal{F}_{d, \theta}$, where, by Lemma 11(i) in the online supplement, we have $\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}_{n}} f(x)|\log f(x)| d x<\infty$.

To bound $R_{5}$. We use the fact that for $f \in \mathcal{F}_{d, \theta}, x \in \mathcal{X}$ and $\epsilon^{\prime}>0$,

5.2. Proof of Lemma 7. Since this proof is long, we focus here on the main argument, and defer proofs of bounds on the many error terms to Appendix A.8.

Proof of Lemma 7. We employ the same notation as in the proof of Lemma 3, except that we redefine $\delta_{n}$ so that $\delta_{n}:=k c_{n}^{d} \log ^{3}(n-1) /(n-1)$.

We write $\mathcal{X}_{n}:=\left\{x: f(x) \geq \delta_{n}\right\}$ for this newly-defined $\delta_{n}$. Similar to the proof of Lemma 3, all error terms inside $O(\cdot)$ and $o(\cdot)$ that depend on $k$ are uniform for $k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}$, and we now adopt the additional convention that, where relevant, these error terms are also uniform for $f \in \mathcal{F}_{d, \theta}$. By the nested properties of the classes $\mathcal{F}_{d, \theta}$ with respect to the smoothness parameter $\beta$, we may assume without loss of generality that $\beta \in(0,1]$. We first deal with the variance of the unweighted estimator $\hat{H}_{n}$, and note that

& =\frac{e^{\Psi(k)}}{k(n-1)}-\frac{1}{n}+\sum_{i=1}^{4} W_{i}=O\left(\frac{1}{n k}\right)+\sum_{i=1}^{4} W_{i} .
\end{align*}
$$

The proof in the unweighted case is completed by showing in Appendix A.8.4 that for every $\epsilon>0$,

$$
\begin{aligned}
& \sum_{i=1}^{4}\left|W_{i}\right| \\
& \quad=O\left(\max \left\{\frac{\log ^{\frac{5}{2}} n}{n k^{\frac{1}{2}}}, \frac{k^{\frac{3}{2}+\frac{\alpha-\epsilon}{\alpha+d}}}{n^{1+\frac{\alpha-\epsilon}{\alpha+d}}}, \frac{k^{\frac{3}{2}+\frac{2 \beta}{d}}}{n^{1+\frac{2 \beta}{d}}}, \frac{k^{\left(1+\frac{d}{2 \beta}\right) \frac{\alpha-\epsilon}{\alpha+d}}}{n^{1+\frac{\alpha-\epsilon}{\alpha+d}}}, \frac{k^{\frac{1}{2}+\frac{\beta}{d}} \log n}{n^{1+\frac{\beta}{d}}}, \frac{k^{\frac{2 \alpha-\epsilon}{\alpha+d}}}{n^{\frac{2 \alpha-\epsilon}{\alpha+d}}}\right\}\right)
\end{aligned}
$$

as $n \rightarrow \infty$.
The proof in the weighted case uses similar arguments; details are deferred to Appendix A.8.4.

### 5.3. Proofs of Theorems 1 and 2.

Proof of Theorem 1. Writing $j_{t}:=\lfloor t k / d\rfloor$ for $t=1, \ldots, d$ and $d^{\prime}:=$ $\lfloor d / 4\rfloor+1$ for convenience, a sufficient condition for $\mathcal{W}^{(k)} \neq \emptyset$ is that the matrix $A^{(k)} \in \mathbb{R}^{d^{\prime} \times d^{\prime}}$ with $(l, t)^{\text {th }}$ entry

$$
A_{l t}^{(k)}=\Gamma\left(j_{t}\right)^{-1} \Gamma\left(j_{t}+2(l-1) / d\right) k^{-2(l-1) / d}
$$

is invertible. This follows because, writing $e_{1}:=(1,0, \ldots, 0)^{T} \in \mathbb{R}^{d^{\prime}}$ we can then define $w=w^{(k)} \in \mathcal{W}^{(k)}$ by setting

$$
\left(w_{j_{t}}\right)_{t=1}^{\lfloor d / 4\rfloor+1}:=\left(A^{(k)}\right)^{-1} e_{1}
$$

and setting all other entries of $w$ to be zero. Now define $A \in \mathbb{R}^{d^{\prime} \times d^{\prime}}$ to have $(l, t)^{t h}$ entry $A_{l t}:=(t / d)^{2(l-1) / d}$. Since $x^{-a} \Gamma(x)^{-1} \Gamma(x+a) \rightarrow 1$ as $x \rightarrow \infty$ for $a \in \mathbb{R}$, we have $\left\|A^{(k)}-A\right\| \rightarrow 0$ as $k \rightarrow \infty$. Now, $A$ is a Vandermonde matrix (depending only on $d$ ) and as such has determinant

$$
|A|=\prod_{1 \leq t_{1}<t_{2} \leq d^{\prime}} d^{-2 / d}\left(t_{2}^{2 / d}-t_{1}^{2 / d}\right)>0
$$

Hence, by the continuity of the determinant and eigenvalues of a matrix, we have that there exists $k_{d}>0$ such that, for $k \geq k_{d}$, the matrix $A^{(k)}$ is invertible and

$$
\left\|\left(A^{(k)}\right)^{-1} e_{1}\right\| \leq\left|\lambda_{\min }\left(A^{(k)}\right)\right|^{-1} \leq 2\left|\lambda_{\min }(A)\right|^{-1}
$$

where $\lambda_{\min }(\cdot)$ denotes the eigenvalue of a matrix with smallest absolute value. It follows that, for each $k \geq k_{d}$, there exists $w^{(k)} \in \mathcal{W}^{(k)}$ satisfying $\sup _{k \geq k_{d}}\left\|w^{(k)}\right\|<\infty$, as required.

Now, by Corollary 4 and the fact that $w \in \mathcal{W}^{(k)}$, we have for $\epsilon>0$ sufficiently small,

$$
\mathbb{E}_{f}\left(\hat{H}_{n}^{w}\right)-H(f)=O\left(\max \left\{\frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}, \frac{k^{\frac{2 d^{\prime}}{d}}}{n^{\frac{2 d^{\prime}}{d}}}, \frac{k^{\frac{\beta}{d}}}{n^{\frac{\beta}{d}}}\right\}\right)=o\left(n^{-1 / 2}\right)
$$

uniformly for $f \in \mathcal{F}_{d, \theta}$, under our conditions on $k_{1}^{*}, \alpha$ and $\beta$. By Lemma 7 we have $\operatorname{Var} \hat{H}_{n}^{w}=n^{-1} V(f)+o\left(n^{-1}\right)$ uniformly for $f \in \mathcal{F}_{d, \theta}$. Note that by Cauchy-Schwarz, very similar arguments to those used at (18) and Lemma 11 in the supplement we have that, for $j \in \operatorname{supp}(w)$,

$$
\left|\operatorname{Cov}_{f}\left(\log \left(\xi_{(j), 1} f\left(X_{1}\right)\right), \log f\left(X_{1}\right)\right)\right| \leq\left\{V(f) \mathbb{E}_{f}\left[\log ^{2}\left(\xi_{(j), 1} f\left(X_{1}\right)\right)\right]\right\}^{1 / 2} \rightarrow 0
$$

uniformly for $f \in \mathcal{F}_{d, \theta}$. Therefore, also using (20), we have that

$$
\begin{aligned}
& \operatorname{Var}_{f}\left(\hat{H}_{n}^{w}-H_{n}^{*}\right)=\operatorname{Var}_{f} \hat{H}_{n}^{w}+2 \operatorname{Cov}_{f}\left(\hat{H}_{n}^{w}, \log f\left(X_{1}\right)\right)+n^{-1} V(f) \\
& =\operatorname{Var}_{f} \hat{H}_{n}^{w}-n^{-1} V(f)+\frac{2}{n} \sum_{j=1}^{k} w_{j} \operatorname{Cov}_{f}\left(\log \left(\xi_{(j), 1} f\left(X_{1}\right)\right), \log f\left(X_{1}\right)\right) \\
& \\
& \quad+2\left(1-n^{-1}\right) \sum_{j=1}^{k} w_{j} \operatorname{Cov}\left(\log \left(\xi_{(j), 2} f\left(X_{2}\right)\right), \log f\left(X_{1}\right)\right)=o\left(n^{-1}\right)
\end{aligned}
$$

as $n \rightarrow \infty$, uniformly for $f \in \mathcal{F}_{d, \theta}$. The conclusion (3) follows on writing

$$
\mathbb{E}_{f}\left\{\left(\hat{H}_{n}^{w}-H_{n}^{*}\right)^{2}\right\}=\operatorname{Var}_{f}\left(\hat{H}_{n}^{w}-H_{n}^{*}\right)+\left(\mathbb{E}_{f} \hat{H}_{n}^{w}-H(f)\right)^{2}
$$

and the final conclusion is then immediate.

Proof of Theorem 2. We have

$$
\begin{align*}
d_{\mathrm{BL}}\left(\mathcal { L } \left(n^{1 / 2}\right.\right. & \left.\left.\left.\left\{\hat{H}_{n}^{w}-H(f)\right\}\right), \mathcal{L}\left(n^{1 / 2}\left\{H_{n}^{*}-H(f)\right\}\right)\right)\right) \\
& \leq \sup _{h \in \mathcal{H}} \mathbb{E}_{f}\left|h\left(n^{1 / 2}\left\{\hat{H}_{n}^{w}-H(f)\right\}\right)-h\left(n^{1 / 2}\left\{H_{n}^{*}-H(f)\right\}\right)\right| \\
& \leq n^{1 / 2} \mathbb{E}_{f}\left|\hat{H}_{n}^{w}-H_{n}^{*}\right| \leq n^{1 / 2}\left[\mathbb{E}_{f}\left\{\left(\hat{H}_{n}^{w}-H_{n}^{*}\right)^{2}\right\}\right]^{1 / 2} \tag{28}
\end{align*}
$$

Now write $\mathcal{H}^{*}$ for the class of functions $h: \mathbb{R} \rightarrow \mathbb{R}$ having Lipschitz constant at most 1 , and let $Z \sim N(0, V(f))$. Then by standard properties of the Wasserstein distance (e.g. Gibbs and $\mathrm{Su}, 2002$, p. 424) and the non-uniform
version of the Berry-Esseen theorem (e.g. Paditz, 1989, Theorem 1),

$$
\begin{aligned}
d_{\mathrm{BL}}( & \left.\left.\mathcal{L}\left(n^{1 / 2}\left\{H_{n}^{*}-H(f)\right\}\right)\right), N(0, V(f))\right) \\
& \leq \sup _{h \in \mathcal{H}^{*}}\left|\mathbb{E}_{f} h\left(n^{1 / 2}\left\{H_{n}^{*}-H(f)\right\}\right)-\mathbb{E} h(Z)\right| \\
& =\int_{-\infty}^{\infty}\left|\mathbb{P}_{f}\left(n^{1 / 2}\left\{H_{n}^{*}-H(f)\right\} \leq x\right)-\mathbb{P}(Z \leq x)\right| d x \leq \frac{78 \beta_{3}(f)}{n^{1 / 2} V(f)},
\end{aligned}
$$

where

$$
\beta_{3}(f):=\mathbb{E}_{f}\left\{\left|\log f\left(X_{1}\right)+H(f)\right|^{3}\right\}=\int_{\mathcal{X}} f(x)|\log f(x)+H(f)|^{3} d x
$$

We conclude from (28) and (29), together with Theorem 1 and Lemma 11 in the online supplement, that

$$
\sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}} d_{\mathrm{BL}}\left(\mathcal{L}\left(n^{1 / 2}\left(\hat{H}_{n}^{w}-H(f)\right)\right), N(0, V(f))\right) \rightarrow 0
$$

as $n \rightarrow \infty$, as required.
For the second part of the theorem, set

$$
\epsilon_{n}=\epsilon_{n}^{w}(d, \theta):=\frac{\sup _{k \in\left\{1, \ldots, k^{*}\right\}} \sup _{f \in \mathcal{F}_{d, \theta}}\left(2 \mathbb{E}_{f}\left[\left\{\tilde{V}_{n}^{w}-V(f)\right\}^{2}\right]\right)^{1 / 3}}{\inf _{f \in \mathcal{F}_{d, \theta}} V(f)^{2 / 3}}
$$

so that $\epsilon_{n} \rightarrow 0$, by Lemmas 11(ii) and 13 in the online supplement. Then, by two applications of Markov's inequality, for $n$ large enough that $\epsilon_{n} \leq 1$,

$$
\begin{aligned}
\mathbb{P}_{f}\left(\left|\frac{\left(\hat{V}_{n}^{w}\right)^{1 / 2}}{V^{1 / 2}(f)}-1\right| \geq \epsilon_{n}\right) & \leq \mathbb{P}_{f}\left(\left|\frac{\tilde{V}_{n}^{w}}{V(f)}-1\right| \geq \epsilon_{n}\right)+\mathbb{P}_{f}\left(\tilde{V}_{n}^{w} \leq 0\right) \\
& \leq \frac{\mathbb{E}_{f}\left[\left\{\tilde{V}_{n}^{w}-V(f)\right\}^{2}\right]}{V(f)^{2}}\left(\frac{1}{\epsilon_{n}^{2}}+1\right) \leq \epsilon_{n}
\end{aligned}
$$

For $n \in \mathbb{N}$ and $L \geq 1$, define $h_{n, L}: \mathbb{R} \rightarrow[0,1]$ by
$h_{n, L}(x):= \begin{cases}0 & \text { if }|x|>z_{q / 2}\left(1+\epsilon_{n}\right)+1 / L \\ L\left\{z_{q / 2}\left(1+\epsilon_{n}\right)+1 / L-|x|\right\} & \text { if } 0<|x|-z_{q / 2}\left(1+\epsilon_{n}\right) \leq 1 / L \\ 1 & \text { if }|x| \leq z_{q / 2}\left(1+\epsilon_{n}\right) .\end{cases}$
Thus $h_{n, L}$ has Lipschitz constant $L$ and $h_{n, L}(x) \geq \mathbb{1}_{\left\{|x| \leq z_{q / 2}\left(1+\epsilon_{n}\right)\right\}}$. Then,
with $Z \sim N(0,1)$,

$$
\begin{aligned}
\mathbb{P}_{f}\left(I_{n, q} \ni\right. & H(f)) \\
\leq & \mathbb{P}_{f}\left(\frac{n^{1 / 2}\left|\hat{H}_{n}^{w}-H(f)\right|}{V^{1 / 2}(f)} \leq z_{q / 2}\left(1+\epsilon_{n}\right)\right)+\mathbb{P}_{f}\left(\frac{V^{1 / 2}(f)}{\left(\hat{V}_{n}^{w}\right)^{1 / 2}} \leq \frac{1}{1+\epsilon_{n}}\right) \\
\leq & \mathbb{E}_{f} h_{n, L}\left(\frac{n^{1 / 2}\left\{\hat{H}_{n}^{w}-H(f)\right\}}{V^{1 / 2}(f)}\right)+\epsilon_{n} \\
\leq & \mathbb{E}_{f} h_{n, L}(Z)+\epsilon_{n}+L d_{\mathrm{BL}}\left(\mathcal{L}\left(\frac{n^{1 / 2}\left\{\hat{H}_{n}^{w}-H(f)\right\}}{V^{1 / 2}(f)}\right), \mathcal{L}(Z)\right) \\
\leq & \mathbb{P}\left(|Z| \leq z_{q / 2}\left(1+\epsilon_{n}\right)+L^{-1}\right)+\epsilon_{n} \\
& +L \max \left(\left(1, V^{-1 / 2}(f)\right) d_{\mathrm{BL}}\left(\mathcal{L}\left(n^{1 / 2}\left(\hat{H}_{n}^{w}-H(f)\right)\right), N(0, V(f))\right) .\right.
\end{aligned}
$$

Since $L \geq 1$ was arbitrary, we deduce from the first part of the theorem and Lemma 11 in the online supplement that
$\limsup _{n \rightarrow \infty} \sup _{q \in(0,1)} \sup _{k \in\left\{k_{0}^{*}, \ldots, k_{1}^{*}\right\}} \sup _{f \in \mathcal{F}_{\mathcal{A}, \theta}} \mathbb{P}_{f}\left(I_{n, q} \ni H(f)\right)-(1-q) \leq \inf _{L \geq 1} \frac{2}{L(2 \pi)^{1 / 2}}=0$.
The lower bound is obtained by a similar argument, omitted for brevity.

# SUPPLEMENTARY MATERIAL TO 'EFFICIENT MULTIVARIATE ENTROPY ESTIMATION VIA $K$-NEAREST NEIGHBOUR DISTANCES'

Appendix. This is the supplementary material to Berrett, Samworth and Yuan (2017), hereafter referred to as the main text.

## A.4. Proofs of auxiliary results.

Proof of Proposition 9. Fix $\tau \in\left(\frac{d}{\alpha+d}, 1\right]$. We first claim that given any $\epsilon>0$, there exists $A_{\epsilon}>0$ such that $a(\delta) \leq A_{\epsilon} \delta^{-\epsilon}$ for all $\delta \in(0, \gamma]$. To see this, observe that there exists $\delta_{0} \in(0, \gamma]$ such that $a(\delta) \leq \delta^{-\epsilon}$ for $\delta \leq \delta_{0}$. But then

$$
\sup _{\delta \in(0, \gamma]} \delta^{\epsilon} a(\delta) \leq \max \left\{1, \gamma^{\epsilon} a\left(\delta_{0}\right)\right\} \leq \gamma^{\epsilon} \delta_{0}^{-\epsilon},
$$

which establishes the claim, with $A_{\epsilon}:=\gamma^{\epsilon} \delta_{0}^{-\epsilon}$. Now choose $\epsilon=\frac{1}{3}\left(\tau-\frac{d}{\alpha+d}\right)$ and let $\tau^{\prime}:=\frac{\tau}{3}+\frac{2 d}{3(\alpha+d)} \in\left(\frac{d}{\alpha+d}, 1\right)$. Then, by Hölder's inequality, and since $\alpha \tau^{\prime} /\left(1-\tau^{\prime}\right)>d$,

$$
\begin{aligned}
\sup _{f \in \mathcal{F}_{d, \theta}} \int_{\{x: f(x)<\delta\}} a(f(x)) f(x)^{\tau} d x \leq A_{\epsilon} \delta^{\epsilon} \sup _{f \in \mathcal{F}_{d, \theta}} \int_{\{x: f(x)<\delta\}} f(x)^{\tau^{\prime}} d x \\
\leq A_{\epsilon} \delta^{\epsilon}(1+\nu)^{\tau^{\prime}}\left\{\int_{\mathbb{R}^{d}}\left(1+\|x\|^{\alpha}\right)^{-\frac{\tau^{\prime}}{1-\tau^{\prime}}} d x\right\}^{1-\tau^{\prime}} \rightarrow 0
\end{aligned}
$$

as $\delta \searrow 0$, as required.
For the second part, fix $\rho>0$, set $\epsilon:=\frac{1}{2}\left(\tau-\frac{d}{\alpha+d}\right)$ and $\tau^{\prime}:=\frac{\tau}{2}+\frac{d}{2(\alpha+d)} \in$ $\left(\frac{d}{\alpha+d}, 1\right)$. Then, by Hölder's inequality again,

$$
\begin{aligned}
& \sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}} a(f(x))^{\rho} f(x)^{\tau} d x \leq A_{\epsilon / \rho} \sup _{f \in \mathcal{F}_{d, \theta}} \int_{\mathcal{X}} f(x)^{\tau^{\prime}} d x \\
& \leq A_{\epsilon / \rho}(1+\nu)^{\tau^{\prime}}\left\{\int_{\mathbb{R}^{d}}\left(1+\|x\|^{\alpha}\right)^{-\frac{\tau^{\prime}}{1-\tau^{\prime}}} d x\right\}^{1-\tau^{\prime}}<\infty
\end{aligned}
$$

as required.

Proof of Lemma 10. (i) The lower bound is immediate from the fact that $h_{x}(r) \leq V_{d}\|f\|_{\infty} r^{d}$ for any $r>0$. For the upper bound, observe that by Markov's inequality, for any $r>0$,

$$
h_{x}(\|x\|+r)=\int_{B_{x}(\|x\|+r)} f(y) d y \geq \int_{B_{0}(r)} f(y) d y \geq 1-\frac{\mu_{\alpha}(f)}{r^{\alpha}}
$$

The result follows on substituting $r=\left(\frac{\mu_{\alpha}(f)}{1-s}\right)^{1 / \alpha}$ for $s \in(0,1)$.
(ii) We first prove this result in the case $\beta \in(2,4]$, giving the stated form of $b_{1}(\cdot)$. Let $C:=4 d V_{d}^{-\beta / d} /(d+\beta)$, and let $y:=C a(f(x))^{\beta / 2} s\{s / f(x)\}^{\beta / d}$. Now, by the mean value theorem, we have for $r \leq r_{a}(x)$ that

$$
\left|h_{x}(r)-V_{d} r^{d} f(x)-\frac{V_{d}}{2(d+2)} r^{d+2} \Delta f(x)\right| \leq a(f(x)) f(x) \frac{d V_{d}}{2(d+\beta)} r^{d+\beta}
$$

It is convenient to write

s_{x, y}:=s-\frac{s^{1+2 / d} \Delta f(x)}{2(d+2) V_{d}^{2 / d} f(x)^{1+2 / d}}+y
$$

Then, provided $s_{x, y} \in\left(0, V_{d} r_{a}^{d}(x) f(x)\right]$, we have

Now, by our hypothesis, we know that

& \leq \max \left\{\frac{d^{1 / 2} V_{d}^{-2 / d} C_{n}^{2 / d}}{2(d+2)}, C C_{n}^{\beta / d}\right\} \rightarrow 0
\end{aligned}
$$

as $n \rightarrow \infty$. Hence there exists $n_{1}=n_{1}(d, \theta) \in \mathbb{N}$ such that for all $n \geq n_{1}$, all $f \in \mathcal{F}_{d, \theta}, s \in \mathcal{S}_{n}$ and $x \in \mathcal{X}_{n}$, we have

and such that $C_{n} \leq\left(8 d^{1 / 2}\right)^{-d} V_{d} / 2$ for $n \geq n_{3}$. It follows that for $n \geq$ $\max \left(n_{1}, n_{2}, n_{3}\right)=: n_{*}$, for $f \in \mathcal{F}_{d, \theta}, s \in \mathcal{S}_{n}$ and for $x \in \mathcal{X}_{n}$, we have that $s_{x, y} \in\left(0, V_{d} r_{a}^{d}(x) f(x)\right]$ and

& \geq y-\frac{a(f(x)) s^{1+2 / d}}{2 d^{1 / 2} V_{d}^{2 / d} f(x)^{2 / d}}\left\{\frac{d^{1 / 2} V_{d}^{-2 / d} a(f(x)) s^{2 / d}}{2(d+2) f(x)^{2 / d}}+\frac{y}{s}\right\}-\frac{d a(f(x)) s^{1+\beta / d}}{(d+\beta) V_{d}^{\frac{\beta}{d}} f(x)^{\frac{\beta}{d}}} \\
& \begin{aligned}
& \geq \frac{a(f(x))^{\beta / 2} s^{1+\beta / d}}{f(x)^{\beta / d}}\left[C-\frac{a(f(x))^{2-\beta / 2}}{4(d+2) V_{d}^{4 / d}}\left\{\frac{s}{f(x)}\right\}^{(4-\beta) / d}\right. \\
&\left.\quad-\frac{C a(f(x))}{2 d^{1 / 2} V_{d}^{2 / d}}\left\{\frac{s}{f(x)}\right\}^{2 / d}-\frac{d V_{d}^{-\beta / d}}{d+\beta}\right] \geq 0 .
\end{aligned}

The lower bound is proved by very similar calculations, and the result for the case $\beta \in(2,4]$ follows. The general case can be proved using very similar arguments, and is omitted for brevity.

\end{aligned}

where the bound on $\left|\log ^{m}\|f\|_{\infty}\right|$ comes from (13) in the main text.

The following auxiliary result provides control on deviations of the density arising from the smoothness condition of our $\mathcal{F}_{d, \theta}$ classes.

& +d^{m / 2}\|y-x\|^{m} \sup _{z \in B_{x}(\|y-x\|)}\| \| f^{(m)}(z)-f^{(m)}(x)\| \| \\
& \leq a(f(x)) f(x)\|y-x\|\left\{\frac{1}{1-d^{1 / 2}\|y-x\|}+d^{m / 2}\|y-x\|^{\beta-1}\right\} \\
& \leq \frac{15 d^{1 / 2}}{7} a(f(x)) f(x)\|y-x\|,
\end{aligned}

as required.

& \leq\|w\|_{1} \max _{j \in \operatorname{supp}(w)}\left|\mathbb{E}_{f} \log ^{2} \xi_{(j), 1}-\int_{\mathcal{X}} f \log ^{2} f\right|+\operatorname{Var}_{f} \hat{H}_{n}^{w}+\left|\left(\mathbb{E}_{f} \hat{H}_{n}^{w}\right)^{2}-H(f)^{2}\right|
\end{aligned}
$$

& \\
& \quad+O\left(\max \left\{\frac{k^{\beta / d}}{n^{\beta / d}} \log ^{m-1} n, \frac{k^{\frac{\alpha}{\alpha+d}-\epsilon}}{n^{\frac{\alpha}{\alpha+d}-\epsilon}}\right\}\right) \rightarrow 0
\end{aligned}

(i) We may choose any $\alpha>0$, and then set $\nu=d 2^{\alpha / 2-1} \Gamma\left(\frac{\alpha}{2}+\frac{d}{2}\right) / \Gamma\left(1+\frac{d}{2}\right)$. We may also set $\gamma=(2 \pi)^{-d / 2}$. It remains to find $a \in \mathcal{A}$ such that (6) holds. Write $H_{r}(y):=(-1)^{r} e^{y^{2} / 2} \frac{d^{r}}{d y^{r}} e^{-y^{2} / 2}$ for the $r$ th Hermite polynomial, and note that $\left|H_{r}(y)\right| \leq p_{r}(|y|)$, where $p_{r}$ is a polynomial of degree $r$ with nonnegative coefficients. Using multi-index notation for partial derivatives, if $t=\left(t_{1}, \ldots, t_{d}\right) \in\{0,1, \ldots,\}^{d}$ with $|t|:=t_{1}+\ldots+t_{d}$, we have

\left|\frac{\partial f^{t}(x)}{\partial x^{t}}\right|=f(x) \prod_{j=1}^{d}\left|H_{t_{j}}\left(x_{j}\right)\right| \leq f(x) \prod_{j=1}^{d} p_{t_{j}}(\|x\|) \leq f(x) q_{|t|}(\|x\|)
$$

Then $\sup _{x: f(x) \geq \delta} M_{f, a, \beta}(x) \leq a(\delta)$ and $a(\delta)=o\left(\delta^{-\epsilon}\right)$ for every $\epsilon>0$, so (6) holds.

\end{aligned}

say, where $A_{d, m, \rho}^{(1)} \in[0, \infty)$. Similarly,

a(\delta):=\max \left\{1, A_{d, m, \rho}^{(1)}, A_{d, m, \rho}^{(2)}\right\},
$$

we again have that $\sup _{x: f(x) \geq \delta} M_{f, a, \beta}(x) \leq a(\delta)$, so (6) holds.
(iii) We may take any $\alpha>0$ and $\nu=1, \gamma=3$. To verify (6), fix $\beta>0$, set $m:=\lceil\beta\rceil-1$, and define $a \in \mathcal{A}$ by

provided $A_{m}$ in the definition of $a$ is chosen sufficiently large. Hence (6) again holds.

& +O\left(\max \left\{q_{n}^{1-\epsilon}, q_{n} \log n, n^{-1}\right\}\right)
\end{aligned} \quad \begin{array}{r}
\leq \frac{4 d V_{d}^{-\tilde{\beta} / d}}{d+\tilde{\beta}} \frac{\mathrm{B}_{k+\tilde{\beta} / d, n-k}}{\mathrm{~B}_{k, n-k}} \int_{\mathcal{X}_{n}} \frac{C_{n, \tilde{\beta}}(x)}{f(x)^{\tilde{\beta} / d} d x+O\left(\max \left\{q_{n}^{1-\epsilon}, q_{n} \log n, n^{-1}\right\}\right),}
\end{array}
$$

as required.
A.8. Completion of the proof of Lemma 7. To prove Lemma 7, it remains to bound several error terms arising from arguments that approximate the variance of the unweighted Kozachenko-Leonenko estimator $\hat{H}_{n}$, and then to show how these arguments may be adapted to yield the desired asyptotic expansion for $\operatorname{Var}\left(\hat{H}_{n}^{w}\right)$.

& \left.+\left\{\log n+|\log f(x)|+\log \left(1+\frac{\|x\|}{\mu_{\alpha}^{1 / \alpha}(f)}\right)\right\} \mathbb{E}\left|1-\frac{(n-2) \mathrm{B}}{k-1}\right|\right] d y d x \\
= & o\left(\frac{k^{-\frac{1}{2}+\frac{2 \alpha}{\alpha+d}-\epsilon}}{n^{\frac{2 \alpha}{\alpha+d}-\epsilon}}\right),

Using (50) again, we have that $a\left(f\left(y_{x, z}\right)\right) \lesssim f(x)^{-\epsilon}$ for each $\epsilon>0$, uniformly for $x \in \mathcal{X}_{n}$ and $\|z\| \leq\left\{v_{x} f(x)\right\}^{1 / d}+\left\{v_{y} f(x)\right\}^{1 / d}$. From (49), (52) and (53) we therefore have that

=O\left(\max \left\{\frac{k^{1 / 2+2 \beta / d}}{n^{1+2 \beta / d}}, \frac{\log n}{n k^{1 / 2}}, \frac{k^{\frac{1}{2}+\frac{\alpha}{\alpha+\alpha}-\epsilon}}{n^{1+\frac{\alpha}{\alpha+d}-\epsilon}}\right\}\right)
\end{array}, \$ \text {. }
\end{align*}

for every $\epsilon>0$. By (48), (51) and (54) we therefore have that

& \quad+\mathbb{P}\left(N_{1}+N_{3}=k-1, N_{2}+N_{3}=k-1\right) \mathbb{1}_{\left\{\|x-y\| \leq r_{n, u} \wedge r_{n, v}\right\}} .

Now $\mathbb{P}\left(N_{1}+N_{3}=k-1\right)=\binom{n-2}{k-1} p_{n, x, u}^{k-1}\left(1-p_{n, x, u}\right)^{n-k-1} \leq(2 \pi k)^{-1 / 2}\{1+o(1)\}$ and $F_{n, x, y}(u, v)=G_{n, x, y}(u, v)$ if $\|x-y\|>r_{n, u}+r_{n, v}$, and so, by (52) and (53), we have that

When $x \in \mathcal{X}_{n}$ and $y \in B_{x}^{\circ}\left(r_{n, v_{x}}+r_{n, v_{y}}\right)$ we have that, writing $\Delta$ for the symmetric difference and using (50), $\mathbb{P}\left(X_{1} \in B_{x}\left(r_{n, u}\right) \Delta B_{y}\left(r_{n, v}\right)\right)>0$ and so $V$ is invertible. We may therefore set $Z_{i}:=V^{-1 / 2}\left(Y_{i}-\mu\right)$. Then by the

Berry-Esseen bound of Götze (1991), writing $\mathcal{C}$ for the set of closed, convex subsets of $\mathbb{R}^{2}$ and letting $Z \sim N_{2}(0, I)$, there exists a universal constant $C_{2}>0$ such that

First suppose that $u \geq v$. We may write

Moreover, the same lower bound for $\mu_{d}\left(B_{y}\left(r_{n, v}\right) \cap B_{x}\left(r_{n, u}\right)^{c}\right)$ holds when $u<v, u \in\left[l_{x}, v_{x}\right], x \in \mathcal{X}_{n}$, and $y=$ $y_{x, z} \in B_{x}\left(r_{n, v_{x}}+r_{n, v_{y}}\right)$. We deduce that for all $x \in \mathcal{X}_{n}, y=y_{x, z} \in B_{x}\left(r_{n, v_{x}}+\right.$ $\left.r_{n, v_{y}}\right), u \in\left[l_{x}, v_{x}\right]$ and $v \in\left[l_{y}, v_{y}\right]$,

&+\left(p_{n, y, v}-p_{\cap}\right)\left\|V^{-1 / 2}\binom{-p_{n, x, u}}{1-p_{n, y, v}}\right\|^{3} \\
&(64) \quad+\left(1-p_{n, x, u}-p_{n, y, v}+p_{\cap}\right)\left\|V^{-1 / 2}\binom{p_{n, x, u}}{p_{n, y, v}}\right\|^{3}
\end{aligned}
$$

and bound each of these terms in turn. First,

& =p_{\cap}|V|^{-3 / 2}\left\{\left(1-p_{n, x, u}\right)\left(1-p_{n, y, v}\right)\left(p_{n, x, u}+p_{n, y, v}-2 p_{\cap}\right)\right\}^{3 / 2} \\
& =p_{\cap}\left\{\frac{\left(1-p_{n, x, u}\right)\left(1-p_{n, y, v}\right)}{\left.p_{\cap}-p_{n, x, u} p_{n, y, v}+\frac{\left(p_{n, x, u}-p_{n}\right)\left(p_{n, y, v}-p_{\cap}\right)}{p_{n, x, u}+p_{n, y, v}-2 p_{\cap}}\right\}^{3 / 2}}\right. \\
& \leq p_{\cap} \min \left\{\frac{p_{n, x, u}+p_{n, y, v}}{|V|}, \frac{1}{p_{\cap}-p_{n, x, u} p_{n, y, v}}\right\}^{3 / 2} \lesssim n^{1 / 2} / k^{1 / 2}, \tag{65}
\end{align*}
$$

using (61) and (62), and where we derive the final bound from the left hand side of the minimum if $\|z\| \geq 1$ and the right hand side if $\|z\|<1$. Similarly, (66)

for $x \in \mathcal{X}_{n}, y \in B_{x}^{\circ}\left(r_{n, v_{x}}+r_{n, v_{y}}\right), u \in\left[l_{x}, v_{x}\right], v \in\left[l_{y}, v_{y}\right]$. Now let $u=$ $f(x)^{-1}\left(1+k^{-1 / 2} s\right)$ and $v=f(x)^{-1}\left(1+k^{-1 / 2} t\right)$. By the mean value theorem, (52) and (60),

It follows by (58), (59), (68) and (69) that for $x \in \mathcal{X}_{n}$ and $y \in B_{x}^{\circ}\left(r_{n, v_{x}}+\right.$
$\left.r_{n, v_{y}}\right)$,

\end{aligned}

Therefore, by (52) and (53), and since $f(y) \geq f(x) / 2$ for $x \in \mathcal{X}_{n}, y \in$ $B_{x}\left(r_{n, v_{x}}+r_{n, v_{y}}\right)$ and $n \geq n_{0}$, we conclude that for each $\epsilon>0$ and $n \geq n_{0}$

& \int_{B_{0}(3)} \sup _{u \in\left[l_{x}, v_{x}\right], v \in\left[l_{\left.y_{x, z}, v_{y_{x, z}}\right]}\left|F_{n, x, y_{x, z}}^{(1)}(u, v)-\Phi_{\Sigma}(s, t)\right| d z d x\right.} \tag{70}
\end{align*}

By similar (in fact, rather simpler) means we can establish the same bound for the approximation of $G_{n, x, y}$ by $\Phi\left(k^{1 / 2}\{u f(x)-1\}\right) \Phi\left(k^{1 / 2}\{v f(x)-1\}\right)$.

To conclude the proof for the unweighted case, we write $\mathcal{X}_{n}=\mathcal{X}_{n}^{(1)} \cup \mathcal{X}_{n}^{(2)}$, where

& \quad \leq \frac{e^{\Psi(k)}}{V_{d}(n-1) k} \int_{\mathcal{X}_{n}^{(2)}} \int_{\mathbb{R}^{d}} f\left(y_{x, z}\right) \frac{\mathbb{1}_{\left\{\left\|x-y_{x, z}\right\| \leq r_{\left.n, v_{x}+r_{n, v_{y x, z}}\right\}}\right.}^{f(x)^{2} l_{x} l_{y_{x, z}}}}{\int_{-\infty}^{\infty} \int_{-\infty}^{\infty}\left\{\Phi_{\Sigma}(s, t)-\Phi(s) \Phi(t)\right\} d s d t d z d x} \begin{array}{l}
(71) \quad \lesssim \frac{1}{n} \int_{\mathcal{X}_{n}^{(2)}} f(x) \int_{B_{0}(2)} \alpha_{z} d z d x=o\left(\frac{k^{\left(1+\frac{d}{2 \beta}\right) \frac{\alpha}{\alpha+d}-\epsilon}}{n^{1+\frac{\alpha}{\alpha+d}-\epsilon}}\right),
\end{array}, l
\end{aligned}
$$

where to obtain the final error term, we have used the fact that $\int_{B_{0}(2)} \alpha_{z} d z=$ $V_{d}$. By (52) and (53) we have, for each $\epsilon>0$,

\end{aligned}

=\frac{e^{\Psi(k)}}{(n-1) k}+O\left(\max \left\{\frac{\log ^{1 / 2} n}{n k^{1 / 2}}, \frac{k^{\beta / d}}{n^{1+\beta / d}}, \frac{k^{\left(1+\frac{d}{2 \beta}\right) \frac{\alpha}{\alpha+d}-\epsilon}}{n^{1+\frac{\alpha}{\alpha+d}-\epsilon}}\right\}\right) . \tag{72}
\end{equation*}

By Lemma 10(ii) as for (60) we have, for $x \in \mathcal{X}_{n}^{(1)}, y \in B_{x}\left(r_{n, v_{x}}+r_{n, v_{y}}\right)$,

We now turn our attention to the variance of the weighted KozachenkoLeonenko estimator $\hat{H}_{n}^{w}$. We first claim that

& =\int_{\mathcal{X}} f(x) \log ^{2} f(x) d x+o(1)
\end{aligned}

as $n \rightarrow \infty$, uniformly for $1 \leq j<l \leq k_{1}^{*}$. Now (74) follows on noting that $\sup _{k \geq k_{d}}\|w\|<\infty$.

For pairs $(u, v)$ with $u \leq v_{x, j}$ and $v \leq v_{y, l}$, let $\left(M_{1}, M_{2}, M_{3}\right) \sim \operatorname{Multi}(n-$ $\left.2 ; p_{n, x, u}^{(j)} p_{n, y, v}^{(l)}, 1-p_{n, x, u}^{(j)}-p_{n, y, v}^{(l)}\right)$ and write

& =\int_{\mathcal{X} \times \mathcal{X}} f(x) f(y) \int_{\left[l_{y, l}, v_{y, l}\right] \times\left[l_{x, j}, v_{x, j}\right]} h(u, v) d\left(F_{n, x, y}^{\prime}-G_{n, x, y}^{\prime}\right)(u, v) d x d y-\frac{1}{n}+\sum_{i=1}^{2} W_{i}^{\prime} \\

& (76)  \tag{76}\\
& =\frac{V_{d}^{-1} e^{\Psi(j)}}{(n-1) l} \int_{\mathbb{R}^{d}} \alpha_{z}^{\prime} d z-\frac{1}{n}+\sum_{i=1}^{4} W_{i}=O\left(\frac{1}{n k}\right)+\sum_{i=1}^{4} W_{i}^{\prime}
\end{align*}

as $n \rightarrow \infty$. The final equality here follows from the fact that, for Borel measurable sets $K, L \subseteq \mathbb{R}^{d}$,

To bound $W_{2}^{\prime}$ : Similar to our work used to bound $W_{2}$, we may show that

Further, let

&+O\left(\max \left\{\frac{\log n}{n k^{1 / 2}}, \frac{k^{\frac{1}{2}+\frac{2 \beta}{d}}}{n^{1+\frac{2 \beta}{d}}}, \frac{k^{\frac{1}{2}+\frac{\alpha}{\alpha+d}-\epsilon}}{n^{1+\frac{\alpha}{\alpha+\alpha}-\epsilon}}\right\}\right) .

This is rather similar to the corresponding approximation in the bounds on $W_{4}$, so we only present the main differences. First, let

and set $Z_{i}^{\prime}:=V^{\prime-1 / 2}\left(Y_{i}^{\prime}-\mu\right)$. Our aim is to provide a bound on $p_{\cap}$. Since the function

is Lipschitz we have for $x \in \mathcal{X}_{n}, y=x+f(x)^{-1 / d} r_{n, 1}^{(j)} z \in B_{x}\left(r_{n, v_{x, j}}^{(j)}+\right.$ $\left.r_{n, v_{y, l}}^{(l)}\right), u \in\left[l_{x, j}, v_{x, j}\right]$ and $v \in\left[l_{y, l}, v_{y, l}\right]$ that

The equation (76), together the bounds on $W_{1}^{\prime}, \ldots, W_{4}^{\prime}$ just proved, establish the claim (75). We finally conclude from (74) and (75) that

## A. Proof of Theorem 8.

Proof of Theorem 8. For the first part of the theorem we aim to apply Theorem 25.21 of van der Vaart (1998), and follow the notation used there. With $\dot{\mathcal{P}}:=\{\lambda(\log f+H(f)): \lambda \in \mathbb{R}\}$ we will first show that the entropy functional $H$ is differentiable at $f$ relative to the tangent set $\dot{\mathcal{P}}$, with efficient influence function $\tilde{\psi}_{f}=-\log f-H(f)$. Following Example 25.16 in van der Vaart (1998), for $g \in \dot{\mathcal{P}}$, the paths $f_{t, g}$ defined in (10) of the main text are differentiable in quadratic mean at $t=0$ with score function $g$. Note that $\int_{\mathcal{X}} g f=0$ and $\int_{\mathcal{X}} g^{2} f<\infty$ for all $g \in \dot{\mathcal{P}}$. It is convenient to define, for $t \geq 0$, the set $A_{t}:=\{x \in \mathcal{X}: 8 t|g(x)| \leq 1\}$, on which we may expand $e^{-2 t g}$ easily as a Taylor series. By Hölder's inequality, for $\epsilon \in(0,1 / 2)$,

& \leq \frac{16}{3} t^{2} \int_{A_{t}} g^{2} f+72 t^{2} \int_{A_{t}^{c}} g^{2} f \leq 72 t^{2} \int_{\mathcal{X}} g^{2} f \tag{80}
\end{align*}

It follows that

& \left.\leq \frac{1}{t} \int_{A_{t}} f \right\rvert\,\left\{e^{-2 t g}-1+2 t g+\operatorname{tg}\left(e^{-2 t g}-1\right)\right\} \log f \\
& \left.\quad-2 \log \left(\frac{2}{1+e^{-2 t g}}\right)+\operatorname{tg}\left(1+e^{-2 t g}\right) \right\rvert\,+o(1) \\
& \leq \frac{16}{3} t \int_{\mathcal{X}} g^{2} f|\log f|+22 t \int_{\mathcal{X}} g^{2} f+o(1) \rightarrow 0 .

The conclusion (11) in the main text therefore follows from van der Vaart (1998, Theorem 25.21).

We now establish the second part of the theorem. First, by our previous bound on $c(t)$ in (80), for $12 t<\left\{\int_{\mathcal{X}} g^{2} f\right\}^{-1 / 2}$ we have that

Let $\mathcal{J}_{m}$ denote the set of multisets of elements $\{1, \ldots, d\}$ of cardinality at most $m$, and for $J=\left\{j_{1}, \ldots, j_{s}\right\} \in \mathcal{J}_{m}$, define $g_{J}(x):=\frac{\partial^{s} g}{\prod_{\ell=1}^{\partial^{\partial} \partial x_{\ell}}}(x)$. Moreover, for $i \in\{1, \ldots, s\}$, let $\mathcal{P}_{i}(J)$ denote the set of partitions of $J$ into $i$ non-empty multisets. As an illustration, if $d=2$, then

Now, by Lemma 12,

& \quad+\left|\sum_{i=1}^{s}\left\{q^{(i)}\left(g^{*}(y)\right)-q^{(i)}\left(g^{*}(x)\right)\right\} \sum_{\left\{P_{1}, \ldots, P_{i}\right\} \in \mathcal{P}_{i}(J)} g_{P_{1}}^{*} \ldots g_{P_{i}}^{*}(y)\right| \\
& \leq D^{m} q\left(g^{*}(x)\right) a(f(x))^{m^{2}+m+1}\|y-x\|^{\beta-m} \\
& \quad \times \frac{B_{m} 2^{3 m+5} d^{1 / 2}(m+1)^{m+1}\left(1+e^{2 t g^{*}(x)}\right)}{e^{2 t g^{*}(x)}+e^{-2 t\left|g^{*}(y)-g^{*}(x)\right|}}
\end{aligned}
$$

$$
\begin{equation*}
\leq D^{m} q\left(g^{*}(x)\right) a(f(x))^{m^{2}+m+1}\|y-x\|^{\beta-m} B_{m} 2^{3 m+5} d^{1 / 2}(m+1)^{m+1}\left(\frac{56}{41}\right)^{2 t} \tag{88}
\end{equation*}
$$

Using the multivariate Leibnitz rule again, together with (85), (88) and Lemma 12 , for $t \leq 1,\|y-x\| \leq r_{a}(x)$ and $|\omega|=m \geq 1$,

& \left.\quad+\left|\frac{\partial^{\nu} q\left(g^{*}(x)\right)}{\partial x^{\nu}} \| \frac{\partial^{\nu} f(y)}{\partial x^{\nu}}-\frac{\partial^{\nu} f(x)}{\partial x^{\nu}}\right|\right\} \\
& \leq 2^{4 m+9} d^{1 / 2} B_{m}(m+1)^{m+1} D^{m} a(f(x))^{m^{2}+m+1} f_{t, g^{*}}(x)\|y-x\|^{\beta-m} \\
& =: C_{m}^{\prime} D^{m} a(f(x))^{m^{2}+m+1} f_{t, g^{*}}(x)\|y-x\|^{\beta-m} .
\end{aligned}
$$

This also holds in the case $m=0$. Now note that if $12 t<\left\{\int_{\mathcal{X}}\left(g^{*}\right)^{2} f\right\}^{-1 / 2}$ we have

$$
f(x)=\frac{1+e^{-2 t g^{*}(x)}}{2 c(t)} f_{t, g^{*}}(x) \geq \frac{f_{t, g^{*}}(x)}{4} .
$$

Finally, define the function

$$
\begin{equation*}
\tilde{a}(\delta):=d^{m / 2} C_{m}^{\prime} D^{m} a(\delta / 4)^{m^{2}+m+1} . \tag{90}
\end{equation*}
$$

Then $\tilde{a} \in \mathcal{A}$ and from (86) and (89), we have $M_{f_{t, g^{*}}, \tilde{a}, \beta}(x) \leq \tilde{a}\left(f_{t, g^{*}}(x)\right)$. We conclude that for $t<\min \left(1,\left\{144 \int g^{2} f\right\}^{-1 / 2}\right)$, we have that $f_{t, g^{*}} \in \mathcal{F}_{d, \theta^{\prime}}$, where $\theta^{\prime}=(\alpha, \beta, 4 \gamma, 4 \nu, \tilde{a}) \in \Theta$. The result follows on noting that $f_{t, g_{\lambda}}=$ $f_{t \lambda, g^{*}}$.
