# ON THE REGULARITY OF SOLUTIONS OF ONE DIMENSIONAL VARIATIONAL OBSTACLE PROBLEMS

#### Abstract

We study the regularity of solutions of one dimensional variational obstacle problems in $W^{1,1}$ when the Lagrangian is locally Hölder continuous and globally elliptic. In the spirit of the work of Sychev (Syc89, Syc91, Syc92]), a direct method is presented for investigating such regularity problems with obstacles. This consists of introducing a general subclass $\mathcal{L}$ of $W^{1,1}$, related in a certain way to one dimensional variational obstacle problems, such that every function of $\mathcal{L}$ has Tonelli's partial regularity, and then to prove that, depending on the regularity of the obstacles, solutions of corresponding variational problems belong to $\mathcal{L}$. As an application of this direct method, we prove that if the obstacles are $C^{1, \sigma}$ then every Sobolev solution has Tonelli's partial regularity.

## 1. Introduction

In this paper we consider one dimensional variational obstacle problems of type

$$
\begin{equation*}
\inf \left\{\mathcal{J}_{L}(u ;[a, b]):=\int_{a}^{b} L\left(x, u(x), u^{\prime}(x)\right) d x: u \in \mathcal{A}_{f, g}\right\} \tag{1.1}
\end{equation*}
$$

where $L \in C([a, b] \times \mathbb{R} \times \mathbb{R})$ and $\mathcal{A}_{f, g} \subset W^{1,1}([a, b])$ is given by

$$
\mathcal{A}_{f, g}:=\left\{u \in W^{1,1}([a, b]): u(a)=A, u(b)=B \text { and } f \leqslant u \leqslant g\right\}
$$

with $a, b, A, B \in \mathbb{R}$ with $a<b$ and $f, g \in W^{1,1}([a, b])$ with $f<g$. Usually, the functions $f$ and $g$ are called obstacles. The object of the paper is to study the regularity of solutions of one dimensional variational obstacle problems of type (1.1) when the Lagrangian $L$ is locally Hölder continuous and globally elliptic, see the conditions $\left(\mathrm{H}_{1}\right)$ and $\left(\mathrm{H}_{2}\right)$ in Section 2. For this, in the spirit of the work of Sychev ( Syc89, $^{\text {Syc91, Syc92] }) \text {, we develop a direct method }}$ which consists of introducing a general subclass $\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ of $W^{1,1}([a, b])$, see Definition 2.1. related to (1.1), such that under suitable conditions, see $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right)$ and especially $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ in $\S 2.1$, every $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ has Tonelli's partial regularity, see Definition 2.4 and Theorem 2.5 which is the central result of the paper. Then, we prove that if the obstacles $f$ and $g$ are in $C^{1}([a, b])$ then solutions of (1.1) belong to $\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$, see Lemma 2.6, From Theorem 2.5 and Lemma 2.6 we then deduce a regularity result (see Theorem 2.8) for solutions of (1.1) which says that if $L$ is locally Hölder continuous and globally elliptic and if

\lim _{\varepsilon \rightarrow 0} \int_{0}^{\mathrm{e} \varepsilon}\left[\omega_{h}(\xi+\gamma \sqrt{\xi})\right]^{\theta} \frac{d \xi}{\xi}=0 \text { for all } h \in\left\{f, f^{\prime}, g, g^{\prime}\right\} \text { and all } \gamma, \theta>0 \tag{1.2}
\end{equation*}
$$

where $\omega_{h}:[0, \infty[\rightarrow[0, \infty[$ denotes the modulus of continuity of $h$ and e is Napier's number, then every solution of (1.1) has Tonelli's partial regularity. In particular, (1.2) holds when the obstacles $f$ and $g$ belong to $C^{1, \sigma}([a, b])$, see Corollary 2.9.
The regularity of solutions of one dimensional variational obstacle problems of type (1.1) was studied by Sychev in Syc11] where it is established, for $L$ locally Hölder continuous and locally elliptic, that when the obstacles are bounded in $W^{1, \infty}$-norm, solutions exist in the class of Lipschitz functions provided that the obstacles are close, and that if furthermore the obstacles are $C^{1}$ (resp. $C^{1, \sigma}$ ) then these Lipschitz solutions are $C^{1}$ (resp. $C^{1, \sigma}$ ), see [Syc11, Theorem 1.1] (resp. Syc11, Theorem 1.2]). But nothing is proved for Sobolev solutions. The results of our paper are contributions in this direction.

To complete the introduction, let us mention that Gratwick and Preiss proved in GP11, without considering obstacles, that if locally Hölder continuity of $L$ fails, i.e., $L$ is only continuous, then Tonelli's partial regularity does not hold in general. Let us also note that regularity and nonregularity phenomena, depending on Hölder and usual continuity, was known in the context of parametric problems long ago, see Reshetnyak's book Res94, Chapter 6]. We also refer the reader to [GST16] where regularity theory without considering obstacles is developed with singular ellipticity.
The plan of the paper is as follows. In the next section we give our main results. The central result of the paper (see Theorem [2.5) is stated in $\S 2.1$ and its consequences (see Theorem 2.8
and Corollary (2.9) together with their proofs are in $\S 2.2$. Finally, Theorem 2.5 is proved in Section 4. The proof of Theorem 2.5 is based upon a technical lemma (see Lemma 3.1) which is a generalization of Syc92, Lemma 1.1] to the case of obstacle problems. This technical lemma is proved in Section 3.

## 2. Main Results

Let $a, b \in \mathbb{R}$ with $a<b$ and let $L \in C([a, b] \times \mathbb{R} \times \mathbb{R})$. In what follows, we consider the following two assumptions:
$\left(\mathrm{H}_{1}\right) L$ is locally Hölder continuous, i.e., for each compact $G \subset[a, b] \times \mathbb{R} \times \mathbb{R}$ there exist $C=C(G)>0$ and $\alpha=\alpha(G)>0$ such that

\left|L\left(x_{1}, u_{1}, v_{1}\right)-L\left(x_{2}, u_{2}, v_{2}\right)\right| \leqslant C\left(\left|x_{1}-x_{2}\right|+\left|u_{1}-u_{2}\right|+\left|v_{1}-v_{2}\right|\right)^{\alpha}
$$

for all $\left(x_{1}, u_{1}, v_{1}\right),\left(x_{2}, u_{2}, v_{2}\right) \in G$;
$\left(\mathrm{H}_{2}\right) L_{v v} \in C([a, b] \times \mathbb{R} \times \mathbb{R})$ and there exists $\mu>0$ such that $L_{v v} \geqslant \mu$ everywhere.
(Then, we have $L_{v} \in C([a, b] \times \mathbb{R} \times \mathbb{R}$ ) and

$$
L\left(x, u, v_{2}\right)-L\left(x, u, v_{1}\right)-L_{v}\left(x, u, v_{1}\right)\left(v_{2}-v_{1}\right) \geqslant \frac{\mu}{2}\left(v_{2}-v_{1}\right)^{2}
$$

for all $\left(x, u, v_{1}\right),\left(x, u, v_{2}\right) \in[a, b] \times \mathbb{R} \times \mathbb{R}$.)
We begin with a general regularity theorem (see Theorem 2.5) with respect to a subclass of $W^{1,1}([a, b])$ related in a certain way to the one dimensional variational obstacle problem (1.1), see Definition 2.1.
2.1. A general regularity theorem. For each $u \in W^{1,1}([a, b])$ and each $s, t \in[a, b]$ with $s<t$, we set

$$
k_{u}(s, t)=\frac{u(s)-u(t)}{s-t}
$$

and we define $u_{s, t} \in W^{1,1}([a, b])$ by

$$
u_{s, t}(x):= \begin{cases}u(s)+k_{u}(s, t)(x-s) & \text { if } x \in] s, t[  \tag{2.1}\\ u(x) & \text { if } x \in[a, b] \backslash] s, t[.\end{cases}
$$

Then, for every $s, t \in[a, b]$ with $s<t$, one has

$$
\begin{equation*}
\left.u_{s, t}^{\prime}(x)=k_{u}(s, t) \text { for all } x \in\right] s, t[ \tag{2.2}
\end{equation*}
$$

Definition 2.1. Let $K$ be a compact subset of $[a, b] \times \mathbb{R}$, let $\omega:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ be an increasing function in both arguments such that $\omega(k, 0)=0$ for all $k \in[0, \infty[$. Given $c>0$ and $\delta_{0}>0$, we denote by $\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ the class of $u \in W^{1,1}([a, b])$ with the following three properties:

\begin{aligned}
& \left(\mathrm{A}_{1}\right)\{(x, u(x)): x \in[a, b]\} \subset K \\
& \left(\mathrm{~A}_{2}\right) \mathcal{J}_{L}(u ;[a, b]):=\int_{a}^{b} L\left(x, u(x), u^{\prime}(x)\right) d x \leqslant c
\end{aligned}
$$

$\left(\mathrm{A}_{3}\right)$ for every $s, t \in[a, b]$ with $s<t$, if $|s-t| \leqslant \delta_{0}$ then

$$
\mathcal{J}_{L}(u ;[a, b]) \leqslant \mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\omega\left(\left|k_{u}(s, t)\right|,|s-t|\right)|s-t|
$$

Remark 2.2. When $\omega \equiv 0$, the class $\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ is the one introduced by Sychev in [Syc92] for studying the regularity of solutions of variational problems without obstacles. Thus, in Definition [2.1, the appearance of the function $\omega$ is related to the obstacles (see Lemma 2.6).
Remark 2.3. If $L$ satisfies $\left(\mathrm{H}_{2}\right)$ then there exists $N>0$ such that for every $u \in W^{1,1}([a, b])$ satisfying $\left(\mathrm{A}_{1}\right)$ and $\left(\mathrm{A}_{2}\right)$ one has

$$
\begin{equation*}
\left\|u^{\prime}\right\|_{L^{2}([a, b])} \leqslant N \tag{2.3}
\end{equation*}
$$

Indeed, there exists $c_{1}>0$ such that for every $u \in W^{1,1}([a, b])$ satisfying $\left(\mathrm{A}_{1}\right),|u(x)| \leqslant c_{1}$ for all $x \in[a, b]$. As $L$ satisfies $\left(\mathrm{H}_{2}\right)$ there exists $M>0$ such that $L(x, u, v) \geqslant \frac{\mu}{4} v^{2}$ for all $x \in[a, b]$, all $|u| \leqslant c_{1}$ and all $|v| \geqslant M$, where $\mu>0$ is given by $\left(\mathrm{H}_{2}\right)$. Fix any $u \in W^{1,1}([a, b])$ satisfying $\left(\mathrm{A}_{1}\right)$ and $\left(\mathrm{A}_{2}\right)$. Then $\int_{\mid u^{\prime} \geqslant \geqslant M}\left|u^{\prime}(x)\right|^{2} d x \leqslant \frac{4}{\mu} c$, where $c>0$ is given by $\left(\mathrm{A}_{2}\right)$, and so $\left\|u^{\prime}\right\|_{L^{2}([a, b])}^{2} \leqslant \frac{4}{\mu} c+M^{2}(b-a)$ and (2.3) follows with $N=\sqrt{\frac{4}{\mu} c+M^{2}(b-a)}$.
In what follows, given $c>0$ we consider $\left.\Delta_{c} \subset\right] 0,1[$ given by

$$
\Delta_{c}:=\left\{\delta_{0}>0: \delta_{0}+N \sqrt{\delta_{0}} \leqslant 1\right\}
$$

with $N>0$ given by Remark 2.3, Furthermore, when $\left(\mathrm{H}_{1}\right)$ and $\left(\mathrm{H}_{2}\right)$ hold, we introduce the following assumption:
$\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right) \lim _{\varepsilon \rightarrow 0} \int_{0}^{\mathrm{e} \varepsilon} \bar{\omega}(k, \xi) \frac{d \xi}{\xi}=0$ for all $k \in[0, \infty[$, where $\bar{\omega}:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ is given by

$$
\begin{equation*}
\bar{\omega}(k, \varepsilon):=[\sqrt{\widehat{\omega}(k, \varepsilon)}]^{\alpha(k)}+\sqrt{\widehat{\omega}(k, \varepsilon)}+\widehat{\omega}(k, \varepsilon) \tag{2.4}
\end{equation*}
$$

with $\widehat{\omega}(k, \varepsilon):=\sqrt{\omega(k, \varepsilon+N \sqrt{\varepsilon})}$ and, for each $k \in[0, \infty[, \alpha(k)>0$ is the Hölder exponent of $L$, given by $\left(\mathrm{H}_{1}\right)$, with respect to the compact set $G=K_{0} \times[-(k+$ $M(k)), k+M(k)]$, where

$$
\begin{equation*}
K_{0}:=\left\{(t, w) \in[a, b] \times \mathbb{R}: \operatorname{dist}((t, w) ; K) \leqslant \delta_{0}+N \sqrt{\delta_{0}}\right\} \tag{2.5}
\end{equation*}
$$

with $\operatorname{dist}((t, w) ; K):=\inf \{|x-t|+|u-w|:(x, u) \in K\}$ and $M(k)>0$ satisfies the following property:

$$
\begin{equation*}
|\zeta| \geqslant M(k) \Rightarrow \frac{\mu}{4} \zeta^{2}-2 c(k)(|\zeta|+1) \geqslant \omega\left(k, \delta_{0}+N \sqrt{\delta_{0}}\right) \tag{2.6}
\end{equation*}
$$

with $\mu>0$ given by $\left(\mathrm{H}_{2}\right)$ and

$$
\begin{equation*}
c(k):=\max \left\{\sup _{(t, w, p) \in K_{0} \times[-k, k]}|L(t, w, p)|, \sup _{(t, w, p) \in K_{0} \times[-k, k]}\left|L_{v}(t, w, p)\right|\right\} . \tag{2.7}
\end{equation*}
$$

Before stating our main result, see Theorem 2.5 below, recall that every $u \in W^{1,1}([a, b])$ is uniformly continuous on $[a, b]$ and almost everywhere differentiable in $[a, b]$, i.e.,

$$
\left|[a, b] \backslash \Omega_{u}\right|=0 \text { where } \Omega_{u}:=\{x \in[a, b]: u \text { is differentiable at } x\} .
$$

(Note also that $W^{1,1}([a, b])=A C([a, b])$ where $A C([a, b])$ is the class of absolutely continuous functions on $[a, b]$, see [BGH98, Chapter 2] and the references therein.)

Definition 2.4. We say that $u \in W^{1,1}([a, b])$ has Tonelli's partial regularity if the following three conditions hold:

- $\Omega_{u}$ is an open subset of $[a, b]$;
- $[a, b] \backslash \Omega_{u}=\left\{x \in[a, b]: u^{\prime}(x)=-\infty\right.$ or $\left.u^{\prime}(x)=\infty\right\}$;
- $u^{\prime} \in C([a, b] ;[-\infty, \infty])$.

We denote the class of $u \in W^{1,1}([a, b])$ such that $u$ has Tonelli's partial regularity by $W_{\mathrm{T}}^{1,1}([a, b])$. Here is the main result of the paper.

Theorem 2.5. Let $c>0$ and let $\delta_{0} \in \Delta_{c}$. If $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right)$ and $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ hold then

$$
\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right) \subset W_{\mathrm{T}}^{1,1}([a, b])
$$

i.e., every $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ has Tonelli's partial regularity.

Theorem [2.5 can be applied to deal with the regularity of solutions of one dimensional variational obstacle problems of type (1.1).
2.2. Application to the regularity of solutions of variational obstacle problems. Given $f, g \in W^{1,1}([a, b])$ with $f<g$, we set

$$
\mathcal{S}_{f, g}:=\left\{u \in \mathcal{A}_{f, g}: \mathcal{J}_{L}(u ;[a, b]) \leqslant \mathcal{J}_{L}(v ;[a, b]) \text { for all } v \in \mathcal{A}_{f, g}\right\}
$$

Usually, the functions $f$ and $g$ are called the obstacles. The following lemma makes clear the link between the class $\mathcal{S}_{f, g}$ of solutions of the variational obstacle problem (1.1) and the class $\mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ when the obstacles are $C^{1}$.

Lemma 2.6. Assume that $\left(\mathrm{H}_{1}\right)$ holds and the obstacles $f$ and $g$ belong to $C^{1}([a, b])$. Let $K:=\{(x, u) \in[a, b] \times \mathbb{R}: f(x) \leqslant u \leqslant g(x)\}$, let $u \in W^{1,1}([a, b])$, let $c:=\left|\mathcal{J}_{L}(u ;[a, b])\right|+1$ and let $\delta_{0}>0$. Then

$$
u \in \mathcal{S}_{f, g} \Rightarrow u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)
$$

with $\omega:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ given by

$$
\begin{equation*}
\omega(k, \varepsilon):=C_{0}\left[\left(\omega_{f}(\varepsilon)+\omega_{f^{\prime}}(\varepsilon)+k \varepsilon\right)^{\alpha_{0}}+\left(\omega_{g}(\varepsilon)+\omega_{g^{\prime}}(\varepsilon)+k \varepsilon\right)^{\alpha_{0}}\right] \tag{2.8}
\end{equation*}
$$

where $\omega_{f}, \omega_{f^{\prime}}, \omega_{g}, \omega_{g^{\prime}}:\left[0, \infty\left[\rightarrow\left[0, \infty\left[\right.\right.\right.\right.$ are the moduli of continuity of $f, f^{\prime}, g$ and $g^{\prime}$ respectively, and $C_{0}, \alpha_{0}>0$ are given by $\left(\mathrm{H}_{1}\right)$ with $G=[a, b] \times\left[-M_{1}, M_{1}\right] \times\left[-M_{2}, M_{2}\right]$, where $M_{1}:=\max \left\{\|f\|_{\infty},\|g\|_{\infty}\right\}+M_{2}(b-a)$ and $M_{2}:=\max \left\{\left\|f^{\prime}\right\|_{\infty},\left\|g^{\prime}\right\|_{\infty}\right\}$.
Proof of Lemma 2.6. We only have to prove that $\left(\mathrm{A}_{3}\right)$ is satisfied with $\omega$ given by (2.8).
Step 1: defining an admissible function with respect to the obstacles. Let $s, t \in$ $[a, b]$ with $s<t$ and $|s-t| \leqslant \delta_{0}$. Let $v_{s, t} \in W^{1,1}([a, b])$ be given by

$$
v_{s, t}(x)= \begin{cases}u_{s, t}(x) & \text { if } f(x) \leqslant u_{s, t}(x) \leqslant g(x) \\ f(x) & \text { if } f(x)>u_{s, t}(x) \\ g(x) & \text { if } u_{s, t}(x)>g(x)\end{cases}
$$

where $u_{s, t}$ is defined in (2.1). Note that

$$
\left.v_{s, t}(x)=u(x) \text { for all } x \in[a, b] \backslash\right] s, t[\text {. }
$$

because $u \in \mathcal{A}_{f, g}$. Then $v_{s, t} \in \mathcal{A}_{f, g}$ and so

$$
\mathcal{J}_{L}(u ;[a, b]) \leqslant \mathcal{J}_{L}\left(v_{s, t} ;[a, b]\right)
$$

because $u \in \mathcal{S}_{f, g}$.
Step 2: using condition ( $\mathbf{H}_{1}$ ). Set:

- $A_{f}:=\{x \in] s, t\left[: f(x)>u_{s, t}(x)\right\} ;$
- $B_{g}:=\{x \in] s, t\left[: u_{s, t}(x)>g(x)\right\}$.
(Note that much of the arguments in the proof rely on both $A_{f}$ and $B_{g}$ being non-empty. If one is or both are empty then the arguments simplify.) Then, we have

$$
\begin{align*}
\mathcal{J}_{L}(u ;[a, b]) \leqslant & \mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\mathcal{J}_{L}\left(v_{s, t} ;[a, b]\right)-\mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right) \\
= & \mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\mathcal{J}_{L}\left(f ; A_{f}\right)-\mathcal{J}_{L}\left(u_{s, t} ; A_{f}\right)+\mathcal{J}_{L}\left(g ; B_{g}\right)-\mathcal{J}_{L}\left(u_{s, t} ; B_{g}\right) \\
\leqslant & \mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right) \\
& +\int_{A_{f}}\left|L\left(x, f(x), f^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| d x \\
& +\int_{B_{g}}\left|L\left(x, g(x), g^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| d x \tag{2.9}
\end{align*}
$$

Since $A_{f}$ and $B_{g}$ are open sets, there exist two disjointed countable sequences $\left] \alpha_{i}, \alpha_{i+1}[ \}_{i \geqslant 1}\right.$ and $\left] \beta_{i}, \beta_{i+1}[ \}_{i \geqslant 1}\right.$ of open intervals with $s \leqslant \alpha_{i}<\alpha_{i+1} \leqslant t$ and $s \leqslant \beta_{i}<\beta_{i+1} \leqslant t$ for all $i \geqslant 1$ such that:

$$
\begin{align*}
& \left.A_{f}=\cup \underset{i \geqslant 1}{\cup}\right] \alpha_{i}, \alpha_{i+1}\left[\text { and } f\left(\alpha_{i}\right)=u_{s, t}\left(\alpha_{i}\right) \text { for all } i \geqslant 1 ;\right.  \tag{2.10}\\
& \left.B_{g}=\underset{i \geqslant 1}{\cup}\right] \beta_{i}, \beta_{i+1}\left[\text { and } g\left(\beta_{i}\right)=u_{s, t}\left(\beta_{i}\right) \text { for all } i \geqslant 1 .\right. \tag{2.11}
\end{align*}
$$

By using Lagrange's finite-increment theorem, we can assert that there exists two sequences $\left\{x_{i}\right\}_{i \geqslant 1}$ and $\left\{y_{i}\right\}_{i \geqslant 1}$ with $\alpha_{i}<x_{i}<\alpha_{i+1}$ and $\beta_{i}<y_{i}<\beta_{i+1}$ such that:

$$
\begin{align*}
& k_{u}(s, t)=f^{\prime}\left(x_{i}\right) \text { for all } i \geqslant 1  \tag{2.12}\\
& k_{u}(s, t)=g^{\prime}\left(y_{i}\right) \text { for all } i \geqslant 1 \tag{2.13}
\end{align*}
$$

For $h \in C([a, b])$ we set $\|h\|_{\infty}:=\sup \{|h(x)|: x \in[a, b]\}$. From the above it follows that:

$$
\begin{align*}
& \left|u_{s, t}(x)\right| \leqslant \max \left\{\|f\|_{\infty},\|g\|_{\infty}\right\}+\left\|f^{\prime}\right\|_{\infty}(b-a) \text { for all } x \in A_{f} ;  \tag{2.14}\\
& \left|u_{s, t}(x)\right| \leqslant \max \left\{\|f\|_{\infty},\|g\|_{\infty}\right\}+\left\|g^{\prime}\right\|_{\infty}(b-a) \text { for all } x \in B_{g} . \tag{2.15}
\end{align*}
$$

Indeed, given $x \in A_{f}$ there exists $i \geqslant 1$ such that $\left.x \in\right] \alpha_{i}, \alpha_{i+1}$. Hence, using (2.12) we have

\left|u_{s, t}(x)\right| & \leqslant|u(s)|+\left|k_{u}(s, t)\right||x-s| \\
& \leqslant|u(s)|+\left|f^{\prime}\left(x_{i}\right)\right|(b-a) \\

\end{aligned}

and (2.14) follows because $f \leqslant u \leqslant g$. By using the same reasoning with (2.13) instead of (2.12) we obtain (2.15). Moreover, it is easy to see that:

- $x \in[a, b]$;
- $|f(x)| \leqslant\|f\|_{\infty},\left|f^{\prime}(x)\right| \leqslant\left\|f^{\prime}\right\|_{\infty},|g(x)| \leqslant\|g\|_{\infty}$ and $\left|g^{\prime}(x)\right| \leqslant\left\|g^{\prime}\right\|_{\infty}$ for all $x \in[a, b]$;
- $\left|k_{u}(s, t)\right| \leqslant \max \left\{\left\|f^{\prime}\right\|_{\infty},\left\|g^{\prime}\right\|_{\infty}\right\}$ by (2.12) and (2.13),
and consequently, we have:
- $\left(x, f(x), f^{\prime}(x)\right) \in[a, b] \times\left[-M_{1}, M_{1}\right] \times\left[-M_{2}, M_{2}\right]$ for all $x \in A_{f}$;
- $\left(x, g(x), g^{\prime}(x)\right) \in[a, b] \times\left[-M_{1}, M_{1}\right] \times\left[-M_{2}, M_{2}\right]$ for all $x \in B_{g}$;
- $\left(x, u_{s, t}(x), k_{u}(s, t)\right) \in[a, b] \times\left[-M_{1}, M_{1}\right] \times\left[-M_{2}, M_{2}\right]$ for all $x \in A_{f} \cup B_{g}$.

But, using $\left(\mathrm{H}_{1}\right)$ we can assert that

\left|L\left(x_{1}, u_{1}, v_{1}\right)-L\left(x_{2}, u_{2}, v_{2}\right)\right| \leqslant C_{0}\left(\left|x_{1}-x_{2}\right|+\left|u_{1}-u_{2}\right|+\left|v_{1}-v_{2}\right|\right)^{\alpha_{0}}
$$

for all $\left(x_{1}, u_{1}, v_{1}\right),\left(x_{2}, u_{2}, v_{2}\right) \in[a, b] \times\left[-M_{1}, M_{1}\right] \times\left[-M_{2}, M_{2}\right]$, and so:

- $\left|L\left(x, f(x), f^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| \leqslant C_{0}\left(\left|f(x)-u_{s, t}(x)\right|+\left|f^{\prime}(x)-k_{u}(s, t)\right|\right)^{\alpha_{0}}$ for all $x \in A_{f}$;
- $\left|L\left(x, g(x), g^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| \leqslant C_{0}\left(\left|g(x)-u_{s, t}(x)\right|+\left|g^{\prime}(x)-k_{u}(s, t)\right|\right)^{\alpha_{0}}$ for all $x \in B_{g}$.
Fix any $x \in A_{f}$. Then, by (2.10) there exists $i \geqslant 1$ such that $\left.x \in\right] \alpha_{i}, \alpha_{i+1}[$ and, since $f\left(\alpha_{i}\right)=u_{s, t}\left(\alpha_{i}\right)$, we see that

& =\left|f(x)-f\left(\alpha_{i}\right)\right|+\left|k_{u}(s, t)\right|\left|x-\alpha_{i}\right| \\
& \leqslant \omega_{f}(|s-t|)+\left|k_{u}(s, t)\right||s-t| .
\end{aligned}
$$

Moreover, by (2.12) we have

\left|f^{\prime}(x)-k_{u}(s, t)\right|=\left|f^{\prime}(x)-f^{\prime}\left(x_{i}\right)\right| \leqslant \omega_{f^{\prime}}(|s-t|) .

Consequently

\left|L\left(x, f(x), f^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| \leqslant \omega_{1}\left(\left|k_{u}(s, t)\right|,|s-t|\right) \text { for all } x \in A_{f} \tag{2.16}
\end{equation*}
$$

with $\omega_{1}:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ given by

$$
\begin{equation*}
\omega_{1}(k, \varepsilon):=C_{0}\left(\omega_{f}(\varepsilon)+\omega_{f^{\prime}}(\varepsilon)+k \varepsilon\right)^{\alpha_{0}} . \tag{2.17}
\end{equation*}
$$

In the same manner, by using (2.11) and (2.13) instead of (2.10) and (2.12), we obtain

\left|L\left(x, g(x), g^{\prime}(x)\right)-L\left(x, u_{s, t}(x), k_{u}(s, t)\right)\right| \leqslant \omega_{2}\left(\left|k_{u}(s, t)\right|,|s-t|\right) \text { for all } x \in B_{g} \tag{2.18}
\end{equation*}
$$

with $\omega_{2}:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ given by

\begin{equation*}
\omega_{2}(k, \varepsilon):=C_{0}\left(\omega_{g}(\varepsilon)+\omega_{g^{\prime}}(\varepsilon)+k \varepsilon\right)^{\alpha_{0}} . \tag{2.19}
\end{equation*}
$$

Step 3: end of the proof. Let $\omega:[0, \infty[\times[0, \infty[\rightarrow[0, \infty[$ be defined by

& =\mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\omega_{1}\left(\left|k_{u}(s, t)\right|,|s-t|\right)\left|A_{f}\right|+\omega_{2}\left(\left|k_{u}(s, t)\right|,|s-t|\right)\left|B_{g}\right| .
\end{aligned}
$$

But $A_{f}$ and $B_{g}$ are subsets of $] s, t\left[\right.$, hence $\left|A_{f}\right| \leqslant|s-t|$ and $\left|B_{g}\right| \leqslant|s-t|$, and consequently

$$
\begin{aligned}
\mathcal{J}_{L}(u ;[a, b]) & \leqslant \mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\left(\omega_{1}\left(\left|k_{u}(s, t)\right|,|s-t|\right)+\omega_{2}\left(\left|k_{u}(s, t)\right|,|s-t|\right)\right)|s-t| \\
& =\mathcal{J}_{L}\left(u_{s, t} ;[a, b]\right)+\omega\left(\left|k_{u}(s, t)\right|,|s-t|\right)|s-t|
\end{aligned}
$$

which shows that $\left(\mathrm{A}_{3}\right)$ is verified.
Remark 2.7. In the proof of Lemma 2.6 we have in fact established that $\left(\mathrm{A}_{3}\right)$ holds without any restriction that $|s-t|<\delta_{0}$.

As a consequence of Theorem [2.5 and Lemma 2.6, we have
Theorem 2.8. Assume that $\left(\mathrm{H}_{1}\right)$ and $\left(\mathrm{H}_{2}\right)$ are satisfied and the obstacles $f$ and $g$ belong to $C^{1}([a, b])$. If (1.2) holds then

\begin{equation*}
\mathcal{S}_{f, g} \subset W_{T}^{1,1}([a, b]) \tag{2.20}
\end{equation*}
$$

i.e., every solution of the variational obstacle problem (1.1) has Tonelli's partial regularity.

Proof of Theorem 2.8. Let $u \in \mathcal{S}_{f, g}$. To show that $u \in W_{T}^{1,1}([a, b])$ it suffices to prove that $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ holds with $K=\{(x, u) \in[a, b] \times \mathbb{R}: f(x) \leqslant u \leqslant g(x)\}, \delta_{0} \in \Delta_{c}$ with $c=\left|\mathcal{J}_{L}(u ;[a, b])\right|+1$ and $\omega$ given by (2.8). (Indeed, from Lemma 2.6 we then have $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ and so $u \in W_{T}^{1,1}([a, b])$ by Theorem [2.5.) According to (2.8) and (2.4) it is easily seen that to verify $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ we only need to establish that for $N>0$ given by Remark 2.3, one has:

& \lim _{\varepsilon \rightarrow 0} \int_{0}^{\mathrm{e} \varepsilon}\left[\omega_{h}(\xi+N \sqrt{\xi})\right]^{\frac{1}{4} \alpha_{0}} \frac{d \xi}{\xi}=0  \tag{2.22}\\
& \lim _{\varepsilon \rightarrow 0} \int_{0}^{\mathrm{e} \varepsilon}\left[\omega_{h}(\xi+N \sqrt{\xi})\right]^{\frac{1}{2} \alpha_{0}} \frac{d \xi}{\xi}=0  \tag{2.23}\\
& \lim _{\varepsilon \rightarrow 0} \int_{0}^{\mathrm{e} \varepsilon}[\xi+N \sqrt{\xi}]^{\beta} \frac{d \xi}{\xi}=0 \text { for all } \beta>0 . \tag{2.24}
\end{align*}
$$

But (2.21), (2.22) and (2.23) are clearly true by applying (1.2) with $\gamma=N$ and respectively $\theta=\frac{1}{4} \alpha_{0} \alpha(k), \theta=\frac{1}{4} \alpha_{0}$ and $\theta=\frac{1}{2} \alpha_{0}$. Moreover, for every $\varepsilon>0$ we have

\int_{0}^{\mathrm{e} \varepsilon}[\xi+N \sqrt{\xi}]^{\beta} \frac{d \xi}{\xi} & \leqslant C\left(\int_{0}^{\mathrm{e} \varepsilon} \xi^{\beta-1} d \xi+N^{\beta} \int_{0}^{\mathrm{e} \varepsilon} \xi^{\frac{1}{2} \beta-1} d \xi\right) \\
& =C\left(\frac{(\mathrm{e} \varepsilon)^{\beta}}{\beta}+2 N^{\beta} \frac{(\mathrm{e} \varepsilon)^{\frac{1}{2} \beta}}{\beta}\right)
\end{aligned}
$$

with $C>0$ (depending on $\beta$ ). Hence (2.24) holds, and the proof is complete.
As a direct consequence of Theorem 2.8 we have
Corollary 2.9. If $\left(\mathrm{H}_{1}\right)$ and $\left(\mathrm{H}_{2}\right)$ are satisfied and the obstacles $f$ and $g$ belong to $C^{1, \sigma}([a, b])$, then (2.20) holds.

Proof of Corollary [2.9. As the obstacles $f$ and $g$ belong to $C^{1, \sigma}([a, b])$, we have

for all $h \in\left\{f, f^{\prime}, g, g^{\prime}\right\}$, all $\xi \geqslant 0$ and some $c>0$, and (1.2) follows.

## 3. A technical lemma

In this section we prove the following technical lemma which is a generalization of [Syc92, Lemma 1.1]. (This lemma plays an essential role in the proof of Theorem 2.5.)

Lemma 3.1. Let $c>0$ and let $\delta_{0} \in \Delta_{c}$. If $\left(\mathrm{H}_{1}\right)$, $\left(\mathrm{H}_{2}\right)$ and $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ hold, then there exists

$\left(\mathrm{P}_{1}\right) \delta$ is increasing in both arguments and $\delta(k, 0)=0$ for all $k \in[0, \infty[;$
$\left(\mathrm{P}_{2}\right)$ there exist $C:\left[0, \infty[\rightarrow] 0, \infty\left[\right.\right.$ and $\varepsilon_{0}:\left[0, \infty[\rightarrow] 0, \frac{\delta_{0}}{\mathrm{e}}\right]$ such that

$$
\delta(k, \varepsilon) \leqslant C(k)\left[(\sqrt{\varepsilon})^{\frac{1}{4} \min \left\{\alpha(k), \alpha^{2}(k)\right\}}+\int_{0}^{\mathrm{e} \varepsilon} \bar{\omega}\left(k+\eta_{0}, \xi\right) \frac{d \xi}{\xi}\right]
$$

for all $k \in\left[0, \infty\left[\right.\right.$ and all $\varepsilon \in\left[0, \varepsilon_{0}(k)\right]$ with $\eta_{0}>0$ an arbitrary fixed constant and $\bar{\omega}$ given by (2.4), and so

$$
\begin{equation*}
\lim _{\varepsilon \rightarrow 0} \delta(k, \varepsilon)=0 \tag{3.1}
\end{equation*}
$$

for all $k \in[0, \infty[$.
Moreover, for every $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ one has
$\left(\mathrm{P}_{3}\right)$ for every $x_{1}, x_{2} \in[a, b]$ with $0<x_{2}-x_{1} \leqslant \frac{\delta_{0}}{\mathrm{e}}$,

$$
\begin{equation*}
\left|k_{u}\left(x_{1}, x_{2}\right)-k_{u}(s, t)\right| \leqslant \delta\left(\left|k_{u}\left(x_{1}, x_{2}\right)\right|,\left|x_{1}-x_{2}\right|\right) \tag{3.2}
\end{equation*}
$$

for all $s, t \in\left[x_{1}, x_{2}\right]$ with $s<t$.
Proof of Lemma 3.1. For each $(t, y, p) \in[a, b] \times \mathbb{R} \times \mathbb{R}$ we define $L_{(t, y, p)}:[a, b] \times \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$ by

\end{equation*}

for all $x_{1}, x_{2} \in[a, b]$ such that $0<x_{2}-x_{1} \leqslant \delta_{0}$.

Step 1: using $\left(\mathbf{H}_{\mathbf{1}}\right)$ and $\left(\mathbf{H}_{\mathbf{2}}\right)$. For each $k \in\left[0, \infty\left[\right.\right.$ and each $\varepsilon \in\left[0, \widehat{\delta}_{0}\right]$, where $\widehat{\delta}_{0}:=$ $\delta_{0}+N \sqrt{\delta_{0}}$ with $N>0$ given by Remark [2.3, we consider $I_{k, \varepsilon} \subset[0, \infty[$ defined as the set of $M \geqslant 0$ such that for all $x_{1}, x_{2}, x_{3} \in[a, b]$, all $u_{1}, u_{2}, u_{3} \in \mathbb{R}$ and all $p \in \mathbb{R}$ with

\end{equation*}

where $\mu>0$ is given by $\left(\mathrm{H}_{2}\right)$. Let $\Delta_{1}:\left[0, \infty\left[\times\left[0, \widehat{\delta}_{0}\right] \rightarrow[0, \infty[\right.\right.$ be defined by

It is clear that $\Delta_{1}$ is increasing in both arguments and $\Delta_{1}(k, 0)=0$ for all $k \in[0, \infty[$. We claim that there exist $C_{1}, \alpha:[0, \infty[\rightarrow] 0, \infty[$ such that

Let $x_{1}, x_{2}, x_{3} \in[a, b], u_{1}, u_{2}, u_{3} \in \mathbb{R}$ and $p \in \mathbb{R}$ be such that (3.4) is satisfied. First of all, using $\left(\mathrm{H}_{2}\right)$, for every $\zeta \in \mathbb{R}$ we have

& -L_{v}\left(x_{1}, u_{1}, p\right) \zeta-L\left(x_{2}, u_{2}, p\right)+L\left(x_{2}, u_{2}, p\right) \\
& -L\left(x_{3}, u_{3}, p\right) \\
\geqslant & L\left(x_{2}, u_{2}, p+\zeta\right)-L_{v}\left(x_{2}, u_{2}, p\right) \zeta-L\left(x_{2}, u_{2}, p\right) \\
& -\left(\left|L_{v}\left(x_{2}, u_{2}, p\right)\right|+\left|L_{v}\left(x_{1}, u_{1}, p\right)\right|\right)|\zeta| \\
& -\left(\left|L\left(x_{2}, u_{2}, p\right)\right|+\left|L\left(x_{3}, u_{3}, p\right)\right|\right) \\
\geqslant & \frac{\mu}{2} \zeta^{2}-2 c(k)(|\zeta|+1)
\end{aligned}
$$

where $\mu>0$ is given by $\left(\mathrm{H}_{2}\right)$ and $c(k) \geqslant 0$ by (2.7). Consequently, considering $M(k)>0$ with the property (2.6) and using the fact that $\omega(k, \cdot)$ is increasing, we can assert that

& +L_{\left(x_{1}, u_{1}, p\right)}\left(x_{1}, u_{1}, p+\zeta\right)-L_{\left(x_{1}, u_{1}, p\right)}\left(x_{1}, u_{1}, p\right) \\
& -\left|L_{\left(x_{1}, u_{1}, p\right)}\left(x_{1}, u_{1}, p\right)-L_{\left(x_{1}, u_{1}, p\right)}\left(x_{3}, u_{3}, p\right)\right| .
\end{aligned}
$$

Let $C_{1}(k)>0$ and $\alpha(k)>0$ be given by $\left(\mathrm{H}_{1}\right)$ with $G=K_{0} \times[-(k+M(k)), k+M(k)]$ where $K_{0}$ is given by (2.5). Then, for every $\zeta \in \mathbb{R}$ such that $|\zeta| \leqslant M(k)$ we have

\begin{aligned}
L_{\left(x_{1}, u_{1}, p\right)}\left(x_{2}, u_{2}, p+\zeta\right)-L_{\left(x_{1}, u_{1}, p\right)}\left(x_{3}, u_{3}, p\right) \geqslant & -2 C_{1}(k) \varepsilon^{\alpha(k)} \\
& +L_{\left(x_{1}, u_{1}, p\right)}\left(x_{1}, u_{1}, p+\zeta\right)-L_{\left(x_{1}, u_{1}, p\right)}\left(x_{1}, u_{1}, p\right)

& \geqslant \frac{\mu}{2} \zeta^{2}
\end{aligned}
$$

and so

|\zeta| \leqslant M(k) \Rightarrow L_{\left(x_{1}, u_{1}, p\right)}\left(x_{2}, u_{2}, p+\zeta\right)-L_{\left(x_{1}, u_{1}, p\right)}\left(x_{3}, u_{3}, p\right) \geqslant-2 C_{1}(k) \varepsilon^{\alpha(k)}+\frac{\mu}{2} \zeta^{2} .

For each $k \in\left[0, \infty\left[\right.\right.$ and each $\varepsilon \in\left[0, \widehat{\delta}_{0}\right]$ we consider $J_{k, \varepsilon} \subset[0, \infty[$ defined as the set of all $M=\left|L_{\left(x_{1}, u_{1}, p_{1}\right)}\left(x_{2}, u_{2}, p_{2}\right)-L_{\left(x_{1}, u_{1}, p_{1}\right)}\left(x_{3}, u_{3}, p_{3}\right)+\omega(k, \varepsilon)\right|$ for which $x_{1}, x_{2}, x_{3} \in[a, b]$, $u_{1}, u_{2}, u_{3} \in \mathbb{R}$ and $p_{1}, p_{2}, p_{3} \in \mathbb{R}$ are such that

It is easy to see that for each $x_{1}, x_{2}, x_{3} \in[a, b]$, each $u_{1}, u_{2}, u_{3} \in \mathbb{R}$ and each $p_{1}, p_{2}, p_{3} \in \mathbb{R}$ satisfying (3.9), we have

But $\left|L\left(x_{2}, u_{2}, p_{2}\right)-L\left(x_{3}, u_{3}, p_{3}\right)\right| \leqslant C_{1}(k)\left(\varepsilon+\Delta_{1}(k, \varepsilon)\right)^{\alpha(k)}$ because $L$ is $\alpha(k)$-Hölder continuous on the compact $K_{0} \times[-(k+M(k)), k+M(k)]$ and $\left(x_{2}, u_{2}, p_{2}\right),\left(x_{3}, u_{3}, p_{3}\right) \in K_{0} \times[-k, k]$. Moreover, using the continuity of $L_{v}$ on the compact $K \times[-k, k]$ we deduce that there exists

(with $N>0$ given by Remark 2.31). It is clear that $\Delta$ is increasing in both arguments and $\Delta(k, 0)=0$ for all $k \in\left[0, \infty\left[\right.\right.$. From (3.11) and (3.12) we see that there exists $C_{4}:[0, \infty[\rightarrow$ $] 0, \infty[$ such that

For each $k \in\left[0, \infty\left[\right.\right.$ and each $\varepsilon \in\left[0, \frac{\delta_{0}}{\mathrm{e}}\right]$ we consider $A_{k, \varepsilon} \subset[0, \infty[$ given by

Given any $k \in\left[0, \infty\left[\right.\right.$, from $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$ we have $\lim _{\varepsilon \rightarrow 0} \int_{0}^{e \varepsilon} \bar{\omega}\left(k+\eta_{0}, \zeta\right) \frac{d \zeta}{\zeta}=0$, and so $\lim _{\varepsilon \rightarrow 0} 4 \int_{0}^{\mathrm{e} \varepsilon} \Delta\left(k+\eta_{0}, \zeta\right) \frac{d \zeta}{\zeta}=0$ by using (3.14). From the above we see that, under $\left(\mathrm{H}_{\omega}^{K, \delta_{0}}\right)$, we have $A_{k, \varepsilon} \neq \varnothing$ for all $k \in[0, \infty[$ and all $\varepsilon \in\left[0, \varepsilon_{0}(k)\right]$. Given $k \in\left[0, \infty\left[\right.\right.$ and $\varepsilon \in\left[0, \varepsilon_{0}(k)\right]$ there exists $\left\{\delta_{n}\right\}_{n \geqslant 1} \subset A_{k, \varepsilon}$ such that $\lim _{n \rightarrow \infty} \delta_{n}=\delta(k, \varepsilon)$ and $\delta(k, \varepsilon) \leqslant \delta_{n}$ for all $n \geqslant 1$. Step 3: proving $\left(\mathbf{P}_{\mathbf{3}}\right)$. Let $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ and let $x_{1}, x_{2} \in[a, b]$ be such that $0<$ $x_{2}-x_{1} \leqslant \frac{\delta_{0}}{\mathrm{e}}$. For simplicity of notation, set:

\end{aligned}

On the other hand, using again the fact that $\omega\left(\left|k_{1}\right|, \cdot\right)$ is increasing, if $x \in\left[x_{1}, x_{2}\right] \backslash T$ then

Consequently $\left(\mathrm{P}_{3}\right)$ is satisfied for all $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$, and the proof of Lemma 3.1 is complete.

(From (3.23) we see that $\varepsilon_{n}=\frac{1}{\mathrm{e}^{n-1}} \varepsilon$ for all $n \geqslant 1$, and so $\lim _{n \rightarrow \infty} \varepsilon_{n}=0$ with $\varepsilon_{1}>\varepsilon_{2}>$ $\cdots>\varepsilon_{n}>\varepsilon_{n+1}>\cdots$.)
Taking Remark 3.2 into account and noticing that $\left.\left.\cup_{n=1}^{\infty}\left[\mathrm{e} \varepsilon_{n+1}, \mathrm{e} \varepsilon_{n}\right]=\cup_{n=1}^{\infty}\left[\varepsilon_{n}, \mathrm{e} \varepsilon_{n}\right]=\right] 0, \mathrm{e} \varepsilon\right]$, we see that

$$
\begin{aligned}
\delta(|k|, \varepsilon) \geqslant 4 \int_{0}^{\mathrm{e} \varepsilon} \Delta(|k|+\delta(|k|, \varepsilon), \xi) \frac{d \xi}{\xi} & =4 \int_{\underset{n=1}{\infty}\left[\varepsilon_{n}, \mathrm{e} \varepsilon_{n}\right]} \Delta(|k|+\delta(|k|, \varepsilon), \xi) \frac{d \xi}{\xi} \\
& =4 \sum_{n=1}^{\infty} \int_{\varepsilon_{n}}^{\mathrm{e} \varepsilon_{n}} \Delta(|k|+\delta(|k|, \varepsilon), \xi) \frac{d \xi}{\xi} .
\end{aligned}
$$

Using the fact that $\Delta:\left[0, \infty\left[\times\left[0, \delta_{0}\right] \rightarrow[0, \infty[\right.\right.$ defined by (3.13) is increasing in both arguments, it follows that

$$
\begin{align*}
\delta(|k|, \varepsilon) & \geqslant 4 \sum_{n=1}^{\infty} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right) \int_{\varepsilon_{n}}^{\mathrm{e} \varepsilon_{n}} \frac{d \xi}{\xi} \\
& =4 \sum_{n=1}^{\infty} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right)\left[\ln \left(\mathrm{e} \varepsilon_{n}\right)-\ln \left(\varepsilon_{n}\right)\right] \\
& =4 \sum_{n=1}^{\infty} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right) \tag{3.24}
\end{align*}
$$

Thus, to prove (3.2) it is sufficient to establish the following assertion:

\forall m \geqslant 1 \mathcal{P}(m) \tag{3.25}
\end{equation*}
$$

with $\mathcal{P}(m)$ given by

$$
\forall x_{1} \leqslant \sigma<\tau \leqslant x_{2}\left[I_{m+1} \subset[\sigma, \tau] \subset I_{m} \Rightarrow\left|k-k_{u}(\sigma, \tau)\right| \leqslant 4 \sum_{n=1}^{m} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right)\right]
$$

Indeed, applying (3.25) with $m=n_{0}, \sigma=s$ and $\tau=t$, we have

$$
\left|k-k_{u}(s, t)\right| \leqslant 4 \sum_{n=1}^{n_{0}} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right)
$$

and (3.2) follows by using (3.24) together with the fact that $4 \sum_{n=1}^{n_{0}} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right) \leqslant$ $4 \sum_{n=1}^{\infty} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right)$.

Proof of (3.25). We proceed by induction on $m$.

Step 1: base case. Assume that $\mathcal{P}(1)$ is false. Then, there exists $\sigma, \tau \in\left[x_{1}, x_{2}\right]$ with $\sigma<\tau$ such that $I_{2} \subset[\sigma, \tau] \subset I_{1}$ and $\left|k-k_{u}(\sigma, \tau)\right|>4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)$. But $\left|k-k_{u}\left(x_{1}, x_{2}\right)\right|=0$ (because $k=k_{u}\left(x_{1}, x_{2}\right)$ ) with $I_{2} \subset\left[x_{1}, x_{2}\right]=I_{1}$, so by continuity arguments (see Remark 3.4) we can assert that there exist $\bar{\sigma}, \bar{\tau} \in\left[x_{1}, x_{2}\right]$ with $\bar{\sigma}<\bar{\tau}$ such that:

\begin{align*}
& {\left[x_{1}^{2}, x_{2}^{2}\right]=I_{2} \subset[\bar{\sigma}, \bar{\tau}] \subset I_{1}}  \tag{3.26}\\
& \left|k-k_{u}(\bar{\sigma}, \bar{\tau})\right|=4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right) . \tag{3.27}
\end{align*}
$$

Remark 3.4. The existence of $\bar{\sigma}, \bar{\tau} \in\left[x_{1}, x_{2}\right]$ with $\bar{\sigma}<\bar{\tau}$ satisfying (3.26) and (3.27) can be derived as follows. Let $\Psi:\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right] \rightarrow\left[0, \infty\left[\right.\right.$ be defined by $\Psi(y, z):=\left|k-k_{u}(y, z)\right|$. Since $\Psi$ is continuous and $\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]$ is connected, $\Psi\left(\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]\right)$ is an interval. But $0=\Psi\left(x_{1}, x_{2}\right) \in \Psi\left(\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]\right), \Psi(\sigma, \tau) \in \Psi\left(\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]\right)$ and $0 \leqslant 4 \Delta(|k|+$ $\left.\delta(|k|, \varepsilon), \varepsilon_{1}\right)<\Psi(\sigma, \tau)$, hence $4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right) \in \Psi\left(\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]\right)$. Consequently, there exist $(\bar{\sigma}, \bar{\tau}) \in\left[x_{1}, \sigma\right] \times\left[\tau, x_{2}\right]$ such that $\Psi(\bar{\sigma}, \bar{\tau})=4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)$, which is the desired conclusion.

Set:

- $A:=\left\{x \in\left[x_{1}, x_{2}\right]:\left|u^{\prime}(x)-k\right| \geqslant 2 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)\right\} ;$
- $B:=\left\{x \in[\bar{\sigma}, \bar{\tau}]:\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right| \geqslant 2 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)\right\}$.

Then

$$
\begin{equation*}
[\bar{\sigma}, \bar{\tau}] \backslash B \subset A \tag{3.28}
\end{equation*}
$$

Indeed, if $x \in[\bar{\sigma}, \bar{\tau}] \backslash B$ then $x \in I_{1}=\left[x_{1}, x_{2}\right]$ by the right inclusion in (3.26) and $\mid u^{\prime}(x)-$ $k_{u}(\bar{\sigma}, \bar{\tau}) \mid<2 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)$. But, we have

$$
\left|k-k_{u}(\bar{\sigma}, \bar{\tau})\right| \leqslant\left|u^{\prime}(x)-k\right|+\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right|,
$$

hence, using (3.27),

$$
4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right) \leqslant\left|u^{\prime}(x)-k\right|+2 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)
$$

and so $\left|u^{\prime}(x)-k\right| \geqslant 2 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)$, which implies that $x \in A$. On the other hand, since $2 \Delta \geqslant \Delta,|k|+\delta(|k|, \varepsilon) \geqslant|k|$ and $\Delta\left(\cdot, \varepsilon_{1}\right)$ is increasing, it is clear that $A \subset \Omega_{x_{1}, x_{2}}$, where $\Omega_{x_{1}, x_{2}}$ is defined by (3.21) with $y=x_{1}$ and $z=x_{2}$. Recalling that $\varepsilon_{1}=\varepsilon=\left|x_{1}-x_{2}\right|$ and using (3.20) and the fact that $\Delta\left(\cdot, \varepsilon_{1}\right)$ is increasing, we deduce that

$$
\begin{align*}
\int_{A}\left|u^{\prime}(x)-k\right|^{2} d x \leqslant \int_{\Omega_{x_{1}, x_{2}}}\left|u^{\prime}(x)-k\right|^{2} d x & \leqslant \Delta^{2}\left(|k|,\left|x_{1}-x_{2}\right|\right)\left|x_{1}-x_{2}\right| \\
& \leqslant \Delta^{2}\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)\left|x_{1}-x_{2}\right| \tag{3.29}
\end{align*}
$$

But, by definition of $A$, we have

$$
\begin{equation*}
4 \Delta^{2}\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)|A| \leqslant \int_{A}\left|u^{\prime}(x)-k\right|^{2} d x \tag{3.30}
\end{equation*}
$$

and so, combining (3.29) with (3.30), we obtain the following inequality:

\begin{equation*}
|A| \leqslant \frac{1}{4}\left|x_{1}-x_{2}\right| \tag{3.31}
\end{equation*}
$$

From (3.27) it is easily seen that $\left|k_{u}(\bar{\sigma}, \bar{\tau})\right| \leqslant|k|+4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)$, hence $\left|k_{u}(\bar{\sigma}, \bar{\tau})\right| \leqslant$ $|k|+\delta(|k|, \varepsilon)$ by (3.24), and so $\Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right) \geqslant \Delta\left(\left|k_{u}(\bar{\sigma}, \bar{\tau})\right|,|\bar{\sigma}-\bar{\tau}|\right)$ because $\Delta$ is
increasing in both arguments. Thus $B \subset \Omega_{\bar{\sigma}, \bar{\tau}}$, where $\Omega_{\bar{\sigma}, \bar{\tau}}$ is defined by (3.21) with $y=\bar{\sigma}$ and $z=\bar{\tau}$. Using (3.20) it follows that

$$
\begin{aligned}
\int_{B}\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right|^{2} d x \leqslant \int_{\Omega_{\bar{\sigma}, \bar{\tau}}}\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right|^{2} d x & \leqslant \Delta^{2}\left(\left|k_{u}(\bar{\sigma}, \bar{\tau})\right|,|\bar{\sigma}-\bar{\tau}|\right)|\bar{\sigma}-\bar{\tau}| \\
& \leqslant \Delta^{2}\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)|\bar{\sigma}-\bar{\tau}|
\end{aligned}
$$

which combined with that fact that by definition of $B$ we have

$$
4 \Delta^{2}\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{1}\right)|B| \leqslant \int_{B}\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right|^{2} d x
$$

gives the following inequality:

$$
\begin{equation*}
|B| \leqslant \frac{1}{4}|\bar{\sigma}-\bar{\tau}| . \tag{3.32}
\end{equation*}
$$

From (3.28) we see that $|\bar{\sigma}-\bar{\tau}| \leqslant|A|+|B|$, hence $|\bar{\sigma}-\bar{\tau}| \leqslant \frac{1}{4}\left|x_{1}-x_{2}\right|+\frac{1}{4}|\bar{\sigma}-\bar{\tau}|$ by using (3.31) and (3.32), and so $3|\bar{\sigma}-\bar{\tau}| \leqslant\left|x_{1}-x_{2}\right|$. On the other hand, from the left inclusion in (3.26) we see that $\left|I_{2}\right|=\left|x_{1}^{2}-x_{2}^{2}\right| \leqslant|\bar{\sigma}-\bar{\tau}|$, hence $\frac{1}{e}\left|x_{1}-x_{2}\right| \leqslant|\bar{\sigma}-\bar{\tau}|$, i.e., $\left|x_{1}-x_{2}\right| \leqslant \mathrm{e}|\bar{\sigma}-\bar{\tau}|$, by (3.23). It follows that $3|\bar{\sigma}-\bar{\tau}| \leqslant \mathrm{e}|\bar{\sigma}-\bar{\tau}|$, which is impossible.
Step 2: induction. Let $m \geqslant 1$ be such that $\mathcal{P}(m)$ is true. Then, as $I_{m+1}=\left[x_{1}^{m+1}, x_{2}^{m+1}\right] \subset$ $I_{m}$ we can apply $\mathcal{P}(m)$ with $[\sigma, \tau]=I_{m+1}$, and we have

$$
\left|k-k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)\right| \leqslant 4 \sum_{n=1}^{m} \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{n}\right) .
$$

Thus, it is easily seen that for proving that $\mathcal{P}(m+1)$ is true, it is sufficient to establish that $\forall x_{1} \leqslant \sigma<\tau \leqslant x_{2}\left[I_{m+2} \subset[\sigma, \tau] \subset I_{m+1} \Rightarrow\left|k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)-k_{u}(\sigma, \tau)\right| \leqslant 4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{m+1}\right)\right]$. Assume that this latter assertion is false. Then, arguing as in Step 1, we can assert that there exist $\bar{\sigma}, \bar{\tau} \in\left[x_{1}^{m+1}, x_{2}^{m+1}\right]$ with $\bar{\sigma}<\bar{\tau}$ such that:

- $I_{m+2} \subset[\bar{\sigma}, \bar{\tau}] \subset I_{m+1}$;
- $\left|k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)-k_{u}(\bar{\sigma}, \bar{\tau})\right|=4 \Delta\left(|k|+\delta(|k|, \varepsilon), \varepsilon_{m+1}\right)$.

Set:

- $A_{m+1}:=\left\{x \in\left[x_{1}^{m+1}, x_{2}^{m+1}\right]:\left|u^{\prime}(x)-k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)\right| \geqslant 2 \Delta\left(\left|k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)\right|+\right.\right.$ $\left.\left.\delta(|k|, \varepsilon), \varepsilon_{m+1}\right)\right\} ;$
- $B_{m+1}:=\left\{x \in[\bar{\sigma}, \bar{\tau}]:\left|u^{\prime}(x)-k_{u}(\bar{\sigma}, \bar{\tau})\right| \geqslant 2 \Delta\left(\left|k_{u}\left(x_{1}^{m+1}, x_{2}^{m+1}\right)\right|+\delta(|k|, \varepsilon), \varepsilon_{m+1}\right)\right\}$.

Using the same method as in Step 1, we can establish that $\left|A_{m+1}\right| \leqslant \frac{1}{4}\left|x_{1}^{m+1}-x_{2}^{m+1}\right|,\left|B_{m+1}\right| \leqslant$ $\frac{1}{4}|\bar{\sigma}-\bar{\tau}|$ and $[\bar{\sigma}, \bar{\tau}] \backslash B_{m+1} \subset A_{m+1}$. This latter inclusion implies that $|\bar{\sigma}-\bar{\tau}| \leqslant\left|A_{m+1}\right|+\left|B_{m+1}\right|$, and so $3|\bar{\sigma}-\bar{\tau}| \leqslant\left|x_{1}^{m+1}-x_{2}^{m+1}\right|$. On the other hand, as $\left[x_{1}^{m+2}, x_{2}^{m+2}\right]=I_{m+2} \subset[\bar{\sigma}, \bar{\tau}]$ we have $\left|x_{1}^{m+2}-x_{2}^{m+2}\right| \leqslant|\bar{\sigma}-\bar{\tau}|$, hence $\frac{1}{\mathrm{e}}\left|x_{1}^{m+1}-x_{2}^{m+1}\right| \leqslant|\bar{\sigma}-\bar{\tau}|$, i.e., $\left|x_{1}^{m+1}-x_{2}^{m+1}\right| \leqslant \mathrm{e}|\bar{\sigma}-\bar{\tau}|$, by (3.23). It follows that $3|\bar{\sigma}-\bar{\tau}| \leqslant \mathrm{e}|\bar{\sigma}-\bar{\tau}|$, which is impossible.

## 4. Proof of the general regularity theorem

In this section we prove Theorem 2.5 (see §4.2).
4.1. Auxiliary lemmas. To prove Theorem [2.5 we need the following lemmas.

Lemma 4.1. Under the hypotheses of Theorem 2.5, if $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ has a finite derived number $d \in \mathbb{R}$ at $\bar{x} \in] a, b\left[\right.$, i.e., there exist two sequences $\left\{s_{n}\right\}_{n \geqslant 1}$ and $\left\{t_{n}\right\}_{n \geqslant 1}$ with $s_{n}<\bar{x}<t_{n}$ such that:

$$
\begin{align*}
& \lim _{n \rightarrow \infty} s_{n}=\lim _{n \rightarrow \infty} t_{n}=\bar{x}  \tag{4.1}\\
& \lim _{n \rightarrow \infty} k_{u}\left(s_{n}, t_{n}\right)=d, \tag{4.2}
\end{align*}
$$

then $u$ is differentiable at $\bar{x}$ and $u^{\prime}(x)=d$.
Lemma 4.1-bis. Under the hypotheses of Theorem 2.5, if $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$ has a finite derived number $d \in \mathbb{R}$ at a (resp. b), i.e., there exists a sequence $\left\{t_{n}\right\}_{n \geqslant 1}$ (resp. $\left\{s_{n}\right\}_{n \geqslant 1}$ ) with $\bar{x}<t_{n}$ (resp. $s_{n}<\bar{x}$ ) such that:

$$
\begin{align*}
& \lim _{n \rightarrow \infty} t_{n}=\bar{x} \quad\left(\text { resp. } \quad \lim _{n \rightarrow \infty} s_{n}=\bar{x}\right)  \tag{4.3}\\
& \left.\lim _{n \rightarrow \infty} k_{u}\left(a, t_{n}\right)=d \quad \text { (resp. } \lim _{n \rightarrow \infty} k_{u}\left(s_{n}, b\right)=d\right), \tag{4.4}
\end{align*}
$$

then $u$ is differentiable at a (resp. b) and $u^{\prime}(a)=d$ (resp. $u^{\prime}(a)=d$ ).
Proof of Lemma 4.1. By (4.2) there exists $M>0$ such that $\left|k_{u}\left(s_{n}, t_{n}\right)\right| \leqslant M$ for all $n \geqslant 1$. Setting $\varepsilon_{n}:=\left|s_{n}-t_{n}\right|$ for all $n \geqslant 1$ (where, because of (4.1), without loss of generality we can assume that $\varepsilon_{n} \leqslant \frac{\delta}{\mathrm{e}}$ for all $n \geqslant 1$ ) from Lemma 3.1, see (3.2), we have

$$
\left|k_{u}(s, t)-k_{u}\left(s_{n}, t_{n}\right)\right| \leqslant \delta\left(M, \varepsilon_{n}\right)
$$

for all $s, t \in\left[s_{n}, t_{n}\right]$ with $s<t$ and all $n \geqslant 1$ (where $\delta$ is given by Lemma 3.1). Thus

$$
\begin{align*}
\left|k_{u}(s, t)-d\right| & \leqslant\left|k_{u}(s, t)-k_{u}\left(s_{n}, t_{n}\right)\right|+\left|k_{u}\left(s_{n}, t_{n}\right)-d\right| \\
& \leqslant \delta\left(M, \varepsilon_{n}\right)+\left|k_{u}\left(s_{n}, t_{n}\right)-d\right| \tag{4.5}
\end{align*}
$$

for all $s, t \in\left[s_{n}, t_{n}\right]$ with $s<t$ and all $n \geqslant 1$. But $\lim _{n \rightarrow \infty} \varepsilon_{n}=0$ by (4.1) and so $\lim _{n \rightarrow \infty} \delta\left(M, \varepsilon_{n}\right)=0$ by (3.1). Moreover $\lim _{n \rightarrow \infty}\left|k_{u}\left(s_{n}, t_{n}\right)-d\right|=0$ by (4.2). So, from (4.5) we can deduce that

$$
\lim _{\substack{s, t \rightarrow \bar{x} \\ s<\bar{x}<t}} k_{u}(s, t)=d,
$$

which proves that $u$ is differentiable at $\bar{x}$ and $u^{\prime}(\bar{x})=d$.
Proof of Lemma 4.1-bis. This follows by similar arguments as in the proof of Lemma 4.1 by using (4.3) and (4.4) instead of (4.1) and (4.2).
Lemma 4.2. Under the hypotheses of Theorem [2.5, for each $C>0$ and each $\eta>0$ there exists $\widehat{\delta}(C, \eta)>0$ such that for every $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$, one has

$$
\left[\left|u^{\prime}(\bar{x})\right|<C \text { and }|x-\bar{x}|<\widehat{\delta}(C, \eta)\right] \Rightarrow\left|u^{\prime}(x)-u^{\prime}(\bar{x})\right| \leqslant \eta
$$

Proof of Lemma 4.2. Let $C>0$ and $\eta>0$. By (3.1) we have

$$
\lim _{\varepsilon \rightarrow 0} \delta(C+\eta, \varepsilon)=0
$$ So, we can assert that there exists $\left.\left.\varepsilon_{C, \eta} \in\right] 0, \frac{\delta_{0}}{\mathrm{e}}\right]$ such that

\begin{equation*}
\delta\left(C+\eta, \varepsilon_{C, \eta}\right)<\frac{\eta}{2} \tag{4.6}
\end{equation*}
$$

Set $\hat{\delta}(C, \eta):=\varepsilon_{C, \eta}$ and fix $u \in \mathcal{L}_{\omega}\left(L, K, c, \delta_{0}\right)$. Let $x, \bar{x} \in[a, b]$ be such that $\left|u^{\prime}(\bar{x})\right|<C$ and $|x-\bar{x}|<\widehat{\delta}(C, \eta)$ with, without loss of generality, $x<\bar{x}$. We claim that

$$
\begin{equation*}
\left|k_{u}(x, \bar{x})-u^{\prime}(\bar{x})\right| \leqslant \frac{\eta}{2} . \tag{4.7}
\end{equation*}
$$

Indeed, otherwise we have $\left|k_{u}(x, \bar{x})-u^{\prime}(\bar{x})\right|>\frac{\eta}{2}$. By definition of $u^{\prime}(\bar{x})$, there exists $\left.x_{1} \in\right] x, \bar{x}[$ such that

\text { - } B:=\left\{y \in \left[x, \bar{x}\left[:\left|k_{u}(y, \bar{x})-u^{\prime}(\bar{x})\right|>\frac{\eta}{2}\right\} .\right.\right.
\end{array}\right.\right.\right.
$$

Then, from the above, $A \neq \varnothing, B \neq \varnothing$ and $A \cap B=\varnothing$. Moreover, both $A$ and $B$ are open in $[x, \bar{x}[$. As $[x, \bar{x}[$ is a connected set it follows that $[x, \bar{x}[\backslash(A \cup B) \neq \varnothing$, and consequently there exists $\bar{y} \in[x, \bar{x}[$ such that

& \leqslant\left|u^{\prime}\left(x_{n}\right)-k_{u}\left(s_{j}^{n}, t_{j}^{n}\right)\right|+\delta\left(\left|k_{u}\left(x_{1}^{n}, x_{2}^{n}\right)\right|,\left|x_{1}^{n}-x_{2}^{n}\right|\right)+\left|k_{u}\left(x_{1}^{n}, x_{2}^{n}\right)-u^{\prime}\left(x_{0}\right)\right| \\

\left[\left|u^{\prime}(\bar{x})\right|<M+1 \text { and }|x-\bar{x}|<\widehat{\delta}(M+1,1)\right] \Rightarrow\left|u^{\prime}(x)-u^{\prime}(\bar{x})\right| \leqslant 1 \tag{4.32}
\end{equation*}
$$

By (4.23) there exists $n_{2} \geqslant n_{1}$ such that $\left|x_{0}-x_{n_{2}}\right|<\hat{\delta}(M+1,1)$. Hence, taking (4.31) into account and using (4.32) (with $x=x_{0}$ and $\bar{x}=x_{n_{2}}$ ), we obtain $\left|u^{\prime}\left(x_{0}\right)-u^{\prime}\left(x_{n_{2}}\right)\right| \leqslant 1$. Consequently, using again (4.31), i.e., $\left|u^{\prime}\left(x_{n_{2}}\right)\right|<M+1$, we deduce that

$$
\left|u^{\prime}\left(x_{0}\right)\right| \leqslant\left|u^{\prime}\left(x_{0}\right)-u^{\prime}\left(x_{n_{2}}\right)\right|+\left|u^{\prime}\left(x_{n_{2}}\right)\right|<M+2,
$$

which contradicts (4.21). (Similarly, we can prove that if $u^{\prime}\left(x_{0}\right)=-\infty$ then $\lim _{x \rightarrow x_{0}} u^{\prime}(x)=$ $-\infty$.)
