# Discrimination between close hypotheses about Weibull and log-Weibull type distributions by the higher order statistics

## 1 Introduction.

The problem of discrimination between similar tailed distributions appears in many applications of extreme value theory, for example, linked with high risk insurance problems, see Gupta and Kundu (2003), Kundu and Raqab (2007). In addition, distributions of the intermediate values are often well-behaved for modeling by standard distributions that differ from asymptotical behavior of the tails. It seems that theory of contiguity of probability measures, see Roussas (1972), is an important instrument of discriminating between families of distributions with close tails and estimating of power of various discriminating tests. In presented work asymptotical behavior of the ratio of likelihoods

as $n \rightarrow \infty, k_{n} \rightarrow \infty, \frac{n}{k_{n}} \rightarrow \infty$ is considered for the family of distributions with the infinite right point

$$
\begin{equation*}
f(x, \gamma)=\exp (-S(x, \gamma)) \tag{2}
\end{equation*}
$$

where the function $S(x, \gamma)$ is positive starting from some $x_{0}(\gamma)>0$. Suppose the function $S(x, \gamma)$ is strictly monotone and 4 times continuously differentiable by $x$ for all $\gamma$ and $x>$ $x_{0}(\gamma)>0$. There are two types of regularity conditions that will be imposed on the function $S(x, \gamma)$ in our work. The first type makes possible to find the asymptotical behavior of $R_{n}(u)$ as $n \rightarrow \infty$ for the family of probability densities $f_{1}(x, \gamma)$ with $S(x, \gamma) \gtrsim x^{\varepsilon}, \varepsilon>0$. Now introduce some examples of the families of probability densities that satisfy the first type of regularity conditions. Firstly, it should be mentioned the family of Weibull-type probability densities

f_{W}(x, \gamma)=C(\gamma) \exp \left(-x^{\gamma}\right), x \geq 0, \gamma>1
$$

One another example is the family of normal densities, where the parameter $\gamma$ is the variance of concerned distribution:

$$
f_{N}(x, \gamma)=\frac{1}{\sqrt{2 \pi \gamma}} e^{-\frac{x^{2}}{2 \gamma}}, \gamma>0 .
$$

The family of Gumbel-type probability densities also satisfies regularity conditions:

$$
f_{G}(x, \gamma)=\gamma e^{\gamma x} e^{-e^{\gamma x}}, x \geq 0, \gamma>0
$$

If we want to expand our result to a wider family of probability densities $f_{2}(x, \gamma)$ with $S(x, \gamma) \gtrsim(\ln x)^{\varepsilon}, \varepsilon>1$, then we impose the second type of regularity conditions on the concerned family of densities, that are slightly stricter than the first one. Note that the probability density $f(x, \gamma)$ with $S(x, \gamma) \sim \ln x$ belongs to the Frechét maximum domain of attraction as opposed to the families of probability densities with $S(x, \gamma) \gtrsim$ $(\ln x)^{\varepsilon}, \varepsilon>1$, belonging to the Gumbel maximum domain of attraction (this fact is proved later). So, the second type of regularity conditions makes possible to consider practically all distributions with finite right point belonging to the Gumbel domain of attraction. Provide some examples of the families of probability densities that satisfy the second type of regularity conditions. The first important example is the family of log-Weibull-type probability densities:

f_{L W}(x, \gamma)=C(\gamma) \exp \left(-(\ln x)^{\gamma}\right), x \geq 1, \gamma>1 .
$$

The family of Weibull-type probability densities satisfy the regulrity conditions as before:

f_{W}(x, \gamma)=C(\gamma) \exp \left(-x^{\gamma}\right), x \geq 0, \gamma>1 .
$$

Another example is the family of the log-normal densities:

$$
f_{L N}(x, \gamma)=\frac{1}{\sqrt{2 \pi \gamma} x} e^{-\frac{(\ln x)^{2}}{2 \gamma}}, \gamma>0, x \geq 0 .
$$

The method of the likelihood ratio as well as the method of the ratio of maximized likelihoods (RML-test) is well-known and often applied for discriminating between close types of distributions. In this connection the following works (Antle and Bain (1969), Antle and Dumonceaux (1973), Dumonceaux at el. (1973)) should be mentioned. The method of the ratio of maximized likelihoods is applied for discriminating between Weibull-type distributions in the works Gupta and Kundu (2003), Gupta at el. (2001), Dey and Kundu (2012) and other. In addition the wide families of distributions belonging to the Gumbel maximum domain of attraction are discriminated in the works de Haan at el. (2009) and Girard at el. (2011).

Consider the method of the likelihood ratio applied to $k_{n}$ higher order statistics. A similar method is applied in the work Dey and Kundu (2012), but there the lower order statistics for distributions with finite left point are considered, whereas the higher order statistics are significant for extreme value theory in this case. In this work the asymptotical behavior of the likelihood ratio for the family of probability densities $f(x, \gamma)$ satisfying some regularity conditions is considered.

## 2 Main results.

Return to the mentioned above regularity conditions, that are imposed on the function $S(x, \gamma)$. Since we consider the close hypotheses with respect to the parameter $\gamma$, it is natural to make propositions about the general form of the function $S(x, \gamma)$ : for example, we can consider functions like $\gamma S(x)$ or $(S(x))^{\gamma}$. And it is unreasonably to deal with functions like $f(x)+g(x, \gamma)$, since the summand that is not dependent on $\gamma$ is cancelled in the ratio of likelihoods, therefore we will consider in the sequel that $S(x, \gamma)$ is equal to $g(x, \gamma)$ only. So it is reasonably to suppose about behavior of the partial derivative of $S(x, \gamma)$ by $\gamma$ as $x \rightarrow \infty$ the following: $\lim _{x \rightarrow+\infty} \frac{\ln \left|\frac{\partial S(x, \gamma)}{\partial \gamma}\right|}{\ln S(x, \gamma)}=1$.

Impose the following regularity conditions on the function $S(x, \gamma)$ :
A1 There exist $\epsilon=\epsilon(\gamma)>0$ for all $\gamma$ that $\frac{S(x, \gamma)}{x^{1+\epsilon}} \rightarrow+\infty$ as $x \rightarrow+\infty$.
A2 All partial derivatives of the function $S(x, \gamma)$ up to the fourth derivative are not equal to 0 or equal to 0 identically for all $\gamma$ as $x>x_{1}(\gamma)>x_{0}(\gamma)$. In addition all partial derivatives of the function $S(x, \gamma)$ up to the third derivative have a finite or an infinite limit as $x \rightarrow+\infty$.

A3 Suppose $T(x, \gamma)$ is the arbitrary partial derivative of the function $S(x, \gamma)$ up to the third derivative. There holds for all $\gamma$ and $k=1,2,3: \lim _{x \rightarrow+\infty} \frac{\ln \left|\frac{\partial^{k} S(x, \gamma)}{\partial \gamma^{k}}\right|}{\ln S(x, \gamma)}=1$, if these partial derivatives are not equal to 0 identically. All expressions $\frac{\frac{\partial \ln |T(x, \gamma)|}{\partial x}}{\frac{\partial \ln S(x, \gamma)}{\partial x}}$ have a limit for all $\gamma$ as $x \rightarrow+\infty$, if $T(x, \gamma)$ is not equal to 0 identically.


$$
a_{n / k_{n}}=\bar{F}^{\leftarrow}\left(\frac{k_{n}}{n}, \gamma\right),
$$

where $F(x, \gamma)$ is the distribution function with the density $f(x, \gamma), \bar{F}(x, \gamma)=1-F(x, \gamma)$, and $\bar{F}\ulcorner(x, \gamma)=\inf \{t: \bar{F}(x, \gamma)=t\}$. Denote $N(a, b)$ as the normal random variable with the mathematical expectation $a$ and the variance $b$. Notation $\xi_{n} \xrightarrow{d} \eta\left(\xi_{n} \xrightarrow{P}\right.$ $\eta$ ) means that the random sequence $\left\{\xi_{n}\right\}$ converges in distribution (in probability) to the random variable $\eta$ as $n \rightarrow+\infty$. Also we write $S_{x \gamma}^{\prime \prime}\left(a_{n / k_{n}}, \gamma+t\left(k_{n}, u\right)\right)$ instead of $\left.\frac{\partial^{2} S(x, \gamma)}{\partial x \partial \gamma}\right|_{(x, \gamma)=\left(a_{n} / k_{n}, \gamma+t\left(k_{n}, u\right)\right)}$ and for all other partial derivatives of the function $\widetilde{S}(x, \gamma)$ analogously. In the following theorem limit distribution of the likelihood ratio $R_{n}(u)$ on the assumption of slow increase of the sequence $k_{n}$ is found:

Theorem 1 Suppose the family of probability densities $\{f(x, \gamma)\}$ satisfies regularity conditions A1-A3, $n \rightarrow \infty, k_{n} \rightarrow \infty$, and there exists $\varepsilon, 0<\varepsilon<2$, that

\lim _{n \rightarrow \infty} \frac{k_{n}}{\left(\ln \frac{n}{k_{n}}\right)^{\varepsilon}}=1 \tag{3}
\end{equation*}
$$

Suppose also $t\left(k_{n}, u\right):=\frac{u}{\sqrt{k_{n}}} \frac{S_{x}^{\prime}\left(a_{n / k_{n}}, \gamma\right)}{S_{x \gamma}^{\prime \prime}\left(a_{n / k_{n}}, \gamma\right)}$, then

$$
\ln R_{n}(u) \xrightarrow{d} N\left(-\frac{u^{2}}{2}, u^{2}\right) \text { as } n \rightarrow \infty
$$

The parameter $u$ in notation $t\left(k_{n}, u\right)$ will be skipped in the sequel.

Remark 1 Note that if we suppose $k_{n}=n$, i.e. the concerned likelihoods would depend on the whole sample, and take $t\left(k_{n}\right)=\frac{u}{\sqrt{n}}$, then we come to a classical result of contiguity theory (see theorem 2.4.3 in Roussas (1972)).

Since the proof of the theorem 1 seems technically complicated, let's provide the scheme of the proof. Lemma 1 is used to express the ratio of likelihoods $R_{n}(u)$ given $X_{\left(n-k_{n}\right)}=q$ in explicit form. Since we try to find conditional distribution of the likelihood ratio $R_{n}(u)$ given $X_{\left(n-k_{n}\right)}$, then we prove the asymptotical properties of the $\left(n-k_{n}\right)$ th order statistic $X_{\left(n-k_{n}\right)}$ and the quantile $a_{n / k_{n}}$ in Lemma 3. Then the central limit theorem (10) is applied for independent given $X_{\left(n-k_{n}\right)}=q$ and identically distributed random variables $Y_{i}$ emerging in the expression of the logarithm of the likelihood ratio. Using Lemma 2 we find the mathematical expectation (14) and the variance (26) of the random variable $Y_{1}$. And in the end the residual terms in the logarithm of the likelihood ratio (9) are taken into account that leads to a final answer.

Now consider the second type of regularity conditions imposing on the functions $S(x, \gamma)$. Impose the following regularity conditions on the function $S(x, \gamma)$ :

B1 There exists $\epsilon=\epsilon(\gamma)>0$ for all $\gamma$ that $\frac{S(x, \gamma)}{(\ln x)^{1+\epsilon}} \rightarrow+\infty$ as $x \rightarrow+\infty$.
B2 There exists $\delta=\delta(\gamma), 0 \leq \delta<1$, for all $\gamma$ that $\lim _{x \rightarrow+\infty} \frac{\ln \frac{\partial S(x, \gamma)}{\partial x}}{(S(x, \gamma))^{1-\delta}}=0$.
B3 All partial derivatives of the function $S(x, \gamma)$ up to the fourth derivative are not equal to 0 or equal to 0 identically for all $\gamma$ as $x>x_{1}(\gamma)>x_{0}(\gamma)$. In addition all partial derivatives of the function $S(x, \gamma)$ up to the third derivative have a finite or an infinite limit as $x \rightarrow+\infty$.

B4 Suppose $T(x, \gamma)$ is the arbitrary partial derivative of the function $S(x, \gamma)$ up to the third derivative. There holds for all $\gamma$ and $k=1,2,3: \lim _{x \rightarrow+\infty} \frac{\ln \left|\frac{\partial^{k} S(x, \gamma)}{\partial \gamma^{k}}\right|}{\ln S(x, \gamma)}=1$, if these partial derivatives are not equal to 0 identically. All expressions $\frac{\frac{\partial \ln |T(x, \gamma)|}{\partial x}}{\frac{\partial \ln S(x, \gamma)}{\partial x}}$ have a limit for all $\gamma$ as $x \rightarrow+\infty$ and $\lim _{x \rightarrow+\infty} \frac{\ln |T(x, \gamma)|}{S(x, \gamma)}=0$ for all $\gamma$, if $T(x, \gamma)$ is not equal to 0 identically.

Denote

$$
\begin{aligned}
H(x) & =\sqrt{k_{n}} t\left(k_{n}\right)\left(\frac{\int_{x}^{\infty} S_{\gamma}(y, \gamma) \exp (-S(y, \gamma)) d x}{\int_{x}^{\infty} \exp (-S(y, \gamma)) d x}-S_{\gamma}(x, \gamma)-\right. \\
& \left.-\frac{S_{x \gamma}(x, \gamma)}{S_{x}(x, \gamma)}-\frac{S_{x x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{2}}+2 \frac{S_{x x}(x, \gamma) S_{x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{3}}\right) .
\end{aligned}
$$

It follows from the statement of Theorem 2 and its proof, that $H(x)=-\frac{S_{x x}(x, \gamma)}{S_{x}^{2}(x, \gamma)}(1+o(1))$ as $x \rightarrow+\infty$.

Theorem 2 Suppose the family of probability densities $f(x, \gamma)$ satisfies the regularity conditions B1-B4, $n \rightarrow \infty, k_{n} \rightarrow \infty$, and there exists $\varepsilon, 0<\varepsilon<2$, that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{k_{n}}{n^{\varepsilon}}=1 \tag{4}
\end{equation*}
$$

Suppose also $t\left(k_{n}\right)=\frac{u}{\sqrt{k_{n}}} \frac{S_{x}^{\prime}\left(a_{n / k_{n}}, \gamma\right)}{S_{x \gamma}^{\prime}\left(a_{n} / k_{n}, \gamma\right)}$ then

$$
\ln R_{n}(u)-\sqrt{k_{n}} H\left(a_{n / k_{n}}\right) \xrightarrow{d} N\left(-\frac{u^{2}}{2}, u^{2}\right)
$$

as $n \rightarrow+\infty$.
Remark 2 It should be noted, that the asymptotical behavior of the likelihood ratio $R_{n}(u)$ in Theorem 1 and Theorem 2 does not depend on $\gamma$, so it is convenient for construction of the criterion, see Chibisov (2009).

## 3 Auxiliary lemmas

In this section we state several auxiliary lemmas that are used in the proofs of Theorem 1 and Theorem 2. Lemma 1 makes possible to express the likelihood ratio in explicit form such as a function of $\left(n-k_{n}\right)$ th order statistic.

Lemma 1 (lemma 3.4.1 in de Haan (2006)) Let $X, X_{1}, \ldots, X_{n}$ be independent and identically distributed random variables with common distribution function $F(x)$, and let $X_{(1)} \leq \ldots \leq X_{(n)}$ be the $n$th order statistics. The joint distribution of $\left\{X_{(i)}\right\}_{i=n-k+1}^{n}$ given $X_{(n-k)}=q$ for some $k=1 \ldots n-1$ equals the joint distribution of the set of order statistics $\left\{X_{(i)}^{*}\right\}_{i=1}^{k}$ of independent and identically distributed random variables $\left\{X_{i}^{*}\right\}_{i=1}^{k}$ with common distribution function

$$
F_{q}(x)=P(X \leq x \mid X>t)=\frac{F(x)-F(q)}{1-F(q)}, \quad x>q .
$$

The following lemma (Rodionov (2014)) is extension of the Laplace method of estimating integrals and makes possible to find the asymptotic form of integrals emerging in presented work (see, for example, Fedoruk (1977)).

Lemma 2 Consider the behavior of the integral $F(q)=\int_{q}^{+\infty} \exp (-S(x)) d x$ as $q \rightarrow \infty$. Let $S(x)$ satisfy the following regularity conditions:

C1 $\frac{S(x)}{\ln x} \rightarrow+\infty$ as $x \rightarrow+\infty$.
C2 $S(x)$ is strictly monotone and three times continuously differentiable starting from some $x_{0}>0$. In addition, the first, the second and the third derivatives of the function $S(x)$ have a finite or an infinite limit as $x \rightarrow+\infty$.

C3 For $k=1,2,3 \quad \lim _{x \rightarrow+\infty} \frac{\ln \left|\frac{d^{k} S(x)}{d x^{k}}\right|}{S(x)}=0$.
Then

$$
F(q)=\exp (-S(q))\left(\sum_{k=0}^{2} c_{k}+o\left(c_{2}\right)\right) \quad \text { as } \quad q \rightarrow+\infty
$$

where $c_{k}=\left.M^{k}\left(\frac{1}{S^{\prime}(x)}\right)\right|_{x=q}$ and $M=\frac{1}{S^{\prime}(x)} \frac{d}{d x}$.
It is not difficult to prove using this lemma that the class of distributions satisfying regularity conditions A1-A3 (and B1-B4) belongs to the Gumbel maximum domain of attraction. The distribution function of such distributions may be represented in form of Von Mises (see Embrechts at el. (1997)):

\begin{equation*}
1-F(x)=d(x) \exp \left(-\int_{x^{\prime}}^{x} \frac{g(t)}{a(t)} d t\right) \tag{5}
\end{equation*}
$$

where $x^{\prime} \geq 0, a(x)$ is the positive and absolutely continuous function on $\left[x^{\prime} ; \infty\right), a^{\prime}(x) \rightarrow$ $0, d(x) \rightarrow c>0, g(x) \rightarrow 1$ as $x \rightarrow x_{F}$, and $x_{F}$ is the right point of concerned
distribution. On the other hand, one can derive for the concerned family of probability densities $f(x, \gamma)=\exp (-S(x, \gamma)$ ) (since we differentiate only in respect to $x$, we omit the parameter $\gamma$ here):

$$
1-F(x)=\exp (-S(x)) \frac{1}{S^{\prime}(x)}\left(1-\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}+o\left(\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}\right)\right) .
$$

It is proved in Rodionov (2014), that under the conditions of Theorem 1 and Theorem 2 $\lim _{x \rightarrow \infty} \frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}=0$. It follows from the L'Hospital rule, that

$$
\lim _{x \rightarrow \infty} \frac{S^{\prime}(x)}{1 / x}=\lim _{x \rightarrow \infty} \frac{S(x)}{\ln x}=+\infty .
$$

So we can write

$$
d(x)=\left(1-\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}+o\left(\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}\right)\right)
$$

for the function $d(x)$ in (5). So, it should be proved only, that there exist $x^{\prime}, a(x)$ and $g(x)$ in (5) that $S(x)+\ln S^{\prime}(x)=\int_{x^{\prime}}^{x} \frac{g(t)}{a(t)} d t$. Differentiate this equation in respect to $x$ :

$$
S^{\prime}(x)+\frac{S^{\prime \prime}(x)}{S^{\prime}(x)}=S^{\prime}(x)\left(1+\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}\right)=\frac{g(x)}{a(x)} .
$$

It is mentioned earlier, that $\lim _{x \rightarrow \infty} \frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}=0$ under regularity conditions A1-A3 and B1-B4, so let $g(x)=1+\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}$. Since $\left(\frac{1}{S^{\prime}(x)}\right)^{\prime}=-\frac{S^{\prime \prime}(x)}{\left(S^{\prime}(x)\right)^{2}}$, let $a(x)$ be equal $\frac{1}{S^{\prime \prime}(x)}$, it is the positive function starting from some $x_{0}>0$ by the condition C2. Thus we state, that there exist $a(x)$ and $g(x)$ such that $S(x)+\ln S^{\prime}(x)=\int_{x^{\prime}}^{x} \frac{g(t)}{a(t)} d t+C_{1}$, where $C_{1}$ is a certain constant. To finish the proof of the state, that the family of concerned distributions belongs to the Gumbel maximum domain of attraction, take $x^{\prime}=x_{0}$ and move the constant $e^{C_{1}}$ to $d(x)$.

In the following lemma asymptotic distribution of the $\left(n-k_{n}\right)$ th order statistic $X_{\left(n-k_{n}\right)}$ is considered.

Lemma 3 There holds under the conditions of Theorem 1

$$
X_{\left(n-k_{n}\right)}-a_{n / k_{n}} \xrightarrow{P} 0 .
$$

Proof. According to theorem 2.2.1 from de Haan (2006),

$$
\begin{equation*}
\sqrt{k_{n}} \frac{X_{\left(n-k_{n}\right)}-U\left(\frac{n}{k_{n}}\right)}{\frac{n}{k_{n}} U^{\prime}\left(\frac{n}{k_{n}}\right)} \xrightarrow{d} N(0,1), \tag{6}
\end{equation*}
$$

where $U=\left(\frac{1}{1-F}\right)^{\leftarrow}$. According to Lemma 2,

$$
\begin{align*}
a_{n / k_{n}}= & \arg \left\{t: \int_{t}^{\infty} \exp (-S(x, \gamma)) d x=\frac{k_{n}}{n}\right\} \xrightarrow[n \rightarrow \infty]{\longrightarrow} \\
& \xrightarrow[n \rightarrow \infty]{ } \arg \left\{t: \frac{\exp (-S(t, \gamma))}{S^{\prime}(t, \gamma)}=\frac{k_{n}}{n}\right\} . \tag{7}
\end{align*}
$$

In addition, $U\left(\frac{n}{k_{n}}\right)=a_{n / k_{n}}$. Then $U^{\prime}(t)=\frac{[1-F(U(t))]^{2}}{F^{\prime}(U(t))}$ and $U^{\prime}\left(\frac{n}{k_{n}}\right)=\frac{\left(k_{n} / n\right)^{2}}{F^{\prime}\left(a_{n} / k_{n}\right)}$. But $F^{\prime}\left(a_{n / k_{n}}\right)=\exp (-S(t, \gamma))$, where $t=a_{n / k_{n}}$ such that $\frac{\exp (-S(t, \gamma))}{S^{\prime}(t, \gamma)}=\frac{k_{n}}{n}$. It follows from here that $F^{\prime}\left(a_{n / k_{n}}\right)=\frac{k_{n}}{n} S^{\prime}\left(a_{n / k_{n}}, \gamma\right)$. Eventually obtain

$$
\begin{equation*}
\frac{\sqrt{k_{n}}\left(X_{\left(n-k_{n}\right)}-a_{n / k_{n}}\right)}{\frac{1}{S^{\prime}\left(a_{n / k_{n}}, \gamma\right)}} \xrightarrow{d} N(0,1) . \tag{8}
\end{equation*}
$$

It follows from the regularity conditions A1 and A2 that $\lim _{n \rightarrow+\infty} S^{\prime}\left(a_{n / k_{n}}, \gamma\right)=+\infty$, so we obtain using (8)

$$
X_{\left(n-k_{n}\right)}-a_{n / k_{n}} \xrightarrow{P} 0 .
$$

The proof of Lemma 3 is completed.

## 4 Proofs

## The proof of Theorem 1.

Firstly write the likelihood $L\left(X_{(n)}, \ldots, X_{\left(n-k_{n}+1\right)} ; \gamma\right)$ using Lemma 1

Find the asymptotical distribution of $A_{1} \cdot A_{2}$. Consider the random variables $\left\{Y_{i}\right\}_{i=1}^{k_{n}}$ with the $n$th order statistics $Y_{\left(k_{n}-i\right)}=\left[S\left(X_{(n-i)}, \gamma+t\left(k_{n}\right)\right)-S\left(X_{(n-i)}, \gamma\right)\right]-\left[S\left(X_{\left(n-k_{n}\right)}, \gamma+\right.\right.$ $\left.\left.t\left(k_{n}\right)\right)-S\left(X_{\left(n-k_{n}\right)}, \gamma\right)\right], i=0, \ldots, k_{n}-1$, that appear in the expression of $A_{1}$. According to Rényi's representation (for example, see de Haan (2006)), these random variables are independent given $X_{\left(n-k_{n}\right)}=q$. They are also identically distributed. Now consider the multiplier $A_{2}$. It is easy to see, that

According to the proof of Lemma 2 (see Rodionov (2014)), it holds $F(q)=\exp (-S(q))\left(c_{0}+c_{1}+o\left(c_{1}\right)\right)$ for the integral $F(q)=\int_{q}^{+\infty} \exp (-S(x)) d x$ as $q \rightarrow+\infty$, where $c_{0}=\left.\frac{1}{S^{\prime}(x)}\right|_{x=q}$, and $c_{1}=\left.\frac{1}{S^{\prime}(x)} \frac{d}{d x}\left(\frac{1}{S^{\prime}(x)}\right)\right|_{x=q}$. i.e. $\frac{S_{x x \gamma}}{S_{x}^{2}}=O\left(\frac{S_{x x} S_{x \gamma}}{S_{x}^{3}}\right)=\frac{R^{\prime}(S)}{S}$, where $R^{\prime}(x)$ is some slowly varying function. With a glance of previous results and the condition (3) it follows that $\ln A_{3}=\sqrt{k_{n}} \frac{\bar{R}(S)}{S} \xrightarrow{P} 0$, where $\bar{R}(x)$ is some slowly varying function again, and

## The proof of Theorem 2.

The scheme of the proof of Theorem 2 is the same as the proof of Theorem 1. Using Lemma 1, write the ratio of likelihoods

Since the concerned family of densities satisfies the conditions of Lemma 2, then the expansion (9) holds for the ratio of likelihoods given $X_{\left(n-k_{n}\right)}=q$. As before, consider the random variables $\left\{Y_{i}\right\}_{i=1}^{k_{n}}$ with the following $n$th order statistics

It appears from the definition of the function $H(x)$ that the term at $t\left(k_{n}\right)$ in the expansion (32) is equal to 0 identically. Consider the term at $\left(t\left(k_{n}\right)\right)^{2}$ in the expansion (32). Recall that it holds for the integral $F(q)=\int_{q}^{\infty} \exp (-S(x)) d x$ as $q \rightarrow+\infty$ the following

=\lim _{q \rightarrow \infty} \frac{\ln S_{\gamma \gamma}}{\ln S_{\gamma}} \lim _{q \rightarrow \infty} \frac{\ln S}{\ln S_{\gamma}} \lim _{q \rightarrow \infty} \frac{S_{\gamma \gamma} S}{S_{\gamma}^{2}}=\lim _{q \rightarrow \infty} \frac{S_{\gamma \gamma} S}{S_{\gamma}^{2}}
\end{gathered}
$$

hence and from the regularity condition B4 imply that $\frac{S_{x x} S_{x \gamma \gamma}}{S_{x}^{3}}=\frac{S_{x x} S_{x \gamma}^{2}}{S_{x}^{4}} R(S)$, where $R(x)$ is some slowly varying function. So, we obtain that

$$
\left.\left(\frac{S_{x x}}{S_{x}^{2}}\right)_{\gamma \gamma}\right|_{\left(q, \gamma+\theta\left(k_{n}\right)\right)}=\left.\frac{S_{x x} S_{x \gamma}^{2}}{S_{x}^{4}} R(S)\right|_{\left(q, \gamma+\theta\left(k_{n}\right)\right)}
$$

As it is mentioned previously, $\frac{S_{x \gamma}}{S_{x}}=R(S)$ and $R(S(q, \gamma))=R_{1}\left(S\left(q, \gamma+\theta\left(k_{n}\right)\right)\right)$ because of continuity of the function $S(x, \gamma)$ with respect to $\gamma$, where $R(x)$ and $R_{1}(x)$ are some slowly varying functions. So we obtain

$$
\left.k_{n}\left(t\left(k_{n}\right)\right)^{2}\left(\frac{S_{x x}}{S_{x}^{2}}\right)_{\gamma \gamma}\right|_{\left(q, \gamma+\theta\left(k_{n}\right)\right)}=\left.\frac{S_{x x}}{S_{x}^{2}} R_{2}(S)\right|_{\left(q, \gamma+\theta\left(k_{n}\right)\right)},
$$

where $R_{2}(x)$ is some slowly varying function. Recall that according to the regularity condition B2 there exists $\delta>0$ such that $\lim _{q \rightarrow+\infty} \frac{\ln S_{x}}{S^{1-\delta}}=0$, hence imply that $\frac{S_{x x}}{S_{x}^{x}}=o\left(S^{-\delta}\right)$, since

$$
\lim _{q \rightarrow \infty} \frac{\ln S_{x}}{S^{1-\delta}}=\lim _{q \rightarrow \infty} \frac{S_{x x} / S_{x}}{S_{x} S^{-\delta}}=\lim _{q \rightarrow \infty} \frac{S_{x x}}{S_{x}^{2}} S^{\delta}=0 .
$$

So, we obtain that

$$
\left.k_{n}\left(t\left(k_{n}\right)\right)^{2}\left(\frac{S_{x x}}{S_{x}^{2}}\right)_{\gamma \gamma}\right|_{\left(q, \gamma+\theta\left(k_{n}\right)\right)} \xrightarrow{P} 0
$$

as $k_{n} \rightarrow \infty$ and finally

$$
k_{n} B_{2} \xrightarrow{P} \frac{u^{2}}{2} .
$$

The proof of the following fact $k_{n} B_{3} \xrightarrow{P} 0$, where $B_{3}$ is the third summand in the expansion (32), agrees completely with the proof of the analogous fact in the previous section. So, we obtain

$$
\begin{equation*}
k_{n} E Z_{1} \xrightarrow{P} \frac{u^{2}}{2} . \tag{33}
\end{equation*}
$$

Now consider the conditional variance $D Z_{1}=E Z_{1}^{2}-\left(E Z_{1}\right)^{2}$ given $X_{\left(n-k_{n}\right)}=q$. Note as before that since $k_{n} E Z_{1} \xrightarrow{P} u^{2} / 2$ as $n \rightarrow \infty$, then $k_{n}\left(E Z_{1}\right)^{2} \xrightarrow{P} 0$ as $n \rightarrow \infty$. Denote

$$
J(q)=G(q)+\frac{1}{\sqrt{k_{n}}} H(q)+\left[S\left(q, \gamma+t\left(k_{n}\right)\right)-S(q, \gamma)\right],
$$

so we get $Z_{\left(k_{n}-i\right)}=\left[S\left(X_{(n-i)}, \gamma+t\left(k_{n}\right)\right)-S\left(X_{(n-i)}, \gamma\right)\right]-J\left(X_{\left(n-k_{n}\right)}\right)$, where $i=0, \ldots, k_{n}-$ 1. Find the asymptotics of $E Z_{1}^{2}$ as $q \rightarrow \infty$

$$
\begin{align*}
& E Z_{1}^{2}=\frac{\int_{q}^{\infty}\left(\left[S\left(x, \gamma+t\left(k_{n}\right)\right)-S(x, \gamma)\right]-J\right)^{2} \exp (-S(x, \gamma)) d x}{\int_{q}^{\infty} \exp (-S(x, \gamma)) d x}= \\
& =\frac{\int_{q}^{\infty}\left[S\left(x, \gamma+t\left(k_{n}\right)\right)-S(x, \gamma)\right]^{2} \exp (-S(x, \gamma)) d x}{\int_{q}^{\infty} \exp (-S(x, \gamma)) d x}= \\
& -2 \frac{\int_{q}^{\infty}\left[S\left(x, \gamma+t\left(k_{n}\right)\right)-S(x, \gamma)\right] \exp (-S(x, \gamma)) d x}{\int_{q}^{\infty} \exp (-S(x, \gamma)) d x} \cdot J(q)+J^{2}(q) .
\end{align*}
$$

Firstly note that

$$
\begin{gathered}
\left(t\left(k_{n}\right)\right)^{3} \frac{\int_{q}^{\infty} S_{\gamma \gamma \gamma}\left(x, \gamma+\widetilde{t}\left(k_{n}, x\right)\right) \exp (-S(x, \gamma)) d x}{\int_{q}^{\infty} \exp (-S(x, \gamma)) d x}= \\
=\left(t\left(k_{n}\right)\right)^{3} S_{\gamma \gamma \gamma}\left(q, \gamma+\widehat{t}\left(k_{n}\right)\right)(1+o(1))=\frac{1}{\left(k_{n}\right)^{3 / 2}} S\left(q, \gamma+\widehat{t}\left(k_{n}\right)\right) R(S),
\end{gathered}
$$

where as before $\left|\widehat{t}\left(k_{n}\right)\right| \leq\left|t\left(k_{n}\right)\right|$ and the signs of $\widehat{t}\left(k_{n}\right)$ and $t\left(k_{n}\right)$ are the same, $R(x)$ is some slowly varying function. From (24) imply $\frac{S\left(X_{\left(n-k_{n}\right)}^{\ln )}\right.}{\ln \frac{n}{k_{n}}} \xrightarrow{P} 1$. Hence it appears from (4) and continuity of the function $S(x, \gamma)$ in respect to $\gamma$, that $\frac{1}{\sqrt{k_{n}}} S\left(q, \gamma+\widehat{t}\left(k_{n}\right)\right) R(S) \xrightarrow{P} 0$. It means that

$$
\left(t\left(k_{n}\right)\right)^{3} \frac{\int_{q}^{\infty} S_{\gamma \gamma \gamma}\left(x, \gamma+\widetilde{t}\left(k_{n}, x\right)\right) \exp (-S(x, \gamma)) d x}{\int_{q}^{\infty} \exp (-S(x, \gamma)) d x}=o\left(\frac{1}{k_{n}}\right),
$$

as $n \rightarrow \infty$ and $q \rightarrow \infty$. Hence and from the expansions (12), (13) and (31) imply:

$$
J(q)=t\left(k_{n}\right) \frac{\int_{q}^{\infty} S_{\gamma} \exp (-S) d x}{\int_{q}^{\infty} \exp (-S) d x}+\frac{t^{2}\left(k_{n}\right)}{2}\left(\frac{\int_{q}^{\infty} S_{\gamma \gamma} \exp (-S) d x}{\int_{q}^{\infty} \exp (-S) d x}+\frac{S_{x \gamma}^{2}}{S_{x}^{2}}\right)+o\left(\frac{1}{k_{n}}\right) .
$$

Using the last expansion and the expansion (12), represent $E Z_{1}^{2}$ in polynomial form in respect to $t\left(k_{n}\right)$. It is easy to see, that the coefficients at the null and the first powers of $t\left(k_{n}\right)$ are equal to 0 . Consider the coefficient at $\left(t\left(k_{n}\right)\right)^{2}$ whose asymptotics agrees with asymptotics of $E Z_{1}^{2}$. Recall that under the conditions of Theorem 2 holds $\frac{S_{x \gamma}}{S_{x} S_{\gamma}}=$ $O\left(\frac{S_{x x}}{S_{x}^{2}}\right)$, so obtain similarly to (21)

$$
\begin{gathered}
\frac{\int_{q}^{\infty} S_{\gamma}^{2} \exp (-S) d x}{\int_{q}^{\infty} \exp (-S) d x}= \\
=S_{\gamma}^{2}\left[1+2 \frac{S_{x \gamma}}{S_{\gamma} S_{x}}+2 \frac{S_{x x \gamma}}{S_{\gamma} S_{x}^{2}}+2 \frac{S_{x \gamma}^{2}}{S_{\gamma}^{2} S_{x}^{2}}-\frac{6 S_{x x} S_{x \gamma}}{S_{x}^{3} S_{\gamma}}+o\left(\frac{S_{x x}^{2}}{S_{x}^{4}}\right)\right] .
\end{gathered}
$$

So the coefficient at $\left(t\left(k_{n}\right)\right)^{2}$ (denote it as $a_{2}$ ) is equal to

$$
a_{2}=\frac{\int_{q}^{\infty} S_{\gamma}^{2} \exp (-S) d x}{\int_{q}^{\infty} \exp (-S) d x}-\left(\frac{\int_{q}^{\infty} S_{\gamma} \exp (-S) d x}{\int_{q}^{\infty} \exp (-S) d x}\right)^{2}=\frac{S_{x \gamma}^{2}}{S_{x}^{2}}-2 \frac{S_{x \gamma} S_{x x \gamma}}{S_{x}^{3}}-\frac{S_{x x \gamma}^{2}}{S_{x}^{4}} .
$$

Show that $\frac{S_{x x \gamma}}{S_{x}^{2}}=o\left(\frac{S_{x \gamma}}{S_{x}}\right)$ as $q \rightarrow \infty$. It appears from the L'Hospital rule and the regularity conditions that

$$
\begin{equation*}
\lim _{q \rightarrow \infty} \frac{S_{x x \gamma}}{S_{x}^{2}} \frac{S_{x}}{S_{x \gamma}}=\lim _{q \rightarrow \infty} \frac{S_{x x \gamma} / S_{x \gamma}}{S_{x}}=\lim _{q \rightarrow \infty} \frac{\ln S_{x \gamma}}{S}=0 \tag{35}
\end{equation*}
$$

hence the concerned fact appears. Thus we obtain that

$$
a_{2}=\frac{S_{x \gamma}^{2}}{S_{x}^{2}}(1+o(1)) .
$$

Similarly, the coefficient at $\left(t\left(k_{n}\right)\right)^{3}$ is equal to $a_{3}=\frac{S_{x \gamma} S_{x \gamma \gamma}}{S_{x}^{2}}(1+o(1))$. But it follows from (27) that $a_{3}=R(S) a_{2}$, so we obtain

$$
\frac{a_{3}\left(t\left(k_{n}\right)\right)^{3}}{a_{2}\left(t\left(k_{n}\right)\right)^{2}}=\frac{R_{1}(S)}{\sqrt{k_{n}}} \xrightarrow{P} 0,
$$

where $R(S)$ and $R_{1}(S)$ are some slowly varying functions. Finally we get $E Z_{1}^{2}=$ $\left(t\left(k_{n}\right)\right)^{2} \frac{S_{x \gamma}^{2}}{S_{x}^{2}}(1+o(1))$ and consequently

$$
\begin{equation*}
k_{n} D Z_{1} \xrightarrow{P} u^{2} . \tag{36}
\end{equation*}
$$

Verification of Lyapunov condition (30) is done similarly to verification of the condition (11). Thus the conditions of the central limit theorem (29) holds. Since it follows from Lemma 3 that $X_{\left(n-k_{n}\right)}-a_{n / k_{n}} \xrightarrow{P} 0$, then from (33), (36) and the continuous mapping theorem imply

$$
R_{n}(u) \exp \left(-\sqrt{k_{n}} H(q)\right) \xrightarrow{d} \exp \left(-N\left(\frac{u^{2}}{2}, u^{2}\right)\right) .
$$

Now consider the asymptotic behavior of $\exp \left(\sqrt{k_{n}} H(q)\right)$ as $n \rightarrow \infty$. As it is stated in Lemma 3,

$$
\sqrt{k_{n}} S_{x}\left(a_{n / k_{n}}, \gamma\right)\left(X_{\left(n-k_{n}\right)}-a_{n / k_{n}}\right) \xrightarrow{d} N(0,1) .
$$

Denote $\widetilde{H}(x)=\frac{H(x)}{S_{x}(x, \gamma)}, \quad b_{n}=\frac{1}{\sqrt{k_{n} S_{x}\left(a_{n / k_{n}}, \gamma\right)}}$, and $\eta_{n}=\sqrt{k_{n}} S_{x}\left(a_{n / k_{n}}, \gamma\right)\left(X_{\left(n-k_{n}\right)}-a_{n / k_{n}}\right)$. Then according to continuity theorem (see, for example, theorem 1.5.3 in Borovkov(1984)), if there exists the finite limit of the derivative of the function $\widetilde{H}(x)$ as $x \rightarrow \infty$, then

$$
\frac{\widetilde{H}\left(a_{n / k_{n}}+b_{n} \eta_{n}\right)-\widetilde{H}\left(a_{n / k_{n}}\right)}{b_{n}} \xrightarrow{d} \lim _{x \rightarrow+\infty} \widetilde{H}^{\prime}(x) \cdot \eta,
$$

where $\eta \sim N(0,1)$. In other words,

$$
\begin{equation*}
\sqrt{k_{n}}\left(H\left(X_{\left(n-k_{n}\right)}\right) \frac{S_{x}\left(a_{n / k_{n}}, \gamma\right)}{S_{x}\left(X_{\left(n-k_{n}\right)}, \gamma\right)}-H\left(a_{n / k_{n}}\right)\right) \xrightarrow{d} \lim _{x \rightarrow+\infty} \frac{\partial\left(\frac{H(x)}{S_{x}(x, \gamma)}\right)}{\partial x} \cdot N(0,1), \tag{37}
\end{equation*}
$$

where we note especially that the function $\frac{H(x)}{S_{x}(x, \gamma)}$ does not depend on $k_{n}$ by definition of $H(x)$. Find $\lim _{x \rightarrow+\infty} \frac{\partial\left(\frac{H(x)}{S_{x}(x, \gamma)}\right)}{\partial x}$. It follows from the definition of the function $H(x)$, that

$$
\begin{aligned}
& \widetilde{H}(x)=\frac{H(x)}{S_{x}(x, \gamma)}=\frac{u}{S_{x \gamma}(x, \gamma)}\left(\frac{\int_{x}^{\infty} S_{\gamma}(y, \gamma) \exp (-S(y, \gamma)) d y}{\int_{x}^{\infty} \exp (-S(y, \gamma)) d y}-\right. \\
& \left.-S_{\gamma}(x, \gamma)-\frac{S_{x \gamma}(x, \gamma)}{S_{x}(x, \gamma)}-\frac{S_{x x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{2}}+2 \frac{S_{x x}(x, \gamma) S_{x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{3}}\right)
\end{aligned}
$$

Denote

$$
\begin{gathered}
V(x, \gamma)=\frac{\int_{x}^{\infty} S_{\gamma}(y, \gamma) \exp (-S(y, \gamma)) d y}{\int_{x}^{\infty} \exp (-S(y, \gamma)) d y}-S_{\gamma}(x, \gamma)- \\
-\frac{S_{x \gamma}(x, \gamma)}{S_{x}(x, \gamma)}-\frac{S_{x x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{2}}+2 \frac{S_{x x}(x, \gamma) S_{x \gamma}(x, \gamma)}{\left(S_{x}(x, \gamma)\right)^{3}}
\end{gathered}
$$

In the sequel we will omit the arguments of the function $S(x, \gamma), V(x, \gamma)$ and its derivatives, if they are equal to $x$ and $\gamma$ respectively. Using (21) and the fact that under the conditions of Theorem $2 \frac{S_{x \gamma}}{S_{x} S_{\gamma}}=O\left(\frac{S_{x x}}{S_{x}^{2}}\right)$, we obtain

$$
V=-\frac{S_{x x} S_{x \gamma}}{S_{x}^{3}}+o\left(\frac{S_{x x}^{2}}{S_{x}^{4}}\right)
$$

So

$$
\widetilde{H}^{\prime}(x)=\frac{u V_{x}}{S_{x \gamma}}-\frac{u V S_{x x \gamma}}{\left(S_{x \gamma}\right)^{2}} .
$$

Firstly find the asymptotics of the second summand in the last equation

$$
\frac{u V S_{x x \gamma}}{\left(S_{x \gamma}\right)^{2}}=-\frac{u S_{x x}}{S_{x}^{2}} \frac{S_{x x \gamma}}{S_{x} S_{x \gamma}}+o\left(\frac{S_{x x}^{2}}{S_{x}^{4}} \frac{S_{x x \gamma}}{\left(S_{x \gamma}\right)^{2}}\right)
$$

As it is mentioned previously, under the conditions of Theorem 2 we have $\lim _{x \rightarrow \infty} \frac{S_{x x}}{S_{x}^{2}}=0$. Then from (35) imply $\lim _{x \rightarrow \infty} \frac{S_{x x \gamma}}{S_{x \gamma} S_{x}}=0$. So it is necessary to prove $\lim _{x \rightarrow \infty} \frac{S_{x x \gamma}}{\left(S_{x \gamma}\right)^{2}}=0$ to complete the proof of the fact that $\lim _{x \rightarrow \infty} \frac{u V S_{x x y}}{\left(S_{x \gamma}\right)^{2}}=0$, It follows from the L'Hospital rule and the regularity conditions that

$$
\lim _{x \rightarrow \infty} \frac{S_{x x \gamma}}{\left(S_{x \gamma}\right)^{2}}=\lim _{x \rightarrow \infty} \frac{S_{x x \gamma} / S_{x \gamma}}{S_{x \gamma}}=\lim _{x \rightarrow \infty} \frac{\ln S_{x \gamma}}{S_{\gamma}} \lim _{x \rightarrow \infty} \frac{\ln S_{x \gamma}}{S_{\gamma}}=0
$$

that completes the proof of concerned fact. Now find the asymptotics of the function $\frac{u V_{x}}{S_{x \gamma}}$ as $x \rightarrow+\infty$. The search of the explicit form of the function $V_{x}$ requires the complicated calculations, so we omit them and write the answer immediately:

$$
\frac{u V_{x}}{S_{x \gamma}}=-\frac{u S_{x x}}{S_{x}^{2}}+o\left(\frac{S_{x x}}{S_{x}^{2}}\right)
$$

i.e. $\lim _{x \rightarrow \infty} \frac{u V_{x}}{S_{x \gamma}}=0$. Hence we derive $\lim _{x \rightarrow \infty} \widetilde{H}^{\prime}(x)=0$, and from (37) imply

$$
\begin{equation*}
\sqrt{k_{n}}\left(H\left(X_{\left(n-k_{n}\right)}\right) \frac{S_{x}\left(a_{n / k_{n}}, \gamma\right)}{S_{x}\left(X_{\left(n-k_{n}\right)}, \gamma\right)}-H\left(a_{n / k_{n}}\right)\right) \stackrel{d}{\rightarrow} 0 \tag{38}
\end{equation*}
$$

From the mentioned previously the continuity theorem for the function $\frac{1}{S_{x}}$ (where $b_{n}=$ $\frac{1}{\sqrt{k_{n}} S_{x}\left(a_{n / k_{n}}, \gamma\right)}$ and $\eta_{n}=\sqrt{k_{n}} S_{x}\left(a_{n / k_{n}}, \gamma\right)\left(X_{\left(n-k_{n}\right)}-a_{n / k_{n}}\right)$, as before $)$

$$
\frac{\frac{1}{S_{x}\left(a_{n / k_{n}}+b_{n} \eta_{n}, \gamma\right)}-\frac{1}{S_{x}\left(a_{n / k_{n}}, \gamma\right)}}{b_{n}} \xrightarrow{d} \lim _{x \rightarrow \infty} \frac{S_{x x}}{S_{x}^{2}} \xi
$$

where $\xi \sim N(0,1)$. In other words,

$$
\begin{equation*}
\sqrt{k_{n}}\left(\frac{S_{x}\left(a_{n / k_{n}}, \gamma\right)}{S_{x}\left(X_{\left(n-k_{n}\right)}, \gamma\right)}-1\right) \stackrel{d}{\rightarrow} 0 \tag{39}
\end{equation*}
$$

since under the conditions of Theorem 2, $\lim _{x \rightarrow \infty} \frac{S_{x x}}{S_{x}^{2}}=0$. From (21) imply

$$
H(x)=-\frac{S_{x x}}{S_{x}^{2}}+o\left(\frac{S_{x x}^{2}}{S_{x}^{4}} \frac{S_{x}}{S_{x \gamma}}\right) .
$$

Since as it is stated previously $\frac{S_{x}}{S_{x \gamma}}=R(S)$ as $x \rightarrow+\infty$, where $R(S)$ is some slowly varying function, and $\frac{S_{x x}}{S_{x}^{2}}=O\left(S^{-\delta}\right)$ for some $\delta, 0<\delta \leq 1$, then $\lim _{x \rightarrow \infty} H(x)=0$. Hence using (39) we obtain

$$
\sqrt{k_{n}} H\left(X_{\left(n-k_{n}\right)}\right)\left(\frac{S_{x}\left(a_{n / k_{n}}, \gamma\right)}{S_{x}\left(X_{\left(n-k_{n}\right)}, \gamma\right)}-1\right) \xrightarrow{d} 0 .
$$

Combining the previous result and (38) we derive finally

$$
\sqrt{k_{n}}\left(H\left(X_{\left(n-k_{n}\right)}\right)-H\left(a_{n / k_{n}}\right)\right) \xrightarrow{d} 0,
$$

that completes the proof of Theorem 2.
