

# TWO-SAMPLE TESTING IN NON-SPARSE HIGH-DIMENSIONAL LINEAR MODELS

**Abstract:** In analyzing high-dimensional models, sparsity of the model parameter is a common but often undesirable assumption. Though different methods have been proposed for hypothesis testing under sparsity, no systematic theory exists for inference methods that are robust to failure of the sparsity assumption. In this paper, we study the following two-sample testing problem: given two samples generated by two high-dimensional linear models, we aim to test whether the regression coefficients of the two linear models are identical. We propose a framework named TIERS (short for TestIng Equality of Regression Slopes), which solves the two-sample testing problem without making any assumptions on the sparsity of the regression parameters. TIERS builds a new model by convolving the two samples in such a way that the original hypothesis translates into a new moment condition. A self-normalization construction is then developed to form a moment test. We provide rigorous theory for the developed framework. Under very weak conditions of the feature covariance, we show that the accuracy of the proposed test in controlling Type I errors is robust both to the lack of sparsity in the features and to the heavy tails in the error distribution, even when the sample size is much smaller than the feature dimension. Moreover, we discuss minimax optimality and efficiency properties of the proposed test. Simulation analysis demonstrates excellent finite-sample performance of our test. In deriving the test, we also develop tools that are of independent interest. The test is built upon a novel estimator, called Auto-adaptive Dantzig Selector (ADDS), which not only automatically chooses an appropriate scale (variance) of the error term but also incorporates prior information. To effectively approximate the critical value of the test statistic, we develop a novel high-dimensional plug-in approach that complements the recent advances in Gaussian approximation theory.

## 1. Introduction

High-dimensional data are increasingly encountered in many applications of statistics and most prominently in biological and financial research. A common feature of the statistical models used to study high-dimensional data is

that while the dimension  $p$  of the model parameter is high, the sample size  $n$  is relatively small. This is the so-called High-Dimensional Low-Sample Setting (HDLSS) where  $p/n \rightarrow \infty$  as  $n \rightarrow \infty$ . For such models, a common underlying theoretical assumption is that the effective dimensionality of the data is small, i.e., the number of non-zero components of the model parameter, denoted by  $s$ , is either fixed or grows slowly as  $s/n \rightarrow 0$  with  $n \rightarrow \infty$ . Hypothesis testing in such HDLSS settings has recently gained a great deal of attention (see [Dezeure et al. \(2015\)](#) for a review). The problem is fundamentally difficult to solve due to the bias propagation induced by the regularized estimators ([Zhang and Zhang \(2014\)](#)), all of which are specifically designed to resolve the curse-of-dimensionality,  $p \gg n$ , phenomenon. Bias propagation is apparent across models and across regularizations ([Zhang and Huang \(2008\)](#); [Fan and Lv \(2011\)](#)).

However, since consistent estimation without sparsity (i.e.,  $s \gg n$ ) has not been successfully resolved, hypothesis testing in such models has not been addressed until now. Yet, many scientific areas do not support the sparsity assumption and thus require development of new inferential methods that are robust to non-sparsity. A natural question is whether or not we can design effective method for hypothesis testing that allows for such non-sparse high-dimensional models. We answer this question in the context of two-sample simultaneous tests of equality of parameters of the regression models. Below we present a couple of examples that highlight the importance and applications of the problem we consider.

(a) (Dense Differential Regressions) In many situations, two natural subgroups in the data occur; for example, suppose that treatments 1 and 2 are given to  $n_1$  and  $n_2$  patients, respectively, and that the  $j$ -th subject who receives treatment  $i$  ( $i = 1$  or  $2$ ) has response  $y_{ij}$  to treatment at the level  $x_{ij}$ , where the expected value of  $y_{ij}$  is  $x_{ij}^\top \beta_i$  for  $x_{ij} \in \mathbb{R}^p$  and  $\beta_i \in \mathbb{R}^p$ . Specifically, we intend to test the null hypotheses that

$$H_0 : \beta_1 = \beta_2.$$

The effects of the treatment are typically collected in the vectors  $x_{ij}$ . Such effects are rarely sparse as therapies for highly diverse illnesses largely benefit from complicated treatments, for example, radio-chemotherapy ([Allan et al. \(2001\)](#)). In this case, treatment affects a large number of levels of the molecular composition of the cell and many malfunctions have been shown to relate to cancer-like behavior. Hence, in such setting, it is pertinent to consider vector  $x_{ij}$  that measures the treatment on the genetic cell or molecular level, leading to a high-dimensional feature vector with  $p \gg n$  that is in principle not sparse.

(b) (Dense Differential Networks) Hypotheses concerning differences in molecular influences or biological network structure using high-throughput data have become prevalent in modern FMRI studies. Namely, one is interested in discovering “brain connectivity networks” and comparing two of such networks between subgroups of population. Here, one is interested in discovering the difference between two populations modeled by Gaussian graphical models. Significance testing for network differences is a challenging statistical problem, involving

high-dimensional estimation and comparison of non-nested hypotheses. In particular, one can consider  $p$ -dimensional Gaussian random vectors  $Z_1 \sim \mathcal{N}(0, \Sigma_1)$  and  $Z_2 \sim \mathcal{N}(0, \Sigma_2)$ . The conditional independence graphs are characterized by the non-zero entries of the precision matrices  $\Sigma_1^{-1}$  and  $\Sigma_2^{-1}$  (Meinshausen and Bühlmann (2006)). Given an  $n_1$ -sample of  $Z_1$  and an  $n_2$ -sample of  $Z_2$  with  $n_1, n_2 \ll p$ , the objective is to test

$$H_0 : \Sigma_1^{-1} = \Sigma_2^{-1}$$

without assuming any sparse structure on the precision matrices.

### 1.1. This paper

In this paper we consider the following two-sample, linear regression models

$$y_A = x_A^\top \beta_A + u_A \quad (1.1)$$

and

$$y_B = x_B^\top \beta_B + u_B \quad (1.2)$$

with the unknown parameters of interest,  $\beta_A \in \mathbb{R}^p$  and  $\beta_B \in \mathbb{R}^p$ . For simplicity of presentation, we consider Gaussian random design, i.e.  $p$ -dimensional design vectors  $x_A$  and  $x_B$  follow normal distribution  $\mathcal{N}(0, \Sigma_A)$  and  $\mathcal{N}(0, \Sigma_B)$  with unknown covariance matrices  $\Sigma_A$  and  $\Sigma_B$ . Moreover, the noise components  $u_A, u_B$  are mean zero, independent from the design and have a distribution with unknown standard deviations  $\sigma_{u,A}$  and  $\sigma_{u,B}$ . In this formal setting, our objective is to test whether model (1.1) is the same as the model (1.2), i.e., to develop a test for the hypothesis of our interest

$$H_0 : \beta_A = \beta_B \quad (1.3)$$

with  $\beta_A, \beta_B \in \mathbb{R}^p$  and  $p \gg n$ . We will work with two independent samples  $\{(x_{A,i}, y_{A,i})\}_{i=1}^n$  and  $\{(x_{B,i}, y_{B,i})\}_{i=1}^n$  of size  $n$  but similar constructions can be exploited for the two samples of unequal sizes.

Here, we propose a hypothesis test for (1.3) that provides a valid error control without making any assumptions about the sparsity of the two model parameters. Although testing in high-dimensions has gained a lot of attention recently, the procedure proposed is, to the best of our knowledge, the first to possess all of the following properties.

- (a) The proposed test, named TestIng Equality of Regression Slopes (TIERS from here on), is valid regardless of the assumption of sparsity of the model parameters  $\beta_A$  and  $\beta_B$ . Type I error converges to the nominal level  $\alpha$  even if  $p \gg n$  and  $s/p \rightarrow c \in [0, 1]$ .
- (b) TIERS remains valid under any distribution of the model errors  $u_A, u_B$  even in the high-dimensional case. In particular, TIERS is robust to heavy-tailed distribution in the errors  $u_A$  and  $u_B$ , such as the Cauchy distribution.

- (c) Under weak regularity conditions, TIERS is nearly efficient compared to an oracle testing procedure and enjoys minimax optimality. Whenever,  $\Sigma_A = \Sigma_B$ , TIERS achieves the aforementioned efficiency and optimality properties regardless of the sparsity in  $\beta_A$  and  $\beta_B$ .

The approach also extends naturally to groups of regressions and can provide Type I and Type II errors using only convex optimization or linear programming. Additionally, the test can be generalized to the case where one considers nested models. Likewise, tests of the null hypothesis  $H_{0,j,k}: \beta_{A,j} = \beta_{B,k}$  can be performed.

### 1.2. Previous work

Hypothesis testing in high-dimensional regression is extremely challenging. Most estimators cannot guard against inclusion of noise variables unless restrictive and unverifiable assumptions (for example, irrepresentable condition (Zhao and Yu (2006)) or minimum signal strength (Fan and Peng (2004)) are made. Early work on p-values includes methods based on multiplicity correction that are conservative in their Type I error control (Meinshausen, Meier and Bühlmann (2009); Bühlmann (2013)), bootstrap methods that control false discovery rate (Meinshausen, Meier and Bühlmann (2009); Mandozzi and Bühlmann (2016)) and inference methods guaranteeing asymptotically exact tests under the irrepresentable condition (Fan and Li (2001)). More recently, there have been series of important studies that design asymptotically valid tests while relaxing the irrepresentable condition. Pioneering work of Zhang and Zhang (2014) develops de-biasing technique and shows that low-dimensional projections are an efficient way of constructing confidence intervals. In a major generalization, Van de Geer et al. (2014) consider a range of models which includes the linear models and the generalized linear models and obtain valid inference methods when  $s \log(p) = o(n^{1/2})$ . The literature has also seen work similar in spirit for Gaussian graphical models (Ren et al. (2015)). Javanmard and Montanari (2015) compute optimal sample size and minimax optimality of a modified de-biasing method of Javanmard and Montanari (2014), which allows for non-sparse precision matrix in the design. Zhang and Cheng (2016) and Dezeure, Bühlmann and Zhang (2016) evaluate approximating the overall level of significance for simultaneous testing of  $p$  model parameters. They demonstrate that the multiplier bootstrap of Chernozhukov, Chetverikov and Kato (2013) can accurately approximate the overall level of significance whenever the true model is sparse enough.

However, the above mentioned work requires model sparsity i.e.  $s/n \rightarrow 0$  as  $n \rightarrow \infty$  and is hence too restrictive to be used in many scientific data applications (social or biological networks for example). Moreover, despite the above progress in one-sample testing, two-sample hypothesis testing has not been addressed much in the existing literature. In the context of high-dimensional two-sample comparison of means, Bai and Saranadasa (1996); Chen and Qin (2010); Lopes, Jacob and Wainwright (2011); Cai, Liu and Xia (2014) have introduced

global tests to compare the means of two high-dimensional Gaussian vectors with unknown variance with and without direct sparsity in the model. Recently [Cai, Liu and Xia \(2013\)](#) and [Li and Chen \(2012\)](#) develop two-sample tests for covariance matrices of two high-dimensional vectors specifically extending the Hotelling's  $T^2$  statistics to high-dimensional setting, while [Zhu et al. \(2016\)](#) develop new spectral test that allows for block sparsity patterns. [Charbonnier, Verzelen and Villers \(2015\)](#) address the more general heterogeneity test but heavily relies on the direct sparsity in the model parameters. The latest effort in this direction is the work of [Städler and Mukherjee \(2016\)](#) where the authors extend screen-and-clean procedure of [Wasserman and Roeder \(2009\)](#) to the two-sample setting. The authors provide asymptotic Type I error guarantees that are only valid under sparse models. Notice that the last two methods are based on model selection and hence do not apply to dense models because, if  $s = p$ , perfect model selection simply means including all the features ( $p$ -dimensional with  $p \gg n$ ).

### 1.3. Challenges of two-sample testing in non-sparse models

The central problem of two-sample testing with  $p \geq n$  is in finding an adequate measure of comparison of the estimators between the two samples. In light of the great success in designing tests for one sample, it becomes natural to expect that the developed methods trivially apply to the two sample case. However, the situation is far from trivial when the sparsity assumption fails. Below we illustrate this problem via a specific example of dense and high-dimensional linear model.

In particular, we show that a naive extension of the powerful de-biasing procedure to the two-sample problem, fails whenever the model is dense enough. To that end, we consider a simple Gaussian design with  $x_A, x_B \sim \mathcal{N}(0, I_p)$  and assume that the errors are independent with the standard Gaussian distribution,  $u_A, u_B \sim \mathcal{N}(0, 1)$ . The true parameters have  $p$  non-zero elements (dense) and take the following form

$$\beta_A = \beta_B = \mathbf{1}_p c / \sqrt{n}, \quad (1.4)$$

where  $\mathbf{1}_p$  denotes a  $p$ -dimensional vector of ones and  $c \in \mathbb{R}$  is a constant.

For simplicity, we consider the “oracle” de-biasing (de-sparsifying) estimator, which is the estimator defined in Equation (5) of [Van de Geer et al. \(2014\)](#) except that the node-wise Lasso estimators for the precision matrices ( $\Sigma_A^{-1}$  and  $\Sigma_B^{-1}$ ) are replaced by their true values,  $I_p$ . We compute this “oracle” de-biasing estimators for both samples

$$\tilde{\beta}_k = \hat{\beta}_k + n^{-1} \sum_{i=1}^n x_{k,i} (y_{k,i} - x_{k,i}^\top \hat{\beta}_k)$$

for  $k \in \{A, B\}$ , where the initial estimator  $\hat{\beta}_k$  is the scaled Lasso estimator ([Sun](#)

and Zhang (2012)) defined as

$$(\hat{\beta}_k, \hat{\sigma}_k) = \arg \min_{\beta, \sigma} \left\{ \frac{\sum_{i=1}^n (y_{k,i} - x_{k,i}^\top \hat{\beta}_k)^2}{2n\sigma} + \frac{\sigma}{2} + \lambda \|\beta\|_1 \right\}. \quad (1.5)$$

Here,  $\lambda$  is set to be  $\lambda = \lambda_0 \sqrt{n^{-1} \log p}$ , where  $\lambda_0 > \sqrt{2}$  is a constant. As discussed after Theorem 2.2 of Van de Geer et al. (2014), de-biasing principles suggest a “naive” generalization of the one-sample T-test with a test statistic of the form

$$M_n = \max_{1 \leq j \leq p} \sqrt{n} |\tilde{\beta}_{A,j} - \tilde{\beta}_{B,j}| / \sqrt{\hat{\Sigma}_{A,j,j} + \hat{\Sigma}_{B,j,j}}.$$

A test of nominal size  $\alpha \in (0, 1)$ , would reject  $H_0$  whenever  $M_n > m_\alpha$  for the critical value  $m_\alpha$  defined as  $m_\alpha = F^{-1}(1 - \alpha, 0, \hat{\Sigma}_A, \hat{\Sigma}_B)$ , where  $\hat{\Sigma}_k = n^{-1} \sum_{i=1}^n x_{k,i} x_{k,i}^\top$  and  $F^{-1}(\cdot, c, \Sigma_A, \Sigma_B)$  is the inverse with respect to the first argument of  $F(x, c, \Sigma_A, \Sigma_B)$  with

$$F(x, c, \Sigma_A, \Sigma_B) = \mathbb{P} \left( \max_{1 \leq j \leq p} |\zeta_j| / \sqrt{\Sigma_{A,j,j} + \Sigma_{B,j,j}} \leq x \right)$$

and a  $p$ -dimensional Gaussian vector  $\zeta$  with mean  $(\Sigma_A - \Sigma_B) \mathbf{1}_p c$  and covariance  $\Sigma_A + \Sigma_B$ .

**Lemma 1.** *Let the null hypothesis  $H_0$  (1.3) hold. Consider de-biased estimators  $\tilde{\beta}_k$ ,  $k \in \{A, B\}$  with  $\lambda = \lambda_0 \sqrt{n^{-1} \log p}$  for  $\lambda_0 > \sqrt{2}$ . Then, in the above setting, as  $n \rightarrow \infty$*

$$\mathbb{P}(M_n > m_\alpha) = M(\alpha, c) + o(1),$$

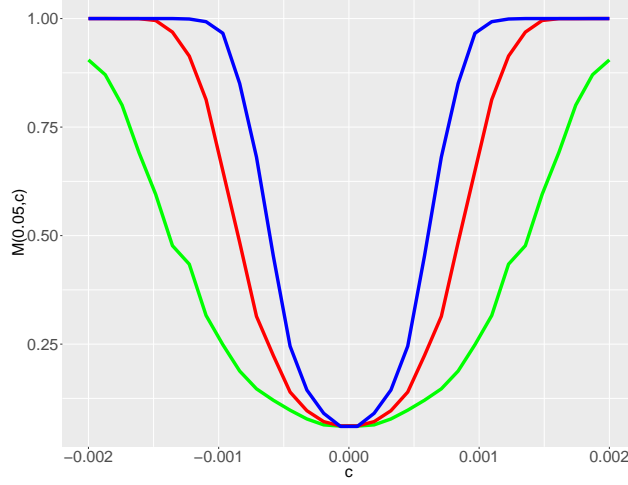
$$\text{where } M(\alpha, c) = \mathbb{E} \left[ F \left( F^{-1}(1 - \alpha, 0, \hat{\Sigma}_A, \hat{\Sigma}_B), c, \hat{\Sigma}_A, \hat{\Sigma}_B \right) \right].$$

Lemma 1 establishes that under  $H_0$ , the “naive” test  $M_n > m_\alpha$  has power approaching  $M(\alpha, c)$ . Notice that for the naive test to be valid, we need  $M(\alpha, c) \leq \alpha$  for all  $c \in \mathbb{R}$ . In Figure 1.1, we plot the function  $M(0.05, \cdot)$  for several combinations of  $(n, p)$ . As we can see,  $M(0.05, c)$  can be substantially larger than 0.05 and even reach one for  $c = 0.002$ . In other words, the probability of rejecting a true hypothesis can approach one when the model is not sparse. Hence, naively applying existing methods does not solve the two-sample testing problem in dense high-dimensional models.

#### 1.4. Notations and Organization of the paper

Throughout this paper,  $^\top$  denotes the matrix transpose and  $I_p$  denotes the  $p \times p$  identity matrix. The (multivariate) Gaussian distribution with mean (vector)  $\mu$  and variance (matrix)  $\Sigma$  is denoted by  $\mathcal{N}(\mu, \Sigma)$ . The cumulative distribution of the standard normal distribution is denoted by  $\Phi(\cdot)$ . For a vector  $v \in \mathbb{R}^k$ , we define its  $\ell_q$ -norm as follows:  $\|v\|_q = (\sum_{i=1}^k |v_i|^q)^{1/q}$  for  $q \in (0, \infty)$ ,  $\|v\|_\infty = \max_{1 \leq i \leq k} |v_i|$  and  $\|v\|_0 = \sum_{i=1}^k \mathbf{1}\{v_i \neq 0\}$ , where  $\mathbf{1}\{\cdot\}$  denotes the indicator

function. For matrix  $A$ , its  $(i, j)$  entry is denoted by  $A_{i,j}$ , its  $i$ -th row by  $a_i$  and its  $j$ -th column by  $A_j$ . We define  $\|A\|_\infty = \max |A_{i,j}|$ , where the maximum is taken over all  $(i, j)$  indices. We use  $\sigma_{\max}(\cdot)$  and  $\sigma_{\min}(\cdot)$  to denote the maximal and minimal singular values, respectively. For two sequences  $a_n, b_n > 0$ , we use  $a_n \asymp b_n$  to denote that there exist positive constants  $C_1, C_2 > 0$  such that  $\forall n$ ,  $a_n \leq C_1 b_n$  and  $b_n \leq C_2 a_n$ . For two real numbers  $a$  and  $b$ , let  $a \vee b$  and  $a \wedge b$  denote  $\max\{a, b\}$  and  $\min\{a, b\}$ , respectively. We use “s.t.” as the abbreviation for “subject to”. For two random quantities  $X$  and  $Y$  (scalars, vectors and matrices),  $X \perp Y$  denotes the independence of  $X$  and  $Y$ .

The rest of the paper is structured as follows. We develop the new methodology and the testing procedure in Section 2, where a novel ADDS estimator is also introduced. In Section 3, we develop a general theory of approximating the distribution of a large of class of test statistics with functions of Gaussian distributions. In Section 4, we derive theoretical properties of our test, such as size and power guarantees and efficiencies, and extend the results to non-Gaussian designs. In Section 5, Monte Carlo simulations are employed to assess the finite-sample performance of the proposed test. The proofs for all of the theoretical results are contained in the appendix.

## 2. Methodology

In this section we propose a new two-step methodology for testing in non-sparse and high-dimensional two-sample models. In the first step, we match the variables from the two samples to obtain a convolved sample, which satisfies a new model, referred to as the convolution regression model. This novel construction

allows us to reformulate the hypothesis of interest (1.3) into testable moment conditions on the convolved sample. In the second step, we construct a suitable moment test by utilizing plug-in principles and self-normalization. Therefore, convolving the two-samples allows us to work directly with a specific moment constraint. This substantially simplifies the problem and facilitates the theoretical analysis in non-sparse high-dimensional models. In contrast, the traditional Wald or Score methods for testing are no longer suitable in the current context.

### 2.1. Constructing testable moment conditions via convolution

This section introduces the idea of constructing a convolution regression equation, which naturally generates moment conditions that are equivalent to the original null hypothesis (1.3). Throughout this section, our interest is on analyzing Gaussian designs, which are common in applications. Extensions to non-Gaussian designs are presented in Section 4.

We propose to reformulate the models (1.1) and (1.2) into a new model, in which  $\beta_A - \beta_B$  appears as a regression coefficient, and then use it to derive a moment condition corresponding to the testing problem  $H_0 : \beta_A = \beta_B$ . Instead of naively concatenating two samples, we consider convolving the variables from the two respective samples as follows. Define the convolved response and error  $y = y_A + y_B$  and  $u = u_A + u_B$  and the new design matrices  $w = x_A + x_B$  and as well as  $z = x_A - x_B$ . With this notation at hand, (1.1) and (1.2) imply the following convolved regression model:

$$y = w^\top \theta_* + z^\top \gamma_* + u, \quad (2.1)$$

with unknown parameters

$$\theta_* = (\beta_A + \beta_B)/2 \quad \text{and} \quad \gamma_* = (\beta_A - \beta_B)/2.$$

In the above convolved model, parameter  $\gamma_*$  is of main interest as the null hypothesis  $H_0$  in (1.3) is equivalent to

$$H_0 : \gamma_* = 0.$$

Due to the high-dimensionality and potential lack of sparsity in  $\theta_*$  and  $\gamma_*$ , we cannot simply estimate  $\theta_*$  and  $\gamma_*$  and test  $\gamma_* = 0$ . In order to construct a number of testable moment restrictions, we use the conditioning information between  $w$  and  $z$ . Namely, we introduce the following parameter

$$\Pi_{*,j} = (\mathbb{E}[ww^\top])^{-1} \mathbb{E}[wz_j] \in \mathbb{R}^p,$$

describing correlation between the column  $z_j \in \mathbb{R}$  and the design matrix  $w \in \mathbb{R}^{n \times p}$ . In the case of Gaussian designs parameter  $\Pi_{*,j}$  also encodes their dependence structure. If we know  $\Pi_{*,j}$  then we can decouple the parameter of interest  $\gamma_*$  from the nuisance parameter  $\theta_*$  in (2.1). In order to see that, observe that

$$v_j = z_j - w^\top \Pi_{*,j}, \quad (2.2)$$



defined for  $1 \leq j \leq p$  satisfies that  $\mathbb{E}[vw^\top] = 0$ , where  $v = (v_1, \dots, v_p)^\top \in \mathbb{R}^p$ . Additionally for Gaussian design we have  $w \perp v$ . However, observe that  $v_1, \dots, v_p$  can be highly dependent.

The following lemma characterizes the unknown parameter  $\Pi_{*,j}$  and the covariance structure of the vector  $v$  of (2.2), i.e.,  $\mathbb{E}[vv^\top]$ . The proof is merely straight-forward computation and is thus omitted.

**Lemma 2.** *Under (1.1), (1.2) and (2.2), we have  $\Pi_* = (\Pi_{*,1}, \dots, \Pi_{*,p})$  with*

$$\Pi_* = (\Sigma_A + \Sigma_B)^{-1}(\Sigma_A - \Sigma_B) \in \mathbb{R}^{p \times p}$$

$$\text{and } \mathbb{E}[vv^\top] = 4(\Sigma_A^{-1} + \Sigma_B^{-1})^{-1}.$$

Now we illustrate how vector  $v$  can be utilized to decouple  $\gamma_*$  from  $\theta_*$ . First, observe that

$$\mathbb{E}[v(y - w^\top \theta_*)] = \mathbb{E}[vz^\top] \gamma_* = \mathbb{E}[vv^\top] \gamma_*$$

where equalities hold by (2.1) and (2.2), respectively. Second, we observe that by Lemma 2, the matrix  $\mathbb{E}[vv^\top]$  is nonsingular as long as  $\Sigma_A$  and  $\Sigma_B$  are nonsingular. Since  $\gamma_* = (\beta_A - \beta_B)/2$ , it follows that the original hypothesis  $H_0 : \beta_A = \beta_B$  holds if and only if  $\mathbb{E}[v(y - w^\top \theta_*)] = 0$ . Therefore, the two problems are equivalent and we can proceed to test the following moment condition

$$H_0 : \mathbb{E}[(z^\top - w^\top \Pi_*)(y - w^\top \theta_*)] = 0. \quad (2.3)$$

We will show that this restriction allows for the construction of a highly successful test while allowing  $\theta_*$  to be fully dense vector with  $p \geq n$ .

## 2.2. Testing the moment condition (2.3)

Now we discuss the effective construction of the test. The moment condition (2.3) involves the unknown quantities  $\Pi_*$  and  $\theta_*$ , which we replace with estimated counterparts. However, observe that the convolved model does not have the same distributional or sparsity properties as the original linear models. We do not assume consistent estimation for  $\theta_*$  and the validity of our test is built upon consistent estimation of  $\Pi_*$  only. We start by introducing some notations.

Given the two samples  $\{(x_{A,i}, y_{A,i})\}_{i=1}^n$  and  $\{(x_{B,i}, y_{B,i})\}_{i=1}^n$ , we define a new response vector  $Y = (y_{A,1} + y_{B,1}, \dots, y_{A,n} + y_{B,n})^\top \in \mathbb{R}^n$ , and use a matrix  $X_A = (x_{A,1}, \dots, x_{A,n})^\top \in \mathbb{R}^{n \times p}$ , and  $X_B = (x_{B,1}, \dots, x_{B,n})^\top \in \mathbb{R}^{n \times p}$ . Furthermore, we define two new design matrices,  $W = X_A + X_B \in \mathbb{R}^{n \times p}$  and  $Z = X_A - X_B \in \mathbb{R}^{n \times p}$ . We denote by  $u_i^\top$  the  $i$ -th row of  $U = (Y_A - X_A \beta_A) + (Y_B - X_B \beta_B)$ . Finally, the  $j$ -th column of  $X_A$ ,  $X_B$  and  $Z$  will be denoted by  $X_{A,j}$ ,  $X_{B,j}$  and  $Z_j$ , respectively.

### 2.2.1. Auto-aDaptive Dantzig Selector (ADDS)

We propose a novel estimator for  $\theta_*$ , which can be used to construct the test statistic. Let

$$\begin{aligned} \hat{\theta}(\sigma) &= \arg \min_{\theta \in \mathbb{R}^p} \|\theta\|_1 \\ \text{s.t.} \quad &\left\| n^{-1}(X_A + X_B)^\top (Y_A + Y_B - X_A\theta - X_B\theta) \right\|_\infty \leq \eta\sigma, \end{aligned} \quad (2.4)$$

where  $\eta \asymp \sqrt{n^{-1} \log p}$  is a tuning parameter that does not depend on  $\sigma_u$ . Moreover, let

$$\begin{aligned} \tilde{\sigma}_u &= \arg \max_{\sigma \geq 0} \sigma \\ \text{s.t.} \quad &\left\| Y_A + Y_B - X_A \hat{\theta}(\sigma) - X_B \hat{\theta}(\sigma) \right\|_2^2 \geq n\sigma^2/2. \end{aligned} \quad (2.5)$$

Our estimator for  $\theta_*$ , referred to as the Auto-aDaptive Dantzig Selector (ADDS), is defined as

$$\tilde{\theta} = \hat{\theta}(\tilde{\sigma}_u). \quad (2.6)$$

An advantage of the proposed estimator is that it simultaneously estimates  $\sigma_u^2 = \mathbb{E}[u^2]$  and  $\theta_*$  and is thus “scale-free”. The intuition behind the proposed ADDS is that estimation of the signal and estimation of its variance are closely related and can benefit from each other: a more accurate estimation of the variance can lead to a better signal estimation and a more accurate signal estimation can help estimate the variance better. Notice that the solution is well defined if  $\text{rank}(W) = n$ ; when  $\text{rank}(W) = n$ ,  $\hat{\theta}(0)$  exists and 0 satisfies the constraint in the optimization problem (2.5). Moreover, the solution path  $\sigma \mapsto \hat{\theta}(\sigma)$  can be computed very efficiently using algorithms such as DASSO (James, Radchenko and Lv (2009)) and the parametric simplex method (Pang, Liu and Vanderbei (2014); Vanderbei (2014)). Once the solution path is obtained, computing  $\tilde{\sigma}_u$  is only a one-dimensional optimization problem and thus can be solved efficiently.

The estimator for  $\Pi_*$  also takes the form of ADDS estimator and is defined as follows. For every  $j \in \{1, \dots, p\}$ ,  $\hat{\Pi}_j(\tilde{\sigma}_j) \in \mathbb{R}^p$  is defined by

$$\begin{aligned} \hat{\Pi}_j(\sigma) &= \arg \min_{\pi \in \mathbb{R}^p} \|\pi\|_1 \\ \text{s.t.} \quad &\left\| n^{-1}(X_A + X_B)^\top (X_{A,j} - X_{B,j} - X_A\pi - X_B\pi) \right\|_\infty \leq \eta\sigma, \end{aligned} \quad (2.7)$$

and

$$\begin{aligned} \tilde{\sigma}_j &= \arg \max_{\sigma \geq 0} \sigma \\ \text{s.t.} \quad &\left\| X_{A,j} - X_{B,j} - X_A \hat{\Pi}_j(\sigma) - X_B \hat{\Pi}_j(\sigma) \right\|_2^2 \geq n\sigma^2/2. \end{aligned} \quad (2.8)$$

where  $\eta \asymp \sqrt{n^{-1} \log p}$  is a tuning parameter.

Then, the ADDS estimator of  $\Pi_*$  is defined as

$$\tilde{\Pi} = (\tilde{\Pi}_1, \dots, \tilde{\Pi}_p) \in \mathbb{R}^{p \times p} \quad \text{with} \quad \tilde{\Pi}_j = \hat{\Pi}_j(\tilde{\sigma}_j) \in \mathbb{R}^p. \quad (2.9)$$

Observe that ADDS estimator  $\tilde{\Pi}$  allows for adaptive and more accurate tuning of the heteroscedastic components  $v_1, \dots, v_p$ . Another advantage of ADDS is that the structure of the ADDS allow us to derive certain properties of our test without any restrictions on the distribution of the vector  $v$ . We relegate further discussions of ADDS for the Section 4.1.

### 2.2.2. A new test statistics

In this section we propose a new test statistics and a new simulation method to obtain its critical value.

We develop a test statistic for testing (1.3) as a scale-adjusted estimator of the moment condition (2.3) that requires estimates of  $\Pi_*$  and  $\theta_*$ . For  $\tilde{\Pi}$  and  $\tilde{\theta}$  defined in (2.9) and (2.6), we define our test statistic

$$T_n = n^{-1/2} \hat{\sigma}_u^{-1} \left\| (Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta}) \right\|_\infty, \quad (2.10)$$

with  $\hat{\sigma}_u$  defined as

$$\hat{\sigma}_u = \|Y - W\tilde{\theta}\|_2 / \sqrt{n}.$$

The value of  $T_n$  tends to be moderate when  $H_0$  is true, and large when  $H_0$  is false. Therefore, our test is to reject  $H_0$  in favor of  $H_1 : \beta_A \neq \beta_B$  if  $T_n$  is “too large.” Observe that the distribution of the test statistic  $T_n$  is difficult to obtain due to the complicated dependencies between different entries of  $(Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta})$ . However, we propose a new plug-in Gaussian approximation method that automatically takes into account such inter-dependence and the high-dimensionality. The critical value is defined as the pre-specified quantile of the  $\ell_\infty$  norm of a zero-mean Gaussian vector with known covariance matrix and is thus easy to compute by simulation.

Under  $H_0$ , the behavior of the test statistic can be analyzed through the following decomposition

$$n^{-1/2} (Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta}) = n^{-1/2} V^\top \hat{U} + \Delta,$$

where  $\hat{U} = Y - W\tilde{\theta}$ ,

$$\Delta = n^{-1/2} (\Pi_* - \tilde{\Pi})^\top W^\top \hat{U}$$

and  $V = (V_1, \dots, V_p)$  with

$$V_j = Z_j - W\Pi_{*,j}.$$

As we will show in the proof,

$$\|\Delta\|_\infty \hat{\sigma}_u^{-1} = o_P(1)$$

and the behavior of  $T_n$  is driven by  $\|n^{-1/2}V^\top \hat{U} \hat{\sigma}_u^{-1}\|_\infty$ .

Our approximation procedure is rooted in the implicit independence in the linear approximation term  $\sum_{i=1}^n v_i \hat{u}_i$ , where  $\hat{u}_i$  is the  $i$ -th entry of  $\hat{U}$  and  $v_i^\top$  is the  $i$ -th row of  $V$ . Suppose that  $H_0$  (1.3) holds. Notice that  $V$  is independent of  $(Y, W)$  by construction and that we purposely constructed ADDS estimator  $\tilde{\theta}$  as a function of  $(Y, W)$  only. Therefore,  $V$  is independent of  $\hat{U}$ . Because of this independence,

$$\left\| n^{-1/2} \sum_{i=1}^n v_i \hat{u}_i \hat{\sigma}_u^{-1} \right\|_\infty \text{ conditional on } \{\hat{u}_i\}_{i=1}^n \text{ has the same distribution as } \|\xi\|_\infty, \quad (2.11)$$

where

$$\xi \sim \mathcal{N}(0, Q) \quad \text{and} \quad Q = n^{-1} \sum_{i=1}^n \hat{\sigma}_u^{-2} \hat{u}_i^2 \mathbb{E}[v_i v_i^\top] = \mathbb{E}[v_1 v_1^\top].$$

Observe that covariance matrix  $Q$  is an unknown nuisance parameter in approximating the distribution of  $T_n$  with  $\|\mathcal{N}(0, Q)\|_\infty$ . Per Lemma 2,  $Q$  is a positive-definite matrix of growing dimensions. We propose to construct  $\hat{Q}$ , an estimator for  $Q$ , and then use a plug-in approach for the critical value by simulating the distribution of  $\|\mathcal{N}(0, \hat{Q})\|_\infty$ . We consider a natural estimator

$$\hat{Q} = n^{-1} \sum_{i=1}^n \hat{v}_i \hat{v}_i^\top, \quad (2.12)$$

where  $\hat{v}_i^\top$  is the  $i$ -th row of  $\hat{V} = Z - W\tilde{\Pi} \in \mathbb{R}^{n \times p}$ . In Section 3, we develop a general approximation theory that does not depend on the specific form of  $\hat{Q}$ , as long as it is a sufficiently good estimator of  $Q$ . For the ease of presentation, we introduce the function  $\Gamma(x, A) := \mathbb{P}(\|\xi\|_\infty \leq x)$  with  $\xi \sim \mathcal{N}(0, A)$ . Notice that for a given matrix  $A$ ,  $\Gamma(\cdot, A)$  can be easily computed via simulation. We summarize our method in Algorithm 1.

**Remark 1.** Notice that we assume the Gaussianity of  $v_i$  and thus the distribution of  $\|n^{-1/2} \sum_{i=1}^n v_i \hat{u}_i \hat{\sigma}_u^{-1}\|_\infty$  is exactly Gaussian. The above setup is more general in that it also applies when the Gaussianity of  $v_i$  fails. See Section 4.6 for details.

The methodology for our approximation when the null hypothesis prevails closely parallels that for construction of critical values in classical statistics, in which the limiting distribution of the test statistics can be derived but contains unknown nuisance parameters. In low-dimensional problems it is common to resort to a plug-in principle where the nuisance parameter is replaced by its consistent estimate. In this paper, we deal with high-dimensional problems for which the extreme dimensionality  $p \gg n$  renders the classical central limit theorems non applicable and poses challenges in deriving accurate approximations of the distributions of test statistics. With recent advances in high-dimensional central

- return** Reject  $H_0$  (1.3) if and only if  $T_n > \Gamma^{-1}(1 - \alpha, \hat{Q})$ .

limit theorem (see Chernozhukov, Chetverikov and Kato (2013) for example), we are able to generalize the classical plug-in method to the high-dimensional settings.

### 3. A high-dimensional plug-in principle

Many test statistics related to ratios, correlation and regression coefficients in statistics may be expressed as a nonlinear function of the vector of population quantities. Additionally, in high-dimensional setting test statistics often take the form of the maximum of a large number of random quantities  $\max_{1 \leq j \leq p} |G_{n,j}|$ , with  $G_{n,j} \in \mathbb{R}$ . Individual  $G_{n,j}$ 's can be studentized t-statistics, such as in Dezeure, Bühlmann and Zhang (2016), or simply the difference between a parameter and its estimator, such as in Zhang and Cheng (2016). Studying asymptotic distribution of such non-linear quantities is extremely difficult. However, linearization may prove to be a useful technique. Linearization decomposes a test statistic of interest into a linear term and an approximation error:

$$G_{n,j} = n^{-1/2} \sum_{i=1}^n \Psi_{i,j} + \Delta_{n,j}.$$

In display above we consider  $\Psi_i = (\Psi_{i,1}, \dots, \Psi_{i,p})^\top \in \mathbb{R}^p$  with  $p \gg n$  and  $i = 1, \dots, n$ .

In this section, we propose a general method of computing the critical value of the test statistic  $\max_{1 \leq j \leq p} |G_{n,j}|$ . This method is simple to implement and applies to a wide range of problems for which the above decomposition holds. The method is based on Gaussian approximations, as they enable easy approximations by simulation. Apart from high-dimensionality, the challenge is the presence of the approximation error  $\Delta_n = (\Delta_{n,1}, \dots, \Delta_{n,p})^\top \in \mathbb{R}^p$  and the fact that the linear terms  $\Psi_i$  are often not observed, i.e. depend on unknown parameters.

To present the main result, we define the covariance matrix  $Q = n^{-1} \sum_{i=1}^n \mathbb{E}(\Psi_i \Psi_i^\top | \mathcal{F}_n)$ , where  $\mathcal{F}_n$  is a  $\sigma$ -algebra such that  $\Psi_i$ , conditional on  $\mathcal{F}_n$ , is independent (or weakly dependent, e.g., strong mixing) across  $i$ . Moreover, we make assumptions on the structure of matrix  $Q$  and linearization terms.

**Assumption 1.** Suppose that

(i) there exist constants  $b_1, b_2 \in (0, \infty)$  such that

$$\mathbb{P} \left( b_1 \leq \min_{1 \leq j \leq p} Q_{j,j} \leq \max_{1 \leq j \leq p} Q_{j,j} \leq b_2 \right) \rightarrow 1;$$

(ii)  $\sup_{x \in \mathbb{R}} |\mathbb{P}(\|n^{-1/2} \sum_{i=1}^n \Psi_i\|_\infty \leq x \mid \mathcal{F}_n) - \Gamma(x, Q)| = o_P(1);$

(iii)  $\|\Delta_n\|_\infty \sqrt{\log p} = o_P(1)$  and there exists a matrix  $\hat{Q}$  such that  $\|\hat{Q} - Q\|_\infty \sqrt{\log p} = o_P(1).$

Assumption 1(ii) states a Gaussian approximation for the partial sum  $n^{-1/2} \sum_{i=1}^n \Psi_i$ . Sufficient conditions for this assumption are provided by Chernozhukov, Chetverikov and Kato (2013, 2014); see Proposition 1 in the appendix. Assumption 1(iii) is very mild and only assumes entry-wise consistency of the matrix estimator. For example, if  $\{\Psi_i\}_{i=1}^n$  is sub-Gaussian (Vershynin (2010)) and is observed, Bernstein's inequality and the union bound imply that the sample covariance matrix satisfies this assumption if  $\log p = o(\sqrt{n})$ .

**Theorem 3.** Suppose that Assumption 1 holds. Then, as  $n, p \rightarrow \infty$

$$\sup_{x \in \mathbb{R}} \left| \mathbb{P} \left( \max_{1 \leq j \leq p} |G_{n,j}| \leq x \mid \mathcal{F}_n \right) - \Gamma(x, \hat{Q}) \right| = o_P(1).$$

Theorem 3 states that, under the regularity conditions stated in Assumption 1, the distribution of the test statistic  $\max_{1 \leq j \leq p} G_{n,j}$  can be approximated by  $\Gamma(\cdot, \hat{Q})$ , which can be easily simulated. Notice that the multiplier bootstrap method by Chernozhukov, Chetverikov and Kato (2013, 2014), which requires explicit observations of  $\Psi_i$ , does not apply in our context.

## 4. Theoretical results

In this section we present theoretical guarantees and optimality of the test proposed in Section 2. We also consider extensions to non-Gaussian designs and present theoretical results in this setting as well. We start by deriving the theoretical properties of ADDS.

### 4.1. ADDS properties

Auto-aDaptive Dantzig Selector introduced in Section 2.2.1 is broadly applicable to a class of linear models where an estimator of the high-dimensional parameter is needed together with its scale. In this section we provide more details of the proposed estimator and its properties in a setup where apart from a sparsity constraint we allow for a general class of constraints as well. Our result is comparable to the Dantzig selector; see Candès and Tao (2007) and Bickel, Ritov and Tsybakov (2009).

With a slight abuse in notation, we consider a model

$$H = Gb_* + \varepsilon,$$

where  $H \in \mathbb{R}^n$  is a response vector,  $G \in \mathbb{R}^{n \times p}$  is a design matrix,  $\varepsilon \in \mathbb{R}^n$  is an error of the model and  $b_* \in \mathbb{R}^p$  is the unknown parameter of interest. Let  $\sigma \mapsto \mathcal{B}(\sigma)$  be a mapping such that (1)  $\mathcal{B}(\sigma) \subseteq \mathbb{R}^p$  for any  $\sigma \geq 0$  and (2)  $\mathcal{B}(\sigma_1) \subseteq \mathcal{B}(\sigma_2)$  for  $\sigma_1 \leq \sigma_2$ . We shall provide more discussion on the set  $\mathcal{B}(\sigma)$  later. Then a generalized ADDS is defined as

$$\begin{aligned} \hat{b}(\sigma) = \arg \min_{b \in \mathbb{R}^p} \quad & \|b\|_1 \\ \text{s.t.} \quad & \|n^{-1}G^\top(H - Gb)\|_\infty \leq \eta\sigma, \\ & b \in \mathcal{B}(\sigma) \end{aligned} \quad (4.1)$$

where  $\eta \asymp \sqrt{n^{-1} \log p}$  is a tuning parameter that does not depend on the magnitude of  $\varepsilon$ . Then we compute

$$\begin{aligned} \tilde{\sigma} = \arg \max_{\sigma \geq 0} \quad & \sigma \\ \text{s.t.} \quad & \|H - G\hat{b}(\sigma)\|_2^2 \geq n\sigma^2/2. \end{aligned} \quad (4.2)$$

Now the ADDS estimator for  $b_*$  is defined as

$$\tilde{b} = \hat{b}(\tilde{\sigma}). \quad (4.3)$$

In the proposed method, the estimation starts with the framework of Dantzig selector where the tuning parameter is split into two components: a variance-tuning component  $\sigma$  and variance-free component  $\eta$ . Variance is therefore treated as another tuning parameter and the standardized “regularization” tuning parameter is fixed at an optimal theoretical value proportional to  $\sqrt{\log(p)}/n$ . In practice, we can obtain  $\eta$  by simulating  $\|n^{-1}G^\top \xi\|_\infty$ , where  $\xi \sim \mathcal{N}(0, I_n)$ . In the first step (4.1), we compute the solution path, which maps the variance tuning parameter  $\sigma$  to its estimate  $\hat{b}(\sigma)$ . Then in the second step (4.2), we compute an “optimal” choice for the variance tuning parameter  $\tilde{\sigma}$ . The ADDS is then defined as the point on the solution path corresponding to this optimal choice  $\tilde{\sigma}$ .

The set  $\mathcal{B}(\sigma)$  is introduced for a general setup, where additional constraints other than the usual Dantzig restrictions are imposed. These additional constraints are represented by the set  $\mathcal{B}(\sigma)$ . This set could incorporate prior knowledge of the parameter of interest, e.g., a bound for the signal-to-noise ratio represented by  $\mathcal{B}(\sigma) = \{b \in \mathbb{R}^p : \|b\|_2 \leq c\sigma\}$  with some pre-specified  $c > 0$ . In case of non-Gaussian designs (see Algorithm 2), an additional constraint is placed to ensure the high-dimensional central limit theorem. Other strategies in literature, such as the square-root Lasso by Belloni, Chernozhukov and Wang (2011), the scaled Lasso by Sun and Zhang (2012) and self-tuned Dantzig selector by Gautier and Tsybakov (2013), do not have this flexibility.

**Assumption 2.** *There exist constants  $\eta, \kappa, \sigma_* > 0$  such that (i)  $\|n^{-1}G^\top \varepsilon\|_\infty \leq \eta\sigma_*$ , (ii)  $3\sigma_*^2/4 \leq n^{-1}\|\varepsilon\|_2^2 \leq 2\sigma_*^2$ , (iii)  $b_* \in \mathcal{B}(\sigma_*)$ , (iv)  $28\eta\sqrt{\|b_*\|_0/\kappa} \leq 1$  and the matrix  $G$  is such that the Restricted Eigenvalue condition holds, i.e., (v)*

$$\min_{J_0 \subseteq \{1, \dots, p\}, |J_0| \leq \|b_*\|_0} \min_{a \neq 0, \|a_{J_0^c}\|_1 \leq \|a_{J_0}\|_1} \frac{\|Ga\|_2^2}{n\|a_{J_0}\|_2^2} \geq \kappa. \quad (4.4)$$

In the usual linear regression setup, one can typically show that Assumption 2 holds with high probability. This is in line with the usual argument in high-dimensional statistics, where the conclusion often states the properties of an estimator on an event that occurs with probability close to one. Now we present the behavior of ADDS under Assumption 2.

**Theorem 4.** *Let Assumption 2 hold. Consider  $\tilde{\sigma}$  and  $\tilde{b}$  defined in (4.2) and (4.3), respectively. Then, for  $\hat{\sigma} = n^{-1/2}\|H - G\tilde{b}\|_2$ , we have*

$$\sigma_* \leq \tilde{\sigma} \leq 3\sigma_*, \quad (4.5)$$

$$\|G(\tilde{b} - b_*)\|_2 \leq 8\sigma_*\eta\sqrt{n\|b_*\|_0/\kappa}, \quad (4.6)$$

$$\|\tilde{b} - b_*\|_1 \leq 16\eta\sigma_*\|b_*\|_0/\kappa, \quad (4.7)$$

$$\sigma_*/\sqrt{2} \leq \hat{\sigma} \leq 2\sigma_*, \quad (4.8)$$

$$\|n^{-1}G^\top(H - G\tilde{b})\|_\infty \hat{\sigma}^{-1} \leq 3\sqrt{2}\eta. \quad (4.9)$$

Notice that  $\sigma_*$  might not always be equal to the standard deviation  $\sigma_\varepsilon := \sqrt{\mathbb{E}\|\varepsilon\|_2^2/n}$ . In fact,  $\sigma_*$  is only a rough proxy of  $\sigma_\varepsilon$  since any number in  $[0.9\sigma_\varepsilon, 1.1\sigma_\varepsilon]$  can serve as  $\sigma_*$ . This flexibility is especially useful for misspecified models, where  $\varepsilon$  is correlated with the design and  $\sigma_*$  is a quantity that depends on this correlation. Since  $\tilde{\theta}$  defined in (2.6) does not contain  $Z$ , the alternative hypothesis corresponds to a misspecified regression and we shall derive the power properties by exploiting the aforementioned flexibility in the interpretation of  $\sigma_*$ . Due to this flexibility, it is not reasonable to expect consistent estimator for  $\sigma_*$ , but Theorem 4 implies that ADDS estimator can generate an estimator that automatically approaches  $\|\varepsilon\|_2/\sqrt{n}$ . Under Assumption 2,

$$n^{-1/2} \left| \|H - G\tilde{b}\|_2 - \|\varepsilon\|_2 \right| \leq n^{-1/2} \|G(\tilde{b} - b_*)\|_2 \leq 8\sigma_*\eta\sqrt{\|b_*\|_0/\kappa}.$$

In other words, whenever  $\sigma_*\eta\sqrt{\|b_*\|_0/\kappa} = o(1)$ , we obtain that  $\|H - G\tilde{b}\|_2/\sqrt{n}$  is a consistent estimator for  $\|\varepsilon\|_2/\sqrt{n}$ .

#### 4.2. Size properties

We now turn to the properties of the introduced TIERS test while imposing extremely weak conditions when both  $n$  and  $p$  tend to  $\infty$ .

**Assumption 3.** *Consider the models (1.1) and (1.2). Suppose that the following hold:*



- (i) the design follows Gaussian distributions:  $x_A \sim \mathcal{N}(0, \Sigma_A)$  and  $x_B \sim \mathcal{N}(0, \Sigma_B)$
- (ii) there exist constants  $\kappa_1, \kappa_2 \in (0, \infty)$  such that the eigenvalues of  $\Sigma_A$  and  $\Sigma_B$  lie in  $(\kappa_1, \kappa_2)$
- (iii) for  $s_\Pi = \max_{1 \leq j \leq p} \|\Pi_{*,j}\|_0$ , let  $s_\Pi = o\left(\sqrt{n/\log^3 p}\right)$ .

Conditions (i)-(iii) of Assumption 3 are very mild. Gaussian designs are considered for the simplicity of the proofs. We study general sub-Gaussian designs in Section 4.6. Moreover, well-behaved designs with bounded eigenvalues of the covariance matrix is a common condition imposed in the literature. Finally, condition (iii) imposes column-wise sparsity of the matrix  $\Pi_*$ . When  $\Sigma_A = c\Sigma_B$  for  $c > 0$ , Lemma 2 implies that  $\Pi_* = I_p(c-1)/(c+1)$ , regardless of the sparsity of  $\Sigma_A$  and  $\Sigma_B$ , hence satisfying the imposed sparsity assumption. Observe that in contrast to the existing literature we do not assume sparsity of  $\Sigma_A$  and  $\Sigma_B$  (or their inverses), by Lemma 2 we only require certain products to be approximately sparse, a condition that is weaker and more flexible; see Cai and Liu (2011). Our first result is on the Type I error of the introduced TIERS test.

**Theorem 5.** *Consider Algorithm 1. Let Assumption 3 hold. Then, under  $H_0$  (1.3), as long as  $\log p = o(\sqrt{n})$  and  $n \rightarrow \infty$ , we have*

$$\mathbb{P}\left(T_n > \Gamma^{-1}(1 - \alpha, \hat{Q})\right) \rightarrow \alpha \quad \forall \alpha \in (0, 1).$$

There are two unique features of this result. Firstly, we do not assume any sparsity condition on  $\beta_A$  and  $\beta_B$ . This is remarkable in high dimensions with  $p \gg n$ . Secondly, the result of Theorem 5 holds without imposing any restriction on the distribution of the errors  $u_A$  and  $u_B$  in the models (1.1) and (1.2), respectively. This surprising property is achieved by the special design of the “partial self-normalization” of the test statistic and scale-free estimation of the introduced ADDS estimator. Notice that (2.11) holds does not require any assumption on the distribution of the error terms, such as the existence of probability densities. In light of this, we show that regardless of the sparsity of  $\theta_*$  and/or the distribution of  $U$ , the term  $n^{-1/2}V^\top(Y - W\hat{\theta})\hat{\sigma}_u^{-1}$  “partially self-normalized” by  $\hat{\sigma}_u = \|Y - W\hat{\theta}\|_2/\sqrt{n}$  is free of scales of the error terms and has a normal distribution under  $H_0$  (1.3). Moreover, as pointed out by de la Pena, Klass and Leung Lai (2004), self-normalization often eliminates or weakens moment assumptions.

### 4.3. Power properties

Due to the convolved regression model (2.1), we can assess the power properties of the TIER test by considering the following alternative hypothesis

$$H_1 : \gamma_* \neq 0. \tag{4.10}$$

It is clear that the difficulty of differentiating  $H_0$  from  $H_1$  depends on the magnitude of  $\gamma_*$ . We shall establish the rate for magnitude of  $\gamma_*$  such that our

test has power approaching one; see Theorem 6. Later, we shall also show that this rate is optimal; see Theorems 7 and 8.

**Assumption 4.** *Let Assumption 3 hold. In addition, suppose (1) that  $s_\Pi \|\beta_A - \beta_B\|_0 + \|\beta_A + \beta_B\|_0 = o(\sqrt{n}/\log p)$  and (2) that there exist constant  $\delta, \kappa_3 \in (0, \infty)$  such that  $\mathbb{E}|u_A|^{2+\delta} \leq \kappa_3$  and  $\mathbb{E}|u_B|^{2+\delta} \leq \kappa_3$ .*

Assumption 4 is reasonably weak. It is not surprising that certain sparse structure is needed to guarantee asymptotic power of high-dimensional tests. However, we still allow for lack of sparsity structure in the model parameters  $\beta_A$  and  $\beta_B$ . In particular, we only require sparsity of  $\beta_A + \beta_B$  and that the product  $s_\Pi \|\beta_A - \beta_B\|_0$  is small. For example, if  $\beta_A = -\beta_B = \beta_*$  for some dense  $\beta_*$  and  $\Sigma_A = \Sigma_B$ , then  $s_\Pi = 0$  and  $\beta_A + \beta_B = 0$ , satisfying Assumption 4. Moreover, for sparse vectors  $\beta_A$  and  $\beta_B$  the rate condition  $o(\sqrt{n}/\log p)$  matches those of one-sample testing; see Van de Geer et al. (2014) and Cai and Guo (2015).

**Theorem 6.** *Let  $H_1$  in (4.10) and Assumption 4 hold. Suppose that  $n \rightarrow \infty$  and  $p \rightarrow \infty$  with  $\log p = o(\sqrt{n})$ . Then, there exist constants  $K_1, K_2 > 0$  depending only on the constants in Assumption 4 such that, whenever*

$$\|\Sigma_V \gamma_*\|_\infty \geq \sqrt{n^{-1} \log p} (K_1 \|\gamma_*\|_2 + K_2),$$

with  $\Sigma_V$  defined in Lemma 2, the test in Algorithm 1 is asymptotically powerful, i.e.,

$$\mathbb{P}\left(T_n > \Gamma^{-1}(1 - \alpha, \hat{Q})\right) \rightarrow 1 \quad \forall \alpha \in (0, 1).$$

For power comparison, we consider two benchmarks in the next two sections: the most powerful test, which is infeasible, and the minimax optimality. We show that, in terms of rate for the magnitude of deviations from the null hypothesis, our test differs from the most powerful test by only a logarithm factor and achieves the minimax optimality whenever the model possesses certain sparsity properties. In this sense, our test is efficient in sparse settings and is robust to the lack of sparsity and heavy tails.

#### 4.4. Efficiency

In the rest of the section, we assume that the data is jointly Gaussian and derive the optimal power of the likelihood-ratio test of one distribution against another. As such a test is the most powerful test for distinguishing two given distributions (Lehmann and Romano (2006)), we named it the oracle test. We proceed to show that the power of our test differs from that of the oracle test by a logarithmic factor.

Let the distribution of the data be indexed by  $\lambda = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_B)$ . The probability, expectation and variance under  $\lambda$  are denoted by  $\mathbb{P}_\lambda$ ,  $\mathbb{E}_\lambda$  and  $\text{Var}_\lambda$ , respectively. Consider the problem of testing

$$H_0 : \lambda = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_A)$$

versus

$$H_1 : \lambda = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_A + \gamma_*) \text{ for a given } \gamma_* \neq 0.$$

**Theorem 7.** *Let the data be jointly Gaussian. Consider the likelihood ratio test of nominal size  $\alpha$  for the above problem. Then, as  $n \rightarrow \infty$ , the power of the likelihood ratio test is*

$$\Phi(d_n - \Phi^{-1}(1 - \alpha)) + o(1),$$

with

$$d_n = \frac{\sqrt{n}\gamma_*^\top \Sigma_B \gamma_*}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2/2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^2}}.$$

Due to the optimality of the likelihood ratio test, Theorem 7 says that there does not exist any test that has power approaching one against the alternatives where  $\|\gamma_*\|_2 = O(n^{-1/2})$ , even if  $\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2$  and  $\beta_A$  are known. In the extreme sparse setting with  $\|\beta_A\|_0 = O(1)$  and  $\|\beta_B\|_0 = O(1)$ , Theorem 7 in turn implies that one should not expect perfect power against  $\|\beta_A - \beta_B\|_\infty \asymp n^{-1/2}$ . On the other hand, Theorem 6 says that our test has asymptotically perfect power against  $\|\beta_A - \beta_B\|_\infty \asymp \sqrt{n^{-1} \log p}$  when  $\|\beta_A\|_2 = O(1)$ ,  $\|\beta_B\|_2 = O(1)$  and  $\Sigma_V$  is sparse. In this sense, our test is nearly optimal – in terms of the magnitude of deviations from the null hypothesis, our test differs from the most powerful test up to a mere logarithm factor.

#### 4.5. Minimax Optimality

Notice that the critical value of the above likelihood ratio test depends on  $\gamma_*$  in the alternative hypothesis. In practice, the value of  $\gamma_*$  is often unknown; in fact, the values of  $\Sigma_A, \Sigma_B, \sigma_{u,A}, \sigma_{u,B}$  and  $\beta_A$  are usually unknown as well. We thus compare our test with a benchmark test that has guaranteed power against a class of alternative hypotheses (in terms of  $\gamma_*$ ).

We define

$$\Lambda_0 = \left\{ \lambda = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_B) : \right. \\ \left. \sigma_{\min}(\Sigma_A), \sigma_{\min}(\Sigma_B), \sigma_{\max}(\Sigma_A), \sigma_{\max}(\Sigma_B), \sigma_{u,A}, \sigma_{u,B} \in [M_1, M_2] \text{ and } \beta_A = \beta_B \right\},$$

where  $M_1, M_2 \in (0, \infty)$  are constants. For  $\tau > 0$ , we also define

$$\Lambda(\tau) = \left\{ \lambda = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_B) : \right. \\ \left. \sigma_{\min}(\Sigma_A), \sigma_{\min}(\Sigma_B), \sigma_{\max}(\Sigma_A), \sigma_{\max}(\Sigma_B), \sigma_{u,A}, \sigma_{u,B} \in [M_1, M_2] \right. \\ \left. \text{and } \|\Sigma_V(\beta_B - \beta_A)\|_\infty \geq \tau \sqrt{n^{-1} \log p} (\|\beta_B - \beta_A\|_2 + 1) \right\}.$$

We consider the problem of testing

$$H_0 : \lambda \in \Lambda_0 \quad \text{versus} \quad H_1 : \lambda \in \Lambda(\tau).$$

**Theorem 8.** Let  $\tau = (M_1 + M_2)/8$ . Suppose that the data is jointly Gaussian,  $\log p = o(\sqrt{n})$  and  $p \rightarrow \infty$ . Then for any test  $\phi_n = \phi_n(Y_A, Y_B, X_A, X_B)$  satisfying  $\limsup_{n \rightarrow \infty} \sup_{\lambda \in \Lambda_0} \mathbb{E}_\lambda \phi_n \leq \alpha$ , we have

$$\liminf_{n \rightarrow \infty} \inf_{\lambda \in \Lambda(\tau)} \mathbb{E}_\lambda \phi_n \leq \alpha.$$

Theorem 8 says that there does not exist any test that has power against all the alternatives in  $\Lambda(\tau)$  for some fixed  $\tau > 0$ . This means that power can only be guaranteed uniformly against alternatives with deviations of magnitude of at least  $\sqrt{n^{-1} \log p}$  in terms of  $\|\Sigma_V(\beta_B - \beta_A)\|_\infty / (\|\beta_B - \beta_A\|_2 \vee 1)$ . Comparing with the power that TIER test achieves in Theorem 6, the test TIER is rate-optimal when Assumption 4 holds.

#### 4.6. Considerations for Non-Gaussian Designs

Here, we highlight the extension of the proposed methodology for non-Gaussian designs. For non-Gaussian designs, in order to better control the estimation error, we propose to augment the ADDS estimator for  $\theta$  with an additional constraint on the size of the residuals. Namely, we define

$$\begin{aligned} \check{\theta}(\sigma) &= \arg \min_{\theta \in \mathbb{R}^p} \|\theta\|_1 \\ \text{s.t.} \quad &\|n^{-1}W^\top(Y - W\theta)\|_\infty \leq \eta\sigma, \\ &\|Y - W\theta\|_\infty \leq \mu\sigma \end{aligned} \quad (4.11)$$

For some tuning parameter  $\eta \asymp \sqrt{n^{-1} \log p}$  and  $\mu \asymp n^{1/9} \log^{1/3} p$ . Then, we compute

$$\begin{aligned} \check{\sigma}_u &= \arg \max_{\sigma \geq 0} \sigma \\ \text{s.t.} \quad &\|Y - W\check{\theta}(\sigma)\|_2^2 \geq n\sigma^2/2 \end{aligned} \quad (4.12)$$

Now our estimator for  $\theta_*$ , is defined as

$$\check{\theta}^+ = \check{\theta}(\check{\sigma}_u). \quad (4.13)$$

##### 4.6.1. Type I error control

Next, we present size properties for the developed test TIER<sup>+</sup> summarized in Algorithm 2. Such a result requires certain high-level conditions on the errors and the design, which we present below.

**Assumption 5.** Consider the model (1.1) and (1.2). Suppose that

- (i) There exist constants  $\kappa_1, \kappa_2 \in (0, \infty)$  such that the eigenvalues of both  $\Sigma_A = \mathbb{E}(x_A x_A^\top)$  and  $\Sigma_B = \mathbb{E}(x_B x_B^\top)$  lie in  $(\kappa_1, \kappa_2)$ .
- (ii) There exists a constant  $\kappa_3 \in (0, \infty)$  such that  $\|x_A\|_{\psi_2} < \kappa_3$  and  $\|x_B\|_{\psi_2} < \kappa_3$ .
- (iii) The error of the model (2.2),  $v_j$ , is independent of the design vector  $w$  for all  $1 \leq j \leq p$ .

**Algorithm 2** Testing of Equality of Regression Slopes with Non-Gaussian Design (TIERS<sup>+</sup>)

---

**Require:** Two samples  $(X_A, Y_A)$  and  $(X_B, Y_B)$  and level  $\alpha \in (0, 1)$  of the test.

**Ensure:** Decision whether or not to reject the null Hypothesis (1.3)

- 1: Given:  $(X_A, Y_A)$  and  $(X_B, Y_B)$  return whether or not to reject the null Hypothesis (1.3).
- 2: Construct  $W = X_A + X_B$ ,  $Z = X_A - X_B$  and  $Y = Y_A + Y_B$
- 3: Compute  $\check{\theta}$  in (4.13) with tuning parameters  $\eta \asymp \sqrt{n^{-1} \log p}$  and  $\mu \asymp n^{1/9} \log^{1/3} p$ .
- 4: Compute  $\tilde{\Pi}$  in (2.9) with tuning parameter  $\eta \asymp \sqrt{n^{-1} \log p}$ .
- 5: Compute the test statistic  $T_n^+$  as

$$T_n^+ = n^{-1/2} \check{\sigma}_u^{-1} \|(Z - W\tilde{\Pi})^\top (Y - W\check{\theta})\|_\infty, \quad (4.14)$$

with  $\check{\sigma}_u = n^{-1/2} \|Y - W\check{\theta}\|_2$  and  $\hat{Q}$  as in (2.12).

- 6: Compute  $\Gamma^{-1}(1 - \alpha, \hat{Q})$  (by simulation), where  $\Gamma^{-1}(\cdot, \hat{Q})$  is the inverse of  $\Gamma(\cdot, \hat{Q})$ .
  - return** Reject  $H_0$  (1.3) if and only if  $T_n > \Gamma^{-1}(1 - \alpha, \hat{Q})$
- 

Here, the design matrices are allowed to be sub-Gaussian and the errors of the original models (1.1) and (1.2) are still unrestricted. The following Theorem 9 shows that TIERS<sup>+</sup> test has asymptotically Type I-error equal to the nominal level  $\alpha \in (0, 1)$ .

**Theorem 9.** *Consider Algorithm 2. Let Assumption 5 hold. Suppose that  $n \rightarrow \infty$  and  $p \rightarrow \infty$  with  $\log p = o(n^{1/27})$ . Then, under  $H_0$  (1.3),*

$$\mathbb{P}\left(T_n^+ > \Gamma^{-1}(1 - \alpha, \hat{Q})\right) \rightarrow \alpha \quad \forall \alpha \in (0, 1).$$

Similar to Theorem 5, Theorem 9 is not based on the assumption of sparsity and does not need any assumption on the distribution of the error terms  $u_A$  and  $u_B$ . Theorem 9 establishes though somewhat stronger conditions on the growth of the dimension  $p$ . Now,  $p$  can grow with  $n$  as  $\log p = o(n^{1/27})$ , rather than  $\log p = o(\sqrt{n})$ . This can be considered as a price to pay for allowing for such weak distributional assumptions on both the errors and the designs of the models.

#### 4.6.2. Type II error control

Now we turn to power considerations and establish asymptotically that TIERS<sup>+</sup> is powerful as long as certain assumptions on the model structure are imposed.

**Assumption 6.** *Consider the model (1.1) and (1.2). Let Assumption 5 hold. In addition, suppose that  $\mathbb{E}|u_{A,i}|^9$  and  $\mathbb{E}|u_{B,i}|^9$  are bounded above with a constant  $\kappa_3 > 0$  and that  $s_\Pi \|\beta_A - \beta_B\|_0 + \|\beta_A + \beta_B\|_0 = o(\sqrt{n}/\log p)$*

Assumption 6 only imposes bounded ninth moment of the error distribution in addition to the size requirements of the model parameter (a condition needed for Gaussian designs as well – see Assumption 4).

The next result establishes asymptotic power of the TERS<sup>+</sup> test for a class of alternatives defined in (4.10) where  $\gamma_* = (\beta_A - \beta_B)/2$ .

**Theorem 10.** *Consider Algorithm 2. Let Assumption 6 hold. Suppose that  $n \rightarrow \infty$  and  $p \rightarrow \infty$  with  $\log p = o(n^{1/27})$ . Then, there exist constants  $K_1, K_2 > 0$  depending only on the constants in Assumption 6 and with  $\Sigma_V$  as defined in Lemma 2 such that, whenever*

$$\|\Sigma_V \gamma_*\|_\infty \geq \sqrt{n^{-1} \log p} (K_1 \|\gamma_*\|_2 + K_2),$$

*the test in Algorithm 2 is asymptotically powerful, i.e.,*

$$\mathbb{P}\left(T_n^+ > \Gamma^{-1}(1 - \alpha, \hat{Q})\right) \rightarrow 1 \quad \forall \alpha \in (0, 1).$$

Per Theorem 10 we conclude that TERS<sup>+</sup> preserves power properties similar to TERS. In particular, whenever the model is sparse, the test achieves optimal power and does not lose efficiency compared to tests designed only for sparse models.

## 5. Numerical Examples

In this section we present finite-sample evidence of the accuracy of the proposed method. We consider two broad groups of examples: differential regressions and differential networks.

### 5.1. Differential Regressions

In all the setups, we consider  $n = 200$  and  $p = 500$ . We consider the Toeplitz design  $x_A \sim \mathcal{N}(0, \Sigma_A)$  and  $x_B \sim \mathcal{N}(0, \Sigma_B)$  with  $(\Sigma_A)_{i,j} = (0.4)^{|i-j|}$  and  $\Sigma_B = c\Sigma_A$ . We consider two specifications for the model parameters:

- (1) In the sparse regime,  $\beta_A = (1, 1, 1, 0, \dots, 0)^\top$  and  $\beta_B = (1+h, 1, 1, 0, \dots, 0)^\top$ , i.e.,  $\|\beta_A\|_0 = \|\beta_B\|_0 = 3$ ;
- (2) In the dense regime,  $\beta_A = \zeta \|\zeta\|_2^{-1}$  with entries of  $\zeta$  being drawn from the uniform distribution on  $[0, 1]$  and  $\beta_B = \beta_A + (h, 0, \dots, 0)^\top$ .

The null hypothesis  $H_0$  (1.3) corresponds to  $h = 0$  and alternative hypotheses correspond to  $h \neq 0$ . We also consider two specifications for the error distributions

- (a) In the light-tail case,  $u_A$  and  $u_B$  are drawn from the standard normal distribution,
- (b) In the heavy-tail case,  $u_A$  and  $u_B$  are drawn from the standard Cauchy distribution.

These different specifications will be denoted as follows: SL (for sparse and light-tail), SH (for sparse and heavy-tail), DL (for dense and light-tail) and DH (for dense and heavy-tail).

The summary of the results is presented in Tables 1 - 3 where the rejection probabilities are computed based on 100 repetitions. The tuning parameter  $\eta$  is chosen as adaptively as

$$\eta = \sqrt{2 \log(p)/n} \max_{1 \leq j \leq p} \|W_j\|_2 / \sqrt{n}.$$

We vary deviations from the null to highlight power properties as well as the Type I errors. From the tables we observe that the TIERS performs exceptionally well in both Gaussian and heavy-tailed setting for the error terms. The rejection probabilities under the null hypothesis ( $h = 0$ ) are close to the nominal size 5% in all the settings, as expected from our theory.

In the case of light-tailed models (SL and DL) TIERS achieves perfect power relatively quickly independent of the sparsity of the underlying model. The dense case required larger deviations from the null to reach power of one. In the case of heavy-tailed models, TIERS shows excellent performance irrespective of the sparsity of the model. In comparison with the models with light-tailed errors, the models with the heavier tails need larger deviations from the null in order

to reach the same power. This is expected as the simulated Cauchy errors had an average variance of about 140 over 100 independent repetitions. Remarkably, dense models with heavy tailed errors performed extremely close to those of sparse models with heavy tailed errors, indicating that the heavy tails are the main driver of the power loss.

## 5.2. Differential Networks

We consider two independent Gaussian graphical models, where  $z_A \sim \mathcal{N}(0, \Omega_A^{-1})$  and  $z_B \sim \mathcal{N}(0, \Omega_B^{-1})$ . The goal is to conduct inference on the first row of the precision matrices by testing

$$H_0 : \Omega_{A,1,j} = \Omega_{B,1,j}, \quad \forall 1 \leq j \leq p.$$

We consider the follow specification

$$\Omega_A = \begin{pmatrix} \sigma^{-2} & -\beta_A^\top \sigma^{-2} \\ -\beta_A \sigma^{-2} & \Omega + \beta_A \beta_A^\top \sigma^{-2} \end{pmatrix} \quad \text{and} \quad \Omega_B = \begin{pmatrix} \sigma^{-2} & -\beta_B^\top \sigma^{-2} \\ -\beta_B \sigma^{-2} & \Omega + \beta_B \beta_B^\top \sigma^{-2} \end{pmatrix}.$$

Notice that we can write the model in the regression form:  $z_{A,1} = z_{A,-1}^\top \beta_A + \varepsilon_A$  and  $z_{B,1} = z_{B,-1}^\top \beta_B + \varepsilon_B$ , where  $\varepsilon_A$  and  $\varepsilon_B$  are the error terms. Therefore, it is equivalent to testing

$$H_0 : \beta_A = \beta_B.$$

We set  $\sigma = 0.5$  and

$$\beta_{B,j} = \begin{cases} \beta_{A,1} + h & \text{if } j = 1 \\ \beta_{B,j} & \text{otherwise.} \end{cases}$$

As in the linear case,  $h$  represents the deviations from the null hypothesis and  $h = 0$  corresponds to the null hypothesis. We consider two cases for  $\beta_A$ :

1. In the sparse case,  $\beta_A = (1, 1, 1, 0, \dots, 0)^\top / \sqrt{3}$ .
2. In the dense case,  $\beta_A = \zeta \|\zeta\|_2^{-1}$  with entries of  $\zeta$  being drawn from the uniform distribution on  $[0, 1]$ .

We consider two regimes for  $\Omega$ : sparse regime and dense regime.

- (a) For the sparse regime, we follow Ren et al. (2015) by setting  $\Omega = D$ , where  $D \in \mathbb{R}^{(p-1) \times (p-1)}$  is block diagonal with  $D_1 \in \mathbb{R}^{p_1 \times p_1}$ ,  $D_2 \in \mathbb{R}^{p_2 \times p_2}$  and  $D_3 \in \mathbb{R}^{p_2 \times p_2}$  on the diagonal. Here,  $p = 500$ ,  $p_1 = 249$  and  $p_2 = 125$ . For  $k = 1, 2, 3$ , we set  $D_{k,j,j} = \alpha_k$ ,  $D_{k,j,j-1} = D_{k,j-1,j} = 0.5\alpha_k$  and  $D_{k,j,j-2} = D_{k,j-2,j} = 0.4\alpha_k$ , where  $\alpha_1 = 1$ ,  $\alpha_2 = 2$  and  $\alpha_3 = 4$ .
- (b) For the dense regime, we set  $\Omega = D^{-1}$ .

It is worth pointing out that no existing method applies to the setting of  $\Omega = D^{-1}$ , i.e. the setting of large-scale and dense graphical models. The results are summarized in Table 4, where four cases are considered:  $S\beta+S\Omega$  (for sparse  $\beta_A$  and sparse  $\Omega$ ),  $D\beta+S\Omega$  (for dense  $\beta_A$  and sparse  $\Omega$ ),  $S\beta+D\Omega$  (for sparse  $\beta_A$  and dense  $\Omega$ ) and  $D\beta+D\Omega$  (for dense  $\beta_A$  and dense  $\Omega$ ).

In both sparse and dense settings, TIER performs well in terms of (1) controlling the size for  $h = 0$  and (2) exhibiting power against alternatives  $h \neq 0$ . As should be expected, TIER has better power in sparse specifications than in dense specifications, although the power eventually reaches on in all the settings.

## Conclusions and discussions

We have presented a framework for performing inference on the equivalence of the coefficients vectors between two linear regression models. We show that the rejection probability of the proposed tests under the null hypothesis converges to the nominal size under extremely weak conditions: (1) no assumption on the structure or sparsity of the coefficient vector and (2) no assumption on the error distribution. If the features in the two samples have the same variance matrix, then our result does not require any assumption on the feature covariance either. To the best of our knowledge, this is the first result for two-sample testing in

the high-dimensional setting that is robust to the failure of the model sparsity and thus is truly novel. Moreover, we establish both efficiency and optimality of our procedure. Applying this framework to performing inference on differential regressions and differential networks, we obtain new procedures of constructing accurate inferences in situations not previously addressed in the literature.

Our work also opens doors to new research areas in statistics. In terms of methodology, our work exploits the implication of the null hypothesis and can be extended to other inference problems. For example, it is practically important to extend our method to the high-dimensional ANCOVA problems, where the hypothesis of interest involves equivalence of parameters in multiple samples. Another extension is the inference of partial equivalence. Consider the problem of two or more samples generated by linear models, where the goal is to test the hypothesis that certain components in the model parameter are identical in the two samples. One important application is specification tests in large-scale models. Suppose that the data is collected from many different sources and contain several subgroups of observations. A common approach of extracting information from these datasets is to assume that all the subgroups are generated from linear models but these different subgroups share the same values in certain entries of the model parameters. Numerous methods have been developed in order to estimate the common components. However, as far as we know, no work exists that can be used to verify whether it is reasonable to assume common components. Our work can be further extended to provide simple tests for the specification of the common parameter values.

## Appendix A: Sufficient condition of Gaussian approximation in high dimensions

For the reader's convenience, we state the following result that applies to the conditional probability measure  $\mathbb{P}(\cdot \mid \mathcal{F}_n)$ . This result can be used to verify assumption (ii) of Theorem 3.

**Proposition 1** (Proposition 2.1 of Chernozhukov, Chetverikov and Kato (2014)).

Let  $\{\Psi_i\}_{i=1}^n$  be a sequence of random vectors in  $\mathbb{R}^p$  such that, conditional on some  $\sigma$ -algebra  $\mathcal{F}_n$ , is independent across  $i$  and has zero mean. Let  $Q = n^{-1} \sum_{i=1}^n \mathbb{E}(\Psi_i \Psi_i^\top \mid \mathcal{F}_n)$ . Suppose that

- (i) there exists a constant  $b \in (0, \infty)$  such that  $\mathbb{P}(\min_{1 \leq j \leq p} Q_{j,j} \geq b) \rightarrow 1$ .
- (ii) there exists a sequence of  $\mathcal{F}_n$ -measurable random variables  $B_n > 0$  such that  $B_n = o(\sqrt{n}/\log^{7/2}(pn))$ ,  $\max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n \mathbb{E}(|\Psi_{i,j}|^3 \mid \mathcal{F}_n) \leq B_n$  and  $\max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n \mathbb{E}(|\Psi_{i,j}|^4 \mid \mathcal{F}_n) \leq B_n^2$ .
- (iii) either (1)  $\max_{1 \leq i \leq n, 1 \leq j \leq p} \mathbb{E}[\exp(|\Psi_{i,j}|/B_n) \mid \mathcal{F}_n] \leq 2$  or (2)  $\max_{1 \leq i \leq n} \mathbb{E}(\max_{1 \leq j \leq p} |\Psi_{i,j}|^q \mid \mathcal{F}_n) \leq B_n^q$  for some  $B_n = o(n^{1-2/q}/\log^3(pn))$  and  $q > 0$ .

Then, when  $n \rightarrow \infty$  and  $p \rightarrow \infty$ , we have

$$\sup_{x \in \mathbb{R}} \left| \mathbb{P} \left( \left\| n^{-1/2} \sum_{i=1}^n \Psi_i \right\|_{\infty} \leq x \mid \mathcal{F}_n \right) - \Gamma(x, Q) \right| = o_P(1).$$

## Appendix B: Proof of Lemma 1

**Proof of Lemma 1.** Let  $Y_k = (y_{k,1}, \dots, y_{k,n})^\top \in \mathbb{R}^n$  and  $X_k = (x_{k,1}, \dots, x_{k,n})^\top \in \mathbb{R}^{n \times p}$  and define the event  $\mathcal{J} = \mathcal{J}_A \cap \mathcal{J}_B$ , where

$$\mathcal{J}_k = \{\|n^{-1} X_k^\top Y_k\|_{\infty} \leq \lambda n^{-1/2} \|Y_k\|_2\}$$

for  $k \in \{A, B\}$ . We proceed in two steps: (1) show the result assuming  $\mathbb{P}(\mathcal{J}) \rightarrow 1$  and (2) show  $\mathbb{P}(\mathcal{J}) \rightarrow 1$ .

**Step 1: show the result assuming  $\mathbb{P}(\mathcal{J}) \rightarrow 1$ .**

Let  $\beta_* = \mathbf{1}_p c / \sqrt{n}$  and

$$\zeta = \sqrt{n}(\hat{\Sigma}_A - \hat{\Sigma}_B)\beta_* + n^{-1/2} \sum_{i=1}^n (x_{A,i} u_{A,i} - x_{B,i} u_{B,i}).$$

For  $k \in \{A, B\}$ , on the event  $\mathcal{J}_k$ , the trivial estimator  $\bar{\beta}_k = 0$  satisfies the KKT optimality conditions of the scaled Lasso optimization (1.5):

$$\begin{cases} n^{-1} X_{k,j}^\top (Y_k - X_k \bar{\beta}_k) = \lambda \bar{\sigma}_k \text{sign}(\bar{\beta}_{k,j}) & \text{if } \bar{\beta}_{k,j} \neq 0 \\ |n^{-1} X_{k,j}^\top (Y_k - X_k \bar{\beta}_k)| \leq \lambda \bar{\sigma}_k & \text{if } \bar{\beta}_{k,j} = 0 \\ \bar{\sigma}_k = \|Y_k - X_k \bar{\beta}_k\|_2 / \sqrt{n}, \end{cases}$$

where  $\beta_{k,j}$  denotes the  $j$ -th entry of  $\beta_k$ ,  $X_{k,j}$  denotes the  $j$ -th column of  $X_k$  and  $\text{sign}(\cdot)$  is the sign function defined by  $\text{sign}(x) = x/|x|$  for  $x \neq 0$  and  $\text{sign}(0) = 0$ . Therefore, on the event  $\mathcal{J}$ , a trivial solution of all zeros is a scaled Lasso solution, i.e.  $\hat{\beta}_A = \hat{\beta}_B = 0$ . Since  $\beta_A = \beta_B = \beta_*$  (by  $H_0$  (1.3)), we have that, on the event  $\mathcal{J}$ ,

$$\begin{aligned} \sqrt{n}(\tilde{\beta}_A - \tilde{\beta}_B) &= n^{-1/2} X_A^\top Y_A - n^{-1/2} X_B^\top Y_B \\ &= \sqrt{n}(\hat{\Sigma}_A \beta_A - \hat{\Sigma}_B \beta_B) + n^{-1/2} \sum_{i=1}^n (x_{A,i} u_{A,i} - x_{B,i} u_{B,i}) \\ &= \sqrt{n}(\hat{\Sigma}_A - \hat{\Sigma}_B)\beta_* + n^{-1/2} \sum_{i=1}^n (x_{A,i} u_{A,i} - x_{B,i} u_{B,i}) = \zeta. \end{aligned}$$

Since  $\mathbb{P}(\mathcal{J}) \rightarrow 1$ , we have

$$\mathbb{P} \left( \sqrt{n}(\tilde{\beta}_A - \tilde{\beta}_B) = \zeta \right) \rightarrow 1. \quad (\text{B.1})$$

Notice that, conditional on  $\{(x_{A,i}, x_{B,i})\}_{i=1}^n$ ,  $\zeta$  is Gaussian with mean  $\sqrt{n}(\hat{\Sigma}_A - \hat{\Sigma}_B)\beta_*$  and variance  $\hat{\Sigma}_A + \hat{\Sigma}_B$ .

Therefore,  $F(\cdot, c, \hat{\Sigma}_A, \hat{\Sigma}_B)$  is the conditional distribution function of  $\max_{1 \leq j \leq p} |\zeta_j| / \sqrt{\hat{\Sigma}_{A,j,j} + \hat{\Sigma}_{B,j,j}}$ . Thus, the desired result follows by (B.1).

**Step 2: show  $\mathbb{P}(\mathcal{J}) \rightarrow 1$ .**

We show  $\mathbb{P}(\mathcal{J}_k) \rightarrow 1$ . Recall that  $\lambda = \lambda_0 \sqrt{n^{-1} \log p}$ . Let  $U_k = Y_k - X_k \beta_k$ . For simplicity, we drop the subscript  $k$  and write  $X$ ,  $Y$  and  $U$ , instead of  $X_k$ ,  $Y_k$  and  $U_k$ . Moreover, for  $1 \leq l \leq p$ , we define  $X_l$  as the  $l$ -th column of  $X$  and

$$\varepsilon_l = n^{-1/2} c \sum_{j=1, j \neq l}^p X_j + U.$$

Notice that  $X_l \perp \varepsilon_l$  and  $Y = cn^{-1/2} X_l + \varepsilon_l$  for any  $1 \leq l \leq p$ . Let  $\lambda_1$  be a constant satisfying  $\sqrt{2} < \lambda_1 < \lambda_0$ ; this is possible since  $\lambda_0 > \sqrt{2}$  is a constant.

Observe that

$$\mathbb{E} \|Y\|_2^2 / n = \sigma_*^2$$

with  $\sigma_* = \sqrt{n^{-1} p c^2 + 1}$ . Since  $n^{-1} \|Y\|_2^2 \sigma_*^{-2}$  is the average of  $n$  independent  $\chi^2(1)$  random variables, the classical central limit theorem implies that

$$n^{-1} \|Y\|_2^2 \sigma_*^{-2} = 1 + O_P(n^{-1/2}).$$

This means that

$$\mathbb{P} \left( n^{-1/2} \|Y\|_2 > \left( 1 - n^{-1/2} \log^{1/4} p \right) \sigma_* \right) \rightarrow 1.$$

Since  $n^{-1} \|X_l\|_2^2$  is also the average of  $n$  independent  $\chi^2(1)$  random variables, which are sub-exponential, the Bernstein's inequality and the union bound imply that, there exists a constant  $c_1 > 0$  such that

$$\mathbb{P} \left( \max_{1 \leq l \leq p} n^{-1} \|X_l\|_2^2 < 1 + c_1 \sqrt{n^{-1} \log p} \right) \rightarrow 1.$$

Hence,  $\mathbb{P}(\mathcal{A}) \rightarrow 1$  with

$$\mathcal{A} = \left\{ \max_{1 \leq l \leq p} n^{-1} \|X_l\|_2^2 < 1 + c_1 \sqrt{n^{-1} \log p} \right\} \cap \left\{ n^{-1/2} \|Y\|_2 > \left( 1 - n^{-1/2} \log^{1/4} p \right) \sigma_* \right\}. \quad (\text{B.2})$$

Conditional on  $X_l$ ,  $n^{-1/2} X_l^\top \varepsilon_l$  is Gaussian with mean zero and variance  $\sigma_l^2 = n^{-1} \|X_l\|_2^2 \sigma_+^2$ , where  $\sigma_+^2 = n^{-1} c^2 (p-1) + 1$ . Recall the elementary inequality that for  $Z \sim \mathcal{N}(0, \sigma^2)$  and  $t > 0$ ,  $\mathbb{P}(|Z| > t) \leq 2 \exp(-t^2/(2\sigma^2))$ . It follows that

$$\mathbb{P} \left( |n^{-1/2} X_l^\top \varepsilon_l| > \sigma_+ t \text{ and } \mathcal{A} \right) \leq 2 \mathbb{E} \exp \left[ -\frac{t^2}{2} / \left( 1 + c_1 \sqrt{n^{-1} \log p} \right) \right] \quad \forall t > 0.$$

Therefore,

$$\mathbb{P} \left( \max_{1 \leq l \leq p} |n^{-1/2} X_l^\top \varepsilon_l| > \lambda_1 \sigma_+ \sqrt{\log p} \right)$$

$$\begin{aligned}
&\leq \mathbb{P}(\mathcal{A}^c) + \sum_{l=1}^p \mathbb{P}\left(|n^{-1/2}X_l^\top \varepsilon_l| > \lambda_1 \sigma_+ \sqrt{\log p} \text{ and } \mathcal{A}\right) \\
&\leq \mathbb{P}(\mathcal{A}^c) + 2p \exp\left[-\frac{\lambda_1^2 \log p}{2(1 + c_1 \sqrt{n^{-1} \log p})}\right] \stackrel{(i)}{=} o(1), \tag{B.3}
\end{aligned}$$

where (i) holds by  $\lambda_1 > \sqrt{2}$  and (B.2). Since

$$Y = cn^{-1/2}X_l + \varepsilon_l,$$

we have  $n^{-1/2}X_l^\top Y = n^{-1}\|X_l\|_2^2 c + n^{-1/2}X_l^\top \varepsilon_l$ . It follows, by (B.3) and (B.2), that

$$\begin{aligned}
&\mathbb{P}\left(\max_{1 \leq l \leq p} |n^{-1}X_l^\top Y| > \lambda_1 \sigma_+ \sqrt{n^{-1} \log p} + 2cn^{-1/2}\right) \\
&\leq \mathbb{P}\left(\max_{1 \leq l \leq p} |n^{-1/2}X_l^\top \varepsilon_l| > \lambda_1 \sigma_+ \sqrt{\log p}\right) + \mathbb{P}\left(\max_{1 \leq l \leq p} n^{-1}\|X_l\|_2^2 > 2\right) = o(1). \tag{B.4}
\end{aligned}$$

Notice that

$$\begin{aligned}
&\mathbb{P}\left(n^{-1/2}\|Y\|_2 \lambda \geq \lambda_1 \sigma_+ \sqrt{n^{-1} \log p} + 2cn^{-1/2}\right) \tag{B.5} \\
&= \mathbb{P}\left(n^{-1/2}\|Y\|_2 \lambda_0 \sqrt{n^{-1} \log p} \geq \lambda_1 \sigma_+ \sqrt{n^{-1} \log p} + 2cn^{-1/2}\right) \\
&\geq \mathbb{P}\left(n^{-1/2}\|Y\|_2 \lambda_0 \sqrt{n^{-1} \log p} \geq \lambda_1 \sigma_+ \sqrt{n^{-1} \log p} + 2cn^{-1/2} \text{ and } \mathcal{A}\right) \\
&\stackrel{(i)}{\geq} \mathbb{P}\left(\left(1 - n^{-1/2} \log^{1/4} p\right) \sigma_* \lambda_0 \geq \lambda_1 \sigma_+ + 2c/\sqrt{\log p} \text{ and } \mathcal{A}\right) \\
&\geq \mathbb{P}\left(\left(1 - n^{-1/2} \log^{1/4} p\right) \sigma_* \lambda_0 \geq \lambda_1 \sigma_+ + 2c/\sqrt{\log p}\right) - \mathbb{P}(\mathcal{A}^c) \stackrel{(ii)}{\geq} 1 - o(1),
\end{aligned}$$

where (i) holds by (B.2) and (ii) holds by (B.2) and  $\lambda_1 < \lambda_0$ . Hence, by (B.4) and (B.5), we have  $\mathbb{P}(\|n^{-1}X^\top Y\|_\infty \leq \lambda n^{-1/2}\|Y\|_2) \rightarrow 1$ . The proof is complete.  $\square$

### B.1. Proof of Theorem 3

**Proof of Theorem 3.** For notational convenience, we denote by  $\mathbb{P}_{\mathcal{F}_n}(\cdot)$  by  $\mathbb{P}(\cdot \mid \mathcal{F}_n)$ . Let  $\bar{G} = \max_{1 \leq j \leq p} |G_{n,j}|$ . We proceed in two steps, where we show that (1)  $\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x)$  can be approximated by  $\Gamma(x, Q)$  and (2)  $\Gamma(x, Q)$  can be approximated by  $\Gamma(x, \hat{Q})$ . Since  $\|\hat{Q} - Q\|_\infty = o_P(1)$ , we have that

$$\mathbb{P}(\mathcal{J}_n) \rightarrow 1, \quad \text{where} \quad \mathcal{J}_n = \left\{ \hat{Q}_{j,j} \text{ and } Q_{j,j} \in [b_1/2, 2b_2], \forall 1 \leq j \leq p \right\}. \tag{B.6}$$

**Step 1: show that  $\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x)$  can be approximated by  $\Gamma(x, Q)$ .**

Fix an arbitrary  $\delta > 0$  and define  $\varepsilon_n = \delta/\sqrt{\log p}$ . Let  $S^\Psi = n^{-1/2} \sum_{i=1}^n \Psi_i$ ,  $Q_S^\Psi(x) = \mathbb{P}_{\mathcal{F}_n}(\|S^\Psi\|_\infty \leq x)$  and  $q_n = \sup_{x \in \mathbb{R}} |\Gamma(x, Q) - Q_S^\Psi(x)|$ . By assumption,  $q_n = o_P(1)$ . Let  $\xi \mid \mathcal{F}_n \sim \mathcal{N}(0, Q)$ . Notice that

$$\begin{aligned} & \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\|S^\Psi\|_\infty \in (x - \varepsilon_n, x + \varepsilon_n]) - \mathbb{P}_{\mathcal{F}_n}(\|\xi\|_\infty \in (x - \varepsilon_n, x + \varepsilon_n])| \\ &= \sup_{x \in \mathbb{R}} |[Q_S^\Psi(x + \varepsilon_n) - Q_S^\Psi(x - \varepsilon_n)] - [\Gamma(x + \varepsilon_n, Q) - \Gamma(x - \varepsilon_n, Q)]| \\ &\leq \sup_{x \in \mathbb{R}} |Q_S^\Psi(x + \varepsilon_n) - \Gamma(x + \varepsilon_n, Q)| + \sup_{x \in \mathbb{R}} |Q_S^\Psi(x - \varepsilon_n) - \Gamma(x - \varepsilon_n, Q)| \stackrel{(i)}{=} 2q_n \end{aligned}$$

where (i) holds by the definition of  $q_n$ . Therefore,

$$\begin{aligned} & \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x) - \Gamma(x, Q)| \tag{B.8} \\ &= \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\|S^\Psi + \Delta_n\|_\infty \leq x) - \Gamma(x, Q)| \\ &\leq \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\|S^\Psi + \Delta_n\|_\infty \leq x) - \mathbb{P}_{\mathcal{F}_n}(\|S^\Psi\|_\infty \leq x)| \\ &\quad + \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\|S^\Psi\|_\infty \leq x) - \Gamma(x, Q)| \\ &\stackrel{(i)}{\leq} \mathbb{P}_{\mathcal{F}_n}(\|\Delta_n\|_\infty > \varepsilon_n) + \sup_{x \in \mathbb{R}} \mathbb{P}_{\mathcal{F}_n}(\|S^\Psi\|_\infty \in (x - \varepsilon_n, x + \varepsilon_n]) + q_n \\ &\stackrel{(ii)}{\leq} \mathbb{P}_{\mathcal{F}_n}(\|\Delta_n\|_\infty > \varepsilon_n) + \sup_{x \in \mathbb{R}} \mathbb{P}_{\mathcal{F}_n}(\|\xi\|_\infty \in (x - \varepsilon_n, x + \varepsilon_n]) + 3q_n \\ &\stackrel{(iii)}{\leq} \mathbb{P}_{\mathcal{F}_n}(\|\Delta_n\|_\infty > \varepsilon_n) + C_b \varepsilon_n \sqrt{\log p} + 3q_n \text{ for some constant } C_b > 0, \end{aligned}$$

where (i) follows by Lemma 17 and the definition of  $q_n$ , (ii) follows by (B.7) and (iii) follows by Lemma 18. It follows that,  $\forall \delta > 0$ ,

$$\mathbb{E} \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x) - \Gamma(x, Q)| \leq \mathbb{P}(\|\Delta_n\|_\infty \sqrt{\log p} > \delta) + C_b \delta + 3\mathbb{E}q_n \stackrel{(i)}{=} o(1) + C_b \delta,$$

where (i) holds by  $\|\Delta_n\|_\infty \sqrt{\log p} = o_P(1)$  and  $\mathbb{E}q_n = o(1)$ : since  $q_n = o_P(1)$  and  $q_n$  is bounded (hence uniformly integrable), Theorem 5.4 on page 220 of Gut (2012) implies  $\mathbb{E}q_n = o(1)$ . Since  $\delta > 0$  is arbitrary, we have

$$\mathbb{E} \sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x) - \Gamma(x, Q)| = o(1).$$

By the Markov's inequality,

$$\sup_{x \in \mathbb{R}} |\mathbb{P}_{\mathcal{F}_n}(\bar{G} \leq x) - \Gamma(x, Q)| = o_P(1). \tag{B.9}$$

**Step 2: show that  $\Gamma(x, Q)$  can be approximated by  $\Gamma(x, \hat{Q})$ .**

Let  $\hat{\xi} \mid \mathcal{G}_n \sim \mathcal{N}(0, \hat{Q})$ , where  $\mathcal{G}_n$  is the  $\sigma$ -algebra generated by  $\mathcal{F}_n$  and  $\hat{Q}$ . Let  $\mathcal{D}(\xi) = (\xi^\top, -\xi^\top)^\top \in \mathbb{R}^{2p}$  and  $\mathcal{D}(\hat{\xi}) = (\hat{\xi}^\top, \hat{\xi}^\top)^\top \in \mathbb{R}^{2p}$ . Hence, we have that

$$\mathcal{D}(\xi) \mid \mathcal{F}_n \sim \mathcal{N}\left(0, \begin{pmatrix} Q & -Q \\ -Q & Q \end{pmatrix}\right) \quad \text{and} \quad \mathcal{D}(\hat{\xi}) \mid \mathcal{G}_n \sim \mathcal{N}\left(0, \begin{pmatrix} \hat{Q} & -\hat{Q} \\ -\hat{Q} & \hat{Q} \end{pmatrix}\right). \quad (\text{B.10})$$

Therefore, on the event  $\mathcal{J}_n$ ,

$$\begin{aligned} \sup_{x \in \mathbb{R}} \left| \Gamma(x, Q) - \Gamma(x, \hat{Q}) \right| &\stackrel{(i)}{=} \sup_{x \in \mathbb{R}} \left| \mathbb{P}_{\mathcal{F}_n} \left( \max_{1 \leq j \leq 2p} [\mathcal{D}(\xi)]_j \leq x \right) - \mathbb{P}_{\mathcal{G}_n} \left( \max_{1 \leq j \leq 2p} [\mathcal{D}(\hat{\xi})]_j \leq x \right) \right| \\ &\stackrel{(ii)}{\leq} C \|\hat{Q} - Q\|_\infty^{1/3} \left[ 1 \vee \log \left( p / \|\hat{Q} - Q\|_\infty \right) \right]^{2/3} \end{aligned}$$

for some constant  $C > 0$  depending only on  $b_1$  and  $b_2$ ; (i) holds by the fact  $\max_{1 \leq j \leq 2p} [\mathcal{D}(\xi)]_j = \|\xi\|_\infty$  and  $\max_{1 \leq j \leq 2p} [\mathcal{D}(\hat{\xi})]_j = \|\hat{\xi}\|_\infty$  and (ii) holds by (B.10) and Lemma 3.1 of Chernozhukov, Chetverikov and Kato (2013). Since  $\|\hat{Q} - Q\|_\infty = o_P(1/\sqrt{\log p})$ , it follows by (B.6) and the above display, that

$$\sup_{x \in \mathbb{R}} \left| \Gamma(x, Q) - \Gamma(x, \hat{Q}) \right| = o_P(1). \quad (\text{B.11})$$

The desired result follows by (B.9) and (B.11).  $\square$

## B.2. Proof of Theorem 4

**Proof of Theorem 4.** The arguments are similar to the proof of Theorem 7.2 of Bickel, Ritov and Tsybakov (2009). Let  $\Delta = \hat{b}(\sigma_*) - b_*$ ,  $J = \text{supp}(b_*)$  and  $s = |J|$ . Here, for any vector  $v = (v_1, \dots, v_p)^\top$ , we define  $\text{supp}(v) = \{j \mid |v_j| > 0\}$ . The proof proceeds in two steps. In the first step, we show that  $\sigma_*^2/2 \leq \|H - G\hat{b}(\sigma_*)\|_2^2/n$ ; in the second step, we show the desired results.

**Step 1: show  $\sigma_*^2/2 \leq \|H - G\hat{b}(\sigma_*)\|_2^2/n$**

Since  $\|n^{-1}G^\top(H - Gb_*)\|_\infty = \|n^{-1}G^\top \varepsilon\|_\infty \leq \eta\sigma_*$  and  $b_* \in \mathcal{B}(\sigma_*)$ , we have  $\|\hat{b}(\sigma_*)\|_1 \leq \|b_*\|_1$  and thus  $\|[\hat{b}(\sigma_*)]_J\|_1 + \|[\hat{b}(\sigma_*)]_{J^c}\|_1 \leq \|b_{*,J}\|_1$ . It follows, by the triangular inequality, that

$$\|\Delta_{J^c}\|_1 = \|[\hat{b}(\sigma_*)]_{J^c}\|_1 \leq \|b_{*,J}\|_1 - \|[\hat{b}(\sigma_*)]_J\|_1 \leq \|\Delta_J\|_1 \quad (\text{B.12})$$

$$\|\Delta\|_1 = \|\Delta_J\|_1 + \|\Delta_{J^c}\|_1 \leq 2\|\Delta_J\|_1. \quad (\text{B.13})$$

Since  $\|n^{-1}G^\top(H - Gb_*)\|_\infty \leq \eta\sigma_*$  and  $\|n^{-1}G^\top(H - G\hat{b}(\sigma_*))\|_\infty \leq \eta\sigma_*$ , the triangular inequality implies that  $\|n^{-1}G^\top G\Delta\|_\infty \leq 2\eta\sigma_*$ . Then

$$n^{-1}\Delta^\top G^\top G\Delta \leq \|\Delta\|_1 \|n^{-1}G^\top G\Delta\|_\infty \leq 2\eta\sigma_* \|\Delta\|_1 \stackrel{(i)}{\leq} 4\|\Delta_J\|_1 \eta\sigma_* \stackrel{(ii)}{\leq} 4\sqrt{s} \|\Delta_J\|_2 \eta\sigma_*,$$

where (i) follows by (B.13) and (ii) follows by Holder's inequality. By (4.4) and (B.13),  $n^{-1}\Delta^\top G^\top G\Delta \geq \kappa\|\Delta_J\|_2^2$ . Therefore, the above display implies that

$$\|\Delta_J\|_2 \leq 4\sqrt{s}\eta\sigma_*/\kappa. \quad (\text{B.14})$$

and

$$n^{-1/2}\|G\Delta\|_2 = \sqrt{n^{-1}\Delta^\top G^\top G\Delta} \leq \sqrt{4\sqrt{s}\|\Delta_J\|_2\eta\sigma_*} \leq 4\eta\sigma_*\sqrt{s/\kappa}. \quad (\text{B.15})$$

Then

$$n^{-1/2}\|Y - G\hat{b}(\sigma_*)\|_2 \geq n^{-1/2}\|\varepsilon\|_2 - n^{-1/2}\|G\Delta\|_2 \stackrel{(i)}{\geq} \sqrt{3\sigma_*^2/4 - 4\eta\sigma_*\sqrt{s/\kappa}} \stackrel{(ii)}{\geq} \frac{\sigma_*}{\sqrt{2}}, \quad (\text{B.16})$$

where (i) follows by  $n^{-1}\|\varepsilon\|_2^2 \geq 3\sigma_*^2/4$  and (B.15) and (ii) follows by  $28\eta\sqrt{s/\kappa} \leq 1$ .

### Step 2: show the desired results

Recall  $\tilde{b} = \hat{b}(\tilde{\sigma})$  and define  $\delta = \tilde{b} - b_*$ . By (B.16), we have  $\sigma_* \leq \tilde{\sigma}$  and thus  $\mathcal{B}(\sigma_*) \subseteq \mathcal{B}(\tilde{\sigma})$  (by the property of  $\mathcal{B}(\sigma_1) \subseteq \mathcal{B}(\sigma_2)$  for  $\sigma_1 \leq \sigma_2$ ), implying that  $\hat{b}(\sigma_*) \in \mathcal{B}(\tilde{\sigma})$ . By construction, the mapping  $\sigma \mapsto \|\hat{b}(\sigma)\|_1$  is non-increasing. It follows that  $\|\tilde{b}\|_1 = \|\hat{b}(\tilde{\sigma})\|_1 \leq \|\hat{b}(\sigma_*)\|_1$ . Recall from Step 1, we have that  $\|\hat{b}(\sigma_*)\|_1 \leq \|b_*\|_1$ . Therefore,

$$\|\tilde{b}\|_1 \leq \|b_*\|_1,$$

which means that  $\|\tilde{b}_J\|_1 + \|\tilde{b}_{J^c}\|_1 \leq \|b_{*,J}\|_1$  and thus  $\|\tilde{b}_{J^c}\|_1 \leq \|b_{*,J}\|_1 - \|\tilde{b}_J\|_1$ . It follows, by the triangular inequality, that

$$\|\delta_{J^c}\|_1 = \|\tilde{b}_{J^c}\|_1 \leq \|b_{*,J}\|_1 - \|\tilde{b}_J\|_1 \leq \|\delta_J\|_1 \text{ and } \|\delta\|_1 = \|\delta_J\|_1 + \|\delta_{J^c}\|_1 \leq 2\|\delta_J\|_1. \quad (\text{B.17})$$

Since  $\|n^{-1}G^\top(H - G\tilde{b})\|_\infty \leq \eta\tilde{\sigma}$  and  $\|n^{-1}G^\top\varepsilon\|_\infty \leq \eta\sigma_*$ , we have that

$$\begin{aligned} \|n^{-1}G^\top G\delta\|_\infty &= \|n^{-1}G^\top(H - G\tilde{b} - \varepsilon)\|_\infty \\ &\leq \|n^{-1}G^\top(H - G\tilde{b})\|_\infty + \|n^{-1}G^\top\varepsilon\|_\infty \leq \eta(\tilde{\sigma} + \sigma_*). \end{aligned} \quad (\text{B.18})$$

Hence,

$$\begin{aligned} n^{-1}\delta^\top G^\top G\delta &\stackrel{(i)}{\leq} \|\delta\|_1 \|n^{-1}G^\top G\delta\|_\infty \\ &\stackrel{(ii)}{\leq} 2\|\delta_J\|_1 \eta(\tilde{\sigma} + \sigma_*) \\ &\stackrel{(iii)}{\leq} 2\sqrt{s}\|\delta_J\|_2 \eta(\tilde{\sigma} + \sigma_*), \end{aligned} \quad (\text{B.19})$$

where (i) follows by Holder's inequality, (ii) follows by (B.17) and (B.18) and (iii) follows by Holder's inequality. By (4.4) and (B.17), we have  $n^{-1}\|G\delta\|_2^2 \geq \kappa\|\delta_J\|_2^2$ . This and (B.19) imply that

$$\|\delta_J\|_2 \leq 2\sqrt{s}\eta(\tilde{\sigma} + \sigma_*)/\kappa. \quad (\text{B.20})$$



and thus

$$n^{-1}\|G\delta\|_2^2 \leq 2\sqrt{s}\|\delta_J\|_2\eta(\tilde{\sigma} + \sigma_*) \leq 4s\eta^2(\tilde{\sigma} + \sigma_*)^2/\kappa. \quad (\text{B.21})$$

Since  $\tilde{\sigma}^2/2 \leq \|H - G\tilde{b}\|_2^2/n$ , we have that

$$\begin{aligned} \frac{\tilde{\sigma}}{\sqrt{2}} &\leq n^{-1/2}\|H - G\tilde{b}\|_2 = n^{-1/2}\|\varepsilon - G\delta\|_2 \\ &\leq n^{-1/2}\|G\delta\|_2 + n^{-1/2}\|\varepsilon\|_2 \\ &\stackrel{(i)}{\leq} 2\sqrt{s/\kappa}\eta(\tilde{\sigma} + \sigma_*) + \sqrt{2}\sigma_*, \end{aligned} \quad (\text{B.22})$$

where (i) follows by (B.21) and the assumption  $n^{-1}\|\varepsilon\|_2^2 \leq 2\sigma_*^2$ . Regrouping (B.22), we have

$$\left(1/\sqrt{2} - 2\eta\sqrt{s/\kappa}\right)\tilde{\sigma} \leq \left(2\eta\sqrt{s/\kappa} + \sqrt{2}\right)\sigma_*.$$

Since  $2\eta\sqrt{\|b_*\|_0/\kappa} \leq 1/14$ , it follows that

$$\tilde{\sigma} \leq \frac{2\eta\sqrt{s/\kappa} + \sqrt{2}}{1/\sqrt{2} - 2\eta\sqrt{s/\kappa}}\sigma_* \leq \frac{1/14 + \sqrt{2}}{1/\sqrt{2} - 1/14}\sigma_* < 3\sigma_*. \quad (\text{B.23})$$

By the definition of  $\tilde{\sigma}$  (4.2),  $\sigma_* \leq \tilde{\sigma}$ . We have proved claim (4.5). We prove claim (4.6) by combining (B.21) and (B.23). We obtain claim (4.7) by noticing that

$$\|\delta\|_1 \stackrel{(i)}{\leq} 2\|\delta_J\|_1 \stackrel{(ii)}{\leq} 2\sqrt{s}\|\delta_J\|_2 \stackrel{(iii)}{\leq} 4s\eta(\tilde{\sigma} + \sigma_*)/\kappa \stackrel{(iv)}{\leq} 16s\eta\sigma_*/\kappa,$$

where (i) follows by (B.17), (ii) follows by Holder's inequality, (iii) follows by (B.20) and (iv) follows by (B.23).

To see claim (4.8), first notice that  $\tilde{\sigma}/\sqrt{2} \leq n^{-1/2}\|H - G\tilde{b}\|_2$  by the constraint in the optimization problem (4.2). By (4.5), we have  $\sigma_*/\sqrt{2} \leq \tilde{\sigma}/\sqrt{2} \leq n^{-1/2}\|H - G\tilde{b}\|_2$ . On the other hand,

$$\begin{aligned} n^{-1/2}\|H - G\tilde{b}\|_2 &\stackrel{(i)}{\leq} \sqrt{2}\sigma_* + 2\sqrt{s/\kappa}\eta(\tilde{\sigma} + \sigma_*) \\ &\stackrel{(ii)}{\leq} (\sqrt{2} + 8/28)\sigma_* < 2\sigma_*, \end{aligned}$$

where (i) follows by (B.22) and (ii) follows by  $\tilde{\sigma} \leq 3\sigma_*$  (due to (4.5)) and  $\sqrt{s/\kappa}\eta \leq 1/28$ . Claim (4.8) follows.

To see claim (4.9), we combine (4.5) and the constraint  $\|n^{-1}G^\top(H - G\tilde{b})\|_\infty \leq \eta\tilde{\sigma}$  in (4.1), obtaining  $\|n^{-1}G^\top(H - G\tilde{b})\|_\infty \leq 3\eta\sigma_*$ . Since  $\sigma_* \leq \sqrt{2}\hat{\sigma}$  (from (4.8)), we have that  $\|n^{-1}G^\top(H - G\tilde{b})\|_\infty \leq 3\sqrt{2}\eta\hat{\sigma}$ . Claim (4.9) follows. The proof is complete.  $\square$

### B.3. Proof of Theorem 5

We introduce some notations that will be used in the rest of the paper. Let  $\hat{Q} = n^{-1} \sum_{i=1}^n \hat{v}_i \hat{v}_i^\top \hat{u}_i^2 \hat{\sigma}_u^{-2}$  with  $(\hat{v}_1, \dots, \hat{v}_n)^\top = \hat{V} = Z - W\tilde{\Pi}$ . Let  $\sigma_{v,j}^2 = \mathbb{E}v_{1,j}^2$ .

**Lemma 11.** *Consider Algorithm 1. Let Assumption 3 hold. Then*

- (1)  $\max_{1 \leq j \leq p} \|W(\tilde{\Pi}_j - \Pi_{*,j})\|_2^2 = O_P(s_\Pi \log p)$  and  $\max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 = O_P(s_\Pi \sqrt{n^{-1} \log p})$ .
- (2)  $\|n^{-1/2}(\Pi_* - \tilde{\Pi})^\top W^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1}\|_\infty = O_P(s_\Pi n^{-1/2} \log p)$ .

*Proof of Lemma 11.* Define the event  $\mathcal{A} = \bigcap_{j=1}^p \mathcal{A}_j$  with

$$\mathcal{A}_j = \{3\sigma_{v,j}^2/4 \leq \|V_j\|_2^2 n^{-1} \leq 2\sigma_{v,j}^2 \text{ and } \|n^{-1}W^\top V_j\|_\infty \leq \eta\sigma_{v,j}\}.$$

Since  $v_{i,j}^2$  and entries of  $w_i v_{i,j}$  have bounded sub-exponential norms (due to the sub-Gaussian property of  $w_i$  and  $v_{i,j}$ ), it follows, by Bernstein's inequality and the union bound, that  $\mathbb{P}(\mathcal{A}) \rightarrow 1$ . Moreover, by Theorem 6 in Rudelson and Zhou (2013), the restricted eigenvalue condition in (4.4) (with  $G = W$ ) holds for some constant  $\kappa > 0$  with probability approaching one. It follows, by Theorem 4, that

$$\max_{1 \leq j \leq p} \|W(\tilde{\Pi}_j - \Pi_{*,j})\|_2^2 = O_P(s_\Pi \log p)$$

and

$$\max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 = O_P(s_\Pi \sqrt{n^{-1} \log p}).$$

This proves part (1). Observe that

$$\begin{aligned} \|n^{-1}W^\top (Y - W\tilde{\theta})\|_\infty &= \|n^{-1}W^\top (Y - W\hat{\theta}(\tilde{\sigma}_u))\|_\infty \\ &\stackrel{(i)}{\leq} \eta\tilde{\sigma}_u \\ &\stackrel{(ii)}{\leq} \eta\sqrt{2}n^{-1/2}\|Y - W\hat{\theta}(\tilde{\sigma}_u)\|_2 = \sqrt{2}\eta\tilde{\sigma}_u, \end{aligned}$$

where (i) and (ii) follow by (2.4) and (2.5), respectively. Part (2) follows by Holder's inequality:

$$\begin{aligned} &\left\| n^{-1/2}(\Pi_* - \tilde{\Pi})^\top W^\top (Y - W\tilde{\theta}) \right\|_\infty \hat{\sigma}_u^{-1} \\ &= \max_{1 \leq j \leq p} \left| n^{-1/2}(\Pi_{*,j} - \tilde{\Pi}_j)^\top W^\top (Y - W\tilde{\theta}) \right| \hat{\sigma}_u^{-1} \\ &\leq \sqrt{n} \max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 \|n^{-1}W^\top (Y - W\tilde{\theta})\|_\infty \hat{\sigma}_u^{-1} \\ &\leq \sqrt{n} \max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 \sqrt{2}\eta = O_P(s_\Pi n^{-1/2} \log p). \end{aligned}$$

The proof is complete.  $\square$

**Lemma 12.** *Consider Algorithm 1. Let Assumption 3 hold. Then*

$$\|\hat{Q} - \mathbb{E}v_1 v_1^\top\|_\infty = O_P\left((s_\Pi n^{-1} \log p) \vee \sqrt{n^{-1} \log p}\right).$$

*Proof of Lemma 12.* Notice that

$$\begin{aligned}\|\hat{Q} - \mathbb{E}v_1v_1^\top\|_\infty &= \left\| n^{-1} \sum_{i=1}^n (\hat{v}_i\hat{v}_i^\top - \mathbb{E}v_1v_1^\top) \right\|_\infty \\ &\leq \left\| n^{-1} \sum_{i=1}^n (\hat{v}_i\hat{v}_i^\top - v_iv_i^\top) \right\|_\infty + \left\| n^{-1} \sum_{i=1}^n (v_iv_i^\top - \mathbb{E}v_1v_1^\top) \right\|_\infty\end{aligned}\quad (\text{B.24})$$

We bound both terms separately. Since entries in  $v_i$  are Gaussian with bounded variance, the entries in  $v_iv_i^\top$  have sub-exponential norms bounded above by some constant  $K > 0$ . It follows, by Proposition 5.16 of Vershynin (2010), that  $\forall t > 0$ ,

$$\begin{aligned}\mathbb{P}\left(\left\| n^{-1} \sum_{i=1}^n (v_iv_i^\top - \mathbb{E}v_1v_1^\top) \right\|_\infty > t\sqrt{n^{-1}\log p}\right) \\ \leq \sum_{j_1=1}^p \sum_{j_2=1}^p \mathbb{P}\left(\left| \sum_{i=1}^n v_{i,j_1}v_{i,j_2} - \mathbb{E}v_{1,j_1}v_{1,j_2} \right| > t\sqrt{n\log p}\right) \\ \leq 2p^2 \exp\left[-c \min\left(\frac{t^2 n \log p}{K^2 n}, \frac{t\sqrt{n\log p}}{K}\right)\right],\end{aligned}$$

where  $c > 0$  is a universal constant. Therefore, by taking  $t = 4K^2/c$ , we have

$$\left\| n^{-1} \sum_{i=1}^n (v_iv_i^\top - \mathbb{E}v_1v_1^\top) \right\|_\infty = O_P(\sqrt{n^{-1}\log p}). \quad (\text{B.25})$$

Notice that  $\hat{v}_i\hat{v}_i^\top - v_iv_i^\top = v_iw_i^\top(\Pi_* - \tilde{\Pi}) + (\Pi_* - \tilde{\Pi})^\top w_iw_i^\top + (\Pi_* - \tilde{\Pi})^\top w_iw_i^\top(\Pi_* - \tilde{\Pi})$ . Therefore,

$$\begin{aligned}&\left\| n^{-1} \sum_{i=1}^n (\hat{v}_i\hat{v}_i^\top - v_iv_i^\top) \right\|_\infty \\ &\leq 2 \left\| n^{-1} \sum_{i=1}^n v_iw_i^\top(\Pi_* - \tilde{\Pi}) \right\|_\infty + \left\| n^{-1} \sum_{i=1}^n (\Pi_* - \tilde{\Pi})^\top w_iw_i^\top(\Pi_* - \tilde{\Pi}) \right\|_\infty \\ &= 2 \max_{1 \leq j \leq p} \max_{1 \leq l \leq p} \left| n^{-1} \sum_{i=1}^n v_{i,l}w_{i,j}^\top(\Pi_{*,j} - \tilde{\Pi}_j) \right| + \max_{1 \leq j \leq p} \left\| n^{-1} W(\tilde{\Pi}_j - \Pi_{*,j}) \right\|_2^2 \\ &\stackrel{(i)}{\leq} 2 \max_{1 \leq l \leq p} \left\| n^{-1} \sum_{i=1}^n v_{i,l}w_i^\top \right\|_\infty \max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 + \max_{1 \leq j \leq p} \left\| n^{-1} W(\tilde{\Pi}_j - \Pi_{*,j}) \right\|_2^2 \\ &\stackrel{(ii)}{\leq} \left\| n^{-1} \sum_{i=1}^n v_iw_i^\top \right\|_\infty O_P(s_\Pi \sqrt{n^{-1}\log p}) + O_P(n^{-1}s_\Pi \log p),\end{aligned}$$

where (i) follows by Holder's inequality and (ii) follows by Lemma 11. By the sub-Gaussian property of  $v_i$  and  $w_i$ , we can show that entries in  $v_iw_i^\top$  have

bounded exponential norm and Proposition 5.16 of [Vershynin \(2010\)](#) and the union bound imply that  $\|n^{-1} \sum_{i=1}^n v_i w_i^\top\|_\infty = O_P(\sqrt{n^{-1} \log p})$ . Therefore,

$$\left\| n^{-1} \sum_{i=1}^n (\hat{v}_i \hat{v}_i^\top - v_i v_i^\top) \right\|_\infty = O_P(n^{-1} s_\Pi \log p). \quad (\text{B.26})$$

The desired result follows by [\(B.24\)](#), combined with [\(B.25\)](#) and [\(B.26\)](#).  $\square$

**Proof of Theorem 5.** Consider the test statistic [\(2.10\)](#). Assume that  $H_0$  [\(1.3\)](#) is true. We observe the following decomposition:

$$\begin{aligned} T_n &= \left\| n^{-1/2} (Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right\|_\infty = \left\| n^{-1/2} (V + W(\Pi - \tilde{\Pi}))^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right\|_\infty \\ &= \left\| n^{-1/2} V^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} + \Delta_n \right\|_\infty, \end{aligned} \quad (\text{B.27})$$

where

$$\Delta_n = n^{-1/2} (\Pi_* - \tilde{\Pi})^\top W^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1}.$$

We invoke Theorem 3 to obtain the desired result.

Let  $\mathcal{F}_n$  denote the  $\sigma$ -algebra generated by  $U$  and  $W$ . Notice that under  $H_0$ ,

$$Y - W\tilde{\theta} = U + W(\theta_* - \tilde{\theta})$$

due to [\(2.1\)](#). Since  $\tilde{\theta}$  is a function of  $(Y, W)$  (and thus a function of  $U$  and  $W$ ),  $\tilde{\theta}$  is a function of  $U$  and  $W$ . Notice that  $V$  is independent of  $(U, W)$ . It follows, by the Gaussianity of  $V$  and  $n^{-1/2} \|Y - W\tilde{\theta}\|_2 = \hat{\sigma}_u$ , that

$$n^{-1/2} V^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \mid \mathcal{F}_n \sim \mathcal{N}(0, Q),$$

where  $Q = \mathbb{E} v_1 v_1^\top$ . In other words,

$$\mathbb{P} \left( \|n^{-1/2} V^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1}\|_\infty \leq x \mid \mathcal{F}_n \right) = \Gamma(x, Q) \quad \forall x \geq 0.$$

By Lemmas 11 and 12, together with  $n^{-1} s_\Pi^2 \log^3 p = o(1)$ , we have that

$$\|\Delta_n\|_\infty = o_P(1/\sqrt{\log p}) \quad \text{and} \quad \|\hat{Q} - Q\|_\infty = o_P(1/\sqrt{\log p}).$$

Therefore, we have verified all the assumptions of Theorem 3, which then implies the desired result.  $\square$

#### B.4. Proof of Theorem 6

**Lemma 13.** Consider Algorithm 1. Let  $U(\gamma_*) = V\gamma_* + U$ . Suppose that Assumption 4 holds. Then with probability approaching one,

$$3\sigma_*^2/4 \leq n^{-1} \|U(\gamma_*)\|_2^2 \leq 2\sigma_*^2$$

$$\|n^{-1}W^\top U(\gamma_*)\|_\infty \leq \eta\sigma_*, \text{ where } \sigma_* = \sqrt{\gamma_*^\top \Sigma_V \gamma_* + \sigma_u^2}.$$

*Proof of Lemma 13.* Notice that the entries of  $U(\gamma_*)/\sigma_*$  are i.i.d  $\mathcal{N}(0, 1)$  random variables that are independent of  $W$ . We apply Lemma 19 with  $L = p$ ,  $x_{i,l} = w_{i,l}$  and  $h_{i,l} = (v_i^\top \gamma_* + u_i)/\sigma_*$  for  $1 \leq l \leq L$ . It follows that

$$\mathbb{P}(\|n^{-1}W^\top U(\gamma_*)\|_\infty > \eta\sigma_*) = \mathbb{P}(\|n^{-1}W^\top U(\gamma_*)/\sigma_*\|_\infty > \eta) \rightarrow 0.$$

Notice that  $n^{-1}\|U(\gamma_*)\|_2^2 \sigma_*^{-2}$  is the average of independent  $\chi^2(1)$  random variables. By the law of large numbers,  $n^{-1}\|U(\gamma_*)\|_2^2 \sigma_*^{-2} = 1 + o_P(1)$ . Therefore,

$$3/4 \leq n^{-1}\|U(\gamma_*)\|_2^2 \sigma_*^{-2} \leq 2$$

with probability approaching one. The proof is complete.  $\square$

**Proof of Theorem 6.** By (2.1) and (2.2), we have that  $Y = W\theta_* + Z\gamma_* + U = W(\theta_* + \Pi_*\gamma_*) + V\gamma_* + U$ . We apply Theorem 4 with  $(H, G, b_*, \varepsilon) = (Y, W, \theta_* + \Pi_*\gamma_*, V\gamma_* + U)$  and  $\mathcal{B}(\sigma) = \mathbb{R}^p \forall \sigma \geq 0$ . Notice that, by Theorem 6 in Rudelson and Zhou (2013), the restricted eigenvalue condition in (4.4) holds for some constant  $\kappa > 0$  with probability approaching one. Also notice that

$$\|\theta_* + \Pi_*\gamma_*\|_0 \leq \|\theta_*\|_0 + \|\Pi_*\gamma_*\|_0 \leq \|\theta_*\|_0 + \max_{1 \leq j \leq p} \|\Pi_{*,j}\|_0 \cdot \|\gamma_*\|_0 =: s_*.$$

Thus, by Theorem 4 and Lemma 13, together with  $s_*^2 n^{-1} \log p \rightarrow 0$ , it follows that, with probability approaching one,

$$\begin{cases} \hat{\sigma}_*/\sqrt{2} \leq \hat{\sigma}_u \leq 2\sigma_* & (1) \\ \|\theta_* + \Pi_*\gamma_* - \tilde{\theta}\|_1 \hat{\sigma}_u^{-1} \leq 16s_*\eta\sigma_*\hat{\sigma}_u^{-1}/\kappa \leq 16\sqrt{2}s_*\eta/\kappa & (2) \\ \|n^{-1}W^\top(Y - W\tilde{\theta})\|_\infty \hat{\sigma}_u^{-1} \leq 3\sqrt{2}\eta & (3) \end{cases} \quad (\text{B.28})$$

where  $\sigma_* = \sqrt{\gamma_*^\top \Sigma_V \gamma_* + \sigma_u^2}$ . Let  $j_* \in \{1, \dots, p\}$  satisfy that  $\|\Sigma_V \gamma_*\|_\infty = |e_{j_*}^\top \Sigma_V \gamma_*|$ , where  $e_{j_*} \in \mathbb{R}^p$  is the  $j_*$ th column of  $I_p$ .

### Step 1: derive the behavior of the test statistic.

By the triangular inequality, we have

$$\begin{aligned} T_n &= \left\| n^{-1/2} (Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right\|_\infty \\ &\geq \left| n^{-1/2} (Z_{j_*} - W\tilde{\Pi}_{j_*})^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right| \\ &= \left| n^{-1/2} (V_{j_*} + W(\Pi_{*,j_*} - \tilde{\Pi}_{j_*}))^\top (W(\theta_* + \Pi_*\gamma_* - \tilde{\theta}) + V\gamma_* + U) \hat{\sigma}_u^{-1} \right| \\ &\geq \underbrace{\left| n^{-1/2} V_{j_*}^\top V\gamma_* \hat{\sigma}_u^{-1} \right|}_{J_1} - \underbrace{\left| n^{-1/2} V_{j_*}^\top W(\theta_* + \Pi_*\gamma_* - \tilde{\theta}) \hat{\sigma}_u^{-1} \right|}_{J_2} - \underbrace{\left| n^{-1/2} V_{j_*}^\top U \hat{\sigma}_u^{-1} \right|}_{J_3} \end{aligned} \quad (\text{B.29})$$

$$- \underbrace{\left| n^{-1/2} (\Pi_{*,j_*} - \tilde{\Pi}_{j_*})^\top W^\top \left( W(\theta_* + \Pi_* \gamma_* - \tilde{\theta}) + V \gamma_* + U \right) \hat{\sigma}_u^{-1} \right|}_{J_4}.$$

Notice that

$$\begin{aligned} J_4 &= \left| n^{-1/2} (\Pi_{*,j_*} - \tilde{\Pi}_{j_*})^\top W^\top \left( Y - W\tilde{\theta} \right) \hat{\sigma}_u^{-1} \right| \\ &\stackrel{(i)}{\leq} \sqrt{n} \|\tilde{\Pi}_{j_*} - \Pi_{*,j_*}\|_1 \|n^{-1} W^\top (Y - W\tilde{\theta})\|_\infty \hat{\sigma}_u^{-1} \\ &\stackrel{(ii)}{\leq} \sqrt{n} O_P(s_\Pi \sqrt{n^{-1} \log p}) 3\sqrt{2}\eta \stackrel{(iii)}{=} o_P(1), \end{aligned} \quad (\text{B.30})$$

where (i) follows by Holder's inequality, (ii) follows by  $\max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 = O_P(s_\Pi \sqrt{n^{-1} \log p})$  (due to Lemma 11) and (B.28)(3) and (iii) holds by  $s_\Pi = o(\sqrt{n}/\log p)$ .

Since  $v_{i,j_*}$  has bounded sub-Gaussian norms, the law of large numbers implies that  $n^{-1} \sum_{i=1}^n v_{i,j_*}^2 = \Sigma_{V,j_*,j_*} + o_P(1)$  and hence

$$\mathbb{P} \left( n^{-1} \sum_{i=1}^n v_{i,j_*}^2 > C_1 + 1 \right) \rightarrow 0$$

for any constant  $C_1 \geq \max_{1 \leq j \leq p} \Sigma_{V,j,j}$ . By the sub-Gaussian property of  $w_i$ , we apply Lemma 19 (with  $x_{i,j} = w_{i,j}$  and  $h_{i,j} = v_{i,j_*}$  for  $1 \leq j \leq p$ ). It follows that

$$\|n^{-1/2} V_{j_*}^\top W\|_\infty = \max_{1 \leq j \leq p} \left| n^{-1/2} \sum_{i=1}^n w_{i,j} v_{i,j_*} \right| = O_P(\sqrt{\log p}).$$

By Holder's inequality and (B.28)(2), it follows that

$$J_2 \leq \|n^{-1/2} V_{j_*}^\top W\|_\infty \|\theta_* + \Pi_* \gamma_* - \tilde{\theta}\|_1 \hat{\sigma}_u^{-1} \leq O_P(\sqrt{\log p}) 16\sqrt{2} s_* \eta / \kappa \stackrel{(i)}{=} o_P(1), \quad (\text{B.31})$$

where (i) holds by  $s_* = o(\sqrt{n}/\log p)$ .

Notice that  $\mathbb{E}|v_{i,j_*} u_i|^{2+\delta} = \mathbb{E}|v_{i,j_*}|^{2+\delta} \mathbb{E}|u_i|^{2+\delta}$  is bounded by a constant  $C_2 > 0$ , where  $\delta > 0$  is the constant in Assumption 4. The Lyapunov's central limit theorem implies that

$$|n^{-1/2} V_{j_*}^\top U| = \left| n^{-1/2} \sum_{i=1}^n v_{i,j_*} u_i \right| = O_P(1).$$

Hence,

$$\mathbb{P} \left( J_3 > \sqrt{\log p} \right) = \mathbb{P} \left( \left| n^{-1/2} V_{j_*}^\top U \right| > \hat{\sigma}_u \sqrt{\log p} \right) \stackrel{(i)}{\leq} \mathbb{P} \left( |n^{-1/2} V_{j_*}^\top U| > \sigma_* \sqrt{\log(p)/2} \right) = o_P(1), \quad (\text{B.32})$$

where (i) holds by (B.28)(1).

Due to the (sub)-Gaussian property of  $v_i$  and the definition of  $\sigma_*$ ,  $\mathbb{E}|v_{i,j_*} v_i^\top \gamma_* / \sigma_*|^3$  is bounded above by a constant. Again, the Lyapunov's central limit theorem implies that

$$\sqrt{n} |n^{-1} V_{j_*}^\top V \gamma_* - e_{j_*}^\top \Sigma_V \gamma_*| / \sigma_* = \left| n^{-1/2} \sum_{i=1}^n [(v_{i,j_*} v_i^\top \gamma_* / \sigma_*) - \mathbb{E}(v_{i,j_*} v_i^\top \gamma_* / \sigma_*)] \right| = O_P(1).$$

Hence, it follows, by (B.28)(1), that

$$\begin{aligned} & \mathbb{P} \left( \sqrt{n} |n^{-1} V_{j_*}^\top V \gamma_* - e_{j_*}^\top \Sigma_V \gamma_*| \hat{\sigma}_u^{-1} > \sqrt{\log p} \right) \\ & \leq \mathbb{P} \left( \sqrt{n} |n^{-1} V_{j_*}^\top V \gamma_* - e_{j_*}^\top \Sigma_V \gamma_*| / \sigma_* > \sqrt{\log(p)/2} \right) = o_P(1). \end{aligned} \quad (\text{B.33})$$

Therefore, for any  $K > 0$ ,

$$\begin{aligned} & \mathbb{P} \left( T_n > (K-4)\sqrt{\log p} \right) \\ & \stackrel{(i)}{\geq} \mathbb{P} \left( J_1 > (K-1)\sqrt{\log p} \right) - \mathbb{P} \left( J_2 > \sqrt{\log p} \right) - \mathbb{P} \left( J_3 > \sqrt{\log p} \right) - \mathbb{P} \left( J_4 > \sqrt{\log p} \right) \\ & \stackrel{(ii)}{=} \mathbb{P} \left( J_1 > (K-1)\sqrt{\log p} \right) - o(1) \\ & \geq \mathbb{P} \left( |e_{j_*}^\top \Sigma_V \gamma_*| \hat{\sigma}_u^{-1} > K \sqrt{n^{-1} \log p} \right) - \mathbb{P} \left( |n^{-1} V_{j_*}^\top V \gamma_* - e_{j_*}^\top \Sigma_V \gamma_*| \hat{\sigma}_u^{-1} > \sqrt{n^{-1} \log p} \right) - o(1) \\ & \stackrel{(iii)}{=} \mathbb{P} \left( |e_{j_*}^\top \Sigma_V \gamma_*| > K \hat{\sigma}_u \sqrt{n^{-1} \log p} \right) - o(1) \\ & \stackrel{(iv)}{\geq} \mathbb{P} \left( |e_{j_*}^\top \Sigma_V \gamma_*| > 2K \sigma_* \sqrt{n^{-1} \log p} \right) - o(1), \end{aligned}$$

where (i) holds by (B.29) and the sub-additivity of probability measures, (ii) holds by (B.30), (B.31) and (B.32), (iii) holds by (B.33) and (iv) holds by (B.28)(1). Recall that

$$\sigma_*^2 = \gamma_*^\top \Sigma_V \gamma_* + \sigma_u^2.$$

Therefore, there exist constants  $C_3, C_4 > 0$  such that

$$\sigma_*^2 \leq C_3 \|\gamma_*\|_2^2 + C_4 \leq (\sqrt{C_3} \|\gamma_*\|_2 + \sqrt{C_4})^2.$$

Hence, the above display implies that for any  $K > 0$ ,

$$\begin{aligned} & \mathbb{P} \left( T_n > (K-4)\sqrt{\log p} \right) \geq \mathbb{P} \left( |e_{j_*}^\top \Sigma_V \gamma_*| > 2K \sigma_* \sqrt{n^{-1} \log p} \right) - o(1) \\ & \geq \mathbb{P} \left( |e_{j_*}^\top \Sigma_V \gamma_*| > 2K [\sqrt{C_3} \|\gamma_*\|_2 + \sqrt{C_4}] \sqrt{n^{-1} \log p} \right) - o(1). \end{aligned} \quad (\text{B.34})$$

## Step 2: derive the behavior of the critical value.

Recall the elementary inequality that for  $\xi \sim \mathcal{N}(0, 1)$ ,  $\mathbb{P}(|\xi| > x) \leq 2 \exp(-x^2/2)$  for all  $x > 0$ . By the union bound, we have that

$$1 - \Gamma(x, \hat{Q}) = \mathbb{P}(\|\zeta\|_\infty > x \mid \hat{Q}) \leq 2p \exp[-x^2/(2\|\hat{Q}\|_\infty)],$$

where  $\zeta \mid \hat{Q} \sim \mathcal{N}(0, \hat{Q})$ . It follows that,  $\forall \alpha \in (0, 1)$ ,

$$\Gamma^{-1}(1 - \alpha, \hat{Q}) \leq \sqrt{-2\|\hat{Q}\|_\infty \log(\alpha/(2p))}.$$

Let  $C_5 > 0$  be a constant such that  $\|\mathbb{E}v_1v_1^\top\|_\infty \leq C_5$ . By Lemma 12,  $\mathbb{P}(\|\hat{Q}\|_\infty \leq 2C_5) \rightarrow 1$ . Hence,

$$\mathbb{P}\left(\Gamma^{-1}(1 - \alpha, \hat{Q}) > 2\sqrt{-C_5 \log(\alpha/(2p))}\right) \rightarrow 0 \quad \forall \alpha \in (0, 1). \quad (\text{B.35})$$

Let  $K = 4\sqrt{C_5 \vee 1} + 8$ . Notice that for large  $p$ ,

$$\lim_{p \rightarrow \infty} \frac{(K-4)\sqrt{\log p}}{2\sqrt{-C_5 \log(\alpha/(2p))}} \geq 2 > 1 \quad \forall \alpha \in (0, 1).$$

Thus, it follows, by (B.34) and (B.35) as well as  $\|\Sigma_V \gamma_*\|_\infty = |e_{j_*}^\top \Sigma_V \gamma_*|$ , that

$$\mathbb{P}\left(T_n > \Gamma^{-1}(1 - \alpha, \hat{Q})\right) \geq \mathbb{P}\left(\|\Sigma_V \gamma_*\|_\infty > 2K[\sqrt{C_3}\|\gamma_*\|_2 + \sqrt{C_4}]\sqrt{n^{-1} \log p}\right) - o(1).$$

Then the desired result holds with  $K_1 = 2K\sqrt{C_3}$  and  $K_2 = 2K\sqrt{C_4}$ . The proof is complete.  $\square$

### B.5. Proof of Theorems 7 and 8

**Proof of Theorem 7.** Let

$$\lambda_0 = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_B)$$

and

$$\lambda_1 = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_A + \gamma_*).$$

Let  $w_i = (w_{A,i}^\top, w_{B,i}^\top)^\top \in \mathbb{R}^{2(p+1)}$  with  $w_{A,i} = (y_{A,i}, x_{A,i}^\top)^\top \in \mathbb{R}^{p+1}$  and  $w_{B,i} = (y_{B,i}, x_{B,i}^\top)^\top \in \mathbb{R}^{p+1}$ . The proof proceeds in two steps. First, we characterize the test statistic and the critical value; second, we derive the behavior of the test statistic under  $\mathbb{P}_{\lambda_1}$ .

#### Step 1: characterize the test statistic and the critical value.

Notice that the log likelihood under  $\mathbb{P}_{\lambda_0}$  is

$$2n \log(2\pi)^{-(p+1)/2} + \frac{n}{2} \log \det(\Omega_A) - \frac{1}{2} \sum_{i=1}^n w_{A,i}^\top \Omega_A w_{A,i} + \frac{n}{2} \log \det(\Omega_{B,0}) - \frac{1}{2} \sum_{i=1}^n w_{B,i}^\top \Omega_{B,0} w_{B,i},$$

where

$$\Omega_A = \begin{bmatrix} 1 & 0 \\ -\beta_A & I_p \end{bmatrix} \begin{bmatrix} \sigma_{u,A}^{-2} & 0 \\ 0 & \Sigma_A^{-1} \end{bmatrix} \begin{bmatrix} 1 & -\beta_A^\top \\ 0 & I_p \end{bmatrix} \quad \text{and} \quad \Omega_{B,0} = \begin{bmatrix} 1 & 0 \\ -\beta_A & I_p \end{bmatrix} \begin{bmatrix} \sigma_{u,B}^{-2} & 0 \\ 0 & \Sigma_B^{-1} \end{bmatrix} \begin{bmatrix} 1 & -\beta_A^\top \\ 0 & I_p \end{bmatrix}.$$



The log likelihood under  $\mathbb{P}_{\lambda_1}$  is

$$2n \log(2\pi)^{-(p+1)/2} + \frac{n}{2} \log \det(\Omega_A) - \frac{1}{2} \sum_{i=1}^n w_{A,i}^\top \Omega_A w_{A,i} + \frac{n}{2} \log \det(\Omega_{B,1}) - \frac{1}{2} \sum_{i=1}^n w_{B,i}^\top \Omega_{B,1} w_{B,i},$$

where

$$\Omega_{B,1} = \begin{bmatrix} 1 & 0 \\ -\beta_A - \gamma_* & I_p \end{bmatrix} \begin{bmatrix} \sigma_{u,B}^{-2} & 0 \\ 0 & \Sigma_B^{-1} \end{bmatrix} \begin{bmatrix} 1 & -\beta_A^\top - \gamma_*^\top \\ 0 & I_p \end{bmatrix}.$$

Notice that  $\det \Omega_{B,0} = \det \Omega_{B,1}$  and thus the likelihood ratio test can be written with the test statistic being

$$LR_n = \frac{1}{2} \sum_{i=1}^n w_{B,i}^\top (\Omega_{B,0} - \Omega_{B,1}) w_{B,i} = \sum_{i=1}^n s_i, \quad (\text{B.36})$$

where

$$s_i = \sigma_{u,B}^{-2} y_{B,i} x_{B,i}^\top \gamma_* - \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_*) (x_{B,i}^\top \beta_A) - \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_*)^2 / 2.$$

Let  $c_n(\alpha)$  be the critical value for a test of nominal size  $\alpha$ , i.e.,  $\mathbb{P}_{\lambda_0}(LR_n > c_n(\alpha)) = \alpha$ .

Notice that, under  $\mathbb{P}_{\lambda_0}$ ,

$$s_i = \sigma_{u,B}^{-2} x_{B,i}^\top \gamma_* u_{B,i} - \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_*)^2 / 2.$$

By the Gaussian assumption, we have

$$\begin{cases} \mathbb{E}_{\lambda_0}(s_i \|\gamma_*\|_2^{-1}) = -\sigma_{u,B}^{-2} \gamma_*^\top \Sigma_B \gamma_* \|\gamma_*\|_2^{-1} / 2 \\ \text{Var}_{\lambda_0}(s_i \|\gamma_*\|_2^{-1}) = \gamma_*^\top \Sigma_B \gamma_* \|\gamma_*\|_2^{-2} \sigma_{u,B}^{-2} + \sigma_{u,B}^{-4} (\gamma_*^\top \Sigma_B \gamma_*)^2 \|\gamma_*\|_2^{-2} / 2 \\ \mathbb{E}_{\lambda_0}|s_i \|\gamma_*\|_2^{-1}|^3 = O(1). \end{cases}$$

By the Lyapunov's central limit theorem applied to  $\{s_i \|\gamma_*\|_2^{-1}\}_{i=1}^n$ , we have that

$$\frac{n^{-1/2} \sum_{i=1}^n [s_i \|\gamma_*\|_2^{-1} - \mathbb{E}(s_i \|\gamma_*\|_2^{-1})]}{\sqrt{\text{Var}_{\lambda_0}(s_i \|\gamma_*\|_2^{-1})}} \xrightarrow{d} \mathcal{N}(0, 1). \quad (\text{B.37})$$

By (B.36), we have

$$\begin{aligned} 1 - \alpha &= \mathbb{P}_{\lambda_0}(LR_n \leq c_n(\alpha)) \\ &= \mathbb{P}_{\lambda_0} \left( \frac{n^{-1/2} \sum_{i=1}^n [s_i \|\gamma_*\|_2^{-1} - \mathbb{E}(s_i \|\gamma_*\|_2^{-1})]}{\sqrt{\text{Var}_{\lambda_0}(s_i \|\gamma_*\|_2^{-1})}} \leq \frac{n^{-1/2} c_n(\alpha) + \sqrt{n} \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2} / 2}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 \sigma_{u,B}^{-4} / 2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}} \right) \\ &\stackrel{(i)}{=} \Phi \left( \frac{n^{-1/2} c_n(\alpha) + \sqrt{n} \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2} / 2}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 \sigma_{u,B}^{-4} / 2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}} \right) + o(1), \end{aligned}$$

where (i) follows by (B.37) and Polya's theorem (Theorem 9.1.4 of [Athreya and Lahiri \(2006\)](#)). Therefore,

$$\frac{n^{-1/2}c_n(\alpha) + \sqrt{n}\gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}/2}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 \sigma_{u,B}^{-4}/2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}} \rightarrow \Phi^{-1}(1 - \alpha). \quad (\text{B.38})$$

**Step 2: behavior of the test statistic under  $\mathbb{P}_{\lambda_1}$ .**

Notice that, under  $\mathbb{P}_{\lambda_1}$ ,

$$s_i = \sigma_{u,B}^{-2} x_{B,i}^\top \gamma_* u_{B,i} + \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_*)^2 / 2.$$

Similarly as before, we have that

$$\begin{cases} \mathbb{E}_{\lambda_1} (s_i \|\gamma_*\|_2^{-1}) = \gamma_*^\top \Sigma_B \gamma_* \|\gamma_*\|_2^{-1} \sigma_{u,B}^{-2} / 2 \\ \text{Var}_{\lambda_1} (s_i \|\gamma_*\|_2^{-1})^2 = \gamma_*^\top \Sigma_B \gamma_* \|\gamma_*\|_2^{-2} \sigma_{u,B}^{-2} + (\gamma_*^\top \Sigma_B \gamma_*)^2 \|\gamma_*\|_2^{-2} \sigma_{u,B}^{-4} / 2 \\ \mathbb{E}_{\lambda_1} |s_i \|\gamma_*\|_2^{-1}|^3 = O(1). \end{cases}$$

By (B.36), we have

$$\begin{aligned} & \mathbb{P}_{\lambda_1} (LR_n > c_n(\alpha)) \\ &= 1 - \mathbb{P}_{\lambda_1} \left( \frac{n^{-1/2} \sum_{i=1}^n [s_i \|\gamma_*\|_2^{-1} - \mathbb{E}(s_i \|\gamma_*\|_2^{-1})]}{\sqrt{\text{Var}_{\lambda_0}(s_i \|\gamma_*\|_2^{-1})}} \leq \frac{n^{-1/2}c_n(\alpha) - \sqrt{n}\gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}/2}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 \sigma_{u,B}^{-4}/2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}} \right) \\ &\stackrel{(i)}{=} 1 - \Phi \left( \frac{n^{-1/2}c_n(\alpha) - \sqrt{n}\gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}/2}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 \sigma_{u,B}^{-4}/2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}} \right) + o(1) \\ &\stackrel{(ii)}{=} 1 - \Phi \left( \Phi^{-1}(1 - \alpha) - d_n \right) + o(1) \quad \text{for} \quad d_n = \frac{\sqrt{n}\gamma_*^\top \Sigma_B \gamma_*}{\sqrt{(\gamma_*^\top \Sigma_B \gamma_*)^2 / 2 + \gamma_*^\top \Sigma_B \gamma_* \sigma_{u,B}^{-2}}}, \end{aligned}$$

where (i) follows Lyapunov's central limit theorem and Polya's theorem and (ii) follows by (B.38). The desired result follows by the elementary identity of  $1 - \Phi(z) = \Phi(-z) \forall z \in \mathbb{R}$ .  $\square$

**Proof of Theorem 8.** Let  $\phi_n = \phi_n(Y_A, X_A, Y_B, X_B)$  be a test such that  $\limsup_{n \rightarrow \infty} \sup_{\lambda \in \Lambda_0} \mathbb{E}_\lambda \phi_n \leq \alpha$ . Define

$$\lambda_0 = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_A + \gamma_*)$$

with  $\Sigma_A = \Sigma_B = I_p(M_1 + M_2)/2$ ,  $\sigma_{u,A} = \sigma_{u,B} = (M_1 + M_2)/2$  and  $\gamma_* = 0$ . For  $1 \leq j \leq p$ , let

$$\gamma_j = c_j e_j \sqrt{n^{-1} \log p},$$

where  $e_j$  is the  $j$ th column of  $I_p$ ,  $c_j = C / \sqrt{e_j^\top \Sigma_B e_j}$  and  $C = \sigma_{u,B}/2$ . Define

$$\lambda_j = (\Sigma_A, \Sigma_B, \sigma_{u,A}^2, \sigma_{u,B}^2, \beta_A, \beta_A + \gamma_j).$$

Lemma 2 implies that  $\Sigma_V = 2I_p$ . Then  $\lambda_0 \in \Lambda_0$  and  $\lambda_j \in \Lambda(\tau)$  with  $\tau = (M_1 + M_2)/8$ . Notice that

$$\begin{aligned}
\liminf_{n \rightarrow \infty} \inf_{\lambda \in \Lambda(\tau)} \mathbb{E}_\lambda \phi_n - \alpha &\leq \liminf_{n \rightarrow \infty} \left[ p^{-1} \sum_{j=1}^p (\mathbb{E}_{\lambda_j} \phi_n - \alpha) \right] \\
&\stackrel{(i)}{\leq} \liminf_{n \rightarrow \infty} \left[ p^{-1} \sum_{j=1}^p (\mathbb{E}_{\lambda_j} \phi_n - \mathbb{E}_{\lambda_0} \phi_n) \right] \\
&\stackrel{(ii)}{=} \liminf_{n \rightarrow \infty} \mathbb{E}_{\lambda_0} \left[ \phi_n p^{-1} \sum_{j=1}^p \left( \frac{d\mathbb{P}_{\lambda_j}}{d\mathbb{P}_{\lambda_0}} - 1 \right) \right] \\
&\stackrel{(iii)}{\leq} \liminf_{n \rightarrow \infty} \mathbb{E}_{\lambda_0} \left| p^{-1} \sum_{j=1}^p \left( \frac{d\mathbb{P}_{\lambda_j}}{d\mathbb{P}_{\lambda_0}} - 1 \right) \right| \\
&\stackrel{(iv)}{\leq} \liminf_{n \rightarrow \infty} \sqrt{\mathbb{E}_{\lambda_0} \left[ p^{-1} \sum_{j=1}^p \left( \frac{d\mathbb{P}_{\lambda_j}}{d\mathbb{P}_{\lambda_0}} - 1 \right) \right]^2},
\end{aligned} \tag{B.39}$$

where (i) holds by  $\limsup_{n \rightarrow \infty} \mathbb{E}_{\lambda_0} \phi_n \leq \alpha$ , (ii) holds by  $\mathbb{E}_{\lambda_j} \phi_n = \mathbb{E}_{\lambda_0} \phi_n d\mathbb{P}_{\lambda_j}/d\mathbb{P}_{\lambda_0}$ , (iii) holds by  $|\phi_n| \leq 1$  and (iv) follows by Lyapunov's inequality.

By Step 1 of the proof of Theorem 7, we have that

$$d\mathbb{P}_{\lambda_j}/d\mathbb{P}_{\lambda_0} = \exp(T_j) \quad \text{with} \quad T_j = \sum_{i=1}^n s_{i,j} \quad \text{and} \quad s_{i,j} = \sigma_{u,B}^{-2} x_{B,i}^\top \gamma_j u_{B,i} - \frac{1}{2} \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_j)^2. \tag{B.40}$$

By the moment generating function (MGF) of Gaussian distributions,  $\mathbb{E}(\exp(s_{i,j}) \mid x_{B,i}) = 1$  and thus

$$\mathbb{E} \exp(T_j) = [\mathbb{E} \exp(s_{i,j})]^n = 1. \tag{B.41}$$

Similarly, we also have  $\mathbb{E}(\exp(2s_{i,j}) \mid x_{B,i}) = \exp(\sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_j)^2)$ . Since

$$(x_{B,i}^\top \gamma_j)^2 / (\gamma_j^\top \Sigma_B \gamma_j) \sim \chi^2(1),$$

it follows, by  $\sigma_{u,B}^{-2} \gamma_j^\top \Sigma_B \gamma_j < 1/2$  and the MGF of chi-squared distributions, that

$$\begin{aligned}
\mathbb{E} \exp(2T_j) &= \mathbb{E} \exp \left( \sum_{i=1}^n \sigma_{u,B}^{-2} (x_{B,i}^\top \gamma_j)^2 \right) = \left\{ \mathbb{E} \exp \left[ \left( \sigma_{u,B}^{-2} \gamma_j^\top \Sigma_B \gamma_j \right) ((x_{B,1}^\top \gamma_j)^2 / (\gamma_j^\top \Sigma_B \gamma_j)) \right] \right\}^n \\
&= (1 - 2\sigma_{u,B}^{-2} \gamma_j^\top \Sigma_B \gamma_j)^{-n/2} \\
&= \left( 1 - \frac{1}{2} n^{-1} \log p \right)^{-n/2}.
\end{aligned} \tag{B.42}$$

Next, observe

$$\begin{aligned}
& \mathbb{E} \left( p^{-1} \sum_{j=1}^p \exp(T_j) \right)^2 \\
&= p^{-2} \sum_{j=1}^p \mathbb{E} \exp(2T_j) + p^{-2} \sum_{j_1 \neq j_2} \mathbb{E} \exp(T_{j_1} + T_{j_2}) \\
&= p^{-2} \sum_{j=1}^p \left( 1 - \frac{1}{2} n^{-1} \log p \right)^{-n/2} + p^{-2} \sum_{j_1 \neq j_2} \mathbb{E} \{ \mathbb{E} [\exp(T_{j_1} + T_{j_2}) \mid \{x_{B,i}\}_{i=1}^n] \} \\
&\stackrel{(i)}{=} p^{-1} \left( 1 - \frac{1}{2} n^{-1} \log p \right)^{-n/2} + p^{-2} \sum_{j_1 \neq j_2} \left[ \mathbb{E} \exp \left( \sigma_{u,B}^{-2} (x_{B,1}^\top \gamma_{j_1}) (x_{B,1}^\top \gamma_{j_2}) \right) \right]^n,
\end{aligned} \tag{B.43}$$

where (i) follows by the Gaussian MGF and the fact that

$$T_{j_1} + T_{j_2} \mid \{x_{B,i}\}_{i=1}^n \sim \mathcal{N}(\mu_t, \sigma_t^2)$$

is Gaussian with mean  $\mu_t = -\sigma_{u,B}^{-2} \sum_{i=1}^n (x_{B,i}^\top \gamma_{j_1})^2 / 2 - \sigma_{u,B}^{-2} \sum_{i=1}^n (x_{B,i}^\top \gamma_{j_2})^2 / 2$  and variance

$$\sigma_t^2 = \sigma_{u,B}^{-2} \sum_{i=1}^n (x_{B,i}^\top \gamma_{j_1} + x_{B,i}^\top \gamma_{j_2})^2.$$

Notice that, for  $j_1 \neq j_2$ ,  $x_{B,1}^\top \gamma_{j_1}$  and  $x_{B,1}^\top \gamma_{j_2}$  are independent Gaussian random variables since  $\Sigma_B$  is diagonal. Hence, for  $j_1 \neq j_2$ ,

$$\begin{aligned}
& \mathbb{E} \exp \left( \sigma_{u,B}^{-2} (x_{B,1}^\top \gamma_{j_1}) (x_{B,1}^\top \gamma_{j_2}) \right) \\
&= \mathbb{E} \left\{ \mathbb{E} \left[ \exp \left( \sigma_{u,B}^{-2} (x_{B,1}^\top \gamma_{j_1}) (x_{B,1}^\top \gamma_{j_2}) \right) \mid (x_{B,1}^\top \gamma_{j_2}) \right] \right\} \\
&\stackrel{(i)}{=} \mathbb{E} \left\{ \exp \left( \frac{1}{2} \sigma_{u,B}^{-4} (x_{B,1}^\top \gamma_{j_2})^2 C^2 n^{-1} \log p \right) \right\} \\
&\stackrel{(ii)}{=} \left( 1 - \sigma_{u,B}^{-4} C^4 n^{-2} \log^2 p \right)^{-1/2} \\
&= \left( 1 - \frac{1}{8} n^{-2} \log^2 p \right)^{-1/2},
\end{aligned} \tag{B.44}$$

where (i) follows by Gaussian MGF and the definition of  $\gamma_j$ s and (ii) follows by

$$(x_{B,1}^\top \gamma_{j_2})^2 / (\gamma_{j_2}^\top \Sigma_B \gamma_{j_2}) \sim \chi^2(1),$$

chi-squared MGF and the definition of  $\gamma_j$ s. We combine (B.43) and (B.45), obtaining

$$\mathbb{E} \left( p^{-1} \sum_{j=1}^p \exp(T_j) \right)^2 = \underbrace{p^{-1} \left( 1 - \frac{1}{2} n^{-1} \log p \right)^{-n/2}}_{J_1} + \underbrace{\frac{p-1}{p} \left( 1 - \frac{1}{8} n^{-2} \log^2 p \right)^{-n/2}}_{J_2}. \tag{B.46}$$

Since  $n/\log p \rightarrow \infty$ , we have that  $[1 + (-1/2) \cdot n^{-1} \log p]^{n/\log p} \rightarrow \exp(-1/2)$ . Therefore,

$$\begin{aligned} \log J_1 &= -\log p - \frac{\log p}{2} \log \left( 1 - \frac{1}{2} n^{-1} \log p \right)^{n/\log p} \\ &= \left[ -1 - \frac{1}{2} \left( -\frac{1}{2} + o(1) \right) \right] \log p \rightarrow -\infty. \end{aligned}$$

Recall the fact that if  $a_n \rightarrow 0$ , then  $(1 + n^{-1} a_n)^n \rightarrow \exp(0) = 1$ . Since  $n^{-1} \log^2 p \rightarrow 0$ , we have

$$J_2 = \frac{p-1}{p} \cdot \frac{1}{\sqrt{[1 + n^{-1} \cdot (-\frac{1}{8} n^{-1} \log^2 p)]^n}} \rightarrow 1 \cdot \frac{1}{\sqrt{1}} = 1.$$

Thus, (B.46) and the above two displays imply that

$$\mathbb{E} \left( p^{-1} \sum_{j=1}^p \exp(T_j) \right)^2 = 1 + o(1).$$

By (B.41), we have that  $\mathbb{E} \left( p^{-1} \sum_{j=1}^p \exp(T_j) - 1 \right)^2 = o(1)$ . By (B.39) and (B.40), it follows that

$$\liminf_{n \rightarrow \infty} \inf_{\lambda \in \Lambda(\tau)} \mathbb{E}_\lambda \phi_n - \alpha \leq 0.$$

The proof is complete.  $\square$

### B.6. Proof of Theorems 9 and 10

**Lemma 14.** *Let  $X$  be a random variable. Suppose that there exists a constant  $c > 0$  such that  $\mathbb{P}(|X| > t) \leq \exp(1 - ct^2) \forall t > 0$ . Then  $\mathbb{E} \exp(|X|/D) < 2$ , where  $D \geq \sqrt{7/[c \log(3/2)]}$ .*

*Proof of Lemma 14.* Let  $Z = \exp(|X|/D)$ . Since  $Z \geq 1$ , we have the decomposition

$$Z = \sum_{i=1}^{\infty} Z \mathbf{1}\{i - 1/2 < Z \leq i + 1/2\}.$$

Define the sequence of constants

$$b_i = (i - 1/2)^2 \exp[-cD^2 \log^2(i - 1/2)].$$

By Fubini's theorem,

$$\mathbb{E} Z = \sum_{i=1}^{\infty} \mathbb{E} Z \mathbf{1}\{i - 1/2 < Z \leq i + 1/2\} \leq \sum_{i=1}^{\infty} (i + 1/2) \mathbb{P}(Z > i - 1/2)$$

$$\begin{aligned}
&= 3/2 + \sum_{i=2}^{\infty} (i+1/2) \mathbb{P}(Z > i-1/2) \\
&= 3/2 + \sum_{i=2}^{\infty} (i+1/2) \mathbb{P}(|X| > D \log(i-1/2)) \\
&\stackrel{(i)}{\leq} 3/2 + e \sum_{i=2}^{\infty} (i+1/2) \exp[-cD^2 \log^2(i-1/2)], \\
&\stackrel{(ii)}{\leq} 3/2 + e \sum_{i=2}^{\infty} b_i,
\end{aligned} \tag{B.47}$$

where (i) follows by  $\mathbb{P}(|X| > t) \leq \exp(1 - ct^2) \forall t > 0$  and (ii) follows by the elementary inequality that

$$(i+1/2) \leq (i-1/2)^2$$

for  $i \geq 2$ . Notice that, for  $i \geq 2$ ,

$$\begin{aligned}
\log b_i - \log(i^{-4}) &\leq \log b_i - \log(i-1/2)^{-4} = [6 - cD^2 \log(i-1/2)] \log(i-1/2) \\
&\stackrel{(i)}{\leq} [6 - cD^2 \log(3/2)] \log(i-1/2) \\
&\stackrel{(ii)}{\leq} -\log(i-1/2) \leq 0,
\end{aligned}$$

where (i) holds by  $i \geq 2$  and (ii) holds by the definition of  $D$  in the statement of the lemma. The above display implies that,  $\forall i \geq 2$ ,

$$b_i \leq i^{-4}.$$

It follows, by (B.47), that

$$\mathbb{E}Z \leq 3/2 + e \sum_{i=2}^{\infty} i^{-4}.$$

It can be shown that  $\sum_{i=2}^{\infty} i^{-4} = \pi^4/90 - 1 \leq 1/10$ . Thus,  $\mathbb{E}Z < 3/2 + e/10 < 2$ .  $\square$

**Lemma 15.** Consider Algorithm 2. Let Assumption 5 hold. Then

- (1)  $\max_{1 \leq j \leq p} \|W(\tilde{\Pi}_j - \Pi_{*,j})\|_2^2 = O_P(s_{\Pi} \log p)$  and  $\max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 = O_P(s_{\Pi} \sqrt{n^{-1} \log p})$ .
- (2)  $\|n^{-1/2}(\Pi_* - \tilde{\Pi})^{\top} W^{\top} (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1}\|_{\infty} = O_P(s_{\Pi} n^{-1/2} \log p)$ .

*Proof of Lemma 15.* Part (1) follows the same argument as the proof of part(1) in Lemma 11 since changing the distribution of  $Z$  and  $W$  from Gaussian to sub-Gaussian does not affect the arguments.

Part (2) also follows a similar argument. Notice that

$$\|n^{-1} W^{\top} (Y - W\tilde{\theta})\|_{\infty} = \|n^{-1} W^{\top} (Y - W\hat{\theta}(\tilde{\sigma}_u))\|_{\infty}$$

$$\begin{aligned}
&\stackrel{(i)}{\leq} \eta \tilde{\sigma}_u \\
&\stackrel{(ii)}{\leq} \eta \sqrt{2} n^{-1/2} \|Y - W\hat{\theta}(\tilde{\sigma}_u)\|_2 = \sqrt{2} \eta \hat{\sigma}_u,
\end{aligned}$$

where (i) and (ii) follow by the constraints (4.11) and (4.12), respectively. Therefore,

$$\begin{aligned}
&\left\| n^{-1/2} (\Pi_* - \tilde{\Pi})^\top W^\top (Y - W\tilde{\theta}) \right\|_\infty \hat{\sigma}_u^{-1} \\
&= \max_{1 \leq j \leq p} \left| n^{-1/2} (\Pi_{*,j} - \tilde{\Pi}_j)^\top W^\top (Y - W\tilde{\theta}) \right| \hat{\sigma}_u^{-1} \\
&\stackrel{(i)}{\leq} \sqrt{n} \max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 \|n^{-1} W^\top (Y - W\tilde{\theta})\|_\infty \hat{\sigma}_u^{-1} \\
&\leq \sqrt{n} \max_{1 \leq j \leq p} \|\tilde{\Pi}_j - \Pi_{*,j}\|_1 \sqrt{2} \eta = O_P(s_\Pi n^{-1/2} \log p),
\end{aligned}$$

where (i) follows by Holder's inequality. This proves part (2). The proof is complete.  $\square$

**Proof of Theorem 9.** The argument is similar to the proof of Theorem 5, except that we need to invoke a high-dimensional central limit theorem under non-Gaussian designs. We proceed in two steps. First, we show the desired result assuming a “central limit theorem” (stated below in (B.52)) and then we show the “central limit theorem”.

**Step 1: show the desired result assuming a “central limit theorem”**

Consider the test statistic  $T_n^+$  (4.14). Assume that  $H_0$  (1.3) is true. Then

$$\begin{aligned}
T_n^+ &= \left\| n^{-1/2} (Z - W\tilde{\Pi})^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right\|_\infty \\
&= \left\| n^{-1/2} (V + W(\Pi - \tilde{\Pi}))^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} \right\|_\infty
\end{aligned} \tag{B.48}$$

$$\begin{aligned}
&= \left\| n^{-1/2} V^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1} + \Delta_n \right\|_\infty, \\
&= \left\| n^{-1/2} \sum_{i=1}^n \Psi_i + \Delta_n \right\|_\infty,
\end{aligned} \tag{B.49}$$

where

$$\Delta_n = n^{-1/2} (\Pi_* - \tilde{\Pi})^\top W^\top (Y - W\tilde{\theta}) \hat{\sigma}_u^{-1}$$

and  $\Psi_i = v_i \hat{u}_i \hat{\sigma}_u^{-1}$  with  $\hat{u}_i = y_i - w_i^\top \tilde{\theta}$ . Let  $\mathcal{F}_n$  be the  $\sigma$ -algebra generated by  $W$  and  $Y$ .

Since  $\hat{u}_i$  and  $\hat{\sigma}_u$  are computed using only  $Y$  and  $W$ , which, under  $H_0$  (1.3), are independent of  $V$ , it follows that

$$\mathbb{E}(v_i v_i^\top \hat{u}_i^2 \hat{\sigma}_u^{-2} \mid \mathcal{F}_n) = \Sigma_V \hat{u}_i^2 \hat{\sigma}_u^{-2}.$$

By  $\hat{\sigma}_u^2 = n^{-1} \|Y - W\hat{\theta}\|_2^2 = n^{-1} \sum_{i=1}^n \hat{u}_i^2$ , we have  $Q := n^{-1} \sum_{i=1}^n \mathbb{E}(\Psi_i \Psi_i^\top \mid \mathcal{F}_n) = \Sigma_V$ . By Assumption 5 and Lemma 2, there exist constant constants  $b_1, b_2 > 0$  such that

$$b_1 \leq \min_{1 \leq j \leq p} Q_{j,j} \leq \max_{1 \leq j \leq p} Q_{j,j} \leq b_2. \quad (\text{B.50})$$

By Lemmas 15 and 12, we have

$$\begin{cases} \|\Delta_n\|_\infty = O_P(s_\Pi \log p) = o_P(1/\sqrt{\log p}) \\ \|\hat{Q} - Q\|_\infty = O_P\left((s_\Pi n^{-1} \log p) \vee \sqrt{n^{-1} \log p}\right) = o_P(1/\sqrt{\log p}). \end{cases} \quad (\text{B.51})$$

We prove the result assuming the following claim, which is proved afterwards:

$$\sup_{x \in \mathbb{R}} \left\| \mathbb{P} \left( \left\| n^{-1/2} \sum_{i=1}^n \Psi_i \right\|_\infty \leq x \mid \mathcal{F}_n \right) - \Gamma(x, \Sigma_V) \right\| = o_P(1). \quad (\text{B.52})$$

We apply Theorem 3 to the decomposition (B.49). From (B.51), (B.50) and (B.52), all the assumptions of Theorem 3 are satisfied. Therefore, the desired result follows by Theorem 3.

### Step 2: show the “central limit theorem”

It remains to prove the claim in (B.52). To this end, we invoke Proposition 1. Hence, we only need to verify the following conditions.

- (a) There exists a constant  $b > 0$  such that  $\mathbb{P}(\min_{1 \leq j \leq p} \Sigma_{V,j,j} \geq b) \rightarrow 1$ .
- (b) There exists a sequence of  $\mathcal{F}_n$ -measurable random variables  $B_n > 0$  such that  $B_n = o(\sqrt{n}/\log^{7/2}(pn))$ ,  $\max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^3 \hat{\sigma}_u^{-3} \mathbb{E}|v_{i,j}|^3 \leq B_n$  and  $\max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^4 \hat{\sigma}_u^{-4} \mathbb{E}|v_{i,j}|^4 \leq B_n^2$ .
- (c)  $\max_{1 \leq i \leq n, 1 \leq j \leq p} \mathbb{E}[\exp(|v_{i,j} \hat{u}_i \hat{\sigma}_u^{-1}|/B_n) \mid \mathcal{F}_n] \leq 2$ .

Notice that Condition (a) follows by (B.50) and  $\Sigma_V = Q$ . To show the other two conditions, notice that, by the constraints (4.11) and (4.12),  $\max_{1 \leq i \leq n} |\hat{u}_i| \leq \mu \tilde{\sigma}_u$  and  $\tilde{\sigma}_u^2/2 \leq \hat{\sigma}_u^2$ . Therefore,

$$\max_{1 \leq i \leq n} |\hat{u}_i| \hat{\sigma}_u^{-1} \leq \sqrt{2} \mu. \quad (\text{B.53})$$

Since  $v_{i,j}$  has a bounded sub-Gaussian norm, there exists a constant  $C_1 > 0$  such that  $\forall 1 \leq j \leq p$  and  $\forall 1 \leq i \leq n$ ,  $\mathbb{E}|v_{i,j}|^3 \leq C_1$  and  $\mathbb{E}v_{i,j}^4 \leq C_1^2$ . By the sub-Gaussian property and Lemma 14, there exists a constant  $C_2 > 0$  such that  $\max_{1 \leq i \leq p, 1 \leq i \leq n} \mathbb{E} \exp(|v_{i,j}|/C_2) \leq 2$ . We define

$$B_n = 4(\mu^3 \vee 1)(C_1 \vee C_2). \quad (\text{B.54})$$



By (B.53), we have that

$$\left\{ \begin{array}{l} \max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^3 \hat{\sigma}_u^{-3} \mathbb{E} |v_{i,j}|^3 \\ \leq C_1 \max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^3 \hat{\sigma}_u^{-3} \leq 2\sqrt{2}\mu^3 C_1 \leq B_n \\ \max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^4 \hat{\sigma}_u^{-4} \mathbb{E} |v_{i,j}|^4 \\ \leq C_1^2 \max_{1 \leq j \leq p} n^{-1} \sum_{i=1}^n |\hat{u}_i|^4 \hat{\sigma}_u^{-4} \leq 4\mu^4 C_1^2 \leq B_n^2 \\ \mathbb{E}[\exp(|v_{i,j} \hat{u}_i \hat{\sigma}_u^{-1}|/B_n) \mid \mathcal{F}_n] \\ \leq \mathbb{E}[\exp(|v_{i,j}|/\sqrt{2}\mu/B_n) \mid \mathcal{F}_n] \leq \mathbb{E}[\exp(|v_{i,j}|/C_2) \mid \mathcal{F}_n] \leq 2. \end{array} \right.$$

By the rate conditions in Assumption 5, it is not hard to see that  $B_n$  in (B.54) satisfies  $B_n = o(\sqrt{n}/\log^{7/2}(pn))$ . We have showed Conditions (b) and (c). The proof is complete.  $\square$

**Lemma 16.** Consider Algorithm 2. Let  $U(\gamma_*) = V\gamma_* + U$ . Suppose that Assumption 5 holds. Then with probability approaching one,

$$\begin{aligned} 3\sigma_*^2/4 &\leq n^{-1} \|U(\gamma_*)\|_2^2 \leq 2\sigma_*^2, \\ \|n^{-1} W^\top U(\gamma_*)\|_\infty &\leq \eta\sigma_* \text{ and} \\ \|V\gamma_* + U\|_\infty &\leq \mu\sigma_*, \text{ where } \sigma_* = \sqrt{\gamma_*^\top \Sigma_V \gamma_* + \sigma_u^2}. \end{aligned}$$

*Proof of Lemma 16.* Let  $u_i(\gamma_*) = v_i^\top \gamma_* + u_i$ . Then  $\mathbb{E} u_i^2(\gamma_*) \sigma_*^{-2} = 1$ . By the law of large numbers,  $n^{-1} \|U(\gamma_*)\|_2^2 \sigma_*^{-2} = n^{-1} \sum_{i=1}^n u_i^2(\gamma_*) \sigma_*^{-2} = 1 + o_P(1)$ . Hence,

$$\mathbb{P}(3/4 \leq n^{-1} \|U(\gamma_*)\|_2^2 \sigma_*^{-2} \leq 2) \rightarrow 1.$$

Since  $\mathbb{P}(n^{-1} \sum_{i=1}^n u_i^2(\gamma_*) \sigma_*^{-2} \geq 2) \rightarrow 0$  and entries of  $w_i$  have sub-Gaussian norms bounded above by some constant  $C_1 > 0$ , we can apply Lemma 19 (with  $x_{i,j} = w_{i,j}$  and  $h_{i,j} = u_i(\gamma_*) \sigma_*^{-1}$  for  $1 \leq j \leq p$ ). It follows that

$$\mathbb{P}\left(\|n^{-1} W^\top U(\gamma_*) \sigma_*^{-1}\|_\infty > C_2 \sqrt{n^{-1} \log p}\right) \rightarrow 0,$$

where  $C_2 > 0$  is a constant depending only on  $C_1$ . To see  $\mathbb{P}(\|V\gamma_* + U\|_\infty \leq \mu\sigma_*) \rightarrow 1$ , first notice that, by Minkowski's inequality and the bounded ninth moment of  $u_1$ , there exists a constant  $C_3 > 0$  such that

$$[\mathbb{E}|u_1(\gamma_*)|^9]^{1/9} \leq [\mathbb{E}|v_1^\top \gamma_*|^9]^{1/9} + [\mathbb{E}|u_1|^9]^{1/9} \leq C_3 (\|\gamma_*\|_2 \vee 1).$$

Therefore, there exists a constant  $C_4 > 0$  such that

$$\begin{aligned} \mathbb{P}(|u_1(\gamma_*)| > \mu\sigma_*) &= \mathbb{P}(|u_1(\gamma_*)|^9 > \mu^9 \sigma_*^9) \\ &\stackrel{(i)}{\leq} \frac{\mathbb{E}|u_1(\gamma_*)|^9}{\mu^9 \sigma_*^9} \\ &\leq \frac{C_3^9 (\|\gamma_*\|_2^9 \vee 1)}{\sigma_*^9 n \log^3 p} \\ &\stackrel{(ii)}{\leq} C_4 n^{-1} \log^{-3} p, \end{aligned} \tag{B.55}$$

where (i) follows by Markov's inequality and (ii) holds by the definition of  $\sigma_*$  and the fact that eigenvalues of  $\Sigma_V$  is bounded away from zero (due to Lemma 2). Hence,

$$\begin{aligned} \mathbb{P}(\|V\gamma_* + U\|_\infty \leq \mu\sigma_*) &= \mathbb{P}\left(\max_{1 \leq i \leq n} |u_i(\gamma_*)| \leq \mu\sigma_*\right) \\ &= \prod_{i=1}^n \mathbb{P}(|u_i(\gamma_*)| \leq \mu\sigma_*) \\ &= [\mathbb{P}(|u_1(\gamma_*)| \leq \mu\sigma_*)]^n = [1 - \mathbb{P}(|u_1(\gamma_*)| > \mu\sigma_*)]^n \\ &\stackrel{(i)}{\geq} [1 - C_4 n^{-1} \log^{-3} p]^n \stackrel{(ii)}{\geq} 1 + o(1), \end{aligned}$$

where (i) holds by (B.55) and (ii) holds by  $(1 + n^{-1}a_n)^n \rightarrow \exp(0) = 1$  for  $a_n = o(1)$  (here  $a_n = -C_4 \log^{-3} p$ ). The proof is complete.  $\square$

**Proof of Theorem 10.** The proof is almost identical to that of Theorem 6, except the reasoning for (B.28). We now apply Theorem 4 with  $\mathcal{B}(\sigma) = \{b \in \mathbb{R}^p \mid \|Y - Wb\|_\infty \leq \mu\sigma\}$  instead of  $\mathcal{B}(\sigma) = \mathbb{R}^p$ . We follow the argument at the beginning of the proof of Theorem 6 with Lemma 13 replaced by Lemma 16. The rest of the proof is the same.  $\square$

### B.7. Technical tools

**Lemma 17.** *Let  $X$  and  $Y$  be two random vectors. Then  $\forall t, \varepsilon > 0$ ,*

$$|\mathbb{P}(\|X\|_\infty \leq t) - \mathbb{P}(\|Y\|_\infty \leq t)| \leq \mathbb{P}(\|X - Y\|_\infty > \varepsilon) + \mathbb{P}(\|Y\|_\infty \in (t - \varepsilon, t + \varepsilon]).$$

*Proof of Lemma 17.* By the triangular inequality, we have

$$\begin{aligned} \mathbb{P}(\|X\|_\infty > t) &\leq \mathbb{P}(\|X - Y\|_\infty > \varepsilon) + \mathbb{P}(\|Y\|_\infty > t - \varepsilon) \\ &= \mathbb{P}(\|X - Y\|_\infty > \varepsilon) + \mathbb{P}(\|Y\|_\infty > t) + \mathbb{P}(\|Y\|_\infty \in (t - \varepsilon, t]) \end{aligned}$$

and

$$\begin{aligned} \mathbb{P}(\|X\|_\infty > t) &\geq \mathbb{P}(\|Y\|_\infty > t + \varepsilon) - \mathbb{P}(\|X - Y\|_\infty > \varepsilon) \\ &= \mathbb{P}(\|Y\|_\infty > t) - \mathbb{P}(\|Y\|_\infty \in (t, t + \varepsilon]) - \mathbb{P}(\|X - Y\|_\infty > \varepsilon). \end{aligned}$$

The above two display imply that

$$|\mathbb{P}(\|X\|_\infty > t) - \mathbb{P}(\|Y\|_\infty > t)| \leq \mathbb{P}(\|X - Y\|_\infty > \varepsilon) + \mathbb{P}(\|Y\|_\infty \in (t - \varepsilon, t + \varepsilon]).$$

The result follows by noticing that

$$|\mathbb{P}(\|X\|_\infty > t) - \mathbb{P}(\|Y\|_\infty > t)| = |\mathbb{P}(\|X\|_\infty \leq t) - \mathbb{P}(\|Y\|_\infty \leq t)|.$$

$\square$

**Lemma 18.** *Let  $Y = (Y_1, \dots, Y_p)^\top$  be a random vector and  $\mathcal{F}$  a  $\sigma$ -algebra. If  $\mathbb{E}(Y \mid \mathcal{F}) = 0$ ,  $Y \mid \mathcal{F}$  is Gaussian and  $\min_{1 \leq j \leq p} \mathbb{E}(Y_j^2 \mid \mathcal{F}) \geq b$  almost surely for some constant  $b > 0$ , then there exists a constant  $C > 0$  depending only on  $b$  such that  $\forall \varepsilon > 0$ .*

$$\sup_{x \in \mathbb{R}} \mathbb{P}(\|Y\|_\infty \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \leq C\varepsilon\sqrt{\log p} \quad a.s.$$

*Proof of Lemma 18.* By Nazarov's anti-concentration inequality (Lemma A.1 in Chernozhukov, Chetverikov and Kato (2014)), there exists a constant  $C_b > 0$  depending only on  $b$  such that almost surely,

$$\begin{cases} \sup_{x \in \mathbb{R}} \mathbb{P}(\max_{1 \leq j \leq p} Y_j \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \leq 2C_b\varepsilon\sqrt{\log p} \\ \sup_{x \in \mathbb{R}} \mathbb{P}(\max_{1 \leq j \leq p} (-Y_j) \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \leq 2C_b\varepsilon\sqrt{\log p}. \end{cases}$$

Since  $\|Y\|_\infty = \max\{\max_{1 \leq j \leq p} Y_j, \max_{1 \leq j \leq p} (-Y_j)\}$ , the desired result follows by

$$\begin{aligned} & \sup_{x \in \mathbb{R}} \mathbb{P}(\|Y\|_\infty \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \\ & \leq \sup_{x \in \mathbb{R}} \mathbb{P}(\max_{1 \leq j \leq p} Y_j \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \\ & \quad + \sup_{x \in \mathbb{R}} \mathbb{P}(\max_{1 \leq j \leq p} (-Y_j) \in (x - \varepsilon, x + \varepsilon] \mid \mathcal{F}) \leq 4C_b\varepsilon\sqrt{\log p}. \end{aligned}$$

□

**Lemma 19.** *Let  $\{x_i\}_{i=1}^n$  and  $\{h_i\}_{i=1}^n$  be two sequences of random vectors in  $\mathbb{R}^L$  that are independent across  $i$ . Suppose that  $\{x_i\}_{i=1}^n$  and  $\{h_i\}_{i=1}^n$  are also independent and that there exist constants  $K_1, K_2 > 0$  such that  $\forall 1 \leq l \leq L$ , the sub-Gaussian norm of  $x_{i,l}$  is bounded above by  $K_1$  and  $\mathbb{P}(\max_{1 \leq l \leq L} n^{-1} \sum_{i=1}^n h_{i,l}^2 > K_2) \rightarrow 0$ .*

*Then, if  $L \rightarrow \infty$ , then there exists a constant  $K > 0$  depending only on  $K_1, K_2$  such that*

$$\mathbb{P}\left(\max_{1 \leq l \leq L} \left| n^{-1/2} \sum_{i=1}^n x_{i,l} h_{i,l} \right| > K\sqrt{\log L}\right) \rightarrow 0.$$

*Proof of Lemma 19.* Define the event  $\mathcal{J}_n = \{\max_{1 \leq l \leq L} n^{-1} \sum_{i=1}^n h_{i,l}^2 \leq K_2\}$ . By the bounded sub-Gaussian norm of  $x_{i,l}$ , we have that, on the event  $\mathcal{J}_n$

$$\begin{aligned} & \mathbb{P}\left(\max_{1 \leq l \leq L} \left| n^{-1/2} \sum_{i=1}^n x_{i,l} h_{i,l} \right| > t \mid \{h_i\}_{i=1}^n\right) \\ & \leq \sum_{l=1}^L \mathbb{P}\left(\left| n^{-1/2} \sum_{i=1}^n x_{i,l} h_{i,l} \right| > t \mid \{h_i\}_{i=1}^n\right) \\ & \stackrel{(i)}{\leq} p \exp\left[1 - \frac{ct^2}{K_1^2 \max_{1 \leq l \leq L} n^{-1} \sum_{i=1}^n h_{i,l}^2}\right] \stackrel{(ii)}{\leq} p \exp\left[1 - \frac{ct^2}{K_1^2 K_2}\right], \end{aligned}$$

where  $c > 0$  is a universal constant; (i) holds by Proposition 5.10 of [Vershynin \(2010\)](#) (applied to the conditional probability measure). Letting  $t = 2K_1\sqrt{K_2c^{-1}\log L}$ , we have that

$$\begin{aligned} & \mathbb{P}\left(\max_{1 \leq l \leq L} \left| n^{-1/2} \sum_{i=1}^n x_{i,l} h_{i,l} \right| > 2K_1\sqrt{K_2c^{-1}\log L}\right) \\ & \leq \mathbb{P}(\mathcal{J}_n^c) + p \exp\left[1 - \frac{c\left(2K_1\sqrt{K_2c^{-1}\log L}\right)^2}{K_1^2 K_2}\right] \\ & = \mathbb{P}(\mathcal{J}_n^c) + e/L^3 = o(1). \end{aligned}$$

Hence, the desired result holds with  $K = 2K_1\sqrt{K_2c^{-1}\log L}$ .  $\square$
