# Small energy Ginzburg-Landau minimizers in $\mathbb{R}^{3}$

#### Abstract

We prove that a local minimizer of the Ginzburg-Landau energy in $\mathbb{R}^{3}$ satisfying the condition $\lim \inf _{R \rightarrow \infty} \frac{E\left(u ; B_{R}\right)}{R \ln R}<2 \pi$ must be constant. The main tool is a new sharp $\eta$-ellipticity result for minimizers in dimension three that might be of independent interest.


## 1 Introduction and main results

Consider the Ginzburg-Landau equation in $\mathbb{R}^{N}$

$$
\begin{equation*}
-\Delta u=\left(1-|u|^{2}\right) u . \tag{1.1}
\end{equation*}
$$

Much effort has been devoted to classifying the solutions to (1.1) under various assumptions. In the scalar case, the famous De Giorgi conjecture states that any bounded solution satisfying $\partial_{x_{N}} u>0$ must depend on one Euclidean variable only, at least when $N \leq 8$. This conjecture was proved to be true in dimension $N=2$ by Ghoussoub and Gui [10], for $N=3$ by Ambrosio and Cabré [2], and under the additional assumption $\lim _{x_{N} \rightarrow \pm \infty} u\left(x^{\prime}, x_{N}\right)= \pm 1$, for $4 \leq N \leq 8$, by Savin [20]. On the other hand, the counterexample of del Pino et al. [8] shows that indeed $N=8$ is optimal.

Much less is known in the vector-valued case $u: \mathbb{R}^{N} \rightarrow \mathbb{R}^{m}$. In that case the monotony hypothesis no longer makes sense. On the other hand, the class of locally minimizing solutions in the sense of De Giorgi - i.e., solutions that are minimizing for their own boundary values on every ball - come up naturally as blow-up limits of minimizers of the Ginzburg-Landau energy

$$
E_{\varepsilon}(u)=\int \frac{1}{2}|\nabla u|^{2}+\frac{1}{4 \varepsilon^{2}}\left(1-|u|^{2}\right)^{2},
$$

as $\varepsilon$ goes to zero. In fact, monotone scalar solutions of (1.1) also have a certain local minimality property (see [1, Thm 4.4]).

[^0]When $N=m=2$ it follows from the results of Sandier [18] and Mironescu [15] that every local minimizer is either constant or equal to $U(x):=f(|x|) \frac{x}{|x|}$, up to rotations and translations, where $f$ is the unique solution of the corresponding ODE. When $N=m=3$ a similar classification was proved by Millot and Pisante [14] under the assumption

$$
\limsup _{R \rightarrow \infty} \frac{E\left(u ; B_{R}\right)}{R}<\infty \quad\left(\text { here } E\left(u ; B_{R}\right)=E_{1}\left(u ; B_{R}\right)\right)
$$

Under additional assumptions, Pisante [16] extended the result to $N=m \geq 4$. Note that in these cases the existence of a non-constant local minimizer is a nontrivial fact.

We are interested in the case $N=3, m=2$. In this case, it is easy to deduce from the local minimality property of $U$ that $V(x, z)=U(x)$ is a local minimizer. We conjecture that it is the only non-constant one, up to the obvious symmetries of the problem. As a first step in this direction we prove:

Theorem 1.1. If $u: \mathbb{R}^{3} \rightarrow \mathbb{R}^{2}$ is a local minimizer of the Ginzburg-Landau energy such that

$$
\liminf _{R \rightarrow \infty} \frac{E\left(u ; B_{R}\right)}{R \ln R}<2 \pi
$$

then $u$ is constant.
Note that the constant $2 \pi$ is optimal since

$$
\lim _{R \rightarrow \infty} \frac{E\left(V ; B_{R}\right)}{R \ln R}=2 \pi
$$

A different assumption was considered by Farina [9] who proved that a local minimizer $u: \mathbb{R}^{N} \rightarrow \mathbb{R}^{2}$ with $N=3$ or 4 , is constant provided $\lim _{|x| \rightarrow \infty}|u(x)|=1$.

Theorem 1.1 is an easy consequence of the following sharp $\eta$-ellipticity type result for minimizers in dimension three:

Theorem 1.2. For every $\gamma \in(0,2 \pi)$ and $\lambda>0$ there exists $\varepsilon_{1}(\gamma, \lambda)$ such that for every $u_{\varepsilon}$ which is a minimizer of $E_{\varepsilon}$ on $B_{1}$ with $\varepsilon \leq \varepsilon_{1}(\gamma, \lambda)$ satisfying $E_{\varepsilon}\left(u ; B_{1}\right) \leq \gamma|\ln \varepsilon|$ there holds

$$
\begin{equation*}
\left|\left|u_{\varepsilon}(0)\right|-1\right| \leq \lambda \tag{1.2}
\end{equation*}
$$

Such a result first appeared in the work of Rivière [17] for the case of minimizers in dimension three. There were subsequent generalizations by Lin-Rivière [12, 13] and Bethuel-Brezis-Orlandi $[4,5]$. The result in [5] is the most general, covering the case of solutions (not necessary minimizers) of the Ginzburg-Landau equation in any dimension.

All these results establish the existence of a constant $\gamma>0$ for which the result is true, but no explicit bound is given. We are able to give the optimal bound, but only for minimizers in dimension three. Working with minimizers allows us to apply a construction of an appropriate test function. This is done in Proposition 1.3 below, which plays an important role in the proof of Theorem 1.2 (see Section 2 for notation).
Proposition 1.3. Let $u$ be a minimizer for $E$ on $B_{R} \subset \mathbb{R}^{3}$, for its boundary values on $S_{R}$. If

$$
\begin{equation*}
E^{(T)}\left(u ; S_{R}\right) \leq \gamma \ln R, \tag{1.3}
\end{equation*}
$$

with $\gamma<2 \pi$ and $R>r_{0}(\gamma)$ then there exist $\alpha=\alpha(\gamma) \in(0,1)$ and a universal $\sigma \in(0,1)$ such that

$$
\begin{equation*}
E\left(u ; B_{R}\right) \leq \sigma R E^{(T)}\left(u ; S_{R}\right)+C_{\gamma} R^{\alpha} \ln R . \tag{1.4}
\end{equation*}
$$

## 2 Notation and some preliminary results

We begin by introducing some notation. By $B_{R}(a)$ we denote a ball in $\mathbb{R}^{N}, N \geq 2$ (usually for $N=3$ ) and then $S_{R}(a)=\partial B_{R}(a)$. Specifically in dimension two, we denote by $D_{R}(a)$ a disc and by $C_{R}(a)=\partial D_{R}(a)$ its boundary. In case $a=0$ we denote for short:

$$
B_{R}=B_{R}(0), S_{R}=\partial B_{R}(0), D_{R}=D_{R}(0), C_{R}=\partial D_{R}(0)
$$

For a set $D$ in $\mathbb{R}^{N}, N \geq 2, \varepsilon>0$ and $u \in H^{1}\left(D ; \mathbb{R}^{2}\right)$ we denote:

$$
E_{\varepsilon}(u ; D)=\int_{D} \frac{1}{2}|\nabla u|^{2}+\frac{1}{4 \varepsilon^{2}}\left(1-|u|^{2}\right)^{2} .
$$

For $\widetilde{D} \subseteq S_{R}(a) \subset \mathbb{R}^{N}, N \geq 2$, and $u \in H^{1}\left(\widetilde{D} ; \mathbb{R}^{2}\right)$ we denote

$$
E_{\varepsilon}^{(T)}(u ; \widetilde{D})=\int_{\widetilde{D}} \frac{1}{2}\left|\nabla_{T} u\right|^{2}+\frac{1}{4 \varepsilon^{2}}\left(1-|u|^{2}\right)^{2}
$$

When $\varepsilon=1$ we denote for short $E(u ; D)=E_{1}(u ; D)$ and $E^{(T)}(u ; \widetilde{D})=E_{1}^{(T)}(u ; \widetilde{D})$.
We denote by $\widetilde{D}_{\rho}^{R}(a)$ a spherical disc on the sphere $S_{R}=S_{R}(0) \subset \mathbb{R}^{3}$, with center at $a$ and radius $\rho$ (using the geodesic distance) and by $\widetilde{C}_{\rho}^{R}(a)=\partial \widetilde{D}_{\rho}^{R}(a)$ its boundary. In case there is no risk of confusion we shall omit the superscript $R$. We often identify $\mathbb{R}^{2}$-valued maps with $\mathbb{C}$-valued maps.
We recall the following basic estimates valid for an arbitrary (vector valued) solution of the Ginzburg-Landau equation (1.1) in dimension $N \geq 2$. The first is a $L^{\infty}$-bound for $u$ and its gradient ([5, Lemma III.2]).

Lemma 2.1. Assume $u$ satisfies (1.1) in $B_{1} \subset \mathbb{R}^{N}$. Then, there is a constant $K=K(N)>0$ such that

$$
\begin{equation*}
\|u\|_{L^{\infty}\left(B_{1 / 2}\right)} \leq K \tag{2.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\|\nabla u\|_{L^{\infty}\left(B_{1 / 2}\right)} \leq K \tag{2.2}
\end{equation*}
$$

Sketch of proof. For the proof of (2.1) we argue as in Brezis [7, Remark 3] to get, using Kato's inequality, that $\varphi=\left(|u|^{2}-1\right)^{+}$satisfies

$$
\begin{equation*}
\Delta \varphi \geq \varphi^{2} \text { in } B_{R} \tag{2.3}
\end{equation*}
$$

The result then follows by the Keller-Osserman theory (see [6] and the references therein).
Once (2.1) is established, (2.2) follows by standard elliptic estimates.
The second is a version of the monotonicity formula ([5, Corollary II.1]):
Lemma 2.2. Let $u$ be a solution of (1.1) in $B_{R} \subset \mathbb{R}^{N}$. Then, the function $r \mapsto E\left(u ; B_{r}\right) / r^{N-2}$ is nondecreasing in $(0, R)$.

Another useful result is the following estimate for harmonic functions in balls.
Lemma 2.3. Let $w \in C^{1}\left(\bar{B}_{R}\right)$ be a harmonic function in a ball $B_{R} \subset \mathbb{R}^{N}$. Then

$$
\begin{equation*}
\int_{B_{R}}|\nabla w|^{2} \leq \frac{R}{N-1} \int_{\partial B_{R}}\left|\nabla_{T} w\right|^{2} . \tag{2.4}
\end{equation*}
$$

Proof. First note that since $|\nabla w|^{2}$ is subharmonic we have

$$
\int_{B_{R}}|\nabla w|^{2} \leq \int_{0}^{R}\left(\frac{r^{N-1}}{R^{N-1}} \int_{\partial B_{R}}|\nabla w|^{2}\right) d r=\frac{R}{N} \int_{\partial B_{R}}|\nabla w|^{2},
$$

i.e.,

$$
\begin{equation*}
N \int_{B_{R}}|\nabla w|^{2} \leq R \int_{\partial B_{R}}\left(\left|\nabla_{T} w\right|^{2}+\left|\frac{\partial w}{\partial n}\right|^{2}\right) . \tag{2.5}
\end{equation*}
$$

On the other hand, Pohozaev identity gives

$$
\begin{equation*}
(N-2) \int_{B_{R}}|\nabla w|^{2}=R \int_{\partial B_{R}}\left(\left|\nabla_{T} w\right|^{2}-\left|\frac{\partial w}{\partial n}\right|^{2}\right) . \tag{2.6}
\end{equation*}
$$

Adding (2.5) with (2.6) yields (2.4).

## 3 Proof of Proposition 1.3

The next lemma deals with a Ginzburg-Landau minimization problem on a spherical disc. The proof requires simple modification of the methods developed for the case of the usual Ginzburg-Landau energy in the plane with zero degree boundary condition (see [3]).

Lemma 3.1. Let $u \in H^{1}\left(\widetilde{D}_{\rho}^{R}(a), \mathbb{R}^{2}\right)$ with

$$
\begin{equation*}
\rho / R<1 / 10 \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
E^{(T)}\left(u ; \widetilde{C}_{\rho}^{R}(a)\right) \leq c_{1} / \rho \tag{3.2}
\end{equation*}
$$

Then, if $\rho \geq R_{0}\left(c_{1}\right)$ we have

$$
\begin{equation*}
||u|-1| \leq 1 / 8 \text { on } \widetilde{C}_{\rho}^{R}(a) . \tag{3.3}
\end{equation*}
$$

If we further assume that

$$
\begin{equation*}
\operatorname{deg}\left(u, \widetilde{C}_{\rho}^{R}(a)\right)=0 \tag{3.4}
\end{equation*}
$$

then for $\rho \geq R_{1}\left(c_{1}\right) \geq R_{0}\left(c_{1}\right)$, any minimizer $v$ of the energy $E\left(\cdot ; \widetilde{D}_{\rho}^{R}(a)\right)$ for the boundary data u on $\widetilde{C}_{\rho}^{R}(a)$, satisfies:

$$
\begin{equation*}
|1-|v|| \leq 1 / 8 \text { on } \widetilde{D}_{\rho}^{R}(a) . \tag{3.5}
\end{equation*}
$$

Proof. The proof of (3.3) is easy and standard (see [11, Lemma 1]). Indeed, assume that for some point $x_{0} \in \widetilde{C}_{\rho}=\widetilde{C}_{\rho}^{R}(a)$ we have

$$
\begin{equation*}
\left|\left|u\left(x_{0}\right)\right|-1\right|>1 / 8 . \tag{3.6}
\end{equation*}
$$

Then, for any $x_{1} \in \widetilde{C}_{\rho}$ we have, using Hölder inequality on the arc of circle $A\left(x_{0}, x_{1}\right) \subset \widetilde{C}_{\rho}$ and (3.2):

$$
\left|u\left(x_{0}\right)-u\left(x_{1}\right)\right| \leq\left(2 E^{(T)}\left(u ; \widetilde{C}_{\rho}\right)\right)^{1 / 2}\left|A\left(x_{0}, x_{1}\right)\right|^{1 / 2} \leq\left(\frac{2 c_{1}}{\rho}\right)^{1 / 2}\left|A\left(x_{0}, x_{1}\right)\right|^{1 / 2}
$$

It follows, using (3.6), that there exists $\lambda>0$ such that

$$
\begin{equation*}
||u|-1| \geq 1 / 16 \text { on }\left\{\left|x-x_{0}\right|<\lambda \rho / c_{1}\right\} \cap \widetilde{C}_{\rho} . \tag{3.7}
\end{equation*}
$$

Clearly, (3.7) implies, for some positive constant $c_{2}$, that

$$
\int_{\widetilde{C}_{\rho}}\left(1-|u|^{2}\right)^{2} \geq c_{2} \rho,
$$

which contradicts (3.2) for $\rho$ large enough.
For the proof of (3.5) it is convenient to treat an equivalent problem for a certain weighted Ginzburg-Landau energy on a planar disc. For that matter we will perform a change of variables in several steps. Without loss of generality we may assume that $a=(0, \ldots, 0,-R)$, the south pole of $S_{R}$. Denoting by $\mathcal{S}: S_{1} \rightarrow \mathbb{R}^{2}$ the standard stereographic projection we define a function $\tilde{u}: D_{\tan (\rho / 2 R)} \rightarrow \mathbb{R}^{2}$ by $\tilde{u}(x)=u\left(R \mathcal{S}^{-1} x\right)$. We have

$$
E\left(u ; \widetilde{D}_{\rho}^{R}(a)\right)=\int_{D_{\tan (\rho / 2 R)}}\left\{\frac{1}{2}|\nabla \tilde{u}|^{2}+\frac{R^{2}\left(1-|\tilde{u}|^{2}\right)^{2}}{\left(1+|x|^{2}\right)^{2}}\right\} d x .
$$

A final rescaling, setting $U(y)=\tilde{u}(\tan (\rho / 2 R) y)$, yields $U: D_{1} \rightarrow \mathbb{R}^{2}$ satisfying

$$
F_{\varepsilon}\left(U ; D_{1}\right)=E\left(u ; \widetilde{D}_{\rho}^{R}(a)\right)
$$

with

$$
F_{\varepsilon}\left(U ; D_{1}\right):=\int_{D_{1}}\left\{\frac{1}{2}|\nabla U|^{2}+\frac{p(y)}{4 \varepsilon^{2}}\left(1-|U|^{2}\right)^{2}\right\} d y
$$

where

$$
\varepsilon=1 /(2 R \tan (\rho / 2 R)) \text { and } p(y)=1 /\left(1+\tan ^{2}(\rho / 2 R)|y|^{2}\right)^{2} .
$$

Note that by (3.1) $p(y)$ is bounded between two positive constants, and all its derivatives are uniformly bounded as well. Moreover, by (3.2) we have

$$
\int_{\partial D_{1}}\left\{\frac{1}{2}|\nabla U|^{2}+\frac{p(y)}{4 \varepsilon^{2}}\left(1-|U|^{2}\right)^{2}\right\} \leq \tilde{c}_{1},
$$

where $\tilde{c}_{1}$ depends on $c_{1}$ only.
The proof of (3.5) follows by a simple modification of the arguments in [3, Thm 2] (in particular the proof of (95) there), see also [11, Lemma 2]; the fact that here we deal with a weighted Ginzburg-Landau energy causes no difficulty since the weight is smooth, as explained above.

The next lemma is concerned with an extension problem in a cylinder. It will be useful for a similar problem on a spherical cylinder in the course of the proof of Proposition 1.3.

Lemma 3.2. Let $u, v \in H^{1}\left(D_{R}, \mathbb{R}^{2}\right)$ be such that

$$
\begin{align*}
u & =v \text { on } C_{R},  \tag{3.8}\\
|1-|v|| & \leq 1 / 8 \text { and }|u| \leq K \quad \text { on } \bar{D}_{R} . \tag{3.9}
\end{align*}
$$

Then, for any $H>0$ there exists $U \in H^{1}\left(D_{R} \times(0, H)\right)$ satisfying

$$
\begin{align*}
U(x, H) & =u(x),  \tag{3.10}\\
&  \tag{3.11}\\
U(x, 0) & =v(x),  \tag{3.12}\\
& x \in D_{R} \\
U(x, z) & =u(x)=v(x), \quad x \in \partial D_{R}, z \in(0, H)
\end{align*}
$$

and

$$
\begin{equation*}
E\left(U ; D_{R} \times(0, H)\right) \leq C\left(H+R^{2} / H\right)\left(E\left(u ; D_{R}\right)+E\left(v ; D_{R}\right)\right) . \tag{3.13}
\end{equation*}
$$

Proof. We first extend $v$ to the cylinder $\bar{D}_{R} \times[0, H]$ by letting

$$
\begin{equation*}
V(x, z)=v(x), \quad x \in \bar{D}_{R}, z \in[0, H] . \tag{3.14}
\end{equation*}
$$

Define the cone $\Gamma$ by

$$
\begin{equation*}
\Gamma=\{(x, z) ; 0<|x|<R,(H / R)|x|<z<H\} . \tag{3.15}
\end{equation*}
$$

Let $w$ be defined in $\bar{D}_{R}$ by $w=u / v$ and then extend it to $\bar{D}_{R} \times[0, H]$ by

$$
W(x, z)= \begin{cases}1 & (x, z) \in \bar{D}_{R} \times[0, H] \backslash \Gamma  \tag{3.16}\\ w(H x / z) & (x, z) \in \Gamma\end{cases}
$$

Finally we set

$$
\begin{equation*}
U=V W \quad \text { in } \bar{D}_{R} \times[0, H] \tag{3.17}
\end{equation*}
$$

Clearly,

$$
\begin{equation*}
E\left(W ; \bar{D}_{R} \times[0, H]\right)=E(W ; \Gamma)=\int_{0}^{H} d z \int_{D_{R z / H} \times\{z\}} \frac{1}{2}|\nabla W|^{2}+\frac{1}{4}\left(1-|W|^{2}\right)^{2} . \tag{3.18}
\end{equation*}
$$

First note that

$$
\begin{equation*}
\int_{D_{R z / H} \times\{z\}}\left|\nabla_{x} W\right|^{2}=\int_{D_{R}}|\nabla w|^{2}, \tag{3.19}
\end{equation*}
$$

while

$$
\begin{align*}
\int_{D_{R z / H} \times\{z\}}\left|\frac{\partial W}{\partial z}\right|^{2} & =\int_{D_{R z / H}}\left|\nabla w(H x / z) \cdot\left(H x / z^{2}\right)\right|^{2}  \tag{3.20}\\
& \leq \frac{1}{H^{2}} \int_{D_{R}}|\nabla w(y)|^{2}|y|^{2} d y \leq\left(\frac{R}{H}\right)^{2} \int_{D_{R}}|\nabla w|^{2} .
\end{align*}
$$

Integrating (3.19)-(3.20) over $z \in(0, H)$ yields

$$
\begin{equation*}
\int_{D_{R} \times(0, H)}|\nabla W|^{2} \leq\left(H+R^{2} / H\right) \int_{D_{R}}|\nabla w|^{2} . \tag{3.21}
\end{equation*}
$$

Since by (3.9)

$$
\begin{equation*}
|\nabla w| \leq C(|\nabla u|+|\nabla v|), \tag{3.22}
\end{equation*}
$$

we deduce from (3.21) that

$$
\begin{equation*}
\int_{D_{R} \times(0, H)}|\nabla W|^{2} \leq C\left(H+R^{2} / H\right)\left(\int_{D_{R}}|\nabla u|^{2}+\int_{D_{R}}|\nabla v|^{2}\right) . \tag{3.23}
\end{equation*}
$$

Next we turn to estimate the second term in the energy. We have

$$
\begin{align*}
& \int_{D_{R z / H}}\left(|W(x, z)|^{2}-1\right)^{2} d x=\int_{D_{R z / H}}\left(|w(H x / z)|^{2}-1\right)^{2} d x \\
&=(z / H)^{2} \int_{D_{R}}\left(|w(y)|^{2}-1\right)^{2} d y \tag{3.24}
\end{align*}
$$

so integrating (3.24) for $z \in(0, H)$ gives

$$
\begin{equation*}
\int_{\Gamma}\left(|W|^{2}-1\right)^{2}=(H / 3) \int_{D_{R}}\left(|w(y)|^{2}-1\right)^{2} d y \tag{3.25}
\end{equation*}
$$

Noting that

$$
\begin{equation*}
\left||w|^{2}-1\right|=\frac{\left||u|^{2}-|v|^{2}\right|}{|v|^{2}} \leq(8 / 7)^{2}\left(\left.| | u\right|^{2}-1\left|+\left||v|^{2}-1\right|\right)\right. \tag{3.26}
\end{equation*}
$$

we conclude from (3.25) that

$$
\begin{equation*}
\int_{\Gamma}\left(|W|^{2}-1\right)^{2} \leq C H\left(\int_{D_{R}}\left(|u|^{2}-1\right)^{2}+\int_{D_{R}}\left(|v|^{2}-1\right)^{2}\right) . \tag{3.27}
\end{equation*}
$$

We also clearly have

$$
\begin{align*}
\int_{D_{R} \times(0, H)}|\nabla V|^{2} & =H \int_{D_{R}}|\nabla v|^{2},  \tag{3.28}\\
\int_{D_{R} \times(0, H)}\left(1-|V|^{2}\right)^{2} & =H \int_{D_{R}}\left(1-|v|^{2}\right)^{2} . \tag{3.29}
\end{align*}
$$

Similarly to (3.22) we have $|\nabla U| \leq c(|\nabla V|+|\nabla W|)$. Hence, from (3.23) and (3.28) we get that

$$
\begin{equation*}
\int_{D_{R} \times(0, H)}|\nabla U|^{2} \leq C\left(H+R^{2} / H\right)\left(\int_{D_{R}}|\nabla u|^{2}+\int_{D_{R}}|\nabla v|^{2}\right) . \tag{3.30}
\end{equation*}
$$

By (3.17), (3.9) and (3.14) we have

$$
\left||U|^{2}-1\right| \leq\left.\left||V|^{2}\right| W\right|^{2}-|V|^{2}\left|+\left||V|^{2}-1\right| \leq(9 / 8)^{2}\right||W|^{2}-1\left|+\left||V|^{2}-1\right|\right.
$$

and applying (3.29) and (3.27) yields

$$
\begin{equation*}
\int_{D_{R} \times(0, H)}\left(1-|U|^{2}\right)^{2} \leq C H\left(\int_{D_{R}}\left(1-|v|^{2}\right)^{2}+\int_{D_{R}}\left(1-|u|^{2}\right)^{2}\right) . \tag{3.31}
\end{equation*}
$$

Clearly (3.13) follows from (3.30)-(3.31).

Proof of Proposition 1.3. The proof is divided to several steps.
Step 1: Locating the "bad discs" on $S_{R}$ and choosing $\alpha$.

The following result should seem plausible to specialists in the field; we state it as a Lemma and prove it in the appendix.
Lemma 3.3. Given $\gamma<2 \pi$ and $\Lambda>0$ there exists $R_{0}>0$ such that if $R>R_{0}$ and $u: S_{R} \rightarrow \mathbb{R}^{2}$ satisfies

E^{(T)}\left(u ; S_{R}\right) \leq \gamma \ln R,
$$

then there exist $\alpha \in(0,1)$ and spherical discs $\widetilde{D}_{i}=\widetilde{D}_{r_{i}}^{R}\left(a_{i}\right), i=1, \ldots, k$, such that

\begin{align*}
& |u|>7 / 8 \text { on } S_{R} \backslash \bigcup_{i=1}^{k} \widetilde{D}_{i},  \tag{3.32}\\
& \sum_{i=1}^{k} r_{i} \leq R^{\alpha},  \tag{3.33}\\
& E^{(T)}\left(u, \partial \widetilde{D}_{i}\right) \leq \frac{2 \pi}{r_{i}}, i=1, \ldots, k,  \tag{3.34}\\
& \operatorname{deg}\left(u, \partial \widetilde{D}_{i}\right)=0, i=1, \ldots, k,  \tag{3.35}\\
& r_{i} \geq \Lambda, \quad i=1, \ldots, k . \tag{3.36}
\end{align*}
$$

Applying Lemma 3.3 with $\Lambda=R_{1}(2 \pi)$ (see Lemma 3.1) yields a collection $\left\{\widetilde{D}_{r_{i}}^{R}\left(a_{i}\right)\right\}_{i=1}^{k}$ satisfying (3.32)-(3.36).
Step 2: Extension to a map in $B_{R} \backslash B_{R-R^{\alpha}}$ with a phase on $S_{R-R^{\alpha}}$.
For each $i=1, \ldots, k$ we apply Lemma 3.1 with $c_{1}=2 \pi$ to find a map $v_{i}$ defined in $\widetilde{D}_{i}=$ $\widetilde{D}_{r_{i}}^{R}\left(a_{i}\right)$ satisfying:

\begin{align*}
& v_{i}=u \text { on } \partial \widetilde{D}_{i},  \tag{3.37}\\
& \left|\left|v_{i}\right|-1\right| \leq 1 / 8 \text { on } \widetilde{D}_{i},  \tag{3.38}\\
& E^{(T)}\left(v_{i} ; \widetilde{D}_{i}\right) \leq E^{(T)}\left(u ; \widetilde{D}_{i}\right) . \tag{3.39}
\end{align*}
$$

Note that for any spherical cylinder of the form

$$
\mathcal{C}=\{(r \sin \varphi \cos \theta, r \sin \varphi \sin \theta, \cos \varphi) ; r \in(R-H, R), \varphi \in[0, \rho / R), \theta \in[0,2 \pi)\}
$$

there is a $C^{1}$ diffeomorphism $\Psi: D_{\rho} \times(0, H) \rightarrow \mathcal{C}$ given by

\Psi\left(y_{1}, y_{2}, y_{3}\right)=\left(\frac{y_{3}+R-H}{R}\right)\left(y_{1}, y_{2}, \sqrt{R^{2}-y_{1}^{2}-y_{2}^{2}}\right) .
$$

A direct computation yields that

\begin{equation*}
D \Psi=\operatorname{Id}+O(\rho / R)+O(H / R) \text { and } D\left(\Psi^{-1}\right)=\operatorname{Id}+O(\rho / R)+O(H / R) \tag{3.40}
\end{equation*}
$$

Consider each spherical cylinder

$$
\mathcal{C}_{i}=\left\{r y ; y \in \widetilde{D}_{i}, r \in\left(\frac{R-R^{\alpha}}{R}, 1\right)\right\}, \quad i=1, \ldots, k .
$$

By applying a rotation (sending $a_{i}$ to $\mathcal{N}$ ) and then the map $\Psi^{-1}$ we find a regular cylinder $D_{r_{i}} \times\left(0, R^{\alpha}\right)$ on which we perform the construction of Lemma 3.2. Going back to $\mathcal{C}_{i}$, we get, taking into account (3.40), a map $U_{i} \in H^{1}\left(\mathcal{C}_{i}, \mathbb{R}^{2}\right)$ satisfying:

\begin{align*}
& U_{i}(x)=u(x), \quad x \in \widetilde{D}_{i},  \tag{3.41}\\
& U_{i}(x)=v_{i}\left(R x /\left(R-R^{\alpha}\right)\right), \quad x \in\left(\left(R-R^{\alpha}\right) / R\right) \widetilde{D}_{i} \subset S_{R-R^{\alpha}},  \tag{3.42}\\
& U_{i}(x)=u(R x /|x|)=v_{i}(R x /|x|), \quad \frac{R x}{|x|} \in \partial \widetilde{D}_{i}, \tag{3.43}
\end{align*}
$$

and

$$
\begin{equation*}
E\left(U_{i} ; \mathcal{C}_{i}\right) \leq C\left(R^{\alpha}+r_{i}^{2} / R^{\alpha}\right) E^{(T)}\left(u ; \widetilde{D}_{i}\right) \leq C R^{\alpha} E^{(T)}\left(u ; \widetilde{D}_{i}\right) . \tag{3.44}
\end{equation*}
$$

Denoting by $\mathcal{P}_{R}(x)=R x /|x|$ the radial projection on $S_{R}$, we finally define $U$ in $B_{R} \backslash B_{R-R^{\alpha}}$ by

$$
U(x)= \begin{cases}U_{i}(x) & \text { if } \mathcal{P}_{R}(x) \in \widetilde{D}_{i} \text { for some } i  \tag{3.45}\\ u\left(\mathcal{P}_{R}(x)\right) & \text { otherwise }\end{cases}
$$

We clearly have

$$
\begin{align*}
& U(x)=u(x) \text { on } S_{R} \\
& V(x):=\left.U\right|_{S_{R-R^{\alpha}}}(x) \text { satisfies } 7 / 8 \leq|V(x)| \leq K \text { on } S_{R-R^{\alpha}} . \tag{3.46}
\end{align*}
$$

Moreover,

$$
\begin{align*}
E^{(T)}\left(V ; S_{R-R^{\alpha}}\right) & \leq E^{(T)}\left(u ; S_{R}\right),  \tag{3.47}\\
E\left(U ; B_{R} \backslash B_{R-R^{\alpha}}\right) & \leq C R^{\alpha} \ln R . \tag{3.48}
\end{align*}
$$

Indeed, (3.47) follows by summing up the contribution of each $\widetilde{D}_{i}$ in (3.39) and using (3.45). The inequality (3.48) follows from (3.44)-(3.45) and (1.3).

Step 3: Extension in $B_{R-R^{\alpha}}$.
On $S_{R-R^{\alpha}}$ we may write

\end{equation*}

with $7 / 8 \leq \tilde{\rho} \leq K$. We first extend to $U(x)=\rho(x) e^{i \varphi(x)}$ in $A(R):=B_{R-R^{\alpha}} \backslash \bar{B}_{R-2 R^{\alpha}}$ by setting:

& \rho(x)=\frac{r-\left(R-2 R^{\alpha}\right)}{R^{\alpha}} \tilde{\rho}\left(\left(R-R^{\alpha}\right) x /|x|\right)+\frac{\left(R-R^{\alpha}\right)-r}{R^{\alpha}}  \tag{3.50}\\
& \varphi(x)=\varphi\left(\left(R-R^{\alpha}\right) x /|x|\right), \tag{3.51}
\end{align*}
$$

where $r=|x| \in\left(R-2 R^{\alpha}, R-R^{\alpha}\right)$. A direct computation gives:

$$
\begin{gather*}
\int_{A(R)}\left|\frac{\partial \rho}{\partial r}\right|^{2} \leq \frac{C}{R^{\alpha}} \ln R  \tag{3.52}\\
\int_{A(R)}\left|\nabla_{T} \rho\right|^{2} \leq C R^{\alpha} \ln R  \tag{3.53}\\
\int_{A(R)}\left(1-\rho^{2}\right)^{2} \leq C R^{\alpha} \ln R  \tag{3.54}\\
\int_{A(R)}|\nabla \varphi|^{2} \leq C R^{\alpha} \ln R \tag{3.55}
\end{gather*}
$$

From (3.52)-(3.55) it follows that

$$
\begin{equation*}
E(U ; A(R)) \leq C R^{\alpha} \ln R \tag{3.56}
\end{equation*}
$$

Moreover, by (3.51) and (3.45)-(3.46) we have

$$
\begin{equation*}
\int_{S_{R-2 R^{\alpha}}}|\nabla \varphi|^{2}=\int_{S_{R-R^{\alpha}}}|\nabla \varphi|^{2} \leq 2(8 / 7)^{2} E^{(T)}\left(u ; S_{R}\right) . \tag{3.57}
\end{equation*}
$$

Finally, denoting by $\Phi$ the harmonic extension of $\varphi$ to $B_{R-2 R^{\alpha}}$, we set

U(x)=e^{i \Phi(x)} \text { in } B_{R-2 R^{\alpha}} .
$$

Combining (2.4),(3.57), (3.48) and (3.56) we obtain

E\left(U ; B_{R}\right) \leq(1 / 2)(8 / 7)^{2}\left(R-2 R^{\alpha}\right) E^{(T)}\left(u ; S_{R}\right)+C R^{\alpha} \ln R, \tag{3.58}
\end{equation*}
$$

that clearly implies (1.4) for $R$ large, since $E\left(u ; B_{R}\right) \leq E\left(U ; B_{R}\right)$.

## 4 Proof of the main results

We begin with the proof of Theorem 1.2. It will be more convenient to prove instead the theorem under the following equivalent formulation, obtained by rescaling:

Theorem 4.1. For every $\gamma \in(0,2 \pi)$ and $\lambda>0$ there exists $R_{1}(\gamma, \lambda)$ such that for every $u$ which is a minimizer of $E$ on $B_{R}$, with $R \geq R_{1}(\gamma, \lambda)$, satisfying $E\left(u ; B_{R}\right) \leq \gamma R \ln R$ there holds

$$
\begin{equation*}
||u(0)|-1| \leq \lambda . \tag{4.1}
\end{equation*}
$$

Proof of Theorem 4.1. We will use the shorthand $E(R)$ for $E\left(u ; B_{R}\right)$ and also

$$
\begin{aligned}
E^{\prime}(R) & :=\frac{d}{d R} E(R)=\int_{S_{R}} \frac{1}{2}|\nabla u|^{2}+\frac{1}{4}\left(1-|u|^{2}\right)^{2}, \\
e_{T}(R) & :=E^{(T)}\left(u ; S_{R}\right)=\int_{S_{R}} \frac{1}{2}\left|\nabla_{T} u\right|^{2}+\frac{1}{4}\left(1-|u|^{2}\right)^{2} .
\end{aligned}
$$

The value of $R_{1}=R_{1}(\gamma, \lambda)$ will be determined later. For the moment we will assume its value is known and in the course of the proof we shall obtain some constraints that will allow us to detrmine its value definitively. We first fix $\varepsilon$ satisfying

\gamma+3 \varepsilon<2 \pi \tag{4.2}
\end{equation*}
$$

Next we take any $\beta \in(0,1)$, e.g., $\beta=1 / 2$. Since

\int_{R^{\beta}}^{R} E^{\prime}(r) d r \leq E(R)<\gamma R \ln R=\gamma \int_{R^{\beta}}^{R}(\ln r+1) d r+\gamma R^{\beta} \ln \left(R^{\beta}\right),
$$

there exists $\rho_{1} \in\left[R^{\beta}, R\right]$ such that

$$
\begin{equation*}
E^{\prime}\left(\rho_{1}\right) \leq \gamma\left(\ln \rho_{1}+1+\frac{R^{\beta} \ln \left(R^{\beta}\right)}{R-R^{\beta}}\right) \leq(\gamma+\varepsilon) \ln \rho_{1} \tag{4.3}
\end{equation*}
$$

if $R_{1}$ is chosen large enough. Since $e_{T}\left(\rho_{1}\right) \leq E^{\prime}\left(\rho_{1}\right) \leq(\gamma+\varepsilon) \ln \rho_{1}$, we may apply Proposition 1.3 (with $\gamma+\varepsilon$ playing the role of $\gamma$ ) to get

E\left(\rho_{1}\right) \leq \sigma \rho_{1} e_{T}\left(\rho_{1}\right)+C \rho_{1}^{\alpha} \ln \rho_{1} \leq \sigma(\gamma+2 \varepsilon) \rho_{1} \ln \rho_{1}, \tag{4.4}
\end{equation*}
$$

provided $R_{1}$ is large enough. Next we fix $\delta \in(0,1)$ satisfying

$$
\begin{equation*}
\gamma_{0}:=\frac{(\gamma+3 \varepsilon)}{\delta}<2 \pi \tag{4.5}
\end{equation*}
$$

By (4.4) we have, for every $r \in\left[\delta \rho_{1}, \rho_{1}\right]$,

$$
\begin{equation*}
E(r) \leq E\left(\rho_{1}\right) \leq \frac{\sigma(\gamma+2 \varepsilon)}{\delta} \delta \rho_{1} \ln \rho_{1}<\left(\sigma \gamma_{0}\right) \delta \rho_{1} \ln \left(\delta \rho_{1}\right) \leq\left(\sigma \gamma_{0}\right) r \ln r \tag{4.6}
\end{equation*}
$$

again, if $R_{1}$ is chosen large enough. Let $M>0$ denote a constant such that for $R \geq M$ all the inequalities, (4.3),(4.4) and (4.6) hold true. Set

$$
\begin{equation*}
\rho_{2}:=\inf \left\{R \in\left[\widetilde{R}_{0}, \rho_{1}\right]: E(s)<\left(\sigma \gamma_{0}\right) s \ln s, \forall s \in\left[R, \rho_{1}\right]\right\}, \tag{4.7}
\end{equation*}
$$

where $\widetilde{R}_{0}=\widetilde{R}_{0}\left(\gamma_{0}, \sigma\right) \geq r_{0}\left(\gamma_{0}\right)$ (see Proposition 1.3) will be determined below. Thanks to (4.6) we have $\rho_{2} \leq \delta \rho_{1}$. For $r \in\left[\rho_{2}, \rho_{1}\right]$ we have, either

$$
\begin{equation*}
E^{\prime}(r) \geq \frac{E(r)}{\sigma r} \tag{4.8}
\end{equation*}
$$

or

$$
\begin{equation*}
E^{\prime}(r)<\frac{E(r)}{\sigma r} . \tag{4.9}
\end{equation*}
$$

In the latter case, when (4.9) holds, we have by (4.7),

$$
e_{T}(r) \leq E^{\prime}(r)<\frac{E(r)}{\sigma r} \leq \gamma_{0} \ln r .
$$

Applying Proposition 1.3 yields

$$
\begin{equation*}
E^{\prime}(r) \geq e_{T}(r) \geq \frac{E(r)-C r^{\alpha} \ln r}{\sigma r} \tag{4.10}
\end{equation*}
$$

The first possibility (4.8) clearly implies (4.10). Hence, for every $r \in\left[\rho_{2}, \rho_{1}\right]$, (4.10) holds. We rewrite (4.10) as

\left(r^{-1 / \sigma} E(r)\right)^{\prime} \geq-\frac{C}{\sigma} r^{\alpha-1-1 / \sigma} \ln r . \tag{4.11}
\end{equation*}
$$

Integrating (4.11) for $r \in\left[\rho_{2}, \rho_{1}\right]$ gives

\frac{E\left(\rho_{1}\right)}{\rho_{1}^{1 / \sigma}}-\frac{E\left(\rho_{2}\right)}{\rho_{2}^{1 / \sigma}} \geq-\frac{C}{\sigma}\left(\frac{\rho_{1}^{\alpha-1 / \sigma}}{\alpha-1 / \sigma} \ln \rho_{1}-\frac{\rho_{1}^{\alpha-1 / \sigma}}{(\alpha-1 / \sigma)^{2}}-\frac{\rho_{2}^{\alpha-1 / \sigma}}{\alpha-1 / \sigma} \ln \rho_{2}+\frac{\rho_{2}^{\alpha-1 / \sigma}}{(\alpha-1 / \sigma)^{2}}\right), \tag{4.12}
\end{equation*}
$$

whence by (4.6),

$$
\begin{align*}
E\left(\rho_{2}\right) \leq & \left(\frac{\rho_{2}}{\rho_{1}}\right)^{1 / \sigma} E\left(\rho_{1}\right)+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2} \leq\left(\frac{\rho_{2}}{\rho_{1}}\right)^{1 / \sigma} \sigma \gamma_{0}\left(\delta \rho_{1}\right) \ln \left(\delta \rho_{1}\right)+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2}  \tag{4.13}\\
& =\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} \rho_{2}^{1 / \sigma}\left(\delta \rho_{1}\right)^{1-1 / \sigma} \ln \left(\delta \rho_{1}\right)+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2} .
\end{align*}
$$

Using $\rho_{2} \leq \delta \rho_{1}$ and the fact that the function $t \mapsto(\ln t) t^{1-1 / \sigma}$ is decreasing for $t \geq c_{0}$, we obtain from (4.13) that

$$
\begin{align*}
E\left(\rho_{2}\right) & \leq\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} \rho_{2}^{1 / \sigma} \cdot \rho_{2}^{1-1 / \sigma} \ln \rho_{2}+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2}  \tag{4.14}\\
& =\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} \rho_{2} \ln \rho_{2}+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2} .
\end{align*}
$$

Let $r_{1}$ denote the value of $\rho_{2} \neq 1$ for which equality holds between the right hand sides of (4.14) and (4.7) (for $s=\rho_{2}$ ). That is, $r_{1}$ satisfies the equality

$$
\begin{equation*}
\left(\sigma \gamma_{0}\right) r_{1}=\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} r_{1}+C(\alpha, \sigma) r_{1}^{\alpha} \tag{4.15}
\end{equation*}
$$

A simple computation gives

$$
\begin{equation*}
r_{1}=\left(\frac{C(\alpha, \sigma)}{\sigma \gamma_{0}\left(1-\delta^{1 / \sigma}\right)}\right)^{\frac{1}{1-\alpha}} \tag{4.16}
\end{equation*}
$$

and we may indeed assume that $r_{1}>1$ by replacing, if necessary, $C(\alpha, \sigma)$ by a larger constant. Note that

$$
\begin{equation*}
\left(\sigma \gamma_{0}\right) \rho \ln \rho>\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} \rho \ln \rho+C(\alpha, \sigma) \rho^{\alpha} \ln \rho \quad \text { for } \rho>r_{1} \tag{4.17}
\end{equation*}
$$

Next we claim that if we take in (4.7) $\widetilde{R}_{0}=\widetilde{R}_{0}(\gamma)$ satisfying

$$
\begin{equation*}
\widetilde{R}_{0} \geq \max \left\{r_{0}\left(\gamma_{0}\right), r_{1}, M\right\} \tag{4.18}
\end{equation*}
$$

then necessarily

$$
\begin{equation*}
\rho_{2}=\widetilde{R}_{0} \tag{4.19}
\end{equation*}
$$

Indeed, otherwise $\rho_{2}>\widetilde{R}_{0}$ and by (4.7) and (4.17) we must have

$$
\begin{equation*}
E\left(\rho_{2}\right)=\left(\sigma \gamma_{0}\right) \rho_{2} \ln \rho_{2}>\left(\sigma \gamma_{0}\right) \delta^{1 / \sigma} \rho_{2} \ln \rho_{2}+C(\alpha, \sigma) \rho_{2}^{\alpha} \ln \rho_{2} \tag{4.20}
\end{equation*}
$$

which contradicts the bound in (4.14).
In view of (4.19) we know that (4.11) holds for all $r \in\left[\widetilde{R}_{0}, \rho_{1}\right]$, and integration over this interval yields, as in (4.12)-(4.13),

$$
\begin{align*}
E\left(\widetilde{R}_{0}\right) & \leq \sigma \gamma_{0} \delta \rho_{1}^{1-1 / \sigma} \widetilde{R}_{0}^{1 / \sigma} \ln \left(\delta \rho_{1}\right)+C(\alpha, \sigma) \widetilde{R}_{0}^{\alpha} \ln \widetilde{R}_{0} \\
& =\sigma \gamma_{0} \delta \widetilde{R}_{0}^{\alpha}\left(\widetilde{R}_{0}^{1 / \sigma-\alpha} / \rho_{1}^{1 / \sigma-1}\right) \ln \left(\delta \rho_{1}\right)+C(\alpha, \sigma) \widetilde{R}_{0}^{\alpha} \ln \widetilde{R}_{0} \tag{4.21}
\end{align*}
$$

Let $\widetilde{R}_{1}=\widetilde{R}_{1}\left(\widetilde{R}_{0}\right)$ be determined by the equation

$$
\begin{equation*}
\widetilde{R}_{0}^{1 / \sigma-\alpha}=\widetilde{R}_{1}^{\beta(1 / \sigma-1)} / \ln \left(\widetilde{R}_{1}^{\beta}\right)\left(\leq \rho_{1}^{1 / \sigma-1} / \ln \rho_{1}\right) . \tag{4.22}
\end{equation*}
$$

It follows from (4.21) that for every $R_{1} \geq \widetilde{R}_{1}\left(\widetilde{R}_{0}\right)$, where $\widetilde{R}_{0}$ satisfies (4.18), we have (under the assumption of the Theorem, i.e., $E(R) \leq \gamma R \ln R$ for some $\left.R \geq R_{1}\right)$ :

\begin{equation*}
E\left(\widetilde{R}_{0}\right) \leq \sigma \gamma_{0} \delta \widetilde{R}_{0}^{\alpha}+C(\alpha, \sigma) \widetilde{R}_{0}^{\alpha} \ln \widetilde{R}_{0} \leq \widetilde{C} \widetilde{R}_{0}^{\alpha} \ln \widetilde{R}_{0} \tag{4.23}
\end{equation*}
$$

for some $\widetilde{C}$ (which actually depends only on $\gamma$ ).

Finally we turn to the proof of (4.1). It is clearly enough to consider $\lambda<2 K$ (where $K$ is given by Lemma 2.1). Looking for contradiction, assume that

$$
\begin{equation*}
||u(0)|-1|>\lambda . \tag{4.24}
\end{equation*}
$$

Then, by Lemma 2.1,

\begin{equation*}
||u(x)|-1|>\lambda / 2 \text { in } B_{\lambda / 2 K} . \tag{4.25}
\end{equation*}
$$

By (4.23) and (4.25) and Lemma 2.2 we obtain

\begin{equation*}
\frac{1}{4}\left(\frac{\lambda}{2}\right)^{2}\left(\frac{\lambda}{2 K}\right)^{3}\left|B_{1}\right| \leq E\left(u ; B_{\lambda / 2 K}\right) \leq E\left(u ; B_{1}\right) \leq E\left(\widetilde{R}_{0}\right) / \widetilde{R}_{0} \leq \widetilde{C} \widetilde{R}_{0}^{\alpha-1} \ln \widetilde{R}_{0} \tag{4.26}
\end{equation*}
$$

Let $T=T(\lambda, \alpha)$ be a large enough value of $\widetilde{R}_{0}$ for which (4.26) is violated, i.e.,

$$
\begin{equation*}
\frac{\lambda^{5}\left|B_{1}\right|}{128 K^{3}}>\widetilde{C} T^{\alpha-1} \ln T \tag{4.27}
\end{equation*}
$$

Therefore, taking $\widetilde{R}_{0}=\widetilde{R}_{0}(\gamma, \lambda)$ satisfying both (4.18) and $\widetilde{R}_{0} \geq T$, and then setting $R_{1}(\gamma, \lambda):=\widetilde{R}_{1}\left(\widetilde{R}_{0}\right)$ (see (4.22)), we see that (4.26), and hence also (4.24), cannot hold for $R \geq R_{1}(\gamma, \lambda)$.

Proof of Theorem 1.1. Fix any point $x \in \mathbb{R}^{3}$. For each $\lambda>0$ we may apply Theorem 4.1 on $B_{R_{n}}(x)$ for an appropriate sequence $R_{n} \rightarrow \infty$ to conclude that $|u(x)|=1$. Hence $|u| \equiv 1$ in $\mathbb{R}^{3}$ and from (1.1) we deduce that both components of $u=\left(u_{1}, u_{2}\right)$ are harmonic functions. Assuming without loss of generality that $u(0)=(1,0)$, we conclude from the maximum principle that $u_{1} \equiv 1$ and therefore $u \equiv(1,0)$ in $\mathbb{R}^{3}$.

## Appendix. Proof of Lemma 3.3

Proof. We let $\varepsilon=1 / R$ and $v(x)=u(R x)$. Then $v: S_{1} \rightarrow \mathbb{R}^{2}$ satisfies

$$
\begin{equation*}
E_{\varepsilon}^{(T)}\left(v ; S_{1}\right) \leq \gamma \ln \frac{1}{\varepsilon} \tag{A.1}
\end{equation*}
$$

Following [19], proof of Theorem 5.3, given $\delta>0$ there exists a collection of disjoint spherical discs that we denote $\mathcal{D}_{0}$ such that each disc in the family has radius bounded below by $\Lambda \varepsilon$, such that $|v|>1-\delta$ on the complement of $\mathcal{D}_{0}$ and such that, denoting by $r_{0}$ the sum of the radii of the discs, we have

$$
\begin{equation*}
r_{0} \leq C \gamma|\ln \varepsilon| \frac{\varepsilon}{\delta^{3}} . \tag{A.2}
\end{equation*}
$$

It should be noted that in contrast with the situation considered in [19], the restriction of $v$ to $S_{1}$ does not necessarily satisfy the Ginzburg-Landau equation (which would involve the Laplace-Beltrami operator on $S_{1}$ ). However, (2.2) implies that the restriction of $v$ to $S_{1}$ satisfies an estimate of the form $\|\nabla v\|_{L^{\infty}} \leq C / \varepsilon$, which is what needed to construct $\mathcal{D}_{0}$ using the method of [19]. Then we apply the ball-growth procedure as in [19, Thm 4.2]. This yields, for any $t>0$, a family of spherical discs $\mathcal{D}(t)$ which is increasing and such that the sum of the radii of the discs in $\mathcal{D}(t)$ is $e^{t} r_{0}$. Moreover, denoting

$$
\mathcal{F}(x, r)=E_{\varepsilon}^{(T)}\left(v ; \widetilde{D}_{r}(x)\right) \text { and } \mathcal{F}(\mathcal{D}(t))=\sum_{\widetilde{D}_{r}(x) \in \mathcal{D}(t)} \mathcal{F}(x, r),
$$

we deduce from [19, Proposition 4.1] and (A.1) that, for all $s>0$,

$$
\gamma|\ln \varepsilon| \geq \mathcal{F}(\mathcal{D}(s))-\mathcal{F}(\mathcal{D}(0)) \geq \int_{0}^{s} \sum_{\widetilde{D}_{r}(x) \in \mathcal{D}(t)} r \frac{\partial \mathcal{F}}{\partial r}(x, r) d t
$$

Hence, by Fubini's theorem there exists $t \in(0, s)$ such that $\mathcal{D}(t)=\left\{\widetilde{D}_{\rho_{i}}=\widetilde{D}_{\rho_{i}}\left(x_{i}\right), 1 \leq i \leq k\right\}$ satisfies

$$
\sum_{i=1}^{k} \rho_{i} \frac{\partial \mathcal{F}}{\partial r}\left(x_{i}, \rho_{i}\right) \leq \frac{\gamma|\ln \varepsilon|}{s}
$$

Choosing $s=\frac{2 \pi+\gamma}{4 \pi}|\ln \varepsilon|$, we find that,

$$
\begin{equation*}
\sum_{i=1}^{k} \rho_{i} \frac{\partial \mathcal{F}}{\partial r}\left(x_{i}, \rho_{i}\right) \leq 2 \pi\left(\frac{2 \gamma}{\gamma+2 \pi}\right) \tag{A.3}
\end{equation*}
$$

On the other hand, since $|v|>1-\delta$ on the complement of $\mathcal{D}_{0}$, we have for each $i$

$$
\frac{\partial \mathcal{F}}{\partial r}\left(x_{i}, \rho_{i}\right)=E_{\varepsilon}^{(T)}\left(v ; \partial \widetilde{D}_{\rho_{i}}\right) \geq \frac{\pi}{\sin \rho_{i}} \operatorname{deg}\left(v, \partial \widetilde{D}_{\rho_{i}}\right)^{2}(1-\delta)^{2} \geq \frac{\pi}{\rho_{i}} \operatorname{deg}\left(v, \partial \widetilde{D}_{\rho_{i}}\right)^{2}(1-\delta)^{2},
$$

where we used the fact that the Euclidean radius of the circle $\partial \widetilde{D}_{\rho_{i}}$ is $\sin \rho_{i}$. Substituting in (A.3) yields

$$
\begin{equation*}
\sum_{i=1}^{k} \operatorname{deg}\left(v, \partial \widetilde{D}_{\rho_{i}}\right)^{2} \leq \frac{2}{(1-\delta)^{2}} \cdot \frac{2 \gamma}{\gamma+2 \pi}<2 \tag{A.4}
\end{equation*}
$$

the last inequality on the R.H.S. of (A.4) holds for $\delta>0$ small enough, $\delta<\delta_{0}(\gamma)$. We thus fix any $\delta \in\left(0, \min \left(1 / 8, \delta_{0}(\gamma)\right)\right)$. Since $\sum_{i=1}^{k} \operatorname{deg}\left(v, \partial \widetilde{D}_{\rho_{i}}\right)=0$, it follows from (A.4) that $\operatorname{deg}\left(v, \partial \widetilde{D}_{\rho_{i}}\right)=0$ for all $i$. Indeed, otherwise we would have at least two nonzero degrees, clearly violating (A.4).

Now the sum of the radii of the discs in $\left\{\widetilde{D}_{\rho_{i}}\right\}_{i=1}^{k}$ is $r=e^{t} r_{0}$ hence bounded by $e^{s} r_{0}$. Using (A.2) we conclude that for some $C>0$ depending on $\gamma$,

$$
r \leq C|\ln \varepsilon| \varepsilon \times \varepsilon^{-\frac{2 \pi+\gamma}{4 \pi}}=C|\ln \varepsilon| \varepsilon^{\frac{2 \pi-\gamma}{4 \pi}} \leq \varepsilon^{\tilde{\alpha}}
$$

for every small enough $\varepsilon$, provided $0<\tilde{\alpha}<\frac{2 \pi-\gamma}{4 \pi}$. We fix such a value of $\tilde{\alpha}$.
The family of spherical discs $\left\{\widetilde{D}_{\rho_{i}}\right\}_{i=1}^{k}$ is therefore such that $|v|>1 / 2$ outside the discs, their total radius is less than $\varepsilon^{\tilde{\alpha}}$, the winding number of $v$ on the boundary of each disc is zero, and such that for each $1 \leq i \leq k$ we have using (A.3) that

$$
E_{\varepsilon}^{(T)}\left(v ; \partial \tilde{D}_{\rho_{i}}\right) \leq \frac{2 \pi}{\rho_{i}} \frac{2 \gamma}{\gamma+2 \pi}<\frac{2 \pi}{\rho_{i}}
$$

Rescaling back, we see easily that the spherical discs on $S_{R}, \widetilde{D}_{r_{i}}^{R}\left(R x_{i}\right):=R \widetilde{D}_{\rho_{i}}, i=$ $1, \ldots, k$, satisfy all the assertions (3.32)-(3.36) of Lemma 3.3 with $\alpha=1-\tilde{\alpha}$.
