# Global classical solutions, stability of constant equilibria, and spreading speeds in attraction-repulsion chemotaxis systems with logistic source on $\mathbb{R}^{N}$

#### Abstract

In this paper, we consider the following chemotaxis systems of parabolic-elliptic-elliptic type on $\mathbb{R}^{N}$, $$
\begin{cases}u_{t}=\Delta u-\chi_{1} \nabla\left(u \nabla v_{1}\right)+\chi_{2} \nabla\left(u \nabla v_{2}\right)+u(a-b u), \quad x \in \mathbb{R}^{N}, t>0 \\ 0=\left(\Delta-\lambda_{1} I\right) v_{1}+\mu_{1} u, & x \in \mathbb{R}^{N}, t>0 \\ 0=\left(\Delta-\lambda_{2} I\right) v_{2}+\mu_{2} u, & x \in \mathbb{R}^{N}, t>0 \\ u(\cdot, 0)=u_{0}, \quad x \in \mathbb{R}^{N}, & \end{cases}
$$


where $\chi_{i} \geq 0, \lambda_{i}>0, \mu_{i}>0(i=1,2)$ and $a>0, b>0$ are constant real numbers, and $N$ is a positive integer. First, under some conditions on the parameters $\chi_{i}, \mu_{i}, \lambda_{i}, a, b$ and $N$, we prove the global existence and boundedness of classical solutions $\left(u\left(x, t ; u_{0}\right), v_{1}\left(x, t ; u_{0}\right), v_{2}\left(x, t ; u_{0}\right)\right)$ for nonnegative, bounded, and uniformly continuous initial functions $u_{0}(x)$. Next, we explore the asymptotic stability of the constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ and prove under some further assumption on the parameters that, for every strictly positive initial $u_{0}(x)$,

Finally, we investigate the spreading properties of the global solutions with compactly supported initial functions. We show that under some conditions on the parameters, there are two positive numbers $0<c_{-}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right) \leq c_{+}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$ such that for every nonnegative initial function $u_{0}(x)$ with nonempty and compact support, we have

whenever $0 \leq c<c_{-}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$, and

\lim _{t \rightarrow \infty}\left[\sup _{|x| \geq c t}\left|u\left(x, t ; u_{0}\right)\right|+\sup _{|x| \geq c t}\left|v_{1}\left(x, t ; u_{0}\right)\right|+\sup _{|x| \geq c t}\left|v_{2}\left(x, t ; u_{0}\right)\right|\right]=0
$$

whenever $c>c_{+}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$. Furthermore we show that

## 1 Introduction and the Statement of the Main Results

Chemotaxis describes the oriented movement of biological cells or organism in response to chemical gradients. The oriented movement of cells has a crucial role in a wide range of biological phenomena. At the beginning of 1970s, Keller and Segel (see [24, [25]) introduced systems of partial differential equations of the following form to model the time evolution of both the density $u(x, t)$ of a mobile species and the density $v(x, t)$ of a chemoattractant,

complemented with certain boundary condition on $\partial \Omega$ if $\Omega$ is bounded, where $\Omega \subset \mathbb{R}^{N}$ is an open domain; $\tau \geq 0$ is a non-negative constant linked to the speed of diffusion of the chemical; the function $\chi(u, v)$ represents the sensitivity with respect to chemotaxis; and the functions $f$ and $g$ model the growth of the mobile species and the chemoattractant, respectively. In literature, (1.1) is called the Keller-Segel (KS) model or a chemotaxis model.

Since the works by Keller and Segel, a rich variety of mathematical models for studying chemotaxis has appeared (see [1, [6], 7], [14, [18], [19, [23], 34], [42], [43, [44, [47, [50], [51], [52], [53, [54, [55], [58], and the references therein). The reader is referred to [17, 20] for some detailed introduction into the mathematics of KS models. In the current paper, we consider chemoattraction-repulsion process in which cells undergo random motion and chemotaxis towards attractant and away from repellent [32]. Moreover, we consider the model with proliferation and death of cells and assume that chemicals diffuse very quickly. These lead to the model of partial differential equations as follows:

complemented with certain boundary condition on $\partial \Omega$ if $\Omega$ is bounded.
When $\Omega$ is a smooth bounded domain, it is seen that (1.2) complemented with Neumann boundary conditions

has a unique nonzero constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$. The global existence of classical solutions and the stability of the above equilibrium solution of (1.2) + (1.3) are among central dynamical issues. They have been studied in many papers (see [8, 21, 22, 28, 30, 56, 31, 32, 45, 46, 57] and the references therein). For example, in [56], amount others, the authors proved that

- If $b>\chi_{1} \mu_{1}-\chi_{2} \mu_{2}$, or $N \leq 2$, or $\frac{N-2}{N}\left(\chi_{1} \mu_{1}-\chi_{2} \mu_{2}\right)<b$ and $N \geq 3$, then for every nonnegative initial $u_{0} \in C^{0}(\bar{\Omega}),(1.2)+(1.3)$ has a unique global classical solution $\left(u(\cdot, \cdot), v_{1}(\cdot, \cdot), v_{2}(\cdot, \cdot)\right)$ which is uniformly bounded.
- If $a=b>2 \chi_{1} \mu_{1}$, then for every nonnegative initial $u_{0} \in C^{0}(\bar{\Omega}), u_{0} \neq 0$, the global classical solution $\left(u(\cdot, \cdot), v_{1}(\cdot, \cdot), v_{2}(\cdot, \cdot)\right)$ of (1.2) $+(1.3)$ satisfies

While attraction-repulsion chemotaxis systems on bounded domains have been studied in many papers, there is little study of such systems on unbounded domains. The objective of this paper is to study the dynamics of (1.2) with $\Omega=\mathbb{R}^{N}$, that is,

\begin{cases}u_{t}=\Delta u-\chi_{1} \nabla\left(u \nabla v_{1}\right)+\chi_{2} \nabla\left(u \nabla v_{2}\right)+u(a-b u), \quad x \in \mathbb{R}^{N}, t>0,  \tag{1.4}\\ 0=\left(\Delta-\lambda_{1} I\right) v_{1}+\mu_{1} u, & x \in \mathbb{R}^{N}, t>0, \\ 0=\left(\Delta-\lambda_{2} I\right) v_{2}+\mu_{2} u, & x \in \mathbb{R}^{N}, t>0, \\ u(\cdot, 0)=u_{0}, \quad x \in \mathbb{R}^{N} . & \end{cases}
$$

In the case that the chemorepellent is absent, that is, $\chi_{2}=0$, the authors of the current paper studied in [37] the global existence of classical solutions and asymptotic behavior of bounded global classical solutions of (1.4). In the current paper, we investigate the global existence of classical solutions, stability of constant equilibria, and spreading speeds of (1.4) when both chemoattractant and chemorepellent are present. More precisely, we identify the circumstances under which positive classical solutions of (1.4) with nonnegative, bounded, and uniformly continuous initial functions exist globally; investigate the asymptotic stability of the nonzero constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$; and explore the spreading properties of the global solutions with compactly supported initial functions. We pay special attention to the combined effect of the chemoattractant and chemorepellent on the above dynamical issues.

Note that, due to biological interpretations, only nonnegative initial functions will be of interest. We call $\left(u(x, t), v_{1}(x, t), v_{2}(x, t)\right)$ a classical solution of (1.4) on $[0, T)$ if $u, v_{1}, v_{2} \in$ $C\left(\mathbb{R}^{N} \times[0, T)\right) \cap C^{2,1}\left(\mathbb{R}^{N} \times(0, T)\right)$ and satisfies (1.4) for $(x, t) \in \mathbb{R}^{N} \times(0, T)$ in the classical sense. A classical solution $\left(u(x, t), v_{1}(x, t), v_{2}(x, t)\right)$ of (1.4) on $[0, T)$ is called nonnegative if $u(x, t) \geq 0$, $v_{1}(x, t) \geq 0$ and $v_{2}(x, t) \geq 0$ for all $(x, t) \in \mathbb{R}^{N} \times[0, T)$. A global classical solution of (1.4) is a classical solution on $[0, \infty)$.
Let

C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right)=\left\{u \in C\left(\mathbb{R}^{N}\right) \mid u(x) \text { is uniformly continuous in } x \in \mathbb{R}^{N} \text { and } \sup _{x \in \mathbb{R}^{N}}|u(x)|<\infty\right\} \tag{1.5}
\end{equation*}
$$ equipped with the norm $\|u\|_{\infty}=\sup _{x \in \mathbb{R}^{N}}|u(x)|$. We have the following result on the global existence of classical solutions of (1.4) for initial functions belonging to $C_{\mathrm{unif}}^{b}\left(\mathbb{R}^{N}\right)$.

Theorem A. Suppose that

Then for every nonnegative initial function $u_{0} \in C_{\mathrm{unif}}^{b}\left(\mathbb{R}^{N}\right)$, (1.4) has a unique nonnegative global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$ with $u\left(\cdot, 0 ; u_{0}\right)=u_{0}$. Furthermore, it holds that

\left\|u\left(\cdot, t ; u_{0}\right)\right\|_{\infty} \leq \begin{cases}\left\|u_{0}\right\|_{\infty} & \text { if (1.6) holds }  \tag{1.9}\\ \max \left\{\left\|u_{0}\right\|_{\infty}, \frac{a}{b+\chi_{2} \mu_{2}-\chi_{1} \mu_{1}-M}\right\} & \text { if (1.7) holds } .\end{cases}

Remark 1.1. $M \leq \chi_{2} \mu_{2}$. (1.6) and (1.7) provide explicit conditions for the global existence of classical solutions. The following special and important conditions follow from (1.7).
(i) If $b>\chi_{1} \mu_{1}$, (1.4) always has global bounded classical solution for any initial $u_{0} \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right)$ with $u_{0} \geq 0$.
(ii) If $\lambda_{1} \leq \lambda_{2}$ and $\chi_{2} \mu_{2} \lambda_{2} \geq \chi_{1} \mu_{1} \lambda_{1}$, we have that $M=\chi_{2} \mu_{2}-\frac{\lambda_{1}}{\lambda_{2}} \chi_{1} \mu_{1}$. In this case, it follows from Theorem $A$ that for every nonnegative bounded and uniformly continuous initial data $u_{0}$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$, whenever $b>\chi_{1} \mu_{1}\left(1-\frac{\lambda_{1}}{\lambda_{2}}\right)$. Thus, in the absence of chemoattractant, i.e $\chi_{1}=0$, for every nonnegative bounded and uniformly continuous initial data $u_{0}$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$, whenever $b>0$.
(iii) If $\lambda_{1} \leq \lambda_{2}$ and $\chi_{2} \mu_{2} \lambda_{2} \leq \chi_{1} \mu_{1} \lambda_{1}$, we have that $M=0$. In this case, it follows from Theorem A that for every nonnegative bounded and uniformly continuous initial data $u_{0}$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$, whenever $b>$ $\chi_{1} \mu_{1}-\chi_{2} \mu_{2}$.
(iv) We note that if $\lambda_{1} \geq \lambda_{2}$ and $\chi_{2} \mu_{2} \lambda_{2} \geq \chi_{1} \mu_{1} \lambda_{1}$, then $M=\chi_{2} \mu_{2}-\chi_{1} \mu_{1}$. Thus, if $\lambda_{1} \geq \lambda_{2}$ and $\chi_{2} \mu_{2} \lambda_{2} \geq \chi_{1} \mu_{1} \lambda_{1}$, it follows from Theorem $A$ that for every $b>0$ and for every nonnegative bounded and uniformly continuous initial data $u_{0}$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$.
(v) If $\lambda_{1} \geq \lambda_{2}$ and $\chi_{2} \mu_{2} \lambda_{2} \leq \chi_{1} \mu_{1} \lambda_{1}$, we have that $M=\frac{\left(\lambda_{1}-\lambda_{2}\right) \chi_{2} \mu_{2}}{\lambda_{1}}$. In this case, it follows from Theorem $A$ that for every nonnegative bounded and uniformly continuous initial data $u_{0}$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$, whenever $b>\chi_{1} \mu_{1}-\frac{\lambda_{2}}{\lambda_{1}} \chi_{2} \mu_{2}$.

It follows from Remark 1.1 (iii)\&(v), that when $\chi_{2}=0$, we recover as a special case Theorem 1.5 in [37] for the case $b>\chi_{1}$ and $\mu_{1}=1$. When (1.7) does not hold, we leave it open whether for any nonnegative initial function $u_{0} \in C_{\mathrm{unif}}^{b}\left(\mathbb{R}^{N}\right)$ global solution to (1.4) exists.

Theorem A is fundamental. Assume the conditions in Theorem A. Then (1.4) generates a dynamical system on the infinite dimensional space $X^{+}=\left\{u \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right) \mid u \geq 0\right\}$. Methods and theorems for general infinite dimensional dynamical systems in literature (e.g. [15, [39]) may then be utilized for the further study of many important dynamical aspects, including the long time behavior of bounded solutions, stability of certain special solutions, existence of global attractor, etc. In the following, we explore the stability of the nonzero constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$.

We first study the stability of $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ with respect to strictly positive initial functions. From now on, we shall always suppose that $a>0$, unless otherwise specified. We prove
Theorem B. Suppose that

& \left.\frac{1}{\lambda_{1}}\left(\left|\chi_{1} \mu_{1} \lambda_{1}-\chi_{2} \mu_{2} \lambda_{2}\right|+\chi_{2} \mu_{2}\left|\lambda_{1}-\lambda_{2}\right|\right)\right\} . \tag{1.11}

Then for every initial function $u_{0} \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right)$ with $\inf _{x \in \mathbb{R}^{N}} u_{0}(x)>0$, (1.4) has a unique bounded global classical solution $\left(u\left(\cdot, \cdot ; u_{0}\right), v_{1}\left(\cdot, \cdot ; u_{0}\right), v_{2}\left(\cdot, \cdot ; u_{0}\right)\right)$ with $u\left(\cdot, 0 ; u_{0}\right)=u_{0}$. Furthermore we have that

\lim _{t \rightarrow \infty}\left\|u\left(\cdot, t ; u_{0}\right)-\frac{a}{b}\right\|_{\infty}=0 \tag{1.12}
\end{equation*}

and

Remark 1.2. (1) (1.10) provides explicit conditions for the global stability of the constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ with respect to strictly positive initial functions. We point out the following special and important equivalent conditions of (1.10).
(i) If $\lambda_{1} \leq \lambda_{2}$, and $\chi_{2} \mu_{2} \lambda_{2} \geq \chi_{1} \mu_{1} \lambda_{1}$, then (1.10) holds if and only if $b>2 \chi_{1} \mu_{1}-2 \frac{\lambda_{1}}{\lambda_{2}} \chi_{1} \mu_{1}$.
(ii) If $\lambda_{1} \leq \lambda_{2}$, and $\chi_{2} \mu_{2} \lambda_{2} \leq \chi_{1} \mu_{1} \lambda_{1}$, then (1.10) holds if and only if $b>2 \chi_{1} \mu_{1}-2 \chi_{2} \mu_{2}$ ).
(iii) If $\lambda_{1} \geq \lambda_{2}$, and $\chi_{2} \mu_{2} \lambda_{2} \geq \chi_{1} \mu_{1} \lambda_{1}$, then (1.10) holds if and only if $b>0$.
(iv) If $\lambda_{1} \geq \lambda_{2}$, and $\chi_{1} \mu_{1} \lambda_{1} \geq \chi_{2} \mu_{2} \lambda_{2}$, then (1.10) holds if and only if $b>2 \chi_{1} \mu_{1}-2 \frac{\lambda_{2}}{\lambda_{1}} \chi_{2} \mu_{2}$.
(2) $B y$ (i)-(iv), if $b>2 \chi_{1} \mu_{1}$, then (1.10) holds. Hence the hypothesis (1.10) is weaker than the known result on bounded domain.
(3) If $\chi_{2}=0$, then (ii) and (iv) extend [37, Theorem 1.7].
(4) By (i) and (iii), if $\chi_{1}=0$, then the constant solution $\frac{a}{b}$ is stable with respect to strictly positive perturbation whenever $b>0$.
(5) It is interesting to know whether hypothesis (1.7) is enough to have the stability of the constant steady solution ( $\frac{a}{b}, \frac{a \mu_{1}}{b \lambda_{1}}, \frac{a \mu_{2}}{b \lambda_{2}}$ ) with respect to strictly positive perturbation. We plan to study this question in our future work.

Next, we study the attraction of $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ with respect to global classical solutions of (1.4) with compactly supported initial functions, or equivalently, the spreading properties of global classical solutions of (1.4) with compactly supported initial functions. For $x=\left(x_{1}, x_{2}, \cdots, x_{N}\right) \in$ $\mathbb{R}^{N}$, let $|x|=\left(\sum_{i=1}^{N} x_{i}^{2}\right)^{\frac{1}{2}}$. We obtain the following main results.

which is referred to as Fisher or KPP equations due to the pioneering works by Fisher ( 9 ) and Kolmogorov, Petrowsky, Piscunov ([26) on the spreading properties of (1.20). It follows from the works [9], [26, and [48] that $c_{-}^{*}$ and $c_{+}^{*}$ in Theorem C and Theorem D, respectively, can be chosen so that $c_{-}^{*}=c_{+}^{*}=2 \sqrt{a}\left(c^{*}:=2 \sqrt{a}\right.$ is called the spatial spreading speed of (1.20) in literature), and that (1.20) has traveling wave solutions $u(t, x)=\phi(x-c t)$ connecting $\frac{a}{b}$ and 0 (i.e. $\left(\phi(-\infty)=\frac{a}{b}, \phi(\infty)=0\right)$ ) for all speeds $c \geq c^{*}$ and has no such traveling wave solutions of slower speed. Since the pioneering works by Fisher [9] and Kolmogorov, Petrowsky, Piscunov
[26], a huge amount research has been carried out toward the spreading properties of reaction diffusion equations of the form,

It is interesting to know the relationship between $c_{u p}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$ and $2 \sqrt{a}$ as well as the relationship between $c_{\text {low }}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$ and $2 \sqrt{a}$. It is also interesting to know whether $c_{\text {low }}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)=c_{u p}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)$. We plan to study these questions in our future works.
(iii) When $\chi_{2}=0, \lambda_{1}=\mu_{1}=1$, and $0<\chi_{1}<\frac{b}{2}$, in a very recent work [38] it was shown that there is a positive constant $c^{*}\left(\chi_{1}\right) \geq 2 \sqrt{a}$ such that for every $c \geq c^{*}\left(\chi_{1}\right)$ and $\xi \in S^{N-1}$, (1.4) has a traveling wave solution $(u(x, t), v(x, t))=(u(x \cdot \xi-c t), v(x \cdot \xi-c t))$ connecting the trivial solutions $\left(\frac{a}{b}, \frac{a}{b}\right)$ and $(0,0)$ and propagating in the direction of $\xi$ with speed $c$, and no such traveling wave solution exists for speed less than $2 \sqrt{a}$. We plan to study these questions for (1.4) when both $\chi_{1}>0$ and $\chi_{2}>0$.

We end up the introduction with the following remarks. First, our study is based on many techniques developed in (37]. But, to apply these techniques to (1.4) with non-zeros $\chi_{1}$ and $\chi_{2}$, nontrivial modifications are needed and made in the current paper. The modified techniques would be useful for the further study of attraction-repulsion chemotaxis systems. Second, most results obtained in [37] for the special case $\chi_{2}=0$ are recovered and extended further in the current paper. Third, conditions explicitly depending on the sensitivity parameters $\chi_{1}$ and $\chi_{2}$ of the chemoattractant and chemorepellent are provided in the current paper for the global existence of classical solutions of (1.4) and stability of the nonzero constant equilibrium ( $\left.\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$, and lower and upper bounds explicitly depending on $\chi_{1}$ and $\chi_{2}$ are established for the spreading speeds of positive solutions with compactly supported initial distributions. These conditions and lower and upper bounds would be of great practical importance.

The rest of the paper is organized as follows. Section 2 is devoted to the study of global existence of classical solutions. It is here that we prove Theorem A. In section 3, we study the asymptotic stability of the constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ and prove Theorem B. We study the spreading properties of global classical solutions of (1.4) with compactly supported initial functions and prove Theorems C and D in section 4.

## 2 Global Existence

In this section, we discuss the existence of global/bounded classical solutions and prove Theorem A. We start with the following result which guarantees the existence of a unique local in time classical solution of (1.4) for any nonnegative bounded and uniformly continuous initial data.

Lemma 2.1. For any $u_{0} \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right)$ with $u_{0} \geq 0$, there exists $T_{\max } \in(0, \infty]$ such that (1.4) has a unique non-negative classical solution $\left(u\left(x, t ; u_{0}\right), v_{1}\left(x, t ; u_{0}\right), v_{2}\left(x, t, u_{0}\right)\right)$ on $\left[0, T_{\max }\right)$ with $\lim _{t \rightarrow 0} u\left(\cdot, t ; u_{0}\right)=u_{0}$ in $C_{\text {uinf }}^{b}\left(\mathbb{R}^{N}\right)$-norm. Moreover, if $T_{\max }<\infty$, then

## 3 Asymptotic stability of the constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$

In this section, we discuss the asymptotic stability of the constant equilibrium $\left(\frac{a}{b}, \frac{\mu_{1}}{\lambda_{1}} \frac{a}{b}, \frac{\mu_{2}}{\lambda_{2}} \frac{a}{b}\right)$ of (1.4) and prove Theorem B. Throughout this section we suppose that (1.7) holds, so that for
every nonnegative, bounded, and uniformly continuous initial function $u_{0}$, (1.4) has a nonnegative bounded global classical solution $\left(u\left(x, t ; u_{0}\right), v_{1}\left(x, t ; u_{0}\right), v_{2}\left(x, t ; u_{0}\right)\right)$.

For given $u_{0} \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right)$ with $u_{0} \geq 0$, define

## 4 Spreading properties of classical solutions

In this section we study how fast the mobiles species spread over time and prove Theorems C and D. Throughout this section, we always suppose that $u_{0} \in C_{\text {unif }}^{b}\left(\mathbb{R}^{N}\right), u_{0}(x) \geq 0$ has compact and nonempty support. The next three lemmas will be useful in the subsequent.

Using the facts that $\sup _{t \geq 0}\|u(\cdot, t)\|_{\infty}<\infty, t_{n} \rightarrow \infty$ as $n \rightarrow \infty, \int_{0}^{\infty} e^{-\tau} \tau^{-\frac{1}{2}-\alpha} d \tau=\Gamma\left(\frac{1}{2}-\alpha\right)<\infty$ and $\int_{0}^{\infty} e^{-\tau} \tau^{-\alpha} d \tau=\Gamma(1-\alpha)<\infty$, it follows from (4.26) that

Similar arguments as those used in the proof of Theorem 1.1 [37] yield that the functions $u_{n}:[-T, T] \rightarrow X^{\alpha}$ are equicontinuous for every $T>0$. Hence Arzela-Ascili's Theorem and Theorem 15 (page 80 of [12]) imply that there is a function $\left(\tilde{u}, \tilde{v}_{1}, \tilde{v}_{2}\right) \in\left[C^{2,1}\left(\mathbb{R}^{N} \times \mathbb{R}\right)\right]^{3}$ and a subsequence $\left\{\left(u_{n^{\prime}}, v_{1, n^{\prime}}, v_{2, n^{\prime}}\right)\right\}_{n \geq 1}$ of $\left\{\left(u_{n}, v_{1, n}, v_{2, n}\right)\right\}_{n \geq 1}$ such that $\left(u_{n^{\prime}}, v_{1, n^{\prime}}, v_{2, n^{\prime}}\right) \rightarrow\left(\tilde{u}, \tilde{v}_{1}, \tilde{v}_{2}\right)$ in $C_{l o c}^{1+\delta^{\prime}, \delta^{\prime}}\left(\mathbb{R}^{N} \times \mathbb{R}\right)$ for some $\delta^{\prime}>0$. Moreover $\mu_{i} \tilde{u}=\left(\lambda_{i} I-\Delta\right) \tilde{v}_{i}$ for every $i=1,2$. Note that

\tilde{u}(x, t)=\lim _{n \rightarrow \infty} u\left(x+x_{n^{\prime}}, t+t_{n^{\prime}} ; u_{0}\right), \quad \forall x \in \mathbb{R}^{N}, \quad t \in \mathbb{R}

Choose $\tilde{c} \in\left(c, c_{-}^{*}\left(\chi_{1}, \mu_{1}, \lambda_{1}, \chi_{2}, \mu_{2}, \lambda_{2}\right)\right)$. For every $x \in \mathbb{R}^{N}, t \in \mathbb{R}$ and $t_{n^{\prime}} \geq \frac{|x|+\tilde{c}|t|}{\tilde{c}-c}$, we have

\left|x+x_{n^{\prime}}\right| \leq|x|+c t_{n^{\prime}} \leq \tilde{c}\left(t_{n^{\prime}}+t\right)

It follows from last inequality and (4.20) that

Hence $\inf _{(x, t) \in \mathbb{R}^{N+1}} \tilde{u}(x, t)>0$.
Next, we claim that $\tilde{u}(x, t)=\frac{a}{b}$ for every $x \in \mathbb{R}^{N}, t \in \mathbb{R}$. Indeed, let $\underline{u}_{0}=\inf _{(x, t) \in \mathbb{R}^{N+1}} \tilde{u}(x, t)$ and $\bar{u}_{0}(x, t)=\sup _{(x, t) \in \mathbb{R}^{N+1}} \tilde{u}(x, t)$. For every $t_{0} \in \mathbb{R}$, let $\bar{U}\left(t, t_{0}\right)$ and $\underline{U}\left(t, t_{0}\right)$ be the solution of the ODEs

It follows from inequalities (4.35) and (4.36) that

\left(b+\chi_{2} \mu_{2}-\chi_{1} \mu_{1}-K\right)\left(\bar{u}_{0}-\underline{u}_{0}\right) \leq 0 . \tag{4.37}
\end{equation*}
$$

Since (1.10) holds, it follows from the last inequality that $\bar{u}_{0}=\underline{u}_{0}$. Combining this with inequalities (4.33) and (4.34) we obtain that $\bar{u}_{0}=\underline{u}_{0}=\frac{a}{b}$. Hence, we have that $\tilde{u}(x, t)=\frac{a}{b}$ for every $x \in \mathbb{R}^{N}$ and $t \in \mathbb{R}$. In particular, we have that $\tilde{u}(0,0)=\frac{a}{b}$, which contradicts (4.28).

Hence the claim is true and Theorem D is thus proved.
