# VARIATIONS ON A PROOF OF A BORDERLINE BOURGAIN-BREZIS SOBOLEV EMBEDDING THEOREM

#### Abstract

We offer a variant of a proof of a borderline BourgainBrezis Sobolev embedding theorem on $\mathbb{R}^{n}$. We use this idea to extend the result to real hyperbolic spaces $\mathbb{H}^{n}$.


## 1. Introduction

The Sobolev embedding theorem states that if $\dot{W}^{1, p}\left(\mathbb{R}^{n}\right)$ is the homogeneous Sobolev space, obtained by completing the set of compactly supported smooth functions $C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ under the norm $\|\nabla u\|_{L^{p}\left(\mathbb{R}^{n}\right)}$, then $\dot{W}^{1, p}\left(\mathbb{R}^{n}\right)$ embeds into $L^{p^{*}}\left(\mathbb{R}^{n}\right)$, whenever $n \geq 2,1 \leq p<n$ and $\frac{1}{p^{*}}=\frac{1}{p}-\frac{1}{n}$. This fails when $p=n$, i.e. $\dot{W}^{1, n}\left(\mathbb{R}^{\bar{n}}\right)$ does not embed into $L^{\infty}\left(\mathbb{R}^{n}\right)$. One of the well-known remedies of this failure is to say that $\dot{W}^{1, n}\left(\mathbb{R}^{n}\right)$ embeds into $\operatorname{BMO}\left(\mathbb{R}^{n}\right)$, the space of functions of bounded mean oscillation. In [2, 4], Bourgain and Brezis established another remedy of the failure of this Sobolev embedding for $\dot{W}^{1, n}\left(\mathbb{R}^{n}\right)$. They proved, among other things, that if $X$ is a differential $\ell$-form on $\mathbb{R}^{n}$ with $\dot{W}^{1, n}\left(\mathbb{R}^{n}\right)$ coefficients, where $1 \leq \ell \leq n-1$, then there exists a differential $\ell$-form $Y$, whose components are all in $\dot{W}^{1, n} \cap L^{\infty}\left(\mathbb{R}^{n}\right)$, such that

$$
d Y=d X
$$

with

$$
\|Y\|_{\dot{W}^{1, n} \cap L^{\infty}} \leq C\|d X\|_{L^{n}} .
$$

(Such a theorem would have been trivial by Hodge decomposition, if $\dot{W}^{1, n}\left(\mathbb{R}^{n}\right)$ were to embed into $L^{\infty}\left(\mathbb{R}^{n}\right)$.) The existing proofs of the above theorem are all long and complicated. On the contrary, a weaker version of this theorem, where one replaces the space $\dot{W}^{1, n} \cap L^{\infty}$ by $L^{\infty}$, can be obtained from the following theorem of Van Schaftingen [9], when $\ell \leq n-2$ :

Theorem 1 (Van Schaftingen [9]). Suppose $f$ is a smooth vector field on $\mathbb{R}^{n}$, with

$$
\operatorname{div} f=0 .
$$

Then for any compactly supported smooth vector field $\phi$ on $\mathbb{R}^{n}$, we have

$$
\begin{equation*}
\left|\int_{\mathbb{R}^{n}}\langle f, \phi\rangle\right| \leq C\|f\|_{L^{1}}\|\nabla \phi\|_{L^{n}} \tag{1}
\end{equation*}
$$

where $\langle\cdot, \cdot\rangle$ is the pointwise Euclidean inner product of two vector fields in $\mathbb{R}^{n}$.

See e.g. Bourgain and Brezis [4], Lanzani and Stein [6]. We refer the interested reader to the survey in [10], for a more detailed account of this circle of ideas.

The original direct proof of Theorem [1 in [9] proceeds by decomposing

$$
\int_{\mathbb{R}^{n}}\langle f, \phi\rangle=\sum_{i=1}^{m} \int_{\mathbb{R}}\left(\int_{\mathbb{R}^{i-1} \times\{s\} \times \mathbb{R}^{n-i}} f_{i} \phi_{i}\right) \mathrm{d} s,
$$

and by estimating first directly the innermost $(n-1)$-dimensional integral. This gives the impression that the strategy is quite rigid. The first goal of this note is to prove Theorem 1 by averaging a suitable estimate over all unit spheres in $\mathbb{R}^{n}$.

In a second part of this paper, we adapt this idea of averaging over families of sets to prove an analogue of Theorem[1, in the setting where $\mathbb{R}^{n}$ is replaced by the real hyperbolic space $\mathbb{H}^{n}$ :

Theorem 2. Suppose $f$ is a smooth vector field on $\mathbb{H}^{n}$, with

$$
\operatorname{div}_{g} f=0
$$

where $\operatorname{div}_{g}$ is the divergence with respect to the metric $g$ on $\mathbb{H}^{n}$. Then for any compactly supported smooth vector field $\phi$ on $\mathbb{H}^{n}$, we have

$$
\begin{equation*}
\left|\int_{\mathbb{H}^{n}}\langle f, \phi\rangle_{g} \mathrm{~d} V_{g}\right| \leq C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)} . \tag{2}
\end{equation*}
$$

where $\langle\cdot, \cdot\rangle_{g}$ and $\mathrm{d} V_{g}$ are the pointwise inner product and the volume measure with respect to $g$ respectively, $\nabla_{g} \phi$ is the $(1,1)$ tensor given by the Levi-Civita connection of $\phi$ with respect to $g$, and

$$
\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}=\int_{\mathbb{H}^{n}}|f|_{g} \mathrm{~d} V_{g}, \quad\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}=\left(\int_{\mathbb{H}^{n}}\left|\nabla_{g} \phi\right|_{g}^{n} \mathrm{~d} V_{g}\right)^{1 / n}
$$

We note that the above theorem is formulated entirely geometrically on $\mathbb{H}^{n}$, without the need of specifying a choice of coordinate chart. As explained in Appendix A, Theorem 2 can be proved indirectly by
patching together known estimates on $\mathbb{R}^{n}$ via a partition of unity, and by applying Hardy's inequality to get rid of lower order terms.

We shall prove Theorem 2 by averaging a suitable estimate over a family of hypersurfaces in $\mathbb{H}^{n}$, where the family of hypersurfaces is obtained from the orbit of a "vertical hyperplane" under all isometries in $\mathbb{H}^{n}$. The latter shares a similar flavour to the proof we will give below of Theorem [1. The main innovation there is in deducing Theorem 2 from Proposition 6, and in establishing Lemma [10(see Section 3 for details).

## 2. Another proof of Theorem 1

Theorem 11 will follow from the following Proposition:
Proposition 3. Let $f, \phi$ be as in Theorem 1. Write $\mathbb{B}^{n}$ for the unit ball $\left\{x \in \mathbb{R}^{n}:|x|<1\right\}$ in $\mathbb{R}^{n}$, and $\mathbb{S}^{n-1}$ for the unit sphere (i.e. the boundary of $\mathbb{B}^{n}$ ). Also write $\mathrm{d} \sigma$ for the standard surface measure on $\mathbb{S}^{n-1}$, and $\nu$ for the outward unit normal to the sphere $\mathbb{S}^{n-1}$. Then

$$
\begin{equation*}
\left|\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle\langle\phi, \nu\rangle \mathrm{d} \sigma\right| \leq C\|f\|_{L^{1}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)}^{\frac{1}{n}}\|f\|_{L^{1}\left(\mathbb{S}^{n-1}\right)}^{1-\frac{1}{n}}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)} . \tag{3}
\end{equation*}
$$

Here $\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}=\|\phi\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}+\left\|\nabla_{\mathbb{S}^{n-1}} \phi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}$, where $\nabla_{\mathbb{S}^{n-1}} \phi$ is the $(1,1)$ tensor on $\mathbb{S}^{n-1}$ given by the covariant derivative of the vector field $\phi$.

The proof of Proposition 3 in turn depends on the following two lemmas. The first one is a simple lemma about integration by parts:

Lemma 4. Let $f, \nu$ be as in Proposition 3. Then for any compactly supported smooth function $\psi$ on $\mathbb{R}^{n}$, we have

$$
\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle \psi \mathrm{d} \sigma=-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\langle f, \nabla \psi\rangle \mathrm{d} x .
$$

The second one is a decomposition lemma for functions on the sphere $\mathbb{S}^{n-1}$ :

Lemma 5. Let $\varphi$ be a smooth function on $\mathbb{S}^{n-1}$. For any $\lambda>0$, there exists a decomposition

$$
\varphi=\varphi_{1}+\varphi_{2} \quad \text { on } \mathbb{S}^{n-1}
$$

and an extension $\tilde{\varphi}_{2}$ of $\varphi_{2}$ to $\mathbb{R}^{n} \backslash \mathbb{B}^{n}$, such that $\tilde{\varphi}_{2}$ is smooth and bounded on $\mathbb{R}^{n} \backslash \mathbb{B}^{n}$, with

$$
\begin{aligned}
&\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} \\
&\left\|\nabla \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} .
\end{aligned}
$$

Here $\left|\nabla_{\mathbb{S}^{n-1}} \varphi\right|$ is the norm of the gradient of the function $\varphi$ on $\mathbb{S}^{n-1}$. We postpone the proofs of Lemmas 4 and 5 to the end of this section.

Now we are ready for the proof of Proposition 3,
Proof of Proposition [3, Let $f, \phi$ be as in the statement of Theorem 1, Apply Lemma 5to $\varphi=\langle\phi, \nu\rangle$, where $\lambda>0$ is to be chosen. Then since

$$
\left\|\nabla_{\mathbb{S}^{n-1}}\langle\phi, \nu\rangle\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} \leq C\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)},
$$

there exists a decomposition

$$
\langle\phi, \nu\rangle=\varphi_{1}+\varphi_{2} \quad \text { on } \mathbb{S}^{n-1}
$$

and an extension $\tilde{\varphi}_{2}$ of $\varphi_{2}$ to $\mathbb{R}^{n} \backslash \mathbb{B}^{n}$, such that $\tilde{\varphi}_{2} \in C^{\infty} \cap L^{\infty}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)$,

$$
\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}
$$

and

$$
\left\|\nabla \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)} .
$$

Now

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle\langle\phi, \nu\rangle \mathrm{d} \sigma & =\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle \varphi_{1} \mathrm{~d} \sigma+\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle \varphi_{2} \mathrm{~d} \sigma \\
& =I+I I .
\end{aligned}
$$

In the first term, we estimate trivially

$$
|I| \leq\|f\|_{L^{1}\left(\mathbb{S}^{n-1}\right)}\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}}\|f\|_{L^{1}\left(\mathbb{S}^{n-1}\right)}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)} .
$$

To estimate the second term, we let $\theta$ be a smooth cut-off function with compact support on $\mathbb{R}^{n}$ such that $\theta(x)=1$ whenever $|x| \leq 1$. For $\varepsilon \in(0,1)$, let $\theta_{\varepsilon}(x)=\theta(\varepsilon x)$. Then $\theta_{\varepsilon}=1$ on $\mathbb{S}^{n-1}$, so we can rewrite $I I$ as

$$
I I=\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle \varphi_{2} \theta_{\varepsilon} \mathrm{d} \sigma
$$

for any $\varepsilon \in(0,1)$. We then integrate by parts using Lemma 4, with $\psi:=\tilde{\varphi}_{2} \theta_{\varepsilon}$, and obtain

$$
I I=-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\left\langle f, \nabla \tilde{\varphi}_{2}\right\rangle \theta_{\varepsilon} \mathrm{d} x-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\left\langle f, \nabla \theta_{\varepsilon}\right\rangle \tilde{\varphi}_{2} \mathrm{~d} x .
$$

(The cut-off function $\theta_{\varepsilon}$ is inserted so that $\psi$ has compact support.) We now let $\varepsilon \rightarrow 0^{+}$. The second term then tends to 0 , since it is just

$$
-\varepsilon \int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\langle f(x),(\nabla \theta)(\varepsilon x)\rangle \tilde{\varphi}_{2}(x) \mathrm{d} x
$$

where $f \in L^{1}, \nabla \theta(\varepsilon \cdot) \in L^{\infty}$ and $\tilde{\varphi}_{2} \in L^{\infty}$ on $\mathbb{R}^{n} \backslash \mathbb{B}^{n}$. On the other hand, the first term tends to

$$
-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\left\langle f, \nabla \tilde{\varphi}_{2}\right\rangle \mathrm{d} x
$$

by dominated convergence theorem, since $f \in L^{1}$ and $\nabla \tilde{\varphi}_{2} \in L^{\infty}$ on $\mathbb{R}^{n} \backslash \mathbb{B}^{n}$. As a result,

$$
I I=-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}}\left\langle f, \nabla \tilde{\varphi}_{2}\right\rangle \mathrm{d} x
$$

from which we see that

$$
|I I| \leq\|f\|_{L^{1}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)}\left\|\nabla \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\|f\|_{L^{1}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}
$$

Together, by choosing $\lambda=\frac{\|f\|_{L^{1}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)}}{\|f\|_{L^{1}\left(\mathbb{S}^{n}\right)}}$, we get

$$
\left|\int_{\mathbb{S}^{n-1}}\langle f, \nu\rangle\langle\phi, \nu\rangle \mathrm{d} \sigma\right| \leq C\|f\|_{L^{1}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)}^{\frac{1}{n}}\|f\|_{L^{1}\left(\mathbb{S}^{n-1}\right)}^{1-\frac{1}{n}}\|\phi\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}
$$

as desired.
We will now deduce Theorem 1 from Proposition 3, The idea is to average (3) over all unit spheres in $\mathbb{R}^{n}$.

Proof of Theorem 11. First, for each fixed $x \in \mathbb{R}^{n}$, we have

$$
\begin{equation*}
\langle f(x), \phi(x)\rangle=c \int_{\mathbb{S}^{n-1}}\langle f(x), \omega\rangle\langle\phi(x), \omega\rangle \mathrm{d} \sigma(\omega) \tag{4}
\end{equation*}
$$

where we are identifying $\omega \in \mathbb{S}^{n-1}$ with the corresponding unit tangent vector to $\mathbb{R}^{n}$ based at the point $x$. Hence to estimate $\int_{\mathbb{R}^{n}}\langle f(x), \phi(x)\rangle \mathrm{d} x$, it suffices to estimate

$$
\int_{\mathbb{R}^{n}} \int_{\mathbb{S}^{n-1}}\langle f(x), \omega\rangle\langle\phi(x), \omega\rangle \mathrm{d} \sigma(\omega) \mathrm{d} x
$$

which is the same as

$$
\int_{\mathbb{R}^{n}} \int_{\mathbb{S}^{n}-1}\langle f(z+\omega), \omega\rangle\langle\phi(z+\omega), \omega\rangle \mathrm{d} \sigma(\omega) \mathrm{d} z
$$

by a change of variable $(x, \omega) \mapsto(z+\omega, \omega)$. Now when $z=0$, the inner integral can be estimated by Proposition 3; for a general $z \neq 0$, one can still estimate the inner integral by Proposition 3, since the
proposition is invariant under translations. Thus the above double integral is bounded, in absolute value, by

$$
C\|f\|_{L^{1}\left(\mathbb{R}^{n}\right)}^{\frac{1}{n}} \int_{\mathbb{R}^{n}}\|f(z+\cdot)\|_{L^{1}\left(\mathbb{S}^{n-1}\right)}^{1-\frac{1}{n}}\|\phi(z+\cdot)\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)} \mathrm{d} z
$$

Applying Hölder's inequality to the last integral in $z$, one bounds this by

$$
C\|f\|_{L^{1}\left(\mathbb{R}^{n}\right)}^{\frac{1}{n}}\left(\int_{\mathbb{R}^{n}}\|f(z+\cdot)\|_{L^{1}\left(\mathbb{S}^{n-1}\right)} \mathrm{d} z\right)^{1-\frac{1}{n}}\left(\int_{\mathbb{R}^{n}}\|\phi(z+\cdot)\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}^{n} \mathrm{~d} z\right)^{\frac{1}{n}}
$$

Since

$$
\int_{\mathbb{R}^{n}}\|f(z+\cdot)\|_{L^{1}\left(\mathbb{S}^{n-1}\right)} \mathrm{d} z=c\|f\|_{L^{1}\left(\mathbb{R}^{n}\right)}
$$

and

$$
\int_{\mathbb{R}^{n}}\|\phi(z+\cdot)\|_{W^{1, n}\left(\mathbb{S}^{n-1}\right)}^{n} \mathrm{~d} z \leq c\left(\|\phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}^{n}+\|\nabla \phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}^{n}\right),
$$

we proved that under the assumption of Theorem 1 we have

$$
\begin{equation*}
\left|\int_{\mathbb{R}^{n}}\langle f, \phi\rangle\right| \leq C\|f\|_{L^{1}\left(\mathbb{R}^{n}\right)}\left(\|\nabla \phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}+\|\phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}\right) . \tag{5}
\end{equation*}
$$

This is almost the desired conclusion, except that we have an additional zeroth order term on $\phi$ on the right hand side of the estimate. But that can be scaled away by homogeneity. In fact, if $f$ and $\phi$ satisfies the assumption of Theorem [1, then so does the dilations

$$
f_{\varepsilon}(x):=\varepsilon^{-n} f\left(\varepsilon^{-1} x\right), \quad \phi_{\varepsilon}(x):=\phi\left(\varepsilon^{-1} x\right), \quad \varepsilon>0 .
$$

Applying (5) to $f_{\varepsilon}$ and $\phi_{\varepsilon}$ instead, we get

$$
\left|\int_{\mathbb{R}^{n}}\left\langle f_{\varepsilon}, \phi_{\varepsilon}\right\rangle\right| \leq C\left\|f_{\varepsilon}\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}\left(\left\|\nabla \phi_{\varepsilon}\right\|_{L^{n}\left(\mathbb{R}^{n}\right)}+\left\|\phi_{\varepsilon}\right\|_{L^{n}\left(\mathbb{R}^{n}\right)}\right),
$$

i.e.

$$
\left|\int_{\mathbb{R}^{n}}\langle f, \phi\rangle\right| \leq C\|f\|_{L^{1}\left(\mathbb{R}^{n}\right)}\left(\|\nabla \phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}+\varepsilon\|\phi\|_{L^{n}\left(\mathbb{R}^{n}\right)}\right)
$$

so letting $\varepsilon \rightarrow 0^{+}$, we get the desired conclusion of Theorem 1 .
Proof of Lemma 4. Note that $\langle f, \nu\rangle \psi=\langle\psi f, \nu\rangle$, and $\nu$ is the inward unit normal to $\partial\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)$. So by the divergence theorem on $\mathbb{R}^{n}$, we have

$$
\int_{\mathbb{S}^{n}-1}\langle f, \nu\rangle \psi \mathrm{d} \sigma=-\int_{\mathbb{R}^{n} \backslash \mathbb{B}^{n}} \operatorname{div}(\psi f) \mathrm{d} x .
$$

But since div $f=0$, we have

$$
\operatorname{div}(\psi f)=\langle f, \nabla \psi\rangle+\psi \operatorname{div} f=\langle f, \nabla \psi\rangle
$$

and the desired equality follows.
Proof of Lemma 5. Suppose $\varphi$ and $\lambda$ are as in Lemma 5. We will construct first a decomposition $\varphi=\varphi_{1}+\varphi_{2}$ on $\mathbb{S}^{n-1}$, so that both $\varphi_{1}$ and $\varphi_{2}$ are smooth on $\mathbb{S}^{n-1}$, and

$$
\begin{gathered}
\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} \\
\left\|\nabla_{\mathbb{S}^{n-1}} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}
\end{gathered}
$$

(Here $\nabla_{\mathbb{S}^{n-1}} \varphi_{2}$ is the gradient on $\mathbb{S}^{n-1}$.) Once this is established, the lemma will follow, by extending $\varphi_{2}$ so that it is homogeneous of degree 0 ; in other words, we will then define

$$
\tilde{\varphi}_{2}(x):=\varphi_{2}\left(\frac{x}{|x|}\right), \quad|x| \geq 1 .
$$

It is then straight forward to verify that

$$
\left\|\nabla \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \mathbb{B}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}
$$

since the radial derivative of $\tilde{\varphi}_{2}$ is zero.
To construct the desired decomposition on $\mathbb{S}^{n-1}$, we proceed as follows.

If $\lambda \geq 1$, we set $\varphi_{2}=f_{\mathbb{S}^{n}} \varphi$, so that $\nabla_{\mathbb{S}^{n-1}} \varphi_{2}=0$ on $\mathbb{S}^{n-1}$; then

$$
\varphi_{1}=\varphi-f_{\mathbb{S}^{n}} \varphi
$$

and the estimate for $\varphi_{1}$ follows from the classical Morrey-Sobolev estimate.

If $0<\lambda<1$, we pick a non-negative radial cut-off function $\eta \in$ $C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$, with $\eta=1$ in a neighborhood of 0 , and define $\eta_{\lambda}(x)=\eta\left(\lambda^{-1} x\right)$ for $x \in \mathbb{R}^{n}$. We then consider the function

$$
x \in \mathbb{R}^{n} \mapsto \int_{\mathbb{S}^{n-1}} \eta_{\lambda}(x-y) \mathrm{d} \sigma(y) .
$$

When restricted to $x \in \mathbb{S}^{n-1}$, this function is a constant independent of the choice of $x \in \mathbb{S}^{n-1}$, by rotation invariance of the integral. We then write $c_{\lambda}$ for this constant, i.e.

$$
\begin{equation*}
c_{\lambda}:=\int_{\mathbb{S}^{n-1}} \eta_{\lambda}(x-y) \mathrm{d} \sigma(y), \quad|x|=1 \tag{6}
\end{equation*}
$$

Note that by our choice of $\eta$, when $0<\lambda<1$,

$$
\begin{equation*}
c_{\lambda} \simeq \lambda^{n-1} . \tag{7}
\end{equation*}
$$

Now we define, for $x \in \mathbb{S}^{n-1}$, that

$$
\varphi_{2}(x)=c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}} \eta_{\lambda}(x-y) \varphi(y) \mathrm{d} \sigma(y), \quad \varphi_{1}(x)=\varphi(x)-\varphi_{2}(x)
$$

Then for $x \in \mathbb{S}^{n-1}$, we have

$$
\varphi_{1}(x)=c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}} \eta_{\lambda}(x-y)[\varphi(x)-\varphi(y)] \mathrm{d} \sigma(y)
$$

by definition of $c_{\lambda}$. But for $x, y \in \mathbb{S}^{n-1}$, we have, by Morrey's embedding, that

$$
|\varphi(x)-\varphi(y)| \leq C|x-y|^{\frac{1}{n}}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} .
$$

It follows that

$$
\left|\varphi_{1}(x)\right| \leq C\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}} \eta_{\lambda}(x-y)|x-y|^{\frac{1}{n}} \mathrm{~d} \sigma(y)
$$

Letting $\tilde{\eta}(x)=|x|^{\frac{1}{n}} \eta(x)$, and $\tilde{\eta}_{\lambda}(x)=\tilde{\eta}\left(\lambda^{-1} x\right)$, we see that the right hand side above is just

$$
C \lambda^{\frac{1}{n}}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}} \tilde{\eta}_{\lambda}(x-y) \mathrm{d} \sigma(y)
$$

But this last integral can be estimated by

$$
\int_{\mathbb{S}^{n-1}} \tilde{\eta}_{\lambda}(x-y) \mathrm{d} \sigma(y) \lesssim \lambda^{n-1}
$$

by the support and $L^{\infty}$ bound of $\tilde{\eta}_{\lambda}$. Hence using also (7), we see that

$$
\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}
$$

as desired.
Next, suppose $x \in \mathbb{S}^{n-1}$, and $v$ is a unit tangent vector to $\mathbb{S}^{n-1}$ at $x$. Then

$$
\begin{equation*}
\partial_{v} \phi_{2}(x)=\lambda^{-1} c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}}\langle v, \nabla \eta\rangle\left(\lambda^{-1}(x-y)\right) \varphi(y) \mathrm{d} \sigma(y) . \tag{8}
\end{equation*}
$$

But if we differentiate both sides of the definition (6) of $c_{\lambda}$ with respect to $\partial_{v}$, we see that

$$
\begin{equation*}
0=\int_{\mathbb{S}^{n}-1}\langle v, \nabla \eta\rangle\left(\lambda^{-1}(x-y)\right) \mathrm{d} \sigma(y) . \tag{9}
\end{equation*}
$$

Multiplying (19) by $\lambda^{-1} c_{\lambda}^{-1} \phi(x)$, and subtracting that from (8), we get

$$
\partial_{v} \phi_{2}(x)=\lambda^{-1} c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}}\langle v, \nabla \eta\rangle\left(\lambda^{-1}(x-y)\right)[\varphi(y)-\varphi(x)] \mathrm{d} \sigma(y) .
$$

Using Morrey's embedding again, we see that

$$
\left|\partial_{v} \phi_{2}(x)\right| \leq C \lambda^{-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{\left.L^{n} \mathbb{S}^{n-1}\right)} c_{\lambda}^{-1} \int_{\mathbb{S}^{n-1}}|\langle v, \nabla \eta\rangle|\left(\lambda^{-1}(x-y)\right)|x-y|^{\frac{1}{n}} \mathrm{~d} \sigma(y) .
$$

Letting $\bar{\eta}(x)=|x|^{\frac{1}{n}}|\langle v, \nabla \eta\rangle|(x)$, and $\bar{\eta}_{\lambda}(x)=\bar{\eta}\left(\lambda^{-1} x\right)$, we see that the right hand side above is just

$$
C \lambda^{\frac{1}{n}} \lambda^{-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)} c_{\lambda}^{-1} \int_{\mathbb{S}^{n}-1} \bar{\eta}_{\lambda}(x-y) \mathrm{d} \sigma(y)
$$

But this last integral can be estimated by

$$
\int_{\mathbb{S}^{n-1}} \bar{\eta}_{\lambda}(x-y) \mathrm{d} \sigma(y) \mathrm{d} \sigma(y) \lesssim \lambda^{n-1}
$$

by the support and $L^{\infty}$ bound of $\bar{\eta}_{\lambda}$. Hence using also (7), we see that

$$
\left\|\nabla_{\mathbb{S}^{n-1}} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{S}^{n-1}\right)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{\mathbb{S}^{n-1}} \varphi\right\|_{L^{n}\left(\mathbb{S}^{n-1}\right)}
$$

as desired.

## 3. A borderline Sobolev embedding on the real HYPERBOLIC SPACE $\mathbb{H}^{n}$

We now turn to a corresponding result on the real hyperbolic space $\mathbb{H}^{n}$. We will first give a direct proof in this current section, in the spirit of the earlier proof of Theorem $⿴$ using spherical averages. In the appendix we give a less direct proof, using a variant of Theorem 1 on $\mathbb{R}^{n}$.

First we need some notations. We will use the upper half space model for the hyperbolic space. In other words, we take $\mathbb{H}^{n}$ to be

$$
\mathbb{H}^{n}=\mathbb{R}_{+}^{n}=\left\{x=\left(x^{\prime}, x_{n}\right) \in \mathbb{R}^{n-1} \times \mathbb{R}: x_{n}>0\right\}
$$

and the metric on $\mathbb{H}^{n}$ to be

$$
g:=\frac{|\mathrm{d} x|^{2}}{x_{n}^{2}} .
$$

We will use the following orthonormal frame of vector fields

$$
e_{i}:=x_{n} \frac{\partial}{\partial x_{i}}, \quad i=1, \ldots, n
$$

at every point of $\mathbb{H}^{n}$. Note that if $j \neq n$, then

$$
\begin{equation*}
\nabla_{e_{n}} e_{j}=0 \tag{10}
\end{equation*}
$$

(Here $\nabla=\nabla_{g}$ is the Levi-Civita connection with respect to the hyperbolic metric $g$.) In fact, since $\left\{e_{1}, \ldots, e_{n}\right\}$ is an orthonormal basis, for any $k=1, \ldots, n$, we have

$$
\begin{aligned}
\left\langle\nabla_{e_{n}} e_{j}, e_{k}\right\rangle_{g} & =\frac{1}{2}\left(\left\langle\left[e_{n}, e_{j}\right], e_{k}\right\rangle_{g}-\left\langle\left[e_{n}, e_{k}\right], e_{j}\right\rangle_{g}-\left\langle\left[e_{j}, e_{k}\right], e_{n}\right\rangle_{g}\right) \\
& =\frac{1}{2}\left(\left\langle e_{j}, e_{k}\right\rangle_{g}-\left\langle\left(1-\delta_{k n}\right) e_{k}, e_{j}\right\rangle_{g}-\left\langle-\delta_{k n} e_{j}, e_{n}\right\rangle_{g}\right)=0 .
\end{aligned}
$$

Also, we have

$$
\begin{equation*}
\nabla_{e_{n}} e_{n}=0 \tag{11}
\end{equation*}
$$

This is because if $j \neq n$, then

$$
\left\langle\nabla_{e_{n}} e_{n}, e_{j}\right\rangle_{g}=-\left\langle e_{n}, \nabla_{e_{n}} e_{j}\right\rangle_{g}=0
$$

by (10), and

$$
\left\langle\nabla_{e_{n}} e_{n}, e_{n}\right\rangle_{g}=\frac{1}{2} e_{n}\left(\left\langle e_{n}, e_{n}\right\rangle_{g}\right)=0 .
$$

To prove Theorem 2, note that we only need to consider the case $n \geq 2$, since when $n=1$,

$$
\|\phi\|_{L^{\infty}\left(\mathbb{H}^{1}\right)} \leq \int_{0}^{\infty}\left|\partial_{y} \phi(y)\right| d y=\left\|\nabla_{g} \phi\right\|_{L^{1}\left(\mathbb{H}^{1}\right)},
$$

and (2) follows trivially. Hence from now on we assume $n \geq 2$.
We will deduce Theorem 22 from the following Proposition:
Proposition 6. Assume $n \geq 2$. Let $f, \phi$ be as in Theorem 图. Write $S$ for the copy of $(n-1)$-dimensional hyperbolic space inside $\mathbb{H}^{n}$, given by

$$
S=\left\{x \in \mathbb{H}^{n}: x_{1}=0\right\},
$$

and $X$ for the half-space

$$
X=\left\{x \in \mathbb{H}^{n}: x_{1}>0\right\}
$$

so that $S$ is the boundary of $X$. Also write $\mathrm{d} V_{g}^{\prime}$ for the volume measure on $S$ with respect to the hyperbolic metric on $S$, and $\nu=e_{1}$ for the unit normal to $S$. Then

$$
\begin{equation*}
\left|\int_{S}\langle f, \nu\rangle_{g}\langle\phi, \nu\rangle_{g} \mathrm{~d} V_{g}^{\prime}\right| \leq C\|f\|_{L^{1}(X)}^{\frac{1}{n}}\|f\|_{L^{1}(S)}^{1-\frac{1}{n}}\|\phi\|_{W^{1, n}(S)} . \tag{12}
\end{equation*}
$$

Here $\|\phi\|_{W^{1, n}(S)}=\|\phi\|_{L^{n}(S)}+\left\|\nabla_{g} \phi\right\|_{L^{n}(S)}$, and all integrals on $S$ on the right hand side are with respect to $\mathrm{d} V_{g}^{\prime}$.

The $S$ will be called a vertical hyperplane in $\mathbb{H}^{n}$. It is a totally geodesic submanifold of $\mathbb{H}^{n}$. We will consider all hyperbolic hyperplanes in $\mathbb{H}^{n}$, that is the image of $S$ under all isometries of $\mathbb{H}^{n}$. The set of all such hypersurfaces in $\mathbb{H}^{n}$ will be denoted by $\mathcal{S}$; it will consist of all Euclidean parallel translates of $S$ in the $x^{\prime}$-direction, and all Euclidean northern hemispheres whose centers lie on the plane $\left\{x_{n}=0\right\}$.

The proof of Proposition 6 in turn depends on the following two lemmas. The first one is a simple lemma about integration by parts, which is the counterpart of Lemma 4 :

Lemma 7. Assume $n \geq 2$. Let $f, S, X, \nu$ be as in Proposition 6 . Then for any compactly supported smooth function $\psi$ on $\mathbb{H}^{n}$, we have

$$
\int_{S}\langle f, \nu\rangle_{g} \psi \mathrm{~d} V_{g}^{\prime}=-\int_{X}\left\langle f, \nabla_{g} \psi\right\rangle_{g} \mathrm{~d} V_{g} .
$$

The second one is a decomposition lemma for functions on $S$, which is the counterpart of Lemma 5:

Lemma 8. Assume $n \geq 2$. Let $\varphi$ be a smooth function with compact support on $S$. For any $\lambda>0$, there exists a decomposition

$$
\varphi=\varphi_{1}+\varphi_{2} \quad \text { on } S
$$

and an extension $\tilde{\varphi}_{2}$ of $\varphi_{2}$ to $\mathbb{H}^{n}$, such that $\tilde{\varphi}_{2}$ is smooth with compact support on $\mathbb{H}^{n}$, and

$$
\left\|\varphi_{1}\right\|_{L^{\infty}(S)} \leq C \lambda^{\frac{1}{n}}\left\|\nabla_{g} \varphi\right\|_{L^{n}(S)}
$$

with

$$
\left\|\nabla_{g} \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{g} \varphi\right\|_{L^{n}(S)}
$$

We postpone the proofs of Lemmas 7 and 8 to the end of this section.
Now we are ready for the proof of Proposition 6.
Proof of Proposition 6. Let $f, \phi$ be as in the statement of Theorem 2. Apply Lemma 8 to $\varphi=\langle\phi, \nu\rangle_{g}$, where $\lambda>0$ is to be chosen. Then since

$$
\left\|\nabla_{g}\langle\phi, \nu\rangle_{g}\right\|_{L^{n}(S)} \leq C\|\phi\|_{W^{1, n}(S)}
$$

(this follows since $\left|e_{k}\langle\phi, \nu\rangle\right|=\left|\left\langle\nabla_{e_{k}} \phi, \nu\right\rangle+\left\langle\phi, \nabla_{e_{k}} \nu\right\rangle\right| \leq\left|\nabla_{g} \phi\right|_{g}+|\phi|_{g}$ for all $k$ ), there exists a decomposition

$$
\langle\phi, \nu\rangle_{g}=\varphi_{1}+\varphi_{2} \quad \text { on } S
$$

and an extension $\tilde{\varphi}_{2}$ of $\varphi_{2}$ to $\mathbb{H}^{n}$, such that $\tilde{\varphi}_{2} \in C_{c}^{\infty}\left(\mathbb{H}^{n}\right)$,

$$
\left\|\varphi_{1}\right\|_{L^{\infty}(S)} \leq C \lambda^{\frac{1}{n}}\|\phi\|_{W^{1, n}(S)}
$$

and

$$
\left\|\nabla_{g} \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{n}\right)} \leq C \lambda^{\frac{1}{n}-1}\|\phi\|_{W^{1, n}(S)}
$$

Now

$$
\begin{aligned}
\int_{S}\langle f, \nu\rangle_{g}\langle\phi, \nu\rangle_{g} \mathrm{~d} V_{g}^{\prime} & =\int_{S}\langle f, \nu\rangle_{g} \varphi_{1} \mathrm{~d} V_{g}^{\prime}+\int_{S}\langle f, \nu\rangle_{g} \varphi_{2} \mathrm{~d} V_{g}^{\prime} \\
& =I+I I
\end{aligned}
$$

In the first term, we estimate trivially

$$
|I| \leq\|f\|_{L^{1}(S)}\left\|\varphi_{1}\right\|_{L^{\infty}(S)} \leq C \lambda^{\frac{1}{n}}\|f\|_{L^{1}(S)}\|\phi\|_{W^{1, n}(S)}
$$

In the second term, we first integrate by parts using Lemma 7, with $\psi=\tilde{\varphi}_{2}$, and obtain

$$
I I=-\int_{X}\left\langle f, \nabla_{g} \tilde{\varphi}_{2}\right\rangle_{g} \mathrm{~d} V_{g},
$$

so

$$
\begin{aligned}
|I I| & \leq\|f\|_{L^{1}(X)}\left\|\nabla_{g} \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{n}\right)} \\
& \leq C \lambda^{\frac{1}{n}-1}\|f\|_{L^{1}(X)}\|\phi\|_{W^{1, n}(S)} .
\end{aligned}
$$

Together, by choosing $\lambda=\frac{\|f\|_{L^{1}(X)}}{\|f\|_{L^{1}(S)}}$, we get

$$
\left|\int_{S}\langle f, \nu\rangle_{g}\langle\phi, \nu\rangle_{g} \mathrm{~d} V_{g}^{\prime}\right| \leq C\|f\|_{L^{1}(X)}^{\frac{1}{n}}\|f\|_{L^{1}(S)}^{1-\frac{1}{n}}\|\phi\|_{W^{1, n}(S)}
$$

as desired.
We will now deduce Theorem 2 from Proposition 6. The idea is to average (12) over all images of $S$ under isometries in $\mathbb{H}^{n}$ (i.e. all hypersurfaces in the collection $\mathcal{S}$ ).

Proof of Theorem 囩. First, for each fixed $x=\left(x^{\prime}, x_{n}\right) \in \mathbb{H}^{n}$, we have the following analogue of the identity (4), used in the proof of Theorem 1:

$$
\langle f(x), \phi(x)\rangle_{g}=c \int_{\mathbb{S}^{n-1}}\left\langle f(x), x_{n} \omega\right\rangle_{g}\left\langle\phi(x), x_{n} \omega\right\rangle_{g} \mathrm{~d} \sigma(\omega)
$$

Here we are identifying $\omega \in \mathbb{S}^{n-1}$ with the corresponding tangent vector to $\mathbb{H}^{n}$ based at the point $x$. (Note then $x_{n} \omega$ has length 1 with respect to the metric $g$ at $x$, so $x_{n} \omega$ belongs to the unit sphere bundle at $x$.) Furthermore, since the above integrand is even in $\omega$, we may replace the integral over $\mathbb{S}^{n-1}$ by the integral only over the northern hemisphere $\mathbb{S}_{+}^{n-1}:=\left\{\omega \in \mathbb{S}^{n-1}: \omega_{n}>0\right\}$. Hence to estimate $\int_{\mathbb{H}^{n}}\langle f(x), \phi(x)\rangle_{g} \mathrm{~d} V_{g}$, it suffices to estimate

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{n}} \int_{\mathbb{S}_{+}^{n-1}}\left\langle f(x), x_{n} \omega\right\rangle_{g}\left\langle\phi(x), x_{n} \omega\right\rangle_{g} \mathrm{~d} \sigma(\omega) \frac{\mathrm{d} x}{x_{n}^{n}} \tag{13}
\end{equation*}
$$

We will compute this integral by making a suitable change of variables.
To do so, given $x \in \mathbb{R}_{+}^{n}$ and $\omega \in \mathbb{S}_{+}^{n-1}$, let $S(x, \omega)$ be the hyperbolic hypersurface in $\mathcal{S}$ passing through $x$ with normal vector $\omega$ at $x$. In other words, $S(x, \omega)$ would be an Euclidean hemisphere, with center on the plane $\left\{x_{n}=0\right\}$; we denote the center of this Euclidean hemisphere by $(z, 0)$, where $z=z(x, \omega)$.

For each fixed $x \in \mathbb{R}_{+}^{n}$, the map $\omega \mapsto z(x, \omega)$ provides an invertible change of variables from $\mathbb{S}_{+}^{n-1}$ to $\mathbb{R}^{n-1}$. Thus we are led to parametrize
the integral in (13) by $z$ instead of $\omega$. In order to do that we observe that the vectors $x-(z, 0)$ and $\omega$ are collinear. This implies that if $z=z(x, \omega)$, then

$$
\omega=\frac{x-(z, 0)}{|x-(z, 0)|}
$$

(Here $|x-(z, 0)|$ is the Euclidean norm of $x-(z, 0)$.) Write $\Phi_{x}(z)$ for the right hand side of the above equation. We view $\Phi_{x}$ as a map $\Phi_{x}: \mathbb{R}^{n-1} \rightarrow \mathbb{S}_{+}^{n-1} \subset \mathbb{R}^{n}$, and compute the Jacobian of the map. We have

$$
\left(D \Phi_{x}\right)^{t}(z)=\frac{1}{|x-(z, 0)|}\left((-I, 0)+\frac{\left(x^{\prime}-z\right) \otimes(x-(z, 0))^{t}}{|x-(z, 0)|^{2}}\right)
$$

(here we think of $x, z$ as column vectors, and $D \Phi_{x}$ as an $(n-1) \times n$ matrix). Thus

$$
\left(D \Phi_{x}\right)^{t} D \Phi_{x}(z)=\frac{1}{|x-(z, 0)|^{2}}\left(I-\frac{\left(x^{\prime}-z\right) \otimes\left(x^{\prime}-z\right)^{t}}{|x-(z, 0)|^{2}}\right)
$$

By computing the determinant in a basis that contains $x^{\prime}-z$, we get

$$
\begin{aligned}
\operatorname{Jac} \Phi_{x}(z) & =\sqrt{\operatorname{det}\left[\left(D \Phi_{x}\right)^{t} D \Phi_{x}(z)\right]} \\
& =\frac{1}{|x-(z, 0)|^{n-1}} \sqrt{1-\frac{\left|x^{\prime}-z\right|^{2}}{|x-(z, 0)|^{2}}} \\
& =\frac{x_{n}}{|x-(z, 0)|^{n}} .
\end{aligned}
$$

By a change of variable $\omega=\Phi_{x}(z)$, and using Fubini's theorem, we see that (13) is equal to

$$
\begin{equation*}
\int_{\mathbb{R}^{n-1}} \int_{\mathbb{R}_{+}^{n}} \frac{\left\langle f(x), x_{n} \Phi_{x}(z)\right\rangle_{g}\left\langle\phi(x), x_{n} \Phi_{x}(z)\right\rangle_{g}}{|x-(z, 0)|^{n}} \frac{\mathrm{~d} x}{x_{n}^{n-1}} \mathrm{~d} z \tag{14}
\end{equation*}
$$

Now we fix $z \in \mathbb{R}^{n-1}$, and compute the inner integral over $x$ by integrating over successive hemispheres of radius $r$ centered at $(z, 0)$. More precisely, let $S(z, r)$ be the Euclidean northern hemisphere with center $(z, 0)$ and of radius $r>0$. Then $S(z, r) \in \mathcal{S}$, and for any $z \in \mathbb{R}^{n-1}$, we have

$$
\begin{aligned}
& \int_{\mathbb{R}_{+}^{n}} \frac{\left\langle f(x), x_{n} \Phi_{x}(z)\right\rangle_{g}\left\langle\phi(x), x_{n} \Phi_{x}(z)\right\rangle_{g}}{|x-(z, 0)|^{n}} \frac{\mathrm{~d} x}{x_{n}^{n-1}} \\
= & \int_{0}^{\infty} \int_{x \in S(z, r)}\left\langle f(x), x_{n} \Phi_{x}(z)\right\rangle_{g}\left\langle\phi(x), x_{n} \Phi_{x}(z)\right\rangle_{g} \frac{\mathrm{~d} \sigma(x)}{x_{n}^{n-1}} \frac{\mathrm{~d} r}{r^{n}},
\end{aligned}
$$

where $\mathrm{d} \sigma(x)$ is the Euclidean surface measure on $S(z, r)$. However, if $x \in S(z, r)$, then $x_{n} \Phi_{x}(z)$ is precisely the upward unit normal to $S(z, r)$
at $x$. Also, if $\mathrm{d} V_{g}^{\prime}$ is the induced surface measure on $S(z, r)$ from the hyperbolic metric on $\mathbb{H}^{n}$, then

$$
\mathrm{d} V_{g}^{\prime}=\frac{\mathrm{d} \sigma(x)}{x_{n}^{n-1} r}
$$

indeed if we write $\omega=\frac{x-(z, 0)}{|x-(z, 0)|}$, then at $x \in S(z, r)$ we have

$$
\mathrm{d} V_{g}^{\prime}=i_{x_{n} \omega} \mathrm{~d} V_{g}=i_{x_{n} \omega} \frac{\mathrm{~d} x}{x_{n}^{n}}=\frac{i_{r \omega} \mathrm{~d} x}{x_{n}^{n-1} r}=\frac{\mathrm{d} \sigma(x)}{x_{n}^{n-1} r}
$$

(here $i$ denotes the interior product of a vector with a differential form). Hence the integral (14) is just equal to

$$
\begin{equation*}
\int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{S(z, r)}\langle f, \nu\rangle_{g}\langle\phi, \nu\rangle_{g} \mathrm{~d} V_{g}^{\prime} \frac{\mathrm{d} r}{r^{n-1}} \mathrm{~d} z . \tag{15}
\end{equation*}
$$

By Proposition 6 and its invariance under isometries of the hyperbolic space $\mathbb{H}^{n}$, we have

$$
\begin{aligned}
& \left|\int_{S(z, r)}\langle f, \nu\rangle_{g}\langle\phi, \nu\rangle_{g} \mathrm{~d} V_{g}^{\prime}\right| \\
\leq & C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}^{\frac{1}{n}}\left(\int_{S(z, r)}|f|_{g} \mathrm{~d} V_{g}^{\prime}\right)^{1-\frac{1}{n}}\left(\int_{S(z, r)}\left(\left|\nabla_{g} \phi\right|_{g}^{n}+|\phi|_{g}^{n}\right) \mathrm{d} V_{g}^{\prime}\right)^{\frac{1}{n}}
\end{aligned}
$$

Hence by Hölder's inequality, (15) is bounded by

$$
\begin{aligned}
& C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}^{\frac{1}{n}}\left(\int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{S(z, r)}|f|_{g} \mathrm{~d} V_{g}^{\prime} \frac{\mathrm{d} r}{r^{n-1}} \mathrm{~d} z\right)^{1-\frac{1}{n}} \\
& \cdot\left(\int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{S(z, r)}\left(\left|\nabla_{g} \phi\right|_{g}^{n}+|\phi|_{g}^{n}\right) \mathrm{d} V_{g}^{\prime} \frac{\mathrm{d} r}{r^{n-1}} \mathrm{~d} z\right)^{\frac{1}{n}} .
\end{aligned}
$$

But undoing our earlier changes of variable, we see that

$$
\begin{aligned}
& \int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{S(z, r)}|f|_{g} \mathrm{~d} V_{g}^{\prime} \frac{\mathrm{d} r}{r^{n-1}} \mathrm{~d} z \\
= & \int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{x \in S(z, r)}|f(x)|_{g} \frac{\mathrm{~d} \sigma(x)}{x_{n}^{n-1}} \frac{\mathrm{~d} r}{r^{n}} \mathrm{~d} z \\
= & \int_{\mathbb{R}^{n-1}} \int_{\mathbb{R}_{+}^{n}} \frac{|f(x)|_{g}}{|x-(z, 0)|^{n}} \frac{\mathrm{~d} x}{x_{n}^{n-1}} \mathrm{~d} z \\
= & \int_{\mathbb{R}_{+}^{n}}|f(x)|_{g}\left(\int_{\mathbb{R}^{n-1}} \frac{x_{n}}{|x-(z, 0)|^{n}} \mathrm{~d} z\right) \frac{\mathrm{d} x}{x_{n}^{n}} \\
= & C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)} .
\end{aligned}
$$

Similarly,

$$
\int_{\mathbb{R}^{n-1}} \int_{0}^{\infty} \int_{S(z, r)}\left(\left|\nabla_{g} \phi\right|_{g}^{n}+|\phi|_{g}^{n}\right) \mathrm{d} V_{g}^{\prime} \frac{\mathrm{d} r}{r^{n-1}} \mathrm{~d} z=C\left(\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}^{n}+\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}^{n}\right)
$$

Altogether, (15) (and hence (13)) is bounded by

$$
C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}\left(\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}+\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}\right) .
$$

This is almost what we want, except that on the right hand side we have an additional $\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}$. To fix this, one applies Lemma 9 below, with $p=n$, and the desired conclusion of Theorem 2 follows.

Lemma 9. Assume $n \geq 2$. For any compactly supported smooth vector field $\phi$ on $\mathbb{H}^{n}$, and any $1 \leq p<\infty$, we have

$$
\|\phi\|_{L^{p}\left(\mathbb{H}^{n}\right)} \leq C\left\|\nabla_{g} \phi\right\|_{L^{p}\left(\mathbb{H}^{n}\right)} .
$$

Proof. In fact, for any function $\Phi \in C_{c}^{\infty}\left(\mathbb{H}^{n}\right)$, and any exponent $1 \leq$ $p<\infty$, we have, from Hardy's inequality, that

$$
\begin{equation*}
\|\Phi\|_{L^{p}\left(\mathbb{H}^{n}\right)} \leq C\left\|e_{n} \Phi\right\|_{L^{p}\left(\mathbb{H}^{n}\right)} \tag{16}
\end{equation*}
$$

This is because

$$
\int_{0}^{\infty}|\Phi(x)|^{p} \frac{\mathrm{~d} x_{n}}{x_{n}^{n}} \leq\left(\frac{p}{n-1}\right)^{p} \int_{0}^{\infty}\left|e_{n} \Phi\right|^{p}(x) \frac{\mathrm{d} x_{n}}{x_{n}^{n}}
$$

by Hardy's inequality. (16) then follows by integrating over all $x^{\prime} \in$ $\mathbb{R}^{n-1}$ with respect to $\mathrm{d} x^{\prime}$. Now we apply (16) to $\Phi=\left\langle\phi, e_{j}\right\rangle, 1 \leq j \leq$ $n-1$. In view of (10), we have

$$
e_{n} \Phi=\left\langle\nabla_{e_{n}} \phi, e_{j}\right\rangle+\left\langle\phi, \nabla_{e_{n}} e_{j}\right\rangle=\left\langle\nabla_{e_{n}} \phi, e_{j}\right\rangle
$$

so we get

$$
\left\|\left\langle\phi, e_{j}\right\rangle\right\|_{L^{p}\left(\mathbb{H}^{n}\right)} \leq C\left\|\nabla_{g} \phi\right\|_{L^{p}\left(\mathbb{H}^{n}\right)} .
$$

Similarly, we can apply (16) to $\Phi=\left\langle\phi, e_{n}\right\rangle$, and use (11) in place of (10). Altogether we see that

$$
\|\phi\|_{L^{p}\left(\mathbb{H}^{n}\right)} \leq C\left\|\nabla_{g} \phi\right\|_{L^{p}\left(\mathbb{H}^{n}\right)}
$$

as desired.
We now turn to the proofs of Lemma 7 and 8 .
Proof of Lemma 7. Note that $\langle f, \nu\rangle_{g} \psi=\langle\psi f, \nu\rangle_{g}$, and $\nu$ is the inward unit normal to $\partial X$. Also $\mathrm{d} V_{g}^{\prime}$ agrees with the induced surface measure on $S$ from $\mathbb{H}^{n}$. So by the divergence theorem on $\mathbb{H}^{n}$, we have

$$
\int_{S}\langle f, \nu\rangle_{g} \psi \mathrm{~d} V_{g}^{\prime}=-\int_{X} \operatorname{div}_{g}(\psi f) \mathrm{d} V_{g}
$$

But since $\operatorname{div}_{g} f=0$, we have

$$
\operatorname{div}_{g}(\psi f)=\left\langle f, \nabla_{g} \psi\right\rangle_{g}+\psi \operatorname{div}_{g} f=\left\langle f, \nabla_{g} \psi\right\rangle_{g}
$$

and the desired equality follows.
The proof of Lemma 8 will be easy, once we establish the following lemma:

Lemma 10. Let $\varphi$ be a smooth function with compact support on $\mathbb{H}^{m}$, $m \geq 1$. For any $p>m$ and $\lambda>0$, there exists a decomposition

$$
\varphi=\varphi_{1}+\varphi_{2} \quad \text { on } \mathbb{H}^{m}
$$

such that $\varphi_{2}$ is smooth with compact support on $\mathbb{H}^{m}$, and

$$
\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \leq C \lambda^{1-\frac{m}{p}}\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}
$$

with

$$
\left\|\nabla_{g} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \leq C \lambda^{-\frac{m}{p}}\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}
$$

We postpone the proof of this lemma to the end of this section.
Proof of Lemma 8. Suppose $\varphi$ and $\lambda$ are as in Lemma 8, We identify $S$ with $\mathbb{H}^{m}$, where $m=n-1$. (This is possible because the restriction of the metric of $\mathbb{H}^{n}$ to $S$ induces a metric on $S$ that is isometric to that of $\mathbb{H}^{m}$.) Using Lemma 10, with $p=n$, we obtain a decomposition $\varphi=\varphi_{1}+\varphi_{2}$ on $S$, such that

$$
\left\|\varphi_{1}\right\|_{L^{\infty}(S)} \leq C \lambda^{\frac{1}{n}}\left\|\nabla_{g} \varphi\right\|_{L^{n}(S)}
$$

with

$$
\begin{equation*}
\left\|\nabla_{g} \varphi_{2}\right\|_{L^{\infty}(S)} \leq C \lambda^{\frac{1}{n}-1}\left\|\nabla_{g} \varphi\right\|_{L^{n}(S)} \tag{17}
\end{equation*}
$$

We then extend $\varphi_{2}$ to $\mathbb{H}^{n}$ by setting for $\left(x_{1}, x^{\prime \prime}, x_{n}\right) \in \mathbb{R} \times \mathbb{R}^{n-2} \times \mathbb{R}_{+}$

$$
\tilde{\varphi}_{2}\left(x_{1}, x^{\prime \prime}, x_{n}\right)=\varphi_{2}\left(0, x^{\prime \prime}, \sqrt{x_{1}^{2}+x_{n}^{2}}\right)
$$

One immediately checks that $\tilde{\varphi}_{2}$ is smooth with compact support on $\mathbb{H}^{n}$, with

$$
\left\|\nabla_{g} \tilde{\varphi}_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{n}\right)} \leq\left\|\nabla_{g} \varphi_{2}\right\|_{L^{\infty}(S)}
$$

In view of (17), we obtain the desired bound for $\nabla_{g} \tilde{\varphi}_{2}$.
It remains to prove Lemma 10.
Proof of Lemma 10. When $m=1$, the 1-dimensional hyperbolic space $\mathbb{H}^{1}$ is isometric to $\mathbb{R}$, and Lemma 10 follows from its counterpart on $\mathbb{R}$ (see e.g. [9]). Alternatively, it will follow from our treatment in the case $m \geq 2,0<\lambda<1$ below.

So assume from now on $m \geq 2$. Suppose $\varphi$ is smooth with compact support on $\mathbb{H}^{m}, p>m$ and $\lambda>0$. We will construct our desired
decomposition $\varphi=\varphi_{1}+\varphi_{2}$. Recall that since $p>m$, the Morrey inequality on $\mathbb{H}^{m}$ implies that

$$
\begin{equation*}
\|\varphi\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} . \tag{18}
\end{equation*}
$$

To see this, let $\zeta \in C_{c}^{\infty}(\mathbb{R})$ is a cut-off function such that $\zeta(s)=1$ if $|s| \leq 1 / 2$, and $\zeta(s)=0$ if $|s| \geq 1$. Let $x_{0}:=(0,1) \in \mathbb{H}^{m}$, and let $\zeta_{x_{0}}(x):=\zeta\left(d\left(x, x_{0}\right)\right)$, where $d$ is the hyperbolic distance on $\mathbb{H}^{m}$. Consider the localization $\zeta_{x_{0}} \varphi$ of $\varphi$, to the unit ball centered at $x_{0}$. It satisfies

$$
\begin{equation*}
\left\|\zeta_{x_{0}} \varphi\right\|_{W^{1, p}\left(\mathbb{R}^{m}\right)} \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} \tag{19}
\end{equation*}
$$

where the left-hand side is a shorthand for

$$
\left\|\zeta_{x_{0}} \varphi\right\|_{L^{p}\left(\mathbb{R}^{m}\right)}+\left\|\nabla_{e}\left(\zeta_{x_{0}} \varphi\right)\right\|_{L^{p}\left(\mathbb{R}^{m}\right)}
$$

here $\nabla_{e}$ denotes the Euclidean gradient of a function. (19) holds because by the support of $\zeta_{x_{0}}$, we have

$$
\left\|\zeta_{x_{0}} \varphi\right\|_{L^{p}\left(\mathbb{R}^{m}\right)} \simeq\left\|\zeta_{x_{0}} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} \leq\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)},
$$

and

$$
\begin{aligned}
\left\|\nabla_{e}\left(\zeta_{x_{0}} \varphi\right)\right\|_{L^{p}\left(\mathbb{R}^{m}\right)} & \leq\left\|\left(\nabla_{e} \zeta_{x_{0}}\right) \varphi\right\|_{L^{p}\left(\mathbb{R}^{m}\right)}+\left\|\zeta_{x_{0}}\left(\nabla_{e} \varphi\right)\right\|_{L^{p}\left(\mathbb{R}^{m}\right)} \\
& \leq C\left(\|\varphi\|_{L^{p}\left(\mathbb{H}^{m}\right)}+\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}\right) \\
& \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}
\end{aligned}
$$

where we have used Lemma 9 in the last inequalities (note that Lemma 9 applies now since $m \geq 2$ ). In particular, by Morrey's inequality on $\mathbb{R}^{m}$, we get, from (19), that

$$
\left|\zeta_{x_{0}}(x) \varphi(x)-\zeta_{x_{0}}(y) \varphi(y)\right| \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}|x-y|^{1-\frac{m}{p}}
$$

for all $x, y \in \mathbb{R}^{m}$. Taking $x=x_{0}$ and $y \in \mathbb{H}^{m}$ such that $d\left(y, x_{0}\right)=2$, we get that

$$
\left|\varphi\left(x_{0}\right)\right| \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} .
$$

Since the isometry group of $\mathbb{H}^{m}$ acts transitively on $\mathbb{H}^{m}$, and since the right hand side of the above inequality is invariant under isometries, we obtain

$$
|\varphi(x)| \leq C\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} .
$$

for all $x \in \mathbb{H}^{m}$, and hence (18).
In particular, in view of (18), when $\lambda \geq 1$, it suffices to take $\varphi_{1}=\varphi$ and $\varphi_{2}=0$. We then get the desired estimates for $\varphi_{1}$ and $\varphi_{2}$ trivially.

On the other hand, suppose now $0<\lambda<1$. We fix a compactly supported smooth function $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{m}\right)$, with

$$
\int_{\mathbb{R}^{m}} \eta(v) \mathrm{d} v=1
$$

For $x=\left(x^{\prime}, x_{m}\right) \in \mathbb{H}^{m}$, we define

$$
\varphi_{2}(x)=\int_{\mathbb{R}^{m}} \varphi\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) \lambda^{-m} \eta\left(\lambda^{-1} v\right) \mathrm{d} v
$$

(where we wrote $v=\left(v^{\prime}, v_{m}\right) \in \mathbb{R}^{m-1} \times \mathbb{R}$ ), and define

$$
\varphi_{1}(x)=\varphi(x)-\varphi_{2}(x)
$$

Note that $\varphi_{2}$ is smooth with compact support on $\mathbb{H}^{m}$, and hence so is $\varphi_{1}$. Now for $i=1,2, \ldots, m-1$, we have

$$
\left(e_{i} \varphi_{2}\right)(x, y)=\int_{\mathbb{R}^{m}} e^{-v_{m}}\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} u^{\prime} e^{v_{m}}, x_{m} e^{v_{m}}\right) \lambda^{-m} \eta\left(\lambda^{-1} v\right) \mathrm{d} v
$$

Since $v \mapsto \eta\left(\lambda^{-1} v\right)$ has support uniformly bounded with respect to $0<\lambda<1$, we have $e^{-v_{m}} \leq C$ on the support of the integral, where $C$ is independent of $0<\lambda<1$. Hence by Hölder's inequality, we have

$$
\begin{aligned}
& \left\|e_{i} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \\
\leq & C\left(\int_{\mathbb{R}^{m}}\left|e_{i} \varphi\right|^{p}\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) \mathrm{d} v\right)^{\frac{1}{p}}\left\|\lambda^{-m} \eta\left(\lambda^{-1} v\right)\right\|_{L^{p^{\prime}}(\mathrm{d} v)} \\
= & C \lambda^{-\frac{m}{p}}\left(\int_{\mathbb{R}_{+}^{m}}\left|e_{i} \varphi\right|^{p}(z) \frac{\mathrm{d} z}{z_{m}^{m}}\right)^{\frac{1}{p}}
\end{aligned}
$$

the last line following from the changes of variables $z_{m}=e^{v_{m}}$, and then $z^{\prime}=x^{\prime}+z_{m} v^{\prime}$. We thus see that

$$
\left\|e_{i} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \leq C \lambda^{-\frac{m}{p}}\left\|e_{i} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}
$$

as desired.
Furthermore, when $i=m$,

$$
\begin{aligned}
\left(e_{m} \varphi_{2}\right)(x)=\int_{\mathbb{R}^{m}} & {\left[\left(e_{m} \varphi\right)\left(x^{\prime}+x_{m} v^{\prime} e^{v_{m}}, x_{m} e^{v_{m}}\right)\right.} \\
& \left.+\sum_{i=1}^{m-1} v_{i}\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} v^{\prime} e^{v_{m}}, x_{m} e^{v_{m}}\right)\right] \lambda^{-m} \eta\left(\lambda^{-1} v\right) \mathrm{d} v
\end{aligned}
$$

Using that $\left|v_{i}\right| \leq C$ on the support of the integrals (uniformly in $0<$ $\lambda<1$ ), and Hölder's inequality as above, we see that

$$
\left\|e_{m} \varphi_{2}\right\|_{L^{\infty}\left(\mathbb{H}^{m}\right)} \leq C \lambda^{-\frac{m}{p}}\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)}
$$

as desired.
Finally, to estimate $\varphi_{1}$, note that

$$
\varphi(x)=\lim _{\lambda \rightarrow 0^{+}} \int_{\mathbb{R}^{m}} \varphi\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) \lambda^{-m} \eta\left(\lambda^{-1} v\right) \mathrm{d} v .
$$

Hence

$$
\begin{aligned}
\varphi_{1}(x) & =\varphi(x)-\varphi_{2}(x) \\
& =-\int_{0}^{\lambda} \int_{\mathbb{R}^{m}} \varphi\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) \frac{d}{d s}\left[s^{-m} \eta\left(s^{-1} v\right)\right] \mathrm{d} v \mathrm{~d} s
\end{aligned}
$$

But

$$
-\frac{d}{d s}\left[s^{-m} \eta\left(s^{-1} v\right)\right]=\sum_{i=1}^{m} \frac{\partial}{\partial v_{i}}\left[s^{-m}\left(v_{i} \eta\right)\left(s^{-1} v\right)\right]
$$

so we can plug this back in the equation for $\varphi_{1}$, and integrate by parts in $v$. Now
$\frac{\partial}{\partial v_{i}}\left[\varphi\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right)\right]=\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right), \quad i=1, \ldots, m-1$.
and

$$
\begin{aligned}
\frac{\partial}{\partial v_{m}}\left[\varphi\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right)\right]= & \left(e_{m} \varphi\right)\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) \\
& +\sum_{i=1}^{m-1} v_{i}\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right)
\end{aligned}
$$

Hence

$$
\begin{aligned}
& \varphi_{1}(x) \\
= & -\int_{0}^{\lambda} \sum_{i=1}^{m} \int_{\mathbb{R}^{m}}\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) s^{-m}\left(v_{i} \eta\right)\left(s^{-1} v\right) \mathrm{d} v \mathrm{~d} s \\
& -\int_{0}^{\lambda} \sum_{i=1}^{m-1} \int_{\mathbb{R}^{m}} v_{i}\left(e_{i} \varphi\right)\left(x^{\prime}+x_{m} e^{v_{m}} v^{\prime}, x_{m} e^{v_{m}}\right) s^{-m}\left(v_{i} \eta\right)\left(s^{-1} v\right) \mathrm{d} v \mathrm{~d} s .
\end{aligned}
$$

When $0<\lambda<1$, the integral in $v$ in each term can now be estimated by Hölder's inequality, yielding

$$
\begin{aligned}
\left\|\varphi_{1}\right\|_{L^{\infty}\left(\mathbb{H}^{n}\right)} & \leq \int_{0}^{\lambda} C s^{-\frac{m}{p}}\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} \mathrm{d} s \\
& =C \lambda^{1-\frac{m}{p}}\left\|\nabla_{g} \varphi\right\|_{L^{p}\left(\mathbb{H}^{m}\right)} .
\end{aligned}
$$

This completes the proof of Lemma 10 .

## Appendix A. Indirect proof of Theorem 2

We will give an alternative proof of Theorem 2 from the following variant of Theorem 1, whose proof can be found, for instance, in Van Schaftingen [9] (it can also be deduced by a small modification of the proof we gave above of Theorem (1):

Proposition 11 (Van Schaftingen [9]). Suppose $f$ is a smooth vector field on $\mathbb{R}^{n}$ (not necessarily div $f=0$ ). Then for any compactly supported smooth vector field $\phi$ on $\mathbb{R}^{n}$, we have

$$
\begin{equation*}
\left|\int_{\mathbb{R}^{n}}\langle f, \phi\rangle\right| \leq C\left(\|f\|_{L^{1}}\|\nabla \phi\|_{L^{n}}+\|\operatorname{div} f\|_{L^{1}}\|\phi\|_{L^{n}}\right), \tag{20}
\end{equation*}
$$

where $\langle\cdot, \cdot\rangle$ is the pointwise Euclidean inner product of two vector fields in $\mathbb{R}^{n}$.

To prove Theorem 2, we consider a function $\zeta \in C_{c}^{\infty}(\mathbb{R})$ and we define for $\alpha \in \mathbb{H}^{n}$ the function $\zeta_{\alpha}: \mathbb{H}^{n} \rightarrow \mathbb{R}$ by

$$
\zeta_{\alpha}(x)=\zeta(d(x, \alpha))
$$

We assume that

$$
\int_{\mathbb{H}^{n}} \zeta_{\alpha}^{2}(x) \mathrm{d} V_{g}(\alpha)=1
$$

Now given vector fields $f$ and $\phi$ as in Theorem 2, we write

$$
\int_{\mathbb{H}^{n}}\langle f, \phi\rangle_{g} \mathrm{~d} V_{g}=\int_{\mathbb{H}^{n}} \int_{\mathbb{H}^{n}}\left\langle\zeta_{\alpha} f(x), \zeta_{\alpha} \phi(x)\right\rangle_{g} \mathrm{~d} V_{g}(z) \mathrm{d} V_{g}(\alpha) .
$$

If $\alpha=(0,1) \in \mathbb{H}^{n}$, then

$$
\int_{\mathbb{H}^{n}}\left\langle\zeta_{\alpha} f(x), \zeta_{\alpha} \phi(x)\right\rangle_{g} \mathrm{~d} V_{g}=\int_{\mathbb{R}_{+}^{n}}\left\langle\zeta_{\alpha} f, \frac{\zeta_{\alpha} \phi}{x_{n}^{n+2}}\right\rangle_{e} \mathrm{~d} x,
$$

where $\langle\cdot, \cdot\rangle_{e}$ is the Euclidean inner product of two vectors. Hence by Proposition 11, this last integral is bounded by

$$
C\left(\left\|\zeta_{\alpha} f\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}\left\|\nabla_{e}\left(\frac{\zeta_{\alpha} \phi}{x_{n}^{n+2}}\right)\right\|_{L^{n}\left(\mathbb{R}^{n}\right)}+\left\|\left\langle\nabla_{e}\left(\zeta_{\alpha}\right), f\right\rangle_{e}\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}\left\|\frac{\zeta_{\alpha} \phi}{x_{n}^{n+2}}\right\|_{L^{n}\left(\mathbb{R}^{n}\right)}\right)
$$

where we write $\nabla_{e}$ to emphasize that the gradients are with respect to the Euclidean metric. Now on the support of $\zeta_{\alpha}$, we have $\left|x_{n}\right| \simeq 1$, so altogether we get

$$
\begin{align*}
& \left|\int_{\mathbb{H}^{n}}\left\langle\zeta_{\alpha} f, \zeta_{\alpha} \phi\right\rangle_{g} \mathrm{~d} V_{g}\right|  \tag{21}\\
\leq & C\left(\left\|\zeta_{\alpha} f\right\|_{L^{1}\left(\mathbb{H}^{n}\right)}+\left\|\left\langle\nabla_{g}\left(\zeta_{\alpha}\right), f\right\rangle_{g}\right\|_{L^{1}\left(\mathbb{H}^{n}\right)}\right)\left(\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}+\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}\right) .
\end{align*}
$$

This remains true even if $\alpha \neq(0,1)$, since there is an isometry mapping $\alpha$ to $(0,1)$, and since (21) is invariant under isometries of $\mathbb{H}^{n}$. By integrating with respect to $\alpha \in \mathbb{H}^{n}$, we see that

$$
\left|\int_{\mathbb{H}^{n}}\langle f, \phi\rangle_{g} \mathrm{~d} V_{g}\right| \leq C\|f\|_{L^{1}\left(\mathbb{H}^{n}\right)}\left(\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}+\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}\right) .
$$

We now use Lemma 9 to bound $\|\phi\|_{L^{n}\left(\mathbb{H}^{n}\right)}$ by $\left\|\nabla_{g} \phi\right\|_{L^{n}\left(\mathbb{H}^{n}\right)}$. This concludes our alternative proof of Theorem 2,
