# MULTI-BUMP SOLUTIONS FOR FRACTIONAL NIRENBERG PROBLEM

#### Abstract

We consider the multi-bump solutions of the following fractional Nirenberg problem $$
\begin{equation*} (-\Delta)^{s} u=K(x) u^{\frac{n+2 s}{n-2 s}}, \quad u>0 \quad \text { in } \mathbb{R}^{n} \tag{0.1} \end{equation*}
$$ where $s \in(0,1)$ and $n>2+2 s$. If $K$ is a periodic function in some $k$ variables with $1 \leq k<\frac{n-2 s}{2}$, we proved that (0.1) has multi-bump solutions with bumps clustered on some lattice points in $\mathbb{R}^{k}$ via Lyapunov-Schmidt reduction. It is also established that the equation (0.1) has an infinite-many-bump solutions with bumps clustered on some lattice points in $\mathbb{R}^{n}$ which is isomorphic to $\mathbb{Z}_{+}^{k}$.


## 1. Introduction and main results

The classic Nirenberg problem asks that on the standard sphere $\left(\mathbb{S}^{n}, g_{\mathbb{S}^{n}}\right)$ with $n \geq 2$, whether there exists a function $w$ such that the scalar curvature (Gauss curvature in the dimension 2) of the conformal metric $g=e^{w} g_{\mathbb{S} n}$ equals to a prescribed function $\tilde{K}$. This probelm is equivalent to solving the following equations

-\Delta_{g_{\mathbb{S}^{n}}} w+1=\tilde{K} e^{2 w} \text { on } \mathbb{S}^{2} \tag{1.1}
\end{equation*}
$$

and

$$
\begin{equation*}
-\Delta_{g_{\mathbb{S}^{n}}} v+\frac{n-2}{4(n-1)} R_{g_{\mathbb{S}^{n}}} v=\frac{n-2}{4(n-1)} \tilde{K} v^{\frac{n+2}{n-2}} \text { on } \mathbb{S}^{n} \text { for } n \geq 3 \tag{1.2}
\end{equation*}
$$

where $R_{g_{\mathbb{S}^{n}}}=n(n-1)$ is the scalar curvature of $\left(\mathbb{S}^{n}, g_{\mathbb{S}^{n}}\right)$ and $v=e^{\frac{n-2}{4} w}$. The linear operators defined on left-hand side of the equation (1.1) and (1.2) are called the conformal Laplacian on $\mathbb{S}^{n}$.

For any Riemannian manifold $(M, g)$, the conformal Laplacian is defined by $P_{1}^{g}=-\Delta_{g}+$ $\frac{n-2}{4(n-1)} R_{g}$, where $R_{g}$ is the scalar curvature of $(M, g)$. Let $u>0$ and $h=u^{\frac{4}{n-2}} g$, the conformal Laplacian has the following conformally invariant property

P_{1}^{g}(u \phi)=u^{\frac{n+2}{n-2}} P_{1}^{h}(\phi) \quad \text { for } \quad \phi \in C^{\infty}(M)
$$

The Paneitz operator $P_{2}^{g}$ is another interesting conformal invariant operator. It was defined in [27] by

P_{2}^{g}=\Delta_{g}^{2}+d i v_{g}\left(a_{n} R_{g} I d-b_{n} \mathcal{R} i c_{g}\right) \nabla_{g}+\frac{n-4}{2} Q_{g}
$$

[^0]where $a_{n}=\frac{(n-2)^{2}+4}{2(n-1)(n-2)}, b_{n}=-\frac{4}{n-2}$, $\mathcal{R} i c: T M \rightarrow T M$ is a $(1,1)$-tensor operator defined by $\mathcal{R i c} c_{i}^{j}=g^{j k} \operatorname{Ric}_{k i}$ and $Q_{g}=-\frac{2}{(n-2)^{2}}\left|\operatorname{Ric}_{g}\right|^{2}+\frac{n^{3}-4 n^{2}+16 n-16}{8(n-1)^{2}(n-2)^{2}} R_{g}^{2}-\frac{1}{2(n-1)} \Delta_{g} R_{g}$ which is called the $Q$-curvature of $(M, g)$.

Later on, more conformally covariant elliptic operators were found. The operator $P_{1}^{g}$ and $P_{2}^{g}$ were generalized by Graham, Jenne, Mason and Sparling in [16] to a sequence of integer order conformally covariant elliptic operators $P_{k}^{g}$ for $k \in \mathbb{N}_{+}$if $n$ is odd; and $k \in\left\{1, \ldots \frac{n}{2}\right\}$ if $n$ is even. Furthermore, any real number order conformally covariant pseudo-differential operator was intrinsically defined by Peterson in [28. Graham and Zworski in [17] proved that the operators $P_{k}^{g}$ can be considered as the residue of a meromorphic family of scattering operators $S(s)$ at $s=\frac{n}{2}+k$. Then a family of non-integer order conformally covariant pseudo-differential operators $P_{s}^{g}\left(0<s<\frac{n}{2}\right)$ were naturally defined. Using the localization method in [5], Chang and González [6] showed that for any $s \in\left(0, \frac{n}{2}\right)$, the operator $P_{s}^{g}$ can also be defined as a Dirichlet-to-Neumann operator of a conformally compact Einstein manifold.

The conformally covariant law for $P_{s}^{g}$ means that for any Riemannian manifold $(M, g)$ and a conformal transformation $h=v^{\frac{4}{n-2 s}} g, v>0$, there holds

P_{s}^{g}(v \phi)=v^{\frac{n+2 s}{n-2 s}} P_{s}^{h}(\phi) \quad \text { for } \phi \in C^{\infty}(M)
$$

Especially, $P_{s}^{g}(1)$ is called the $Q_{s}$ curvature or $s$-curvature of $(M, g)$ ( see [6] and [18] for example).
The fractional Nirenberg problem was naturally raised on $Q_{s}$ curvature, it asks that on the standard sphere $\mathbb{S}^{n}$, whether there exists a function $v>0$ such that the $Q_{s}$ curvature of the conformal metric $g=v^{\frac{4}{n-s}} g_{\mathbb{S} n}$ equals to a prescribed function $\tilde{K}$. It can be reduced to the existence of the solution of the following equation

$$
\begin{equation*}
P_{s}^{g_{S^{n}}}(v)=\tilde{K} v^{\frac{n+2 s}{n-2 s}}, \quad v>0 \text { on } \mathbb{S}^{n} \tag{1.3}
\end{equation*}
$$

where $s \in(0,1), n>2 s$ and $\tilde{K}$ is a given positive function.
It was shown in [4] that the operator $P_{s}^{g^{S_{n}}}$ is an intertwining operator and can be expressed as

$$
P_{s}^{g_{\mathbb{S}^{n}}}=\frac{\Gamma\left(B+\frac{1}{2}+s\right)}{\Gamma\left(B+\frac{1}{2}-s\right)}, \quad B=\sqrt{-\Delta_{\mathbb{S}^{n}}+\left(\frac{n-1}{2}\right)^{2}}
$$

where $\Delta_{\mathbb{S}^{n}}$ is the Beltrami-Laplacian operator. What is more, $P_{s}^{g \mathbb{S}^{n}}$ is more concrete under the stereographic projection. Let

$$
F: \mathbb{R}^{n} \rightarrow \mathbb{S}^{n} \backslash\{\mathcal{N}\}, \quad x \mapsto\left(\frac{2 x}{|x|^{2}+1}, \frac{|x|^{2}-1}{|x|^{2}+1}\right)
$$

be the inverse of stereographic projection, where $\mathcal{N}$ is the north pole of $\mathbb{S}^{n}$. Then it holds that

P_{s}^{g_{\mathbb{S}^{n}}}(\phi) \circ F=\left|J_{F}\right|^{-\frac{n+2 s}{2 n}}(-\Delta)^{s}\left(\left|J_{F}\right|^{\frac{n-2 s}{2 n}}(\phi \circ F)\right)
$$

where $(-\Delta)^{s}$ is the fractional Laplacian defined by

$$
(-\Delta)^{s} \phi(x)=C(n, s) P . V . \int_{\mathbb{R}^{n}} \frac{\phi(x)-\phi(y)}{|x-y|^{n+2 s}} d y, \quad \text { where } \phi \in C^{\infty}\left(\mathbb{R}^{n}\right)
$$

If we write $u=\left|J_{F}\right|^{\frac{n-2 s}{2 n}}(v \circ F)$ and $K=\tilde{K} \circ F$, the equation (1.3) is transformed into

$$
\begin{equation*}
(-\Delta)^{s} u=K(x) u^{\frac{n+2 s}{n-2 s}}, \quad u>0 \text { in } \mathbb{R}^{n} \tag{1.4}
\end{equation*}
$$

where $s \in(0,1)$ and $n>2 s$. The existence of the solutions to the problem (1.3) has been proved under various conditions(see for exmaple [1,2,7,9, 11, 18, 19). The compactness of the solutions to (1.3) was studied in [18]. Chen and Zheng [10] found a 2-peak solution when $K(x)=1+\varepsilon \tilde{K}(x)$ has at least two critical points and satisfies some local conditions. What is more, Liu in [25] constructed infinitely many 2-peak solutions when $K$ has a sequence of strictly local maximum points moving to infinity. When $K$ is a radial symmetric function, in [24] and [26] it was showed that (1.4) has infinitely many non-radial solutions.

In this paper, we continue to study the bump solutions or peak solutions of (1.4). Assume that $K$ satisfies the following conditions
$\left(H_{1}\right) 0<\inf _{\mathbb{R}^{n}} K \leq \sup _{\mathbb{R}^{n}} K<\infty$;
$\left(H_{2}\right) K(x)$ is a $C^{1,1}$ function, and 1-periodic in the first $k$ variables $x_{1}, \cdots, x_{k}$;
$\left(H_{3}\right) 0$ is a critical point of $K$, and in a neighborhood of 0 , there is a number $\beta \in(n-2 s, n)$ such that

$$
K(x)=K(0)+\sum_{i=1}^{n} a_{i}\left|x_{i}\right|^{\beta}+R(x),
$$

where $a_{i} \neq 0$ for $i=1, \ldots, n, \sum_{i=1}^{n} a_{i}<0, R(y) \in C^{[\beta]-1,1}$ and $\sum_{j=0}^{[\beta]}\left|\nabla^{j} R(y) \| y\right|^{-\beta+j}=o(1)$ as $y \rightarrow 0$. Here $\nabla^{j} R(y)$ denote all of the possible derivatives of $R(y)$ of the order $j$.

We note that the conditions $\left(H_{1}\right)-\left(H_{3}\right)$ and the condition $(\mathcal{K})$ in [25] has some intersecion. When $K$ satisfies both the condition ( $\mathcal{K}$ ) in [25] and our conditions $\left(H_{1}\right)-\left(H_{3}\right)$, the equation (1.4) has infinitely many 2 -peak solutions according to [25.

In this paper, we will show that equation (1.4) has solutions with large number bumps and its bumps located near some lattice points in $\mathbb{R}^{k}$ with $1 \leq k<\frac{n-2 s}{2}$.

Let $Q_{m}:=\left([0, m+1)^{k} \times \mathbf{0}\right) \cap \mathbb{Z}^{n}$, where $m \in \mathbb{N}_{+} \cup\{\infty\}$ and $\mathbf{0}$ is a zero vector in $\mathbb{R}^{n-k}$.
Theorem 1.1. Suppose $n>2 s+2, m \in \mathbb{N}_{+} \cup\{\infty\}$ and $1 \leq k<\frac{n-2 s}{2}$. If $K$ satisfies the conditions $\left(H_{1}\right)-\left(H_{3}\right)$, there exists an integer $l_{0} \in \mathbb{N}$, such that for any integer $l>l_{0}$, the equation (1.4) has a solution with its bumps clustered on $l Q_{m}$.

Notice that $Q_{\infty}$ is an infinite lattice which isomorphic to $\mathbb{Z}_{+}^{k}$. So we get an infinite-many-bump solution of the equation (1.5) via Theorem 1.1.

In order to prove Theorem 1.1, we assume $K(0)=1$ with no loss of generality. For any positive integer $l$, define $\lambda=l^{\frac{n-2 s}{\beta-n+2 s}}$. Then we have $\lambda^{\beta}=(\lambda l)^{n-2 s}$. Using the transformation $u(x) \mapsto \lambda^{-\frac{n-2 s}{2}} u\left(\frac{x}{\lambda}\right)$, we can change the equation (1.4) into

\begin{equation*}
(-\Delta)^{s} u=K\left(\frac{x}{\lambda}\right) u^{\frac{n+2 s}{n-2 s}}, u>0, \text { in } \mathbb{R}^{n} . \tag{1.5}
\end{equation*}
$$

The functional corresponding to equation (1.5) is

$$
I(u)=\frac{1}{2} \int_{\mathbb{R}^{n}}\left|(-\Delta)^{\frac{s}{2}} u\right|^{2}-\frac{n-2 s}{2 n} \int_{\mathbb{R}^{n}} K\left(\frac{x}{\lambda}\right)\left(u_{+}\right)^{\frac{2 n}{n-2 s}}, \quad u \in \dot{H}^{s}\left(\mathbb{R}^{n}\right),
$$

where $u_{+}=\max \{u, 0\}$. The Hilbert space $\dot{H}^{s}\left(\mathbb{R}^{n}\right)$ is the completion of $C_{0}^{\infty}\left(\mathbb{R}^{n}\right)$ under the Gagliardao semi-norm (cf. [15] for detail)

$$
[u]_{\dot{H}^{s}\left(\mathbb{R}^{n}\right)}:=\left(\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{n+2 s}}\right)^{\frac{1}{2}}=\left(2 C(n, s) \int_{\mathbb{R}^{n}}\left|(-\Delta)^{\frac{s}{2}}\right|^{2}\right)^{\frac{1}{2}},
$$

where $C(n, s)$ is a constant depending on $n$ and $s$. It is well known that $\dot{H}^{s}\left(\mathbb{R}^{n}\right)$ can be imbedded into $L^{2^{*}(s)}\left(\mathbb{R}^{n}\right)$ and the following Hardy-Littlewood-Sobolev inequality holds

\begin{equation*}
S\left(\int_{\mathbb{R}^{n}}|u|^{2^{*}(s)}\right)^{\frac{2}{2^{*(s)}}} \leq \int_{\mathbb{R}^{n}}\left|(-\Delta)^{\frac{s}{2}} u\right|^{2}, \quad \text { for } u \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right) \tag{1.6}
\end{equation*}
$$

where $s \in(0,1), n>2 s$ and $2^{*}(s)=\frac{2 n}{n-2 s}$. Lieb [23] proved that the extremals corresponding to the best constant $S$ of (1.6) are of the form

$$
U_{\xi, \Lambda, C_{0}}=C_{0}\left(\frac{\Lambda}{1+\Lambda^{2}|x-\xi|^{2}}\right)^{\frac{n-2 s}{2}}
$$

where $C_{0}, \Lambda \in \mathbb{R}_{+}$and $\xi \in \mathbb{R}^{n}$.
Choosing a suitable constant $C_{0}=C_{0}(n, s)$, we see that the function $U_{\xi, \Lambda}:=U_{\xi, \Lambda, C_{0}}$ solves the equation

$$
\begin{equation*}
(-\Delta)^{s} u=u^{\frac{n+2 s}{n-2 s}}, \quad u>0 \text { in } \mathbb{R}^{n} \tag{1.7}
\end{equation*}
$$

Under some decay assumptions, $8,20,22$ proved that all the solutions of (1.7) are only of the form $U_{\xi, \Lambda}$. Furthermore, it was proved in [13] that the solution $U_{\xi, \Lambda}$ of the equation (1.7) is nondegenerate, i.e. any bounded solution of the equation $(-\Delta)^{s} \phi=\frac{n+2 s}{n-2 s} U_{\xi, \Lambda}^{\frac{4 s}{n-2 s}} \phi$ is a linear combination of $\frac{\partial U_{\xi, \Lambda}}{\partial \Lambda}$ and $\frac{\partial U_{\xi, \Lambda}}{\partial \xi_{i}}, i=1,2 \ldots, n$.

We will use the functions $U_{\xi, \Lambda}$ to construct the approximate solutions of the equation (1.5). We define $X_{l, m}=\left\{\lambda l x \mid x \in Q_{m}\right\}$ and arrange it in any way as a sequence $X_{l, m}=\left\{X^{i}\right\}_{i=1}^{(m+1)^{k}}$. Let $P^{i} \in B_{\frac{1}{2}}\left(X^{i}\right)=\left\{X \in \mathbb{R}^{n}| | X-X^{i} \left\lvert\,<\frac{1}{2}\right.\right\}, \Lambda_{i} \in\left[C_{1}, C_{2}\right]$, for $i=1,2 \ldots,(m+1)^{k}$, where $C_{1}$ and $C_{2}$ are some positive numbers to be defined later( see (3.6)). Let

$$
W_{m}(x):=\sum_{i=1}^{(m+1)^{k}} U_{P^{i}, \Lambda_{i}}(x)
$$

to be an approximate solution of the problem (1.5).
Theorem 1.2. Under the same conditions of Theorem 1.1, there exists an interger $l_{0}>0$, such that for any integer $l>l_{0}$, equation (1.5) has a $C_{\text {loc }}^{2}$ solution $u_{m}$ of the form

$$
u_{m}=W_{m}+\phi_{m},
$$

where $m \in \mathbb{N}_{+} \cup\{\infty\},|\phi|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \rightarrow 0$ and $\max _{i=1, \ldots,(m+1)^{k}}\left\{\left|P^{i}-X^{i}\right|\right\} \rightarrow 0$ as $l \rightarrow \infty$.
As a consequence of Theorem 1.2, we have
Corollary 1.3. Under the same conditions of Theorem [1.1, the equation (1.4) has infinitely many multi-bump solutions.

Theorem 1.1 follows from Theorem 1.2. So we only need to prove Theorem 1.2, In this article we use $l$ as the pertubation parameter and follow the methods developed in [21, 29]. In the section 2, we carry out the Liapunov-Schmidt reduction. Theorem 1.2 is proved in the section 3. Some useful estimations are presented in Appendix A. The expansions of the functional $\frac{\partial}{\partial \Lambda_{i}} I\left(W_{m}\right)$ and $\frac{\partial}{\partial P_{j}} I\left(W_{m}\right)$ are shown in Appendix B.

In this article, $\stackrel{3}{C}$ denotes a varying constant independent of $m$.

## 2. Finite dimensional Reduction

In this section, we will carry out the Lyapunov-Schmidt reduction in the case of $m<\infty$. We define two weighted norms

\|u\|_{*}=\sup _{y \in \mathbb{R}^{n}}\left(\gamma(y) \sum_{i=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{i}\right|\right)^{\frac{n-2 s}{2}+\tau}}\right)^{-1}|u(y)|,
$$

and

$$
\|u\|_{* *}=\sup _{y \in \mathbb{R}^{n}}\left(\gamma(y) \sum_{i=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{i}\right|\right)^{\frac{n+2 s}{2}+\tau}}\right)^{-1}|u(y)|,
$$

where

$$
\gamma(y)=\min \left\{\min _{i=1, \ldots,(m+1)^{k}}\left(\frac{1+\left|y-X^{i}\right|}{\lambda}\right)^{\tau-s}, 1\right\},
$$

and $\tau \in\left(k, \frac{n-2 s}{2}\right)$ is a constant.
Consider the following equation

$$
\begin{equation*}
(-\Delta)^{s} \phi-\frac{n+2 s}{n-2 s} K\left(\frac{x}{\lambda}\right) W_{m}^{\frac{4 s}{n-2 s}} \phi=g \text { in } \mathbb{R}^{n} . \tag{2.1}
\end{equation*}
$$

Lemma 2.1. Let $\phi$ be a solution of the equation (2.1), then we have the following estimate

$$
\begin{align*}
&\left(\gamma(y) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau}}\right)^{-1}|\phi(y)| \\
& \leq C\|g\|_{* *}+C\|\phi\|_{*}\left(\frac{1}{(\lambda l)^{\frac{4 s}{n-2 s} k}} \frac{\sum_{h=1}^{(m+1)^{k}}}{\sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau+\theta}}}\right)  \tag{2.2}\\
&\left(1+\left|y-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau}
\end{align*},
$$

where $\theta>0$ is a constant and $C$ is independent of $m$.
Proof. We rewrite the equation (2.1) into an integral equation

$$
\begin{equation*}
\phi(y)=C_{1}(n, s) \int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}}\left(\frac{n+2 s}{n-2 s} K\left(\frac{z}{\lambda}\right) W_{m}^{\frac{4 s}{n-2 s}}(z) \phi(z)+g(z)\right) d z, \tag{2.3}
\end{equation*}
$$

where the constant $C_{1}(n, s)$ is defined in the Green function of $(-\Delta)^{s}$ on $\mathbb{R}^{n}$ (cf. [5]).

From Lemma A.5, we get

\begin{align*}
& \left|\int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}} K\left(\frac{z}{\lambda}\right) W_{m}^{\frac{4 s}{n-2 s}}(z) \phi(z) d z\right| \\
\leq & C\|\phi\|_{*} \int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}} W_{m}^{\frac{4 s}{n-2 s}}(z) \gamma(z) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|z-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau}} d z \\
\leq & C\|\phi\|_{*}\left(\gamma(y) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau+\theta}}\right. \\
& \left.+\frac{1}{(\lambda l)^{\frac{4 s}{n-2 s} k}} \gamma(y) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|y-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau}}\right) . \tag{2.4}
\end{align*}
$$

For the second term on the right-hand side of (2.3), we have

\int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}}|g(z)| d z \leq\|g\|_{* *} \int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}} \gamma(z) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|z-X^{h}\right|\right)^{\frac{n+2 s}{2}+\tau}} d z \tag{2.5}
\end{equation*}
$$

Using Lemma A.2, we obtain

\int_{\mathbb{R}^{n}} \frac{1}{|y-z|^{n-2 s}} \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|z-X^{h}\right|\right)^{\frac{n+2 s}{2}+\tau}} d z \leq C \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|z-X^{h}\right|\right)^{\frac{n-2 s}{2}+\tau}} \tag{2.6}
\end{equation*}
$$

Define $B_{i}:=B_{\lambda l}\left(X^{i}\right), B_{i, m}:=B_{r_{0}}\left(X^{i}\right)$ with $r_{0}=\max \left\{\frac{m}{4}, 1\right\}$ and

$$
\Omega_{i}:=\left\{z \in \mathbb{R}^{n}:\left|z-X^{i}\right|=\min _{j=1, \ldots,(m+1)^{k}}\left|z-X^{j}\right|\right\}
$$

Without loss of generality, we assume $y \in \Omega_{1}$. Make use of Lemma A. 3 under different cases, we have

\begin{equation*}

\leq & \frac{C}{\lambda^{\frac{n+2 s}{2}-\tau}} \gamma(y) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|x-X^{h}\right|\right)^{\frac{n+2 s}{2}+\tau}} . \tag{2.18}
\end{align*}
$$

Summarizing (2.17) and (2.18), we have

In order to use the contraction map theorem, we define $A \varphi:=L_{m}\left(N(\varphi)+l_{m}\right)$, where $L_{m}$ is an operator defined in Proposition 2.3 ,

Firstly, we show that $A$ maps $E$ into itself for $\lambda$ large. Combining Proposition 2.3 and Lemma [2.4. we have $\forall \varphi \in E$,

\leq & C\left(\left\|\varphi_{1}\right\|_{*}^{\frac{4 s}{n-2 s}}+\left\|\varphi_{2}\right\|_{*}^{\frac{4 s}{n-2 s}}\right)\left\|\varphi_{1}-\varphi_{2}\right\|_{*}\left(\gamma(x) \sum_{h=1}^{(m+1)^{k}} \frac{1}{\left(1+\left|x-X^{h}\right|\right)^{\frac{n+2 s}{2}+\tau}}\right) .
\end{aligned}

We remind that in the last inequality, we have used the Hölder inequality. Hence $\| N\left(\varphi_{1}\right)-$ $N\left(\varphi_{2}\right)\left\|_{* *} \leq C\left(\left\|\varphi_{1}\right\|_{*}^{\frac{4 s}{n-2 s}}+\left\|\varphi_{2}\right\|_{*}^{\frac{4 s}{n-2 s}}\right)\right\| \varphi_{1}-\varphi_{2} \|_{*}$.

For $\lambda$ large enough, we get $\left\|A \varphi_{1}-A \varphi_{2}\right\|_{*} \leq \frac{1}{2}\left\|\varphi_{1}-\varphi_{2}\right\|_{*}$.
Using the contracting map theorem, we know that there is a unique $\phi_{m} \in E$, such that $A\left(\phi_{m}\right)=\phi_{m}$, i.e. $\phi_{m}$ is a unique solution of (2.15) in $E$. From Proposition 2.3 and Lemma 2.4, we know $\phi_{m} \in \dot{H}^{s}\left(\mathbb{R}^{n}\right) \cap C^{0, \alpha}\left(\mathbb{R}^{n}\right)$ satisfying $\left\|\phi_{m}\right\|_{*}=\left\|A \phi_{m}\right\|_{*} \leq \frac{C}{\lambda^{\frac{n+2 s}{2}-\tau}}$ and $\left|c_{i j}^{(m)}\right| \leq C \lambda^{-\frac{n}{2}}$, since $\left(\frac{n+2 s}{2}-\tau-\epsilon_{1}\right) \min \left\{2,2^{*}(s)-1\right\}>\frac{n+2 s}{2}-\tau$.

## 3. Proof of the main theorem

We define $J(P, \Lambda)=I\left(W_{m}+\phi_{m}\right)$, where $\phi_{m}$ is a unique small solution obtained by Proposition 2.5, A standard argument shows that from a critical point of $J$, we can get a critical point of $I$ of the form $W_{m}+\phi_{m}$ (for example, cf. [14, Lemma 6.1] for ideas).
Proposition 3.1. For $\lambda$ large, we have the following expansions

The functional $\frac{\partial I}{\partial P_{j}^{i}}\left(W_{m}\right)$ is expanded in the Proposition B.6. So we only need to estimate the last two terms in the eqality above.

From Lemma A.4, we see that for $\lambda$ large enough, $\left\{x: W_{m} \leq-\phi_{m}\right\} \subset\left\{x: \frac{1}{2} W_{m} \leq\left|\phi_{m}\right|\right\} \subset$ $\cup_{h}\left(\Omega_{h} \cap B_{h}^{c}\right)$. Then we have

\left|\left(D^{2} F(b) x\right)_{i_{0}}\right| & =\left|c_{2} \sum_{h \neq i_{0}} A_{i_{0} h} x_{h}-c_{1}\left(\frac{2 \beta}{n-2 s}-1\right) b_{i_{0}}^{\frac{2 \beta}{n-2 s}-2} x_{i_{0}}\right| \\
& \geq c_{1}\left(\frac{2 \beta}{n-2 s}-1\right) b_{i_{0}}^{\frac{2 \beta}{n-2 s}-2}\left|x_{i_{0}}\right|-c_{2}\left|\sum_{h \neq i} A_{i_{0} h} x_{h}\right| \\
& \geq c_{1}\left(\frac{2 \beta}{n-2 s}-1\right) b_{i_{0}}^{\frac{2 \beta}{n-2 s}-1}\left|\frac{x_{i_{0}}}{b_{i_{0}}}\right|-c_{2} \sum_{h \neq i} A_{i_{0} h} b_{h}\left|\frac{x_{i_{0}}}{b_{i_{0}}}\right| \\
& =c_{1}\left(\frac{2 \beta}{n-2 s}-2\right) b_{i_{0}}^{\frac{2 \beta}{n-2 s}-2}\left|x_{i_{0}}\right| \geq C_{4}\|x\|_{0} .

From the definition of $\|\cdot\|_{0}$, we get $\left\|D^{2} F(b) x\right\|_{0} \geq C_{4}\|x\|_{0}$.
Let $\theta=\left(\theta_{1}, \ldots, \theta_{(m+1)^{k}}\right) \in \mathbb{R}^{(m+1)^{k}}$ whose component $\theta_{i}:=d_{i}-b_{i}, i=1, \ldots,(m+1)^{k}$. We define $X:=\left(X^{1}, \ldots, X^{(m+1)^{k}}\right) \in \mathbb{R}^{n \times(m+1)^{k}}$, in which $X^{i}=\left(X_{1}^{i}, \ldots, X_{n}^{i}\right) \in \mathbb{R}^{n}$ for $i=$ $1, \ldots,(m+1)^{k}$. For any $Y=\left(Y^{1}, \ldots, Y^{(m+1)^{k}}\right) \in \mathbb{R}^{n \times(m+1)^{k}}$, we use the notation $\|Y\|:=$ $\max _{i=1, \ldots,(m+1)^{k}}\left\{\left|Y^{i}\right|\right\}$ to denote the maximum norm.

To simplify the equations (3.4), we need to define some vector value functions below. Let $\Xi^{(1)}:=\Xi^{(1)}(P, \Lambda, \lambda) \in \mathbb{R}^{n \times(m+1)^{k}}$ and $\Theta^{(1)}:=\Theta^{(1)}(P, \Lambda, \lambda) \in \mathbb{R}^{n \times(m+1)^{k}}$ with their exponents defined by

Let $\Xi^{(2)}:=\Xi^{(2)}(P, \Lambda, \lambda) \in \mathbb{R}^{(m+1)^{k}}, \Theta^{(2)}:=\Theta^{(2)}(P, \Lambda, \lambda) \in \mathbb{R}^{(m+1)^{k}}$ with exponents defined by $\left(\Xi^{(2)}\right)^{i}=\Lambda_{i}^{\frac{n-2 s}{2}+1} \Xi_{n+1}^{i} \frac{\left|P^{i}-X^{i}\right|^{\min \{2, \beta-1\}}}{\|P-X\|^{\min \{2, \beta-1\}}} \quad$ and $\quad\left(\Theta^{(2)}\right)^{i}=\Lambda_{i}^{\frac{n-2 s}{2}+1} \Theta_{n+1}^{i}, \quad i=1, \ldots,(m+1)^{k}$.
Define $\Pi(\theta):=\left(\Pi(\theta)^{1}, \ldots, \Pi(\theta)^{(m+1)^{k}}\right)$, where $\Pi(\theta)^{i}\left(i=1, \ldots,(m+1)^{k}\right)$ is defined by

From their definition, we know there is a constant $C$ and a constant $C_{\lambda}$ satisfying $C_{\lambda} \rightarrow 0$ as $\lambda \rightarrow \infty$ such that $\left\|\Xi^{(1)}\right\| \leq C,\left\|\Xi^{(2)}\right\|_{0} \leq C ;\left\|\Theta^{(1)}\right\| \leq C_{\lambda}$ and $\left\|\Theta^{(2)}\right\|_{0} \leq C_{\lambda}$.

Using these notations and Taylor expansion, we can write the equations (3.4) into another form:

For each $(P, \theta) \in B$, Choose $C_{\lambda}$ small enough, we have

Since $C_{\lambda} \rightarrow 0$ as $\lambda \rightarrow \infty$, so for $\lambda$ large enough, we use the Brouwer fixed-point theorem to get a solution $\left(P^{1}, \ldots, P^{(m+1)^{k}}, \theta\right)$ of (3.7) in $B$. It holds that

& \geq \int_{\mathbb{R}^{n}}\left|(-\Delta)^{\frac{s}{2}} u_{m}^{-}\right|^{2} d x .

The Hardy-Littlewood-Sobolev inequality yields

Suppose $u_{m}^{-} \not \equiv 0$, we have $\int_{\mathbb{R}^{n}}\left|u_{m}^{-}\right|^{\frac{2 n}{n-2 s}} d x \geq C$. It is easy to get $u_{m}^{-} \leq\left|\phi_{m}\right|$. From this fact,

& \leq\left\|\phi_{m}\right\|_{*}^{\frac{2 n}{n-2 s}} C(m, k) \sum_{h} \int_{\mathbb{R}^{n}} \frac{1}{\left(1+\left|x-X^{h}\right|\right)^{n+\frac{2 n}{n-2 s} \tau}} d x .

So we get $C \leq \int_{\mathbb{R}^{n}}\left|u_{m}^{-}\right|^{\frac{2 n}{n-2 s}} d x \leq C(m, k)\left\|\phi_{m}\right\|_{*} \rightarrow 0$ as $\lambda \rightarrow \infty$, which is impossible. Hence $u_{m} \geq 0$. Suppose there is a point $x_{0}$ such that $u_{m}\left(x_{0}\right)=0$, then

Then $u_{m} \equiv 0$ which is impossible. Hence $u_{m}>0$.
According to Proposition [2.5, $u_{m}=W_{m}+\phi_{m} \in C^{0, \alpha}\left(\mathbb{R}^{n}\right) \cap \dot{H}^{s}\left(\mathbb{R}^{n}\right)$. Using local Schauder estimate [18, Proposition 2.11] and a bootstrap argument, we know $u_{m} \in C_{l o c}^{2, \alpha^{\prime}}\left(\mathbb{R}^{n}\right)$, for some $\alpha^{\prime} \in(0,1)$.

What is more, $\left|u_{m}\right|_{L^{\infty}}\left(\mathbb{R}^{n}\right) \leq C$ with $C$ independent of $m$. In fact, Choosing $x \in \Omega_{1}$ with no loss of generality, we have

Since $\phi_{m}$ satisfies the equation $(-\Delta)^{s} \phi_{m}-\frac{n+2 s}{n-2 s} K\left(\frac{x}{\lambda}\right) W_{m}^{\frac{4 s}{n-2 s}} \phi_{m}=N\left(\phi_{m}\right)+l_{m}$, then from Lemma A.8, Lemma 2.4 and Proposition 2.5, we know that for any $x, y \in \mathbb{R}^{n}$ with $x \neq y$, there holds

Also from simple calculation, we get for any $x \in \mathbb{R}^{n}$ and $R>0,\left\|W_{m}\right\|_{C^{0, \alpha}\left(B_{2 R}(x)\right)} \leq C(n, R)$, where $C(n, R)$ is a constant independent of $m$. Hence $\left\|u_{m}\right\|_{C^{0, \alpha}\left(B_{2 R}(x)\right)} \leq C(n, R)$. Local Schauder estimate and a bootstrip argument yields that $\left\|u_{m}\right\|_{C^{2, \alpha^{\prime}\left(B_{R}(x)\right)}} \leq C(n, R)$. Thanks to Azellà-Ascolli theorem, we have $u_{m}$ convergent uniformly to a $C_{l o c}^{2, \alpha^{\prime}}$ function $u_{\infty}=W_{\infty}+\phi_{\infty}$ on compact sets as $m \rightarrow \infty$. We know $u_{\infty}$ satisfies $\left|u_{\infty}\right|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \leq C$ and $\left\|u_{\infty}\right\|_{C^{2, \alpha^{\prime}}\left(B_{R}(x)\right)} \leq C(n, R)$.

We will show that $u_{\infty}$ satisfies the equation (1.5). Let $v_{m}=u_{m}-u_{\infty}$. From above, we know $v_{m}$ has the property $\left|v_{m}\right|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \leq C ;\left|v_{m}\right|_{C^{2}\left(B_{1}(x)\right)} \leq C$ and $v_{m} \rightarrow 0$ uniformly on compact sets.

From the definition of $(-\Delta)^{s}$, we have for any $x \in \mathbb{R}^{n}$

& +\int_{\mathbb{R}^{n} \backslash B_{R}(x)} \frac{\left|v_{m}(x)-v_{m}(y)\right|}{|x-y|^{n+2 s}} d y \\
= & T_{1}+T_{2}+T_{3} .

For the term $T_{1}$, we have

For the third term,

Then we estimate the term $T_{2}$. For fixed $R$ large enough and $\varepsilon_{0}$ small enough, $B_{R}(x) \backslash B_{\varepsilon_{0}}(x)$ is a compact set. So we have $T_{2} \rightarrow 0$ as $m \rightarrow \infty$. Hence $(-\Delta)^{s} u_{m}(x) \rightarrow(-\Delta)^{s} u_{\infty}(x)$ as $m \rightarrow \infty$. Therefore $u_{\infty}$ satisfies equation (1.5).

Proof of Corollary 1.3. Fix the constant $m<\infty$. Using a similar argument as in [29], we can expand $I\left(W_{m}+\phi_{m}\right)$ as

For any $m_{1}, m_{2} \in \mathbb{N}_{+}$such that $m_{1} \neq m_{2}$, we can find two solutions $W_{m_{1}}+\phi_{m_{1}}$ and $W_{m_{2}}+\phi_{m_{2}}$ of (1.5), such that $I\left(W_{m_{1}}+\phi_{m_{1}}\right) \neq I\left(W_{m_{2}}+\phi_{m_{2}}\right)$. Hence we can find infinitely many solutions of (1.5).

= & \int_{\mathbb{R}^{n}} K\left(\frac{x}{\lambda}\right) U_{P^{-}, \Lambda_{i}}^{\frac{n+2 s}{n-2 s}} \frac{\partial U_{P^{i}, \Lambda_{i}}}{\partial \Lambda_{i}}+\frac{n+2 s}{n-2 s} \int_{\mathbb{R}^{n}} K\left(\frac{x}{\lambda}\right) U_{P^{-}, \Lambda_{i}}^{\frac{4 s}{n-2 s}} \sum_{h \neq i} U_{P^{h}, \Lambda_{h}} \frac{\partial U_{P^{i}, \Lambda_{i}}}{\partial \Lambda_{i}}  \tag{B.12}\\
& +O\left((\lambda l)^{-n}\right) .
\end{align*}
$$

Now Lemma B. 1 follows from the estimate (B.3), (B.8) and (B.12).

Choose $\delta$ to be a fixed constant some enough. Since $n>4 s>n+2 s-\beta$, the condition $\left(H_{3}\right)$ implies

\leq & \frac{C}{\lambda^{\beta} \mid X^{i}-X^{h} n^{n-2 s}} \int_{B_{\delta \lambda}\left(X^{h}\right)} \frac{\left|x-X^{h}\right|^{\beta}}{\left(1+\left|x-X^{h}\right|\right)^{n+2 s}} \leq \frac{C}{\lambda^{2 s}\left|X^{i}-X^{h}\right|^{n-2 s}} . \tag{B.15}

+O\left(\frac{\left|P^{i}-X^{i}\right|^{2}}{\lambda^{\beta}}\right)+o\left(\lambda^{-\beta}\right) \tag{B.19}

Then we get

= & \frac{1}{\lambda} \int_{\mathbb{R}^{n}} \frac{\partial K}{\partial t_{j}}\left(\frac{x+P^{i}}{\lambda}\right) U_{0, \Lambda_{i}}^{\frac{n+2 s}{n-2 s}} U_{P^{h}-P^{i}, \Lambda_{h}}-\int_{\mathbb{R}^{n}} K\left(\frac{x+P^{i}}{\lambda}\right) U_{0, \Lambda_{i}}^{\frac{n+2 s}{n-2 s}} \frac{\partial U_{P^{h}-P^{i}, \Lambda_{h}}}{\partial P_{j}^{i}} \\

& \leq \sum_{h \neq i} \frac{C}{\left|X^{h}-X^{i}\right|^{n-s}} \int_{\mathbb{R}^{n}} \frac{1}{\left(1+\left|y-X^{h}\right|\right)^{n+s+1}} \\
& \leq C(\lambda l)^{-(n-s)} . \tag{B.24}
\end{align*}

Then the expansion of $\frac{\partial I}{\partial P_{j}^{i}}\left(W_{m}\right)$ follows from (B.19) $(\overline{\mathrm{B} .20)}$, (B.21), (B.22), (B.23) and (B.24).
