# Viscous Aubry-Mather theory and the Vlasov equation

#### Abstract

The Vlasov equation models a group of particles moving under a potential $V$; moreover, each particle exerts a force, of potential $W$, on the other ones. We shall suppose that these particles move on the $p$ dimensional torus $\mathbf{T}^{p}$ and that the interaction potential $W$ is smooth. We are going to perturb this equation by a Brownian motion on $\mathbf{T}^{p}$; adapting to the viscous case methods of Gangbo, Nguyen, Tudorascu and Gomes, we study the existence of periodic solutions and the asymptotics of the Hopf-Lax semigroup.


## Introduction

The Vlasov equation models the motion of a group of particles under the action of a time-dependent potential $V$ and a mutual interaction $W$. For definiteness, we shall suppose that the particles move on the torus $\mathbf{T}^{p}:=\frac{\mathbf{R}^{p}}{\mathbf{Z}^{p}}$; we put on the position and velocity space $\mathbf{T}^{p} \times \mathbf{R}^{p}$ the coordinates ( $x, v$ ) and we suppose that, at time $t$, the particles are distributed on $\mathbf{T}^{p} \times \mathbf{R}^{p}$ according to a probability measure $f_{t}$. Then, the Vlasov equation has the form

\end{equation*}
$$

where

$$
P(t, x)=V(t, x)+\int_{\mathbf{T}^{p} \times \mathbf{R}^{p}} W\left(x-x^{\prime}\right) \mathrm{d} f_{t}\left(x^{\prime}, v^{\prime}\right)
$$

and $\langle\cdot, \cdot\rangle$ denotes the scalar product in $\mathbf{R}^{p}$. Since [7], one looks for weak solutions of $(V L)_{\infty}$; in other words, given an initial distribution $f_{0}$, one looks for a continuous curve of probability measures $f_{t}$ satisfying

\end{gathered}

for all $\phi \in C_{0}^{\infty}\left([0,+\infty) \times \mathbf{T}^{p} \times \mathbf{R}^{p}\right)$.
Our hypotheses on $V$ and $W$ are the following:

1) $V \in C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right)$, and
2) $W \in C^{3}\left(\mathbf{T}^{p}\right)$. Thus, $W$ lifts to a $C^{3}$ function on $\mathbf{R}^{p}, \mathbf{Z}^{p}$-periodic; we shall also suppose that $W(x)=$ $W(-x)$ and that $W(0)=0$.

A recent idea (see [11], [12]) is to view $(V L)_{\infty}$ as a Lagrangian system in the space of measures; indeed, it is possible to define what it means for a curve $\mu_{t}$ of probability measures on $\mathbf{T}^{p}$ to minimize the Lagrangian action

\int_{t_{0}}^{t_{1}}\left[\frac{1}{2}\left\|\dot{\mu}_{t}\right\|^{2}+\int_{\mathbf{T}^{p}} V(t, x) \mathrm{d} \mu_{t}+\frac{1}{2} \int_{\mathbf{T}^{p} \times \mathbf{T}^{p}} W\left(x-x^{\prime}\right) \mathrm{d}\left(\mu_{t} \times \mu_{t}\right)\left(x, x^{\prime}\right)\right] \mathrm{d} t . \tag{1}
\end{equation*}

The advantages are that one can use the tools of Lagrangian dynamics (Aubry-Mather theory, HamiltonJacobi equations, minimal characteristics, etc...) albeit in the difficult "differential manifold" of probability measures.

In this paper, we are going to adapt to the viscous case an older approach: following [7], we jury-rig a fixed point theorem to the viscous Mather theory of [13]. Let us briefly outline what we are doing in the case of periodic orbits.

We let $\psi(t, x)$ be a continuous family of densities, periodic in time; in other words, we ask that
d1) $\psi \in C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$
d2) $\psi \geq 0$
d3) $\int_{\mathbf{T}^{p}} \psi(t, x) \mathrm{d} x=1$ for all $t \in \mathbf{T}$.
Let us define

P_{\psi}(t, x)=V(t, x)+\int_{\mathbf{T}^{p}} W\left(x-x^{\prime}\right) \psi\left(t, x^{\prime}\right) \mathrm{d} x^{\prime}
$$

and, for $c \in \mathbf{R}^{p}$, let us set

\begin{gathered}
\mathcal{L}_{c, \psi}: \mathbf{T} \times \mathbf{T}^{p} \times \mathbf{R}^{p} \rightarrow \mathbf{R}, \quad \mathcal{L}_{c, \psi}(t, x, \dot{x})=\frac{1}{2}|\dot{x}|^{2}-\langle c, \dot{x}\rangle-P_{\psi}(t, x) \\
H_{\psi}: \mathbf{T} \times \mathbf{T}^{p} \times \mathbf{R}^{p} \rightarrow \mathbf{R}, \quad H_{\psi}(t, x, p)=\frac{1}{2}|p|^{2}+P_{\psi}(t, x) .
\end{gathered}
$$

We have the following.

Theorem 1. Let $c \in \mathbf{R}^{p}$ and let $\beta>0$. Then, there is a couple of functions

\rho_{\beta} \in C^{1}\left(\mathbf{T} \times \mathbf{T}^{p}\right) \cap C\left(\mathbf{T}, C^{2}\left(\mathbf{T}^{p}\right)\right), \quad u_{\beta} \in C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right) \cap C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right)
$$

and $\bar{H}_{\beta}(c) \in \mathbf{R}$ such that $\rho_{\beta}$ satisfies points d1)-d3) above and

\frac{1}{2 \beta} \Delta u_{\beta}+\partial_{t} u_{\beta}-H_{\rho_{\beta}}\left(t, x, c-\partial_{x} u_{\beta}\right)+\bar{H}_{\beta}(c)=0, & (H J)_{\rho_{\beta}, p e r} \\
\frac{1}{2 \beta} \Delta \rho_{\beta}-\operatorname{div}\left[\rho_{\beta} \cdot\left(c-\partial_{x} u_{\beta}\right)\right]-\partial_{t} \rho_{\beta}=0 . & (F P)_{c-\partial_{x} u_{\beta}, p e r}
\end{array}
$$

Moreover, among the triples $\left(\rho_{\beta}, u_{\beta}, \bar{H}_{\beta}(c)\right)$ which solve $(H J)_{\rho_{\beta}, p e r}-(F P)_{c-\partial_{x} u_{\beta}, p e r}$, there is one which minimizes

\int_{\mathbf{T} \times \mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \rho_{\beta}}\left(t, x, \partial_{x} u_{\beta}\right) \rho_{\beta}(t, x) \mathrm{d} t \mathrm{~d} x . \tag{2}
\end{equation*}
$$

Thus, our "characteristics" are the solutions of a Fokker-Planck equation bringing mass forward in time; the drift of this equation, or the optimal trajectory, is determined by a Hamilton-Jacobi equation, backward in time. This is quite typical for this kind of problems: see for instance equation (5.40) of [17] or theorem 3.9 of [12].

We briefly sketch the proof of theorem 1 ; the complete details are in section 1 below. First of all, we fix $\psi$ satisfying points d 1$)-\mathrm{d} 3$ ) above; then we find, as in [13], a couple $\left(u_{\psi}, \bar{H}_{\psi}(c)\right)$ which solves $(H J)_{\psi, p e r}$. By [13], the number $\bar{H}_{\psi}(c)$ is unique and $u_{\psi}$ is unique up to an additive constant. To $c-\partial_{x} u_{\psi}$ is associated a stochastic flow, whose stationary Fokker-Planck equation is $(F P)_{c-\partial_{x} u_{\psi}, p e r}$; again by [13], $(F P)_{c-\partial_{x} u_{\psi}, \text { per }}$ has a unique periodic solution $\rho_{\psi}$ satisfying d1)-d3). In other words, we have a map : $\psi \rightarrow \rho_{\psi}$ bringing densities to densities; we shall find a fixed point $\rho_{\beta}$ of this map by the Schauder fixed point theorem. We shall see that $\left(u_{\rho_{\beta}}, \rho_{\beta}, \bar{H}_{\rho_{\beta}}(c)\right)$ solves $(H J)_{\rho_{\beta}, p e r}-(F P)_{c-\partial_{x} u_{\rho_{\beta}}, \text { per }}$ practically by definition; the existence of a minimum in (2) will follow from the fact that the fixed points of $\rho_{\beta}$ are a compact set.

In section 2, we study the Hopf-Lax semigroup. We denote by $\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ the space of Borel probability measures on $\mathbf{T}^{p}$ with the 1-Wasserstein distance (see section 1 for a definition); we shall prove the following.

Theorem 2. Let $U: \mathcal{M}_{1}\left(\mathbf{T}^{p}\right) \rightarrow \mathbf{R}$ be of the form

U(\mu)=\int_{\mathbf{T}^{p}} f \mathrm{~d} \mu
$$

for some $f \in C^{3}\left(\mathbf{T}^{p}\right)$. Let $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and let $m \in \mathbf{N}$. Then, there are $R_{\beta} \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ with density $\rho_{\beta} \in C^{1}\left((-m, 0] \times \mathbf{T}^{p}\right) \cap C\left((-m, 0] \times C^{2}\left(\mathbf{T}^{p}\right)\right)$ and $u_{\beta} \in C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right) \cap C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)$ such that $u_{\beta}$ solves

\left\{\begin{array}{l}
\frac{1}{2 \beta} \Delta u_{\beta}+\partial_{t} u_{\beta}-H_{\rho_{\beta}}\left(t, x, c-\partial_{x} u_{\beta}\right)=0, \quad t<0 \\
u_{\beta}(0, x)=f \quad \forall x \in \mathbf{T}^{p}
\end{array}\right.
$$

and $R_{\beta}$ together with its density $\rho_{\beta}$ solve

$$
\left\{\begin{array}{l}
\frac{1}{2 \beta} \Delta \rho_{\beta}-\operatorname{div}\left[\rho_{\beta} \cdot\left(c-\partial_{x} u_{\beta}\right)\right]-\partial_{t} \rho_{\beta}=0, \quad t>-m \\
R_{\beta}(-m)=\mu
\end{array}\right.
$$

Among the solutions $\left(u_{\beta}, \rho_{\beta}\right)$ of $(H J)_{\beta, f}-(F P)_{-m, c-\partial_{x} u_{\beta}, \mu}$, there is one which minimizes

$$
\int_{-m}^{0} \mathrm{~d} t \int_{\mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \rho_{\beta}}\left(t, x, c-\partial_{x} u_{\beta}\right) \rho_{\beta} \mathrm{d} x+U\left(\rho_{\beta}(0)\right)
$$

We call such a minimum $\left(\Lambda_{c}^{m} U\right)(\mu)$.

Since minimizing over fixed points is uncomfortable, one could ask whether this restriction can be removed, getting a problem more similar to (1).

Theorem 3. 1) Let $U$ and $\left(\Lambda_{c}^{m} U\right)(\mu)$ be as in theorem 2. Then,

\left(\Lambda_{c}^{m} U\right)(\mu)=\min _{Y} E_{w}\left\{\int_{-m}^{0} \mathcal{L}_{c, \frac{1}{2} \rho}(t, X, Y) \mathrm{d} t\right\}+U(\rho(0)) \tag{3}
\end{equation*}
$$

where $\rho$ solves $(F P)_{-m, Y, \mu}, E_{w}$ denotes expectation with respect to the Brownian motion $w, X$ solves the stochastic differential equation

$$
\left\{\begin{array}{l}
\mathrm{d} X(-m, s, x)=Y(s, X(-m, s, x)) \mathrm{d} t+\mathrm{d} w(s) \quad s \geq-m \\
X(-m,-m, x)=X_{\mu}
\end{array}\right.
$$

for a random variable $X_{\mu}$ of law $\mu$, independent on $w(s)$ for $s \geq-m$. The minimum is taken over all Lipschitz vector fields $Y$.
2) Any minimal $Y$ satisfies $Y=c-\partial_{x} u$, where $u$ solves $(H J)_{\rho, f}$.

In other words, $(H J)_{\rho_{\beta}, f^{-}}(F P)_{-m, c-\partial_{x} u_{\beta}, \mu}$ are the Euler-Lagrange equations of the functional (3), exactly as in the zero-viscosity situation (we refer again to [12], theorem 3.9.) We also note a quirk of the notation: in the Hamilton-Jacobi equation we have $H_{\rho_{\beta}}$, while in (3) we have $\mathcal{L}_{c, \frac{1}{2} \rho_{\beta}}$; again, we share this factor two with the zero-viscosity situation and we shall see the reason for it in the proof of lemma 2.5 below.

Theorems like theorem 3 are common in the theory of mean field games (see for instance [4]). In the language of mean field games, we are saying that each particle tries to minimize unilaterally the cost

\min _{Y} E_{w}\left\{\int_{-m}^{0} \mathcal{L}_{c, \rho}(t, X, Y) \mathrm{d} t+f(X(0))\right\}
$$

where $X$ solves $(S D E)_{-m, Y, \delta_{x_{0}}}$ and $\rho$ is the distribution of the other particles; this is the reason of equation $(H J)_{\rho_{\beta}, f}$ in theorem 2. The result of the independent efforts of all the particles (or the Nash equilibrium, as it is called) is that the whole community minimizes (3).

Let $U: \mathcal{M}_{1}\left(\mathbf{T}^{p}\right) \rightarrow \mathbf{R}$ be bounded; theorem 3 prompts us to define

$$
\begin{equation*}
\left(\Psi_{c}^{m} U\right)(\mu)=\inf _{Y}\left\{E_{w} \int_{-m}^{0} \mathcal{L}_{c, \frac{1}{2} \rho}(t, X, Y) \mathrm{d} t+U(\rho(0))\right\} \tag{4}
\end{equation*}
$$

where the infimum is taken over all Lipschitz vector fields $Y$; the density $\rho$ satisfies $(F P)_{-m, Y, \mu}$. Naturally, if $U$ is linear as in theorem 3 , then $\Psi_{c}^{m} U=\Lambda_{c}^{m} U$.

We shall see in proposition 2.10 below that $\Psi_{c}^{m}$ has the semigroup property: $\Psi_{c}^{m+n}=\Psi_{c}^{m} \circ \Psi_{c}^{n}$.
Theorem 3 tells us that the infimum in (4) is a minimum when $U$ is a linear function on measures as in theorem 2; we don't know whether this is true when $U$ is in some more reasonable class, for instance continuous or Lipschitz. We don't even know whether, for $U$ continuous, $\Psi_{c}^{1} U$ is continuous; however, when $U$ is linear as in theorem 2, we can prove that $\Psi_{c}^{m} U$ is Lipschitz, uniformly in $m$. This allows us to find, for a suitable $\lambda \in \mathbf{R}$, Lipschitz fixed points of the operator $\Psi_{c, \lambda}$ defined by

\Psi_{c, \lambda}: U \rightarrow \Psi_{c}^{1} U+\lambda
$$

Theorem 4. There is a unique $\lambda \in \mathbf{R}$ for which $\Psi_{c, \lambda}$ has a fixed point $\hat{U}$ in $C\left(\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right.$, $\left.\mathbf{R}\right)$. In other words, for any $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$, there is a Lipschitz vector field $\bar{Y}$ such that

\left(\Psi_{c, \lambda}^{1} \hat{U}\right)(\mu)=E_{w}\left\{\int_{-1}^{0} \mathcal{L}_{c, \frac{1}{2} \bar{\rho}}(t, \bar{X}, \bar{Y}) \mathrm{d} t\right\}+\hat{U}(\bar{\rho}(0)), \tag{5}
\end{equation*}
$$

where $X$ solves $(S D E)_{-1, \bar{Y}, \mu}$ and $\bar{\rho}$ solves $(F P)_{-1, \bar{Y}, \mu}$.
The function $\hat{U}$ is Lipschitz for the 1-Wasserstein distance; by (5), the infimum in the definition of (4) of $\Psi_{c, \lambda}^{1} \hat{U}$ is a minimum.

The proof of this theorem is similar to the corresponding statement in Aubry-Mather theory. Indeed, using an approximation with finitely many particles, we shall prove that, for a suitable $\lambda \in \mathbf{R}$, the sequence $\left(\Lambda_{c, \lambda}\right)^{n}(0)$ of continuous functions on the compact space $\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ is equibounded and equilipschitz; by Ascoli-Arzelà, it has a subsequence converging to a limit $\hat{U}$; we shall prove that $\hat{U}$ is a fixed point of $\Lambda_{c, \lambda}$.

## $\S 1$

## Periodic orbits

In this section, we are going to prove theorem 1. We begin with a study of $(H J)_{\psi, p e r}$; we follow the approach of [13] but, for completeness' sake, we reprove several results of this paper using, as in [2], the Feynman-Kac formula.

## Definitions.

- We group in a set Den the functions on $\mathbf{T} \times \mathbf{T}^{p}$ which satisfy points d1)-d3) in the introduction. Clearly, the set $D e n$ is closed in $C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$.
- We define $\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ as the space of all Borel probability measures on $\mathbf{T}^{p}$; if $\mu_{1}, \mu_{2} \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$, we define the 1-Wasserstein distance between them as

$$
d_{1}\left(\mu_{1}, \mu_{2}\right)=\min \left\{\int_{\mathbf{T}^{p} \times \mathbf{T}^{p}}\left|x-x^{\prime}\right|_{\mathbf{T}^{p}} \mathrm{~d} \gamma\left(x, x^{\prime}\right)\right\}
$$

where $\left|x-x^{\prime}\right|_{\mathbf{T}^{p}}$ is the distance on the flat torus $\mathbf{T}^{p}$. The minimum is taken over all the Borel probability measures $\gamma$ on $\mathbf{T}^{p} \times \mathbf{T}^{p}$ whose first and second marginals are, respectively, $\mu_{1}$ and $\mu_{2}$. It is standard (see for instance section 7.1 of [17]) that $d_{1}$ turns $\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ into a complete metric space, and induces the weak* topology.

We note that, if $\psi \in D e n$ and $\mathcal{L}^{p}$ denotes the Lebesgue measure on $\mathbf{T}^{p}$, then the function : $t \rightarrow \psi(t, \cdot) \mathcal{L}^{p}$ belongs to $C\left(\mathbf{T}, \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$.

- We extend the definition of $P_{\psi}$ we gave in the introduction: for $\psi \in C\left(\mathbf{R}, \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ we set

\begin{equation*}
P_{\psi}(t, x)=V(t, x)+\int_{\mathbf{T}^{p}} W\left(x-x^{\prime}\right) \mathrm{d} \psi\left(t, x^{\prime}\right) \tag{1.1}
\end{equation*}
$$

Lemma 1.1. There is $C_{1}>0$, independent on $\psi \in C\left(\mathbf{R}, \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$, such that the function $P_{\psi}(t, x)$ defined in (1.1) satisfies

$$
\begin{equation*}
\left\|P_{\psi}\right\|_{C\left(\mathbf{R}, C^{3}\left(\mathbf{T}^{p}\right)\right)} \leq C_{1} \tag{1.2}
\end{equation*}
$$

Proof. We recall that, by definition,

$$
\left\|P_{\psi}\right\|_{C\left(\mathbf{R}, C^{3}\left(\mathbf{T}^{p}\right)\right)}=\sup _{t \in \mathbf{R}}\left\|P_{\psi}(t, \cdot)\right\|_{C^{3}\left(\mathbf{T}^{p}\right)}
$$

where, as usual,

$$
\|f\|_{C^{3}\left(\mathbf{T}^{p}\right)}=\|f\|_{C^{0}\left(\mathbf{T}^{p}\right)}+\left\|D_{x} f\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}+\left\|D_{x}^{2} f\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}+\left\|D_{x}^{3} f\right\|_{C^{0}\left(\mathbf{T}^{p}\right)} .
$$

By our hypotheses on $V$ and $W$, we have that

$$
\begin{equation*}
\|V\|_{C\left(\mathbf{R}, C^{3}\left(\mathbf{T}^{p}\right)\right)}+\|W\|_{C^{3}\left(\mathbf{T}^{p}\right)}=C_{1}<+\infty . \tag{1.3}
\end{equation*}
$$

For $0 \leq j \leq 3$, differentiation under the integral sign implies that

$$
D_{x}^{j} P_{\psi}(t, x)=D_{x}^{j} V(t, x)+\int_{\mathbf{T}^{p}} D_{x}^{j} W\left(x-x^{\prime}\right) \mathrm{d} \psi\left(t, x^{\prime}\right)
$$

Since : $t \rightarrow \psi(t, \cdot)$ is continuous from $\mathbf{R}$ to the weak* topology, the formula above implies that $P_{\psi}$ is in $C\left(\mathbf{R}, C^{3}\left(\mathbf{T}^{p}\right)\right)$. Since $\psi(t, \cdot)$ is a probability mesure and the $C^{3}$ norm is convex, (1.2) follows from the last formula and (1.3).

From now on, we shall fix $\psi \in \operatorname{Den}$; the functions $P_{\psi}, \mathcal{L}_{c, \psi}$ and $H_{\psi}$ are defined as in the introduction. Following [2], we note that, if $(u, A)$ solves

\frac{1}{2 \beta} \Delta u+\partial_{t} u-H_{\psi}\left(t, x, c-\partial_{x} u\right)+A=0 \quad \forall t \in \mathbf{R} \\
u(t, \cdot)=u(t+1, \cdot) \quad \forall t \in \mathbf{R}
\end{array}\right.
$$

and is periodic in space (i. e. it quotients to a continuous function on $\mathbf{T}^{p}$ ), then the couple $(v, A)=\left(e^{-\beta u}, A\right)$ is a solution, periodic in space, of the "twisted" Schrödinger equation

$$
\left\{\begin{array}{l}
\partial_{t} v+e^{-\beta\langle c, x\rangle}\left[\frac{1}{2 \beta} \Delta+\beta P_{\psi}(t, x)-\beta A\right]\left(e^{\beta\langle c, x\rangle} v\right)=0 \quad \forall t \in \mathbf{R}  \tag{TS}\\
v(t, \cdot)=v(t+1, \cdot) \quad \forall t \in \mathbf{R} .
\end{array}\right.
$$

Vice-versa, the logarithm of a positive solution of $(T S)_{\psi, p e r}$ solves $(H J)_{\psi, p e r}$. Thus, solving $(H J)_{\psi, p e r}$ reduces to solving $(T S)_{\psi, p e r}$; that's what we are going to do next.

For $\phi \in C\left(\mathbf{T}^{p}\right)$ and $A \in \mathbf{R}$ we consider the evolution (or involution, since it goes backward in time) problem

$$
\left\{\begin{array}{l}
\partial_{t} v+e^{-\beta\langle c, x\rangle}\left[\frac{1}{2 \beta} \Delta+\beta P_{\psi}(t, x)-\beta A\right]\left(e^{\beta\langle c, x\rangle} v\right)=0, \quad t \leq 0  \tag{TS}\\
v(0, x)=\phi(x) .
\end{array}\right.
$$

If $t \leq 0$, we can use the Feynman-Kac formula (see for instance [6]) and write the unique solution of $(T S)_{\psi, \phi}$ as

$$
v(t, x)=\left(L_{(\psi, A, t)} \phi\right)(x), \quad t \leq 0
$$

where

$$
\begin{equation*}
\left(L_{(\psi, A, t)} \phi\right)(x)=e^{-\beta\langle c, x\rangle} \cdot E_{w}\left[e^{\int_{t}^{0} \beta\left[P_{\psi}\left(\tau, \frac{1}{\sqrt{\beta}} w(\tau)+x\right)-A\right] \mathrm{d} \tau} e^{\beta\left\langle c, \frac{1}{\sqrt{\beta}} w(0)+x\right\rangle} \phi\left(\frac{1}{\sqrt{\beta}} w(0)+x\right)\right] . \tag{1.5}
\end{equation*}
$$

In the formula above, $w$ is a Brownian motion on $[t,+\infty]$ with $w(t)=0$, and $E_{w}$ is the expectation with respect to the Wiener measure.

We shall see in lemma 1.4 below that there is a bijection between the positive eigenfunctions of $L_{(\psi, 0,-1)}$ and the positive solutions of $(T S)_{\beta, p e r}$; now, we prove that such eigenfunctions exist.

Lemma 1.2. 1) (Existence) there is $(v, B) \in C\left(\mathbf{T}^{p}\right) \times \mathbf{R}$ such that

L_{(\psi, 0,-1)} v=B v  \tag{1.6}\\
v>0 \\
B>0 .
\end{array}\right.
$$

2) (Uniqueness) Let ( $v_{1}, B_{1}$ ) and ( $v_{2}, B_{2}$ ) solve (1.6) $\psi$; then, $B_{1}=B_{2}$ and $v_{1}=\alpha v_{2}$ for some $\alpha>0$. In particular, there is a unique couple $\left(v_{\psi}, B_{\psi}\right)$ which satisfies $(1.6)_{\psi}$ and such that

$$
\begin{equation*}
\int_{\mathbf{T}^{p}} v_{\psi}(x) \mathrm{d} x=1 . \tag{1.7}
\end{equation*}
$$

Proof. We recall from [16] (see also chapter XVI of [3] for G. Birkhoff's original exposition) a few facts about the Perron-Frobenius theorem. Let us denote by $\mathcal{C}_{+} \subset C\left(\mathbf{T}^{p}\right)$ the cone of strictly positive, continuous functions. We forego the easy proof that $L_{(\psi, 0,-1)}$ brings $\mathcal{C}_{+}$into itself.

Let $v_{1}, v_{2} \in \mathcal{C}_{+}$; we say that $v_{1}$ and $v_{2}$ are equivalent, or $v_{1} \simeq v_{2}$, if $v_{1}=t v_{2}$ for some $t>0$. Given $v_{1}, v_{2} \in \mathcal{C}_{+}$, we define

$$
\alpha\left(v_{1}, v_{2}\right)=\sup \left\{t>0: v_{2}-t v_{1} \in \mathcal{C}_{+}\right\}
$$

and

$$
\theta\left(v_{1}, v_{2}\right)=-\log \left[\alpha\left(v_{1}, v_{2}\right) \alpha\left(v_{2}, v_{1}\right)\right] .
$$

It turns out $([16])$ that $\left(\frac{\mathcal{C}_{+}}{\sim}, \theta\right)$ is a complete metric space. We refer again to [16] or [3] for the proof that

$$
\theta\left(L_{(\psi, 0,-1)} v_{1}, L_{(\psi, 0,-1)} v_{2}\right) \leq\left(1-e^{-D}\right) \theta\left(v_{1}, v_{2}\right)
$$

where

$$
D=\sup _{v_{1}, v_{2} \in \mathcal{C}_{+}} \theta\left(L_{(\psi, 0,-1)} v_{1}, L_{(\psi, 0,-1)} v_{2}\right) .
$$

As a consequence, points 1) and 2) follow from the contraction mapping theorem if we prove that $D<+\infty$. Actually, we are going to show that $D$ is bounded from above independently of $\psi \in D e n$; equivalently, the Lipschitz constant of $L_{(\psi, 0,-1)}$ does not depend on $\psi$. We shall need this fact in the next lemma.

Let $v_{1}, v_{2} \in \mathcal{C}_{+}$. Recalling the definition of $\theta$, we see that

Thus, $D<+\infty$ follows if we prove that there is $C_{3}>0$ such that

for all $v \in \mathcal{C}_{+}$; since the term on the left is homogeneous of degree zero in $v$, we can suppose that $v$ satisfies (1.7).

We prove (1.9); in the following, $C_{i}$ always denotes a constant independent on $v$ and $\psi$. By (1.5) and the fact that $v>0$, we have that

\left(L_{(\psi, 0,-1)} v\right)(x) \geq e^{-\beta\langle c, x\rangle} e^{\beta \min P_{\psi}} \frac{1}{\sqrt{(2 \pi)^{p}}} \int_{\mathbf{R}^{p}} e^{\beta\left\langle c, \frac{1}{\sqrt{\beta}} z+x\right\rangle} v\left(\frac{1}{\sqrt{\beta}} z+x\right) e^{-\frac{|z|^{2}}{2}} \mathrm{~d} z
$$

Setting $\frac{1}{\sqrt{\beta}} z=y$ and simplifying $e^{-\beta\langle c, x\rangle}$ outside the integral with $e^{\beta\langle c, x\rangle}$ inside, we get the first inequality below

$$
\begin{gathered}
\left(L_{(\psi, 0,-1)} v\right)(x) \geq e^{\beta \min P_{\psi}} \sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \int_{\mathbf{R}^{p}} e^{\beta\langle c, y\rangle} v(x+y) e^{-\frac{\beta}{2}|y|^{2}} \mathrm{~d} y \geq \\
e^{-\beta C_{1}} \sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \int_{[0,1]^{p}} e^{\beta\langle c, y\rangle} v(x+y) e^{-\frac{\beta}{2}|y|^{2}} \mathrm{~d} y
\end{gathered}
$$

The second inequality above comes from lemma 1.1 and the fact that $v$, which belongs to $\mathcal{C}_{+}$, is positive. By lemma 1.1, the constant $C_{1}$ does not depend on $\psi \in D e n$.

We assert that

$$
\begin{equation*}
\left(L_{(\psi, 0,-1)} v\right)(x) \geq e^{-\beta C_{1}} \sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \min _{y \in[0,1]^{p}}\left[e^{\beta\langle c, y\rangle} e^{-\frac{\beta}{2}|y|^{2}}\right] \int_{[0,1]^{p}} v(x+y) \mathrm{d} y=C_{5} \tag{1.10}
\end{equation*}
$$

for a constant $C_{5}>0$ independent on $\psi$ and $v$. Indeed, the inequality follows since $v$ is positive; since $v$ is periodic and satisfies (1.7), the integral above is 1 , and the equality follows.

For the estimate from above, we get from (1.5) that

\left(L_{(\psi, 0,-1)} v\right)(x) \leq e^{-\beta\langle c, x\rangle} e^{\beta \max P_{\psi}} \frac{1}{\sqrt{(2 \pi)^{p}}} \int_{\mathbf{R}^{p}} e^{\beta\left\langle c, \frac{1}{\sqrt{\beta}} z+x\right\rangle} v\left(\frac{1}{\sqrt{\beta}} z+x\right) e^{-\frac{|z|^{2}}{2}} \mathrm{~d} z
$$

We simplify $e^{-\beta\langle c, x\rangle}$ outside the integral with $e^{\beta\langle c, x\rangle}$ inside; now lemma 1.1 gives us the first inequality below; the equality follows from the change of variables $\frac{1}{\sqrt{\beta}} z=y$.

$$
\begin{gathered}
\left(L_{(\psi, 0,-1)} v\right)(x) \leq \frac{e^{\beta C_{1}}}{\sqrt{(2 \pi)^{p}}} \int_{\mathbf{R}^{p}} e^{\beta\left\langle c, \frac{1}{\sqrt{\beta}} z\right\rangle} v\left(\frac{1}{\sqrt{\beta}} z+x\right) e^{-\frac{|z|^{2}}{2}} \mathrm{~d} z= \\
e^{\beta C_{1}} \sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \int_{\mathbf{R}^{p}} e^{\beta\langle c, y\rangle} v(x+y) e^{-\frac{\beta}{2}|y|^{2}} \mathrm{~d} y .
\end{gathered}
$$

Since $v$ is positive periodic, and by (1.7) integrates to 1 on the unit cube, we get the first inequality below.

\left(L_{(\psi, 0,-1)} v\right)(x) \leq e^{\beta C_{1}} \sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \cdot \sum_{k \in \mathbf{Z}^{p}} \max _{y \in k+[0,1]^{p}}\left[e^{\beta\langle c, y\rangle} e^{-\frac{\beta}{2}|y|^{2}}\right] \leq
$$

$$
C_{6} \sum_{k \in \mathbf{Z}^{p}} e^{\beta|c|(|k|+\sqrt{p})} e^{-\frac{\beta}{2}(|k|-\sqrt{p})^{2}}
$$

Since the sum in the last formula is finite, we get that

$$
\begin{equation*}
\left(L_{(\psi, 0,-1)} v\right)(x) \leq C_{7} \quad \forall x \in \mathbf{T}^{p} \tag{1.11}
\end{equation*}
$$

for a constant $C_{7}>0$ independent on $\psi$ and $v$. Now (1.9) follows from the last formula and (1.10); we have seen that (1.9), by the contraction mapping theorem, implies points 1) and 2) of the thesis.

Lemma 1.3. Let $\psi \in D e n$ and let $\left(v_{\psi}, B_{\psi}\right)$ be as in the last lemma. Then, $v_{\psi} \in C^{3}\left(\mathbf{T}^{p}\right)$ and the following two points hold.

1) (Uniform estimates) There is $C_{8}>0$, independent on $\psi \in D e n$, such that

ii)

$$

iii)

$$
\frac{1}{C_{8}} \leq B_{\psi} \leq C_{8}
$$

2) (Continuous dependence) The function

$$
K: D e n \rightarrow C^{3}\left(\mathbf{T}^{p}\right) \times \mathbf{R}, \quad K: \psi \rightarrow\left(v_{\psi}, B_{\psi}\right)
$$

is continuous.

Proof. We prove point 1). Since $v_{\psi}$ satisfies (1.7), by (1.10) and (1.11) there is $C_{8}>1$ such that

\frac{1}{C_{8}} \leq \min L_{(\psi, 0,-1)} v_{\psi} \leq \max L_{(\psi, 0,-1)} v_{\psi} \leq C_{8}
$$

Since we also have that $L_{(\psi, 0,-1)} v_{\psi}=B_{\psi} v_{\psi}$, we get that

\frac{1}{B_{\psi}} \cdot \frac{1}{C_{8}} \leq \min v_{\psi} \leq v_{\psi} \leq \max v_{\psi} \leq \frac{1}{B_{\psi}} C_{8} \tag{1.12}

Integrating on $\mathbf{T}^{p}$ and using (1.7), we get that

\frac{1}{B_{\psi}} \cdot \frac{1}{C_{8}} \leq \int_{\mathbf{T}^{p}} v_{\psi} \mathrm{d} x=1 \leq \frac{1}{B_{\psi}} \cdot C_{8}
$$

from which $i i i$ ) of point 1) follows.
From point $i i i$ ) and (1.12), possibly increasing $C_{8}$, we get point $i i$ ). We show $i$ ).

We would like to differentiate under the integral sign in (1.5); we cannot do this immediately, because we only know that the final condition $\phi$ (which in our case is $v_{\psi}$ ) is in $C^{0}$. Let $E_{(0, z)}$ denote the expectation of the Brownian bridge with $w(-1)=0$ and $w(0)=z$; by (1.5) we get that, for $v \in \mathcal{C}_{+}$,

\begin{gathered}
\left(L_{(\psi, 0,-1)} v\right)(x)= \\
e^{-\beta\langle c, x\rangle} \frac{1}{\sqrt{(2 \pi)^{p}}} \cdot \int_{\mathbf{R}^{p}} e^{-\frac{|z|^{2}}{2}} e^{\beta\left\langle c, \frac{1}{\sqrt{\beta}} z+x\right\rangle} v\left(\frac{1}{\sqrt{\beta}} z+x\right) \cdot E_{(0, z)}\left[e^{\int_{-1}^{0} \beta P_{\psi}\left(\tau, \frac{1}{\sqrt{\beta}} w(\tau)+x\right) \mathrm{d} \tau}\right] \mathrm{d} z
\end{gathered}
$$

Setting $\frac{1}{\sqrt{\beta}} z+x=y$, we get that

$$
\begin{gathered}
\left(L_{(\psi, 0,-1)} v\right)(x)=\sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \cdot e^{-\beta\langle c, x\rangle} \\
\int_{\mathbf{R}^{p}} e^{-\frac{\beta}{2}|y-x|^{2}} e^{\beta\langle c, y\rangle} v(y) \cdot E_{(0, \sqrt{\beta}(y-x))}\left[e^{\int_{-1}^{0} \beta P_{\psi}\left(\tau, \frac{1}{\sqrt{\beta}} w(\tau)+x\right) \mathrm{d} \tau}\right] \mathrm{d} y
\end{gathered}
$$

We recall from [14] that, if $\tilde{w}$ is a Brownian bridge with $\tilde{w}(-1)=\tilde{w}(0)=0$, then $w(t):=\sqrt{\beta}(y-x)(t+1)+\tilde{w}(t)$ is a Brownian bridge with $w(-1)=0, w(0)=\sqrt{\beta}(y-x)$. This and the last formula imply that

\left(L_{(\psi, 0,-1)} v\right)(x)=\sqrt{\left(\frac{\beta}{2 \pi}\right)^{p}} \cdot e^{-\beta\langle c, x\rangle} \\
\int_{\mathbf{R}^{p}} e^{-\frac{\beta}{2}|y-x|^{2}} e^{\beta\langle c, y\rangle} v(y) \cdot E_{(0,0)}\left[e^{\int_{-1}^{0} \beta P_{\psi}\left(\tau,(y-x)(\tau+1)+\frac{1}{\sqrt{\beta}} \tilde{w}(\tau)+x\right) \mathrm{d} \tau}\right] \mathrm{d} y .
\end{gathered}
$$

The formula above allows us to differentiate under the integral sign, even if $v$ is only $C^{0}$; using lemma 1.1, we easily get

\left\|L_{(\psi, 0,-1)} v\right\|_{C^{3}\left(\mathbf{T}^{p}\right)} \leq C_{9}\|v\|_{C^{0}\left(\mathbf{T}^{p}\right)} \tag{1.13}
\end{equation*}

for a constant $C_{9}$ independent of $\psi$. By $i i$, we get that

\left\|L_{(\psi, 0,-1)} v\right\|_{C^{3}\left(\mathbf{T}^{p}\right)} \leq C_{8} \cdot C_{9}
$$

Since $L_{(\psi, 0,-1)} v_{\psi}=B_{\psi} v_{\psi}$, formula $i$ ) now follows from $\left.i i i\right)$.
We prove point 2); in the first three steps below, we show a weaker result, namely that the map $: \psi \rightarrow v_{\psi}$ is continuous from Den to $C^{0}\left(\mathbf{T}^{p}\right)$; this will follow from the theorem of contractions depending on a parameter applied to the map

\Xi:\left(D e n,\|\cdot\|_{\text {sup }}\right) \times\left(\mathcal{C}_{+}, \theta\right) \rightarrow\left(\mathcal{C}_{+}, \theta\right), \quad \Xi:(\psi, v) \rightarrow L_{(\psi, 0,-1)} v
$$

Step 1. We begin to observe that $\theta$ and the sup norm induce equivalent topologies on the subset $\mathcal{A}$ of the functions of $\mathcal{C}_{+}$which satisfy (1.7). Indeed, (1.8) proves that the $C^{0}$ topology is stronger; for the opposite inclusion, let $\theta\left(v_{n}, v\right) \rightarrow 0$ and let $v_{n}, v$ satisfy (1.7). Since $\theta\left(v_{n}, v\right) \rightarrow 0$, we have that, for any $\epsilon>0$ and $n$ large enough,

The definition of $\alpha$ implies the first two inequalities below; the last one follows by the first inequality above.

\alpha\left(v, v_{n}\right) v \leq v_{n} \leq \frac{1}{\alpha\left(v_{n}, v\right)} v \leq \frac{\alpha\left(v, v_{n}\right)}{1-\epsilon} v .
$$

Since $v$ and $v_{n}$ satisfy (1.7), if we integrate the formula above on $\mathbf{T}^{p}$, we get that $\alpha\left(v_{n}, v\right) \rightarrow 1$ and that $\alpha\left(v, v_{n}\right) \rightarrow 1$; since $\min v>0$, again from the formula above we get that $v_{n} \rightarrow v$ uniformly.

Step 2. Let $v \in \mathcal{C}_{+}$be fixed; we assert that the map $: \psi \rightarrow \Xi(\psi, v)$ is continuous from the $\|\cdot\|_{\text {sup }}$ to the $\theta$ topology. Indeed, we saw in step 1 that, on $\mathcal{C}_{+}$, the $C^{0}$ topology is stronger than the $\theta$ topology; thus, it suffices to prove that $\Xi(\cdot, v):\left(D e n,\|\cdot\|_{\text {sup }}\right) \rightarrow\left(\mathcal{C}_{+},\|\cdot\|_{\text {sup }}\right)$ is continuous. The proof of this, which ends the proof of the assertion, follows by applying the theorem of continuity under the integral sign to (1.5), and we forego it.

Step 3. We assert that the map : $\psi \rightarrow v_{\psi}$ is continuous from $\left(D e n,\|\cdot\|_{\text {sup }}\right)$ to $\left(\mathcal{A},\|\cdot\|_{\text {sup }}\right)$; by step 1 , it suffices to prove that it is continuous from $\left(D e n,\|\cdot\|_{\text {sup }}\right)$ to $(\mathcal{A}, \theta)$. We have seen in the proof of lemma 1.2 that $: v \rightarrow \Xi(\psi, v)$ is a contraction for the $\theta$-topology, whose Lipschitz constant does not depend on $\psi$. Since $: \psi \rightarrow \Xi(\psi, v)$ is continuous by step 2 , we can apply the theorem of contractions depending on a parameter, and get that the map : $\psi \rightarrow v_{\psi}$ is continuous from ( $\operatorname{Den},\|\cdot\|_{\text {sup }}$ ) to $\left(\mathcal{C}_{+}, \theta\right)$, as we wanted.
Step 4. We assert that the map $: \psi \rightarrow B_{\psi}$ is continuous from $D e n$ to $\mathbf{R}$. Since $L_{(\psi, 0,-1)} v_{\psi}=B_{\psi} v_{\psi}$, it suffices to prove that both maps : $\psi \rightarrow v_{\psi}$ and $: \psi \rightarrow L_{(\psi, 0,-1)} v_{\psi}$ are continuous from Den to $C^{0}\left(\mathbf{T}^{p}\right)$. The first fact has been proven in step 3 ; we prove that : $\psi \rightarrow L_{(\psi, 0,-1)} v_{\psi}$ is continuous. Indeed,

\left\|L_{\left(\psi^{\prime}, 0,-1\right)} v_{\psi^{\prime}}-L_{(\psi, 0,-1)} v_{\psi}\right\|_{\text {sup }} \leq\left\|L_{\left(\psi^{\prime}, 0,-1\right)}\left(v_{\psi^{\prime}}-v_{\psi}\right)\right\|_{\text {sup }}+\left\|\left(L_{\left(\psi^{\prime}, 0,-1\right)}-L_{(\psi, 0,-1)}\right) v_{\psi}\right\|_{\text {sup }}
$$

Now the assertion follows from the fact that (with the sup norm in all spaces) : $\psi \rightarrow v_{\psi}$ is continuous, that $: \psi \rightarrow L_{(\psi, 0,-1)} v$ is continuous, and that $: v \rightarrow L_{(\psi, 0,-1)} v$ is uniformly Lipschitz by (1.13).
End of the proof of point 2). For $\phi \in \mathcal{C}_{+}$, we get from (1.5) that

L_{(\psi, r,-1)} \phi=e^{-\beta r} L_{(\psi, 0,-1)} \phi \tag{1.14}
\end{equation*}
$$

Setting $A_{\psi}=\frac{1}{\beta} \log B_{\psi}$, the formula above implies that

L_{\left(\psi, A_{\psi},-1\right)} v_{\psi}=v_{\psi} \tag{1.15}
\end{equation*}
$$

The same proof which yielded (1.13) also yields that there is $C_{10}>0$ such that, if $A$ and $A^{\prime}$ satisfy the estimate of point 1), iii) of this lemma, then

\left\|L_{(\psi, A,-1)} v-L_{\left(\psi^{\prime}, A^{\prime},-1\right)} v\right\|_{C^{3}\left(\mathbf{T}^{p}\right)} \leq C_{10}\left(\left\|\psi-\psi^{\prime}\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}+\left|A-A^{\prime}\right|\right) \cdot\|v\|_{C^{0}\left(\mathbf{T}^{p}\right)} \tag{1.16}
\end{equation*}
$$

Thus,

$$
\begin{gathered}
\left\|v_{\psi}-v_{\psi^{\prime}}\right\|_{C^{3}\left(\mathbf{T}^{p}\right)}=\left\|L_{\left(\psi, A_{\psi},-1\right)} v_{\psi}-L_{\left(\psi^{\prime}, A_{\psi^{\prime}},-1\right)} v_{\psi^{\prime}}\right\|_{C^{3}\left(\mathbf{T}^{p}\right)} \leq \\

C_{9}\left\|v_{\psi}-v_{\psi^{\prime}}\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}+C_{10}\left(\left\|\psi-\psi^{\prime}\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}+\left|A_{\psi}-A_{\psi^{\prime}}\right|\right) \cdot\left\|v_{\psi^{\prime}}\right\|_{C^{0}\left(\mathbf{T}^{p}\right)}

where the the equality comes from (1.15) and the last inequality comes from (1.13) and (1.16). Since the map : $\psi \rightarrow v_{\psi}$ is continuous from Den to the $C^{0}$ topology by step 3 , and : $\psi \rightarrow A_{\psi}$ is continuous too (because $: \psi \rightarrow B_{\psi}$ is continuous by step 4 and point 1 ), $i i i$ ) of this lemma holds), point 2 ) follows.

In the next lemma, we show how the fixed points of $L_{(\psi, 0,-1)}$ induce solutions of $(T S)_{\psi, p e r}$.

Lemma 1.4. 1) (Existence) Given $\psi \in D e n$, we can find $A \in \mathbf{R}$ and $\hat{v} \in C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right)$ such that $\hat{v}>0$ and $(\hat{v}, A)$ solves $(T S)_{\psi, p e r}$.
2) (Uniqueness) Let us suppose that $(\hat{v}, A)$ and $\left(\hat{v}^{1}, A^{1}\right)$ are two solutions of $(T S)_{\psi, p e r}$ with $\hat{v}>0$ and $\hat{v}^{1}>0$. Then, $A=A_{1}$ and $\hat{v}=\lambda \hat{v}^{1}$ for some $\lambda>0$.
3) (Estimates) Let us call $\left(\hat{v}_{\psi}, A_{\psi}\right)$ the solution of $(T S)_{\psi, p e r}$ such that $\hat{v}_{\psi}>0$ and $\hat{v}_{\psi}(0, \cdot)$ satisfies (1.7). Then, there is a constant $C_{10}>0$, independent on $\psi \in D e n$, such that

4) (Continuous dependence) Let $\left(\hat{v}_{\psi}, A_{\psi}\right)$ be as in point 3), and let us consider the map $I: \psi \rightarrow\left(\hat{v}_{\psi}, A_{\psi}\right)$. Then, $I$ is continuous from Den to $\left[C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right)\right] \times \mathbf{R}$.

Proof. As in the proof of lemma 1.3, we set $A_{\psi}=\frac{1}{\beta} \log B_{\psi}$. For $t \leq 0$, we set

The first equality below is (1.19). Since $\hat{v}_{\psi}$ is periodic, we can suppose that $t \in[-1,0]$; now (1.5), implies the first inequality below; the second inequality follows from lemma 1.1 and the fact that $t \in[-1,0]$; the third one comes from point 1 ), $i i$ ) and $i i i$ ) of lemma 1.3.

This yields the inequality on the left of (1.18).

We prove (1.17). We begin to note that the estimate on $A_{\psi}$ follows by point 1 ), iii) of lemma 1.3 , and by the fact that $A_{\psi}=\frac{1}{\beta} \log B_{\psi}$.

We end the proof of (1.17) with the estimates on the derivatives. Let $\tilde{w}$ be the Brownian bridge with $\tilde{w}(-1)=0=\tilde{w}(0)$ and let $\tilde{E}_{(0,0)}$ denote its expectation; for $t<0$, let $w$ be the Brownian bridge with $w(t)=0=w(0)$ and let $E_{(0,0)}$ denote its expectation; we recall that

By theorem 9.1 and proposition 6.6 of [6], the Feynman-Kac formula holds for the unbounded final condition $e^{\beta\langle c, x\rangle} v_{\psi}$; this, (1.19) and (1.5) imply that $\hat{v}_{\psi}$ satisfies the first formula of $(T S)_{\psi, p e r}$ for $t<0$; since it is periodic in $t$, it satisfies it for all times. Moreover, $\hat{v}_{\psi}>0$ because, by (1.19) and (1.5), it is an integral, with a positive weight, of the positive $v_{\psi}$. This ends the proof of point 1 ).

We have just seen that (1.19) gives a bijection between the periodic, positive solutions of $(T S)_{\psi, p e r}$ and the positive eigenfunctions of $L_{(\psi, 0,-1)}$; since the latter are unique up to a multiplicative constant by point 2) of lemma 1.2 , we get that the former too are unique up to a multiplicative constant; this proves point 2 ).

We prove point 4). To prove that the map : $\psi \rightarrow A_{\psi}$ is continuous, it suffices to note that $A_{\psi}=\frac{1}{\beta} \log B_{\psi}$, that the map : $\psi \rightarrow B_{\psi}$ is continuous by point 2 ) of lemma 1.3 , and that $B_{\psi}$ is bounded away from zero and infinity by point 1 ), $i$ iii) of the same lemma.

By point 2) of lemma 1.3, we know that : $\psi \rightarrow v_{\psi}$ is continuous from Den to $C^{3}\left(\mathbf{T}^{p}\right)$; this and (1.19) easily imply that : $\psi \rightarrow \hat{v}_{\psi}$ is continuous from $\operatorname{Den}$ to $C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right)$.

3) (Continuous dependence) The couple $\left(u_{\psi}, \bar{H}_{\psi}(c)\right)$ depends continuously on $\psi$ : if $\psi_{n} \rightarrow \psi$ in Den, then $\bar{H}_{\psi_{n}}(c) \rightarrow \bar{H}_{\psi}(c)$ in $\mathbf{R}$ and $u_{\psi_{n}} \rightarrow u_{\psi}$ in $C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right)$.

Proof. By lemma 1.4, there is a unique couple

Formula (1.22) follows from (1.23); indeed, the derivatives of the logarithm of $\hat{v}_{\psi}$ are bounded by (1.17) and (1.18). In an analogous way, point 3 ) follows from point 4 ) of lemma 1.4.

Let the Lagrangian $\mathcal{L}_{c, \psi}$ be as in the introduction, and let $u_{\psi}$ be as in lemma 1.5. It is well-known ([9]) that $u_{\psi}$ satisfies, for $t \leq 0$,

We would like to consider the law of the stochastic differential equation above when the initial condition is distributed according to a measure $\mu$. One way to do this is to call $\rho_{x_{0}}$ the solution of $(F P)_{t, Y, \delta_{x_{0}}}$ and to set

Another one, which yields the same law, is to suppose that the Brownian motion is on a probability space $\Omega$ on which there is a random variable $M$ independent on $w(s)$ for $s \geq t$ and with law $\mu$; we consider the solution $z$ of the stochastic differential equation above with initial condition $M$ and we say that $z$ solves $(S D E)_{t, Y, \mu}$.

Let $Y \in V e c t$; by [13], there is $\mu \in C\left(\mathbf{T}, \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ which is invariant by the stochastic differential equation; in other words, there is a measure $\mu_{0}$ such that, if $\mu_{t}$ is the measure induced by a solution $z$ of $(S D E)_{0, Y, \mu_{0}}$ for $t \geq 0$, then $\mu_{0}=\mu_{1}$. Equivalently, we are saying that there is a weak solution $\mu$ of $(F P)_{Y, p e r}$. We sketch a proof of this fact: the map which brings the measure $\mu_{0}$ into $\mu_{1}$, the solution of the Fokker-Planck equation at time 1, has a fixed point by the Schauder theorem.

We shall use the following classical uniqueness result ([7], proposition 1, [1], theorem 4.1, [17], theorem 5.34) to prove that $\mu$ has a smooth density $\rho_{Y}$.

Proof. We begin to note that $\mu_{t}:=\nu_{t}^{2}-\nu_{t}^{1}$ satisfies

Indeed, $\psi$ is $C^{1}$ in $t$ and $C^{2}$ in $x$ on $s<t$ by theorem 9 of chapter 1 of [10]; it is obviously $C^{2}$ on $s>t$; it is $C^{2}$ also in a neighbourhood of $s=t$, because, by the uniqueness of the Cauchy problem for the equation $\partial_{s} \phi+A_{Y} \phi=\gamma$, and the fact that $\gamma(s, x)=0$ for $s \in[t-\epsilon, t]$ we have that $\phi(s, x)=0$ for $s \geq t-\epsilon$. We use $\psi$ as a test function in (1.26), getting the second equality below.

3) There is $C_{13}>0$, independent on $Y \in V e c t$, such that

where $\mathcal{L}^{p}$ denotes the Lebesgue measure on $\mathbf{T}^{p}$. It is standard that, for $t>0, \rho_{x_{0}}(t, \cdot)$ satisfies properties d2) and d3) of the introduction, and that

$$
\begin{equation*}
\left\|\rho_{x_{0}}\right\|_{C^{1}\left([1,2] \times \mathbf{T}^{p}\right)}+\left\|\rho_{x_{0}}\right\|_{C\left([1,2], C^{2}\left(\mathbf{T}^{p}\right)\right)} \leq C_{13} \tag{1.27}
\end{equation*}
$$

for a constant $C_{13}>0$ which depends only on the $C^{1}$ norm of $Y$; as a consequence, $C_{13}$ is the same for all $Y \in V e c t$ and $x_{0} \in \mathbf{T}^{p}$ (again, we refer the reader to lemma 2.3 below).

For $t>0$, we define

$$
\begin{equation*}
\rho_{Y}(t, z)=\int_{\mathbf{T}^{p}} \rho_{x_{0}}(t, z) \mathrm{d} \mu_{0}\left(x_{0}\right) \tag{1.28}
\end{equation*}
$$

By lemma 1.6, $\rho_{Y}(t, \cdot)$ is the density of $\mu_{t}$; since $\mu_{t}$ is periodic, we get that $\rho_{Y}(t+1, \cdot)=\rho_{Y}(t, \cdot)$. Point 3) follows from this, $(1.27),(1.28)$ and the fact that norms are convex. One consequence of point 3$)$ is that $\rho_{Y}$ also satisfies hypothesis d1) of the introduction; since we saw above that it satisfies d2) and d3), we get that $\rho_{Y} \in D e n$. Again from point 3), we get that $\rho_{Y}$ is a classical solution of $(F P)_{Y, p e r}$; since by [13] there is only one of them, we get point 2 ).

We prove point 4). Let $Y_{n} \rightarrow Y$ in $C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$, and let $\rho_{Y_{n}}$ and $\rho_{Y}$ solve $(F P)_{Y_{n}, p e r}$ and $(F P)_{Y, p e r}$ respectively. We have just proved that $\rho_{Y_{n}}$ satisfies point 3) of the thesis; thus, we can apply Ascoli-Arzelà and get that, up to subsequences, $\rho_{Y_{n}} \rightarrow \rho$ in $C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$. Taking limits in (1.25) we see that $\rho$ is a weak, periodic solution of $(F P)_{Y, p e r}$; by the uniqueness of point 2 ), we get that $\rho=\rho_{Y}$. Thus, any subsequence of $\rho_{Y_{n}}$ has a sub-subsequence converging to $\rho_{Y}$ in $C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$; by a well-known principle, this implies that $\rho_{Y_{n}} \rightarrow \rho_{Y}$ in $C\left(\mathbf{T} \times \mathbf{T}^{p}\right)$.

Definition. Let $C_{13}$ be as in lemma 1.7. We group in a set $\rho \in D e n^{r e g}$ the elements of $D e n$ which belong to $\operatorname{Lip}\left(\mathbf{T} \times \mathbf{T}^{p}\right)$ and such that $\|\rho\|_{\operatorname{Lip}\left(\mathbf{T} \times \mathbf{T}^{p}\right)} \leq C_{13}$. By point 3) of lemma 1.7, if $Y \in V e c t$, then $\rho_{Y} \in D e n^{r e g}$.

Lemma 1.8. There is a continuous map $\Phi: D e n \rightarrow$ Den whose fixed points $\rho_{\beta}$ induce solutions $\left(u_{\rho_{\beta}}, \rho_{\beta}, \bar{H}_{\rho_{\beta}}(c)\right)$ of $(H J)_{\rho_{\beta}, p e r}-(F P)_{c-\partial_{x} u_{\beta}, \text { per }}$. Moreover, $\Phi(D e n) \subset D e n^{r e g}$.

Proof. We define the map $\Phi$ by composition. By lemma 1.5 and formula (1.24), we know that there is a map

$$
\Phi_{1}: \text { Den } \rightarrow \text { Vect }, \times \mathbf{R}, \quad \Phi_{1}: \psi \rightarrow\left(c-\partial_{x} u_{\psi}, \bar{H}_{\psi}(c)\right) .
$$

This map is continuous by point 3 ) of lemma 1.5 .
Let $\rho_{Y}$ be as in point 1) of lemma 1.7 ; by point 4) of this lemma, the map

$$
\Phi_{2}: \text { Vect } \times \mathbf{R} \rightarrow \text { Den, } \quad \Phi_{2}:(Y, \lambda) \rightarrow \rho_{Y}
$$

is continuous; by point 3 ), it has image in $D e n^{r e g}$. Thus, the map $\Phi:=\Phi_{2} \circ \Phi_{1}$ is continuous from Den to Den, and has image in $D e n^{r e g}$, as we wanted.

Let now $\rho_{\beta}$ be a fixed point of $\Phi$; we recall that $\Phi_{1}\left(\rho_{\beta}\right)=\left(c-\partial_{x} u_{\rho_{\beta}}, \bar{H}_{\rho_{\beta}(c)}\right)$, with $\left(u_{\rho_{\beta}}, \bar{H}_{\rho_{\beta}(c)}\right)$ which satisfies $(H J)_{\rho_{\beta}, \text { per }}$ and (1.21). Moreover,

$$
\rho_{\beta}=\Phi_{2} \circ \Phi_{1}\left(\rho_{\beta}\right)=\Phi_{2}\left(c-\partial_{x} u_{\rho_{\beta}}, \bar{H}_{\rho_{\beta}(c)}\right)
$$

solves, by the definition of $\Phi_{2},(F P)_{c-\partial_{x} u_{\rho_{\beta}}, p e r}$; in other words, $\left(\rho_{\beta}, u_{\rho_{\beta}}, \bar{H}_{\rho_{\beta}}(c)\right)$ solves $(H J)_{\rho_{\beta}, p e r}-$ $(F P)_{c-\partial_{x} u_{\rho_{\beta}}, p e r}$, and we are done.

Proof of theorem 1. We begin to show that there are couples $\left(u_{\beta}, \rho_{\beta}\right)$ which satisfy $(H J)_{\rho_{\beta}, p e r}-$ $(F P)_{c-\partial_{x} u_{\beta}, p e r}$. By lemma 1.8, this follows if we show that $\Phi$ has fixed points. But this is true by Schauder's fixed point theorem: indeed, by lemma $1.8, \Phi$ is a continuous map from $D e n$ to itself which preserves the compact, convex set Den reg.

Let us now call $\mathbf{S}$ the set of the triples $(u, \rho, H)$ such that $\rho \in D e n$ is a weak solution of $(F P)_{c-\partial_{x} u, p e r}$ and $(u, H)$ is a classical solution of $(H J)_{\rho, p e r}$. Let $\left(u^{n}, \rho^{n}, H^{n}\right) \in \mathbf{S}$ be such that

$$
\begin{equation*}
\int_{\mathbf{T} \times \mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \rho^{n}}\left(t, x, \partial_{x} u^{n}\right) \rho^{n}(t, x) \mathrm{d} t \mathrm{~d} x \rightarrow \inf _{(u, \rho, H) \in \mathbf{S}} \int_{\mathbf{T} \times \mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \rho}\left(t, x, \partial_{x} u\right) \rho(t, x) \mathrm{d} t \mathrm{~d} x . \tag{1.29}
\end{equation*}
$$

By lemma 1.1, $\mathcal{L}_{c, \frac{1}{2} \rho}$ is bounded from below independently on $\rho$; as a consequence, the inf in the right hand side of (1.29) is finite. Note that, if $\rho^{n} \in D e n$, lemma 1.5 implies that $c-\partial_{x} u^{n} \in V e c t$; since $\rho^{n}$ is a fixed point, we get by lemma 1.7 that $\rho^{n} \in D e n_{m}^{r e g}$; since $D e n^{r e g}$ is compact in Den, we can suppose that, up to subsequences,

$$
\rho^{n} \rightarrow \bar{\rho} \text { in } \quad \text { Den. }
$$

By point 3) of lemma 1.5, this implies that

$$
\left(u^{n}, H^{n}\right) \rightarrow(\bar{u}, \bar{H}) \quad \text { in } \quad\left[C\left(\mathbf{T}, C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left(\mathbf{T}, C^{1}\left(\mathbf{T}^{p}\right)\right)\right] \times \mathbf{R},
$$

with $(\bar{u}, \bar{H})$ solving $(H J)_{\bar{\rho}, p e r}$. This and point 4) of lemma 1.7 yield that $\bar{\rho}=\rho_{c-\partial_{x} \bar{u}}$ solves $(F P)_{c-\partial_{x} \bar{u}, p e r}$ and satisfies the estimate of point 3 ) of that lemma. In other words, $(\bar{u}, \bar{\rho}, \bar{H}) \in \mathbf{S}$; now (1.29) and the last three formulas easily imply that

\int_{\mathbf{T} \times \mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \bar{\rho}}\left(t, x, \partial_{x} \bar{u}\right) \bar{\rho}(t, x) \mathrm{d} t \mathrm{~d} x=\inf _{(u, \rho, H) \in S} \int_{\mathbf{T} \times \mathbf{T}^{p}} \mathcal{L}_{c, \frac{1}{2} \rho}\left(t, x, \partial_{x} u\right) \rho(t, x) \mathrm{d} t \mathrm{~d} x
$$

yielding the thesis.

## The evolution equation

In this section, we shall prove theorems 2 and 3 . We begin with some notation.
We recall that the map

:(\mu, \nu) \rightarrow d_{1}(\mu, \nu)
$$

is convex, i. e.

d_{1}\left((1-\lambda) \nu_{1}+\lambda \mu_{1},(1-\lambda) \nu_{2}+\lambda \mu_{2}\right) \leq(1-\lambda) d_{1}\left(\nu_{1}, \mu_{1}\right)+\lambda d_{1}\left(\nu_{2}, \mu_{2}\right)
$$

Indeed, the dual formulation

$$
d_{1}(\mu, \nu)=\sup \left\{\int_{\mathbf{T}^{p}} f \mathrm{~d}(\mu-\nu): f \in \operatorname{Lip}^{1}\left(\mathbf{T}^{p}\right)\right\}
$$

implies that $d_{1}$ is the supremum of a family of linear functions. Since the functions $f$ in the dual formulation belong to $\operatorname{Lip}_{1}\left(\mathbf{T}^{p}\right)$ and $\mathbf{T}^{p}$ has diameter $\sqrt{p}$, we can as well suppose that $\|f\|_{\infty} \leq \frac{1}{2} \sqrt{p}$; as a consequence,

$$
\begin{equation*}
d_{1}(\mu, \nu) \leq \sqrt{p}\|\mu-\nu\|_{t o t} \tag{2.1}
\end{equation*}
$$

where $\|\cdot\|_{\text {tot }}$ denotes total variation.

Definition. We are going to denote by the norm symbol the distance on $C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$, which is no norm at all: if $R_{1}, R_{2} \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$, then we set

$$
\left\|R_{1}-R_{2}\right\|_{C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)}=\sup _{t \in[-m, 0]} d_{1}\left(R_{1}(t), R_{2}(t)\right)
$$

Though this is no norm, it is convex thanks to the convexity of $d_{1}$ :

$$
\begin{gather*}
\left\|(1-\lambda) R_{1}+\lambda R_{2}-(1-\lambda) \tilde{R}_{1}-\lambda \tilde{R}_{2}\right\|_{C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)} \leq \\
(1-\lambda)\left\|R_{1}-\tilde{R}_{1}\right\|_{C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)}+\lambda\left\|R_{2}-\tilde{R}_{2}\right\|_{C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)} \tag{2.2}
\end{gather*}
$$

Definition. For $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and $m \in \mathbf{N}$, we group in a set $\operatorname{Den}_{m}(\mu)$ all the maps $R \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ such that $R(-m)=\mu$. This space inherits the distance of $C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$.

Lemma 2.1. Let $f \in C^{3}\left(\mathbf{T}^{p}\right)$ and let $H^{Z}(t, q, p)=\frac{1}{2}|p|^{2}+Z(t, q)$, with $Z \in C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)$.

1) Then, there is a unique solution $u^{Z}$ of

$$
\left\{\begin{array}{l}
\frac{1}{2 \beta} \Delta u^{Z}+\partial_{t} u^{Z}-H^{Z}\left(t, x, c-\partial_{x} u^{Z}\right)=0, \quad t \in[-m, 0]  \tag{HJ}\\
u^{Z}(0, x)=f \quad \forall x \in \mathbf{T}^{p} .
\end{array}\right.
$$

2) There is $C_{13}>0$, only depending on $\|f\|_{C^{3}\left(\mathbf{T}^{p}\right)},\|Z\|_{C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)}$ and $m$, such that

$$
\left\|u^{Z}\right\|_{C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)}+\left\|u^{Z}\right\|_{C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)} \leq C_{13}
$$

3) The map

$$
: Z \rightarrow u^{Z}
$$

is continuous from $C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)$ to $C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)$.

Proof. We know that the twisted Schroedinger equation with potential $Z$ and final condition $e^{-\beta f} \in$ $C^{3}\left(\mathbf{T}^{p}\right)$ has a unique solution $v^{Z}$, which can be represented by the Feynman-Kac formula (1.20) with $e^{-\beta f}$
in stead of $v_{\psi}$ and $Z$ in stead of $P_{\psi}$. Since $e^{-\beta f}>0$, we get that $v^{Z}>0$ too. We saw in section 1 that $u^{Z}=-\frac{1}{\beta} \log v^{Z}$ solves $(H J)^{Z}$, and point 1) follows.

Points 2) and 3 ) follow as in section 1 if we prove that

$$
\left\|\partial_{x} v^{Z}\right\|_{C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)}+\left\|v^{Z}\right\|_{C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)} \leq C_{14}
$$

and that the map : $Z \rightarrow\left(v^{z}, \partial_{x} v^{z}\right)$ is continuous. Since $e^{-\beta f}$, the final condition of the Schroedinger equation, is of class $C^{3}$, this is a standard result; for instance, differentiation under the integral sign in (1.20) gives the estimate on $\left\|v^{Z}\right\|_{C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)}$; from this and the fact that $v^{Z}$ solves the Scroedinger equation, we get the estimate on $\left\|v^{Z}\right\|_{C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)}$.

Recalling lemma 1.1, we get this immediate consequence.

Corollary 2.2. 1) Let $f \in C^{3}\left(\mathbf{T}^{p}\right)$, let $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and let $R \in \operatorname{Den}^{m}(\mu)$. Then, there is a unique solution $u_{R}$ of

$$
\left\{\begin{array}{l}
\frac{1}{2 \beta} \Delta u_{R}+\partial_{t} u_{R}-H_{R}\left(t, x, c-\partial_{x} u_{R}\right)=0, \quad t \in[-m, 0]  \tag{HJ}\\
u_{R}(0, x)=f \quad \forall x \in \mathbf{T}^{p} .
\end{array}\right.
$$

2) There is $C_{14}=C_{14}(m)>0$, independent of $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and on $R \in \operatorname{Den}_{m}(\mu)$, such that

$$
\left\|u_{R}\right\|_{C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)}+\left\|u_{R}\right\|_{C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)} \leq C_{14} .
$$

3) The map

$$
: R \rightarrow u_{R}
$$

is continuous from $\operatorname{Den}_{m}(\mu)$ to $C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right) \cap C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right)$.

Definition. By point 2) of corollary 2.2 , there is $C_{15}>0$ such that, setting $Y=c-\partial_{x} u_{R}$, we have

$$
\|Y\|_{C^{1}\left([-m, 0], C\left(\mathbf{T}^{p}\right)\right)}+\|Y\|_{C\left([-m, 0], C^{2}\left(\mathbf{T}^{p}\right)\right)} \leq C_{15}
$$

with $C_{15}$ independent on $R \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$. We group in a set $V_{e c t}{ }_{m}$ all the vector fields $Y$ on $[-m, 0] \times \mathbf{T}^{p}$ which satisfy the estimate above. The distance on Vect $_{m}$ is the one induced by the norm above.

Lemma 2.3. Let $Y \in \operatorname{Vect}_{m}$, and let $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$. Then, the following holds.

1) There is a unique $R_{Y} \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ which solves $(F P)_{-m, Y, \mu}$ in the weak sense.
2) For $t \in(-m, 0], R_{Y}(t)$ has density $\rho_{Y}$. There are $C_{16}, C_{17}:(-m, 0] \rightarrow[0,+\infty)$, independent on $Y \in$ Vect $_{m}$ and on $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$, such that
a) $C_{17}(T) \rightarrow 0$ as $T \rightarrow-m, C_{16}$ and $C_{17}$ are bounded on ( $\left.-m+\epsilon, 0\right]$ for all $\epsilon \in(0, m)$ and
b) For $T \in(-m, 0]$, we have

$$
\left\{\begin{array}{l}
\left\|\rho_{Y}\right\|_{C^{1}\left((T, 0) \times \mathbf{T}^{p}\right)}+\left\|\rho_{Y}\right\|_{C\left((T, 0), C^{2}\left(\mathbf{T}^{p}\right)\right.} \leq C_{16}(T)  \tag{2.3}\\
d_{1}\left(R_{Y}(T), \mu\right) \leq C_{17}(T)
\end{array}\right.
$$

where $d_{1}$ denotes the 1-Wasserstein distance.

Proof. The uniqueness of point 1) comes from lemma 1.6; for the existence, we begin to recall from PDE theory (see for instance chapter 1 of [10]) that, for $x_{0} \in \mathbf{T}^{p},(F P)_{-m, Y, \delta_{x_{0}}}$ has a solution $R_{x_{0}}$ with density $\rho_{x_{0}}$. Always from [10], the function $\rho_{x_{0}}$ satisfies the first formula of (2.3) for a constant $C_{16}(T)$ which depends neither on $x_{0} \in \mathbf{T}^{p}$ nor on the particular element $Y \in V^{\prime} c_{m}$. Moreover, as $T \rightarrow-m$, we get from [10] that, if $g \in C\left(\mathbf{T}^{p}\right)$, then

$$
\int_{\mathbf{T}^{p}} g(x) \mathrm{d} R_{x_{0}}(T) \rightarrow g\left(x_{0}\right)
$$

uniformly in $x_{0} \in \mathbf{T}^{p}$; since $d_{1}$ induces the weak* topology and $\mathbf{T}^{p}$ is compact, we have that $d_{1}\left(R_{x_{0}}(T), \delta_{x_{0}}\right) \leq$ $C_{17}(T)$, for a constant $C_{17}(T)$ which depends neither on $x_{0} \in \mathbf{T}^{p}$ nor on $Y \in V e c t_{m}$, and such that $C_{17}(T) \rightarrow 0$ as $T \rightarrow-m$. In other words, $\rho_{x_{0}}$ satisfies (2.3) for two uniform constants $C_{16}(T), C_{17}(T)$, depending neither on $x_{0}$ nor on $Y \in$ Vect $_{m}$.

Now we set

$$
\begin{equation*}
\rho_{Y}(t, x)=\int_{\mathbf{T}^{p}} \rho_{x_{0}}(t, x) \mathrm{d} \mu\left(x_{0}\right) . \tag{2.4}
\end{equation*}
$$

Clearly, $\rho_{Y}$ is a solution of $(F P)_{-m, Y, \mu}$, and this ends the proof of point 1$)$.
We have seen that $\rho_{x_{0}}$ satisfies the first formula of (2.3); since norms are convex, (2.4) implies that $\rho_{Y}$ too satisfies this formula. Now $\rho_{x_{0}}$ satisfies $d_{1}\left(R_{x_{0}}(T), \delta_{x_{0}}\right) \leq C_{17}(T)$, and the map

$$
:(\mu, \nu) \rightarrow d_{1}(\mu, \nu)
$$

is convex; it follows again by (2.4) that $\rho_{Y}$ too satisfies the second formula of (2.3).

Definition. We define $\operatorname{Den} n_{m}^{r e g}(\mu)$ as the subset of the elements $R \in D e n_{m}(\mu)$ which, for $t \in(-m, 0]$, have a density $\rho$ with respect to the Lebesgue measure. Moreover, we ask that $R$ and $\rho$ satisfy

$$
\left\{\begin{array}{l}
\|\rho\|_{L i p\left([T, 0] \times \mathbf{T}^{p}\right)} \leq C_{16}(T), \quad \forall T \in(-m, 0]  \tag{2.5}\\
d_{1}(R(T), \mu) \leq C_{17}(T), \quad \forall T \in(-m, 0]
\end{array}\right.
$$

where $C_{16}(T)$ and $C_{17}(T)$ are the same two constants of (2.3). By lemma 2.3, if $Y \in V e c t, \mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and $R_{Y}$ solves $(F P)_{-m, Y, \mu}$ in the weak sense, then $R_{Y} \in \operatorname{Den}_{m}^{r e g}(\mu)$.

Lemma 2.4. $\quad \operatorname{Den}_{m}^{r e g}(\mu)$ is compact in $\operatorname{Den}_{m}(\mu)$ for the $C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ topology.

Proof. Let $R_{n} \in \operatorname{Den}_{m}^{r e g}(\mu)$ have density $\rho_{n}$ for $n \in \mathbf{N}$. We must show that it has a subsequence converging in $\operatorname{Den}_{m}(\mu)$.

Since $\rho_{n}$ satisfies the first formula of (2.5), Ascoli-Arzelà implies that, up to subsequences, $\rho_{n} \rightarrow \rho$ in $C_{l o c}^{0}\left((-m, 0] \times \mathbf{T}^{p}\right)$; clearly, $\rho$ satisfies the first formula of (2.5). Denoting by $\mathcal{L}^{p}$ the Lebesgue measure on $\mathbf{T}^{p}$, we set $R(t)=\rho(t) \mathcal{L}^{p}$ and we see that, for any fixed $T \in(-m, 0]$,

where the first inequality comes from (2.1) and the limit from the fact that $\rho_{n} \rightarrow \rho$ in $C_{l o c}^{0}\left((-m, 0] \times \mathbf{T}^{p}\right)$. Since $R_{n}$ satisfies the second formula of (2.5), we have that

The last two formulas imply that $R$ satisfies the second formula of (2.5).
It remains to prove that $R_{n} \rightarrow R$ in $C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$; it suffices to note that, for $\delta \in(0, m)$,

where the last inequality comes from the second formula of (2.5) and from (2.1). Since $C_{17}(T) \rightarrow 0$ as $T \searrow-m$, we can fix $\delta>0$ so that the first term on the right is smaller than $\epsilon$; having thus fixed $\delta$, we take $n$ so large that, by convergence in $C_{l o c}^{0}\left((-m, 0] \times \mathbf{T}^{p}\right)$, the second term on the right is smaller than $\epsilon$, and we are done.

We only sketch the proof of the next lemma, since it is identical to point 4) of lemma 1.7.

Lemma 2.5. Given $\epsilon>0$, we can find $\delta>0$ with the following property. Let $Y, \bar{Y} \in V e c t_{m}$ and let $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$; let $R_{\bar{Y}}$ and $R_{Y}$ satisfy $(F P)_{-m, \bar{Y}, \mu}$ and $(F P)_{-m, Y, \mu}$ respectively. Let $\|\bar{Y}-Y\|_{C\left([-m, 0] \times \mathbf{T}^{p}\right)} \leq \delta$. Then, $\left\|R_{\bar{Y}}-R_{Y}\right\|_{C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)} \leq \epsilon$.

Proof. Let $\left\{Y_{n}\right\}_{n \geq 1},\left\{\bar{Y}_{n}\right\}_{n \geq 1}$ be two sequences in Vect $_{m}$ and let $\left\{\mu_{n}\right\}_{n \geq 1} \subset \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$. We suppose that $\left\|\bar{Y}_{n}-Y_{n}\right\|_{C\left([-m, 0] \times \mathbf{T}^{p}\right)} \rightarrow 0$; we let $R_{Y_{n}}$ solve $(F P)_{-m, Y_{n}, \mu_{n}}$ and $R_{\bar{Y}_{n}}$ solve $(F P)_{-m, \bar{Y}_{n}, \mu_{n}}$; we have to prove that

Since $\bar{Y}_{n}, Y_{n} \in$ Vect $_{m}$ and $\left\|\bar{Y}_{n}-Y_{n}\right\|_{C\left([-m, 0] \times \mathbf{T}^{p}\right)} \rightarrow 0$, by Ascoli-Arzelà up to taking subsequences we can suppose that $\bar{Y}_{n}, Y_{n} \rightarrow Y$ in $C\left([-m, 0] \times \mathbf{T}^{p}\right)$; we can also suppose that $\mu_{n} \rightarrow \mu$. To reach a contradiction
with the formula above, it suffices to show that $R_{Y_{n}}$ and $R_{\bar{Y}_{n}}$ both converge to $R_{Y}$; since the proof for $R_{\bar{Y}_{n}}$ is analogous, we prove convergence for $R_{Y_{n}}$.

We note that $\left\{R_{Y_{n}}\right\}$ in contained in $\operatorname{Den}_{m}^{r e g}\left(\mu_{n}\right)$ by lemma 2.3 ; thus, by lemma 2.4 , it has a subsequence converging to a limit $R$. Since $R_{Y_{n}}$ is a weak solution of $(F P)_{-m, Y_{n}, \mu_{n}}$, we easily get that $R$ is a weak solution of $(F P)_{-m, Y, \mu}$; by lemma $1.6, R=R_{Y}$. In other words, every subsequence of $R_{Y_{n}}$ has a sub-subsequence converging to $R_{Y}$; this implies that $R_{Y_{n}}$ converges to $R_{Y}$, and we are done.

Proof of theorem 2. For $Q \in \operatorname{Den}_{m}(\mu)$, let $u_{Q}$ be as in corollary 2.2; for $Y \in V e c t_{m}$, let $R_{Y}=\rho_{Y} \mathcal{L}^{p}$ be as in lemma 2.3. The two maps

Being the composition of two continuous functions, $\Phi$ is continuous; moreover, by point 2) of lemma 2.3 , it has image in $D e n_{m}^{r e g}(\mu)$; this latter set is clearly convex, and it is compact in $D e n_{m}(\mu)$ by lemma 2.4. Thus, we have that

With the same argument as in the proof of theorem 1, we see that, if $R$ is a fixed point of $\Phi$, then $\left(u_{R}, R\right)$ solves $(H J)_{R, f}-(F P)_{-m, c-\partial_{x} u_{R}, \mu}$. This yields existence.

We continue as in the proof of theorem 1 . Let us call $\mathbf{S}$ the set of the couples $(u, R)$ where $u$ is a classical solution of $(H J)_{R, f}$ and $R \in \operatorname{Den}_{m}(\mu)$ is a weak solution of $(F P)_{-m, c-\partial_{x} u, \mu}$.

Let us consider a sequence $\left(u_{n}, R_{n}\right) \in \mathbf{S}$ such that, denoting by $\rho_{n}$ the density of $R_{n}$,

Whatever is $R_{n} \in \operatorname{Den}_{m}(\mu), u_{n}$ satisfies the estimates of point 2 ) of corollary 2.2 ; in particular, $c-\partial_{x} u_{n} \in$ Vect ${ }_{m}$. Since $R_{n}$ satisfies $(F P)_{-m, c-\partial_{x} u_{n}, \mu}$ lemma 2.3 implies that $R_{n} \in \operatorname{Den}_{m}^{r e g}(\mu)$; by lemma 2.4 , up to subsequences we can suppose that $R_{n} \rightarrow \bar{R}$, with $\bar{R} \in D e n_{m}^{r e g}(\mu)$. By point 3 ) of corollary 2.2 , we get that $u_{n} \rightarrow \bar{u}$ in $C^{1}\left([-m, 0], C^{1}\left(\mathbf{T}^{p}\right)\right) \cap C\left([-m, 0], C^{3}\left(\mathbf{T}^{p}\right)\right)$, and that $\bar{u}$ solves $(H J)_{\bar{R}, f}$. Thus, $(\bar{u}, \bar{R}) \in \mathbf{S}$; now, the formula above easily implies that $(\bar{u}, \bar{R})$ is minimal in $\mathbf{S}$.

We turn to the proof of theorem 3; our route will pass through an approximation with a finite number of particles.
Definitions. Let us define the Lagrangian for one particle as

The infimum above is over all vector fields $Y^{n}(s, x)=\left(Y_{1}^{n}\left(s, x_{1}\right), Y_{2}^{n}\left(s, x_{2}\right), \ldots, Y_{n}^{n}\left(s, x_{n}\right)\right)$ continuous in $s$ and Lipschitz in $x$; each component of the function

In the formula above, each $w_{i}$ is a standard Brownian motion on $\mathbf{R}^{p}$; the $w_{i}$ are independent and $E_{w_{1}, \ldots, w_{n}}$ denotes the expectaction with respect to the product of the Wiener measures. It remains to define $R^{n}(-m, 0)$; to do this, we let $\rho_{i}^{n}(-m, s, x)$ be the density on $\mathbf{T}^{p}$ which solves $(F P)_{-m, Y_{i}^{n}, \delta_{z_{i}}}$ and we set, for $t \in[-m, 0]$,

We note that we are not considering the most general vector field $Y$ on $\left(\mathbf{T}^{p}\right)^{n}$. On the contrary, we assign to each particle $x_{i} \in \mathbf{T}^{p}$ a control $Y_{i}$ which depends only on $x_{i}$, and not on the positions of the other particles; these, however, interact with $x_{i}$ via the potential $W$. We have chosen this particular problem because we want $U_{n}(-m, z)$ to converge, as $n \rightarrow+\infty$, to $\Lambda_{c}^{m} U$; we recall that, in the definition of $\Lambda_{c}^{m}$, there is a control $Y$ which depends on the single particle in $\mathbf{T}^{p}$.

Lemma 2.6. Let us suppose that $U$ is as in the statement of theorem 1 and let $U^{n}(-m, z)$ be defined as in (2.6). Then for any fixed $n \in \mathbf{N}$, the infimum in (2.6) is a minimum.

Proof. Let $\left\{Y^{n, k}\right\}_{k \geq 1}$ be a minimizing sequence. We are going to show that we can build another minimizing sequence, say $\left\{\tilde{Y}^{n, k}\right\}_{k \geq 1}$, which is Lipschitz in $(t, x)$ uniformly in $k$. Once we know this, the lemma follows by Ascoli-Arzelà.

For the vector field $Y^{n, k}$, let us define $\rho_{i}^{n, k}$ and $\rho^{n, k}$ as in (2.7); we set

Note that, in contrast with $L_{c}^{n}$, a factor $\frac{1}{2}$ in the interaction sum is missing. We know from lemma 1.1 that the potential in $L_{c, Y^{n, k}, i}^{n}$ satisfies a uniform $C^{3}$ estimate. By [9], for $(t, x) \in[-m, 0] \times \mathbf{T}^{p}$, there is $\tilde{Y}_{i}^{n, k}$ on which the minimum below is attained

By lemma 2.1,

In the following, whenever we have a drift, say $Y_{i}^{B}$, we shall denote by $X_{i}^{B}\left(t, s, x_{i}\right)$ the solution of $(S D E)_{t, Y_{i}^{B}, \delta_{x_{i}}}$; we shall set $X^{B}=\left(X_{1}^{B}, \ldots, X_{n}^{B}\right)$ and $z=\left(z_{1}, \ldots, z_{n}\right)$.

We are going to isolate the first particle and show that the mean action decreases if we substitute $Y_{1}^{n, k}$ with the smoother $\tilde{Y}_{1}^{n, k}$ defined above. Since the interaction potential is even and satisfies $W(0)=0$, we get the first equality below; since the Brownian motions $\left(w_{1}, \ldots, w_{n}\right)$ are independent, we get the second one.

If we consider $\left(\tilde{Y}_{1}^{n, k}, Y_{2}^{n, k}, \ldots, Y_{n}^{n, k}\right)$ instead of $\left(Y_{1}^{n, k}, Y_{2}^{n, k}, \ldots, Y_{n}^{n, k}\right)$, we see that the terms $a 1$ ) and $a 2$ ) in the formula above remain the same, while, by our choice of $\left.\tilde{Y}_{1}^{n, k}, a 3\right)$ gets smaller. After applying this procedure to each coordinate, we get a sequence $\tilde{Y}^{n, k}=\left(\tilde{Y}_{1}^{n, k}, \ldots, \tilde{Y}_{n}^{n, k}\right)$ which satisfies the following two properties.

Thus, for each $i$,

From the proof of the last lemma, we extract the following corollary: it says that the minimum in (2.6) is a Nash equilibrium ([4]). Note one fact about the value function $u_{i}^{n}$ in the corollary below: for simplicity, we let $i=1$. Then the function $u_{1}^{n}$ depends not only on $\left(x_{2}, \ldots, x_{n}\right)$, but on $x_{1}$ too: namely, if $x_{1}$ moves, the drifts $\left(Y_{2}, \ldots, Y_{n}\right)$ will adjust, and the Lagrangian $L_{c, Y, 1}$ will change. If it hadn't been too clumsy, we could have written $u_{1}^{n,\left(x_{1}, \ldots, x_{n}\right)}$ and said that $c-\partial_{x} u_{1}^{n,\left(x_{1}, \ldots, x_{n}\right)}(x)$ is the best drift for particle $x_{1}$.

Corollary 2.7. Let $\bar{Y}^{n}(t, x)=\left(\bar{Y}_{1}^{n}\left(t, x_{1}\right), \ldots, \bar{Y}_{n}^{n}\left(t, x_{n}\right)\right)$ be minimal in (2.6) and let $L_{c, \bar{Y}^{n}, i}^{n}$ be defined as in (2.8). Let

The functions $\rho$ and $\tilde{\rho}$ in the formula above satisfy $(F P)_{-m, Y, \mu}$ and $(F P)_{-m, \tilde{Y}, \mu}$ respectively, while $X$ and $\tilde{X}$ satisfy $(S D E)_{-m, Y, \mu}$ and $(S D E)_{-m, \tilde{Y}, \mu}$ respectively. The minimum is taken over all Lipschitz vector fields $\tilde{Y}$.

Note that, in principle, $U(-m, \mu)$ could depend on the subsequence $\left\{n_{k}\right\}_{k \geq 1}$ chosen in lemma 2.8; the formula above says that this is not the case. Moreover, it says that any $(u, \rho)$ arising in lemma 2.8 as the limit of a subsequence, minimizes the last expression of (2.18).

The second equality of (2.18) follows from lemma 2.8: it is just another way of writing (2.12). Again by lemma $2.8,(u, \rho) \in \mathbf{S}$, and thus, by the definition of $\left(\Lambda_{c}^{m} U\right)(\mu)$,

Let $\tilde{\rho}$ solve $(F P)_{-m, \tilde{Y}, \mu}$ and let $\tilde{\rho}_{i}$ solve $(F P)_{-m, \tilde{Y}, \delta_{z_{i}}}$; by linearity, we get that $\frac{1}{n} \sum_{i=1}^{n} \tilde{\rho}_{i}(-m, s, x)$ solves $(F P)_{-m, \tilde{Y}, \frac{1}{n}\left(\delta_{z_{1}+\ldots+\delta_{z_{n}}}\right)}$. In other words, $\tilde{\rho}$ and $\frac{1}{n} \sum_{i=1}^{n} \tilde{\rho}_{i}(-m, s, x)$ solve a Fokker-Planck equation with the same drift, but initial distributions $\mu$ and $\frac{1}{n}\left(\delta_{z_{1}}+\ldots \delta_{z_{n}}\right)$ respectively; by $(2.10)$, it is standard to see that

In the formula above, $X_{1}$ solves $(S D E)_{-(n+m), Y_{1}, \mu}, X_{2}$ solves $(S D E)_{-m, Y_{2}, \rho_{1}(-m)}, X$ solves $(S D E)_{-(n+m), Y, \mu}$ and $\rho_{1}, \rho_{2}, \rho_{Y}$ are the densities of the laws of $X_{1}, X_{2}$ and $X$ respectively.

Moreover, we can require that

We note that $X=X_{1}$ when $s \in[-(n+m),-n]$, since both functions solve the same stochastic differential equation; as a consequence,

To prove this, we recall that $X$ and $X_{2}$ solve two stochastic differential equations with drift $Y$ and $Y_{2}$ respectively; this means that, for $s \geq-n$ and any trajectory $w$ of the Brownian motion, we have that

Since $Y$ and $Y_{2}$ are bounded uniformly in $\bar{\delta}$, we get that $|a| \leq M$ if $\tau \in[-n, 0]$ for a constant $M$ independent on $\bar{\delta}$; since $Y$ coincides with the Lipschitz $Y_{2}$ on $[-n+\bar{\delta}, 0]$, we get that, for $\tau \geq-n+\bar{\delta}$,

Proposition 2.10. 1) The map $\Psi_{c}^{m}$ defined in the introduction has the semigroup property, i. e. for $n, m \geq 0$ and $U \in C\left(\mathcal{M}_{1}\left(\mathbf{T}^{p}\right), \mathbf{R}\right)$,

Proof. Properties 2) and 3) follow in a standard way from the definition of $\Psi_{c}^{m}$; we prove 1).
Let $\mu \in \mathcal{M}_{1}$; by the definition of $\Psi_{c}^{n+m} U$ as an infimum, for any $\epsilon>0$ we can find a Lipschitz vector field $Y$ such that

\left(\Psi_{c}^{m} \circ \Psi_{c}^{n} U\right)(\mu)-\epsilon .

The second and third inequalities above come from the definition of $\Psi_{c}^{n} U$ and $\Psi_{c}^{m} \circ \Psi_{c}^{n} U$ as infima. Since $\epsilon$ is arbitrary, this means that

Let $\epsilon, \delta>0$; by lemma 2.9, we can find a Lipschitz vector field $Y$ equal to $Y_{1}$ on $[-(n+m),-n] \times \mathbf{T}^{p}$ and to $Y_{2}$ on $[-n+\delta, 0] \times \mathbf{T}^{p}$, such that (2.22) and (2.23) holds. The first inequality below comes from the definition of $\Psi^{n+m} U$ as a infimum; the second one from (2.22) and (2.23); the third and fourth ones come from (2.30) and (2.29) respectively.

Since $\epsilon>0$ is arbitrary, we get the inequality opposite to (2.28), and thus the thesis.

## Fixed points

As in [8] and in [15], the following proposition is essential in proving theorem 4.

Proposition 3.1. Let $U$ be linear as in theorem 2. Then, there is $L>0$, independent on $n$, such that $\Lambda_{c}^{n} U=\Psi_{c}^{n} U$ is L-Lipschitz for the Wasserstein distance $d_{1}$.

To prove this proposition, we shall need two lemmas.

Lemma 3.2. Let $R \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$ and let $u$ solve $(H J)_{R, f}$. Then, there is $C>0$, independent both of $m \in \mathbf{N}$ and of $R \in C\left([-m, 0], \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)\right)$, such that

Proof. We have seen in section 1 that, if $u$ is a solution of $(H J)_{R, f}, v=e^{-\beta u}$ and $a \in \mathbf{R}$, then $e^{-\beta a} v=$ $e^{-\beta(u+a)}$ is a solution of $(T S)_{R, e^{-\beta(f+a)}}$ with $A=0$. Let $a_{k} \in \mathbf{R}$ such that $e^{-\beta a_{k}} v(-k, \cdot)=e^{-\beta\left(u+a_{k}\right)}$ satisfies (1.7) for $k=0,1,2, \ldots$ By the Feynman-Kac formula, for $k \geq 0$,

\frac{1}{C_{1}} \leq e^{-\beta a_{k}} v(-k-1, x) \leq C_{1} \quad \forall x \in \mathbf{T}^{p}
$$

We consider (3.1) with $e^{-\beta a_{k}} v(-k-1, x)$ on the right hand side and differentiate under the integral sign; proceeding as in lemma 1.3 , and using the last formula, we get that, for $k \geq 0$,

\left\|e^{-\beta a_{k}} v(-k-2, \cdot)\right\|_{C^{3}\left(\mathbf{T}^{p}\right)} \leq C_{2}
$$

As in lemma 1.4, this implies that there is $C_{3}>0$, independent on $k \geq 0$ (it depends only on $C_{1}$ and $C_{2}$ ) such that, for $k \geq 0$,

\left\|e^{-\beta a_{k}} v(t, \cdot)\right\|_{C\left([-(k+3),-(k+2)], C^{3}\left(\mathbf{T}^{p}\right)\right)}+\left\|e^{-\beta a_{k}} v(t, \cdot)\right\|_{C^{1}\left([-(k+3),-(k+2)], C^{1}\left(\mathbf{T}^{p}\right)\right)} \leq C_{3} .
\end{gathered}
$$

By our definition of $v$,

\text { for } \quad t \in[-(k+3),-(k+2)], \quad u=-\frac{1}{\beta} \log \left(e^{-\beta a_{k}} v\right)-a_{k} .
$$

From the two formulas above, we get that

\left\|\partial_{x} u\right\|_{C\left([-m,-2], C^{2}\left(\mathbf{T}^{p}\right)\right)}+\left\|\partial_{x} u\right\|_{C^{1}\left([-m,-2], C\left(\mathbf{T}^{p}\right)\right)} \leq C \quad \text { for } \quad t \leq-2 .
$$

It remains to bound $\partial_{x} u(t, x)$ when $t \in[-2,0]$; since $f \in C^{3}\left(\mathbf{T}^{p}\right)$, this follows by differentiation under the integral sign in (1.20), and we are done.

We recall some notation: in the following $U^{n}(-m, z)$ will be the minimum in (2.6); moreover, given $z=\left(z_{1}, \ldots, z_{n}\right) \in\left(\mathbf{R}^{p}\right)^{n}$, we set

Lemma 3.3. Let $U$ be as in theorem 2 and let $U^{n}(-m, z)$ be defined as in (2.6). Then, there is a constant $C>0$ such that, for all positive integers $n$ and $m$, we have

is $\frac{C}{n}$-Lipschitz and that the constant $C$ does not depend neither on $m \in \mathbf{N}$ nor on $\left(z_{1}, \ldots, z_{i-1}, z_{i+1}, \ldots, z_{n}\right) \in$ $\left(\mathbf{T}^{p}\right)^{n-1}$. We shall prove this for $i=1$; from this the general case follows, since $U$ is a symmetric function of $\left(z_{1}, \ldots, z_{n}\right)$.

We write the function $U^{n}\left(-m,\left(z_{1}, z^{\prime}\right)\right)$ as in lemma 2.6, isolating particle $z_{1}$ :

\left.\frac{1}{2 n^{2}} \sum_{j, i \neq 1} \int_{-m}^{0} W\left(X_{i}\left(-m, s, z_{i}\right)-X_{j}\left(-m, s, z_{j}\right)\right) \mathrm{d} s+\frac{1}{n} \sum_{j \neq 1} f\left(X_{j}\left(-m, 0, z_{j}\right)\right)\right\}+ \\
\frac{1}{n} E_{w_{1}}\left\{\int_{-m}^{0} L_{c, Y, 1}^{n}\left(s, X_{1}\left(-m, s, z_{1}\right), Y_{1}\left(s, X_{1}\left(-m, s, z_{1}\right)\right)\right) \mathrm{d} s+f\left(X_{1}\left(-m, 0, z_{1}\right)\right)\right\} \tag{3.2}
\end{gather*}
$$

where the vector field $Y=\left(Y_{1}, \ldots, Y_{n}\right)$ is minimal. By the definition of $U^{n}\left(-m,\left(\tilde{z}_{1}, z^{\prime}\right)\right)$ as a minimum, we get that

U^{n}\left(-m,\left(\tilde{z}_{1}, z^{\prime}\right)\right) \leq E_{w_{1}, \ldots, w_{n}}\left\{\frac{1}{n} \sum_{j \neq 1} \int_{-m}^{0} L_{c}\left(s, X_{j}\left(-m, s, z_{j}\right), Y_{j}\left(s, X_{j}\left(-m, s, z_{j}\right)\right)\right) \mathrm{d} s+\right.
$$

$$
\begin{align*}
& \left.\frac{1}{2 n^{2}} \sum_{j, i \neq 1} \int_{-m}^{0} W\left(X_{i}\left(-m, s, z_{i}\right)-X_{j}\left(-m, s, z_{j}\right)\right) \mathrm{d} s+\frac{1}{n} \sum_{j \neq 1} f\left(X_{j}\left(-m, 0, z_{j}\right)\right)\right\}+ \\
& \frac{1}{n} E_{w_{1}}\left\{\int_{-m}^{0} L_{c, Y, 1}^{n}\left(s, X_{1}\left(-m, s, \tilde{z}_{1}\right), Y_{1}\left(s, X_{1}\left(-m, s, \tilde{z}_{1}\right)\right)\right) \mathrm{d} s+f\left(X_{1}\left(-m, 0, \tilde{z}_{1}\right)\right)\right\} . \tag{3.3}
\end{align*}
$$

The term with $E_{w_{1}, \ldots, w_{n}}$ is identical in (3.2) and (3.3); defining $u_{1}^{n}$ as in corollary 2.7, we see that the term with $E_{w_{1}}$ is equal to the function $u_{1}^{n}\left(-m, z_{1}\right)$ in (3.2), and to $u_{1}^{n}\left(-m, \tilde{z}_{1}\right)$ in (3.3); subtracting (3.2) from (3.3), we get that

where the last inequality comes from lemma 3.2. Exchanging the rôles of $z_{1}$ and $\tilde{z}_{1}$, we get that the function $: z_{1} \rightarrow U^{n}\left(-m,\left(z_{1}, z^{\prime}\right)\right)$ is $\frac{C}{n}$-Lipschitz; we saw at the beginning of the proof that this implies the thesis.

Proof of proposition 3.1. By lemma 2.8, we know that

We saw in (2.18) that $U(-m, \mu)=\left(\Lambda_{c}^{m} U\right)(\mu)$. Thus it suffices to show that

It is standard ([5]) that

\end{equation*}

where the minimum is taken over all the permutations $\sigma$ of $\{1, \ldots, n\}$. In terms of transport, when we are connecting two $n$-uples of deltas, there is not just a minimal transfer plan, but a minimal transfer map.

Since

But this is an immediate consequence of lemma 3.3.

When $U$ is linear, we define $\Lambda_{c, \lambda} U=\Lambda_{c} U+\lambda$; thus, in case of a linear $U$, we have that $\Lambda_{c, \lambda} U=\Psi_{c, \lambda} U$ for the operator $\Psi_{c, \lambda}$ defined in the introduction. In the next lemma, we stick to the $\Lambda_{c, \lambda}$ notation.

Lemma 3.4. Let the operator $\Lambda_{c, \lambda}$ be defined as in the introduction and let $U=0$. Then, there is a unique $\lambda \in \mathbf{R}$ such that

\hat{U}(\mu):=\liminf _{n \rightarrow+\infty}\left(\Lambda_{c, \lambda}^{n} 0\right)(\mu)
$$

is finite for all $\mu \in \mathcal{M}_{1}$. Moreover, $\hat{U}$ is $L$-Lipschitz for the constant $L$ of proposition 3.1.

Proof. Clearly, there is at most one $\lambda \in \mathbf{R}$ for which the lim inf above is finite; let us prove that it exists. This means finding $\lambda \in \mathbf{R}$ such that, for all $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$,

Note that the formula above implies that $\hat{U}$ is finite; it is $L$-Lipschitz because it is the lim inf of $L$-Lipschitz functions.

By proposition 3.1, $\Lambda_{c, 0}^{n} 0$ is $L$-Lipschitz for all $n \in \mathbf{N}$; since $\mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ is a compact metric space, we can find $M>0$ such that

\end{equation*}

From (3.10), it follows that $\lambda \in[-M, M]$. We assert that $\lambda$ satisfies (3.8). We prove the inequality on the left of (3.8), since the one on the right is analogous; actually, we are going to prove that, for all $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and all $n \in \mathbf{N}$,

Indeed, let us suppose by contradiction that, for some $m \in \mathbf{N}$ and $\bar{\mu} \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$, we have

Proof of theorem 4. Let $\hat{U}$ be as in the last lemma; since $\hat{U}$ may not be linear, we switch to the $\Psi_{c, \lambda}^{1}$ notation. We have to prove that $\hat{U}$ is a fixed point of $\Psi_{c, \lambda}^{1}$ and that a minimizing vector field exists.

Let $\mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)$ and $\epsilon>0$; by the definition of $\Psi_{c, \lambda}^{1} \hat{U}$, we can find a Lipschitz vector field $\bar{Y}$ for which

Let $n \in \mathbf{N}$; by theorem 3, applied to $f \equiv 0$ with an obvious translation in time, we can find $Y_{n}$ be such that

Let $\tilde{Y}$ be equal to $\bar{Y}$ on $[0,1] \times \mathbf{T}^{p}$, to $Y_{n}$ on $[1+\delta, n+1] \times \mathbf{T}^{p}$ and a Lipschitz connection in between. By lemma 2.9, we can choose the Lipschitz connection in such a way that

E_{w}\left\{\int_{0}^{n+1} \mathcal{L}_{c, \frac{1}{2} \tilde{\rho}}(s, \tilde{X}(0, s, \mu), \tilde{Y}(s, \tilde{X}(0, s, \mu))) \mathrm{d} s\right\}-\epsilon \tag{3.14}
\end{equation*}
$$

Now (3.13) and the definition of $\hat{U}$ imply the first inequality below, (3.14) the second one while the third one follows from the definition of $\Psi_{c, \lambda}^{n+1} 0$. The equality at the end follows by the definition of $\hat{U}$.

\liminf _{n \rightarrow+\infty} E_{w}\left\{\int_{1}^{n+1} \mathcal{L}_{c, \frac{1}{2} \rho_{n}}\left(s, X_{n}\left(1, s, \rho_{\bar{Y}}(1)\right), Y_{n}\right) \mathrm{d} s+\lambda n\right\}-\epsilon \geq \\
\liminf _{n \rightarrow+\infty} E_{w}\left\{\int_{0}^{n+1} \mathcal{L}_{c, \frac{1}{2} \tilde{\rho}}(s, \tilde{X}(0, s, \mu), \tilde{Y}) \mathrm{d} s+\lambda(n+1)\right\}-2 \epsilon \geq \liminf _{n \rightarrow+\infty}\left(\Psi_{c, \lambda}^{n+1} 0\right)(\mu)-2 \epsilon=\hat{U}(\mu)-2 \epsilon
\end{gathered}
$$

Since $\epsilon>0$ is arbitrary, we get that

Thus, we can apply Ascoli-Arzelà and, after further refining $\left\{n_{h}\right\}$, we can suppose that $\left.Y_{n_{h}}\right|_{[0,1] \times \mathbf{T}^{p}}$ converges to a vector field $\bar{Y}$ in the $C^{0}$ topology. The formula above yields the first equality below, while the second one follows from the fact that $\left.Y_{n_{h}}\right|_{[0,1] \times \mathbf{T}^{p}}$ converges uniformly to $\bar{Y}$; the first inequality follows from the definition of $\hat{U}\left(\hat{\rho}(1) \mathcal{L}^{p}\right)$, the second one from the definition of $\Psi_{c, 0}^{1}$.

E_{w}\left(\int_{0}^{1} \mathcal{L}_{c, \frac{1}{2} \bar{\rho}}(s, \bar{X}, \bar{Y}) \mathrm{d} s+\lambda\right)+\hat{U}\left(\bar{\rho}(1) \mathcal{L}^{p}\right) \geq \Psi_{c, 0}^{1} \hat{U}(\mu) \quad \forall \mu \in \mathcal{M}_{1}\left(\mathbf{T}^{p}\right)
\end{gathered}

where $\bar{\rho}$ stays for $\rho_{\bar{Y}}$. This proves the inequality opposite to (3.15). Thus, $\hat{U}=\Psi_{c, 0}^{1} \hat{U}$; by the last formula, this implies that $\bar{Y}$ satisfies (5).

It remains to prove that the constant $\lambda$ is unique. Let $\Psi_{c, \lambda_{1}}^{1} \hat{U}_{1}=\hat{U}_{1}$ and $\Psi_{c, \lambda_{2}}^{2} \hat{U}_{2}=\hat{U}_{2}$. Let us suppose by contradiction that $\lambda_{1}<\lambda_{2}$. Since $\hat{U}_{i}$ is a continuous fixed point, we can suppose that $\left\|\hat{U}_{i}\right\|_{\text {sup }} \leq M$ for
$i=1,2$; as a consequence, $\hat{U}_{2} \geq \hat{U}_{1}-2 M$. By proposition 2.10 , the first inequality below follows; the second equality follows from the fact that $\hat{U}_{1}$ is a fixed point.

$$
\begin{gathered}
\Psi_{c, \lambda_{2}}^{n} \hat{U}_{2} \geq \Psi_{c, \lambda_{2}}^{n} \hat{U}_{1}-2 M \geq \Psi_{c, \lambda_{1}}^{n} \hat{U}_{1}+n\left(\lambda_{2}-\lambda_{1}\right)-2 M= \\
\hat{U}_{1}+n\left(\lambda_{2}-\lambda_{1}\right)-2 M \geq \hat{U}_{2}+n\left(\lambda_{2}-\lambda_{1}\right)-4 M
\end{gathered}
$$

For $n$ large enough, the last formula contradicts the fact that $\hat{U}_{2}$ is a fixed point.
