# $L^{\infty}$ RESOLVENT BOUNDS FOR STEADY BOLTZMANN'S EQUATION

#### Abstract

We derive lower bounds on the resolvent operator for the linearized steady Boltzmann equation over weighted $L^{\infty}$ Banach spaces in velocity, comparable to those derived by Pogan\&Zumbrun in an analogous weighted $L^{2}$ Hilbert space setting. These show in particular that the operator norm of the resolvent kernel is unbounded in $L^{p}(\mathbb{R})$ for all $1<p \leq \infty$, resolving an apparent discrepancy in behavior between the two settings suggested by previous work.


## 1. Introduction

In this note, we derive an $L^{\infty}$ lower bound on the resolvent operator for the linearized steady Boltzmann equation, in the process resolving a discrepancy between results of [2] and [4]. Let $L_{r, \xi}^{\infty}$ denote the space of functions $h(\xi), \xi \in \mathbb{R}^{3}$, with finite norm $\|h\|_{L_{r, \xi}^{\infty}}:=\sup _{\xi \in \mathbb{R}^{3}}(1+|\xi|)^{r}|h(\xi)|$. A key element in the study [2] of existence of invariant manifolds for the steady Boltzmann equation with hard sphere potential is the resolvent estimate [2, Thm. 11, (108)]

\|h\|_{L_{3, \xi}^{\infty}}(x) \leq C \int_{\mathbb{R}} e^{-\beta|x-y|}\|g\|_{L_{2, \xi}^{\infty}}(y) d y, \quad \beta>0 \tag{1.1}
\end{equation*}
$$

for solutions of the linearized inhomogeneous equation with "microscopic" data,

$$
\begin{equation*}
\xi_{1} \partial_{x} h-L h=g, \quad g \in \operatorname{Ker} L^{\perp}, \tag{1.2}
\end{equation*}
$$

where $L:=\bar{M}^{-1 / 2} \mathscr{L} \bar{M}^{1 / 2}$, with $\mathscr{L}$ the linearized collision operator about a reference Maxwellian $\bar{M}(\xi)=c e^{-|\xi-v|^{2} / d}$, and $h:=(f-\bar{M}) / \bar{M}^{1 / 2}$, with $f(x, \xi, t)$ the standard Boltzmann variable denoting density of particles of velocity $\xi \in \mathbb{R}^{3}$ at point $(x, t) \in \mathbb{R}^{2}$ in space and time [1, 2, 1,

Estimate (1.1) may be expressed equivalently as a bound $|R(x, \cdot \cdot \cdot)|_{L_{2, \xi}^{\infty} \rightarrow L_{3, \xi}^{\infty}} \leq C e^{-\beta|x|}, \beta>0$ on the resolvent kernel $R\left(x, \xi, \xi_{*}\right)$ for (1.2), that is, the kernel of resolvent operator

$$
\mathscr{R}=\left.\left(\xi_{1} \partial_{x}-L\right)^{-1}\right|_{\operatorname{Ker} L^{\perp}}, \quad(\mathscr{R} g)(x, \xi)=\int_{\mathbb{R}} \int_{\mathbb{R}^{3}} R\left(x-y, \xi, \xi_{*}\right) g\left(y, \xi_{*}\right) d \xi_{*} d y .
$$

(See [2] for a construction of $R$.) Either implies by standard convolution bounds uniform estimates

$$
\begin{equation*}
\|h\|_{L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)} \leq C\|g\|_{L^{q}\left(\mathbb{R}, L_{2, \xi}^{\infty}\right)}, \quad 1 \leq q \leq \infty \tag{1.3}
\end{equation*}
$$

Taking $q=\infty$ in (1.3), and noting [1, 3] that the associated bilinear collision operator $Q(h, h)$ of the full, nonlinear equation is bounded from $L_{3, \xi}^{\infty} \times L_{3, \xi}^{\infty} \rightarrow L_{2, \xi}^{\infty}$, yields $L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)$-contractivity of the map $h \rightarrow \mathscr{R} Q(h, h)$, giving the basis for the fixed-point iteration schemes defined in [2].

By comparison, in a nearby Hilbert-space setting 2 it has been shown [4] that the operator norm of the resolvent kernel is unbounded in all $L^{p}(\mathbb{R})$, by explicit computation using self-adjointness of $L$ to diagonalize by unitary transformation. This is in sharp contrast with (1.1), especially since finite-dimensional intuition would suggest that optimal bounds be found in coordinates for which $L$ is unitarily diagonalizable. Here, we resolve this apparent paradox by (i) establishing the following result contradicting (1.3), hence (1.1), and (ii) identifying a corresponding error in [2].

[^0]Proposition 1.1. The solution operator for (1.2) does not satisfy $\|h\|_{L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)} \leq C\|g\|_{L^{q}\left(\mathbb{R}, L_{2, \xi}^{\infty}\right)}$ for any $q<\infty, C=C(q)$. Likewise, $|R(x, \cdot, \cdot)|_{L_{2, \xi}^{\infty} \rightarrow L_{3, \xi}^{\infty}}$ is unbounded in $L^{p}(\mathbb{R}), p>1$.
Proof. Recall [1] that the linearized collision operator $L$ appearing in (1.2) may be decomposed as $L=-\nu(\xi)+K$, where $\nu(\xi) \sim\langle\xi\rangle:=\left(1+|\xi|^{2}\right)^{1 / 2}$ and $(K h)(\xi)=\int_{\mathbb{R}^{3}} k\left(\xi, \xi_{*}\right) h\left(\xi_{*}\right) d \xi_{*}$, with kernel $\left|k\left(\xi, \xi_{*}\right)\right| \leq C\left|\xi-\xi_{*}\right|^{-1} e^{-c\left|\xi-\xi_{*}\right|^{2}}$. By $\left\||\xi|^{-1} e^{-c|\xi|^{2}}\right\|_{L^{1}}<\infty$ and standard convolution bounds, $K$ is bounded on $L^{\infty}(\xi)$. Similarly, using the inequality $\langle\xi\rangle /\left\langle\xi-\xi_{*}\right\rangle \leq C\left\langle\xi_{*}\right\rangle$ and $\left\||\xi|^{r-1} e^{-c|\xi|^{2}}\right\|_{L^{1}}<\infty$, we obtain the standard result $|K|_{L_{r, \xi}^{\infty}}<+\infty$ [1], 2]. Recall, further, that $\operatorname{Ker} L$ is finite-dimensional, tangent to the 5-dimensional manifold of Maxwellians [1. Defining $\mathscr{S}=\left(\xi_{1} \partial_{x}+\nu(\xi)\right)^{-1}$, we have the explicit solution formula $(\mathscr{S} g)(x, \xi)=\int_{\mathbb{R}} S_{\xi}(x-y) g(y, \xi) d y$, with $S_{\xi}(\theta)=\xi_{1}^{-1} e^{-\nu(\xi) \xi_{1}^{-1}|\theta|}$ for $\theta \xi_{1}>0,0$ otherwise. Computing $\left\|S_{\xi}(\cdot)\right\|_{L^{1}(\mathbb{R})}=1 / \nu(\xi) \leq C /\langle\xi\rangle$, we have by standard convolution bounds $|\mathscr{S}|_{L^{\infty}\left(\mathbb{R}, L_{2, \xi}^{\infty}\right) \rightarrow L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)}<+\infty$.

Writing (1.2) as $\left(\xi_{1} \partial_{x}+\nu(\xi)\right) h=K h+g$, applying $\mathscr{S}$, and rearranging, gives $\mathscr{S} g=h-\mathscr{S} K h$, hence $|\mathscr{S} g|_{L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)} \leq C|h|_{L^{\infty}\left(3, L_{r, \xi}^{\infty}\right)}$ by boundedness of $|K|_{L_{3, \xi}^{\infty}},|\mathscr{S}|_{L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)}$. Thus, (1.3) would imply a comparable bound $|\mathscr{S} g|_{L^{\infty}\left(\mathbb{R}, L_{3, \xi}^{\infty}\right)} \leq C|g|_{L^{q}\left(\mathbb{R}, L_{2, \xi}^{\infty}\right)}$ on $\mathscr{S}$. This is easily seen to be false for $g \in L_{2, \xi}^{\infty}$, using test functions $g_{\alpha}(x, \xi)=\langle\xi\rangle^{-2} \alpha^{-1 / q} e^{-\alpha^{-1}|x|},\left\|g_{\alpha}\right\|_{L^{q}\left(\mathbb{R}, L_{2, \xi}^{\infty}\right)} \equiv 1, \alpha \rightarrow 0$, and computing $\mathscr{S} g_{\alpha}(0,(\alpha, 1,0))=\left(1+\alpha^{2}\right)^{-1} \int_{0}^{+\infty} \alpha^{-1} e^{-\left(1+\alpha^{2}\right)^{1 / 2} \alpha^{-1} y} \alpha^{-1 / q} e^{-\alpha^{-1} y} d y \sim \alpha^{-1 / q} \rightarrow+\infty$. Using linear combinations of members $g_{\alpha_{j}}$ of the infinite-dimensional family $\left\{g_{\alpha}\right\}$, we may obtain a contradiction also for $g$ ranging on any finite-codimension subspace, in particular on $\operatorname{Ker} L^{\perp}$.

The argument of [2]. In [2], the authors study the steady Boltzmann equation by a timeregularization scheme based on detailed pointwise bounds on the time-evolutionary Green function $G\left(x, t, \xi, \xi_{*}\right)$, through the relation $R=\int_{\mathbb{R}^{+}} G d t$. However, this analysis contains a key error. By [2, (67)]: $S_{x} b=\int_{\mathbb{R}^{+}} \int_{\mathbb{R}^{3}} G\left(x, t, \cdot, \xi_{*}\right) \xi_{1, *} b\left(\xi_{*}\right) d \xi_{*} d t$ and the symmetric [2, (68)], [2, (52)] is equivalent to $\left\|\int_{\mathbb{R}^{+}} \int_{\mathbb{R}^{3}} G\left(x, t, \cdot, \xi_{*}\right) \xi_{1, *} b\left(\xi_{*}\right) d \xi_{*} d t\right\|_{L_{3, \xi}^{\infty}} \leq C e^{-\beta|x|}\|b\|_{L_{3, \xi}^{\infty}}$. In [2, (102)], this is used to estimate

$$
\begin{equation*}
\left\|\int_{\mathbb{R}^{+}} \int_{\mathbb{R}^{3}} G\left(x, t, \cdot, \xi_{*}\right) \tilde{b}\left(\xi_{*}\right) d \xi_{*} d t\right\|_{L_{3, \xi}^{\infty}} \leq C e^{-\beta|x|}\|\tilde{b}\|_{L_{2, \xi}^{\infty}}, \tag{1.4}
\end{equation*}
$$

in effect asserting $\left\|\xi_{1}^{-1} \tilde{b}\right\|_{L_{3, \xi}^{\infty}} \lesssim\|\tilde{b}\|_{L_{2, \xi}}$, or $\left|\xi_{1}\right|^{-1} \lesssim(1+|\xi|)^{-1}$ - evidently false for $\xi_{1}$ small. But, (1.4) is the basis for (1.1), the resolvent estimate underlying the fixed-point constructions of [2].

Discussion and open problems. Proposition 1.1 shows that [2, Thm. 11] is incorrect, invalidating the conclusions of [2] on existence of invariant manifolds. Our proof of Proposition 1.1 depends on the property that the principle part $\mathscr{S}$ of the resolvent $\mathscr{R}$ is unbounded from $L^{q}\left(x, L_{2, \xi}^{\infty}\right) \rightarrow L^{\infty}\left(x, L_{3, \xi}^{\infty}\right)$ for $q<\infty$, which is much stronger than $|S(x, \cdot \cdot \cdot)|_{L_{2, \xi}^{\infty} \rightarrow L_{3, \xi}^{\infty}} \notin L^{p}$ for $1=1 / p+1 / q$. Estimate $|S(x, \cdot \cdot \cdot)|_{L_{2, \xi}^{\infty} \rightarrow L_{3, \xi}^{\infty}}^{\infty} \sim|x|^{-1}$ as $x \rightarrow 0$ shows that the latter holds also at the boundary $p=1$; we conjecture that it holds for $R$ as well. This, and the determination of upper bounds (1.3), $q=\infty$ on $\mathscr{R}$ we regard as very interesting open problems.
