

A Model of Radiational Gaseous Stars

Abstract

We introduce a model concerning radiational gaseous stars and establish the existence theory of stationary solutions to the free boundary problem of hydrostatic equations describing the radiative equilibrium. We also concern the local well-posedness of the moving boundary problem of the corresponding Navier-Stokes-Fourier-Poisson system and construct a priori estimates of strong and classical solutions. Our results explore the vacuum behaviour of density and temperature near the free boundary for the equilibrium and capture such degeneracy in the evolutionary problem.

1 Introduction

1.1 Problems

The evolutionary configuration of a radiational gaseous star can be described by the following hydrodynamic system,

$$\begin{cases} \rho_t + \operatorname{div}(\rho \vec{u}) = 0 & x \in \Omega(t), \\ (\rho \vec{u})_t + \operatorname{div}(\rho \vec{u} \otimes \vec{u}) + \nabla P + \rho \nabla \psi = \iota \operatorname{div} \mathbb{S} & x \in \Omega(t), \\ (\rho e)_t + \operatorname{div}(\rho e \vec{u}) + \theta P_\theta \operatorname{div} \vec{u} = \Delta \theta + \epsilon \rho + \iota \mathbb{S} : \nabla \vec{u} & x \in \Omega(t), \\ \Delta \psi = \rho & x \in \mathbb{R}^3, \end{cases} \quad (1.1) \quad \text{eq:dynm}$$

where $\rho, \vec{u}, P, \psi, e, \mathbb{S}$ represent the mass density, the velocity field, the pressure potential, the gravitation potential, the specific inner energy and the viscous stress tensor. The gas is assumed to be ideal and Newtonian. That is

$$P = K \rho \theta = \theta P_\theta, \quad \mathbb{S} = \mu (\nabla \vec{u} + \nabla \vec{u}^\top) + \lambda \mathbb{I}_3 \operatorname{div} \vec{u},$$

with constants $K > 0, \mu, \lambda > 0$. Also, the specific inner energy is taken in the form $e = c_\nu \theta$ with the specific heat coefficient $c_\nu > 0$. $\iota = 0, 1$ correspond to the inviscid case and the viscous case respectively. $\epsilon > 0$ on the right of (eq:dynm)₃ represents the uniform rate of generation of energy. $\Omega(t) := \{x \in \mathbb{R}^3 | \rho(x, t) > 0\}$ is the moving occupied domain of the gas. (eq:dynm)₁ is complemented with the following boundary condition

$$\iota \mathbb{S} \vec{n}|_{\Gamma(t)} = 0, \quad \theta|_{\Gamma(t)} = 0, \quad \lim_{|x| \rightarrow \infty} \psi = 0, \quad \mathcal{V}(t) = \vec{u} \cdot \vec{n}|_{\Gamma(t)}, \quad (1.2) \quad \text{eq:bdrcdn}$$

where $\Gamma(t) = \partial \Omega(t)$ is the boundary of the moving domain, $\mathcal{V}(t)$ represents the moving velocity of $\Gamma(t)$ and \vec{n} is the exterior normal direction on $\Gamma(t)$.

To study (eq:dynm)₁, a fundamental question is whether there exists a steady state to such a hydrodynamic system. In fact, the equilibrium is determined by the steady state of (eq:dynm)₁. That is,

$$\begin{cases} \nabla(K \rho \theta) = -\rho \nabla \psi & x \in \Omega, \\ -\Delta \theta = \epsilon \rho & x \in \Omega, \\ \Delta \psi = \rho & x \in \mathbb{R}^3, \end{cases} \quad (1.3) \quad \text{rdmd01}$$

where $\Omega = \{x \in \mathbb{R}^3 | \rho(x) > 0\}$. ^(I.3)_{rdmd01} is complemented with the following condition

$$\int_{\Omega} \rho dx = M > 0, \quad \lim_{|x| \rightarrow \infty} \psi = 0, \quad (1.4) \quad \text{totalmas}$$

$$\theta = 0 \quad \text{on } \Gamma := \partial\Omega. \quad (1.5) \quad \text{ztmb}$$

Compared with the usual zero normal heat flux condition, θ is assumed to vanish in both the evolutionary boundary condition ^(I.2)_{eq:bdrcdn} and the steady boundary condition ^(I.5)_{ztmb}. This indicates that the temperature on the surface of a star is very low and close to zero. Roughly speaking, this is interpreted as follows. On the surface of a star, radiation transfers the heat to the space in the form of light (through emission of photons), and thus the temperature of the gas is relatively very low. Therefore, the equations ^(I.3)_{rdmd01}₂ and ^(I.5)_{ztmb} form a balance of the heat source and the heat loss through the heat conductivity and radiation. We refer to ^[2]_{Chandrasekhar1958} for the validity of this boundary condition. See also ^[16]_{Hansen2004} for more discussion on the models of radiational gaseous stars.

There are several questions arising from the problems ^(I.1)_{eq:dynm} and ^(I.3)_{rdmd01} naturally. That is,

1. is there any regular solution to ^(I.3)_{rdmd01} with compact support;
2. supposed the steady state solution exists, what is the corresponding boundary behavior of ρ and θ ;
3. if ^(I.1)_{eq:dynm} is given with the initial data $(\rho(x, 0), \vec{u}(x, 0), \theta(x, 0), \Omega(0)) = (\rho_0, \vec{u}_0, \theta_0, \Omega_0)$ with (ρ_0, θ_0) satisfying the boundary behavior of the steady state solution, is the system ^(I.1)_{eq:dynm} locally well-posed?

In this work, we will answer these questions. In fact, we will establish the necessary and sufficient condition for the existence of steady states ^(I.3)_{rdmd01} with compact support in term of the rate of generation of energy ϵ , and the local well-posedness of strong and classical solutions to ^(I.1)_{eq:dynm} in the spherically symmetric motions for the viscous flows ($\iota = 1$).

The difficulties to solve ^(I.3)_{rdmd01} are as follows. On one hand, the temperature θ is determined by a Poisson equation ^(I.3)_{rdmd01}₂ with a Dirichlet boundary condition ^(I.5)_{ztmb}. Thus, to solve θ , we need the information from the distribution of the density ρ which determines the heat source and the domain of the Dirichlet problem for the Poisson equation. On the other hand, the distribution of the density ρ is determined through a free boundary problem consisting of ^(I.3)_{rdmd01}₁ and ^(I.3)_{rdmd01}₃ with ^(I.4)_{totalmas} which involves θ . This strong coupling makes the classical variational approach less obvious. However, despite

the complex interaction of the radiation, the pressure and the self-gravity, we find out that (1.3) can essentially be reduced to the well-known Lane-Emden equation. Such reduction will yield the existence of steady state solutions and the corresponding boundary behaviors of the density and the temperature. Indeed, if and only if $1/6 < \epsilon K < 1$, there exist infinitely many steady states (unique up to scaling) and they are spherically symmetric. On the boundary $\partial\Omega$,

$$\rho, \theta|_{\partial\Omega} = 0, \quad -\infty < \nabla_n \rho^{\frac{\epsilon K}{1-\epsilon K}}, \nabla_n \theta|_{\partial\Omega} \leq -C < 0. \quad (1.6) \quad \boxed{\text{PVT}}$$

Given the initial velocity $\vec{u}_0 = u_0(r)\frac{x}{r}$ the initial density and the initial temperature $\rho_0 = \rho_0(r), \theta_0 = \theta_0(r)$ satisfying (1.6), where $r = |x|$, the spherically symmetric motion $\vec{u} = u(r, t)\frac{x}{r}$ of (1.1) with $\iota = 1$ is described by,

$$\begin{cases} \partial_t(\rho r^2) + \partial_r(\rho r^2 u) = 0 & r \in (0, R(t)), \\ \partial_t(\rho r^2 u) + \partial_r(\rho r^2 u^2) + r^2 \partial_r(K \rho \theta) \\ \quad = -\rho r^2 \partial_r \psi + (2\mu + \lambda) r^2 \partial_r \left(\frac{\partial_r(r^2 u)}{r^2} \right) & r \in (0, R(t)), \\ \partial_t(c_\nu \rho r^2 \theta) + \partial_r(c_\nu \rho r^2 \theta u) - \partial_r(r^2 \partial_r \theta) = -K \rho \theta \partial_r(r^2 u) \\ \quad + \epsilon \rho r^2 + 2\mu r^2 ((\partial_r u)^2 + 2(\frac{u}{r})^2) + \lambda r^2 (\partial_r u + 2\frac{u}{r})^2 & r \in (0, R(t)), \\ \partial_r \psi = \frac{1}{r^2} \int_0^r s^2 \rho(s) ds & r \in (0, R(t)), \end{cases} \quad (1.7) \quad \boxed{\text{eq:sphericalmotion}}$$

where $R(t) > 0$ is the radius of the moving domain $\Omega(t)$. (1.7) is complemented with the following boundary condition

$$\begin{aligned} u(0, t) = 0, \quad (2\mu r^2 \partial_r u + \lambda \partial_r(r^2 u))(R(t), t) = 0, \quad \theta(R(t), t) = 0, \\ \partial_t R(t) = u(R(t), t), \quad R(0) = R_0. \end{aligned} \quad (1.8) \quad \boxed{\text{symtrboundary}}$$

The corresponding problem for an isentropic flow has already been studied in [18]. Just as in the classical literatures, the coordinate singularity at the centre need extra work to overcome. While in [18] the author separated the entire domain into the boundary and the interior subdomains and considered the problem around the centre in Eulerian coordinates to avoid the coordinate singularity, the authors in [33–35] developed a technique to recover the regularity at the centre without imposing conditions on the derivatives of velocity in the Lagrangian coordinate. Instead, they only assume that the central velocity vanishes. Such technique was also applied in [19]. As a matter of fact, the key is to study the problem in the Lagrangian coordinate induced by the flow trajectory. Such a coordinate

system enables a careful track of the flow and in turn resolves the coordinate singularity. This program involves less derivative estimates in order to recover the central regularity comparing to the strategy of [18]. We show in this work that we can as well recover the regularity of the temperature without imposing any condition on the derivatives of θ or itself at the centre. In particular, we show that the derivative of θ at the centre vanishes for a classical solution (see Corollary 3).

On the other hand, just as in [18] and other related literatures, the vacuum boundary (1.6) will make the problem complicated and the heat conductivity does not help to make it easier. In the previous work [33], by passing to the Lagrangian coordinate, the degenerate density ρ is reduced to a coefficient of the equation. Unfortunately, such a structure no longer exists for the temperature θ . We will show that for a classical solution, (1.6) can be tracked for the temperature (see Lemma 20).

1.2 Reviews of Related Works

Before diving into our problems, we will review some related works. In the past decades, the mathematical study of gaseous stars mainly focuses on the degenerate gaseous star ([31, 32]). That is to consider the following isentropic system

$$\begin{cases} \nabla P(\rho) = -\rho \nabla \psi & x \in \Omega, \\ \Delta \psi = \rho & x \in \mathbb{R}^3. \end{cases} \quad (1.9) \quad \boxed{\text{IsenGS}}$$

In this case, the variational structure associated with (1.9) plays important roles. For example, in [11, 10, 24], the authors considered the rotating gaseous stars problem (that is, on the left of (1.9)₁ is an additional convection) with prescribed angular momentum or angular velocity. Under some assumptions on the equation of state, the prescribed angular momentum or angular velocity, the authors have shown the existence of solutions to the rotating gaseous star problem with compact support (see also [11, 31, 32]). For a non-rotating gaseous star, the variational structure associated with (1.9), together with the Hardy-Littlewood-Sobolev inequality (see [25, 26], also known as the monotonically decreasing rearranging inequality), shows that the solution is spherically symmetric. Thus such a problem is reduced to solve an ordinary differential equation (ODE). In particular, for $P(\rho) = \rho^\gamma$ with $\gamma > 1$, such solutions are called the Lane-Emden solutions for gaseous stars. Meanwhile, in [28], the author studied the linear stability and instability of the Lane-Emden solutions. Roughly speaking, for $\gamma \geq 6/5$, there is a Lane-Emden solution to (1.9) with compact support (see [2]). Moreover, for $4/3 < \gamma < 2$,

there exists a unique ball-type solution and it is neutrally stable; for $\gamma = 4/3$, only for a special total mass $M^* > 0$ (known as the critical mass for radiation gaseous stars [Fu1998, I2]) there are infinitely many ball-type solutions, and they are marginally stable; for $6/5 < \gamma < 4/3$, it admits ball-type, singular ball-type and singular ground state solutions and the ball-type solution is unique and unstable; for $\gamma = 6/5$, there is only a ground state solution with finite total mass; for $1 < \gamma < 6/5$, no solution with finite total mass exists. For the ball-type solutions, the physical vacuum boundary holds, i.e.

$$\rho|_{x \in \partial\Omega} = 0, \quad -\infty < \nabla_{\vec{n}} P'(\rho)|_{x \in \partial\Omega} \leq -C < 0, \quad (1.10) \quad \boxed{\text{PV}}$$

for some constant $0 < C < \infty$, where \vec{n} is the exterior normal vector on the surface $\partial\Omega$ and $c^2 := P'(\rho) = \frac{d}{d\rho} P(\rho)$ represents the square of sound speed.

It shall be emphasised that the physical vacuum (1.10) causes big challenges in the study of the evolutionary problem of (1.9). That is to study the following Euler-Poisson system

$$\begin{cases} \partial_t \rho + \operatorname{div}(\rho \vec{u}) = 0 & x \in \Omega(t), \\ \rho \partial_t \vec{u} + \rho \vec{u} \cdot \nabla \vec{u} + \nabla P = -\rho \nabla \psi & x \in \Omega(t), \\ \Delta \psi = \rho & x \in \mathbb{R}^3. \end{cases} \quad (1.11) \quad \boxed{\text{EPE}}$$

Indeed, the physical vacuum boundary implies that the sound speed c is only $1/2$ -Hölder continuous rather than Lipschitz continuous across the boundary. As pointed out in [29], this singularity makes the standard hyperbolic method fail. It is only recently that the local well-posedness theory is studied by Coutand, Lindblad and Shkoller [5-7], Jang and Masmoudi [20, 21], Gu and Lei [13, 14], Luo, Xin and Zeng [33] in the setting of one spatial dimension, three spatial dimension and spherical symmetry with or without self-gravitation. See [18] for a viscous flow. We refer to [29, 36, 40, 41] for other discussions on the physical vacuum problem and the references therein for other vacuum problems.

As for the global dynamic property of (1.11), the nonlinear stability and instability of the equilibrium is partially understood only for spherically symmetric motions. In particular, the works from Jang and Tice [17, 19, 22] show that for $6/5 \leq \gamma < 4/3$, the Lane-Emden solutions are unstable, and additional viscosities can not reduce such instability. When it comes to the case $4/3 < \gamma < 2$, the asymptotic stability theory is first studied in [35] in the viscous case. See [34] for the model with a degenerate viscosity. Meanwhile, the case $\gamma = 4/3$, which is also referred to as the radiation case (see [2, 15]), is rather complicated. On one hand, only for a specific total mass $M^* > 0$,

called the critical mass, the problem (I.9) admits solutions with compact support. On the other hand, by studying a class of self-similar solutions in [12], the authors showed the existence of expanding and collapsing solutions with variant total mass. Such phenomena are far from fully understood. Recently, in [15], the authors show the asymptotic stability of the expanding solutions. Their analysis contains the exploration of a damping structure in the Lagrangian coordinate. For other discussions on the stability property of rotating or other models of gaseous stars, see [3, 4, 8, 9, 24, 30–32, 37–39].

1.3 Lagrangian Formulation, Methodology and Results

I will summarize the key observation and technique in this work. In order to solve the steady state problem (I.3), the key observation is that from (I.3)₁,

$$K \frac{\theta}{\rho} \nabla \rho + K \nabla \theta = -\nabla \psi,$$

where ρ, θ both are positive interiorly and vanish on the boundary, $\nabla \psi$ must be parallel to the normal direction of the surface $\partial\Omega$. In fact, with some regularity assumption on the regular solution, I will show that for any regular solution, such a parallel relation holds. Moreover, it implies that the gravitation potential ψ is a constant along the boundary $\partial\Omega$. Therefore, a Pohozaev type argument will imply that $\epsilon \nabla \psi = -\nabla \theta$ inside Ω . Such a property together with (I.3)₁ yields that the temperature is in the form $\theta = \theta(\rho)$. Hence, after substituting this relation into (I.3), the problem is reduced to the classical isentropic gaseous star system with $P = P(\rho)$. Therefore, we can achieve the existence theory and the spherically symmetric property of the solutions after applying the classical existence theory. In fact, the solution will satisfy (I.6) and

$$|\partial_r^k \rho| \leq O(\rho^{\frac{1-(1+k)\epsilon K}{1-\epsilon K}}), \quad |\partial_r^k \theta| \leq O(1) + O(\theta^{\frac{1-\epsilon K}{\epsilon K}-k+2}), \quad (1.12) \quad \text{intro:exb}$$

near the boundary, where $k \in \mathbb{Z}^+$ and ∂_r represents the derivative along the radial direction.

As for the evolutionary problem (I.7), we shall work in the Lagrangian coordinate. In other words, denote $r = r(x, t)$ defined by $\frac{dr}{dt} = u(r(x, t), t)$

and $r(x, 0) = x$, where $x \in (0, R_0)$. Then [\(II.7\)](#) can be written as,

$$\begin{cases} \left(\frac{x}{r} \right)^2 \rho_0 \partial_t v + \left(K \frac{x^2 \rho_0}{r^2 r_x} \Theta \right)_x = - \frac{x^2 \rho_0}{r^4} \int_0^x s^2 \rho_0(s) ds \\ \quad + (2\mu + \lambda) \left(\frac{(r^2 v)_x}{r^2 r_x} \right)_x & x \in (0, R_0), \\ c_\nu x^2 \rho_0 \partial_t \Theta + K \frac{x^2 \rho_0}{r^2 r_x} \Theta (r^2 v)_x - \left(\frac{r^2}{r_x} \Theta_x \right)_x = \epsilon x^2 \rho_0 \\ \quad + 2\mu r^2 r_x \left(\left(\frac{v_x}{r_x} \right)^2 + 2 \left(\frac{v}{r} \right)^2 \right) + \lambda r^2 r_x \left(\frac{v_x}{r_x} + 2 \frac{v}{r} \right)^2 & x \in (0, R_0), \end{cases} \quad (1.13)$$

where the Lagrangian unknowns are defined as

$$v(x, t) = u(r(x, t), t) = \partial_t r(x, t), \quad \Theta(x, t) = \theta(r(x, t), t). \quad (1.14)$$

[\(II.13\)](#) is complemented with the initial and boundary conditions

$$\Theta(x, 0) = \Theta_0(x) = \theta(x, 0), \quad v(x, 0) = v_0(x) = u(x, 0), \quad x \in (0, R_0), \quad (1.15)$$

where $\rho_0 > 0, \Theta_0 > 0$ for $x \in (0, R_0)$ and are imposed with the properties [\(II.6\)](#) and [\(II.12\)](#). That is, for $x \in (R_0/2, R_0]$

where $k \in \mathbb{Z}^+$.

To study the well-posedness of the problem [\(II.13\)](#), which will yield the well-posedness of [\(II.7\)](#), we will focus on resolving the coordinate singularity. In the energy estimates, we use the Hardy's inequality and the rescaled Poincaré inequality to manipulate the coordinate singularity at the center ($x = 0$) and the vacuum singularity on the boundary ($x = R_0$, see [Lemma 2](#)). Compared with the isentropic case in [\[35\]](#), we need the estimate of the pressure potential, or equivalently, the estimate of Θ , in order to recover the spatial regularity of r, v at the coordinate center. This can be done by calculating the $L_t^\infty L_x^2$ norm of

$$\frac{1}{r\sqrt{r_x}} \left(\frac{r^2}{r_x} \Theta_x \right)_x = \frac{\text{the rest terms in } (II.13)_2}{r\sqrt{r_x}}.$$

The denominator $r\sqrt{r_x}$ here is specially designed to avoid extra remaining nonlinear term. This yields the $L_t^\infty L_x^2$ estimates of Θ_x and $x\Theta_{xx}$. On the other hand, the quantity $\mathcal{G} := \log \frac{r^2 r_x}{x^2}$ satisfies an equation of the form

$$\mathcal{G}_{xt} = f\mathcal{G}_x + g$$

for some functions f, g . Thus by applying Grönwall's inequality, it implies the bound of $L_t^\infty L_x^2$ norms of \mathcal{G}_x and \mathcal{G}_{xt} . This will yield the bound of $L_t^\infty L_x^2$ norm of $r_{xx}, v_{xx}, (\frac{r}{x})_x$ and $(\frac{v}{x})_x$. Such a structure is first used in [34, 35]. These steps will resolve the coordinate singularity.

Besides, we obtain some new point-wise estimates without using the embedding theory, which will dramatically reduce the nonlinearity of the system and may be useful in future study. By applying the multiplier r^3 to (II.13)₁, we will be able to obtain the point-wise estimates of v_x and v/x . In addition, after integrating (II.13)₂ from the centre, we will obtain the point-wise bound of $x^{1/2}\Theta_x$ (see Lemma II.13). For a classical solution (higher order regularity), similar point-wise estimate will yield $\Theta_x(0, t) = 0$ (see Corollary III.3). Also, Θ_{xt} is point-wisely bounded near the boundary for such a solution. Then the fundamental theory of calculus shows that $-\infty < \Theta_x < -C$ (and $C < \Theta/\sigma < \infty$) with some constant $C > 0$ for a short time (see Lemma II.20). Thus the vacuum property (II.17)₁ (and hence (II.6)) is recovered.

The rest of the paper will be organized as follows. In the next section, we will introduce the main theorems and some notations used in this work. In Section III, we show the existence theory for the steady state problem (II.3) and prove Theorem II.1. In Section IV, we show the a priori estimates for the evolutionary problem (II.13). In particular, the point-wise estimates are given in Section IV.1. The energy estimates for the strong solutions are given in Section IV.3. Section IV.2 is devoted to the regularity estimates for the strong solution. In Section IV.4, we present the corresponding estimates for the classical solutions and it will finish the proof of Theorem II.2. In Section V, we employ the fixed point theory to derive the well-posedness theory (i.e. Theorem II.3).

2 Main Theorems and Preliminaries

During this work, the following notations are adopted. For any quantities A, B , by $A \lesssim B$ it means that

$$\exists C > 0, A \leq C \cdot B, \quad (2.1)$$

where C is a generic constant and will be different from lines to lines but independent of the solutions. Also, $A \simeq B$ means $A \lesssim B$ and $B \lesssim A$. By $C = C(\cdot)$, it means a positive constant C depends solely on the inputs. Similarly, by $P = P(\cdot)$, it means a positive polynomial of the inputs which is increasing in each input.

A regular solution to the steady state problem [\(1.3\)](#) ^{rdmd01} is defined as follows.

Definition 1 ^{rdmd01} We call the triple (ρ, θ, Ω) a regular solution to the free boundary problem [\(1.3\)](#) with complementing conditions [\(1.4\)](#) ^{totalmas} and [\(1.5\)](#) ^{ztmb} if it satisfies,

- $\Omega \subset \mathbb{R}^3$ is a bounded, star-shaped domain, and the origin $O = (0, 0, 0)$ lies inside Ω ;
- the boundary of Ω is a C^2 closed surface in \mathbb{R}^3 ;
- ρ, θ vanish on the boundary of Ω , and are positive inside Ω ;
- $\theta \in C^2(\bar{\Omega})$, and $\rho \in C^1(\Omega) \cap C(\bar{\Omega})$.

To consider the evolutionary problem [\(1.13\)](#) ^{eq:LagrangianCoordinates}, we will work in the space-time $(x, t) \in [0, R_0] \times [0, T]$ for some constant $T > 0$ which will be determined later. Also, the Sobolev space $X_t Y_x$ is defined as

In this work, we will make use of the following lemmas. The first lemma shows that the gradient of a function with positive value interiorly and zero value on the boundary is parallel to the exterior normal direction on the boundary.

Lemma 1 (Parallel Relation) Consider the domain $\Omega^+ = \mathbb{T}^2 \times \mathbb{R}^+ = (-1, 1)^2 \times (0, +\infty)$ and a function f satisfies:

V is uniformly continuous and bounded up to the boundary,

Then V can be continuously extended to the boundary $\partial\Omega^+$ and is also denoted as V . In addition, we have $V \parallel (0, 0, 1)^\top$ and $V \cdot (0, 0, 1)^\top \geq 0$ on $\partial\Omega^+$.

Proof After shifting, it suffices to show, in the sense of trace,

First, $V_3(0, 0, 0) \geq 0$ is easy to verify. Suppose it was not true, i.e. $V_3(0, 0, 0) < 0$. Then there would be a constant $\delta > 0$ such $V_3(0, 0, x_3) < 0$ for $x_3 \in (0, \delta)$,

which would imply, $\partial_{x_3} f(0, 0, x_3) < 0$. In particular, $0 < f(0, 0, \delta/2) < f(0, 0, 0) = 0$ which is impossible.

Next, we show $V_1(0, 0, 0), V_2(0, 0, 0) = 0$ through a contradictory argument. Otherwise, without loss of generality, suppose $V_2(0, 0, 0) \geq c > 0$ for some positive constant c . In the following, we work in the plane

We consider two cases, $V_3(0, 0, 0) = 0$ and $V_3(0, 0, 0) > 0$.

This will imply $\partial_{x_2} f(0, x_2, x_3) > 0$ in $B_\delta(0) \cap S$. Then f is strictly increasing in the x_2 -variable inside such neighbourhood, and by the implicit function theorem, through any point $p \in B_\delta(0) \cap S$, there is a neighbourhood of p such that the level set of f passing through p is well-defined. This will suggest that any level set of f does not have end-points inside $B_\delta(0)$. Let $\delta^* \leq \delta/2$. Consider the level set of f , $\{f = f(0, 0, \delta^*) > 0\}$. Then the intersection of such level set and the plane S is a curve, parametrised by

as long as τ is still inside such neighbourhood, which follows from the fact τ has no end-points inside this area and the fact V is pointing to-ward the normal direction of τ . First, $x'_3(0) \neq 0$. Otherwise, from (2.12) and (2.13), $x'_2(0) = 0$, which is impossible. Without loss of generality, let's assume $x'_3(0) < 0$. Denote $T = \sup\{t | \tau(s) \in B_\delta(0) \text{ for } 0 < s < t\}$, called the escaping time of the curve. Due to the monotonicity of f in x_2 -variable, the curve τ will eventually extend outside $B_\delta(0)$ through the boundary $\partial B_\delta(0) \cap \{x_3 > 0\}$, since otherwise τ would be a closed curve and this would be contradictory to the monotonicity of f . In the meantime, we claim $x'_3(t) < 0$ for $0 < t < T$. Otherwise, there was a $t^* \in (0, T)$ such that $x'_3(t^*) = 0$. Together with (2.12) and (2.13), it would imply $x'_2(t^*) = 0$ which is impossible. Therefore, the curve τ will pass the boundary section $\partial B_\delta(0) \cap \{0 < x_3 < \delta/2\}$. It follows $|x_2(T)| \geq \delta/2$. On the

other hand, from $\frac{x'_2(t)}{x_2(t)} = 0$ if and only if $V_3(\tau(t)) = 0$. Hence $\{t \in (0, T) | V_3(\tau(t)) \neq 0\} = \{t \in (0, T) | x'_2(t) \neq 0\}$. Direct calculation shows

Assume R is the first zero of u , i.e. $u(r) > 0$ for $0 \leq r < R$, $u(R) = 0$. Then $\rho(r) := u^3(r)$ for $r \in [0, R]$ is the solution to (2.17) (or equivalently (2.16)), where r denotes the radius $|x|$. Similarly, define \bar{u} to be the solution to (2.18) with $\bar{u}(0) = \bar{\rho}^{1/3}(0)$, $\partial_r \bar{u}(0) = 0$. Let \bar{R} be the first zero of \bar{u} . Then $\bar{\rho}$ agrees with \bar{u}^3 for $r \in [0, \bar{R}]$. Meanwhile, define

The next proposition concerns the relation between \tilde{K} and $M_c = M_c(\tilde{K})$.

4/3 Proposition 3 *For $\gamma = 4/3$, the critical mass M_c depends only on the gas dynamic constant \tilde{K} . Moreover, $M_c = M_c(\tilde{K})$ is monotonically increasing with respect to \tilde{K} . More precisely, there exists a constant $M_1 > 0$ such that $M_c(\tilde{K}) = \tilde{K}^{3/2}M_1$.*

Proof We already know from Proposition [2](#), the total (critical) mass M_c is independent of the central density. Without loss of generality, we start with the solution u_1 to the following ODE (i.e. [\(2.18\)](#) with $\tilde{K} = 1$),

$$4\left(\frac{d^2}{dr^2}u_1(r) + \frac{2}{r}\frac{d}{dr}u_1(r)\right) + u_1^3(r) = 0, \quad \text{with } u_1(0) = 1, \quad \partial_r u_1(0) = 0, \quad (2.21)$$

with the first zero R_1 of u_1 . The total mass of u_1 is defined to be

$$M_1 = 4\pi \int_0^{R_1} u_1^3(r) r^2 dr.$$

For any $s > 0$, define $u_s(r) = u_1(sr)$. Then u_s satisfies

$$4\left(\frac{d^2}{dr^2}u_s(r) + \frac{2}{r}\frac{d}{dr}u_s(r)\right) + s^2 u_s^3(r) = 0, \quad \text{with } u_s(0) = 1, \quad \partial_r u_s(0) = 0,$$

or

$$4s^{-2}\left(\frac{d^2}{dr^2}u_s(r) + \frac{2}{r}\frac{d}{dr}u_s(r)\right) + u_s^3(r) = 0,$$

with the first zero $R_s = s^{-1}R_1$, and the total mass of u_s is given by

$$M_s = 4\pi \int_0^{R_s} u_s^3(r) r^2 dr = 4\pi \int_0^{s^{-1}R_1} u_1^3(sr) r^2 dr = s^{-3} M_1.$$

For any solution (ρ, Ω) to [\(2.16\)](#) with $\tilde{K} > 0$ and $\rho(0) = 1$, by choosing $s = \tilde{K}^{-1/2}$, the uniqueness theory of ODE yields that ρ agrees with u_s^3 for $0 \leq r \leq R_s$ through a similar argument as in the proof of Proposition [2](#). In particular, the value of the critical mass is

$$M_c = M_s = (\tilde{K}^{-1/2})^{-3} M_1 = \tilde{K}^{3/2} M_1.$$

□

To overcome the difficulties caused by the coordinate singularity and the degeneracy of the density and the temperature in the problem [\(1.13\)](#), the following form of Hardy's inequality and Poincaré inequality will be useful. [eq:LagrangianCoordinates](#)

Lemma 2 *Let k be a given real number, and let g be a function satisfying $\int_0^1 s^k(g^2 + g'^2) dx < \infty$.*

a) *If $k > 1$, then we have*

$$\int_0^1 s^{k-2} g^2 ds \leq C \int_0^1 s^k (g^2 + g'^2) ds.$$

b) If $k < 1$, then g has a trace at $x = 0$ and moreover

$$\int_0^1 s^{k-2} (g - g(0))^2 ds \leq C \int_0^1 s^k g'^2 ds.$$

c) In particular, if $g(1) = 0$, the following Poincaré type inequality holds

$$\int_0^1 s^2 g^2 ds \leq C \int_0^1 s^2 g'^2 ds.$$

d) Suppose $g(s)$ is defined in $s \in [0, \omega)$ and $g(0) = 0$, the standard Poicaré inequality reads,

$$\int_0^\omega g^2 ds \leq C\omega^2 \int_0^\omega g'^2 ds.$$

Proof While d) is the rescaling of the standard Poincaré inequality, we refer a) and b) to [19] and mainly show c) in the following. Notice, by applying the Cauchy inequality and a),

$$\begin{aligned} s^2 g^2 &= \left(\int_s^1 (\tau g' + g) d\tau \right)^2 \leq (1-s)C \left(\int_s^1 \tau^2 g'^2 d\tau + \int_s^1 g^2 d\tau \right) \\ &\leq (1-s)C \left(\int_0^1 \tau^2 g^2 d\tau + \int_0^1 \tau^2 g'^2 d\tau \right). \end{aligned}$$

Then

$$\begin{aligned} \int_0^1 s^2 g^2 ds &= \int_0^{s_0} s^2 g^2 ds + \int_{s_0}^1 s^2 g^2 ds \\ &\leq (s_0 - 1/2s_0^2)C \left(\int_0^1 \tau^2 g^2 d\tau + \int_0^1 \tau^2 g'^2 d\tau \right) + \int_{s_0}^1 g^2 d\tau. \end{aligned}$$

Then by choosing $s_0 > 0$ small enough, it holds

$$\begin{aligned} \int_0^1 s^2 g^2 ds &\leq C_{s_0} \int_0^1 s^2 g'^2 ds + C_{s_0} \int_{s_0}^1 g^2 ds \\ &\leq C_{s_0} \int_0^1 s^2 g'^2 ds + C_{s_0} \int_{s_0}^1 g'^2 ds \leq C_{s_0} \int_0^1 s^2 g'^2 ds, \end{aligned}$$

where in the second inequality we have applied the Poincaré inequality. \square

In the following, we adopt the notations

$$\int \cdot dt := \int_0^T \cdot dt, \quad \int \cdot dx := \int_0^{R_0} \cdot dx. \quad (2.22)$$

Also, for the constant $\delta \in (0, 1)$, $C_\delta \simeq 1/\delta > 1$.

3 The Steady States (rdmd01 1.3)

Before showing the non-existence and existence theory of the steady state problem (rdmd01
1.3), we first show the parallel relation

$$\nabla\psi \parallel \vec{n} \text{ on } \partial\Omega \quad (3.1) \quad \text{prop:parallelrelation}$$

for the regular solution defined in (def:regularsol
1).

From (rdmd01
1.3)₁, $K\theta\nabla\rho + K\rho\nabla\theta = -\rho\nabla\psi$, which is equivalent to say, in Ω ,

$$K\frac{\theta}{\rho}\nabla\rho + K\nabla\theta = -\nabla\psi. \quad (3.2) \quad \text{nonextc}$$

On one hand, $\nabla\theta$ and $\nabla\psi$ are uniformly continuous and uniformly bounded up to the boundary $\partial\Omega$, which follows from the standard elliptic estimates on the equations (rdmd01
1.3)₂ and (rdmd01
1.3)₃. This implies

$$V := \frac{\theta}{\rho}\nabla\rho$$

is uniformly continuous and uniformly bounded up to the boundary. Meanwhile, the strong maximum principle and the Hopf lemma imply that $\theta \simeq d(x)$ where $d(x)$ denotes the distance from $x \in \Omega$ to the boundary and $\nabla\theta \parallel \vec{n}$ on $\partial\Omega$. By employing Lemma (lm:pllr1tn
1), V is parallel to the normal direction and $V \cdot \vec{n} \leq 0$ on the boundary $\partial\Omega$. Therefore, it holds that $\nabla\psi = -K\nabla\theta - KV$ is parallel to \vec{n} on the boundary and

$$\int_{\partial\Omega} \frac{\theta}{\rho} \nabla\rho \cdot \vec{n} \, dx \leq 0, \quad \int_{\partial\Omega} \theta \nabla\rho \cdot \vec{n} \, dx \leq 0, \quad (3.3) \quad \text{prop:snbndint}$$

where the integrands are defined by (nonextc
3.2) on the boundary, i.e.

$$\begin{aligned} \frac{\theta}{\rho} \nabla\rho \cdot \vec{n} &:= V \cdot \vec{n} = -\nabla\theta \cdot \vec{n} - \frac{1}{K} \nabla\psi \cdot \vec{n}, \\ \theta \nabla\rho \cdot \vec{n} &:= \rho V \cdot \vec{n} = -\rho \nabla\theta \cdot \vec{n} - \frac{\rho}{K} \nabla\psi \cdot \vec{n}. \end{aligned} \quad (3.4) \quad \text{prop:traceoftheboundar}$$

In the following sections, we will show that $1/6 < \epsilon K < 1$ is a necessary and sufficient condition for the existence of steady state solutions to (rdmd01
1.3) and study the degeneracy of the density and the temperature near the boundary.

3.1 Non-Existence for High and Low Rate of Generation of Energy

In this section, we show that $1/6 < \epsilon K \leq 1$ is a necessary condition for the existence of regular solutions to (1.3). That is to say for $\epsilon K \geq 1$ or $0 < \epsilon K \leq 1/6$, there is no regular solution. We show this in the following two lemmas.

Lemma 3 *There is no regular solution to (1.3) with $\epsilon K \geq 1$.*

Proof We prove this by contradiction. Suppose for some ϵ satisfying $\epsilon K \geq 1$, there is a regular solution (ρ, θ, Ω) to (1.3) with (1.4), (1.5). By dividing the first equation (1.3)₁ by ρ and taking divergence in the resulting equation, one can derive

$$K \operatorname{div} \left(\frac{\theta}{\rho} \nabla \rho \right) = (\epsilon K - 1) \rho. \quad (3.5) \quad \text{nonex01}$$

Integration this equation in Ω yields

$$K \int_{\partial\Omega} \frac{\theta}{\rho} \nabla \rho \cdot \vec{n} dS = (\epsilon K - 1) \int_{\Omega} \rho dx = M(\epsilon K - 1), \quad (3.6) \quad \text{nonex03}$$

where \vec{n} denotes the exteriorly normal vector on the surface $\partial\Omega$ and we have used (1.4). The integration on the left of (3.6) is understood in the sense of trace (see (5.4)). Therefore, (3.3) implies

$$\epsilon K - 1 \leq 0 \quad \text{or} \quad \epsilon K \leq 1.$$

Thus $\epsilon K = 1$. Hence, the right of (3.5) vanishes. Multiply (3.5) with ρ and integrate the resulting equation in Ω . It follows,

$$-K \int_{\Omega} \frac{\theta}{\rho} |\nabla \rho|^2 dx + K \int_{\partial\Omega} \theta \nabla \rho \cdot \vec{n} dS = 0. \quad (3.7) \quad \text{nonex02}$$

However, for a regular solution,

$$\int_{\Omega} \frac{\theta}{\rho} |\nabla \rho|^2 dx > 0 \quad \text{and} \quad \int_{\partial\Omega} \theta \nabla \rho \cdot \vec{n} dS \leq 0,$$

(see (3.3)) and therefore,

$$-K \int_{\Omega} \frac{\theta}{\rho} |\nabla \rho|^2 dx + K \int_{\partial\Omega} \theta \nabla \rho \cdot \vec{n} dS < 0,$$

which contradicts (3.7). \square

Lemma 4 *There is no regular solution to (1.3) with $0 < \epsilon K \leq \frac{1}{6}$.*

Proof Again, we will prove this through a contradictory argument. Suppose that for some ϵ satisfying $0 < \epsilon K \leq \frac{1}{6}$, there is a regular solution (ρ, θ, Ω) to (1.3). We employ a Pohozaev type argument as in [8]. Multiply (1.3)₁ with x and integrate the resulting in Ω

$$\int_{\Omega} \nabla (K\rho\theta) \cdot x \, dx = - \int_{\Omega} \rho \nabla \psi \cdot x \, dx.$$

Integration by parts on the left yields

$$-3K \int_{\Omega} \rho \theta \, dx = - \int_{\Omega} \rho \nabla \psi \cdot x \, dx. \quad (3.8) \quad \text{nonex001}$$

Meanwhile, multiply (1.3)₃ with $\nabla \psi \cdot x$, and integrate the resulting in Ω

$$\int_{\Omega} \Delta \psi (\nabla \psi \cdot x) \, dx = \int_{\Omega} \rho (\nabla \psi \cdot x) \, dx. \quad (3.9) \quad \text{nonex002}$$

Integration by parts on the left yields,

$$\begin{aligned} \int_{\Omega} \Delta \psi (\nabla \psi \cdot x) \, dx \\ &= - \int_{\Omega} |\nabla \psi|^2 \, dx - \frac{1}{2} \int_{\Omega} x \cdot \nabla |\nabla \psi|^2 \, dx + \int_{\partial \Omega} (\nabla \psi \cdot \vec{n}) (\nabla \psi \cdot x) \, dS \\ &= \frac{1}{2} \int_{\Omega} |\nabla \psi|^2 \, dx + \frac{1}{2} \int_{\partial \Omega} |\nabla \psi|^2 x \cdot \vec{n} \, dS, \end{aligned} \quad (3.10) \quad \text{nonex003}$$

where we have used the fact

$$\int_{\partial \Omega} (\nabla \psi \cdot \vec{n}) (\nabla \psi \cdot x) \, dS = \int_{\partial \Omega} |\nabla \psi|^2 x \cdot \vec{n} \, dS$$

due to $\nabla \psi \parallel \vec{n}$ on $\partial \Omega$ (see (B.1)). (B.8), (B.9), (B.10) yield the identity

$$-3K \int_{\Omega} \rho \theta \, dx = - \frac{1}{2} \int_{\Omega} |\nabla \psi|^2 \, dx - \frac{1}{2} \int_{\partial \Omega} |\nabla \psi|^2 x \cdot \vec{n} \, dS. \quad (3.11) \quad \text{nonex006}$$

On the other hand, multiply (1.3)₃ with ψ and integrate the resulting in Ω . After integration by parts, it follows

$$- \int_{\Omega} |\nabla \psi|^2 \, dx + \int_{\partial \Omega} \psi (\nabla \psi \cdot \vec{n}) \, dS = \int_{\Omega} \rho \psi \, dx. \quad (3.12) \quad \text{nonex004}$$

Multiply (1.3)₂ with ψ and (1.3)₃ with θ and integrate the resulting expressions in Ω . After integration by parts,

$$\int_{\Omega} \nabla \theta \cdot \nabla \psi \, dx - \int_{\partial \Omega} \psi (\nabla \theta \cdot \vec{n}) \, dS = \epsilon \int_{\Omega} \rho \psi \, dx,$$

$$-\int_{\Omega} \nabla \psi \cdot \nabla \theta \, dx = \int_{\Omega} \rho \theta \, dx,$$

which together with $\frac{\text{nonex004}}{(3.12)}$ yields

$$\begin{aligned} \int_{\Omega} \rho \theta \, dx &= - \int_{\partial\Omega} \psi (\nabla \theta \cdot \vec{n}) \, dS - \epsilon \int_{\Omega} \rho \psi \, dx \\ &= - \int_{\partial\Omega} \psi (\nabla \theta \cdot \vec{n}) \, dS + \epsilon \int_{\Omega} |\nabla \psi|^2 \, dx - \epsilon \int_{\partial\Omega} \psi (\nabla \psi \cdot \vec{n}) \, dS. \end{aligned} \quad (3.13) \quad \text{nonex005}$$

Therefore, $\frac{\text{nonex005}}{(3.13)} \times 3K + \frac{\text{nonex006}}{(3.11)}$ implies

$$\begin{aligned} \frac{1-6\epsilon K}{2} \int_{\Omega} |\nabla \psi|^2 \, dx &= -\frac{1}{2} \int_{\partial\Omega} |\nabla \psi|^2 x \cdot \vec{n} \, dS \\ &\quad - 3K \left(\int_{\partial\Omega} \psi (\nabla \theta \cdot \vec{n}) \, dS + \epsilon \int_{\partial\Omega} \psi (\nabla \psi \cdot \vec{n}) \, dS \right). \end{aligned} \quad (3.14) \quad \text{nonex007}$$

Notice, since $\theta = 0$ on $\partial\Omega$,

$$\begin{aligned} \int_{\partial\Omega} \psi (\nabla \theta \cdot \vec{n}) \, dS + \epsilon \int_{\partial\Omega} \psi (\nabla \psi \cdot \vec{n}) \, dS &= \frac{1}{\epsilon} \int_{\partial\Omega} (\theta + \epsilon \psi) \nabla (\theta + \epsilon \psi) \cdot \vec{n} \, dS \\ &= \frac{1}{2\epsilon} \int_{\partial\Omega} \nabla (\theta + \epsilon \psi)^2 \cdot \vec{n} \, dS. \end{aligned} \quad (3.15) \quad \text{nonex009}$$

Meanwhile, from $\frac{\text{rdmd01}}{(1.3)_2}$ and $\frac{\text{rdmd01}}{(1.3)_3}$,

$$\begin{aligned} \Delta (\theta + \epsilon \psi)^2 &= 2 |\nabla (\theta + \epsilon \psi)|^2 + 2 (\theta + \epsilon \psi) \Delta (\theta + \epsilon \psi) \\ &= 2 |\nabla (\theta + \epsilon \psi)|^2 + 2 (\theta + \epsilon \psi) (-\epsilon \rho + \epsilon \rho) = 2 |\nabla (\theta + \epsilon \psi)|^2 \geq 0. \end{aligned}$$

Integrating this expression in Ω , after integration by parts, implies

$$\int_{\partial\Omega} \nabla (\theta + \epsilon \psi)^2 \cdot \vec{n} \, dS = 2 \int_{\Omega} |\nabla (\theta + \epsilon \psi)|^2 \, dx \geq 0. \quad (3.16) \quad \text{nonex008}$$

$\frac{\text{nonex001}}{(3.14)}, \frac{\text{nonex001}}{(3.15)}, \frac{\text{nonex008}}{(3.16)}$ then yield

$$0 \leq \frac{1-6\epsilon K}{2} \int_{\Omega} |\nabla \psi|^2 \, dx \leq -\frac{1}{2} \int_{\partial\Omega} |\nabla \psi|^2 x \cdot \vec{n} \, dS \leq 0,$$

due to the contradictory assumption $0 < \epsilon K \leq \frac{1}{6}$ and the fact that Ω is star-shaped. Therefore, $\nabla \psi \equiv 0$ in $\bar{\Omega}$. This is impossible for a regular solution. Otherwise, after integrating $\frac{\text{rdmd01}}{(1.3)_3}$ over Ω it follows,

$$0 = \int_{\partial\Omega} \nabla \psi \cdot \vec{n} \, dS = \int_{\Omega} \rho \, dx = M > 0.$$

Thus it reaches a contradiction. \square

sec:existence

3.2 Existence of Steady State Solutions

In this section, we will construct the regular solution to (1.3) when $1/6 < \epsilon K < 1$ by reducing the problem to the classical Lane-Emden equation. But before we start, it should be noticed that even though it looks like the non-existence theory of the Lane-Emden equation implies the non-existence theory in Section 3.1, it actually does not. In fact, in the following reduction process, it has already assumed $\epsilon K < 1$ (see Lemma 6). Therefore the reduction does not work for the non-existence theory and the proof in Section 3.1 is not redundant.

We start with the following property of the regular solution to (1.3).

improp

Lemma 5 Any regular solution to (1.3) will satisfy

$$\nabla (\theta + \epsilon\psi) = 0 \quad \text{in } \Omega. \quad (3.17) \quad \text{idtt01}$$

Proof From (1.3)₂ and (1.3)₃,

$$\Delta (\theta + \epsilon\psi) = -\epsilon\rho + \epsilon\rho = 0 \quad x \in \Omega. \quad (3.18) \quad \text{harmonicid01}$$

Again, we employ a Pohozaev type argument. Multiply (3.18) with $\nabla (\theta + \epsilon\psi) \cdot x$, and integrate the resulting in Ω . Integration by parts then yields

$$\begin{aligned} 0 &= \int_{\Omega} \Delta (\theta + \epsilon\psi) \nabla (\theta + \epsilon\psi) \cdot x \, dx \\ &= - \int_{\Omega} |\nabla (\theta + \epsilon\psi)|^2 \, dx - \frac{1}{2} \int_{\Omega} \nabla |\nabla (\theta + \epsilon\psi)|^2 \cdot x \, dx \\ &\quad + \int_{\partial\Omega} (\nabla (\theta + \epsilon\psi) \cdot \vec{n}) (\nabla (\theta + \epsilon\psi) \cdot x) \, dS \\ &= \frac{1}{2} \int_{\Omega} |\nabla (\theta + \epsilon\psi)|^2 \, dx + \frac{1}{2} \int_{\partial\Omega} |\nabla (\theta + \epsilon\psi)|^2 x \cdot \vec{n} \, dS, \end{aligned}$$

where we have used the fact $\nabla (\theta + \epsilon\psi) \parallel \vec{n}$ on $\partial\Omega$ in the last equality (see (3.1)). Therefore, together with the assumption on the geometry of Ω , which yields the right is the sum of two nonnegative integrals, this identity shows $\nabla (\theta + \epsilon\psi) \equiv 0$ in Ω . \square

Remark 1 Indeed, $\nabla (\theta + \epsilon\psi) \parallel \vec{n}$ on $\partial\Omega$ implies that $\theta + \epsilon\psi$ is constant on the boundary and hence from (3.18) and the maximum principle for harmonic equations, $\theta + \epsilon\psi$ is constant in Ω ⁱ. In particular, $\nabla\theta + \epsilon\nabla\psi = 0$ in Ω .

ⁱThis is pointed out by Prof. YanYan Li in a private conversation.

In the next lemma, we will show that the property $\text{\texttt{ldtt01}}$ (3.17) implies that $\text{\texttt{rdmd01}}$ (1.3) can be reduced to the classical system for gaseous stars $\text{\texttt{rdprb01}}$ (2.15), for some constants $\tilde{K} > 0, \gamma > 1$.

Lemma 6 *For any regular solution (ρ, θ, Ω) to $\text{\texttt{rdmd01}}$ (1.3) with $0 < \epsilon K < 1$, $\exists \tilde{K} > 0, \gamma > 1$ such that (ρ, Ω) satisfies the system $\text{\texttt{rdprb01}}$ (2.15). Moreover, there is a positive constant $S > 0$ such that*

$$\rho^{-\epsilon K} \theta^{1-\epsilon K} = S \quad x \in \Omega. \quad (3.19) \quad \text{\texttt{pmtr}}$$

Proof Let (ρ, θ, Ω) be a regular solution to $\text{\texttt{rdmd01}}$ (1.3). Then from $\text{\texttt{ldtt01}}$ (3.17) in Lemma 5, $\text{\texttt{improp}}$

$$\nabla \psi = -\frac{1}{\epsilon} \nabla \theta.$$

Together with $\text{\texttt{rdmd01}}$ (1.3)₁, it holds,

$$K\theta \nabla \rho + K\rho \nabla \theta = \frac{\rho}{\epsilon} \nabla \theta, \quad (3.20)$$

which yields, for $\epsilon K \neq 1$,

$$\nabla (\rho^{-\epsilon K} \theta^{1-\epsilon K}) = 0 \quad x \in \Omega.$$

Since ρ, θ are both positive and finite in Ω , this means $\exists S > 0$, such that $\text{\texttt{pmtr}}$ (3.19) holds. Define $\tilde{K} = S^{\frac{1}{1-\epsilon K}} K > 0, \gamma = 1 + \frac{\epsilon K}{1-\epsilon K} > 1$. Then

$$\theta = (S\rho^{\epsilon K})^{\frac{1}{1-\epsilon K}} \quad \text{and} \quad P = K\rho\theta = K\rho (S\rho^{\epsilon K})^{\frac{1}{1-\epsilon K}} = \tilde{K}\rho^\gamma. \quad (3.21) \quad \text{\texttt{rdpm}}$$

This finishes the proof. \square

In the following lemma, we prove $1/6 < \epsilon K < 1$ is not only a necessary, but also a sufficient condition to guarantee the existence of regular solutions to $\text{\texttt{rdmd01}}$ (1.3).

Lemma 7 *For $\frac{1}{6} < \epsilon K < 1$ and any constant $M > 0$, there exist infinitely many regular solutions to $\text{\texttt{rdmd01}}$ (1.3) with $\text{\texttt{totalmas}}$ (1.4) and $\text{\texttt{ztmb}}$ (1.5). Moreover, all regular solutions are spherically symmetric.*

Proof In the following, we write

$$\gamma_\epsilon = 1 + \frac{\epsilon K}{1 - \epsilon K} = \frac{1}{1 - \epsilon K}.$$

Case 1. $\frac{1}{6} < \epsilon K < \frac{1}{4}$ or $\frac{1}{4} < \epsilon K < 1$.

In this case, $\frac{6}{5} < \gamma_\epsilon < \frac{4}{3}$ or $\gamma_\epsilon > \frac{4}{3}$. For any fixed $S > 0$, let $\tilde{K}_S = S^{\gamma_\epsilon} K$. From Proposition II, there is a unique regular ball type solution (ρ_S, Ω_S) to (2.15) and (1.4) with $\tilde{K} = \tilde{K}_S$. Inspired by (3.21), define

$$\theta_S = \frac{\tilde{K}_S}{K} \rho_S^{\gamma_\epsilon - 1} = S^{\gamma_\epsilon} \rho_S^{\gamma_\epsilon - 1}.$$

Then it is easy to verify that $(\rho_S, \theta_S, \Omega_S)$ is a solution to (1.3) with (1.4) and (1.5) for any $S > 0$. Therefore, by choosing different values of $S > 0$, there are infinitely many regular solutions to (1.3). Therefore, S given above is a parametrisation of these regular solutions. Notice, ρ_S, θ_S, S satisfy the relation (3.19).

Case 2. $\epsilon K = \frac{1}{4}$, $\gamma_\epsilon = \frac{4}{3}$.

From Proposition B, there is a $\tilde{K}_4 = (\frac{M}{M_1})^{2/3}$, such that

$$M_c(\tilde{K}_4) = \tilde{K}_4^{3/2} M_1 = M. \quad (3.22) \quad \text{par4/3001}$$

By taking $\tilde{K} = \tilde{K}_4$ in (2.16), Proposition II yields there are infinitely many regular ball type solutions (ρ, Ω) to (2.16) with prescribed total mass $M = M_c(\tilde{K}_4)$. Similarly, by defining

$$\theta = \frac{\tilde{K}_4}{K} \rho^{1/3},$$

then (ρ, θ, Ω) is a regular solution to (1.3). The multiplicity of regular ball type solutions to (2.16) yields the multiplicity of regular solutions to (1.3). Moreover, S given by (3.19) satisfies

$$S = \rho^{-1/4} \theta^{1-1/4} = \left(\frac{\tilde{K}_4}{K} \right)^{3/4} = \left(\frac{M}{K^{3/2} M_1} \right)^{1/2}, \quad (3.23) \quad \text{par4/3}$$

which depends only on the total mass M and the coefficient K . In this case, S does not parametrize the solutions. \square

Remark 2 In the case $1/6 \leq \epsilon K < 1/4$, similar arguments actually also show the existence of singular solutions or ground-state type solutions to (1.3).

We claim that the regular solutions obtained in Lemma [7](#) ^{exists} are all the regular solutions to [\(1.3\)](#) ^{rdmd01}. This is a direct consequence of Lemma [6](#) ^{equivc01}.

lm:alsol **Lemma 8** For $\frac{1}{6} < \epsilon K < 1$ and $M > 0$, the regular solutions obtained in Lemma [7](#) ^{exists} are all the regular solutions to [\(1.3\)](#) ^{rdmd01}.

Notice, S given in [\(3.19\)](#) ^{pmttr} does not always parametrize the regular solutions to [\(1.3\)](#) ^{rdmd01}. In the next lemma, we show that the solutions can be parametrized by a scaling variable.

lm:hit **Lemma 9 (Homology Invariance)** Given a regular solution (ρ, θ, Ω) to [\(1.3\)](#) ^{rdmd01} with [\(1.4\)](#) ^{totalmas} and [\(1.5\)](#) ^{ztmb}, for $s > 0$, define

$$\begin{aligned} \rho_s(x) &= s^3 \rho(sx), \quad \theta_s(x) = s\theta(sx), \\ \Omega_s &= \{x \in \mathbb{R}^3 | \rho_s(x) > 0\} = \{x = s^{-1}y | \rho(y) > 0\}. \end{aligned} \tag{3.24} \quad \text{hlinvrt}$$

Then $(\rho_s, \theta_s, \Omega_s)$ is also a regular solution to [\(1.3\)](#) ^{rdmd01} with the same total mass $M > 0$.

Proof The proof follows from a direct calculation and is omitted here. \square

lm:chrs **Lemma 10 (Parametrization of Regular Solutions)** For any fixed ϵ in [\(1.3\)](#) ^{rdmd01} with $\frac{1}{6} < \epsilon K < 1$ and $M > 0$, all regular solutions to [\(1.3\)](#) ^{rdmd01} with [\(1.4\)](#) ^{totalmas} and [\(1.5\)](#) ^{ztmb} are parametrised by $s > 0$ as in [\(3.24\)](#) ^{hlinvrt}, where (ρ, θ, Ω) is one of the regular solutions to [\(1.3\)](#) ^{rdmd01} with [\(1.4\)](#) ^{totalmas} and [\(1.5\)](#) ^{ztmb} given in Lemma [7](#) ^{exists}.

Proof The proof follows from the construction of regular solutions Lemma [7](#) ^{exists}, Lemma [8](#) ^{lm:alsol}, Lemma [9](#) ^{lm:hit} and the parametrization of the solutions to [\(2.16\)](#) in Proposition [2](#) ^{ch4/3}. \square

A direct consequence of the homology invariance [\(3.24\)](#) ^{hlinvrt} is the following.

Corollary 1 For fixed $M > 0$ and $\frac{1}{6} < \epsilon K < 1$, let $(\rho, \theta, \Omega = B(R))$ be the regular solution to [\(1.3\)](#) ^{rdmd01} with [\(1.4\)](#) ^{totalmas} and [\(1.5\)](#) ^{ztmb}. The radius R of Ω is monotonically decreasing with respect to the central density $\rho(0)$ and the central temperature $\theta(0)$. And the central density $\rho(0)$ is monotonically increasing with respect to the central temperature $\theta(0)$. In particular, there exist constants C_1 and C_2 , depending on the total mass M and ϵK , such that $R \cdot \theta(0) = C_1$ and $\rho(0) = C_2 \theta^3(0)$, and consequently $R^3 \rho(0) = C_1^3 C_2$.

In the following lemma, we point out the vacuum property of ρ, θ near the gas-vacuum interface $\partial\Omega$ for the regular solution (ρ, θ, Ω) to (I.3).

stationary:boundary

Lemma 11 *For any regular solution (ρ, θ, Ω) to (I.3) with $1/6 < \epsilon K < 1$, θ is Lipschitz continuous across $\partial\Omega$, while ρ is $\frac{1-\epsilon K}{\epsilon K}$ -Hölder continuous across $\partial\Omega$. Moreover, it obeys the following asymptotic behaviour near the origin and the boundary respectively,*

1. ρ, θ is analytic at the origin, and in particular, $\theta = a + br^2 + O(r^4)$, $r \sim 0$ with $\partial_r^{2k+1}\theta(0) = 0$ for any nonnegative integer $k \geq 0$;
2. $\rho, \theta|_{\partial\Omega} = 0$, $-\infty < \partial_r \rho^{\frac{\epsilon K}{1-\epsilon K}}, \partial_r \theta|_{\partial\Omega} \leq -C < 0$;
3. $|\partial_r^k \rho| \leq O(\rho^{\frac{1-(1+k)\epsilon K}{1-\epsilon K}})$, $|\partial_r^k \theta| \leq O(1) + O(\theta^{\frac{1-\epsilon K}{\epsilon K}-k+2})$ for any $k > 0$ near the boundary,

where ∂_r represents the derivative along the radial direction of Ω .

Proof Similar as before, denote the constants

$$S = \rho^{-\epsilon K} \theta^{1-\epsilon K}, \gamma_\epsilon = 1 + \frac{\epsilon K}{1-\epsilon K}, \alpha_\epsilon = \frac{1-\epsilon K}{\epsilon K}, \bar{K} = \frac{1}{\epsilon K} S^{\frac{1}{1-\epsilon K}} K = \frac{S^{1/(1-\epsilon K)}}{\epsilon}.$$

Then, $\alpha_\epsilon \in (0, 5)$, $\gamma_\epsilon \in (6/5, \infty)$. We study the following ODE,

$$\bar{K} \left(\partial_{rr} + \frac{2}{r} \partial_r \right) u + u^{\alpha_\epsilon} = 0, \quad u(0) = \rho(0)^{\epsilon K/(1-\epsilon K)}, \partial_r u(0) = 0. \quad (3.25) \quad \text{ODE: Lane-Emden}$$

Also, let $0 < R < \infty$ be the first zero of u . It can be verified, similar as before, $\rho = u^{\alpha_\epsilon}$, $\theta = S^{1/(1-\epsilon K)} u$ for $r \in [0, R]$. Without loss of generality, we assume $\bar{K} = 1$ and $\rho(0) = 1$. We study u first. Similar to [19, Lemma 3.3], we claim

- a) u is analytic at the origin. $u(r) = 1 - br^2 + O(r^4)$, $r \sim 0$, for some positive constant $b > 0$. Also, $\partial_r^{2k+1} u(0) = 0$ for any nonnegative integer $k \geq 0$;
- b) $|\partial_r^k u| \leq O(1) + O(u^{\alpha_\epsilon - k + 2})$ for $k \geq 1$, $r \sim R$, and $|\partial_r u| = O(1)$ for $r \sim R$.

Then the lemma follows after a substitution. Indeed, the property for θ is a direct consequence of a) and b). We briefly demonstrate how to get the

asymptotic behaviour of $\partial_r^k \rho$ near the boundary. Notice, $u = \rho^{\gamma_\epsilon - 1}$. It is easy to verify $|\partial_r \rho| = O(\rho^{2-\gamma_\epsilon}) = O(\rho^{\frac{1-2\epsilon K}{1-\epsilon K}})$. Moreover, it holds,

$$|\rho^{\gamma_\epsilon - 2} \partial_r^k \rho| - L_k \leq |\partial_r^k u| \leq O(1) + O(\rho^{1-(k-2)(\gamma_\epsilon - 1)}), \quad (3.26) \quad \boxed{\text{sub01}}$$

where L_k contains the terms look like the absolute value of

$$\rho^{\gamma_\epsilon - 1 - n} (\partial_r^{\alpha_1^k} \rho) (\partial_r^{\alpha_2^k} \rho) \cdots (\partial_r^{\alpha_n^k} \rho),$$

with $\alpha_1^k + \alpha_2^k + \cdots + \alpha_n^k = k, 2 \leq n \leq k, 1 \leq \alpha_i^k < k$ for $i = 1, 2, \dots, n$. Then, if it is assumed $|\partial_r^l \rho| \leq O(\rho^{\frac{1-(1+l)\epsilon K}{1-\epsilon K}})$ holds for $0 < l < k$, L_k can be bounded by

$$\rho^{\gamma_\epsilon - 1 - k \frac{\epsilon K}{1-\epsilon K}}.$$

Therefore, it shall hold from $\boxed{\text{sub01}}$ (3.26)

$$|\partial_r^k \rho| \leq O(\rho^{2-\gamma_\epsilon}) + O(\rho^{3-\gamma_\epsilon - (k-2)(\gamma_\epsilon - 1)}) + O(\rho^{1-k \frac{\epsilon K}{1-\epsilon K}}) \leq O(\rho^{1-k \frac{\epsilon K}{1-\epsilon K}}).$$

This will finish the proof via the induction principle. What is left is to show the claim. In fact, it is standard and following the same program as in [\[19\]](#). We attach the proof here for the sake of convenience. [Jang2014](#)

To show a), rewrite $\boxed{\text{ODE:Lane-Emden}}$ (3.25) as

$$ru_{rr} + 2u_r + cru^{\alpha_\epsilon} = 0, \quad (3.27) \quad \boxed{\text{ODE:Lane-Emden001}}$$

for some constant $c > 0$. After dividing this expression by r and taking the limit $r \rightarrow 0^+$, it holds $3u_{rr}(0) + c = 0$. Next, differentiating $\boxed{\text{ODE:Lane-Emden001}}$ (3.27) once yields the identity,

$$ru_{rrr} + 3u_{rr} + c(\alpha_\epsilon ru^{\alpha_\epsilon - 1} u_r + u^{\alpha_\epsilon}) = 0. \quad (3.28) \quad \boxed{\text{ODE:Lane-Emden002}}$$

Again, dividing $\boxed{\text{ODE:Lane-Emden002}}$ (3.28) with r will give the following,

$$u_{rrr} + 3 \frac{u_{rr} - u_{rr}(0)}{r} + c \left(\alpha_\epsilon u^{\alpha_\epsilon - 1} u_r + \frac{u^{\alpha_\epsilon} - u^{\alpha_\epsilon}(0)}{r} \right) = 0,$$

where it has been applied the relation $3u_{rr}(0) + c = 0$ and $u(0) = 1$. Passing the limit $r \rightarrow 0^+$ then yields $4u_{rrr}(0) = 0$. To calculate $u_{rrrr}(0)$, from $\boxed{\text{ODE:Lane-Emden002}}$ (3.28),

$$ru_{rrrr} + 4u_{rrr} + c(\alpha_\epsilon(\alpha_\epsilon - 1)ru^{\alpha_\epsilon - 2}u_r^2 + \alpha_\epsilon u^{\alpha_\epsilon - 1} \underbrace{(ru_{rr} + 2u_r)}_{-cru^{\alpha_\epsilon}}) = 0.$$

Thus $5u_{rrr}(0) - \alpha_\epsilon c^2 = 0$. In general, for any integer $k \geq 1$, apply ∂_r^{2k-2} to (B.27) and use Leibniz's rule to get

$$r\partial_r^{2k}u + 2k\partial_r^{2k-1}u + c\partial_r^{2k-2}(ru^{\alpha_\epsilon}) = 0. \quad (3.29) \quad \text{ODE:Lane-Emden003}$$

Now we claim for any positive integer $k \geq 1$

$$\partial_r^{2k-2}(ru^{\alpha_\epsilon})(0) = 0 \quad \text{and} \quad \partial_r^{2k-1}u(0) = 0. \quad (3.30) \quad \text{ODE:Lane-Emden004}$$

This has been shown for $k = 1, 2$. By the principle of mathematical induction, we only need to show the relation (B.30) with $k = n+1$ under the assumption that (B.30) holds for all $k \leq n$. Consider (B.29) with $k = n$, which can be written as.

$$\partial_r^{2n}u + 2n\frac{\partial_r^{2n-1}u}{r} + c\frac{\partial_r^{2n-2}(ru^{\alpha_\epsilon})}{r} = 0.$$

Passing the limit $r \rightarrow 0^+$ and noticing (B.30), it holds

$$(2n+1)\partial_r^{2n}u(0) + cl_n = 0, \quad (3.31) \quad \text{ODE:Lane-Emden005}$$

with $l_n = \lim_{r \rightarrow 0^+} \frac{\partial_r^{2n-2}(ru^{\alpha_\epsilon})}{r} = \partial_r^{2n-1}(ru^{\alpha_\epsilon})(0)$. Again, differentiate (B.29) with $k = n$ with respect to r , and it holds

$$r\partial_r^{2n+1}u + (2n+1)\partial_r^{2n}u + c\partial_r^{2n-1}(ru^{\alpha_\epsilon}) = 0,$$

or equivalently, by making use of (B.31)

$$\partial_r^{2n+1}u + (2n+1)\frac{\partial_r^{2n}u - \partial_r^{2n}u(0)}{r} + c\frac{\partial_r^{2n-1}(ru^{\alpha_\epsilon}) - \partial_r^{2n-1}(ru^{\alpha_\epsilon})(0)}{r} = 0.$$

Passing the limit $r \rightarrow 0^+$ then yields $(2n+2)\partial_r^{2n+1}u(0) + c\partial_r^{2n}(ru^{\alpha_\epsilon})(0) = 0$. Meanwhile, direct calculation shows

$$\partial_r^{2n}(ru^{\alpha_\epsilon})(0) = (r\partial_r^{2n}u^{\alpha_\epsilon})(0) + 2n(\partial_r^{2n-1}u^{\alpha_\epsilon})(0) = 0 + 0 = 0, \quad (3.32)$$

where we have used the fact that the expansion of $\partial_r^{2n-1}u^{\alpha_\epsilon}$ contains at least one multiplier with an odd-order derivative of u . Thus $\partial_r^{2n+1}u(0) = -\frac{c}{2n+2}\partial_r^{2n}(ru^{\alpha_\epsilon})(0) = 0$. This finishes the proof of (B.30).

In order to show b), it suffices to study u near $r = R$. We already know $|u_r| = O(1)$ for $r \simeq R$. Hence, $|u_{rr}| \leq O(1) + O(u^{\alpha_\epsilon})$ for $r \simeq R$ as a consequence of (B.27). Inductively, $|u_{rrr}| \leq O(1) + O(u^{\alpha_\epsilon-1})$, $|u_{rrrr}| \leq O(1) + O(u^{\alpha_\epsilon-2})$, ... $|\partial_r^k u| \leq O(1) + O(u^{\alpha_\epsilon-k+2})$ for $r \simeq R$. \square

As a corollary of the homology invariance (B.24), we will construct a class of self-similar solutions describing the expanding or collapsing configuration for the radiational gaseous stars in the following.

lm:expanding

Lemma 12 For $\iota = 0$, $c_\nu = 3K$ and $1/6 < \epsilon K < 1$, there is a globally expanding solution to (eq:dynm) with $\Omega(t) = B_{a+bt}(0)$ for any positive constants $a, b > 0$, where $B_s(0)$ represents a ball centred at the origin with radius s . Also, for any $a > 0, b < 0$, there is a collapsing solution with $\Omega(t) = B_{a+bt}(0)$ and the collapsing time is given by $|a/b|$.

Proof Given a regular solution $(\bar{\rho}, \bar{\theta}, \bar{\Omega})$ to (rdmd01) , it is spherically symmetric. Without loss of generality one can assume it is in the form

$$(\bar{\rho}, \bar{\theta}, \bar{\Omega}) = (\bar{\rho}(r), \bar{\theta}(r), \bar{B}_1),$$

with $r = |x|$ and \bar{B}_1 being a ball centred at the origin with radius $\bar{R} = 1$.

Define the ansatz $(\rho(t, x), u(t, x), \theta(t, x), \Omega(t))$ as follows.

$$\begin{cases} \rho(t, x) = \alpha^3(t) \bar{\rho}(\alpha(t) \cdot r), \\ \theta(t, x) = \alpha(t) \bar{\theta}(\alpha(t) \cdot r), \\ u(t, x) = -\frac{\alpha'(t)}{\alpha(t)} x, \\ x \in \Omega(t) = \alpha^{-1}(t) \bar{B}_1 = \{x \in \mathbb{R}^3 | 0 \leq |x| \leq \alpha^{-1}\}, \end{cases} \quad (3.33) \quad \text{dy:ansatz}$$

with $r = |x|$ and $\alpha(t) > 0$ to be determined. Plug (dy:ansatz) into (eq:dynm) . Notice, the homology invariance (hlinvrt) implies the following identity

$$\begin{cases} \nabla(K\rho\theta) = -\rho\nabla\psi & x \in \Omega(t), \\ -\Delta\theta = \epsilon\rho & x \in \Omega(t), \\ \Delta\psi = \rho & x \in \mathbb{R}^3. \end{cases} \quad (3.34)$$

Therefore, (eq:dynm) is reduced to

$$\begin{cases} \rho_t + \text{div}(\rho u) = 0 & x \in \Omega(t), \\ (\rho u)_t + \text{div}(\rho u \otimes u) = 0 & x \in \Omega(t), \\ c_\nu(\rho\theta)_t + c_\nu \text{div}(\rho\theta u) + K\rho\theta \text{div} u = 0 & x \in \Omega(t), \end{cases} \quad (3.35) \quad \text{dy:rdastz}$$

or equivalently

$$\begin{cases} \left(-\frac{\alpha'}{\alpha}\right)' + \left(\frac{\alpha'}{\alpha}\right)^2 = 0, \\ c_\nu \alpha' - 3K\alpha' = 0. \end{cases} \quad (3.36) \quad \text{dy:rdastz01}$$

When $c_\nu = 3K$, (dy:rdastz01) has a non-trivial solution satisfying

$$\alpha''\alpha = 2\alpha'^2,$$

and therefore the non-trivial solution is

$$\alpha(t) = \frac{1}{a + bt} \quad \text{for some constants } a, b. \quad (3.37)$$

Moreover, it follows from the ansatz [\(3.33\)](#), [eq:ansatz](#)

$$u(t, x) = \frac{b}{a + bt}x \quad \text{and} \quad \Omega(t) = (a + bt)\bar{B}_1. \quad (3.38)$$

This will finish the proof after choosing $a, b > 0$ or $a > 0, b < 0$. \square

4 A Prior Estimates

[sec:aprior](#)

In this section, we will establish the a prior estimate for the problem [\(1.13\)](#), [eq:LagrangianCoordinates](#) with the initial density and the initial temperature satisfying [\(1.17\)](#), [PV:lagrangian](#). In the following, we denote $\alpha = \frac{1-\epsilon K}{\epsilon K}$ and $\sigma = R_0 - x$ for $0 \leq x \leq R_0$ being the distance to the vacuum boundary. Then we have $\rho_0 \simeq \sigma^\alpha$ and $\Theta_0 \simeq \sigma$. Therefore, ρ_0, Θ_0 satisfy

$$|\partial_x^k \rho_0| \lesssim \sigma^{\alpha-k}, \quad |\partial_x^k \Theta_0| \lesssim 1 + \sigma^{\alpha-k+2}. \quad (4.1) \quad \text{PV:lagrangianboundary}$$

By denoting

$$\Phi = \frac{1}{x^3} \int_0^x s^2 \rho_0(s) ds, \quad \mathfrak{B} = (2\mu + \lambda) \frac{v_x}{r_x} + 2\lambda \frac{v}{r},$$

we rewrite [\(1.13\)](#), [eq:LagrangianCoordinates](#) as

$$\begin{cases} x^2 \rho_0 \partial_t v + \left(K \frac{x^2 \rho_0}{r_x} \Theta \right)_x - 2Kx \rho_0 \Theta \frac{x}{r} = -\frac{x^5 \rho_0}{r^2} \Phi \\ \quad + r^2 \mathfrak{B}_x + 4\mu r^2 \left(\frac{v}{r} \right)_x & x \in (0, R_0), \\ c_\nu x^2 \rho_0 \partial_t \Theta + Kx^2 \rho_0 \Theta \frac{\partial_t(r^2 r_x)}{r^2 r_x} - \left(\frac{r^2}{r_x} \Theta_x \right)_x = \epsilon x^2 \rho_0 \\ \quad + 2\mu r^2 r_x \left(\left(\frac{v_x}{r_x} \right)^2 + 2 \left(\frac{v}{r} \right)^2 \right) + \lambda r^2 r_x \left(\frac{v_x}{r_x} + 2 \frac{v}{r} \right)^2 & x \in (0, R_0). \end{cases} \quad (4.2)$$

[eq:Lg000](#)

Notice

$$\|\Phi\|_{L_t^\infty L_x^\infty} < \infty, \quad \mathfrak{B}|_{x=R_0} = 0, \quad (4.3)$$

and it is easy to verify that for a strong (or classical) solution, $\Theta > 0$ in $(0, R_0)$.

We will organize this section as follows. In Section [4.1](#), we obtain some point-wise estimates, which will manipulate the nonlinearity. In Section [4.2](#), we obtain the regularity estimates for the strong solutions in the spatial variable. In Section [4.3](#), we close the energy estimates for the strong solutions. In Section [4.4](#), we will perform the corresponding higher order estimates for the classical solutions.

4.1 Point-wise Estimates

In this section, the goal is to derive the bound the quantity

$$\Lambda_0 = \Lambda_0(r, v, \Theta) := \sup_{x \in (0, R_0)} \left\{ \left| \frac{1}{r_x} \right|, \left| \frac{x}{r} \right|, \sum_{i=0}^1 |\partial_t^i r_x|, \sum_{i=0}^1 \left| \frac{\partial_t^i r}{x} \right|, \left| \frac{\Theta}{\sigma} \right| \right\}. \quad (4.4)$$

Also, we denote

$$M_0 = M_0(r) := \sup_{x \in (0, R_0)} \left\{ |r_x|, \left| \frac{r}{x} \right|, \left| \frac{1}{r_x} \right|, \left| \frac{x}{r} \right| \right\}. \quad (4.5)$$

In the following, it is assumed $M_0, \Lambda_0 < \infty$.

Lemma 13 *For a strong solution to [\(1.13\)](#) in the space \mathfrak{X} defined in [\(2.6\)](#), we have*

$$\|v_x\|_{L_t^\infty L_x^\infty}, \left\| \frac{v}{x} \right\|_{L_t^\infty L_x^\infty}, \left\| \frac{\Theta}{\sigma} \right\|_{L_t^\infty L_x^\infty} \lesssim P(M_0)(\mathcal{E}_1 + 1). \quad (4.6)$$

Also,

$$\Lambda_0, \|x^{1/2}\Theta_x\|_{L_t^\infty L_x^\infty} \lesssim P(M_0)(\mathcal{E}_1 + 1). \quad (4.7)$$

In particular,

$$x^{1/2}\Theta_x|_{x=0} = 0. \quad (4.8)$$

Proof For a strong solution in the space \mathfrak{X} defined in [\(2.6\)](#), the embedding theory yields,

$$\begin{aligned} J_3^3 &= \int \chi \frac{x^2}{r^2} v_t \left(2 \frac{rv}{x^2} \mathfrak{B}_x \right) dx = -2 \int \mathfrak{B} \left(\chi \frac{vv_t}{r} \right)_x dx \lesssim \delta \int \chi (v_{xt}^2 + (\frac{v_t}{x})^2) dx \\ &\quad + C_\delta P(\Lambda_0) \mathcal{E}_1. \end{aligned}$$

Summing up these estimates with a small enough δ yields,

4.4 Higher Regularity

In this section, we will perform higher order estimates of the solutions to [\(H.13\)](#) ^{eq:LagrangianCoordinates}. In the following, it is assumed $\mathcal{E}_1 < \infty, \Lambda_0 < \infty, M_0 \leq 2$ and $\mathcal{E}_2^0 < \infty$. We will show that for a short time, $\mathcal{E}_2 < \infty$. In particular, we study the regularity of classical solutions in the space \mathfrak{Y} . In order to do so, we first establish some elliptic estimates for the classical solutions, and then head to the energy estimates.

Elliptic Estimates for Classical Solutions

In the following, we shall perform higher order elliptic estimates for the classical solutions. In particular, we will consider the following system, which consists of the temporal derivative version of [\(H.17\)](#) ^{eq:altformofmteq} and the rearrangement of [\(H.33\)](#)₂ ^{eq:Lg010},

$$\begin{aligned} I_1^2 &= \partial_t^2 \left(\frac{\Theta}{r_x}\right), \quad I_2^2 = \partial_t^2 \left(\Theta \frac{x}{r}\right), \quad I_3^2 = \partial_t^2 \left(\frac{r^2}{x^2} \mathfrak{B}_x\right) - \frac{r^2}{x^2} \mathfrak{B}_{xtt}, \\ I_4^2 &= \partial_t^2 \left(4\mu \frac{r^2}{x^2} \left(\frac{v}{r}\right)_x\right) - 4\mu \frac{r^2}{x^2} \left(\frac{v_{tt}}{r}\right)_x, \quad I_5^2 = -\partial_t^2 \left(\frac{x^3}{r^2} \Phi\right), \\ I_6^2 &= \partial_t^2 \left(\Theta \frac{(r^2 r_x)_t}{r^2 r_x}\right), \\ I_7^2 &= \partial_t^2 \left[2\mu \frac{r^2 r_x}{x^2} \left(\left(\frac{v_x}{r_x}\right)^2 + 2\left(\frac{v}{r}\right)^2\right) + \lambda \frac{r^2 r_x}{x^2} \left(\frac{v_x}{r_x} + 2\frac{v}{r}\right)^2\right], \\ I_8^2 &= \partial_t (I_8^1 \Theta_x) - \partial_t \left(\frac{r^2}{x^2 r_x}\right) \Theta_{xt}. \end{aligned}$$

(4.86) should be complemented with the following boundary conditions eq:Lg020

$$\partial_t^2 v(0, t) = 0, \quad \partial_t^2 \Theta(R_0, t) = 0, \quad \mathfrak{B}_{tt}(R_0, t) = 0, \quad t \geq 0.$$

Similar as before, we shall present energy estimates on (4.86). Multiply (4.86)₁ with v_{tt} and (4.86)₂ with Θ_{tt} respectively and integrate the resulting equations over $x \in (0, R_0)$. After integration by parts, it holds the following, eq:Lg020

$$\begin{aligned} & \frac{d}{dt} \left\{ \frac{c_\nu}{2} \int x^2 \rho_0 \Theta_{tt}^2 dx \right\} + \int \frac{r^2}{r_x} \Theta_{xtt}^2 dx = -K \int x^2 \rho_0 I_6^2 \Theta_{tt} dx \\ & \quad + \int x^2 I_7^2 \Theta_{tt} dx + \int x^2 I_8^2 \Theta_{xtt} := \sum_{i=6}^8 J_i^4. \end{aligned} \quad (4.88) \quad \text{ene:2nd-002}$$

By noticing

$$\begin{aligned} \mathfrak{B}_{tt}(r^2 v_{tt})_x - 4\mu r^2 \left(\frac{v_{tt}}{r}\right)_x v_{tt} &= r^2 r_x \left\{ 2\mu \left(\frac{v_{xtt}^2}{r_x^2} + 2\frac{v_{tt}^2}{r^2}\right) + \lambda \left(\frac{v_{xtt}}{r_x} + 2\frac{v_{tt}}{r}\right)^2 \right\} \\ &\quad - (r^2 v_{tt})_x \left[3 \left((2\mu + \lambda) \frac{v_x}{r_x} \frac{v_{xt}}{r_x} + 2\lambda \frac{v}{r} \frac{v_t}{r} \right) - \left((2\mu + \lambda) \frac{v_x^3}{r_x^3} + 2\lambda \frac{v^3}{r^3} \right) \right], \end{aligned}$$

~~(H.87)~~ and ~~(H.88)~~ can be written as

$$\begin{aligned} \frac{d}{dt} \left\{ \frac{1}{2} \int x^2 \rho_0 v_{tt}^2 dx \right\} + \int r^2 r_x \left(2\mu \left(\frac{v_{xtt}}{r_x}\right)^2 + 2\left(\frac{v_{tt}}{r}\right)^2 + \lambda \left(\frac{v_{xtt}}{r_x} + 2\frac{v_{tt}}{r}\right)^2 \right) dx \\ = \sum_{i=1}^5 J_i^4 + J_9^4, \\ \frac{d}{dt} \left\{ \frac{c_\nu}{2} \int x^2 \rho_0 \Theta_{tt}^2 dx \right\} + \int \frac{r^2}{r_x} \Theta_{xtt}^2 dx = \sum_{i=6}^8 J_i^4, \end{aligned}$$

with

$$J_9^4 = \int (r^2 v_{tt})_x \left[3 \left((2\mu + \lambda) \frac{v_x}{r_x} \frac{v_{xt}}{r_x} + 2\lambda \frac{v}{r} \frac{v_t}{r} \right) - \left((2\mu + \lambda) \frac{v_x^3}{r_x^3} + 2\lambda \frac{v^3}{r^3} \right) \right] dx. \quad (4.89)$$

Similar as before, J_i^4 's can be evaluated as follows,

$$\begin{aligned} J_1^4 + J_2^4 + J_4^4 + J_5^4 + J_9^4 &\lesssim \delta \int (x^2 v_{xtt}^2 + v_{tt}^2) dx + C_\delta P(\Lambda_0) \mathcal{E}_2, \\ J_6^4 + J_7^4 + J_8^4 &\lesssim \delta \left(\int (x^2 v_{xtt}^2 + v_{tt}^2) dx + \int x^2 \Theta_{xtt}^2 dx \right) \\ &\quad + (1 + C_\delta) P(\Lambda_0) (1 + \|v_{xt}\|_{L_t^\infty L_x^\infty}^2 + \|\frac{v_t}{x}\|_{L_t^\infty L_x^\infty}^2) \mathcal{E}_2. \end{aligned}$$

To evaluate J_3^4 , after noticing

integration by parts yields,

$$\begin{aligned} & \|x\sqrt{\rho_0}\Theta_{tt}\|_{L_t^\infty L_x^2}^2 + \|x\Theta_{xtt}\|_{L_t^2 L_x^2}^2 \lesssim \|xv_{xtt}\|_{L_t^2 L_x^2}^2 + \|v_{tt}\|_{L_t^2 L_x^2}^2 \\ & + TP(\Lambda_0)(1 + \|v_{xt}\|_{L_t^\infty L_x^\infty}^2 + \|\frac{v_t}{x}\|_{L_t^\infty L_x^\infty}^2)\mathcal{E}_2 + P(M_0)\mathcal{E}_2^0. \end{aligned} \quad (4.91) \quad \boxed{\text{ene:2nd-020}}$$

On the other hand, multiply (eq:Lg020) with $\chi\frac{v_{tt}}{r^2}$ and integrate the resulting equation over $x \in (0, R_0)$. After integration by parts, it holds,

$$\begin{aligned} & \int \chi \frac{x^2}{r^2} \rho_0 v_{tt} \partial_t v_{tt} dx + \int (\mathfrak{B}_{tt} + 4\mu \frac{v_{tt}}{r})(\chi v_{tt})_x dx = K \int x^2 \rho_0 I_1^2 (\chi \frac{v_{tt}}{r^2})_x dx \\ & + 2K \int \chi x \rho_0 I_2^2 \frac{v_{tt}}{r^2} dx + \int \chi \frac{x^2}{r^2} v_{tt} (I_3^2 + I_4^2) dx + \int \chi \frac{x^2}{r^2} \rho_0 v_{tt} I_5^2 dx := \sum_{i=10}^{13} J_i^4. \end{aligned}$$

The left side of the above identity can be rewritten as, after integration by parts,

$$\frac{d}{dt} \left\{ \frac{1}{2} \int \chi \frac{x^2}{r^2} \rho_0 v_{tt}^2 \right\} + (2\mu + \lambda) \int \chi r_x \left(\left(\frac{v_{xtt}}{r_x} \right)^2 + \left(\frac{v_{tt}}{r} \right)^2 \right) dx - J_{14}^4,$$

where

$$\begin{aligned} J_{14}^4 &= - \int \chi \frac{x^2 v}{r^3} \rho_0 v_{tt}^2 dx - (2\mu + \lambda) \int \chi' v_{tt} \left(\frac{v_{xtt}}{r_x} + \frac{v_{tt}}{r} \right) dx \\ &+ \int \left\{ 3 \left((2\mu + \lambda) \frac{v_{xt} v_x}{r_x^2} + 2\lambda \frac{v_t v}{r^2} \right) - 2 \left((2\mu + \lambda) \frac{v_x^3}{r_x^3} + 2\lambda \frac{v^3}{r^3} \right) \right\} (\chi v_{tt})_x dx. \end{aligned}$$

Thus it ends up with

$$\frac{d}{dt} \left\{ \frac{1}{2} \int \chi \frac{x^2}{r^2} \rho_0 v_{tt}^2 dx \right\} + (2\mu + \lambda) \int \chi r_x \left(\left(\frac{v_{xtt}}{r_x} \right)^2 + \left(\frac{v_{tt}}{r} \right)^2 \right) dx = \sum_{i=10}^{14} J_i^4.$$

By applying Cauchy's inequality and the Hardy's inequality, the following estimate can be achieved,

$$+ (1 + C_\delta)P(\Lambda_0) \int (x^2 \Theta_{xtt}^2 + x^2 v_{xtt}^2 + v_{tt}^2) dx + (1 + C_\delta)P(\Lambda_0)\mathcal{E}_2.$$

In the meantime, integration by parts yields together with Cauchy's inequality,

$$\begin{aligned} J_{12}^4 &= - \int \left((4\chi \frac{v}{r} v_{tt})_x \mathfrak{B}_t + (2\chi (\frac{v^2}{r^2} + \frac{v_t}{r}) v_{tt})_x \mathfrak{B} \right) dx \\ &\quad - \int \left((8\mu\chi (\frac{v^2}{r^2} + \frac{v_t}{r}) v_{tt})_x \frac{v}{r} + (16\mu\chi \frac{v}{r} v_{tt})_x (\frac{v_t}{r} - \frac{v^2}{r^2}) \right. \\ &\quad \left. + (4\mu\chi v_{tt})_x (-3\frac{v_t v}{r^2} + 2\frac{v^3}{r^3}) \right) dx \lesssim \delta \int \chi (v_{xtt}^2 + (\frac{v_{tt}}{x})^2) dx \\ &\quad + (1 + C_\delta)P(\Lambda_0) \int (x^2 v_{xtt}^2 + v_{tt}^2) dx + (1 + C_\delta)P(\Lambda_0)\mathcal{E}_2. \end{aligned}$$

Therefore, after choosing $\delta \ll 1$ small enough, integration in the temporal variable in the above yields,

$$\begin{aligned} &\| \sqrt{\chi \rho_0} v_{tt} \|_{L_t^\infty L_x^2}^2 + \| \sqrt{\chi} v_{xtt} \|_{L_t^2 L_x^2}^2 + \| \sqrt{\chi} \frac{v_{tt}}{x} \|_{L_t^2 L_x^2}^2 \\ &\lesssim P(\Lambda_0) (\| x \Theta_{xtt} \|_{L_t^2 L_x^2}^2 + \| x v_{xtt} \|_{L_t^2 L_x^2}^2 + \| v_{tt} \|_{L_t^2 L_x^2}^2 + T \mathcal{E}_2) + P(M_0) \mathcal{E}_2^0. \end{aligned} \quad (4.92)$$

From (4.90), (4.91) and (4.92), we will derive the a priori estimates for the classical solution.

Lemma 22 *For a solution to (1.13), there is a time*

$$T_{**} = T_{**}(\mathcal{E}_1^0, \mathcal{E}_2^0) \geq \frac{1}{P_{**}(\mathcal{E}_1^0 + 1, \mathcal{E}_2^0 + 1)}, \quad (4.93)$$

for some positive polynomial $P_{**} = P_{**}(\cdot)$ and some positive constant $1 < C_{**} < \infty$.

Proof From (4.90), (4.91) and (4.92), after applying the fundamental theory of calculus in the temporal variable, we have

Then, together with [\(1.13\)](#), it implies

for some positive polynomial $P_5 = P_5(\cdot)$, $P_6 = P_6(\cdot)$. Let

Then for $T \leq \min\{T_*, T_3, T_4, 1\}$, it follows,

5 Local Well-posedness of [\(1.13\)](#) [eq:LagrangianCoordinates](#)

[sec:well-posedness](#)

In this section, we will use the a priori estimates obtained in [Section 4](#) [eq:LagrangianCoordinates](#) to derive the local well-posedness of the problem [\(1.13\)](#). In particular, we introduce the following Hilbert space [sec:aprior](#)

$$\begin{aligned} \mathfrak{M} := \{ & (r, v, \Theta) \mid r, v \in L_t^2 H_x^2, v_t \in L_t^2 H_x^1, \Theta \in L_t^2 H_x^1, x\Theta \in L_t^2 H_x^2, \\ & x\Theta_t \in L_t^2 H_x^1 \}. \end{aligned} \quad (5.1)$$

\mathfrak{M} is endowed with the norm

$$\begin{aligned} \|(r, v, \Theta)\|_{\mathfrak{M}}^2 := & \|r\|_{L_t^2 H_x^2}^2 + \|v\|_{L_t^2 H_x^2}^2 + \|v_t\|_{L_t^2 H_x^1}^2 + \|\Theta\|_{L_t^2 H_x^1}^2 \\ & + \|x\Theta\|_{L_t^2 H_x^2}^2 + \|x\Theta_t\|_{L_t^2 H_x^1}^2. \end{aligned} \quad (5.2)$$

A closed, bounded, convex subset of \mathfrak{M} is defined as

$$\begin{aligned} \mathfrak{S} = \mathfrak{S}_{\bar{M}} := \{ & (r, v, \Theta) \in \mathfrak{M} \mid \|(r, v, \Theta)\|_{\mathfrak{M}} < \tilde{P}(\bar{M}), \mathcal{E}_1(v, \Theta) \leq \bar{M}, \\ & \Lambda_0(r, v, \Theta) \leq \bar{M}, M_0(r) \leq 2 \}, \end{aligned} \quad (5.3)$$

for some positive polynomial $\tilde{P} = \tilde{P}(\cdot)$ to be determined later. We will write down the linearized problem of [\(1.13\)](#) [eq:LagrangianCoordinates](#) and construct a map

$$\mathcal{T} : \mathfrak{S} \rightsquigarrow \mathfrak{S}. \quad (5.4)$$

Then we can apply the Tychonoff fixed point theory [\(6\)](#) [Coutand2011a](#) to derive the well-posedness of [\(1.13\)](#) [eq:LagrangianCoordinates](#).

5.1 The Linearized Problem

We first introduce the linearized problem. Given $(\bar{r}, \bar{v}, \bar{\Theta}) \in \mathfrak{S}$, consider the linearized problem,

$$\begin{cases} \left(\frac{x}{\bar{r}} \right)^2 \rho_0 \partial_t v + \left(K \frac{x^2 \rho_0}{\bar{r}^2 \bar{r}_x} \Theta \right)_x = - \frac{x^2 \rho_0}{\bar{r}^4} \int_0^x s^2 \rho_0(s) ds \\ \quad + (2\mu + \lambda) \left(\frac{(\bar{r}^2 v)_x}{\bar{r}^2 \bar{r}_x} \right)_x & x \in (0, R_0), \\ c_\nu x^2 \rho_0 \partial_t \Theta + K \frac{x^2 \rho_0}{\bar{r}^2 \bar{r}_x} \bar{\Theta} (\bar{r}^2 v)_x - \left(\frac{\bar{r}^2}{\bar{r}_x} \Theta_x \right)_x = \epsilon x^2 \rho_0 \\ \quad + 2\mu \bar{r}^2 \bar{r}_x \left(\frac{\bar{v}_x v_x}{\bar{r}_x^2} + 2 \frac{\bar{v} v}{\bar{r}^2} \right) + \lambda \bar{r}^2 \bar{r}_x \left(\frac{\bar{v}_x}{\bar{r}_x} + 2 \frac{\bar{v}}{\bar{r}} \right) \cdot \left(\frac{v_x}{\bar{r}_x} + 2 \frac{v}{\bar{r}} \right) & x \in (0, R_0), \end{cases} \quad (5.5) \quad \text{eq:linearized}$$

and r is defined by, for $0 < t < T$,

$$r(x, t) = x + \int_0^t v(x, s) ds. \quad (5.6) \quad \text{linearized:r}$$

The boundary condition of [\(5.5\)](#) is given as

$$v(0, t) = 0, \quad \Theta(R_0, t) = 0, \quad \left[(2\mu + \lambda) \frac{v_x}{\bar{r}_x} + 2\lambda \frac{v}{\bar{r}} \right] (R_0, t) = 0, \quad t \geq 0. \quad (5.7) \quad \text{linearized:boundarycon}$$

To solve the linearized problem, we consider the variables

$$(X, Y) := (\rho_0 v, x^2 \rho_0 \Theta)$$

and rewrite [\(5.5\)](#) in the new variables X, Y . Then following standard Galerkin approximation (see [\[6\]](#)), denote the $n \geq 1$ level of approximating solutions as $(X_n, Y_n) = (\sum_{i=0}^n \lambda_i^n(t) e_i, \sum_{i=0}^n \delta_i^n(t) e_i)$, where $(e_n)_{n \in \mathbb{N}}$ is a Hilbert basis of $H_0^1(0, R_0)$ and each e_n is of class $H^k(0, R_0)$ for all $k \geq 1$. Then (X_n, Y_n) can be solved through the ODE system, for $1 \leq i \leq n$,

$$\begin{cases} \left(\left(\frac{x}{\bar{r}} \right)^2 X_{nt}, e_i \right)_{L^2} - \left(K \frac{Y_n}{\bar{r}^2 \bar{r}_x}, e_{i,x} \right)_{L^2} = - \left(\frac{x^2 \rho_0}{\bar{r}^4} \int_0^x s^2 \rho_0(s) ds, e_i \right)_{L^2} \\ \quad - \left((2\mu + \lambda) \frac{(X_n/\rho_0)_x}{\bar{r}_x} + \lambda \frac{X_n/\rho_0}{\bar{r}}, e_{i,x} \right)_{L^2} + 4\mu \left(\left(\frac{X_n}{\rho_0 \bar{r}} \right)_x, e_i \right)_{L^2}, \\ c_\nu (Y_{nt}, e_i)_{L^2} + \left(K \frac{x^2 \rho_0}{\bar{r}^2 \bar{r}_x} \bar{\Theta} (\bar{r}^2 \frac{X_n}{\rho_0})_x, e_i \right)_{L^2} + \left(\frac{\bar{r}^2}{\bar{r}_x} \left(\frac{Y_n}{x^2 \rho_0} \right)_x, e_{ix} \right)_{L^2} \\ = \epsilon (x^2 \rho_0, e_i)_{L^2} + \left(2\mu \bar{r}^2 \bar{r}_x \left(\frac{\bar{v}_x (X_n/\rho_0)_x}{\bar{r}_x^2} + 2 \frac{\bar{v} X_n/\rho_0}{\bar{r}^2} \right), e_i \right)_{L^2} \\ + \left(\lambda \bar{r}^2 \bar{r}_x \left(\frac{\bar{v}_x}{\bar{r}_x} + 2 \frac{\bar{v}}{\bar{r}} \right) \cdot \left(\frac{(X_n/\rho_0)_x}{\bar{r}_x} + 2 \frac{X_n/\rho_0}{\bar{r}} \right), e_i \right)_{L^2}, \end{cases}$$

with the initial data

$$\lambda_i^n(0) = (\rho_0 v_0, e_i)_{L^2}, \quad \delta_i^n(0) = (x^2 \rho_0 \Theta_0, e_i)_{L^2},$$

where $(\cdot, \cdot)_{L^2}$ denotes the L^2 -inner product on $(0, R_0)$. Here (v_0, Θ_0) satisfies $\mathcal{E}_1^0 < \infty$. By applying the Hardy's inequalities in Lemma 2, the above Galerkin approximating problem is well-defined and can be solved via the ODE theory. In the following, define $(v, \Theta) = (v_n, \Theta_n) := (X_n/\rho_0, Y_n/(x^2 \rho_0))$. Also, define $r = r_n$ by (5.6). Then $(r, v, \Theta) \in \mathfrak{M}$.

In the rest of this section, we will sketch some n -independent a priori estimates to show $(r, v, \Theta) \in \mathfrak{S}$ for $0 < T < \tilde{T}_*$ where $\tilde{T}_* = \tilde{T}_*(\bar{M}) > 0$ for some $\bar{M} > 0$. Then by taking $n \rightarrow \infty$, we solve the linearized problem (5.5).

For the sake of convenience, denote

$$\bar{\mathcal{E}}_1 = \mathcal{E}_1(\bar{v}, \bar{\Theta}) \leq \bar{M}, \bar{\Lambda}_0 = \Lambda_0(\bar{r}, \bar{v}, \bar{\Theta}) \leq \bar{M}, \bar{M}_0 = M_0(\bar{r}) \leq 2.$$

Following similar steps as in Section 4.3, the energy estimates yield

$$\begin{aligned} & \|x\sqrt{\rho_0}v_t\|_{L_t^\infty L_x^2}^2 + \|x\sqrt{\rho_0}\Theta_t\|_{L_t^\infty L_x^2}^2 + \|xv_{xt}\|_{L_t^2 L_x^2}^2 + \|v_t\|_{L_t^2 L_x^2}^2 \\ & + \|x\Theta_{xt}\|_{L_t^2 L_x^2}^2 \lesssim T(1 + C_\delta)P(\bar{\Lambda}_0)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1) + \delta\bar{\mathcal{E}}_1\Lambda_0^2 \\ & + P(\bar{M}_0)\mathcal{E}_1^0, \\ & \|xv_x\|_{L_t^\infty L_x^2}^2 + \|v\|_{L_t^\infty L_x^2}^2 + \|x\Theta_x\|_{L_t^\infty L_x^2}^2 + \|x\sqrt{\rho_0}v_t\|_{L_t^2 L_x^2}^2 \\ & + \|x\sqrt{\rho_0}\Theta_t\|_{L_t^2 L_x^2}^2 \lesssim T(1 + C_\delta)P(\bar{\Lambda}_0)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1) \\ & + \delta\bar{\mathcal{E}}_1\Lambda_0^2 + P(\bar{M}_0)\mathcal{E}_1^0, \\ & \|\sqrt{\chi}\rho_0v_t\|_{L_t^2 L_x^2}^2 + \|\sqrt{\chi}v_{xt}\|_{L_t^2 L_x^2}^2 + \|\sqrt{\chi}\frac{v_t}{x}\|_{L_t^2 L_x^2}^2 \\ & \lesssim T(1 + C_\delta)P(\bar{\Lambda}_0)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1) + \delta\bar{\mathcal{E}}_1\Lambda_0^2 + P(\bar{M}_0)\mathcal{E}_1^0, \\ & \|\sqrt{\chi}v_x\|_{L_t^\infty L_x^2}^2 + \|\sqrt{\chi}\frac{v}{x}\|_{L_t^\infty L_x^2}^2 + \|\sqrt{\chi}\rho_0v_t\|_{L_t^2 L_x^2}^2 \\ & \lesssim T(1 + C_\delta)P(\bar{\Lambda}_0)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1) + \delta\bar{\mathcal{E}}_1\Lambda_0^2 + P(\bar{M}_0)\mathcal{E}_1^0. \end{aligned}$$

We point out the estimates of the terms involving higher order derivative of $\bar{v}, \bar{\Theta}$ in the above estimates. When calculating $\int \partial_t (\bar{v})_2 \Theta_t$, we engage with the following estimates on the right

$$\begin{aligned} & \int \left\{ 2\mu\bar{r}^2\bar{r}_x \left(\frac{\bar{v}_x v_x}{\bar{r}_x^2} + 2\frac{\bar{v}v}{\bar{r}^2} \right) + \lambda\bar{r}^2\bar{r}_x \left(\frac{\bar{v}_x}{\bar{r}_x} + 2\frac{\bar{v}}{\bar{r}} \right) \cdot \left(\frac{v_x}{\bar{r}_x} + 2\frac{v}{\bar{r}} \right) \right\}_t \Theta_t dx \\ & \lesssim \mathcal{E}_1 + \delta \left(\Lambda_0^2 \int (x^2 \bar{v}_{xt}^2 + \bar{v}_t^2) dx + \int (x^2 v_{xt}^2 + v_t^2) dx \right) \end{aligned}$$

$$+ (1 + C_\delta)P(\bar{\Lambda}_0) \int x^2 \Theta_t^2 dx,$$

and on the left

$$\begin{aligned} \left| \int k\left(\frac{x^2 \rho_0}{\bar{r}^2 \bar{r}_x} \bar{\Theta}(\bar{r}^2 v)_x\right)_t \Theta_t dx \right| &\lesssim P(\bar{M}_0) \Lambda_0 \int x^2 \rho_0 |\bar{\Theta}_t \Theta_t| dx \\ &+ (1 + C_\delta)P(\bar{\Lambda}_0) \int x^2 \Theta_t^2 dx + \delta \int (x^2 v_{xt}^2 + v_t^2) dx + \mathcal{E}_1 \\ &\lesssim \delta \left(\Lambda_0^2 \int x^2 \bar{\Theta}_{xt}^2 dx + \int (x^2 v_{xt}^2 + v_t^2) dx \right) \\ &+ \mathcal{E}_1 + (1 + C_\delta)P(\bar{\Lambda}_0) \int x^2 \Theta_t^2 dx. \end{aligned}$$

Then after applying [\(4.40\)](#) and integrating in the temporal variable, one can get the corresponding estimates.

The next step is to employ similar estimates as in Lemma [4.3](#), one can derive

$$\Lambda_0 \lesssim P(\bar{M}_0)(C_\delta \mathcal{E}_1 + \delta \bar{\mathcal{E}}_1 + 1). \quad (5.8) \quad \boxed{\text{linearized:0001}}$$

Therefore, we have the following inequality

$$\begin{aligned} \mathcal{E}_1 &\leq T(1 + C_\delta)P_8(\bar{\Lambda}_0)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1) + \delta P_9(\bar{M}_0, \bar{\mathcal{E}}_1)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1)^2 \\ &+ P_{10}(\bar{M}_0)\mathcal{E}_1^0, \end{aligned}$$

for some positive polynomials $P_8 = P_8(\cdot), P_9 = P_9(\cdot), P_{10} = P_{10}(\cdot)$. Then after choosing δ so that $\delta P_9(\bar{M}_0, \bar{\mathcal{E}}_1)(\mathcal{E}_1 + \bar{\mathcal{E}}_1 + 1)^2 \leq 1$, we have

$$\mathcal{E}_1 \leq TP_{11}(\bar{M})(\mathcal{E}_1 + \bar{M} + 1)^3 + 1 + C_3 \mathcal{E}_1^0,$$

for some positive polynomial $P_{11} = P_{11}(\cdot)$ and some constant $0 < C_3 < \infty$. Hence, let

$$\tilde{T}_* := \frac{1}{P_{11}(\bar{M})(\mathcal{E}_1 + \bar{M} + 1)^3}.$$

Then for $T < \tilde{T}_*$ and $\bar{M} > 2 + C_3 \mathcal{E}_1^0$,

$$\mathcal{E}_1 \leq 1 + 1 + C_3 \mathcal{E}_1^0 \leq \bar{M}. \quad (5.9) \quad \boxed{\text{linearized:0002}}$$

Also, from [\(5.8\)](#), for some positive polynomial $P_{12} = P_{12}(\cdot)$, choosing $\delta \sqrt{\bar{M}} \simeq 1$,

$$\Lambda_0 \leq P_{12}(2)(C_\delta \mathcal{E}_1 + \delta \bar{M} + 1) \leq P_{12}(2)(\sqrt{\bar{M}}(2 + C_3 \mathcal{E}_1^0) + \sqrt{\bar{M}} + 1) \leq \bar{M},$$

for \bar{M} sufficiently large. Also, applying the fundamental theory of calculus yields,

$$M_0 \leq 1 + (\Lambda_0 + \Lambda_0^2)T \leq 2 \text{ for } T < 1/(\bar{M} + \bar{M}^2).$$

Therefore, we can refine \tilde{T}_* to be

$$\tilde{T}_* = \frac{1}{P_{13}(\bar{M})}, \quad (5.10) \quad \boxed{\text{linearized:0003}}$$

for some positive polynomial $P_{13} = P_{13}(\cdot)$. Finally, the elliptic estimates as in Section 4.2 will show $(r, v, \Theta) \in \mathfrak{X}$ and in particular $\|(r, v, \Theta)\|_{\mathfrak{M}} < \tilde{P}(\bar{M})$ for some positive polynomial $\tilde{P} = \tilde{P}(\cdot)$.

Therefore, after taking $n \rightarrow \infty$, we get the solution $(r, v, \Theta) \in \mathfrak{S} \cap \mathfrak{X}$ of the linearized problem (5.5). It is easy to verify that the solution is unique.

5.2 The Fixed Point

Let $\mathcal{T}(\bar{r}, \bar{v}, \bar{\Theta}) := (r, v, \Theta)$ be the unique solution to the linearized problem (5.5). Then from the last section, \mathcal{T} is mapping from \mathfrak{S} to \mathfrak{S} . Also, it is furthermore clear that \mathcal{T} is weakly continuous in the \mathfrak{M} norm. Then the Tychonoff fixed point theory yields there is at least one solution to the nonlinear problem (1.13) in \mathfrak{S} for $T < T_*$ (defined in (5.10)).

Then the a priori estimates in Section 4.2 show that $(r, v, \Theta) \in \mathfrak{X}$. Consequently, we get the well-posedness theory of strong solutions to (1.13). On the other hand, the estimates in Section 4.4 show that the strong solution becomes classical if the initial data satisfies $\mathcal{E}_2^0 < \infty$. Thus we have the well-posedness theory of classical solutions to (1.13).
