

# A $W^{2,p}$ -ESTIMATE FOR NEARLY UMBILICAL HYPERSURFACES

ABSTRACT. Let  $n \geq 2$ ,  $p$  in  $(1, +\infty)$  be given and let  $\Sigma$  be a  $n$ -dimensional, closed hypersurface in  $\mathbb{R}^{n+1}$ . Denote by  $A$  its second fundamental form, and by  $\mathring{A}$  the tensor  $A - \frac{\text{tr}_g A}{n} g$  where  $g := \delta|_{\Sigma}$  and  $\delta$  is the flat metric in  $\mathbb{R}^{n+1}$ . Assuming that  $\Sigma$  is the boundary of a convex, open set we generalize the results of [3] and we prove that if the  $L^p$  norm of  $\mathring{A}$  is small, then  $\Sigma$  must be  $W^{2,p}$ -close to a round sphere, with a quantitative estimate.

## 1. INTRODUCTION

Let  $\Sigma$  be a  $n$ -dimensional hypersurface in  $\mathbb{R}^{n+1}$ . We say that a point in  $q \in \Sigma$  is umbilical if its second fundamental form  $A$  is diagonal when evaluated at  $q$ . A classical theorem in differential geometry assures that if  $\Sigma$  is connected and every point  $p$  is umbilical, then  $\Sigma$  is a (portion of a) sphere or a (portion of a) plane. In particular if the hypersurface  $\Sigma$  is closed then it must be a round sphere and it must satisfy  $A = \lambda g$ , where  $\lambda$  is a real number and  $g = \delta|_{\Sigma}$  is the induced metric. There have been many attempts to give a quantitative version of the rigidity theorems, especially for hypersurfaces which are boundaries of convex sets. For example in [7] it is proven that if a 2-dimensional surface in  $\mathbb{R}^3$  is the boundary of a convex set and satisfies certain conditions on the ratio of the eigenvalues of the second fundamental form, then it must be close to a round sphere. More recently in [3] the authors have proven the existence of a universal constant  $C$  such that for every closed surface  $\Sigma$  in  $\mathbb{R}^3$  the following estimate holds:

$$\min_{\lambda \in \mathbb{R}} \|A - \lambda g\|_{L^2_g(\Sigma)} \leq C \|\mathring{A}\|_{L^2_g(\Sigma)}$$

where  $\mathring{A}$  is the traceless second fundamental form. In the same work they also proved that if  $\|\mathring{A}\|_p$  is smaller than a universal constant then there exist a conformal parametrization  $\psi: \mathbb{S}^n \rightarrow \Sigma$  and a vector  $c = c(\Sigma)$  such that

$$\|\psi - \text{id} - c\|_{W^{2,2}(\mathbb{S}^2)} \leq C \|\mathring{A}\|_{L^2_g(\Sigma)}$$

where  $C$  is again a universal constant. In this article we prove a stronger version of this estimate. Our theorem works for every dimension  $n \geq 2$  and for every  $p \in (1, +\infty)$ , although within the assumption that our surface is the boundary of a convex set. The proof of the theorem in [3] however is limited in dimension 2, so in order to prove such result in every dimension, we need to find other ways. We state our result. Here:

$\text{Vol}_n$	$n$ -dimensional Hausdorff measure.
$\mathbb{S}^n$	standard sphere in $\mathbb{R}^{n+1}$ .
$\sigma$	standard metric on the sphere.
$g$	restriction of the $\mathbb{R}^{n+1}$ -flat metric to $\Sigma$ .
$A$	second fundamental form for $\Sigma$ .
$\mathring{A}$	traceless second fundamental for $\Sigma$ .
$x \lesssim_\alpha y$	$x \leq Cy$ where $C$ is a positive constant depending only on $\alpha$ .

We will also say that a hypersurface  $\Sigma$  is  $\delta$ -admissible if it satisfies the following conditions:

$$(1.1) \quad \Sigma = \partial U, \text{ where } U \text{ is an open, convex set}$$

$$(1.2) \quad \text{Vol}_n(\mathbb{S}^n) = \text{Vol}_n(\Sigma)$$

$$(1.3) \quad \|\mathring{A}\|_{L_g^p(\Sigma)} \leq \delta$$

**Theorem 1.1.** *Let  $n \geq 2$  and  $p \in (1, +\infty)$  be given, and let  $\Sigma$  be a smooth, closed  $n$ -dimensional hypersurface. There exists  $\delta = \delta(n, p) > 0$  with the following property. If  $\Sigma$  is  $\delta$ -admissible there exist a smooth parametrization  $\psi: \mathbb{S}^n \rightarrow \Sigma$  and a vector  $c = c(\Sigma) \in U$  such that for the following estimate holds:*

$$(1.4) \quad \|\psi - \text{id} - c\|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p(\Sigma)}$$

From theorem 1.1 we infer the following corollary, which improves a result proved in [3].

**Corollary 1.2.** *Under the assumptions of theorem 1.1 the following estimate holds:*

$$(1.5) \quad \|g - \sigma\|_{W_{\sigma}^{1,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p(\Sigma)}$$

The proof of the theorem is essentially divided into three main parts. Firstly we show that under certain assumptions we can find a constant  $\lambda$  so that it is possible to control the  $L^p$ -norm of  $A - \lambda g$  with the  $L^p$ -norm of  $\mathring{A}$ . This estimate is basically the nonlinear version of our result. Secondly we prove that a convex surface whose the  $L^p$ -norm of  $\mathring{A}$  is small is  $W^{1,\infty}$ -near to a sphere with qualitative estimates. Thirdly we make quantitative the results obtained in the previous part, proving a certain estimate which is very close to (1.4). As we will see, this estimate depends on the position of  $\Sigma$  in  $\mathbb{R}^{n+1}$ . From these three results we prove our theorem by centering  $\Sigma$  properly.

**Notation.** Throughout this paper we will use the previous notational conventions plus the following ones:

$D$	usual derivative in $\mathbb{R}^n$ .
$\nabla$	Levi-Civita connection associated to $\sigma$ .

## 2. PROOF OF THE MAIN THEOREM

Before entering in the details, we exhibit the parametrization on which we will work. Let us assume for a moment that  $\Sigma$  is the border of an open, convex set  $U$  containing 0. We can give the following radial parametrization for  $\Sigma$ :

$$(2.1) \quad \psi: \mathbb{S}^n \longrightarrow \Sigma, \quad \psi(x) := \rho(x) x := e^{f(x)} x$$

Clearly  $\psi$  is a smooth diffeomorphism. If  $U$  does not contain 0 we can still give such parametrization by properly translating  $U$ . We will say that  $\Sigma$  is *radially parametrized* if it can be written as the image of such  $\psi$ .

Now we can state the three main steps outlined in the introduction and show how these propositions easily lead to the theorem.

**Proposition 2.1.** *Let  $\Sigma$  be a radially parametrized manifold in  $\mathbb{R}^{n+1}$ . Then the following estimate holds:*

$$(2.2) \quad \min_{\lambda \in \mathbb{R}} \|A - \lambda g\|_{L_g^p(\Sigma)} \leq C \|\mathring{A}\|_{L_g^p(\Sigma)}$$

with  $C = C(n, p, \text{osc}(f), \|\nabla f\|_\infty)$ .

**Proposition 2.2.** *For every  $0 < \varepsilon < \frac{1}{4}$  there exists  $0 < \delta = \delta(n, p, \varepsilon)$  with the following property. If  $\Sigma$  is a  $\delta$ -admissible, there exist  $c = c(\Sigma) \in \mathbb{R}^{n+1}$  such that  $\Sigma - c$  is radially parametrized and the mapping  $\psi$  defined by (2.1) satisfies the inequalities:*

$$(2.3) \quad \|f\|_\infty \leq \varepsilon$$

$$(2.4) \quad \|\nabla f\|_\infty \leq 2\sqrt{\varepsilon}$$

**Proposition 2.3.** *Let  $\Sigma$  be a  $\delta$ -admissible, radially parametrized hypersurface and let its parametrization  $\psi$  satisfy inequality (2.3), (2.4). Then the following estimate holds:*

$$(2.5) \quad \|f - (v_f, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p(\Sigma)} + \sqrt{\varepsilon} \|f\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

where we have set

$$v_f := \oint_{\mathbb{S}^n} (n+1) z f(z) dV_\sigma(z)$$

We show how propositions 2.1, 2.2 and 2.3 prove theorem 1.1.

*Proof of theorem 1.1.* Let  $0 < \varepsilon < \frac{1}{4}$  be fixed for the moment. At the end of the argument we will choose it small enough. Let  $\delta$  and  $\Sigma$  be given such that  $\psi$  satisfies inequalities 2.3, 2.4 and 2.5. We notice that for every  $c \in U$  we can define

$$(2.6) \quad \psi_c: \mathbb{S}^n \longrightarrow \Sigma - c, \quad \psi_c(x) := \rho_c(x) x := e^{f_c(x)} x$$

For every  $c$  the mapping  $\psi_c$  is an alternative radial parametrization for  $\Sigma$ , and it is a well defined diffeomorphism. We can also define:

$$(2.7) \quad \Phi: U \longrightarrow \mathbb{R}^{n+1}, \quad \Phi(c) := \int_{\mathbb{S}^n} (n+1) z f_c(z) dV_\sigma(z)$$

Our idea is to find  $c_0 \in U$  such that  $\Phi(c_0) = 0$ . Then we are done, because for such  $f_{c_0}$  we obtain the estimate

$$\|f_{c_0}\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\dot{A}\|_{L_g^p(\Sigma)} + \sqrt{\varepsilon} \|f_{c_0}\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

Therefore we can find  $\varepsilon_0 = \varepsilon_0(n, p)$  so that the last term can be absorbed:

$$\|f_{c_0}\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\dot{A}\|_{L_g^p(\Sigma)}$$

This estimate proves theorem 1.1 with  $c = c_0$ .

Let us find such  $c_0$ . By the hypothesis made we have that  $\psi := \psi_0$  satisfies the estimates (2.3), (2.4) and (2.5). We can easily find a radius  $r = r(\Sigma) > 0$  such that for every  $c \in \mathbb{D}_r$  we have that  $f_c$  still satisfies such estimates. Now we work with  $H$  inside the disk  $\mathbb{D}_r$ . We start with the following simple consideration: for every  $z \in \mathbb{S}^n$  there exists  $x_c = x_c(z)$  in  $\mathbb{S}^n$  so that

$$\psi_c(z) = \psi(x_c) - c$$

We expand this equality and find

$$\rho_c(z) z = \rho(x_c) x_c - c$$

We take the absolute value and obtain that  $\rho_c$  satisfies the equality:

$$\rho_c(z) = |\rho(x_c) x_c - c|$$

while  $x_c = x_c(z)$  satisfies the relation

$$(2.8) \quad x_c(z) = \frac{\rho_c(z) z + c}{\rho(x_c(z))}$$

Using the  $W^{1,\infty}$ -smallness, we approximate  $\rho$  and  $\rho_c$ , and find

$$(2.9) \quad x_c(z) = (z + c)(1 + O(\varepsilon))$$

We approximate  $f_c$ :

$$\begin{aligned} f_c(z) &= \frac{1}{2} \log \left| e^{f(x_c)} x_c - c \right|^2 = \frac{1}{2} \log \left( e^{2f(x_c)} - 2e^{f(x_c)}(x_c, c) + |c|^2 \right) \\ &= \frac{1}{2} \log \left( 1 + |c|^2 - 2(x_c(z), c) + O(\varepsilon) \right) \\ &= |c|^2 - 2(x_c(z), c) + o(|c|) + O(\varepsilon) = -2(z, c) + o(|c|) + O(\varepsilon) \end{aligned}$$

This allows us to write  $\Phi$  as follows:

$$\begin{aligned} \Phi(c) &= -(n+1) \int_{\mathbb{S}^n} (x_c(z), c) z dV_\sigma + o(|c|) + O(\varepsilon) \\ &= -(n+1) \int_{\mathbb{S}^n} ((z+c)(1+O(\varepsilon)), c) z dV_\sigma + o(|c|) + O(\varepsilon) \end{aligned}$$

$$= -(n+1)c + o(|c|) + O(\varepsilon)$$

Now we define  $\varphi := -\frac{1}{n+1}\Phi$ : we want to show that 0 is in the range of  $\varphi$ . We restrict  $\varphi$  to  $\mathbb{D}_r$  and finally we choose  $0 < \varepsilon < \frac{1}{4}$  and  $0 < r$  so small that

$$|\varphi(x) - x| < \frac{1}{2} \text{ for every } x \in \mathbb{D}_r$$

Let us argue by contradiction: suppose that  $0 \notin R(\varphi)$ , then we can consider  $\bar{\varphi} := \frac{\varphi}{|\cdot|} : \mathbb{S}^n \rightarrow \mathbb{S}^n$ , and notice that

$$(2.10) \quad |\bar{\varphi}(x) - x| < 2 \text{ for every } x \in \mathbb{S}^n$$

It is easy to see that if  $c_n \rightarrow c_0$  then  $f_{c_n} \rightarrow f_{c_0}$  pointwise and the family  $\{f_c\}_{c \in \mathbb{D}_r}$  is equibounded. This proves that  $\Phi$  and therefore also  $\varphi$  are continuous. However, estimate (2.10) tells us that  $\bar{\varphi}$  is homotopic to the identity; but at the same time, we obtain that  $\bar{\varphi}$  is the restriction of a continuous map defined on the ball, hence it cannot be homotopic to the identity.  $\square$

The rest of the article will be devoted to proving the three propositions.

### 3. PROOFS OF THE PROPOSITIONS

Before starting the proofs we need to report a computational lemma which shows the expression for the main geometric quantities of  $\Sigma$  in the radial parametrization  $\psi$ .

**Lemma 3.1.** *Let  $\psi$  be as in (2.1). Then we have the following expressions:*

$$(3.1) \quad g_{ij} = e^{2f}(\sigma_{ij} + \nabla_i f \nabla_j f)$$

$$(3.2) \quad g^{ij} = e^{-2f} \left( \sigma_{ij} - \frac{\nabla_i f \nabla_j f}{1 + |\nabla f|^2} \right)$$

$$(3.3) \quad \nu(x) = \frac{1}{\sqrt{1 + |\nabla f|^2}}(x - \text{grad}_\sigma f(x))$$

$$(3.4) \quad A_{ij} = \frac{e^f}{\sqrt{1 + |\nabla f|^2}} \left( \sigma_{ij} + \nabla_i f \nabla_j f - \nabla_{ij}^2 f \right)$$

$$(3.5) \quad A_j^i = \frac{e^{-f}}{\sqrt{1 + |\nabla f|^2}} \left( \delta_j^i - \nabla^i \nabla_j f + \frac{1}{1 + |\nabla f|^2} \nabla^i f \nabla^2 f [\nabla f]_j \right)$$

$$(3.6) \quad dV_g = e^{nf} \sqrt{1 + |\nabla f|^2} dV_\sigma$$

$$(3.7) \quad {}_g\Gamma_{ij}^k = \Gamma_{ij}^k + \frac{1}{1 + |\nabla f|^2} \nabla_{ij}^2 f \nabla^k f + \left( \nabla_i f \delta_j^k + \nabla_j f \delta_i^k - {}_g\nabla^k f g_{ij} \right)$$

The proof of the lemma is in the last section of the article.

**3.1. Proof of proposition 2.1.** Here we prove proposition 2.1. We show that the proposition follows by two lemmas.

**Lemma 3.2.** *Let  $\Sigma$  be a radially parametrized hypersurface and let us call  $H := \frac{1}{n} g^{ij} A_{ij}$ . We have the equality*

$$(3.8) \quad \nabla H = \frac{1}{n-1} \text{div}_\sigma \mathring{A} + \frac{n}{n-1} \mathring{A}[\nabla f]$$

**Lemma 3.3.** *Let  $p \in (1, \infty)$ ,  $\mathbf{u} \in C^\infty(\mathbb{S}^n)$ ,  $\mathbf{f} \in \Gamma(T^*\mathbb{S}^n \otimes T\mathbb{S}^n)$ ,  $\mathbf{h} \in \Gamma(T\mathbb{S}^n)$  be given so that the following equation holds:*

$$\nabla \mathbf{u} = \operatorname{div}_\sigma \mathbf{f} + \mathbf{f}[\mathbf{h}]$$

*There exists  $\lambda_0 \in \mathbb{R}$  such that the following estimate holds:*

$$(3.9) \quad \|\mathbf{u} - \lambda_0\|_{L_\sigma^p(\mathbb{S}^n)} \lesssim_{n,p} (1 + \|\mathbf{h}\|_\infty) \|\mathbf{f}\|_{L_\sigma^p(\mathbb{S}^n)}$$

We show now how lemmas 3.2 and 3.3 prove proposition 2.1.

*Proof of proposition 2.1.* We apply lemma 3.3 with  $\mathbf{u} = H$ ,  $\mathbf{h} = n\nabla f$  and  $\mathbf{f}_j^i = \frac{1}{n-1}g^{ik}\mathring{A}_{jk}$ . There exists  $\lambda_0 \in \mathbb{R}$  such that

$$\|H - \lambda_0\|_{L_\sigma^p(\mathbb{S}^n)} \lesssim_{n,p} (1 + \|\nabla f\|_\infty) \|\mathring{A}\|_{L_\sigma^p(\mathbb{S}^n)}$$

We use this result and make the straight estimate:

$$\begin{aligned} \|A - \lambda_0 g\|_{L_g^p} &\leq \|\mathring{A}\|_{L_g^p} + n\|H - \lambda_0\|_{L_g^p} \leq \|\mathring{A}\|_{L_g^p} + n \max_{\mathbb{S}^n} \left| \frac{dV_g}{dV_\sigma} \right|^{\frac{1}{p}} \|H - \lambda_0\|_{L_\sigma^p} \\ &\lesssim_{n,p} \|\mathring{A}\|_{L_g^p} + \max_{\mathbb{S}^n} \left| \frac{dV_g}{dV_\sigma} \right|^{\frac{1}{p}} (1 + \|\nabla f\|_\infty) \|\mathring{A}\|_{L_\sigma^p} \\ &\leq (1 + \|\nabla f\|_\infty) \max_{\mathbb{S}^n} \left| \frac{dV_g}{dV_\sigma} \right|^{\frac{1}{p}} \max_{\mathbb{S}^n} \left| \frac{dV_\sigma}{dV_g} \right|^{\frac{1}{p}} \|\mathring{A}\|_{L_g^p} \\ &\leq (1 + \|\nabla f\|_\infty)^{\frac{p+1}{p}} \exp\left(\frac{n}{p} \operatorname{osc}(f)\right) \|\mathring{A}\|_{L_g^p} \\ &= C \|\mathring{A}\|_{L_g^p(\mathbb{S}^n)} \end{aligned}$$

where the dependence of  $C$  is the following:

$$(3.10) \quad C(n, p, \operatorname{osc}(f), \nabla f) = C_{n,p} (1 + \|\nabla f\|_\infty)^{\frac{p+1}{p}} \exp\left(\frac{n}{p} \operatorname{osc}(f)\right)$$

This estimate completes the proof.  $\square$

Now we prove the two lemmas and complete this section.

*Proof of lemma 3.2.* We firstly recall the Codazzi equation for the second fundamental form (see [4] for a proof):

$$(3.11) \quad {}_g\nabla_k A_j^i = {}_g\nabla_j A_k^i$$

Equation (3.11) however holds for the Levi-Civita connection  ${}_g\nabla$  taken with respect to the metric  $g$ , while we need to find a formula for the  $\sigma$  connection  $\nabla$ . So we firstly expand  ${}_g\nabla A$ :

$${}_g\nabla_k A_j^i = D_k A_j^i + {}_g\Gamma_{kl}^i A_j^l - {}_g\Gamma_{kj}^l A_l^i$$

Now we plug this expression into (3.11), and use the expression (3.7) for the Christoffel symbols obtaining

$$\begin{aligned} \nabla_k A_j^i &= \nabla_j A_k^i + \frac{\nabla^i f}{1 + |\nabla f|^2} (\nabla_{jl}^2 f A_k^l - \nabla_{jk}^2 f A_l^i) + \\ &\quad + (\nabla_j f \delta_l^i + \nabla_l f \delta_j^i - {}_g\nabla^i f g_{jl}) A_k^l - (\nabla_k f \delta_l^i + \nabla_l f \delta_k^i - {}_g\nabla^i f g_{kl}) A_j^l \end{aligned}$$

We now notice that  $\nabla_{jl}^2 f A_k^l = \nabla_{kl}^2 f A_j^l$ . Expanding the term in fact we have

$$\begin{aligned} \nabla_{jl}^2 f A_k^l &= \frac{e^{-f} \nabla_{jl}^2 f}{1 + |\nabla f|^2} \left( \delta_k^l - \nabla^l \nabla_k f + \frac{1}{1 + |\nabla f|^2} \nabla^2 f [\nabla f]_j \nabla^l f \right) \\ &= \frac{e^{-f}}{1 + |\nabla f|^2} \left( \nabla_{jk}^2 f - (\nabla^2 f \nabla^2 f)_{jk} + \frac{\nabla^2 f [\nabla f]_j}{1 + |\nabla f|^2} \nabla^2 f [\nabla f]_k \right) \\ &= \frac{e^{-f}}{1 + |\nabla f|^2} \left( \nabla_{jk}^2 f - (\nabla^2 f \nabla^2 f)_{kj} + \frac{\nabla^2 f [\nabla f]_k}{1 + |\nabla f|^2} \nabla^2 f [\nabla f]_j \right) \\ &= \nabla_{kl}^2 f A_j^l \end{aligned}$$

This allows us to simplify the equation, obtaining

$$\nabla_k A_j^i = \nabla_j A_k^i + \left( \nabla_j f \delta_l^i + \nabla_l f \delta_j^i \right) A_k^l - \left( \nabla_k f \delta_l^i + \nabla_l f \delta_k^i \right) A_j^l$$

We track the indexes  $i$  and  $j$ :

$$\begin{aligned} \nabla_k A_j^i &= \nabla_i A_k^i + \left( \nabla_i f \delta_l^i + \nabla_l f \delta_i^i \right) A_k^l - \left( \nabla_k f \delta_l^i + \nabla_l f \delta_k^i \right) A_i^l \\ &= \nabla_i A_k^i + n A_k^l \nabla_l f - A_i^l \nabla_k f \end{aligned}$$

Finally we complete the proof. Indeed we write

$$A_j^i = \mathring{A}_j^i + \frac{1}{n} A_l^l \delta_j^i = \mathring{A}_j^i + H \delta_j^i$$

With this expression we obtain

$$(n-1) \nabla_k H = \nabla_i \mathring{A}_k^i + n \mathring{A}_k^l \nabla_l f$$

The thesis follows dividing by  $n-1$ .  $\square$

*Proof of lemma 3.3.* Using normal coordinates and the symmetries of the sphere, it is easy to show that for every  $0 < \varepsilon$  there exist  $0 < R = R(\varepsilon)$  such that for every  $x \in \mathbb{S}^n$  the following estimates hold in  $B_R^\sigma(x)$ :

$$(3.12) \quad \begin{cases} (1-\varepsilon) dV_\sigma \leq dx \leq (1+\varepsilon) dV_\sigma \\ |g_{ij} - \delta_{ij}| \leq \varepsilon^2 \\ |\Gamma_{ij}^k| \leq \varepsilon \\ |D_k g_{ij}| \leq \varepsilon \end{cases}$$

Using these coordinates we localize the expression for  $\mathbf{u}$ . In fact we write in local chart:

$$\begin{aligned} \operatorname{div}_\sigma \mathbf{f}_k &= g^{ij} \nabla_i \mathbf{f}_{jk} = g^{ij} \left( D_i \mathbf{f}_{jk} + \Gamma_{ij}^l \mathbf{f}_{lk} + \Gamma_{ik}^l \mathbf{f}_{jl} \right) \\ &= D_i \left( g^{ij} \mathbf{f}_{jk} \right) + g^{ij} \left( \Gamma_{ij}^l \mathbf{f}_{lk} + \Gamma_{ik}^l \mathbf{f}_{jl} \right) - D_i g^{ij} \mathbf{f}_{jk} \\ &=: \operatorname{div}_\delta \tilde{\mathbf{f}} + O_\varepsilon(\mathbf{f}) \end{aligned}$$

where we have denoted by  $\operatorname{div}_\delta$  the flat divergence  $\operatorname{div} X_j = D^i X_{ij}$ ,  $\tilde{\mathbf{f}}$  and by  $O_\varepsilon(\mathbf{f})$  a quantity which satisfies the estimate

$$|O(\mathbf{f})| \leq C(\mathbb{S}^n) \varepsilon |\mathbf{f}|$$

In summary we have obtained:

$$D\mathbf{u} = \operatorname{div}_\delta \tilde{\mathbf{f}} + \mathbf{f}[\mathbf{h}] + O_\varepsilon(\mathbf{f}) \text{ in } B_R^\sigma(x)$$

We notice that  $\tilde{\mathbf{f}}$  satisfies the estimate  $|\tilde{\mathbf{f}} - \mathbf{f}| \leq \varepsilon$ . Now we write  $\mathbf{u} = \mathbf{v} + \mathbf{w}$ , with  $\mathbf{v}$  and  $\mathbf{w}$  satisfying the conditions:

$$\begin{cases} \Delta_\delta \mathbf{v} = \operatorname{div}_\delta \operatorname{div}_\delta \tilde{\mathbf{f}} \\ \mathbf{v}|_{\partial B_R^\sigma(x)} = \mathbf{u}|_{\partial B_R^\sigma(x)} \end{cases}$$

and

$$\begin{cases} \Delta_\delta \mathbf{w} = \operatorname{div}(\mathbf{f}[h] + O_\varepsilon(\mathbf{f})) \\ \mathbf{w}|_{\partial B_R^\sigma(x)} = 0 \end{cases}$$

where  $\Delta_\delta$  is the flat laplacian. The first system is studied in [6] where the author proves the existence of a real number  $\lambda$  such that the following estimate holds:

$$\|\mathbf{v} - \lambda(x)\|_{L_\delta^p(B_{R/4}(x))} \lesssim_{n,p} \|\mathbf{f}\|_{L_\delta^p(B_R(x))}$$

The second system is well known. In [1] it is shown the inequality:

$$\|\mathbf{w}\|_{L_\delta^p(B_R(x))} \lesssim_{n,p} \|\mathbf{f}[h] + O_\varepsilon(\mathbf{f})\|_{L_\delta^p(B_R(x))} \lesssim (\|h\|_\infty + \varepsilon) \|\mathbf{f}\|_{L_\delta^p(B_R(x))}$$

We patch together the two estimates. Choosing  $\varepsilon$  sufficiently small, say  $\varepsilon = \frac{1}{2}$ , we find a radius  $R$  and a constant  $0 < C = C(n, p)$  such that for every  $x \in \mathbb{S}^n$  there exists  $\lambda(x) \in \mathbb{R}$  which satisfies the estimate:

$$(3.13) \quad \|\mathbf{u} - \lambda(x)\|_{L_\sigma^p(B_{R/4}^\sigma(x))} \leq C(1 + \|\nabla f\|_\infty) \|\mathbf{A}\|_{L_\sigma^p(B_R^\sigma(x))}$$

Now we have to make this estimate global. We follow a technique used in [6] and prove the following lemma.

**Lemma 3.4.** *Suppose  $\mathbf{u} \in C^\infty(\mathbb{S}^n)$  has the following property. There is a radius  $\rho$  such that for every  $x \in \mathbb{S}^n$  the local estimate is satisfied:*

$$(3.14) \quad \|\mathbf{u} - \lambda(x)\|_{L_\sigma^p(B_r(x))} \leq \beta$$

where  $\lambda(x)$  is a real number depending on  $x$ ,  $r \leq 2\rho$  and  $\beta$  does not depend on  $x$ . Then  $\mathbf{u}$  satisfies the global estimate:

$$\|\mathbf{u} - \lambda\|_{L_\sigma^p(\mathbb{S}^n)} \leq C\beta$$

where  $\lambda \in \mathbb{R}$  and  $C = C(n, p, \rho)$  is a positive constant.

*Proof.* We choose a finite covering of balls  $\{(B_j, \lambda_j)\}_{j=1}^N$  which satisfies the following properties. Every ball  $B_j$  has radius  $2\rho$ , estimate (3.14) holds with  $\lambda_j$ , and for every  $j, k$  there exists a ball of radius  $\rho$  contained in  $B_j \cap B_k$ . Therefore, given two balls  $B_j$  and  $B_k$  whose intersection is non empty, we have:

$$\begin{aligned} |\lambda_j - \lambda_k| &= \frac{1}{\operatorname{Vol}_n(B_j \cap B_k)^{\frac{1}{p}}} \|\lambda_j - \lambda_k\|_{L_\sigma^p(B_j \cap B_k)} \\ &= \frac{1}{\operatorname{Vol}_n(B_j \cap B_k)^{\frac{1}{p}}} \|\lambda_j - \mathbf{u} + \mathbf{u} - \lambda_k\|_{L_\sigma^p(B_j \cap B_k)} \\ &\leq \frac{1}{\operatorname{Vol}_n(B_j \cap B_k)^{\frac{1}{p}}} \left( \|\mathbf{u} - \lambda_k\|_{L_\sigma^p(B_j \cap B_k)} + \|\mathbf{u} - \lambda_j\|_{L_\sigma^p(B_j \cap B_k)} \right) \\ &\leq \frac{2\beta}{\operatorname{Vol}_n(B_j \cap B_k)^{\frac{1}{p}}} \end{aligned}$$



Using the properties of the covering we obtain

$$|\lambda_j - \lambda_k| \leq 2 \operatorname{Vol}_n(B_\rho)^{-\frac{1}{p}} \beta$$

The volume of the ball  $B_\rho$  does not depend on the center because of the symmetry of the sphere. Define  $\lambda_{\min} := \min_{1 \leq j \leq n} \lambda_j$  and  $\lambda_{\max} := \max_{1 \leq j \leq n} \lambda_j$ . Consider a path joining the ball in the cover with  $\lambda_{\min}$  to the one with  $\lambda_{\max}$ . Since this path can cross at most  $N$  different balls, we obtain

$$|\lambda_{\max} - \lambda_{\min}| \leq 2N \operatorname{Vol}_n(B_\rho)^{-\frac{1}{p}} \beta = C(n, p, \rho) \beta$$

For every  $\lambda_{\min} \leq \lambda \leq \lambda_{\max}$  we have

$$\begin{aligned} \|\mathbf{u} - \lambda\|_{L_\sigma^p(\mathbb{S}^n)} &\leq \sum_{j=1}^N \|\mathbf{u} - \lambda\|_{L_\sigma^p(B_j)} \\ &\leq \sum_{j=1}^N \|\mathbf{u} - \lambda_j + \lambda_j - \lambda\|_{L_\sigma^p(B_j)} \\ &\leq \sum_{j=1}^N \|\mathbf{u} - \lambda_j\|_{L_\sigma^p(B_j)} + |\lambda_j - \lambda| \operatorname{Vol}_n(B_j)^{-\frac{1}{p}} \\ &\leq \sum_{j=1}^N \|\mathbf{u} - \lambda_j\|_{L_\sigma^p(B_j)} + |\lambda_{\max} - \lambda_{\min}| \operatorname{Vol}_n(B_j)^{-\frac{1}{p}} \\ &\leq C_2(n, p, \rho) \beta \end{aligned}$$

and the lemma follows.  $\square$

We apply this lemma with  $\beta = \|\mathring{A}\|_{L_\sigma^p}$  and find the thesis.  $\square$

**3.2. Proof of proposition 2.2.** We prove here proposition 2.2. We start with the  $L^\infty$ -bound.

**3.2.1. Bound for  $f$ .** Before starting the proof we recall the a proposition proved in [6] which shows how the smallness of  $\|\mathring{A}\|_p$  implies the nearness of  $\Sigma$  to a sphere.<sup>1</sup>:

**Proposition 3.5.** *Let  $n \geq 2$ ,  $p \in (1, +\infty)$  be given, and let  $\Sigma^n \subset \mathbb{R}^{n+1}$  be a  $n$ -dimensional, closed hypersurface with induced Riemannian metric  $g$ , satisfying*

- $\Sigma = \partial U$  where  $U$  is an open, convex set.
- $\operatorname{Vol}_n(\Sigma) = \operatorname{Vol}_n(\mathbb{S}^n)$

*For every  $\varepsilon > 0$  there exist  $\delta > 0$  depending on  $n, p, \varepsilon$ , such that*

$$(3.15) \quad \|\mathring{A}\|_{L_g^p(\Sigma)} \leq \delta \Rightarrow d_{\text{HD}}(\Sigma, \mathbb{S}^n(c)) \leq \varepsilon \text{ for some } c \in U$$

*where  $d_{\text{HD}}$  is the Hausdorff distance between two sets, that is*

$$d_{\text{HD}}(A, B) := \max \left\{ \sup_{x \in A} d(x, B), \sup_{y \in B} d(y, A) \right\}$$

Using 3.5 we immediately deduce our  $L^\infty$ -nearness.

---

<sup>1</sup>Actually, the statement in [6] is different. However, as the author points out in ([6], p.22), it is easy to see that assuming  $\Sigma$  to be the boundary of a convex set leads to this formulation.

*Proof.* We assume  $c = 0$  without loss of generality. By proposition 3.5, for every  $\varepsilon > 0$  there exists  $\delta = \delta(n, p, \varepsilon) > 0$  such that

$$\|\mathring{A}\|_{L_g^p(\Sigma)} \leq \delta \Rightarrow d_{\text{HD}}(\Sigma, \mathbb{S}^n) \leq \varepsilon$$

Let us assume  $\|\mathring{A}\|_p \leq \delta$ : this immediately implies

$$(3.16) \quad |\rho(x) - 1| = |\rho(x)x - x| \leq d_{\text{HD}}(\mathbb{S}^n, \Sigma) \leq \varepsilon$$

By equation (3.16) we obtain

$$\left| f(x) \int_0^1 \rho(x)^t dt \right| \leq \varepsilon$$

Now using the estimate on  $\rho$  we have

$$\left| f(x) \int_0^1 (1 - \varepsilon)^t dt \right| \leq \varepsilon$$

and solving the integral

$$|f(x)| \leq |\log(1 - \varepsilon)| \leq \varepsilon$$

which is the thesis.  $\square$

### 3.2.2. Bound for $\nabla f$ .

*Proof.* This bound actually does not depend on any other assumptions on  $\Sigma$  except than the oscillation of  $f$ . In fact, it follows immediately by the following lemma:

**Lemma 3.6.** *Let  $\Sigma$  be a convex, radially parametrized hypersurface in  $\mathbb{R}^{n+1}$ . The following inequality holds:*

$$\|\nabla f\|_\infty^2 \leq 2 \operatorname{osc}(f) (1 + \|\nabla f\|_\infty^2)$$

In particular if  $\operatorname{osc}(f) < \frac{1}{2}$  we find the estimate:

$$(3.17) \quad \|\nabla f\|_\infty \leq \sqrt{\frac{\operatorname{osc}(f)}{1 - 2 \operatorname{osc}(f)}}$$

*Proof.* In [4] it is shown that a hypersurface is the boundary of a convex, open set iff its second fundamental form satisfies the inequality  $A \geq 0$ . By lemma 3.1 we obtain that  $\Sigma$  is convex iff  $f$  satisfies the inequality

$$(3.18) \quad \nabla^2 f \leq \sigma + \nabla f \otimes \nabla f$$

Consider a point  $x_0 \in \mathbb{S}^n$ , and an unit vector  $\xi$  in  $T_{x_0}\mathbb{S}^n$  which satisfies  $(\nabla f(x_0), \xi) = -\|\nabla f\|_\infty$ . Setting  $x_\tau = \exp_{x_0}(\tau\xi)$  the lemma follows by the simple equality

$$f(x_\tau) - f(x_0) = (\nabla f(x_0), \tau\xi) + \int_0^1 t \int_0^1 \nabla^2 f(\gamma(st))[\dot{\gamma}(st), \dot{\gamma}(st)] ds dt$$

where  $\gamma: [0, 1] \rightarrow \mathbb{S}^n$  is the geodesic which connects  $x_0$  and  $x_\tau$ . Applying (3.18) we find

$$f(x_\tau) - f(x_0) \leq (\nabla f(x_0), \tau\xi) + \frac{\tau^2}{2} (1 + \|\nabla f\|_\infty^2)$$

$$= -\tau \|\nabla f\|_\infty + \frac{\tau^2}{2} (1 + \|\nabla f\|_\infty^2)$$

Finally we obtain the inequality

$$\|\nabla f\|_\infty \leq \frac{\text{osc}(f)}{\tau} + \frac{\tau}{2} (1 + \|\nabla f\|_\infty^2) \text{ for every } \tau > 0$$

Choosing  $\tau = \sqrt{2 \text{osc}(f) (1 + \|\nabla f\|_\infty)}$  we obtain the result.  $\square$

Now that we have proven this result, we notice that for  $0 < \varepsilon < \frac{1}{4}$  we find our thesis.  $\square$

**3.3. Proof of proposition 2.3.** We deal with proposition 2.3. The idea of the proof is to see proposition 2.1 as a nonlinear version of an elliptic estimate and then linearise it. For simplicity, we have split the proof in two parts.

**3.3.1. Linearisation.** In this section we prove the following proposition.

**Proposition 3.7.** *Let  $0 < \varepsilon < \frac{1}{4}$  be given, and let  $\delta$  be as in proposition 2.2. If  $\Sigma$  is a  $\delta$ -admissible, radially parametrized sphere, then the following estimate is true:*

$$(3.19) \quad \|\Delta f + n f\|_{L_g^p} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p} + \sqrt{\varepsilon} \|f\|_{W_\sigma^{2,p}}$$

*Proof.* We need the following corollary of theorem 2.1, which will be proved in the last section of this article.

**Corollary 3.8.** *The following inequality holds:*

$$\|A - \overline{H} g\|_{L_g^p(\Sigma)} \leq (n+1) \min_{\lambda \in \mathbb{R}} \|A - \lambda g\|_{L_g^p(\Sigma)}$$

where  $\overline{H}$  is the average of  $H$

$$\overline{H} := \int_{\mathbb{S}^n} H dV_g$$

This result give us the following estimate:

$$\|A - \overline{H} g\|_{L_g^p(\Sigma)} \leq C \|\mathring{A}\|_{L_g^p(\Sigma)}$$

where  $C$  is given by (3.10). We notice that *a priori*  $C$  depends on  $n, p, \text{osc}(f)$  and  $\|\nabla f\|$ , but thanks to proposition 2.2 we can remove the dependences on  $\text{osc}(f)$  and  $\|\nabla f\|$  by using the  $W^{1,\infty}$ -smallness. Therefore we can write:

$$(3.20) \quad \|A - \overline{H} g\|_{L_g^p(\Sigma)} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p(\Sigma)}$$

Let  $0 < \varepsilon < \frac{1}{4}$  and  $\delta$  be chosen so by proposition 2.2 inequalities (2.3), (2.4) are true. We will show how these two inequalities lead to the conclusion. Before entering in the details, we need to fix a notation: we will write  $O_{\varepsilon^\gamma}(\|f\|_{k,p})$  to denote a quantity which satisfies the estimate:

$$\|O_{\varepsilon^\gamma}(\|f\|_{k,p})\|_{k,p} \lesssim_{n,p} \varepsilon^\gamma \|f\|_{k,p}$$

Now we can start the proof. From (3.20) we obtain

$$\|A - g\|_{L_g^p} \lesssim_{n,p} \|\mathring{A}\|_{L_g^p} + |\overline{H} - 1|$$

We simplify the left hand side. We recall formula (3.4):

$$A_{ij} = \frac{e^f}{\sqrt{1 + |\nabla f|^2}} (\sigma_{ij} + \nabla_i f \nabla_j f - \nabla_{ij}^2 f)$$

This formula can be strongly simplified using the  $W^{1,\infty}$ -smallness of  $f$ . Indeed, we have

$$\frac{1}{\sqrt{1 + |\nabla f|^2}} - 1 = \int_0^1 \frac{d}{dt} \frac{1}{\sqrt{1 + t^2 |\nabla f|^2}} dt = O_{\sqrt{\varepsilon}}(\|\nabla f\|_p)$$

Therefore we obtain

$$\begin{aligned} A_{ij} &= e^f (\sigma_{ij} + \nabla_i f \nabla_j f - \nabla_{ij}^2 f) + O_{\sqrt{\varepsilon}}(\|\nabla f\|_{1,p}) \\ &= e^f (\sigma_{ij} - \nabla_{ij}^2 f) + O_{\sqrt{\varepsilon}}(\|\nabla f\|_{1,p}) \end{aligned}$$

We use the same idea for simplifying the exponential: by standard calculus, we find

$$e^f = 1 + f + O_{\varepsilon}(\|f\|_p)$$

These simplifications give us the approximated second fundamental form:

$$(3.21) \quad A_{ij} = \sigma_{ij} - \nabla_{ij}^2 f + f \sigma_{ij} + O_{\sqrt{\varepsilon}}(\|f\|_{2,p})$$

With the same ideas we find also the approximated metric

$$(3.22) \quad g_{ij} = (1 + 2f + O_{\sqrt{\varepsilon}}(\|f\|_{1,p})) \sigma_{ij}$$

and its inverse

$$(3.23) \quad g^{ij} = (1 - 2f + O_{\sqrt{\varepsilon}}(\|f\|_{1,p})) \sigma^{ij}$$

Via formulas (3.21) and (3.22) we find the approximated equation:

$$A - g = -f \sigma - \nabla^2 f + O_{\sqrt{\varepsilon}}(\|f\|_{2,p})$$

We prove that the term  $|\overline{H} - 1|$  is negligible. Firstly we show how formulas (3.23) and (3.21) give us approximated expression for the mean curvature.

$$\begin{aligned} g^{ij} A_{ij} &= (1 - 2f + O_{\sqrt{\varepsilon}}(\|f\|_{1,p})) \sigma^{ij} (\sigma_{ij} - \nabla_{ij}^2 f + f \sigma_{ij} + O_{\sqrt{\varepsilon}}(\|f\|_{2,p})) \\ &= n - n f - \Delta f + O_{\sqrt{\varepsilon}}(\|f\|_{2,p}) \end{aligned}$$

We obtain the approximated mean curvature:

$$(3.24) \quad H = 1 - f - \frac{1}{n} \Delta f + O_{\sqrt{\varepsilon}}(\|f\|_{2,p})$$

Now we approximated  $\overline{H}$ :

$$\begin{aligned} \overline{H} &= \int_{\mathbb{S}^n} H dV_g = \int_{\mathbb{S}^n} \left( 1 - f - \frac{1}{n} \Delta f + O_{\sqrt{\varepsilon}}(\|f\|_{2,p}) \right) e^{nf} \sqrt{1 + |\nabla f|^2} dV_{\sigma} \\ &= \int_{\mathbb{S}^n} e^{nf} (1 - f) dV_{\sigma} + O_{\sqrt{\varepsilon}}(\|f\|_{2,p}) \\ &= 1 - (n - 1) \int_{\mathbb{S}^n} f dV_{\sigma} + O_{\sqrt{\varepsilon}}(\|f\|_{2,p}) \end{aligned}$$

We have found the approximated average of the mean curvature:

$$(3.25) \quad \overline{H} = 1 - (n - 1) \int_{\mathbb{S}^n} f dV_{\sigma} + O_{\sqrt{\varepsilon}}(\|f\|_{2,p})$$

We show that the average of  $f$  is actually negligible. Indeed, since  $\Sigma$  is  $\delta$ -admissible it satisfies the volume condition

$$\text{Vol}_n(\Sigma) = \text{Vol}_n(\mathbb{S}^n)$$

However, by the volume formula 3.6 the condition means

$$\oint_{\mathbb{S}^n} e^{nf} \sqrt{1 + |\nabla f|^2} dV_\sigma = 1$$

With the previous approximations, we find

$$0 = \oint_{\mathbb{S}^n} e^{nf} \sqrt{1 + |\nabla f|^2} dV_\sigma - 1 = n \oint_{\mathbb{S}^n} f dV_\sigma + O_{\sqrt{\varepsilon}}(\|f\|_{1,p})$$

This means

$$\oint_{\mathbb{S}^n} f dV_\sigma = O_{\sqrt{\varepsilon}}(\|f\|_{1,p})$$

Finally we infer

$$(3.26) \quad |\overline{H} - 1| = O_{\sqrt{\varepsilon}}(\|f\|_{2,p})$$

Using formulas (3.21), (3.25), (3.26) we obtain the approximated version of inequality of (3.20):

$$(3.27) \quad \|\nabla^2 f + f\sigma\|_{L_\sigma^p(\mathbb{S}^n)} \lesssim_{n,p} \|\dot{A}\|_{L_\sigma^p(\Sigma)} + \sqrt{\varepsilon}\|f\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

We obtain the thesis by simply applying the Cauchy-Schwartz inequality:

$$|\Delta f + nf| = |(\nabla^2 f + f\sigma, \sigma)| \leq n|\nabla^2 f + f\sigma|$$

□

**3.3.2. Conclusion.** We prove the following proposition.

**Proposition 3.9.** *Let  $f \in C^\infty(\mathbb{S}^n)$ . Then, the following estimate holds:*

$$(3.28) \quad \|f - (v_f, \cdot)\|_{W^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|\Delta f + nf\|_{L^p(\mathbb{S}^n)}$$

*Proof.* Proposition 3.9 completes the theorem. Firstly we recall the main ingredient of this part, the Obata theorem (see [5]):

**Theorem 3.10.** *Let  $(M, g)$  be a closed manifold which satisfies the following condition on the Ricci tensor Ric:*

$$(3.29) \quad \text{Ric}(X, X) \geq (n-1)g(X, X) \text{ for every vector field } X$$

*and the Laplacian condition:*

$$(3.30) \quad -\Delta_g f = nf \text{ for some } f$$

*Then  $M$  is isometric to the round sphere  $(\mathbb{S}^n, \sigma)$  and we also have*

$$(3.31) \quad \ker -\Delta_\sigma - n = \{\varphi_v \mid \varphi_v(x) = (v, x), v \in \mathbb{R}^{n+1}\}$$

Obata's result give us the equality

$$\|\Delta + nf\|_{L_\sigma^p(\mathbb{S}^n)} = \inf_{v \in \mathbb{R}^{n+1}} \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

What remains is to prove the following estimate:

$$(3.32) \quad \|f - (v_f, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \inf_{v \in \mathbb{R}^{n+1}} \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

In order to achieve this result, we define the alternative Sobolev norm

$$(3.33) \quad \|f\|_{W_\sigma^{2,p}(\mathbb{S}^n)}^p := \|f\|_{L_\sigma^p(\mathbb{S}^n)}^p + \|\nabla^2 f\|_{L_\sigma^p(\mathbb{S}^n)}^p$$

The alternative Sobolev norm is equivalent to the standard Sobolev norm. Moreover, the equivalence constants depend only on the geometry of the sphere, hence on  $n$  and  $p$ . Due to the equivalence of the two norms, we have

$$\inf_{v \in \mathbb{R}^{n+1}} \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \inf_{v \in \mathbb{R}^{n+1}} \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

therefore, we can work with the alternative Sobolev norm without loss of generality. We notice that for any  $v$  we have the following inequality:

$$\|f - (v_f, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \leq \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} + \|(v_f - v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)}$$

We notice that if  $v$  has unit norm, then

$$\|(v, \cdot)\|_{2,p}^p = (n+1) \|(v, \cdot)\|_{2,p} = (n+1) \|(e_1, \cdot)\|_{2,p} = c_{n,p}$$

and this gives us the estimate

$$(3.34) \quad \|f - (v_f, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} \|f - (v, \cdot)\|_{W_\sigma^{2,p}(\mathbb{S}^n)} + |v_f - v| \text{ for any } v$$

What remains is to study  $|v_f - v_m|$ , where  $v_m$  is the minimum of the function  $v \mapsto \|f - (v, \cdot)\|_{2,p}$ . Given any  $v$ , we have

$$\begin{aligned} |v_{f,i} - v_i| &= \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - v_i \right| \\ &= \frac{1}{\text{Vol}_n(\mathbb{S}^n)} \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - \text{Vol}_n(\mathbb{S}^n) v_i \right| \\ &= \frac{1}{\text{Vol}_n(\mathbb{S}^n)} \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - (n+1) \left( \int_{\mathbb{S}^n} |x_i|^2 dV_\sigma \right) v_i \right| \\ &= \frac{1}{\text{Vol}_n(\mathbb{S}^n)} \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - (n+1) \int_{\mathbb{S}^n} (v, x) x_i dV_\sigma \right| \\ &= \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - (n+1) \int_{\mathbb{S}^n} (v, x) x_i dV_\sigma \right| \end{aligned}$$

where we have used the simple equality

$$\int_{\mathbb{S}^n} |x_i|^2 dV_\sigma = \frac{\text{Vol}_n(\mathbb{S}^n)}{n+1} \text{ for every } i = 1 \dots n+1$$

Recalling that for every  $v \in \mathbb{R}^{n+1}$  we have  $\Delta(v, \cdot) + n(v, \cdot) = 0$ , we find

$$\begin{aligned} |v_{f,i} - v_i| &= \left| (n+1) \int_{\mathbb{S}^n} x_i f dV_\sigma - (n+1) \int_{\mathbb{S}^n} (v, x) x_i dV_\sigma \right| \\ &= \left| (n+1) \int_{\mathbb{S}^n} x_i (f - (v, \cdot)) dV_\sigma \right| \\ &= \left| \int_{\mathbb{S}^n} x_i (f - (v, \cdot)) dV_\sigma - \int_{\mathbb{S}^n} \Delta x_i (f - (v, \cdot)) dV_\sigma \right| \\ &= \left| \int_{\mathbb{S}^n} x_i (f - (v, \cdot)) dV_\sigma - \int_{\mathbb{S}^n} x_i \Delta (f - (v, \cdot)) dV_\sigma \right| \\ &\leq \int_{\mathbb{S}^n} |f - (v, \cdot)| dV_\sigma + \int_{\mathbb{S}^n} |\Delta (f - (v, \cdot))| dV_\sigma \\ &\lesssim_{n,p} \|f - (v, \cdot)\|_p + \|\Delta (f - (v, \cdot))\|_p \end{aligned}$$

$$\leq \|f - (v, \cdot)\|_p + \|\nabla^2(f - (v, \cdot))\|_p = |f - (v, \cdot)|_{2,p}$$

This estimate works for every  $v$ , hence we find

$$|v_f - v_m|_{2,p} \lesssim_{n,p} |f - (v_m, \cdot)|_{2,p}$$

We can improve (3.34), obtaining

$$\begin{aligned} |f - (v_f, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} &\leq |f - (v_m, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} + |(v_f - v_m, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \\ &\lesssim_{n,p} |f - (v_m, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} + |v_f - v_m| \\ &\lesssim_{n,p} |f - (v_m, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \\ &= \min_{v \in \mathbb{R}^{n+1}} |f - (v, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \\ &\lesssim_{n,p} \min_{v \in \mathbb{R}^{n+1}} \|f - (v, \cdot)\|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \end{aligned}$$

Now we recall that the two Sobolev norms are equivalent, so we obtain

$$\|f - (v_f, \cdot)\|_{W_{\sigma}^{2,p}(\mathbb{S}^n)} \lesssim_{n,p} |f - (v_f, \cdot)|_{W_{\sigma}^{2,p}(\mathbb{S}^n)}$$

and the thesis follows.  $\square$

**3.4. Proof of the computational lemmas.** We end the article reporting the proof of lemmas 3.1 and 3.8.

*Proof of lemma 3.1.* Firstly, we compute the differential of  $\psi$ :

$$(3.35) \quad d\psi|_x : T_x \mathbb{S}^n \longrightarrow T_{\psi(x)} \Sigma, \quad d\psi|_x [z] = e^{f(x)}(z + \nabla_z f x)$$

In order to compute the expression for  $g$  in  $\mathbb{S}^n$ , we fix  $x$  in  $\mathbb{S}^n$  and use the usual polar coordinates  $\{\frac{\partial}{\partial \vartheta^1} \dots \frac{\partial}{\partial \vartheta^n}\}$  for the sphere. We find

$$\begin{aligned} g &= g_{ij} d\vartheta^i d\vartheta^j = \psi^* \delta|_{\Sigma} \left( \frac{\partial}{\partial \vartheta^i}, \frac{\partial}{\partial \vartheta^j} \right) d\vartheta^i d\vartheta^j \\ &= e^{2f} \left( \frac{\partial}{\partial \vartheta^i} + \nabla_i f x, \frac{\partial}{\partial \vartheta^j} + \nabla_j f x \right) d\vartheta^i d\vartheta^j \\ &= e^{2f} (\sigma_{ij} + \nabla_i f \nabla_j f) d\vartheta^i d\vartheta^j \end{aligned}$$

The expression for  $g^{-1}$  follows by direct computation.

Now we compute the normal  $\nu = \nu_{\Sigma}$ . Fix  $x \in \mathbb{S}^n$  and consider the system  $\{\frac{\partial}{\partial \vartheta^1} \dots \frac{\partial}{\partial \vartheta^n}, x\}$  which is orthogonal in  $\mathbb{R}^{n+1}$ . By the definition of  $\nu$  we have the relation  $(\nu(x), d\psi|_x[z]) = 0$  for every  $z \in \langle x \rangle^{\perp}$ . Now we write  $\nu = \nu^j \frac{\partial}{\partial \vartheta^j} + \nu^x x$  and obtain

$$\left| \frac{\partial}{\partial \vartheta^j} \right|^2 \nu_j + \nabla_j f \nu^x = 0 \text{ for every } j$$

Normalizing we have

$$\nu(x) = \frac{1}{\sqrt{1 + |\nabla f|^2}} (x - \text{grad}_{\sigma} f(x))$$

which is exactly (3.3).

The expression for  $A$  is more complex to compute. Firstly, we easily compute the differential of  $\nu$ :

$$d\nu \left[ \frac{\partial}{\partial \vartheta^j} \right] = \nabla_j \left( \frac{1}{\sqrt{1 + |\nabla f|^2}} \right) (x - \nabla f(x)) +$$

$$+ \frac{1}{\sqrt{1+|\nabla f|^2}} \left( \frac{\partial}{\partial \vartheta^j} - \nabla_j(\nabla f) \right)$$

and now we can make our computation

$$\begin{aligned} A_{ij} &:= \left( d\psi \left[ \frac{\partial}{\partial \vartheta^i} \right], d\nu \left[ \frac{\partial}{\partial \vartheta^j} \right] \right) = \\ &= \frac{e^f}{\sqrt{1+|\nabla f|^2}} \left( \frac{\partial}{\partial \vartheta^i} + \nabla_i f, \frac{\partial}{\partial \vartheta^j} - \nabla_j \nabla f \right) \\ &= \frac{e^f}{\sqrt{1+|\nabla f|^2}} \left( \sigma_{ij} - \nabla_i f (\nabla_j \nabla f, \underbrace{x}_{\nu_{\mathbb{S}^n}}) - \left( \nabla_j \nabla f, \frac{\partial}{\partial \vartheta^i} \right) \right) \end{aligned}$$

We compute  $\nabla_j \nabla f$  in the orthogonal system  $\{ \frac{\partial}{\partial \vartheta^1} \dots \frac{\partial}{\partial \vartheta^n} \}$ .

$$\begin{aligned} (\nabla_j \nabla f, x) &= \nabla_j \underbrace{(\nabla f, x)}_{=0} - (\nabla f, \nabla_j \nu_{\mathbb{S}^n}) = -A_{\mathbb{S}^n} \left( \nabla f, \frac{\partial}{\partial \vartheta^j} \right) = -\nabla_j f \\ \left( \nabla_j \nabla f, \frac{\partial}{\partial \vartheta^i} \right) &= \nabla_j \underbrace{\left( \nabla f, \frac{\partial}{\partial \vartheta^i} \right)}_{=\partial_i f} - \left( \nabla f, \nabla_i \frac{\partial}{\partial \vartheta^j} \right) = \partial_{ij}^2 f - \Gamma_{ij}^k \partial_k f = \nabla_{ij}^2 f \end{aligned}$$

We finally write

$$A_{ij} = \frac{e^f}{\sqrt{1+|\nabla f|^2}} (\sigma_{ij} + \nabla_i f \nabla_j f - \nabla_{ij}^2 f)$$

which is exactly (3.4), and we are done. Equality (3.5) follows by a direct computation by writing  $A_j^i = g^{li} A_{lj}$  and we do not report it.

Formula (3.6) follows from the area formula (see [2]):

$$\int_{\Sigma} h(y) dV_g(y) = \int_{\mathbb{S}^n} h(\psi(x)) J_{d\psi}(x) dV_{\sigma} \text{ for any } h \in C(\Sigma)$$

with

$$J_{d\psi}(x)^2 = \det d^* \psi|_x \circ d\psi|_x$$

where  $d^* \psi$  is the adjoint differential, whose representative matrix is simply the transpose of the  $d\psi$  representative matrix. Taking  $\{ \frac{\partial}{\partial \vartheta^1} \dots \frac{\partial}{\partial \vartheta^n}, x \}$  as frame for  $\mathbb{R}^{n+1}$  we easily find the expression

$$\det d^* \psi|_x \circ d\psi|_x = e^{2nf} (1 + |\nabla f|^2)$$

and the result follows simply by taking the square root.

Lastly we deal with the Christoffel symbols. We recall the formula

$${}_g \Gamma_{ij}^k = \frac{1}{2} g^{ks} (\partial_i g_{js} + \partial_j g_{is} - \partial_s g_{ij})$$

and now we expand it:

$$\begin{aligned} {}_g \Gamma_{ij}^k &= \frac{1}{2} \left( \sigma^{ks} - \frac{\nabla^k f \nabla^s f}{1+|\nabla f|^2} \right) (\partial_i \sigma_{js} + \partial_j \sigma_{is} - \partial_s \sigma_{ij}) + \\ &+ \frac{1}{2} \left( \sigma^{ks} - \frac{\nabla^k f \nabla^s f}{1+|\nabla f|^2} \right) (\partial_i (\partial_j f \partial_s f) + \partial_j (\partial_i f \partial_s f) - \partial_s (\partial_i f \partial_j f)) + \\ &+ \frac{1}{2} g^{ks} (\nabla_i f g_{js} + \nabla_j f g_{is} - \nabla_s f g_{ij}) \end{aligned}$$



$$\begin{aligned}
&= \frac{1}{2} \left( \sigma^{ks} - \frac{\nabla^k f \nabla^s f}{1 + |\nabla f|^2} \right) (\partial_i \sigma_{js} + \partial_j \sigma_{is} - \partial_s \sigma_{ij} + 2 \partial_{ij}^2 f \partial_s f) + \\
&+ \frac{1}{2} (\nabla_i f \delta_j^k + \nabla_j f \delta_i^k - g \nabla_k f g_{ij}) \\
&= \Gamma_{ij}^k + \partial_{ij}^2 f \partial^k f - \frac{|\nabla f|^2}{1 + |\nabla f|^2} \partial_{ij}^2 f \partial^k f + \\
&- \frac{1}{1 + |\nabla f|^2} \partial^k f \partial_s f \frac{\sigma^{ls}}{2} (\partial_i \sigma_{js} + \partial_j \sigma_{is} - \partial_s \sigma_{ij}) + \\
&+ \frac{1}{2} (\nabla_i f \delta_j^k + \nabla_j f \delta_i^k - g \nabla_k f g_{ij}) \\
&= \Gamma_{ij}^k + \frac{1}{1 + |\nabla f|^2} (\partial_{ij}^2 f - \partial_s f \Gamma_{ij}^s) \partial^k f + \\
&+ \frac{1}{2} (\nabla_i f \delta_j^k + \nabla_j f \delta_i^k - g \nabla_k f g_{ij}) \\
&= \Gamma_{ij}^k + \frac{1}{1 + |\nabla f|^2} \nabla_{ij}^2 f \nabla^k f + \frac{1}{2} (\nabla_i f \delta_j^k + \nabla_j f \delta_i^k - g \nabla_k f g_{ij})
\end{aligned}$$

□

Lastly, we prove corollary 3.8.

*Proof of corollary 3.8.* Let  $\lambda_0 \in \mathbb{R}$  such that

$$\|A - \lambda_0 g\|_p = \min_{\lambda \in \mathbb{R}} \|A - \lambda g\|$$

We simply write

$$\begin{aligned}
\|A - \overline{H} g\|_p &= \|(A - \lambda_0 g) + (\lambda_0 - \overline{H}) g\|_p \\
&\leq \|A - \lambda_0 g\|_p + n \operatorname{Vol}_n(\mathbb{S}^n)^{\frac{1}{p}} |\overline{H} - \lambda_0|
\end{aligned}$$

The thesis follows estimating the last term.

$$\begin{aligned}
|\overline{H} - \lambda_0| &= \left| \int_{\mathbb{S}^n} \frac{1}{n} \operatorname{tr}_g A dV_g - \lambda_0 \right| = \frac{1}{n} \left| \int g^{ij} (A_{ij} - \lambda_0 g_{ij}) dV_g \right| \\
&= \frac{1}{n \operatorname{Vol}_n(\mathbb{S}^n)} \left| \int (g, A - \lambda_0 g) dV_g \right| \leq \frac{1}{n \operatorname{Vol}_n(\mathbb{S}^n)} \|g\|_{p'} \|A - \lambda_0 g\|_p \\
&= \operatorname{Vol}_n(\mathbb{S}^n)^{-\frac{1}{p}} \|A - \lambda_0 g\|_p
\end{aligned}$$

We have obtained

$$\|A - \overline{H} g\|_p \leq (n + 1) \min_{\lambda \in \mathbb{R}} \|A - \lambda g\|_p$$

which is exactly the thesis. □
