# Hadronic decay properties of newly observed $\Omega_{c}$ baryons

#### Abstract

Hadronic decay widths of the newly observed charmed strange baryons, $\Omega_{c}(3000)^{0}, \Omega_{c}(3050)^{0}$, $\Omega_{c}(3066)^{0}, \Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$ have been calculated in a ${ }^{3} P_{0}$ model. Our results indicate that $\Omega_{c}(3066)^{0}$ and $\Omega_{c}(3090)^{0}$ can be interpreted as the $1 P$-wave $\Omega_{c 2}\left(\frac{3}{2}^{-}\right)$or $\Omega_{c 2}\left(\frac{5}{2}^{-}\right)$. Though the measured masses of $\Omega_{c}(3000)^{0}, \Omega_{c}(3050)^{0}$ and $\Omega_{c}(3119)^{0}$ are lower than existed theoretical predictions of $1 D$-wave $\Omega_{c}$, the hadronic decay features of these $\Omega_{c}$ favor assignments of the $1 D$-wave states. $\Omega_{c}(3000)^{0}$ is possibly $\Omega_{c 1}\left(\frac{1}{2}^{+}\right)$or $\Omega_{c 1}\left(\frac{3}{2}+\right), \Omega_{c}(3050)^{0}$ is possibly $\hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right)$or $\hat{\Omega}_{c 3}\left(\frac{7}{2}^{+}\right)$, and $\Omega_{c}(3119)^{0}$ is possibly $\hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right), \hat{\Omega}_{c 3}\left(\frac{7}{2}^{+}\right), \Omega_{c 3}\left(\frac{5}{2}^{+}\right)$or $\Omega_{c 3}\left(\frac{7}{2}^{+}\right)$. The predicted total decay widths in these assignments are consistent with experiment.

## I. INTRODUCTION

Very recently, five narrow excited $\Omega_{c}^{0}$ baryons were reported by the LHCb collaboration (1]. Their masses and decay widths were measured in $\Omega_{c}^{0} \rightarrow \Xi_{c}^{+} K^{-}$as follows,

The $J^{P}$ quantum numbers of these five $\Omega_{c}^{0}$ baryons have not been measured.

According to Particle Data Group [2], two $\Omega_{c}$ baryons have been observed: the ground state $\Omega_{c}^{0}$ and $\Omega_{c}(2770)^{0}$ (also known as $\Omega_{c}^{*}$ ) with $J^{P}=\frac{1}{2}^{+}$and $\frac{3}{2}^{+}$, respectively. No other $\Omega_{c}$ baryon has been reported before the LHCb experiment.

Theoretical predictions of the spectra of orbitally excited $\Omega_{c}$ baryons have been conducted in many different models 3-8]. Relevant references can be found in reviews [9-11] and references therein. From the spectra,

[^0]these newly observed baryons are most possibly the orbitally excited $1 P$ or the radially excited $2 S$ states. Theoretical predicted masses of the orbitally excited $1 D \Omega_{c}$ baryons are $100-200 \mathrm{MeV}$ higher than the observed ones.

Since the report of LHCb , the spectra of orbitally excited $\Omega_{c}^{0}$ baryons have been explored in Refs. [12 15]. The hadronic decays of these baryons have also been studied through QCD sum rules, chiral quark model or other models in Refs. 13, 15-18]. In these explorations, the observed $\Omega_{c}^{0}$ baryons were interpreted as the $1 P$ or $2 S \Omega_{c}$, while the $1 D$ possibility has not been explored for their lower masses. However, the mass prediction may be largely different in different models. As indicated in Ref. 19], the mass prediction of the excited $\Lambda_{c}$ and $\Xi_{c}$ baryons in Ref. 3] were really largely different from the results in Ref. [4]. The study of $1 D$ possibility of these $\Omega_{c}^{0}$ through their hadronic decays is necessary.

For the understanding of these excited baryons, it is useful to explore their hadronic decays in different model for a cross-check. ${ }^{3} P_{0}$ model is a phenomenological method to study the OZI-allowed hadronic decays of hadrons. In addition to mesons, it is employed successfully to explain the hadronic decays of baryons $3,3,20$ 24]. In this paper, ${ }^{3} P_{0}$ model will be employed to study the hadronic decays of $\Omega_{c}(3000)^{0}, \Omega_{c}(3050)^{0}, \Omega_{c}(3066)^{0}$, $\Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$. In particular, the $1 D$ possibility of these $\Omega_{c}^{0}$ will be examined in detail.

This work is organized as follows. In Sec.II, we give a brief review of the ${ }^{3} P_{0}$ model. In Sec.III, we present our numerical results. We give our conclusions and discussions in Sec.IV.

## II. BARYON DECAY IN THE ${ }^{3} P_{0}$ MODEL

Proposed by Micu [25] and later developed by Yaouanc et al 24, 26, 27], ${ }^{3} P_{0}$ model is also known as a Quark Pair Creation (QPC) model. It assumes that a pair of quark $q \bar{q}$ is created from the vacuum with $J^{P C}=$ $0^{++}\left({ }^{2 S+1} L_{J}={ }^{3} P_{0}\right)$, and then the created quarks regroup with the quarks from the initial hadron A to form

two daughter hadrons B and C. The process of a baryon decay is shown in Fig. I.

In the ${ }^{3} P_{0}$ model, the hadronic decay width $\Gamma$ of a process $A \rightarrow B+C$ is as follows [27],

where $m_{A}$ and $J_{A}$ are the mass and total angular momentum of the initial baryon A, respectively. $m_{B}$ and $m_{C}$ are the masses of the final hadrons. $\mathcal{M}^{M_{J_{A}}} M_{J_{B}} M_{J_{C}}$ is the helicity amplitude, which reads [23]

Simple harmonic oscillator (SHO) wave functions are employed as the baryon wave functions [3, 21, 22]. For practical calculations such as the flavor matrix $\left\langle\varphi_{B}^{1,4,3} \varphi_{C}^{2,5} \mid \varphi_{A}^{1,2,3} \varphi_{0}^{4,5}\right\rangle$ and the space integrals in the

model, more details were presented in Refs. 21, 23, 27, 28].

Two parameters, the $\beta$ in SHO and the quark pair creation strength $\gamma$, are adopted as those in Refs. [23, 28, 29]. $\gamma=13.4$, and $\beta=476 \mathrm{MeV}$ for meson $K$. For baryons, a universal value $\beta=600 \mathrm{MeV}$ is employed. The masses of $\Omega_{c}(3000)^{0}, \Omega_{c}(3050)^{0}, \Omega_{c}(3066)^{0}, \Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$ are taken as $3000.4 \mathrm{MeV}, 3050.2 \mathrm{MeV}$, $3065.6 \mathrm{MeV}, 3090.2 \mathrm{MeV}$ and 3119.1 MeV , respectively. Masses of K mesons and $\Xi_{c}$ baryons are taken from PDG [2].

The quantum numbers of the P -wave and D -wave baryons are complicated [30, 31], and we follow the notations in Ref. [23]. The quantum numbers involved in the calculations are listed in Table [] In the table, $L_{\rho}$ denotes the orbital angular momentum between the two light quarks, $L_{\lambda}$ denotes the orbital angular momentum between the charm quark and the two light quark system, $L$ is the total orbital angular momentum of $L_{\rho}$ and $L_{\lambda}$. $S_{\rho}$ denotes the total spin of the two light quarks, $J_{l}$ is total angular momentum of $L$ and $S_{\rho}$. $J$ is the total angular momentum of the baryons. The hat and the check are also used to denote the assignments with $L_{\rho}=2$ and $L_{\rho}=1$, respectively. The superscript $L$ is adopted to denote the different total orbital angular momentum in $\check{\Omega}_{c J_{l}}^{L}$.

## III. NUMERICAL RESULTS

In the ${ }^{3} P_{0}$ model, $u \bar{u}, d \bar{d}$ and $s \bar{s}$ could be created from the vacuum. However, there exists no experimental signal for the decay mode with a $s \bar{s}$ creation. Once the measured masses of $\Omega_{c}$ baryons and the mass threshold of the final particles, $\Xi_{c}^{+} K^{-}$and $\Xi_{c}^{0} K^{0}$, have been taken into account, there are two decay channels for $\Omega_{c}(3000)^{0}, \Omega_{c}(3050)^{0}$ and $\Omega_{c}(3066)^{0}$. For $\Omega_{c}(3090)^{0}$ and

$\Omega_{c}(3119)^{0}, \Xi_{c}^{\prime}+K^{-}$and $\Xi_{c}^{\prime 0} K^{0}$ are also allowed. Possible decay modes and corresponding hadronic decay widths of these $\Omega_{c}$ baryons in different $P$-wave and $D$-wave assignments have been computed and presented in from Table III to Table VI. The vanish modes in these five tables indicate forbidden channels.

All the five new $\Omega_{c}^{0}$ baryons were observed in the $\Xi_{c}^{+} K^{-}$channel. The decay width of $\Omega_{c}(3000)^{0}$ is $\Gamma_{\Omega_{c}(3000)^{0}}=(4.5 \pm 0.6 \pm 0.3) \mathrm{MeV}$. From the results in Table III the most possible assignment of $\Omega_{c}(3000)^{0}$ is $\Omega_{c 1}\left(\frac{1}{2}^{+}\right)$or $\Omega_{c 1}\left(\frac{3}{2}^{+}\right)$. In these two assignments, the total decay widths are the same 5.0 MeV , which is very close to the experimental data.

The experimental measured decay width of $\Omega_{c}(3050)^{0}$ is extremely narrow, which is smaller than 1.0 MeV . From Table III, the possible assignment of $\Omega_{c}(3050)^{0}$ is $\hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right)$or $\hat{\Omega}_{c 3}\left(7_{2}^{2}\right)$. The theoretical prediction of the decay width is 0.2 MeV .

For $\Omega_{c}(3066)^{0}$, the measured decay width is $(3.5 \pm 0.4 \pm$ $0.2) \mathrm{MeV}$. From Table IV] the total decay widths of $\Omega_{c 2}\left(\frac{3}{2}^{-}\right)$and $\Omega_{c 2}\left(\frac{5}{2}^{-}\right)$are the same 8.5 MeV , which is a little larger than the experimental result. Under the theoretical uncertainty, these assignments are possible for

$\Omega_{c}(3066)^{0}$.
For $\Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$, the channels $\Xi_{c}^{\prime+} K^{-}$and $\Xi_{c}^{\prime 0} K^{0}$ open. In Table $V$ and Table VI, many channels decaying to $\Xi_{c}^{+} K^{-}$and $\Xi_{c}^{0} K^{0}$ are forbidden while to $\Xi_{c}^{\prime}+K^{-}$and $\Xi_{c}^{\prime 0} K^{0}$ are not. In particular, the total decay widths of $\Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$ in some assignments are extremely large. In comparison with experiment, the possible assignment for $\Omega_{c}(3090)^{0}$ is $\Omega_{c 2}\left(\frac{3}{2}^{-}\right)$ or $\Omega_{c 2}\left(\frac{5}{2}^{-}\right)$, and four $D$-wave assignments are possible for $\Omega_{c}(3119)^{0}: \Omega_{c 3}\left(\frac{5}{2}^{+}\right), \Omega_{c 3}\left(\frac{7}{2}^{+}\right), \hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right)$and $\hat{\Omega}_{c 3}\left(\frac{7}{2}^{+}\right)$. In these assignments, the decay widths to $\Xi_{c}^{\prime}+K^{-}$and $\Xi_{c}^{\prime 0} K^{0}$ channels are very tiny and could be neglected.

## IV. CONCLUSIONS AND DISCUSSIONS

In this work, we study the hadronic decays of five newly observed baryons $\Omega_{c}(3000)^{0}, \quad \Omega_{c}(3050)^{0}, \quad \Omega_{c}(3066)^{0}$, $\Omega_{c}(3090)^{0}$ and $\Omega_{c}(3119)^{0}$ in the ${ }^{3} P_{0}$ model. In different assignments of $1 P$-wave and $1 D$-wave $\Omega_{c}$, hadronic decay widths of these baryons have been calculated. In comparison with experiment, possible assignments of

these $\Omega_{c}^{0}$ have been made.
All the five $\Omega_{c}^{0}$ baryons were observed in the $\Xi_{c}^{+} K^{-}$ channel with very narrow decay widths. Our results indicates that these $\Omega_{c}^{0}$ could be $P$-wave or $D$-wave $\Omega_{c}^{0}$ baryons. $\Omega_{c}(3000)^{0}$ is possibly $1 D$-wave $\Omega_{c 1}\left(\frac{1}{2}^{+}\right)$ or $\Omega_{c 1}\left(\frac{3}{2}^{+}\right) . \quad \Omega_{c}(3050)^{0}$ is possibly $1 D$-wave $\hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right)$ or $\hat{\Omega}_{c 3}\left(\frac{7}{2}^{+}\right) . \quad \Omega_{c}(3066)^{0}$ is possibly $1 P$-wave $\Omega_{c 2}\left(\frac{3}{2}^{-}\right)$ or $\Omega_{c 2}\left(\frac{5}{2}^{-}\right)$. The possible assignment for $\Omega_{c}(3090)^{0}$ is $1 P$-wave $\Omega_{c 2}\left(\frac{3}{2}^{-}\right)$or $\Omega_{c 2}\left(\frac{5}{2}^{-}\right)$, and four $D$-wave assignments $\Omega_{c 3}\left(\frac{5}{2}^{+}\right), \Omega_{c 3}\left(\frac{7}{2}^{+}\right), \hat{\Omega}_{c 3}\left(\frac{5}{2}^{+}\right)$and $\hat{\Omega}_{c 3}\left(\frac{7}{2}^{+}\right)$are possible for $\Omega_{c}(3119)^{0}$. The predicted decay widths are consistent with experimental data.

In experiment, only $\Omega_{c}^{0} \rightarrow \Xi_{c}^{+} K^{-}$were observed, which
may not provide enough information on their identification. Furthermore, resonance with the same $J^{P}$ numbers and similar masses may mix with each other, which may make it difficult to distinguish them. As for $1 D$-wave $\Omega_{c}$, the channels $\Xi_{c}^{\prime}{ }^{+} K^{-}$and $\Xi_{c}^{\prime 0} K^{0}$ is hardly to be observed for the tiny decay widths. More information on these $\Omega_{c}$ baryons are expected to be given in forthcoming experiment.
