# Matrix Completion and Related Problems via Strong Duality

#### Abstract

This work studies the strong duality of non-convex matrix factorization problems: we show that under certain dual conditions, these problems and its dual have the same optimum. This has been well understood for convex optimization, but little was known for non-convex problems. We propose a novel analytical framework and show that under certain dual conditions, the optimal solution of the matrix factorization program is the same as its bi-dual and thus the global optimality of the non-convex program can be achieved by solving its bi-dual which is convex. These dual conditions are satisfied by a wide class of matrix factorization problems, although matrix factorization problems are hard to solve in full generality. This analytical framework may be of independent interest to non-convex optimization more broadly.

We apply our framework to two prototypical matrix factorization problems: matrix completion and robust Principal Component Analysis (PCA). These are examples of efficiently recovering a hidden matrix given limited reliable observations of it. Our framework shows that exact recoverability and strong duality hold with nearly-optimal sample complexity guarantees for matrix completion and robust PCA.

## 1 Introduction

Non-convex matrix factorization problems have been an emerging object of study in theoretical computer science [JNS13, Har14, SL15, RSW16], optimization [WYZ12, SWZ14], machine learning [BNS16, GLM16, GHJY15, JMD10, LLR16, WX12], and many other domains. In theoretical computer science and optimization, the study of such models has led to significant advances in provable algorithms that converge to local minima in linear time [JNS13, Har14, SL15, AAZB ${ }^{+}$16, AZ16]. In machine learning, matrix factorization serves as a building block for large-scale prediction and recommendation systems, e.g., the winning submission for the Netflix prize [KBV09]. Two prototypical examples are matrix completion and robust Principal Component Analysis (PCA).

This work develops a novel framework to analyze a class of non-convex matrix factorization problems with strong duality, which leads to exact recoverability for matrix completion and robust Principal Component Analysis (PCA) via the solution to a convex problem. The matrix factorization problems can be stated as finding a target matrix $\mathbf{X}^{*}$ in the form of $\mathbf{X}^{*}=\mathbf{A B}$, by minimizing the objective function $H(\mathbf{A B})+$ $\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}$ over factor matrices $\mathbf{A} \in \mathbb{R}^{n_{1} \times r}$ and $\mathbf{B} \in \mathbb{R}^{r \times n_{2}}$ with a known value of $r \ll \min \left\{n_{1}, n_{2}\right\}$, where $H(\cdot)$ is some function that characterizes the desired properties of $\mathbf{X}^{*}$.

Our work is motivated by several promising areas where our analytical framework for non-convex matrix factorizations is applicable. The first area is low-rank matrix completion, where it has been shown that a low-rank matrix can be exactly recovered by finding a solution of the form $\mathbf{A B}$ that is consistent with the observed entries (assuming that it is incoherent) [JNS13, SL15, GLM16]. This problem has received a tremendous amount of attention due to its important role in optimization and its wide applicability in many areas such as quantum information theory and collaborative filtering [Har14, ZLZ16, BZ16]. The second area is robust PCA, a fundamental problem of interest in data processing that aims at recovering both the low-rank and the sparse components exactly from their superposition [CLMW11, NNS ${ }^{+}$14, GWL16, ZLZC15, ZLZ16, YPCC16], where the low-rank component corresponds to the product of $\mathbf{A}$ and $\mathbf{B}$ while the sparse component is captured by a proper choice of function $H(\cdot)$, e.g., the $\ell_{1}$ norm [CLMW11, ABHZ16]. We believe our analytical framework can be potentially applied to other non-convex problems more broadly, e.g., matrix sensing [TBSR15], dictionary learning [SQW17a], weighted low-rank approximation [RSW16, LLR16], and deep linear neural network [Kaw16], which may be of independent interest.

Without assumptions on the structure of the objective function, direct formulations of matrix factorization problems are NP-hard to optimize in general [HMRW14, ZLZ13]. With standard assumptions on the structure of the problem and with sufficiently many samples, these optimization problems can be solved efficiently, e.g., by convex relaxation [CR09, Che15]. Some other methods run local search algorithms given an initialization close enough to the global solution in the basin of attraction [JNS13, Har14, SL15, GHJY15, JGN ${ }^{+}$17]. However, these methods have sample complexity significantly larger than the information-theoretic lower bound; see Table 1 for a comparison. The problem becomes more challenging when the number of samples is small enough that the sample-based initialization is far from the desired solution, in which case the algorithm can run into a local minimum or a saddle point.

Another line of work has focused on studying the loss surface of matrix factorization problems, providing positive results for approximately achieving global optimality. One nice property in this line of research is that there is no spurious local minima for specific applications such as matrix completion [GLM16], matrix sensing [BNS16], dictionary learning [SQW17a], phase retrieval [SQW16], linear deep neural networks [Kaw16], etc. However, these results are based on concrete forms of objective functions. Also, even when any local minimum is guaranteed to be globally optimal, in general it remains NP-hard to escape high-order saddle points [AG16], and additional arguments are needed to show the achievement of a local minimum. Most importantly, all existing results rely on strong assumptions on the sample size.

### 1.1 Our Results

Our work studies the exact recoverability problem for a variety of non-convex matrix factorization problems. The goal is to provide a unified framework to analyze a large class of matrix factorization problems, and to achieve efficient algorithms. Our main results show that although matrix factorization problems are hard to optimize in general, under certain dual conditions the duality gap is zero, and thus the problem can be converted to an equivalent convex program. The main theorem of our framework is the following.
Theorems 4 (Strong Duality. Informal). Under certain dual conditions, strong duality holds for the non-convex optimization problem

where "the function $H(\cdot)$ is closed" means that for each $\alpha \in \mathbb{R}$, the sub-level set $\left\{\mathbf{X} \in \mathbb{R}^{n_{1} \times n_{2}}: H(\mathbf{X}) \leq \alpha\right\}$ is a closed set. In other words, problem (1) and its bi-dual problem

\widetilde{\mathbf{X}}=\underset{\mathbf{X} \in \mathbb{R}^{n_{1} \times n_{2}}}{\operatorname{argmin}} H(\mathbf{X})+\|\mathbf{X}\|_{r *}, \tag{2}

have exactly the same optimal solutions in the sense that $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\widetilde{\mathbf{X}}$, where $\|\mathbf{X}\|_{r *}$ is a convex function defined by $\|\mathbf{X}\|_{r *}=\max _{\mathbf{M}}\langle\mathbf{M}, \mathbf{X}\rangle-\frac{1}{2}\|\mathbf{M}\|_{r}^{2}$ and $\|\mathbf{M}\|_{r}^{2}=\sum_{i=1}^{r} \sigma_{i}^{2}(\mathbf{M})$ is the sum of the first $r$ largest squared singular values.

Theorem 4 connects the non-convex program (1) to its convex counterpart via strong duality; see Figure 1. We mention that strong duality rarely happens in the non-convex optimization region: low-rank matrix approximation [OW92] and quadratic optimization with two quadratic constraints [BE06] are among the few paradigms that enjoy such a nice property. Given strong duality, the computational issues of the original problem can be overcome by solving the convex bi-dual problem (2).

The positive result of our framework is complemented by a lower bound to formalize the hardness of the above problem in general. Assuming that the random 4-SAT problem is hard (see Conjecture 1) [RSW16], we give a strong negative result for deterministic algorithms. If also BPP $=\mathrm{P}$ (see Section 6 for a discussion), then the same conclusion holds for randomized algorithms succeeding with probability at least $2 / 3$.

Theorem 6.1 (Hardness Statement. Informal). Assuming that random 4-SAT is hard on average, there is a problem in the form of (1) such that any deterministic algorithm achieving $(1+\epsilon) \mathrm{OPT}$ in the objective function value with $\epsilon \leq \epsilon_{0}$ requires $2^{\Omega\left(n_{1}+n_{2}\right)}$ time, where OPT is the optimum and $\epsilon_{0}>0$ is an absolute constant. If $\mathrm{BPP}=\mathrm{P}$, then the same conclusion holds for randomized algorithms succeeding with probability at least $2 / 3$.

Our framework only requires the dual conditions in Theorem 4 to be verified. We will show that two prototypical problems, matrix completion and robust PCA, obey the conditions. They belong to the linear inverse problems of form (1) with a proper choice of function $H(\cdot)$, which aim at exactly recovering a hidden matrix $\mathbf{X}^{*}$ with $\operatorname{rank}\left(\mathbf{X}^{*}\right) \leq r$ given a limited number of linear observations of it.

For matrix completion, the linear measurements are of the form $\left\{\mathbf{X}_{i j}^{*}:(i, j) \in \Omega\right\}$, where $\Omega$ is the support set which is uniformly distributed among all subsets of $\left[n_{1}\right] \times\left[n_{2}\right]$ of cardinality $m$. With strong

duality, we can either study the exact recoverability of the primal problem (1), or investigate the validity of its convex dual (or bi-dual) problem (2). Here we study the former with tools from geometric analysis. Recall that in the analysis of matrix completion, one typically requires an $\mu$-incoherence condition for a given rank- $r$ matrix $\mathbf{X}^{*}$ with skinny $\operatorname{SVD} \mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}$ [Rec11, CT10]:

\left\|\mathbf{U}^{T} \mathbf{e}_{i}\right\|_{2} \leq \sqrt{\frac{\mu r}{n_{1}}}, \quad \text { and } \quad\left\|\mathbf{V}^{T} \mathbf{e}_{i}\right\|_{2} \leq \sqrt{\frac{\mu r}{n_{2}}}, \quad \text { for all } i \tag{3}
\end{equation*}
$$

where $\mathbf{e}_{i}$ 's are vectors with $i$-th entry equal to 1 and other entries equal to 0 . The incoherence condition claims that information spreads throughout the left and right singular vectors and is quite standard in the matrix completion literature. Under this standard condition, we have the following results.

Theorems 4.1, 4.2, and 4.3 (Matrix Completion. Informal). $\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}$ is the unique matrix of rank at most $r$ that is consistent with the $m$ measurements with minimum Frobenius norm by a high probability, provided that $m=\mathcal{O}\left(\kappa^{2} \mu\left(n_{1}+n_{2}\right) r \log \left(n_{1}+n_{2}\right) \log _{2 \kappa}\left(n_{1}+n_{2}\right)\right)$ and $\mathbf{X}^{*}$ satisfies incoherence (3). In addition, there exists a convex optimization for matrix completion in the form of (2) that exactly recovers $\mathbf{X}^{*}$ with high probability, provided that $m=\mathcal{O}\left(\kappa^{2} \mu\left(n_{1}+n_{2}\right) r \log \left(n_{1}+n_{2}\right) \log _{2 \kappa}\left(n_{1}+n_{2}\right)\right)$, where $\kappa$ is the condition number of $\mathbf{X}^{*}$.

To the best of our knowledge, our result is the first to connect convex matrix completion to non-convex matrix completion, two parallel lines of research that have received significant attention in the past few years. Table 1 compares our result with prior results.

For robust PCA, instead of studying exact recoverability of problem (1) as for matrix completion, we investigate problem (2) directly. The robust PCA problem is to decompose a given matrix $\mathbf{D}=\mathbf{X}^{*}+\mathbf{S}^{*}$ into the sum of a low-rank component $\mathbf{X}^{*}$ and a sparse component $\mathbf{S}^{*}$ [ANW12]. We obtain the following theorem for robust PCA.

[^1]Theorems 5.1 (Robust PCA. Informal). There exists a convex optimization formulation for robust PCA in the form of problem (2) that exactly recovers the incoherent matrix $\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}$ and $\mathbf{S}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}$ with high probability, even if $\operatorname{rank}\left(\mathbf{X}^{*}\right)=\Theta\left(\frac{\min \left\{n_{1}, n_{2}\right\}}{\mu \log ^{2} \max \left\{n_{1}, n_{2}\right\}}\right)$ and the size of the support of $\mathbf{S}^{*}$ is $m=\Theta\left(n_{1} n_{2}\right)$, where the support set of $\mathbf{S}^{*}$ is uniformly distributed among all sets of cardinality $m$, and the incoherence parameter $\mu$ satisfies constraints (3) and $\left\|\mathbf{X}^{*}\right\|_{\infty} \leq \sqrt{\frac{\mu r}{n_{1} n_{2}}} \sigma_{r}\left(\mathbf{X}^{*}\right)$.

The bounds in Theorem 5.1 match the best known results in the robust PCA literature when the supports of $\mathbf{S}^{*}$ are uniformly sampled [CLMW11], while our assumption is arguably more intuitive; see Section 5 . Note that our results hold even when $\mathbf{X}^{*}$ is close to full rank and a constant fraction of the entries have noise. Independently of our work, Ge et al. [GJY17] developed a framework to analyze the loss surface of low-rank problems, and applied the framework to matrix completion and robust PCA. Their bounds are: for matrix completion, the sample complexity is $\mathcal{O}\left(\kappa^{6} \mu^{4} r^{6}\left(n_{1}+n_{2}\right) \log \left(n_{1}+n_{2}\right)\right)$; for robust PCA, the outlier entries are deterministic and the number that the method can tolerate is $\mathcal{O}\left(\frac{n_{1} n_{2}}{\mu r \kappa^{5}}\right)$. Zhang et al. [ZWG17] also studied the robust PCA problem using non-convex optimization, where the outlier entries are deterministic and the number of outliers that their algorithm can tolerate is $\mathcal{O}\left(\frac{n_{1} n_{2}}{r \kappa}\right)$. The strong duality approach is unique to our work.

### 1.2 Our Techniques

Reduction to Low-Rank Approximation. Our results are inspired by the low-rank approximation problem:

\min _{\mathbf{A} \in \mathbb{R}^{n_{1} \times r}, \mathbf{B} \in \mathbb{R}^{r \times n_{2}}} \frac{1}{2}\|-\widetilde{\boldsymbol{\Lambda}}-\mathbf{A B}\|_{F}^{2} \tag{4}
\end{equation*}

We know that all local solutions of (4) are globally optimal (see Lemma 3.1) and that strong duality holds for any given matrix $-\widetilde{\boldsymbol{\Lambda}} \in \mathbb{R}^{n_{1} \times n_{2}}$ [GRG16]. To extend this property to our more general problem (1), our main insight is to reduce problem (1) to the form of (4) using the $\ell_{2}$-regularization term. While some prior work attempted to apply a similar reduction, their conclusions either depended on unrealistic conditions on local solutions, e.g., all local solutions are rank-deficient [HYV14, GRG16], or their conclusions relied on strong assumptions on the objective functions, e.g., that the objective functions are twice-differentiable [HV15]. Instead, our general results formulate strong duality via the existence of a dual certificate $\widetilde{\mathbf{\Lambda}}$. For concrete applications, the existence of a dual certificate is then converted to mild assumptions, e.g., that the number of measurements is sufficiently large and the positions of measurements are randomly distributed. We will illustrate the importance of randomness below.
The Blessing of Randomness. The desired dual certificate $\widetilde{\Lambda}$ may not exist in the deterministic world. A hardness result [RSW16] shows that for the problem of weighted low-rank approximation, which can be cast in the form of (1), without some randomization in the measurements made on the underlying low rank matrix, it is NP-hard to achieve a good objective value, not to mention to achieve strong duality. A similar phenomenon was observed for deterministic matrix completion [HM12]. Thus we should utilize such randomness to analyze the existence of a dual certificate. For matrix completion, the assumption that the measurements are random is standard, under which, the angle between the space $\Omega$ (the space of matrices which are consistent with observations) and the space $\mathcal{T}$ (the space of matrices which are low-rank) is small with high probability, namely, $\mathbf{X}^{*}$ is almost the unique low-rank matrix that is consistent with the measurements. Thus, our dual certificate can be represented as another form of a convergent Neumann series concerning the projection operators on the spaces $\Omega$ and $\mathcal{T}$. The remainder of the proof is to show that such a construction obeys the dual conditions.

To prove the dual conditions for matrix completion, we use the fact that the subspace $\Omega$ and the complement space $\mathcal{T}^{\perp}$ are almost orthogonal when the sample size is sufficiently large. This implies
the projection of our dual certificate on the space $\mathcal{T}^{\perp}$ has a very small norm, which exactly matches the dual conditions.

Non-Convex Geometric Analysis. Strong duality implies that the primal problem (1) and its bi-dual problem (2) have exactly the same solutions in the sense that $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\widetilde{\mathbf{X}}$. Thus, to show exact recoverability of linear inverse problems such as matrix completion and robust PCA, it suffices to study either the non-convex primal problem (1) or its convex counterpart (2). Here we do the former analysis for matrix completion. We mention that traditional techniques [CT10, Rec11, CRPW12] for convex optimization break down for our non-convex problem, since the subgradient of a non-convex objective function may not even exist [BV04]. Instead, we apply tools from geometric analysis [Ver09] to analyze the geometry of problem (1). Our non-convex geometric analysis is in stark contrast to prior techniques of convex geometric analysis [Ver15] where convex combinations of non-convex constraints were used to define the Minkowski


Figure 2: Feasibility. functional (e.g., in the definition of atomic norm) while our method uses the non-convex constraint itself.

For matrix completion, problem (1) has two hard constraints: a) the rank of the output matrix should be no larger than $r$, as implied by the form of $\mathbf{A B}$; b) the output matrix should be consistent with the sampled measurements, i.e., $\mathcal{P}_{\Omega}(\mathbf{A B})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)$. We study the feasibility condition of problem (1) from a geometric perspective: $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$ is the unique optimal solution to problem (1) if and only if starting from $\mathbf{X}^{*}$, either the rank of $\mathbf{X}^{*}+\mathbf{D}$ or $\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{F}$ increases for all directions $\mathbf{D}$ 's in the constraint set $\Omega^{\perp}=\left\{\mathbf{D} \in \mathbb{R}^{n_{1} \times n_{2}}: \mathcal{P}_{\Omega}\left(\mathbf{X}^{*}+\mathbf{D}\right)=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)\right\}$. This can be geometrically interpreted as the requirement that the set $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right)=\left\{\mathbf{X}-\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}: \operatorname{rank}(\mathbf{X}) \leq r,\|\mathbf{X}\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}\right\}$ and the constraint set $\Omega^{\perp}$ must intersect uniquely at $\mathbf{0}$ (see Figure 2). This can then be shown by a dual certificate argument.

Putting Things Together. We summarize our new analytical framework with the following figure.


Other Techniques. An alternative method is to investigate the exact recoverability of problem (2) via standard convex analysis. We find that the sub-differential of our induced function $\|\cdot\|_{r *}$ is very similar to that of the nuclear norm. With this observation, we prove the validity of robust PCA in the form of (2) by combining this property of $\|\cdot\|_{r *}$ with standard techniques from [CLMW11].

## 2 Preliminaries

We will use calligraphy to represent a set, bold capital letters to represent a matrix, bold lower-case letters to represent a vector, and lower-case letters to represent scalars. Specifically, we denote by $\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}$ the
underlying matrix. We use $\mathbf{X}_{: t} \in \mathbb{R}^{n_{1} \times 1}\left(\mathbf{X}_{t:} \in \mathbb{R}^{1 \times n_{2}}\right)$ to indicate the $t$-th column (row) of $\mathbf{X}$. The entry in the $i$-th row, $j$-th column of $\mathbf{X}$ is represented by $\mathbf{X}_{i j}$. The condition number of $\mathbf{X}$ is $\kappa=\sigma_{1}(\mathbf{X}) / \sigma_{r}(\mathbf{X})$. We let $n_{(1)}=\max \left\{n_{1}, n_{2}\right\}$ and $n_{(2)}=\min \left\{n_{1}, n_{2}\right\}$. For a function $H(\mathbf{M})$ on an input matrix $\mathbf{M}$, its conjugate function $H^{*}$ is defined by $H^{*}(\boldsymbol{\Lambda})=\max _{\mathbf{M}}\langle\boldsymbol{\Lambda}, \mathbf{M}\rangle-H(\mathbf{M})$. Furthermore, let $H^{* *}$ denote the conjugate function of $H^{*}$.

We will frequently use $\operatorname{rank}(\mathbf{X}) \leq r$ to constrain the rank of $\mathbf{X}$. This can be equivalently represented as $\mathbf{X}=\mathbf{A B}$, by restricting the number of columns of $\mathbf{A}$ and rows of $\mathbf{B}$ to be $r$. For norms, we denote by $\|\mathbf{X}\|_{F}=\sqrt{\sum_{i j} \mathbf{X}_{i j}^{2}}$ the Frobenius norm of matrix $\mathbf{X}$. Let $\sigma_{1}(\mathbf{X}) \geq \sigma_{2}(\mathbf{X}) \geq \ldots \geq \sigma_{r}(\mathbf{X})$ be the non-zero singular values of $\mathbf{X}$. The nuclear norm (a.k.a. trace norm) of $\mathbf{X}$ is defined by $\|\mathbf{X}\|_{*}=\sum_{i=1}^{r} \sigma_{i}(\mathbf{X})$, and the operator norm of $\mathbf{X}$ is $\|\mathbf{X}\|=\sigma_{1}(\mathbf{X})$. Denote by $\|\mathbf{X}\|_{\infty}=\max _{i j}\left|\mathbf{X}_{i j}\right|$. For two matrices $\mathbf{A}$ and $\mathbf{B}$ of equal dimensions, we denote by $\langle\mathbf{A}, \mathbf{B}\rangle=\sum_{i j} \mathbf{A}_{i j} \mathbf{B}_{i j}$. We denote by $\partial H(\mathbf{X})=\left\{\boldsymbol{\Lambda} \in \mathbb{R}^{n_{1} \times n_{2}}\right.$ : $H(\mathbf{Y}) \geq H(\mathbf{X})+\langle\boldsymbol{\Lambda}, \mathbf{Y}-\mathbf{X}\rangle$ for any $\mathbf{Y}\}$ the sub-differential of function $H$ evaluated at $\mathbf{X}$. We define the indicator function of convex set $\mathcal{C}$ by $\mathbf{I}_{\mathcal{C}}(\mathbf{X})=\left\{\begin{array}{ll}0, & \text { if } \mathbf{X} \in \mathcal{C} ; \\ +\infty, & \text { otherwise. }\end{array}\right.$ For any non-empty set $\mathcal{C}$, denote by cone $(\mathcal{C})=\{t \mathbf{X}: \mathbf{X} \in \mathcal{C}, t \geq 0\}$.

We denote by $\Omega$ the set of indices of observed entries, and $\Omega^{\perp}$ its complement. Without confusion, $\Omega$ also indicates the linear subspace formed by matrices with entries in $\Omega^{\perp}$ being 0 . We denote by $\mathcal{P}_{\Omega}$ : $\mathbb{R}^{n_{1} \times n_{2}} \rightarrow \mathbb{R}^{n_{1} \times n_{2}}$ the orthogonal projector of subspace $\Omega$. We will consider a single norm for these operators, namely, the operator norm denoted by $\|\mathcal{A}\|$ and defined by $\|\mathcal{A}\|=\sup _{\|\mathbf{X}\|_{F}=1}\|\mathcal{A}(\mathbf{X})\|_{F}$. For any orthogonal projection operator $\mathcal{P}_{\mathcal{T}}$ to any subspace $\mathcal{T}$, we know that $\left\|\mathcal{P}_{\mathcal{T}}\right\|=1$ whenever $\operatorname{dim}(\mathcal{T}) \neq 0$. For distributions, denote by $\mathcal{N}(0,1)$ a standard Gaussian random variable, $\operatorname{Uniform}(m)$ the uniform distribution of cardinality $m$, and $\operatorname{Ber}(p)$ the Bernoulli distribution with success probability $p$.

## $3 \ell_{2}$-Regularized Matrix Factorizations: A New Analytical Framework

In this section, we develop a novel framework to analyze a general class of $\ell_{2}$-regularized matrix factorization problems. Our framework can be applied to different specific problems and leads to nearly optimal sample complexity guarantees. In particular, we study the $\ell_{2}$-regularized matrix factorization problem
(P) $\quad \min _{\mathbf{A} \in \mathbb{R}^{n_{1} \times r}, \mathbf{B} \in \mathbb{R}^{r \times n_{2}}} F(\mathbf{A}, \mathbf{B})=H(\mathbf{A B})+\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}, H(\cdot)$ is convex and closed.

We show that under suitable conditions the duality gap between $(\mathbf{P})$ and its dual (bi-dual) problem is zero, so problem ( $\mathbf{P}$ ) can be converted to an equivalent convex problem.

### 3.1 Strong Duality

We first consider an easy case where $H(\mathbf{A B})=\frac{1}{2}\|\widehat{\mathbf{Y}}\|_{F}^{2}-\langle\widehat{\mathbf{Y}}, \mathbf{A B}\rangle$ for a fixed $\widehat{\mathbf{Y}}$, leading to the objective function $\frac{1}{2}\|\widehat{\mathbf{Y}}-\mathbf{A B}\|_{F}^{2}$. For this case, we establish the following lemma.
Lemma 3.1. For any given matrix $\widehat{\mathbf{Y}} \in \mathbb{R}^{n_{1} \times n_{2}}$, any local minimum of $f(\mathbf{A}, \mathbf{B})=\frac{1}{2}\|\widehat{\mathbf{Y}}-\mathbf{A B}\|_{F}^{2}$ over $\mathbf{A} \in \mathbb{R}^{n_{1} \times r}$ and $\mathbf{B} \in \mathbb{R}^{r \times n_{2}}\left(r \leq \min \left\{n_{1}, n_{2}\right\}\right)$ is globally optimal, given by $\operatorname{svd}_{r}(\widehat{\mathbf{Y}})$. The objective function $f(\mathbf{A}, \mathbf{B})$ around any saddle point has a negative second-order directional curvature. Moreover, $f(\mathbf{A}, \mathbf{B})$ has no local maximum. ${ }^{2}$

The proof of Lemma 3.1 is basically to calculate the gradient of $f(\mathbf{A}, \mathbf{B})$ and let it equal to zero; see Appendix B for details. Given this lemma, we can reduce $F(\mathbf{A}, \mathbf{B})$ to the form $\frac{1}{2}\|\widehat{\mathbf{Y}}-\mathbf{A B}\|_{F}^{2}$ for some $\widehat{\mathbf{Y}}$

F(\mathbf{A}, \mathbf{B}) & =\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}+H(\mathbf{A B})=\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}+H^{* *}(\mathbf{A B})=\max _{\boldsymbol{\Lambda}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}+\langle\boldsymbol{\Lambda}, \mathbf{A B}\rangle-H^{*}(\boldsymbol{\Lambda}) \\
& =\max _{\boldsymbol{\Lambda}} \frac{1}{2}\|-\boldsymbol{\Lambda}-\mathbf{A B}\|_{F}^{2}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{F}^{2}-H^{*}(\boldsymbol{\Lambda}) \triangleq \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}), \tag{5}
\end{align*}
$$
\]

where we define $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}) \triangleq \frac{1}{2}\|-\boldsymbol{\Lambda}-\mathbf{A B}\|_{F}^{2}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{F}^{2}-H^{*}(\boldsymbol{\Lambda})$ as the Lagrangian of problem $(\mathbf{P}),{ }^{3}$ and the second equality holds because $H$ is closed and convex w.r.t. the argument $\mathbf{A B}$. For any fixed value of $\boldsymbol{\Lambda}$, by Lemma 3.1, any local minimum of $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$ is globally optimal, because minimizing $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$ is equivalent to minimizing $\frac{1}{2}\|-\boldsymbol{\Lambda}-\mathbf{A B}\|_{F}^{2}$ for a fixed $\boldsymbol{\Lambda}$.

The remaining part of our analysis is to choose a proper $\widetilde{\mathbf{\Lambda}}$ such that $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}})$ is a primal-dual saddle point of $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$, so that $\min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})$ and problem $(\mathbf{P})$ have the same optimal solution $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$. For this, we introduce the following condition, and later we will show that the condition holds with high probability.

Condition 1. For a solution ( $\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ to problem $(\mathbf{P})$, there exists an $\left.\widetilde{\mathbf{\Lambda}} \in \partial_{\mathbf{X}} H(\mathbf{X})\right|_{\mathbf{X}=\tilde{\mathbf{A}}} \tilde{\mathbf{B}}$ such that

$$
\begin{equation*}
-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}} \widetilde{\mathbf{B}}^{T}=\widetilde{\mathbf{\Lambda}} \widetilde{\mathbf{B}}^{T} \quad \text { and } \quad \widetilde{\mathbf{A}}^{T}(-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})=\widetilde{\mathbf{A}}^{T} \widetilde{\mathbf{\Lambda}} . \tag{6}
\end{equation*}
$$

Explanation of Condition 1. We note that $\nabla_{\mathbf{A}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=\mathbf{A B B}^{T}+\boldsymbol{\Lambda B}^{T}$ and $\nabla_{\mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=$ $\mathbf{A}^{T} \mathbf{A B}+\mathbf{A}^{T} \boldsymbol{\Lambda}$ for a fixed $\boldsymbol{\Lambda}$. In particular, if we set $\boldsymbol{\Lambda}$ to be the $\widetilde{\boldsymbol{\Lambda}}$ in (6), then $\left.\nabla_{\mathbf{A}} L(\mathbf{A}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}})\right|_{\mathbf{A}=\widetilde{\mathbf{A}}}=\mathbf{0}$ and $\left.\nabla_{\mathbf{B}} L(\widetilde{\mathbf{A}}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})\right|_{\mathbf{B}=\widetilde{\mathbf{B}}}=\mathbf{0}$. So Condition 1 implies that $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ is either a saddle point or a local minimizer of $L(\mathbf{A}, \mathbf{B}, \tilde{\bar{\Lambda}})$ as a function of $(\mathbf{A}, \mathbf{B})$ for the fixed $\widetilde{\mathbf{\Lambda}}$.

The following lemma states that if it is a local minimizer, then strong duality holds.
Lemma 3.2 (Dual Certificate). Let $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ be a global minimizer of $F(\mathbf{A}, \mathbf{B})$. If there exists a dual certificate $\widetilde{\mathbf{\Lambda}}$ satisfying Condition 1 and the pair $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ is a local minimizer of $L(\mathbf{A}, \mathbf{B}, \widetilde{\mathbf{\Lambda}})$ for the fixed $\widetilde{\mathbf{\Lambda}}$, then strong duality holds. Moreover, we have the relation $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}})$.
Proof Sketch. By the assumption of the lemma, we can show that $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}})$ is a primal-dual saddle point to the Lagrangian $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$; see Appendix $\mathbf{C}$. To show strong duality, by the fact that $F(\mathbf{A}, \mathbf{B})=$ $\max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$ and that $\widetilde{\boldsymbol{\Lambda}}=\operatorname{argmax}_{\boldsymbol{\Lambda}} L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \boldsymbol{\Lambda})$, we have $F(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}}) \leq L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})$, for any $\mathbf{A}, \mathbf{B}$, where the inequality holds because $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}})$ is a primal-dual saddle point of $L$. So on the one hand, $\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=F(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}) \leq \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}}) \leq \max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$. On the other hand, by weak duality, we have $\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}) \geq \max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$. Therefore, $\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=\max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$, i.e., strong duality holds. Therefore, $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{argmin}_{\mathbf{A B}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})=\operatorname{argmin}_{\mathbf{A B}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}+\langle\widetilde{\boldsymbol{\Lambda}}, \mathbf{A B}\rangle-H^{*}(\widetilde{\boldsymbol{\Lambda}})=\operatorname{argmin}_{\mathbf{A B}} \frac{1}{2} \|-\widetilde{\boldsymbol{\Lambda}}-$ $\mathbf{A B} \|_{F}^{2}=\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}})$, as desired.

This lemma then leads to the following theorem.
Theorem 3.3. Denote by $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ the optimal solution of problem $(\mathbf{P})$. Define a matrix space

$$
\mathcal{T} \triangleq\left\{\widetilde{\mathbf{A}} \mathbf{X}^{T}+\mathbf{Y} \widetilde{\mathbf{B}}, \mathbf{X} \in \mathbb{R}^{n_{2} \times r}, \mathbf{Y} \in \mathbb{R}^{n_{1} \times r}\right\} .
$$

Then strong duality holds for problem $(\mathbf{P})$, provided that there exists $\widetilde{\mathbf{\Lambda}}$ such that
(1) $\widetilde{\mathbf{\Lambda}} \in \partial H(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}) \triangleq \Psi$,
(2) $\mathcal{P}_{\mathcal{T}}(-\widetilde{\boldsymbol{\Lambda}})=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$,
(3) $\left\|\mathcal{P}_{\mathcal{T} \perp} \widetilde{\boldsymbol{\Lambda}}\right\|<\sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.

Proof. The proof idea is to construct a dual certificate $\widetilde{\Lambda}$ so that the conditions in Lemma 3.2 hold. $\widetilde{\Lambda}$ should satisfy the following:
(a) $\quad \widetilde{\mathbf{\Lambda}} \in \partial H(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}), \quad$ (by Condition 1)
(b) $\quad(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{\Lambda}}) \widetilde{\mathbf{B}}^{T}=\mathbf{0} \quad$ and $\quad \widetilde{\mathbf{A}}^{T}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{\Lambda}})=\mathbf{0}, \quad$ (by Condition 1)
(c) $\quad \widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}}) . \quad$ (by the local minimizer assumption and Lemma 3.1)

It turns out that for any matrix $\mathbf{M} \in \mathbb{R}^{n_{1} \times n_{2}}, \mathcal{P}_{\mathcal{T} \perp} \mathbf{M}=\left(\mathbf{I}-\widetilde{\mathbf{A}} \widetilde{\mathbf{A}}^{\dagger}\right) \mathbf{M}\left(\mathbf{I}-\widetilde{\mathbf{B}} \widetilde{\mathbf{B}}^{\dagger}\right)$ and so $\left\|\mathcal{P}_{\mathcal{T}}{ }^{\perp} \mathbf{M}\right\| \leq\|\mathbf{M}\|$, a fact that we will frequently use in the sequel. Denote by $\mathcal{U}$ the left singular space of $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$ and $\mathcal{V}$ the right singular space. Then the linear space $\mathcal{T}$ can be equivalently represented as $\mathcal{T}=\mathcal{U}+\mathcal{V}$. Therefore, $\mathcal{T}^{\perp}=(\mathcal{U}+\mathcal{V})^{\perp}=\mathcal{U}^{\perp} \cap \mathcal{V}^{\perp}$. With this, we note that: (b) $(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{A}}) \widetilde{\mathbf{B}}^{T}=\mathbf{0}$ and $\widetilde{\mathbf{A}}^{T}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{\Lambda}})=\mathbf{0}$ imply $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\Lambda} \in \operatorname{Null}\left(\widetilde{\mathbf{A}} \widetilde{\mathrm{A}}^{T}\right)=\operatorname{Col}(\widetilde{\mathbf{A}})^{\perp}$ and $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{\Lambda}} \in \operatorname{Row}(\widetilde{\mathbf{B}})^{\perp}\left(\right.$ so $\left.\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\widetilde{\mathbf{\Lambda}} \in \mathcal{T}^{\perp}\right)$, and vice versa. And (c) $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}})$ implies that for an orthogonal decomposition $-\widetilde{\mathbf{\Lambda}}=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}+\mathbf{E}$, where $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}} \in \mathcal{T}$, and $\mathbf{E} \in$ $\mathcal{T}^{\perp}$, we have $\|\mathbf{E}\|<\sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$. Conversely, $\|\mathbf{E}\|<\sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\widetilde{\mathbf{B}}})$ and condition (b) imply $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{svd}_{r}(-\widetilde{\mathbf{A}})$. Therefore, the dual conditions in (8) are equivalent to (1) $\widetilde{\boldsymbol{\Lambda}} \in \partial H(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}) \triangleq \Psi$; (2) $\mathcal{P}_{\mathcal{T}}(-\widetilde{\boldsymbol{\Lambda}})=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$; (3) $\left\|\mathcal{P}_{\mathcal{T} \perp} \widetilde{\boldsymbol{\Lambda}}\right\|<\sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.

To show the dual condition in Theorem 4, intuitively, we need to show that the angle $\theta$ between subspace $\mathcal{T}$ and $\Psi$ is small (see Figure 3) for a specific function $H(\cdot)$. In the following (see Section G), we will demonstrate applications that, with randomness, obey this dual condition with high probability.

## 4 Matrix Completion

In matrix completion, there is a hidden matrix $\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}$ with rank $r$. We are given measurements $\left\{\mathbf{X}_{i j}^{*}:(i, j) \in \Omega\right\}$, where $\Omega \sim \operatorname{Uniform}(m)$, i.e., $\Omega$ is sampled uniformly at random from all subsets of $\left[n_{1}\right] \times\left[n_{2}\right]$ of cardinality $m$. The goal is to exactly recover $\mathbf{X}^{*}$ with high probability. Here we apply our unified framework in Section 3 to matrix completion, by setting $H(\cdot)=\mathbf{I}_{\left\{\mathbf{M}: \mathcal{P}_{\Omega}(\mathbf{M})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)\right\}}(\cdot)$.

A quantity governing the difficulties of matrix completion is the incoherence parameter $\mu$. Intuitively, matrix completion is possible only if the information spreads evenly throughout the low-rank matrix. This intuition is captured by the incoherence conditions. Formally, denote by $\mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}$ the skinny SVD of a fixed $n_{1} \times n_{2}$ matrix $\mathbf{X}$ of rank $r$. Candès et al. [CLMW11, CR09, Rec11, ZLZ16] introduced the $\mu$-incoherence condition (3) to the low-rank matrix $\mathbf{X}$. For conditions (3), it can be shown that $1 \leq \mu \leq \frac{n_{(1)}}{r}$. The condition holds for many random matrices with incoherence parameter $\mu$ about $\sqrt{r \log n_{(1)}}$ [KMO10a].

We first propose a non-convex optimization problem whose unique solution is indeed the ground truth $\mathbf{X}^{*}$, and then apply our framework to show that strong duality holds for this non-convex optimization and its bi-dual optimization problem.

Theorem 4.1 (Uniqueness of Solution). Let $\Omega \sim \operatorname{Uniform}(m)$ be the support set uniformly distributed among all sets of cardinality $m$. Suppose that $m \geq c \kappa^{2} \mu n_{(1)} r \log n_{(1)} \log _{2 \kappa} n_{(1)}$ for an absolute constant $c$ and $\mathbf{X}^{*}$ obeys $\mu$-incoherence (3). Then $\mathbf{X}^{*}$ is the unique solution of non-convex optimization

$$
\begin{equation*}
\min _{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}, \quad \text { s.t. } \quad \mathcal{P}_{\Omega}(\mathbf{A B})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right), \tag{9}
\end{equation*}
$$

with probability at least $1-n_{(1)}^{-10}$.
Proof Sketch. Here we sketch the proof and defer the details to Appendix F. We consider the feasibility of the matrix completion problem:

Find a matrix $\mathbf{X} \in \mathbb{R}^{n_{1} \times n_{2}}$ such that $\quad \mathcal{P}_{\Omega}(\mathbf{X})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right), \quad \operatorname{rank}(\mathbf{X}) \leq r, \quad\|\mathbf{X}\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}$.
Our proof first identifies a feasibility condition for problem (10), and then shows that $\mathbf{X}^{*}$ is the only matrix which obeys this feasibility condition when the sample size is large enough. More specifically, we note that $\mathbf{X}^{*}$ obeys the conditions in problem (10). Therefore, $\mathbf{X}^{*}$ is the only matrix which obeys condition (10) if and only if $\mathbf{X}^{*}+\mathbf{D}$ does not follow the condition for all $\mathbf{D}$, i.e., $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{\mathbf{0}\}$, where $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right)$ is defined as

$$
\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right)=\left\{\mathbf{X}-\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}: \operatorname{rank}(\mathbf{X}) \leq r,\|\mathbf{X}\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}\right\} .
$$

This can be shown by combining the satisfiability of the dual conditions in Theorem, and the well known fact that $\mathcal{T} \cap \Omega^{\perp}=\{\mathbf{0}\}$ when the sample size is large.

Given the non-convex problem, we are ready to state our main theorem for matrix completion.
Theorem 4.2 (Efficient Matrix Completion). Let $\Omega \sim \operatorname{Uniform}(m)$ be the support set uniformly distributed among all sets of cardinality $m$. Suppose $\mathbf{X}^{*}$ has condition number $\kappa=\sigma_{1}\left(\mathbf{X}^{*}\right) / \sigma_{r}\left(\mathbf{X}^{*}\right)$. Then there are absolute constants $c$ and $c_{0}$ such that with probability at least $1-c_{0} n_{(1)}^{-10}$, the output of the convex problem

$$
\begin{equation*}
\widetilde{\mathbf{X}}=\underset{\mathbf{X}}{\operatorname{argmin}}\|\mathbf{X}\|_{r *}, \quad \text { s.t. } \quad \mathcal{P}_{\Omega}(\mathbf{X})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right), \tag{11}
\end{equation*}
$$

is unique and exact, i.e., $\widetilde{\mathbf{X}}=\mathbf{X}^{*}$, provided that $m \geq c \kappa^{2} \mu r n_{(1)} \log _{2 \kappa}\left(n_{(1)}\right) \log \left(n_{(1)}\right)$ and $\mathbf{X}^{*}$ obeys $\mu$-incoherence (3). Namely, strong duality holds for problem (9). ${ }^{4}$
Proof Sketch. We have shown in Theorem 4.1 that the problem $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=\operatorname{argmin}_{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}$, s.t. $\mathcal{P}_{\Omega}(\mathbf{A B})=$ $\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)$, exactly recovers $\mathbf{X}^{*}$, i.e., $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$, with small sample complexity. So if strong duality holds, this non-convex optimization problem can be equivalently converted to the convex program (11). Then Theorem 4.2 is straightforward from strong duality.

It now suffices to apply our unified framework in Section 3 to prove the strong duality. We show that the dual condition in Theorem 4 holds with high probability by the following arguments. Let $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ be a global solution to problem (11). For $H(\mathbf{X})=\mathbf{I}_{\left\{\mathbf{M} \in \mathbb{R}^{n_{1} \times n_{2}}: \mathcal{P}_{\Omega} \mathbf{M}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\}}(\mathbf{X})$, we have

$$
\begin{aligned}
\Psi & =\partial H(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})=\left\{\mathbf{G} \in \mathbb{R}^{n_{1} \times n_{2}}:\langle\mathbf{G}, \widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\rangle \geq\langle\mathbf{G}, \mathbf{Y}\rangle, \text { for any } \mathbf{Y} \in \mathbb{R}^{n_{1} \times n_{2}} \text { s.t. } \mathcal{P}_{\Omega} \mathbf{Y}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\} \\
& =\left\{\mathbf{G} \in \mathbb{R}^{n_{1} \times n_{2}}:\left\langle\mathbf{G}, \mathbf{X}^{*}\right\rangle \geq\langle\mathbf{G}, \mathbf{Y}\rangle, \text { for any } \mathbf{Y} \in \mathbb{R}^{n_{1} \times n_{2}} \text { s.t. } \mathcal{P}_{\Omega} \mathbf{Y}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\}=\Omega,
\end{aligned}
$$

where the third equality holds since $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$. Then we only need to show
(1) $\widetilde{\Lambda} \in \Omega$,
(2) $\mathcal{P}_{\mathcal{T}}(-\widetilde{\boldsymbol{\Lambda}})=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$,
(3) $\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \widetilde{\boldsymbol{\Lambda}}\right\|<\frac{2}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.

[^4]It is interesting to see that dual condition (12) can be satisfied if the angle $\theta$ between subspace $\Omega$ and subspace $\mathcal{T}$ is very small; see Figure 3. When the sample size $|\Omega|$ becomes larger and larger, the angle $\theta$ becomes smaller and smaller (e.g., when $|\Omega|=n_{1} n_{2}$, the angle $\theta$ is zero as $\Omega=\mathbb{R}^{n_{1} \times n_{2}}$ ). We show that the sample size $m=\Omega\left(\kappa^{2} \mu r n_{(1)} \log _{2 \kappa}\left(n_{(1)}\right) \log \left(n_{(1)}\right)\right)$ is a sufficient condition for condition (12) to hold.

This positive result matches a lower bound from prior work up to a logarithmic factor, which shows that the sample complexity in Theorem 4.1 is nearly optimal.

Theorem 4.3 (Information-Theoretic Lower Bound. [CT10], Theorem 1.7). Denote by $\Omega \sim \operatorname{Uniform}(m)$ the support set uniformly distributed among all sets of cardinality $m$. Suppose that $m \leq c \mu n_{(1)} r \log n_{(1)}$ for an absolute constant $c$. Then there exist infinitely many $n_{1} \times n_{2}$ matrices $\mathbf{X}^{\prime}$ of rank at most $r$ obeying $\mu$-incoherence (3) such that $\mathcal{P}_{\Omega}\left(\mathbf{X}^{\prime}\right)=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)$, with probability at least $1-n_{(1)}^{-10}$.

## 5 Robust Principal Component Analysis

In this section, we develop our theory for robust PCA based on our framework. In the problem of robust PCA, we are given an observed matrix of the form $\mathbf{D}=\mathbf{X}^{*}+\mathbf{S}^{*}$, where $\mathbf{X}^{*}$ is the ground-truth matrix and $\mathbf{S}^{*}$ is the corruption matrix which is sparse. The goal is to recover the hidden matrices $\mathbf{X}^{*}$ and $\mathbf{S}^{*}$ from the observation D. We set $H(\mathbf{X})=\lambda\|\mathbf{D}-\mathbf{X}\|_{1}$.

To make the information spreads evenly throughout the matrix, the matrix cannot have one entry whose absolute value is significantly larger than other entries. For the robust PCA problem, Candès et al. [CLMW11] introduced an extra incoherence condition (Recall that $\mathbf{X}^{*}=\mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}$ is the skinny SVD of $\mathbf{X}^{*}$ )

$$
\begin{equation*}
\left\|\mathbf{U} \mathbf{V}^{T}\right\|_{\infty} \leq \sqrt{\frac{\mu r}{n_{1} n_{2}}} \tag{13}
\end{equation*}
$$

In this work, we make the following incoherence assumption for robust PCA instead of (13):

$$
\begin{equation*}
\left\|\mathbf{X}^{*}\right\|_{\infty} \leq \sqrt{\frac{\mu r}{n_{1} n_{2}}} \sigma_{r}\left(\mathbf{X}^{*}\right) \tag{14}
\end{equation*}
$$

Note that condition (14) is very similar to the incoherence condition (13) for the robust PCA problem, but the two notions are incomparable. Note that condition (14) has an intuitive explanation, namely, that the entries must scatter almost uniformly across the low-rank matrix.

We have the following results for robust PCA.
Theorem 5.1 (Robust PCA). Suppose $\mathbf{X}^{*}$ is an $n_{1} \times n_{2}$ matrix of rank $r$, and obeys incoherence (3) and (14). Assume that the support set $\Omega$ of $\mathbf{S}^{*}$ is uniformly distributed among all sets of cardinality $m$. Then with probability at least $1-\mathrm{cn}_{(1)}^{-10}$, the output of the optimization problem

$$
(\widetilde{\mathbf{X}}, \widetilde{\mathbf{S}})=\underset{\mathbf{X}, \mathbf{S}}{\operatorname{argmin}}\|\mathbf{X}\|_{r *}+\lambda\|\mathbf{S}\|_{1}, \quad \text { s.t. } \quad \mathbf{D}=\mathbf{X}+\mathbf{S},
$$

with $\lambda=\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{\sqrt{n_{(1)}}}$ is exact, namely, $\widetilde{\mathbf{X}}=\mathbf{X}^{*}$ and $\widetilde{\mathbf{S}}=\mathbf{S}^{*}$, provided that $\operatorname{rank}\left(\mathbf{X}^{*}\right) \leq \rho_{r} \frac{n_{(2)}}{\mu \log ^{2} n_{(1)}}$ and $m \leq$ $\rho_{s} n_{1} n_{2}$, where $c, \rho_{r}$, and $\rho_{s}$ are all positive absolute constants, and function $\|\cdot\|_{r *}$ is given by (15).

The bounds on the rank of $\mathbf{X}^{*}$ and the sparsity of $\mathbf{S}^{*}$ in Theorem 5.1 match the best known results for robust PCA in prior work when we assume the support set of $\mathbf{S}^{*}$ is sampled uniformly [CLMW11].

## 6 Computational Aspects

Computational Efficiency. We discuss our computational efficiency given that we have strong duality. We note that the dual and bi-dual of primal problem $(\mathbf{P})$ are given by (see Appendix J)

$$
\begin{array}{ll}
\text { (Dual, D1) } & \max _{\boldsymbol{\Lambda} \in \mathbb{R}^{n_{1} \times n_{2}}}-H^{*}(\boldsymbol{\Lambda})-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{r}^{2}, \quad \text { where }\|\boldsymbol{\Lambda}\|_{r}^{2}=\sum_{i=1}^{r} \sigma_{i}^{2}(\boldsymbol{\Lambda}),  \tag{15}\\
\text { (Bi-Dual, D2) } & \min _{\mathbf{M} \in \mathbb{R}^{n_{1} \times n_{2}}} H(\mathbf{M})+\|\mathbf{M}\|_{r *}, \quad \text { where }\|\mathbf{M}\|_{r *}=\max _{\mathbf{X}}\langle\mathbf{M}, \mathbf{X}\rangle-\frac{1}{2}\|\mathbf{X}\|_{r}^{2} .
\end{array}
$$

Problems (D1) and (D2) can be solved efficiently due to their convexity. In particular, Grussler et al. [GRG16] provided a computationally efficient algorithm to compute the proximal operators of functions $\frac{1}{2}\|\cdot\|_{r}^{2}$ and $\|\cdot\|_{r *}$. Hence, the Douglas-Rachford algorithm can find global minimum up to an $\epsilon$ error in function value in time poly ( $1 / \epsilon$ ) [HY12].
Computational Lower Bounds. Unfortunately, strong duality does not always hold for general non-convex problems ( $\mathbf{P}$ ). Here we present a very strong lower bound based on the random 4-SAT hypothesis. This is by now a fairly standard conjecture in complexity theory [Fei02] and gives us constant factor inapproximability of problem ( $\mathbf{P}$ ) for deterministic algorithms, even those running in exponential time.

If we additionally assume that BPP $=P$, where BPP is the class of problems which can be solved in probabilistic polynomial time, and P is the class of problems which can be solved in deterministic polynomial time, then the same conclusion holds for randomized algorithms. This is also a standard conjecture in complexity theory, as it is implied by the existence of certain strong pseudorandom generators or if any problem in deterministic exponential time has exponential size circuits [IW97]. Therefore, any subexponential time algorithm achieving a sufficiently small constant factor approximation to problem $(\mathbf{P})$ in general would imply a major breakthrough in complexity theory.

The lower bound is proved by a reduction from the Maximum Edge Biclique problem [AMS11]. The details are presented in Appendix I.

Theorem 6.1 (Computational Lower Bound). Assume Conjecture 1 (the hardness of Random 4-SAT). Then there exists an absolute constant $\epsilon_{0}>0$ for which any deterministic algorithm achieving $(1+\epsilon)$ OPT in the objective function value for problem $(\mathbf{P})$ with $\epsilon \leq \epsilon_{0}$, requires $2^{\Omega\left(n_{1}+n_{2}\right)}$ time, where OPT is the optimum. If in addition, $\mathrm{BPP}=\mathrm{P}$, then the same conclusion holds for randomized algorithms succeeding with probability at least $2 / 3$.

Proof Sketch. Theorem 6.1 is proved by using the hypothesis that random 4-SAT is hard to show hardness of the Maximum Edge Biclique problem for deterministic algorithms. We then do a reduction from the Maximum Edge Biclique problem to our problem.

The complete proofs of other theorems/lemmas and related work can be found in the appendices.

## A Other Related Work

Non-convex matrix factorization is a popular topic studied in theoretical computer science [JNS13, Har14, SL15, RSW16], machine learning [BNS16, GLM16, GHJY15, JMD10, LLR16], and optimization [WYZ12, SWZ14]. We review several lines of research on studying the global optimality of such optimization problems.

Global Optimality of Matrix Factorization. While lots of matrix factorization problems have been shown to have no spurious local minima, they either require additional conditions on the local minima, or are based on particular forms of the objective function. Specifically, Burer and Monteiro [BM05] showed that one can minimize $F\left(\mathbf{A A}^{T}\right)$ for any convex function $F$ by solving for $\mathbf{A}$ directly without introducing any local minima, provided that the rank of the output $\mathbf{A}$ is larger than the rank of the true minimizer $\mathbf{X}_{\text {true }}$. However, such a condition is often impossible to check as $\operatorname{rank}\left(\mathbf{X}_{\text {true }}\right)$ is typically unknown a priori. To resolve the issue, Bach et al. [BMP08] and Journée et al. [JBAS10] proved that $\mathbf{X}=\mathbf{A} \mathbf{A}^{T}$ is a global minimizer of $F(\mathbf{X})$, if $\mathbf{A}$ is a rank-deficient local minimizer of $F\left(\mathbf{A A}^{T}\right)$ and $F(\mathbf{X})$ is a twice differentiable convex function. Haeffele and Vidal [HV15] further extended this result by allowing a more general form of objective function $F(\mathbf{X})=G(\mathbf{X})+H(\mathbf{X})$, where $G$ is a twice differentiable convex function with compact level set and $H$ is a proper convex function such that $F$ is lower semi-continuous. However, a major drawback of this line of research is that these result fails when the local minimizer is of full rank.

Matrix Completion. Matrix completion is a prototypical example of matrix factorization. One line of work on matrix completion builds on convex relaxation (e.g., [SS05, CR09, CT10, Rec11, CRPW12, NW12]). Recently, Ge et al. [GLM16] showed that matrix completion has no spurious local optimum, when $|\Omega|$ is sufficiently large and the matrix $\mathbf{Y}$ is incoherent. The result is only for positive semi-definite matrices and their sample complexity is not nearly optimal.

Another line of work is built upon good initialization for global convergence. Recent attempts showed that one can first compute some form of initialization (e.g., by singular value decomposition) that is close to the global minimizer and then use non-convex approaches to reach global optimality, such as alternating minimization, block coordinate descent, and gradient descent [KMO10b, KMO10a, JNS13, Kes12, Har14, BKS16, ZL15, ZWL15, TBSR15, CW15, SL15]. In our result, in contrast, we can reformulate non-convex matrix completion problems as equivalent convex programs, which guarantees global convergence from any initialization.

Robust PCA. Robust PCA is also a prototypical example of matrix factorization. The goal is to recover both the low-rank and the sparse components exactly from their superposition [CLMW11, NNS ${ }^{+}$14, GWL16, ZLZC15, ZLZ16, YPCC16]. It has been widely applied to various tasks, such as video denoising, background modeling, image alignment, photometric stereo, texture representation, subspace clustering, and spectral clustering.

There are typically two settings in the robust PCA literature: a) the support set of the sparse matrix is uniformly sampled [CLMW11, ZLZ16]; b) the support set of the sparse matrix is deterministic, but the non-zero entries in each row or column of the matrix cannot be too large [YPCC16, GJY17]. In this work, we discuss the first case. Our framework provides results that match the best known work in setting (b) [CLMW11].

Other Matrix Factorization Problems. Matrix sensing is another typical matrix factorization problem [CRPW12, JNS13, ZWL15]. Bhojanapalli et al. [BNS16] and Tu et al. [TBSR15] showed that the matrix recovery model $\min _{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|\mathcal{A}(\mathbf{A B}-\mathbf{Y})\|_{F}^{2}$, achieves optimality for every local minimum, if the operator $\mathcal{A}$ satisfies the restricted isometry property. They further gave a lower bound and showed that the unstructured operator $\mathcal{A}$ may easily lead to a local minimum which is not globally optimal.

Some other matrix factorization problems are also shown to have nice geometric properties such as the property that all local minima are global minima. Examples include dictionary learning [SQW17a], phase
retrieval [SQW16], and linear deep neural networks [Kaw16]. In multi-layer linear neural networks where the goal is to learn a multi-linear projection $\mathbf{X}^{*}=\prod_{i} \mathbf{W}_{i}$, each $\mathbf{W}_{i}$ represents the weight matrix that connects the hidden units in the $i$-th and $(i+1)$-th layers. The study of such linear models is central to the theoretical understanding of the loss surface of deep neural networks with non-linear activation functions [Kaw16, $\left.\mathrm{CHM}^{+} 15\right]$. In dictionary learning, we aim to recover a complete (i.e., square and invertible) dictionary matrix $\mathbf{A}$ from a given signal $\mathbf{X}$ in the form of $\mathbf{X}=\mathbf{A B}$, provided that the representation coefficient $\mathbf{B}$ is sufficiently sparse. This problem centers around solving a non-convex matrix factorization problem with a sparsity constraint on the representation coefficient B [BMP08, SQW17a, SQW17b, ABGM14]. Other high-impact examples of matrix factorization models range from the classic unsupervised learning problems like PCA, independent component analysis, and clustering, to the more recent problems such as non-negative matrix factorization, weighted low-rank matrix approximation, sparse coding, tensor decomposition [BCMV14, $\mathrm{AGH}^{+}$14], subspace clustering [ZLZG15, ZLZG14], etc. Applying our framework to these other problems is left for future work.

Atomic Norms. The atomic norm is a recently proposed function for linear inverse problems [CRPW12]. Many well-known norms, e.g., the $\ell_{1}$ norm and the nuclear norm, serve as special cases of atomic norms. It has been widely applied to the problems of compressed sensing [TBSR13], low-rank matrix recovery [CR13], blind deconvolution [ARR14], etc. The norm is defined by the Minkowski functional associated with the convex hull of a set $\mathcal{A}:\|\mathbf{X}\|_{\mathcal{A}}=\inf \{t>0: \mathbf{X} \in t \mathcal{A}\}$. In particular, if we set $\mathcal{A}$ to be the convex hull of the infinite set of unit- $\ell_{2}$-norm rank-one matrices, then $\|\cdot\|_{\mathcal{A}}$ equals to the nuclear norm. We mention that our objective term $\|\mathbf{A B}\|_{F}$ in problem (1) is similar to the atomic norm, but with slight differences: unlike the atomic norm, we set $\mathcal{A}$ to be the infinite set of unit- $\ell_{2}$-norm rank- $r$ matrices for $\operatorname{rank}(\mathbf{X}) \leq r$. With this, we achieve better sample complexity guarantees than the atomic-norm based methods.

## B Proof of Lemma 3.1

Lemma 3.1 (Restated). For any given matrix $\widehat{\mathbf{Y}} \in \mathbb{R}^{n_{1} \times n_{2}}$, any local minimum of $f(\mathbf{A}, \mathbf{B})=\frac{1}{2}\|\widehat{\mathbf{Y}}-\mathbf{A B}\|_{F}^{2}$ over $\mathbf{A} \in \mathbb{R}^{n_{1} \times r}$ and $\mathbf{B} \in \mathbb{R}^{r \times n_{2}}\left(r \leq \min \left\{n_{1}, n_{2}\right\}\right)$ is globally optimal, given by $\operatorname{svd}_{r}(\widehat{\mathbf{Y}})$. The objective function $f(\mathbf{A}, \mathbf{B})$ around any saddle point has a negative second-order directional curvature. Moreover, $f(\mathbf{A}, \mathbf{B})$ has no local maximum.

Proof. (A,B) is a critical point of $f(\mathbf{A}, \mathbf{B})$ if and only if $\nabla_{\mathbf{A}} f(\mathbf{A}, \mathbf{B})=\mathbf{0}$ and $\nabla_{\mathbf{B}} f(\mathbf{A}, \mathbf{B})=\mathbf{0}$, or equivalently,

$$
\begin{equation*}
\mathbf{A B B}^{T}=\widehat{\mathbf{Y}} \mathbf{B}^{T} \quad \text { and } \quad \mathbf{A}^{T} \mathbf{A B}=\mathbf{A}^{T} \widehat{\mathbf{Y}} \tag{16}
\end{equation*}
$$

Note that for any fixed matrix $\mathbf{A}$ (resp. B), the function $f(\mathbf{A}, \mathbf{B})$ is convex in the coefficients of $\mathbf{B}$ (resp. A). To prove the desired lemma, we have the following claim.

Claim 1. If two matrices $\mathbf{A}$ and $\mathbf{B}$ define a critical point of $f(\mathbf{A}, \mathbf{B})$, then the global mapping $\mathbf{M}=\mathbf{A B}$ is of the form

$$
\mathbf{M}=\mathcal{P}_{\mathbf{A}} \widehat{\mathbf{Y}},
$$

with A satisfying

$$
\begin{equation*}
\mathbf{A A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}=\mathbf{A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger}=\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger} \tag{17}
\end{equation*}
$$

Proof. If A and $\mathbf{B}$ define a critical point of $f(\mathbf{A}, \mathbf{B})$, then (16) holds and the general solution to (16) satisfies

$$
\begin{equation*}
\mathbf{B}=\left(\mathbf{A}^{T} \mathbf{A}\right)^{\dagger} \mathbf{A}^{T} \widehat{\mathbf{Y}}+\left(\mathbf{I}-\mathbf{A}^{\dagger} \mathbf{A}\right) \mathbf{L} \tag{18}
\end{equation*}
$$

for some matrix $\mathbf{L}$. So $\mathbf{M}=\mathbf{A B}=\mathbf{A}\left(\mathbf{A}^{T} \mathbf{A}\right)^{\dagger} \mathbf{A}^{T} \widehat{\mathbf{Y}}=\mathbf{A} \mathbf{A}^{\dagger} \widehat{\mathbf{Y}}=\mathcal{P}_{\mathbf{A}} \widehat{\mathbf{Y}}$ by the property of the MoorePenrose pseudo-inverse: $\mathbf{A}^{\dagger}=\left(\mathbf{A}^{T} \mathbf{A}\right)^{\dagger} \mathbf{A}^{T}$.

By (16), we also have

$$
\mathbf{A B B} \mathbf{B}^{T} \mathbf{A}^{T}=\widehat{\mathbf{Y}} \mathbf{B}^{T} \mathbf{A}^{T} \quad \text { or equivalently } \quad \mathbf{M} \mathbf{M}^{T}=\widehat{\mathbf{Y}} \mathbf{M}^{T} .
$$

Plugging in the relation $\mathbf{M}=\mathbf{A} \mathbf{A}^{\dagger} \widehat{\mathbf{Y}}$, (B) can be rewritten as

$$
\mathbf{A} \mathbf{A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger}=\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger}
$$

Note that the matrix $\mathbf{A} \mathbf{A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger}$ is symmetric. Thus

$$
\mathbf{A A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \mathbf{A} \mathbf{A}^{\dagger}=\mathbf{A} \mathbf{A}^{\dagger} \widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}
$$

as desired.
To prove Lemma 3.1, we also need the following claim.
Claim 2. Denote by $\mathcal{I}=\left\{i_{1}, i_{2}, \ldots, i_{r}\right\}$ any ordered $r$-index set (ordered by $\lambda_{i_{j}}, j \in[r]$ from the largest to the smallest) and $\lambda_{i}, i \in\left[n_{1}\right]$, the ordered eigenvalues of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \in \mathbb{R}^{n_{1} \times n_{1}}$ with $p$ distinct values. Let $\mathbf{U}=\left[\mathbf{u}_{1}, \mathbf{u}_{2}, \ldots, \mathbf{u}_{n_{1}}\right]$ denote the matrix formed by the orthonormal eigenvectors of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T} \in \mathbb{R}^{n_{1} \times n_{1}}$ associated with the ordered $p$ eigenvalues, whose multiplicities are $m_{1}, m_{2}, \ldots, m_{p}\left(m_{1}+m_{2}+\ldots+m_{p}=n_{1}\right)$. For any matrix $\mathbf{M}$, let $\mathbf{M}_{: \mathcal{I}}$ denote the submatrix $\left[\mathbf{M}_{i_{1}}, \mathbf{M}_{i_{2}}, \ldots, \mathbf{M}_{i_{r}}\right]$ associated with the index set $\mathcal{I}$.

Then two matrices $\mathbf{A}$ and $\mathbf{B}$ define a critical point of $f(\mathbf{A}, \mathbf{B})$ if and only if there exists an ordered $r$-index set $\mathcal{I}$, an invertible matrix $\mathbf{C}$, and an $r \times n$ matrix $\mathbf{L}$ such that

$$
\begin{equation*}
\mathbf{A}=(\mathbf{U D})_{: \mathcal{I}} \mathbf{C} \quad \text { and } \quad \mathbf{B}=\mathbf{A}^{\dagger} \widehat{\mathbf{Y}}+\left(\mathbf{I}-\mathbf{A}^{\dagger} \mathbf{A}\right) \mathbf{L} \tag{19}
\end{equation*}
$$

where $\mathbf{D}$ is a p-block-diagonal matrix with each block corresponding to the eigenspace of an eigenvalue. For such a critical point, we have

$$
\begin{gather*}
\mathbf{A B}=\mathcal{P}_{\mathbf{A}} \widehat{\mathbf{Y}}, \\
f(\mathbf{A}, \mathbf{B})=\frac{1}{2}\left(\operatorname{tr}\left(\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}\right)-\sum_{i \in \mathcal{I}} \lambda_{i}\right)=\frac{1}{2} \sum_{i \notin \mathcal{I}} \lambda_{i} . \tag{20}
\end{gather*}
$$

Proof. Note that $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}$ is a real symmetric covariance matrix. So it can always be represented as $\mathbf{U} \boldsymbol{\Lambda} \mathbf{U}^{T}$, where $\mathbf{U} \in \mathbb{R}^{n_{1} \times n_{1}}$ is an orthonormal matrix consisting of eigenvectors of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}$ and $\boldsymbol{\Lambda} \in \mathbb{R}^{n_{1} \times n_{1}}$ is a diagonal matrix with non-increasing eigenvalues of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}$.

If $\mathbf{A}$ and $\mathbf{B}$ satisfy (19) for some $\mathbf{C}, \mathbf{L}$, and $\mathcal{I}$, then

$$
\mathbf{A B B} \mathbf{B}^{T}=\widehat{\mathbf{Y}} \mathbf{B}^{T} \quad \text { and } \quad \mathbf{A}^{T} \mathbf{A B}=\mathbf{A}^{T} \widehat{\mathbf{Y}}
$$

which is (16). So $\mathbf{A}$ and $\mathbf{B}$ define a critical point of $f(\mathbf{A}, \mathbf{B})$.
For the converse, notice that

$$
\mathcal{P}_{\mathbf{U}^{T} \mathbf{A}}=\mathbf{U}^{T} \mathbf{A}\left(\mathbf{U}^{T} \mathbf{A}\right)^{\dagger}=\mathbf{U}^{T} \mathbf{A} \mathbf{A}^{\dagger} \mathbf{U}=\mathbf{U}^{T} \mathcal{P}_{\mathbf{A}} \mathbf{U}
$$

or equivalently, $\mathcal{P}_{\mathbf{A}}=\mathbf{U} \mathcal{P}_{\mathbf{U}^{T} \mathbf{A}} \mathbf{U}^{T}$. Thus (17) yields

$$
\mathbf{U} \mathcal{P}_{\mathbf{U}^{T} \mathbf{A}} \mathbf{U}^{T} \mathbf{U} \boldsymbol{\Lambda} \mathbf{U}^{T}=\mathbf{U} \boldsymbol{\Lambda} \mathbf{U}^{T} \mathbf{U} \mathcal{P}_{\mathbf{U}^{T} \mathbf{A}} \mathbf{U}^{T},
$$

or equivalently, $\mathcal{P}_{\mathbf{U}^{T} \mathbf{A}} \boldsymbol{\Lambda}=\boldsymbol{\Lambda} \mathcal{P}_{\mathbf{U}^{T} \mathbf{A}}$. Notice that $\boldsymbol{\Lambda} \in \mathbb{R}^{n_{1} \times n_{1}}$ is a diagonal matrix with $p$ distinct eigenvalues of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}$, and $\mathcal{P}_{\mathbf{U}^{T} \mathbf{A}}$ is an orthogonal projector of rank $r$. So $\mathcal{P}_{\mathbf{U}^{T} \mathbf{A}}$ is a rank- restriction of the blockdiagonal PSD matrix $\mathbf{F}:=\mathbf{T T}^{T}$ with $p$ blocks, each of which is an orthogonal projector of dimension $m_{i}$,
corresponding to the eigenvalues $\lambda_{i}, i \in[p]$. Therefore, there exists an $r$-index set $\mathcal{I}$ and a block-diagonal matrix $\mathbf{D}$ such that $\mathcal{P}_{\mathbf{U}^{T} \mathbf{A}}=\mathbf{D}_{: \mathcal{I}} \mathbf{D}_{: \mathcal{I}}^{T}$, where $\mathbf{D}=\mathbf{T}$. It follows that

$$
\mathcal{P}_{\mathbf{A}}=\mathbf{U} \mathcal{P}_{\mathbf{U}^{T} \mathbf{A}} \mathbf{U}^{T}=\mathbf{U} \mathbf{D}_{: \mathcal{I}} \mathbf{D}_{: \mathcal{I}}^{T} \mathbf{U}^{T}=(\mathbf{U D})_{: \mathcal{I}}(\mathbf{U D})_{: \mathcal{I}}^{T} .
$$

Since the column space of $\mathbf{A}$ coincides with the column space of $(\mathbf{U D})_{: \mathcal{I}}, \mathbf{A}$ is of the form $\mathbf{A}=(\mathbf{U D})_{: \mathcal{I}} \mathbf{C}$, and $\mathbf{B}$ is given by (18). Thus $\mathbf{A B}=\mathbf{A}\left(\mathbf{A}^{T} \mathbf{A}\right)^{\dagger} \mathbf{A}^{T} \widehat{\mathbf{Y}}+\mathbf{A}\left(\mathbf{I}-\mathbf{A}^{\dagger} \mathbf{A}\right) \mathbf{L}=\mathcal{P}_{\mathbf{A}} \widehat{\mathbf{Y}}$ and

$$
\begin{aligned}
f(\mathbf{A}, \mathbf{B}) & =\frac{1}{2}\|\widehat{\mathbf{Y}}-\mathbf{A B}\|_{F}^{2} \\
& =\frac{1}{2}\left\|\widehat{\mathbf{Y}}-\mathcal{P}_{\mathbf{A}} \widehat{\mathbf{Y}}\right\|_{F}^{2} \\
& =\frac{1}{2}\left\|\mathcal{P}_{\mathbf{A}^{\perp}} \widehat{\mathbf{Y}}\right\|_{F}^{2} \\
& =\frac{1}{2} \sum_{i \notin \mathcal{I}} \lambda_{i} .
\end{aligned}
$$

The claim is proved.
So the local minimizer of $f(\mathbf{A}, \mathbf{B})$ is given by (19) with $\mathcal{I}$ such that $\left(\lambda_{i_{1}}, \lambda_{i_{2}}, \ldots, \lambda_{i_{r}}\right)=\Phi$, where $\Phi$ is the sequence of the $r$ largest eigenvalues of $\widehat{\mathbf{Y}} \widehat{\mathbf{Y}}^{T}$. Such a local minimizer is globally optimal according to (20). We then show that when $\mathcal{I}$ consists of other combinations of indices of eigenvalues, i.e., $\left(\lambda_{i_{1}}, \lambda_{i_{2}}, \ldots, \lambda_{i_{r}}\right) \neq \Phi$, the corresponding pair ( $\mathbf{A}, \mathbf{B}$ ) given by (19) is a strict saddle point.

Claim 3. If $\mathcal{I}$ is such that $\left(\lambda_{i_{1}}, \lambda_{i_{2}}, \ldots, \lambda_{i_{r}}\right) \neq \Phi$, then the pair $(\mathbf{A}, \mathbf{B})$ given by (19) is a strict saddle point.
Proof. If $\left(\lambda_{i_{1}}, \lambda_{i_{2}}, \ldots, \lambda_{i_{r}}\right) \neq \Phi$, then there exists a $i$ such that $\lambda_{i_{i}}$ does not equal the $i$-th element $\lambda_{i}$ of $\Phi$. Denote by $\mathbf{U D}=\mathbf{R}$. It is enough to slightly perturb the column space of $\mathbf{A}$ towards the direction of an eigenvector of $\lambda_{i}$. More precisely, let $j$ is the largest index in $\mathcal{I}$. For any $\epsilon$, let $\widetilde{\mathbf{R}}$ be the matrix such that $\widetilde{\mathbf{R}}_{: k}=\mathbf{R}_{: k}(k \neq j)$ and $\widetilde{\mathbf{R}}_{: j}=\left(1+\epsilon^{2}\right)^{-1 / 2}\left(\mathbf{R}_{: j}+\epsilon \mathbf{R}_{: i}\right)$. Let $\widetilde{\mathbf{A}}=\widetilde{\mathbf{R}}_{\mathcal{I}} \mathbf{C}$ and $\widetilde{\mathbf{B}}=\widetilde{\mathbf{A}}^{\dagger} \mathbf{Y}+\left(\mathbf{I}-\widetilde{\mathbf{A}}^{\dagger} \widetilde{\mathbf{A}}\right) \mathbf{L}$. A direct calculation shows that

$$
f(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=f(\mathbf{A}, \mathbf{B})-\epsilon^{2}\left(\lambda_{i}-\lambda_{j}\right) /\left(2+2 \epsilon^{2}\right) .
$$

Hence,

$$
\lim _{\epsilon \rightarrow 0} \frac{f(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})-f(\mathbf{A}, \mathbf{B})}{\epsilon^{2}}=-\frac{1}{2}\left(\lambda_{i}-\lambda_{j}\right)<0,
$$

and thus the pair $(\mathbf{A}, \mathbf{B})$ is a strict saddle point.
Note that all critical points of $f(\mathbf{A}, \mathbf{B})$ are in the form of (19), and if $\mathcal{I} \neq \Phi$, the pair $(\mathbf{A}, \mathbf{B})$ given by (19) is a strict saddle point, while if $\mathcal{I}=\Phi$, then the pair $(\mathbf{A}, \mathbf{B})$ given by (19) is a local minimum. We conclude that $f(\mathbf{A}, \mathbf{B})$ has no local maximum. The proof is completed.

## C Proof of Lemma 3.2

Lemma 3.2 (Restated). Let $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ be a global minimizer of $F(\mathbf{A}, \mathbf{B})$. If there exists a dual certificate $\widetilde{\mathbf{A}}$ as in Condition 1 such that the pair $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ is a local minimizer of $L(\mathbf{A}, \mathbf{B}, \widetilde{\mathbf{\Lambda}})$ for the fixed $\widetilde{\mathbf{\Lambda}}$, then strong duality holds. Moreover, we have the relation $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}})$.

Proof. By the assumption of the lemma, $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ is a local minimizer of $L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})=\frac{1}{2}\|-\widetilde{\mathbf{\Lambda}}-\mathbf{A B}\|_{F}^{2}+$ $c(\widetilde{\mathbf{\Lambda}})$, where $c(\widetilde{\mathbf{\Lambda}})$ is a function that is independent of $\mathbf{A}$ and $\mathbf{B}$. So according to Lemma $3.1,(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=$ $\operatorname{argmin}_{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}})$, namely, $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ globally minimizes $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$ when $\boldsymbol{\Lambda}$ is fixed to $\widetilde{\boldsymbol{\Lambda}}$. Furthermore, $\left.\widetilde{\boldsymbol{\Lambda}} \in \partial_{\mathbf{X}} H(\mathbf{X})\right|_{\mathbf{X}=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}}$ implies that $\left.\widetilde{\mathbf{A}} \widetilde{\mathbf{B}} \in \partial_{\boldsymbol{\Lambda}} H^{*}(\boldsymbol{\Lambda})\right|_{\boldsymbol{\Lambda}=\widetilde{\boldsymbol{\Lambda}}}$ by the convexity of function $H$, meaning that $\mathbf{0} \in \partial_{\boldsymbol{\Lambda}} L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \boldsymbol{\Lambda})$. So $\widetilde{\boldsymbol{\Lambda}}=\operatorname{argmax}_{\boldsymbol{\Lambda}} L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \boldsymbol{\Lambda})$ due to the concavity of $L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \boldsymbol{\Lambda})$ w.r.t. variable $\boldsymbol{\Lambda}$. Thus $(\mathbf{A}, \widetilde{\mathbf{B}}, \widetilde{\boldsymbol{\Lambda}})$ is a primal-dual saddle point of $L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$.

We now prove the strong duality. By the fact that $F(\mathbf{A}, \mathbf{B})=\max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$ and that $\widetilde{\boldsymbol{\Lambda}}=$ $\operatorname{argmax}_{\boldsymbol{\Lambda}} L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \boldsymbol{\Lambda})$, we have

$$
F(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=L(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \tilde{\boldsymbol{\Lambda}}) \leq L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}}), \forall \mathbf{A}, \mathbf{B} .
$$

where the inequality holds because $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}, \widetilde{\mathbf{\Lambda}})$ is a primal-dual saddle point of $L$. So on the one hand, we have

$$
\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=F(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}}) \leq \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}}) \leq \max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}) .
$$

On the other hand, by weak duality,

$$
\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}) \geq \max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda}) .
$$

Therefore, $\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})=\max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} L(\mathbf{A}, \mathbf{B}, \boldsymbol{\Lambda})$, i.e., strong duality holds. Hence,

$$
\begin{aligned}
\widetilde{\mathbf{A}} \widetilde{\mathbf{B}} & =\underset{\mathbf{A B}}{\operatorname{argmin}} L(\mathbf{A}, \mathbf{B}, \widetilde{\boldsymbol{\Lambda}}) \\
& =\underset{\mathbf{A B}}{\operatorname{argmin}} \frac{1}{2}\|-\widetilde{\boldsymbol{\Lambda}}-\mathbf{A B}\|_{F}^{2}-\frac{1}{2}\|\widetilde{\boldsymbol{\Lambda}}\|_{F}^{2}-H^{*}(\widetilde{\boldsymbol{\Lambda}}) \\
& =\underset{\mathbf{A B}}{\operatorname{argmin}} \frac{1}{2}\|-\widetilde{\boldsymbol{\Lambda}}-\mathbf{A B}\|_{F}^{2} \\
& =\operatorname{svd}_{r}(-\widetilde{\boldsymbol{\Lambda}}),
\end{aligned}
$$

as desired.

## D Existence of Dual Certificate for Matrix Completion

Let $\widetilde{\mathbf{A}} \in \mathbb{R}^{n_{1} \times r}$ and $\widetilde{\mathbf{B}} \in \mathbb{R}^{r \times n_{2}}$ such that $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$. Then we have the following lemma.
Lemma D.1. Let $\Omega \sim \operatorname{Uniform}(m)$ be the support set uniformly distributed among all sets of cardinality $m$. Suppose that $m \geq c \kappa^{2} \mu n_{(1)} r \log n_{(1)} \log _{2 \kappa} n_{(1)}$ for an absolute constant $c$ and $\mathbf{X}^{*}$ obeys $\mu$-incoherence (3). Then there exists $\widetilde{\boldsymbol{\Lambda}}$ such that
(1) $\tilde{\Lambda} \in \Omega$,
(2) $\mathcal{P}_{\mathcal{T}}(-\widetilde{\boldsymbol{\Lambda}})=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$,
(3) $\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \widetilde{\boldsymbol{\Lambda}}\right\|<\frac{2}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.
with probability at least $1-n_{(1)}^{-10}$.
The rest of the section is denoted to the proof of Lemma D.1. We begin with the following lemma.

Lemma D.2. If we can construct an $\boldsymbol{\Lambda}$ such that
(a) $\quad \boldsymbol{\Lambda} \in \Omega$,
(b) $\quad\left\|\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right\|_{F} \leq \sqrt{\frac{r}{3 n_{(1)}^{2}}} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$,
(c) $\quad\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}\right\|<\frac{1}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$,
then we can construct an $\widetilde{\boldsymbol{\Lambda}}$ such that Eqn. (21) holds with probability at least $1-n_{(1)}^{-10}$.
Proof. To prove the lemma, we first claim the following theorem.
Theorem D. 3 ([CR09], Theorem 4.1). Assume that $\Omega$ is sampled according to the Bernoulli model with success probability $p=\Theta\left(\frac{m}{n_{1} n_{2}}\right)$, and incoherence condition (3) holds. Then there is an absolute constant $C_{R}$ such that for $\beta>1$, we have

$$
\left\|p^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}-\mathcal{P}_{\mathcal{T}}\right\| \leq C_{R} \sqrt{\frac{\beta \mu n_{(1)} r \log n_{(1)}}{m}} \triangleq \epsilon
$$

with probability at least $1-3 n^{-\beta}$ provided that $C_{R} \sqrt{\frac{\beta \mu n_{(1)} r \log n_{(1)}}{m}}<1$.
Suppose that Condition (22) holds. Let $\mathbf{Y}=\widetilde{\boldsymbol{\Lambda}}-\boldsymbol{\Lambda} \in \Omega$ be the perturbation matrix between $\boldsymbol{\Lambda}$ and $\widetilde{\boldsymbol{\Lambda}}$ such that $\mathcal{P}_{\mathcal{T}}(-\widetilde{\boldsymbol{\Lambda}})=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$. Such a $\mathbf{Y}$ exists by setting $\mathbf{Y}=\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{-1}\left(\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right)$. So $\left\|\mathcal{P}_{\mathcal{T}} \mathbf{Y}\right\|_{F} \leq \sqrt{\frac{r}{3 n_{(1)}^{2}}} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$. We now prove Condition (3) in Eqn. (21). Observe that

$$
\begin{align*}
\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \widetilde{\boldsymbol{\Lambda}}\right\| & \leq\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}\right\|+\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}\right\| \\
& \leq \frac{1}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})+\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}\right\| . \tag{23}
\end{align*}
$$

So we only need to show $\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}\right\| \leq \frac{1}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.
Before proceeding, we begin by introducing a normalized version $\mathcal{Q}_{\Omega}: \mathbb{R}^{n_{1} \times n_{2}} \rightarrow \mathbb{R}^{n_{1} \times n_{2}}$ of $\mathcal{P}_{\Omega}$ :

$$
\mathcal{Q}_{\Omega}=p^{-1} \mathcal{P}_{\Omega}-\mathcal{I}
$$

With this, we have

$$
\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}=p \mathcal{P}_{\mathcal{T}}\left(\mathcal{I}+\mathcal{Q}_{\Omega}\right) \mathcal{P}_{\mathcal{T}} .
$$

Note that for any operator $\mathcal{P}: \mathcal{T} \rightarrow \mathcal{T}$, we have

$$
\mathcal{P}^{-1}=\sum_{k \geq 0}\left(\mathcal{P}_{\mathcal{T}}-\mathcal{P}\right)^{k} \text { whenever }\left\|\mathcal{P}_{\mathcal{T}}-\mathcal{P}\right\|<1 .
$$

So according to Theorem D.3, the operator $p\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{-1}$ can be represented as a convergent Neumann series

$$
p\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{-1}=\sum_{k \geq 0}(-1)^{k}\left(\mathcal{P}_{\mathcal{T}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{k},
$$

because $\left\|\mathcal{P}_{\mathcal{T}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \epsilon<\frac{1}{2}$ once $m \geq C \mu n_{(1)} r \log n_{(1)}$ for a sufficiently large absolute constant $C$. We also note that

$$
p\left(\mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)=\mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}
$$

because $\mathcal{P}_{\mathcal{T} \perp} \mathcal{P}_{\mathcal{T}}=0$. Thus

$$
\begin{aligned}
\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}\right\| & \left.=\| \mathcal{P}_{\mathcal{T} \perp} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{-1}\left(\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right)\right) \| \\
& =\left\|\mathcal{P}_{\mathcal{T} \perp} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}} p\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{-1}\left(\left(\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A} \mathbf{B}}\right)\right)\right\| \\
& =\left\|\sum_{k \geq 0}(-1)^{k} \mathcal{P}_{\mathcal{T} \perp} \mathcal{Q}_{\Omega}\left(\mathcal{P}_{\mathcal{T}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{k}\left(\left(\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right)\right)\right\| \\
& \leq \sum_{k \geq 0}\left\|(-1)^{k} \mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{Q}_{\Omega}\left(\mathcal{P}_{\mathcal{T}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right)^{k}\left(\left(\mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right)\right)\right\|_{F} \\
& \left.\left.\leq\left\|\mathcal{Q}_{\Omega}\right\| \sum_{k \geq 0}\left\|\mathcal{P}_{\mathcal{T}} \mathcal{Q}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\|^{k} \| \mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right)\right) \|_{F} \\
& \left.\leq \frac{4}{p} \| \mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})-\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\right) \|_{F} \\
& \leq \Theta\left(\frac{n_{1} n_{2}}{m}\right) \sqrt{\frac{r}{3 n_{(1)}^{2}}} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}) \\
& \leq \frac{1}{3} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})
\end{aligned}
$$

with high probability. The proof is completed.
It thus suffices to construct a dual certificate $\boldsymbol{\Lambda}$ such that all conditions in (22) hold. To this end, partition $\Omega=\Omega_{1} \cup \Omega_{2} \cup \ldots \cup \Omega_{b}$ into $b$ partitions of size $q$. By assumption, we may choose

$$
q \geq \frac{128}{3} C \beta \kappa^{2} \mu r n_{(1)} \log n_{(1)} \quad \text { and } \quad b \geq \frac{1}{2} \log _{2 \kappa}\left(24^{2} n_{(1)}^{2} \kappa^{2}\right)
$$

for a sufficiently large constant $C$. Let $\Omega_{j} \sim \operatorname{Ber}(q)$ denote the set of indices corresponding to the $j$ th partitions. Define $\mathbf{W}_{0}=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}$ and set $\boldsymbol{\Lambda}_{k}=\frac{n_{1} n_{2}}{q} \sum_{j=1}^{k} \mathcal{P}_{\Omega_{j}}\left(\mathbf{W}_{j-1}\right), \mathbf{W}_{k}=\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}-\mathcal{P}_{\mathcal{T}}\left(\boldsymbol{\Lambda}_{k}\right)$ for $k=1,2, \ldots, b$. Then by Theorem D.3,

$$
\begin{aligned}
\left\|\mathbf{W}_{k}\right\|_{F} & =\left\|\mathbf{W}_{k-1}-\frac{n_{1} n_{2}}{q} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega_{k}}\left(\mathbf{W}_{k-1}\right)\right\|_{F}=\left\|\left(\mathcal{P}_{\mathcal{T}}-\frac{n_{1} n_{2}}{q} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega_{k}} \mathcal{P}_{\mathcal{T}}\right)\left(\mathbf{W}_{k-1}\right)\right\|_{F} \\
& \leq \frac{1}{2 \kappa}\left\|\mathbf{W}_{k-1}\right\|_{F} .
\end{aligned}
$$

So it follows that $\left\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}-\mathcal{P}_{\mathcal{T}}\left(\boldsymbol{\Lambda}_{b}\right)\right\|_{F}=\left\|\mathbf{W}_{b}\right\|_{F} \leq(2 \kappa)^{-b}\left\|\mathbf{W}_{0}\right\|_{F} \leq(2 \kappa)^{-b} \sqrt{r} \sigma_{1}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}) \leq \sqrt{\frac{r}{24^{2} n_{(1)}^{2}}} \sigma_{r}(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})$.
The following lemma together implies the strong duality of (11) straightforwardly.
Lemma D.4. Under the assumptions of Theorem 4.2, the dual certification $\boldsymbol{\Lambda}_{b}$ obeys the dual condition (22) with probability at least $1-n_{(1)}^{-10}$.
Proof. It is well known that for matrix completion, the Uniform model $\Omega \sim \operatorname{Uniform}(m)$ is equivalent to the Bernoulli model $\Omega \sim \operatorname{Ber}(p)$, where each element in $\left[n_{1}\right] \times\left[n_{2}\right]$ is included with probability $p=$ $\Theta\left(m /\left(n_{1} n_{2}\right)\right)$ independently; see Section $K$ for a brief justification. By the equivalence, we can suppose $\Omega \sim \operatorname{Ber}(p)$.

To prove Lemma D.4, as a preliminary, we need the following lemmas.
Lemma D. 5 ([Che15], Lemma 2). Suppose $\mathbf{Z}$ is a fixed matrix. Suppose $\Omega \sim \operatorname{Ber}(p)$. Then with high probability,

$$
\left\|\left(\mathcal{I}-p^{-1} \mathcal{P}_{\Omega}\right) \mathbf{Z}\right\| \leq C_{0}^{\prime}\left(\frac{\log n_{(1)}}{p}\|\mathbf{Z}\|_{\infty}+\sqrt{\frac{\log n_{(1)}}{p}}\|\mathbf{Z}\|_{\infty, 2}\right)
$$

where $C_{0}^{\prime}>0$ is an absolute constant and

$$
\|\mathbf{Z}\|_{\infty, 2}=\max \left\{\max _{i} \sqrt{\sum_{b} \mathbf{Z}_{i b}^{2}}, \max _{j} \sqrt{\sum_{a} \mathbf{Z}_{a j}^{2}}\right\}
$$

Lemma D. 6 ([CLMW11], Lemma 3.1). Suppose $\Omega \sim \operatorname{Ber}(p)$ and $\mathbf{Z}$ is a fixed matrix. Then with high probability,

$$
\left\|\mathbf{Z}-p^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathbf{Z}\right\|_{\infty} \leq \epsilon\|\mathbf{Z}\|_{\infty}
$$

provided that $p \geq C_{0} \epsilon^{-2}\left(\mu r \log n_{(1)}\right) / n_{(2)}$ for some absolute constant $C_{0}>0$.
Lemma D. 7 ([Che15], Lemma 3). Suppose that $\mathbf{Z}$ is a fixed matrix and $\Omega \sim \operatorname{Ber}(p)$. If $p \geq c_{0} \mu r \log n_{(1)} / n_{(2)}$ for some $c_{0}$ sufficiently large, then with high probability,

$$
\left\|\left(p^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}-\mathcal{P}_{\mathcal{T}}\right) \mathbf{Z}\right\|_{\infty, 2} \leq \frac{1}{2} \sqrt{\frac{n_{(1)}}{\mu r}}\|\mathbf{Z}\|_{\infty}+\frac{1}{2}\|\mathbf{Z}\|_{\infty, 2}
$$

Observe that by Lemma D.6,

$$
\left\|\mathbf{W}_{j}\right\|_{\infty} \leq\left(\frac{1}{2}\right)^{j}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}
$$

and by Lemma D.7,

$$
\left\|\mathbf{W}_{j}\right\|_{\infty, 2} \leq \frac{1}{2} \sqrt{\frac{n_{(1)}}{\mu r}}\left\|\mathbf{W}_{j-1}\right\|_{\infty}+\frac{1}{2}\left\|\mathbf{W}_{j-1}\right\|_{\infty, 2}
$$

So

$$
\begin{aligned}
&\left\|\mathbf{W}_{j}\right\|_{\infty, 2} \\
& \leq\left(\frac{1}{2}\right)^{j} \sqrt{\frac{n_{(1)}}{\mu r}}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+\frac{1}{2}\left\|\mathbf{W}_{j-1}\right\|_{\infty, 2} \\
& \leq j\left(\frac{1}{2}\right)^{j} \sqrt{\frac{n_{(1)}}{\mu r}}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+\left(\frac{1}{2}\right)^{j}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty, 2} .
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
& \left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}_{b}\right\| \\
\leq & \sum_{j=1}^{b}\left\|\frac{n_{1} n_{2}}{q} \mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{P}_{\Omega_{j}} \mathbf{W}_{j-1}\right\| \\
= & \sum_{j=1}^{b}\left\|\mathcal{P}_{\mathcal{T}^{\perp}}\left(\frac{n_{1} n_{2}}{q} \mathcal{P}_{\Omega_{j}} \mathbf{W}_{j-1}-\mathbf{W}_{j-1}\right)\right\| \\
\leq & \sum_{j=1}^{b}\left\|\left(\frac{n_{1} n_{2}}{q} \mathcal{P}_{\Omega_{j}}-\mathcal{I}\right)\left(\mathbf{W}_{j-1}\right)\right\| .
\end{aligned}
$$

Let $p$ denote $\Theta\left(\frac{q}{n_{1} n_{2}}\right)$. By Lemma D.5,

$$
\begin{aligned}
& \left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}_{b}\right\| \\
\leq & C_{0}^{\prime} \frac{\log n_{(1)}}{p} \sum_{j=1}^{b}\left\|\mathbf{W}_{j-1}\right\|_{\infty}+C_{0}^{\prime} \sqrt{\frac{\log n_{(1)}}{p}} \sum_{j=1}^{b}\left\|\mathbf{W}_{j-1}\right\|_{\infty, 2} \\
\leq & C_{0}^{\prime} \frac{\log n_{(1)}}{p} \sum_{j=1}^{b}\left(\frac{1}{2}\right)^{j}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+C_{0}^{\prime} \sqrt{\frac{\log n_{(1)}}{p}} \sum_{j=1}^{b}\left[j\left(\frac{1}{2}\right)^{j} \sqrt{\frac{n_{(1)}}{\mu r}}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+\left(\frac{1}{2}\right)^{j}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty, 2}\right] \\
\leq & C_{0}^{\prime} \frac{\log n_{(1)}}{p}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+2 C_{0}^{\prime} \sqrt{\frac{\log n_{(1)}}{p}} \sqrt{\frac{n_{(1)}}{\mu r}}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty}+C_{0}^{\prime} \sqrt{\frac{\log n_{(1)}}{p}}\|\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\|_{\infty, 2}
\end{aligned}
$$

Setting $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$, we note the facts that (we assume WLOG $n_{2} \geq n_{1}$ )

$$
\left\|\mathbf{X}^{*}\right\|_{\infty, 2}=\max _{i}\left\|\mathbf{e}_{i}^{T} \mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}\right\|_{2} \leq \max _{i}\left\|\mathbf{e}_{i}^{T} \mathbf{U}\right\| \sigma_{1}\left(\mathbf{X}^{*}\right) \leq \sqrt{\frac{\mu r}{n_{1}}} \sigma_{1}\left(\mathbf{X}^{*}\right) \leq \sqrt{\frac{\mu r}{n_{1}}} \kappa \sigma_{r}\left(\mathbf{X}^{*}\right)
$$

and that

$$
\begin{aligned}
\left\|\mathbf{X}^{*}\right\|_{\infty} & =\max _{i j}\left\langle\mathbf{X}^{*}, \mathbf{e}_{i} \mathbf{e}_{j}^{T}\right\rangle=\max _{i j}\left\langle\mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}, \mathbf{e}_{i} \mathbf{e}_{j}^{T}\right\rangle=\max _{i j}\left\langle\mathbf{e}_{i}^{T} \mathbf{U} \boldsymbol{\Sigma}, \mathbf{e}_{j}^{T} \mathbf{V}\right\rangle \\
& \leq \max _{i j}\left\|\mathbf{e}_{i}^{T} \mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}\right\|_{2}\left\|\mathbf{e}_{j}^{T} \mathbf{V}\right\|_{2} \leq \max _{j}\left\|\mathbf{X}^{*}\right\|_{\infty, 2}\left\|\mathbf{e}_{j}^{T} \mathbf{V}\right\|_{2} \leq \frac{\mu r \kappa}{\sqrt{n_{1} n_{2}}} \sigma_{r}\left(\mathbf{X}^{*}\right)
\end{aligned}
$$

Substituting $p=\Theta\left(\frac{\kappa^{2} \mu r n_{(1)} \log \left(n_{(1)}\right) \log _{2 \kappa}\left(n_{(1)}\right)}{n_{1} n_{2}}\right)$, we obtain $\left\|\mathcal{P}_{\mathcal{T}} \perp \boldsymbol{\Lambda}_{b}\right\|<\frac{1}{3} \sigma_{r}\left(\mathbf{X}^{*}\right)$. The proof is completed.

## E Subgradient of the $r *$ Function

Lemma E.1. Let $\mathbf{U} \mathbf{\Sigma} \mathbf{V}^{T}$ be the skinny SVD of matrix $\mathbf{X}^{*}$ of rank $r$. The subdifferential of $\|\cdot\|_{r_{*}}$ evaluated at $\mathbf{X}^{*}$ is given by

$$
\partial\left\|\mathbf{X}^{*}\right\|_{r *}=\left\{\mathbf{X}^{*}+\mathbf{W}: \mathbf{U}^{T} \mathbf{W}=\mathbf{0}, \mathbf{W} \mathbf{V}=\mathbf{0},\|\mathbf{W}\| \leq \sigma_{r}\left(\mathbf{X}^{*}\right)\right\}
$$

Proof. Note that for any fixed function $f(\cdot)$, the set of all optimal solutions of the problem

$$
\begin{equation*}
f^{*}\left(\mathbf{X}^{*}\right)=\max _{\mathbf{Y}}\left\langle\mathbf{X}^{*}, \mathbf{Y}\right\rangle-f(\mathbf{Y}) \tag{24}
\end{equation*}
$$

form the subdifferential of the conjugate function $f^{*}(\cdot)$ evaluated at $\mathbf{X}^{*}$. Set $f(\cdot)$ to be $\frac{1}{2}\|\cdot\|_{r}^{2}$ and notice that the function $\frac{1}{2}\|\cdot\|_{r}^{2}$ is unitarily invariant. By Von Neumann's trace inequality, the optimal solutions to problem (24) are given by $\left[\mathbf{U}, \mathbf{U}^{\perp}\right] \operatorname{Diag}\left(\left[\sigma_{1}(\mathbf{Y}), \ldots, \sigma_{r}(\mathbf{Y}), \sigma_{r+1}(\mathbf{Y}), \ldots, \sigma_{n_{(2)}}(\mathbf{Y})\right]\right)\left[\mathbf{V}, \mathbf{V}^{\perp}\right]^{T}$, where $\left\{\sigma_{i}(\mathbf{Y})\right\}_{i=r+1}^{n_{(2)}}$ can be any value no larger than $\sigma_{r}(\mathbf{Y})$ and $\left\{\sigma_{i}(\mathbf{Y})\right\}_{i=1}^{r}$ are given by the optimal solution to the problem

$$
\max _{\left\{\sigma_{i}(\mathbf{Y})\right\}_{i=1}^{r}} \sum_{i=1}^{r} \sigma_{i}\left(\mathbf{X}^{*}\right) \sigma_{i}(\mathbf{Y})-\frac{1}{2} \sum_{i=1}^{r} \sigma_{i}^{2}(\mathbf{Y})
$$

The solution is unique such that $\sigma_{i}(\mathbf{Y})=\sigma_{i}\left(\mathbf{X}^{*}\right), i=1,2, \ldots, r$. The proof is complete.

## F Proof of Theorem 4.1

Theorem 4.1 (Uniqueness of Solution. Restated). Let $\Omega \sim \operatorname{Uniform}(m)$ be the support set uniformly distributed among all sets of cardinality $m$. Suppose that $m \geq c \kappa^{2} \mu n_{(1)} r \log n_{(1)} \log _{2 \kappa} n_{(1)}$ for an absolute constant $c$ and $\mathbf{X}^{*}$ obeys $\mu$-incoherence (3). Then $\mathbf{X}^{*}$ is the unique solution of non-convex optimization

$$
\begin{equation*}
\min _{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}, \quad \text { s.t. } \quad \mathcal{P}_{\Omega}(\mathbf{A B})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right), \tag{25}
\end{equation*}
$$

with probability at least $1-n_{(1)}^{-10}$.
Proof. We note that a recovery result under the Bernoulli model automatically implies a corresponding result for the uniform model [CLMW11]; see Section K for the details. So in the following, we assume the Bernoulli model.

Consider the feasibility of the matrix completion problem:
Find a matrix $\mathbf{X} \in \mathbb{R}^{n_{1} \times n_{2}}$ such that $\quad \mathcal{P}_{\Omega}(\mathbf{X})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right), \quad\|\mathbf{X}\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}, \quad \operatorname{rank}(\mathbf{X}) \leq r$.
Note that if $\mathbf{X}^{*}$ is the unique solution of (26), then $\mathbf{X}^{*}$ is the unique solution of (25). We now show the former. Our proof first identifies a feasibility condition for problem (26), and then shows that $\mathbf{X}^{*}$ is the only matrix that obeys this feasibility condition when the sample size is large enough. We denote by

$$
\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right)=\left\{\mathbf{X}-\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}: \operatorname{rank}(\mathbf{X}) \leq r,\|\mathbf{X}\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}\right\},
$$

and

$$
\mathcal{T}=\left\{\mathbf{U} \mathbf{X}^{T}+\mathbf{Y} \mathbf{V}^{T}, \mathbf{X} \in \mathbb{R}^{n_{2} \times r}, \mathbf{Y} \in \mathbb{R}^{n_{1} \times r}\right\},
$$

where $\mathbf{U} \boldsymbol{\Sigma} \mathbf{V}^{T}$ is the skinny $\operatorname{SVD}$ of $\mathbf{X}^{*}$.
We have the following proposition for the feasibility of problem (26).
Proposition F. 1 (Feasibility Condition). $\mathbf{X}^{*}$ is the unique feasible solution to problem (26) if $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=$ \{0\}.

Proof. Notice that problem (26) is equivalent to another feasibility problem
Find a matrix $\mathbf{D} \in \mathbb{R}^{n_{1} \times n_{2}}$ such that $\operatorname{rank}\left(\mathbf{X}^{*}+\mathbf{D}\right) \leq r,\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}, \quad \mathbf{D} \in \Omega^{\perp}$.
Suppose that $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{\mathbf{0}\}$. Since $\operatorname{rank}\left(\mathbf{X}^{*}+\mathbf{D}\right) \leq r$ and $\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{F} \leq\left\|\mathbf{X}^{*}\right\|_{F}$ are equivalent to $\mathbf{D} \in \mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right)$, and note that $\mathbf{D} \in \Omega^{\perp}$, we have $\mathbf{D}=\mathbf{0}$, which means $\mathbf{X}^{*}$ is the unique feasible solution to problem (26).

The remainder of the proof is to show $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{\mathbf{0}\}$. To proceed, we note that

$$
\begin{aligned}
\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) & =\left\{\mathbf{X}-\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}: \operatorname{rank}(\mathbf{X}) \leq r, \frac{1}{2}\|\mathbf{X}\|_{F}^{2} \leq \frac{1}{2}\left\|\mathbf{X}^{*}\right\|_{F}^{2}\right\} \\
& \subseteq\left\{\mathbf{X}-\mathbf{X}^{*} \in \mathbb{R}^{n_{1} \times n_{2}}:\|\mathbf{X}\|_{r *} \leq\left\|\mathbf{X}^{*}\right\|_{r *}\right\} \quad\left(\text { since } \frac{1}{2}\|\mathbf{Y}\|_{F}^{2}=\|\mathbf{Y}\|_{r *} \text { for any rank-r matrix }\right) \\
& \triangleq \mathcal{D}_{\mathcal{S}_{*}}\left(\mathbf{X}^{*}\right) .
\end{aligned}
$$

We now show that

$$
\begin{equation*}
\mathcal{D}_{\mathcal{S}_{*}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{\mathbf{0}\}, \tag{27}
\end{equation*}
$$

when $m \geq c \kappa^{2} \mu r n_{(1)} \log _{2 \kappa}\left(n_{(1)}\right) \log \left(n_{(1)}\right)$, which will prove $\mathcal{D}_{\mathcal{S}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{\mathbf{0}\}$ as desired.
By Lemma D.1, there exists a $\boldsymbol{\Lambda}$ such that

$$
\begin{align*}
& \boldsymbol{\Lambda} \in \Omega  \tag{1}\\
& \mathcal{P}_{\mathcal{T}}(-\boldsymbol{\Lambda})=\mathbf{X}^{*},  \tag{2}\\
& \left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}\right\|<\frac{2}{3} \sigma_{r}\left(\mathbf{X}^{*}\right) . \tag{3}
\end{align*}
$$

Consider any $\mathbf{D} \in \Omega^{\perp}$ such that $\mathbf{D} \neq \mathbf{0}$. By Lemma E.1, for any $\mathbf{W} \in \mathcal{T}^{\perp}$ and $\|\mathbf{W}\| \leq \sigma_{r}\left(\mathbf{X}^{*}\right)$,

$$
\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{r *} \geq\left\|\mathbf{X}^{*}\right\|_{r *}+\left\langle\mathbf{X}^{*}+\mathbf{W}, \mathbf{D}\right\rangle .
$$

Since $\langle\mathbf{W}, \mathbf{D}\rangle=\left\langle\mathcal{P}_{\mathcal{T}} \perp \mathbf{W}, \mathbf{D}\right\rangle=\left\langle\mathbf{W}, \mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\rangle$, we can choose $\mathbf{W}$ such that $\langle\mathbf{W}, \mathbf{D}\rangle=\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}$. Then

$$
\begin{aligned}
\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{r^{*}} & \geq\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathbf{X}^{*}, \mathbf{D}\right\rangle \\
& =\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathbf{X}^{*}+\mathbf{\Lambda}, \mathbf{D}\right\rangle \quad \text { (since } \boldsymbol{\Lambda} \in \Omega \text { and } \mathbf{D} \in \Omega^{\perp} \text { ) } \\
& =\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathbf{X}^{*}+\mathcal{P}_{\mathcal{T}} \mathbf{\Lambda}, \mathbf{D}\right\rangle+\left\langle\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{\Lambda}, \mathbf{D}\right\rangle \\
& =\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{\Lambda}, \mathbf{D}\right\rangle \quad \text { by condition (2)) } \\
& =\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}, \mathbf{D}\right\rangle \\
& =\left\|\mathbf{X}^{*}\right\|_{r *}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}+\left\langle\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{\Lambda}, \mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\rangle \\
& \geq\left\|\mathbf{X}^{*}\right\|_{r^{*}}+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*}-\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \boldsymbol{\Lambda}\right\|\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*} \quad \text { (by Hölder's inequality) } \\
& \geq\left\|\mathbf{X}^{*}\right\|_{r *}+\frac{1}{3} \sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{D}\right\|_{*} \quad \text { (by condition (3)). }
\end{aligned}
$$

So if $\mathcal{T} \cap \Omega^{\perp}=\{\mathbf{0}\}$, since $\mathbf{D} \in \Omega^{\perp}$ and $\mathbf{D} \neq \mathbf{0}$, we have $\mathbf{D} \notin \mathcal{T}$. Therefore,

$$
\left\|\mathbf{X}^{*}+\mathbf{D}\right\|_{r *}>\left\|\mathbf{X}^{*}\right\|_{r *}
$$

which then leads to $\mathcal{D}_{\mathcal{S}_{*}}\left(\mathbf{X}^{*}\right) \cap \Omega^{\perp}=\{0\}$.
The rest of proof is to show that $\mathcal{T} \cap \Omega^{\perp}=\{0\}$. We have the following lemma.
Lemma F.2. Assume that $\Omega \sim \operatorname{Ber}(p)$ and the incoherence condition (3) holds. Then with probability at least $1-n_{(1)}^{-10}$, we have $\left\|\mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}\right\| \leq \sqrt{1-p+\epsilon p}$, provided that $p \geq C_{0} \epsilon^{-2}\left(\mu r \log n_{(1)}\right) / n_{(2)}$, where $C_{0}$ is an absolute constant.

Proof. If $\Omega \sim \operatorname{Ber}(p)$, we have, by Theorem D.3, that with high probability

$$
\left\|\mathcal{P}_{\mathcal{T}}-p^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \epsilon
$$

provided that $p \geq C_{0} \epsilon^{-2} \frac{\mu r \log n_{(1)}}{n_{(2)}}$. Note, however, that since $\mathcal{I}=\mathcal{P}_{\Omega}+\mathcal{P}_{\Omega^{\perp}}$,

$$
\mathcal{P}_{\mathcal{T}}-p^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}=p^{-1}\left(\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}-(1-p) \mathcal{P}_{\mathcal{T}}\right)
$$

and, therefore, by the triangle inequality

$$
\left\|\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}\right\| \leq \epsilon p+(1-p) .
$$

Since $\left\|\mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}\right\|^{2} \leq\left\|\mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}\right\|$, the proof is completed.
We note that $\left\|\mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}}\right\|<1$ implies $\Omega^{\perp} \cap \mathcal{T}=\{\mathbf{0}\}$. The proof is completed.

## G Proof of Theorem 4.2

We have shown in Theorem 4.1 that the problem $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})=\operatorname{argmin}_{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|\mathbf{A B}\|_{F}^{2}$, s.t. $\mathcal{P}_{\Omega}(\mathbf{A B})=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}\right)$, exactly recovers $\mathbf{X}^{*}$, i.e., $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$, with nearly optimal sample complexity. So if strong duality holds, this non-convex optimization problem can be equivalently converted to the convex program (11). Then Theorem 4.2 is straightforward from strong duality.

It now suffices to apply our unified framework in Section 3 to prove the strong duality. Let

$$
H(\mathbf{X})=\mathbf{I}_{\left\{\mathbf{M} \in \mathbb{R}^{n_{1} \times n_{2}}: \mathcal{P}_{\Omega} \mathbf{M}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\}}(\mathbf{X})
$$

in Problem $(\mathbf{P})$, and let $(\widetilde{\mathbf{A}}, \widetilde{\mathbf{B}})$ be a global solution to the problem. Then by Theorem 4.1, $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$. For Problem ( $\mathbf{P}$ ) with this special $H(\mathbf{X})$, we have

$$
\begin{aligned}
\Psi & =\partial H(\widetilde{\mathbf{A}} \widetilde{\mathbf{B}})=\left\{\mathbf{G} \in \mathbb{R}^{n_{1} \times n_{2}}:\langle\mathbf{G}, \widetilde{\mathbf{A}} \widetilde{\mathbf{B}}\rangle \geq\langle\mathbf{G}, \mathbf{Y}\rangle, \text { for any } \mathbf{Y} \in \mathbb{R}^{n_{1} \times n_{2}} \text { s.t. } \mathcal{P}_{\Omega} \mathbf{Y}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\} \\
& =\left\{\mathbf{G} \in \mathbb{R}^{n_{1} \times n_{2}}:\left\langle\mathbf{G}, \mathbf{X}^{*}\right\rangle \geq\langle\mathbf{G}, \mathbf{Y}\rangle, \text { for any } \mathbf{Y} \in \mathbb{R}^{n_{1} \times n_{2}} \text { s.t. } \mathcal{P}_{\Omega} \mathbf{Y}=\mathcal{P}_{\Omega} \mathbf{X}^{*}\right\}=\Omega
\end{aligned}
$$

where the third equality holds since $\widetilde{\mathbf{A}} \widetilde{\mathbf{B}}=\mathbf{X}^{*}$. Combining with Lemma D. 1 shows that the dual condition in Theorem 4 holds with high probability, which leads to strong duality and thus proving Theorem 4.2.

## H Proof of Theorem 5.1

Theorem 5.1 (Robust PCA. Restated). Suppose $\mathbf{X}^{*}$ is an $n_{1} \times n_{2}$ matrix of rank $r$, and obeys incoherence (3) and (14). Assume that the support set $\Omega$ of $\mathbf{S}^{*}$ is uniformly distributed among all sets of cardinality $m$. Then with probability at least $1-c n_{(1)}^{-10}$, the output of the optimization problem

$$
\begin{equation*}
(\widetilde{\mathbf{X}}, \widetilde{\mathbf{S}})=\underset{\mathbf{X}, \mathbf{S}}{\operatorname{argmin}}\|\mathbf{X}\|_{r *}+\lambda\|\mathbf{S}\|_{1}, \quad \text { s.t. } \quad \mathbf{D}=\mathbf{X}+\mathbf{S}, \tag{28}
\end{equation*}
$$

with $\lambda=\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{\sqrt{n_{(1)}}}$ is exact, namely, $\widetilde{\mathbf{X}}=\mathbf{X}^{*}$ and $\widetilde{\mathbf{S}}=\mathbf{S}^{*}$, provided that $\operatorname{rank}\left(\mathbf{X}^{*}\right) \leq \rho_{r} \frac{n_{(2)}}{\mu \log ^{2} n_{(1)}}$ and $m \leq$ $\rho_{s} n_{1} n_{2}$, where $c, \rho_{r}$, and $\rho_{s}$ are all positive absolute constants, and function $\|\cdot\|_{r *}$ is given by (15).

## H. 1 Dual Certificates

Lemma H.1. Assume that $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq 1 / 2$ and $\lambda<\sigma_{r}\left(\mathbf{X}^{*}\right)$. Then $\left(\mathbf{X}^{*}, \mathbf{S}^{*}\right)$ is the unique solution to problem (5.1) if there exists $(\mathbf{W}, \mathbf{F}, \mathbf{K})$ for which

$$
\mathbf{X}^{*}+\mathbf{W}=\lambda\left(\operatorname{sign}\left(\mathbf{S}^{*}\right)+\mathbf{F}+\mathcal{P}_{\Omega} \mathbf{K}\right),
$$

where $\mathbf{W} \in \mathcal{T}^{\perp},\|\mathbf{W}\| \leq \frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{2}, \mathbf{F} \in \Omega^{\perp},\|\mathbf{F}\|_{\infty} \leq \frac{1}{2}$, and $\left\|\mathcal{P}_{\Omega} \mathbf{K}\right\|_{F} \leq \frac{1}{4}$.
Proof. Let $\left(\mathbf{X}^{*}+\mathbf{H}, \mathbf{S}^{*}-\mathbf{H}\right)$ be any optimal solution to problem (28). Denote by $\mathbf{X}^{*}+\mathbf{W}^{*}$ an arbitrary subgradient of the $r *$ function at $\mathbf{X}^{*}$ (see Lemma E.1), and $\operatorname{sign}\left(\mathbf{S}^{*}\right)+\mathbf{F}^{*}$ an arbitrary subgradient of the $\ell_{1}$ norm at $\mathbf{S}^{*}$. By the definition of the subgradient, the inequality follows

$$
\begin{aligned}
&\left\|\mathbf{X}^{*}+\mathbf{H}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}-\mathbf{H}\right\|_{1} \geq\left\|\mathbf{X}^{*}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\left\langle\mathbf{X}^{*}+\mathbf{W}^{*}, \mathbf{H}\right\rangle-\lambda\left\langle\operatorname{sign}\left(\mathbf{S}^{*}\right)+\mathbf{F}^{*}, \mathbf{H}\right\rangle \\
&=\left\|\mathbf{X}^{*}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\left\langle\mathbf{X}^{*}-\lambda \operatorname{sign}\left(\mathbf{S}^{*}\right), \mathbf{H}\right\rangle+\left\langle\mathbf{W}^{*}, \mathbf{H}\right\rangle-\lambda\left\langle\mathbf{F}^{*}, \mathbf{H}\right\rangle \\
&=\left\|\mathbf{X}^{*}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\left\langle\mathbf{X}^{*}-\lambda \operatorname{sign}\left(\mathbf{S}^{*}\right), \mathbf{H}\right\rangle+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}+\lambda\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1} \\
&=\left\|\mathbf{X}^{*}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\left\langle\lambda \mathbf{F}+\lambda \mathcal{P}_{\Omega} \mathbf{K}-\mathbf{W}, \mathbf{H}\right\rangle+\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}+\lambda\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1} \\
& \geq\left\|\mathbf{X}^{*}\right\|_{r^{*}}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{2}\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}+\frac{\lambda}{2}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1}-\frac{\lambda}{4}\left\|\mathcal{P}_{\Omega} \mathbf{H}\right\|_{F},
\end{aligned}
$$

where the third line holds by picking $\mathbf{W}^{*}$ such that $\left\langle\mathbf{W}^{*}, \mathbf{H}\right\rangle=\sigma_{r}\left(\mathbf{X}^{*}\right)\left\|\mathcal{P}_{\mathcal{T}} \perp \mathbf{H}\right\|_{*}$ and $\left\langle\mathbf{F}^{*}, \mathbf{H}\right\rangle=$ $-\left\|\mathcal{P}_{\Omega} \perp \mathbf{H}\right\|_{1} .{ }^{5}$ We note that

\begin{aligned}
\left\|\mathcal{P}_{\Omega} \mathbf{H}\right\|_{F} & \leq\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathbf{H}\right\|_{F}+\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{F} \\
& \leq \frac{1}{2}\|\mathbf{H}\|_{F}+\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{F} \\
& \leq \frac{1}{2}\left\|\mathcal{P}_{\Omega} \mathbf{H}\right\|_{F}+\frac{1}{2}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{F}+\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{F},
\end{aligned}
$$

which implies that $\frac{\lambda}{4}\left\|\mathcal{P}_{\Omega} \mathbf{H}\right\|_{F} \leq \frac{\lambda}{4}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{F}+\frac{\lambda}{2}\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{F} \leq \frac{\lambda}{4}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1}+\frac{\lambda}{2}\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}$. Therefore,

$$
\begin{array}{r}
\left\|\mathbf{X}^{*}+\mathbf{H}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}-\mathbf{H}\right\|_{1} \geq\left\|\mathbf{X}^{*}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}\right\|_{1}+\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)-\lambda}{2}\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}+\frac{\lambda}{4}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1} \\
\geq\left\|\mathbf{X}^{*}+\mathbf{H}\right\|_{r *}+\lambda\left\|\mathbf{S}^{*}-\mathbf{H}\right\|_{1}+\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)-\lambda}{2}\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{H}\right\|_{*}+\frac{\lambda}{4}\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{H}\right\|_{1},
\end{array}
$$

where the second inequality holds because ( $\mathbf{X}^{*}+\mathbf{H}, \mathbf{S}^{*}-\mathbf{H}$ ) is optimal. Thus $\mathbf{H} \in \mathcal{T} \cap \Omega$. Note that $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\|<1$ implies $\mathcal{T} \cap \Omega=\{0\}$ and thus $\mathbf{H}=0$. This completes the proof.

According to Lemma H.1, to show the exact recoverability of problem (28), it is sufficient to find an appropriate $\mathbf{W}$ for which

\left\|\mathcal{P}_{\Omega^{\perp}}\left(\mathbf{X}^{*}+\mathbf{W}\right)\right\|_{\infty} \leq \frac{\lambda}{2}
\end{array}\right.
$$

under the assumptions that $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq 1 / 2$ and $\lambda<\sigma_{r}\left(\mathbf{X}^{*}\right)$. We note that $\lambda=\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{\sqrt{n_{(1)}}}<\sigma_{r}\left(\mathbf{X}^{*}\right)$. To see $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq 1 / 2$, we have the following lemma.

Lemma H. 2 ([CLMW11], Cor 2.7). Suppose that $\Omega \sim \operatorname{Ber}(p)$ and incoherence (3) holds. Then with probability at least $1-n_{(1)}^{-10},\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\|^{2} \leq p+\epsilon$, provided that $1-p \geq C_{0} \epsilon^{-2} \mu r \log n_{(1)} / n_{(2)}$ for an absolute constant $C_{0}$.

Setting $p$ and $\epsilon$ as small constants in Lemma H.2, we have $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq 1 / 2$ with high probability.

## H. 2 Dual Certification by Least Squares and the Golfing Scheme

The remainder of the proof is to construct $\mathbf{W}$ such that the dual condition (29) holds true. Before introducing our construction, we assume $\Omega \sim \operatorname{Ber}(p)$, or equivalently $\Omega^{\perp} \sim \operatorname{Ber}(1-p)$, where $p$ is allowed be as large as an absolute constant. Note that $\Omega^{\perp}$ has the same distribution as that of $\Omega_{1} \cup \Omega_{2} \cup \ldots \cup \Omega_{j_{0}}$, where the $\Omega_{j}$ 's are drawn independently with replacement from $\operatorname{Ber}(q), j_{0}=\left\lceil\log n_{(1)}\right\rceil$, and $q$ obeys $p=(1-q)^{j_{0}}$ ( $q=\Omega\left(1 / \log n_{(1)}\right)$ implies $\left.p=\mathcal{O}(1)\right)$. We construct $\mathbf{W}$ based on such a distribution.

Our construction separates $\mathbf{W}$ into two terms: $\mathbf{W}=\mathbf{W}^{L}+\mathbf{W}^{S}$. To construct $\mathbf{W}^{L}$, we apply the golfing scheme introduced by [Gro11, Rec11]. Specifically, $\mathbf{W}^{L}$ is constructed by an inductive procedure:

\mathbf{Y}_{j}=\mathbf{Y}_{j-1}+q^{-1} \mathcal{P}_{\Omega_{j}} \mathcal{P}_{\mathcal{T}}\left(\mathbf{X}^{*}-\mathbf{Y}_{j-1}\right), \mathbf{Y}_{0}=\mathbf{0},  \tag{30}\\
\mathbf{W}^{L}=\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}_{j_{0}} .
\end{gather*}
$$

[^5]To construct $\mathbf{W}^{S}$, we apply the method of least squares by [CLMW11], which is

$$
\begin{equation*}
\mathbf{W}^{S}=\lambda \mathcal{P}_{\mathcal{T}^{\perp}} \sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right) \tag{31}
\end{equation*}
$$

Note that $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq 1 / 2$. Thus $\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right\| \leq 1 / 4$ and the Neumann series in (31) is well-defined. Observe that $\mathcal{P}_{\Omega} \mathbf{W}^{S}=\lambda\left(\mathcal{P}_{\Omega}-\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)\left(\mathcal{P}_{\Omega}-\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{-1} \operatorname{sign}\left(\mathbf{S}^{*}\right)=\lambda \operatorname{sign}\left(\mathbf{S}^{*}\right)$. So to prove the dual condition (29), it suffices to show that

> (a) $\left\|\mathbf{W}^{L}\right\| \leq \frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{4}$,
> (b) $\left\|\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}+\mathbf{W}^{L}\right)\right\|_{F} \leq \frac{\lambda}{4}$,
> (c) $\left\|\mathcal{P}_{\Omega^{\perp}}\left(\mathbf{X}^{*}+\mathbf{W}^{L}\right)\right\|_{\infty} \leq \frac{\lambda}{4}$,
> (d) $\left\|\mathbf{W}^{S}\right\| \leq \frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{4}$
> (e) $\left\|\mathcal{P}_{\Omega^{\perp}} \mathbf{W}^{S}\right\|_{\infty} \leq \frac{\lambda}{4}$.

## H. 3 Proof of Dual Conditions

Since we have constructed the dual certificate $\mathbf{W}$, the remainder is to show that $\mathbf{W}$ obeys dual conditions (32) and (33) with high probability. We have the following.

Lemma H.3. Assume $\Omega_{j} \sim \operatorname{Ber}(q), j=1,2, \ldots, j_{0}$, and $j_{0}=2\left\lceil\log n_{(1)}\right\rceil$. Then under the other assumptions of Theorem 5.1, $\mathbf{W}^{L}$ given by (30) obeys dual condition (32).

Proof. Let $\mathbf{Z}_{j}=\mathcal{P}_{\mathcal{T}}\left(\mathbf{X}^{*}-\mathbf{Y}_{j}\right) \in \mathcal{T}$. Then we have

\mathbf{Z}_{j}=\mathcal{P}_{\mathcal{T}} \mathbf{Z}_{j-1}-q^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega_{j}} \mathcal{P}_{\mathcal{T}} \mathbf{Z}_{j-1}=\left(\mathcal{P}_{\mathcal{T}}-q^{-1} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega_{j}} \mathcal{P}_{\mathcal{T}}\right) \mathbf{Z}_{j-1},
$$

and $\mathbf{Y}_{j}=\sum_{k=1}^{j} q^{-1} \mathcal{P}_{\Omega_{k}} \mathbf{Z}_{k-1} \in \Omega^{\perp}$. We set $q=\Omega\left(\epsilon^{-2} \mu r \log n_{(1)} / n_{(2)}\right)$ with a small constant $\epsilon$.
Proof of (a). It holds that

\begin{aligned}
\left\|\mathbf{W}^{L}\right\| & =\left\|\mathcal{P}_{\mathcal{T}^{\perp}} \mathbf{Y}_{j_{0}}\right\| \leq \sum_{k=1}^{j_{0}}\left\|q^{-1} \mathcal{P}_{\mathcal{T}^{\perp}} \mathcal{P}_{\Omega_{k}} \mathbf{Z}_{k-1}\right\| \\
& =\sum_{k=1}^{j_{0}}\left\|\mathcal{P}_{\mathcal{T}^{\perp}}\left(q^{-1} \mathcal{P}_{\Omega_{k}} \mathbf{Z}_{k-1}-\mathbf{Z}_{k-1}\right)\right\| \\
& \leq \sum_{k=1}^{j_{0}}\left\|q^{-1} \mathcal{P}_{\Omega_{k}} \mathbf{Z}_{k-1}-\mathbf{Z}_{k-1}\right\| \\
& \leq C_{0}^{\prime}\left(\frac{\log n_{(1)}}{q} \sum_{k=1}^{j_{0}}\left\|\mathbf{Z}_{k-1}\right\|_{\infty}+\sqrt{\frac{\log n_{(1)}}{q}} \sum_{k=1}^{j_{0}}\left\|\mathbf{Z}_{k-1}\right\|_{\infty, 2}\right) . \quad \text { (by Lemma D.5) }
\end{aligned}
$$

We note that by Lemma D.6,

\left\|\mathbf{Z}_{k-1}\right\|_{\infty} \leq\left(\frac{1}{2}\right)^{k-1}\left\|\mathbf{Z}_{0}\right\|_{\infty}
$$

and by Lemma D.7,

\left\|\mathbf{Z}_{k-1}\right\|_{\infty, 2} \leq \frac{1}{2} \sqrt{\frac{n_{(1)}}{\mu r}}\left\|\mathbf{Z}_{k-2}\right\|_{\infty}+\frac{1}{2}\left\|\mathbf{Z}_{k-2}\right\|_{\infty, 2}
$$

Therefore,

\left\|\mathbf{Z}_{k-1}\right\|_{\infty, 2} & \leq\left(\frac{1}{2}\right)^{k-1} \sqrt{\frac{n_{(1)}}{\mu r}}\left\|\mathbf{Z}_{0}\right\|_{\infty}+\frac{1}{2}\left\|\mathbf{Z}_{k-2}\right\|_{\infty, 2} \\
& \leq(k-1)\left(\frac{1}{2}\right)^{k-1} \sqrt{\frac{n_{(1)}}{\mu r}}\left\|\mathbf{Z}_{0}\right\|_{\infty}+\left(\frac{1}{2}\right)^{k-1}\left\|\mathbf{Z}_{0}\right\|_{\infty, 2}
\end{aligned}
$$

and so we have

$$
\begin{aligned}
& \left\|\mathbf{W}^{L}\right\| \\
\leq & C_{0}^{\prime}\left[\frac{\log n_{(1)}}{q} \sum_{k=1}^{j_{0}}\left(\frac{1}{2}\right)^{k-1}\left\|\mathbf{Z}_{0}\right\|_{\infty}+\sqrt{\frac{\log n_{(1)}}{q}} \sum_{k=1}^{j_{0}}\left((k-1)\left(\frac{1}{2}\right)^{k-1} \sqrt{\frac{n_{(1)}}{\mu r}}\left\|\mathbf{Z}_{0}\right\|_{\infty}+\left(\frac{1}{2}\right)^{k-1}\left\|\mathbf{Z}_{0}\right\|_{\infty, 2}\right)\right] \\
\leq & 2 C_{0}^{\prime}\left[\frac{\log n_{(1)}}{q}\left\|\mathbf{X}^{*}\right\|_{\infty}+\sqrt{\frac{n_{(1)} \log n_{(1)}}{q \mu r}}\left\|\mathbf{X}^{*}\right\|_{\infty}+\sqrt{\frac{\log n_{(1)}}{q}}\left\|\mathbf{X}^{*}\right\|_{\infty, 2}\right] \\
\leq & \frac{1}{16}\left[\frac{n_{(2)}}{\mu r}\left\|\mathbf{X}^{*}\right\|_{\infty}+\frac{\sqrt{n_{(1)} n_{(2)}}}{\mu r}\left\|\mathbf{X}^{*}\right\|_{\infty}+\sqrt{\frac{n_{(2)}}{\mu r}}\left\|\mathbf{X}^{*}\right\|_{\infty, 2}\right] \quad\left(\text { since } q=\Omega\left(\mu r \log n_{(1)}\right) / n_{(2)}\right) \\
\leq & \frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{4}, \quad(\text { by incoherence (14)) }
\end{aligned}
$$

where we have used the fact that

$$
\left\|\mathbf{X}^{*}\right\|_{\infty, 2} \leq \sqrt{n_{(1)}}\left\|\mathbf{X}^{*}\right\|_{\infty} \leq \sqrt{\frac{\mu r}{n_{(2)}}} \sigma_{r}\left(\mathbf{X}^{*}\right)
$$

Proof of $(b)$. Because $\mathbf{Y}_{j_{0}} \in \Omega^{\perp}$, we have $\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}+\mathcal{P}_{\mathcal{T} \perp} \mathbf{Y}_{j_{0}}\right)=\mathcal{P}_{\Omega}\left(\mathbf{X}^{*}-\mathcal{P}_{\mathcal{T}} \mathbf{Y}_{j_{0}}\right)=\mathcal{P}_{\Omega} \mathbf{Z}_{j_{0}}$. It then follows from Theorem D. 3 that for a properly chosen $t$,

& \leq t^{j_{0}} \sqrt{n_{1} n_{2}}\left\|\mathbf{X}^{*}\right\|_{\infty} \\
& \leq t^{j_{0}} \sqrt{n_{1} n_{2}} \sqrt{\frac{\mu r}{n_{1} n_{2}}} \sigma_{r}\left(\mathbf{X}^{*}\right) \\
& \leq \frac{\lambda}{8} \quad \quad\left(t^{j_{0}} \leq e^{-2 \log n_{(1)}} \leq n_{(1)}^{-2}\right)
\end{aligned}
$$

Proof of (c). By definition, we know that $\mathbf{X}^{*}+\mathbf{W}^{L}=\mathbf{Z}_{j_{0}}+\mathbf{Y}_{j_{0}}$. Since we have shown $\left\|\mathbf{Z}_{j_{0}}\right\|_{F} \leq \lambda / 8$, it suffices to prove $\left\|\mathbf{Y}_{j_{0}}\right\|_{\infty} \leq \lambda / 8$. We have

$$
\begin{aligned}
\left\|\mathbf{Y}_{j_{0}}\right\|_{\infty} & \leq q^{-1} \sum_{k=1}^{j_{0}}\left\|\mathcal{P}_{\Omega_{k}} \mathbf{Z}_{k-1}\right\|_{\infty} \\
& \leq q^{-1} \sum_{k=1}^{j_{0}} \epsilon^{k-1}\left\|\mathbf{X}^{*}\right\|_{\infty} \quad(\text { by Lemma D.6) } \\
& \leq \frac{n_{(2)} \epsilon^{2}}{C_{0} \mu r \log n_{(1)}} \sqrt{\frac{\mu r}{n_{(1)} n_{(2)}}} \sigma_{r}\left(\mathbf{X}^{*}\right) \quad(\text { by incoherence }(14)) \\
& \leq \frac{\lambda}{8}
\end{aligned}
$$

if we choose $\epsilon=C\left(\frac{\mu r\left(\log n_{(1)}\right)^{2}}{n_{(2)}}\right)^{1 / 4}$ for an absolute constant $C$. This can be true once the constant $\rho_{r}$ is sufficiently small.

We now prove that $\mathbf{W}^{S}$ given by (31) obeys dual condition (33). We have the following.
Lemma H.4. Assume $\Omega \sim \operatorname{Ber}(p)$. Then under the other assumptions of Theorem 5.1, $\mathbf{W}^{S}$ given by (31) obeys dual condition (33).

Proof. According to the standard de-randomization argument [CLMW11], it is equivalent to studying the case when the signs $\delta_{i j}$ of $\mathbf{S}_{i j}^{*}$ are independently distributed as

Proof of (d). Recall that

\mathbf{W}^{S} & =\lambda \mathcal{P}_{\mathcal{T}^{\perp}} \sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right) \\
& =\lambda \mathcal{P}_{\mathcal{T}^{\perp}} \operatorname{sign}\left(\mathbf{S}^{*}\right)+\lambda \mathcal{P}_{\mathcal{T}^{\perp}} \sum_{k \geq 1}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right) .
\end{aligned}
$$

To bound the first term, we have $\left\|\operatorname{sign}\left(\mathbf{S}^{*}\right)\right\| \leq 4 \sqrt{n_{(1)} p}[V e r 10]$. So $\left\|\lambda \mathcal{P}_{\mathcal{T}} \perp \boldsymbol{\operatorname { s i g n }}\left(\mathbf{S}^{*}\right)\right\| \leq \lambda\left\|\operatorname{sign}\left(\mathbf{S}^{*}\right)\right\| \leq$ $4 \sqrt{p} \sigma_{r}\left(\mathbf{X}^{*}\right) \leq \sigma_{r}\left(\mathbf{X}^{*}\right) / 8$.

We now bound the second term. Let $\mathcal{G}=\sum_{k \geq 1}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k}$, which is self-adjoint, and denote by $N_{n_{1}}$ and $N_{n_{2}}$ the $\frac{1}{2}$-nets of $\mathbb{S}^{n_{1}-1}$ and $\mathbb{S}^{n_{1}-1}$ of sizes at most $6^{n_{1}}$ and $6^{n_{2}}$, respectively [Led05]. We know that [[Ver10], Lemma 5.4]

$$
\begin{aligned}
\left\|\mathcal{G}\left(\operatorname{sign}\left(\mathbf{S}^{*}\right)\right)\right\| & =\sup _{\mathbf{x} \in \mathbb{S}^{n_{2}-1}, \mathbf{y} \in \mathbb{S}^{n_{1}-1}}\left\langle\mathcal{G}\left(\mathbf{y} \mathbf{x}^{T}\right), \operatorname{sign}\left(\mathbf{S}^{*}\right)\right\rangle \\
& \leq 4 \sup _{\mathbf{x} \in N_{n_{2}}, \mathbf{y} \in N_{n_{1}}}\left\langle\mathcal{G}\left(\mathbf{y} \mathbf{x}^{T}\right), \operatorname{sign}\left(\mathbf{S}^{*}\right)\right\rangle .
\end{aligned}
$$

Consider the random variable $X(\mathbf{x}, \mathbf{y})=\left\langle\mathcal{G}\left(\mathbf{y x}{ }^{T}\right), \operatorname{sign}\left(\mathbf{S}^{*}\right)\right\rangle$ which has zero expectation. By Hoeffding's inequality, we have

$$
\operatorname{Pr}(|X(\mathbf{x}, \mathbf{y})|>t) \leq 2 \exp \left(-\frac{t^{2}}{2\left\|\mathcal{G}\left(\mathbf{x y}^{T}\right)\right\|_{F}^{2}}\right) \leq 2 \exp \left(-\frac{t^{2}}{2\|\mathcal{G}\|^{2}}\right)
$$

Therefore, by a union bound,

$$
\operatorname{Pr}\left(\left\|\mathcal{G}\left(\operatorname{sign}\left(\mathbf{S}^{*}\right)\right)\right\|>t\right) \leq 2 \times 6^{n_{1}+n_{2}} \exp \left(-\frac{t^{2}}{8\|\mathcal{G}\|^{2}}\right)
$$

Note that conditioned on the event $\left\{\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \sigma\right\}$, we have $\|\mathcal{G}\|=\left\|\sum_{k \geq 1}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k}\right\| \leq \frac{\sigma^{2}}{1-\sigma^{2}}$. So
$\operatorname{Pr}\left(\lambda\left\|\mathcal{G}\left(\operatorname{sign}\left(\mathbf{S}^{*}\right)\right)\right\|>t\right) \leq 2 \times 6^{n_{1}+n_{2}} \exp \left(-\frac{t^{2}}{8 \lambda^{2}}\left(\frac{1-\sigma^{2}}{\sigma^{2}}\right)^{2}\right) \operatorname{Pr}\left(\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \sigma\right)+\operatorname{Pr}\left(\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\|>\sigma\right)$.
Lemma H. 2 guarantees that event $\left\{\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \sigma\right\}$ holds with high probability for a very small absolute constant $\sigma$. Setting $t=\frac{\sigma_{r}\left(\mathbf{X}^{*}\right)}{8}$, this completes the proof of (d).

Proof of (e). Recall that $\mathbf{W}^{S}=\lambda \mathcal{P}_{\mathcal{T} \perp} \sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right)$ and so

$$
\begin{aligned}
\mathcal{P}_{\Omega^{\perp}} \mathbf{W}^{S} & =\lambda \mathcal{P}_{\Omega^{\perp}}\left(\mathcal{I}-\mathcal{P}_{\mathcal{T}}\right) \sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right) \\
& =-\lambda \mathcal{P}_{\Omega^{\perp}} \mathcal{P}_{\mathcal{T}} \sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \operatorname{sign}\left(\mathbf{S}^{*}\right) .
\end{aligned}
$$

Then for any $(i, j) \in \Omega^{\perp}$, we have

$$
\mathbf{W}_{i j}^{S}=\left\langle\mathbf{W}^{S}, \mathbf{e}_{i} \mathbf{e}_{j}^{T}\right\rangle=\left\langle\lambda \operatorname{sign}\left(\mathbf{S}^{*}\right),-\sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\left(\mathbf{e}_{i} \mathbf{e}_{j}^{T}\right)\right\rangle .
$$

Let $X(i, j)=-\sum_{k \geq 0}\left(\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}} \mathcal{P}_{\Omega}\right)^{k} \mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\left(\mathbf{e}_{i} \mathbf{e}_{j}^{T}\right)$. By Hoeffding's inequality and a union bound,

$$
\operatorname{Pr}\left(\sup _{i j}\left|\mathbf{W}_{i j}^{S}\right|>t\right) \leq 2 \sum_{i j} \exp \left(-\frac{2 t^{2}}{\lambda^{2}\|X(i, j)\|_{F}^{2}}\right) .
$$

We note that conditioned on the event $\left\{\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \sigma\right\}$, for any $(i, j) \in \Omega^{\perp}$,

$$
\begin{aligned}
\|X(i, j)\|_{F} & \leq \frac{1}{1-\sigma^{2}} \sigma\left\|\mathcal{P}_{\mathcal{T}}\left(\mathbf{e}_{i} \mathbf{e}_{j}^{T}\right)\right\|_{F} \\
& \leq \frac{1}{1-\sigma^{2}} \sigma \sqrt{1-\left\|\mathcal{P}_{\mathcal{T}^{\perp}}\left(\mathbf{e}_{i} \mathbf{e}_{j}^{T}\right)\right\|_{F}^{2}} \\
& =\frac{1}{1-\sigma^{2}} \sigma \sqrt{1-\left\|\left(\mathbf{I}-\mathbf{U U}^{T}\right) \mathbf{e}_{i}\right\|_{2}^{2}\left\|\left(\mathbf{I}-\mathbf{V} \mathbf{V}^{T}\right) \mathbf{e}_{j}\right\|_{2}^{2}} \\
& \leq \frac{1}{1-\sigma^{2}} \sigma \sqrt{1-\left(1-\frac{\mu r}{n_{(1)}}\right)\left(1-\frac{\mu r}{n_{(2)}}\right)} \\
& \leq \frac{1}{1-\sigma^{2}} \sigma \sqrt{\frac{\mu r}{n_{(1)}}+\frac{\mu r}{n_{(2)}}} .
\end{aligned}
$$

Then unconditionally,

$$
\operatorname{Pr}\left(\sup _{i j}\left|\mathbf{W}_{i j}^{S}\right|>t\right) \leq 2 n_{(1)} n_{(2)} \exp \left(-\frac{2 t^{2}}{\lambda^{2}} \frac{\left(1-\sigma^{2}\right)^{2} n_{(1)} n_{(2)}}{\sigma^{2} \mu r\left(n_{(1)}+n_{(2)}\right)}\right) \operatorname{Pr}\left(\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\| \leq \sigma\right)+\operatorname{Pr}\left(\left\|\mathcal{P}_{\Omega} \mathcal{P}_{\mathcal{T}}\right\|>\sigma\right) .
$$

By Lemma H. 2 and setting $t=\lambda / 4$, the proof of (e) is completed.

## I Proof of Theorem 6.1

Our computational lower bound for problem $(\mathbf{P})$ assumes the hardness of random 4-SAT.
Conjecture 1 (Random 4-SAT). Let $c>\ln 2$ be a constant. Consider a random 4-SAT formula on $n$ variables in which each clause has 4 literals, and in which each of the $16 n^{4}$ clauses is picked independently with probability $c / n^{3}$. Then any algorithm which always outputs 1 when the random formula is satisfiable, and outputs 0 with probability at least $1 / 2$ when the random formula is unsatisfiable, must run in $2^{c^{\prime} n}$ time on some input, where $c^{\prime}>0$ is an absolute constant.

Based on Conjecture 1, we have the following computational lower bound for problem ( $\mathbf{P}$ ). We show that problem $(\mathbf{P})$ is in general hard for deterministic algorithms. If we additionally assume $B P P=P$, then the same conclusion holds for randomized algorithms with high probability.

Theorem 6.1 (Computational Lower Bound. Restated). Assume Conjecture 1. Then there exists an absolute constant $\epsilon_{0}>0$ for which any algorithm that achieves $(1+\epsilon) \mathrm{OPT}$ in objective function value for problem ( $\mathbf{P}$ ) with $\epsilon \leq \epsilon_{0}$, and with constant probability, requires $2^{\Omega\left(n_{1}+n_{2}\right)}$ time, where OPT is the optimum. If in addition, $\mathrm{BPP}=\mathrm{P}$, then the same conclusion holds for randomized algorithms succeeding with probability at least $2 / 3$.

Proof. Theorem 6.1 is proved by using the hypothesis that random 4-SAT is hard to show hardness of the Maximum Edge Biclique problem for deterministic algorithms.

Definition 1 (Maximum Edge Biclique). The problem is
Input: An n-by-n bipartite graph $G$.
Output: A $k_{1}$-by- $k_{2}$ complete bipartite subgraph of $G$, such that $k_{1} \cdot k_{2}$ is maximized.
[GL04] showed that under the random 4-SAT assumption there exist two constants $\epsilon_{1}>\epsilon_{2}>0$ such that no efficient deterministic algorithm is able to distinguish between bipartite graphs $G(U, V, E)$ with $|U|=|V|=n$ which have a clique of size $\geq(n / 16)^{2}\left(1+\epsilon_{1}\right)$ and those in which all bipartite cliques are of size $\leq(n / 16)^{2}\left(1+\epsilon_{2}\right)$. The reduction uses a bipartite graph $G$ with at least $t n^{2}$ edges with large probability, for a constant $t$.

Given a given bipartite graph $G(U, V, E)$, define $H(\cdot)$ as follows. Define the matrix $\mathbf{Y}$ and $\mathbf{W}: \mathbf{Y}_{i j}=1$ if edge $\left(U_{i}, V_{j}\right) \in E, \mathbf{Y}_{i j}=0$ if edge $\left(U_{i}, V_{j}\right) \notin E ; \mathbf{W}_{i j}=1$ if edge $\left(U_{i}, V_{j}\right) \in E$, and $\mathbf{W}_{i j}=\operatorname{poly}(n)$ if edge $\left(U_{i}, V_{j}\right) \notin E$. Choose a large enough constant $\beta>0$ and let $H(\mathbf{A B})=\beta \sum_{i j} \mathbf{W}_{i j}^{2}\left(\mathbf{Y}_{i j}-(\mathbf{A B})_{i j}\right)^{2}$. Now, if there exists a biclique in $G$ with at least $(n / 16)^{2}\left(1+\epsilon_{2}\right)$ edges, then the number of remaining edges is at most $t n^{2}-(n / 16)^{2}\left(1+\epsilon_{1}\right)$, and so the solution to $\min H(\mathbf{A B})+\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}$ has cost at most $\beta\left[t n^{2}-(n / 16)^{2}\left(1+\epsilon_{1}\right)\right]+n^{2}$. On the other hand, if there does not exist a biclique that has more than $(n / 16)^{2}\left(1+\epsilon_{2}\right)$ edges, then the number of remaining edges is at least $(n / 16)^{2}\left(1+\epsilon_{2}\right)$, and so any solution to $\min H(\mathbf{A B})+\frac{1}{2}\|\mathbf{A B}\|_{F}^{2}$ has cost at least $\beta\left[\operatorname{tn}^{2}-(n / 16)^{2}\left(1+\epsilon_{2}\right)\right]$. Choose $\beta$ large enough so that $\beta\left[t n^{2}-(n / 16)^{2}\left(1+\epsilon_{2}\right)\right]>\beta\left[\operatorname{tn}^{2}-(n / 16)^{2}\left(1+\epsilon_{1}\right)\right]+n^{2}$. This combined with the result in [GL04] completes the proof for deterministic algorithms.

To rule out randomized algorithms running in time $2^{\alpha\left(n_{1}+n_{2}\right)}$ for some function $\alpha$ of $n_{1}, n_{2}$ for which $\alpha=o(1)$, observe that we can define a new problem which is the same as problem ( $\mathbf{P}$ ) except the input description of $H$ is padded with a string of 1 s of length $2^{(\alpha / 2)\left(n_{1}+n_{2}\right)}$. This string is irrelevant for solving problem $(\mathbf{P})$ but changes the input size to $N=\operatorname{poly}\left(n_{1}, n_{2}\right)+2^{(\alpha / 2)\left(n_{1}+n_{2}\right)}$. By the argument in the previous paragraph, any deterministic algorithm still requires $2^{\Omega(n)}=N^{\omega(1)}$ time to solve this problem, which is super-polynomial in the new input size $N$. However, if a randomized algorithm can solve it in $2^{\alpha\left(n_{1}+n_{2}\right)}$ time, then it runs in poly $(N)$ time. This contradicts the assumption that BPP $=\mathrm{P}$. This completes the proof.

## J Dual and Bi-Dual Problems

In this section, we derive the dual and bi-dual problems of non-convex program ( $\mathbf{P}$ ). According to (5), the primal problem $(\mathbf{P})$ is equivalent to

$$
\min _{\mathbf{A}, \mathbf{B}} \max _{\boldsymbol{\Lambda}} \frac{1}{2}\|-\boldsymbol{\Lambda}-\mathbf{A B}\|_{F}^{2}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{F}^{2}-H^{*}(\boldsymbol{\Lambda}) .
$$

Therefore, the dual problem is given by

$$
\begin{align*}
& \max _{\boldsymbol{\Lambda}} \min _{\mathbf{A}, \mathbf{B}} \frac{1}{2}\|-\boldsymbol{\Lambda}-\mathbf{A B}\|_{F}^{2}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{F}^{2}-H^{*}(\boldsymbol{\Lambda}) \\
= & \max _{\boldsymbol{\Lambda}} \frac{1}{2} \sum_{i=r+1}^{n_{(2)}} \sigma_{i}^{2}(-\boldsymbol{\Lambda})-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{F}^{2}-H^{*}(\boldsymbol{\Lambda}) \\
= & \max _{\boldsymbol{\Lambda}}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{r}^{2}-H^{*}(\boldsymbol{\Lambda}), \quad \quad \text { (D1) } \tag{D1}
\end{align*}
$$

where $\|\boldsymbol{\Lambda}\|_{r}^{2}=\sum_{i=1}^{r} \sigma_{i}^{2}(\boldsymbol{\Lambda})$. The bi-dual problem is derived by

$$
\begin{align*}
& \min _{\mathbf{M}} \max _{\boldsymbol{\Lambda}, \boldsymbol{\Lambda}^{\prime}}-\frac{1}{2}\|\boldsymbol{\Lambda}\|_{r}^{2}-H^{*}\left(\boldsymbol{\Lambda}^{\prime}\right)+\left\langle\mathbf{M}, \boldsymbol{\Lambda}^{\prime}-\boldsymbol{\Lambda}\right\rangle \\
= & \min _{\mathbf{M}} \max _{-\boldsymbol{\Lambda}}\left[\langle\mathbf{M},-\boldsymbol{\Lambda}\rangle-\frac{1}{2}\|-\boldsymbol{\Lambda}\|_{r}^{2}\right]+\max _{\boldsymbol{\Lambda}^{\prime}}\left[\left\langle\mathbf{M}, \boldsymbol{\Lambda}^{\prime}\right\rangle-H^{*}\left(\boldsymbol{\Lambda}^{\prime}\right)\right] \\
= & \min _{\mathbf{M}}\|\mathbf{M}\|_{r *}+H(\mathbf{M}), \quad(\mathbf{D} \mathbf{2}) \tag{D2}
\end{align*}
$$

where $\|\mathbf{M}\|_{r *}=\max _{\mathbf{X}}\langle\mathbf{M}, \mathbf{X}\rangle-\frac{1}{2}\|\mathbf{X}\|_{r}^{2}$ is a convex function, and $H(\mathbf{M})=\max _{\boldsymbol{\Lambda}^{\prime}}\left[\left\langle\mathbf{M}, \boldsymbol{\Lambda}^{\prime}\right\rangle-H^{*}\left(\boldsymbol{\Lambda}^{\prime}\right)\right]$ holds by the definition of conjugate function.

Problems (D1) and (D2) can be solved efficiently due to their convexity. In particular, [GRG16] provided a computationally efficient algorithm to compute the proximal operators of functions $\frac{1}{2}\|\cdot\|_{r}^{2}$ and $\|\cdot\|_{r *}$. Hence, the Douglas-Rachford algorithm can find the global minimum up to an $\epsilon$ error in function value in time poly (1/ $\epsilon$ ) [HY12].

## K Recovery under Bernoulli and Uniform Sampling Models

We begin by arguing that a recovery result under the Bernoulli model with some probability automatically implies a corresponding result for the uniform model with at least the same probability. The argument follows Section 7.1 of [CLMW11]. For completeness, we provide the proof here.

Denote by $\operatorname{Pr}_{U_{\text {nif }(m)}}$ and $\operatorname{Pr}_{B e r(p)}$ probabilities calculated under the uniform and Bernoulli models and let "Success" be the event that the algorithm succeeds. We have

$$
\begin{aligned}
\operatorname{Pr}_{\operatorname{Ber}(p)}(\text { Success }) & =\sum_{k=0}^{n_{1} n_{2}} \operatorname{Pr}_{\operatorname{Ber}(p)}(\text { Success }| | \Omega \mid=k) \operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|=k) \\
& \leq \sum_{k=0}^{m} \operatorname{Pr}_{\text {Unif }(k)}(\operatorname{Success}| | \Omega \mid=k) \operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|=k)+\sum_{k=m+1}^{n_{1} n_{2}} \operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|=k) \\
& \leq \operatorname{Pr}_{\text {Unif }(m)}(\text { Success })+\operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|>m),
\end{aligned}
$$

where we have used the fact that for $k \leq m, \operatorname{Pr}_{\text {Unif }(k)}($ Success $) \leq \operatorname{Pr}_{\text {Unif }(m)}($ Success $)$, and that the conditional distribution of $|\Omega|$ is uniform. Thus

$$
\operatorname{Pr}_{U n i f(m)}(\text { Success }) \geq \operatorname{Pr}_{\operatorname{Ber}(p)}(\text { Success })-\operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|>m) .
$$

Take $p=m /\left(n_{1} n_{2}\right)-\epsilon$, where $\epsilon>0$. The conclusion follows from $\operatorname{Pr}_{\operatorname{Ber}(p)}(|\Omega|>m) \leq e^{-\frac{\epsilon^{2} n_{1} n_{2}}{2 p}}$.
