# A Proof of the Explicit Formula for Product Moments of Multivariate Gaussian Random Variables

#### Abstract

A detailed proof of a recent result on explicit formulae for the product moments $E\left\{X_{1}^{a_{1}} X_{2}^{a_{2}} \cdots X_{n}^{a_{n}}\right\}$ of multivariate Gaussian random variables is provided in this note.

Keywords: jointly Gaussian random variables, Gaussian random vector, joint moment, multivariate Gaussian random variables, product moment


## 1. Introduction

Recently, explicit formulae for the product moments of multivariate Gaussian random variables have been derived in Song and Lee (2015). The formulae not only are simpler and more concise than any of the other ones but also allow us 5 to promptly compute any term of the product moments.

Since the publication of the results, a huge number of requests has been received for the details of the proof. In this note, we provide a detailed proof of the main result of Song and Lee (2015).

## 2. Proof of the Explicit Formula

Theorem 1. For the product moments

$$
\begin{equation*}
E\left\{\prod_{i=1}^{n} X_{i}^{a_{i}}\right\}=\sum_{\boldsymbol{l} \in S_{\boldsymbol{a}}} d_{\boldsymbol{a}, \boldsymbol{l}}\left(\prod_{i=1}^{n} \prod_{j=i}^{n} \varphi_{i j}^{l_{i j}}\right)\left(\prod_{j=1}^{n} \mu_{j}^{L_{\boldsymbol{a}, j}}\right) \tag{1}
\end{equation*}
$$

of multivariate Gaussian random variables, we have

$$
\begin{equation*}
d_{\boldsymbol{a}, \boldsymbol{l}}=\frac{\prod_{k=1}^{n} a_{k}!}{2^{M_{l}}\left(\prod_{i=1}^{n} \prod_{j=i}^{n} l_{i j}!\right)\left(\prod_{j=1}^{n} L_{\boldsymbol{a}, j}!\right)} \tag{2}
\end{equation*}
$$

for $\boldsymbol{l} \in S_{\boldsymbol{a}}$, where $M_{\boldsymbol{l}}=\sum_{k=1}^{n} l_{k k}$.
Here, the elements of the two sets $\boldsymbol{a}=\left\{a_{1}, a_{2}, \cdots, a_{n}\right\}$ and $\boldsymbol{l}=\left\{\left\{l_{i j}\right\}_{i=1}^{n}\right\}_{j=i}^{n}$
20 are nonnegative integers,

$$
\begin{equation*}
L_{\boldsymbol{a}, k}=a_{k}-l_{k k}-\sum_{j=1}^{n} l_{j k} \tag{3}
\end{equation*}
$$

with $l_{j i}=l_{i j}$, and $S_{\boldsymbol{a}}$ denotes the collection of all the sets $\boldsymbol{l}$ such that

\begin{equation*}
\left\{L_{\boldsymbol{a}, k} \geq 0\right\}_{k=1}^{n} \tag{4}
\end{equation*}
$$

### 2.2. Proof

Let us prove Theorem 1 by mathematical induction. First, it is clear from Lemma 2.2, Theorem 1, and Theorem 2 of Song and Lee (2015) that (2) holds ${ }_{25}$ for $n=1,2$, and 3 , respectively.

Next, assume that (2) is true when $n=m-1$. Then, since

\begin{equation*}
E\left\{X_{1}^{a_{1}} X_{2}^{a_{2}} \cdots X_{m}^{a_{m}}\right\}=E\left\{X_{1}^{a_{1}} X_{2}^{a_{2}} \cdots X_{m-1}^{a_{m-1}}\right\} E\left\{X_{m}^{a_{m}}\right\} \tag{5}
\end{equation*}
$$

when $\varphi_{1 m}=\varphi_{2 m}=\cdots=\varphi_{m-1, m}=0$, we get $\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{1 m} \mapsto 0, l_{2 m} \mapsto 0, \cdots, l_{m-1, m} \mapsto 0}=$ $d_{\boldsymbol{a}_{1}, l_{1}} d_{a_{m}, l_{m m}}$, or

$$
\begin{align*}
& {\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{1 m} \mapsto 0, l_{2 m} \mapsto 0, \cdots, l_{m-1, m} \mapsto 0}=} \\
& \frac{\prod_{k=1}^{m} a_{k}!}{2^{M_{l_{2}}}\left(\prod_{i=1}^{m-1} \prod_{j=i}^{m-1} l_{i j}!\right) l_{m m}!\left(\prod_{j=1}^{m-1} L_{\boldsymbol{a}_{1}, j}!\right)\left(a_{m}-2 l_{m m}\right)!} \tag{6}
\end{align*}
$$

using (2) with $n=m-1$ and

$$
\begin{equation*}
d_{a_{1}, l}=\frac{a_{1}!}{2^{l} l!\left(a_{1}-2 l\right)!} \tag{7}
\end{equation*}
$$

${ }_{30}$ (Eq. (5), Song and Lee (2015)) for $l=0,1, \cdots,\left\lfloor\frac{a_{1}}{2}\right\rfloor$, where $\boldsymbol{a}_{1}=\left\{a_{i}\right\}_{i=1}^{m-1}$, $\boldsymbol{a}_{2}=\boldsymbol{a}_{1} \cup\left\{a_{m}\right\}, \boldsymbol{l}_{1}=\left\{l_{i j}\right\}$ with $j=i, i+1, \cdots, m-1$ for $i=1,2, \cdots, m-1$, and $\boldsymbol{l}_{2}=\boldsymbol{l}_{1} \cup\left\{l_{i m}\right\}_{i=1}^{m}$. Here, the symbol $\mapsto$ denotes a substitution: For example, $\alpha \mapsto \beta$ means the substitution of $\alpha$ with $\beta$.

Next, employing the result

$$
\begin{equation*}
\frac{\partial}{\partial \varphi_{i j}} E\left\{\prod_{k=1}^{n} X_{k}^{a_{k}}\right\}=a_{i} a_{j} E\left\{X_{i}^{a_{i}-1} X_{j}^{a_{j}-1} \prod_{\substack{k=1 \\ k \neq i, j}}^{n} X_{k}^{a_{k}}\right\} \tag{8}
\end{equation*}
$$

for $(i, j)=(1, m),(2, m), \cdots,(m-1, m)$ in Price (1958), and then taking some steps (similar to those from (16) to (20) in Song and Lee (2015)), we will get

$$
\begin{equation*}
\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{i m} \mapsto l_{i m}+1}=\frac{a_{i}!a_{m}!\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{i m} \mapsto 0, a_{i} \mapsto a_{i}-l_{i m}-1, a_{m} \mapsto a_{m}-l_{i m}-1}}{\left(a_{i}-l_{i m}-1\right)!\left(a_{m}-l_{i m}-1\right)!\left(l_{i m}+1\right)!} \tag{9}
\end{equation*}
$$

and then, by substituting $l_{i m}+1$ with $l_{i m}$ in (9), we have

$$
\begin{equation*}
d_{\boldsymbol{a}_{2}, l_{2}}=\frac{a_{i}!a_{m}!\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{i m} \mapsto 0, a_{i} \mapsto a_{i}-l_{i m}, a_{m} \mapsto a_{m}-l_{i m}}}{\left(a_{i}-l_{i m}\right)!\left(a_{m}-l_{i m}\right)!\left(l_{i m}\right)!} \tag{10}
\end{equation*}
$$

for $i=1,2, \cdots, m-1$. Now, letting $l_{2 m}=0$ in (10) with $i=1$, we get

$$
\begin{equation*}
\left[d_{\boldsymbol{a}_{2}, l_{2}}\right]_{l_{2 m} \mapsto 0}=\frac{a_{1}!a_{m}!\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{1 m} \mapsto 0, l_{2 m} \mapsto 0, a_{1} \mapsto a_{1}-l_{1 m}, a_{m} \mapsto a_{m}-l_{1 m}}}{\left(a_{1}-l_{1 m}\right)!\left(a_{m}-l_{1 m}\right)!l_{1 m}!} \tag{11}
\end{equation*}
$$

which can be used into (10) with $i=2$ to produce

$$
\begin{align*}
d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}= & \frac{a_{2}!a_{m}!}{\left(a_{2}-l_{2 m}\right)!\left(a_{m}-l_{2 m}\right)!l_{2 m}!} \times \frac{a_{1}!\left(a_{m}-l_{2 m}\right)!}{\left(a_{1}-l_{1 m}\right)!\left(a_{m}-l_{1 m}-l_{2 m}\right)!l_{1 m}!} \\
& \times\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{1 m} \mapsto 0, l_{2 m} \mapsto 0, a_{1} \mapsto a_{1}-l_{1 m}, a_{2} \mapsto a_{2}-l_{2 m}, a_{m} \mapsto a_{m}-l_{1 m}-l_{2 m}} . \tag{12}
\end{align*}
$$

${ }_{40}$ Subsequently, letting $l_{3 m}=0$ in (12), we get

$$
\begin{align*}
& {\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{3 m} \mapsto 0}=\frac{a_{1}!a_{2}!a_{m}!}{l_{1 m}!l_{2 m}!\left(a_{1}-l_{1 m}\right)!\left(a_{2}-l_{2 m}\right)!\left(a_{m}-l_{1 m}-l_{2 m}\right)!}} \\
& \quad \times\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{k m} \mapsto 0 \text { for } k=1,2,3, a_{1} \mapsto a_{1}-l_{1 m}, a_{2} \mapsto a_{2}-l_{2 m}, a_{m} \mapsto a_{m}-l_{1 m}-l_{2 m}} \tag{13}
\end{align*}
$$

which can be employed into (10) with $i=3$ to produce

$$
\begin{align*}
d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}= & \frac{a_{3}!a_{m}!}{\left(a_{3}-l_{3 m}\right)!\left(a_{m}-l_{3 m}\right)!l_{3 m}!} \\
& \times \frac{a_{1}!a_{2}!\left(a_{m}-l_{3 m}\right)!}{l_{1 m}!l_{2 m}!\left(a_{1}-l_{1 m}\right)!\left(a_{2}-l_{2 m}\right)!\left(a_{m}-l_{1 m}-l_{2 m}-l_{3 m}\right)!} \\
& \times\left[d_{\left.\boldsymbol{a}_{2}, \boldsymbol{l}_{2}\right]_{l_{k m} \mapsto 0, a_{k} \mapsto a_{k}-l_{k m}} \text { for } k=1,2,3, a_{m} \mapsto a_{m}-l_{1 m}-l_{2 m}-l_{3 m}} .\right. \tag{14}
\end{align*}
$$

From (14), it can be formulated

$$
\begin{align*}
d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}= & \frac{\left(\prod_{k=1}^{i} a_{k}!\right) a_{m}!}{\left(\prod_{k=1}^{i} l_{k m}!\right)\left\{\prod_{k=1}^{i}\left(a_{k}-l_{k m}\right)!\right\}\left(a_{m}-\sum_{k=1}^{i} l_{k m}\right)!} \\
& \times\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{k m} \mapsto 0, a_{k} \mapsto a_{k}-l_{k m} \text { for } k=1,2,3, a_{m} \mapsto a_{m}-\sum_{k=1}^{i} l_{k m}} \tag{15}
\end{align*}
$$

with $i=3$. Next, letting $l_{4 m}=0$ in (15), we will get $\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{4 m} \mapsto 0}$ which can be employed into (10) with $i=4$ to produce (15) with $i=4$. After proceeding the
${ }_{45}$ above procedures until $i=m-1$, we will eventually get

$$
\begin{align*}
d_{\boldsymbol{a}_{2}, l_{2}}= & \frac{\left(\prod_{k=1}^{m-1} a_{k}!\right) a_{m}!}{\left(\prod_{k=1}^{m-1} l_{k m}!\right)\left\{\prod_{k=1}^{m-1}\left(a_{k}-l_{k m}\right)!\right\}\left(a_{m}-\sum_{k=1}^{m-1} l_{k m}\right)!} \\
& \times\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{k m} \mapsto 0, a_{k} \mapsto a_{k}-l_{k m} \text { for } k=1,2, \cdots, m-1, a_{m} \mapsto a_{m}-\sum_{k=1}^{m-1} l_{k m}} \tag{16}
\end{align*}
$$

from $\left[d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}\right]_{l_{m-1, m \mapsto 0}}$ (obtained by letting $l_{m-1, m}=0$ in (15) with $i=m-2$ )
and (10) with $i=m-1$. Finally, by combining (6) into (16), we can get

$$
\begin{align*}
d_{\boldsymbol{a}_{2}, \boldsymbol{l}_{2}}= & \frac{\left(\prod_{k=1}^{m-1} a_{k}!\right) a_{m}!}{\left(\prod_{k=1}^{m-1} l_{k m}!\right)\left\{\prod_{k=1}^{m-1}\left(a_{k}-l_{k m}\right)!\right\}\left(a_{m}-\sum_{k=1}^{m-1} l_{k m}\right)!} \\
& \times \frac{\left\{\prod_{k=1}^{m-1}\left(a_{k}-l_{k m}\right)!\right\}\left(a_{m}-\sum_{k=1}^{m-1} l_{k m}\right)!}{2^{M_{l_{2}}\left(\prod_{k=1}^{m-1} \prod_{j=i}^{m-1} l_{k j}!\right) l_{m m}!}} \\
& \times \frac{\prod_{j=1}^{m-1}\left(\left[L_{\boldsymbol{a}_{1}, j}\right]_{a_{k} \mapsto a_{k}-l_{k m} \text { for }} k=1,2, \cdots, m-1\right)!}{\left(a_{m}-\sum_{k=1}^{m-1} l_{k m}-2 l_{m m}\right)!} \\
& \times \frac{1}{\left(\prod_{i=1}^{m} \prod_{j=i}^{m} l_{i j}!\right)\left(\prod_{j=1}^{m} L_{a_{2}, j}!\right)}
\end{align*}
$$

which implies that (2) holds when $n=m$ also.
