# Fast learning rate of deep learning via a kernel perspective

### Abstract

We develop a new theoretical framework to analyze the generalization error of deep learning, and derive a new fast learning rate for two representative algorithms: empirical risk minimization and *Bayesian deep learning*. The series of theoretical analyses of deep learning has revealed its high expressive power and universal approximation capability. Although these analyses are highly nonparametric, existing generalization error analyses have been developed mainly in a fixed dimensional parametric model. To compensate this gap, we develop an infinite dimensional model that is based on an integral form as performed in the analysis of the universal approximation capability. This allows us to define a reproducing kernel Hilbert space corresponding to each layer. Our point of view is to deal with the ordinary finite dimensional deep neural network as a finite approximation of the infinite dimensional one. The approximation error is evaluated by the *degree of freedom* of the reproducing kernel Hilbert space in each layer. To estimate a good finite dimensional model, we consider both of empirical risk minimization and Bayesian deep learning. We derive its generalization error bound and it is shown that there appears bias-variance trade-off in terms of the number of parameters of the finite dimensional approximation. We show that the optimal width of the internal layers can be determined through the degree of freedom and the convergence rate can be faster than  $O(1/\sqrt{n})$  rate which has been shown in the existing studies.

#### 1. Introduction

Deep learning has been showing great success in several applications such as computer vision, natural language processing, and many other area related to pattern recognition. Several high-performance methods have been developed and it has been revealed that deep learning possesses great potential. Despite the development of practical methodologies, its theoretical understanding is not satisfactory. Wide rage of researchers including theoreticians and practitioners are expecting deeper understanding of deep learning.

Among theories of deep learning, a well developed topic is its expressive power. It has been theoretically shown that deep neural network has exponentially large expressive power against the number of layers. For example, Montufar et al. (2014) showed that the number of polyhedral regions created by deep neural network can exponentially grow as the number of layers increases. Bianchini and Scarselli (2014) showed that the Betti numbers of the level set of a function created

by deep neural network grows up exponentially against the number of layers. Other researches also concluded similar facts using different notions such as tensor rank and extrinsic curvature (Cohen et al., 2016; Cohen and Shashua, 2016; Poole et al., 2016).

Another important issue in neural network theories is its universal approximation capability. It is well known that 3-layer neural networks have the ability, and thus the deep neural network also does (Cybenko, 1989; Hornik, 1991; Sonoda and Murata, 2015). When we discuss the universal approximation capability, the target function that is approximated is arbitrary and the theory is highly nonparametric in its nature.

Once we knew the expressive power and universal approximation capability of deep neural network, the next theoretical question naturally arises in its generalization error. The generalization ability is typically analyzed by evaluating the *Rademacher complexity*. Bartlett (1998) studied 3layer neural networks and characterized its Rademacher complexity using the norm of weights. Koltchinskii and Panchenko (2002) studied deep neural network and derived its Rademacher complexity under norm constraints. More recently, Neyshabur et al. (2015) analyzed the Rademacher complexity based on more generalized norm, and Sun et al. (2015) derived a generalization error bound with a large margine assumption. As a whole, the studies listed above derived  $O(1/\sqrt{n})$ convergence of the generalization error where n is the sample size. One concern in this line of convergence analyses is that the convergence of the generalization error is only  $O(1/\sqrt{n})$  where n is the sample size. Although this is minimax optimal, it is expected that we could show faster convergence rate with some additional assumptions such as strong convexity of the loss function. Actually, in a regular parametric model, we have O(1/n) convergence of the generalization error (Hartigan et al., 1998). Moreover, the generalization error bound has been mainly given in finite dimensional models. As we have observed, the deep neural network possesses exponential expressive power and universal approximation capability which are highly nonparametric characterizations. This means that the theories are developed separately in the two regimes; finite dimensional parametric model and infinite dimensional nonparametric model. Therefore, theories that connect these two regimes are expected to comprehensively understand statistical performance of deep learning.

In this paper, we consider both of empirical risk minimization and Bayesian deep learning and analyze the generalization error using the terminology of kernel methods. Consequently, (i) we derive a faster learning rate than  $O(1/\sqrt{n})$  and (ii) we connect the finite dimensional regime and the infinite dimensional regime based on the theories of kernel methods. The empirical risk minimization is a typical approach to learn the deep neural network model. It is usually performed by applying stochastic gradient descent with the back-propagation technique (Widrow and Hoff, 1960; Amari, 1967; Rumelhart et al.). To avoid over-fitting, such techniques as regularization and dropout have been employed (Srivastava et al., 2014). Although the practical techniques for the empirical risk minimization have been extensively studied, there is still much room for improvement in its generalization error analysis. Bayesian deep learning has been recently gathering more attentions mainly because it can deal with the estimation uncertainty in a natural way. Examples of Bayesian deep learning researches include probabilistic backpropagation (Hernandez-Lobato and Adams, 2015), Bayesian dark knowledge (Balan et al., 2015), weight uncertainty by Bayesian backpropagation (Blundell et al., 2015), dropout as Bayesian approximation (Gal and Ghahramani, 2016). To analyze a sharper generalization error bound, we utilize the so-called local Rademacher complexity technique for the empirical risk minimization method (Mendelson, 2002; Bartlett et al., 2005; Koltchinskii, 2006; Giné and Koltchinskii, 2006), and, as for the Bayesian method, we employ the theoretical techniques developed to analyze nonparametric Bayes methods (Ghosal et al., 2000;

van der Vaart and van Zanten, 2008, 2011). These analyses are quite advantageous to the typical Rademacher complexity analysis because we can obtain convergence rate between O(1/n) and  $O(1/\sqrt{n})$  which is faster than that of the standard Rademacher complexity analysis  $O(1/\sqrt{n})$ . As for the second contribution, we first introduce an integral form of deep neural network as performed in the research of the universal approximation capability of 3-layer neural networks (Sonoda and Murata, 2015). This allows us to have a nonparametric model of deep neural network as a natural extension of usual finite dimensional models. Afterward, we define a reproducing kernel Hilbert space (RKHS) corresponding to each layer like in Bach (2017, 2015). By doing so, we can borrow the terminology developed in the kernel method into the analysis of deep learning. In particular, we define the degree of freedom of the RKHS as a measure of complexity of the RKHS (Caponnetto and de Vito, 2007; Bach, 2015), and based on that, we evaluate how large a finite dimensional model should be to approximate the original infinite dimensional model with a specified precision. These theoretical developments reveal that there appears bias-variance trade-off. That is, there appears trade-off between the size of the finite dimensional model approximating the nonparametric model and the variance of the estimator. We will show that, by balancing the trade-off, a fast convergence rate is derived. In particularly, the optimal learning rate of the kernel method is reproduced from our deep learning analysis due to the fact that the kernel method can be seen as a 3-layer neural network with an infinite dimensional internal layer. A remarkable property of the derived generalization error bound is that the error is characterized by the complexities of the RKHSs defined by the degree of freedom. Moreover, the notion of the degree of freedom gives a practical implication about determination of the width of the internal layers.

The obtained generalization error bound is summarized in Table  $1^1$ .

### 2. Integral representation of deep neural network

Here we give our problem settings and the model that we consider in this paper. Suppose that n input-output observations  $D_n = (x_i, y_i)_{i=1}^n \subset \mathbb{R}^{d_x} \times \mathbb{R}$  are independently identically generated from a regression model

$$y_i = f^{o}(x_i) + \xi_i \ (i = 1, \dots, n)$$

where  $(\xi_i)_{i=1}^n$  is an i.i.d. sequence of Gaussian noises  $N(0, \sigma^2)$  with mean 0 and variance  $\sigma^2$ , and  $(x_i)_{i=1}^n$  is generated independently identically from a distribution P(X) with a compact support in  $\mathbb{R}^{d_x}$ . The purpose of the deep learning problem we consider in this paper is to estimate  $f^o$  from the *n* observations  $D_n$ .

To analyze the generalization ability of deep learning, we specify a function class in which the true function  $f^{o}$  is included, and, by doing so, we characterize the "complexity" of the true function in a correct way.

In order to give a better intuition, we first start from the simplest model, the 3-layer neural network. Let  $\eta$  be a nonlinear activation function such as ReLU (Nair and Hinton, 2010; Glorot et al., 2011);  $\eta(x) = (\max\{x_i, 0\})_{i=1}^d$  for a *d*-dimensional vector  $x \in \mathbb{R}^d$ . The 3-layer neural network model is represented by

$$f(x) = W^{(2)}\eta(W^{(1)}x + b^{(1)}) + b^{(2)}$$

where we denote by  $m_2$  the number of nodes in the internal layer, and  $W^{(2)} \in \mathbb{R}^{1 \times m_2}$ ,  $W^{(1)} \in \mathbb{R}^{m_2 \times d_x}$ ,  $b^{(1)} \in \mathbb{R}^{m_2}$  and  $b^{(2)} \in \mathbb{R}$ . It is known that this model is *universal approximator* and it is important to consider its *integral form* 

$$f(x) = \int h(w, b) \eta(w^{\top} x + b) dw db + b^{(2)}.$$
 (1)

where  $(w, b) \in \mathbb{R}^{d_x} \times \mathbb{R}$  is a hidden parameter,  $h : \mathbb{R}^{d_x} \times \mathbb{R} \to \mathbb{R}$  is a function version of the weight matrix  $W^{(2)}$ , and  $b^{(2)} \in \mathbb{R}$  is the bias term. This integral form appears in many places to analyze the capacity of the neural network. In particular, through the ridgelet analysis, it is shown that there exists the integral form corresponding to any  $f \in L_1(\mathbb{R}^{d_x})$  which has an integrable Fourier transform for an appropriately chosen activation function  $\eta$  such as ReLU (Sonoda and Murata, 2015).

Motivated by the integral form of the 3-layer neural network, we consider a more general representation for deeper neural network. To do so, we define a feature space on the  $\ell$ -th layer. The feature space is a a probability space  $(\mathcal{T}_{\ell}, \mathcal{B}_{\ell}, \mathcal{Q}_{\ell})$  where  $\mathcal{T}_{\ell}$  is a Polish space,  $\mathcal{B}_{\ell}$  is its Borel algebra, and  $\mathcal{Q}_{\ell}$  is a probability measure on  $(\mathcal{T}_{\ell}, \mathcal{B}_{\ell})$ . This is introduced to represent a general (possibly) continuous set of features as well as a discrete set of features. For example, if the  $\ell$ -th internal layer is endowed with a  $d_{\ell}$ -dimensional finite feature space, then  $\mathcal{T}_{\ell} = \{1, \ldots, d_{\ell}\}$ . On the other hand, the integral form (1) corresponds to a continuous feature space  $\mathcal{T}_2 = \{(w, b) \in \mathbb{R}^{d_x} \times \mathbb{R}\}$  in the second layer. Now the input x is a  $d_x$ -dimensional real vector, and thus we may set  $\mathcal{T}_1 = \{1, \ldots, d_x\}$ . Since the output is one dimensional, the output layer is just a singleton  $\mathcal{T}_{L+1} = \{1\}$ . Based on these feature spaces, our integral form of the deep neural network is constructed by stacking the map on the  $\ell$ -th layer  $f_{\ell}^{o} : L_2(Q_{\ell}) \to L_2(Q_{\ell+1})$  given as

$$f_{\ell}^{\mathrm{o}}[g](\tau) = \int_{\mathcal{T}_{\ell}} h_{\ell}^{\mathrm{o}}(\tau, w) \eta(g(w)) \mathrm{d}Q_{\ell}(w) + b_{\ell}^{\mathrm{o}}(\tau), \tag{2a}$$

where  $h_{\ell}^{o}(\tau, w)$  corresponds to the weight of the feature w for the output  $\tau$  and  $h_{\ell}^{o} \in L_{2}(Q_{\ell+1} \times Q_{\ell})$ and  $h_{\ell}^{o}(\tau, \cdot) \in L_{2}(Q_{\ell+1})$  for all  $\tau \in \mathcal{T}_{\ell+1}^{2}$ . Specifically, the first and the last layers are represented as

$$f_1^{\rm o}[x](\tau) = \sum_{j=1}^{d_{\rm x}} h_1^{\rm o}(\tau, j) x_j Q_1(j) + b_1^{\rm o}(\tau),$$
(2b)

$$f_L^{\rm o}[g](1) = \int_{\mathcal{T}_L} h_L^{\rm o}(w) \eta(g(w)) \mathrm{d}Q_L(w) + b_L^{\rm o}, \tag{2c}$$

where we wrote  $h_L^o(w)$  to indicate  $h_L^o(1, w)$  for simplicity because  $\mathcal{T}_{L+1} = \{1\}$ . Then the true function  $f^o$  is given as

$$f^{\mathbf{o}}(x) = f_L^{\mathbf{o}} \circ f_{L-1}^{\mathbf{o}} \circ \dots \circ f_1^{\mathbf{o}}(x).$$
(3)

Since, the shallow 3-layer neural network is a universal approximator, and so is our generalized deep neural network model (3). It is known that deep neural network tends to give more efficient representation of a function than the shallow network. Actually, Eldan and Shamir (2016) gave an example of a function that the 3-layer neural network cannot approximate under a precision unless its with is exponential in the input dimension but the 4-layer neural network can approximate with polynomial order widths (see Safran and Shamir (2016) for other examples). In other words, each layer of a deep neural network can be much "simpler" than one of a shallow network (more rigorous definition of complexity of each layer will be given in the next section). Therefore, it is quite important to consider the integral representation of a deep neural network rather than a 3-layer network.

The integral representation is natural also from the practical point of view. Indeed, it is well known that the deep neural network learns a simple pattern in the early layers and it gradually extracts more complicated features as the layer is going up. The trained feature is usually continuous one. For example, in computer vision tasks, the second layer typically extracts gradients toward several degree angles (Krizhevsky et al., 2012). The angle is a continuous variable and thus the feature space should be continuous to cover all angles. On the other hand, the real network discretize the feature space because of limitation of computational resources. Our theory introduced in the next section offers a measure to evaluate this discretization error.

### 3. Finite approximation of the integral form

The integral form is a convenient way to describe the true function. However, it is not useful to estimate the function. When we estimate that, we need to discretize the integrals by finite sums due to limitation of computational resources as we do in practice. In other word, we consider the usual finite sum deep learning model as an approximation of the integral form. However, the discrete approximation induces approximation error. Here we give an upper bound of the approximation error. Naturally, there arises the notion of bias and variance trade-off, that is, as the complexity of the finite model increases the "bias" (approximation error) decreases but the "variance" for finding the best parameter in the model increases. Afterwards, we will bound the variance for estimating

the finite approximation in Section 4.3. Combining these two notions, it is possible to quantify the bias-variance trade-off and find the best strategy to minimize the entire generalization error.

The approximation error analysis of the deep neural network can be well executed by utilizing notions of the kernel method. Here we construct RKHS for each layer in a way analogous to Bach (2015, 2017) who studied shallow learning and the kernel quadrature rule. Let the output of the  $\ell$ -th layer be  $F_{\ell}^{o}(x,\tau) := (f_{\ell}^{o} \circ \cdots \circ f_{1}^{o}(x))(\tau)$ . We define a *reproducing kernel Hilbert space* (RKHS) corresponding to the  $\ell$ -th layer ( $\ell \ge 2$ ) by introducing its associated kernel function  $k_{\ell} : \mathbb{R}^{d_{x}} \times \mathbb{R}^{d_{x}} \to \mathbb{R}$ . We define the positive definite kernel  $k_{\ell}$  as

$$\mathsf{k}_{\ell}(x,x') := \int_{\mathcal{T}_{\ell}} \eta(F^{\mathrm{o}}_{\ell-1}(x,\tau)) \eta(F^{\mathrm{o}}_{\ell-1}(x',\tau)) \mathrm{d}Q_{\ell}(\tau)$$

It is easy to check that  $k_{\ell}$  is actually symmetric and positive definite. It is known that there exists a unique RKHS  $\mathcal{H}_{\ell}$  corresponding the kernel  $k_{\ell}$  (Aronszajn, 1950). Close investigation of the RKHS for several examples for shallow network has been given in (Bach, 2017).

Under this setting, all arguments at the  $\ell$ -th layer can be carried out through the theories of kernel methods. Importantly, for  $g \in \mathcal{H}_{\ell}$ , there exists  $h \in L_2(Q_{\ell})$  such that

$$g(x) = \int_{T_{\ell}} h(\tau) \eta(F_{\ell-1}^{o}(x,\tau)) \mathrm{d}Q_{\ell}(\tau).$$

Moreover, the norms of g and h are connected as

$$||g||_{\mathcal{H}_{\ell}} = ||h||_{L_2(Q_{\ell})},\tag{4}$$

(Bach, 2015, 2017). Therefore, the function

$$x \mapsto \int_{\mathcal{T}_{\ell}} h^{\mathrm{o}}_{\ell}(\tau, w) \eta(F^{\mathrm{o}}_{\ell-1}(x, w)) \mathrm{d}Q_{\ell}(w),$$

representing the magnitude of a feature  $\tau \in \mathcal{T}_{\ell+1}$  for the input x is included in the RKHS and its RKHS norm is equivalent to that of the internal layer weight  $\|h^{o}(\tau, \cdot)\|_{L_{2}(Q_{\ell})}$  because of Eq. (4).

To derive the approximation error, we need to evaluate the "complexity" of the RKHS. Basically, the complexity of the  $\ell$ -th layer RKHS  $\mathcal{H}_{\ell}$  is controlled by the behavior of the eigenvalues of the kernel. To formally state this notion, we introduce the integral operator associated with the kernel  $k_{\ell}$  defined as

$$T_{\ell} : g \mapsto \int_{\mathcal{X}} \mathsf{k}_{\ell}(\cdot, x) g(x) \mathrm{d}P(x),$$
$$L_{2}(P(X)) \to L_{2}(P(X)).$$

If the kernel function admits an orthogonal decomposition

$$\mathsf{k}_{\ell}(x, x') = \sum_{j=1}^{\infty} \mu_j^{(\ell)} \phi_j^{(\ell)}(x) \phi_j^{(\ell)}(x'),$$

in  $L_2(P(X) \times P(X))$  where  $(\mu_j^{(\ell)})_{j=1}^{\infty}$  is the sequence of the eigenvalues ordered in decreasing order, and  $(\phi_j^{(\ell)})_{j=1}^{\infty}$  forms an orthonormal system in  $L_2(P(X))$ , then for  $g(x) = \sum_{j=1}^{\infty} \alpha_j \phi_j^{(\ell)}(x)$ , the

integral operation is expressed as  $T_{\ell}g = \sum_{j=1}^{\infty} \alpha_j \mu_j^{(\ell)} \phi_j^{(\ell)}$  (see Steinwart and Christmann (2008); Steinwart and Scovel (2012) for more details). Therefore each eigenvalue  $\mu_j^{(\ell)}$  plays a role like a "filter" for each component  $\phi_j^{(\ell)}$ . Here it is known that for all  $g \in \mathcal{H}_\ell$ , there exists  $\bar{h} \in L_2(P(X))$  such that  $g = T_\ell \bar{h}$  and  $\|g\|_{\mathcal{H}_\ell} = \|\bar{h}\|_{L_2(P(X))}$  (Caponnetto and de Vito, 2007; Steinwart et al., 2009). Combining this with Eq. (4), we have  $\|g\|_{\mathcal{H}_\ell} = \|h\|_{L_2(Q_\ell)} = \|\bar{h}\|_{L_2(P(X))}$ 

Based on the integral operator  $T_{\ell}$ , we define the *degree of freedom*  $N_{\ell}(\lambda)$  of the RKHS as

$$N_{\ell}(\lambda) = \operatorname{Tr}[(T_{\ell} + \lambda)^{-1}T_{\ell}]$$
(5)

for  $\lambda > 0$ . The degree of freedom can be represented as  $N_{\ell}(\lambda) = \sum_{j=1}^{\infty} \frac{\mu_j^{(\ell)}}{\mu_j^{(\ell)} + \lambda}$  by using the eigenvalues of the kernel.

Now, we assume that the true function  $f^{o}$  satisfies a norm condition as follows.

**Assumption 1** For each  $\ell$ ,  $h_{\ell}^{o}$  and  $b_{\ell}^{o}$  satisfy that

$$\begin{aligned} \|h_{\ell}^{\mathrm{o}}(\tau, \cdot)\|_{L_{2}(Q_{\ell})} &\leq R \ (\forall \tau \in T_{\ell})\\ |b_{\ell}^{\mathrm{o}}(\tau)| &\leq R_{b} \ (\forall \tau \in T_{\ell}). \end{aligned}$$

By Eq. (4), the first assumption  $\|h_{\ell}^{o}(\tau, \cdot)\|_{L_{2}(Q_{\ell})} \leq R$  is interpreted as  $F_{\ell}^{o}(\tau, \cdot) \in \mathcal{H}_{\ell}$  and  $\|F_{\ell}^{o}(\tau, \cdot)\|_{\mathcal{H}_{\ell}} \leq R$ . This means that the feature map  $F_{\ell}^{o}(\tau, \cdot)$  in each internal layer is well regulated by the RKHS norm.

Moreover, we also assume that the activation function is scale invariant.

**Assumption 2** We assume the following conditions on the activation function  $\eta$ .

- $\eta$  is scale invariant:  $\eta(ax) = a\eta(x)$  for all a > 0 and  $x \in \mathbb{R}^d$  (for arbitrary d).
- $\eta$  is 1-Lipschitz continuous:  $|\eta(x) \eta(x')| \le ||x x'||$  for all  $x, x' \in \mathbb{R}^d$ .

The first assumption on the scale invariance is essential to derive tight error bounds. The second one ensures that deviation in each layer does not affect the output so much. The most important example of an activation function that satisfies these conditions is ReLU activation. Another one is the identity map  $\eta(x) = x$ .

Finally we assume that the input distribution has a compact support.

**Assumption 3** The support of P(X) is compact and it is bounded as

$$||x||_{\infty} := \max_{1 \le i \le d_{x}} |x_{i}| \le D_{x} \ (\forall x \in \operatorname{supp}(P(X))).$$

We consider a finite dimensional approximation  $f^*$  given as follows: let  $m_\ell$  be the number of nodes in the  $\ell$ -th internal layer (we set the dimensions of the output and input layers to  $m_{L+1} = 1$  and  $m_1 = d_x$ ) and consider a model

$$f_{\ell}^{*}(g) = W^{(\ell)}\eta(g) + b^{(\ell)} \quad (g \in \mathbb{R}^{m_{\ell}}, \ \ell = 2, \dots, L),$$
  
$$f_{1}^{*}(x) = W^{(1)}x + b^{(1)},$$
  
$$f^{*}(x) = f_{L}^{*} \circ f_{L-1}^{*} \circ \dots \circ f_{1}^{*}(x),$$

where  $W^{(\ell)} \in \mathbb{R}^{m_{\ell+1} \times m_{\ell}}$  and  $b^{(\ell)} \in \mathbb{R}^{m_{\ell+1}}$ .

**Theorem 1 (Finite approximation error bound of the nonparametric model)** For any  $1 > \delta > 0$  and  $\lambda_{\ell} > 0$ , suppose that

 $m_{\ell} \ge 5N_{\ell}(\lambda_{\ell})\log\left(32N_{\ell}(\lambda_{\ell})/\delta\right) \quad (\ell=2,\ldots,L),$ 

then there exist  $W^{(\ell)} \in \mathbb{R}^{m_{\ell+1} \times m_{\ell}}$  and  $b^{(\ell)} \in \mathbb{R}^{m_{\ell+1}}$  such that, by letting  $\hat{c}_{\delta} = \frac{4}{1-\delta}$ ,

$$\|W^{(\ell)}\|_{\mathbf{F}}^2 \le \hat{c}_{\delta} R^2 \ (\ell = 1, \dots, L),$$
 (6a)

$$\|b^{(\ell)}\| \le R_b/(1-\delta) \ (\ell=1,\dots,L),$$
 (6b)

and

$$\|f^{o} - f^{*}\|_{L_{2}(P(X))} \leq \sum_{\ell=2}^{L} 2\sqrt{\hat{c}_{\delta}^{L-\ell}} R^{L-\ell+1} \sqrt{\lambda_{\ell}},$$
(7)

$$\|f^*\|_{\infty} \le (\sqrt{\hat{c}_{\delta}}R)^L D_x + \sum_{\ell=1}^L (\sqrt{\hat{c}_{\delta}}R)^{L-\ell} \frac{R_b}{1-\delta}.$$
(8)

The proof is given in Appendix A. This theorem is proven by borrowing the theoretical technique recently developed for the *kernel quadrature rule* (Bach, 2015). We also employed some techniques analogous to the analysis of the low rank tensor estimation (Suzuki, 2015; Kanagawa et al., 2016; Suzuki et al., 2016). Intuitively, the degree of freedom  $N_{\ell}(\lambda_{\ell})$  is the intrinsic dimension of the  $\ell$ -th layer to achieve the  $\sqrt{\lambda_{\ell}}$  approximation error. Indeed, we show in the proof that the  $\ell$ -th layer is approximated by the  $m_{\ell}$  dimensional nodes with the precision  $\sqrt{\lambda_{\ell}}$  under the condition  $m_{\ell} = \Omega(N_{\ell}(\lambda_{\ell}) \log(N_{\ell}(\lambda_{\ell})))$ . The error bound (7) indicates that the total approximation error of the whole network is basically obtained by summing up the approximation error  $\sqrt{\lambda_{\ell}}$  of each layer where the factor  $\sqrt{\hat{c}_{\delta}^{L-\ell}}R^{L-\ell+1}$  is a Lipschitz constant for error propagation.

We would like to emphasize that the approximation error bound (7) and the norm bounds (6) of  $W^{(\ell)}$  and  $b^{(\ell)}$  are independent of the dimensions  $(m_{\ell})_{\ell=1}^{L}$  of the internal layers. This is due to the scale invariance property of the activation function. This is quite beneficial to derive a tight generalization error bound. Indeed, without the scale invariance, we only have a much looser bound  $\|f^{o} - f^{*}\|_{L_{2}(P(X))} \leq \sum_{\ell=2}^{L} 2\sqrt{m_{\ell+1}\hat{c}_{\delta}^{L-\ell}}R^{L-\ell+1}\sqrt{\lambda_{\ell}}$ , and  $\|W^{(\ell)}\|_{\mathrm{F}}^{2} \leq m_{\ell+1}\hat{c}_{\delta}R^{2}$ ,  $\|b^{(\ell)}\|^{2} \leq m_{\ell+1}R_{b}^{2}$  which depend on the dimensions  $(m_{\ell})_{\ell=1}^{L}$  and could be huge for small  $\lambda_{\ell}$ . This would support the practical success of using the ReLU activation.

Let the norm bounds shown in Theorem 1 be

$$\bar{R} = \sqrt{\hat{c}_{\delta}}R, \ \bar{R}_b = R_b/(1-\delta).$$

Remind that Theorem 1 gives an upper bound of the infinity norm of  $f^*$ , that is,  $||f^*||_{\infty} \leq \hat{R}_{\infty}$  where

$$\hat{R}_{\infty} = \bar{R}^L D_x + \sum_{\ell=1}^L \bar{R}^{L-\ell} \bar{R}_b.$$

Let the set of finite dimensional functions with the norm constraint (6) be

$$\mathcal{F} = \{ f(x) = (W^{(L)}\eta(\cdot) + b^{(L)}) \circ \cdots \circ (W^{(1)}x + b^{(1)}) \mid ||W^{(\ell)}||_{\mathbf{F}} \le \bar{R}, ||b^{(\ell)}|| \le \bar{R}_b \ (\ell = 1, \dots, L) \}$$

Then, we can show that the infinity norm of  $\mathcal{F}$  is also uniformly bounded as the following lemma.

**Lemma 1** For all  $f \in \mathcal{F}$ , it holds that  $||f||_{\infty} \leq \hat{R}_{\infty}$ .

The proof is given in Appendix A.2. Because of this, we can derive the generalization error bound with respect to the population  $L_2$ -norm instead of the empirical  $L_2$ -norm. One can check that  $||f||_{\infty} \leq \hat{R}_{\infty}$  for all  $f \in \mathcal{F}$  by Lemma 1 or Lemma 3.

### 4. Generalization error bounds

In this section, we define the two estimators in the finite dimensional model introduced in the last section: the empirical risk minimizer and the Bayes estimator. The generalization error bounds for both of these estimators are derived. We also give some examples in which the generalization error is analyzed in details.

#### 4.1 Notations

Before we state the generalization error bounds, we prepare some notations. Let  $\hat{G} = L\bar{R}^{L-1}D_x + \sum_{\ell=1}^{L} \bar{R}^{L-\ell}$ , and define  $\hat{\delta}_{1,n}$ ,  $\hat{\delta}_{2,n}$  as<sup>3</sup>

$$\hat{\delta}_{1,n} = \sum_{\ell=2}^{L} 2\sqrt{\hat{c}_{\delta}^{L-\ell}} R^{L-\ell+1} \sqrt{\lambda_{\ell}},$$
$$\hat{\delta}_{2,n}^{2} = \frac{2}{n} \sum_{\ell=1}^{L} m_{\ell} m_{\ell+1} \log_{+} \left( 1 + \frac{4\sqrt{2}\hat{G} \max\{\bar{R},\bar{R}_{b}\}\sqrt{n}}{\sigma\sqrt{\sum_{\ell=1}^{L} m_{\ell} m_{\ell+1}}} \right)$$

Note that  $\hat{\delta}_{1,n}$  is the finite approximation error given in Theorem 1. Roughly speaking,  $\hat{\delta}_{2,n}$  corresponds to the amount of deviation of the estimators in the finite dimensional model.

### 4.2 Empirical risk minimization

In this section, we define the empirical risk minimizer and investigate its generalization error. Let the empirical risk minimizer be  $\hat{f}$ :

$$\widehat{f} := \operatorname*{argmin}_{f \in \mathcal{F}} \sum_{i=1}^{n} (y_i - f(x_i))^2.$$

Note that there exists at least one minimizer because the parameter set corresponding to  $\mathcal{F}$  is a compact set and  $\eta$  is a continuous function.  $\hat{f}$  needs not necessarily be the exact minimizer but it could be an approximated minimizer. We, however, assume  $\hat{f}$  is the exact minimizer for theoretical simplicity. In practice, the empirical risk minimizer is obtained by using the back-propagation technique. The regularization for the norm of the weight matrices and the bias terms are implemented by using the  $L_2$ -regularization and the drop-out techniques.

The generalization error of the empirical risk minimizer is bounded as in the following theorem.

**Theorem 2** For any  $\delta > 0$  and  $\lambda_{\ell} > 0$ , suppose that

$$n_{\ell} \ge 5N_{\ell}(\lambda_{\ell})\log\left(32N_{\ell}(\lambda_{\ell})/\delta\right) \quad (\ell = 2, \dots, L).$$
(9)

<sup>3.</sup> We define  $\log_+(x) = \max\{1, \log(x)\}.$ 

Then, there exists universal constants  $C_1$  such that, for any r > 0 and  $\tilde{r} > 1$ ,

$$\|\widehat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} \leq C_{3} \left\{ \widetilde{r} \widehat{\delta}_{1,n}^{2} + (\sigma^{2} + \widehat{R}_{\infty}^{2}) \widehat{\delta}_{2,n}^{2} + \frac{(\widehat{R}_{\infty}^{2} + \sigma^{2})}{n} \left[ \log_{+} \left( \frac{\sqrt{n}}{\min\{\sigma/\widehat{R}_{\infty}, 1\}} \right) + r \right] \right\}$$

with probability 
$$1 - \exp\left(-\frac{n\delta_{1,n}^2(\tilde{r}-1)^2}{11\hat{R}_{\infty}^2}\right) - 2\exp(-r)$$
 for every  $r > 0$  and  $\tilde{r}' > 1$ .

The proof is given in Appendix C. This theorem can be shown by evaluating the covering number of the model  $\mathcal{F}$  and applying the local Rademacher complexity technique (Mendelson, 2002; Bartlett et al., 2005; Koltchinskii, 2006; Giné and Koltchinskii, 2006).

It is easily checked that the third term of the right side  $\left(\frac{(\hat{R}_{\infty}^2 + \sigma^2)}{n} \left[ \log_+ \left( \frac{\sqrt{n}}{\min\{\sigma/\hat{R}_{\infty}, 1\}} \right) + r \right] \right)$  is smaller than the first two terms, therefore the generalization error bound can be simply evaluated as

$$\|\widehat{f} - f^{\mathrm{o}}\|_{L_2}^2 = O_p(\widehat{\delta}_{1,n}^2 + \widehat{\delta}_{2,n}^2).$$

Based on a rough evaluation

$$\hat{\delta}_{1,n}^2 \simeq L \sum_{\ell=1}^L \lambda_\ell, \quad \hat{\delta}_{2,n}^2 \simeq \sum_{\ell=1}^L \frac{m_\ell m_{\ell+1}}{n} \log(n),$$

and the constraint  $m_{\ell} \gtrsim N_{\ell}(\lambda_{\ell}) \log(N_{\ell}(\lambda_{\ell}))$ , we can observe the bias-variance trade-off for the generalization error bound because, as  $\lambda_{\ell}$  decreases, the required width of the internal layer  $m_{\ell}$  increases by the condition (9) and thus the deviation  $\hat{\delta}_{2,n}$  in the finite dimensional model should increase. In other words, if we want to construct a finite dimensional model which well approximates the true function, then a more complicated model is required and we should pay larger variance of the estimator. A key notion for the bias-variance trade-off is the degree of freedom  $N_{\ell}(\lambda_{\ell})$  which expresses the "complexity" of the RKHS  $\mathcal{H}_{\ell}$  in each layer. The degree of freedom of a complicated RKHS grows up faster than a simpler one as  $\lambda$  goes to 0. This is also informative in practice because, to determine the width of each layer, the degree of freedom gives a good guidance. That is, if the degree of freedom is small compared with the sample size, then we may increase the width of the layer. An estimate of the degree of freedom can be computed from the trained network by computing the Gram matrix corresponding to the kernel induced from the trained network (where the kernel is defined by the finite sum instead of the integral form) and using the eigenvalue of the Gram matrix.

To obtain the best generalization error bound,  $(\lambda_{\ell})_{\ell=1}^{L}$  should be tuned to balance the biasvariance terms (and accordingly  $(m_{\ell})_{\ell=2}^{L}$  should also be fine-tuned). The examples of the best achievable generalization error will be shown in Section 4.4.

#### 4.3 Bayes estimator

In this section, we formulate a Bayes estimator and derive its generalization error. To define the Bayes estimator, we just need to specify the prior distribution. Let  $\mathcal{B}_d(C)$  be the ball in the Euclidean space  $\mathbb{R}^d$  with radius C > 0 ( $\mathcal{B}_d(C) = \{x \in \mathbb{R}^d \mid ||x|| \leq C\}$ ), and  $U(\mathcal{B}_d(C))$  be the uniform distribution on the ball  $\mathcal{B}_d(C)$ . Since Theorem 1 ensures the norms of  $W^{(\ell)}$  and  $b^{(\ell)}$  are bounded above by  $\overline{R}$  and  $\overline{R}_b$ , it is natural to employ a prior distribution that possesses its support on the set of

parameters with norms not greater than those norm bounds. Based on this observation, we employ uniform distributions on balls with the radii indicated above as a prior distribution:

$$W^{(\ell)} \sim \mathrm{U}(\mathcal{B}_{m_{\ell+1} \times m_{\ell}}(\bar{R})), \ b^{(\ell)} \sim \mathrm{U}(\mathcal{B}_{m_{\ell+1}}(\bar{R}_b)).$$

In practice, the Gaussian distribution is also employed instead of the uniform distribution. However, the Gaussian distribution does not give good tail probability bound for the infinity norm of the deep neural network model. That is crucial to develop the generalization error bound. For this reason, we decided to analyze the uniform prior distribution.

The prior distribution on the parameters  $(W^{(\ell)}, b^{(\ell)})_{\ell=1}^L$  induces the distribution of the function f in the space of continuous functions endowed with the Borel algebra corresponding to the  $L_{\infty}(\mathbb{R}^{d_x})$ -norm. We denote by  $\Pi$  the induced distribution. Using the prior, the posterior distribution is defined via the Bayes principle:

$$\Pi(\mathrm{d}f|D_n) = \frac{\exp(-\sum_{i=1}^n \frac{(y_i - f(x_i))^2}{2\sigma^2})\Pi(\mathrm{d}f)}{\int \exp(-\sum_{i=1}^n \frac{(y_i - f'(x_i))^2}{2\sigma^2})\Pi(\mathrm{d}f')}$$

Since the purpose of this paper is to give a theoretical analysis for the generalization error, we do not pursue the computational issue of the Bayesian deep learning. See, for example, Hernandez-Lobato and Adams (2015); Blundell et al. (2015) for practical algorithms.

The following theorem gives how fast the Bayes posterior contracts around the true function.

**Theorem 3** Fix arbitrary  $\delta > 0$  and  $\lambda_{\ell} > 0$  ( $\ell = 1, ..., L$ ), and suppose that the condition (9) on  $m_{\ell}$  is satisfied. Then, for all  $r \ge 1$ , the posterior tail probability can be bounded as

$$\mathbb{E}_{D_n} \left[ \Pi(f: \|f - f^{\mathrm{o}}\|_{L_2(P(X))} \ge (\hat{\delta}_{1,n} + \sigma \hat{\delta}_{2,n}) r \sqrt{\max\{12, 33\frac{\hat{R}_{\infty}^2}{\sigma^2}\}} |D_n) \right]$$
  
$$\le \exp\left[ -n \hat{\delta}_{1,n}^2 \frac{(r^2 - 1)^2}{11\hat{R}_{\infty}^2} \right] + 12 \exp\left( -n (\hat{\delta}_{1,n} + \sigma \hat{\delta}_{2,n})^2 \frac{r^2}{8\sigma^2} \right).$$

The proof is given in Appendix B. The proof is accomplished by using the technique for non-parametric Bayes methods (Ghosal et al., 2000; van der Vaart and van Zanten, 2008, 2011). Roughly speaking this theorem indicates that the posterior distribution concentrates in the distance  $\hat{\delta}_{1,n} + \sigma \hat{\delta}_{2,n}$  from the true function  $f^{\circ}$ . The tail probability is sub-Gaussian and thus the posterior mass outside the distance  $\hat{\delta}_{1,n} + \sigma \hat{\delta}_{2,n}$  from the true function rapidly decrease. Here we again observe that there appears bias-variance trade-off between  $\hat{\delta}_{1,n}$  and  $\hat{\delta}_{2,n}$ . This can be understood essentially in the same way as the empirical risk minimization.

From the posterior contraction rate, we can derive the generalization error bound of the posterior mean.

**Corollary 1** Under the same setting as in Theorem 3, there exists a universal constant  $C_1$  such that the generalization error of the posterior mean  $\hat{f}$  is bounded as

$$\mathbf{E}_{D_n}\left[\|\widehat{f} - f^{\mathbf{o}}\|_{L_2(P(X))}^2\right] \le C_1 \max\left\{12, \frac{33\hat{R}_{\infty}^2}{\sigma^2}\right\} \left[\left(1 + \frac{\hat{R}_{\infty}}{\sqrt{n\hat{\delta}_{1,n}^2}}\right)(\hat{\delta}_{1,n}^2 + \sigma^2\hat{\delta}_{2,n}^2) + \frac{\sigma^2}{n}\right].$$

Therefore, for sufficiently large n such that  $n\hat{\delta}_{1,n}^2/\hat{R}_{\infty}^2 \ge 1$  (which is the regime of our interest), the generalization error is simply bounded as

$$\|\widehat{f} - f^{\mathrm{o}}\|_{L_{2}(P(X))}^{2} = O_{p}\left(\max\{1, \frac{\widehat{R}_{\infty}^{2}}{\sigma^{2}}\}(\widehat{\delta}_{1,n}^{2} + \sigma^{2}\widehat{\delta}_{2,n}^{2})\right).$$

### 4.4 Examples

Here, we give some examples of the generalization error bound. We have seen that both of the empirical risk minimizer and the Bayes estimators have a simplified generalization error bound as

$$\|\widehat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} = O_{p}(\widehat{\delta}_{1,n}^{2} + \widehat{\delta}_{2,n}^{2}) = O_{p}\left(L\sum_{\ell=2}^{L} \bar{R}^{L-\ell+1}\lambda_{\ell} + \sum_{\ell=1}^{L} \frac{m_{\ell}m_{\ell+1}}{n}\log(n)\right),$$

by supposing  $\sigma$ ,  $\hat{R}_{\infty}$  and  $\sqrt{\hat{c}_{\delta}^{L}R^{L}}$  are in constant order. We evaluate the bound under the best choice of  $m_{\ell}$  balancing the bias-variance trade-off.

One way to balance the terms is to set  $\lambda_{\ell}$  so that

$$\sum_{\ell=2}^{L} \lambda_{\ell} = \sum_{\ell=1}^{L} \frac{m_{\ell} m_{\ell+1}}{n}$$

where the  $\log(n)$ -factor and L are dropped for simplicity. Since the inequality of arithmetic sum geometric mean gives  $\sum_{\ell=1}^{L} \frac{m_{\ell} m_{\ell+1}}{n} \leq \sum_{\ell=1}^{L+1} \frac{m_{\ell}^2}{n}$ , we may set  $m_{\ell}$  to satisfy

$$\lambda_{\ell} = \frac{m_{\ell}^2}{n} \quad (\ell = 2, \dots, L). \tag{10}$$

Considering this relation and the constraint  $m_{\ell} \gtrsim N_{\ell}(\lambda_{\ell}) \log(N_{\ell})$  (Eq. (9)), we can estimate the best width  $m_{\ell}$  that minimizes the upper bound of the generalization error.

#### 4.4.1 FINITE DIMENSIONAL INTERNAL LAYER

If all RKHSs are finite dimensional, say  $m_{\ell}^*$ -dimensional. Then  $N_{\ell}(\lambda) \leq m_{\ell}^*$  for all  $\lambda \geq 0$ . Therefore, by setting  $\lambda_{\ell} = 0$  ( $\forall \ell$ ), the generalization error bound is obtained as

$$\|\widehat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} \lesssim \frac{\sigma^{2} + \widehat{R}_{\infty}^{2}}{n} \sum_{\ell=1}^{L} m_{\ell}^{*} m_{\ell+1}^{*} \log(n),$$
(11)

where we omitted the factors depending only on  $\log(\bar{R}\bar{R}_b\hat{G})$ . Note that, although there appears the  $L_{\infty}$ -norm bound  $\hat{R}_{\infty}$ , this convergence rate is independent of the Lipschitz constant  $\bar{R}^{L-\ell+1}$  and  $\bar{R}_b$  up to log-order but is solely dependent on the number of parameters. Moreover, the convergence rate is  $O(\log(n)/n)$  in terms of the sample size n. This is much faster than the existing bounds that utilize the Rademacher complexity because their bounds are  $O(1/\sqrt{n})$ . This result matches more precise arguments for a finite dimensional 3-layer neural network based on asymptotic expansions (Fukumizu, 1999; Watanabe, 2001) which also showed the generalization error of the 3-layer neural network can be evaluated as  $O((m_1^*m_2^* + m_2^*m_3^*)/n)$ .

### 4.4.2 POLYNOMIAL DECREASING RATE OF EIGENVALUES

We assume that the eigenvalue  $\mu_i^{(\ell)}$  decays in polynomial order as

$$\mu_j^{(\ell)} \le a_\ell j^{-\frac{1}{s_\ell}},\tag{12}$$

for a positive real  $0 < s_{\ell} < 1$  and  $a_{\ell} > 0$ . This is a standard assumption in the analysis of kernel methods (Caponnetto and de Vito, 2007; Steinwart and Christmann, 2008), and it is known that this assumption is equivalent to the usual covering number assumption (Steinwart et al., 2009). For small  $s_{\ell}$ , the decay rate is fast and it is easy to approximate the kernel by another one corresponding to a finite dimensional subspace. Therefore small  $s_{\ell}$  corresponds to a simple model and large  $s_{\ell}$  corresponds to a complicated model. In this setting, the degree of freedom is evaluated as

$$N_{\ell}(\lambda_{\ell}) \lesssim (\lambda_{\ell}/a_{\ell})^{-s_{\ell}} \,. \tag{13}$$

This can be shown as follows: for any positive integer M, the degree of freedom can be bounded as

$$N_{\ell}(\lambda_{\ell}) = \sum_{j=1}^{\infty} \frac{\mu_j^{(\ell)}}{\mu_j^{(\ell)} + \lambda_{\ell}} \le M + \sum_{j=M+1}^{\infty} \frac{\mu_j^{(\ell)}}{\lambda_{\ell}} \le M + \frac{a_{\ell}}{\lambda_{\ell}} \int_M^{\infty} x^{-1/s_{\ell}} \mathrm{d}x$$
$$\le M + (a_{\ell}/\lambda_{\ell})(1 - 1/s_{\ell})^{-1} M^{1 - 1/s_{\ell}}.$$

Letting  $M = \left[ (a_{\ell}/\lambda_{\ell})(1-1/s_{\ell})^{-1} \right]^{s_{\ell}}$  to balance the first and the second term, we obtain the evaluation (13). Hence, we can show that, according to Eq. (10),

$$\lambda_{\ell} = a_{\ell}^{\frac{2s_{\ell}}{1+2s_{\ell}}} n^{-\frac{1}{1+2s_{\ell}}}$$

gives the optimal rate, and we obtain the generalization error bound as

$$\|\widehat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} \lesssim L \sum_{\ell=2}^{L} (\bar{R} \vee 1)^{2(L-\ell+1)} a_{\ell}^{\frac{2s_{\ell}}{1+2s_{\ell}}} n^{-\frac{1}{1+2s_{\ell}}} \log\left(n\right) + \frac{d_{x}^{2}}{n} \log(n), \qquad (14)$$

where we omitted the factors depending on  $s_{\ell}$ ,  $\log(\bar{R}\bar{R}_b\hat{G})$ ,  $\sigma^2$  and  $\hat{R}_{\infty}$ . This indicates that the complexity  $s_{\ell}$  of the RKHS affects the convergence rate directly. As expected, if the RKHSs are simple (that is,  $(s_{\ell})_{\ell=2}^{L}$  are small), we obtain faster convergence.

### 4.4.3 ONE INTERNAL LAYER: KERNEL METHOD

Finally, we consider a simple but important situation in which there is only one internal layer (L = 2). In this setting, we only need to adjust  $m_2$  because the dimensions of input and output are fixed as  $m_1 = d_x$  and  $m_3 = 1$ . We assume that the same condition (12) for  $\ell = 2$ . Then, applying the condition (10),

$$\lambda_2 = \frac{(d_{\mathbf{x}} + 1)m_2}{n} \quad \Rightarrow \quad \lambda_2 \simeq a_2^{\frac{s_2}{1+s_2}} \left(\frac{n}{d_{\mathbf{x}} + 1}\right)^{-\frac{1}{1+s_2}} \log(n)$$

gives the optimal convergence rate. Actually, we obtain

$$\|\widehat{f} - f^{\mathbf{o}}\|_{L_2(P(X))}^2 \lesssim ((\bar{R} \vee 1)^2 a_2^{\frac{s_2}{1+s_2}})(d_{\mathbf{x}} + 1)^{\frac{1}{1+s_2}} n^{-\frac{1}{1+s_2}} \log(n).$$

This convergence rate is equivalent to the minimax optimal convergence rate of the kernel ridge regression (Caponnetto and de Vito, 2007; Steinwart et al., 2009) (up to constant and log(n) factors). It is known that the kernel method corresponds to the 3-layer neural network with an infinite dimensional internal layer. In that sense, our analysis includes that of kernel methods. In particular, the finite dimensional approximation we performed in Section 3 can be seen as the kernel quadrature rule (Bach, 2015). Thus, the analysis here ensures that the kernel quadrature rule can achieve the optimal rate as a byproduct of the neural network analysis. In that sense, we can say that the deep neural network is a method that constructs an optimal kernel in a layer-wise manner using a kernel quadrature rule.

Some concrete examples have bee investigated in Bach (2017) for the three layer neural network. However, the analysis does not assume that the loss function is strongly convex, and thus the local Rademacher complexity analysis is not applied. Consequently, the convergence rate is slower than  $O(1/\sqrt{n})$ .

The convergence rate is  $O(n^{-\frac{1}{1+s_2}})$  when L = 2, but we have already observed that the convergence rate (14) of the deep neural network is basically  $\sum_{\ell=2}^{L} n^{-\frac{1}{1+2s_{\ell}}}$ . The sample complexity in each layer is slow for deep neural network (there is a factor 2 before  $s_{\ell}$ ). This is because we need to estimate a matrix in each layer for deep neural network and the number of output grows up as the sample size increases, and as a result, the number of parameters that should be estimated is much larger than the 3-layer neural network in which the dimensions of the input and output are fixed.

### 5. Relations to existing work

In this section, we describe the relation of our work to existing works

The sample complexity of deep neural network has been extensively studied by analyzing its Rademacher complexity. For example, Bartlett (1998) characterized the generalization error of a 3-layer neural network by the norm of the weight vectors instead of the number of parameters. Koltchinskii and Panchenko (2002) studied more general deep neural network and derived its generalization error bound of deep neural network under a norm constraint. They showed the Rademacher complexity of the deep neural network is bounded by the sum of those of single layer neural networks. This is similar to our generalization error bound obtained in Eqs.(14) and (11). More recently, Neyshabur et al. (2015) analyzed the Rademacher complexity of the deep neural network based on the norms of the weight matrix  $(\{W^{(\ell)}\}_{\ell=1}^L$  in our paper). Sun et al. (2015) also derived the Rademacher complexity and showed the generalization error under a large margin assumption. As consequences of these studies, they derived the following type of inequalities:

$$E_{X,Y}[l(\widehat{f}(X),Y)] \le \frac{1}{n} \sum_{i=1}^{n} l(\widehat{f}(x_i),y_i) + \frac{CR^{2L}}{\sqrt{n}}$$

with high probability where l is a loss function,  $\hat{f}$  is the empirical risk minimizer with or without regularization and R is a norm bound of the internal layers (the definition of the norm differs between papers). Basically, these studies considered the finite dimensional situation which was studied in Section 4.4.1 as a special case of our analysis, and a connection to an infinite dimensional model has not been closely discussed. In particular, the bias-variance trade-off has not been analyzed. Moreover, the generalization error is  $O(1/\sqrt{n})$  which is much slower dependency on the sample size than that of our rate O(1/n). This is a big difference from the existing analysis. To improve the convergence rate to faster one for empirical risk minimization approaches, so called *local Rademacher complexity* was important in our analysis. Moreover, we have observed that the Bayesian analysis also gave faster convergence rate.

Analysis of the bias-variance trade-off in three layer neural network from the kernel point of view has been investigated by Bach (2017). The analysis is given for several concrete examples. However, the loss function is not assumed to be strongly convex, and thus the obtained rate is not faster than  $O(1/\sqrt{n})$ .

Another important topic for the analysis of the generalization ability is VC-dimension analysis. VC-dimension of the deep neural network has been studied by, for example, Bartlett et al. (1998); Karpinski and Macintyre (1997); Goldberg and Jerrum (1995). However, VC-dimension is a notion independent of the input distributions. On the other hand, the degree of freedom considered in our paper depends on the input distribution and is more data specific. Hence, our analysis gives tighter bound and could be practically more useful.

In our analysis, the kernel formulation of deep neural network model was the key ingredient for the analysis. Some authors have proposed methods that utilize the representation in the internal layers as a feature map into some RKHS as in our formulation. For example, Cho and Saul (2009); Mairal et al. (2014); Mairal (2016) have proposed novel methods to construct a kernel via deep learning. Their purpose is to suggest a new hierarchical method to construct a kernel, and their proposed methods are different from the ordinary deep learning model. On the other hand, our theoretical approach states that deep learning *itself* can be interpreted as a kind of kernel learning. Moreover, their studies are not for theories but for methodologies. Hence, our analysis and their studies are in complementary relationship, and our analysis would give theoretical support for their methods.

### 6. Conclusion and future work

In this paper, we proposed to use the integral form of deep neural network for generalization error analysis, and based on that, we derived the generalization error bound of the empirical risk minimizer and the Bayes estimator. The integral form enabled us to define an RKHS in each layer, and import the theoretical techniques developed in kernel methods into the analysis of deep learning. In particular, we defined the degree of freedom of each RKHS and showed that the approximation error between a finite dimensional model and the integral form can be characterized by the degree of freedom. In addition to the approximation error, we also derived the estimation error in the finite dimensional model. We have observed that there appears bias-variance trade-off depending on the size of the finite dimensional model.

Based on the analysis, we also derived generalization error bounds of some examples including the situation where the eigenvalues of the kernel function decay in a polynomial order, the one where the true model is finite dimensional, and the one where there is only one internal layer. We have observed that the analysis of the 3-layer neural network reproduces the optimal learning rate of the kernel method up to  $\log(n)$ -order.

Our theoretical frame-work offered a clear description of the bias-variance trade-off for deep learning. This was particularly useful to determine the optimal widths of the internal layers. We believe this study opens up a new direction of a series of theoretical analyses of deep learning.

There remain several topics to be studied. One is characterization of the space of the deep neural network described by the integral form. The integral form can approximate arbitrary function, but

under the norm constraints as we have assumed, it is unclear how large the function class is. Solving this issue is interesting future work.

## Appendix A. Proof of Theorem 1

#### A.1 Approximation error bound for the finite dimensional model

To derive the approximation error bound, we utilize the following proposition that was proven by Bach (2015).

**Proposition 1** For  $\lambda > 0$ , there exists a probability density  $q_{\ell}(\tau)$  with respect to the measure  $Q_{\ell}$  such that, for any  $\delta \in (0, 1)$ , i.i.d. sample  $v_1, \ldots, v_m$  from  $q_{\ell}$  satisfies that

$$\sup_{\|f\|_{\mathcal{H}_{\ell}} \le 1} \inf_{\beta \in \mathbb{R}^m : \|\beta\|_2^2 \le \frac{4}{m}} \left\| f - \sum_{j=1}^m \beta_j q_\ell(v_j)^{-1/2} \eta(F_{\ell-1}(\cdot, v_j)) \right\|_{L_2(P(X))}^2 \le 4\lambda,$$

with probability  $1 - \delta$ , if

$$m \ge 5N_{\ell}(\lambda)\log(16N_{\ell}(\lambda)/\delta).$$

By the scale invaliance of  $\eta$ ,  $\eta(ax) = a\eta(x)$  (a > 0), we have the following proposition based on Proposition 1.

**Proposition 2** For  $\lambda > 0$ , and any  $1/2 > \delta > 0$ , if

$$m \ge 5N_{\ell}(\lambda)\log(16N_{\ell}(\lambda)/\delta),$$

then there exist  $v_1, \ldots v_m \in \mathcal{T}_{\ell}, w_1, \ldots, w_m > 0$  such that

$$\sup_{\|f\|_{\mathcal{H}_{\ell}} \le R} \inf_{\beta \in \mathbb{R}^m : \|\beta\|_2^2 \le \frac{4R^2}{m}} \left\| f - \sum_{j=1}^m \beta_j \eta(w_j F_{\ell-1}(\cdot, v_j)) \right\|_{L_2(P(X))}^2 \le 4\lambda R^2,$$

and

$$\frac{1}{m}\sum_{j=1}^{m}w_j^2 \le (1-2\delta)^{-1}.$$

**Proof** Notice that  $E[\frac{1}{m}\sum_{j=1}^{m}q_{\ell}(v_{j})^{-1}] = E[q_{\ell}(v)^{-1}] = \int_{\mathcal{T}_{\ell}}q_{\ell}(v)^{-1}q_{\ell}(v)dQ_{\ell}(v) = \int_{\mathcal{T}_{\ell}}1dQ_{\ell}(v) = 1$ , thus an i.i.d. sequence  $\{v_{1},\ldots,v_{m}\}$  satisfies  $\frac{1}{m}\sum_{j=1}^{m}q_{\ell}(v_{j})^{-1} \leq 1/(1-2\delta)$  with probability  $2\delta$  by the Markov's inequality. Combining this with Proposition 1, the i.i.d. sequence  $\{v_{1},\ldots,v_{m}\}$  and  $w_{j} = q_{\ell}(v_{j})^{-1/2}$  satisfies the condition in the statement with probability  $1 - (\delta + 1 - 2\delta) = \delta > 0$ . This ensures the existence of sequences  $\{v_{j}\}_{j=1}^{m}$  and  $\{w_{j}\}_{j=1}^{m}$  that satisfy the assertion.

From now on, we define

$$c_0 = 4, c_1 = 4, c_{\delta} = (1 - 2\delta)^{-1}$$

The next theorem gives the proof of the approximation error bound in Theorem 1. The  $L_{\infty}$ -norm bound of  $f^{\circ}$  is given later in Lemma 3. Substituting  $\delta \leftarrow \delta/2$  into the statement in the following Lemma 2 and letting  $\hat{c}_{\delta} = c_1 c_{\delta/2}$ , we obtain Theorem 1.

Lemma 2 (Approximation error bound of the nonparametric model) For any  $1/2 > \delta > 0$ and given  $\lambda_{\ell} > 0$ , let  $m_{\ell} \ge 5N_{\ell}(\lambda_{\ell})\log(16N_{\ell}(\lambda_{\ell})/\delta)$ . Then there exist  $W^{(\ell)} \in \mathbb{R}^{m_{\ell+1} \times m_{\ell}}$  and  $b^{(\ell)} \in \mathbb{R}^{m_{\ell+1}}$  ( $\ell = 1, ..., L$ ) where  $m_{L+1} = 1$  and  $m_1 = d_x$  such that

$$\begin{split} \|W^{(\ell)}\|_{\mathbf{F}}^2 &\leq c_1 c_{\delta} R^2, \ \|b^{(\ell)}\|_2 \leq \sqrt{c_{\delta}} R_b \ (\ell = 1, \dots, L-1), \\ \|W^{(L)}\|_{\mathbf{F}}^2 &\leq c_1 R^2, \ \|b^{(L)}\|_2 \leq R_b, \end{split}$$

and

$$\|f^{o} - f^{*}\|_{L_{2}(P(X))} \leq \sum_{\ell=2}^{L} \sqrt{(c_{1}c_{\delta})^{L-\ell}c_{0}} R^{L-\ell+1} \sqrt{\lambda_{\ell}}.$$

#### Proof

We construct the asserted finite dimensional network recursively from  $\ell = L$  to  $\ell = 1$ . Let  $\{v_j^{(\ell)}\}_{j=1}^{m_\ell}$  and  $\{w_j^{(\ell)}\}_{j=1}^{m_\ell}$  be the sequences given in Proposition 2. Let  $\widehat{\mathcal{T}}_{\ell} = \{v_j^{(\ell)}\}_{j=1}^{m_\ell}$ . With slight abuse of notation, we identify  $f_{\ell}^* : \mathbb{R}^{m_\ell} \to \mathbb{R}^{m_{\ell+1}}$  to a function  $f_{\ell}^* : \widehat{\mathcal{T}}_{\ell} \to \widehat{\mathcal{T}}_{\ell+1}$  in a canonical way. For a function  $F : \mathbb{R}^{d_x} \times \widehat{\mathcal{T}}_{\ell} \to \mathbb{R}$ , we denote by  $f_{\ell}^*[F](x, v_i^{(\ell+1)})$  to express  $f_{\ell}^*[F(x, \cdot)](v_i^{(\ell+1)}) = \sum_{j=1}^{m_\ell} W_{i,j}^{(\ell)}F(x, v_j^{(\ell)}) + b_i^{(\ell)}$  for  $v_i^{(\ell+1)} \in \widehat{\mathcal{T}}_{\ell+1}$ . When we write  $f_{\ell}^*[F]$  for  $F : \mathbb{R}^{d_x} \times \mathcal{T}_{\ell} \to \mathbb{R}$   $((x, v) \mapsto F(x, v))$ , we deal with F as a restriction of F on  $\mathbb{R}^{d_x} \times \widehat{\mathcal{T}}_{\ell}$ . We define the output from the  $\ell$ -th layer of the approximated network  $f^*$  as  $F_{\ell}^*(x, v)$  for  $v \in \widehat{\mathcal{T}}_{\ell}$  and  $x \in \mathbb{R}^{d_x}$ . More precisely, it is recursively defined as  $F_{\ell}^*(x, v) = f_{\ell}^*[F_{\ell-1}](x, v)$ .

We use an analogous notation for other networks such as  $f_{\ell}^{o}$ . That is,  $F_{\ell}^{o}(x,v) = (f_{\ell}^{o} \circ \cdots \circ f_{1}^{o}(x))(v)$  for  $v \in \mathcal{T}_{\ell}$  and  $x \in \mathbb{R}^{d_{x}}$ , and  $F_{\ell}^{o}(x,v) = f_{\ell}^{o}[F_{\ell-1}^{o}](x,v)$ . Step 1 (the last layer,  $\ell = L$ ).

We consider the following approximation of the L-th layer (the last layer): Remember that  $m_{L+1} = 1$  and thus the output from the L-th layer is just one dimensional. We denote by  $\mathcal{T}_{L+1} = \{1\}$  which is the index set of the output (which is just a singleton consisting of an element 1). As a candidate of a good approximation to the true L-th layer, define

$$\tilde{f}_{L}^{*}[F_{L-1}](x,1) = \sum_{j=1}^{m_{L}} \sqrt{m_{L}} \beta_{j}^{(L)} \eta \left(\frac{1}{\sqrt{m_{L}}} w_{j}^{(L)} F_{L-1}(x, v_{j}^{(L)})\right) + b_{L}$$
(15)

by  $\beta^{(L)} \in \mathbb{R}^{m_L}$  and  $w^{(L)} \in \mathbb{R}^{m_L}$  satisfying  $\|\beta^{(L)}\|_2^2 \leq \frac{1}{m_L}c_1R^2$  and  $\|w^{(L)}\|_2^2 \leq m_Lc_\delta$ . Here, define that

$$W_{1,:}^{(L)} = \sqrt{m_L} \beta^{(L)^{\top}}, \ b^{(L)} = (b_L^{o}(1)).$$

Note that the model (15) can be rewritten as

$$\tilde{f}_L^*[F_{L-1}](x,1) = \sum_{j=1}^{m_L} W_{1,j}^{(L)} \eta(\sqrt{m_L}^{-1} w_j^{(L)} F_{L-1}(x, v_j^{(L)})) + b_1^{(L)}.$$

Because of Proposition 2 and Assumption 1, the norms of the weight  $W^{(L)}$  and the bias  $b^{(L)}$  are bounded as

$$\|W^{(L)}\|_F = \|W^{(L)}_{1,:}\|_2 \le \sqrt{c_1}R, \ \|b^{(L)}\|_2 = |b_L| \le R_b.$$
(16)

By the Cauchy-Schwartz inequality and the Lipschitz continuity of  $\eta$ , we have that

$$\begin{split} |f_{L}^{*}[F_{L-1}](x,1) - f_{L}^{*}[F_{L-1}'](x,1)| \\ &\leq |\sum_{j=1}^{m_{L}} W_{1,j}^{(L)}(\eta(\sqrt{m_{L}}^{-1}w_{j}^{(L)}F_{L-1}(x,v_{j}^{(L)})) - \eta(\sqrt{m_{L}}^{-1}w_{j}^{(L)}F_{L-1}'(x,v_{j}^{(L)})))| \\ &\leq ||W_{1,:}^{(L)}||_{2}\sqrt{m_{L}}^{-1}||(w_{j}^{(L)}(F_{L-1}(x,v_{j}^{(L)}) - F_{L-1}'(x,v_{j}^{(L)})))_{j=1}^{m_{L}}||_{2} \\ &\leq ||W_{1,:}^{(L)}||_{2}\sqrt{m_{L}}^{-1}||w^{(L)}||_{2}||(F_{L-1}(x,v_{j}^{(L)}) - F_{L-1}'(x,v_{j}^{(L)}))_{j=1}^{m_{L}}||_{\max} \\ &\leq \sqrt{c_{1}R^{2}}\sqrt{c_{\delta}m_{L}/m_{L}}||(F_{L-1}(x,v_{j}^{(L)}) - F_{L-1}'(x,v_{j}^{(L)}))_{j=1}^{m_{L}}||_{\max} \\ &= \sqrt{c_{1}c_{\delta}}R||(F_{L-1}(x,v_{j}^{(L)}) - F_{L-1}'(x,v_{j}^{(L)}))_{j=1}^{m_{L}}||_{\max}, \end{split}$$

for  $F_{L-1}, F'_{L-1} : \widehat{\mathcal{T}}_L \times \mathbb{R}^{d_x} \to \mathbb{R}$ . Moreover, Proposition 2 ensures that  $\beta^{(L)}$  and  $w^{(L)}$  can be taken so that

$$\|\tilde{f}_L^*[F_{L-1}^{\rm o}](\cdot,1) - f_L^{\rm o}[F_{L-1}^{\rm o}](\cdot,1)\|_{L_2(P(X))}^2 \le c_0 \lambda_L R^2.$$

Hereinafter, we fix  $\beta^{(L)}$  and  $w^{(L)}$  so that this inequality and the norm bound (16) are satisfied. **Step 2** (internal layers for  $\ell = 2, ..., L-1$ ). As for the  $\ell$ -th internal layer, we consider the following approximation:

$$\tilde{f}_{\ell}^{*}[g](v_{i}^{(\ell+1)}) = \sum_{j=1}^{m_{\ell}} \sqrt{m_{\ell}} \beta_{i,j}^{(\ell)} \eta(\sqrt{m_{\ell}}^{-1} w_{j}^{(\ell)} g(v_{j}^{(\ell)})) + b_{\ell}^{o}(v_{i}^{(\ell+1)}),$$

for  $g : \widehat{\mathcal{T}}_{\ell} \to \mathbb{R}$  with  $\beta^{(\ell)} \in \mathbb{R}^{m_{\ell+1} \times m_{\ell}}$  and  $w^{(\ell)} \in \mathbb{R}^{m_{\ell}}$  satisfying  $\|\beta_{j,:}^{(\ell)}\|_2^2 \leq \frac{1}{m_{\ell}}c_1R^2$  ( $\forall j = 1, \ldots, m_{\ell+1}$ ) and  $\|w^{(\ell)}\|_2^2 \leq m_{\ell}c_{\delta}$ . Then, the Lipschitz continuity of  $\widetilde{f}_{\ell}^*$  can be shown as

$$\begin{split} &|\tilde{f}_{\ell}^{*}[F_{\ell-1}](x, v_{i}^{(\ell+1)}) - \tilde{f}_{\ell}^{*}[F_{\ell-1}'](x, v_{i}^{(\ell+1)})| \\ &\leq \left| \sum_{j=1}^{m_{\ell}} \sqrt{m_{\ell}} \beta_{i,j}^{(\ell)}(\eta(\sqrt{m_{\ell}}^{-1} w_{j}^{(\ell)} F_{\ell-1}(x, v_{j}^{(\ell)})) - \eta(\sqrt{m_{\ell}}^{-1} w_{j}^{(\ell)} F_{\ell-1}'(x, v_{j}^{(L)}))) \right| \\ &\leq \|\beta_{i,:}^{(\ell)}\|_{2} \|w^{(\ell)}\|_{2} \|(F_{\ell-1}(x, v_{j}^{(\ell)}) - F_{\ell-1}'(x, v_{j}^{(\ell)}))_{j=1}^{m_{\ell}}\|_{\max} \\ &\leq \sqrt{\frac{c_{1}}{m_{\ell}}} R \sqrt{c_{\delta} m_{\ell}} \|(F_{\ell-1}(x, v_{j}^{(\ell)}) - F_{\ell-1}'(x, v_{j}^{(\ell)}))_{j=1}^{m_{\ell}}\|_{\max} \end{split}$$

$$= \sqrt{c_1 c_\delta} R \| (F_{\ell-1}(x, v_j^{(\ell)}) - F'_{\ell-1}(x, v_j^{(\ell)}))_{j=1}^{m_L} \|_{\max},$$

for any  $v_i^{(\ell+1)} \in \widehat{\mathcal{T}}_{(\ell+1)}$ . Proposition 2 asserts that there exit  $\beta^{(\ell)}$  and  $w^{(\ell)}$  that give an upper bound of the approximation error of the  $\ell$ -th layer as

$$\max_{j=1,\dots,m_{\ell}} \|\tilde{f}_{\ell}^{*}[F_{\ell-1}^{o}](\cdot,v_{j}^{\ell+1}) - f_{\ell}^{o}[F_{\ell-1}^{o}](\cdot,v_{j}^{\ell+1})\|_{L_{2}(P(X))}^{2} \le c_{0}\lambda_{\ell}R^{2}.$$

Finally, let

$$W_{ij}^{(\ell)} = \sqrt{\frac{m_{\ell}}{m_{\ell+1}}} \beta_{ij}^{(\ell)} w_i^{(\ell+1)}, \ b^{(\ell)} = \frac{1}{\sqrt{m_{\ell+1}}} (w_1^{(\ell+1)} b_\ell^{\rm o}(v_1^{(\ell+1)}), \dots, w_{m_{\ell+1}}^{(\ell+1)} b_\ell^{\rm o}(v_{m_{\ell+1}}^{(\ell+1)}))^\top,$$

then, by Assumption 1 and Proposition 2, the norms of these quantities can be bounded as

$$\begin{split} \|W^{(\ell)}\|_{\mathbf{F}}^2 &= \frac{m_{\ell}}{m_{\ell+1}} \sum_{i=1}^{m_{\ell+1}} \sum_{j=1}^{m_{\ell}} \beta_{ij}^{(\ell)^2} w_i^{(\ell+1)2} \\ &\leq \frac{m_{\ell}}{m_{\ell+1}} \sum_{i=1}^{m_{\ell+1}} w_i^{(\ell+1)2} \frac{c_1 R^2}{m_{\ell}} \leq c_1 c_{\delta} R^2, \end{split}$$

and

$$\|b^{(\ell)}\|_2^2 \le \frac{1}{m_{\ell+1}} \sum_{j=1}^{m_{\ell+1}} w^{(\ell+1)^2} R_b^2 \le c_\delta R_b^2.$$

**Step 3** (the first layer,  $\ell = 1$ ).

For the first layer, let

$$\tilde{f}^*(x, v_i^{(2)}) = \sum_{j=1}^{d_x} h_1^{\mathrm{o}}(v_i^{(2)}, j) Q_1(j) x_j + b_1^{\mathrm{o}}(v_i^{(2)})$$

for  $v_i^{(2)} \in \widehat{\mathcal{T}}_2$ . By the definition of  $f^{\mathrm{o}}$ , it holds that

$$\tilde{f}^*(x, v_i^{(2)}) = f^{\mathbf{o}}(x, v_i^{(2)}).$$

Let  $W^{(1)} = \frac{1}{\sqrt{m_2}} (Q_1(j) w_i^{(2)} h_1^o(v_i^{(2)}, j))_{i,j} \in \mathbb{R}^{m_2 \times d_x}$  and  $b^{(1)} = \frac{1}{\sqrt{m_2}} (w_1^{(2)} b_1^o(1), \dots, w_{m_2}^{(2)} b_1^o(m_2))^\top \in \mathbb{R}^{m_2}$ . Then, by Assumption 1 and Proposition 2, it holds that

$$\begin{split} \|W^{(1)}\|_{\rm F}^2 &= \sum_{i=1}^{m_2} \sum_{j=1}^{d_{\rm x}} \frac{1}{m_2} w_i^{(2)^2} h_1^{\rm o}(v_i^{(2)}, j)^2 Q_1(j)^2 \\ &\leq \left(\sum_{i=1}^{m_2} \frac{1}{m_2} w_i^{(2)^2}\right) \max_{1 \le i \le m_2} \left(\sum_{j=1}^{d_{\rm x}} h_1^{\rm o}(v_i^{(2)}, j)^2 Q_1(j)^2\right) \end{split}$$

$$\leq c_{\delta} \max_{1 \leq i \leq m_2} \left( \sum_{j=1}^{d_{\mathbf{x}}} h_1^{\mathbf{o}}(v_i^{(2)}, j)^2 Q_1(j) \right) \leq c_{\delta} R^2,$$

and

$$\|b^{(1)}\|_{2}^{2} \leq \frac{1}{m_{1}} \sum_{i=1}^{m_{2}} w_{i}^{(2)^{2}} R_{b}^{2} \leq c_{\delta} R_{b}^{2}.$$

### Step 4.

Finally, we combine the results we have obtained above. Note that

$$\begin{split} \|f_{L}^{0} \circ f_{L-1}^{0} \circ \cdots \circ f_{1}^{0} - \tilde{f}_{L}^{*} \circ \tilde{f}_{L-1}^{*} \circ \cdots \circ \tilde{f}_{1}^{*}\|_{L_{2}(P(X))} \\ = \|f_{L}^{0} \circ f_{L-1}^{0} \circ \cdots \circ f_{1}^{0} - \tilde{f}_{L}^{*} \circ f_{L-1}^{0} \circ \cdots \circ f_{1}^{0} \\ & \vdots \\ + \tilde{f}_{L}^{*} \circ \cdots \circ \tilde{f}_{\ell+1}^{*} \circ f_{\ell}^{0} \circ f_{\ell-1}^{0} \circ \cdots \circ f_{1}^{0} - \tilde{f}_{L}^{*} \circ \cdots \circ \tilde{f}_{\ell+1}^{*} \circ \tilde{f}_{\ell}^{*} \circ f_{\ell-1}^{0} \circ \cdots \circ f_{1}^{0} \\ & \vdots \\ + \tilde{f}_{L}^{*} \circ \cdots \tilde{f}_{2}^{*} \circ f_{1}^{0} - \tilde{f}_{L}^{*} \circ \cdots \tilde{f}_{2}^{*} \circ \tilde{f}_{1}^{*}\|_{L_{2}(P(X))} \\ \leq \sum_{\ell=1}^{L} \|\tilde{f}_{L}^{*} \circ \cdots \circ \tilde{f}_{\ell+1}^{*} \circ f_{\ell}^{0} \circ f_{\ell-1}^{0} \circ \cdots \circ f_{1}^{0} - \tilde{f}_{L}^{*} \circ \cdots \circ \tilde{f}_{\ell+1}^{*} \circ \tilde{f}_{\ell}^{*} \circ f_{\ell-1}^{0} \circ \cdots \circ f_{1}^{0}\|_{L_{2}(P(X))}. \end{split}$$

Then combining the argument given above, we have

$$\begin{aligned} &\|\tilde{f}_L^* \circ \dots \circ \tilde{f}_{\ell+1}^* \circ f_\ell^{\mathrm{o}} \circ f_{\ell-1}^{\mathrm{o}} \circ \dots \circ f_1^{\mathrm{o}} - \tilde{f}_L^* \circ \dots \circ \tilde{f}_{\ell+1}^* \circ \tilde{f}_\ell^* \circ f_{\ell-1}^{\mathrm{o}} \circ \dots \circ f_1^{\mathrm{o}}\|_{L_2(P(X))} \\ \leq &(\sqrt{c_1 c_\delta} R)^{L-\ell} (\sqrt{c_0 \lambda_\ell} R) = \sqrt{(c_1 c_\delta)^{L-\ell} c_0} R^{L-\ell+1} \sqrt{\lambda_\ell}, \end{aligned}$$

for  $\ell = 2, \ldots, L$ . And the right hand side is 0 for  $\ell = 1$ . This yields that

$$\|f^{o} - \tilde{f}^{*}\|_{L_{2}(P(X))} \leq \sum_{\ell=2}^{L} R^{L-\ell+1} \sqrt{(c_{1}c_{\delta})^{L-\ell}c_{0}} \sqrt{\lambda_{\ell}}.$$

By substituting  $W^{(\ell)}$  and  $b^{(\ell)}$  for  $\ell = 1, ..., L$  defined above into the definition of  $f^*$ , then it is easy to see that

$$f^* = \tilde{f}^*$$

as a function. Then, we obtain the assertion.

# A.2 Bounding the $L_{\infty}$ -norm

The next lemma shows the  $L_{\infty}$ -norm of the true function  $f^{\circ}$  and that of  $f \in \mathcal{F}$ . This gives the  $L_{\infty}$ -norm bound of every  $f \in \mathcal{F}$  in Lemma 1 and thus that of  $f^*$  in Theorem 1 because  $f^* \in \mathcal{F}$ .

**Lemma 3** Under Assumptions 1, 2 and 3, the  $L_{\infty}$ -norms of  $f^{\circ}$  and that of  $f \in \mathcal{F}$  are bounded as

$$\|f^{o}\|_{\infty} \leq R^{L}D_{x} + \sum_{\ell=1}^{L} R^{L-\ell}R_{b},$$
  
$$\|f\|_{\infty} \leq (\sqrt{c_{1}c_{\delta}})^{L}R^{L}D_{x} + \sum_{\ell=1}^{L} (\sqrt{c_{1}c_{\delta}}R)^{L-\ell}\bar{R}_{b}.$$

Proof

Suppose that

$$||F_{\ell-1}^{o}(x,\cdot)||_{L_2(Q_{\ell})} \le G.$$

Then,  $F^{\mathrm{o}}_\ell$  can be bounded inductively: for all  $\tau \in \mathcal{T}_{\ell+1}$ 

$$|F_{\ell}^{o}(x,\tau)| = \left| \int_{\mathcal{T}_{\ell}} h_{\ell}^{o}(\tau,w) \eta(F_{\ell-1}^{o}(x,w)) dQ_{\ell}(w) + b_{\ell}^{o}(\tau) \right|$$
  
$$\leq \|h_{\ell}^{o}(\tau,\cdot)\|_{L_{2}(Q_{\ell})} \|F_{\ell-1}^{o}(x,\cdot)\|_{L_{2}(Q_{\ell})} + |b_{\ell}^{o}(\tau)|$$
  
$$\leq RG + R_{b},$$

by Assumption 1. Similarly, as for  $\ell = 1$ , it holds that, for all  $\tau \in \mathcal{T}_2$  and  $x \in \mathbb{R}^{d_x}$ ,

$$|f_1^{o}(x,\tau)| = |\sum_{i=1}^{d_x} h_1^{o}(\tau,i) x_i Q_1(i) + b_1^{o}(\tau)|$$
  
$$\leq |\sum_{i=1}^{d_x} h_1^{o}(\tau,i) x_i Q_1(i)| + |b_1^{o}(\tau)|$$
  
$$\leq ||h_1^{o}(\tau,\cdot)||_{L_2(Q_1)} ||x||_{L_2(Q_1)} + R_b$$
  
$$\leq RD_x + R_b.$$

Applying the same argument recursively, we have

$$||f^{\mathrm{o}}||_{\infty} \leq R^{L} D_{x} + \sum_{\ell=1}^{L} R^{L-\ell} R_{b}.$$

We can bound the  $L_{\infty}$ -norm of any  $f \in \mathcal{F}$  through a similar argument. Note that  $W^{(\ell)}$  satisfies  $\|W^{(\ell)}\|_{\mathrm{F}} \leq \sqrt{c_1 c_\delta} R$  for  $\ell = 1, \ldots, L - 1$ ,  $W^{(L)}$  satisfies  $\|W^{(L)}\|_{\mathrm{F}} \leq \sqrt{c_1} R$ , and  $b^{(\ell)}$  satisfies  $\|b^{(\ell)}\|_2 \leq \sqrt{c_\delta} R_b$  by its construction. Therefore, though a similar argument to the bound for  $f^{\mathrm{o}}$ , we have that

$$\begin{split} \|f\|_{\infty} &\leq \sqrt{c_1} R \left[ \prod_{\ell=2}^{L-1} \left( \sqrt{c_1 c_{\delta}} R \right) \right] \sqrt{c_{\delta}} R D_x \\ &+ \left( \sum_{\ell=1}^{L-2} \sqrt{c_1} R \left[ \prod_{\ell'=\ell+1}^{L-1} \left( \sqrt{c_1 c_{\delta}} R \right) \right] \sqrt{c_{\delta}} R_b + \sqrt{c_1} R \sqrt{c_{\delta}} R_b + \sqrt{c_{\delta}} R_b \right) \end{split}$$

$$\leq (c_1 c_\delta)^{L/2} R^L D_x + \sum_{\ell=1}^L (\sqrt{c_1 c_\delta} R)^{L-\ell} \bar{R}_b.$$

### Appendix B. Bounding the posterior contraction rate

In this section, we prove Theorem 3. The proof is divided into two parts: posterior contraction rate with respect to the in-sample error (i.e., the empirical  $L_2$ -norm  $||f||_n = \sqrt{\sum_{i=1}^n f(x_i)^2/n}$ ) and that with respect to the out-of-sample error (i.e., the population  $L_2$ -norm  $||f||_{L_2(P(X))} =$ 

$$\sqrt{\int f(X)^2 \mathrm{d}P(X)}$$
  
Here, let

$$\epsilon_n = \hat{\delta}_{1,n} + \sigma \hat{\delta}_{2,n}, \quad \tilde{\epsilon}_n = \hat{\delta}_{1,n} + \hat{\delta}_{2,n}.$$

### **B.1 In-sample error**

Here we show the in-sample error bound. Let  $X_n = (x_1, \ldots, x_n)$ ,  $Y_n = (y_1, \ldots, y_n)$  and  $D_n = (X_n, Y_n)$ . For given  $X_n$ , the probability distribution of  $Y_n$  associated with a function f (i.e.,  $y_i = f(x_i) + \epsilon_i$ ) is denoted by  $P_{n,f}$ . The expectation of a function h of  $Y_n$  with respect to  $P_{n,f}$  is denoted by  $P_{n,f}$ .

For  $\tilde{r} \geq 1$ , let  $\mathcal{A}_{\tilde{r}}$  be the event such that

$$\int \frac{p_{n,f}(Y_n)}{p_{n,f^{\mathrm{o}}}(Y_n)} \Pi(\mathrm{d}f) \ge \exp(-n\tilde{\epsilon}_n^2 \tilde{r}^2/\sigma^2) \Pi(f: \|f - f^*\|_{\infty} \le \hat{\delta}_{2,n} \tilde{r}).$$

The probability of this event is bounded by Lemma 4.

Using a test function  $\phi_n$  defined later (here, a test function is a measurable function of  $D_n$  that takes its value in [0, 1]), we decompose the expected posterior mass as

for  $\epsilon_n > 0$  where the expectation is taken with respect to  $D_n = (X_n, Y_n)$  distributed from the true distribution. We give an upper bound of  $A_n$ ,  $B_n$ ,  $C_n$  and  $D_n$  in the following.

#### Step 1.

For arbitrary r' > 0, define  $C_{r'} = \{f \in \mathcal{F} \mid r' \leq \sqrt{n} \| f - f^{\circ} \|_n / \sigma \}$ . We construct a maximum cardinality set  $\Theta_{r'} \subset C_{r'}$  such that each  $f, f' \in \Theta_{r'}$  satisfies  $\sqrt{n} \| f - f' \|_n / \sigma \geq r' / 2$ . Here we denote by  $D(\epsilon, \mathcal{F}, \|\cdot\|)$  the  $\epsilon$ -packing number of a normed space  $\mathcal{F}$  attached with a norm  $\|\cdot\|$ .

Then, the cardinality of  $\Theta_{r'}$  is equal to  $D(r'/2, C_{r'}, \sqrt{n} \| \cdot \|_n / \sigma)$ . Then, following Lemma 13 of van der Vaart and van Zanten (2011), one can construct a test  $\phi_{r'}$  such that

$$P_{n,f^{o}}\tilde{\phi}_{r'} \leq 9D(r'/2, C_{r'}, \sqrt{n} \|\cdot\|_{n}/\sigma) e^{-\frac{1}{8}{r'}^{2}} \leq 9D(r'/2, \mathcal{F}, \sqrt{n} \|\cdot\|_{n}/\sigma) e^{-\frac{1}{8}{r'}^{2}},$$
  
$$\sup_{f \in C_{r'}} P_{n,f}(1 - \tilde{\phi}_{r'}) \leq e^{-\frac{1}{8}{r'}^{2}},$$

for any r' > 0.

Substituting  $\sqrt{2}\sqrt{n}\epsilon_n r/\sigma$  into r' and denoting  $\phi_n = \tilde{\phi}_{\sqrt{2}\sqrt{n}\epsilon_n r/\sigma}$ , we obtain

$$P_{n,f^{o}}\phi_{n} \leq 9e^{-\frac{1}{4\sigma^{2}}n\epsilon_{n}^{2}r^{2} + \log(D(r'/2,\mathcal{F},\sqrt{n}\|\cdot\|_{n}/\sigma))}$$
(18)

$$\sup_{f \in C_{2\sqrt{2}\sqrt{n}\epsilon_n r}} P_{n,f}(1-\phi_n) \le e^{-\frac{1}{4\sigma^2}n\epsilon_n^2 r^2}.$$
(19)

Hence, we just need to evaluate the (log-)packing number  $\log(D(r'/2, \mathcal{F}, \sqrt{n} \| \cdot \|_n / \sigma))$  where  $r' = \sqrt{2n}\epsilon_n r / \sigma$ . It is known that the packing number is bounded from above by the internal covering number<sup>4</sup>, and the packing number of unit ball in *d*-dimensional Euclidean space and that of the covering number is bounded as

$$D(\epsilon, \mathcal{B}_d(1), \|\cdot\|) \le N(\epsilon, \mathcal{B}_d(1), \|\cdot\|) \le \left(\frac{4+\epsilon}{\epsilon}\right)^d$$

Based on this we evaluate the packing number of  $\mathcal{F}$ .

Let  $f, f' \in \mathcal{F}$  be two functions corresponding to parameters  $(W^{(\ell)}, b^{(\ell)})_{\ell=1}^L$  and  $(W'^{(\ell)}, b'^{(\ell)})_{\ell=1}^L$ . Notice that if  $||W^{(\ell)} - W'^{(\ell)}||_{\mathrm{F}} \leq \epsilon$  and  $||b^{(\ell)} - b'^{(\ell)}|| \leq \epsilon$ , then

$$\|f - f'\|_{\infty} \le L\epsilon \bar{R}^{L-1} D_x + \sum_{\ell=1}^{L} \epsilon \bar{R}^{L-\ell} = \epsilon (L\bar{R}^{L-1} D_x + \sum_{\ell=1}^{L} \bar{R}^{L-\ell}).$$
(20)

Therefore, if  $\epsilon \leq \delta/\hat{G}$  where

$$\hat{G} = (L\bar{R}^{L-1}D_x + \sum_{\ell=1}^{L}\bar{R}^{L-\ell}),$$

then  $||f - f'||_{\infty} \leq \delta$ . Hence, the packing number of the function space  $\mathcal{F}$  can be bounded by using that of the parameter space as

$$\log(D(r'/2,\mathcal{F},\sqrt{n}\|\cdot\|_n/\sigma)) = \log(D(r'/2,\mathcal{F},\sqrt{n}\|\cdot\|_n/\sigma)) \le \log(D(\sigma r'/(2\sqrt{n}),\mathcal{F},\|\cdot\|_\infty))$$
  
$$\le \log(N(\sigma r'/(2\sqrt{n}),\mathcal{F},\|\cdot\|_\infty))$$
  
$$\le \sum_{\ell=1}^L \log(N(\sigma r'/(2\sqrt{n}\hat{G}),\mathcal{B}_{m_{\ell+1}\times m_{\ell}}(\bar{R}),\|\cdot\|)) + \sum_{\ell=1}^L \log(N(\sigma r'/(2\sqrt{n}\hat{G}),\mathcal{B}_{m_{\ell}}(\bar{R}_b),\|\cdot\|))$$

<sup>4.</sup> The  $\epsilon$ -internal covering number of a (semi)-metric space (T, d) is the minimum cardinality of a finite set such that every element in T is in distance  $\epsilon$  from the finite set with respect to the metric d. We denote by  $N(\epsilon, T, d)$  the  $\epsilon$ -internal covering number of (T, d).

$$\leq \sum_{\ell=1}^{L} m_{\ell+1} m_{\ell} \log \left( \frac{4 + \frac{\sigma r'}{2\sqrt{n}\hat{G}\bar{R}}}{\frac{\sigma r'}{2\sqrt{n}\hat{G}\bar{R}}} \right) + \sum_{\ell=1}^{L} m_{\ell} \log \left( \frac{4 + \frac{\sigma r'}{2\sqrt{n}\hat{G}\bar{R}_b}}{\frac{\sigma r'}{2\sqrt{n}\hat{G}\bar{R}_b}} \right)$$
$$= \sum_{\ell=1}^{L} m_{\ell+1} m_{\ell} \log \left( 1 + \frac{4\sqrt{2}\hat{G}\bar{R}}{\epsilon_n r} \right) + \sum_{\ell=1}^{L} m_{\ell} \log \left( 1 + \frac{4\sqrt{2}\hat{G}\bar{R}_b}{\epsilon_n r} \right). \tag{21}$$

Therefore, by Eq. (18), we have that

$$A_n \le 9 \exp\left[-\frac{1}{4\sigma^2}n\epsilon_n^2 r^2 + \sum_{\ell=1}^L m_{\ell+1}m_\ell \log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}}{\epsilon_n r}\right) + \sum_{\ell=1}^L m_\ell \log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}_b}{\epsilon_n r}\right)\right].$$

**Step 2.** Here, we evaluate  $B_n$ . It can be evaluated by Lemma 4 as

$$B_n \le \exp(-n\tilde{\epsilon}_n^2 \tilde{r}^2 / (8\sigma^2)) + \exp(-n\hat{\delta}_{1,n}^2 (\tilde{r}^2 - 1)^2 / (11\hat{R}_{\infty}^2)).$$

**Step 3.** Since  $\mathcal{F}$  is the support of the prior distribution, it is obvious that  $C_n = 0$ .

**Step 4.** Here, we evaluate  $D_n$ . Remind that  $D_n$  is defined as

$$D_n = \mathbb{E}_{X_n} \left[ P_{n, f^{\mathrm{o}}} [\Pi(f \in \mathcal{F} : \|f - f^{\mathrm{o}}\|_n > \sqrt{2} \epsilon r | Y_n) (1 - \phi_n) \mathbf{1}_{\mathcal{A}_{\tilde{r}}} ] \right]$$

Define

$$\Xi_n(\tilde{r}) := -\log(\Pi(f: \|f - f^*\|_\infty \le \hat{\delta}_{2,n}\tilde{r}))$$

for  $\tilde{r} > 0$ . Then,  $D_n$  can be bounded as

$$\begin{split} D_n &= \mathcal{E}_{X_n} \left\{ P_{n,f^{\mathrm{o}}} \left[ \frac{\int_{\mathcal{F}} \mathbf{1}\{f : \|f - f^{\mathrm{o}}\|_n > \sqrt{2}\epsilon r\} p_{n,f} \mathrm{d}\Pi(f)}{\int_{\mathcal{F}} p_{n,f} \mathrm{d}\Pi(f)} (1 - \phi_n) \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \right] \right\} \\ &= \mathcal{E}_{X_n} \left\{ P_{n,f^{\mathrm{o}}} \left[ \frac{\int_{\mathcal{F}} \mathbf{1}\{f : \|f - f^{\mathrm{o}}\|_n > \sqrt{2}\epsilon r\} \frac{p_{n,f}}{p_{n,f^{\mathrm{o}}}} \mathrm{d}\Pi(f)}{\int_{\mathcal{F}} \frac{p_{n,f}}{p_{n,f^{\mathrm{o}}}} \mathrm{d}\Pi(f)} (1 - \phi_n) \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \right] \right\} \\ &\leq \mathcal{E}_{X_n} \left\{ P_{n,f^{\mathrm{o}}} \left[ \int_{f \in \mathcal{F} : \|f - f^{\mathrm{o}}\|_n > \sqrt{2}\epsilon r} p_{n,f} / p_{n,f^{\mathrm{o}}} \mathrm{d}\Pi(f) \exp(n\tilde{\epsilon}_n^2 \tilde{r}^2 / \sigma^2 + \Xi_n(\tilde{r})) (1 - \phi_n) \mathbf{1}_{\mathcal{A}_{\tilde{r}}}} \right] \right\} \\ &= \mathcal{E}_{X_n} \left\{ \int_{f \in \mathcal{F} : \|f - f^{\mathrm{o}}\|_n > \sqrt{2}\epsilon r} p_{n,f} / p_{n,f^{\mathrm{o}}} \mathrm{d}\Pi(f) \exp(n\tilde{\epsilon}_n^2 \tilde{r}^2 / \sigma^2 + \Xi_n(\tilde{r})) \mathrm{d}\Pi(f) \right\} \\ &\leq \exp\left( \frac{n\tilde{\epsilon}_n^2 \tilde{r}^2}{\sigma^2} + \Xi_n(\tilde{r}) - \frac{n\epsilon_n^2 r^2}{4\sigma^2} \right). \end{split}$$

By using the relation (20), the prior mass  $\Xi_n(\tilde{r})$  can be bounded as

$$\Xi_n(\tilde{r}) = -\log(\Pi(f: \|f - f^*\|_\infty \le \hat{\delta}_{2,n}\tilde{r}))$$

$$\leq -\log(\Pi(f: ||f - f^*||_{\infty} \leq \hat{\delta}_{2,n}))$$

$$\leq -\sum_{\ell=1}^{L} \log(\Pi(W^{(\ell)}: ||W^{(\ell)} - W^{*(\ell)}||_{\mathrm{F}} \leq \hat{\delta}_{2,n}/\hat{G}))$$

$$-\sum_{\ell=1}^{L} \log(\Pi(b^{(\ell)}: ||b^{(\ell)} - b^{*(\ell)}||_{2} \leq \hat{\delta}_{2,n}/\hat{G}))$$

$$\leq \sum_{\ell=1}^{L} m_{\ell} m_{\ell+1} \log(\bar{R}\hat{G}/(\hat{\delta}_{2,n}/2)) + \sum_{\ell=1}^{L} m_{\ell} \log(\bar{R}_{b}\hat{G}/(\hat{\delta}_{2,n}/2)).$$
(22)

Step 5. Finally, we combine the results obtained above.

$$E\left[\Pi(\|f - f^{o}\|_{n} \ge \sqrt{2}\epsilon_{n}r|Y_{n})\right] \\
 \le 9 \exp\left[-\frac{1}{4\sigma^{2}}n\epsilon_{n}^{2}r^{2} + \sum_{\ell=1}^{L}m_{\ell+1}m_{\ell}\log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}}{\epsilon_{n}r}\right) + \sum_{\ell=1}^{L}m_{\ell}\log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}_{b}}{\epsilon_{n}r}\right)\right] \\
 + \exp(-n\tilde{\epsilon}_{n}^{2}\tilde{r}^{2}/(8\sigma^{2})) + \exp(-n\hat{\delta}_{1,n}^{2}(\tilde{r}^{2} - 1)^{2}/(11\hat{R}_{\infty}^{2})) \\
 + \exp\left(\frac{n}{\sigma^{2}}\tilde{\epsilon}_{n}^{2}\tilde{r}^{2} + \Xi_{n}(\tilde{r}) - \frac{n\epsilon_{n}^{2}r^{2}}{4\sigma^{2}}\right).$$
(23)

Now, let  $1 \leq \tilde{r} \leq r$ . Then, since  $\epsilon_n \geq \hat{\delta}_{2,n}$  and  $r \geq 1$ , we have that

$$\max\left\{\log\left(\frac{2\hat{G}R'}{\hat{\delta}_{2,n}}\right), \log\left(1 + \frac{4\sqrt{2}\hat{G}R'}{\epsilon_n r}\right)\right\} \le \log\left(1 + \frac{4\sqrt{2}\hat{G}R'}{\hat{\delta}_{2,n}}\right),$$

for all R'>0. Now, we set  $\hat{\delta}_{2,n}$  to satisfy

$$\frac{n\hat{\delta}_{2,n}^2}{\sigma^2} \ge \sum_{\ell=1}^L m_\ell m_{\ell+1} \log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}}{\hat{\delta}_{2,n}}\right) + \sum_{\ell=1}^L m_\ell \log\left(1 + \frac{4\sqrt{2}\hat{G}\bar{R}_b}{\hat{\delta}_{2,n}}\right) (\ge \Xi_n(\tilde{r})), \quad (24)$$

which can be satisfied by

$$\hat{\delta}_{2,n}^2 = \frac{2\sigma^2}{n} \sum_{\ell=1}^L m_\ell m_{\ell+1} \log_+ \left( 1 + \frac{4\sqrt{2}\hat{G}\max\{\bar{R},\bar{R}_b\}\sqrt{n}}{\sigma\sqrt{\sum_{\ell=1}^L m_\ell m_{\ell+1}}} \right).$$

Then, by noticing  $n\hat{\delta}_{2,n}^2 \leq n\tilde{\epsilon}_n^2$  and Eq. (22), the RHS of Eq. (23) is upper bounded by

$$\exp(-n\tilde{\epsilon}_n^2\tilde{r}^2/(8\sigma^2)) + \exp(-n\tilde{\delta}_{1,n}^2(\tilde{r}^2-1)^2/(11\hat{R}_{\infty}^2)) + 10\exp\left[2\frac{n}{\sigma^2}\tilde{\epsilon}_n^2\tilde{r}^2 - \frac{n\epsilon_n^2r^2}{4\sigma^2}\right].$$

Here, by setting  $r^2 = 12\tilde{r}^2 \ge 12$ , then the RHS is further bounded as

$$\begin{split} &\exp(-n\hat{\delta}_{1,n}^2(\tilde{r}^2-1)^2/(11\hat{R}_{\infty}^2)) + \exp(-n\tilde{\epsilon}_n^2\tilde{r}^2/(8\sigma^2)) + 10\exp(-n\epsilon_n^2\tilde{r}^2/\sigma^2) \\ &\leq \exp\left[-n\hat{\delta}_{1,n}^2(\tilde{r}^2-1)^2/(11\hat{R}_{\infty}^2)\right] + 11\exp(-n\epsilon_n^2\tilde{r}^2/(8\sigma^2)). \end{split}$$

**Lemma 4** *Then, for any*  $\tilde{r} > 1$ *, it holds that* 

$$P_{D_n}\left(\int \frac{p_{n,f}(Y_n)}{p_{n,f^{\mathrm{o}}}(Y_n)} \Pi(\mathrm{d}f) \ge \exp(-n\tilde{\epsilon}_n^2 \tilde{r}^2 / \sigma^2) \Pi(f: \|f - f^*\|_{\infty} \le \hat{\delta}_{2,n} \tilde{r})\right)$$
  
$$\ge 1 - \exp(-n\tilde{\epsilon}_n^2 \tilde{r}^2 / (8\sigma^2)) - \exp(-n\tilde{\delta}_{1,n}^2 (\tilde{r}^2 - 1)^2 / (11\hat{R}_{\infty}^2)).$$

### Proof

Note that Lemma 14 of van der Vaart and van Zanten (2011) showed that

$$P_{Y_n|X_n}\left(\int \frac{p_{n,f}(Y_n)}{p_{n,f^{\mathrm{o}}}(Y_n)}\Pi(\mathrm{d}f) \ge \exp(-n\tilde{\epsilon}_n^2\tilde{r}^2/\sigma^2)\Pi(f:\|f-f^{\mathrm{o}}\|_n \le \tilde{\epsilon}_n\tilde{r})\right) \ge 1-\exp(-n\tilde{\epsilon}_n^2\tilde{r}^2/(8\sigma^2)).$$

where  $P_{Y_n|X_n}$  represents the conditional distribution of  $Y_n = (y_i)_{i=1}^n$  conditioned by  $X_n = (x_i)_{i=1}^n$ . Therefore the proof is reduced to show  $||f - f^o||_n \le \hat{\delta}_{1,n}\tilde{r} + ||f - f^*||_{\infty}$  with high probability. Note that

$$||f - f^{\circ}||_{n} \le ||f - f^{*}||_{n} + ||f^{*} - f^{\circ}||_{n} \le ||f - f^{*}||_{\infty} + ||f^{*} - f^{\circ}||_{n}$$

Hence, we just need to show  $||f^* - f^o||_n \le \tilde{r}||f^* - f^o||_{L_2(P(X))} \le \tilde{r}\hat{\delta}_{1,n}$  with high probability. This can be shown by Bernstein's inequality:

$$P\left(\sqrt{1+\tilde{r}'}\|f^* - f^{\rm o}\|_{L_2(P(X))} \le \|f^* - f^{\rm o}\|_n\right) \le \exp\left(-\frac{n\tilde{r}'^2\|f^* - f^{\rm o}\|_{L_2(P(X))}^4}{2(v+\|f^* - f^{\rm o}\|_{\infty}^2\|f^* - f^{\rm o}\|_{L_2(P(X))}^2/3)}\right)$$

where  $v = \mathcal{E}_X[((f^*(X) - f^{o}(X))^2 - \|f^* - f^{o}\|_{L_2(P(X))}^2)]$ . Now  $v \le \mathcal{E}_X[(f^*(X) - f^{o}(X))^4] \le \|f^* - f^{o}\|_{\infty}^2 \|f^* - f^{o}\|_{L_2(P(X))}^2 = \|f^* - f^{o}\|_{\infty}^2 \|f^* - f^{o}\|_{L_2(P(X))}^2$ . This yields that

$$P\left(\sqrt{1+\tilde{r}'}\|f^* - f^{\mathrm{o}}\|_{L_2(P(X))} \le \|f^* - f^{\mathrm{o}}\|_n\right) \le \exp\left[-\frac{3n\tilde{r}'^2}{8}\left(\frac{\|f^* - f^{\mathrm{o}}\|_{L_2(P(X))}}{\|f^* - f^{\mathrm{o}}\|_{\infty}}\right)^2\right].$$
(25)

Since  $||f^* - f^{\mathrm{o}}||_{\infty} \leq 2\hat{R}_{\infty}$  and  $||f^* - f^{\mathrm{o}}||_{L_2(P(X))} \leq \hat{\delta}_{1,n}$ , the RHS is further bounded by  $\exp\left(-\frac{3n\tilde{r}'^2\hat{\delta}_{1,n}^2}{32\hat{R}_{\infty}^2}\right)$ .

Therefore, with probability  $1 - \exp\left(-\frac{3n\hat{\delta}_{1,n}^2 \hat{r}^{\prime 2}}{32\hat{R}_{\infty}^2}\right)$ , it holds that

$$\|f - f^{\mathsf{o}}\|_{n} \le \|f - f^{*}\|_{\infty} + \sqrt{1 + \tilde{r}'} \|f^{*} - f^{\mathsf{o}}\|_{L_{2}(P(X))} \le \|f - f^{*}\|_{\infty} + \sqrt{1 + \tilde{r}'} \hat{\delta}_{1,n}$$

for all f such that  $||f||_{\infty} < \infty$ . Thus by setting  $\tilde{r}'$  so that  $\tilde{r} = \sqrt{1 + \tilde{r}'}$ , we obtain the assertion.

### **B.2** Out of sample error

Now, we are going to show the posterior contraction rate with respect to the out-of-sample predictive error:

$$E_{D_n} \left[ \Pi(f : \|f - f^{o}\|_{L_2(P(X))} \ge \epsilon_n r | D_n) \right],$$
(26)

for sufficiently large  $r \ge 1$ .

To bound the posterior tail, we divide that into four parts:

$$\begin{split} \mathbf{I} &= \mathbf{E}_{D_{n}} \left[ \mathbf{1}_{\mathcal{A}_{\tilde{r}}^{c}} \right], \\ \mathbf{II} &= \mathbf{E}_{D_{n}} \left[ \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \Pi(f : \sqrt{2} \| f - f^{o} \|_{n} > \epsilon_{n} r, \ \| f \|_{\infty} \le \hat{R}_{\infty} \mid D_{n}) \right], \\ \mathbf{III} &= \mathbf{E}_{D_{n}} \left[ \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \Pi(f : \| f - f^{o} \|_{L_{2}(P(X))} > \epsilon_{n} r \ge \sqrt{2} \| f - f^{o} \|_{n}, \ \| f \|_{\infty} \le \hat{R}_{\infty} \mid D_{n}) \right], \\ \mathbf{IV} &= \mathbf{E}_{D_{n}} \left[ \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \Pi(f : \| f \|_{\infty} > \hat{R}_{\infty} \mid D_{n}) \right]. \end{split}$$

The term I and II are already evaluated in Section B.1, that is, I + II is bounded by the right hand side of Eq. (17) which is what we have upper bounded in Section B.1.

The term III is bounded as follows. To bound this, we need to evaluate the difference between the empirical norm  $||f - f^{\circ}||_n$  and the expected norm  $||f - f^{\circ}||_{L_2(P(X))}$ , which can be done by Bernstein's inequality. Following the same argument to derive Eq. (25), it holds that

$$P\left(\|f - f^{\mathrm{o}}\|_{L_{2}(P(X))} \ge \sqrt{2}\|f - f^{\mathrm{o}}\|_{n}\right) \le \exp\left(-\frac{n\|f - f^{\mathrm{o}}\|_{L_{2}(P(X))}^{2}}{11\hat{R}_{\infty}^{2}}\right).$$

Therefore, we arrive at the following bound of III:

$$\begin{aligned} \operatorname{III} &\leq \operatorname{E}_{X_n} \left[ P_{n,f^{\mathrm{o}}} \left[ \int_{f \in \mathcal{F}: \|f - f^{\mathrm{o}}\|_{L_2(P(X))} > \epsilon_n r \geq \sqrt{2} \|f - f^{\mathrm{o}}\|_n} p_{n,f} / p_{n,f^{\mathrm{o}}} \mathrm{d}\Pi(f) \right] \exp(n \tilde{\epsilon}_n^2 \tilde{r}^2 / \sigma^2 + \Xi_n(\tilde{r})) \mathbf{1}_{\mathcal{A}_{\tilde{r}}} \right] \\ &\leq \exp(n \tilde{\epsilon}_n^2 \tilde{r}^2 / \sigma^2 + \Xi_n(\tilde{r})) \int_{f \in \mathcal{F}: \|f - f^{\mathrm{o}}\|_{L_2(P(X))} > \epsilon_n r} P(\|f - f^{\mathrm{o}}\|_{L_2(P(X))} \geq \sqrt{2} \|f - f^{\mathrm{o}}\|_n) \mathrm{d}\Pi(f) \\ &\leq \exp\left(\frac{n \tilde{\epsilon}_n^2 \tilde{r}^2}{\sigma^2} + \Xi_n(\tilde{r}) - \frac{n \epsilon_n^2 r^2}{11 \hat{R}_\infty^2}\right) \\ &\leq \exp\left(\frac{2n \tilde{\epsilon}_n^2 \tilde{r}^2}{\sigma^2} - \frac{n \epsilon_n^2 r^2}{11 \hat{R}_\infty^2}\right). \end{aligned}$$

Finally, since all  $f \in \mathcal{F}$  satisfies  $||f||_{\infty} \leq \hat{R}_{\infty}$ , IV = 0. Combining the results we arrive at

### Appendix C. Convergence rate for the empirical risk minimizer

**Proposition 3 (Gaussian concentration inequality (Theorem 2.5.8 in Giné and Nickl (2015)))** Let  $(\xi_i)_{i=1}^n$  be i.i.d. Gaussian sequence with mean 0 and variance  $\sigma^2$ , and  $(x_i)_{i=1}^n \subset \mathcal{X}$  be a given set of input variables. Then, for a set  $\tilde{\mathcal{F}}$  of functions from  $\mathcal{X}$  to  $\mathbb{R}$  which is separable with respect to  $L_{\infty}$ -norm and  $\sup_{f \in \tilde{\mathcal{F}}} \left| \sum_{i=1}^n \frac{1}{n} \xi_i f(x_i) \right| < \infty$  almost surely, it holds that for every r > 0,

$$P\left(\sup_{f\in\tilde{\mathcal{F}}}\left|\sum_{i=1}^{n}\frac{1}{n}\xi_{i}f(x_{i})\right|\geq \mathbb{E}\left[\sup_{f\in\tilde{\mathcal{F}}}\left|\frac{1}{n}\sum_{i=1}^{n}\xi_{i}f(x_{i})\right|\right]+r\right)\leq \exp\left[-nr^{2}/2(\sigma\|\tilde{\mathcal{F}}\|_{n})^{2}\right]$$

where  $\|\tilde{\mathcal{F}}\|_n^2 = \sup_{f \in \tilde{\mathcal{F}}} \frac{1}{n} \sum_{i=1}^n f(x_i)^2$ . Here the probability is taken with respect to  $(\xi_i)_{i=1}^n$ .

Remind that every  $f \in \mathcal{F}$  satisfies  $||f||_n \leq ||f||_\infty \leq \hat{R}_\infty$ . Hence  $||\mathcal{F}||_n \leq \hat{R}_\infty$ . For an observation  $(x_i)_{i=1}^n$ , let  $\mathcal{G}_{\delta} = \{f - f^* \mid ||f - f^*||_n \leq \delta, f \in \mathcal{F}\}$ . It is obvious that  $\mathcal{G}_{\delta}$  is separable with respect to  $L_\infty$ -norm. Then, by the Gaussian concentration inequality, we have that

$$P\left(\sup_{f\in\mathcal{G}_{\delta}}\left|\sum_{i=1}^{n}\frac{1}{n}\xi_{i}f(x_{i})\right|\geq \mathbb{E}\left[\sup_{f\in\mathcal{G}_{\delta}}\left|\frac{1}{n}\sum_{i=1}^{n}\xi_{i}f(x_{i})\right|\right]+r\right)\leq \exp\left[-nr^{2}/2(\sigma\delta)^{2}\right]$$

for every r > 0. By applying this inequality for  $\delta_j = 2^{j-1}\sigma/\sqrt{n}$  for  $j = 1, \ldots, \lceil \log_2(\hat{R}_{\infty}\sqrt{n}/\sigma) \rceil$ and using the uniform bound, we can show that, for every r > 0, with probability  $\lceil \log_2(\hat{R}_{\infty}\sqrt{n}/\sigma) \rceil \exp[-nr^2/2\sigma^2]$ , it holds that any  $f \in \mathcal{G}_{\delta}$  uniformly satisfies

$$\left|\frac{1}{n}\sum_{i=1}^{n}\xi_{i}(f(x_{i})-f^{*}(x_{i}))\right| \geq \mathbb{E}\left[\left|\sup_{f\in\mathcal{G}_{2\delta}}\frac{1}{n}\sum_{i=1}^{n}\xi_{i}f(x_{i})\right|\right]+2\delta r$$

where  $\delta$  is any positive real satisfying  $\delta \geq \sigma/\sqrt{n}$  and  $f \in \mathcal{G}_{\delta}$ .

**Lemma 5** There exists a universal constant C such that for any  $\delta$  it holds that

$$\mathbb{E}\left[\left|\sup_{f\in\mathcal{G}_{2\delta}}\frac{1}{n}\sum_{i=1}^{n}\xi_{i}f(x_{i})\right|\right] \leq C\sigma\delta\sqrt{\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\delta}\right)}.$$

**Proof** Since  $f \mapsto \frac{1}{\sqrt{n}} \sum_{i=1}^{n} \xi_i f(x_i)$  is a sub-Gaussian process relative to the metric  $\|\cdot\|_n$ . By the chaining argument (see, for example, Theorem 2.3.6 of Giné and Nickl (2015)), it holds that

$$\mathbb{E}\left[\left|\sup_{f\in\mathcal{G}_{2\delta}}\frac{1}{n}\sum_{i=1}^{n}\xi_{i}f(x_{i})\right|\right] \leq 4\sqrt{2}\frac{\sigma}{\sqrt{n}}\int_{0}^{2\delta}\sqrt{\log(2N(\epsilon,\mathcal{G}_{2\delta},\|\cdot\|_{n}))}\mathrm{d}\epsilon.$$

Since  $\log N(\epsilon, \mathcal{G}_{2\delta}, \|\cdot\|_n) \leq \log N(\epsilon, \mathcal{F}, \|\cdot\|_\infty) \leq 2\frac{\sum_{\ell=1}^L m_\ell m_{\ell+1}}{n} \log\left(1 + \frac{4\hat{G}\max\{\bar{R}, \bar{R}_b\}}{\epsilon}\right)$ , the right hand side is bounded by

$$\int_{0}^{2\delta} \sqrt{\log(2N(\epsilon, \mathcal{F}, \|\cdot\|_n))} \mathrm{d}\epsilon \le \int_{0}^{2\delta} \sqrt{\log(2) + 2\frac{\sum_{\ell=1}^{L} m_{\ell} m_{\ell+1}}{n} \log\left(1 + \frac{4\hat{G}\max\{\bar{R}, \bar{R}_b\}}{\epsilon}\right)} \mathrm{d}\epsilon$$

$$\leq C\delta_{\sqrt{\frac{\sum_{\ell=1}^{L} m_{\ell} m_{\ell+1}}{n} \log_{+} \left(1 + \frac{4\hat{G}\max\{\bar{R}, \bar{R}_{b}\}}{\delta}\right)},$$

where C is a universal constant. This gives the assertion.

Therefore, by substituting  $\delta \leftarrow \left( \|f - f^*\|_n \lor \sigma \sqrt{\frac{\sum_{\ell=1}^L m_\ell m_{\ell+1}}{n}} \right)$  and  $r \leftarrow \sigma r/\sqrt{n}$ , the following inequality holds:

$$\begin{split} &-\frac{1}{n}\sum_{i=1}^{n}\xi_{i}(f(x_{i})-f^{*}(x_{i}))\\ &\leq C\sigma\left(\|f-f^{*}\|_{n}\vee\sqrt{\frac{\sigma^{2}\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}}\right)\sqrt{\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}}\log_{+}\left(1+\frac{4\sqrt{n}\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\sigma\sqrt{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}}\right)}\\ &+2\left(\|f-f^{*}\|_{n}\vee\sqrt{\frac{\sigma^{2}\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}}\right)\sigma\frac{r}{\sqrt{n}}\\ &\leq \frac{1}{4}\left(\|f-f^{*}\|_{n}\vee\sqrt{\frac{\sigma^{2}\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}}\right)^{2}\\ &+2C^{2}\sigma^{2}\left(\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\sqrt{n}\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\sigma}\right)+4\frac{r^{2}}{n}\right), \end{split}$$

uniformly for all  $f \in \mathcal{F}$  with probability  $1 - \lceil \log_2(\hat{R}_{\infty}\sqrt{n}/\sigma) \rceil \exp[-r^2/2]$ . Here let

$$\Psi_{r,n} := 2C^2 \sigma^2 \left( \frac{\sum_{\ell=1}^L m_\ell m_{\ell+1}}{n} \log_+ \left( 1 + \frac{4\sqrt{n}\hat{G} \max\{\bar{R}, \bar{R}_b\}}{\sigma \sqrt{\sum_{\ell=1}^L m_\ell m_{\ell+1}}} \right) + 4\frac{r^2}{n} \right).$$

Remind that the empirical risk minimizer in the model  $\mathcal{F}$  is denoted by  $\widehat{f}$ :

$$\widehat{f} := \operatorname*{argmin}_{f \in \mathcal{F}} \sum_{i=1}^{n} (y_i - f(x_i))^2.$$

Since  $\hat{f}$  minimizes the empirical risk, it holds that

$$\frac{1}{n} \sum_{i=1}^{n} (y_i - \hat{f}(x_i))^2 \le \frac{1}{n} \sum_{i=1}^{n} (y_i - f^*(x_i))^2$$
  

$$\Rightarrow \frac{2}{n} \sum_{i=1}^{n} y_i (f^*(x_i) - \hat{f}(x_i)) + \|\hat{f}\|_n^2 - \|f^*\|_n^2 \le 0$$
  

$$\Rightarrow \frac{2}{n} \sum_{i=1}^{n} (\xi_i + f^o(x_i)) (f^*(x_i) - \hat{f}(x_i)) + \|\hat{f}\|_n^2 - \|f^*\|_n^2 \le 0$$

$$\Rightarrow \frac{2}{n} \sum_{i=1}^{n} \xi_i (f^*(x_i) - \hat{f}(x_i)) + \frac{2}{n} \sum_{i=1}^{n} f^{o}(x_i) (f^*(x_i) - \hat{f}(x_i)) + \|\hat{f}\|_n^2 - \|f^*\|_n^2 \le 0$$
  
$$\Rightarrow \frac{2}{n} \sum_{i=1}^{n} \xi_i (f^*(x_i) - \hat{f}(x_i)) + \|\hat{f} - f^{o}\|_n^2 \le \|f^* - f^{o}\|_n^2.$$

Therefore, we have

$$-\frac{1}{4}\left(\|\widehat{f} - f^*\|_n \vee \sqrt{\frac{\sigma^2 \sum_{\ell=1}^L m_\ell m_{\ell+1}}{n}}\right)^2 - \Psi_{r,n} + \|\widehat{f} - f^\circ\|_n^2 \le \|f^* - f^\circ\|_n^2.$$
(27)

Let us assume  $\|\widehat{f} - f^*\|_n^2 \ge \frac{\sigma^2 \sum_{\ell=1}^L m_\ell m_{\ell+1}}{n}$ . Then, by Eq. (27), we have

$$-\frac{1}{4}\|\widehat{f} - f^*\|_n^2 - \Psi_{r,n} + \|\widehat{f} - f^o\|_n^2 \le \|f^* - f^o\|_n^2$$

$$\Rightarrow -\frac{1}{4}\|\widehat{f} - f^*\|_n^2 - \Psi_{r,n} + \frac{1}{2}\|\widehat{f} - f^*\|_n^2 - \|f^* - f^o\|_n^2 \le \|f^* - f^o\|_n^2$$

$$\Rightarrow \frac{1}{4}\|\widehat{f} - f^*\|_n^2 \le 2\|f^* - f^o\|_n^2 + \Psi_{r,n}.$$
(28)

Otherwise, we trivially have  $\|\widehat{f} - f^*\|_n^2 < \frac{\sigma^2 \sum_{\ell=1}^L m_\ell m_{\ell+1}}{n}$ .

Combining the inequalities, it holds that

$$\|\widehat{f} - f^*\|_n^2 \le 8\|f^* - f^o\|_n^2 + 4\Psi_{r,n} + \frac{\sigma^2 \sum_{\ell=1}^L m_\ell m_{\ell+1}}{n}.$$
(29)

Based on this inequality, we derive a bound for  $\|\widehat{f} - f^*\|_{L_2(P(X))}$  instead of the empirical  $L_2$ -norm  $\|\widehat{f} - f^*\|_n$ .

**Proposition 4 (Talagrand's concentration inequality (Talagrand, 1996; Bousquet, 2002))** Let  $(x_i)_{i=1}^n$  be an i.i.d. sequence of input variables in  $\mathcal{X}$ . Then, for a set  $\tilde{\mathcal{F}}$  of functions from  $\mathcal{X}$  to  $\mathbb{R}$  which is separable with respect to  $L_{\infty}$ -norm and  $||f||_{\infty} \leq \tilde{R}$  for all  $f \in \tilde{\mathcal{F}}$ , it holds that for every r > 0,

$$P\left(\sup_{f\in\tilde{\mathcal{F}}}\left|\frac{1}{n}\sum_{i=1}^{n}f(x_{i})^{2}-\mathrm{E}[f^{2}]\right|\geq C\left\{\mathrm{E}\left[\sup_{f\in\tilde{\mathcal{F}}}\left|\frac{1}{n}\sum_{i=1}^{n}f(x_{i})^{2}-\mathrm{E}[f^{2}]\right|\right]+\sqrt{\frac{\|\tilde{\mathcal{F}}^{2}\|_{L_{2}(P(X))}^{2}r}{n}}+\frac{r\tilde{R}^{2}}{n}\right\}\right\}$$
$$\leq\exp(-r)$$

where  $\|\tilde{\mathcal{F}}^2\|_{L_2(P(X))}^2 = \sup_{f \in \tilde{\mathcal{F}}} \mathbb{E}[f(X)^4].$ 

Let  $\mathcal{G}'_{\delta} = \{f - f^* \mid ||f - f^*||_{L_2(P(X))} \leq \delta, f \in \mathcal{F}\}$ . By the bound  $||f||_{\infty} \leq \hat{R}_{\infty}$  for all  $f \in \mathcal{F}$ (Lemma 3),  $||g||_{\infty} \leq 2\hat{R}_{\infty}$  for all  $g \in \mathcal{G}'_{\delta}$ . Therefore, we have  $||\mathcal{G}'_{\delta}^2||^2_{L_2(P(X))} \leq 4\hat{R}^2_{\infty}\delta^2$ . Hence, Talagrand's concentration inequality yields that

$$\sup_{f \in \mathcal{G}_{\delta}'} \left| \frac{1}{n} \sum_{i=1}^{n} f(x_{i})^{2} - \mathbb{E}[f^{2}] \right| \geq C_{1} \left\{ \mathbb{E} \left[ \sup_{f \in \mathcal{G}_{\delta}'} \left| \frac{1}{n} \sum_{i=1}^{n} f(x_{i})^{2} - \mathbb{E}[f^{2}] \right| \right] + \sqrt{\frac{\delta^{2} \hat{R}_{\infty}^{2} r}{n}} + \frac{r \tilde{R}^{2}}{n} \right\}$$
(30)

with probability  $1 - \exp(-r)$  where  $C_1$  is a universal constant.

**Lemma 6** There exists a universal constant C > 0 such that, for all  $\delta > 0$ ,

$$\mathbb{E}\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}f(x_{i})^{2}-\mathbb{E}[f^{2}]\right|\right] \\
 \leq C\left[\delta\hat{R}_{\infty}\sqrt{\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\delta}\right)} \\
 \vee\hat{R}_{\infty}^{2}\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\delta}\right)\right].$$

### Proof

Let  $(\epsilon_i)_{i=1}^n$  be i.i.d. Rademacher sequence. Then, by the standard argument of Rademacher complexity, we have

$$\operatorname{E}\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}f(x_{i})^{2}-\operatorname{E}[f^{2}]\right|\right]\leq 2\operatorname{E}\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}\epsilon_{i}f(x_{i})^{2}\right|\right]$$

(see, for example, Lemma 2.3.1 in van der Vaart and Wellner (1996)). Since  $||f||_{\infty} \leq 2\hat{R}_{\infty}$  for all  $f \in \mathcal{G}'_{\delta}$ , the contraction inequality (Ledoux and Talagrand, 1991, Theorem 4.12) gives an upper bound of the RHS as

$$2\mathrm{E}\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}\epsilon_{i}f(x_{i})^{2}\right|\right] \leq 4(2\hat{R}_{\infty})\mathrm{E}\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}\epsilon_{i}f(x_{i})\right|\right].$$

We further bound the RHS. By Theorem 3.1 in Giné and Koltchinskii (2006) or Lemma 2.3 of Mendelson (2002) with the covering number bound (21), there exists a universal constant C' such that

$$E\left[\sup_{f\in\mathcal{G}_{\delta}'}\left|\frac{1}{n}\sum_{i=1}^{n}\epsilon_{i}f(x_{i})\right|\right] \\
 \leq C'\left[\delta\sqrt{\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\delta}\right)}\right. \\
 \lor \hat{R}_{\infty}\frac{\sum_{\ell=1}^{L}m_{\ell}m_{\ell+1}}{n}\log_{+}\left(1+\frac{4\hat{G}\max\{\bar{R},\bar{R}_{b}\}}{\delta}\right)\right].$$

This concludes the proof.

Let  $\Phi_n := \frac{\sum_{\ell=1}^L m_\ell m_{\ell+1}}{n} \log_+ \left( 1 + \frac{4\sqrt{n}\hat{G}\max\{\bar{R},\bar{R}_b\}}{\hat{R}_\infty \sqrt{\sum_{\ell=1}^L m_\ell m_{\ell+1}}} \right)$ . Then, applying the inequality (30) for  $\delta = 2^{j-1}\hat{R}_\infty / \sqrt{n}$  for  $j = 1, \ldots, \lceil \log_2(\sqrt{n}) \rceil$ , it is shown that there exists an event with probability  $1 - \lceil \log_2(\sqrt{n}) \rceil \exp(-r)$  such that, uniformly for all  $f \in \mathcal{F}$ , it holds that

$$\left|\frac{1}{n}\sum_{i=1}^{n}(f(x_{i})-f^{*}(x_{i}))^{2}-\mathrm{E}[(f-f^{*})^{2}]\right| \leq C_{1}\left[C(2\delta\hat{R}_{\infty}\sqrt{\Phi_{n}})\vee(\hat{R}_{\infty}^{2}\Phi_{n})+\delta\sqrt{\frac{\hat{R}_{\infty}^{2}r}{n}}+\frac{r\hat{R}_{\infty}^{2}}{n}\right]$$

$$\leq \frac{\delta^2}{2} + 2C_1^2(2C^2 + 1)\hat{R}_{\infty}^2\Phi_n + (C_1^2 + C_1)\frac{\hat{R}_{\infty}^2r}{n},$$

where  $\delta$  is any positive real such that  $\delta^2 \ge E[(f - f^*)^2]$  and  $\delta^2 \ge \hat{R}_{\infty}^2 \sum_{\ell=1}^L m_\ell m_{\ell+1}/n$ . The right hand side can be further bounded by

$$\frac{\delta^2}{2} + C_2 \hat{R}_\infty^2 \left( \Phi_n + \frac{r}{n} \right)$$

for an appropriately defined universal constant  $C_2$ . Applying this inequality for  $f = \hat{f}$  to Eq. (29) gives that

$$\frac{1}{2}\|\widehat{f} - f^*\|_{L_2(P(X))}^2 \le C_2 \hat{R}_\infty^2 \left(\Phi_n + \frac{r}{n}\right) + 8\|f^* - f^o\|_n^2 + 4\Psi_{r,n} + \left(\frac{\sigma^2 + \hat{R}_\infty^2}{n}\right) \sum_{\ell=1}^L m_\ell m_{\ell+1}.$$

Finally, by the Bernstein's inequality (25), the term  $||f^* - f^o||_n^2$  is bounded as

$$\|f^* - f^{\mathsf{o}}\|_n^2 \le (1 + \tilde{r}')\|f^* - f^{\mathsf{o}}\|_{L_2(P(X))}^2 \le (1 + \tilde{r}')\hat{\delta}_{1,n}^2$$

with probability  $1 - \exp\left(-\frac{3n\delta_{1,n}^2 \tilde{r}'^2}{32\hat{R}_{\infty}^2}\right)$  for every  $\tilde{r}' > 0$ .

Combining all inequalities, we obtain that

$$\|\widehat{f} - f^*\|_{L_2(P(X))}^2 \le 2C_2 \hat{R}_\infty^2 \left(\Phi_n + \frac{r}{n}\right) + 16(1 + \tilde{r}')\hat{\delta}_{1,n}^2 + 4\Psi_{r,n} + \frac{2(\sigma^2 + \hat{R}_\infty^2)}{n} \sum_{\ell=1}^L m_\ell m_{\ell+1}.$$

This gives a bound for the distance between  $\hat{f}$  and  $f^*$ . However, what we want is a bound on the distance from the true function  $f^{\text{o}}$  to  $\hat{f}$ . This can be accomplished by noticing that  $\|\hat{f} - f^{\text{o}}\|_{L_2(P(X))}^2 \leq 2(\|\hat{f} - f^*\|_{L_2(P(X))}^2 + \|f^{\text{o}} - f^*\|_{L_2(P(X))}^2) \leq 2\|\hat{f} - f^*\|_{L_2(P(X))}^2 + 2\hat{\delta}_{1,n}^2$ , and conclude that

$$\|\widehat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} \leq 4C_{2}\widehat{R}_{\infty}^{2}\left(\Phi_{n} + \frac{r}{n}\right) + (34 + 32\widetilde{r}')\widehat{\delta}_{1,n}^{2} + 8\Psi_{r,n} + \frac{4(\sigma^{2} + \widehat{R}_{\infty}^{2})}{n}\sum_{\ell=1}^{L} m_{\ell}m_{\ell+1}.$$

More concisely, letting

$$\alpha(U) := U^2 \frac{\sum_{\ell=1}^L m_\ell m_{\ell+1}}{n} \log_+ \left( 1 + \frac{4\sqrt{n}\hat{G} \max\{\bar{R}, \bar{R}_b\}}{U\sqrt{\sum_{\ell=1}^L m_\ell m_{\ell+1}}} \right),$$

the right side is further upper bounded as

$$\|\hat{f} - f^{\circ}\|_{L_{2}(P(X))}^{2} \leq C_{3} \left\{ \alpha(\hat{R}_{\infty}) + \alpha(\sigma) + \frac{(\hat{R}_{\infty}^{2} + \sigma^{2})}{n} \left[ \log_{+} \left( \frac{\sqrt{n}}{\min\{\sigma/\hat{R}_{\infty}, 1\}} \right) + r \right] + (1 + \tilde{r}') \hat{\delta}_{1,n}^{2} \right\}$$
with probability  $1 - \exp\left( -\frac{3n\hat{\delta}_{1,n}^{2}\tilde{r}'^{2}}{n} \right) - 2\exp(-r)$  for every  $r > 0$  and  $\tilde{r}' > 0$ 

with probability  $1 - \exp\left(-\frac{3n\delta_{1,n}^2 \tilde{r}'^2}{32\hat{R}_{\infty}^2}\right) - 2\exp(-r)$  for every r > 0 and  $\tilde{r}' > 0$ .
