# UPPER AND LOWER LEBESGUE CLASSIFICATION OF MULTIVALUED MAPPINGS OF TWO VARIABLES

#### Abstract

We introduce a functional Lebesgue classification of multivalued mappings and obtain results on upper and lower Lebesgue classifications of multivalued mappings $F: X \times Y \rightarrow Z$ for wide classes of spaces $X, Y$ and $Z$.

## 1. Introduction

Investigations of Lebesgue classification of separately continuous single-valued functions (i.e., functions of several variables which are continuous with respect to each variable) and theirs analogs were started by H. Lebesgue in 9 and by K. Kuratowski in [6]. These investigations were continued in papers of many mathematicians (see, for example, [12, [7, [1, [2], 10], 4] and the literature given there).

Some analogs of Lebesgue classification are also known for multivalued maps and are connected with the upper and lower semi-continuity. Namely, a multivalued $\operatorname{map} F: X \rightarrow[0,1]$ defined on a topological space $X$ is called upper (lower) semicontinuous at $x_{0} \in X$ if for every open set $U$ in $[0,1]$ with $F\left(x_{0}\right) \subseteq U\left(F\left(x_{0}\right) \cap U \neq \emptyset\right)$ the set

$$
\begin{gathered}
F^{+}(U)=\{x \in X: F(x) \subseteq U\} \\
\left(F^{-}(U)=\{x \in X: F(x) \cap U \neq \emptyset\}\right)
\end{gathered}
$$

is a neighborhood of $x_{0}$ in $X$. A multivalued map $F: X \rightarrow[0,1]$ is continuous at $x_{0} \in X$ if it is upper and lower semi-continuous at $x_{0}$ simultaneously. It is well known that a multivalued map $F: X \rightarrow[0,1]$ is continuous at $x_{0} \in X$ if and only if it is continuous at $x_{0}$ as a single-valued map with values in the space of all non-empty subsets of $[0,1]$ with the Vietoris topology.

For topological spaces $X$ and $Y$ let $\mathrm{U}(X, Y)(\mathrm{L}(X, Y))$ stands for the collection of all upper (lower) semi-continuous multivalued maps $F: X \rightarrow Y$.

Let $X$ and $Y$ be topological spaces and $\alpha$ be an at most countable ordinal. A multivalued map $F: X \rightarrow Y$ belongs to the

- $\alpha$ 'th upper Lebesgue class if for every open set $A \subseteq Y$ the set $F^{+}(A)$ belongs to the $\alpha$ 'th additive class in $X$;
- $\alpha^{\prime}$ th lower Lebesgue class if for every open set $A \subseteq Y$ the set $F^{-}(A)$ belongs to the $\alpha$ 'th additive class in $X$.

[^0]Let us observe that Lebesgue classes are often called Borel classes.
For topological spaces $X$ and $Y$ the collection of all multivalued maps $F: X \rightarrow Y$ of the $\alpha$ 'th upper (lower) Lebesgue class we denote by $\mathrm{U}_{\alpha}(X, Y)\left(\mathrm{L}_{\alpha}(X, Y)\right)$.

For a multivalued map $F: X \times Y \rightarrow Z, x \in X$ and $y \in Y$ we write $F^{x}(y)=$ $F_{y}(x)=F(x, y)$.

Recall that a topological space is said to be perfect if every its closed subset is $G_{\delta}$.
G. Kwiecińska proved in [8] the following result on Lebesgue classification of multivalued maps of two variables.

Theorem 1.1 ([8). Let $(X, d)$ be a metric space, $\mathcal{T}$ be a topology on $X, D \subseteq X$ be an at most countable set, $(U(x): x \in X)$ be a family of $\mathcal{T}$-open sets $U(x) \subseteq X$, $Y$ and $Z$ be perfectly normal spaces, $\alpha$ be an at most countable ordinal and $F$ : $X \times Y \rightarrow Z$ be a compact-valued (multivalued) map satisfying the conditions
(a) $D$ is dense in $(X, \mathcal{T})$;
(b) for every $x \in D$ the set $A(x)=\{u \in X: x \in U(u)\}$ belongs to the $\alpha$ 'th additive class in $(X, d)$;
(c) for every $x \in X$ the sequence $\left(B_{n}(x)\right)_{n \in \omega}$ of sets

$$
B_{n}(x)=U(x) \cap\left\{u \in X: d(x, u)<\frac{1}{n}\right\}
$$

forms a base of $(X, \mathcal{T})$ at $x$;
(d) for every $y \in Y$ the multivalued map $F_{y}:(X, \mathcal{T}) \rightarrow Z$ is continuous;
(e) for every $x \in D$, the multivalued map $F^{x}: Y \rightarrow Z$ belongs to the $\alpha$ 'th lower (upper) Lebesgue class.
Then $F$ is of the upper (lower) Lebesgue class $\alpha+1$ on the product $(X, d) \times Y$.
Another variants of Lebesgue classification of multivalued maps of two variables were obtained in 5.

Theorem 1.2 (5). Let $X$ be a metrizable space, $D$ be a dense subset of $X, Y$ be $a$ perfect space, $Z$ be a perfectly normal space, $\alpha$ be an at most countable ordinal and $F: X \times Y \rightarrow Z$ be a compact-valued (multivalued) map satisfying the conditions
(a) for every $y \in Y$ the multivalued map $F_{y}: X \rightarrow Z$ is continuous;
(b) for every $x \in D$, the multivalued map $F^{x}: Y \rightarrow Z$ is of the $\alpha^{\prime}$ 'th lower (upper) Lebesgue class.
Then $F$ is of the upper (lower) Lebesgue class $\alpha+1$ on the product $X \times Y$.
In this paper we introduce a functional Lebesgue classification of multivalued maps and generalize Theorems 1.1 and 1.2 for a wide class of topological spaces $X$.

## 2. MULTIVALUED MAPS OF THE $\alpha$ 'Th UPPER AND LOWER LEBESGUE FUNCTIONAL CLASS

Definition 2.1. Let $X$ and $Y$ be topological spaces. A multivalued map $F: X \rightarrow$ $Y$ is called

- upper (lower) functionally semi-continuous multivalued map if $F^{+}(A)\left(F^{-}(A)\right)$ is a functionally open set for every functionally open set $A \subseteq Y$;
- strongly upper (lower) functionally semi-continuous multivalued map if $F^{+}(A)$ $\left(F^{-}(A)\right)$ is a functionally open set for every open set $A \subseteq Y$;
- weakly upper (lower) functionally semi-continuous multivalued map if $F^{+}(A)$
$\left(F^{-}(A)\right)$ is an open set for every functionally open set $A \subseteq Y$.

The collection of all upper (lower, strongly upper, strongly lower, weakly upper, weakly lower) functional semi-continuous multivalued maps $F: X \rightarrow Y$ we denote by $\mathrm{U}^{f}(X)\left(\mathrm{L}^{f}(X), \mathrm{U}_{s}^{f}(X), \mathrm{L}_{s}^{f}(X), \mathrm{U}_{w}^{f}(X), \mathrm{L}_{w}^{f}(X)\right)$.

Let $X$ be a topological space. We denote by $\mathcal{A}_{0}(X)$ and $\mathcal{M}_{0}(X)$ the systems of all functionally open and functionally closed subsets of $X$, respectively. For every at most countable ordinal $\alpha \geq 1$ the system of all unions $\bigcup_{n \in \omega} A_{n}$ of sets $A_{n}$ from $\bigcup_{\xi<\alpha} \mathcal{M}_{\alpha}(X)$ we denote by $\mathcal{A}_{\alpha}(X)$, and the system of all intersections $\bigcap_{n \in \omega} M_{n}$ of sets $M_{n}$ from $\bigcup_{\xi<\alpha} \mathcal{A}_{\alpha}(X)$ we denote by $\mathcal{M}_{\alpha}(X)$. Clearly,

$$
\mathcal{A}_{\alpha}(X)=\left\{X \backslash M: M \in \mathcal{M}_{\alpha}(X)\right\}
$$

Definition 2.2. Let $X$ and $Y$ be topological spaces and $\alpha$ be an at most countable ordinal. A multivalued map $F: X \rightarrow Y$ is called

- upper Lebesgue functional class $\alpha$ multivalued map if $F^{+}(A) \in \mathcal{A}_{\alpha}(X)$ for every functionally open set $A \subseteq Y$;
- lower Lebesgue functional class $\alpha$ multivalued map if $F^{-}(A) \in \mathcal{A}_{\alpha}(X)$ for every functionally open set $A \subseteq Y$.

It is easy to see that $F$ is an upper (lower) Lebesgue functional class $\alpha$ multivalued map if and only if $F^{-}(B) \in \mathcal{A}_{\alpha}(X)\left(F^{+}(B) \in \mathcal{A}_{\alpha}(X)\right)$ for every functionally closed set $B \subseteq Y$.

For topological spaces $X$ and $Y$ the collection of all multivalued maps $F: X \rightarrow Y$ of the $\alpha^{\prime}$ th upper (lower) Lebesgue functional class we denote by $\mathrm{U}_{\alpha}^{f}(X)\left(\mathrm{L}_{\alpha}^{f}(X)\right)$. Notice that $\mathrm{U}_{0}^{f}(X)=\mathrm{U}^{f}(X)$ and $\mathrm{L}_{0}^{f}(X)=\mathrm{L}^{f}(X)$.

The facts below follow easily from the definitions and we omit their proof.
Proposition 2.3. Let $X$ and $Y$ be a topological spaces, $F: X \rightarrow Y$ be a multivalued map and $\alpha$ be at most countable ordinal.
(1) $\mathrm{U}(X, Y) \cup \mathrm{U}^{f}(X, Y) \subseteq \mathrm{U}_{w}^{f}(X, Y)$ and $\mathrm{L}(X, Y) \cup \mathrm{L}^{f}(X, Y) \subseteq \mathrm{L}_{w}^{f}(X, Y)$.
(2) $\mathrm{U}_{s}^{f}(X, Y) \subseteq \mathrm{U}(X, Y) \cap \mathrm{U}^{f}(X, Y)$ and $\mathrm{L}_{s}^{f}(X, Y) \subseteq \mathrm{L}(X, Y) \cap \mathrm{L}^{f}(X, Y)$.
(3) If $X$ is perfectly normal, then $\mathrm{U}_{s}^{f}(X, Y)=\mathrm{U}(X, \bar{Y}) \subseteq \mathrm{U}^{f}(X, Y)=\mathrm{U}_{w}^{f}(X, Y)$ and $\mathrm{L}_{s}^{f}(X, Y)=\mathrm{L}(X, Y) \subseteq \mathrm{L}^{f}(X, Y)=\mathrm{L}_{w}^{f}(X, Y)$.
(4) If $Y$ is completely regular, then $\mathrm{U}^{f}(X, Y) \subseteq \mathrm{U}(X, Y)$ and $\mathrm{L}^{f}(X, Y) \subseteq$ $\mathrm{L}(X, Y)$.
(5) If $Y$ is perfectly normal, then $\mathrm{U}_{s}^{f}(X, Y)=\mathrm{U}^{f}(X, Y) \subseteq \mathrm{U}(X, Y)=\mathrm{U}_{w}^{f}(X, Y)$ and $\mathrm{L}_{s}^{f}(X, Y)=\mathrm{L}^{f}(X, Y) \subseteq \mathrm{L}(X, Y)=\mathrm{L}_{w}^{f}(X, Y)$.
(6) $\mathrm{U}_{\alpha}^{f}(X, Y) \subseteq \mathrm{L}_{\alpha+1}^{f}(X, Y)$.
(7) If $F$ is a compact-valued map then $\mathrm{L}_{\alpha}^{f}(X, Y) \subseteq \mathrm{U}_{\alpha+1}^{f}(X, Y)$.

Proposition 2.4. Let $Y$ be a topological space such that $\{\emptyset, Y\}$ is the system of all functionally open sets in $Y$ (see, for example, [3, 2.7.18]). Then
(1) for every topological space $X$ any multivalued map $F: X \rightarrow Y$ is upper and lower functionally semi-continuous;
(2) for every $T_{1}$-space $Z$ any strongly upper functionally semi-continuous map $F: Y \rightarrow Z$ is constant;
(3) for every (completely) regular space $Z$ any strongly lower (lower) functionally semi-continuous closed-valued map $F: Y \rightarrow Z$ is constant.

Proof. (1). Since $F^{+}(\emptyset)=F^{-}(\emptyset)=\emptyset$ and $F^{+}(Y)=F^{-}(Y)=X, F: X \rightarrow Y$ is upper and lower functionally semi-continuous.
(2). Let $Z$ be a $T_{1}$-space, $F: Y \rightarrow Z$ be a map which is non-constant. We chose $y_{1}, y_{2} \in Y$ such that $F\left(y_{1}\right) \nsubseteq F\left(y_{2}\right)$. Since $Y$ is a $T_{1}$-space, there exists an open set $G \subseteq Z$ such that $F\left(y_{1}\right) \nsubseteq G \supseteq F\left(y_{2}\right)$. Then $y_{1} \notin F^{+}(G) \ni y_{2}$. Therefore, $F^{+}(G) \notin\{\emptyset, Y\}$ and $F^{+}(G)$ is not functionally open. Hence, $F$ is not strongly upper functionally semi-continuous.
(3). Let $Z$ be a regular space, $F: Y \rightarrow Z$ be a non-constant map. We choose $y_{1}, y_{2} \in Y$ such that $F\left(y_{1}\right) \nsubseteq F\left(y_{2}\right)$. Since $Y$ is a regular space and $F\left(y_{2}\right)$ is closed, there exists an open set $G \subseteq Z$ such that $G \cap F\left(y_{1}\right) \neq \emptyset$ and $G \cap F\left(y_{2}\right)=\emptyset$. Then $y_{1} \in F^{-}(G) \not \supset y_{2}$. Therefore, $F^{-}(G) \notin\{\emptyset, Y\}$ and $F^{-}(G)$ is not functionally open. Hence, $F$ is not strongly lower functionally semi-continuous. In the case of completely regular space $Z$ we can choose a functionally open set $G$ and the map $F$ is not lower functionally semi-continuous.

Example 2.5. Let $A \subseteq[0,1]$ be a non Borel-measurable set. Then the multivalued map $F:[0,1] \rightarrow[0,1]$,

$$
F(x)= \begin{cases}{[0,1],} & x \in A \\ {[0,1),} & x \in[0,1] \backslash A\end{cases}
$$

is a lower (functionally) semi-continuous and $F$ is upper (functionally) nonmeasurable, that is, $F \notin \bigcup_{\alpha<\omega_{1}} \mathrm{U}_{\alpha}^{f}([0,1],[0,1])$.

## 3. Functional Lebesgue classification of multivalued maps of two VARIABLES

The following auxiliary statement can be found in [4, Proposition 1.4].
Lemma 3.1. Let $X$ be a topological space, $\alpha$ be an at most countable ordinal, $\left(U_{i}: i \in I\right)$ be a locally finite family of functionally open in $X$ sets $U_{i}$ and $\left(A_{i}: i \in I\right)$ be a family of sets $A_{i} \in \mathcal{A}_{\alpha}(X)\left(A_{i} \in \mathcal{M}_{\alpha}(X)\right)$ with $A_{i} \subseteq U_{i}$ for every $i \in I$. Then $\left.\bigcup_{i \in I} A_{i} \in \mathcal{A}_{\alpha}(X) \bigcup_{i \in I} A_{i} \in \mathcal{M}_{\alpha}(X)\right)$.

Let us observe that a union of a locally finite family of sets of the $\alpha$ 'th functionally multiplicative class does not belong to the same class even for $\alpha=0$.

Indeed, let $X$ be the Niemytski plane, i.e. $X=\mathbb{R} \times[0,+\infty)$, where a base of neighborhoods of $(x, y) \in X$ with $y>0$ form open balls with the center in $(x, y)$, and a base of neighborhoods of $(x, 0)$ form the sets $U \cup\{(x, 0)\}$, where $U$ is an open ball which tangent to $\mathbb{R} \times\{0\}$ in the point $(x, 0)$.

Notice that for every $p \in X$ the set $\{p\}$ is functionally closed in $X$, since each continuous function on $\mathbb{R} \times[0,+\infty)$ is continuous on $X$. Then the family $\mathcal{F}=(\{(x, 0)\}: x \in \mathbb{Q})$ consists of functionally closed subsets of $X$. To obtain a contradiction, we assume that the union $F=\bigcup \mathcal{F}$ is functionally closed in $X$ and choose a continuous function $f: X \rightarrow[0,1]$ such that $F=f^{-1}(0)$. For all $(x, y) \in X$ and $n \in \mathbb{N}$ we put

$$
f_{n}(x, y)= \begin{cases}f(x, y), & y \geq \frac{1}{n} \\ f\left(x, \frac{1}{n}\right), & 0 \leq y<\frac{1}{n}\end{cases}
$$

Then $f_{n}: \mathbb{R} \times[0,+\infty) \rightarrow[0,1]$ is a continuous function and $\lim _{n \rightarrow \infty} f_{n}(x, y)=$ $f(x, y)$ for every $(x, y) \in X$. Since $F=\bigcap_{k=1}^{\infty} \bigcup_{n=k}^{\infty} f_{n}^{-1}\left(\left[0, \frac{1}{k}\right)\right), F$ is a $G_{\delta}$-subset of $\mathbb{R} \times[0,+\infty)$, which implies a contradiction.

Definition 3.2. A family $\left(A_{i}: i \in I\right)$ of subsets $A_{i}$ of topological space $X$ is called functionally locally finite in $X$, if there exists a locally finite in $X$ family
$\left(U_{i}: i \in I\right)$ of functionally open in $X$ sets $U_{i} \supseteq A_{i}$. A family $\left(A_{i}: i \in I\right)$ of subsets $A_{i}$ of topological space $X$ is called $\sigma$-functionally locally finite if there exists a partition $I=\bigsqcup_{n \in \omega} I_{n}$ such that every family $\left(A_{i}: i \in I_{n}\right)$ is functionally locally finite in $X$.

Theorem 3.3. Let $X, Y$ and $Z$ be topological spaces, $\alpha$ be an at most countable ordinal, $\left(\mathcal{A}_{n}\right)_{n=1}^{\infty}$ be a sequence of $\sigma$-functionally locally finite covers $\mathcal{A}_{n}=\left(A_{i, n}\right.$ : $\left.i \in I_{n}\right)$ of $X$ by sets $A_{i, n} \in \mathcal{A}_{\alpha}(X),\left(\left(x_{i, n}: i \in I_{n}\right)\right)_{n=1}^{\infty}$ be a sequence of families of points $x_{i, n} \in X$ and $F: X \times Y \rightarrow Z$ be a compact-valued/multivalued/ map satisfying the conditions

1) for every $x \in X$, for every $y \in Y$ and for every sequence $\left(i_{n}\right)_{n \in \omega}$ of indexes $i_{n} \in I_{n}$ with $x \in A_{i_{n}, n}$ the sequence $\left(F\left(x_{i_{n}, n}, y\right)\right)_{n \in \omega}$ converges to $F(x, y)$ with respect the Vietoris topology;
2) $F^{x} \in \mathrm{~L}_{\alpha}^{f}(Y, Z)\left(F^{x} \in \mathrm{U}_{\alpha}^{f}(Y, Z)\right)$ for every $x \in D=\left\{x_{i, n}: n \in \mathbb{N}, i \in I_{n}\right\}$.

Then $F \in \mathrm{U}_{\alpha+1}^{f}(X \times Y, Z)\left(F \in \mathrm{~L}_{\alpha+1}^{f}(X \times Y, Z)\right)$.
Proof. We consider the case of compact-valued map $F$. For every $n \in \omega$ and $i \in I_{n}$ we put $F_{i, n}=F^{x_{i, n}}$. Let $W \subseteq Z$ be a functionally closed set and $\varphi: Z \rightarrow[0,1]$ be a continuous function with $W=\varphi^{-1}(0)$. For every $n \in \omega$ we put $W_{n}=\varphi^{-1}\left(\left[0, \frac{1}{n}\right]\right)$ and $G_{n}=\varphi^{-1}\left(\left[0, \frac{1}{n}\right)\right)$. For every $m, n \in \omega$ we put

$$
C_{m, n}=\bigcup_{i \in I_{n}}\left(A_{i, n} \times F_{i, n}^{-}\left(G_{m}\right)\right) \text { and } C=\bigcap_{m \in \omega} \bigcup_{n \geq m} C_{n, m}
$$

Since $A_{i, n} \in \mathcal{A}_{\alpha}(X)$ and $F_{i, n}^{-}\left(G_{m}\right) \in \mathcal{A}_{\alpha}(Y)$ by condition 2$)$,

$$
A_{i, n} \times F_{i, n}^{-}\left(G_{m}\right) \in \mathcal{A}_{\alpha}(X \times Y)
$$

for every $m, n \in \omega$ and $i \in I_{n}$. Now according to Lemma 3.1 $C_{m, n} \in \mathcal{A}_{\alpha}(X \times Y)$. Therefore, $C \in \mathcal{M}_{\alpha+1}(X \times Y)$.

It remains to show that $C=F^{-}(W)$. Let $\left(x_{0}, y_{0}\right) \in F^{-}(W)$. We fix $m \in \omega$. Notice that $\left(x_{0}, y_{0}\right) \in F^{-}\left(G_{m}\right)$. We consider the neighborhood

$$
O=\left\{B \subseteq Z: B \cap G_{m} \neq \emptyset\right\}
$$

of $F\left(x_{0}, y_{0}\right)$ with respect the Vietoris topology. According to condition 1$)$, there exists $n_{0} \geq m$ such that for every $n \geq n_{0}$ if $i \in I_{n}$ with $x_{0} \in A_{i, n}$, then $F\left(x_{i, n}, y_{0}\right) \in$ $O$, that is, $\left(x_{i, n}, y_{0}\right) \in F^{-}\left(G_{m}\right)$. In particular, for some $i \in I_{n_{0}}$ we have $x_{0} \in A_{i, n_{0}}$ and $y_{0} \in F_{i, n_{0}}^{-}\left(G_{m}\right)$. Therefore, $\left(x_{0}, y_{0}\right) \in C_{m, n_{0}}$. Thus, $\left(x_{0}, y_{0}\right) \in C$.

Now let $\left(x_{0}, y_{0}\right) \notin F^{-}(W)$. Then

$$
F\left(x_{0}, y_{0}\right) \subseteq Z \backslash W=\bigcup_{m \in \omega}\left(Z \backslash W_{m}\right)
$$

Since $F\left(x_{0}, y_{0}\right)$ is a compact set, there exists $m_{0} \in \omega$ such that $F\left(x_{0}, y_{0}\right) \subseteq Z \backslash W_{m_{0}}$. We consider the following neighborhood

$$
O_{1}=\left\{B \subseteq Z: B \cap W_{m_{0}}=\emptyset\right\}
$$

of $F\left(x_{0}, y_{0}\right)$ with respect the Vietoris topology. According to condition 1), there exists $n_{0} \in \omega$ such that for every $n \geq n_{0}$ if $x_{0} \in A_{i, n}$ then $F\left(x_{i, n}, y_{0}\right) \in O_{1}$. Therefore, $F\left(x_{i, n}, y_{0}\right) \subseteq Z \backslash W_{m_{0}} \subseteq Z \backslash W_{m}$ and $y_{0} \notin F_{i . n}^{-}\left(G_{m}\right)$ for every $m \geq m_{0}$, $n \geq n_{0}$ and $i \in I_{n}$ with $x_{0} \in A_{i, n}$. This implies that $\left(x_{0}, y_{0}\right) \notin C_{n, m}$ for every $n \geq n_{0}$ and $m \geq m_{0}$. Thus, $\left(x_{0}, y_{0}\right) \notin C$.

Now let $F$ be a multivalued map and $F^{x} \in \mathrm{U}_{\alpha}^{f}(Y, Z)$ for every $x \in D$. We argue similarly as in the previous case and use analogous notations. For every $m, n \in \omega$ we put

$$
C_{m, n}=\bigcup_{i \in I_{n}}\left(A_{i, n} \times F_{i, n}^{+}\left(G_{m}\right)\right)
$$

According to Lemma 3.1, $C_{m, n} \in \mathcal{A}_{\alpha}(X \times Y)$ and

$$
C=\bigcap_{m \in \omega} \bigcup_{n \geq m} C_{n, m} \in \mathcal{M}_{\alpha+1}(X \times Y)
$$

Further, we show that $C=F^{+}(W)$. Let $\left(x_{0}, y_{0}\right) \in F^{+}(W)$ and $m \in \omega$. Then $\left(x_{0}, y_{0}\right) \in F^{+}\left(G_{m}\right)$. According to condition 1$)$, there exist $n \geq m$ and $i \in I_{n}$ such that $x_{0} \in A_{i, n}$ and $F\left(x_{i, n}, y_{0}\right) \subseteq G_{m}$. Therefore, $\left(x_{0}, y_{0}\right) \in C_{m, n}$. Thus, $\left(x_{0}, y_{0}\right) \in C$.

Now let $\left(x_{0}, y_{0}\right) \notin F^{+}(W)$. Then $F\left(x_{0}, y_{0}\right) \cap(Z \backslash W) \neq \emptyset$ and there exists $m_{0} \in \omega$ such that $F\left(x_{0}, y_{0}\right) \cap\left(Z \backslash W_{m_{0}}\right) \neq \emptyset$. According to condition 1$)$, there exists $n_{0} \in \omega$ such that for every $n \geq n_{0}$ if $x_{0} \in A_{i, n}$ then $F\left(x_{i, n}, y_{0}\right) \cap\left(Z \backslash W_{m_{0}}\right) \neq \emptyset$. Therefore, $\left(x_{0}, y_{0}\right) \notin C_{n, m}$ for every $n \geq n_{0}$ and $m \geq m_{0}$. Thus, $\left(x_{0}, y_{0}\right) \notin C$.

Remark 3.4. The multivalued map $F:(X, d) \times Y \rightarrow Z$ from the Theorem 1.1 satisfies conditions 1) -2) of Theorem [3.3, For every $u \in D$ and $n \in \omega$ we put

$$
A_{u, n}=A(u) \cap\left\{v \in X: d(u, v)<\frac{1}{n}\right\} \quad \text { and } \quad x_{u, n}=u
$$

Then the sequences of families $\left(A_{u, n}: u \in D\right)$ and $\left(x_{u, n}: u \in D\right)$ provides condition 1). Moreover, condition 2) is equivalent to condition (e). Thus, Theorem 3.3 generalizes Theorem 1.1.
Definition 3.5. A topological space $X$ is called (strong) PP-space if (for any dense set $D \subseteq X)$ there exist a sequence $\left(\mathcal{U}_{n}\right)_{n=1}^{\infty}$ of locally finite covers $\mathcal{U}_{n}=\left(U_{i, n}: i \in\right.$ $\left.I_{n}\right)$ of $X$ and a sequence $\left(\left(x_{i, n}: i \in I_{n}\right)\right)_{n=1}^{\infty}$ of families of points of $X$ (of $D$ ) such that for every $x \in X$ and for every neighborhood $U$ of $x$ there exists $n_{0} \in \omega$ such that for every $n \geq n_{0}$ and $i \in I_{n}$ the inclusion $x \in U_{i, n}$ implies the inclusion $x_{i, n} \in U$.

Obviously, every strong PP-space is a PP-space.
For topological spaces $X, Y$ and $Z$ and at most countable ordinal $\alpha$ the collection of all multivalued maps $F: X \times Y \rightarrow Z$ which are continuous with respect the first variable and are upper (lower) Lebesgue functional class $\alpha$ with respect the second variable we denote by $\mathrm{CU}_{\alpha}^{f}(X, Y, Z)\left(\mathrm{CL}_{\alpha}^{f}(X, Y, Z)\right)$. Analogously, the collection of all multivalued maps $F: X \times Y \rightarrow Z$ which are continuous with respect the first variable and such that for some dense in $X$ set $D$ every multivalued map $F^{x}$ is upper (lower) Lebesgue functional class $\alpha$ we denote by $\overline{\mathrm{C}} \mathrm{U}_{\alpha}^{f}(X, Y, Z)\left(\overline{\mathrm{C}}{ }_{\alpha}^{f}(X, Y, Z)\right)$. The collections $\mathrm{CU}_{\alpha}(X, Y, Z), \mathrm{CL}_{\alpha}^{f}(X, Y, Z) \overline{\mathrm{C}}{ }_{\alpha}^{f}(X, Y, Z)$ and $\overline{\mathrm{C}}{ }_{\alpha}^{f}(X, Y, Z)$ are introduced analogously.

Corollary 3.6. Let $X$ be a $P P$-space, $Y$ and $Z$ be topological spaces and $\alpha$ be an at most countable ordinal. Then $\mathrm{CU}_{\alpha}^{f}(X, Y, Z) \subseteq \mathrm{L}_{\alpha+1}^{f}(X \times Y, Z)$ and $\mathrm{CL}_{\alpha}^{f}(X, Y, Z) \subseteq$ $\mathrm{U}_{\alpha+1}^{f}(X \times Y, Z)$.
Proof. Let $\left(\mathcal{U}_{n}\right)_{n=1}^{\infty}$ and $\left(\left(x_{i, n}: i \in I_{n}\right)\right)_{n=1}^{\infty}$ be sequences from Definition 3.5 and $A_{i, n}=U_{i, n}$ for every $n \in \omega$ and $i \in I_{n}$. It remains to use Theorem 3.3.

For strongly PP-spaces we can prove the following result similarly.
Corollary 3.7. Let $X$ be a strong PP-space, $Y$ and $Z$ be topological spaces and $\alpha$ be an at most countable ordinal. Then $\mathrm{C}_{\alpha}^{f}(X, Y, Z) \subseteq \mathrm{L}_{\alpha+1}^{f}(X \times Y, Z)$ and $\mathrm{C} \overline{\mathrm{L}}_{\alpha}^{f}(X, Y, Z) \subseteq \mathrm{U}_{\alpha+1}^{f}(X \times Y, Z)$.

## 4. Lebesgue classification of multivalued maps of two variables

We start from the following generalization of Theorem 3.30 from [11].
Theorem 4.1. Let $X$ be a perfect space, $\alpha$ be an at most countable ordinal, $\left(A_{i}\right.$ : $i \in I$ ) be a locally finite family of sets $A_{i}$ of additive (multiplicative) class $\alpha$ on $X$. Then the set $A=\bigcup_{i \in I} A_{i}$ is of additive (multiplicative) class $\alpha$ on $X$.

Proof. We argue using the induction on $\alpha$. It is well-known that this statement is true for $\alpha=0$.

Let $\left(A_{i}: i \in I\right)$ be a locally finite family of $F_{\sigma}$-sets $A_{i} \subseteq X$ and $\left(\left(B_{i, n}\right)_{n \in \omega}: i \in I\right)$ be a sequence of families of closed in $X$ sets $B_{i, n}$ such that $A_{i}=\bigcup_{n \in \omega} B_{i, n}$ for every $i \in I$. Notice that every family $\left(B_{i, n}: i \in I\right)$ is locally finite. Therefore, all sets $B_{n}=\bigcup_{i \in I} B_{i, n}$ is closed and $A=\bigcup_{n \in \omega} B_{n}$ is an $F_{\sigma}$-set.

Let $\left(A_{i}: i \in I\right)$ be a locally finite family of $G_{\delta}$ sets $A_{i} \subseteq X$ and $\left(\left(B_{i, n}\right)_{n \in \omega}: i \in I\right)$ be a sequence of families of open in $X$ sets $B_{i, n}$ such that $A_{i}=\bigcap_{n \in \omega} B_{i, n}$ for every $i \in I$. For every $i \in I$ we put $F_{i}=\overline{A_{i}}$. Clearly, the family ( $F_{i}: i \in I$ ) is locally finite and the set $F=\bigcup_{i \in I} F_{i}$ is closed in $X$. For every $x \in F$ we put $I(x)=\left\{i \in I: x \in F_{i}\right\}$ and $n(x)=|I(x)|$. Moreover, $K_{n}=\left\{x \in F_{I(x)}: n(x)>n\right\}$ for every $n \in \omega$. Since $\left(F_{i}: i \in I\right)$ is locally finite, every set $K_{n}$ is closed. We consider the set $C=F \backslash A$ and show that $C$ is an $F_{\sigma}$-set.

For every $n \in \omega$ we put

$$
\begin{gathered}
C_{n}=\{x \in C:|n(x)|=n\} \\
\mathcal{J}_{n}=\{J \subseteq I:|J|=n\}
\end{gathered}
$$

and

$$
C_{J, n}=\left\{x \in C_{n}: I(x)=J\right\}
$$

for every $J \in \mathcal{J}_{n}$. Show that every family $\mathcal{C}_{n}=\left(C_{J, n}: J \in \mathcal{J}_{n}\right)$ is locally finite. Fix $x \in X$ and choose a neighborhood $U$ of $x$ in $X$ such that the set $I_{1}=\{i \in I$ : $\left.U \cap F_{i} \neq \emptyset\right\}$ is finite. Then

$$
\mathcal{I}_{1}=\left\{J \in \mathcal{J}_{n}: U \cap C_{J, n} \neq \emptyset\right\} \subseteq\left\{J \in \mathcal{J}_{n}: J \subseteq I_{1}\right\}
$$

Therefore, $\mathcal{I}_{1}$ is finite and $\mathcal{C}_{n}$ is locally finite. Now show that

$$
C_{J, n}=\left(\bigcap_{i \in J} F_{i}\right) \backslash\left(K_{n} \cup \bigcup_{i \in J} A_{i}\right)
$$

for every $n \in \omega$ and $J \in \mathcal{J}_{n}$. Since $C_{J, n} \subseteq \bigcap_{i \in J} F_{i}$ and $C_{J, n} \cap\left(K_{n} \cup \bigcup_{i \in J} A_{i}\right)=\emptyset$, $C_{J, n} \subseteq\left(\bigcap_{i \in J} F_{i}\right) \backslash\left(K_{n} \cup \bigcup_{i \in J} A_{i}\right)$. Conversely, let $x \in \bigcap_{i \in J} F_{i}, x \notin K_{n}$ and $x \notin \bigcup_{i \in J} A_{i}$. Then $n(x) \geq|J|=n$ and $n(x) \leq n$. Therefore, $n(x)=n$ and $I(x)=J$. Thus, $x \notin F_{i}$ for every $i \in I \backslash J$. Hence,

$$
x \notin\left(\bigcup_{i \in J} A_{i}\right) \bigcup\left(\bigcup_{i \in I \backslash J} F_{i}\right) \supseteq A
$$

Since $\bigcap_{i \in J} F_{i}$ and $K_{n}$ are closed and $\bigcup_{i \in J} A_{i}$ is a $G_{\delta}$-set, the $C_{J, n}$ is a $F_{\sigma}$-set. Therefore, every $C_{n}$ is an $F_{\sigma}$-set as a locally finite union of $F_{\sigma}$-sets. Thus, $C$ is an $F_{\sigma}$-set too.

Assume that Lemma is true for all $\alpha<\beta$ where $\beta \geq 1$ is an at most countable ordinal. Let $\left(A_{i}: i \in I\right)$ be a locally finite family of sets of additive class $\beta$ on $X$. Suppose that $\beta=\alpha+1$ for some $\alpha<\omega_{1}$. Then for every $i \in I$ there exists a sequence $\left(B_{i, n}\right)_{n \in \omega}$ of sets $B_{i, n}$ of multiplicative class $\alpha$ on $X$ such that $A_{i}=\bigcup_{n \in \omega} B_{i, n}$ for every $i \in I$. According to the assumption, every set $B_{n}=\bigcup_{i \in I} B_{i, n}$ belongs to the $\alpha$ 'th multiplicative class in $X$. Therefore, the set $A=\bigcup_{n \in \omega} B_{n}$ belongs to the $\beta^{\prime}$ 'th additive class in $X$.

We consider the case of limit ordinal $\beta$. We choose an increasing sequence of ordinals $\alpha_{n}<\beta$ such that $\sup _{n \in \omega} \alpha_{n}=\beta$. For every $i \in I$ there exists a sequence $\left(B_{i, n}\right)_{n \in \omega}$ of sets $B_{i, n}$ of the multiplicative class $\alpha_{n}$ in $X$ such that $A_{i}=\bigcup_{n \in \omega} B_{i, n}$ for every $i \in I$. Then every set $B_{n}=\bigcup_{i \in I} B_{i, n}$ belongs to the $\alpha$ 'th multiplicative class in $X$ and $A=\bigcup_{n \in \omega} B_{n}$ belongs to the $\beta^{\prime}$ th additive class in $X$.

Now we consider the case of sets of a multiplicative class $\beta \geq 2$. Let $\left(A_{i}: i \in I\right)$ be a locally finite family of sets of the $\beta^{\prime}$ th multiplicative class in $X, \beta=\alpha+1$ for some $\alpha<\omega_{1}$ and $\left(\left(B_{i, n}\right)_{n \in \omega}: i \in I\right)$ be a sequence of families of sets $B_{i, n}$ of additive class $\alpha$ in $X$ such that $A_{i}=\bigcap_{n \in \omega} B_{i, n}$ for every $i \in I$. For every $i \in I$ we put $F_{i}=\overline{A_{i}}$. The family $\left(F_{i}: i \in I\right)$ is locally finite. For every $n \in \omega$ and $i \in I$ we put $A_{i, n}=B_{i, n} \cap F_{i}$. Since $\alpha \geq 1$, every set $A_{i, n}$ belongs to the $\alpha$ 'th additive class. Then every set $B_{n}=\bigcup_{i \in I} A_{i, n}$ belongs to the $\alpha$ 'th additive class and $A=\bigcup_{n \in \omega} B_{n}$.

For a limit ordinal $\beta$ we argue analogously.
The following results can be proved similarly as the corresponding results from the previous section.

Theorem 4.2. Let $X$ be a topological space, $Y$ be a perfect space and $Z$ be a perfectly normal space, $\alpha$ be an at most countable ordinal, $\left(\mathcal{A}_{n}\right)_{n=1}^{\infty}$ be a sequence of $\sigma$-locally finite covers $\mathcal{A}_{n}=\left(A_{i, n}: i \in I_{n}\right)$ of $X$ by sets $A_{i, n}$ of additive class $\alpha$ on $X,\left(\left(x_{i, n}: i \in I_{n}\right)\right)_{n=1}^{\infty}$ be a sequence of families of points $x_{i, n} \in X$ and $F: X \times Y \rightarrow Z$ be a compact-valued (multivalued) map satisfying the conditions

1) for every $x \in X$, for every $y \in Y$ and for every sequence $\left(i_{n}\right)_{n \in \omega}$ of indexes $i_{n} \in I_{n}$ with $x \in A_{i_{n}, n}$ the sequence $\left(F\left(x_{i_{n}, n}, y\right)\right)_{n \in \omega}$ converges to $F(x, y)$ with respect the Vietoris topology;
2) $F^{x} \in \mathrm{~L}_{\alpha}(Y, Z)\left(F^{x} \in \mathrm{U}_{\alpha}(Y, Z)\right)$ for every $x \in D=\left\{x_{i, n}: n \in \mathbb{N}, i \in I_{n}\right\}$.

Then $F \in \mathrm{U}_{\alpha+1}(X \times Y, Z)\left(F \in \mathrm{~L}_{\alpha+1}(X \times Y, Z)\right)$.
Corollary 4.3. Let $X$ be a PP-space, $Y$ be a perfect space, $Z$ be a perfectly normal spaces and $\alpha$ be an at most countable ordinal. Then $\mathrm{CU}_{\alpha}(X, Y, Z) \subseteq \mathrm{L}_{\alpha+1}(X \times Y, Z)$ and $\mathrm{CL}_{\alpha}(X, Y, Z) \subseteq \mathrm{U}_{\alpha+1}(X \times Y, Z)$.

Corollary 4.4. Let $X$ be a strong PP-space, $Y$ and $Z$ be topological spaces and $\alpha$ be an at most countable ordinal. Then $\mathrm{C}_{\alpha}(X, Y, Z) \subseteq \mathrm{L}_{\alpha+1}(X \times Y, Z)$ and $\mathrm{C} \overline{\mathrm{L}}_{\alpha}(X, Y, Z) \subseteq \mathrm{U}_{\alpha+1}(X \times Y, Z)$.

Remark 4.5. Since every metrizable space is a strong PP-space, Theorem 4.2 generalizes Theorem 1.2. Moreover, Theorem 4.2 generalizes Theorem 1.1 (it is enough to argue analogously as in Remark 3.4).

The following example shows that the condition of map to be compact-valued is essential in Theorems 3.3 and 4.2 .

Proposition 4.6. There exists a separately continuous lower semi-continuous map $F:[0,1]^{2} \rightarrow[0,1]$ which is upper (functionally) nonmeasurable.
Proof. Let $A \subseteq[0,1]$ be a non-measurable set. We consider a continuous function $g:[0,1]^{2} \rightarrow[0,1], g(x, y)=\frac{2(x+1)(y+1)}{(x+1)^{2}+(y+1)^{2}}$, and a multivalued maps $F:[0,1]^{2} \rightarrow$ $[0,1]$,

$$
F(x, y)= \begin{cases}{[0, g(x, y)],} & (x, y) \in[0,1]^{2} \backslash\{(z, z): z \in A\} \\ {[0,1),} & (x, y) \in\{(z, z): z \in A\}\end{cases}
$$

We put $\Delta=\{(x, x): x \in[0,1]\}$. Since the function $g$ is continuous, the map $F$ is separately continuous at every point of the set $[0,1]^{2} \backslash\{(z, z): z \in A\}$ and jointly continuous at every point of the set $[0,1]^{2} \backslash \Delta$. Since the map $H(x, y)=[0, g(x, y)]$ is continuous and $H^{-}(G)=F^{-}(G)$ for every open set $G \subseteq[0,1]$, the map $F$ is lower semi-continuous. Moreover, $F(x, y) \subseteq[0,1) \subseteq F(z, z)$ for every $(x, y) \in$ $[0,1]^{2} \backslash \Delta$ and $z \in[0,1]$. Therefore, $F$ is separately upper semi-continuous at every point of the set $\Delta$. Thus, $F$ is a separately continuous lower semi-continuous map. According to Example 2.5, the restriction $\left.F\right|_{\Delta}$ is upper nonmeasurable. Hence, $F$ is upper nonmeasurable too.
