# A model theoretic Rieffel's theorem of quantum 2 -torus

#### Abstract

We defined a notion of quantum 2-torus $T_{\theta}$ in [1] and studied its model theoretic property. In this note we associate quantum 2-tori $T_{\theta}$ with the structure over $\mathbb{C}_{\theta}=\left(\mathbb{C},+, \cdot, y=x^{\theta}\right)$, where $\theta \in \mathbb{R} \backslash \mathbb{Q}$, and introduce the notion of geometric isomorphisms between such quantum 2-tori.

We show that this notion is closely connected with the fundamental notion of Morita equivalence of non-commutative geometry. Namely, we prove that the quantum 2-tori $T_{\theta_{1}}$ and $T_{\theta_{2}}$ are Morita equivalent if and only if $\theta_{2}=\frac{a \theta_{1}+b}{c \theta_{1}+d}$ for some $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z})$ with $|a d-b c|=$ 1. This is our version of Rieffel's Theorem [3] which characterises Morita equivalence of quantum tori in the same terms.

The result in essence confirms that the representation $T_{\theta}$ in terms of model-theoretic geometry [1] is adequate to its original definition in terms of non-commutative geometry.


## 1 Introduction

We introduce the notion of geometric transformation from a quantum 2 -torus into another which fixes the underlying field structure and gives a one-to-one correspondence between the canonical bases of the

[^0]modules constituting the quantum 2-tori. When there is a geometric transformation, say $L$, from $T_{1}$ to $T_{2}$. In this case we say that the quantum 2-tori $T_{1}$ and $T_{2}$ are geometrically isomorphic.

Our main result establishes a direct correspondence between the notion of geometric isomorphism of tori and the well-known notion of Morita equivalence of quantum 2-tori given in terms of their "coordinate" algebras.

Recall that two algebras $A$ and $B$ are said to be Morita equivalent if the categories $A$-mod and $B$-mod of modules are equivalent.

For quantum tori this notion was studied by M.Rieffel and in the particular case of 2-tori we have the following

Theorem 1 (Rieffel [3]) Let $A_{\theta_{1}}$ and $A_{\theta_{2}}$ be (the coordinate algebras of) quantum 2-tori Tori. Then $A_{\theta_{1}}$ and $A_{\theta_{2}}$ are Morita equivalent if and only if there exist integers $a, b, c, d$ such that $a d-b c= \pm 1$ and $\theta_{2}=\frac{a \theta_{1}+b}{c \theta_{1}+d}$.

We also say in this case that the quantum 2-tori $T_{\theta_{1}}$ and $T_{\theta_{2}}$ are Morita equivalent.

In section 4 we prove Theorem 12 stating that: $T_{\theta_{1}}$ and $T_{\theta_{2}}$ are Morita equivalent if and only if $T_{\theta_{1}}$ and $T_{\theta_{2}}$ are geometrically isomorphic.

Of course, in light of Rieffel's theorem it is enough to prove that the geometric isomorphism of $T_{\theta_{1}}$ and $T_{\theta_{2}}$ amounts to the condition
$\theta_{2}=\frac{a \theta_{1}+b}{c \theta_{1}+d}$ for some $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z})$ with $|a d-b c|=1$.
In section 2 we review quickly the construction of quantum 2-tori defined in [1]. In section 3, we introduce the notion of Morita transformation and Morita equivalence and prove basic properties. In section 4, we characterise the property of functions giving rise to Morita transformations and prove Theorem 12.

## 2 Quick review of the construction of a quantum 2-torus

Let $\theta \in \mathbb{R} \backslash \mathbb{Q}$ and put $q=\exp (2 \pi i \theta)$. Let $\mathbb{C}^{*}=\mathbb{C} \backslash\{0\}$. Consider a $\mathbb{C}^{*}$-algebra $\mathcal{A}_{q}$ generated by operators $U, U^{-1}, V, V^{-1}$ satisfying

V U=q_{1} U V, \quad U U^{-1}=U^{-1} U=V V^{-1}=V^{-1} V=I .
$$

Let $\Gamma_{\theta}=q^{\mathbb{Z}}=\left\{q^{n}: n \in \mathbb{Z}\right\}$ be a cyclic multiplicative subgroup of $\mathbb{C}^{*}$. From now on in this note we work in an uncountable $\mathbb{C}$-module $\mathcal{M}$ such that $\operatorname{dim} \mathcal{M} \geq|\mathbb{C}|$.

## $2.1 \quad \Gamma$-sets, $\Gamma$-bundles, line-bundles

For each pair $(u, v) \in \mathbb{C}^{*} \times \mathbb{C}^{*}$, we will construct two $\mathcal{A}_{q}$-modules $M_{|u, v\rangle}$ and $M_{\langle v, u|}$ so that both $M_{|u, v\rangle}$ and $M_{\langle v, u|}$ are sub-modules of $\mathcal{M}$.

The module $M_{|u, v\rangle}$ is generated by linearly independent elements labelled $\left\{\mathbf{u}(\gamma u, v) \in \mathcal{M}: \gamma \in \Gamma_{\theta}\right\}$ satisfying

$$
\begin{align*}
& U: \mathbf{u}(\gamma u, v) \mapsto \gamma u \mathbf{u}(\gamma u, v), \\
& V: \mathbf{u}(\gamma u, v) \mapsto v \mathbf{u}\left(q^{-1} \gamma u, v\right) . \tag{1}
\end{align*}
$$

Next let $\phi: \mathbb{C}^{*} / \Gamma_{\theta} \rightarrow \mathbb{C}^{*}$ such that $\phi\left(x \Gamma_{\theta}\right) \in x \Gamma_{\theta}$ for each $x \Gamma_{\theta} \in$ $\mathbb{C}^{*} / \Gamma_{\theta}$. Put $\Phi=\operatorname{ran}(\phi)$. We call $\phi$ a choice function and $\Phi$ the system of representatives.

Set for $\langle u, v\rangle \in \Phi^{2}$

\Gamma \cdot \mathbf{u}(u, v) & :=\left\{\gamma \mathbf{u}(u, v): \gamma \in \Gamma_{\theta}\right\}, \\
\mathbf{U}_{\langle u, v\rangle} & :=\bigcup_{\gamma \in \Gamma_{\theta}} \Gamma_{\theta} \cdot \mathbf{u}(\gamma u, v)=\left\{\gamma_{1} \cdot \mathbf{u}\left(\gamma_{2} u, v\right): \gamma_{1}, \gamma_{2} \in \Gamma_{\theta}\right\} . \tag{2}
\end{array}
$$

And set

$$
\begin{align*}
\mathbf{U}_{\phi} & :=\bigcup_{\langle u, v\rangle \in \Phi^{2}} \mathbf{U}_{\langle u, v\rangle} \\
& =\left\{\gamma_{1} \cdot \mathbf{u}\left(\gamma_{2} u, v\right):\langle u, v\rangle \in \Phi^{2}, \gamma_{1} \cdot \gamma_{2} \in \Gamma_{\theta}\right\},  \tag{3}\\
\mathbb{F}^{*} \mathbf{U}_{\phi_{1}} & :=\left\{x \cdot \mathbf{u}(\gamma u, v):\langle u, v\rangle \in \Phi^{2}, x \in \mathbb{F}^{*}, \gamma \in \Gamma_{\theta}\right\} .
\end{align*}
$$

We call $\Gamma \cdot \mathbf{u}(u, v)$ a $\Gamma$-set over the pair $(u, v), \mathbf{U}_{\phi}$ a $\Gamma$-bundle over $\mathbb{C}^{*} \times \mathbb{C}^{*} / \Gamma$, and $\mathbb{C}^{*} \mathbf{U}_{\phi}$ a line-bundle over $\mathbb{C}^{*}$. Notice that $\mathbf{U}_{\phi}$ can also be seen as a bundle inside $\bigcup_{\langle u, v\rangle} M_{|u, v\rangle}$. Noticee also that the line bundle $\mathbb{C}^{*} \mathbf{U}_{\phi}$ is closed under the action of the operators $U$ and $V$ satisfying the relations (1).

We define the module $M_{\langle v, u|}$ generated by linearly independent elements labelled $\{\mathbf{v}(\gamma v, u) \in \mathcal{M}: \gamma \in \Gamma\}$ satisfying

U & : \quad \mathbf{v}(\gamma v, u) \mapsto u \mathbf{v}(q \gamma v, u) \\
V & : \mathbf{v}(\gamma v, u) \mapsto \gamma v \mathbf{v}(\gamma v, u) \tag{4}
\end{align*}

and also

$$
\begin{align*}
U^{-1} & : \mathbf{u}(\gamma u, v) \mapsto \gamma^{-1} u^{-1} \mathbf{u}(\gamma u, v) \\
V^{-1} & : \mathbf{u}(\gamma u, v) \mapsto v^{-1} \mathbf{u}(q \gamma u, v) \tag{5}
\end{align*}
$$

Similarly a $\Gamma$-set $\Gamma \cdot \mathbf{v}(v, u)$ over the pair $(v, u)$, a $\Gamma$-bundle $\mathbf{V}_{\phi}$ over $\mathbb{C}^{*} / \Gamma \times \mathbb{C}^{*}$, and $\mathbb{C}^{*} \mathbf{V}_{\phi}$ a line-bundle over $\mathbb{C}^{*}$ are defined.

To define the line bundles $\mathbb{C}^{*} \mathbf{U}_{\phi}$ and $\mathbb{C}^{*} \mathbf{V}_{\phi}$, we do not need any particular properties of the element $q=\exp (2 \pi i \theta)$ or the choice function $\phi$. Therefore we have:

Proposition 2 (Proposition $2[1]$ ) Let $\mathbb{F}, \mathbb{F}^{\prime}$ be fields and $q \in \mathbb{F}$, $q^{\prime} \in \mathbb{F}^{\prime}$ such that there is an field isomorphism $i$ from $\mathbb{F}$ to $\mathbb{F}^{\prime}$ sending $q$ to $q^{\prime}$. Then $i$ can be extended to an isomorphism from the $\Gamma$-bundle $\mathbf{U}_{\phi}$ to the $\Gamma^{\prime}$-bundle $\mathbf{U}_{\phi^{\prime}}$ and also from the line-bundle $\mathbb{F}^{*} \mathbf{U}_{\phi}$ to the line-bundle $\left(\mathbb{F}^{*}\right)^{\prime} \mathbf{U}_{\phi^{\prime}}$. The same is true for the line-bundles $\mathbb{F}^{*} \mathbf{V}_{\phi}$ and $\left(\mathbb{F}^{\prime}\right)^{*} \mathbf{V}_{\phi^{\prime}}$.

In particular the isomorphism type of $\Gamma$-bundles and line-bundles does not depend on the choice function.

Proof: Let $i$ be an isomorphism from $\mathbb{F}$ to $\mathbb{F}^{\prime}$ sending $q$ to $q^{\prime}$. Set $i(x \cdot \mathbf{u}(\gamma u, v))=i(x) \cdot \mathbf{u}(i(\gamma u), i(v))$. Then this defines an isomorphism from $\mathbb{F}^{*} \mathbf{U}_{\phi}$ to $\left(\mathbb{F}^{\prime}\right)^{*} \mathbf{U}_{\phi^{\prime}}$.

### 2.2 Pairing function

Recall next the notion of pairing function $\langle\cdot \mid \cdot\rangle$ which plays the rôle of an inner product of two $\Gamma$-bundles $\mathbf{U}_{\phi}$ and $\mathbf{V}_{\phi}$ :

\begin{equation*}
\langle\cdot \mid \cdot\rangle:\left(\mathbf{V}_{\phi} \times \mathbf{U}_{\phi}\right) \cup\left(\mathbf{U}_{\phi} \times \mathbf{V}_{\phi}\right) \rightarrow \Gamma \tag{6}
\end{equation*}
$$

having the following properties:

1. $\langle\mathbf{u}(u, v) \mid \mathbf{v}(v, u)\rangle=1$,
2. for each $r, s \in \mathbb{Z},\left\langle U^{r} V^{s} \mathbf{u}(u, v) \mid U^{r} V^{s} \mathbf{v}(v, u)\right\rangle=1$,
3. for $\gamma_{1}, \gamma_{2}, \gamma_{3}, \gamma_{4} \in \Gamma$,

$$
\left\langle\gamma_{1} \mathbf{u}\left(\gamma_{2} u, v\right) \mid \gamma_{3} \mathbf{v}\left(\gamma_{4} v, u\right)\right\rangle=\left\langle\gamma_{3} \mathbf{v}\left(\gamma_{4} v, u\right) \mid \gamma_{1} \mathbf{u}\left(\gamma_{2} u, v\right)\right\rangle
$$

4. $\left\langle\gamma_{1} \mathbf{u}\left(\gamma_{2} u, v\right) \mid \gamma_{3} \mathbf{v}\left(\gamma_{4} v, u\right)\right\rangle=\gamma_{1}^{-1} \gamma_{3}\left\langle\mathbf{u}\left(\gamma_{2} u, v\right) \mid \mathbf{v}\left(\gamma_{4} v, u\right)\right\rangle$, and
5. for $v^{\prime} \notin \Gamma \cdot v$ or $u^{\prime} \notin \Gamma \cdot u,\left\langle q^{s} \mathbf{v}\left(v^{\prime}, u\right) \mid q^{r} \mathbf{u}\left(u^{\prime}, v\right)\right\rangle$ is not defined.

Proposition 3 (Proposition 3 [1]) The pairing function (6) defined above satisfies the following: for any $m, k, r, s \in \mathbb{N}$ we have

\left\langle q^{s} \mathbf{v}\left(q^{m} v, u\right) \mid q^{r} \mathbf{u}\left(q^{k} u, v\right)\right\rangle=q^{r-s-k m} \tag{7}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\langle q^{r} \mathbf{u}\left(q^{k} u, v\right) \mid q^{s} \mathbf{v}\left(q^{m} v, u\right)\right\rangle=q^{k m+s-r}=\left\langle q^{s} \mathbf{v}\left(q^{m} v, u\right) \mid q^{r} \mathbf{u}\left(q^{k} u, v\right)\right\rangle^{-1} \tag{8}
\end{equation*}
$$

We call the three sorted structure $\left\langle\mathbf{U}_{\phi}, \mathbf{V}_{\phi},\langle\cdot \mid \cdot\rangle\right\rangle$ a quantum 2torus and denoted by $T_{\theta}$.

From Propositon 2 we know that the structure of the line-bundles does not depend on the choice function. The next proposition tells us that the structure of the quantum 2 -torus $T_{q}^{2}(\mathbb{C})$ depends only on $\mathbb{C}$, $q$ and not on the choice function.

Proposition 4 (cf. Proposition 4.4, [5]) Given $q \in \mathbb{F}^{*}$ not a root of unity, any two structures of the form $T_{q}^{2}(\mathbb{F})$ are isomorphic over $\mathbb{F}$. In other words, the isomorphism type of $T_{q}^{2}(\mathbb{F})$ does not depend on the system of representatives $\Phi$.

## 3 Geometrically isomorphic quantum 2-tori

From now on we work in the structure $\mathbb{C}^{\theta}=\left(\mathbb{C},+, \cdot, 1, x^{\theta}\right)$ (raising to real power $\theta$ in the complex numbers).

We define

$$
x^{\theta}=\exp (\theta \cdot(\ln x+2 \pi i \mathbb{Z}))=\{\exp (\theta \cdot(\ln x+2 \pi i k)): k \in \mathbb{Z}\} .
$$

as a multi-valued function and by $y=x^{\theta}$ we mean the relation $\exists z(x=$ $\exp (z) \wedge y=\exp (z \theta))$.

Notation $5 C_{\theta}(x, y)$ denotes the binary relation $y=x^{\theta}$ as defined above.

Let $\theta_{1}, \theta_{2} \in \mathbb{R} \backslash \mathbb{Q}$. Set $q_{1}=\exp \left(2 \pi i \theta_{1}\right)$ and $q_{2}=\exp \left(2 \pi i \theta_{2}\right)$. Put $\Gamma_{q_{1}}=\left\langle q_{1}\right\rangle$ and $\Gamma_{q_{2}}=\left\langle q_{2}\right\rangle$.

Let $\Phi_{1}$ be the system of representatives for a choice function $\phi_{1}$ : $\mathbb{C}^{*} / \Gamma_{q_{1}} \rightarrow \mathbb{C}^{*}$. Let $T_{q_{2}}$ be quantum 2-tori constructed as explainde in the previous section.

Suppose $(u, v) \in\left(\Phi_{1}\right)^{2}$. We identify the modules $M_{|u, v\rangle}$ constitutes the quantum 2-torus $T_{q_{1}}$ with its canonical basis denoted by $E_{|u, v\rangle}$. Put

$$
E_{|u, v\rangle}=\left\{q^{n l} \mathbf{u}\left(q^{n} u, v\right): l, n \in \mathbb{Z}\right\}
$$

We see the $\Gamma_{q_{1}}$-bundle $\mathbf{U}_{\phi_{1}}$ as a bundle inside $\bigcup_{(u, v) \in\left(\Phi_{1}\right)^{2}} M_{|u, v\rangle}$. Thus knowing the set of bases of $\mathbf{U}_{\phi_{1}}$ that is the set $\bigcup_{(u, v) \in\left(\Phi_{1}\right)^{2}} E_{|u, v\rangle}$, we can determine the quantum 2-torus $T_{q_{1}}$ which we denote $T_{\theta_{1}}$.

Let $\Phi_{2}$ be the system of representatives for a choice function $\phi_{2}$ : $\mathbb{C}^{*} / \Gamma_{q_{2}} \rightarrow \mathbb{C}^{*}$. Let $T_{q_{2}}$ be quantum 2-tori constructed as explainde in the previous section.

We define a similar set $E_{\left|u^{\prime}, v^{\prime}\right\rangle}$ which is a canonical basis for $M_{\left|u^{\prime}, v^{\prime}\right\rangle}$ where $\left(u^{\prime}, v^{\prime}\right) \in\left(\Phi_{2}\right)^{2}$ and the set $\bigcup_{\left(u^{\prime}, v^{\prime}\right) \in\left(\Phi_{2}\right)^{2}} E_{\left|u^{\prime}, v^{\prime}\right\rangle}$ determines the quantum 2 -torus $T_{q_{2}}$ which we denote $T_{\theta_{2}}$.

We now introduce the notion called Morita equivalence between quantum 2-tori.

Definition 6 Let $a, b \in \mathbb{C}^{*}$.
(1) We say that $C_{\theta}$ sends the coset $a \cdot \Gamma_{q_{1}}$ of $\Gamma_{q_{1}}$ to the coset $b \cdot \Gamma_{q_{2}}$ of $\Gamma_{q_{2}}$ if

$$
\forall x^{\prime} \in a \cdot \Gamma_{q_{1}} \forall y^{\prime} \in \mathbb{C}^{*}\left(y^{\prime} \in b \cdot \Gamma_{q_{2}} \Longleftrightarrow C_{\theta}\left(x^{\prime}, y^{\prime}\right)\right) .
$$

(2) We say that $C_{\theta}$ sends the cosets of $\Gamma_{q_{1}}$ to the cosets of $\Gamma_{q_{2}}$ if $C_{\theta}$ gives rise to a one-to-one correspondence from the cosets of $\Gamma_{q_{1}}$ to the cosets of $\Gamma_{q_{2}}$.

Definition 7 (Geometric isomorphism) We say that the quantum 2-torus $T_{\theta_{1}}$ is geometrically isomorphic to $T_{\theta_{2}}$, written $T_{\theta_{1}} \simeq{ }_{\theta} T_{\theta_{2}}$, if
(1) $C_{\theta}$ sends the cosets of $\Gamma_{q_{1}}$ to the cosets of $\Gamma_{q_{2}}$, and
(2) there is a one-to-one correspondence $L_{\theta}$ from $\bigcup_{\langle u, v\rangle} E_{|u, v\rangle}$ to $\bigcup_{\left\langle u^{\prime}, v^{\prime}\right\rangle} E_{\left|u^{\prime}, v^{\prime}\right\rangle}$ such that for each $(u, v) \in\left(\Phi_{1}\right)^{2}$ and $\left(u^{\prime}, v^{\prime}\right) \in$ $\left(\Phi_{2}\right)^{2}$ satisfying $C_{\theta}\left(u, u^{\prime}\right)$ and $C_{\theta}\left(v, v^{\prime}\right)$ we have

$$
\left.L_{\theta}\left(q_{1}^{n l} \mathbf{u}\left(q_{1}^{n} u, v\right)\right)=q_{2}^{n l} \mathbf{u}\left(q_{2}^{n} u^{\prime}, v^{\prime}\right)\right) .
$$

We call $L_{\theta}$ a geometric transformation from $\bigcup_{\langle u, v\rangle} E_{|u, v\rangle}$ to $\bigcup_{\left\langle u^{\prime}, v^{\prime}\right\rangle} E_{\left|u^{\prime}, v^{\prime}\right\rangle}$ and we simply write as

$$
L_{\theta}: E_{|u, v\rangle} \mapsto E_{\left|u^{\prime}, v^{\prime}\right\rangle} .
$$

For a geometric transformation $L_{\theta}$, we have the following diagrams, for each $(u, v) \in\left(\Phi_{1}\right)^{2}$ and $\left(u^{\prime}, v^{\prime}\right) \in\left(\Phi_{2}\right)^{2}$ :

and


Conversely, the existence of such diagrams is sufficient for $L_{\theta}$ to be a geometric transformation.

Remark. Note that for corresponding $(u, v) \in\left(\Phi_{1}\right)^{2}$ and $\left(u^{\prime}, v^{\prime}\right) \in$ $\left(\Phi_{2}\right)^{2}$ such diagram to exist it is enough to have isomorphism between the groups $\Gamma_{q_{1}}$ and $\Gamma_{q_{2}}$. This is clearly the case when $q_{1}$ and $q_{2}$ are of infinite order.

In order to show that a geometric transformation gives rise to a geometric isomorphism between quantum 2-tori, we need to show that it preserves the values of pairing functions $\langle\cdot \mid \cdot\rangle_{\theta_{1}}$ in $T_{\theta_{1}}$ and and the pairing function $\langle\cdot \mid \cdot\rangle_{\theta_{2}}$ in $T_{\theta_{2}}$.

Lemma 8 A geometric transformation preserves the values of paring functions $\langle\cdot \mid \cdot\rangle_{\theta_{1}}$ and $\langle\cdot \mid \cdot\rangle_{\theta_{2}}$. More precisely we have;

$$
L_{\theta}\left(\langle\cdot \mid \cdot\rangle_{\theta_{1}}\right)=\left\langle L_{\theta}(\cdot) \mid L_{\theta}(\cdot)\right\rangle_{\theta_{2}} .
$$

Proof: We show that the five properties of pairing function are preserved by geometric transformation.
1.

2. It suffices to note that we have for each $r, s \in \mathbb{Z}$,

$$
L_{\theta}\left(U^{r} V^{s} \mathbf{u}(u, v)\right)=U^{r} V^{s}\left(L_{\theta}(\mathbf{u}(u, v))\right)=U^{r} V^{s}\left(\mathbf{u}\left(u^{\prime}, v^{\prime}\right)\right)
$$

and the same equation for $\mathbf{v}(v, u)$.
3., 4., 5 ., are proved by similar computations.

Knowing the modules $M_{|u, v\rangle}$ for each $(u, v) \in\left(\Phi_{1}\right)^{2}$ and the modules $M_{\left|u^{\prime}, v^{\prime}\right\rangle}$ for each $\left(u^{\prime}, v^{\prime}\right) \in\left(\Phi_{2}\right)^{2}$ we can determine the structure of quantun 2-tori $T_{\theta_{1}}$ and $T_{\theta_{2}}$. Thus we have

Lemma 9 A geometric transformation from $\bigcup_{(u, v) \in\left(\Phi_{1}\right)^{2}} E_{|u, v\rangle}$ to $\bigcup_{\left(u^{\prime}, v^{\prime}\right) \in\left(\Phi_{2}\right)^{2}} E_{\left|u^{\prime}, v^{\prime}\right\rangle}$ induces a geometric isomorphism between $T_{\theta_{1}}$ and $T_{\theta_{2}}$.

## 4 Relations giving rise to geometric transformations

Proposition 10 For each $\left(\begin{array}{ll}m_{11} & m_{12} \\ m_{21} & m_{22}\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z})$, the binary relation

$$
C_{\Theta}(x, y), \quad \Theta=\frac{m_{11} \theta+m_{12}}{m_{21} \theta+m_{22}}
$$

corresponding to

$$
y=x^{\frac{m_{11} \theta+m_{12}}{m_{21} \theta+m_{22}}}
$$

is positive quantifier-free definable in the structure $\mathbb{C}_{\theta}$.
Proof: Observe the following immediate equivalences:

- $y=x^{m \theta} \equiv C_{\theta}\left(x^{m}, y\right)$
- $y=x^{m \theta+n} \equiv C_{\theta}\left(x^{m}, y x^{-n}\right)$
- $y=x^{\frac{1}{\theta}} \equiv C_{\theta}(y, x)$
- $y=x^{\frac{1}{m \theta+n}} \equiv x=y^{m \theta+n} \equiv C_{\theta}\left(y^{m}, x y^{-n}\right)$

It follows

$$
\begin{aligned}
y=x^{\frac{m_{11} \theta+m_{12}}{m_{21} \theta+m_{22}}} & \equiv y^{m_{21} \theta+m_{22}}=x^{m_{11} \theta+m_{12}} \\
& \equiv\left(y^{m_{21}} x^{-m_{11}}\right)^{\theta}=x^{m_{12}} y^{-m_{22}} \\
& \equiv C_{\theta}\left(y^{m_{21}} x^{-m_{11}}, x^{m_{12}} y^{-m_{22}}\right)
\end{aligned}
$$

Lemma 11 Suppose that $C_{\theta}$ sends the cosets of $\Gamma_{q_{1}}$ to the cosets of $\Gamma_{q_{2}}$. Then there is a geometric transformation from $T_{\theta_{1}}$ to $T_{\theta_{2}}$, hence we have $T_{\theta_{1}} \simeq_{\theta} T_{\theta_{2}}$.

Proof: Once we know the correspondence between the cosets of $\Gamma_{q_{1}}$ and the cosets of $\Gamma_{q_{2}}$, by the remark above we can define a geometric transformation $L_{\theta}$ from $T_{\theta_{1}}$ to $T_{\theta_{2}}$, and we have $T_{\theta_{1}} \simeq{ }_{\theta} T_{\theta_{2}}$

### 4.1 Main theorem

We now show the main theorem.
Theorem 12 Let $\theta_{1}, \theta_{2} \in \mathbb{R} \backslash \mathbb{Q}$. Then $T_{\theta_{1}} \simeq_{\theta} T_{\theta_{2}}$ if and only if $\theta_{2}=\frac{a \theta_{1}+b}{c \theta_{1}+d}$ for some $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z})$ with $|a d-b c|=1$.

Proof: By Lemma $11 T_{\theta_{1}} \simeq_{\theta} T_{\theta_{2}}$ if and only if $C_{\theta}$ sends cosets of $\Gamma_{q_{1}}$ to $\Gamma_{q_{2}}$. In particular, $C_{\theta}$ induces a group isoomorphism $\Gamma_{q_{1}}=\left\langle q_{1}\right\rangle$ to $\Gamma_{q_{2}}=\left\langle q_{2}\right\rangle:$
$\exp \left(2 \pi i\left(\mathbb{Z} \theta_{1}+\mathbb{Z}\right)\right) \stackrel{\theta}{\longmapsto} \exp \left(2 \pi i\left(\left(\mathbb{Z} \theta_{1}+\mathbb{Z}\right) \theta\right)\right)=\exp \left(2 \pi i\left(\mathbb{Z} \theta_{2}+\mathbb{Z}\right)\right)$.
The isomorphism is completely determind by the images of $q_{1}=$ $\exp \left(2 \pi i \theta_{1}\right)$ and 1 both in $\Gamma_{q_{1}}$. Thus it suffices to know the images of $\theta_{1}$ and 1 by this isomorphism i.e., multiplication by $\theta$. Hence we have


It follows that

$$
\begin{equation*}
\theta=\frac{a \theta_{2}+b}{\theta_{1}}=c \theta_{2}+d . \tag{9}
\end{equation*}
$$

Solving for $\theta_{2}$ we get

$$
\begin{equation*}
\theta_{2}=\frac{d \theta_{1}-b}{-c \theta_{1}+a} \tag{10}
\end{equation*}
$$

Since $|a d-b c|=1$ we have

$$
\left(\begin{array}{cc}
d & -b \\
-c & a
\end{array}\right)= \pm\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right)^{-1} \in \mathrm{GL}_{2}(\mathbb{Z})
$$

And this complets the proof.
