# TORSION TABLE FOR THE LIE ALGEBRA $\operatorname{nil}_{n}$

#### Abstract

We study the Lie ring $\mathfrak{n i l}_{n}$ of all strictly upper-triangular $n \times n$ matrices with entries in $\mathbb{Z}$. Its complete homology for $n \leq 8$ is computed.

We prove that every $p^{m}$-torsion appears in $H_{*}\left(\mathfrak{n i l}_{n} ; \overline{\mathbb{Z}}\right)$ for $p^{m} \leq n-2$. For $m=1$, Dwyer proved that the bound is sharp, i.e. there is no $p$-torsion in $H_{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Z}\right)$ when prime $p>n-2$. In general, for $m>1$ the bound is not sharp, as we show that there is 8 -torsion in $H_{*}\left(\mathfrak{n i l}_{8} ; \mathbb{Z}\right)$.

As a sideproduct, we derive the known result, that the ranks of the free part of $H_{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Z}\right)$ are the Mahonian numbers (=number of permutations of [ $n$ ] with $k$ inversions), using a different approach than Kostant. Furthermore, we determine the algebra structure (cup products) of $H^{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Q}\right)$.


## 1. Introduction

Let $\mathfrak{n i l}_{n}$ be the Lie algebra of integral $n \times n$ strictly upper-triangular matrices. The complete homology $H_{k}\left(\mathfrak{n i l}_{n} ; \mathbb{Z}\right)$ is known only for $n \leq 6$ [4]:

The main reason why computations for larger $n$ are exceedingly difficult is that the chain complex $C_{*}=\Lambda^{*} \mathfrak{n i l}_{n}$ is immense. It has $2^{\binom{n}{2}}$ generators, which is more than 2 million for $n=7$. In the paper, we divide $C_{*}$ in numerous direct summands $\llbracket w \rrbracket$ (corresponding to sequences $w \in\{1, \ldots, n\}^{n}$ with $w_{1}+\ldots+w_{n}=\binom{n+1}{2}$ ) and show how many of them are isomorphic (up to dimension shift), many are contractible

[^0]and many are obtained from smaller ones as the cone of a chain map $\llbracket w^{\prime} \rrbracket \stackrel{\rightharpoonup}{\rightarrow} \llbracket w^{\prime} \rrbracket$. The direct summands corresponding to permutations of $(1, \ldots, n)$ are generated by just one element, hence those contribute only to free part. We show that any other direct summand contributes only to torsion, so we get $H^{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Q}\right)$.

Complex. Let $e_{i j}$ be the matrix with all entries 0 except 1 in the position $(i, j)$. The chain complex $C_{*}=\Lambda^{*} \mathfrak{n i l}_{n}$, due to Chevalley (1948), is generated by wedges $e_{a_{1} b_{1}} \wedge \ldots \wedge e_{a_{k} b_{k}}$, where $1 \leq a_{i}<b_{i} \leq n$ for all $i$. From now on, for the sake of brevity, we shall omit the $\wedge$ symbols. The boundary is defined by

where $\left[e_{a b}, e_{c d}\right]$ equals $e_{a d}$ if $b=c$, equals $-e_{c b}$ if $a=d$, and equals 0 otherwise.
AMT. For some computations later on, we shall use algebraic Morse theory, so we include a short review of it. To a chain complex of free modules $\left(C_{*}, \partial_{*}\right)$ we associate a weighted digraph $\Gamma_{C_{*}}$ (vertices are basis elements of $C_{*}$, weights of edges are nonzero entries of matrices $\partial_{*}$ ). Then we carefully select a matching $\mathcal{M}$ in this digraph, so that its edges have invertible weights and if we reverse the direction of every $e \in \mathcal{M}$ in $\Gamma_{B_{*}}$, the obtained digraph $\Gamma_{C_{*}}^{\mathcal{M}}$ contains no directed cycles and no infinite paths in two adjacent degrees. Under these conditions (i.e. if $\mathcal{M}$ is a Morse matching), the AMT theorem ( [8, [4, [6]) provides a homotopy equivalent complex $\left(\dot{C}_{*}, \partial_{*}\right)$, spanned by the unmatched vertices in $\Gamma_{C_{*}}^{\mathcal{M}}$, and with the boundary $\partial_{*}$ of $v \in \dot{C}_{k}$ given by the sum of weights of directed paths in $\Gamma_{C_{*}}^{\mathcal{M}}$ to all critical $v^{\prime} \in \dot{C}_{k-1}$. For more details, we refer the reader to the three articles above (which specify the homotopy equivalence), or [7] for a quick introduction and formulation.

## 2. SUBCOMPLEXES

For a set $M=\left\{\left(a_{1}, b_{1}\right), \ldots,\left(a_{k}, b_{k}\right)\right\} \subseteq\{(i, j) ; 1 \leq i<j \leq n\}$ we denote $e_{M}=$ $e_{a_{1} b_{1}} \ldots e_{a_{k} b_{k}}$. For $M_{i}:=\{x ;(i, x) \in M\}$ we have $e_{M}=\wedge_{i=1}^{n-1} e_{\{i\} \times M_{i}}$. We define the weight vector $\widetilde{w}\left(e_{M}\right)=\left(\widetilde{w}_{1}, \ldots, \widetilde{w}_{n}\right)$ by $\widetilde{w}_{i}=|\{x ;(x, i) \in M\}|-|\{y ;(i, y) \in M\}|$, i.e. the number of times $i$ appears on the right in $e_{M}$ minus the number of times $i$ appears on the left in $e_{M}$. Then $\sum_{i=1}^{n} \widetilde{w}_{i}=0$. Every summand in $\partial\left(e_{M}\right)$ has the same weight as $e_{M}$. Therefore a submodule $[\widetilde{w}]$ of $\Lambda^{*} \mathfrak{n i l}_{n}$, spanned by the basis elements with weight $\widetilde{w}$, forms a chain subcomplex which is a direct summand.

Most equalities will be described more conveniently using the modified weight $w\left(e_{M}\right)=(1, \ldots, n)-\widetilde{w}\left(e_{M}\right)=\left(1-\widetilde{w}_{1}, \ldots, n-\widetilde{w}_{n}\right)$. Then $\sum_{i=1}^{n} w_{i}=\binom{n+1}{2}$ and $i-n \leq \widetilde{w}_{i} \leq i-1$ implies $1 \leq w_{i} \leq n$ for all $i$. We denote $\llbracket w \rrbracket=[(1, \ldots, n)-w]$ and let $\llbracket w \rrbracket_{k}$ be the complex $\llbracket w \rrbracket$ dimensionally shifted by $k$. Let $\mathcal{S}_{n}:=\left\{\left(w_{1}, \ldots, w_{n}\right) \in\right.$ $\left.\{1, \ldots, n\}^{n} ; w_{1}+\ldots+w_{n}=\binom{n+1}{2}\right\}$, so that $\Lambda^{*} \mathfrak{n i l}_{n}=\bigoplus_{w \in \mathcal{S}_{n}} \llbracket w \rrbracket$. Notice that $\llbracket w_{1}, \ldots, w_{n-1}, n \rrbracket=\llbracket w_{1}, \ldots, w_{n-1} \rrbracket$ and $\llbracket 1, w_{2}, \ldots, w_{n} \rrbracket=\llbracket w_{2}-1, \ldots, w_{n}-1 \rrbracket$.

Example 2.1. Let us take a look at bracket subcomplexes in $\Lambda^{*} \mathfrak{n i l}_{n}$ for $n \leq 4$.
Set $\mathcal{S}_{2}$ consists of permutations of $(1,2)$. Furthermore, there holds $H_{k} \llbracket 1,2 \rrbracket=$ $H_{k}\langle\emptyset\rangle \cong\left\{\begin{array}{l}\mathbb{Z} ; \text { if } k=0 \\ 0 ; \text { if } k \neq 0\end{array}\right.$ and $H_{k} \llbracket 2,1 \rrbracket=H_{k}\left\langle e_{12}\right\rangle \cong\left\{\begin{array}{l}\mathbb{Z} ; \text { if } k=1 \\ 0 ; \text { if } k \neq 1\end{array}\right.$.

Set $\mathcal{S}_{3}$ consists of permutations of $(1,2,3),(2,2,2)$. Furthermore, $H_{k} \llbracket 1,2,3 \rrbracket=$ $H_{k}\langle\emptyset\rangle \cong\left\{\begin{array}{l}\mathbb{Z} ; \text { if } k=0 \\ 0 ; \text { if } k \neq 0\end{array}, H_{k} \llbracket 1,3,2 \rrbracket=H_{k}\left\langle e_{23}\right\rangle \cong\left\{\begin{array}{l}\mathbb{Z} ; \text { if } k=1 \\ 0 ; \text { if } k \neq 1\end{array}, H_{k} \llbracket 2,1,3 \rrbracket=H_{k}\left\langle e_{12}\right\rangle \cong\right.\right.$

$H_{k} \llbracket 3,2,1 \rrbracket=H_{k}\left\langle e_{12} e_{13} e_{23}\right\rangle \cong\left\{\begin{array}{l}\mathbb{Z} \text {; if } k=3 \\ 0 ; \text { if } k \neq 3\end{array}, H_{k} \llbracket 2,2,2 \rrbracket=H_{k}\left\langle e_{13}, e_{12} e_{23}\right\rangle \simeq 0\right.$.
Set $\mathcal{S}_{4}$ consists of permutations of $(1,1,4,4),(1,2,3,4),(1,3,3,3),(2,2,2,4),(2,2,3,3)$. The largest complexes are $\llbracket 3,2,3,2 \rrbracket=\left\langle e_{12} e_{14} e_{24}, e_{13} e_{14} e_{34}, e_{12} e_{14} e_{23} e_{34}, e_{12} e_{13} e_{24} e_{34}\right\rangle$ and $\llbracket 2,3,2,3 \rrbracket=\left\langle e_{14} e_{23}, e_{13} e_{24}, e_{12} e_{23} e_{24}, e_{13} e_{23} e_{34}\right\rangle$, with $\llbracket 3,2,3,2 \rrbracket \cong \llbracket 2,3,2,3 \rrbracket_{1}$. See the final chapter for the complete computation of $H_{*} \mathfrak{n i l}_{4}$.

Lemma 2.2. $\llbracket w_{1}, \ldots, w_{n} \rrbracket \cong \llbracket n+1-w_{n}, \ldots, n+1-w_{1} \rrbracket$.
Proof. Define $\tau\left(e_{a b}\right)=e_{n+1-b, n+1-a}$ and $\tau\left(\wedge_{i=1}^{k} e_{a_{i} b_{i}}\right)=(-1)^{k+1} \wedge_{i=1}^{k} \tau\left(e_{a_{i} b_{i}}\right)$. Now $e_{M} \in \llbracket w_{1}, \ldots, w_{n} \rrbracket$ implies $\tau\left(e_{M}\right) \in \llbracket n+1-w_{n}, \ldots, n+1-w_{1} \rrbracket$, because

From $\left[\tau\left(e_{a b}\right), \tau\left(e_{c d}\right)\right]=-\tau\left(\left[e_{a b}, e_{c d}\right]\right)$, we obtain

& =(-1)^{k} \sum_{i<j}(-1)^{i+j} \tau\left[e_{a_{i} b_{i}}, e_{a_{j} b_{j}}\right] \ldots \widehat{\tau}\left(e_{a_{i} b_{i}}\right) \ldots \widehat{\tau}\left(e_{a_{j} b_{j}}\right) \ldots \\
& =\tau \partial\left(e_{a_{1} b_{1}} \ldots e_{a_{k} b_{k}}\right)

so $\tau$ is a chain map. Since $\tau \circ \tau=\mathrm{id}$, our $\tau$ is an isomorphism of chain complexes.
Lemma 2.3. $\llbracket w_{1}, w_{2}, \ldots, w_{n} \rrbracket \cong \llbracket w_{2}, \ldots, w_{n}, w_{1} \rrbracket_{2 w_{1}-n-1}$.
Proof. Define a linear map $\varphi: \llbracket w_{1}, w_{2}, \ldots, w_{n} \rrbracket \longrightarrow \llbracket w_{2}, \ldots, w_{n}, w_{1} \rrbracket_{2 w_{1}-n-1}$ by

where $M_{1}^{C}=\{2, \ldots, n\} \backslash M_{1}$; it is convenient to have indices in the codomain go from 2 to $n+1$ instead of from 1 to $n$. There holds

Length difference of $e_{M}$ and $\varphi\left(e_{M}\right)$ is $\left(n-1-\left|M_{1}\right|\right)-\left|M_{1}\right|=n-1-2\left(w_{1}-1\right)=n+1-2 w_{1}$. Thus $\varphi$ is a well-defined bijection. Denoting $M \backslash x \cup y:=(M \backslash\{x\}) \cup\{y\}$, we have

for $\varepsilon_{x y}, \varepsilon_{x y}^{\prime} \in\{1,-1\}$. Since $\left[e_{y, n+1}, e_{x, y}\right]=-e_{x, n+1}$, there is a minus before $\varepsilon_{x y}^{\prime}$. We must show that $(-1)^{y-x} \varepsilon_{x y}=(-1)^{n} \varepsilon_{x y}^{\prime}$ : if $\alpha=\left(\right.$ position of $x$ in $\left.M_{1}\right), \beta=($ position of $(x, y)$ in $N), \gamma=\left(\right.$ position of $y$ in $\left.M_{1} \backslash x \cup y\right)$, then $y$ in $M_{1}^{C}$ has position $y-\gamma-1$ and $x$ in $M_{1}^{C} \backslash y \cup x$ has position $x-\alpha$, so $(-1)^{y-x} \varepsilon_{x y}=(-1)^{y-x+\alpha+\left(\left|M_{1}\right|+\beta\right)+(\gamma-1)}=$
$(-1)^{n+(y-\gamma-1)+\left(n-1-\left|M_{1}\right|+\beta\right)+(x-\alpha-1)}=(-1)^{n} \varepsilon_{x y}^{\prime}$. Therefore $\varphi \partial=(-1)^{n-1} \partial \varphi$, hence $\bar{\varphi}\left(e_{M}\right):=\left\{\begin{array}{ll}\varphi\left(e_{M}\right)(-1)^{n-1} & ; \text { if }|M| \in 2 \mathbb{N} \\ \varphi\left(e_{M}\right) & ; \text { if }|M| \notin 2 \mathbb{N}\end{array}\right.$ is an isomorphism of chain complexes.
Lemma 2.4. $\llbracket w_{1}, \ldots, w_{k-1}, n, w_{k+1}, \ldots, w_{n} \rrbracket \cong \llbracket w_{1}, \ldots, w_{k-1}, w_{k+1}, \ldots, w_{n} \rrbracket_{n-k}$ and $\llbracket w_{1}, \ldots, w_{k-1}, 1, w_{k+1}, \ldots, w_{n} \rrbracket \cong \llbracket w_{1}-1, \ldots, w_{k-1}-1, w_{k+1}-1, \ldots, w_{n}-1 \rrbracket_{k-1}$.
Proof. We can identify $\llbracket w_{1}, \ldots, w_{n-1}, n \rrbracket$ with $\llbracket w_{1}, \ldots, w_{n-1} \rrbracket$. By Lemma 2.3.

\begin{aligned}
\llbracket w_{1}, \ldots, w_{k-1}, n, w_{k+1}, \ldots, w_{n} \rrbracket & \cong \llbracket w_{k+1}, \ldots, w_{n}, w_{1}, \ldots, w_{k-1}, n \rrbracket_{-2 \sum_{i=k+1}^{n} w_{i}+(n-k)(n+1)} \\
& \cong \llbracket w_{k+1}, \ldots, w_{n}, w_{1}, \ldots, w_{k-1} \rrbracket_{-2 \sum_{i=k+1}^{n} w_{i}+(n-k)(n+1)} \\
& \cong \llbracket w_{1}, \ldots, w_{k-1}, n, w_{k+1}, \ldots, w_{n} \rrbracket_{(n-k) \cdot 1} .
\end{aligned}
$$

We can identify $\llbracket 1, w_{2}, \ldots, w_{n} \rrbracket$ with $\llbracket w_{2}-1, \ldots, w_{n}-1 \rrbracket$. By Lemma 2.3,

\begin{aligned}
\llbracket w_{1}, \ldots, w_{k-1}, 1, w_{k+1}, \ldots, w_{n} \rrbracket & \cong \llbracket 1, w_{k+1}, \ldots, w_{n}, w_{1}, \ldots, w_{k-1} \rrbracket_{2 \sum_{i=1}^{k-1} w_{i}-(k-1)(n+1)} \\
& \cong \llbracket w_{k+1}-1, \ldots, w_{n}-1, w_{1}-1, \ldots, w_{k-1}-1 \rrbracket_{2 \sum_{i=1}^{k-1} w_{i}-(k-1)(n+1)} \\
& \cong \llbracket w_{1}-1, \ldots, w_{k-1}-1, w_{k+1}-1, \ldots, w_{n}-1 \rrbracket_{2(k-1)-(k-1)} .
\end{aligned}
$$

This establishes the first and second part of the claim.
If all elements in $w=\left(w_{1}, \ldots, w_{n}\right)$ are distinct, then by applying Lemma $2.4 n$ times, we see that $\llbracket w \rrbracket$ has only one generator, namely

which is the wedge of inversions of permutation $w=\pi$ of $(1, \ldots, n)$. Indeed, $w_{k}\left(e_{\pi}\right)=$ $k-\left|\left\{i ; e_{i k} \in e_{\pi}\right\}\right|+\left|\left\{j ; e_{k j} \in e_{\pi}\right\}\right|=k-\left|\left\{i ; i<k, w_{i}>w_{k}\right\}\right|+\left|\left\{j ; k<j, w_{k}>w_{j}\right\}\right|=$ $1+\left|\left\{i ; i<k, w_{i}<w_{k}\right\}\right|+\left|\left\{j ; k<j, w_{k}>w_{j}\right\}\right|=1+\left|\left\{r ; r \neq k, w_{r}<w_{k}\right\}\right|=w_{k}$.

Let $\mathcal{F}_{n}=\left\{\left(w_{1}, \ldots, w_{n}\right) \in \mathcal{S}_{n} ; w_{i} \neq w_{j}\right.$ for $\left.i \neq j\right\}=\left\{\pi(1, \ldots, n) ; \pi \in S_{n}\right\}$. In Lemma 4.2, we show that for $w \notin \mathcal{F}_{n}$ the homology of $\llbracket w \rrbracket$ has only torsion. Therefore the free part is $F H_{*}\left(\mathfrak{n i l}_{n}\right)=\bigoplus_{w \in \mathcal{F}_{n}} \llbracket w \rrbracket$. Thus we calculate what was already known to Kostant [5, 2], who used the Laplacian method (the fact that $\operatorname{dim} H_{k}\left(C_{*}, \partial_{*}\right)=$ $\operatorname{dim} \operatorname{Ker}\left(\partial_{k+1} \partial_{k+1}^{t}+\partial_{k}^{t} \partial_{k}\right)$ over $\left.\mathbb{Q}\right)$ to obtain part (a) of the following result:

Theorem 2.5. (a) $F H_{k}\left(\mathfrak{n i l}_{n}\right) \cong \mathbb{Z}^{T(n, k)}$, where $T(n, k)$ is the Mahonian number. (b) $H^{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Q}\right) \cong\left\langle x_{\pi} ; \pi \in S_{n}\right\rangle \leq \Lambda_{\mathbb{Q}}\left[x_{i j} ; 1 \leq i<j \leq n\right]$, where $x_{\pi}=\bigwedge_{i<j, \pi_{i}>\pi_{j}} x_{i j}$.

In words, the cohomology algebra over $\mathbb{Q}$ is isomorphic to the subalgebra of the polynomial exterior algebra, spanned by the inversions of all permutations.
Proof. (a) By definition (OEIS A008302), $T(n, k)$ is the number of permutations of $[n]$ which have $k$ inversions, so the result follows from (2.1) and Lemma 4.2 , (b) For any $\alpha \in H^{i}(\mathfrak{g})$ and $\beta \in H^{j}(\mathfrak{g})$, the cup product is given by

(\alpha \smile \beta)\left(x_{1} \cdots x_{i+j}\right)=\sum_{\pi \in S_{i+j}, \pi_{1}<\ldots<\pi_{i}, \pi_{i+1}<\ldots<\pi_{i+j}} \operatorname{sgn} \pi \alpha\left(x_{\pi_{1}} \cdots x_{\pi_{i}}\right) \beta\left(x_{\pi_{i+1}} \cdots x_{\pi_{i+j}}\right)
$$

In our case, $H^{*}\left(\mathfrak{n i l}_{n} ; \mathbb{Q}\right)$ is spanned by the duals $\left\{x_{\pi}:=e_{\pi}^{*} ; \pi \in S_{n}\right\}$. Furthermore, $\left(e_{\pi}^{*} \smile e_{\pi^{\prime}}^{*}\right)\left(e_{M}\right)=\left\{\begin{array}{l}1 ; \text { if } e_{M}=e_{\pi} e_{\pi^{\prime}} \\ 0 ; \text { if } e_{M} \neq e_{\pi} e_{\pi^{\prime}}\end{array}\right.$, hence $e_{\pi}^{*} \smile e_{\pi^{\prime}}^{*}=\left(e_{\pi} \wedge e_{\pi^{\prime}}\right)^{*}$.

## 3. Filtrations

Let $w=\left(2, w_{2}, \ldots, w_{n}\right)$, so every wedge in $\llbracket w \rrbracket$ contains exactly one $e_{1 *}$. There is a natural filtration of $\llbracket w \rrbracket$ by subcomplexes: if $F_{k}^{w}$ is spanned by $\left\{e_{1 i} e_{M} ; i \geq k\right\}$, then $0=F_{n+1}^{w} \leq F_{n}^{w} \leq \ldots \leq F_{2}^{w}=\llbracket w \rrbracket$. The quotient $F_{k}^{w} / F_{k+1}^{w}$ has generators $\left\{\left[e_{1 k} e_{M}\right] ; e_{1 k} e_{M} \in F_{k}^{w}\right\}$ and boundary $\partial\left[e_{1 k} e_{M}\right]=-\left[e_{1 k} \partial e_{M}\right]$, therefore

$$
\begin{align*}
F_{k}^{w} / F_{k+1}^{w} & \cong \llbracket 1, w_{2}, \ldots, w_{k-1}, w_{k}+1, w_{k+1}, \ldots, w_{n} \rrbracket_{1}  \tag{3.1}\\
& \cong \llbracket w_{2}-1, \ldots, w_{k-1}-1, w_{k}, w_{k+1}-1, \ldots, w_{n}-1 \rrbracket_{1} .
\end{align*}
$$

Lemma 3.1. If $w_{r}=w_{s}=w_{t} \in\{2, n-1\}$ for distinct $r, s, t$, then $H_{*} \llbracket w_{1}, \ldots, w_{n} \rrbracket \cong 0$.
Proof. By Lemmas 2.3 and [2.2, we may assume that $r=1$ and $w_{r}=w_{s}=w_{t}=2$. For any $i \notin\{s, t\}$ there holds $F_{i}^{w} / F_{i+1}^{w} \cong \llbracket w_{2}-1, \ldots, 1, \ldots, w_{i}, \ldots, 1, \ldots, w_{n}-1 \rrbracket_{1} \cong$ $\llbracket w_{2}-2, \ldots, 0, \ldots, w_{i}-1, \ldots, w_{n}-2 \rrbracket_{t} \cong 0$, by (3.1) and Lemma [2.4 Thus we have $0=F_{n}^{w}=\ldots=F_{t+1}^{w}<F_{t}^{w}=\ldots=F_{s+1}^{w}<F_{s}^{w}=\ldots=\llbracket w \rrbracket$ and a long exact sequence of a pair $\ldots \rightarrow H_{k+1} \frac{\llbracket w \rrbracket}{F_{t}^{w}} \xrightarrow{\chi} H_{k} F_{t}^{w} \rightarrow H_{k} \llbracket w \rrbracket \rightarrow H_{k} \frac{\llbracket w \rrbracket}{F_{t}^{w}} \xrightarrow{\chi} H_{k-1} F_{t}^{w} \rightarrow \ldots$. To prove $H_{*} \llbracket w \rrbracket \cong 0$, it suffices to show that $\chi$ is an isomorphism, where $\chi\left(x+F_{t}^{w}\right)=[\partial(x)]$.

Let $x \in \llbracket w \rrbracket / F_{t}^{w}=F_{s}^{w} / F_{s+1}^{w}$, so $x=e_{1 s} \cdots$. By $w_{t}=2, x=e_{1 s} e_{\{2, \ldots, s, \ldots, t-1\} \times\{t\}} \cdots$. By $w_{s}=2, x=\left[e_{1 s} e_{\{2, \ldots, s-1\} \times\{s\}} e_{\{2, \ldots, s, \ldots, t-1\} \times\{t\}} e_{M}\right]$ with no indices $s$ and $t$ in $M$.

Let $y \in F_{t}^{w}=F_{t}^{w} / F_{t+1}^{w}$, so $y=e_{1 t} \cdots$. Since $w_{s}=2, y=e_{1 t} e_{\{2, \ldots, s-1\} \times\{s\}} \cdots$. Since $w_{t}=2, y=e_{1 t} e_{\{2, \ldots, s-1\} \times\{s\}} e_{\{2, \ldots, \hat{s}, \ldots, t-1\} \times\{t\}} e_{M}$ with no indices $s$ and $t$ in $M$.

Since $H_{k} \frac{\llbracket w \rrbracket}{F_{t}^{w}}=\frac{\text { Ker } \partial}{\mathrm{Im} \partial}$, its elements are sent by $\partial$ to $F_{t}^{w}$, so in $x$ the only multiplication is $\left[e_{1 s}, e_{s t}\right]=e_{1 t}$. Thus $\chi$ sends $x \mapsto y$ and is bijective.
Lemma 3.2. $\llbracket \ldots, 2,2, \ldots \rrbracket \simeq 0$ and $\llbracket \ldots, n-1, n-1, \ldots \rrbracket \simeq 0$.
Proof. By Lemmas 2.3 and 2.2 it suffices to show that $\llbracket w \rrbracket:=\llbracket 2,2, w_{3}, \ldots, w_{n} \rrbracket \simeq 0$. Now $\llbracket w \rrbracket$ consists of $e_{1 i} e_{M}$ with $i \geq 3$ and $e_{12} e_{2 i} e_{M}$, where 2 is not an index in $M$. Hence $\mathcal{M}=\left\{e_{12} e_{2 i} e_{M} \rightarrow e_{1 i} e_{M} ; e_{1 i} e_{M} \in \llbracket w \rrbracket\right\}$ is a Morse matching with $\dot{\mathcal{M}}=\emptyset$.

Lemma 3.3. Let $w=\left(2, w_{2}, w_{3}, \ldots, w_{n}\right)$ and $w^{\prime}=\left(2, w_{3}, \ldots, w_{n}, w_{2}\right)$. Then $F_{3}^{w} \cong$ $\llbracket w^{\prime} \rrbracket_{2 w_{2}-n-2} / F_{n}^{w^{\prime}}$. If $H_{*} \llbracket w_{2}, w_{3}-1, \ldots, w_{n}-1 \rrbracket \cong 0$, then $H_{*} \llbracket w \rrbracket \cong H_{*} \llbracket w^{\prime} \rrbracket_{2 w_{2}-n-2}$.
Proof. Define a linear map $\varphi: F_{3}^{w} \rightarrow \llbracket w^{\prime} \rrbracket_{2 w_{2}-n-2} / F_{n}^{w^{\prime}}$ by

$$
\varphi\left(e_{1 b} \wedge_{i=2}^{n-1} e_{\{i\} \times M_{i}}\right)=(-1)^{\Sigma M_{2}}\left[e_{1 b} e_{M_{2}^{C} \times\{n+1\}} \wedge_{i=3}^{n-1} e_{\{i\} \times M_{i}}\right],
$$

where $M_{2}^{C}=\{3, \ldots, n\} \backslash M_{2}$ and indices in the codomain are $1,3, \ldots, n+1$. Our $\varphi$ is a bijection and proof that it is a chain map is similar to the one in Lemma 2.3

Let $H_{*} \llbracket w_{2}, w_{3}-1, \ldots, w_{n}-1 \rrbracket \cong 0$, which by (3.1) is $H_{*}\left(F_{2}^{w} / F_{3}^{w}\right)$. By the long exact sequence and first part, $H_{*} \llbracket w \rrbracket=H_{*} F_{2}^{w} \cong H_{*} F_{3}^{w} \cong H_{*}\left(\llbracket w^{\prime} \rrbracket_{2 w_{2}-n-2} / F_{n}^{w^{\prime}}\right)$. By (3.1), $H_{*} F_{n}^{w^{\prime}} \cong H_{*} \llbracket w_{3}-1, \ldots, w_{n}-1, w_{2} \rrbracket \cong H_{*} \llbracket w_{2}, w_{3}-1, \ldots, w_{n}-1 \rrbracket_{n-2 w_{2}} \cong 0$, so by the long exact sequence, $H_{*}\left(\llbracket w^{\prime} \rrbracket / F_{n}^{w^{\prime}}\right) \cong H_{*} \llbracket w^{\prime} \rrbracket$ and the result follows.

Recall that any chain map $\varphi: B_{*} \rightarrow C_{*}$ induces a chain complex $D_{*}=\operatorname{Cone} \varphi$, where $D_{n}=B_{n-1} \oplus C_{n}$ and $\partial(b, c)=(\partial(b), \varphi(b)-\partial(c))$. Furthermore, there is an exact sequence $\ldots \rightarrow H_{k+1} D_{*} \rightarrow H_{k} B_{*} \xrightarrow{\varphi_{*}} H_{k} C_{*} \rightarrow H_{k} D_{*} \rightarrow H_{k-1} B_{*} \xrightarrow{\varphi_{*}} \ldots$.
Lemma 3.4. Let $w=\left(2, w_{2}, \ldots, w_{k}, 3,3, w_{k+3}, \ldots, w_{n}\right)$ and $w^{\prime}=\left(w_{2}-2, \ldots, w_{k}-2\right.$, $\left.3, w_{k+3}-2, \ldots, w_{n}-2\right)$. Then $H_{*} \llbracket w \rrbracket \cong H_{*} \operatorname{Cone}\left(\llbracket w^{\prime} \rrbracket_{k} \xrightarrow{\cdot 2} \llbracket w^{\prime} \rrbracket_{k}\right)$.
Proof. Let $k=1$, so $w=(2,3,3, \ldots)$. By (3.1) and Lemma3.3, $F_{k}^{w} / F_{k+1}^{w} \simeq 0$ for $k \geq 4$, so $H_{*} F_{4}^{w} \cong 0$ and $H_{*} \llbracket w \rrbracket \cong H_{*}\left(\llbracket w \rrbracket / F_{4}^{w}\right)$. There are 4 types of generators in $\llbracket w \rrbracket / F_{4}^{w}$ :

- $A=\left\{\left[e_{12} e_{23} e_{2 a} e_{3 b} e_{M}\right] ;\right.$ all indices in $M$ are $\left.\geq 4\right\}$,
- $B=\left\{\left[e_{13} e_{23} e_{3 a} e_{3 b} e_{M}\right]\right.$; all indices in $M$ are $\left.\geq 4\right\}$,
- $C=\left\{\left[e_{12} e_{2 a} e_{2 b} e_{M}\right] ; \quad\right.$ all indices in $M$ are $\left.\geq 4\right\}$,
- $D=\left\{\left[e_{13} e_{2 a} e_{3 b} e_{M}\right] ; \quad\right.$ all indices in $M$ are $\left.\geq 4\right\}$.

The set $\mathcal{M}=\left\{A \ni e_{12} e_{23} e_{2 a} e_{M} \rightarrow e_{13} e_{2 a} e_{M} \in D\right\}$ is a Morse matching, with critical elements $\mathcal{M}=B \cup C$. Nontrivial zig-zag paths go from $B$ to $C$ and come in pairs:

which add up to $\cdot 2$. We have $\langle\mathcal{M}\rangle /\langle C\rangle \cong \llbracket w^{\prime} \rrbracket_{2}$ (omit $e_{13} e_{23}$ and indices 1, 2) and $\langle C\rangle \cong \llbracket w^{\prime} \rrbracket_{1}$ (omit $e_{12}$ and indices 1,3 ), so $H_{*} \llbracket w \rrbracket \cong H_{*}\langle\dot{\mathcal{M}}\rangle \cong H_{*}$ Cone $\left(\llbracket w^{\prime} \rrbracket_{1} \xrightarrow{\cdot 2} \llbracket w^{\prime} \rrbracket_{1}\right)$.

Finally, if $k \geq 2$, then $H_{*} \llbracket w \rrbracket \cong H_{*} \llbracket 2,3,3, w_{k+3}, \ldots, w_{n}, w_{2}, \ldots, w_{k} \rrbracket_{\sum_{i=2}^{k}\left(2 w_{i}-n-2\right)}$ $\cong H_{*}$ Cone $\left(.2 \bigcirc \llbracket 3, w_{k+3}-2, \ldots, w_{n}-2, w_{2}-2, \ldots, w_{k}-2 \rrbracket_{1+\sum_{i=2}^{k}\left(2 w_{i}-n-2\right)}\right) \cong H_{*}$ Cone $\left(.2 \bigcirc \llbracket w_{2}-2, \ldots, w_{k}-2,3, w_{k+3}-2, \ldots, w_{n}-2 \rrbracket_{1+\sum_{i=2}^{k}\left(2 w_{i}-n-2\right)-\sum_{i=2}^{k}\left(2\left(w_{i}-2\right)-(n-1)\right)}\right) \cong$ $H_{*}$ Cone $\left(\llbracket w^{\prime} \rrbracket_{k} \xrightarrow{\cdot 2} \llbracket w^{\prime} \rrbracket_{k}\right)$ by Lemmas 3.2, 3.3, 2.3, so the job is done.

Lemma 3.5. Let $w=\left(2, w_{2}, \ldots, w_{k-1}, 2, w_{k+1}, \ldots, w_{n}\right)$.
(1) Let $A=\left\{e_{\{1, \ldots, k-1\} \times\{k\}} e_{k a} e_{M} \in \llbracket w \rrbracket\right\}$ and $B=\left\{e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M} \in \llbracket w \rrbracket ; a>k\right\}$. There exists a Morse matching $\mathcal{M}$ for $\llbracket w \rrbracket$, such that $\dot{\mathcal{M}}=A \cup B,\left.\partial\right|_{B}=\left.\partial\right|_{B}$,

\begin{aligned}
\left.\partial \circ\right|_{A}: e_{\{1, \ldots, k-1\} \times\{k\}} e_{k a} e_{M} & \mapsto(-1)^{k+1}\left(e_{\{1, \ldots, k-1\} \times\{k\}} \partial\left(e_{k a} e_{M}\right)+n_{M} e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M}\right) \\
& +\sum_{(b, c) \in X}(-1)^{\epsilon b+k+1} e_{1 c} e_{\{2, \ldots, k-1\} \times\{k\}} e_{b a} e_{M \backslash\{(b, c)\}},
\end{aligned}
$$

where $n_{M}=|\{b \in\{1, \ldots, k-1\} ;(b, a) \notin M\}|, \epsilon_{b c}=($ position of $(b, c)$ in $M)$, and $X=\{(b, c) \in M ; b<k<c,(b, a) \notin M\}$.
(2) $H_{*} \llbracket w \rrbracket \cong H_{*}$ Cone $\varphi$ for some chain map $\varphi: F_{k+1}^{w} \rightarrow F_{k+1}^{w}$.
(3) $H_{*} \llbracket 2, w_{2}, \ldots, w_{n-2}, 2, w_{n} \rrbracket \cong H_{*} \operatorname{Cone}\left(\cdot\left(w_{n}-1\right) \bigcirc \llbracket w_{2}-1, \ldots, w_{n-2}-1,1, w_{n} \rrbracket_{1}\right)$.

Proof. (1): There are four types of generators in $\llbracket w \rrbracket: A, B$,
$C=\left\{e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M} ; a<k\right.$, there is no index 1 or $k$ in $\left.M\right\}$, $D=\left\{e_{\{1, \ldots, \hat{a}, \ldots, k-1\} \times\{k\}} e_{M} ; 1<a<k\right.$, there is no index 1 or $k$ in $\left.M\right\}$.
Set $\mathcal{M}=\left\{C \ni e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M} \rightarrow e_{\{1, \ldots, \hat{a}, \ldots, k-1\} \times\{k\}} e_{M} \in D\right\}$ is a Morse matching, with $\mathcal{M}=A \cup B$. Zig-zag paths starting in $B$ are arrows and end in $B$, so $\left.\partial\right|_{B}=\left.\partial\right|_{B}$. Zig-zag paths starting in $A$ are $e_{\{1, \ldots, k-1\} \times\{k\}} e_{k a} e_{M} \xrightarrow{(-1)^{k+1}} e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M}$ and

(2): Follows from (1), because $\langle B\rangle=F_{k+1}^{w}$ and $\langle\mathcal{M}\rangle /\langle B\rangle \cong\langle B\rangle_{1}$ (we mod out $B$, so 2nd and 3rd summand in $\left.\partial\right|_{A}$ are 0 , thus $e_{\{1, \ldots, k-1\} \times\{k\}} e_{k a} e_{M} \mapsto e_{1 a} e_{\{2, \ldots, k-1\} \times\{k\}} e_{M}$ is a chain isomorphism). Ergo $\varphi$ is the part of $\left.\partial\right|_{A}$ that goes to $B$.
(3): Follows from (2), since $F_{k+1}^{w}=F_{n}^{w} \cong \llbracket w^{\prime} \rrbracket_{1}$ (omit $e_{1 n}$ and index 1) and $X=\emptyset$ and $n_{M}=|\{b \in\{1, \ldots, n-2\} ;(b, n) \notin M\}|=n-1-\left(n-w_{n}\right)=w_{n}-1$.

Dwyer [1] reports how Kunkel proved that $H_{*} \mathfrak{n i l}_{n}$ has $p$-torsion for prime $p<n-1$. Now we can easily see that $H_{*} \mathfrak{n i l}_{n}$ also has $p^{m}$-torsion for every $p^{m}<n-1$ :
Example 3.6. Let $q=p^{m}=n-2$ and $w=(2,3, \ldots, q+1,2, q+1)$. By Lemma 3.5, $H_{*} \llbracket w \rrbracket \cong H_{*} \operatorname{Cone}\left(\llbracket w^{\prime} \rrbracket_{1} \xrightarrow{\cdot q} \llbracket w^{\prime} \rrbracket_{1}\right)$. Since $w^{\prime}=(2, \ldots, q, 1, q+1)$ is a permutation of $(1, \ldots, q+1)$ and $\left|\left\{(i, j) ; i<j, w_{i}^{\prime}>w_{j}^{\prime}\right\}\right|=q-1$, we have $H_{k} \llbracket w^{\prime} \rrbracket \cong\left\{\begin{array}{l}\mathbb{Z} \text {; if } k=q-1 \\ 0 ; \text { if } k \neq q-1\end{array}\right.$, so $H_{k} \llbracket w \rrbracket \cong\left\{\begin{array}{c}\mathbb{Z}_{q} ; \text { if } k=q \\ 0 ; \text { if } k \neq q\end{array}\right.$. If $q<n-2$, then $H_{*} \llbracket w, q+3, \ldots, n \rrbracket \cong H_{*} \llbracket w \rrbracket$.

In [1], Dwyer proved that there is no $p$-torsion in $H_{*} \mathfrak{n i l}_{n}$ for any prime $p \geq n-1$. The next example shows that $H_{*} \mathfrak{n i l}_{n}$ can have $p^{m}$-torsion for some $p^{m} \geq n-1$ :

Example 3.7. Let $w=(2,4,7,5,4,2,5,7)$. Complex $\llbracket w \rrbracket$ is spanned by 192 wedges. Using Lemma 3.5, $H_{*} \llbracket w \rrbracket \cong H_{*} \operatorname{Cone}\left(\varphi \subset F_{7}^{w}\right)$. By (3.1), $F_{8}^{w} \cong \llbracket 3,6,4,3,1,4,7 \rrbracket_{1} \cong$ $\llbracket 3,6,4,3,1,4 \rrbracket_{1} \cong \llbracket 2,5,3,2,3 \rrbracket_{5} \cong \llbracket 2,3,2,3 \rrbracket_{8}$, so $H_{10} F_{8}^{w} \cong \mathbb{Z}_{2}$ generated by $\left.e_{18} e_{M}=: a\right\rceil$ for $M=\{(2,7),(4,5)\} \cup\{(i, 6) ; i=2, \ldots, 5\} \cup\{(3, i) ; i=4,5,7\}$. By Lemmas 2.4, 2.2, 3.5

\begin{aligned}
H_{*} F_{7}^{w} / F_{8}^{w} & \cong H_{*} \llbracket 3,6,4,3,1,5,6 \rrbracket_{1} \cong H_{*} \llbracket 2,5,3,2,4,5 \rrbracket_{5} \cong \\
& \cong H_{*} \llbracket 2,3,5,4,2,5 \rrbracket_{5} \cong H_{*} \operatorname{Cone}\left(\cdot 4 \bigcirc \llbracket 2,4,3,1,5 \rrbracket_{6}\right) .
\end{aligned}
$$

Because $H_{*} \llbracket 2,4,3,1,5 \rrbracket \cong \mathbb{Z}$ generated by $\left[e_{14} e_{23} e_{24} e_{34}\right]$, we have $H_{*} \llbracket 2,3,5,4,2,5 \rrbracket \cong \mathbb{Z}_{4}$ generated by $\left[e_{16} e_{N}\right]$ where $N=\{(2,3),(2,4),(2,5),(3,4)\}$. Then $H_{5} \llbracket 2,5,3,2,4,5 \rrbracket$ is generated by $\left[e_{16} e_{N^{\prime}}\right]$ for $N^{\prime}=\{(7-y, 7-x) ;(x, y) \in N\}$, and $H_{10} F_{7}^{w} / F_{8}^{w}$ is generated by $\left[e_{17} e_{28} e_{P}=: b\right]$ for $P=\{(3,4),(3,5),(3,7),(4,5)\} \cup\{(i, 6) ; i=2, \ldots, 5\}$.

Exact sequence $\ldots \rightarrow H_{k+1} \frac{F_{7}^{w}}{F_{8}^{w}} \xrightarrow[\rightarrow]{\chi} H_{k} F_{8}^{w} \xrightarrow{\iota_{*}} H_{k} F_{7}^{w} \xrightarrow{\pi_{*}} H_{k} \frac{F_{7}^{w}}{F_{8}^{w}} \xrightarrow[\rightarrow]{\chi} H_{k-1} F_{8}^{w} \rightarrow \ldots$ implies $H_{k} F_{7}^{w} \cong 0$ for $k \neq 10$ and $H_{10} F_{7}^{w}=\left(\right.$ extension of $\mathbb{Z}_{2}$ by $\left.\mathbb{Z}_{4}\right) \cong\left(\mathbb{Z}_{2} \times \mathbb{Z}_{4}\right.$ or $\left.\mathbb{Z}_{8}\right)$ generated by $[a]$ and $[b]$. Since $\partial\left(\sum_{i \in\{3,4,5,7\}} e_{17} e_{2 i} e_{i 8} e_{P}\right)=4 e_{17} e_{28} e_{P}+e_{18} e_{M}(*)$ in $F_{7}^{w}$, we have $0=4[b]+[a]$ in $H_{10} F_{7}^{w}$, hence $[b]$ itself is a generator and $H_{10} F_{7}^{w} \cong \mathbb{Z}_{8}$.

Let us compute $\varphi_{*}$. In the proof of Lemma 3.5 for our case, $a, b \in\langle B\rangle$ and $x:=$ $e_{16} e_{67} e_{28} e_{P}=e_{\{1, \ldots, 5\} \times\{6\}} e_{67} e_{R} \in\langle A\rangle \cong\langle B\rangle_{1}$ for $R=\{(2,8),(3,4),(3,5),(3,7),(4,5)\}$;

$$
\varphi(x)=\partial ْ(x)= \pm n_{R} e_{17} e_{\{2, \ldots, 5\} \times\{6\}} e_{R} \pm e_{18} e_{\{2, \ldots, 5\} \times\{6\}} e_{27} e_{R \backslash\{(2,8)\}}= \pm 4 b \pm a
$$

By $(*), \varphi_{*}(x)$ is 0 or $\pm 8[b]$. In both cases, $\varphi_{*}=0$. Exact sequence $\ldots \rightarrow H_{k+1} \llbracket w \rrbracket \rightarrow$ $H_{k} F_{7}^{w} \xrightarrow{\varphi_{*}} H_{k} F_{7}^{w} \rightarrow H_{k} \llbracket w \rrbracket \rightarrow H_{k-1} F_{7}^{w} \xrightarrow{\varphi_{*}} \ldots$ then implies $H_{k} \llbracket w \rrbracket \cong\left\{\begin{array}{ll}\mathbb{Z}_{8} ; & \text { if } k \in\{10,11\} \\ 0 ; & \text { if } k \notin\{10,11\}\end{array} . \diamond\right.$

## 4. Free part of homology

We can generalise the filtration from the previous section to an arbitrary complex $\llbracket w_{1}, \ldots, w_{n} \rrbracket=\llbracket w \rrbracket$. In every $e_{M} \in \llbracket w \rrbracket$, there are exactly $t:=w_{1}-1$ occurrences of $e_{1 *}$. Thus $F_{k}^{w}:=\left\langle e_{1 i_{1}} \ldots e_{1 i_{t}} e_{M} ; i_{1}+\ldots+i_{t} \geq k, 1\right.$ is not in $\left.M\right\rangle \leq \llbracket w \rrbracket$ is a subcomplex.

Define $w\left(i_{1}, \ldots, i_{t}\right) \in \mathcal{S}_{n-1}$ as $\left(w_{2}^{\prime}, \ldots, w_{n}^{\prime}\right)$, where $w_{j}^{\prime}=\left\{\begin{array}{ll}w_{j} ; & \text { if } j \in\left\{i_{1}, \ldots, i_{t}\right\} \\ w_{j}-1 ; \text { if } j \notin\left\{i_{1}, \ldots, i_{t}\right\}\end{array}\right.$. Then

F_{k}^{w} / F_{k+1}^{w} \cong \bigoplus_{i_{1}+\ldots+i_{t}=k} \llbracket w\left(i_{1}, \ldots, i_{t}\right) \rrbracket_{t} . \tag{4.1}
\end{equation*}
$$

Example 4.1. Let us compute $H_{*} \llbracket 3,3,3,3,3 \rrbracket$. By Lemmas 3.2, 3.5, (4.1), $F_{10}^{w}=0$, $F_{9}^{w} / F_{10}^{w} \cong \llbracket 2,2,3,3 \rrbracket_{2} \simeq 0, H_{*} F_{8}^{w} / F_{9}^{w} \cong H_{*} \llbracket 2,3,2,3 \rrbracket_{2} \cong \mathbb{Z}_{2}$ generated by $\left[e_{13} e_{15} e_{24} e_{35}\right]$, $F_{7}^{w} / F_{8}^{w} \cong \llbracket 3,2,2,3 \rrbracket_{2} \oplus \llbracket 2,3,3,2 \rrbracket_{2} \simeq 0, H_{*} F_{6}^{w} / F_{7}^{w} \cong H_{*} \llbracket 3,2,3,2 \rrbracket_{2} \cong H_{*} \llbracket 2,3,2,3 \rrbracket_{3} \cong \mathbb{Z}_{2}$ generated by $\left[e_{12} e_{14} e_{23} e_{25} e_{35}\right], F_{5}^{w} / F_{6}^{w} \cong \llbracket 3,3,2,2 \rrbracket_{2} \simeq 0, F_{5}^{w}=\llbracket w \rrbracket$. Thus $H_{*} \llbracket w \rrbracket \cong$ $H_{*} F_{6}$ and $H_{*} F_{7}^{w} \cong H_{*} F_{8}^{w} \cong H_{*} F_{8}^{w} / F_{9}^{w} \cong \mathbb{Z}_{2}$ generated by [ $e_{13} e_{15} e_{24} e_{35}$ ]. In the exact sequence $\ldots \rightarrow H_{k+1} \frac{F_{6}^{w}}{F_{7}^{w}} \xrightarrow{\chi} H_{k} F_{7}^{w} \rightarrow H_{k} F_{6}^{w} \rightarrow H_{k} \frac{F_{6}^{w}}{F_{7}^{w}} \xrightarrow{\chi} H_{k-1} F_{7}^{w} \rightarrow \ldots$ our $\chi$ sends

$$
\begin{aligned}
{\left[e_{12} e_{14} e_{23} e_{25} e_{35}\right] } & \mapsto\left[e_{13} e_{14} e_{25} e_{35}+e_{14} e_{15} e_{23} e_{35}\right]= \\
& {\left[-e_{13} e_{15} e_{24} e_{35}-\partial\left(e_{13} e_{15} e_{23} e_{34} e_{35}\right)+\partial\left(e_{13} e_{14} e_{25} e_{34} e_{45}\right)\right] }
\end{aligned}
$$

It is an isomorphism, hence by exactness, $H_{*} \llbracket 3,3,3,3,3 \rrbracket \cong H_{*} F_{6}^{w} \cong 0$.
Lemma 4.2. For $w \in \mathcal{S}_{n} \backslash \mathcal{F}_{n}=: \mathcal{T}_{n}$, the homology of $\llbracket w \rrbracket$ has only torsion.
Proof. We use induction on $n$. Computing over $\mathbb{Q}$, by universal coefficient theorem, it suffices to show that $H_{*} \llbracket w \rrbracket \cong 0$. The claim is trivial for $n=2$ since $\mathcal{T}_{2}=\emptyset$. Let $n>2$ and $w \in \mathcal{T}_{n}$. By Lemma 2.4 and induction hypothesis, we may assume that $2 \leq w_{1}, \ldots, w_{n} \leq n-1$. By Lemma 2.3 we may assume that $w_{1} \leq w_{i}$ for all $i$. If $w_{1} \geq 3$, all elements of the sequence $w\left(i_{1}, \ldots, i_{w_{1}-1}\right)$ are at least 2 , so $w\left(i_{1}, \ldots, i_{w_{1}-1}\right) \in \mathcal{T}_{n-1}$. By (4.1) and induction, $H_{*} F_{k}^{w} / F_{k+1}^{w} \cong 0$ for all $k$, hence $H_{*} \llbracket w \rrbracket \cong 0$.

Let $w_{1}=2$. If $w(i) \in \mathcal{T}_{n-1}$ for all $i$, then by (4.1) and induction, $H_{*} F_{i}^{w} / F_{i+1}^{w} \cong 0$ for all $i$, hence $H_{*} \llbracket w \rrbracket \cong 0$. Suppose there exists $i \in\{2, \ldots, n\}$ with $w(i) \notin \mathcal{T}_{n-1}$. Then $w_{i}=n-1, w_{1}=2$, and other elements of $w$ form a permutation of $(2, \ldots, n-1)$, so there are exactly two numbers $j<i$ such that $w(j), w(i) \in \mathcal{F}_{n-1}$. In the filtration $0=F_{n+1}^{w} \leq \ldots \leq F_{i+1}^{w} \leq F_{i}^{w} \leq \ldots \leq F_{j+1}^{w} \leq F_{j}^{w} \leq \ldots \leq F_{2}^{w}=\llbracket w \rrbracket$, by (3.1) and (2.1) we have $H_{k} F_{i}^{w} / F_{i+1}^{w} \cong\left\{\begin{array}{c}\mathbb{Q} ; \text { if } k=1+\left|I_{i}\right| \\ 0 ; \text { if } k \neq 1+\left|I_{i}\right|\end{array}, H_{k} F_{j}^{w} / F_{j+1}^{w} \cong\left\{\begin{array}{c}\mathbb{Q} ; \text { if } k=1+\left|I_{j}\right| \\ 0 ; \text { if } k \neq 1+\left|I_{j}\right|\end{array}\right.\right.$, and $H_{*} F_{r}^{w} / F_{r+1}^{w} \cong 0$ for $r \notin\{i, j\}$, where $I_{i}=\{$ inversions of $w(i)\}$ and $I_{j}=\{$ inversions of $w(j)\}$. Therefore $0 \cong H_{*} F_{n+1} \cong \ldots \cong H_{*} F_{i+1}, H_{*} F_{i} \cong\left\{\begin{array}{l}\mathbb{Q} ; \text { if } k=1+\left|I_{i}\right| \\ 0 ; \text { if } k \neq 1+\left|I_{i}\right|\end{array}, H_{*} F_{i}^{w} \cong \ldots \cong H_{*} F_{j+1}^{w}, H_{*} F_{j}^{w} \cong\right.$ $\ldots \cong H_{*} \llbracket w \rrbracket$. Consequently, it suffices to show that in the exact sequence

the morphism $\chi_{k+1}$ for $k=\left|I_{j}\right|$ is bijective. Notice that $H_{k+1} \frac{F_{j}^{w}}{F_{j+1}^{w}}$ and $H_{k} F_{j+1}^{w} \cong H_{k} \frac{F_{i}^{w}}{F_{i+1}^{w}}$ are generated by $\left[e_{1 j} \bigwedge_{(a, b) \in I_{j}} e_{a+1, b+1}\right]=:[x]$ and $\left[e_{1 i} \bigwedge_{(a, b) \in I_{i}} e_{a+1, b+1}\right]=:[y]$. Since $I_{j}=I_{i} \cup\{(j-1, i-1)\}$, we get $\chi([x])=[\partial(x)]=[ \pm y]$, which concludes the argument.

Lemma 4.3. $H_{k} \llbracket w_{n}, \ldots, w_{1} \rrbracket \cong H_{\binom{n}{2}-k-1} \llbracket w_{1}, \ldots, w_{n} \rrbracket$ for $\left(w_{1}, \ldots, w_{n}\right) \in \mathcal{T}_{n}$.
Proof. Let $\left(C^{*}, \delta^{*}\right)$ be the dual of the complex $\left(C_{*}, \partial_{*}\right)$ of $\mathfrak{n i l}{ }_{n}$, let $f_{M}$ be the dual of a basis element $e_{M}$, and $N=\binom{n}{2}$. Define $\tau_{*}: C_{*} \rightarrow C^{N-*}$ by $\tau\left(e_{M}\right)=\varepsilon_{M} f_{M^{C}}$, where $\varepsilon_{M}$ is the sign of the permutation $\left(M, M^{C}\right)$ of $\{(i, j) ; 1 \leq i<j \leq n\}$. By [3, p.640], $\tau_{*}$ is a chain isomorphism, i.e. $\tau_{k-1} \partial_{k}=\delta^{N-k} \tau_{k}$. For $e_{M} \in \llbracket w_{1}, \ldots, w_{n} \rrbracket$ we have

w_{i}\left(\tau\left(e_{M}\right)\right) & =i-\left|\left\{x ;(x, i) \in M^{C}\right\}\right|+\left|\left\{x ;(i, x) \in M^{C}\right\}\right| \\
& =i-(i-1-|\{x ;(x, i) \in M\}|)+(n-i-|\{x ;(i, x) \in M\}|)=n+1-w_{i},
\end{aligned}
$$

hence $\tau\left(\llbracket w_{1}, \ldots, w_{n} \rrbracket\right)=\llbracket n+1-w_{1}, \ldots, n+1-w_{n} \rrbracket^{*} \cong \llbracket w_{n}, \ldots, w_{1} \rrbracket^{*}$ by Lemma 2.2. Now the result follows from Lemma 4.2 and the universal coefficient theorem.

## 5. Computations

We have $H_{*} \mathfrak{n i l}_{n} \cong\left(\bigoplus_{w \in \mathcal{F}_{n}} H_{*} \llbracket w \rrbracket\right) \oplus\left(\bigoplus_{w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right)$. Free part $\bigoplus_{w \in \mathcal{F}_{n}} H_{*} \llbracket w \rrbracket$ is known from Theorem [2.5] For the torsion part, we use Lemma 2.4

T H_{*}\left(\mathfrak{n i l}_{n}\right) & \cong\left(\oplus_{1, n \notin w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right) \oplus \frac{\left(\oplus_{1 \in w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right) \oplus\left(\oplus_{n \in w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right)}{\oplus_{1, n \in w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket} \\
& \cong\left(\oplus_{1, n \notin w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right) \oplus \frac{\oplus_{w \in \mathcal{T}_{n-1}} \oplus_{k=1}^{n} H_{*} \llbracket w \rrbracket k-1 \oplus H_{*} \llbracket w \rrbracket \rrbracket_{n-k}}{\oplus_{w \in \mathcal{T}_{n-2} \oplus_{i \in[n-1], j \in[n]} H_{*} \llbracket w \rrbracket i-1+n-j}} \\
& \cong\left(\oplus_{1, n \notin w \in \mathcal{T}_{n}} H_{*} \llbracket w \rrbracket\right) \oplus \frac{\oplus_{k=0}^{n-1} T H_{*+k}\left(\mathfrak{n i l} \eta_{n-1}\right)^{2}}{\oplus_{i=0}^{2 n-3} T H_{*+i}\left(\mathfrak{n i} \mathfrak{n}_{n-2}\right)^{\min \{i+1,2 n-2-i\}}} .
\end{aligned}
$$

By induction and Lemmas 3.1 3.2 it suffices to calculate only $H_{*} \llbracket w \rrbracket$ coming from $\widetilde{\mathcal{T}}_{n}:=\left\{w \in \mathcal{T}_{n} ; 1, n \notin w, \nexists i: w_{i}=w_{i+1} \in\{2, n-1\}, \nexists i<j<k: w_{i}=w_{j}=w_{k} \in\{2, n-1\}\right\}$. Define maps $\alpha, \beta, \gamma: \widetilde{\mathcal{T}}_{n} \rightarrow \widetilde{\mathcal{T}}_{n}$ by $\alpha\left(w_{1}, \ldots, w_{n}\right)=\left(w_{2}, \ldots, w_{n}, w_{1}\right), \beta\left(w_{1}, \ldots, w_{n}\right)=$ $\left(n+1-w_{n}, \ldots, n+1-w_{1}\right), \gamma\left(w_{1}, \ldots, w_{n}\right)=\left(w_{n}, \ldots, w_{1}\right)$. Let $\sim$ be the smallest equivalence relation on $\widetilde{\mathcal{T}}_{n}$ with $w \sim \xi(w)$ for $\xi \in\{\alpha, \beta, \gamma\}$. By Lemmas 2.3, 2.2, 4.3 we need to compute $H_{*}$ only for one complex in each equivalence class.

Case $n=4$ : The set $\mathcal{S}_{4}$ consists of all permutations of $(1,1,4,4),(1,2,3,4),(1,3,3,3)$, $(2,2,2,4),(2,2,3,3)$, whilst $\widetilde{\mathcal{T}}_{4} / \sim=\{(2,3,2,3)\}$. Now $\llbracket 3,2,3,2 \rrbracket \cong \llbracket 2,3,2,3 \rrbracket_{1}$ has only 4 generators, so $H_{*}$ can be computed directly, but let us use Lemma 3.5 $H_{*} \llbracket\left[2,3,2,3 \rrbracket \cong H_{*} \operatorname{Cone}\left(\llbracket 2,1,3 \rrbracket_{1} \xrightarrow{\cdot 2} \llbracket 2,1,3 \rrbracket_{1}\right)\right.$. Since $\llbracket 2,1,3 \rrbracket=\left\langle e_{12}\right\rangle$, we conclude that $H_{k} \llbracket 2,3,2,3 \rrbracket \cong\left\{\begin{array}{l}\mathbb{Z}_{2} ; \text { if } k=2 \\ 0 ;\end{array}\right.$ if $k \neq 2$. Hence the torsion part is $T H_{k}\left(\mathfrak{n i l}_{4}\right) \cong\left\{\begin{array}{l}\mathbb{Z}_{2} ; \text { if } k \in\{2,3\} \\ 0 ;\end{array}\right.$ if $k \notin\{2,3\}$.

Case $n=5$ : Set $\widetilde{\mathcal{T}}_{5} / \sim$ consists of $a=(2,3,4,2,4), b=(2,3,3,3,4), c=(2,3,3,4,3)$, $d=(3,3,3,3,3)$. By Lemma [3.5 $H_{*} \llbracket a \rrbracket \cong H_{*} \operatorname{Cone}\left(\llbracket 2,3,1,4 \rrbracket_{1} \xrightarrow{\cdot 3} \llbracket 2,3,1,4 \rrbracket_{1}\right) \cong$ $\left\{\begin{array}{l}\mathbb{Z}_{3} ; \text { if } k=3 \\ 0 ; \text { if } k \neq 3\end{array}\right.$. By Lemma [3.4 $H_{*} \llbracket b \rrbracket \cong H_{*}$ Cone $\left(\llbracket 1,3,2 \rrbracket_{2} \xrightarrow{\circ} \llbracket 1,3,2 \rrbracket_{2}\right) \cong\left\{\begin{array}{l}\mathbb{Z}_{2} ; \text { if } k=3 \\ 0 ; ~ i f ~ \\ k \neq 3\end{array}\right.$, and $H_{*} \llbracket c \rrbracket \cong H_{*} \operatorname{Cone}\left(\llbracket 3,2,1 \rrbracket_{1} \xrightarrow{\cdot 2} \llbracket 3,2,1 \rrbracket_{1}\right) \cong\left\{\begin{array}{l}\mathbb{Z}_{2} ; \\ 0 ; \\ 0 ;\end{array}\right.$ if $k=4.4$. By Example 4.1$] H_{*} \llbracket d \rrbracket \cong$ 0. Because $\beta(a)=(2,4,2,3,4)=\alpha^{3}(a), \beta(b)=(2,3,3,3,4)=b, \beta(c)=(3,2,3,3,4)=$ $\alpha^{4}(c)$, and $\gamma(x) \neq \alpha^{i}(x)$ for all $x \in\{a, b, c\}$ and all $i$, we conclude that

\bigoplus_{w \in \widetilde{\mathcal{T}}_{n}} H_{k} \llbracket w \rrbracket=\bigoplus_{x \in\{a, b, c\}} \bigoplus_{i \in\{0, \ldots, 4\}}\left(H_{k} \llbracket \alpha^{i}(x) \rrbracket \oplus H_{k} \llbracket \gamma \alpha^{i}(x) \rrbracket\right)=\left\{\begin{array}{l}

Case $n=6$ is still doable by hand. Set $\widetilde{\mathcal{T}}_{6} / \sim$ has 28 elements: 9 cases are done by Lemma 3.4, 6 by Lemma 3.5, and the rest by examining their filtration. There are only 3 classes containing no 2 or $n-1$ : $(3,3,3,4,4,4),(3,3,4,3,4,4),(3,4,3,4,3,4)$.

Cases $n=7,8$ require a computer. The set $\widetilde{\mathcal{T}}_{7} / \sim$ has 250 elements, and $\widetilde{\mathcal{T}}_{8} / \sim$ has 3485 elements. See the table below for the homology of $\mathfrak{n i l}_{7}$ and $\mathfrak{n i l}_{8}$.

Cases $n \geq 9$ : The set $\widetilde{\mathcal{T}}_{9} / \sim$ has 59102 elements. We have not been able to compute, among other things, the homology of the complex $\llbracket 5,5,5,5,5,5,5,5,5 \rrbracket$.

## 6. Afterword

6.1. Conclusion. We have seen that methods, designed for a specific family of Lie algebras, where we partition the problem into smaller pieces and solve only the nontrivial nonequivalent parts, can enable us to compute more than twice as much data compared with the usual approach.
