REPRODUCING KERNEL FUNCTIONS AND ASYMPTOTIC EXPANSIONS ON JORDAN-KEPLER MANIFOLDS

ABSTRACT. We study the complex geometry of generalized Kepler manifolds, defined in Jordan theoretic terms, introduce Hilbert spaces of holomorphic functions defined by radial measures, and find the complete asymptotic expansion of the corresponding reproducing kernels for Kähler potentials, both in the flat and bounded setting.

1. INTRODUCTION

For a Kähler manifold, with (integral) Kähler form ω and quantizing line bundle \mathcal{L} , it is a fundamental problem to measure the deviation of the 'classical' curvature $\nu\omega$ of the ν -th power \mathcal{L}^{ν} from the 'quantum' curvature ω_{ν} obtained by the pull-back of the Fubini-Study form on the projective space of holomorphic sections. This relationship is usually expressed in terms of an asymptotic expansion of ω_{ν} in inverse powers of the deformation parameter ν , known as the TYZ-expansion of the Kempf distortion function. Closely related is the asymptotic expansion of the reproducing kernel function of the Hilbert space of holomorphic sections, a fundamental tool in complex analysis.

In this paper we carry out this program for an important class of algebraic varieties, the so-called Kepler varieties defined in a Jordan theoretic setting, which generalize the well-known determinantal varieties in matrix spaces. These varieties and their regular part (Kepler manifolds) are of interest from several points of view. As algebraic varieties, we show that Kepler varieties are normal, and classify invariant holomorphic differential forms of top-degree. Using a natural polar decomposition, these manifolds carry radial measures giving rise to reproducing kernel Hilbert spaces of holomorphic functions. The most interesting radial measures on Kepler manifolds come from Kähler potentials, both in the flat and bounded setting. For these, the reproducing kernel functions are related to multi-variable hypergeometric functions of type $_1F_1$ and $_2F_1$. Among our main results is the asymptotic expansion of these hypergeometric functions, which in the multi-variable case is quite challenging, and leads to the TYZ-expansion mentioned above.

Using chains of Peirce spaces in Jordan triples, the approach presented here can be extended to yield asymptotic expansions of TYZ-type in a quite general setting of homogeneous flag varieties.

2. Generalized Kepler manifolds

It is well-known that hermitian bounded symmetric domains are characterized (via their holomorphic tangent space at the origin) by the so-called **hermitian Jordan triples**. Geometrically, the Jordan triple product gives the holomorphic part of the Riemann curvature tensor. We use [14] as our standard reference concerning Jordan algebras and analysis on symmetric cones. For the more general Jordan triples, see [20]. Let Z be an irreducible hermitian Jordan triple of rank r. Let $\{u; v; w\} =: D(u, v)w$ denote the Jordan triple product of $u, v, w \in Z$. Consider the Bergman operators

$$B(u,v) \equiv B_{u,v} := id - D(u,v) + Q_u Q_v$$

where $Q_u z := \frac{1}{2} \{ u; z; u \}.$

Choose a frame e_1, \ldots, e_r of minimal orthogonal tripotents. The associated 'joint Peirce decomposition' [20, Theorem 3.13] defines numerical invariants a, b such that $d := \dim Z$ satisfies

$$\frac{d}{r} = 1 + \frac{a}{2}(r-1) + b$$

and the so-called **genus** is given by

$$p := 2 + a(r-1) + b. \tag{2.1}$$

We say that Z has **type** (r, a, b). Consider the Peirce decomposition $Z = Z_e^2 \oplus Z_e^1$ for the maximal tripotent $e := e_1 + \cdots + e_r$. Then d = d' + d'', where $d' := \dim Z_e^2$, $d'' := \dim Z_e^1$. Then

$$p - \frac{d}{r} = \frac{d'}{r}.$$

If b = 0 then $Z = Z_e^2$ is the complexification of a euclidean Jordan algebra with unit element e. We say that Z is 'of tube type'. For tube type triples, let $P_s = Q_s Q_e$ denote the 'quadratic representation'.

Let Z denote the open dense subset of all elements of maximal rank r. If Z is of tube type, with Jordan determinant N, then

$$\mathring{Z} = \{ z \in Z : N(z) \neq 0 \}$$

consists of all invertible elements in Z.

Let \check{K} denote the connected complex Lie group of linear transformations of Z generated by all Bergman operators B(u, v) which are invertible. The identity component K of the Jordan triple automorphism group is a compact real form of \check{K} . The Lie algebra \mathfrak{k} of K is the **R**-linear span of D(u, v) - D(v, u), with $u, v \in Z$. The Lie algebra $\mathring{\mathfrak{k}} = \mathfrak{k}^{\mathbf{C}}$ of \check{K} is the **C**-linear span of D(u, v), with $u, v \in Z$.

The **rank** of $z \in Z$ is the rank of its supporting tripotent, or equivalently, the rank of its Peirce 2-space considered as a unital Jordan algebra. For $1 \le \ell \le r$ the set

$$\check{Z}_{\ell} = \{ z \in Z : \text{ rank } z = \ell \}$$

is a complex manifold called the (generalized) **Kepler manifold** associated with Z. Its closure is the **Kepler variety**

$$Z_{\ell} := \{ z \in Z : \text{ rank } z \le \ell \}.$$

The group \mathring{K} preserves the rank of elements in Z and acts transitively on \mathring{Z}_{ℓ} . Let $S_{\ell} \subset \mathring{Z}_{\ell}$ denote the compact real manifold of all tripotents of rank ℓ . For maximal $\ell = r$ we have $\mathring{Z}_r = \mathring{Z}$ and $S_r =: S$ is the **Shilov boundary** of the unit ball of Z. The **symmetric cone** [14] of a euclidean Jordan algebra X will be denoted by Ω . For any tripotent $c \in Z$ let X_c denote the self-adjoint part of the Peirce 2-space Z_c^2 under the involution Q_c . This is a euclidean Jordan algebra with unit element c, symmetric cone Ω_c and Jordan determinant N_c normalized by $N_c(c) = 1$. The Kepler manifold has a **polar decomposition**

$$\mathring{Z}_{\ell} = \bigcup_{c \in S_{\ell}} \Omega_c. \tag{2.2}$$

For $\ell = 1$ we have $\Omega_c = \mathbf{R}_+ c$, where $\mathbf{R}_+ := \{t \in \mathbf{R} : t > 0\}$, and (2.2) simplifies to $Z_1 = \mathbf{R}_+ S_1$. The **quasi-determinant** $\Delta(z, w) = \det B(z, w)^{1/p}$ of Z has an expansion

$$\Delta(z,w) = \sum_{i=0}^{r} (-1)^i \ \Delta_i(z,w)$$

into K-invariant sesqui-polynomials $\Delta_i(z, w)$, homogeneous of bi-degree (i, i).

Lemma 2.1. Restricted to X_c , we have $\Delta_{\ell}(x, x) = N_c(x)^2 = N_c(x^2)$. Hence $\Delta_{\ell}(z, z) > 0$ for all $z \in \mathring{Z}_{\ell}$.

Proof. Let $x = \sum_{i=1}^{\ell} \lambda_i c_i$ be the spectral decomposition of x, with $\lambda_i > 0$ and $c_1 + \ldots + c_{\ell} = c$. Then

$$\Delta(x,x) = \prod_{i=1}^{\ell} (1-\lambda_i^2) = \sum_{j=0}^{\ell} (-1)^j \sigma_j(\lambda_1^2, \dots, \lambda_{\ell}^2).$$

Thus the component of bi-degree (ℓ, ℓ) is given by $\Delta_{\ell}(x, x) = \sigma_{\ell}(\lambda_1^2, \dots, \lambda_{\ell}^2) = \prod_{i=1}^{\ell} \lambda_i^2 = N_c(x)^2$. \Box

Example 2.2. For $d = n+1 \ge 3$ consider $Z = \mathbf{C}^d$ with coordinates $z = (z_0, \ldots, z_n)$. Put $(z|w) := 2z \cdot \overline{w}$. Endowed with the triple product

$$\{x; y; z\} = (x|y)z + (z|y)x - (x|\overline{z})\overline{y}$$

Z becomes a hermitian Jordan triple of rank 2, called a **spin factor**, and denoted by $Z = IV_d$. Here a = n - 1 = d - 2 and b = 0. The minimal tripotents $e_1 := (\frac{1}{2}, \frac{i}{2}, 0, \dots, 0)$ and $e_2 := \overline{e}_1$ form a frame. Put $e := e_1 + e_2 = (1, 0, \dots, 0)$. Then

$$N(z) := \frac{1}{2}(z|\overline{z}) = z \cdot z = z_0^2 + \ldots + z_n^2$$

is the Jordan determinant normalized by N(e) = 1. For $\ell = 1$ we obtain the Kepler manifold

$$\mathring{Z}_1 = \{ z \in Z : z \neq 0, N(z) = 0 \} = \{ z \in \mathbf{C}^{n+1} \setminus \{ 0 \} : z \cdot z = z_0^2 + \ldots + z_n^2 = 0 \}$$

studied in [10]. Its closure is

$$Z_1 = \{ z \in Z : N(z) = 0 \} = \{ z \in \mathbf{C}^{n+1} : z \cdot z = z_0^2 + \ldots + z_n^2 = 0 \}.$$
 (2.3)

The compact manifold S_1 of all rank 1 tripotents can be identified with the **cosphere bundle** $\mathbf{S}^*(\mathbf{S}^n) = \{(x,\xi) : ||x|| = ||\xi|| = 1, x \cdot \xi = 0\}$ over \mathbf{S}^n via the map

$$\mathbf{S}^*(\mathbf{S}^n) \to S_1, \quad (x,\xi) \mapsto \frac{x+i\xi}{2}.$$

It follows that $\ddot{Z}_1 = \mathbf{R}_+ S_1$ is the cotangent bundle of \mathbf{S}^n without the zero-section.

Closely related to the Kepler manifold is the **Peirce manifold** M_{ℓ} of Z, consisting of all Peirce 2-spaces in Z of rank ℓ . This is a compact complex manifold, and there is a holomorphic submersion $\mathring{Z}_{\ell} \to M_{\ell}$ which maps $z \in \mathring{Z}_{\ell}$ to its (generalized) Peirce 2-space Z_z^2 [24]. Thus there is a holomorphic fibration

$$\overset{\circ}{Z}_{\ell} = \bigcup_{E \in M_{\ell}} \overset{\circ}{E}$$

$$S_{\ell} = \bigcup_{E \in M_{\ell}} S_{E},$$
(2.4)

and a real-analytic fibration

where S_E denotes the Shilov boundary relative to E.

Let $U := Z_c^2$, $V := Z_c^1$, $W := Z_c^0$ denote the Peirce spaces for the 'base point'

$$c := e_1 + \ldots + e_\ell \in S_\ell. \tag{2.5}$$

Then $U = X_c \oplus iX_c$. The compact manifold S_ℓ has the tangent space $T_c(S_\ell) = iX_c \oplus V$. Therefore (2.2) implies $T_c(\mathring{Z}_\ell) = U \oplus V = W^{\perp}$. It follows that

$$d_{\ell} := \dim \mathring{Z}_{\ell} = d'_{\ell} + d''_{\ell}, \tag{2.6}$$

where $d'_{\ell} := \dim U = \ell (1 + \frac{a}{2}(\ell - 1))$ and

$$d_{\ell}'' = \dim V = \ell(a(r-\ell) + b).$$
(2.7)

For $\ell = 1$ we obtain $d_1 = \dim_{\mathbf{C}} Z_1 = 1 + a(r-1) + b = p-1$, where p is the genus (2.1) of Z.

Denote by K^c the stabilizer of c in K. The following result is known for classical (non-exceptional) Jordan triples [18, Proposition 8.3] (with a case-by-case proof).

Theorem 2.3. For any hermitian Jordan triple Z, the Kepler variety Z_{ℓ} is normal.

Proof. In general, let G be a connected algebraic group, acting linearly on a vector space Z. Let $U \subset Z$ be a linear subspace and put $P := \{g \in G : gU = U\}$. Assume that M = G/P is complete and that the action of P on U is completely reducible. Consider the homogeneous vector bundle

$$G \times_P U = \{[g, u] = [gp, p^{-1}u] : g \in G, u \in U, p \in P\}$$

over G/P induced by the linear action of P on U. Then there is a G-equivariant morphism $f: G \times_P U \to Z$ given by $f[g, u] = g(u) = gp(p^{-1}u)$. Under these assumptions, [16, Theorem 0] asserts that the image $f(G \times_P U) \subset Z$ is a closed normal variety. We will apply this theorem to the hermitian Jordan triple Z and the connected algebraic group $G = \mathring{K}$ acting on Z. Put $U = Z_c^2$. Then $P = \{h \in \mathring{K} : hU = U\}$. Therefore $G/P = M_\ell$ is a compact, hence complete, complex manifold. The homogeneous vector bundle $\mathring{K} \times_P U$ coincides with the **tautological bundle** \mathcal{T}_ℓ over M_ℓ , whose fibre over $E \in M_\ell$ is E itself. The G-equivariant morphism $f: \mathcal{T}_\ell \to Z$ is the inclusion map $E \subset Z$ on each fibre E. Since Z_ℓ is the union of all Peirce 2-spaces of rank ℓ it follows that $f(\mathcal{T}_\ell) = Z_\ell$. The identity component L of the Jordan triple automorphism group of U acts irreducibly on U. Moreover, the natural restriction homomorphism $P \to L$ given by $p \mapsto p|_U$ is surjective, since for any $h \in L$ there exists $\tilde{h} \in K$ such that $\tilde{h}U = U$ and $h = \tilde{h}|_U$. Therefore P acts also irreducibly on U. Thus all the assumptions of [16, Theorem 0] are satisfied, and hence Z_ℓ is a normal Cohen-Macauley variety.

We remark that, moreover, the map $f: \mathcal{T}_{\ell} \to Z_{\ell}$ is birational, since it is an isomorphism from $\bigcup_{E \in M_{\ell}} \check{E}$ onto the Kepler manifold. Hence, by the same Theorem, Z_{ℓ} has only rational singularities.

For the spin factor, the variety Z_1 given by (2.3) is one of the 'standard' examples of a normal variety.

For any normal variety X the following 'Second Riemann Extension Theorem' [19, p. 341, Corollary] holds: Suppose the singular set $Y \subset X$ is of codimension ≥ 2 . Then every holomorphic function $f: X \setminus Y \to \mathbf{C}$ has a (unique) holomorphic extension $\tilde{f}: X \to \mathbf{C}$. We will apply this result to the Kepler varieties Z_{ℓ} .

The case where Z is of tube type and $\ell = r$ is somewhat exceptional and will be treated separately.

Theorem 2.4. Exclude the case $\ell = r$, b = 0. Then any holomorphic function $f : Z_{\ell} \to \mathbf{C}$ on the Kepler manifold has a unique holomorphic extension to its closure Z_{ℓ} .

Proof. By (2.6), the singular set $Z_{\ell-1}$ of Z_{ℓ} is an analytic subvariety of codimension $d_{\ell} - d_{\ell-1} = 1 + b + a(r-\ell) \ge 2$. Since Z_{ℓ} is normal by Theorem 2.3, the assertion follows by the Second Riemann Extension Theorem quoted above.

3. RADIAL MEASURES AND POLAR DECOMPOSITION

A K-invariant smooth measure ρ on \tilde{Z}_{ℓ} , or a suitable K-invariant subset, has a **polar decomposi**tion

$$\int_{\tilde{Z}_{\ell}} d\rho(z) f(z) := \int_{\Omega_c} d\tilde{\rho}(t) \int_{K} dk f(k\sqrt{t})$$
(3.1)

for all continuous compactly supported functions f. Here the **radial part** $d\tilde{\rho}(t)$ is a (smooth) measure on Ω_c which is invariant under the automorphism group $L_c = \operatorname{Aut}(X_c)$ of the euclidean Jordan algebra X_c . For $\ell = 1$, (3.1) simplifies to

$$\int_{\tilde{Z}_1} d\rho(z) \ f(z) := \int_0^\infty d\tilde{\rho}(t) \int_{S_1} ds \ f(s\sqrt{t}).$$
(3.2)

The basic K-invariant measure on Z_{ℓ} is the **Riemann measure** Λ_{ℓ} induced by the hermitian metric on Z. In general, a smooth map $\gamma : M \to N$ between Riemannian manifolds with Riemann measure Λ_M and Λ_N , respectively, satisfies

$$\gamma^* \Lambda_N = \delta \cdot \Lambda_M,$$

where the density δ on M is given by $\delta(z) := (\det T_z(\gamma)^* T_z(\gamma))^{1/2}$. If M, N are complex hermitian manifolds and γ is holomorphic, the density becomes $\delta(z) = \det(\gamma'(z)^* \gamma'(z))$ for the holomorphic derivative $\gamma'(z)$.

Lemma 3.1. Consider the map $\gamma : \Omega_c \times K/K^c \to \mathring{Z}_\ell$ defined by $\gamma(t, kK^c) := kt$ for all $k \in K$ and $t \in \Omega_c$. Then $(\det T_{t,c}(\gamma)^*T_{t,c}(\gamma))^{1/2} = 2^{-d'_\ell} N_c(t)^{2d''_\ell/\ell} \det F'(t)$, where $F(t) = t^2 = Q_t c = \frac{1}{2} \{t; c; t\}$ is the square-map on Ω_c .

Proof. Since $K/K^c = S_\ell$, with base point c, we have $T_c(K/K^c) = iX_c \oplus V$. For $y \in iX_c$ the vector field $\xi_y := \frac{1}{4}(D(y,c) - D(c,y)) \in \mathfrak{k}$ satisfies $\xi_y c = \frac{1}{2}D(y,c)c = y$ since D(c,y)c = -D(y,c)c. For $v \in V$ the vector field $\xi_v := D(v,c) - D(c,v) \in \mathfrak{k}$ satisfies $\xi_v c = D(v,c)c = v$ since D(c,v)c = 0. Let $t \in \Omega_c$. Since D(c,y)t = -D(y,c)t and D(c,v)t = 0, it follows that

$$T_{t,c}(\gamma)(y+v,x) = x + \xi_y t + \xi_v t = x + \frac{1}{2}\{y;c;t\} + \{v;c;t\} = x + \frac{1}{2}D(t,c)y + D(t,c)v$$

for all $x \in T_t(\Omega_c) = X_c$. Thus $T_{t,c}(\gamma) = id_{X_c} \oplus \frac{1}{2}D(t,c)|_{iX_c} \oplus D(t,c)|_V$ is a block-diagonal matrix with respect to the orthogonal decomposition $X_c \oplus iX_c \oplus V$. Since the square-map has the derivative $F'(t) = D(t,c)|_{X_c}$, it follows that $\det D(t,c)|_{iX_c} = \det D(t,c)|_{X_c} = \det F'(t)$. Hence

$$\det(T_{t,c}(\gamma)^*T_{t,c}(\gamma))^{1/2} = 2^{-d'_{\ell}} \det D(t,c)|_{iX_c} \det D(t,c)|_{V_{\mathbf{R}}} = 2^{-d'_{\ell}} \det F'(t) |\det D(t,c)|_{V}|^2.$$

The map $u \mapsto D(u,c)|_V$ is a representation of U on V, with $D(c,c)|_V = id$. Thus (2.7) implies

$$\det D(u,c)|_V = N_c(u)^{d'_\ell/\ell} \tag{3.3}$$

for all $u \in U$. Putting u := t the assertion follows.

For any $1 \leq \ell \leq r$ the Peirce manifold M_{ℓ} can be regarded as the conformal compactification [20] of the Peirce 1-space Z_c^1 , considered as a hermitian Jordan subtriple of Z. The normalized inner product on Z (with minimal tripotents of length 1) induces an inner product on Z_c^1 and hence an invariant volume form on $\hat{Z}_c^1 \approx M_{\ell}$. Somewhat surprisingly, the associated volume $|M_{\ell}|$ can be expressed in a uniform way using the invariants of Z.

Proposition 3.2. Let $1 \le \ell \le r$. Then the volume $|M_{\ell}|$ of the ℓ -th Peirce manifold M_{ℓ} satisfies

$$\frac{|M_{\ell}|}{\pi^{d_{\ell}''}} = \frac{\Gamma_{\ell}(d_{\ell}'/\ell) \ \Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)}$$
(3.4)

(this yields the value 1 in the extreme case $\ell = r, b = 0$).

Proof. The volume $|\hat{Z}|$ of the conformal compactification \hat{Z} of an irreducible hermitian Jordan triple Z, under the invariant metric induced by the normalized inner product on $Z = T_0(\hat{Z})$, satisfies

$$\frac{|\vec{Z}|}{\pi^d} = \int_{Z} \frac{dw}{\pi^d} \Delta(w, -w)^{-p} = \frac{\Gamma_r(p - d/r)}{\Gamma_r(p)} = \frac{\Gamma_r(d'/r)}{\Gamma_r(p)}.$$
(3.5)

(see, e.g., [11, p. 5]). This can also be verified using the case-by-case formulas of [1] where, however, a different normalization is used. We will show that applying (3.5) to Z_c^1 one obtains (3.4). This is not obvious since the type of Z_c^1 is quite different from the type of Z. We denote by $\Gamma^{(a)}$ the Gindikin Gamma-function for parameter a. It suffices to compare the 'reduced' volumes $|\cdot|_{red}$ obtained by dividing by $\pi^{d''_{\ell}}$. For the **symmetric matrices** $Z = \mathbf{C}_{sum}^{r \times r}$, the rank of $Z_c^1 = \mathbf{C}^{\ell \times (r-\ell)}$ is given by $\min(\ell, r-\ell)$.

Evaluating (3.4) with a = 1, d/r = (r+1)/2 and $d'_{\ell}/\ell = (\ell+1)/2$, we obtain, using the duplication formula and the elementary relation $\Gamma_{\ell}^{(2)}(\ell) \Gamma_{n-\ell}^{(2)}(n) = \Gamma_n^{(2)}(n) = \Gamma_{n-\ell}^{(2)}(n-\ell) \Gamma_{\ell}^{(2)}(n)$

$$\frac{\Gamma_{\ell}^{(1)}(\frac{\ell+1}{2}) \Gamma_{\ell}^{(1)}(\frac{\ell}{2})}{\Gamma_{\ell}^{(1)}(\frac{r+1}{2}) \Gamma_{\ell}^{(1)}(\frac{r}{2})} = \prod_{i=1}^{\ell} \frac{\Gamma(\frac{\ell+1}{2} - \frac{i-1}{2}) \Gamma(\frac{\ell}{2} - \frac{i-1}{2})}{\Gamma(\frac{r+1}{2} - \frac{i-1}{2}) \Gamma(\frac{r}{2} - \frac{i-1}{2})} \\
= 2^{\ell(r-\ell)} \prod_{i=1}^{\ell} \frac{\Gamma(\ell+1-i)}{\Gamma(r+1-i)} = 2^{\ell(r-\ell)} \frac{\Gamma_{\ell}^{(2)}(\ell)}{\Gamma_{\ell}^{(2)}(r)} = 2^{\ell(r-\ell)} \frac{\Gamma_{r-\ell}^{(2)}(r-\ell)}{\Gamma_{r-\ell}^{(2)}(r)} = |\hat{Z}_{c}^{1}|_{red} \tag{3.6}$$

since under the induced inner product minimal tripotents in Z_c^1 have length $\sqrt{2}$, so the induced inner product is twice the normalized inner product relative to Z_c^1 . In all other cases, minimal tripotents in Z_c^1 are also minimal in Z, hence the normalized inner products agree. For the full matrices $Z = \mathbf{C}^{r \times s}$ with $r \leq s$, the factors of the product $Z_c^1 = \mathbf{C}^{\ell \times (s-\ell)} \times \mathbf{C}^{(r-\ell) \times \ell}$ have rank $\min(\ell, s-\ell)$ and $\min(\ell, r-\ell)$, respectively. Evaluating (3.4) with a = 2, $d'_{\ell}/\ell = \ell$ and d/r = s, yields

$$\frac{\Gamma_{\ell}^{(2)}(\ell)}{\Gamma_{\ell}^{(2)}(s)} \ \frac{\Gamma_{\ell}^{(2)}(\ell)}{\Gamma_{\ell}^{(2)}(r)} = \frac{\Gamma_{\ell}^{(2)}(\ell)}{\Gamma_{\ell}^{(2)}(s)} \ \frac{\Gamma_{r-\ell}^{(2)}(r-\ell)}{\Gamma_{r-\ell}^{(2)}(r)} = \frac{\Gamma_{s-\ell}^{(2)}(s-\ell)}{\Gamma_{s-\ell}^{(2)}(s)} \ \frac{\Gamma_{r-\ell}^{(2)}(r-\ell)}{\Gamma_{r-\ell}^{(2)}(r)} = |\hat{Z}_{c}^{1}|_{red}.$$

For the **anti-symmetric matrices** $Z = \mathbf{C}_{asym}^{n \times n}$, with $n = 2r + \epsilon$ and $\epsilon = 0, 1$, the rank of $Z_c^1 = \mathbf{C}^{2\ell \times (n-2\ell)}$ is given by min $(2\ell, n-2\ell)$. Evaluating (3.4) with a = 4, $d/r = 2r - 1 + 2\epsilon$, $d'_{\ell}/\ell = 2\ell - 1$ yields

$$\frac{\Gamma_{\ell}^{(4)}(2\ell-1) \Gamma_{\ell}^{(4)}(2\ell)}{\Gamma_{\ell}^{(4)}(2r-1+2\epsilon) \Gamma_{\ell}^{(4)}(2r)} = \prod_{i=1}^{\ell} \frac{\Gamma(2\ell-1-2(i-1)) \Gamma(2\ell-2(i-1))}{\Gamma(2r-1+2\epsilon-2(i-1)) \Gamma(2r-2(i-1))}$$
$$= \prod_{j=1}^{2\ell} \frac{\Gamma(2\ell+1-j)}{\Gamma(2r+\epsilon+1-j)} = \frac{\Gamma_{2\ell}^{(2)}(2\ell)}{\Gamma_{2\ell}^{(2)}(n)} = \frac{\Gamma_{n-2\ell}^{(2)}(n-2\ell)}{\Gamma_{n-2\ell}^{(2)}(n)} = |\hat{Z}_{c}^{1}|_{red}.$$

For the spin factor $Z = IV_d$, we may assume $d \ge 5$ since $IV_3 = \mathbf{C}_{sym}^{2\times 2}$ and $IV_4 = \mathbf{C}^{2\times 2}$. Then $Z_c^1 = IV_{d-2}$. Evaluating (3.4) for a = d-2, $\ell = 1$, $d'_1/1 = 1$ yields

$$\frac{\Gamma_1^{(d-2)}(1) \ \Gamma_1^{(d-2)}(\frac{d}{2}-1)}{\Gamma_1^{(d-2)}(\frac{d}{2}) \ \Gamma_1^{(d-2)}(d-2)} = \frac{\Gamma(1) \ \Gamma(\frac{d}{2}-1)}{\Gamma(\frac{d}{2}) \ \Gamma(d-2)} = \frac{\Gamma_2^{(d-4)}(\frac{d}{2}-1)}{\Gamma_2^{(d-4)}(d-2)} = |\hat{Z}_c^1|_{red}$$

The exceptional Jordan triple $Z = \mathbf{O}_{\mathbf{C}}^{1 \times 2}$ has r = 2, a = 6, d/r = 8. For $\ell = 1$ we have $Z_c^1 = \mathbf{C}_{asym}^{5 \times 5}$. Evaluating (3.4) yields

$$\frac{\Gamma_1^{(6)}(3) \ \Gamma_1^{(6)}(1)}{\Gamma_1^{(6)}(8) \ \Gamma_1^{(6)}(6)} = \frac{\Gamma(3) \ \Gamma(1)}{\Gamma(8) \ \Gamma(6)} = \frac{\Gamma_2^{(4)}(3)}{\Gamma_2^{(4)}(8)} = |\hat{Z}_c^1|_{red}.$$

For $\ell = 2$ we have $Z_e^2 = Z_e^1 = IV_8$. Evaluating (3.4) with $d'_2/2 = 4$ yields

$$\frac{\Gamma_2^{(6)}(4)}{\Gamma_2^{(6)}(8)}\frac{\Gamma_2^{(6)}(6)}{\Gamma_2^{(6)}(6)} = \frac{\Gamma_2^{(6)}(4)}{\Gamma_2^{(6)}(8)} = |\hat{Z}_e^1|_{red}.$$

For the exceptional Jordan algebra $Z = \mathcal{H}_3(\mathbf{O}) \otimes \mathbf{C}$ of rank 3, we have $Z_c^1 = \mathbf{O}_{\mathbf{C}}^{1 \times 2}$ both for $\ell = 1$ and $\ell = 2$. Evaluating (3.4) with a = 8, d/r = 9 and $d'_1/1 = 1$, $d'_2/2 = 5$ yields

$$\frac{\Gamma_1^{(8)}(1)\ \Gamma_1^{(8)}(4)}{\Gamma_1^{(8)}(9)\ \Gamma_1^{(8)}(12)} = \frac{\Gamma_2^{(8)}(5)\ \Gamma_2^{(8)}(8)}{\Gamma_2^{(8)}(9)\ \Gamma_2^{(8)}(12)} = \frac{\Gamma(1)\ \Gamma(4)}{\Gamma(9)\ \Gamma(12)} = \frac{\Gamma_2^{(6)}(4)}{\Gamma_2^{(6)}(12)} = |\hat{Z}_c^1|_{red}.$$

Corollary 3.3. The tripotent manifold S_{ℓ} , considered as a closed Riemannian submanifold of Z, has the volume

$$|S_{\ell}| = 2^{d'_{\ell}} \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \pi^{d_{\ell}}.$$
(3.7)

Proof. Since the fibration (2.4) is orthogonal under the Riemann measure, it follows that $|S_{\ell}| = |M_{\ell}| \cdot |S_c|$, where S_c is the Shilov boundary of Z_c^2 . Since $|S_c| = \frac{(2\pi)^{d'_{\ell}}}{\Gamma_{\ell}(d'_{\ell}/\ell)}$ by [14, Corollary X.2.5] applied to Z_c^2 , the assertion follows with Proposition 3.2.

Theorem 3.4. The Riemann measure Λ_{ℓ} on \mathring{Z}_{ℓ} has the radial part

$$d\tilde{\Lambda}_{\ell}(t) = \frac{\pi^{d_{\ell}} \Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \Gamma_{\ell}(ar/2)} N_{c}(t)^{d_{\ell}''/\ell} dt$$
(3.8)

on Ω_c . In particular, $d\tilde{\Lambda}_1(t) = \frac{\pi^{p-1} \Gamma(a/2)}{\Gamma(d/r) \Gamma(ar/2)} t^{p-2} dt$ for t > 0. For the spin factor of dimension n+1, we obtain $d\tilde{\Lambda}_1(t) = \frac{2\pi^n}{(n-1)!} t^{n-1} dt$.

Proof. Let ds be the normalized K-invariant measure on S_{ℓ} . Then $\Omega_c \times S_{\ell}$ has the Riemann measure $|S_{\ell}| dt ds$. Therefore Lemma 3.1 implies

$$\begin{split} \int_{\mathring{Z}_{\ell}} d\Lambda_{\ell}(z) \ f(z) &= \int_{\Omega_{c} \times S_{\ell}} d(\gamma^{*}\Lambda_{\ell})(t,s) \ f(\gamma(t,s)) = |S_{\ell}| \int_{\Omega_{c}} dt \int_{S_{\ell}} ds \ (\det T_{t,s}(\gamma)^{*}T_{t,s}(\gamma))^{1/2} \ f(\gamma(t,s)) \\ &= |S_{\ell}| \int_{\Omega_{c}} dt \int_{K} dk \ (\det T_{t,kc}(\gamma)^{*}T_{t,kc}(\gamma))^{1/2} \ f(kt) = |S_{\ell}| \int_{\Omega_{c}} dt \ (\det T_{t,c}(\gamma)^{*}T_{t,c}(\gamma))^{1/2} \int_{K} dk \ f(kt) \\ &= \frac{|S_{\ell}|}{2^{d'_{\ell}}} \int_{\Omega_{c}} dt \ \det F'(t) \ N_{c}(t)^{2d''_{\ell}/\ell} \int_{K} dk \ f(kt). \end{split}$$

Replacing t by \sqrt{t} it follows that $d\tilde{\Lambda}_{\ell}(t) = \frac{|S_{\ell}|}{2^{d'_{\ell}}} N_c(t) d''_{\ell}/\ell dt$. Now the assertion follows with (3.7).

Replacing f by $f \circ \lambda^{-1/2}$ for the dilation $z \mapsto \lambda^{-1/2} z$ with $\lambda > 0$, the left hand side of (3.8) scales as $\lambda^{d_{\ell}}$, whereas the right hand side scales as $\lambda^{d'_{\ell}+\ell d''_{\ell}/\ell}$. Thus the power $N_c(x)^{d''_{\ell}/\ell}$ is confirmed by this scaling argument.

Any absolutely continuous K-invariant measure ρ on Z_{ℓ} has a positive K-invariant density δ on Z_{ℓ} with respect to the Riemann measure. It follows that ρ has the radial part

$$d\tilde{\rho}(t) = d\tilde{\Lambda}_{\ell}(t) \ \delta(\sqrt{t}) = \frac{\pi^{d_{\ell}} \ \Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \ N_{c}(t)^{d_{\ell}^{\prime\prime}/\ell} \ \delta(\sqrt{t}) \ dt.$$
(3.9)

As an example, Lemma 2.1 implies

$$\int_{\mathring{Z}_{\ell}} d\Lambda_{\ell}(z) \ \Delta_{\ell}(z,z)^{\beta} \ f(z) = \frac{\pi^{d_{\ell}} \ \Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \int_{\Omega_{c}} dt \ N_{c}(t)^{d_{\ell}^{\prime\prime}/\ell+\beta} \int_{K} dk \ f(k\sqrt{t}).$$

Lemma 3.5. The holomorphic chart $\tau : \mathring{U} \times V \to \mathring{Z}_{\ell}$ defined by $\tau(u, v) := B_{v,-c}u$, satisfies $\tau'_{u,v}(\xi, \eta) = B_{v,-c}(\xi + D_{u,c}\eta)$ for all $\xi \in U, \eta \in V$.

Proof. For $z = (u, v) \in W^{\perp}$ we have $Z_{\tau_z}^0 = Z_{B(v, -c)u}^0 = B_{c, -v}^{-1} Z_u^0 = B_{c, -v}^{-1} W$. As a consequence of [20, JP13] we have $D_{v,c}D_{u,c}\eta = D_{v,Q_cu}\eta$ for all $\eta \in V$, since $Q_c\eta = 0$. With $Q_cD_{u,c}\eta = 0$ it follows that

$$B_{v,-c}D_{u,c}\eta = D_{u,c}\eta + D_{v,c}D_{u,c}\eta + Q_vQ_cD_{u,c}\eta = D_{u,c}\eta + D_{v,c}D_{u,c}\eta = D_{u,c}\eta + D_{v,Q_cu}\eta.$$

 $\begin{array}{l} \text{Therefore } \tau'_{u,v}(\xi,\eta) = \xi + D(\eta,c)u + D(v,c)\xi + Q_vQ_c\xi + D(v,Q_cu)\eta = B_{v,-c}\xi + D(u,c)\eta + D(v,Q_cu)\eta = B_{v,-c}(\xi + D_{u,c}\eta) \text{ for all } \xi \in U, \eta \in V. \end{array}$

Since $d\lambda(z) = du \, dv$ is the Lebesgue measure on $W^{\perp} = U \oplus V$, the Riemann measure Λ_{ℓ} on \mathring{Z}_{ℓ} has the pull-back

$$\tau^* \Lambda_\ell = \det(\tau_z'^* \tau_z') \ d\lambda(z). \tag{3.10}$$

Interesting K-invariant measures arise from **Kähler potentials**. A strictly-plurisubharmonic function ϕ on a complex manifold of dimension n induces a Kähler form $\omega = \partial \overline{\partial} \phi$, with associated (n, n)-form ω^n and measure denoted by $|\omega^n|$. If $\omega = \sum_{i,j} \omega_{ij}(z) dz_i \wedge d\overline{z}_j$ is a (1,1)-form on W^{\perp} , then

$$\frac{\omega^n}{n!} = \det\left(\omega_{ij}(z)\right) \, dz_1 \wedge d\overline{z}_1 \wedge \ldots \wedge dz_n \wedge d\overline{z}_n.$$

If ψ is a smooth function on W^{\perp} , then $\partial \overline{\partial} \psi(z) = \sum_{i,j} \partial_i \overline{\partial}_j \psi(z) \, dz_i \wedge d\overline{z}_j$ is a (1,1)-form and

$$\frac{(\partial\overline{\partial}\psi)^n}{n!} = \det\left(\partial_i\overline{\partial}_j\psi(z)\right)\,dz_1\wedge d\overline{z}_1\wedge\ldots\wedge dz_n\wedge d\overline{z}_n.$$

We will study two cases where symplectic potentials arise naturally. Define a **bounded version** of the Kepler manifold ('Kepler ball') by taking the intersection with the bounded symmetric domain (spectral unit ball) \check{Z} of the underlying hermitian Jordan triple Z.

Proposition 3.6. (i) Consider the plurisubharmonic function $\phi_{\ell}(w) := (w|w)^{\alpha}$ on \mathring{Z}_{ℓ} , where $\alpha > 0$. Then

$$\frac{|(\partial \overline{\partial} \phi_{\ell})^{d_{\ell}}|}{d_{\ell}! \ 2^{d_{\ell}}} = \alpha^{d_{\ell}+1} (w|w)^{d_{\ell}(\alpha-1)} \ d\Lambda_{\ell}(w).$$

(ii) Consider the plurisubharmonic function $\phi_{\ell}(w) := \log \Delta(w, w)^{-p}$ on the Kepler ball $\mathring{Z}_{\ell} \cap \check{Z}$. Then

$$\frac{|(\partial \overline{\partial} \phi_{\ell})^{d_{\ell}}|}{d_{\ell}! \ 2^{d_{\ell}}} = \Delta(w, w)^{-p} \ d\Lambda_{\ell}(w).$$

Proof. Consider the holomorphic chart τ defined in Lemma 3.5, and let z_i be an orthonormal basis of W^{\perp} . Suppose that det $\left(\partial_i \overline{\partial}_j (\phi \circ \tau)(z)\right) = \det(\tau'_z^* \tau'_z) F(\tau_z)$ for some smooth function F. Then (3.10) implies

$$\tau^* \frac{|(\partial \overline{\partial} \phi)^{d_\ell}|}{d_\ell! 2^{d_\ell}} = \frac{|(\partial \overline{\partial} (\phi \circ \tau))^{d_\ell}|}{d_\ell! 2^{d_\ell}} = \det \left(\partial_i \overline{\partial}_j (\phi \circ \tau)(z)\right) d\lambda(z)$$
$$= F(\tau_z) \ \det(\tau'_z {}^* \tau'_z) \ d\lambda(z) = F(\tau_z) \ \tau^* \Lambda_\ell = \tau^* \Big(F(w) \ d\Lambda_\ell(w)\Big).$$

(i) In the first case we have

$$\frac{\partial_u \overline{\partial}_v (\phi_\ell \circ \tau)(z)}{\alpha (\tau_z | \tau_z)^{\alpha - 1}} = (\tau_z' u | \tau_z' v) + \frac{\alpha - 1}{(\tau_z | \tau_z)} (\tau_z' u | \tau_z) (\tau_z | \tau_z' v) = \left(u \Big| \tau_z'^* \Big(id + \frac{\alpha - 1}{(\tau_z | \tau_z)} \tau_z \tau_z^* \Big) \tau_z' v \Big),$$

where $\xi \eta^* v := \xi(\eta|v)$. The inner 'matrix' $id + \frac{\alpha - 1}{(\tau_z|\tau_z)} \tau_z \tau_z^*$ is the identity on $(Ran \ \tau_z')^{\perp} = Z_{\tau_z}^0$ since $\tau_z^*(Z_{\tau_z}^0) = (\tau_z|Z_{\tau_z}^0) = \{0\}$. It follows that

$$\frac{1}{\alpha^{d_{\ell}} (\tau_{z}|\tau_{z})^{d_{\ell}(\alpha-1)}} \frac{\det\left(\partial_{i}\overline{\partial}_{j}(\phi_{\ell}\circ\tau)(z)\right)}{\det(\tau'_{z}{}^{*}\tau'_{z})} = \det_{T_{\tau_{z}}(\mathring{Z}_{\ell})}\left(id + \frac{\alpha-1}{(\tau_{z}|\tau_{z})}\tau_{z}\tau^{*}_{z}\right)$$
$$= \det_{Z}\left(id + \frac{\alpha-1}{(\tau_{z}|\tau_{z})}\tau_{z}\tau^{*}_{z}\right) = 1 + \frac{\alpha-1}{(\tau_{z}|\tau_{z})}\operatorname{tr}\tau_{z}\tau^{*}_{z} = \alpha.$$

(ii) In the bounded case, by [20], the Bergman metric on \check{Z} is given by $(B_{z,z}^{-1}u|v)$ for $z \in \check{Z}$ and tangent vectors $u, v \in T_z(\check{Z}) = Z$. Hence $\partial_u \overline{\partial}_v \log \Delta(z,z)^{-p} = \partial_u \overline{\partial}_v \log \det B(z,z)^{-1} = (B_{z,z}^{-1}u|v)$. Since the chart τ is holomorphic, we obtain for $\xi, \eta \in W^{\perp}$

$$\partial_{\xi}\overline{\partial}_{\eta}(\phi_{\ell}\circ\tau)(z) = (B_{\tau_z,\tau_z}^{-1}\tau'_z\xi|\tau'_z\eta) = (\xi|\tau'^*_zB_{\tau_z,\tau_z}^{-1}\tau'_z\eta).$$

For any $w \in \mathring{Z}_{\ell}$ we have $T_w(\mathring{Z}_{\ell}) = Z_w^2 \oplus Z_w^1$, and $B_{w,w}|_{Z_w^0} = id$. It follows that

$$\frac{\det\left(\partial_i\overline{\partial}_j(\phi_\ell\circ\tau)(z)\right)}{\det(\tau_z'^*\tau_z')} = \det_{T_{\tau_z}(\mathring{Z}_\ell)}B_{\tau_z,\tau_z}^{-1} = \det_Z B_{\tau_z,\tau_z}^{-1} = \Delta(\tau_z,\tau_z)^{-p}.$$

Associated with the Kähler potentials ϕ_{ℓ} we consider, for $\nu > 0$, the K-invariant measures

$$\rho_{\ell}^{\nu} := e^{-\nu \phi_{\ell}(w)} \frac{|(\partial \partial \phi_{\ell})^{d_{\ell}}|}{d_{\ell}! (2\pi)^{d_{\ell}}}.$$
(3.11)

Corollary 3.7. (i) For the potential $\phi_{\ell}(w) = (w|w)^{\alpha}$ on \mathring{Z}_{ℓ} the measure (3.11) has the radial part

$$d\tilde{\rho}(t) = \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \alpha^{d_{\ell}+1} \ N_{c}(t)^{d_{\ell}''/\ell} \ (t|c)^{d_{\ell}(\alpha-1)} \ e^{-\nu(t|c)^{\alpha}} \ dt$$
(3.12)

on Ω_c . In particular, $d\tilde{\rho}_1^{\nu}(tc) = \alpha^p t^{p-2} t^{(p-1)(\alpha-1)} e^{-\nu t^{\alpha}} dt = \alpha^p t^{\alpha(p-1)-1} e^{-\nu t^{\alpha}} dt$ for t > 0. (ii) For the potential $\phi_{\ell}(w) = \log \Delta(w, w)^{-p}$ on $\mathring{Z}_{\ell} \cap \check{Z}$, the measure (3.11) has the radial part

$$d\tilde{\rho}(t) = \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \ N_c(t)^{d_{\ell}''/\ell} \ N_c(c-t)^{\nu-p} \ dt$$
(3.13)

on $\Omega_c \cap (c - \Omega_c)$. In particular, $d\tilde{\rho}_1^{\nu}(tc) = t^{p-2} (1-t)^{\nu-p} dt$ for 0 < t < 1.

Proof. Since $(\sqrt{t}|\sqrt{t}) = (t|c)$ for all $t \in \Omega_c$ and $\Delta(\sqrt{t}, \sqrt{t}) = N_c(c-t)$ for all $t \in \Omega_c \cap (c - \Omega_c)$, the assertion follows with (3.8) and Proposition 3.6.

4. Reproducing Kernel Hilbert spaces

Let \mathbf{N}^r_+ be the set of all partitions \boldsymbol{m} of length $\leq r$ and denote by $E^{\boldsymbol{m}}(z,w) = E^{\boldsymbol{m}}_w(z)$ the Fischer-Fock reproducing kernel for the Peter-Weyl space $\mathcal{P}_{\boldsymbol{m}}(Z)$. Thus

$$e^{(z|w)} = \sum_{\boldsymbol{m}} E^{\boldsymbol{m}}(z, w).$$
(4.1)

Putting $|\boldsymbol{m}| := m_1 + \ldots + m_r$, it follows that

$$\frac{(z|w)^k}{k!} = \sum_{|\boldsymbol{m}|=k} E^{\boldsymbol{m}}(z,w).$$
(4.2)

Put $d_m := \dim \mathcal{P}_m(Z)$. Consider the Gindikin-Koecher Gamma function

$$\Gamma_r(\boldsymbol{m}) = (2\pi)^{\frac{r(r-1)}{4}a} \prod_{j=1}^r \Gamma(m_j - \frac{j-1}{2}a)$$
(4.3)

and define the generalized **Pochhammer symbol**, for a complex number s and $m \in \mathbf{N}_{+}^{r}$, by

$$(s)_{m} = \frac{\Gamma_{r}(m+s)}{\Gamma_{r}(s)} = \prod_{j=1}^{r} (s - \frac{j-1}{2}a)_{m_{j}}.$$
(4.4)

Then [14, Section IX.4] implies

$$E^{\boldsymbol{m}}(e,e) = \frac{d_{\boldsymbol{m}}}{(d/r)_{\boldsymbol{m}}}.$$
(4.5)

It follows that $E_e^{\boldsymbol{m}}(z) = \frac{d_{\boldsymbol{m}}}{(d/r)_{\boldsymbol{m}}} \Phi_{\boldsymbol{m}}(z)$, where $\Phi_{\boldsymbol{m}}$ is the so-called **spherical polynomial** of type \boldsymbol{m} . This relationship will often be used later.

Lemma 4.1. For partitions (m) = (m, 0, ..., 0) of length $\ell = 1$, we have

$$E^{(m)}(z,w) = \frac{(z|w)^m}{m!} \quad \forall \ z,w \in \mathring{Z}_1.$$
(4.6)

Proof. The vector space $\mathcal{P}_{\boldsymbol{m}}(Z)$ is spanned by K-translates of the highest weight polynomial

 $N_{\boldsymbol{m}}(z) = N_1(z)^{m_1 - m_2} N_2(z)^{m_2 - m_3} \cdots N_r(z)^{m_r}.$

Now suppose that $m_2 > 0$. Then every $p \in \mathcal{P}_m(Z)$ vanishes on \mathring{Z}_1 . Since $E_w^m \in \mathcal{P}_m(Z)$ for all $w \in Z$ it follows that $E^m(z, w) = E_w^m(z) = 0$ if $z \in \mathring{Z}_1$. This implies (4.6) for $z, w \in \mathring{Z}_1$, since the sum in (4.2) has only terms with $m_2 = 0$.

Lemma 4.2. Let $z, w, c \in Z$. Then

$$\int_{K} dk \ E^{\boldsymbol{m}}(z, kc) \ E^{\boldsymbol{n}}(kc, w) = \frac{\delta_{\boldsymbol{m}, \boldsymbol{n}}}{d_{\boldsymbol{m}}} \ E^{\boldsymbol{m}}(c, c) \ E^{\boldsymbol{m}}(z, w).$$

In particular, choosing $c = e_1 + \ldots + e_\ell$, we have

$$(E_z^{\boldsymbol{m}}|E_w^{\boldsymbol{n}})_{S_\ell} = \int\limits_{S_\ell} ds \ E^{\boldsymbol{m}}(z,s) \ E^{\boldsymbol{n}}(s,w) = \frac{\delta_{\boldsymbol{m},\boldsymbol{n}}}{d_{\boldsymbol{m}}} \ E^{\boldsymbol{m}}(c,c) \ E^{\boldsymbol{m}}(z,w).$$

In the special case $\ell = 1$, we have $\int\limits_{S_1} ds \ (z|s)^m \ (s|w)^n = \frac{\delta_{m,n}}{d_{(m)}} \ (z|w)^m \quad \forall \ z, w \in \mathring{Z}_1.$

Proof. Applying Schur orthogonality [8, Theorem 14.3.3] to the compact group K and its irreducible representation π on $\mathcal{P}_{\boldsymbol{m}}(Z)$ it follows that

$$\int_{K} dk \ E^{m}(z,ks) \ E^{n}(ks,w) = \int_{K} dk \ (E^{m}_{z}|E^{m}_{ks})(E^{n}_{ks}|E^{n}_{w})$$
$$= \int_{K} dk \ (E^{m}_{z}|k^{\pi}E^{m}_{s})(k^{\pi}E^{n}_{s}|E^{n}_{w}) = \frac{\delta_{m,n}}{d_{m}}(E^{m}_{s}|E^{m}_{s})(E^{m}_{z}|E^{m}_{w}) = \frac{\delta_{m,n}}{d_{m}} \ E^{m}(s,s) \ E^{m}(z,w).$$

The special case $\ell = 1$ follows from Lemma 4.1 since (s|s) = 1 for all $s \in S_1$.

From now until the conclusion of this section, let us temporarily exclude the 'top rank on tube domain' case $\ell = r$, b = 0. Since polynomials in \mathcal{P}_m vanish on elements of rank ℓ if $m_{\ell+1} > 0$, Theorem 2.4 implies that any holomorphic function f on \mathring{Z}_{ℓ} (or on a suitable K-invariant open subset containing the origin) has the Peter-Weyl expansion

$$f = \sum_{\boldsymbol{m} \in \mathbf{N}_{+}^{\ell}} f_{\boldsymbol{m}},\tag{4.7}$$

where $\mathbf{N}_{+}^{\ell} := \{ \boldsymbol{m} \in \mathbf{N}_{+}^{r} : \boldsymbol{m}_{\ell+1} = 0 \}$ denotes the set of all partitions of length $\leq \ell$. For a given coefficient 'sequence' $\sigma = (\sigma_{\boldsymbol{m}})_{\boldsymbol{m} \in \mathbf{N}_{+}^{\ell}}$, let \mathcal{H}_{σ} denote the Hilbert space of all holomorphic functions on \mathring{Z}_{ℓ} (or a suitable K-invariant open subset), endowed with the inner product

$$(f|g)_{\sigma} := \sum_{\boldsymbol{m} \in \mathbf{N}_{+}^{\ell}} \sigma_{\boldsymbol{m}}(f_{\boldsymbol{m}}|g_{\boldsymbol{m}})_{S_{\ell}}$$

$$(4.8)$$

in terms of the Peter-Weyl decomposition (4.7). In case $\ell = 1$ for $f, g \in \mathcal{H}_{\sigma}$ we have

$$(f|g)_{\sigma} = \sum_{m=0}^{\infty} \sigma_m (f_m|g_m)_{S_1}.$$

Proposition 4.3. The reproducing kernel of \mathcal{H}_{σ} has the **Peter-Weyl decomposition**

$$\mathcal{K}^{\sigma}(z,w) = \sum_{\boldsymbol{m}\in\mathbf{N}_{+}^{\ell}} \frac{(d_{\ell}^{\prime}/\ell)_{\boldsymbol{m}}}{\sigma_{\boldsymbol{m}}} \frac{d_{\boldsymbol{m}}}{d_{\boldsymbol{m}}^{c}} E^{\boldsymbol{m}}(z,w) \quad \forall \ z,w \in \mathring{Z}_{\ell},$$
(4.9)

where $d_{\boldsymbol{m}}^c := \dim \mathcal{P}_{\boldsymbol{m}}(Z_c^2)$. For $\ell = 1$ this simplifies to

$$\mathcal{K}^{\sigma}(z,w) = \sum_{m \ge 0} \frac{d_{(m)}}{\sigma_m} \ (z|w)^m.$$
(4.10)

Proof. There exist constants $c_m > 0$ such that

$$\mathcal{K}^{\sigma}(z,w) = \mathcal{K}^{\sigma}_{w}(z) = \sum_{\boldsymbol{m} \in \mathbf{N}^{\ell}_{+}} c_{\boldsymbol{m}} \ E^{\boldsymbol{m}}(z,w) = \sum_{\boldsymbol{m} \in \mathbf{N}^{\ell}_{+}} c_{\boldsymbol{m}} \ E^{\boldsymbol{m}}_{w}(z).$$

The reproducing property and (4.8) yield

$$\sum_{\boldsymbol{m}} c_{\boldsymbol{m}} E^{\boldsymbol{m}}(z,w) = \mathcal{K}^{\sigma}(z,w) = (\mathcal{K}_{z}^{\sigma}|\mathcal{K}_{w}^{\sigma})_{\sigma} = \sum_{\boldsymbol{m}} \sigma_{\boldsymbol{m}} c_{\boldsymbol{m}}^{2} (E_{z}^{\boldsymbol{m}}|E_{w}^{\boldsymbol{m}})_{S_{\ell}} = \sum_{\boldsymbol{m}} \frac{\sigma_{\boldsymbol{m}}c_{\boldsymbol{m}}^{2}}{d_{\boldsymbol{m}}} E^{\boldsymbol{m}}(c,c) E^{\boldsymbol{m}}(z,w).$$

Comparing coefficients it follows that

$$\frac{1}{c_{\boldsymbol{m}}} = \frac{\sigma_{\boldsymbol{m}}}{d_{\boldsymbol{m}}} \ E^{\boldsymbol{m}}(c,c) = \frac{\sigma_{\boldsymbol{m}}}{d_{\boldsymbol{m}}} \ \frac{d_{\boldsymbol{m}}^c}{(d'_{\ell}/\ell)_{\boldsymbol{m}}}$$

Here we applied (4.5) to Z_c^2 and used the fact that E^m restricted to Z_c^2 is the Fischer-Fock kernel relative to Z_c^2 . For $\ell = 1$ use $(d'_1/1)_m = m!$ and Lemma 4.1.

Let $H^2(\mathring{Z}_{\ell}, d\rho)$ denote the Hilbert space of all holomorphic functions on \mathring{Z}_{ℓ} , or a suitable K-invariant open subset, which are square-integrable with respect to a given K-invariant measure ρ .

Proposition 4.4. For a K-invariant smooth measure ρ the coefficients for the Hilbert space $H^2(\mathring{Z}_{\ell}, d\rho)$ are given by the **moments**

$$\sigma_{\boldsymbol{m}} = \int\limits_{\Omega_c} d\tilde{\rho} \ N_{\boldsymbol{m}}$$

For $\ell = 1$ we obtain $\sigma_m = \int_0^\infty d\tilde{\rho}(t) t^m$.

Proof. Lemma 4.2 implies $(E_z^m | E_w^m)_{S_\ell} = \frac{1}{d_m} E^m(c,c) E^m(z,w)$. Since

$$(E_z^{\boldsymbol{m}}|E_w^{\boldsymbol{m}})_{\rho} = \int d\rho(\zeta) \ \overline{E_z^{\boldsymbol{m}}(\zeta)} \ E_w^{\boldsymbol{m}}(\zeta) = \int d\tilde{\rho}(t) \int_K dk \ \overline{E_z^{\boldsymbol{m}}(k\sqrt{t})} \ E_w^{\boldsymbol{m}}(k\sqrt{t}) = \frac{E^{\boldsymbol{m}}(z,w)}{d_{\boldsymbol{m}}} \int d\tilde{\rho}(t) \ E_e^{\boldsymbol{m}}(t) = \frac{E^{\boldsymbol{m}}(z,w)}{d_{\boldsymbol{m}}} \int d\tilde{\rho}(t) \ E_e^{\boldsymbol{m}}(t)$$

the associated coefficients (4.8) are given by

$$\sigma_{\boldsymbol{m}} = \frac{1}{E^{\boldsymbol{m}}(c,c)} \int_{\Omega_c} d\tilde{\rho}(t) \ E^{\boldsymbol{m}}(t,e) = \int_{\Omega_c} d\tilde{\rho}(t) \ N_{\boldsymbol{m}}(t).$$

The last equality is proved as follows: For $m \in \mathbf{N}^{\ell}_+$ the restriction of N_m to X_c coincides with the conical function N^c_m relative to X_c . The two integrals agree since

$$\int_{L_c} dk \ N_{m}(kt) = \frac{E^{m}(t,c)}{E^{m}(c,c)} = \frac{E^{m}(t,e)}{E^{m}(c,c)}$$
(4.11)

for all $t \in X_c$, and $d\tilde{\rho}$ is invariant under the Jordan algebra automorphism group L_c of X_c .

Combining these results with (4.9) or (4.10), respectively, yields the 'Peter-Weyl decomposition' of the reproducing kernel of the Hilbert space $H^2(\mathring{Z}_{\ell}, d\rho)$ associated with a K-invariant measure ρ .

We now consider K-invariant measures arising from a Kähler potential $\phi(w)$.

Lemma 4.5. Let X be a euclidean Jordan algebra of dimension d and rank r. Let $\phi \in \mathcal{P}(X)$ be an *m*-homogeneous polynomial. Then we have, for $Re(\zeta) \geq 0$,

$$\int_{\Omega} dx \ e^{-(x|e)} (x|e)^{\zeta} \ \phi(x) = \frac{\Gamma(m+d+\zeta)}{\Gamma(m+d)} \int_{\Omega} dx \ e^{-(x|e)} \ \phi(x).$$

More generally, for $\alpha > 0$,

$$\alpha \int_{\Omega} dx \ e^{-(x|e)^{\alpha}} \ (x|e)^{\zeta} \ \phi(x) = \frac{\Gamma\left(\frac{m+d+\zeta}{\alpha}\right)}{\Gamma(m+d)} \int_{\Omega} dx \ e^{-(x|e)} \ \phi(x).$$

In particular, for each partition $\boldsymbol{m} \in \mathbf{N}_+^r$, we have

$$\frac{\Gamma(|\boldsymbol{m}|+d)}{\Gamma\left(\frac{|\boldsymbol{m}|+d+\zeta}{\alpha}\right)} \alpha \int_{\Omega} dx \ e^{-(x|e)^{\alpha}} \ (x|e)^{\zeta} \ N_{\boldsymbol{m}}(x) = \int_{\Omega} dx \ e^{-(x|e)} \ N_{\boldsymbol{m}}(x) = \Gamma_r\left(\boldsymbol{m}+\frac{d}{r}\right) = \Gamma_r(d/r) \ (d/r)_{\boldsymbol{m}}.$$
(4.12)

Proof. Write $X = \mathbf{R}e \oplus Y$, with $Y = e^{\perp}$. Then $\phi(te + y) = \sum_{k=0}^{m} t^k \phi_k(y)$, where $\phi_k \in \mathcal{P}(Y)$ are (m-k)-homogeneous. Note that

$$Y_t := \{y \in Y : te + y \in \Omega\} = Y \cap (\Omega - te) = t(Y \cap (\Omega - e)) = tY_1$$

Thus for t > 0

$$\mathcal{I}_k(t) := \int_{Y_t} dy \ \phi_k(y) = \int_{Y_1} dy_1 \ t^{d-1} \ t^{m-k} \phi_k(y_1) = t^{d-1+m-k} \ \mathcal{I}_k(1).$$

Therefore

$$F_k(\zeta) := \int_0^\infty dt \ e^{-rt} \ (rt)^{\zeta} \ t^k \int_{Y_t} dy \ \phi_k(y) = \int_0^\infty dt \ e^{-rt} \ (rt)^{\zeta} \ t^k \ \mathcal{I}_k(t)$$
$$= \int_0^\infty \frac{dt}{t} \ e^{-rt} \ (rt)^{\zeta} \ t^{d+m} \ \mathcal{I}_k(1) = \frac{\Gamma(m+d+\zeta)}{r^{m+d}} \ \mathcal{I}_k(1).$$

It follows that

$$\int_{\Omega} dx \ e^{-(x|e)}(x|e)^{\zeta} \ \phi(x) = \int_{0}^{\infty} dt \ e^{-rt} \ (rt)^{\zeta} \int_{Y_t} dy \ \phi(te+y) = \sum_{k=0}^{m} F_k(\zeta) = \frac{\Gamma(m+d+\zeta)}{r^{m+d}} \ \sum_{k=0}^{m} \mathcal{I}_k(1).$$

Putting $\zeta = 0$ in this relation and taking quotients, the first claim follows. For parameter $\alpha > 0$ we put $rs := (rt)^{\alpha}$. Then $(t/s)^{\alpha} = (rs)^{1-\alpha}$ and $\alpha dt = (t/s)ds$. Write $te + y = \frac{t}{s}(se + v)$. Then y := (t/s)v satisfies $dy = (t/s)^{d-1} dv$ and $y \in Y_t$ if and only if $v \in Y_s$. Since $\phi(te + y) = (t/s)^m \phi(se + v)$ and (te + y|e) = rt it follows that

$$\begin{aligned} \alpha \int_{\Omega} dx \ e^{-(x|e)^{\alpha}} \ (x|e)^{\zeta} \ \phi(x) &= \alpha \int_{0}^{\infty} dt \ e^{-(rt)^{\alpha}} \ (rt)^{\zeta} \int_{Y_{t}} dy \ \phi(te+y) \\ &= \int_{0}^{\infty} ds \ e^{-rs} \ (rs)^{(\zeta+(1-\alpha)(d+m))/\alpha} \int_{Y_{s}} dv \ \phi(se+v) \\ &= \int_{\Omega} dx \ e^{-(x|e)} \ (x|e)^{(\zeta+(1-\alpha)(d+m))/\alpha} \phi(x). \end{aligned}$$

Since $\frac{\zeta + (1-\alpha)(d+m)}{\alpha} + d + m = \frac{\zeta + d+m}{\alpha}$, the second assertion is reduced to the first case. The last assertion follows with [14, VII.1.1].

Theorem 4.6. (i) For the potential $\phi_{\ell}(w) = (w|w)^{\alpha}$, $\alpha > 0$ the Hilbert space $H^2(\mathring{Z}_{\ell}, \rho)$ for the measure (3.11) has the moments

$$\sigma_{\boldsymbol{m}} = \alpha^{d_{\ell}} \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \Gamma_{\ell}(ar/2)} \frac{\Gamma_{\ell}(\boldsymbol{m} + d_{\ell}/\ell)}{\nu^{d_{\ell} + |\boldsymbol{m}|/\alpha}} \frac{\Gamma(d_{\ell} + \frac{|\boldsymbol{m}|}{\alpha})}{\Gamma(d_{\ell} + |\boldsymbol{m}|)}.$$
(4.13)

In the flat case $\alpha = 1$ this simplifies to

$$\sigma_{\boldsymbol{m}} = \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \ \frac{\Gamma_{\ell}(\boldsymbol{m} + d_{\ell}/\ell)}{\nu^{d_{\ell} + |\boldsymbol{m}|}}.$$

For $\ell = 1$ we have

$$\sigma_m = \frac{\alpha^{p-1} \Gamma(p-1)}{\nu^{p-1}} \frac{\Gamma(p-1+\frac{m}{\alpha})}{\Gamma(p-1+m)} \frac{(p-1)_m}{\nu^{m/\alpha}} = \frac{\alpha^{p-1}}{\nu^{p-1}} \frac{\Gamma(p-1+\frac{m}{\alpha})}{\nu^{m/\alpha}}.$$

(ii) For the potential $\phi_{\ell}(w) := \log \Delta(w, w)^{-p}$, the Hilbert space $H^2(\check{Z}_{\ell} \cap \check{Z}, d\rho)$ for the measure (3.11) has the moments

$$\sigma_{\boldsymbol{m}} = \frac{\Gamma_{\ell}(a\ell/2)}{\Gamma_{\ell}(d/r) \ \Gamma_{\ell}(ar/2)} \ \frac{\Gamma_{\ell}(\nu - d_{\ell}/\ell) \ \Gamma_{\ell}(\boldsymbol{m} + d_{\ell}/\ell)}{\Gamma_{\ell}(\boldsymbol{m} + \nu)}.$$
(4.14)

Proof. (i) Put $y := \nu^{1/\alpha} t$. In view of (3.12) it follows that $\frac{\Gamma_{\ell}(d/r) \Gamma_{\ell}(ar/2)}{\Gamma_{\ell}(a\ell/2)} \sigma_{\boldsymbol{m}}$ equals

$$\alpha^{d_{\ell}+1} \int_{\Omega_{c}} dt \ e^{-\nu(t|c)^{\alpha}} \ (t|c)^{d_{\ell}(\alpha-1)} \ N_{\boldsymbol{m}+d_{\ell}^{\prime\prime}/\ell}(t) = \frac{\alpha^{d_{\ell}+1}}{\nu^{d_{\ell}+\frac{|\boldsymbol{m}|}{\alpha}}} \int_{\Omega_{c}} dy \ e^{-(y|c)^{\alpha}} \ (y|c)^{d_{\ell}(\alpha-1)} \ N_{\boldsymbol{m}+d_{\ell}^{\prime\prime}/\ell}(y).$$
(4.15)

Since $|\boldsymbol{m} + \frac{d_{\ell}''}{\ell}| + d_{\ell}' = |\boldsymbol{m}| + d_{\ell}$ and $\boldsymbol{m} + \frac{d_{\ell}''}{\ell} + \frac{d_{\ell}}{\ell} = \boldsymbol{m} + \frac{d_{\ell}}{\ell}$, the assertion (4.13) follows from (4.12) applied to X_c .

(ii) In view of (3.13) it follows that $\frac{\Gamma_{\ell}(d/r) \Gamma_{\ell}(ar/2)}{\Gamma_{\ell}(a\ell/2)} \sigma_{\boldsymbol{m}}$ equals

$$\int_{\Omega_c \cap (c-\Omega_c)} dt \ N_c(t)^{d_\ell''/\ell} \ N_c(c-t)^{\nu-p} \ N_m(t) = \int_{\Omega_c \cap (c-\Omega_c)} dt \ N_c(c-t)^{\nu-p} \ N_{m+d_\ell''/\ell}(t).$$
(4.16)

Evaluating this beta-integral via [14, Theorem VII.1.7], applied to Ω_c , the assertion (4.14) follows with $p = \frac{d'_{\ell} + d_{\ell}}{\ell}$.

Combining these results with Propositions 4.3 and 4.4 yields the Peter-Weyl decomposition of the reproducing kernels \mathcal{K}^{ν} .

We now treat briefly the **exceptional case** where Z is of tube type and $\ell = r$. The corresponding determinant function N does not vanish on \mathring{Z}_r . Thus all negative powers of N are holomorphic on \mathring{Z}_r but do not have a continuous extension to $Z = Z_r$. In this case the codimension is $d_r - d_{r-1} = 1$ and the Peirce manifold $M_r = \{Z\}$ is just a point. The expansion (4.7) gets replaced by

$$f = \sum_{m \in \mathbf{Z}_+^r} f_{m},$$

where the summation extends over all of $\mathbf{Z}_{+}^{r} := \{(m_1, m_2, \dots, m_r) \in \mathbf{Z}^{r} : m_1 \geq m_2 \geq \cdots \geq m_r\}$ (i.e. 'negative' signatures are also allowed); see [14, Chapter XII.3]. Here f_m belongs to the space $\mathcal{P}_m(Z)$ defined for $m_r < 0$ as

$$\mathcal{P}_{\boldsymbol{m}}(Z) = N^{m_r} \mathcal{P}_{\boldsymbol{m}-m_r}(Z),$$

where N is the determinant function on Z. Similarly, one extends the definition of the spherical polynomials Φ_m on Z to $m_r < 0$ by setting

$$\Phi_{\boldsymbol{m}}(z) = N(z)^{m_r} \Phi_{\boldsymbol{m}-m_r}(z)$$

for $z \in \mathring{Z}_r = \{z \in Z : N(z) \neq 0\}$. The functions

$$H^{\boldsymbol{m}}(z,w) := (d/r)_{\boldsymbol{m}} E^{\boldsymbol{m}}(z,w), \qquad \boldsymbol{m} \in \mathbf{N}_{+}^{r}$$

satisfy

$$H^{\boldsymbol{m}+k}(z,w) = N(z)^k H^{\boldsymbol{m}}(z,w) \overline{N(w)}^k, \qquad \forall \boldsymbol{m} \in \mathbf{N}^r_+, \forall k \in \mathbf{N}.$$
(4.17)

Setting

$$H^{\boldsymbol{m}}(z,w) := N(z)^{m_r} H^{\boldsymbol{m}-m_r}(z,w) \overline{N(w)}^{m_r}, \qquad \boldsymbol{m} \in \mathbf{Z}^r_+$$

thus extends the definition of $H^{\boldsymbol{m}}$ also to $\boldsymbol{m} \in \mathbf{Z}_{+}^{r}$, and (4.17) still holds (with any $\boldsymbol{m} \in \mathbf{Z}_{+}^{r}$, $k \in \mathbf{Z}$). Note that $H^{\boldsymbol{m}}(z, e) = d_{\boldsymbol{m}} \Phi_{\boldsymbol{m}}(z)$, where as before $d_{\boldsymbol{m}} = \dim \mathcal{P}_{\boldsymbol{m}}(Z)$.

With this notation, all the results above in this section carry over also to the present setting. The proofs are straightforward modifications of the ones given previously, hence omitted. In particular, for a coefficient 'sequence' $\sigma = (\sigma_m)_{m \in \mathbf{Z}_+^r}$ of positive numbers, consider the Hilbert space \mathcal{H}_{σ} of holomorphic functions on \mathring{Z}_r (or a suitable K-invariant open subset), endowed with the inner product

$$(f|g)_{\sigma} := \sum_{\boldsymbol{m} \in \mathbf{Z}_{+}^{r}} \sigma_{\boldsymbol{m}}(f_{\boldsymbol{m}}|g_{\boldsymbol{m}})_{S_{r}},$$

where $f = \sum_{m \in \mathbb{Z}_+^r} f_m$ is the Peter-Weyl decomposition of a holomorphic function f.

Proposition 4.7. \mathcal{H}_{σ} has the reproducing kernel

$$\mathcal{K}^{\sigma}(z,w) = \sum_{\boldsymbol{m}\in\mathbf{Z}_{+}^{r}} \frac{H^{\boldsymbol{m}}(z,w)}{\sigma_{\boldsymbol{m}}}, \qquad z,w\in\mathring{Z}_{r}.$$

As a special case, for the Hilbert space $H^2(\mathring{Z}_r, d\rho)$ of all holomorphic functions on \mathring{Z}_r (or a suitable K-invariant open subset) which are square-integrable with respect to the measure (3.1), the coefficients are $\sigma_{\mathbf{m}} = \int_{\Omega} d\tilde{\rho} N_{\mathbf{m}}$, and the sum extends over all $\mathbf{m} \in \mathbf{Z}_+^r$ for which the integral is finite.

Here σ_m can be allowed to take the value $+\infty$, in which case $\frac{1}{\sigma_m}$ is interpreted as 0, and $f_m = 0$ for any $f \in \mathcal{H}_{\sigma}$. Note in particular that for $\ell = r$ and b = 0, the integrals (4.15) and (4.16) are infinite if some $m_j < 0$ [14, Theorem VII.1.1].

5. Universal differential operator and hypergeometric functions

In this section we express the reproducing kernels in a more conceptual way and relate them to hypergeometric functions. By polarization and K-invariance, it suffices to express the reproducing kernel \mathcal{K}^{σ} on the diagonal of Ω_c . Consider the **universal differential operator**

on Ω_c , which has order $\ell((r-\ell)a+b) = d''_{\ell}$ and is independent of the Hilbert space chosen.

The following theorem is our main theorem in the general setting.

assuming that the Pochhammer symbols in the denominator don't vanish for all $m \in \mathbf{N}_{+}^{r}$. For $p \leq q$ this series defines an entire function on $X^{\mathbf{C}}$; for p = q + 1 it converges on the unit ball $\check{X}^{\mathbf{C}}$, and for p > q it has empty domain of convergence. For p = q = 1 we obtain the **confluent hypergeometric** function

Proof. In view of (4.6), (5.12) simplifies to (5.15), since $d_1 = p-1$ and $d'_1 = 1$. Similarly, (5.14) simplifies to (5.16).

6. Asymptotic expansion of Bergman kernels

For a given Kähler potential ϕ , the function $e^{-\nu\phi(w)}\mathcal{K}^{\nu}(w,w)$ is closely related to the **Kempf distor**tion function (or Rawnsley's ϵ -function) which is of importance in the study of projective embeddings and constant scalar curvature metrics (Donaldson [9]), where a prominent role is played by the asymptotic behavior as $\nu \to +\infty$ (sometimes referred to as Tian-Yau-Zelditch (TYZ) expansion). For more details, see [10]. In this section, we prove our major results concerning the asymptotic expansion.

Theorem 6.1. Let $\ell = 1$ and $d\rho(t) = \alpha e^{-\nu t^{\alpha}} t^{\alpha(p-1)-1} dt$. Then the reproducing kernel of the associated Hilbert space $\mathcal{H}_{\nu} := \mathcal{H}_{\rho}$ of holomorphic functions on \mathring{Z}_1 satisfies

$$\frac{\Gamma(d/r) \ \Gamma(ar/2)}{\Gamma(a/2) \ \nu^{p-1}} \ e^{-\nu(z|z)^{\alpha}} \ \mathcal{K}_{1}^{\nu}(z,z) = \sum_{j=0}^{p-2} \frac{b_{j}}{\nu^{j} \ (z|z)^{j\alpha}} + O(e^{-\eta\nu(z|z)^{\alpha}})$$

as $\nu \to +\infty$, with some $\eta > 0$ and constants b_j independent of z and ν . Furthermore, $b_0 = 1$.

Proof. Put $s = \nu^{1/\alpha} t$. As $s \to +\infty$, it is known that

$$E_{A,B}(s) = \frac{1}{A} s^{(1-B)/A} e^{s^{1/A}} + O(e^{(1-\eta)s^{1/A}})$$

with some $\eta > 0$, see [10] (one can take any $0 < \eta < \frac{1}{\sqrt{2}}(1 - \cos \frac{2\pi}{A})$ for $A \ge 4$, and any $0 < \eta < \frac{1}{\sqrt{2}}$ for $0 < A \le 4$); furthermore, this remains valid if a derivative of any order is applied to the left-hand side and to the first term on the right-hand side. In our case, $1/A = \alpha$ and (1 - B) = 2 - p. For any polynomial P(s) and constants $\gamma, c \in \mathbf{R}$, a simple induction argument shows that

with another polynomial Q of degree deg P + k, whose leading coefficient equals α^k times the leading coefficient of P. It follows that $\frac{sD_j + D_j s}{2} s^{\gamma \alpha} P(s^{\alpha}) e^{s^{\alpha}} = s^{\gamma \alpha} Q(s^{\alpha}) e^{s^{\alpha}}$, with deg $Q = \deg P + a$ and

leading (Q) = leading $(P) \cdot \alpha^a$; and similarly for the differential operator $s^{\frac{1-r}{2}a} \partial_s^b s^{\frac{r-1}{2}a+b}$. Altogether we get

$$s^{\frac{1-r}{2}a}\partial_{s}^{b}s^{\frac{r-1}{2}a+b}\prod_{j=2}^{r}\frac{sD_{j}+D_{j}s}{2}\ s^{\gamma\alpha}e^{s^{\alpha}}=s^{\gamma\alpha}Q(s^{\alpha})e^{s^{\alpha}},$$

where Q has degree (r-1)a + b = p - 2 and leading coefficient $\alpha^{(r-1)a+b} = \alpha^{p-2}$. Taking $\gamma = 2 - p$ and using Corollary 5.4 gives the result.

The asymptotic expansion as $\nu \to +\infty$ (with the other parameters fixed) of the kernels from Corollary 5.3 can also be obtained by standard methods. As our main results, we will now derive the asymptotic expansion of the reproducing kernel functions associated with the Kähler potentials $\phi_{\ell}(w)$ from Proposition 3.6, both in the flat and the bounded setting. By Corollary 5.3 this is closely related to the asymptotic expansion of multi-variable hypergeometric functions, which by itself is a difficult matter. Accordingly, the following two theorems are of independent interest.

Theorem 6.2. For $\operatorname{Re} \alpha > \frac{d}{r} - 1$ and $\operatorname{Re} \beta > \frac{d}{r} - 1$, there is an asymptotic expansion

These expansions can be differentiated termwise any number of times.

Proof. For any $z \in \Omega$, the element $g = P_z^{1/2} \in \operatorname{Aut}(\Omega)$ satisfies z = ge and $g = g^*$. Hence (gx|e) = (x|ge) = (x|z). Let $\operatorname{Re} \alpha > \frac{d}{r} - 1$, $\operatorname{Re}(\beta - \alpha) > \frac{d}{r} - 1$. By [14, Proposition XI.1.4] we have the integral representation

(The result is stated there only for $z \in \Omega \cap (e - \Omega)$ but with general hypergeometric function ${}_{p}F_{q}$; for p = q as we have here, the proof there actually works without changes for all $z \in \Omega$.) Making the change of variable $x \mapsto e - x$ in (6) gives

The rest of the proof is divided into two parts. In the first part we prove the assertion under the assumption $\operatorname{Re}(\beta - \alpha) \geq \frac{d}{r}$. In this case the contribution to the last integral from the complement of any neighbourhood of zero is exponentially small as $|z| \to +\infty$ as above. Indeed, if $\frac{z}{|z|}$ stays in a compact subset of Ω , then $(x|z) \geq c|x||z|$ for all $x \in \Omega$ with some c > 0 [14, I.1.5], so the integral over $|x| > \delta$ is $O(e^{-c\delta|z|})$ as $|z| \to +\infty$. This implies (6.2) since, up to an error of $O(e^{-c\delta|z|})$, we have

The integral term, again up to an error of $O(e^{-c\delta|z|})$, equals

by [14, XI.2.3]. Inserting this into (6.6), we get (6.1). Furthermore, standard arguments used in the stationary phase method (which is essentially what the proof above was about) show that (6.1) (and (6.2)) can be differentiated termwise any number of times. We have thus established the theorem under the hypothesis $\operatorname{Re}(\beta - \alpha) \geq \frac{d}{r}$.

The second part of the proof removes this restriction via a shifting argument in the parameter β . Suppose $(\beta - 1)_1 \neq 0$. The elementary relation $(\beta - 1)_m \langle \beta - 1 \rangle^m = (\beta - 1)_1 \langle \beta \rangle_m$ together with $D_{\beta - \frac{d}{\tau}} E_e^m = \langle \beta - 1 \rangle^m E_e^m$ (cf. (5.6)) implies

In the special case $\alpha = d/r$ assume that the expansion (6.2) holds for parameter β . Then

for all $n \in \mathbf{N}_{+}^{r}$. We claim that for each m and all $\alpha \in \mathbf{C}$ we have

In fact for all values of α for which the various integrals above converge we have

$$= \sum_{\boldsymbol{m}} (\beta-\alpha)_{\boldsymbol{m}} N(z)^{1-\beta+d/r} \left(\frac{d}{r} - \alpha\right)_{\boldsymbol{m}} \partial_N \left(e^{(z|e)} N(z)^{\alpha-d/r} E_e^{\boldsymbol{m}}(z^{-1})\right)$$

$$= \sum_{\boldsymbol{m}} (\beta-\alpha)_{\boldsymbol{m}} \frac{e^{(z|e)}}{N(z)^{\beta-1-\alpha}} \sum_{\boldsymbol{n}} C_{\boldsymbol{n}}^{\boldsymbol{m}} \left(\frac{d}{r} - \alpha\right)_{\boldsymbol{n}} E_e^{\boldsymbol{n}}(z^{-1})$$

$$\frac{e^{(z|e)}}{N(z)^{\beta-1-\alpha}} \sum_{\boldsymbol{n}} \left(\frac{d}{r} - \alpha\right)_{\boldsymbol{n}} E_e^{\boldsymbol{n}}(z^{-1}) \sum_{\boldsymbol{m}} C_{\boldsymbol{n}}^{\boldsymbol{m}} (\beta-\alpha)_{\boldsymbol{m}} = \frac{e^{(z|e)}}{N(z)^{\beta-1-\alpha}} \sum_{\boldsymbol{n}} \left(\frac{d}{r} - \alpha\right)_{\boldsymbol{n}} (\beta-1-\alpha)_{\boldsymbol{n}} E_e^{\boldsymbol{n}}(z^{-1}).$$

Thus (6.1) also holds for $\beta - 1$ in place of β . By induction, this proves (6.1) even for all complex β such that $(\beta)_{\boldsymbol{m}} \neq 0 \ \forall \boldsymbol{m}$ (which includes, in particular, all β with $\operatorname{Re} \beta > \frac{d}{r} - 1$).

(which can be gleaned for $z \in \Omega$ from (6) by making the change of variable $x \mapsto e - x$, and for general z by analytic continuation), it is even possible to relax also the condition on α in Theorem 6.2; the theorem thus holds in fact for all α, β such that $(\alpha)_{\boldsymbol{m}}(\beta)_{\boldsymbol{m}} \neq 0 \forall \boldsymbol{m}$. We omit the details.

Our second main result in this section gives the asymptotic expansion for the multi-variable Gauss hypergeometric function $_2F_1$, for a euclidean Jordan algebra X of dimension d and rank r.

Theorem 6.3. Let $\alpha, \beta > \frac{d}{r} - 1$ and $y \in \Omega \cap (e - \Omega)$. Then there is an asymptotic expansion

$$\frac{\Gamma_r(d/r) \Gamma_r(\nu)}{\Gamma_r(\beta)} {}_2F_1 \binom{d/r, \nu}{\beta} y \approx \Gamma_r(d/r - \beta + \nu) \frac{N(y)^{d/r - \beta}}{N(e - y)^{d/r - \beta + \nu}}.$$

These expansions can be differentiated any number of times.

The hypothesis $\alpha, \beta > \frac{d}{r} - 1$ ensures that $(\alpha)_m, (\beta)_m > 0 \ \forall m$ and also $(\alpha)_m$ is a nondecreasing function of α for each m. Choose an integer $M \ge 0$ so that $\alpha \le \beta + M$. Kummer's relation (6.11) and the fact that ${}_1F_1\begin{pmatrix} -M \\ \beta \end{pmatrix} x$ is a polynomial of degree M imply

$${}_{4}F_{1}\binom{\alpha}{\beta}x \le {}_{4}F_{1}\binom{\beta+M}{\beta}x = e^{(x|e)}{}_{4}F_{1}\binom{-M}{\beta}x \le c_{M}(x|z)^{M}e^{(x|e)}$$

$$(6.15)$$

for some constant $c_M > 0$. The expression $\delta_z(x) := \frac{N(x)}{(x|z)^r}$ defines a positive continuous function on $\Omega \setminus \{0\}$, which is homogeneous of degree 0 and vanishes at the boundary $\partial\Omega \setminus \{0\}$. Put $U_{\delta} := \{x \in \Omega : \delta_z(x) < \delta\}$. Write $x = t\zeta$, where t = (x|z) > 0 while $\zeta \in \left(\frac{z}{(z|z)} \oplus z^{\perp}\right) \cap \Omega =: \Omega_z$ satisfies $(\zeta|z) = 1$. With $dx = t^{d-1}dt \ d\zeta$ we obtain

$$\frac{1}{c_M} \int_{U_{\delta}} dx \ e^{-(x|y^{-1})} \ {}_1F_1\binom{\alpha}{\beta} x \end{pmatrix} \ N(x)^{\nu - \frac{d}{r}} \leq \int_{U_{\delta}} dx \ e^{-(x|z)} \ (x|z)^{M + r\nu - d} \ N(x)^{\nu - \frac{d}{r}}$$
$$\mathcal{V}^{-d/r} \int_{U_{\delta}} dx \ e^{-(x|z)} \ (x|z)^{M + r\nu - d} = \delta^{\nu - d/r} \ |U_{\delta} \cap \Omega_z| \int_{0}^{\infty} dt \ t^{d-1} \ e^{-t} \ t^{M + r\nu - d} = |U_{\delta} \cap \Omega_y| \ \Gamma(M + r\nu) \ \delta^{\nu - \frac{d}{r}}$$

Since $\frac{\Gamma(M+r\nu)}{\Gamma_r(\nu)} \sim (r\nu)^M \nu^{\frac{r(r-1)}{2}a} \frac{(2\pi)^{\frac{1-r}{2}}}{\sqrt{r}} r^{r\nu} \nu^{\frac{r-1}{2}}$ by Stirling's formula, we get

$$\frac{N(y)^{-\nu}}{\Gamma_r(\nu)} \int\limits_{U_{\delta}} dx \ e^{-(x|y^{-1})} {}_1F_1\binom{\alpha}{\beta} x \end{pmatrix} \ N(x)^{\nu - \frac{d}{r}} \le c' \left(\frac{r^r \delta}{N(y)}\right)^{\nu} \nu^{M + \frac{r-1}{2} - \frac{r(r-1)}{2}a}$$

For $\delta < \frac{N(y)}{r^r N(e-y)}$, this is exponentially smaller as $\nu \to +\infty$ than the right-hand side of (6). It follows that the contribution to (6.14) from the integral over U_{δ} , for $\delta > 0$ small enough, is negligible compared to the right-hand side of (6). It is therefore enough to integrate in (6.14) over $\Omega \setminus U_{\delta}$, where however it is legitimate to replace ${}_1F_1$ by its asymptotic expansion (6.1) obtained in Theorem 6.2. By the same argument as above the integrations over $\Omega \setminus \Omega(\delta)$ can be replaced by integrations over Ω up to an exponentially small error.

In the **special case** $\alpha = d/r$ this implies (6.13) since

$$N(y)^{\nu} \frac{\Gamma_r(d/r) \Gamma_r(\nu)}{\Gamma_r(\beta)} {}_2F_1 \left(\frac{d/r, \nu}{\beta} \middle| y \right) \approx \int_{\Omega} dx \, e^{-(x|y^{-1})} \, \frac{e^{(x|e)}}{N(x)^{\beta - d/r}} \, N(x)^{\nu - \frac{d}{r}} = \int_{\Omega} dx \, e^{-(x|y^{-1} - e)} \, N(x)^{\nu - \beta}$$
$$= \Gamma_r(\nu - \beta + d/r) \, N(y^{-1} - e)^{\beta - \nu - d/r} = \Gamma_r(\nu - \beta + d/r) \frac{N(y)^{\nu - \beta + d/r}}{N(e - y)^{\nu - \beta + d/r}}$$

using [14, Proposition VII.1.2], and

$$N(y^{-1} - e) = N(y^{-1})N(e - y).$$
(6.16)

The general case requires more effort. Put $\boldsymbol{m}^* = (m_r, \ldots, m_2, m_1)$. Then $\Phi_{\boldsymbol{m}}(x^{-1}) = \Phi_{-\boldsymbol{m}^*}(x) = \Phi_{m_1-\boldsymbol{m}^*}(x)N(x)^{-m_1}$ [14, p. 258] and $\Gamma_r(\gamma - \boldsymbol{m}^*) = (-1)^{|\boldsymbol{m}|} \frac{\Gamma_r(\gamma)}{(\frac{d}{r} - \gamma)_{\boldsymbol{m}}}$. By [14, XI.2.3] the spherical polynomial $\Phi_{\boldsymbol{m}}$ satisfies

$$\int_{\Omega} dx \ e^{-(x|z)} \Phi_{\boldsymbol{m}}(x^{-1}) \ N(x)^{\gamma - \frac{d}{r}} = \int_{\Omega} dx \ e^{-(x|z)} \Phi_{m_1 - \boldsymbol{m}^*}(x) N(x)^{\gamma - m_1 - \frac{d}{r}}$$
$$= \Gamma_r(m_1 - \boldsymbol{m}^* + \gamma - m_1) \ \frac{\Phi_{m_1 - \boldsymbol{m}^*}(z)}{N(z)^{\gamma - m_1}} = \Gamma_r(\gamma - \boldsymbol{m}^*) \ \frac{\Phi_{\boldsymbol{m}}(z)}{N(z)^{\gamma}} = \frac{\Gamma_r(\gamma)}{(\frac{d}{r} - \gamma)_{\boldsymbol{m}}} \ \frac{\Phi_{\boldsymbol{m}}(-z)}{N(z)^{\gamma}}. \tag{6.17}$$

Putting $\gamma := \alpha - \beta + \nu$ and using (6) for E_e^m (which is proportional to Φ_m), this yields

$$\frac{\Gamma_r(\alpha)}{\Gamma_r(\beta)} {}_2F_1 \begin{pmatrix} \alpha, \nu \\ \beta \end{pmatrix} | y \rangle \approx \frac{N(y)^{-\nu}}{\Gamma_r(\nu)} \int_{\Omega} dx \ e^{-(x|y^{-1}-e)} \ N(x)^{\alpha-\beta} \sum_{\boldsymbol{m}} (\frac{d}{r} - \alpha)_{\boldsymbol{m}} \ (\beta - \alpha)_{\boldsymbol{m}} \ E_e^{\boldsymbol{m}}(x^{-1}) \ N(x)^{\nu-\frac{d}{r}}$$

$$= \frac{N(y)^{-\nu}}{\Gamma_r(\nu)} \sum_{\boldsymbol{m}} (\frac{d}{r} - \alpha)_{\boldsymbol{m}} \ (\beta - \alpha)_{\boldsymbol{m}} \int_{\Omega} dx \ e^{-(x|y^{-1}-e)} \ N(x)^{\alpha-\beta+\nu-\frac{d}{r}} \ E_e^{\boldsymbol{m}}(x^{-1})$$

$$= \frac{N(y)^{-\nu}}{\Gamma_r(\nu)} \sum_{\boldsymbol{m}} (\frac{d}{r} - \alpha)_{\boldsymbol{m}} \ (\beta - \alpha)_{\boldsymbol{m}} \ \frac{\Gamma_r(\alpha - \beta + \nu)}{(\frac{d}{r} + \beta - \alpha - \nu)_{\boldsymbol{m}}} \ N(y^{-1} - e)^{\beta-\alpha-\nu} \ E_e^{\boldsymbol{m}}(e - y^{-1})$$

$$= \frac{N(y)^{\alpha-\beta}}{N(e - y)^{\alpha-\beta+\nu}} \ \frac{\Gamma_r(\alpha - \beta + \nu)}{\Gamma_r(\nu)} \sum_{\boldsymbol{m}} \frac{(\frac{d}{r} - \alpha)_{\boldsymbol{m}} \ (\beta - \alpha)_{\boldsymbol{m}}}{(\frac{d}{r} + \beta - \alpha - \nu)_{\boldsymbol{m}}} \ E_e^{\boldsymbol{m}}(e - y^{-1})$$
(6.18)

using (6.16) again. Now (6.12) follows.

Spending a little more time on the estimate (6.15), it is again possible to extend the last theorem to all complex α, β such that $(\alpha)_{\boldsymbol{m}}(\beta)_{\boldsymbol{m}} \neq 0 \ \forall \boldsymbol{m}$. We omit the details.

For r = 1, so that $_2F_1$ reduces to the ordinary Gauss hypergeometric function, it is possible to give a different proof by using one of the relations among 'Kummer's 24 integrals', namely [4, 2.9 (27)]

$${}_{2}F_{1}\binom{\alpha,\nu}{\beta}z = \frac{\Gamma(1-\nu)\Gamma(\beta)}{\Gamma(\alpha-\nu+1)\Gamma(\beta-\alpha)}z^{-\alpha}{}_{2}F_{1}\binom{\alpha-\beta+1,\alpha}{\alpha-\nu+1}\frac{1}{z} + \frac{\Gamma(1-\nu)\Gamma(\beta)}{\Gamma(\alpha)\Gamma(\beta-\alpha-\nu-1)}\left(1-\frac{1}{z}\right)^{\beta-\alpha-\nu}\left(-\frac{1}{z}\right)^{\nu}{}_{2}F_{1}\binom{\beta-\alpha,1-\alpha}{\beta-\alpha-\nu+1}1-\frac{1}{z},$$
(6.19)

and then arguing that the first summand is negligible while the second, upon some technical work to show that it yields an asymptotic expansion as $\nu \to +\infty$ even though $1 - \frac{1}{z}$ in general no longer lies in the unit disc (and making sense of the asymptotics of the Gamma functions on the negative half-axis), gives (6.12). Although the analogues of Kummer's 24 integrals for the general case have been worked out by Koranyi [17], we are not aware of anything like (6.19) in the literature, and do not know if this line of proof is feasible.

As an application of the previous two theorems we obtain the TYZ-expansion of the reproducing kernels, both in the flat and the bounded settting.

Corollary 6.4. (i) For $\alpha = 1$, the kernel (5.13) has the asymptotic expansion

$$e^{-\nu(t|c)} \mathcal{K}^{\nu}(\sqrt{t}, \sqrt{t}) \approx \frac{\nu^{d_{\ell}}}{p_0(t)} \sum_{j=0}^{d_{\ell}''} \frac{p_j(t)}{\nu^j}$$

as $\nu \to +\infty$, uniformly in compact subsets of Ω_c . Here $p_j(t)$ are polynomials, with $p_0(t) = N(t)d_\ell''$. (ii) The kernel (5.14) has the asymptotic expansion

$$N_{c}(c-t)^{\nu} \ \mathcal{K}^{\nu}(\sqrt{t},\sqrt{t}) \approx \frac{\Gamma_{\ell}(\nu - d_{\ell}^{\prime\prime}/\ell) \ \nu^{d_{\ell}^{\prime\prime}}}{\Gamma_{\ell}(\nu - d_{\ell}/\ell) \ p_{0}(t)} \sum_{j=0}^{d_{\ell}^{\prime\prime}} \frac{p_{j}(t)}{\nu^{j}}$$
(6.20)

as $\nu \to +\infty$, uniformly on compact subsets of $\Omega_c \cap (c - \Omega_c)$. Here $p_j(t)$ are polynomials, with $p_0(t) = N(c-t)^{d''_{\ell}(1-1/\ell)} N(t)^{d''_{\ell}} = N(c-t)^{(\ell-1)(a(r-\ell)+b)} N(t)^{\ell(a(r-\ell)+b)}$.

Proof. Put $\phi(t) = e^{(t|c)}, \psi(t) = 1$ in the flat case, and $\phi(t) = N_c(c-t)^{-1}, \psi(t) = N_c(c-t)$ in the bounded case. Let ∂_u denote the partial derivative in direction $u \in X_c$. By the Leibniz rule, for any polynomial p(t) there exist polynomials $p_1(t), p_0(t)$ such that

$$\phi(t)^{-\nu}\partial_u \Big(\phi^{\nu}\psi^{\beta}N_c^{\gamma} p\Big)(t) = \psi^{\beta-1}(t) N_c(t)^{\gamma-1}(\nu p_1(t) + p_0(t)),$$

with highest term $p_1(t)$ given by $(t|u) N_c(t) p(t)$ and $(\partial_u N_c)(c-t) N_c(t) p(t)$, respectively. By induction, there exist polynomials $p_0(t), \ldots, p_k(t)$, such that

$$\phi(t)^{-\nu}\partial_{u_1}\dots\partial_{u_k}\left(\phi^{\nu}\psi^{\beta}N_c^{\gamma}p\right)(t) = \psi(t)^{\beta-k} N_c(t)^{\gamma-k} \sum_{j=0}^k \nu^j p_j(t),$$

with highest term $p_k(t)$ given by $(t|u_1) \dots (t|u_k) N_c(t)^k p(t)$ and $(\partial_{u_1} N_c)(c-t) \dots (\partial_{u_k} N_c)(c-t) N_c(t)^k p(t)$, respectively. Now let p(t) be L_c -invariant. Then there exist L_c -invariant polynomials $q_0(t), \dots, q_\ell(t)$ such that

$$\phi(t)^{-\nu}\partial_{N_c}\Big(\phi^{\nu}\psi^{\beta}N_c^{\gamma}p\Big)(t) = \psi(t)^{\beta-\ell}(t) \ N_c(t)^{\gamma-\ell} \sum_{j=0}^{\ell} \nu^j q_j(t),$$

with highest term $q_{\ell}(t)$ given by $N_c(c)N_c(t)^{\ell}p(t) = N_c(t)^{\ell}p(t)$ and $N_c(\nabla_{c-t}N_c)N_c(t)^{\ell}p(t) = N_c(c-t)^{\ell-1}N_c(t)^{\ell}p(t)$, respectively. Here we use $N_c(\nabla_{c-t}N_c) = N_c(N_c(c-t)(c-t)^{-1}) = N_c(c-t)^{\ell}N_c((c-t)^{-1})$. Hence for each complex α there exist L_c -invariant polynomials $q_0^{\alpha}(c), \ldots, q_{\ell}^{\alpha}(t)$ such that

$$\phi(t)^{-\nu} D_{\alpha} \Big(\phi^{\nu} \psi^{\beta} N_{c}^{\gamma} p \Big)(t) = N_{c}(t)^{1-\alpha} \phi(t)^{-\nu} \partial_{N_{c}} \Big(\phi^{\nu} \psi^{\beta} N_{c}^{\gamma+\alpha} p \Big)(t) = \psi(t)^{\beta-\ell} N_{c}(t)^{1+\gamma-\ell} \sum_{j=0}^{\ell} q_{j}^{\alpha}(t),$$
(6.21)

with highest term $q_{\ell}^{\alpha}(t) = q_{\ell}(t)$ independent of α . According to (5), there is a factorization $\mathcal{D}_{\ell} = D_{\alpha_q} \dots D_{\alpha_1}$ for suitable parameters $\alpha_1, \dots, \alpha_q$. Iterating (6.21) we obtain, using obvious notation

$$\phi(t)^{-\nu} \mathcal{D}_{\ell} \Big(\phi(t)^{\nu} \psi(t)^{\beta} N_{c}(t)^{\gamma} p(t) \Big) = \psi(t)^{\beta - q\ell} N_{c}(t)^{\gamma - q(\ell - 1)} \sum_{j_{1}, \dots, j_{q} = 1}^{\ell} \nu^{j_{1}} \dots \nu^{j_{q}} p_{j_{1}, j_{2}, \dots, j_{q}}^{\alpha_{1}, \alpha_{2}, \dots, \alpha_{q}}(t)$$
$$= \psi(t)^{\beta - q\ell} N_{c}(t)^{\gamma - q(\ell - 1)} \sum_{j = 0}^{q\ell} \nu^{j} Q_{j}(t), \qquad (6.22)$$

with highest term $Q_{q\ell(t)} = q_{\ell,\dots,\ell}^{\alpha_1,\dots,\alpha_q}(t)$ equal to $N_c(t)^{q\ell}p(t)$ and $N_c(c-t)^{q(\ell-1)}N(t)^{q\ell}p(t)$, respectively. Now set p(t) = 1 and put $q := (r-\ell)a + b = d_\ell''/\ell$. We apply Theorem 6.2 to X_c , with $\alpha = \frac{d_\ell}{\ell}$ and $\beta = \frac{d_\ell}{\ell} = \alpha + q$. In the flat case we obtain

$$e^{-\nu(t|c)} \ \mathcal{K}^{\nu}(\sqrt{t},\sqrt{t}) = \nu^{d_{\ell}} \frac{\Gamma_{\ell}(d_{\ell}^{\prime}/\ell)}{\Gamma_{\ell}(d_{\ell}/\ell)} \ e^{-\nu(t|c)} \ \mathcal{D}_{\ell} \ {}_{1}F_{1}\left(\frac{d_{\ell}^{\prime}/\ell}{d_{\ell}/\ell}\right| \nu t\right)$$
$$= \nu^{d_{\ell}} \ e^{-\nu(t|c)} \ \mathcal{D}_{\ell}\left(\frac{e^{\nu(t|c)}}{N_{c}(\nu t)^{q}}(1+O(e^{-\delta\nu|t|}))\right) \approx \nu^{d_{\ell}^{\prime}} \ e^{-\nu(t|c)} \ \mathcal{D}_{\ell}\left(\frac{e^{\nu(t|c)}}{N_{c}(t)^{q}}\right) = \frac{\nu^{d_{\ell}^{\prime}}}{N_{c}(t)^{q\ell}} \sum_{j=0}^{q\ell} \nu^{j} \ Q_{j}(t)$$

as $\nu \to +\infty$, uniformly for t in a compact subset of Ω_c , with some $\delta > 0$. In the bounded case we obtain

$$N_{c}(c-t)^{\nu} \ \mathcal{K}^{\nu}(\sqrt{t},\sqrt{t}) = \frac{\Gamma_{\ell}(d_{\ell}^{\prime}/\ell) \ \Gamma_{\ell}(\nu)}{\Gamma_{\ell}(d_{\ell}/\ell) \ \Gamma_{\ell}(\nu-d_{\ell}/\ell)} \ N_{c}(c-t)^{\nu} \ \mathcal{D}_{\ell} \ {}_{2}F_{1}\left(\frac{d_{\ell}^{\prime}/\ell,\nu}{d_{\ell}/\ell}\right|t\right)$$

$$\approx \frac{\Gamma_{\ell}(\nu-q)}{\Gamma_{\ell}(\nu-d_{\ell}/\ell)} \ N_{c}(c-t)^{\nu} \ \mathcal{D}_{\ell}\left(\frac{N_{c}(c-t)^{q-\nu}}{N_{c}(t)^{q}} [1+O(\delta^{-\nu})]\right) = \frac{\Gamma_{\ell}(\nu-q)}{\Gamma_{\ell}(\nu-d_{\ell}/\ell)} \frac{N_{c}(c-t)^{q(1-\ell)}}{N_{c}(t)^{q\ell}} \sum_{j=0}^{q\ell} \nu^{j} \ Q_{j}(t)$$
as $\nu \to +\infty$, uniformly for t in a compact subset of $\Omega_{c} \cap (c-\Omega_{c})$, with some $\delta > 0$.

Replacing $\frac{\Gamma_{\ell}(\nu-d_{\ell}''/\ell)}{\Gamma_{\ell}(\nu-d_{\ell}/\ell)}$ by its asymptotic expansion $\nu^{d'_{\ell}} - \frac{d'_{\ell}d_{\ell}}{\ell}\nu^{d'_{\ell}-1} + \dots$ as $\nu \to +\infty$, one obtains from (6.20) the TYZ expansion of $N_c(c-x)^{\nu} \mathcal{K}^{\nu}(\sqrt{x},\sqrt{x})$ into decreasing powers of ν with leading power $\nu^{d_{\ell}}$, which, however, does not to terminate in general.

7. Invariant measures and *n*-forms

The Riemann measure $d\Lambda_{\ell}$ on \mathring{Z}_{ℓ} is K-invariant, but has no invariance properties with respect to \mathring{K} or a transitive subgroup. We will now investigate the existence of invariant measures and holomorphic differential forms of top-degree. A complex manifold M of dimension n has a trivial canonical bundle if there exists a nowhere vanishing holomorphic n-form Θ on M. If M := G/H for a complex Lie group G, with Lie algebra \mathfrak{g} , and a closed complex Lie subgroup H, with Lie algebra $\mathfrak{h} \subset \mathfrak{g}$, a holomorphic *n*-form Θ is called *G*-invariant if the pull-back $q^*\Theta = \Theta$ for all $q \in G$. In other words,

$$\Theta_{g(z)}(\zeta_1,\ldots,\zeta_n) = \Theta_z(T_z(g)^{-1}\zeta_1,\ldots,T_z(g)^{-1}\zeta_n)$$

for all $g \in G$, $z \in M$ and holomorphic tangent vectors $\zeta_i \in T_{q(z)}(M)$. Let $\epsilon: G \to M := G/H$ be the evaluation map $\epsilon(g) := g(o)$ at the base point $o = H \in M$, with differential $T_e(\epsilon) : \mathfrak{g} \to T_o(M)$ for the tangent space $T_o(M) \approx \mathfrak{g}/\mathfrak{h}$. Every $h \in H$ defines a linear transformation $T_o(h)$ acting on $T_o(M)$. It is well-known [15, Lemma 1.5 and Proposition 1.6] that there exists a non-zero G-invariant holomorphic *n*-form Θ on G/H if and only if det $T_o(h) = 1$ for all $h \in H$. In this case the (n, n)-form $\Theta \wedge \overline{\Theta}$ induces (after multiplying by a constant) a G-invariant measure on M. More generally [15, Theorem 1.7], a non-zero invariant measure \Im exists if and only if the weaker condition $|\det T_{\alpha}(h)| = 1$ holds for all $h \in H$.

In this section we consider such questions for the Kepler manifold $M = \mathring{Z}_{\ell}$ and a suitable subgroup $G \subset \mathring{K}$ acting transitively. If Z is of tube type and $\ell = r$ we take $G := \mathring{K}$. In all other cases (Z not of tube type or $\ell < r$) Z_{ℓ} is homogeneous under the closed subgroup K_0 generated by all commutators in \mathring{K} , since the evaluation map from the Lie algebra $\mathring{\mathfrak{k}}_0$ to the tangent space $T_c(\mathring{Z}_\ell)$ is surjective. The group K_0 is connected, being the closure of a countable union of connected sets centered at the identity. The group $\check{K}_1 := \{g \in \check{K} : |\det_Z g| = 1\}$ contains both \check{K}_0 and K.

By [24, Lemma 2.32] every $g \in \mathring{K}$ satisfies

$$gZ_2^z = Z_2^{gz}, \ g^* Z_0^{gz} = Z_0^z \tag{7.1}$$

for all $z \in Z$, using the generalized Peirce spaces studied in [24]. Define the subgroup

$$\mathring{K}^{U} := \{g \in \mathring{K} : gU = U\} = \{g \in \mathring{K} : gc \in U\} \subset \mathring{K},$$

with Lie algebra $\mathring{\mathfrak{t}}^U := \{A \in \mathfrak{k} : AU \subset U\}$, and its subgroup

$$\mathring{K}^c := \{h \in \mathring{K} : gc = c\} \subset \mathring{K}^U,$$

with Lie algebra $\mathring{\mathfrak{k}}^c := \{A \in \mathfrak{k} : Ac = 0\}$. A similar notation will be used for \mathring{K}_0 .

Lemma 7.1. Every $g \in \mathring{K}^U$ satisfies $gW^{\perp} = W^{\perp}$.

 \approx

Proof. For $g \in \mathring{K}^U$ we have $Z_2^{gc} = gZ_c^2 = gU = U = Z_c^2$. Therefore [24, Proposition 2.19] implies that c and gc are Peirce equivalent. It follows that $W = Z_c^0 = Z_0^{gc} = g^{-*}Z_c^0 = g^{-*}W$. This implies the assertion.

In particular every $h \in \mathring{K}^c \subset \mathring{K}^U$ satisfies $hW^{\perp} = W^{\perp}$. Since $T_c(\mathring{Z}_\ell) = U \oplus V = W^{\perp}$ there exists a non-zero holomorphic d_ℓ -form on \mathring{Z}_ℓ which is invariant under \mathring{K} (resp., \mathring{K}_0) if and only if det $h|_{W^{\perp}} = 1$ for all $h \in \mathring{K}^c$ (resp. \mathring{K}_0^c).

The case where Z is not of tube type is uninteresting. In fact, for $\ell = r$ the group \mathring{K}_0 acts transitively on \mathring{Z}_r and the constant d-form $\Theta = dz_1 \wedge \ldots \wedge dz_d$ is \mathring{K}_0 -invariant since det g = 1 for all $g \in \mathring{K}_0$. On the other hand, if Z is not of tube type and $0 < \ell < r$ then there exists $A \in \mathring{\mathfrak{k}}_0$ with Ac = 0 and $\operatorname{tr} A|_{W^{\perp}} \neq 0$. It follows that the range of det $h|_{W^{\perp}}$, with $h \in \mathring{K}_0^c$, is all of $\mathbf{C} \setminus \{0\}$. Thus a non-zero \mathring{K}_0 -invariant d_ℓ -form (or an invariant measure) on \mathring{Z}_ℓ cannot exist.

From now on we assume that Z is of tube type. Consider first the case $\ell = r$. Then $\mathring{Z}_r = \mathring{Z}$ consists of all invertible elements in the Jordan algebra Z with unit element e and Jordan determinant N. Moreover, $U = W^{\perp} = Z$. For $A \in \mathring{\mathfrak{k}}$ we have

$$\operatorname{tr}_Z A = \frac{d}{r} (Ae|e) = \frac{p}{2} (Ae|e).$$

If p = 2k is even, then $\det_Z g = N(ge)^k$ for all $g \in \mathring{K}$. This implies $\det_Z h = N(he)^k = N(e)^k = 1$ for all $h \in \mathring{K}^e$. Thus there exists a non-zero \mathring{K} -invariant d-form Θ on \mathring{Z} which is given by

$$\Theta = \frac{dz_1 \wedge \ldots \wedge dz_d}{N(z)^k}$$

for all $z \in \mathring{Z}$, since N(gz) = N(z) N(ge) for all $g \in \mathring{K}$. On the other hand, if p is odd, there is no holomorphic square-root of $N(z)^p$ and an invariant d-form does not exist. This occurs in two situations: Either Z is a spin factor of odd dimension, or $Z = \mathbf{C}_{sym}^{r \times r}$ with r even. However, since $|\det_Z h| = |N(he)|^{p/2} = 1$ for all $h \in \mathring{K}^e$, we always have an invariant positive measure \mho on \mathring{Z} , which (up to a positive constant) is given by

$$d\mathfrak{O}(z) = \left(\frac{i}{2}\right)^d \frac{dz_1 \wedge d\overline{z}_1 \wedge \ldots \wedge dz_d \wedge d\overline{z}_d}{|N(z)|^p}.$$

If p is even, the measure \Im and the holomorphic d-form Θ are related by $\Im = \left(\frac{i}{2}\right)^d (-1)^{d(d-1)/2} \Theta \wedge \overline{\Theta}$.

Thus the most interesting case is when Z is of tube type and $0 < \ell < r$. For $1 \le i, j \le r$ let $\mathring{\mathfrak{k}}_{ij}$ denote the complex vector space generated by all linear transformations D(x, y), where $x \in Z_{ik}$, $y \in Z_{kj}$ and $1 \le k \le r$ is arbitrary.

Lemma 7.2. $\mathring{\mathfrak{t}}^U$ contains the spaces $\mathring{\mathfrak{t}}_{ij}$ if $i, j \leq \ell$, or $\ell < i, j$, or $i \leq \ell < j$.

Proof. Let $x \in Z_{ik}$, $y \in Z_{kj}$ for some k. If $i, j \leq \ell$ then $x, y \in \begin{cases} U & k \leq \ell \\ V & k > \ell \end{cases}$. If $i, j > \ell$ then $x, y \in V$.

 $\begin{cases} V & k \leq \ell \\ W & k > \ell \end{cases}$ In both cases $x, y \in Z_{\alpha}^{c}$ for the same $\alpha = 0, 1, 2$, and the Peirce multiplication rules

[20, Theorem 3.13] imply
$$\{x; y; U\} \subset \{Z_{\alpha}^c; Z_{\alpha}^c; U\} \subset U$$
. If $i \leq \ell < j$ then $x \in \begin{cases} U & k \leq \ell \\ V & k > \ell \end{cases}$ and $\begin{cases} V & k \leq \ell \\ V & k > \ell \end{cases}$

$$y \in \begin{cases} V & k \le \ell \\ W & k > \ell \end{cases}$$
. Since $\{U; V; U\} = \{0\} = \{V; W; U\}$ the assertion follows in the third case. \Box

Consider the commuting vector fields $D(e_k, e_k)$, $1 \le k \le r$. By [28, Lemma 1.5] we have

$$[D(c_k, c_k), A] = (\delta_i^k - \delta_j^k)A \tag{7.2}$$

for all k and $A \in \mathfrak{t}_{ij}$. Denote by $\mathfrak{t}_{-1} \subset \mathfrak{t}$ the real span of $iD(e_k, e_k)$ for $1 \leq k \leq r$, and let \mathfrak{t} be a maximal abelian subalgebra of \mathfrak{t} containing \mathfrak{t}_{-1} . By [28, Lemma 1.2] there is a decomposition $\mathfrak{t} = \mathfrak{t}_{-1} \oplus \mathfrak{t}_1$, where $\mathfrak{t}_1 = \{A \in \mathfrak{t} : Ae_k = 0 \ \forall k\}$. Let

$$\mathring{\mathfrak{k}} = \mathfrak{t}^{\mathbf{C}} \oplus \sum_{lpha} \mathring{\mathfrak{k}}_{lpha}$$

denote the **root decomposition** of $\mathring{\mathfrak{k}}$ under $\mathfrak{t}^{\mathbb{C}}$. By [28, Theorem 1.7], we have

$$\sum_{i} \mathring{\mathfrak{k}}_{ii} = \mathfrak{t}^{\mathbf{C}} \oplus \sum_{\alpha | \mathfrak{t}_{-1} = 0} \mathring{\mathfrak{k}}_{\alpha}.$$

Together with [28, Corollary 1.6] we obtain

$$\mathring{\mathfrak{k}} = \sum_{i=1}^{r} \mathring{\mathfrak{k}}_{ii} \oplus \sum_{i \neq j}^{\oplus} \mathring{\mathfrak{k}}_{ij} = \mathfrak{t}^{\mathbf{C}} \oplus \sum_{\alpha | \mathfrak{t}_{-1} = 0} \mathring{\mathfrak{k}}_{\alpha} \oplus \sum_{i \neq j}^{\oplus} \mathring{\mathfrak{k}}_{ij}.$$

It follows that every $A \in \mathring{\mathfrak{k}}$ has a unique decomposition

$$A = \xi + \eta + \sum_{\alpha|_{\mathfrak{t}_{-1}=0}} A_{\alpha} + \sum_{i \neq j} A_{ij},$$
(7.3)

where $A_{ij} \in \mathfrak{k}_{ij}, \eta \in \mathfrak{t}_1^{\mathbf{C}}$ satisfies $\eta e_k = 0$ for all $k, A_\alpha \in \mathfrak{k}_\alpha$ and

$$\xi = \sum_k \lambda_k \ D(c_k, c_k) \in \mathfrak{t}_{-1}^{\mathbf{C}}$$

Lemma 7.3. Let $A \in \mathring{\mathfrak{t}}^U$ have the decomposition (7.3). Then $A_{ij} \in \mathring{\mathfrak{t}}^U$ for all i, j.

Proof. In view of Lemma 7.2 we may assume that $A = \sum_{j \le \ell < i} A_{ij}$. Applying (7.2) yields

$$[D(c_k, c_k), A] = \sum_{j \le \ell < i} [D(c_k, c_k), A_{ij}] = \sum_{j \le \ell < i} (\delta_i^k - \delta_j^k) A_{ij}$$

for all k. For $u \in U$ we have $[D(c_k, c_k), A]u = D(c_k, c_k)Au - AD(c_k, c_k)u \in U$ since $AU \subset U$. It follows that

$$\sum_{j \le \ell < i} (\delta_i^k - \delta_j^k) A_{ij} u \in U$$

for all k. Choosing $k \leq \ell$ we obtain $-\sum_{\ell < i} A_{ik} u \in U$. The components $A_{ik} u \in \sum_{m \leq \ell} Z_{im}$ belong to pairwise orthogonal subspaces of U^{\perp} . Thus each $A_{ik} u = 0$ and hence $A_{ik} \in \mathring{\mathfrak{t}}^U$. Choosing $\ell < k$ we obtain $\sum_{j \leq \ell} A_{kj} u \in U$. The components $A_{kj} u \in \sum_{m \leq \ell} Z_{km}$ belong to pairwise orthogonal subspaces of U^{\perp} . Thus each $A_{kj} u = 0$ and hence $A_{kj} \in \mathring{\mathfrak{t}}^U$.

Proposition 7.4. Let Z be of tube type. Then we have for all $A \in \mathring{\mathfrak{t}}^U$

$$\operatorname{tr}_{W^{\perp}} A = \frac{p - a\ell}{2 + a(\ell - 1)} \operatorname{tr}_{U} A + \frac{a\ell}{p} \operatorname{tr}_{Z} A = \frac{p - a\ell}{2} (Ac|c) + \frac{a\ell}{2} (Ae|e).$$

Proof. Consider the decomposition (7.3) of A. For η we have $\operatorname{tr}_Z \eta = \frac{d}{r}(\eta e|e) = 0$, $\operatorname{tr}_U \eta = \frac{d_U}{\ell}(\eta e|c) = 0$ and $\operatorname{tr}_W \eta = \frac{d_W}{r-\ell}(\eta(e-c)|e-c) = 0$. Hence also $\operatorname{tr}_V \eta = 0$, showing that $\operatorname{tr}_{W^{\perp}} \eta = 0$. For a fixed root $\alpha \in \Delta$ vanishing on \mathfrak{t}_{-1} choose $H \in \mathfrak{t}$ such that $\alpha(H) \neq 0$. Then $[H, A_{\alpha}] = \alpha(H)A_{\alpha}$. Similarly,

$$[D(c_k, c_k), A_{ij}] = (\delta_i^k - \delta_j^k) A_{ij}$$

for all k. Putting $B = A_{\alpha}$ or $B = A_{ij}$ we have B = [C, B] for some $C \in \mathfrak{t}^{\mathbb{C}}$. It follows that $tr_Z B = 0$. Since $B \in \mathring{\mathfrak{t}}^U$ by Lemma 7.3 it follows that B is also a commutator in $\mathring{\mathfrak{t}}^U$, which acts on W^{\perp} . Thus $\operatorname{tr}_{W^{\perp}} B = 0$. Since C commutes with the Peirce projection π onto U and $BU \subset U$, the same argument shows $\operatorname{tr}_U B = 0$. Thus it remains to consider ξ . For $1 \leq i \leq j \leq r$ and $z \in Z_{ij}$ we have

$$\xi z = \sum_{k} \lambda_k \ D(c_k, c_k) z = \sum_{k} \lambda_k (\delta_i^k + \delta_j^k) z = (\lambda_i + \lambda_j) z.$$

Thus $\operatorname{tr}_{Z_{ij}}\xi = (\lambda_i + \lambda_j) \dim Z_{ij}$. Put $\lambda' := \lambda_1 + \ldots + \lambda_\ell$ and $\lambda'' := \lambda_{\ell+1} + \ldots + \lambda_r$. Then

$$\operatorname{tr}_{U}\xi = \sum_{i \leq j \leq \ell} \operatorname{tr}_{Z_{ij}}\xi = a \sum_{i < j \leq \ell} (\lambda_{i} + \lambda_{j}) + 2 \sum_{j \leq \ell} \lambda_{j} = (a(\ell - 1) + 2)\lambda',$$
$$\operatorname{tr}_{V}\xi = \sum_{i \leq \ell < j} \operatorname{tr}_{Z_{ij}}\xi = a \sum_{i \leq \ell < j} (\lambda_{i} + \lambda_{j}) = a(\ell\lambda'' + (r - \ell)\lambda'),$$
$$\operatorname{tr}_{W}\xi = \sum_{\ell < i \leq j} \operatorname{tr}_{Z_{ij}}\xi = a \sum_{\ell < i < j} (\lambda_{i} + \lambda_{j}) + 2 \sum_{\ell < j} \lambda_{j} = (a(r - \ell - 1) + 2)\lambda''.$$

Hence $\operatorname{tr}_{W^{\perp}}\xi = p\lambda' + a\ell\lambda''$ and $\operatorname{tr}_{Z}\xi = p(\lambda' + \lambda'')$. It follows that

$$\operatorname{tr}_{W^{\perp}} \xi = \frac{p - a\ell}{2 + a(\ell - 1)} \operatorname{tr}_{U} \xi + \frac{a\ell}{p} \operatorname{tr}_{Z} \xi$$

Lemma 7.5. Let $s = (s', s'') \in \mathring{U} \times \mathring{W}$ satisfy $\det_Z P_s = 1$. Then $\det_{W^{\perp}} P_s = N_c(s')^{p-a\ell}$.

Proof. For all $s = (s', s'') \in \mathring{U} \times \mathring{W}$ the (Peirce diagonal) transformation P_s satisfies $\det_Z P_s = N(P_s e)^{d/r} = N(s)^p = N_c(s')^p N_{e-c}(s'')^p$. Since $W = Z_2^{e-c}$ has the genus $p - a\ell$ we have $\det_W P_{s''} = N_{e-c}(s'')^{p-a\ell}$. Therefore

$$\det_{W^{\perp}} P_s = \frac{\det_Z P_s}{\det_W P_{s''}} = N_c(s')^p \ N_{e-c}(s'')^{a\ell}.$$

Theorem 7.6. Let Z be of tube type and $0 < \ell < r$. Then there exists a \check{K}_0 -invariant holomorphic d_ℓ -form Θ on \mathring{Z}_ℓ if and only if $p - a\ell = 2 + a(r - \ell - 1)$ is even. (Among all tube type domains, $p - a\ell$ is odd only for the symmetric matrices $Z = \mathbf{C}_{sym}^{r \times r}$ with $r - \ell$ even.)

Proof. For a diagonal element $s = \sum_{j=1}^{r} s_j c_j$ with $s_1 \cdots s_r = 1$ consider the transformation $P_s z = Q_s Q_e z$ in \mathring{K}_0 . Put $s' := s_1 \cdots s_\ell$, $s'' := s_{\ell+1} \cdots s_r$. For $s' = \pm 1$ we have $P_s c = c$. Since $\det_Z P_s = 1$, Lemma 7.5 implies $\det_{W^{\perp}} P_s = s'^{p-a\ell}$. If $p - a\ell$ is odd, this becomes -1 if s' = -1. Thus an invariant d_ℓ -form does not exist. Now assume that $p - a\ell = 2k$ is even. Since $\det_Z g = 1$ for all $g \in \mathring{K}_0$ Proposition 7.4 implies $\operatorname{tr}_{W^{\perp}} A = k(Ac|c)$ for all $A \in \mathring{\mathfrak{k}}_0^U$. The Peirce manifold $M_\ell \approx \mathring{K}_0/\mathring{K}_0^U$ is the conformal compactification of $V = Z_c^1$ and is therefore simply-connected. The exact homotopy sequence implies that \mathring{K}_0^U is connected. Therefore Lemma 7.5 yields $\det_{W^{\perp}} g = N_c(gc)^k$ for all $g \in \mathring{K}_0^U$. In particular, $\det_{W^{\perp}} h = N_c(hc)^k = N_c(c)^k = 1$ whenever $h \in \mathring{K}_c^0$, proving the existence of an invariant d_ℓ -form.

Proposition 7.7. Let Z be of tube type. In case $p - a\ell = 2k$ is even, the invariant holomorphic n-form Θ on \mathring{Z}_{ℓ} $(n := d_{\ell})$ has the local representation

$$(\sigma^*\Theta)_{u,v} = N_c(u)^{a(r-\ell)-k} \ dz_1 \wedge \ldots \wedge dz_n, \tag{7.4}$$

where $a(r - \ell) - k = \frac{a}{2}(r + 1 - \ell) - 1$.

Proof. Let $\Theta_c = dz_1 \wedge \ldots \wedge dz_n = du_1 \wedge \ldots \wedge du_{d'_\ell} \wedge dv_1 \wedge \ldots \wedge dv_{a\ell(r-\ell)}$. Then, up to a constant factor, Θ is given by $\Theta_z := \Theta_c \circ \bigwedge^n g^{-1}$ on $\bigwedge^n T_z(\mathring{Z}_\ell) = \bigwedge^n gW^{\perp}$, where $g \in \mathring{K}_0$ satisfies gc = z. Note that (7.1) implies $g^*Z_0^z = g^*Z_0^{gc} = Z_c^0 = W$ so that $gW^{\perp} = Z_0^{z^{\perp}} = T_z(\mathring{Z}_\ell)$. Let $w := \tau(u, v)$. Then $Z_0^w = Z_0^{B_{v,-c}u} = B_{c,-v}^{-1}Z_0^u = B_{c,-v}^{-1}W$. For $u \in \mathring{U}$ choose $s = (s', s'') \in \mathring{U} \times \mathring{W}$ such that det $P_s = 1$ and $P_sc = P_{s'}c = u$. Then $g := B_{v,-c}P_s \in \mathring{K}_0$ satisfies $gc = B_{v,-c}u = z$. Therefore

 $gU = gZ_c^2 = Z_2^{gc} = Z_2^w \text{ and } Z_0^w = Z_0^{gc} = g^{-1*}Z_c^0 = g^{-1*}W, \text{ and hence } gW^{\perp} = (Z_0^w)^{\perp}. \text{ Now Lemma 3.5 implies } g^{-1}\tau'_{u,v}(\xi,\eta) = P_s^{-1}B_{v,-c}^{-1}\tau'_{u,v}(\xi,\eta) = P_s^{-1}(\xi + D_{u,c}\eta). \text{ It follows that } (\sigma^*\Theta)_{u,v} = \Theta_w \circ \bigwedge^n \tau'_{u,v} = \Theta_c \circ \bigwedge^n g^{-1}\tau'_{u,v} = \Theta_c \circ \bigwedge^n P_s^{-1} \circ (id_U \oplus D(u,c)|_V) = \Theta_c \det_{W^{\perp}} P_s^{-1} \det_V D_{u,c}.$

Since $\det_{W^{\perp}} P_s = N_c(s')^{p-a\ell} = N_c(u)^k$ by Lemma 7.5, the assertion follows with (3.3).

In the example of the **spin factor** $Z = \mathbf{C}^{n+1}$ of rank r = 2, for $\ell = 1$ it follows that $p - a\ell = 2 + a(r - \ell - 1) = 2$ is even. Thus there exists a non-zero holomorphic *n*-form Θ on \mathring{Z}_1 which is invariant under $\mathring{K}_0 = SO(n+1)$. This *n*-form is well-known [23, Lemma 2.2] and has the form

$$\Theta = \frac{dz_1 \wedge \ldots \wedge dz_n}{z_0}$$

on the open dense subset where $z_0 \neq 0$. We have $U = \mathbf{C}c$, $W = \mathbf{C}\overline{c}$ and $V = \langle c, \overline{c} \rangle^{\perp}$. For $v \in V$ we obtain $Q_v c = \frac{1}{2} \{v; c; v\} = -\frac{1}{2} (v|\overline{v})\overline{c} = -v \cdot v \overline{c}$ since (v|c) = 0. Hence

$$B_{v,-c}c = c + \{v;c;c\} + Q_vQ_cc = c + v + Q_vc = c + v - v \cdot v \ \overline{c} = \left(\frac{1 - v \cdot v}{2}, i\frac{1 + v \cdot v}{2}, v\right)$$

and, more generally, $B_{v,-c}uc = \left(u\frac{1-v\cdot v}{2}, iu\frac{1+v\cdot v}{2}, uv\right)$ for $u \in \mathbb{C}$. Thus $z_0 = u\frac{1-v\cdot v}{2}$, $z_1 = iu\frac{1+v\cdot v}{2}$ and $z_{k+1} = u v_k$ for $1 \le k \le a = n-1$. Since

$$(v_1 \, du + u \, dv_1) \wedge \ldots \wedge (v_a \, du + u \, dv_a) = u^a \, dv_1 \wedge \ldots \wedge dv_a + u^{a-1} \sum_{k=1}^a (-1)^{k-1} v_k \, du \wedge dv_1 \wedge \ldots \wedge \widehat{dv_k} \wedge \ldots \wedge dv_a,$$

it follows that

$$-2idz_1 \wedge dz_2 \wedge \ldots \wedge dz_n = ((1+v \cdot v)du + 2u \ v \cdot dv) \wedge (v_1 \ du + u \ dv_1) \wedge \ldots \wedge (v_a \ du + u \ dv_a)$$
$$= u^a (1+v \cdot v)du \wedge dv_1 \wedge \ldots \wedge dv_a + 2u^a \ v \cdot dv \sum_{k=1}^a (-1)^{k-1} v_k \ du \wedge dv_1 \wedge \ldots \wedge \widehat{dv_k} \wedge \ldots \wedge dv_a$$

 $= u^{a}(1+v\cdot v)du \wedge dv_{1} \wedge \ldots \wedge dv_{a} - 2u^{a}\sum_{k=1}^{a}v_{k}^{2}du \wedge dv_{1} \wedge \ldots \wedge dv_{k} \wedge \ldots \wedge dv_{a} = u^{a}(1-v\cdot v)du \wedge dv_{1} \wedge \ldots \wedge dv_{a}.$

Thus, in agreement with the general formula (7.4),

$$\frac{dz_1 \wedge \ldots \wedge dz_n}{z_0} = i \ u^{a-1} du \wedge dv_1 \wedge \ldots \wedge dv_a.$$

For all tube domains, every $h \in \mathring{K}_c^0$ satisfies $(\det_{W^{\perp}} h)^2 = 1$ and thus $\det_{W^{\perp}} h = \pm 1$. More generally, we have $|\det_{W^{\perp}} h| = 1$ for all $h \in \mathring{K}_c^1$. Thus, as in the maximal rank case, there is always a \mathring{K}_1 -invariant measure \Im on \mathring{Z}_ℓ which is a multiple of $\Theta \wedge \overline{\Theta}$ if $p - a\ell$ is even. Since \mathring{K}_1 contains K this measure has a polar decomposition under the natural K-action.

Theorem 7.8. For domains of tube type, the invariant measure \Im on \mathring{Z}_{ℓ} has the polar decomposition

$$\int_{\mathring{Z}_{\ell}} d\mathfrak{U}(z) \ f(z) = \frac{|S_{\ell}|}{2^{d'_{\ell}}} \int_{\Omega_c} \frac{dt}{N_c(t)^{d'_{\ell}/\ell}} \ N_c(t)^{ar/2} \int_{K} dk \ f(k\sqrt{t}).$$
(7.5)

Proof. Write $\Omega_c = G_c/K_c$. Then $N_c(t)^{-d'_\ell/\ell} dt ds$ is the $G_c \times K$ -invariant measure on $\Omega_c \times K/K^c$. Consider the map $\gamma : \Omega_c \times K/K^c \to \mathring{Z}_\ell = \mathring{K}_1/\mathring{K}_c^1$ defined by $\gamma(t, kK^c) := kt$ for all $k \in K$ and $t \in \Omega_c$. Let $s' = \sqrt{t} \in \Omega_c$ denote the square-root relative to Ω_c . Choose $s'' \in \Omega_{e-c}$ such that $s = s' + s'' \in \Omega$ satisfies det $P_s = 1$. Then $P_s c = P_{s'} c = t$. By [15, Lemma X.1.9] we have

$$\int_{\mathring{Z}_{\ell}} d\mathfrak{U}(z) \ f(z) = \int_{\Omega_c \times K/K^c} d(\gamma^*\mathfrak{U})(t,\dot{k}) \ f(kt) = \int_{\Omega_c} \frac{dt}{N_c(t)^{d'_{\ell}/\ell}} \ D(t) \int_{K/K^c} d\dot{k} \ f(kt),$$

where the function D(t) on Ω_c is the determinant of the linear transformation

$$T_t(P_s^{-1}) \circ T_{c,t}(\phi) \circ T_{c,id}(P_{s'} \times id_{S_\ell}) = P_s^{-1}|_{W^{\perp}} \circ T_{c,t}(\phi) \circ (P_{s'} \oplus id_{W^{\perp}})$$

on W^{\perp} . Since $\det_{W^{\perp}}^{\mathbf{R}} P_s = N_c(s')^{2(p-a\ell)} = N_c(t)^{p-a\ell}$ by Lemma 7.5 and $\det P_{s'} = N_c(s')^{2d'_{\ell}/\ell} = N_c(t)^{d'_{\ell}/\ell}$, it follows with Lemma 3.1 that $2^{d'_{\ell}} D(t) = N_c(t)^{a\ell - p + 2a(r-\ell) + d'_{\ell}/\ell} \det F'(t)$, with $a\ell - p + 2a(r-\ell) = a(r+1-\ell) - 2$. Hence

$$\int_{\mathring{Z}_{\ell}} d\mathfrak{U}(z) \ f(z) = \int_{\Omega_c} dt \ N_c(t)^{a(r+1-\ell)-2} \ \det F'(t) \int_K dk \ f(kt).$$

Replacing t by \sqrt{t} , the assertion follows.

For $\ell = 1$ (7.5) yields

$$\int_{\mathring{Z}_1} d\mathfrak{O}(z) \ f(z) = |S_1| \int_0^\infty dt \ t^{ra-1} \int_{S_1} ds \ f(ts).$$

For the spin factor Z we have ar = 2(n-1) and hence, in agreement with [22, Lemma 2.1],

$$\int_{\mathring{Z}_1} d\mho(z) \ f(z) = |S_1| \int_0^\infty dt \ t^{2n-3} \int_{S_1} ds \ f(ts).$$

Comparing (7.5) and (3.8) we obtain

Corollary 7.9. In the tube domain case, the invariant measure \mathfrak{V} and the Riemann measure Λ_{ℓ} are related by $d\Lambda_{\ell}(z) = d\mathfrak{V}(z) \ \Delta_{\ell}(z, z)^k$, where $2k = p - a\ell$.

For domains of tube type, the invariant measure \Im satisfies $\tau^*\Im = |N_c(u)|^{a(r+1-\ell)-2} du dv$. This follows from Proposition 7.7 if $p - a\ell$ is even, and in general by using the absolute value of the respective determinants in its proof. It follows that

$$|\det \tau_{u,v}^{\prime*}\tau_{u,v}^{\prime}| \ du \ dv = \tau^{*}(\Lambda_{\ell}) = \sigma^{*}(\mathfrak{O}) \ \Delta_{\ell}(\tau(u,v))^{k} = N_{c}(u)^{a(r-\ell)-k} \ \Delta_{\ell}(\tau(u,v))^{k} \ du \ dv.$$

Therefore $|\det \tau_{u,v}^{\prime*}\tau_{u,v}'| = N_c(u)^{a(r-\ell)-k} \Delta_\ell(\tau(u,v))^k$. Since $\tau'(u,v) = B_{v,-c} \circ (id_U \oplus D_{u,c}|_V)$ this implies $\det(B_{v,-c}^*B_{v,-c})_{W^\perp} = N_c(u)^{-a(r-\ell)-k} \Delta_\ell(\tau(u,v))^k$. The latter value can in principle be computed.

8. HANKEL OPERATORS

For a measure $d\tilde{\rho}(t)$ on Ω_c invariant under the automorphism group $L_c = \operatorname{Aut}(X_c)$, and the associated radial measure $d\rho$ on \mathring{Z}_{ℓ} , recall that the Hankel operator $H_{\overline{g}}$ on the space $H^2_{\rho}(\mathring{Z}_{\ell}) \equiv H^2_{\rho}$ with symbol $g \in H^2_{\rho}(\mathring{Z}_{\ell})$, is the operator from H^2_{ρ} into $L^2(\mathring{Z}_{\ell}, d\rho) \equiv L^2_{\rho}$ defined by

$$H_{\overline{g}}f := (I - P)(\overline{g}f),$$

where $P: L_{\rho}^2 \to H_{\rho}^2$ is the orthogonal projection. This is a densely defined operator, which is (extends to be) bounded e.g. whenever g is bounded. For the (analogously defined) Hankel operators on the unit disc \mathbf{D} in \mathbf{C} or the unit ball \mathbf{B}^n of \mathbf{C}^n , $n \geq 2$, criteria for the membership of $H_{\overline{g}}$ in the Schatten classes \mathcal{S}^p , p > 0, were given in the classical papers by Arazy, Fisher and Peetre [3, 2]: For $p \leq 1$ there are no nonzero $H_{\overline{g}}$ in \mathcal{S}^p on \mathbf{D} , while for p > 1, $H_{\overline{g}} \in \mathcal{S}^p$ if and only if $g \in B^p(\mathbf{D})$, the p-th order Besov space on \mathbf{D} ; while on \mathbf{B}^n , $n \geq 2$, there are no nonzero $H_{\overline{g}}$ in \mathcal{S}^p if $p \leq 2n$, while for p > 2n, again $H_{\overline{g}} \in \mathcal{S}^p$ if and only if $g \in B^p(\mathbf{B}^n)$. One says that there is a cut-off at p = 1 or p = 2n, respectively. The result remains in force also for \mathbf{D} and \mathbf{B}^n replaced any bounded strictly-pseudoconvex domain in \mathbf{C}^n , $n \geq 1$, with smooth boundary [21]. For bounded symmetric domains of rank r > 1, the situation changes drastically: there are no nonzero compact Hankel operators $H_{\overline{g}}$ at all, i.e. $H_{\overline{g}}$ is compact only if g is constant [5, Theorem D].

Returning to the Kepler manifolds, consider the unit ball \check{Z} of Z and the corresponding 'Kepler balls' $\check{Z}_{\ell} := Z_{\ell} \cap \check{Z}$, and let $d\tilde{\rho}(t) = |S_{\ell}| 2^{-d'_{\ell}} N_c(t)^{a(r-\ell)+b} dt$ (cf. (3.8)) be the measure which makes $d\tilde{\rho}$ the Lebesgue surface measure on \check{Z}_{ℓ} (up to a constant factor). Except for the top-rank tube domain case $\ell = r, \ b = 0$, which we exclude in this section, Theorem 2.4 shows that H^2_{ρ} can be viewed as a space of holomorphic functions on the closure Z_{ℓ} , which we will do from now on. In this situation, it will be shown that the cut-off phenomenon for Hankel operators is exactly the same as described in the previous paragraph: i.e. for $\ell = 1$, the cutoff occurs at $p = 2d_1$, while for $\ell > 2$, $H_{\overline{g}}$ is never a compact operator if it is nonzero.

Theorem 8.1. Let \hat{Z}_{ℓ} and $d\rho$ be as above and $p \geq 1$. Then the following are equivalent.

- (i) There exists nonconstant $g \in H^2_{\rho}$ with $H_{\overline{g}} \in S^p$.
- (ii) There exists a nonzero partition $\mathbf{m} \in \mathbf{N}_+^r$ such that $H_{\overline{q}} \in \mathcal{S}^p$ for all $g \in \mathcal{P}_{\mathbf{m}}$.
- (iii) $\ell = 1 \text{ and } p > 2d_1$.
- (iv) $H_{\overline{q}} \in S^p$ for any polynomial g.

Proof. (i) \Longrightarrow (ii) Let $g = \sum_{m} g_{m}$ be the Peter-Weyl expansion of g. For $k \in K$, consider the rotation operator $U_k f(z) := f(k^{-1}z)$ for $z \in \check{Z}_{\ell}$. Clearly U_k is unitary on H^2_{ρ} as well as on L^2_{ρ} , and

$$U_k H_{\overline{g}} U_k^* = H_{\overline{U_k g}}.$$

Thus also $H_{\overline{U_kg}} \in S^p$ for all $k \in K$. Furthermore, the action $k \mapsto U_k$ is continuous in the strong operator topology, i.e. $k \mapsto U_k f$ is norm continuous for each $f \in L^2_{\rho}$. By [3, Lemma on p. 997] this implies that the map $k \mapsto H_{\overline{U_kg}}$ is even continuous from K into S^p . Consequently, denoting by χ_m the character of the representation π_m of K on \mathcal{P}_m , the Bochner integral

$$\int_{K} dk \ \chi_{\boldsymbol{m}}(k) \ U_k H_{\overline{g}} U_k^* = H_{\overline{g_{\boldsymbol{m}}}}$$

also belongs to S^p , for each \boldsymbol{m} . As g is nonconstant, there exists nonzero $\boldsymbol{m} \in \mathbf{N}_+^r$ for which $g_{\boldsymbol{m}} \neq 0$. Then, again, $H_{\overline{U_k}g_{\boldsymbol{m}}} = U_k H_{\overline{g_{\boldsymbol{m}}}} U_k^* \in S^p$ for all $k \in K$; since, by irreducibility, the translates $U_k g_{\boldsymbol{m}} = \pi_{\boldsymbol{m}}(k)g_{\boldsymbol{m}}$ span all of $\mathcal{P}_{\boldsymbol{m}}$, (ii) follows.

(ii) \Longrightarrow (iii) We first show that $H_{\overline{g}}$, with $g \in \mathcal{P}_m$ nonconstant, can never be compact if $\ell > 1$. To this end, assume that $\ell \geq 2$, and take the polydisc $D := \mathbf{D}e_1 + \cdots + \mathbf{D}e_\ell \subset \check{Z}_\ell$. Denote temporarily by R_D the restriction map $f \mapsto f|_D$, and by $H_{\overline{h}}^D : f \mapsto (I - P_D)(\overline{h}f)$ the Hankel operator with symbol \overline{h} on D, where P_D is the Bergman projection on D. Then

$$(I - P_D)R_D H_{\overline{g}}f = (I - P_D)R_D(gf - P(gf)) = H_{\overline{R_Dg}}^D R_D f - (I - P_D)R_D P(gf) = H_{\overline{R_Dg}}^D R_D f,$$

because, since a restriction to D of a holomorphic function is again holomorphic, $(I - P^D)R_DP = 0$. Thus $(I - P_D)R_DH_{\overline{g}} = H_{\overline{R}_Dg}^DR_D$, hence if $H_{\overline{g}}$ is compact, then so is $H_{\overline{R}_Dg}^DR_D$. Since $\check{Z} \subset D \times \mathbb{C}^{d-\ell}$ (see [26, Theorem 2.5 (ii)]), the restriction operator R_D is surjective (a holomorphic function in the Bergman space of D extends to a function in H_{ρ}^2 by making it independent of the superfluous $d - \ell$ variables; here we are using the fact that $d\rho$ was taken to be the Lebesgue measure). Thus $H_{\overline{R}_Dg}^D$ is compact. By the well-known result recalled in the previous paragraph (which for the polydisc in fact goes back to [26, Proposition 4.1]), R_Dg must be constant. This contradicts the fact that $R^D\mathcal{P}_m$ contains, for instance, the nonconstant function $z_1^{m_1} \dots z_{\rho}^{m_{\ell}}$ on D.

The hypothesis (ii) therefore implies that necessarily $\ell = 1$. In that case, \check{Z}_1 is just the Euclidean unit ball $\{z \in Z_1 : ||z|| < 1\}$ of Z_1 , in particular, it is a strictly pseudoconvex domain with smooth boundary (albeit with a singularity at the origin). Now a general theory of Hankel operators on smoothly bounded strictly pseudoconvex domains in \mathbb{C}^n with symbols smooth on the closure of the domain — even not necessarily anti-holomorphic as in this paper — was developed by one of the authors and G. Zhang in [12], showing in particular that $H_{\overline{g}}$, with g smooth on the closure, belongs to the weak Schatten ideal $\mathcal{S}^{2n,\infty}$, and furthermore, $(H^+_{\overline{q}}H_{\overline{g}})^n$ belongs to the Dixmier class and its Dixmier trace is given, in the particular case of the spherical boundary we have here, just by an integral over the 'unit sphere' $\{z \in Z_1 : ||z|| = 1\}$ of $|\overline{\partial}_b \overline{g}|^2$ (up to a constant factor), where $\overline{\partial}_b$ is the boundary Cauchy-Riemann operator. (See [12, Theorem 11 and formula (24)] for the details.) In particular, if g is holomorphic and nonconstant, then $\overline{\partial}_b \overline{g}$ does not vanish identically, hence the Dixmier trace of $(H^*_{\overline{g}}H_{\overline{g}})^n$ is positive, implying in particular that $H_{\overline{g}}$ cannot belong to any \mathcal{S}^p with $p \leq 2n$. Finally, the proofs in [12] relied on the theory, due to Boutet de Monvel and Guillemin, of generalized Toeplitz operators (with pseudo-differential symbols), which remains in force also if domains in \mathbb{C}^n are replaced by domains in complex varieties which can have singularities in the interior but not on the boundary, cf. §2.i in [6]; in particular, this theory — and, hence, also all the results in [12] — remain in force also in our situation when the domain is the unit ball in the complex variety Z_1 with the sole singularity at the origin. Altogether, it thus follows that if $\ell = 1$ and $g \in \mathcal{P}_m$ is nonconstant, then $H_{\overline{g}} \in \mathcal{S}^{2n,\infty} \subset \mathcal{S}^p$ for all p > 2n, $n := \dim_{\mathbb{C}} \mathring{Z}_1$, but $H_{\overline{g}} \notin \mathcal{S}^p$ for any $p \leq 2n$. Thus (iii) holds. (The beginning of the proof of this implication was inspired by the proof of [7, Proposition 1].)

(iii) \implies (iv) We have seen in the proof of (ii) \implies (iii) that for $\ell = 1$ and $p > 2d_1$, $H_{\overline{g}} \in S^p$ even for any g smooth on the closure of \check{Z}_1 . In particular, since polynomials are smooth on all of Z, this will certainly be the case for any polynomial g.

Since the implication (iv) \implies (i) is trivial, this completes the proof of the theorem.
