# FROBENIUS STRUCTURES AND CHARACTERS OF AFFINE LIE ALGEBRAS

#### Abstract

The explicit description of the Frobenius structure for the elliptic root system of type $D_{4}^{(1,1)}$ in terms of the characters of an affine Lie algebra of type $D_{4}^{(1)}$ is given.


## 1. Introduction

As a generalization of root systems, the elliptic root systems are defined in Saito [16]. The Frobenius structure (also called "the flat structure") for the elliptic root system is introduced [17, 22]. One of the purposes of introducing this structure is to construct the automorphic functions (cf. Saito [15]), where the explicit description of the Frobenius structure is important. For the elliptic root systems of types $G_{2}^{(1,1)}$ [19, 3], $D_{4}^{(1,1)}$ [20] and $E_{6}^{(1,1)}$ [21], the results of the explicit descriptions of the Frobenius structures are given.

In Satake-Takahashi [23], the description of the Frobenius structure for the elliptic root system of type $D_{4}^{(1,1)}$ in [20] is compared with the orbifold Gromov-Witten invariants for the elliptic orbifold of type $(2,2,2,2)$. However, the proofs of the results of [20] are omitted. In this paper, we give the proofs of the results of [20].

The contents of this paper are as follows. In Section 2, we recall the elliptic root system [17]. Also, the normalized characters of affine Lie algebras are introduced in this setting. In Section 3, we review the construction of the Frobenius structure for the elliptic root system [17, 22]. In Section 4, the main theorem (Theorem4.1) which gives the explicit description of a flat generator system and the potential of the Frobenius structure for the elliptic root system of type $D_{4}^{(1,1)}$ is given.

In Section 5, the proof of the main theorem is given. The relation of the Frobenius structure and the normalized characters of affine Lie algebras are, as formula, very simple. However, the conceptual relation among these structures is not yet known. Thereby, we first construct "Jacobi forms" (5.1) from the normalized characters. Then the relation between these Jacobi forms and the Frobenius structure is studied in Proposition 5.4 using differential relations satisfied by Jacobi forms which are given in Section 6. In Proposition 5.7, the relations of the normalized characters of affine Lie algebras and the Frobenius

[^0]structure are studied, where we need the analyses of the respective solutions of both the Kaneko-Zagier equations and the Halphen's equations which are given in Section 7.

For the Jacobi forms, the integers called "weight" and "index" are defined and their "initial terms" are also defined. However, these notions do not fit the differential operators which appear in the construction of the Frobenius structure. Thus, in Section 6 we formulate the (lifted) Jacobi forms and the differential operators on a 1-dimensional higher space where they fit together well. Then we obtain results such as "the determinant construction" of the Jacobi forms from normalized characters in Section 6.2.2 and a description of the intersection form of the Frobenius structure. Then we give a reduction to the 1-dimensional lower space discussed in Section 5. This is the reason for separating Section 5 and Section 6.

In Section 7, the Kaneko-Zagier equations and the Halphen's equations satisfied by modular forms are studied. In Section 8, the duality of the solutions of the KanekoZagier equations is formulated. These results allow for the description of the Frobenius structure. In Appendix A, we give a lemma on the connection used to construct flat sections in Proposition 5.6.

## 2. $W$-Invariants for elliptic root systems

We recall the elliptic root systems (cf. Saito [17]). Some parts are changed in order to fit the notations of Kac [8].
2.1. Elliptic root systems. In this subsection, we define the elliptic root systems (cf. [17]).

Let $l$ be a positive integer. Let $F$ be a real vector space of rank $l+2$ with a positive semi-definite symmetric bilinear form $I: F \times F \rightarrow \mathbb{R}$, whose radical $\operatorname{rad} I:=\{x \in$ $F \mid I(x, y)=0, \forall y \in F\}$ is a vector space of rank 2. For a non-isotropic vector $\alpha \in F$ (i.e. $I(\alpha, \alpha) \neq 0$ ), we put $\alpha^{\vee}:=2 \alpha / I(\alpha, \alpha) \in F$. The reflection $w_{\alpha}$ with respect to $\alpha$ is defined by $w_{\alpha}(u):=u-I\left(u, \alpha^{\vee}\right) \alpha \quad(\forall u \in F)$.

Definition 2.1. A set $R$ of non-isotropic elements of $F$ is an elliptic root system belonging to ( $F, I$ ) if it satisfies the axioms (i)-(iv):
(i) The additive group generated by $R$ in $F$, denoted by $Q(R)$, is a full sub-lattice of $F$.
(ii) $I\left(\alpha, \beta^{\vee}\right) \in \mathbb{Z}$ for $\alpha, \beta \in R$.
(iii) $w_{\alpha}(R)=R$ for $\forall \alpha \in R$.
(iv) If $R=R_{1} \cup R_{2}$, with $R_{1} \perp R_{2}$, then either $R_{1}$ or $R_{2}$ is void.

We have $Q(R) \cap \operatorname{rad} I \simeq \mathbb{Z}^{2}$. We call a 1-dimensional vector space $G \subset \operatorname{rad} I$ satisfying $G \cap Q(R) \simeq \mathbb{Z}$, a marking. We fix $a, \delta \in F$ s.t. $G \cap Q(R)=\mathbb{Z} a$ and $Q(R) \cap \operatorname{rad} I=\mathbb{Z} a \oplus \mathbb{Z} \delta$.

The isomorphism classes of the elliptic root systems with markings are classified in [16]. Hereafter we restrict ourselves to the elliptic root systems of type $X_{l}^{(1,1)}\left(X_{l}=\right.$ $\left.A_{l}, B_{l}, \cdots, G_{2}\right)$ in the notation of [16].

For these elliptic root systems, an $\mathbb{R}$-basis of $F$ is given as follows. We have a natural projection $p: F \rightarrow F / \operatorname{rad} I$. Put $R_{\mathrm{cl}}:=p(R)$. Then, $R_{\mathrm{cl}} \subset F / \operatorname{rad} I$ with an $\mathbb{R}$-bilinear form on $F / \operatorname{rad} I$ induced by $I$ gives a finite root system. We take $\alpha_{1}, \cdots, \alpha_{l} \in R$ s.t. $p\left(\alpha_{1}\right), \cdots, p\left(\alpha_{l}\right)$ give simple roots, where we follow the enumeration of the vertices of the Dynkin diagram of Kac [8, p.53]. We put $F_{\mathrm{cl}}:=\bigoplus_{i=1}^{l} \mathbb{R} \alpha_{i}$. Then we have $F=$ $F_{\mathrm{cl}} \oplus \mathbb{R} \delta \oplus \mathbb{R} a$.

We fix some notations. There exists a unique $\theta \in F_{\mathrm{cl}} \cap R$ which satisfies the condition that $p(\theta)$ is the highest root of the finite root system $p(R) \subset F / \operatorname{rad} I$. Hereafter we assume that $I(\theta, \theta)=2$ which is satisfied by a constant multiplication of $I$ if necessary. For $\alpha \in R$, we put $\alpha^{\vee}=2 \alpha / I(\alpha, \alpha)$. For $i=1, \cdots, l$, we define $a_{i}^{\vee} \in \mathbb{R}$ by the coefficients of $\theta=\sum_{i=1}^{l} a_{i}^{\vee} \alpha_{i}^{\vee}$. Also we put $a_{0}^{\vee}=1$. These $a_{i}^{\vee}(i=0, \cdots, l)$ are known to be positive integers and called colabels. We put $\alpha_{0}=\delta-\theta$. We have $\alpha_{0} \in R$. Then we have $\delta=\sum_{i=0}^{l} a_{i}^{\vee} \alpha_{i}^{\vee}$.
2.2. Hyperbolic extension and fundamental weights. We introduce a hyperbolic extension $(\tilde{F}, \tilde{I})$ of $(F, I)$, i.e. $\tilde{F}$ is a $(l+3)$-dimensional $\mathbb{R}$-vector space of which contain $F$ as a subspace and $\tilde{I}$ is a symmetric $\mathbb{R}$-bilinear form on $\tilde{F}$ which satisfies $\left.\tilde{I}\right|_{F}=I$ and $\operatorname{rad} \tilde{I}=\mathbb{R} a$. It is unique up to isomorphism.

We fix some notations. We define $\Lambda_{0} \in \tilde{F}$ which satisfies $\tilde{I}\left(\Lambda_{0}, \alpha_{i}^{\vee}\right)=\delta_{0, i}$ for $i=$ $0, \cdots, l$ and $\tilde{I}\left(\Lambda_{0}, \Lambda_{0}\right)=0$. Then we have a decomposition $\tilde{F}=F \oplus \mathbb{R} \Lambda_{0}$. For $i=1, \cdots, l$, we define $\omega_{i} \in F_{\mathrm{cl}}$ by $I\left(\omega_{i}, \alpha_{j}^{\vee}\right)=\delta_{i j}$ for $j=1, \cdots, l$. We put $\Lambda_{i}:=a_{i}^{\vee} \Lambda_{0}+\omega_{i} \in \tilde{F}$ for $i=1, \cdots, l$. We call $\Lambda_{0}, \cdots, \Lambda_{l}$, the fundamental weights. We remark that $I\left(\Lambda_{i}, \alpha_{j}^{\vee}\right)=\delta_{i j}$ for $i, j=0, \cdots, l$. We denote the sum of fundamental weights $\sum_{i=0}^{l} \Lambda_{i}$ by $\rho$.
2.3. The elliptic Weyl group and the affine Weyl group. We define the elliptic Weyl group. We first define $O(\tilde{F}, \operatorname{rad} I):=\left\{g \in G L(\tilde{F})|\tilde{I}(g x, g y)=\tilde{I}(x, y) \forall x, y \in \tilde{F}, g|_{\mathrm{rad} I}=\right.$ $i d$.$\} . For \alpha \in R$, we define a reflection $\tilde{w}_{\alpha} \in O(\tilde{F}, \operatorname{rad} I)$ by $\tilde{w}_{\alpha}(u)=u-\tilde{I}\left(u, \alpha^{\vee}\right) \alpha$ for $u \in \tilde{F}$. We define the elliptic Weyl group $W$ by the group generated by $\tilde{w}_{\alpha}(\alpha \in R)$. We have a homomorphism: $p r_{*}: O(\tilde{F}, \operatorname{rad} I) \rightarrow G L(\tilde{F} / \mathbb{R} a)$ induced by $p r: \tilde{F} \rightarrow \tilde{F} / \mathbb{R} a$. Also we have a homomorphism $\oplus_{i=0}^{l} \mathbb{Z} \alpha_{i} \rightarrow W$ which is defined by $\sum k_{i} \alpha_{i}^{\vee} \mapsto(u \mapsto$
$\left.u-a \sum \tilde{I}\left(\sum k_{i} \alpha_{i}^{\vee}, u\right)\right)$. Then we have the following exact sequence (cf. Saito-Takebayashi [18]):

We also define the affine Weyl group $W_{\text {af }}$ by the group generated by $\tilde{w}_{\alpha_{i}}(i=$ $0, \cdots, l)$. Then $W_{\text {af }}$ gives a splitting of the exact sequence (2.1) and we have a semi-direct product decomposition:

We have a group homomorphism $\varepsilon: W_{\text {af }} \rightarrow\{ \pm 1\}$ defined by the parity of number of reflections which define $w \in W_{\text {af }}$.
2.4. Domains and a bilinear form. We define two domains:

Y & :=\left\{x \in \operatorname{Hom}_{\mathbb{R}}(\tilde{F}, \mathbb{C}) \mid\langle a, x\rangle=-2 \pi \sqrt{-1}, \operatorname{Re}\langle\delta, x\rangle>0\right\}, \\
H & :=\left\{x \in \operatorname{Hom}_{\mathbb{R}}(\operatorname{rad} I, \mathbb{C}) \mid\langle a, x\rangle=-2 \pi \sqrt{-1}, \operatorname{Re}\langle\delta, x\rangle>0\right\} .
\end{aligned}
$$

We have a natural morphism $\pi: Y \rightarrow H$. Hereafter we shall identify $H$ and $\mathbb{H}:=\{z \in$ $\mathbb{C} \mid \operatorname{Im} z>0\}$ by the function $\delta / a: H \rightarrow \mathbb{H}$. We define the left action of $g \in W$ on $Y$ by $\langle g \cdot x, \gamma\rangle=\left\langle x, g^{-1} \cdot \gamma\right\rangle$. for $x \in Y$ and $\gamma \in \tilde{F}$. We remark that the domain $Y$ and the action of $W$ and $W_{\text {af }}$ on $Y$ is naturally identified with Kac [8, p.225].

We shall regard $\delta, \alpha_{1}, \cdots, \alpha_{l}, \Lambda_{0}$ as a coordinate system of $Y$.
We define a vector field $E$ by

E:=\frac{\partial}{\partial \Lambda_{0}}: \Omega(Y) \rightarrow F(Y),
$$

where $F(Y)$ is a space of holomorphic functions on $Y$ and $\Omega(Y)$ is a space of holomorphic 1-forms on $Y$. Put $m_{\max }:=\max \left\{a_{0}^{\vee}, \cdots, a_{l}^{\vee}\right\}$. Then we define $E_{\text {norm }}:=\frac{1}{m_{\max }} E$.

Remark 2.2. $E_{\text {norm }}$ is used to define Euler field for the Frobenius structure. $E$ is used to count the degree of the $W$-invariants.

We define a symmetric bilinear form $I^{*}: \Omega(Y) \times \Omega(Y) \rightarrow F(Y)$ and its Laplacian $D$ and $\bar{D}$ by

\bar{D}:=\sum_{i, j=1}^{l} \tilde{I}\left(\alpha_{i}, \alpha_{j}\right) \frac{\partial^{2}}{\partial \alpha_{i} \partial \alpha_{j}},
\end{gathered}
$$

D:=-\left[2 \frac{\partial^{2}}{\partial \delta \partial \Lambda_{0}}+\bar{D}\right]
$$

We define a map

$$
Y \rightarrow \mathbb{H}, \quad h \mapsto \frac{\delta(h)}{a(h)}=\frac{\delta(h)}{-2 \pi \sqrt{-1}},
$$

and denote it by $\tau$. We also define maps

$$
\begin{aligned}
& Y \rightarrow \operatorname{Hom}_{\mathbb{R}}\left(F_{\mathrm{cl}}, \mathbb{C}\right), \quad h \mapsto\left(\gamma \mapsto-\frac{\gamma(h)}{a(h)}=\frac{\gamma(h)}{2 \pi \sqrt{-1}}\right), \\
& Y \rightarrow \mathbb{C}, \quad h \mapsto-\frac{\Lambda_{0}(h)}{a(h)}=\frac{\Lambda_{0}(h)}{2 \pi \sqrt{-1}} .
\end{aligned}
$$

Thus we have

Y \simeq \mathbb{H} \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C} \tag{2.3}
\end{equation*}

where we denote $\operatorname{Hom}_{\mathbb{R}}\left(F_{\mathrm{cl}}, \mathbb{C}\right)$ by $\mathfrak{h}_{\mathbb{C}}$ which is isomorphic to the complexified Cartan subalgebra of the finite dimensional Lie algebra corresponding to the root system $R_{\mathrm{cl}}$.

We remark that the symmetric bilinear form $I^{*}$ induces a morphism $\Omega(Y) \rightarrow \Theta(Y)$ where $\Theta(Y)$ is a space of $\mathbb{C}$-derivations of $S^{W}$ and we also denote it by $I^{*}$. Then we have

2.5. The algebra of the invariants for the elliptic Weyl group. In this subsection, we introduce the algebra of the invariants for the elliptic Weyl group.

We put $F(\mathbb{H}):=\{f: \mathbb{H} \rightarrow \mathbb{C}:$ holomorphic $\}$. For $m \in \mathbb{Z}$, we put $F_{m}(Y):=$ $\{f \in F(Y) \mid E f=m f\}$. By $\pi^{*}: F(\mathbb{H}) \rightarrow F_{0}(Y)$, induced by $\pi: Y \rightarrow H, F_{m}(Y)$ is a $F(\mathbb{H})$-module.

For $m \in \mathbb{Z}$, we put $S_{m}^{W}:=\left\{f \in F_{m}(Y) \mid f(g \cdot z)=f(z) \forall g \in W\right\}, S^{W}:=$ $\bigoplus_{m \in \mathbb{Z}_{\geq 0}} S_{m}^{W} . S^{W}$ is a graded algebra and we see that $S_{0}^{W}$ is just $\pi^{*}(F(\mathbb{H}))$.

Theorem 2.3 ([1, 2, 9, 12, 24]). There exist $l+1$ homogeneous elements $P_{i} \in S_{a_{i}^{V}}^{V}$ $(0 \leq i \leq l)$ such that $S^{W}$ is a polynomial algebra of $P_{0}, \cdots, P_{l}$ over $F(\mathbb{H})$.
2.6. $S^{W}$-modules and $S^{W}$-bilinear forms. We introduce $S^{W}$ modules and tensors on them.

We define $\Omega_{S^{W}}$ as a set of 1-forms for the algebra $S^{W}$. We define $\Theta_{S^{W}}$ as $\mathbb{C}$ derivations of the algebra $S^{W}$. We have

\Theta_{S^{W}}=\bigoplus_{i=-1}^{l} S^{W} \frac{\partial}{\partial P_{i}}, \Omega_{S^{W}}=\bigoplus_{i=-1}^{l} S^{W} d P_{i}, P_{-1}:=\tau
$$

Thus $\Omega_{S^{W}}, \Theta_{S^{W}}$ are free graded $S^{W}$-modules of rank $l+2$.

We introduce a filtration on $\Omega_{S^{W}}$ by the degree of the $S^{W}$-free generators:

which do not depend on the choice of $P_{i}$.
We denote by $q$ the holomorphic function $e^{-\delta}=e^{2 \pi \sqrt{-1} \tau}$ on $\mathbb{H}$. Then we have $\frac{d q}{q}=2 \pi \sqrt{-1} d P_{-1}=2 \pi \sqrt{-1} d \tau, q \frac{d}{d q}=\frac{1}{2 \pi \sqrt{-1}} \frac{\partial}{\partial P_{-1}}=\frac{1}{2 \pi \sqrt{-1}} \frac{\partial}{\partial \tau}$. For $f \in F(\mathbb{H})$, we denote $q \frac{d}{d q} f$ by $f^{\prime}$.

By the natural morphism $\Omega_{S^{W}} \rightarrow \Omega(Y), E, I^{*}, D$ defined in Section 2.4 restricts:

since $\operatorname{Lie}_{E} E=0$, Lie $_{E} I^{*}=0$. We call $E_{\text {norm }}$ the Euler field.
For $f \in F(\mathbb{H}), F \in F_{m}(Y)(m \in \mathbb{Z})$, we have

2.7. The normalized characters. We introduce the normalized characters $\chi_{\Lambda_{i}}(i=$ $1, \cdots, l$ ) motivated by Kac [8, p.226].

Definition 2.4. For $i=0,1, \cdots, l$, we define holomorphic functions on $Y$ :

where $m_{\Lambda_{i}}:=\frac{\left|\Lambda_{i}+\rho\right|^{2}}{2 \tilde{I}\left(\Lambda_{i}+\rho, \delta\right)}-\frac{|\rho|^{2}}{2 \tilde{I}(\rho, \delta)}$.
The function $\chi_{\Lambda_{i}}$ is invariant by the action of $\bigoplus_{i=0}^{l} \mathbb{Z} \alpha_{i}^{\vee}$ and $W_{\mathrm{af}}$ of the subgroups $W$. Then by (2.2), we have

Proposition 2.5. For $i=0,1, \cdots, l, \chi_{\Lambda_{i}} \in S_{a_{i}^{\vee}}^{W}$.
2.8. Some modular forms. We put

where $\sigma_{k}(n):=\sum_{d \mid n} d^{k} . E_{2}, \eta$ are holomorphic functions on $\mathbb{H}$ and we have $E_{2}=24\left(\eta^{\prime} / \eta\right)$.
We define $c h_{\Lambda_{i}}^{(0)}$ and $\chi_{\Lambda_{i}}^{(0)} \in F(\mathbb{H})$ by $c h_{\Lambda_{i}}(\tau, 0,0)$ and $\chi_{\Lambda_{i}}(\tau, 0,0)$ respectively, where $c h_{\Lambda_{i}}(\tau, z, t), \chi_{\Lambda_{i}}(\tau, z, t)$ are defined through the isomorphism $(\tau, z, t) \in \mathbb{H} \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C} \simeq Y$.

## 3. Frobenius structure

The following theorems are proved in [22] in the context of Frobenius manifolds.
Theorem 3.1. Assume that $X_{l}^{(1,1)}=D_{4}^{(1,1)}, E_{6}^{(1,1)}, E_{7}^{(1,1)}, E_{8}^{(1,1)}, F_{4}^{(1,1)}, G_{2}^{(1,1)}$. Then there exist the holomorphic metric $J: \Theta_{S^{W}} \otimes_{S^{W}} \Theta_{S^{W}} \rightarrow S^{W}$ and multiplication $\circ: \Theta_{S^{W}} \otimes_{S^{W}}$ $\Theta_{S^{W}} \rightarrow \Theta_{S^{W}}$ on $\Theta_{S^{W}}$, global unit field $e: \Omega_{S^{W}} \rightarrow S^{W}$, satisfying the following conditions:
(i) the metric is invariant under the multiplication, i.e. $J(X \circ Y, Z)=J(X, Y \circ Z)$ for the vector field $X, Y, Z: \Omega_{S^{W}} \rightarrow S^{W}$,
(ii) (potentiality) the (3,1)-tensor $\nabla \circ$ is symmetric (here $\nabla$ is the Levi-Civita connection of the metric $)$, i.e. $\nabla_{X}(Y \circ Z)-Y \circ \nabla_{X}(Z)-\nabla_{Y}(X \circ Z)+X \circ \nabla_{Y}(Z)-$ $[X, Y] \circ Z=0$, for the vector field $X, Y, Z: \Omega_{S^{W}} \rightarrow S^{W}$,
(iii) the metric $J$ is flat,
(iv) $e$ is a unit field and it is flat, i.e. $\nabla e=0$,
(v) the Euler field $E_{\text {norm }}$ satisfies Lie $e_{E_{\text {norm }}}(\circ)=1 \cdot \circ$, and Lie $e_{E_{\text {norm }}}(J)=1 \cdot J$,
(vi) the intersection form coincides with $I^{*}: J\left(E_{\text {norm }}, J^{*}(\omega) \circ J^{*}\left(\omega^{\prime}\right)\right)=I^{*}\left(\omega, \omega^{\prime}\right)$ for 1-forms $\omega, \omega^{\prime} \in \Omega_{S^{W}}$ and $J^{*}: \Omega_{S^{W}} \rightarrow \Theta_{S^{W}}$ is the isomorphism induced by $J$.

Theorem 3.2. For $c \in \mathbb{C}^{*}$, $\left(c^{-1} \circ, c e, c^{-1} J\right)$ also satisfy the conditions Theorem 3.1. If $\left(\circ^{\prime}, e^{\prime}, J^{\prime}\right)$ satisfy conditions Theorem 3.1, then there exists $c \in \mathbb{C}^{*}$ such that $\left(\circ^{\prime}, e^{\prime}, J^{\prime}\right)=$ $\left(c^{-1} \circ, c e, c^{-1} J\right)$. In particular the Levi-Civita connection $\nabla$ is unique and the vector space $V:=\mathbb{C} e$ does not depend on the choice of $e$.

We introduce the potential $\mathcal{F} \in S^{W}$ of the Frobenius structure by the condition that $E_{\text {norm }} \mathcal{F}=2 \mathcal{F}, J(X \circ Y, Z)=X Y Z \mathcal{F}$ for $X, Y, Z \in \Theta_{S^{W}}$ with $\nabla X=\nabla Y=\nabla Z=0$.

We introduce the flat generator system as follows. Put $t_{-1}:=2 \pi \sqrt{-1} \tau / m_{\max }$ and $d_{-1}=0$. Then we have $\nabla d t_{-1}=0$ and $E_{\text {norm }} t_{-1}=d_{-1} t_{-1}$.

Let $t_{i} \in S^{W}(i=0, \cdots, l)$ be such that $\nabla d t_{i}=0, E_{\text {norm }} t_{i}=d_{i} t_{i}$ and $d t_{-1}, d t_{0}, \cdots, d t_{l}$ form an $S^{W_{-}}$-free basis of $\Omega_{S^{W}}$. Then we call $t_{-1}, t_{0}, \cdots, t_{l}$ the flat generator system. By Theorem 3.1, we assume that $0<d_{0} \leq \cdots \leq d_{l-1}<d_{l}=1$.

By the flat generator system, the potential $\mathcal{F}$ is uniquely determined up to adding a constant multiple of $t_{l}^{2}$ by the inequality $d_{l-1}<d_{l}=1$.

The following Proposition will be used to construct the potential $\mathcal{F}$.
Proposition 3.3. For $i \neq-1$ or $j \neq-1$, we have $\partial^{k} \partial^{i} \partial^{j} \mathcal{F}=\partial^{k}\left[\frac{1}{d_{i}+d_{j}} I^{*}\left(d t_{i}, d t_{j}\right)\right]$ for $\partial^{k}=J^{*}\left(d t^{k}\right)$. For $k=i=j=-1, \partial^{k} \partial^{i} \partial^{j} \mathcal{F}=0$.

Proof. Since $\partial^{i}$ is of degree $d_{i}-1$, the degree of $\partial^{k} \partial^{i} \partial^{j} \mathcal{F}$ is $d_{k}+d_{i}+d_{j}-3+2$, we have $\partial^{k} \partial^{i} \partial^{j} \mathcal{F}=0$ for $k=i=j=-1$. By Theorem 3.1 (vi) and definition of $\mathcal{F}$, we have $I^{*}\left(d t_{i}, d t_{j}\right)=E_{\text {norm }} \partial^{i} \partial^{j} \mathcal{F}=\left(d_{i}+d_{j}\right) \partial^{i} \partial^{j} \mathcal{F}$. If $i \neq-1$ or $j \neq-1$, then $d_{i}+d_{j} \neq 0$. Then we have the result.

## 4. MAIN THEOREM

Theorem 4.1. For the elliptic root system of type $D_{4}^{(1,1)}$, the following holds.
(i) Put $b_{-1}:=\pi \sqrt{-1} \tau, b_{0}:=\eta^{-2} \chi_{\Lambda_{0}}, b_{1}:=\eta^{-2} \chi_{\Lambda_{1}}, b_{2}:=\eta^{-2} \chi_{\Lambda_{3}}, b_{3}:=\eta^{-2} \chi_{\Lambda_{4}}$,

b_{4}:=\frac{1}{8} \sum_{i=0,1,2,3} I^{*}\left(d b_{i}, d b_{i}\right)+\frac{3}{2}\left(b_{0}^{2}+b_{1}^{2}+b_{2}^{2}+b_{3}^{2}\right) \frac{\eta^{\prime}}{\eta}
$$

Then $b_{0}, \cdots, b_{4}$ are polynomial generators of $S^{W}$ over $F(\mathbb{H})$ and $\nabla d b_{i}=0(i=$ $-1, \cdots, 4)$ with respect to $\nabla$ defined in Theorem 3.2. Namely, $b_{i}(i=-1, \cdots, 4)$ are homogeneous flat coordinates.
(ii) We take $\frac{\partial}{\partial b_{i}}(i=-1, \cdots, 4) S^{W}$-free basis of $\Theta_{S^{W}}$. Then $\frac{\partial}{\partial b_{4}} \in V$. Put $e_{0}:=\frac{\partial}{\partial b_{4}}$. By Theorem3.2, we have the unique Frobenius structure whose unit of the product is $e_{0}$. We denote its holomorphic metric by $J_{0}$. Then we have

gives a potential for this Frobenius structure where

Remark 4.2. In Satake [20] and Satake-Takahashi [23], the corresponding results are described. The relation of $\eta^{4} \chi_{\Lambda_{0}}^{(0)}, \eta^{4} \chi_{\Lambda_{1}}^{(0)}$ and $\Theta_{0,1}, \Theta_{\omega_{1}, 1}$ in [23] is $\Theta_{0,1}\left(e^{\pi \sqrt{-1} \tau}\right)=\eta^{4}\left(e^{2 \pi \sqrt{-1} \tau}\right) \chi_{\Lambda_{0}}^{(0)}\left(e^{2 \pi \sqrt{-1} \tau}\right)$, $\Theta_{\omega_{1}, 1}\left(e^{\pi \sqrt{-1} \tau}\right)=\eta^{4}\left(e^{2 \pi \sqrt{-1} \tau}\right) \chi_{\Lambda_{1}}^{(0)}\left(e^{2 \pi \sqrt{-1} \tau}\right)$ because of the result of string function in 9$]$. We remark that $q$ in [23] is $e^{\pi \sqrt{-1} \tau}$ whereas $q$ is $e^{2 \pi \sqrt{-1} \tau}$ in this paper. Also the functions $X_{i}$ in Lemma 2.3 of [23] is the same of the functions $\xi_{i}$ in Section 7.2 (7.9). Thus we may identify our results with those in [23].

## 5. Proof of main theorem

5.1. Characterization of the unit field. In this subsection, we discuss under the setting of Section 3. We give a characterization of the unit field $e$ up to constant multiple which will be used in Proposition 5.4.

We first remind following general results for the Frobenius structure.
Proposition 5.1. Let $J^{*}: \Omega_{S^{W}} \times \Omega_{S^{W}} \rightarrow S^{W}$ be a dual of $J$. Then we have $J^{*}=$ Lie $_{e} I^{*}$. Also we have $\operatorname{Lie}_{e} \operatorname{Lie}_{e} I^{*}=0$.

Proof. By Hertling [7, p.146], $L i e_{e} J=0, \operatorname{Lie}_{e} \circ=\circ, L i e_{e} E_{\text {norm }}=e$. Then we have the results.

We return to the situation of the Frobenius structures for elliptic root systems. We put $V_{1}:=\left\{v \in \Theta_{S^{W}} \mid \operatorname{Lie}_{E_{\text {norm }}} v=-v, \nabla v=0\right\}, V_{2}:=\left\{v \in \Theta_{S^{W}} \mid \operatorname{Lie}_{E_{\text {norm }}} v=\right.$ $\left.-v, \operatorname{Lie}_{v} \operatorname{Lie}_{v} I^{*}=0\right\}$.

Proposition 5.2. For $V$ in Theorem 3.2, we have $V=V_{1}=V_{2}$.

Proof. We see $V \subset V_{1}, V \subset V_{2}$. For the case the Froenius structure for the elliptic root system, the degrees of flat generator system are described by $0, a_{i}^{\vee} / m_{\max }(0 \leq i \leq l)$ and we see that $\operatorname{dim}_{\mathbb{C}} V_{1}=1$. The fact that $\operatorname{dim}_{\mathbb{C}} V_{2}=1$ is shown in Saito [17, §9.3]. Thus we have the result.
5.2. Proof of main theorem. We give a proof of Theorem 4.1 by using Proposition 5.4, 5.5, 5.6, 5.7.

We also put $\tilde{s}_{-1}:=s_{-1}, \tilde{s}_{0}:=s_{0}, \tilde{s}_{1}:=\eta^{4} s_{1}, \tilde{s}_{2}:=\eta^{8} s_{2}, \tilde{s}_{3}:=\eta^{8} s_{3}, \tilde{s}_{4}:=\eta^{12} s_{4}$.
Remark 5.3. The functions $s_{0}, \cdots, s_{4}$ are reductions of the Jacobi forms defined in Section 6 (for the precise statement, see Proposition $6.13(\mathrm{ii})$ ). The functions $\tilde{s}_{0}, \cdots, \tilde{s}_{4}$ are twisted by $\eta$ so that the automorphic factor do not appear. They appear in the calculation of the bilinear forms (see Proposition 6.4 (iii)).

Proposition 5.4. The following results hold.
(i) $\tilde{s}_{0}, \cdots, \tilde{s}_{4}$ give polynomial generators of the algebra $S^{W}$ over $F(\mathbb{H})$.
(ii) By (i), we could take $\frac{\partial}{\partial \tilde{s}_{i}}(i=-1, \cdots, 4)$ as $S^{W}$ free basis of $\Theta_{S^{W}}$. Then $\frac{\partial}{\partial \tilde{s}_{4}} \in V$. We put $e_{1}:=\frac{\partial}{\partial \tilde{s}_{4}}$.

Proof. We give the proof of (i). By Proposition 6.13, $s_{0}, \cdots, s_{4}$ are polynomial generators of $S^{W}$ over $F(\mathbb{H})$. Since $\eta$ is a unit of $F(\mathbb{H})$, we have (i). For the proof of (ii), by Proposition 6.14, $\left(\frac{\partial}{\partial \tilde{s}_{4}}\right)^{2} I^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)=0$ for $i, j=-1, \cdots, 4$. Then by Proposition 5.2, we have $\frac{\partial}{\partial \tilde{s}_{4}} \in V$.

By Proposition 3.2 and Proposition 5.4 (ii), there exists uniquely the Frobenius structure for $S^{W}$ such that the unit of the product o coincides with $e_{1}$. We denote the holomorphic metric for this Frobenius structure by $J_{1}$. Then the dual metric of $J_{1}$ coincides with $L i e_{e_{1}} I^{*}$ by Proposition 5.1. We put $J_{1}^{*}:=L i e_{e_{1}} I^{*}$.

Proposition 5.5. (i) For $d \tilde{s}_{j}(j=-1, \cdots, 4)$, we have

(ii) The connection matrix of $\nabla$ defined in Theorem 3.2 can be calculated by $J_{1}^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)$ $(i, j=-1, \cdots, 4)$ and be expressed in terms of $\eta, \eta^{\prime} / \eta=\frac{1}{24} E_{2}, \tilde{E}_{4}, \tilde{E}_{6}$ and $\tilde{s}_{0}, \cdots, \tilde{s}_{3}$.

Proof. We give the proof of (i). We first show that $I^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)$ for $i, j=-1, \cdots, 4$ could be expressed by $\eta, \tilde{E}_{i}, \tilde{s}_{j} i=2,4,6, j=0, \cdots, 4$. For the cases $i=-1$ or $j=-1$, then they are shown by the equation (2.4). For the cases $i, j=0, \cdots, 4$, then they are shown by Proposition 6.16 and the equation (6.11). Therefore we obtain the results because $J_{1}^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)=e_{1} I^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)$ for $i . j=-1, \cdots, 4$. For the proof of (ii), by Theorem 3.2, the connection $\nabla$ for Frobenius structure could be calculated as the Levi-Civita connection of $J_{1}$, we obtain the connection form by the derivatives of the $J_{1}^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)$ and they could be expressed by $\eta, \tilde{E}_{i}, \tilde{s}_{j} i=2,4,6, j=0, \cdots, 4$ using (7.8).

Proposition 5.6. There exist unique $v_{0}, \cdots, v_{4} \in \Omega_{S^{W}}$ such that $v_{i}-d \tilde{s}_{i} \in F_{0}$ for $0 \leq i \leq 3$ and $v_{4}-d \tilde{s}_{4} \in F_{1}$ for the filtration defined in (2.5) and $\bar{\nabla} v_{j}=0$ for $0 \leq$ $j \leq 4$, where $\bar{\nabla}$ is a connection obtained by the reduction of the entries of the connection matrix of $\nabla$ defined in Theorem 3.2 by $\Omega_{S^{W}} \rightarrow \Omega_{S^{W} / F(\mathbb{H})}$ (more precicely, $\bar{\nabla}: \Omega_{S^{W}} \rightarrow$ $\Omega_{S^{W} / F(\mathbb{H})} \otimes_{S^{W}} \Omega_{S^{W}}$ is a composition of the connection $\nabla: \Omega_{S^{W}} \rightarrow \Omega_{S^{W}} \otimes_{S^{W}} \Omega_{S^{W}}$ with $\Omega_{S^{W}} \otimes_{S^{W}} \Omega_{S^{W}} \rightarrow \Omega_{S^{W} / F(\mathbb{H})} \otimes_{S^{W}} \Omega_{S^{W}}$ induced by the natural morphism $\left.\Omega_{S^{W}} \rightarrow \Omega_{S^{W} / F(\mathbb{H})}\right)$.

In the proof of Proposition 5.5(i), we obtain $I^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right)$. We could express $I^{*}\left(y_{i}, y_{j}\right)$ by $\eta, \eta^{4} \chi_{\Lambda_{0}}, \eta^{4} \chi_{\Lambda_{1}}, \eta^{\prime} / \eta, \tilde{E}_{i}, y_{j} j=0, \cdots, 4$ using the results of Proposition 7.2, Then by Proposition 3.3, we have (iii). By the result of (iii), we obtain $u_{4}=b_{4}$, which gives the proof of (iv).

Proof (of Theorem 4.1). By Theorem 3.2, the connection in Theorem 4.1 is the same as one in Proposition 5.5 (ii). Then (i) is a consequence of Proposition 5.7 (ii) and (iv). By Proposition 5.7 (iv), we have $e_{0}=e_{1}$. Then we have $J_{0}=J_{1}$ and the function $\mathcal{F}_{1}$ gives the potential of the Theorem 4.1.

## 6. JACOBI FORMS

6.1. Domains and differential operators. In order to define Jacobi forms, we prepare domains, group actions on them and differential operators.

We formulate Jacobi forms on the new domains (see (6.13)) which have 1 extra parameter than the domain $Y$ so that the automorphic factors for the group actions do not appear. We also formulate differential operators which are invariant for the group actions on the new domains (see (6.5)). We use notations introduced in Section 2.
6.1.1. Domains and group actions. We put $U:=\{q \in \mathbb{C}| | q \mid<1\}, Y_{\mathbb{H}}:=\mathbb{H} \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C}$, $Y_{U}:=U \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C}, Y_{\{0\}}:=\{0\} \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C}$. We prepare $\mathbb{C}^{*}$ with the coordinate $\omega$. The
maps: $\mathbb{H} \rightarrow U, \tau \mapsto e^{2 \pi \sqrt{-1} \tau}$ and $\{0\} \rightarrow U$ induce the following diagram:

where $\pi$ denotes natural projection.
We shall define the Metaplectic group (cf. [8, p.253]). We first introduce $S L_{2}(\mathbb{Z})$ action on $\mathbb{H}$ by $A \cdot \tau:=\frac{a \tau+b}{c \tau+d}$ for $A=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in S L_{2}(\mathbb{Z})$ and $\tau \in \mathbb{H}$. We define the Metaplectic group $M p_{2}(\mathbb{Z})$ by the set of pair

We define the action of $M p_{2}(\mathbb{Z})$ on $\mathbb{C}^{*} \times \mathbb{H}$ by $(A, j) \cdot(\omega, \tau)=(j \omega, A \cdot \tau)$.
We define the action of $M p_{2}(\mathbb{Z})$ on $(\omega, \tau, z, t) \in \mathbb{C}^{*} \times Y_{\mathbb{H}}$ by

We define the $W$ action on $Y_{\mathbb{H}}$ by the isomorphism $Y \simeq Y_{\mathbb{H}}$ which was obtained in (2.3) and $W$ action on $Y$ defined in Section 2.4. The domain $\mathbb{C}^{*} \times Y_{\mathbb{H}}$ also has the $W$ action whose action on $\mathbb{C}^{*}$ is trivial.
6.1.2. Differential operators. We remind the notion of " $f$-related" which we shall use frequently. Let $f: M_{1} \rightarrow M_{2}$ be a morphism of complex manifolds $M_{1}$ and $M_{2}$. Let $X_{i}$ be a holomorphic vector field on $M_{i}(i=1,2)$. The vector fields $X_{1}$ and $X_{2}$ are called $f$-related if $d f\left(\left(X_{1}\right)_{p}\right)=\left(X_{2}\right)_{f(p)}$ for any $p \in M_{1}$ where $d f: T_{p} M_{1} \rightarrow T_{f(p)} M_{2}$. Then we have a commutative diagram:

commutes, then we also call $D_{1}$ and $D_{2}$ " $f$-related" and use the same notation $P=P_{1}=$ $P_{2}$.

We return to the situation of Section 6.1.1. On each space of the diagram (6.1), we define the vector field $\omega \frac{\partial}{\partial \omega}$. They are $\varphi_{i}$-related $(i=1,2)$ and $\pi$-related, thus we simply denote them by $E_{\omega}$.

On each space of the upper line of the diagram (6.1), we define the vector field $\frac{\partial}{\partial \Lambda_{0}}$. They are $\varphi_{i}$-related $(i=1,2)$, thus we simply denote them by $E$.

On each space $\mathbb{C}^{*} \times Y_{\mathbb{H}}, \mathbb{C}^{*} \times Y_{U}$ and $\mathbb{C}^{*} \times Y_{\{0\}}$, we define the differential operators

(ii) On the space $\mathbb{C}^{*} \times \mathbb{H}$, $E_{\omega}$ and $\delta_{q}$ are invariant w.r.t. the $M p_{2}(\mathbb{Z})$ action. We also have $\left[E_{\omega}, \delta_{q}\right]=(-4) \delta_{q}$.

We could easily check the above facts so we omit a proof.
6.1.3. Function spaces. For $k \in \frac{1}{2} \mathbb{Z}, m \in \mathbb{Z}$ and for each $X=\mathbb{H}, U$ and $\{0\}$, we put

We call $M_{k}$ and $J_{k, m}$ the space of the modular form of weight $k$ and the space of Jacobi forms of weight $k$ and index $m$ respectively.

We put $M_{k}^{\omega=1}:=\left(L_{k}\right)^{-1}\left(\varphi_{1}^{*}\left(M_{k}\right)\right)$ and $J_{k, m}^{\omega=1}:=\left(L_{k}\right)^{-1}\left(\varphi_{1}^{*}\left(J_{k, m}\right)\right)$. We remark that $M_{k}^{\omega=1}$ is a usual space of modular forms of weight $k$ on $\mathbb{H}$. Also we remark that the space $J_{k, m}^{\omega=1}$ for $A_{1}^{(1,1)}$ case corresponds to the space of the even weak Jacobi forms defined in Eichler-Zagier [5] by restricting $\mathbb{H} \times \mathfrak{h}_{\mathbb{C}} \times \mathbb{C}$ to $\mathbb{H} \times \mathfrak{h}_{\mathbb{C}} \times\{0\}$.

Proof. We first study the behavior of $\operatorname{det} \Delta$ at $q=0$. We first observe that for $i \geq 2$, the $(i, j)$ component of $\Delta$ is $\delta_{q}^{\beta_{i}}\left(q^{\gamma_{j}} \overline{F_{j}}\right)$, so it could be factored as $q^{\gamma_{j}} b_{i, j}(q)$ by some holomorphic function $b_{i, j}(q) \in F_{k+2 \beta_{i}}\left(\mathbb{C}^{*} \times U\right)$. Thus det $\Delta$ is factored as $\operatorname{det} \Delta=q^{\gamma} F(\omega, q, z, t)$ by some holomorphic function $F(\omega, q, z, t) \in F_{\beta, m}^{W}\left(\mathbb{C}^{*} \times Y_{U}\right)$.

Second, we study the modular invariance of $\operatorname{det} \Delta$. Here we consider the group of characters: $G:=\left\{\chi: M p_{2}(\mathbb{Z}) \rightarrow \mathbb{C}^{*} \mid \chi\right.$ is a group homomorphism $\}$. We call $f \in$ $F_{k, m}^{W}\left(\mathbb{C}^{*} \times Y_{\mathbb{H}}\right)$ quasi-invariant (resp. invariant) for $M p_{2}(\mathbb{Z})$ if there exist $\chi \in G$ s.t. $f(g \cdot(\omega, \tau, z, t))=\chi(g) f(\omega, \tau, z, t)$ (resp. $f(g \cdot(\omega, \tau, z, t))=f(\omega, \tau, z, t))$ for all $g \in M p_{2}(\mathbb{Z})$.

We show that det $\Delta$ is quasi-invariant. Since $\delta_{q}$ is invariant w.r.t. $M p_{2}(\mathbb{Z})$, we have

Put $\varphi:=(\eta / \omega)^{-24 \gamma} \operatorname{det} \Delta$. Since $\eta / \omega$ is quasi-invariant for $M p_{2}(\mathbb{Z}), \varphi$ is also quasiinvariant for $M p_{2}(\mathbb{Z})$. We see that $\varphi$ is invariant w.r.t. $T \in M p_{2}(\mathbb{Z})$. Since the elements
of the character group $G$ is distinguished by the value on $T=\left(\left(\begin{array}{ll}1 & 1 \\ 0 & 1\end{array}\right), 1\right) \in M p_{2}(\mathbb{Z})$, we see that $\varphi$ is invariant for $M p_{2}(\mathbb{Z})$.

Then $(\eta / \omega)^{-24 \gamma} \operatorname{det} \Delta$ has a modular property and satisfy cusp conditions, so it satisfies the conditions of Jacobi forms.

(i) For the Jacobi forms of types $X_{l}^{(1,1)}\left(X_{l}=\right.$ $\left.A_{l}, B_{l}, \cdots, G_{2}\right)$ except $E_{8}^{(1,1)}$, there exist Jacobi forms $\phi_{i} \in J_{k_{i}, m_{i}}(i=0, \cdots, l)$ for some $k_{i}, m_{i} \in \mathbb{Z}$ such that these are polynomial generator of $J_{* *}$ over $M_{*}$.
(ii) The functions $L_{k_{0}}^{-1}\left(\varphi_{1}^{*}\left(\phi_{0}\right)\right), \cdots, L_{k_{l}}^{-1}\left(\varphi_{1}^{*}\left(\phi_{l}\right)\right)$ are polynomial generator of $S^{W}$ over $F(\mathbb{H})$.

Remark 6.8. For the Jacobi forms of type $E_{8}^{(1,1)}$, the existence of the polynomial generator is not known.
6.3. $D_{4}^{(1,1)}$ case. Hereafter we restrict ourselves to the case of type $D_{4}^{(1,1)}$. Then Theorem 6.7 for this case asserts the existence of the Jacobi forms $\phi_{0} \in J_{0,1}, \phi_{1} \in J_{-2,1}, \phi_{2} \in$ $J_{-4,1}, \phi_{3} \in J_{-4,1}, \phi_{4} \in J_{-6,2}$ such that these are polynomial generator of $J_{*, *}$ over $M_{*}$. Wirthmüller constructs them by the technique of lifting from lower rank Jacobi forms.

Here we shall construct Jacobi forms by the method of "the determinant construction" introduced in Section 6.2.2 using the normalized characters introduced in (2.7).

By Proposition 6.9 (ii), 1-dimensional vector spaces $\mathbb{C}\left(-2 \hat{\chi}_{\Lambda_{1}}+\hat{\chi}_{\Lambda_{3}}+\hat{\chi}_{\Lambda_{4}}\right), \mathbb{C}\left(\hat{\chi}_{\Lambda_{3}}-\right.$ $\left.\hat{\chi}_{\Lambda_{4}}\right)$ and a 2-dimensional vector space $\mathbb{C}\left(\hat{\chi}_{\Lambda_{1}}+\hat{\chi}_{\Lambda_{3}}+\hat{\chi}_{\Lambda_{4}}\right) \oplus \mathbb{C}\left(\hat{\chi}_{\Lambda_{0}}\right)$ have the $M p_{2}(\mathbb{Z})$ action. Then by the determinant construction (Proposition 6.6), we have Jacobi forms. Their initial terms are calculated by Proposition 6.9 (iii).

Proof. By the diagram (6.15), we have $\hat{s}_{4} \in J_{-6,2}$. By the diagram (6.15), the calculation of the initial terms reduces to the $\bar{D}$ action on $\mathbb{C}\left[S\left(\omega_{1}\right), \cdots, S\left(\omega_{4}\right)\right]$. The action of the operator $\bar{D}$ on the monomials of $S\left(\omega_{i}\right)$ could be calculated by Proposition 6.9 (v) and Proposition 6.12.

(ii) For $s_{0}, \cdots, s_{4}$ defined in (5.1)), $s_{i}=L_{k_{i}}^{-1}\left(\varphi_{1}^{*}\left(\hat{s}_{i}\right)\right)$. In particular $s_{i}$ are polynomial generators of $S^{W}$ over $F(\mathbb{H})$.

Proof. We give the proof of (i). By the structure theorem of Jacobi forms (Theorem (6.7), we should check that $\hat{s}_{0} \in J_{0,1} \backslash \hat{E}_{4} J_{-4,1}, \hat{s}_{1} \in J_{-2,1} \backslash\{0\}, \mathbb{C} \hat{s}_{2} \oplus \mathbb{C} \hat{s}_{3}=J_{-4,1}$, $\hat{s}_{4} \in J_{-6,2} \backslash\left(J_{-2,1} \cdot J_{-4,1}\right)$. These are checked by the initial terms given by Proposition 6.10 and Proposition 6.11. We give the proof of (ii). For $i=0,1,2,3$, we have $s_{i}=L_{k_{i}}^{-1}\left(\varphi_{1}^{*}\left(\hat{s}_{i}\right)\right)$. For $i=4$, we have $s_{i}=L_{k_{i}}^{-1}\left(\varphi_{1}^{*}\left(\hat{s}_{i}\right)\right)$ by (6.11). By (i) and Theorem 6.7 (ii), $L_{k_{i}}^{-1}\left(\varphi_{1}^{*}\left(\hat{s}_{i}\right)\right)$ are polynomial generators of $S^{W}$ over $F(\mathbb{H})$, then we have (ii).

We put $S_{1}:=F(\mathbb{H})\left[\tilde{s}_{0}, \cdots, \tilde{s}_{3}\right] \oplus \tilde{s}_{4} F(\mathbb{H})\left[\tilde{s}_{0}, \cdots, \tilde{s}_{3}\right], S_{2}:=\tilde{s}_{4}^{2} S^{W}$. Then we have $S^{W}=S_{1} \oplus S_{2}$.

Proposition 6.14. In the decomposition $S^{W}=S_{1} \oplus S_{2}, S_{2}$-component of $I^{*}\left(d \tilde{s}_{i}, d \tilde{s}_{j}\right) \in$ $S^{W}$ is 0 for $i, j=-1, \cdots, 4$.

Proof. For the cases $i=-1$ or $j=-1$, the assertions are shown by (2.4). We assume $i, j \geq 0$. We put $J_{1}:=M_{*}\left[\hat{s}_{0}, \cdots, \hat{s}_{3}\right] \oplus \hat{s}_{4} M_{*}\left[\hat{s}_{0}, \cdots, \hat{s}_{3}\right], J_{2}:=\hat{s}_{4}^{2} J_{*, *}$. Then we have $J_{*, *}=J_{1} \oplus J_{2}$. By (6.11), we should only prove that $J_{2}$-component of the Jacobi form $\mathcal{I}\left(\hat{s}_{i}, \hat{s}_{j}\right)$ is 0 . We show it by checking its weight and index. The weight and index of this Jacobi form is $k_{i}+k_{j}+2$ and $m_{i}+m_{j}$. However the $J_{2}$-component of such weight and index must be 0 because of the structure theorem of Wirthmüller. Thus we have the result.

We put $J_{k, m}^{\text {cusp }}:=\operatorname{ker}\left(J_{k, m} \rightarrow J_{k, m}^{0}\right)$. Then we have $J_{k, m}^{\text {cusp }}=\left(\hat{E}_{4}^{3}-\hat{E}_{6}^{2}\right) J_{k-12, m}$. Then we have the following Lemma.

Proof. For each equation, the both sides are Jacobi forms of same weight and index. For these weight and index, we could check that the space of cusp forms are \{0\} by Lemma 6.15. Thus we should only check that the initial terms of both sides coincide. This could be done by calculating the $\bar{D}$ action on $\mathbb{C}\left[S\left(\omega_{1}\right), \cdots, S\left(\omega_{4}\right)\right]$. which is discussed in Proposition 6.12.

## 7. Differential relations satisfied by modular forms

In Section 7.1, we show that $\eta^{4} \chi_{\Lambda_{i}}^{(0)}(i=0,1)$ satisfy the linear differential equation called "the Kaneko-Zagier equation" in Proposition 7.1 eq. (7.2). It is used to give the flat generator system in Proposition 5.7 (ii). In Section 7.2, we show that $\eta^{4} \chi_{\Lambda_{i}}^{(0)}$ $(i=0,1)$ satisfy the non-linear differential equations called "the Halphen's equations" in Proposition 7.2 eq. (7.10). It is used to give a description of the potential of the Frobenius structure in Proposition 5.7.
7.1. The Kaneko-Zagier equations. For $k \in \frac{1}{2} \mathbb{Z}$, we consider the following differential equation:

We assert that the $\mathbb{C}$-algebra generated by $\eta^{4} \chi_{\Lambda_{0}}^{(0)}, \eta^{4} \chi_{\Lambda_{1}}^{(0)}, \eta^{\prime} / \eta$ also has a structure of differential algebra which contains the above differential algebra.

For that purpose, we first introduce the following functions

which we call "the Halphen's equations". For these equations, we refer Ohyama [14].

Proposition 7.2. $\eta^{4} \chi_{\Lambda_{0}}^{(0)}, \eta^{4} \chi_{\Lambda_{1}}^{(0)}, \eta^{\prime} / \eta$ satisfy the following relations.

Here we use $E_{2}^{\prime}=\frac{1}{12}\left(E_{2}^{2}-E_{4}\right)$ for 1st equality, use $E_{2}=4\left(\xi_{2}+\xi_{3}+\xi_{4}\right)$ for 2nd equality and use (7.10) for the last equality.

Thus if $a+b+c=0$ for $a, b, c \in \mathbb{C}$, then $a \xi_{2}+b \xi_{3}+c \xi_{4}$ satisfies the Kaneko-Zagier equation for $k=2$.

Since $\eta^{4} \chi_{\Lambda_{0}}^{(0)}, \eta^{4} \chi_{\Lambda_{1}}^{(0)}$ also satisfy the Kaneko-Zagier equation for $k=2$, we obtain the result by comparing the leading terms of the $q$-expansions.

Proof (of Proposition 7.2). In Ohyama [14], the following relations are obtained:

By Proposition 7.3, the equations (7.10a)-(7.10c) and (7.15), we have the results.

## 8. Duality for the Kaneko-Zagier equation

Let $V_{k}$ be a solution space of the Kaneko-Zagier equation for $k \in \frac{1}{2} \mathbb{Z}$. For $k \neq 0,4$, we find the duality between $V_{k}$ and $V_{4-k}$, which appeared already in Proposition 5.7 (i) eq. (5.7) for $k=2$ and [21, (3.25)] for $k=3$. This duality is important for the study of the differential algebra generated by $V_{k}$ which will be used to the explicit construction of the potential of the Frobenius structure for the elliptic root systems of type $E_{6}^{(1,1)}(k=3$ case) and $E_{7}^{(1,1)}(k=7 / 2$ case $)$.

In this section, we first formulate the Kaneko-Zagier equations as a connection on $\mathbb{C}^{*} \times \mathbb{H}$ (eq. (8.1)). Then we have a duality for any $k \in \frac{1}{2} \mathbb{Z}$ (eq. (8.2)). This formulation is analogous to the formulation of Saito [15, §5.4]. Then we restrict ourselves to the cases of $0<k<4$ and give the duality for the Kaneko-Zagier equations (eq. (8.4)).

We put $M:=\mathbb{C}^{*} \times \mathbb{H}$. We denote by $\mathcal{O}_{M}$ the sheaf of holomorphic functions on $M$ and by $\Omega_{M}$ the sheaf of holomorphic 1-forms on $M$. Let

For $k \in \frac{1}{2} \mathbb{Z}$, we define a connection $\nabla^{(k)}: \Omega_{M} \rightarrow \Omega_{M} \otimes_{\mathcal{O}_{M}} \Omega_{M}$ by

We see that it is a flat and torsion free connection on $\Omega_{M}$.

This connection has the following property which is obtained by direct calculation.

By torsion freeness of $\nabla^{(k)}$, the flat section is a closed form. Thus the differential equations $\nabla^{(k)} d F=0$ have 3 -dimensional solutions which contain constant functions.

Hereafter we also assume the homogeneity. Then we have the following differential equations.

Proposition 8.2. For $k \in \frac{1}{2} \mathbb{Z}$ and for a local section $F$ of $\mathcal{O}_{M}$, the following conditions are equivalent:
(1) $X_{1} F=(-2 k) F, \quad \nabla^{(k)} d F=0$.
(2) $X_{1} F=(-2 k) F, \quad \delta_{q} \delta_{q} F=\frac{k}{12} \frac{k+2}{12} \hat{E}_{4} F$.
(3) There exists a local section $f$ of $\mathcal{O}_{\mathbb{H}}$ s.t. $F=\omega^{-2 k} f$ and $\partial_{k+2} \partial_{k} f=\frac{k}{12} \frac{k+2}{12} E_{4} f$.

For each $k \in \frac{1}{2} \mathbb{Z}$, we have 2-dimensional solutions. They contain non-zero constant functions iff $k=0$. Thus these solutions have pairing induced by $h$ which is non-degenerate for $k \neq 0,4$, and degenerate for $k=0,4$.

Hereafter we assume $0<k<4$. For these cases, we shall write down the pairing explicitly. We have one solution $f_{1}^{(k)} \in \mathbb{C}\{\{q\}\}$ whose leading term is 1 . We also have another solution $f_{2}^{(k)} \in q^{\alpha} \mathbb{C}\{\{q\}\}$ whose leading term is $q^{\alpha}$ where $\alpha=\frac{k+1}{6}$. By these conditions, $f_{j}^{(k)}(j=1,2)$ are uniquely determined. Their $q$-expansions are

## Appendix A. A Lemma on the connection

In this appendix, we give a lemma on the connection which was used in the proof of Proposition 5.6.

The idea is as follows. If we have a vector bundle $E$ on $X$ and the flat connection $\nabla$ on $E$ and we have a submersion $\varphi: X \rightarrow Y$ with each fiber is contractible. Then the flat frame of $E$ on $X$ could be obtained by 2 steps: (1) construct frame $v_{1}, \cdots, v_{l}$ of $E$
which are flat along every fiber of $\varphi(2)$ find functions $f_{1}, \cdots, f_{l}$ on $Y$ s.t. $\sum_{i=1}^{l} f_{i} v_{i}$ is flat on $X$.

The following lemma enables us to realize step (1) in the setting of Proposition 5.6. We denote $S^{W}$ by $S$ and $F(\mathbb{H})$ by $R$ in this appendix.

Lemma A.1. Let $E_{1} \subset E_{2} \subset E_{3}$ are graded $S$-free modules. The module $E_{3}$ has a flat connection

We assume that $u_{1}, \cdots, u_{l}$ are $S$-free basis of $E_{1}$, each $u_{i}$ is homogeneous of degree less than r. $u_{1}, \cdots, u_{l}, v_{1}, \cdots, v_{m}$ are $S$-free basis of $E_{2}$, each $v_{i}$ is homogeneous of degree $r . u_{1}, \cdots, u_{l}, v_{1}, \cdots, v_{m}, w_{1}, \cdots, w_{n}$ are $S$-free basis of $E_{3}$, each $w_{i}$ is homogeneous of degree greater than $r$, for some $r \in \mathbb{Z}_{\geq 0}$. We also assume that

(ii) For $1 \leq i \leq m, 1 \leq j \leq l$, there exists uniquely $d_{i j} \in S$ which is homogeneous and $d_{S / R}\left(d_{i j}\right)=\pi\left(c_{i j}\right)$ for $\pi: \Omega_{S / \mathbb{C}} \rightarrow \Omega_{S / R}$.
(iii) For $1 \leq i \leq m$, put $\tilde{v}_{i}:=v_{i}-\sum_{j=1}^{l} d_{i j} u_{j}$. Then $\tilde{v}_{i}$ is homogeneous of degree $k$ and $u_{i}(1 \leq i \leq l)$, $\tilde{v}_{i}(1 \leq i \leq m)$, $w_{i}(1 \leq i \leq n)$ are $S$-free basis of $E_{3}$. By this basis, $\nabla$ is represented as

Then $\bar{\nabla}$ is also connection and it is flat. By the assumption $a_{i j} \in \Omega_{R / \mathbb{C}}(1 \leq i, j \leq l)$, we have $\bar{\nabla} u_{i}=0(1 \leq i \leq l)$. By (i), we have $\bar{\nabla} v_{i}=\sum_{j=1}^{l} \pi\left(c_{i j}\right) \otimes u_{j}(1 \leq i \leq m)$. By the flatness of $\bar{\nabla}$ and $\bar{\nabla} u_{i}=0$, we have $d_{S / R}\left(\pi\left(c_{i j}\right)\right)=0$.

Since $\pi\left(c_{i j}\right)$ is homogeneous of degree $>0$ and the following sequence

0 \longrightarrow R \longrightarrow S \xrightarrow{d_{S / R}} \Omega_{S / R} \xrightarrow{d_{S / R}} \Omega_{S / R}^{2}
$$

is exact and if the homogeneous element $\omega \in \Omega_{S / R}$ satisfies $d_{S / R} \omega=0$, then we have an algorithm to obtain $\eta \in S$ s.t. $d_{S / R}(\eta)=\omega$.

Proof. Since $S$ is a polynomial algebra over $R$, the exactness of the sequence reduces to the one for the case of a polynomial algebra over $\mathbb{Q}$. For this case, the exactness of the sequence holds. Each homogeneous part of the sequence could be represented by matrices of $\mathbb{Q}$-coefficients by any $\mathbb{Q}$-basis, thus we have an algorithm to obtain $\eta$.
