# ON THE COMPARISON OF TWO CONSTRUCTIONS OF WITT VECTORS OF NON-COMMUTATIVE RINGS

#### Abstract

Let $A$ be any associative ring, possibly non-commutative and let $p$ be a prime number. Let $E(A)$ be the ring of $p$-typical Witt vectors as constructed by Cuntz and Deninger in [1] and $W(A)$ be that constructed by Hesselholt in [3]. The goal of this paper is to answer the following question by Hesselholt : Is $H H_{0}(E(A)) \cong W(A)$ ? We show that in the case $p=2$, there is no such isomorphism possible if one insists that it be compatible with the Verscheibung operator and the Teichmüller map.


## 1. Introduction

Let $A$ be a associative unital ring and $p$ be a prime number. When $A$ is commutative, the classical construction of $p$-typical Witt vectors gives us a topological ring $W(A)$, equipped with a Verscheibung operator

$$
W(A) \xrightarrow{V} W(A)
$$

and a Teichmüller map, which we denote by

$$
A \xrightarrow{\zeta} W(A) .
$$

In this paper we consider two generalizations of this construction to the non-commutative case. One of them is a construction of an abelian group $W(A)$ given by Hesselholt in [2] (see also [3]). The other is a construction of a ring $E(A)$ by Cuntz and Deninger, given in [1]. Just as in the commutative case, $E(A)$ and $W(A)$ are topological rings and are equipped with the Verscheibung operator and the Teichmüller map. Moreover, both $W(A)$ and $E(A)$ are isomorphic to the classical construction of Witt vectors when $A$ is commutative. Let $H H_{0}(E(A)):=E(A) / \overline{[E(A), E(A)]}$. The goal of this paper is to answer the following question of Hesselholt.
Question 1.1. Is $W(A)$ isomorphic to $H H_{0}(E(A))$ ?
We note that $H H_{0}(E(A))$ inherits the Verschiebung operator $V$ and the Teichmüller map $\rangle$, from $E(A)$. In this paper we only consider maps from $W(A)$ to $H H_{0}(E(A))$ which are compatible with $V$ and $\rangle$.

The following is one of the main results of this paper.
Theorem 1.2. Let $A=\mathbb{Z}\{X, Y\}$ and $p=2$. Then
(i) $W(A)$ is topologically generated by $\left\{V^{n}(\langle a\rangle) \mid n \in \mathbb{N}_{0}, a \in A\right\}$.
(ii) $H H_{0}(E(A))$ is not topologically generated by $\left\{V^{n}(\langle a\rangle) \mid n \in \mathbb{N}_{0}, a \in A\right\}$.
(iii) there is no continuous surjective map from $W(A) \rightarrow H H_{0}(E(A))$ which commutes with $V$ and is compatible with $\rangle$.

One can thus slightly modify Question 1.1 and ask for existence of a map (not necessarily surjective) from $W(A) \rightarrow H H_{0}(E(A))$ compatible with the Verscheibung operator and the Teichmüller map. The following theorem, shows that even this is not possible, at least in the case $p=2$.
Theorem 1.3. Let $A:=\mathbb{Z}\{X, Y\}$ and $p=2$. Then there is no continuous group homomorphism from $W(A) \rightarrow H H_{0}(E(A))$ which is compatible with $V$ and $\rangle$.

We believe that Theorems 1.2 and 1.3 should hold for all primes $p$.

## 2. Preliminaries

Let $A$ be a unital associative ring, not necessarily commutative. Fix a prime number $p$. Let $\mathbb{N}_{0}:=\mathbb{N} \bigcup\{0\}$. We briefly recall a few facts about the constructions of Witt ring by Hesselholt and by Cuntz and Deninger.
2.1. Hesselholt's construction of $W(A)$ : Let $A$ be a unital associative ring. Consider the map (called as ghost map)

\omega: A^{\mathbb{N}_{0}} \rightarrow\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}} \\
\omega\left(a_{0}, a_{1}, a_{2}, \ldots\right):=\left(\omega_{0}\left(a_{0}\right), \omega_{1}\left(a_{0}, a_{1}\right), \omega_{2}\left(a_{0}, a_{1}, a_{2}\right), \ldots\right)
\end{gathered}
$$

where $\omega_{i}$ 's are ghost polynomials defined by

$$
\omega_{i}\left(a_{0}, \ldots, a_{i}\right):=a_{0}^{p^{i}}+p a_{1}^{p^{i-1}}+p^{2} a_{2}^{p^{i-2}}+\cdots+p^{i} a_{i} .
$$

$\omega$ is merely a map of sets and not a homomorphism of groups. For every integer $n \in \mathbb{N}_{0}$, we also have truncated versions of the above map (denoted again by $\omega$ )

$$
\begin{gathered}
\omega: A^{n} \rightarrow\left(\frac{A}{[A, A]}\right)^{n} \\
\omega\left(a_{0}, \ldots, a_{n-1}\right):=\left(\omega_{0}\left(a_{0}\right), \omega_{1}\left(a_{0}, a_{1}\right), \ldots, \omega_{n-1}\left(a_{0}, a_{1}, a_{2}, \ldots a_{n-1}\right)\right)
\end{gathered}
$$

Hesselholt then inductively defines groups $W_{n}(A)$ (see [3]) such that the map $\omega$ factor through

$$
A^{n} \xrightarrow{q_{n}} W_{n}(A) \xrightarrow{\bar{\omega}}\left(\frac{A}{[A, A]}\right)^{n}
$$

and the following are satisfied
(1) $W_{1}(A)=\frac{A}{[A, A]}$.
(2) $q_{n}$ is surjective map of sets.
(3) $\bar{\omega}$ is an additive homomorphism and is injective if $\frac{A}{[A, A]}$ is $p$-torsion free.

Define $W(A):={\underset{\zeta}{\underset{n}{2}}}_{\lim _{n}} W_{n}(A)$. Clearly one also has a factorization of $A^{\mathbb{N}_{0}} \xrightarrow{\omega}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}$ as

$$
A^{\mathbb{N}_{0}} \xrightarrow{q} W(A) \xrightarrow{\bar{\omega}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

where $q$ is always surjective and where $\bar{\omega}$ is injective if $\frac{A}{[A, A]}$ has no $p$-torsion. Thus every element of $W(A)$ is of the form $q\left(a_{0}, a_{1}, \ldots\right)$ for some (not necessarily unique) $\left(a_{0}, a_{1}, \ldots\right) \in \mathbb{A}^{\mathbb{N}_{0}}$. We will often abuse notation to denote an element of $W(A)$ simply by a tuple ( $a_{0}, a_{1}, \ldots$. ) instead of the cumbersome $q\left(a_{0}, a_{1}, \ldots\right)$ while taking care to handle well definedness issues should they arise.

We have the Verschiebung operator

$$
V: W(A) \rightarrow W(A)
$$

and the Teichmüller map

$$
\rangle: A \longrightarrow W(A)
$$

which satisfy

$$
V\left(a_{0}, a_{1}, \cdots\right)=\left(0, a_{0}, a_{1}, \cdots\right)
$$

and

$$
\langle a\rangle=(a, 0,0, \ldots)
$$

One can show that $V$ and $\rangle$ are well defined and that $V$ is a additive homomorphism. Similarly for $n \in \mathbb{N}_{0}$, we have truncated versions (denoted by the same notation) $W_{n}(A) \xrightarrow{V} W_{n}(A)$ and $A \xrightarrow{\zeta \zeta} W_{n}(A)$, satisfying

V\left(a_{0}, \ldots, a_{n-1}\right)=\left(0, a_{0}, a_{1}, \ldots, a_{n-2}\right)
$$

and

$$
\langle a\rangle=(a, 0,0, \ldots, 0)
$$

2.2. Cuntz and Deninger's construction of $E(A)$ : For any associative ring $R$
(i) Let $V: R^{\mathbb{N}_{0}} \rightarrow R^{\mathbb{N}_{0}}$ be the map defined by $V\left(a_{0}, a_{1}, \ldots\right):=p\left(0, a_{0}, a_{1}, \ldots.\right)$.
(ii) For an element $a \in R$, define $\langle a\rangle \in R^{\mathbb{N}_{0}}$ by $\langle a\rangle:=\left(a, a^{p}, a^{p^{2}}, \ldots\right)$.
(iii) Let $X(R) \subset R^{\mathbb{N}_{0}}$ be the closed subgroup generated by

$$
\left\{V^{m}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{r}\right\rangle\right) \mid m \in \mathbb{N}_{0}, r \in \mathbb{N}, a_{i} \in R \forall i\right\}
$$

Similarly, if $I \subset R$ is an ideal, we let $X(I)$ denote the closed subgroup generated by

$$
\left\{V^{m}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{r}\right\rangle\right) \mid m \in \mathbb{N}_{0}, r \in \mathbb{N}, a_{i} \in I \forall i\right\}
$$

For $n \in \mathbb{N}_{0}$, we also have the following truncated versions of the definitions.
(i) Let $V: \prod_{i=0}^{n} R \rightarrow \prod_{i=0}^{n} R$ be the map defined by $V\left(a_{0}, a_{1}, \ldots, a_{n}\right):=p\left(0, a_{0}, a_{1}, \ldots, a_{n-1}\right)$.
(ii) For an element $a \in R$, define $\langle a\rangle \in \prod_{i=0}^{n} R$ by $\langle a\rangle:=\left(a, a^{p}, a^{p^{2}}, \ldots, a^{p^{n}}\right)$.
(iii) Let $X_{n}(R) \subset \prod_{i=0}^{n} R$ be the subgroup generated by

$$
\left\{V^{m}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{r}\right\rangle\right) \mid m \in \mathbb{N}_{0}, r \in \mathbb{N}, a_{i} \in R \forall i\right\} .
$$

Note that the above definitions depend on the chosen prime number $p$. Now let $A$ be any associative ring. Let $\mathbb{Z} A$ be the monoid algebra of the multiplicative monoid underlying $A$. Thus the elements of $\mathbb{Z} A$ are formal sums of the form $\sum_{r \in \mathbb{Z} A} n_{r}[r]$ with almost all $n_{r}=0$. We have a natural epimorphism of rings from $\mathbb{Z} A \rightarrow A$ and we let $I$ denote its kernel. One now defines

$$
E(A):=\frac{X(\mathbb{Z} A)}{X(I)} \quad \text { and } \quad E_{n}(A):=\frac{X_{n}(\mathbb{Z} A)}{X_{n}(I)}
$$

We have a set map, called the Teichmüller map

$$
\begin{gathered}
\rangle: A \rightarrow E(A) \\
\langle a\rangle:=\left([a],[a]^{p},[a]^{p^{2}}, \ldots\right) \bmod X(I) .
\end{gathered}
$$

It is elementary to check that
(i) $X(\mathbb{Z} A)$ is a subring of $(\mathbb{Z} A)^{\mathbb{N}_{0}}$ and $X(I) \subset X(\mathbb{Z} A)$ is a two sided ideal. Thus $E(A)$ has the structure of an associtive ring. Similarly $E_{n}(A)$ has a ring structure $\forall n \in \mathbb{N}_{0}$.
(ii) $V:(\mathbb{Z} A)^{\mathbb{N}_{o}} \rightarrow(\mathbb{Z} A)^{\mathbb{N}_{o}}$ induces maps (denoted by the same notation for simplicity) called Verscheibung operators

$$
E(A) \xrightarrow{V} E(A) \quad, \quad E_{n}(A) \xrightarrow{V} E_{n}(A)
$$

(iii) The morphism $E(A) \rightarrow E_{n}(A)$ is a continuous epimorphism of rings, where target has discrete topology and $E(A)$ has topology inherited from the product topology on $(\mathbb{Z} A)^{\mathbb{N}_{0}}$. Moreover this map commutes with $V$.

Recall that for any associative ring $R, H H_{0}(R):=R /[R, R]$. However, as $E(A)$ has a topology, we use the notation $H H_{0}(E(A))$ to denote $\left.E(A) / \overline{[E(A), E(A)}\right]$ where $\overline{[E(A), E(A)]}$ is the closure of $[E(A), E(A)]$. The Verscheibung operator and the Teichmüller map induce (see (3.2))

$$
V: H H_{0}(E(A)) \rightarrow H H_{0}(E(A))
$$

and

$$
\left\rangle: A \rightarrow H H_{0}(E(A))\right.
$$

2.3. Comparison of $E(A)$ and $X(A)$ : In the case when $A$ is commutative and has no $p$-torsion, $E(A)$ is isomorphic to $X(A)$. In the non-commutative case we do not know a sufficient condition for $E(A)$ to be isomorphic to $X(A)$. Nevertheless, in this paper we will often find it easier to work in the ring $X(A)$ instead of $E(A)$. We note that exact sequence

$$
0 \rightarrow I \rightarrow \mathbb{Z} A \rightarrow A \rightarrow 0
$$

induces a map $X(\mathbb{Z} A) \rightarrow X(A)$, with $X(I)$ in its kernel. Thus we have a continuous ring homomorphism from

$$
E(A):=X(\mathbb{Z} A) / X(I) \xrightarrow{\pi} X(A)
$$

Like $E(A), X(A)$ also has a Verscheibung operator $V: X(A) \rightarrow X(A)$ given by

$$
V\left(a_{0}, a_{1}, \ldots\right)=p\left(0, a_{0}, a_{1}, \ldots\right)
$$

and the Teichmüller map $\rangle: A \rightarrow X(A)$ given by

$$
\langle a\rangle:=\left(a, a^{p}, a^{p^{2}}, \ldots .\right)
$$

Clearly, the map $E(A) \xrightarrow{\pi} X(A)$ is compatible with the Verscheibung operator and Teichmüller map on both sides.

## 3. Proof of Theorem 1.2

Lemma 3.1. Let $A$ be any associative ring. Then $\overline{[X(A), X(A)]}$ is the closed subgroup of $X(A)$ generated by

$$
\left\{p^{m} V^{n}\left(\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}^{p^{n-m}}\right\rangle \cdots\left\langle b_{t}^{p^{n-m}}\right\rangle\right]\right) \mid m, n \in \mathbb{N}_{0}, m \leq n, s, t \in \mathbb{N}, a_{i}, b_{j} \in A\right\}
$$

Proof. Since $X(A)$ is the closed subgroup of $A^{\mathbb{N}_{0}}$ generated by

$$
\left\{V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right) \mid s \in \mathbb{N}, n \in \mathbb{N}_{0}, a_{i} \in A\right\}
$$

$\overline{[X(A), X(A)]}$ is the closed subgroup generated by

$$
\left\{\left[V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right), V^{m}\left(\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right)\right] \mid s, t \in \mathbb{N}, m, n \in \mathbb{N}_{0}, a_{i}, b_{j} \in A\right\}
$$

Since

$$
\left[V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right), V^{m}\left(\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right)\right]=-\left[V^{m}\left(\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right), V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right)\right]
$$

$\overline{[X(A), X(A)]}$ is also the closed subgroup generated by

$$
\left\{\left[V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right), V^{m}\left(\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right)\right] \mid s, t \in \mathbb{N}, a_{i}, b_{j} \in A, m, n \in \mathbb{N}_{0} \text { with } m \leq n\right\}
$$

When $m \leq n$, a straightforward calculation shows that

$$
\left[V^{n}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle\right), V^{m}\left(\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right)\right]=p^{m} V^{n}\left(\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}^{p^{n-m}}\right\rangle \cdots\left\langle b_{t}^{p^{n-m}}\right\rangle\right]\right)
$$

This proves the lemma.
Corollary 3.2. $V(\overline{[X(A), X(A)]}) \subset \overline{[X(A), X(A)]}$. Thus $V$ induces a map (to be also denoted by $V$ )

$$
H H_{0}(X(A)) \xrightarrow{V} H H_{0}(X(A))
$$

Thus like the Witt rings and like $X(A), H H_{0}(X(A))$ also comes equipped with Verscheibung operator and a Teichmüller map.

Lemma 3.3. Let $A$ be any associative unital ring such that $\frac{A}{[A, A]}$ has no $p$-torsion. Then
(i) for any element $\left(a_{0}, a_{1}, \ldots\right) \in W(A)$

$$
\left(a_{0}, a_{1}, \ldots\right)=\sum_{i=0}^{\infty} V^{i}\left\langle a_{i}\right\rangle .
$$

(ii) $W(A)$ is topologically generated by the set $\left\{V^{n}\langle a\rangle \mid a \in A, n \in \mathbb{N}_{0}\right\}$, i.e. $W(A)$ is the closure of the subgroup generated by this set.

Proof. (ii) is a direct consequence of $(i)$. Thus it is enough to prove (i). The ghost map $W(A) \xrightarrow{\bar{\omega}}$ $\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}$ is a continuous group homomorphism, where addition in $\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}$ is componentwise. Since $\frac{A}{[A, A]}$ has no $p$-torsion, $\bar{\omega}$ is injective. Thus, to prove $(i)$, it is enough to show

$$
\bar{\omega}\left(a_{0}, a_{1}, \ldots\right)=\sum_{i=0}^{\infty} \bar{\omega}\left(V^{i}\left(\left\langle a_{i}\right\rangle\right)\right) .
$$

This is checked by explicit calculation.

$$
\begin{aligned}
\sum_{i=0}^{\infty} \bar{\omega}\left(V^{i}\left(\left\langle a_{i}\right\rangle\right)\right) & =\sum_{i=0}^{\infty} \bar{\omega}\left(0,0, \ldots, 0, a_{i}, 0, \ldots\right) \quad \text { (where } a_{i} \text { is in the } i \text {-th position) } \\
& =\sum_{i=0}^{\infty}\left(0,0, \ldots, 0, p^{i} a_{i}, p^{i} a_{i}^{p}, p^{i} a_{i}^{p^{2}}, \ldots\right) \\
& =\sum_{i=0}^{\infty}\left(0,0, \ldots, 0, p^{i} a_{i}, p^{i} a_{i}^{p}, p^{i} a_{i}^{p^{2}}, \ldots\right) \\
& =\left(a_{0}, a_{0}^{p}+p a_{1}, a_{0}^{p^{2}}+p a_{1}^{p}+p^{2} a_{2}, \ldots .\right) \\
& =\bar{\omega}\left(a_{0}, a_{1}, a_{2}, \ldots .\right)
\end{aligned}
$$

Remark 3.4. It is possible that the above lemma holds without the assumption that $\frac{A}{[A, A]}$ has no $p$-torsion.

Let $A=\mathbb{Z}\{X, Y\}$. Then $A=\oplus_{i \geq 0} A_{i}$ is naturally a graded ring where $A_{i}$ is the free abelian group generated by words in $X, Y$ of length $i$. The center of $A$ is $A_{0}=\mathbb{Z}$. Consider the filtration $F^{\bullet} A$ on $A$ defined by

$$
F^{n} A=\oplus_{i \geq n} A_{i} .
$$

Proof of Theorem 1.2. (iii) is a direct consequence of $(i)$ and (ii). Lemma 3.3 proves (i). Thus to prove the theorem, it remains to show that $H H_{0}(E(A))$ is not topologically generated by $\left\{V^{n}\langle a\rangle \mid a \in\right.$ $\left.A, n \in \mathbb{N}_{0}\right\}$. The surjectivity of $E(A)$ to $X(A)$ implies the surjectivity of the map $H H_{0}(E(A)) \rightarrow$ $H H_{0}(X(A))$. As this map commutes with the $V$ and $\left\rangle\right.$, it suffices to show that $H H_{0}(X(A))$ is not topologically generated by $\left\{V^{n}\langle a\rangle \mid a \in A, n \in \mathbb{N}_{0}\right\}$. More specifically, we will show that the element $\langle X\rangle\langle Y\rangle \in H H_{0}(X(A))$ is not in the closure of the subgroup generated by $\left\{V^{n}\langle a\rangle \mid a \in A, n \in \mathbb{N}_{0}\right\}$. Suppose it is. Then, there exists elements $c_{i} \in A$ and $\ell_{i} \in \mathbb{N}_{0}$, such that in $X(A)$ we have a congruence of the form

$$
\langle X\rangle\langle Y\rangle=\sum_{i} V^{\ell_{i}}\left\langle c_{i}\right\rangle \bmod \overline{[X(A), X(A)]} .
$$

Clearly the integers $\ell_{i}$ are such that the summation above converges. In particular, only finitely many of the $\ell_{i}$ 's can be zero. We may rewrite the above as

$$
\langle X\rangle\langle Y\rangle-\sum_{i} V^{\ell_{i}}\left\langle c_{i}\right\rangle \in \overline{[X(A), X(A)]}
$$

By Lemma 3.1, we have an equality of the form (for suitable choices of integers and elements of $A$ )

$$
\langle X\rangle\langle Y\rangle-\sum_{i=0}^{\infty} V^{\ell_{i}}\left\langle c_{i}\right\rangle=\sum_{j=0}^{\infty} 2^{m_{j}} V^{n_{j}}\left(\left[\left\langle a_{j, 1}\right\rangle \cdots\left\langle a_{j, s_{j}}\right\rangle,\left\langle b_{j, 1}^{2^{n_{j}-m_{j}}}\right\rangle \cdots\left\langle b_{j, t_{j}}^{2^{n_{j}-m_{j}}}\right\rangle\right]\right)
$$

Without loss of generality, we assume that

$$
\begin{gathered}
0=\ell_{0}=\cdots=\ell_{r}<\ell_{r+1} \leq \ell_{r+2} \leq \cdots \\
0=n_{0}=\cdots=n_{\kappa}<n_{\kappa+1} \leq n_{\kappa+2} \leq \cdots
\end{gathered}
$$

Modulo 2, most of the terms in $(\star)$ become zero and we have the following congruence in $\mathbb{A}^{\mathbb{N}_{0}}$

$$
\langle X\rangle\langle Y\rangle-\sum_{i=0}^{r}\left\langle c_{i}\right\rangle=\sum_{j=0}^{\kappa}\left(\left[\left\langle a_{j, 1}\right\rangle \cdots\left\langle a_{j, s_{j}}\right\rangle,\left\langle b_{j, 1}\right\rangle \cdots\left\langle b_{j, t_{j}}\right\rangle\right] \bmod 2\left(A^{\mathbb{N}_{0}}\right)\right.
$$

Looking at the second component (i.e. component indexed by 1) of the tuples we get the following congruence in the ring $A=\mathbb{Z}\{X, Y\}$.

$$
X^{2} Y^{2}-\sum_{i=0}^{r} c_{i}^{2}=\sum_{j=0}^{\kappa}\left[a_{j, 1}^{2} \cdots a_{j, s_{j}}^{2}, b_{j, 1}^{2} \cdots b_{j, t_{j}}^{2}\right] \bmod 2 A
$$

i.e.

$$
X^{2} Y^{2}=\sum_{i=0}^{r} c_{i}^{2} \bmod (2 A+[A, A])
$$

Observe that for any two elements $a, b \in A$ we have

$$
\begin{aligned}
(a+b)^{2} & =a^{2}+b^{2}+a b+b a \\
& =a^{2}+b^{2} \bmod (2 A+[A, A])
\end{aligned}
$$

Thus if we let $c:=\sum_{i=0}^{r} c_{i}$, then

$$
c^{2} \equiv \sum_{i=0}^{r} c_{i}^{2} \bmod (2 A+[A, A])
$$

This implies

$$
X^{2} Y^{2}=c^{2} \bmod (2 A+[A, A])
$$

By Lemma 3.5 below, this is impossible. This proves the proposition.

Lemma 3.5. Let $A=\mathbb{Z}\{X, Y\}$. Then, $\forall c \in A$

$$
X^{2} Y^{2} \neq c^{2} \bmod \left(2 A+[A, A]+F^{5} A\right)
$$

Proof. Let $\bar{A}:=\mathbb{Z} / 2\{X, Y\}$. As in the case of $A, \bar{A}=\oplus_{i \geq 0} \bar{A}_{i}$ where $\bar{A}_{i}$ is $\mathbb{Z} / 2$ span of words in $X, Y$ of length precisely $i$. We let $F^{n} \bar{A}:=\oplus_{i \geq n} A_{i}$. In order to prove the lemma it is enough to arrive at a contradiction by assuming the existence of an element $c \in \bar{A}$, such that

$$
X^{2} Y^{2}=c^{2} \bmod \left([\bar{A}, \bar{A}]+F^{5} \bar{A}\right)
$$

Without loss of generality we may assume that $c=a_{0}+a_{1}+a_{2}+a_{3}+a_{4}$ where $a_{i} \in \bar{A}_{i}$ are its homogeneous components. But then

$$
\begin{aligned}
c^{2} & =a_{0}^{2}+a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2} \bmod \left([\bar{A}, \bar{A}]+F^{5} \bar{A}\right) \\
& =a_{0}^{2}+a_{1}^{2}+a_{2}^{2} \bmod \left([\bar{A}, \bar{A}]+F^{5} \bar{A}\right)
\end{aligned}
$$

Thus, ( $\star \star$ ) continues to hold with $c$ replaced by $a_{0}+a_{1}+a_{2}$. Hence without loss of generality we may assume $c=a_{0}+a_{1}+a_{2}$.

Step 1: Let $\widetilde{A}:=\mathbb{Z} / 2[X, Y]$ be the commutative polynomial ring in variables $X, Y$. This is quotient of the non-commutative polynomial ring $\bar{A}=\mathbb{Z} / 2\{X, Y\}$, i.e. we have a natural surjective map

$$
\bar{A} \xrightarrow{\phi} \widetilde{A}
$$

with $[\bar{A}, \bar{A}] \subset \operatorname{Ker}(\phi)$. The homomorphism $\phi$ preserves grading. We let $F^{n} \widetilde{A}:=\oplus_{i \geq n} \widetilde{A}_{i}$. Applying $\phi$ to the congruence $(\star \star)$ above, we get the following congruence in $\widetilde{A}$

$$
\begin{aligned}
X^{2} Y^{2} & =\phi(c)^{2} \bmod F^{5} \widetilde{A} \\
& =\phi\left(a_{0}\right)^{2}+\phi\left(a_{1}\right)^{2}+\phi\left(a_{2}^{2}\right) \bmod F^{5} \widetilde{A}
\end{aligned}
$$

Note that $\phi\left(a_{i}\right) \in \widetilde{A}_{i}$. Thus both sides of the congruence belong to the subgroup $\oplus_{i=0}^{4} \widetilde{A}_{i}$, which has trivial intersection with $F^{5} \widetilde{A}$. Therefore the congruence gives us an equality in $\widetilde{A}$

$$
X^{2} Y^{2}=\phi\left(a_{0}\right)^{2}+\phi\left(a_{1}\right)^{2}+\phi\left(a_{2}^{2}\right)
$$

Further, since $X^{2} Y^{2} \in \widetilde{A}_{4}$, the only possibility is $\phi\left(a_{0}\right)=\phi\left(a_{1}\right)=0$ and $\phi\left(a_{2}\right)=X Y$. Note that $\phi_{\mid \bar{A}_{i}}: \bar{A}_{i} \longrightarrow \widetilde{A}_{i}$ is an isomorphism for $i=0,1$. Thus

$$
a_{0}=a_{1}=0
$$

Moreover,

$$
\operatorname{Ker}\left(\bar{A}_{2} \xrightarrow{\phi_{\mid \bar{A}_{2}}} \widetilde{A}_{2}\right)=\mathbb{Z} / 2 \text { span of } X Y-Y X
$$

Thus $\phi(c)=\phi\left(a_{2}\right)=X Y$ implies that

$$
c=X Y+\epsilon[X, Y] \quad \text { for some } \epsilon \in \mathbb{Z} / 2
$$

This implies

$$
c^{2}=(X Y)^{2}+\epsilon^{2}(X Y-Y X)^{2} \bmod [\bar{A}, \bar{A}]
$$

Step 2:

$$
\begin{aligned}
(X Y-Y X)^{2} & =(X Y)^{2}+(Y X)^{2} \bmod [\bar{A}, \bar{A}] \\
& =[X, Y X Y] \bmod [\bar{A}, \bar{A}] \\
& =0 \bmod [\bar{A}, \bar{A}]
\end{aligned}
$$

Thus

$$
c^{2}=(X Y)^{2} \bmod [\bar{A}, \bar{A}]
$$

Therefore, without loss of generality, we may assume $c=X Y$.
Step 3: Now ( $\star \star$ ) gives us

$$
X^{2} Y^{2}-X Y X Y=u+v
$$

for some $u \in[\bar{A}, \bar{A}]$ and $v \in F^{5} \bar{A}$. Write $u=\sum_{i} u_{i}$ with $u_{i} \in \bar{A}_{i} \forall i$. Comparing the degree 4 homogeneous components of the above equation, we get

$$
X^{2} Y^{2}-X Y X Y=u_{4}
$$

Note that $[\bar{A}, \bar{A}]$ is graded subgroup of $\bar{A}$. Thus $u_{4} \in[\bar{A}, \bar{A}]$. Let $S \subset \bar{A}_{4}$ be a subset defined by

$$
S:=\{\text { all words in } X, Y \text { of length } 4, \text { except } X Y X Y \text { and } Y X Y X\} \bigcup\{X Y X Y-Y X Y X\}
$$

Let $K \subset \bar{A}_{4}$ be the $\mathbb{Z} / 2$-subspace spanned by $S$. Clearly

$$
X^{2} Y^{2}-X Y X Y \notin K
$$

Thus to finish the proof, it suffices to show $u_{4} \in K$. This will be done in the next step.

Step 4: $u_{4} \in[\bar{A}, \bar{A}] \cap \bar{A}_{4}$. It is elementary to check that $[\bar{A}, \bar{A}] \cap \bar{A}_{4}$ is generated by the set

$$
\left\{a_{i} b_{j}-b_{j} a_{i} \mid(i, j)=(1,3) \text { or }(2,2), \text { with } a_{i}, b_{j} \text { are words of length } i, j \text { respectively }\right\} .
$$

It therefore suffices to show that all elements of the form $a_{i} b_{j}-b_{j} a_{i}$ of the above set belong to $K$. The possibilities for $a_{i}$ and $b_{j}$ appearing in the above set are listed in the table below:

| $a_{1}$ | $X, Y$ |
| :---: | :---: |
| $b_{3}$ | $X^{3}, Y^{3}, X^{2} Y, X Y^{2}, Y X^{2}, Y^{2} X, X Y X, Y X Y$ |
| $a_{2}$ or $b_{2}$ | $X^{2}, Y^{2}, X Y, Y X$ |

For all possible combinations of $a_{1}$ and $b_{3}$, one explicitly checks that $a_{1} b_{3}-b_{3} a_{1}$ always belongs to $K$. Similarly for all possible combinations of $a_{2}$ and $b_{2}$ from the above table, one checks that $a_{2} b_{2}-b_{2} a_{2}$ always belongs to $K$. This finishes the proof.

## 4. Proof of Theorem 1.3

The goal of this section is to prove Theorem 1.3. Define a set map $\Omega: A^{\mathbb{N}_{0}} \rightarrow A^{\mathbb{N}_{0}}$ by

$$
\Omega(\underline{a})=\left(\omega_{0}(\underline{a}), \omega_{1}(\underline{a}), \ldots\right)
$$

where $\omega_{n}(\underline{a})=a_{0}^{p^{n}}+p a_{1}^{p^{n-1}}+\cdots+p^{n} a_{n}$ are the Witt polynomials. Recall that $X(A) \subset \mathbb{A}^{\mathbb{N}_{0}}$ is the closed subgroup generated by elements of the form $V^{i}\left(\left\langle a_{1}\right\rangle \cdots\left\langle a_{r}\right\rangle\right)$ where $V$ and $\rangle$ are as in the construction by Cuntz and Deninger summarized in the previous section.
Lemma 4.1. Image of $\mathbb{A}^{\mathbb{N}_{0}} \xrightarrow{\Omega} \mathbb{A}^{\mathbb{N}_{0}}$ is contained in $X(A)$. In fact, we have the following equality in $X(A)$ :

$$
\Omega\left(a_{0}, a_{1}, \ldots\right)=\sum_{i=0}^{\infty} V^{i}\left\langle a_{i}\right\rangle \quad \forall\left(a_{0}, a_{1}, \ldots\right) \in A^{\mathbb{N}_{0}}
$$

Proof.

$$
\begin{aligned}
\Omega\left(a_{0}, a_{1}, \ldots\right) & =\left(\omega_{0}(\underline{a}), \omega_{1}(\underline{a}), \ldots\right) \\
& =\left(a_{0}, a_{0}^{p}+p a_{1}, a_{0}^{p^{2}}+p a_{1}^{p}+p^{2} a_{2}, \ldots\right) \\
& =\left(a_{0}, a_{0}^{p}, a_{0}^{p^{2}}, \ldots\right)+p\left(0, a_{1}, a_{1}^{p}, a_{1}^{p^{2}}, \ldots\right)+p^{2}\left(0,0, a_{2}, a_{2}^{p}, a_{2}^{p^{2}}, \ldots\right)+\ldots \\
& =\sum_{i=0}^{\infty} V^{i}\left\langle a_{i}\right\rangle
\end{aligned}
$$

Thus, by the above lemma, $\Omega$ induces a map from $\mathbb{A}^{\mathbb{N}_{0}} \rightarrow X(A)$ which will also be denoted by $\Omega$.
Lemma 4.2. Let $A$ be such that $\frac{A}{[A, A]}$ is $p$-torsion free. Suppose there exists a continuous map $\Phi: W(A) \rightarrow H H_{0}(X(A))$ which commutes with $\rangle$ and $V$. Then the following diagram commutes


In other words, $\Phi$ is necessarily given by

$$
\Phi(q(\underline{a}))=\Omega(\underline{a}) \bmod \overline{[X(A), X(A)]} .
$$

Proof. For $\underline{a}=\left(a_{0}, a_{1}, \ldots\right) \in \mathbb{A}^{\mathbb{N}_{0}}$ we have

$$
\begin{array}{rlr}
\Phi(q(\underline{a})) & =\Phi\left(\sum_{i=0}^{\infty} V^{i}\left\langle a_{i}\right\rangle\right) & \quad \text { (by lemma 3.3(i)) } \\
& =\sum_{i=0}^{\infty} \Phi\left(V^{i}\left\langle a_{i}\right\rangle\right) & \quad \text { (by continuity of } \Phi \text { ) } \\
& =\Omega(\underline{a}) \bmod \overline{[X(A), X(A)]} & \text { (by Lemma 4.1 and since } \Phi \text { is continuous and preserves } V,\langle \rangle)
\end{array}
$$

This proves the lemma.
To state the next result we fix the following notation. Let $X(A) \xrightarrow{\gamma}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}$ denote the composition

$$
X(A) \hookrightarrow A^{\mathbb{N}_{0}} \rightarrow\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

Let $E(A) \xrightarrow{\eta}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}$ denote the composition

$$
E(A) \xrightarrow{\pi} X(A) \xrightarrow{\gamma}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

where $\pi$ is the surjection induced by $X(\mathbb{Z} A) \rightarrow X(A)$ (see subsection 2.3). Since $\eta$ and $\gamma$ are ring homomorphisms, and the target is a commutative ring, we have induced maps

$$
\begin{aligned}
& H H_{0}(X(A)) \xrightarrow{\bar{\gamma}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}} \\
& H H_{0}(E(A)) \xrightarrow{\bar{\eta}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
\end{aligned}
$$

The maps $\eta$ and $\bar{\eta}$ are analogous to the ghost map

$$
W(A) \xrightarrow{\bar{\omega}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

In the case when $\frac{A}{[A, A]}$ is is $p$-torsion free, $\bar{\omega}$ is always injective (see [3, page 56$]$ ). However as the following theorem shows, this is not the case for $\bar{\eta}$.
Theorem 4.3. Let $A=\mathbb{Z}\{X, Y\}$, and $p=2$. The map

$$
H H_{0}(E(A)) \xrightarrow{\bar{\eta}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

is not injective.
To prove this theorem we need the following lemma and a construction from [2] (see 4.5).
Lemma 4.4. Let $A=\mathbb{Z}\{X, Y\}$ and $p=2$. Let $A_{4}^{0} \subset A_{4}$ be the free subgroup generated by all words of length 4 in $X, Y$ except the words $X Y X Y$ and $Y X Y X$. Let $H:=A_{4}^{0}+F^{5} A+2 A$. Then

$$
\left(x_{0}, x_{1}, x_{2}, \ldots\right) \in \overline{[X(A), X(A)]} \Longrightarrow x_{1}=0 \bmod H
$$

Proof. By Lemma 3.1, $\overline{[X(A), X(A)]}$ is the closed subgroup generated by the following elements of $X(A)$ :

$$
\left\{2^{m} V^{n}\left(\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}^{2^{n-m}}\right\rangle \cdots\left\langle b_{t}^{2^{n-m}}\right\rangle\right]\right) \mid 0 \leq m \leq n \leq 1, s, t \in \mathbb{N}, a_{i}, b_{j} \in A\right\}
$$

where recall that for $a \in A,\langle a\rangle=\left(a, a^{2}, a^{2^{2}}, \ldots\right) \in X(A)$. As $A_{0}$ is in the center of $A$ we have

$$
\langle c\rangle\langle d\rangle=\langle c d\rangle \forall c \in A_{0} \text { and } d \in A .
$$

Thus, without loss of generality, we may restrict the $a_{i}, b_{j}$ in the generating set above to elements of $A \backslash A_{0}$. In other words $\overline{[X(A), X(A)]}$ is the closed subgroup generated by the following elements of $X(A)$ :

$$
\left\{2^{m} V^{n}\left(\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}^{2^{n-m}}\right\rangle \cdots\left\langle b_{t}^{2^{n-m}}\right\rangle\right]\right) \mid 0 \leq m \leq n \leq 1, s, t \in \mathbb{N}, a_{i}, b_{j} \in A \backslash A_{0}\right\}
$$

Thus it is enough to prove the statement of the lemma when $\left(x_{0}, x_{1}, ..\right)$ is an element of the generating set, i.e.

$$
\left(x_{0}, x_{1}, \ldots .\right)=2^{m} V^{n}\left(\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}^{2^{n-m}}\right\rangle \cdots\left\langle b_{t}^{2^{n-m}}\right\rangle\right]\right)
$$

Clearly if $m>0$ or if $n>0$, the RHS is divisible by 2 and since $2 A \subset H$, we have $x_{1} \in H$. It thus remains to show that for

$$
\left(x_{0}, x_{1}, \ldots\right)=\left[\left\langle a_{1}\right\rangle \cdots\left\langle a_{s}\right\rangle,\left\langle b_{1}\right\rangle \cdots\left\langle b_{t}\right\rangle\right]
$$

where $s, t \geq 1, x_{1} \in H$. Equivalently, we need to show the following:

$$
\left[a_{1}^{2} \cdots a_{s}^{2}, b_{1}^{2} \cdots b_{t}^{2}\right]=0 \bmod H \quad \forall a_{i}, b_{i} \in A
$$

To see this, we first observe that $H$ is a two sided ideal of $A$. The above statement is equivalent to showing that images of the elements $\left(a_{1}^{2} \cdots a_{s}^{2}\right)$ and $\left(b_{1}^{2} \cdots b_{t}^{2}\right)$ in the quotient ring $A / H$ commute. For this it is enough to show that for all $1 \leq i \leq s$ and $1 \leq j \leq t$, the images of the elements $a_{i}^{2}$ and $b_{j}^{2}$ in $A / H$ commute. In other words, we are reduced to showing that for elements $a, b \in A$,

$$
a^{2} b^{2}=b^{2} a^{2} \quad \bmod H
$$

Write

$$
\begin{aligned}
a & =\alpha_{0}+\alpha_{1}+\alpha_{2} \\
b & =\beta_{0}+\beta_{1}+\beta_{2}
\end{aligned}
$$

where $\alpha_{0}, \beta_{0} \in A_{0}, \alpha_{1}, \beta_{1} \in A_{1}$ and $\alpha_{2}, \beta_{2} \in F^{2} A$. Then, since $2 A \subset H$, we have

$$
\begin{aligned}
a^{2} & =\alpha_{0}^{2}+\alpha_{1}^{2}+\alpha_{2}^{2}+\alpha_{1} \alpha_{2}+\alpha_{2} \alpha_{1} \bmod H \\
b^{2} & =\beta_{0}^{2}+\beta_{1}^{2}+\alpha_{2}^{2}+\beta_{1} \beta_{2}+\beta_{2} \beta_{1} \bmod H
\end{aligned}
$$

We now explicitly calculate $a^{2} b^{2}-b^{2} a^{2}$ modulo $H$, while keeping in mind that $\alpha_{0}, \beta_{0}$ are in the center of $A$.

$$
\begin{aligned}
a^{2} b^{2}-b^{2} a^{2}= & \left(\alpha_{0}^{2}+\alpha_{1}^{2}+\alpha_{2}^{2}+\alpha_{1} \alpha_{2}+\alpha_{2} \alpha_{1}\right)\left(\beta_{0}^{2}+\beta_{1}^{2}+\beta_{2}^{2}+\beta_{1} \beta_{2}+\beta_{2} \beta_{1}\right) \\
& -\left(\beta_{0}^{2}+\beta_{1}^{2}+\beta_{2}^{2}+\beta_{1} \beta_{2}+\beta_{2} \beta_{1}\right)\left(\alpha_{0}^{2}+\alpha_{1}^{2}+\alpha_{2}^{2}+\alpha_{1} \alpha_{2}+\alpha_{2} \alpha_{1}\right) \bmod H \\
= & \alpha_{1}^{2} \beta_{1}^{2}-\beta_{1}^{2} \alpha_{1}^{2}+(\operatorname{deg} \geq 5 \text { terms }) \bmod H \\
= & \alpha_{1}^{2} \beta_{1}^{2}-\beta_{1}^{2} \alpha_{1}^{2} \bmod H
\end{aligned}
$$

Thus to finish the proof, it suffices to show that $\alpha_{1}^{2} \beta_{1}^{2}-\beta_{1}^{2} \alpha_{1}^{2} \in A_{4}^{0}$. Since $\alpha_{1}, \beta_{1} \in A_{1}$, there exists integers $m_{i}, n_{i}$ for $i=1,2$ such that

$$
\begin{aligned}
\alpha_{1} & =m_{1} X+n_{1} Y \\
\beta_{1} & =m_{2} X+n_{2} Y
\end{aligned}
$$

It is now elementary to check that in the expression of $\alpha_{1}^{2} \beta_{1}^{2}-\beta_{1}^{2} \alpha_{1}^{2}$, which is a linear combination of words of length 4 in $X$ and $Y$, the coefficients of the words $X Y X Y$ and $Y X Y X$ are zero. By definition of $A_{4}^{0}$, this shows that $\alpha_{1}^{2} \beta_{1}^{2}-\beta_{1}^{2} \alpha_{1}^{2} \in A_{4}^{0}$.
4.5. Hesselholt's construction of the map $[A, A]^{\mathbb{N}_{0}} \longrightarrow A^{\mathbb{N}_{0}}$ : In this subsection we quickly recall the construction of a map from $[A, A]^{\mathbb{N}_{0}} \longrightarrow A^{\mathbb{N}_{0}}$ by Hesselholt (see [2, Page 114]). Everything recalled here is taken directly from [2] and nothing is new, except that instead of the non-unital polynomial
ring $\widetilde{\mathbb{Z}}\{X, Y\}$ we deal with the unital polynomial ring $\mathbb{Z}\{X, Y\}$. Let $A=\mathbb{Z}\{X, Y\}$. Fix a prime $p$. An element $x \in A$ can be uniquely written as

$$
x=\sum_{w} n_{w} w \quad, \quad n_{w} \in \mathbb{Z} \text { with almost all zero }
$$

where the summation is over words $w$ in $X, Y$ (including the empty word). Define two words to be equivalent, if one can be obtained by a cyclic permutation of the other. An equivalence class of words will be called a circular word. One can show that $A /[A, A]$ is a free abelian group generated by circular words. Define a additive section of the quotient map $A \rightarrow A /[A, A]$

$$
\sigma_{0}: \frac{A}{[A, A]} \longrightarrow A
$$

which takes a circular word to the unique word in its equivalence class which is least for the lexicographic order. Define an additive group homomorphism $A \xrightarrow{\phi} A$ by

$$
\phi\left(\sum_{w} n_{w} w\right):=\sum_{w} n_{w} w^{p}
$$

As observed in [2], $\phi$ satisfies the following.
Lemma 4.6. $\phi([A, A]) \subset[A, A]$ and for all $x \in A, x^{p^{n}}=\phi\left(x^{p^{n-1}}\right) \bmod \left(p^{n} A+[A, A]\right)$.
We now define a map

$$
\begin{gathered}
\mathcal{R}:[A, A]^{\mathbb{N}_{0}} \longrightarrow A^{\mathbb{N}_{0}} \\
\mathcal{R}\left(\epsilon_{0}, \epsilon_{1}, \ldots\right):=\left(r_{0}, r_{1}, \ldots\right)
\end{gathered}
$$

where $r_{0}=\epsilon_{0}$ and for $n \geq 1, r_{n}$ 's are recursively defined as:

$$
r_{n}=\epsilon_{n}-\sigma_{0}\left(p^{-n}\left(\omega_{n}\left(r_{0}, r_{1}, \ldots, r_{n-1}, 0\right)-\phi\left(\omega_{n-1}\left(r_{0}, \ldots, r_{n-1}\right)\right)\right)\right)
$$

In the above formula, we note that by $\left(\omega_{n}\left(r_{0}, r_{1}, \ldots, r_{n-1}, 0\right)-\phi\left(\omega_{n-1}\left(r_{0}, \ldots, r_{n-1}\right)\right)\right)$ we actually mean its image in $A /[A, A]$, which is divisible by $p^{n}$ by Lemma 4.6. Moreover, since $A /[A, A]$ has no $p$-torsion, $p^{-n}\left(\omega_{n}\left(r_{0}, r_{1}, \ldots, r_{n-1}, 0\right)-\phi\left(\omega_{n-1}\left(r_{0}, \ldots, r_{n-1}\right)\right)\right)$ is a well defined element of $A /[A, A]$.

Finally we recall the part of [2, Lemma 1.3.7] which remains true.
Lemma 4.7. For any $\underline{\epsilon} \in[A, A]^{\mathbb{N}_{0}}, \mathcal{R}(\underline{\epsilon})$ maps to zero via the ghost map

$$
A^{\mathbb{N}_{0}} \xrightarrow{\omega}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

Proof of Theorem 4.3. As the map $H H_{0}(E(A)) \longrightarrow H H_{0}(X(A))$ is surjective, it is enough to show that the map

$$
H H_{0}(X(A)) \xrightarrow{\bar{\gamma}}\left(\frac{A}{[A, A]}\right)^{\mathbb{N}_{0}}
$$

is not injective. Consider the following diagram


In order to prove the theorem it suffices to find an element $r=\left(r_{0}, r_{1}, \ldots\right) \in A^{\mathbb{N}_{0}}$ such that $\Omega(r) \notin$ $\overline{[X(A), X(A)]}$ and $\omega(r)=0$. Let

$$
r:=\left(r_{0}, r_{1}, r_{2}, \ldots\right):=\mathcal{R}(X Y-Y X, 0,0, \ldots) \in A^{\mathbb{N}_{0}}
$$

By Lemma 4.7, $\omega(r)=0$. It remains to show that $\Omega(r) \notin \overline{[X(A), X(A)]}$. By Lemma 4.4, it suffices to show that the 1 -th component of $\Omega(r)$ (i.e. $\left.\omega_{1}(r)\right)$ is not in $A_{4}^{0}+F^{5} A+2 A$.

$$
\begin{aligned}
\omega_{1}(r) & =r_{0}^{2}+2 r_{1} \\
& =(\mathrm{XY}-\mathrm{YX})^{2}+2(-\mathrm{XYXY}+\mathrm{XXYY}) \\
& =-\mathrm{XYXY}+\mathrm{YXYX}-\mathrm{XYYX}-\mathrm{YXXY}+2 \mathrm{XXYY} \\
& =-\mathrm{XYXY}+\mathrm{YXYX} \bmod A_{4}^{0}+F^{5} A+2 A
\end{aligned}
$$

As a direct consequence of the definition of $A_{4}^{0}$ and $F^{5} A$, one thus sees that $\omega_{1}(r) \notin A_{4}^{0}+F^{5} A+2 A$. This finishes the proof.

Proof of Theorem 1.3. Suppose there exists a continuous group homomorphism $W(A) \rightarrow H H_{0}(E(A))$. Composing with the natural homomorphism $H H_{0}(E(A)) \rightarrow H H_{0}(X(A))$ we get a map

$$
\Phi: W(A) \rightarrow H H_{0}(X(A))
$$

Let us denote the quotient map $X(A) \rightarrow H H_{0}(X(A))$ by $\pi$. By lemma 4.2, the following diagram must commute:


Using surjectivity of $q$ and the fact that both $\Omega$ and $\bar{\omega} \circ q$ are given by the same Witt polynomials, one checks that the above commutative square can be extended to the following commutative diagram.


However, such a commutative diagram is not possible as there exists an element $r \in A^{\mathbb{N}_{0}}$ (see proof of Theorem 4.3) such that $\bar{\gamma} \circ \pi \circ \Omega(r) \neq 0$ but $\bar{\omega} \circ q(r)=0$.
