# QUASI PROJECTIVE DIMENSION FOR COMPLEXES 

TIRDAD SHARIF


#### Abstract

In this note, we extend the quasi-projective dimension of finite (that is, finitely generated) modules to homologically finite complexes, and we investigate some of homological properties of this dimension.


## 1. Introduction

Throughout, all rings are commutative and Noetherian. In [1] Avramov, and in [5] Avramov, Gasharov and Peeva defined and studied the complexity, the complete intersection dimension, and the quasi projective dimension of finite modules.

Let $\mathcal{D}_{b}^{f}(R)$ be the category of homologically finite $R$-complexes, and $X \in \mathcal{D}_{b}^{f}(R)$. The complexity and the complete intersection dimension of $X$, denoted by $\mathrm{cx}_{R} X$ and CI- $\operatorname{dim}_{R} X$, respectively, were defined and studied by Sather-Wagstaff [14]. In this work, we introduce the quasi-projective dimension, as a refinement of the projective dimension, for homologically finite complexes and verify some of it's homological properties analogous to those holding for modules.

Let $Y, Z \in \mathcal{D}_{b}^{f}(R)$. In our main result, Theorem 3.5 as an application of the Intersection Theorem for the quasi-projective dimension, Proposition 3.2(b), and the depth formula for the complete intersection dimension, Proposition 3.4 a lower bound and an upper bound for $-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z,\left(X \otimes_{R}^{\mathbf{L}} Y\right)\right)$ with respect to CI- $-\operatorname{dim}_{R} X, \operatorname{cx}_{R}(X)$ and $-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)$ is determined, when $\sup \left(X \otimes_{R}^{\mathbf{L}} Y\right)<$ $\infty$ and CI- $\operatorname{dim}_{R} X<\infty$. This result is as an extension of a grade inequality in [16, (3.3)] to complexes; see Example 3.8 about this inequality.

## 2. Homology theory of complexes

In this paper, definitions and results are formulated within the framework of the derived category of complexes. The reader is referred to [3, 6, 9, 10, for details of the following brief summary. Let $X$ be a complex of $R$-modules and $R$-homomorphisms. For an integer $n$, the $n$-th shift or suspension of $X$ is the complex $\Sigma^{n} X$ with $\left(\Sigma^{n} X\right)_{\ell}=X_{\ell-n}$ and $\partial_{\ell}^{\Sigma^{n} X}=(-1)^{n} \partial_{\ell-n}^{X}$ for each $\ell$. The $n$-th cokernel of $X$ is $C_{n}^{X}=$ cokernel $\partial_{n+1}^{X}$. The supremum and the infimum of a complex $X$, denoted by $\sup (X)$ and $\inf (X)$, respectively, are defined by the supremum and the infimum of $\left\{i \mid \mathrm{H}_{i}(X) \neq 0\right\}$ and let $\operatorname{amp}(X)=\sup (X)-\inf (X)$. The symbol $\mathcal{D}(R)$ denotes the derived category of $R$-complexes. The full subcategories $\mathcal{D}_{-}(R), \mathcal{D}_{+}(R), \mathcal{D}_{b}(R)$ and $\mathcal{D}_{0}(R)$ of $\mathcal{D}(R)$ consist of $R$-complexes $X$ while $\mathrm{H}_{\ell}(X)=0$, for respectively $\ell \gg 0$, $\ell \ll 0,|\ell| \gg 0$ and $\ell \neq 0$. By $\mathcal{D}^{f}$ we denote the full subcategory of complexes with all homology modules are finite, called homologically degreewise finite complexes.

[^0]A complex $X$ is called homologically finite, if it is homologically both bounded and degreewise finite. The right derived functor of the homomorphism functor of $R$ complexes and the left derived functor of the tensor product of $R$-complexes are denoted by $\mathbf{R} \operatorname{Hom}_{R}(-,-)$ and $-\otimes_{R}^{\mathbf{L}}-$, respectively. A homology isomorphism is a morphism $\alpha: X \rightarrow Y$ such that $\mathrm{H}(\alpha)$ is an isomorphism; homology isomorphisms are marked by the sign $\simeq$, while $\cong$ is used for isomorphisms. The equivalence relation generated by the homology isomorphisms is also denoted by $\simeq$.
2.1. Let $X$ and $Y$ be in $\mathcal{D}_{+}(R)$, then there is an inequality

$$
\inf \left(X \otimes_{R}^{\mathbf{L}} Y\right) \geqslant \inf X+\inf Y
$$

Equality holds if $i=\inf X$ and $j=\inf Y$ are finite and $\mathrm{H}_{i}(X) \otimes_{R} \mathrm{H}_{j}(Y) \neq 0$.
2.2. The support of a complex $X, \operatorname{Supp}(X)$, consists of all $\mathfrak{p} \in \operatorname{Spec}(R)$ such that the $R_{\mathfrak{p}}$-complex $X_{\mathfrak{p}}$ is not homologically trivial.
2.3. Let $R$ be a ring. If $(R, \mathfrak{m}, k)$ is local, depth of a complex $X \in \mathcal{D}_{-}(R)$ is defined as the following

$$
\operatorname{depth}_{R} X=-\sup \mathbf{R} \operatorname{Hom}_{R}(k, X)
$$

(a) Let $X \in \mathcal{D}_{b}^{f}(R)$, then the following inequality holds

$$
\operatorname{depth}_{R} X \leqslant \operatorname{depth}_{R_{\mathfrak{p}}} X_{\mathfrak{p}}+\operatorname{dim} R / \mathfrak{p}
$$

The dimension of a complex $X \in \mathcal{D}_{+}(R)$ is defined by the following formula

$$
\operatorname{dim}_{R} X=\sup \left\{\operatorname{dim} R / \mathfrak{p}-\inf X_{\mathfrak{p}} \mid \mathfrak{p} \in \operatorname{Supp}_{R} X\right\}
$$

(b) Let $X \in \mathcal{D}_{+}^{f}(R)$, then the following inequality holds

$$
\operatorname{dim}_{R_{\mathfrak{p}}} X_{\mathfrak{p}}+\operatorname{dim} R / \mathfrak{p} \leqslant \operatorname{dim}_{R} X
$$

(c) Let $Y \in \mathcal{D}_{+}^{f}(R)$ and $X \in \mathcal{D}_{-}(R)$, then the next equality holds

$$
-\sup \mathbf{R} \operatorname{Hom}_{R}(Y, X)=\inf \left\{\operatorname{depth}_{R_{\mathfrak{p}}} X_{\mathfrak{p}}+\inf Y_{\mathfrak{p}} \mid \mathfrak{p} \in \operatorname{Supp} X \cap \operatorname{Supp} Y\right\} .
$$

2.4. For a ring $R$, let $(-)^{*}=\operatorname{Hom}_{R}(-, R)$. A finite $R$-module $M$ is totally reflexive over $R$ if $M$ is reflexive and $\operatorname{Ext}_{R}^{i}(M, R)=0=\operatorname{Ext}_{R}^{i}\left(M^{*}, R\right)$ for all $i>0$. Let $X \in \mathcal{D}_{b}^{f}(R)$. A $G$-resolution of $X$ is a complex $\mathcal{G} \simeq X$, such that each $\mathcal{G}_{i}$ is totally reflexive over $R$. The Gorenstein dimension of $X$ is

$$
\text { G-dim }{ }_{R}(X)=\inf \left\{\sup \left\{i \mid G_{i} \neq 0\right\} \mid \mathrm{G} \text { is a G-resolution of } \mathrm{X}\right\} .
$$

## 3. Quasi-projective dimension for complexes.

In this section, all rings are local. We introduce the quasi-projective dimension, as a refinement of the projective dimension for homologically finite complexes.
At first, we bring some notions and definitions.
3.1. Let $R$ be a ring, a codimension c , quasi-deformation of $R$ is a diagram of local homomorphisms $R \rightarrow R^{\prime} \leftarrow Q$ such that the first map is flat and the second map is surjective with kernel generated by a $Q$-sequence of length c. The complete intersection dimension and the complexity of a complex $X \in \mathcal{D}_{b}^{f}(R)$ are defined analogous to those of modules as the following

$$
\text { CI- } \operatorname{dim}_{R} X=\inf \left\{\operatorname{pd}_{Q} X^{\prime}-\operatorname{pd}_{Q} R^{\prime} \mid R \rightarrow R^{\prime} \leftarrow Q \text { is a quasi-deformation }\right\}
$$

where $X^{\prime}=X \otimes_{R} R^{\prime}$, and

$$
\operatorname{cx}_{R}(X)=\inf \left\{d \in \mathbb{N}_{0} \mid \beta_{n}(X) \leqslant \gamma n^{d-1} \text { for some } \gamma \in \mathbb{R}\right\}
$$

in which, $\beta_{n}(X)=\operatorname{dim}_{k} \mathrm{H}_{n}\left(X \otimes_{R}^{\mathrm{L}} k\right)$ is the n-th Betti number of $X$.
Now we define the quasi-projective dimension of $X \in \mathcal{D}_{b}^{f}(R)$ similar to that of modules as the following

$$
\operatorname{qpd}_{R} X=\inf \left\{\operatorname{pd}_{Q} X^{\prime} \mid R \rightarrow R^{\prime} \leftarrow Q \text { is a quasi-deformation }\right\} .
$$

In the first part of the following proposition, we extend [5, (5.11)] to complexes. In the second part, we show that in the Intersection Theorem, [9, (18.5)], we can replace the projective dimension with that of the quasi-projective dimension. Note that by (16.22)] it is an extension of [16 (3.1)] to complexes.

Proposition 3.2. Let $X \in \mathcal{D}_{b}^{f}(R)$ with $\mathrm{CI}-\operatorname{dim}_{R} X<\infty$ and $Y \in \mathcal{D}_{+}^{f}(R)$. Then
(a) $\operatorname{qpd}_{R} X=C I-\operatorname{dim}_{R} X+\operatorname{cx}_{R}(X)$.
(b) $\operatorname{dim}_{R} Y \leqslant \operatorname{dim}_{R}\left(X \otimes_{R}^{\mathrm{L}} Y\right)+\operatorname{qpd}_{R} X$.

Proof. (a) From [14, (3.10)] it follows that $\mathrm{cx}_{R}(X)<\infty$. Thus CI- $\operatorname{dim}_{R} X+\mathrm{cx}_{R}(X)$ and $\operatorname{qpd}_{R} X$ are finite. Let $P$ be a projective resolution of $X$. We only need to show that $\operatorname{qpd}_{R} P=$ CI- $\operatorname{dim}_{R} P+\operatorname{cx}_{R}(P)$. Take $n \geqslant \sup X$, and let $C_{n}^{P}$ be the $n$-th cokernel of $P$. By [14, (2.12)] and [14, (3.7)] we get $\operatorname{cx}_{R}(X)=\operatorname{cx}_{R}\left(C_{n}^{P}\right)$ and CI- $\operatorname{dim}_{R} C_{n}^{P}<\infty$, respectively. Hence by [5, (5.10)] we can choose a quasideformation $R \rightarrow R^{\prime} \leftarrow Q$ of codimension equal to $\operatorname{cx}_{R}(X)$ such that $\mathrm{pd}_{Q} C_{n}^{P^{\prime}}<\infty$, where $P^{\prime}=P \otimes_{R} R^{\prime}$. Let $P_{\leqslant n-1}$ and $P_{\geqslant n}$ be the hard left and the hard right truncations of $P$, respectively. The following sequence of complexes is exact

$$
\begin{equation*}
0 \longrightarrow P_{\leqslant n-1} \longrightarrow P \longrightarrow P_{\geqslant n} \longrightarrow 0 . \tag{3.2.1}
\end{equation*}
$$

Since $R^{\prime}$ is faithful flat as an $R$-module, the following sequence of $R^{\prime}$-complexes is also exact

$$
0 \longrightarrow P_{\leqslant n-1}^{\prime} \longrightarrow P^{\prime} \longrightarrow P_{\geqslant n}^{\prime} \longrightarrow 0 .
$$

It is clear that $\operatorname{pd}_{R^{\prime}} P_{\leqslant n-1}^{\prime}<\infty$. Since $\operatorname{pd}_{Q} R^{\prime}<\infty$, thus $\operatorname{pd}_{Q} P_{\leqslant n-1}^{\prime}<\infty$. On the other hand, $P_{\geqslant n}^{\prime} \simeq \Sigma^{n} C_{n}^{P^{\prime}}$ and $\operatorname{pd}_{Q} C_{n}^{P^{\prime}}<\infty$, thus we have $\operatorname{pd}_{Q} P_{\geqslant n}^{\prime}<\infty$. Now from the above exact sequence we find that $\operatorname{pd}_{Q} P^{\prime}<\infty$, and this implies that $\operatorname{qpd}_{R} P \leqslant \operatorname{pd}_{Q} P^{\prime}$. From [14, (3.3)] we have the following (in)equalities

$$
\begin{aligned}
\operatorname{qpd}_{R} P-\mathrm{CI}-\operatorname{dim}_{R} P & \leqslant \operatorname{pd}_{Q} P^{\prime}-\mathrm{G}-\operatorname{dim}_{R} P \\
& =\mathrm{G}_{\mathrm{dim}}^{Q}{ }^{\prime}-\mathrm{G}-\operatorname{dim}_{R} P \\
& =\mathrm{G}^{\prime} \operatorname{dim}_{R^{\prime}} P^{\prime}+\operatorname{cx}_{R}(P)-\mathrm{G}-\operatorname{dim}_{R} P \\
& =\operatorname{cx}_{R}(P),
\end{aligned}
$$

where the equalities hold by [6] (2.3.10)], [6, (2.3.12)], and [7, (5.11)], respectively. On the other hand, there is a quasi-deformation of codimension $c, R \rightarrow R^{\prime \prime} \leftarrow Q^{\prime}$ such that $\operatorname{qpd}_{R} P=\operatorname{pd}_{Q^{\prime}} P^{\prime \prime}$, where $P^{\prime \prime}=P \otimes_{R} R^{\prime \prime}$. Therefore from (3.2.1) we get $\operatorname{pd}_{Q^{\prime}} C_{n}^{P^{\prime \prime}}<\infty$, and from [5, (5.9)] it follows that $\operatorname{cx}_{R} P=\operatorname{cx}_{R}\left(C_{n}^{P}\right) \leqslant c$. We have the following equalities

$$
\left.\begin{array}{rl}
\operatorname{qpd}_{R} P-\mathrm{CI}-\operatorname{dim}_{R} P & =\operatorname{pd}_{Q^{\prime}} P^{\prime \prime}-\mathrm{G}-\operatorname{dim}_{R} P \\
& =\mathrm{G}^{-\operatorname{dim}_{Q^{\prime}} P^{\prime \prime}-\mathrm{G}-\operatorname{dim}_{R} P} \\
& =\mathrm{G}-\operatorname{dim}_{R^{\prime \prime}} P^{\prime \prime}+c-\mathrm{G}-\operatorname{dim} \\
R
\end{array} P=\operatorname{cx}_{R} P\left(C_{n}^{P}\right)=\operatorname{cx}_{R} P\right)
$$

in which, we have used [6, (2.3.10)], [6, (2.3.12)], and [7, (5.11)] again. Now assertion holds.
(b) Let $\rho: A \rightarrow B$ be a surjective homomorphism of rings and let $X, Z \in \mathcal{D}_{b}^{f}(B)$. Then it is easy to see that, $\operatorname{dim}_{A}\left(X \otimes_{A}^{\mathbf{L}} Z\right)=\operatorname{dim}_{B}\left(X \otimes_{B}^{\mathbf{L}} Z\right)$. Now let $\operatorname{qpd}_{R} X=$ $\operatorname{pd}_{Q} X^{\prime}$, when $R \rightarrow R^{\prime} \leftarrow Q$ is a quasi deformation. From [9, (18.5)] we get

$$
\begin{equation*}
\operatorname{dim}_{Q} Z^{\prime} \leqslant \operatorname{dim}_{Q}\left(X^{\prime} \otimes_{Q}^{\mathbf{L}} Z^{\prime}\right)+\operatorname{pd}_{Q} X^{\prime} \tag{3.2.2}
\end{equation*}
$$

We have $\operatorname{dim}_{Q} Z^{\prime}=\operatorname{dim}_{R^{\prime}} Z^{\prime}$ and $\operatorname{dim}_{Q}\left(X^{\prime} \otimes_{Q}^{\mathbf{L}} Z^{\prime}\right)=\operatorname{dim}_{R^{\prime}}\left(X^{\prime} \otimes_{R^{\prime}}^{\mathbf{L}} Z^{\prime}\right)$, because $Q \rightarrow R^{\prime}$ is surjective. By the associativity of the derived tensor product we get $X^{\prime} \otimes_{R^{\prime}}^{\mathbf{L}} Z^{\prime}=\left(X \otimes_{R}^{\mathbf{L}} Z\right)^{\prime}$. Since $R^{\prime}$ is a flat $R$-algebra, from [4, (2.1)] we have the following equalities

$$
\operatorname{dim}_{R^{\prime}} Z^{\prime}=\operatorname{dim}_{R} Z+\operatorname{dim}_{R} R^{\prime} / \mathfrak{m} R^{\prime}
$$

and

$$
\operatorname{dim}_{R^{\prime}}\left(X \otimes_{R}^{\mathbf{L}} Z\right)^{\prime}=\operatorname{dim}_{R}\left(X \otimes_{R}^{\mathbf{L}} Z\right)+\operatorname{dim}_{R} R^{\prime} / \mathfrak{m} R^{\prime}
$$

By combining (3.2.2) with the above equalities, we get the following inequality

$$
\operatorname{dim} Z \leqslant \operatorname{qpd}_{R} X+\operatorname{dim}_{R}\left(X \otimes_{R}^{\mathbf{L}} Z\right)
$$

Now let $Y \in \mathcal{D}_{+}^{f}(R)$. Since $\mathrm{H}_{m}(Y)$ is a finite $R$-module, from the above inequality it follows that

$$
\begin{equation*}
\operatorname{dim}_{R} \mathrm{H}_{m}(Y) \leqslant \operatorname{qpd}_{R} X+\operatorname{dim}_{R}\left(X \otimes_{R}^{\mathbf{L}} \mathrm{H}_{m}(Y)\right) \tag{3.2.3}
\end{equation*}
$$

Let $P$ be a projective resolution of $X$. Thus $P \simeq X$ and $P_{i}=0$, for $i \ll 0$. By applying [9, (16.24.b)] we get

$$
\operatorname{dim}_{R}\left(P \otimes_{R} Y\right)=\sup \left\{\operatorname{dim}_{R}\left(P \otimes_{R} \mathrm{H}_{m}(Y)\right)-m \mid m \in \mathbb{Z}\right\}
$$

Therefore

$$
\operatorname{dim}_{R}\left(X \otimes_{R}^{\mathbf{L}} Y\right)=\sup \left\{\operatorname{dim}_{R}\left(X \otimes_{R}^{\mathbf{L}} \mathrm{H}_{m}(Y)\right)-m \mid m \in \mathbb{Z}\right\} .
$$

Now from (3.2.3) assertion holds.
Remark 3.3. Let $\mathcal{F}(R)$ be the category of $R$-modules of finite flat dimension. The large restricted flat dimension of $X \in \mathcal{D}_{+}(R), \operatorname{Rfd}_{R} X$, was introduced and studied by Christensen, Foxby and Frankild in [8], and is defined as the following

$$
\operatorname{Rfd}_{R} X=\sup \left\{\sup \left(T \otimes_{R}^{\mathbf{L}} X\right) \mid T \in \mathcal{F}(R)\right\}
$$

It is shown that $\operatorname{Rfd}$ is a refinement of the flat dimension, [8, (2.5)]. By [15, (3.6)], it is easy to see that $\operatorname{Rfd}_{R} X$ is also a refinement of CI- $\operatorname{dim}_{R} X$, for $X \in \mathcal{D}_{b}^{f}(R)$. Using these facts, we can prove the first part of the above proposition, without any using of the Gorenstein dimension. However, by [9, $(12,13)]$, [11, $(2.6)$, and [14, (3.3)], we can also prove it, without any using of the above dimensions, see the proof of [5, (5.11)].

The next proposition is the depth formula for the complete intersection dimension of complexes, immediately follows from [13, (3.3)] and [14, (3.3)].

Proposition 3.4. Let CI- $\operatorname{dim}_{R} X<\infty$ and $Y \in \mathcal{D}_{b}^{f}(R)$, if $\lambda=\sup \left(X \otimes_{R}^{\mathrm{L}} Y\right)<\infty$, then

$$
\operatorname{depth}_{R}\left(X \otimes_{R}^{\mathbf{L}} Y\right)=\operatorname{depth}_{R} Y-\text { CI-dim }{ }_{R} X
$$

Now we are in the position of proving our main result.
Theorem 3.5. Let $X, Y, Z \in \mathcal{D}_{b}^{f}(R)$, if CI- $-\operatorname{dim}_{R} X<\infty$ and $\sup \left(X \otimes_{R}^{\mathbf{L}} Y\right)<\infty$, then
(a) $-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)-\mathrm{CI}-\operatorname{dim}_{R} X \leqslant-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z,\left(X \otimes_{R}^{\mathbf{L}} Y\right)\right)$.
(b) $-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z,\left(X \otimes_{R}^{\mathbf{L}} Y\right)\right) \leqslant \operatorname{amp} Y+\operatorname{cx}_{R}(X)-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)-$ $\inf X$.

Proof. (a) From 2.3(c) it follows that there is $\mathfrak{p} \in \operatorname{Supp}_{R} X \cap \operatorname{Supp}_{R} Y \cap \operatorname{Supp}_{R} Z$ such that

$$
-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z,\left(X \otimes_{R}^{\mathbf{L}} Y\right)\right)=\operatorname{depth}_{R_{\mathfrak{p}}}\left(X_{\mathfrak{p}} \otimes_{R_{\mathfrak{p}}}^{\mathbf{L}} Y_{\mathfrak{p}}\right)+\inf Z_{\mathfrak{p}}
$$

Thus we have

$$
\begin{aligned}
-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z,\left(X \otimes_{R}^{\mathbf{L}} Y\right)\right) & =\operatorname{depth}_{R_{\mathfrak{p}}} Y_{\mathfrak{p}}-\text { CI- }-\operatorname{dim}_{R_{\mathfrak{p}}} X_{\mathfrak{p}}+\inf Z_{\mathfrak{p}} \\
& \geqslant \operatorname{depth}_{R_{\mathfrak{p}}} Y_{\mathfrak{p}}-\text { CI- }-\operatorname{dim}_{R} X+\inf Z_{\mathfrak{p}} \\
& \geqslant-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)-\text { CI-dim } R X
\end{aligned}
$$

in which, the equality holds by Proposition 3.4 and the inequalities hold by 14 , (3.4)] and 2.3(c), respectively
(b) By 2.3(c) for some $\mathfrak{p} \in \operatorname{Supp}_{R} Z \cap \operatorname{Supp} Y$, we get $-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)=$ $\operatorname{depth}_{R_{\mathfrak{p}}} Y_{\mathfrak{p}}+\inf Z_{\mathfrak{p}}$. Now let $W=\left(R / \mathfrak{p} \otimes_{R}^{\mathbf{L}} X \otimes_{R}^{\mathbf{L}} Y\right)$. Since $X \otimes_{R}^{\mathbf{L}} Y \in \mathcal{D}_{b}^{f}(R)$, thus we can choose a prime ideal $\mathfrak{q}$ of $R$ which is minimal in Supp $W$. Therefore $\mathfrak{p} \subseteq \mathfrak{q}$ and $\mathfrak{q} \in \operatorname{Supp} X \cap \operatorname{Supp} Y$. On the one hand, since $\mathfrak{p} \in \operatorname{Supp} Z$, thus $\mathfrak{q} \in \operatorname{Supp} Z$. Let $V=\left(R / \mathfrak{p} \otimes_{R}^{\mathbf{L}} Y\right)$. Since $V_{\mathfrak{q}} \in \mathcal{D}_{+}^{f}\left(R_{\mathfrak{q}}\right)$ and $X_{\mathfrak{q}} \in \mathcal{D}_{b}^{f}\left(R_{\mathfrak{q}}\right)$, from Proposition 3.2(b) it follows that

$$
\operatorname{dim}_{R_{\mathfrak{q}}} V_{\mathfrak{q}} \leqslant \operatorname{qpd}_{R_{\mathfrak{q}}} X_{\mathfrak{q}}+\operatorname{dim}_{R_{\mathfrak{q}}} W_{\mathfrak{q}} .
$$

Using 2.1 and the definition of dimension of complexes, it is straightforward to verify that $\operatorname{dim}_{R_{\mathfrak{p}}} V_{\mathfrak{p}}=-\inf Y_{\mathfrak{p}}$ and $\operatorname{dim}_{R_{\mathfrak{q}}} W_{\mathfrak{q}}=-\inf X_{\mathfrak{q}}-\inf Y_{\mathfrak{q}}$.

By 2.3(a) and 2.3(b), we have the following inequalities, respectively.

$$
\operatorname{dim} R_{\mathfrak{q}} / \mathfrak{p} R_{\mathfrak{q}} \geqslant \operatorname{depth}_{R_{\mathfrak{q}}} Y_{\mathfrak{q}}-\operatorname{depth}_{R_{\mathfrak{p}}} Y_{\mathfrak{p}}
$$

and

$$
\operatorname{dim}_{R_{\mathfrak{q}}} V_{\mathfrak{q}} \geqslant \operatorname{dim}_{R_{\mathfrak{p}}} V_{\mathfrak{p}}+\operatorname{dim} R_{\mathfrak{q}} / \mathfrak{p} R_{\mathfrak{q}} .
$$

Therefore the following inequality holds

$$
-\inf Y_{\mathfrak{p}}+\operatorname{depth}_{R_{\mathfrak{q}}} Y_{\mathfrak{q}}-\operatorname{depth}_{R_{\mathfrak{p}}} Y_{\mathfrak{p}} \leqslant \operatorname{qpd}_{R_{\mathfrak{q}}} X_{\mathfrak{q}}-\inf X_{\mathfrak{q}}-\inf Y_{\mathfrak{q}}
$$

Proposition 3.4 yields an equality

$$
\operatorname{depth}_{R_{\mathfrak{q}}} Y_{\mathfrak{q}}=\operatorname{depth}_{R_{\mathfrak{q}}}\left(X_{\mathfrak{q}} \otimes_{R_{\mathfrak{q}}}^{\mathbf{L}} Y_{\mathfrak{q}}\right)+\text { CI- } \operatorname{dim}_{R_{\mathfrak{q}}} X_{\mathfrak{q}}
$$

Now from Proposition 3.2 (a) we get the following inequality
$\operatorname{depth}_{R_{\mathfrak{q}}}\left(X_{\mathfrak{q}} \otimes_{R_{\mathfrak{q}}}^{\mathbf{L}} Y_{\mathfrak{q}}\right)+\inf X_{\mathfrak{q}}+\inf Y_{\mathfrak{q}}-\inf Y_{\mathfrak{p}}+\inf Z_{\mathfrak{p}} \leqslant \operatorname{cx}_{R_{\mathfrak{q}}}\left(X_{\mathfrak{q}}\right)+\operatorname{depth} R_{\mathfrak{p}} Y_{\mathfrak{p}}+\inf Z_{\mathfrak{p}}$.
It is easy to see that $\mathrm{cx}_{R_{\mathfrak{q}}}\left(X_{\mathfrak{q}}\right) \leqslant \mathrm{cx}_{R}(X)$, and $\inf Z_{\mathfrak{q}} \leqslant \inf Z_{\mathfrak{p}}$. Thus from 2.3(c) we have
$-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z, X \otimes_{R}^{\mathbf{L}} Y\right)+\inf X_{\mathfrak{q}}+\inf Y_{\mathfrak{q}}-\inf Y_{\mathfrak{p}} \leqslant \operatorname{cx}_{R}(X)-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)$.
Therefore

$$
-\sup \mathbf{R} \operatorname{Hom}_{R}\left(Z, X \otimes_{R}^{\mathbf{L}} Y\right) \leqslant \operatorname{amp} Y+\operatorname{cx}_{R}(X)-\sup \mathbf{R} \operatorname{Hom}_{R}(Z, Y)-\inf X .
$$

Now assertion holds.
Let $M$ and $N$ be $R$-modules. Then

$$
\operatorname{grade}_{R}(M, N)=\inf \left\{i \mid \operatorname{Ext}_{R}^{i}(M, N) \neq 0\right\}
$$

If $\operatorname{Ext}{ }_{R}^{i}(M, N)=0$, for all $i$, then $\operatorname{grade}_{R}(M, N)=\infty$. We say that $M$ and $N$ are Tor-independent, if $\operatorname{Tor}_{i}^{R}(M, N)=0$, for $i>0$.
The following grade inequality, see [16, (3.3)], is an immediate corollary of the above theorem.

Corollary 3.6. Let $M, N$ and $L$ be finite $R$-modules with CI- $\operatorname{dim}_{R} N<\infty$ such that $M$ and $N$ are Tor-independent $R$-modules. Then

$$
\left.\operatorname{grade}(L, M)-\operatorname{CI}-\operatorname{dim}_{R} N \leqslant \operatorname{grade}\left(L, M \otimes_{R} N\right) \leqslant \operatorname{grade}(L, M)+\operatorname{cx}_{R}(N)\right)
$$

In Example 3.8, it is shown that $\operatorname{grade}\left(L, M \otimes_{R} N\right)$ may be arbitrary greater than $\operatorname{grade}(L, M)-$ CI- $\operatorname{dim}_{R} N$. This example also shows that in the above inequality, the term $\operatorname{cx}_{R}(N)$ is strongly necessary.
3.7. Let $k$ be a field and let $R_{t}$ for $t=1,2$ be $k$-algebras, and suppose that $M_{t}$ is an $R_{t}$-module. Let $R=R_{1} \otimes_{k} R_{2}, N=M_{1} \otimes_{k} R_{2}$, and $M=M_{2} \otimes_{k} R_{1}$. It is easy to see that $\operatorname{Tor}_{i}^{R}(M, N)=0$, for $i>0$, see [12, (4.2)], and $N \simeq M_{1} \otimes_{R_{1}} R$, $M \simeq M_{2} \otimes_{R_{2}} R$.

Example 3.8. We use the above notations. Take an arbitrary integer $n \geqslant 1$. Let $Q_{1}=k\left[\left[X_{j}, Y_{j}\right]\right], B_{1}=\left(X_{j} Y_{j}\right)$, for $1 \leqslant j \leqslant n$ and $Q_{2}=k\left[\left[X_{j}, Y_{j}\right]\right], B_{2}=$ $\left(X_{j} Y_{j}\right)$, for $n<j \leqslant 2 n$. It is clear that the local rings $R_{t}=Q_{t} / B_{t}$, for $t=1,2$, are non-regular complete intersections of codimension $n$. Let $M_{1}=R_{1} /\left(Y_{i}\right) R_{1}$ and $M_{2}=R_{2} /\left(Y_{j}\right) R_{2}$, for $1 \leqslant i \leqslant n$ and $n<j \leqslant 2 n$, respectively. We have $\operatorname{depth} R_{t}=\operatorname{depth}_{R_{t}} M_{t}=n$, for $t=1,2$, and the Auslander-Buchsbaum formula for the complete intersection dimension yields CI- $\operatorname{dim}_{R_{t}} M_{t}=0$, for $t=1,2$.
Let $L_{1}=R_{1} /\left(X_{i}\right) R_{1}$, for $1 \leqslant i \leqslant n$. Theorem 3.2(b) and [9, (16.22)] yield $\operatorname{dim}_{R_{1}} L_{1} \leqslant \operatorname{cx}_{R_{1}}\left(M_{1}\right)+\operatorname{dim}_{R_{1}}\left(L_{1} \otimes_{R_{1}} M_{1}\right)$. Since $L_{1} \otimes_{R_{1}} M_{1} \simeq k$ and $\operatorname{dim}_{R_{1}} L_{1}=n$, thus $\operatorname{cx}_{R_{1}}\left(M_{1}\right) \geqslant n$, and from [2, (8.1.2)] we have $n=\operatorname{cx}_{R_{1}}(k) \geqslant \operatorname{cx}_{R_{1}}\left(M_{1}\right)$, thus $\operatorname{cx}_{R_{1}}\left(M_{1}\right)=n$. It is easy to see that $R=k\left[\left[X_{\ell}, Y_{\ell}\right]\right] /\left(X_{\ell} Y_{\ell}\right)$ and $M \otimes_{R} N=$ $R /\left(Y_{\ell}\right) R$, for $1 \leqslant \ell \leqslant 2 n$. By 3.7, $M$ and $N$ are Tor-independent $R$-modules. Now let $L=R /\left(X_{\ell}\right) R$, for $1 \leqslant \ell \leqslant 2 n$. Then we get $\operatorname{grade}_{R}(L, M)=n$, and $\operatorname{grade}_{R}\left(L, M \otimes_{R} N\right)=2 n$. The natural local homomorphism $\varphi_{t}: R_{t} \rightarrow R$ is flat. Using [3.7, since $R$ is complete intersection, from [5, (1.13.1)] and [5, (5.2.3)] we get CI- $\operatorname{dim}_{R} N=0$ and $\operatorname{cx}_{R}(N)=n$, respectively. Therefor the left side of the inequality of Corollary 3.6 is equal to $n$, and it's right side is equal to $2 n$.
