# A metric result for special subsequences of the Halton sequences

#### Abstract

In this paper we investigate the special subsequence of the Halton sequence indexed by $\lfloor n \beta\rfloor$ with $\beta \in \mathbb{R}$ and prove a metric almost lowdiscrepancy result.

## 1 Introduction

The discrepancy of the first $N$ terms of any sequence $\left(\boldsymbol{z}_{n}\right)_{n \geq 0}$ of points in $[0,1)^{s}$ is defined by

$$
D_{N}\left(\boldsymbol{z}_{n}\right)=\sup _{J}\left|\frac{A_{N}(J)}{N}-\lambda_{s}(J)\right|,
$$

where the supremum is extended over all half-open subintervals $J$ of $[0,1)^{s}, \lambda_{s}$ denotes the $s$-dimensional Lebesgue measure, and the counting function $A_{N}(J)$ is given by

$$
A_{N}(J)=\#\left\{0 \leq n \leq N-1: \boldsymbol{z}_{n} \in J\right\} .
$$

For the sake of simplicity, we will sometimes write $D_{N}$ instead of $D_{N}\left(\boldsymbol{z}_{n}\right)$. If the supremum is extended over all half-open subintervals $J$ of $[0,1)^{s}$ with the lower left point in the origin then we arrive at the notion of the star-discrepancy $D_{N}^{*}$. It is not so hard to see that $D_{N}^{*} \leq D_{N} \leq 2^{s} D_{N}^{*}$. A sequence $\left(\boldsymbol{z}_{n}\right)_{n \geq 0}$ of points in $[0,1)^{s}$ is called uniformly distributed if $\lim _{N \rightarrow \infty} D_{N}=0$.

It is frequently conjectured in the theory of irregularities of distribution, that for every sequence $\left(\boldsymbol{z}_{n}\right)_{n \geq 0}$ in $[0,1)^{s}$ we have

$$
D_{N} \geq c_{s} \frac{\log ^{s} N}{N}
$$

[^0]for a constant $c_{s}>0$ and for infinitely many $N$. Therefore sequences whose discrepancy satisfies $D_{N} \leq C \log ^{s} N / N$ for all $N$ with a constant $C>0$ that is independent of $N$ ( or $D_{N}=O\left(\log ^{s} N / N\right)$ ), are called low-discrepancy sequences. Well-known examples of low-discrepancy sequences are, for example, the $s$-dimensional Halton sequences and one-dimensional Kronecker sequences $(\{n \alpha\})_{n \geq 0}$ with $\alpha$ irrational and having bounded continued fraction coefficients.

For an integer $b \geq 2$, let $\mathbb{Z}_{b}=\{0,1, \ldots, b-1\}$ denote the least residue system modulo $b$. Let $n=\sum_{j=1}^{\infty} a_{j}(n) b^{j-1}$ with all $a_{j}(n) \in \mathbb{Z}_{b}$ and $a_{j}(n)=0$ for all sufficiently large $j$ be the unique digit expansion of the integer $n \geq 0$ in base $b$. The radical-inverse function $\phi_{b}$ in base $b$ is defined by

$$
\phi_{b}(n)=\sum_{j=1}^{\infty} a_{j}(n) b^{-j}
$$

The Halton sequence $\left(\boldsymbol{y}_{n}\right)_{n \geq 0}$ (in the bases $\left.b_{1}, \ldots, b_{s}\right)$ is given by

$$
\boldsymbol{y}_{n}=\left(\phi_{b_{1}}(n), \ldots, \phi_{b_{s}}(n)\right) \in[0,1)^{s}, \quad n=0,1,2, \ldots
$$

It is well known (see [7, Theorem 3.6]) that the discrepancy of the Halton sequence in pairwise coprime bases $b_{1}, \ldots, b_{s} \geq 2$ satisfies a low-discrepancy bound, i.e.,

$$
\begin{equation*}
D_{N}\left(\boldsymbol{y}_{n}\right)=O_{b_{1}, \ldots, b_{s}}\left((\log N)^{s} / N\right) \quad \text { for all } N \geq 2 \tag{1}
\end{equation*}
$$

The one-dimensional Kronecker sequences $((\{n \alpha\}))_{n \geq 0}$ related to the real number $\alpha$ is uniformly distributed if $\alpha$ is irrational. This sequence is a lowdiscrepancy sequence if the continued fraction coefficients of $\alpha$ are bounded. Furthermore, the discrepancy $D_{N}$ satisfies $N D_{N} \leq C(\alpha, \epsilon) \log ^{1+\epsilon} N$ for all $N$ and all $\epsilon>0$ for almost all $\alpha \in \mathbb{R}$ in the sense of Lebesgue measure. Here the positive constant $C(\alpha, \epsilon)$ may depend on $\alpha$ and $\epsilon>0$ but is independent of $N$.

Subsequences of the one-dimensional Kronecker sequence and Halton sequences are frequently studied objects (see for instance [1], 2], 3], 4]). Here we mention a result of Hofer and Ramare [3] who studied the sequence $(\lfloor n \alpha\rfloor \beta)_{n \geq 0}$. It is known to be u.d. $\bmod 1$ when $\alpha$ is a nonzero rational real if and only if $\beta$ is irrational. When $\alpha=0$ the sequence is for no real $\beta$ u.d. $\bmod 1$. And when $\alpha$ is irrational the uniform distribution modulo one of $([n \alpha] \beta)_{n \geq 0}$ is equivalent to the condition, $1, \alpha, \alpha \beta$ being linearly independent over the rationals. (For a proof see [5, Chapter 5, Theorem 1.8].) In [3] many results on the discrepancy of this sequence were proved. Here we mention just one result, i.e., for almost all pairs of real numbers $(\alpha, \beta)$ in the sense of Lebesgue measure we have for every $\epsilon>0$ that $D_{N}([n \alpha] \beta) \ll_{\alpha, \beta, \epsilon} N^{-1+\epsilon}$.

In this paper we investigate the subsequence $\left(\boldsymbol{x}_{n}\right)_{n \geq 0}$ of the Halton sequence of this particular form

$$
\begin{equation*}
\boldsymbol{x}_{n}:=\left(\phi_{b_{1}}(\lfloor n \beta\rfloor), \ldots, \phi_{b_{s}}(\lfloor n \beta\rfloor)\right) \in[0,1)^{s}, \quad n=0,1,2, \ldots \tag{2}
\end{equation*}
$$

with nonzero $\beta \in \mathbb{R}$ and integers $b_{1}, \ldots, b_{s} \geq 2$ pairwise coprime. See Figure 1 for examples.

Figure 1: The first 500 points in bases 2 and 3 for $\beta=1, \sqrt{2}, \pi$ and $e$.



In [2, Example 5.3] the uniform distribution of (2) was studied. A sufficient criterion for the one-dimensional sequence is, for example, the linear independence of $1, \beta$ over $\mathbb{Q}$. This criterion is not a necessary one, as the choice $\beta=1 / d$ with $d \in \mathbb{N}$ also yields a uniformly distributed sequence (2). If $\beta=d \in \mathbb{N}$ such that $\left(d, b_{i}\right)=1$ for $i=1, \ldots, s$ then the sequence 2 is even a low-discrepancy sequence (see [4]).

In this paper we prove that the sequence (2) is for almost all $\beta \in \mathbb{R}$ an almost low-discrepancy sequence by the following theorem.

Theorem 1. For almost all $\beta \in \mathbb{R}$ in the sense of Lebesgue measure the dis-
crepancy of $\left(\boldsymbol{x}_{n}\right)_{n \geq 0}$ satisfies for all $\epsilon>0$

$$
N D_{N}=O_{\beta, \epsilon, b_{1}, \ldots, b_{s}, s}\left(\log ^{s+1+\epsilon} N\right) .
$$

A proof of this theorem will be outsourced in the next section.

## 2 Proof of Theorem 1

We start with the case $\beta \in(0,1)$. We write $\alpha:=1 / \beta$. Note that $\alpha>1$. Then Theorem 1 immediately follows from the following three auxiliary results.

Proposition 1. The star-discrepancy of the first $N$ points of the sequence (2) satisfies

$$
N D_{N}^{*}\left(\boldsymbol{x}_{n}\right) \leq b_{1} \ldots b_{s} \sum_{j_{1}=0}^{f_{1}} \cdots \sum_{j_{s}=0}^{f_{s}} N \Delta_{N}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{n /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right\}\right)+s
$$

where

$$
\begin{equation*}
f_{i}:=\left\lceil\frac{1}{\log b_{i}} \log N\right\rceil \quad \text { for } 1 \leq i \leq s \tag{3}
\end{equation*}
$$

and
$N \Delta_{N}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{\frac{n}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\}\right):=\sup _{0 \leq R<b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\left|A_{N}\left(\left[\frac{R}{b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}, \frac{R+1}{b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right)\right)-\frac{N}{b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right|$.
Proof. The first aim in the proof is to compute or estimate the function $A_{N}(J)-$ $N \lambda_{s}(J)$ relative to the points $\boldsymbol{x}_{n}$ in $(2)$, where $J \subseteq[0,1)^{s}$ is an interval of the form

$$
\begin{equation*}
J=\prod_{i=1}^{s}\left[0, v_{i} b_{i}^{-f_{i}}\right) \tag{4}
\end{equation*}
$$

with $v_{1}, \ldots, v_{s} \in \mathbb{Z}, 1 \leq v_{i}<b_{i}^{f_{i}}$ for $1 \leq i \leq s$. We extend $v_{i}$ in base $b_{i}$, i.e.,

$$
v_{i}=u_{f_{i}}^{(i)}+u_{f_{i}-1}^{(i)} b_{i}+\cdots+u_{1}^{(i)} b_{i}^{f_{i}-1}
$$

We can write $J$ as a union of $\prod_{i=1}^{s}\left(\sum_{j=1}^{f_{i}} u_{j}^{(i)}\right) \leq\left(b_{1}-1\right) \cdots\left(b_{s}-1\right) f_{1} \cdots f_{s}$ elementary intervals of the form

$$
\prod_{i=1}^{s}\left(\bigcup_{j=1}^{f_{i}} \bigcup_{k=1}^{u_{j}^{(i)}}\left[\sum_{l=1}^{j-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{k-1}{b_{i}^{j}}, \sum_{l=1}^{j-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{k}{b_{i}^{j}}\right)\right)
$$

The crucial step is to estimate $A\left(I_{e}, N\right)-N \lambda_{s}\left(I_{e}\right)$ for an elementary interval $I_{e}$ by exploiting special properties of the Halton sequence. Using the definition of the sequence we obtain for any integer $n \geq 0$ that the following three assertions are equivalent.

$$
\left(\phi_{b_{1}}(\lfloor n / \alpha\rfloor), \ldots, \phi_{b_{s}}(\lfloor n / \alpha\rfloor)\right) \in \prod_{i=1}^{s}\left[\sum_{l=1}^{j_{i}-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{k_{i}-1}{b_{i}^{j_{i}}}, \sum_{l=1}^{j_{1}-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{k_{i}}{b_{i}^{j_{i}}}\right)
$$

where $1 \leq j_{i} \leq f_{i}$ and $1 \leq k_{i} \leq u_{j_{i}}^{(i)}$ for $i=1, \ldots, s$.

$$
\begin{equation*}
\lfloor n / \alpha\rfloor \equiv a_{1} \quad\left(\bmod b_{1}^{j_{1}}\right), \ldots,\lfloor n / \alpha\rfloor \equiv a_{s} \quad\left(\bmod b_{1}^{j_{s}}\right) \tag{5}
\end{equation*}
$$

with $a_{i}=\left(k_{i}-1\right) b_{i}^{j_{i}-1}+\sum_{l=1}^{j_{i}-1} u_{l}^{(i)} b_{i}^{l-1}$.

$$
\lfloor n / \alpha\rfloor \equiv R \quad\left(\bmod b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)
$$

where the $R$ is uniquely determined by the $a_{1}, \ldots, a_{s}$.
By observing the fact that

$$
\lfloor n / \alpha\rfloor \equiv\left\lfloor n / \alpha-b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\left\lfloor n /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right\rfloor\right\rfloor \equiv R \quad\left(\bmod b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)
$$

we easily obtain the equivalence of the above assertion to

$$
\left\{\frac{n}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\} \in\left[\frac{R}{b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}, \frac{R+1}{b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right) .
$$

Hence,

$$
\left|A(J, N)-N \lambda_{s}(J)\right| \leq\left(b_{1}-1\right) \ldots\left(b_{s}-1\right) \sum_{j_{1}=1}^{f_{1}} \cdots \sum_{j_{s}=1}^{f_{s}} N \Delta_{N}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{n /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right\}\right)
$$

An arbitrary interval $I \subseteq[0,1)^{s}$ of the form

$$
\begin{equation*}
I=\prod_{i=1}^{s}\left[0, w_{i}\right) \tag{6}
\end{equation*}
$$

with $0<w_{i} \leq 1$ for $1 \leq i \leq s$ can be approximated from below by an interval $J$ of the form (4), by taking the nearest fraction to the left of $w_{i}$ of the form $v_{i} b_{i}^{-f_{i}}$ with $v_{i} \in \mathbb{Z}$. We easily get

$$
\left|A(I, N)-N \lambda_{s}(I)\right| \leq\left|A(J, N)-N \lambda_{s}(J)\right|+\max \left(A(I \backslash J, N), N \lambda_{s}(I \backslash J)\right)
$$

The definition of the $f_{i}$ in (3) yields $f_{i} \geq \log _{b_{i}} N$. Hence $N \lambda_{s}(I \backslash J) \leq$ $N \sum_{i=1}^{s} b_{i}^{f_{i}} \leq s$. It remains to estimate $A(I \backslash J, N)$ : We trivially have $A(I \backslash$ $J, N) \leq A(S, N) \leq\left|A(S, N)-N \lambda_{s}(S)\right|+N \lambda_{s}(S)$ with $S$ a union of elementary intervals $I_{e}$ of the form

$$
S=\bigcup_{k=1}^{s} \prod_{i=1}^{k-1}[0,1) \times\left[\sum_{l=1}^{f_{k}-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{u_{f_{k}}^{(i)}}{b_{i}^{f_{i}}}, \sum_{l=1}^{f_{k}-1} \frac{u_{l}^{(i)}}{b_{i}^{l}}+\frac{u_{f_{k}}^{(i)}+1}{b_{i}^{f_{i}}}\right) \times \prod_{i=k+1}^{s}[0,1)
$$

Now $N \lambda_{s}\left(I_{e}\right) \leq 1$ by the definition of $f_{k}$ and

$$
\left|A\left(I_{e}, N\right)-N \lambda_{s}\left(I_{e}\right)\right| \leq N \Delta_{N}^{\left(0, \ldots, 0, f_{k}, 0, \ldots, 0\right)}\left(\left\{n /\left(\alpha b_{k}^{f_{k}}\right)\right\}\right)
$$

and the result follows.

The discrepancy of a one-dimensional Kronecker sequence $(\{n \beta\})_{n \geq 0}$ can be related to the continued fraction expansion of $\beta$

$$
\beta=\left[\lfloor\beta\rfloor ; a_{1}(\beta), a_{2}(\beta), a_{3} \beta, \ldots\right]=\lfloor\beta\rfloor+\frac{1}{a_{1}(\beta)+\frac{1}{a_{2}(\beta)+\frac{1}{a_{3}(\beta)+1}}}
$$

$\ddots$.
This expansion is obtained by setting $\{\beta\}=x_{1}$ and defining inductively

$$
a_{k}(\beta)=\left\lfloor 1 / x_{k}\right\rfloor \text { and } x_{k+1}=\left\{1 / x_{k}\right\}
$$

The convergents $p_{k} / q_{k}$ to $\beta$ are defined by $p_{k} / q_{k}=\left[\lfloor\beta\rfloor ; a_{1}(\beta), a_{2}(\beta), \ldots, a_{k}(\beta)\right]$. The denominators $q_{k}$ obey the following recursion

$$
q_{k}=a_{k}(\beta) q_{k-1}+q_{k-2} \text { for } k \geq 1 \text { and with } q_{0}=1, q_{-1}=0
$$

Lemma 1. We have

$$
N \Delta_{N}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{n /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right\}\right) \leq \alpha+1+2\left(\sum_{k=1}^{\left\lceil\log _{3 / 2}(N)\right\rceil} a_{k}\left(\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right)\right) .
$$

Proof. We follow the idea of [5, page 125, proof of Theorem 3.4]. Now we use the fact that $\beta \in(0,1)$ and hence $\alpha>1$. Then $\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}>1$, and the first coefficient $a_{1}\left(1 /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right)=\left\lfloor\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right\rfloor$. We compute the Ostrowski expansion using the denominators $1=q_{0}=q_{1}<q_{2}<q_{3}<\cdots$ of the convergents to $1 /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)$ :

$$
N=N_{0}+N_{1} q_{1}+N_{2} q_{2}+\cdots+N_{r} q_{r}
$$

with $q_{r} \leq N<q_{r+1}$ and $N_{i} \leq a_{i+1}\left(1 / \alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)$.
We split
$N \Delta_{N}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{\frac{n}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\}\right) \leq N_{0} \Delta_{N_{0}}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{\frac{n}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\}\right)+\left(N-N_{0}\right) \Delta_{N-N_{0}}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{\frac{n+N_{0}}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\}\right)$
and proceed for the second term as in [5, page 125, proof of Theorem 3.4] and obtain

$$
\begin{aligned}
\left(N-N_{0}\right) \Delta_{N-N_{0}}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{\frac{n+N_{0}}{\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}}\right\}\right) & \leq 2 \sum_{k=2}^{\left\lceil\log _{3 / 2} N\right\rceil+1} a_{k}\left(1 /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right) \\
& \leq 2 \sum_{k=1}^{\left\lceil\log _{3 / 2} N\right\rceil} a_{k}\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)
\end{aligned}
$$

Finally, it is not so hard to see that $N_{0} \Delta_{N_{0}}^{\left(j_{1}, \ldots, j_{s}\right)}\left(\left\{n /\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)\right\}\right) \leq \alpha+1$ with $N_{0} \leq\left\lfloor\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right\rfloor$. Note the fact that $\left.\left[R / b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right),(R+1) / b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)$ either remains empty or contains at most $\lfloor\alpha\rfloor+1$ points, and $N_{0} 1 / b_{1}^{j_{1}} \cdots b_{s}^{j_{s}} \leq\lfloor\alpha\rfloor+1$.

Lemma 2. Let $\alpha \in \mathbb{R}$. For any $L \in \mathbb{N}$ let

$$
S_{L}(\alpha):=\sum_{j_{1}=0}^{L} \cdots \sum_{j_{s}=0}^{L} \sum_{k=1}^{L} a_{k}\left(\alpha b_{1}^{j_{1}} \cdots b_{s}^{j_{s}}\right)
$$

Then for almost all $\alpha \in \mathbb{R}$ we have for every $\epsilon>0$

$$
S_{L}(\alpha)=O_{\alpha, \epsilon, b_{1}, \ldots, b_{s}, s}\left(L^{s+1+\epsilon}\right)
$$

Proof. See e.g. [6, Lemma 2].
Finally we consider $\beta>1$ and set $\alpha:=\beta /(\beta+1)$. Then $1 / 2<\alpha<1$, $\lfloor n \alpha\rfloor=n-\left\lceil n \frac{1}{\beta+1}\right\rceil$ and hence

$$
\{\lfloor n \alpha\rfloor ; n \in \mathbb{N}\}=\{\lfloor n \beta\rfloor ; n \in \mathbb{N}\} \cup \mathbb{N}_{0}
$$

Let
$B:=\left\{\alpha \in(1 / 2,1): D_{N}\left(\phi_{b_{1}}(\lfloor n \alpha\rfloor), \ldots, \phi_{b_{s}}(\lfloor n \alpha\rfloor)\right)=O_{\alpha, \epsilon, b_{1}, \ldots, b_{s}}\left(\frac{(\log N)^{s+1+\epsilon}}{N}\right)\right.$ for all $\left.\epsilon>0\right\}$.
From the above case we know $\lambda(B)=1 / 2$. Let $A:=\{\beta \in(1, \infty): \beta /(\beta+1) \in$ $B\}$. Then $\lambda((1, \infty) \backslash A)=0$.

Now let $\beta \in A$. Then $\alpha \in B$. Since

$$
\underbrace{\left(\phi_{b_{1}}(\lfloor n \alpha\rfloor), \ldots, \phi_{b_{s}}(\lfloor n \alpha\rfloor)\right)_{n \geq 1}}_{D_{N}=O\left((\log N)^{s+1+\epsilon / N)}\right.}=\left(\phi_{b_{1}}(\lfloor n \beta\rfloor), \ldots, \phi_{b_{s}}(\lfloor n \beta\rfloor)\right)_{n \geq 1} \cup \underbrace{\left(\phi_{b_{1}}(n), \ldots, \phi_{b_{s}}(n)\right)_{n \geq 0}}_{D_{N}=O\left((\log N)^{s} / N\right)}
$$

we have

$$
D_{N}\left(\phi_{b_{1}}(\lfloor n \beta\rfloor), \ldots, \phi_{b_{s}}(\lfloor n \beta\rfloor)\right)=O_{\beta, \epsilon, b_{1}, \ldots, b_{s}}\left(\frac{(\log N)^{s+1+\epsilon}}{N}\right) \text { for all } \epsilon>0
$$

and the proof is complete.
