# SPANNING SIMPLICIAL COMPLEXES OF UNI-CYCLIC MULTIGRAPHS

#### Abstract

A multigraph is a nonsimple graph which is permitted to have multiple edges, that is, edges that have the same end nodes. We introduce the concept of spanning simplicial complexes $\Delta_{s}(\mathcal{G})$ of multigraphs $\mathcal{G}$, which provides a generalization of spanning simplicial complexes of associated simple graphs. We give first the characterization of all spanning trees of a uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ with $n$ edges including $r$ multiple edges within and outside the cycle of length $m$. Then, we determine the facet ideal $I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right)$ of spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ and its primary decomposition. The Euler characteristic is a well-known topological and homotopic invariant to classify surfaces. Finally, we device a formula for Euler characteristic of spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$.

## 1. Introduction

Let $\mathcal{G}=\mathcal{G}(V, E)$ be a multigraph on the vertex set $V$ and edge-set $E$. A spanning tree of a multigraph $\mathcal{G}$ is a subtree of $\mathcal{G}$ that contains every vertex of $\mathcal{G}$. We represent the collection of all edge-sets of the spanning trees of a multigraph $\mathcal{G}$ by $s(\mathcal{G})$. The facets of spanning simplicial complex $\Delta_{s}(\mathcal{G})$ is exactly the edge set $s(\mathcal{G})$ of all possible spanning trees of a multigraph $\mathcal{G}$. Therefore, the spanning simplicial complex $\Delta_{s}(\mathcal{G})$ of a multigraph $\mathcal{G}$ is defined by

$$
\Delta_{s}(\mathcal{G})=\left\langle F_{k} \mid F_{k} \in s(\mathcal{G})\right\rangle
$$

which gives a generalization of the spanning simplicial complex $\Delta_{s}(G)$ of an associated simple graph $G$. The spanning simplicial complex of a simple connected finite graph was firstly introduced by Anwar, Raza and Kashif in [1]. Many authors discussed algebraic and combinatorial properties of spanning simplicial complexes of various classes of simple connected finite graphs, see for instance [1], 5], 6] and (9].

Let $\Delta$ be simplicial complex of dimension $d$. We denote $f_{i}$ by the number of $i$-cells of simplicial complex $\Delta$. Then, the Euler characteristic of $\Delta$ is given
by

$$
\chi(\Delta)=\sum_{i=0}^{d-1}(-1)^{i} f_{i}
$$

which is a well-known topological and homotopic invariant to classify surfaces, see [4] and [7].

The uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ is a connected graph having $n$ edges including $r$ multiple edges within and outside the cycle of length $m$. Our aim is to give some algebraic and topological characterizations of spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$.

In Lemma 3.1, we give characterization of all spanning trees of a uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ having $n$ edges including $r$ multiple edges and a cycle of length $m$. In Proposition 3.2, we determine the facet ideal $I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right)$ of spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ and its primary decomposition. In Theorem 3.3, we give a formula for Euler characteristic of spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$.

## 2. Basic Setup

A simplicial complex $\Delta$ on $[n]=\{1, \ldots, n\}$ is a collection of subsets of $[n]$ satisfying the following properties.
(1) $\{j\} \in \Delta$ for all $j \in[n]$;
(2) If $F \in \Delta$ then every subset of $F$ will belong to $\Delta$ (including empty set).

The elements of $\Delta$ are called faces of $\Delta$ and the dimension of any face $F \in \Delta$ is defined as $|F|-1$ and is written as $\operatorname{dim} F$, where $|F|$ is the number of vertices of $F$. The vertices and edges are 0 and 1 dimensional faces of $\Delta$ (respectively), whereas, $\operatorname{dim} \emptyset=-1$. The maximal faces of $\Delta$ under inclusion are said to be the facets of $\Delta$. The dimension of $\Delta$ is denoted by $\operatorname{dim} \Delta$ and is defined by $\operatorname{dim} \Delta=\max \{\operatorname{dim} F \mid F \in \Delta\}$.

If $\left\{F_{1}, \ldots, F_{q}\right\}$ is the set of all the facets of $\Delta$, then $\Delta=<F_{1}, \ldots, F_{q}>$. A simplicial complex $\Delta$ is said to be pure, if all its facets are of the same dimension.

A subset $M$ of $[n]$ is said to be a vertex cover for $\Delta$ if $M$ has non-empty intersection with every $F_{k} . M$ is said to be a minimal vertex cover for $\Delta$ if no proper subset of $M$ is a vertex cover for $\Delta$.

Definition 2.1. Let $\mathcal{G}=\mathcal{G}(V, E)$ be a multigraph on the vertex set $V$ and edge-set $E$. A spanning tree of a multigraph $\mathcal{G}$ is a subtree of $\mathcal{G}$ that contains every vertex of $\mathcal{G}$.

Definition 2.2. Let $\mathcal{G}=\mathcal{G}(V, E)$ be a multigraph on the vertex set $V$ and edgeset $E$. Let $s(\mathcal{G})$ be the edge-set of all possible spanning trees of $\mathcal{G}$. We define a simplicial complex $\Delta_{s}(\mathcal{G})$ on $E$ such that the facets of $\Delta_{s}(\mathcal{G})$ are exactly the elements of $s(\mathcal{G})$, we call $\Delta_{s}(\mathcal{G})$ as the spanning simplicial complex of $\mathcal{G}$ and given by

$$
\Delta_{s}(\mathcal{G})=\left\langle F_{k} \mid F_{k} \in s(\mathcal{G})\right\rangle
$$

Definition 2.3. A uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ is a connected graph having $n$ edges including $r$ multiple edges within and outside the cycle of length $m$.

Let $\Delta$ be simplicial complex of dimension $d$. Then, the chain complex $C_{*}(\Delta)$ is given by

$$
0 \rightarrow C_{d}(\Delta) \xrightarrow{\partial_{d}} C_{d-1}(\Delta) \xrightarrow{\partial_{d-1}} \ldots \xrightarrow{\partial_{2}} C_{1}(\Delta) \xrightarrow{\partial_{1}} C_{0}(\Delta) \stackrel{\partial}{\rightarrow}^{0} 0
$$

Each $C_{i}(\Delta)$ is a free abelian group of rank $f_{i}$. The boundary homomorphism $\partial_{d}: C_{d}(\Delta) \rightarrow C_{d-1}(\Delta)$ is defined by

$$
\partial_{d}\left(\sigma_{\alpha}^{d}\right)=\left.\sum_{i=0}^{d}(-1)^{i} \sigma_{\alpha}^{d}\right|_{\left[v_{0}, v_{1}, \ldots, \hat{v}, \ldots, v_{d}\right]} .
$$

Of course,

$$
H_{i}(\Delta)=Z_{i}(\Delta) / B_{i}(\Delta)=\operatorname{Ker}_{i} / \operatorname{Im} \partial_{i+1}
$$

where $Z_{i}(\Delta)=\operatorname{Ker} \partial_{i}$ and $B_{i}(\Delta)=\operatorname{Im} \partial_{i+1}$ are the groups of simplicial $i$ cycles and simplicial $i$-boundaries, respectively. Therefore,

$$
\operatorname{rank} H_{i}(\Delta)=\operatorname{rank} Z_{i}(\Delta)-\operatorname{rank} B_{i}(\Delta)
$$

One can easily see that rank $B_{d}(\Delta)=0$ due to $B_{d}(\Delta)=0$. For each $i \geqslant 0$ there is an exact sequence

$$
0 \rightarrow Z_{i}(\Delta) \rightarrow C_{i}(\Delta) \xrightarrow{\partial_{i}} B_{i-1}(\Delta) \rightarrow 0
$$

Moreover,

$$
f_{i}=\operatorname{rank} C_{i}(\Delta)=\operatorname{rank} Z_{i}(\Delta)+\operatorname{rank} B_{i-1}(\Delta)
$$

Therefore, the Euler characteristic of $\Delta$ can be expressed as $\chi(\Delta)=\sum_{i=0}^{d}(-1)^{i} f_{i}=\sum_{i=0}^{d}(-1)^{i}\left(\operatorname{rank} Z_{i}(\Delta)+\operatorname{rank} B_{i-1}(\Delta)\right)$
$=\sum_{i=0}^{d}(-1)^{i} \operatorname{rank} Z_{i}(\Delta)+\sum_{i=0}^{d}(-1)^{i} \operatorname{rank} B_{i-1}(\Delta)$.
Changing index of summation in the last sum and using the fact that
$\operatorname{rank} B_{-1}(\Delta)=0=\operatorname{rank} B_{d}(\Delta)$, we get
$\chi(\Delta)=\sum_{i=0}^{d}(-1)^{i} \operatorname{rank} Z_{i}(\Delta)+\sum_{i=0}^{d}(-1)^{i+1} \operatorname{rank} B_{i}(\Delta)$
$=\sum_{i=0}^{d}(-1)^{i}\left(\operatorname{rank} Z_{i}(\Delta)-\operatorname{rank} B_{i}(\Delta)\right)=\sum_{i=0}^{d}(-1)^{i} \operatorname{rank} H_{i}(\Delta)$.
Thus, the Euler characteristic of $\Delta$ is given by

$$
\chi(\Delta)=\sum_{i=0}^{d}(-1)^{i} \beta_{i}(\Delta)
$$

where $\beta_{i}(\Delta)=\operatorname{rank} H_{i}(\Delta)$ is the $i$-th Betti number of $\Delta$, see [4] and [7].

## 3. Topological Characterizations of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$

Let $\mathcal{U}_{n, m}^{r}$ be a uni-cyclic multigraph having $n$ edges including $r$ multiple edges within and outside the cycle of length $m$. We fix the labeling of the edge set $E$ of $\mathcal{U}_{n, m}^{r}$ as follows:
$E=\left\{e_{11}, \ldots, e_{1 t_{1}}, \ldots, e_{r^{\prime} 1}, \ldots, e_{r^{\prime} t_{r^{\prime}}}, e_{\left(r^{\prime}+1\right) 1}, \ldots, e_{m 1}, e_{(m+1) 1}, \ldots, e_{(m+1) t_{m+1}}\right.$, $\left.\ldots, e_{\left(m+r^{\prime \prime}\right) 1}, \ldots, e_{\left(m+r^{\prime \prime}\right) t_{m+r^{\prime \prime}}}, e_{1}, \ldots, e_{v}\right\}$, where $e_{i 1}, \ldots, e_{i t_{i}}$ are the multiple edges of $i$-th edge of cycle with $1 \leq i \leq r^{\prime}$ while $e_{\left(r^{\prime}+1\right) 1}, \ldots, e_{m 1}$ are the single edges of the cycle and $e_{j 1}, \ldots, e_{j t_{j}}$ are the multiple edges of the $j$-th edge outside the cycle with $m+1 \leq j \leq m+r^{\prime \prime}$, moreover, $e_{1}, \ldots, e_{v}$ are single edges appeared outside the cycle.

We give first the characterization of $s\left(\mathcal{U}_{n, m}^{r}\right)$.
Lemma 3.1. Let $\mathcal{U}_{n, m}^{r}$ be the uni-cyclic multigraph having $n$ edges including $r$ multiple edges and a cycle of length $m$ with the edge set $E$, given above. A subset $E\left(T_{w i_{w}}\right) \subset E$ will belong to $s\left(\mathcal{U}_{n, m}^{r}\right)$ if and only if $T_{w i_{w}}=\left\{e_{1 i_{1}}, \ldots, e_{r^{\prime} i_{r^{\prime}}}\right.$, $\left.e_{\left(r^{\prime}+1\right) 1}, \ldots, e_{m 1}, e_{(m+1) i_{(m+1)}}, \ldots, e_{\left(m+r^{\prime \prime}\right) i_{\left(m+r^{\prime \prime}\right)}}, e_{1}, \ldots, e_{v}\right\} \backslash\left\{e_{w i_{w}}\right\}$ for some $i_{h} \in$ $\left\{1, \ldots, t_{h}\right\}$ with $1 \leq h \leq r^{\prime}, m+1 \leq h \leq m+r^{\prime \prime}$ and $i_{w} \in\left\{1, \ldots, t_{w}\right\}$ with $1 \leq w \leq r^{\prime}$ or $i_{w}=1$ with $r^{\prime}+1 \leq w \leq m$ for some $w=h$ and $i_{w}=i_{h}$ appeared in $T_{w i_{w}}$.
Proof. By cutting down method [3], the spanning trees of $\mathcal{U}_{n, m}^{r}$ can be obtained by removing exactly $t_{h}-1$ edges from each multiple edge such that $1 \leq h \leq r^{\prime}$, $m+1 \leq h \leq m+r^{\prime \prime}$ and in addition, an edge from the resulting cycle need to be removed. Therefore, the spanning trees will be of the form $T_{w i_{w}}=$ $\left\{e_{1 i_{1}}, \ldots, e_{r^{\prime} i_{r^{\prime}}}, e_{\left(r^{\prime}+1\right) 1}, \ldots, e_{m 1}, e_{(m+1) i_{(m+1)}}, \ldots, e_{\left(m+r^{\prime \prime}\right) i_{\left(m+r^{\prime \prime}\right.}}, e_{1}, \ldots, e_{v}\right\} \backslash\left\{e_{w i_{w}}\right\}$ for some $i_{h} \in\left\{1, \ldots, t_{h}\right\}$ with $1 \leq h \leq r^{\prime}, m+1 \leq h \leq m+r^{\prime \prime}$ and $i_{w} \in\left\{1, \ldots, t_{w}\right\}$ with $1 \leq w \leq r^{\prime}$ or $i_{w}=1$ with $r^{\prime}+1 \leq w \leq m$ for some $w=h$ and $i_{w}=i_{h}$ appeared in $T_{w i_{w}}$.

In the following result, we give the primary decomposition of facet ideal $I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right.$.
Proposition 3.2. Let $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ be the spanning simplicial complex of unicyclic multigraph $\mathcal{U}_{n, m}^{r}$ having $n$ edges including $r$ multiple edges within and outside the cycle of length $m$. Then,
$I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)=\right.$

$$
\begin{aligned}
& \left(\bigcap_{1 \leq a \leq v}\left(x_{a}\right)\right) \bigcap\left(\bigcap_{1 \leq i \leq r^{\prime} ; r^{\prime}+1 \leq k \leq m}\left(x_{i 1}, \ldots, x_{i t_{i}}, x_{k 1}\right)\right) \bigcap\left(\bigcap_{r^{\prime}+1 \leq k<l \leq m}\left(x_{k 1}, x_{l 1}\right)\right) \\
& \bigcap\left(\bigcap_{1 \leq i<b \leq r^{\prime}}\left(x_{i 1}, \ldots, x_{i t_{i}}, x_{b 1}, \ldots, x_{b t_{b}}\right)\right) \bigcap\left(\bigcap_{m+1 \leq j \leq m+r^{\prime \prime}}\left(x_{j 1}, \ldots, x_{j t_{j}}\right)\right),
\end{aligned}
$$

where $t_{i}$ with $1 \leq i \leq r^{\prime}$ is the number of multiple edges appeared in the $i$-th edge of the cycle and $t_{j}$ with $m+1 \leq j \leq m+r^{\prime \prime}$ is the number of multiple edges appeared in the $j$ th-edge outside the cycle.
Proof. Let $I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right.$ be the facet ideal of the spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$. From ([8], Proposition 1.8), minimal prime ideals of the facet ideal $I_{\mathcal{F}}(\Delta)$ have one-to-one correspondence with the minimal vertex covers of the simplicial complex $\Delta$. Therefore, in order to find the primary decomposition of the facet ideal $I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right)$; it is sufficient to find all the minimal vertex covers of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$.

As $e_{a}, a \in[v]$ is not an edge of the cycle of uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ and does not belong to any multiple edge of $\mathcal{U}_{n, m}^{r}$. Therefore, it is clear by definition of minimal vertex cover that $\left\{e_{a}\right\}, 1 \leq a \leq v$ is a minimal vertex cover of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$. Moreover, a spanning tree is obtained by removing exactly $t_{h}-1$ edges from each multiple edge with $h=1, \ldots, r^{\prime}, m+1, \ldots, m+r^{\prime \prime}$ and
in addition, an edge from the resulting cycle of $\mathcal{U}_{n, m}^{r}$. We illustrate the result into the following cases.
Case 1. If atleast one multiple edge is appeared in the cycle of $\mathcal{U}_{n, m}^{r}$. Then, we cannot remove one complete multiple edge and one single edge from the cycle of $\mathcal{U}_{n, m}^{r}$ to get spanning tree. Therefore, $\left(x_{i 1}, \ldots, x_{i t_{i}}, x_{k 1}\right)$ with $1 \leq i \leq r^{\prime}$, $r^{\prime}+1 \leq k \leq m$ is a minimal vertex cover of the spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ having non-empty intersection with all the spanning trees of $\mathcal{U}_{n, m}^{r}$. Moreover, two single edges cannot be removed from the cycle of $\mathcal{U}_{n, m}^{r}$ to get spanning tree. Consequently, $\left(x_{k 1}, x_{l 1}\right)$ for $r^{\prime}+1 \leq k<l \leq m$ is a minimal vertex cover of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ having non-empty intersection with all the spanning trees of $\mathcal{U}_{n, m}^{r}$.
Case 2. If atleast two multiple edges are appeared in the cycle of $\mathcal{U}_{n, m}^{r}$. Then, two complete multiple edges cannot be removed from the cycle of $\mathcal{U}_{n, m}^{r}$ to get spanning tree. Consequently, $\left(x_{i 1}, \ldots, x_{i t_{i}}, x_{b 1}, \ldots, x_{b t_{b}}\right)$ for $1 \leq i<b \leq r^{\prime}$ is a minimal vertex cover of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ having non-empty intersection with all the spanning trees of $\mathcal{U}_{n, m}^{r}$.
Case 3. If atleast one multiple edge appeared outside the cycle of $\mathcal{U}_{n, m}^{r}$. Then, one complete multiple edge outside the cycle of $\mathcal{U}_{n, m}^{r}$ cannot be removed to get spanning tree. So, $\left(x_{j 1}, \ldots, x_{j t_{j}}\right)$ for $m+1 \leq j \leq m+r^{\prime \prime}$ is a minimal vertex cover of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ having non-empty intersection with all the spanning trees of $\mathcal{U}_{n, m}^{r}$. This completes the proof.

We give now formula for Euler characteristic of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$.
Theorem 3.3. Let $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ be spanning simplicial complex of uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ having $n$ edges including $r$ multiple edges and a cycle of length $m$. Then, $\operatorname{dim}\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right)=n-\sum_{i=1}^{r^{\prime}} t_{i}-\sum_{j=m+1}^{m+r^{\prime \prime}} t_{j}+r-2$ and the Euler characteristic of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ is given by
$\chi\left(\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)\right)=\sum_{i=0}^{n-1}(-1)^{i}\left[\binom{n}{i+1}-\prod_{i=1}^{r^{\prime}} t_{i}\left[\begin{array}{c}n-\alpha+r^{\prime}-m \\ i+1-m\end{array}\right)\right.$
$\left.-\sum_{j=2}^{\beta}\left(\binom{\beta}{j}-\left(\sum_{m+1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{j}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\beta}(-1)^{l-j}\binom{\beta-j}{l-j}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right]$
$\left.-\sum_{j=2}^{\alpha+\beta}\left(\binom{\alpha+\beta}{j}-\left(\begin{array}{c}\sum_{j} \notin\left\{r^{\prime}+1, \ldots, m\right\} \\ 1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime}\end{array} \prod_{k=i_{1}}^{i_{j}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\alpha+\beta}(-1)^{l-j}\binom{\alpha+\beta-j}{l-j}\binom{n-l}{i+1-l}\right]$
with $\alpha=\sum_{i=1}^{r^{\prime}} t_{i}$ and $\beta=\sum_{j=m+1}^{m+r^{\prime \prime}} t_{j}$ such that $r^{\prime}$ and $r^{\prime \prime}$ are the number of multiple edges appeared within and outside the cycle, respectively.

Proof. Let $E=\left\{e_{11}, \ldots, e_{1 t_{1}}, \ldots, e_{r^{\prime} 1}, \ldots, e_{r^{\prime} t_{r^{\prime}}}, e_{\left(r^{\prime}+1\right) 1}, \ldots, e_{m 1}, e_{(m+1) 1}, \ldots\right.$,
$\left.e_{(m+1) t_{m+1}}, \ldots, e_{\left(m+r^{\prime \prime}\right) 1}, \ldots, e_{\left(m+r^{\prime \prime}\right) t_{m+r^{\prime \prime}}}, e_{1}, \ldots, e_{v}\right\}$ be the edge set of uni-cyclic multigraph $\mathcal{U}_{n, m}^{r}$ having $n$ edges including $r$ multiple edges and a cycle of length $m$ such that $r^{\prime}$ and $r^{\prime \prime}$ are the number of multiple edges appeared within and outside the cycle, respectively.

One can easily see that each facet $T_{w i_{w}}$ of $\Delta_{s}\left(\mathcal{U}_{n, m}^{r}\right)$ is of the same dimension $n-\sum_{i=1}^{r^{\prime}} t_{i}-\sum_{j=m+1}^{m+r^{\prime \prime}} t_{j}+r-2=n-\alpha-\beta+r-2$ with $\alpha=\sum_{i=1}^{r^{\prime}} t_{i}$ and $\beta=\sum_{j=m+1}^{m+r^{\prime \prime}} t_{j}$, see Lemma 3.1.

By definition, $f_{i}$ is the number of subsets of $E$ with $i+1$ elements not containing cycle and multiple edges. There are $\prod_{i=1}^{r^{\prime}} t_{i}\binom{n-\alpha+r^{\prime}-m}{i+1-m}$ number of subsets of $E$ containing cycle but not containing any multiple edge within the cycle. There are

$$
\binom{n-\alpha+r^{\prime}-m-\beta}{i+1-m-\beta}=\binom{\beta}{\beta} \sum_{l=\beta}^{\beta}(-1)^{l-\beta}\binom{\beta-\beta}{l-\beta}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}
$$

subsets of $E$ containing cycle and $\beta$ multiple edges of $\mathcal{U}_{n, m}^{r}$ outside the cycle but not containing any multiple edge within the cycle. There are

$$
\begin{aligned}
& \binom{\beta}{\beta-1}\left[\binom{n-\alpha+r^{\prime}-m-(\beta-1)}{i+1-m-(\beta-1)}-\binom{n-\alpha+r^{\prime}-m-\beta}{i+1-m-\beta}\right] \\
& =\binom{\beta}{\beta-1} \sum_{l=\beta-1}^{\beta}(-1)^{l-(\beta-1)}\binom{\beta-(\beta-1)}{l-(\beta-1)}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}
\end{aligned}
$$

subsets of $E$ containing cycle and $\beta-1$ multiple edges of $\mathcal{U}_{n, m}^{r}$ outside the cycle but not containing any multiple edge within the cycle. Continuing in similar manner, the number of subsets of $E$ containing cycle and two edges from a multiple edge outside the cycle but not containing any multiple edge within the cycle is given by
$\binom{\beta-2}{0}\binom{n-\alpha+r^{\prime}-m-2}{i+1-m-2}-\binom{\beta-2}{1}\binom{n-\alpha+r^{\prime}-m-3}{i+1-m-3}+\binom{\beta-2}{2}\binom{n-\alpha+r^{\prime}-m-4}{i+1-m-4}+\cdots$
$+(-1)^{\beta-2}\binom{\beta-2}{\beta-2}\binom{n-\alpha+r^{\prime}-m-\beta}{i+1-m-\beta}=\sum_{l=2}^{\beta}(-1)^{l-2}\binom{\beta-2}{l-2}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}$.
There are $\left(\binom{\beta}{2}-\left(\sum_{m+1 \leq i_{1}<i_{2} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{2}}\binom{t_{k}}{1}\right)\right)$ choices of two edges from a multiple edge outside the cycle. Therefore, we obtain

$$
\left(\binom{\beta}{2}-\left(\sum_{m+1 \leq i_{1}<i_{2} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{2}}\binom{t_{k}}{1}\right)\right) \sum_{l=2}^{\beta}(-1)^{l-2}\binom{\beta-2}{l-2}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}
$$

the number of subsets of $E$ with $i+1$ elements containing cycle and all possible choices of two edges from a multiple edge outside the cycle but not containing multiple edges within the cycle.

Now, we use inclusion exclusion principal to obtain (number of subsets of $E$ containing cycle but not containing multiple edges) $=$ $\prod_{i=1}^{r^{\prime}} t_{i}[$ (number of subsets of $E$ with $i+1$ elements containing cycle but not containing multiple edges within the cycle)-(number of subsets of $E$ with $i+1$ elements containing cycle and $\beta$ multiple edges outside the cycle but
not containing multiple edges within the cycle)-(number of subsets of $E$ with $i+1$ elements containing cycle and $\beta-1$ multiple edges outside the cycle but not containing multiple edges within the cycle) $-\cdots-$ (number of subsets of $E$ with $i+1$ elements containing cycle and two edges from a multiple edge outside the cycle but not containing multiple edges within the cycle)]

$$
\begin{aligned}
& =\prod_{i=1}^{r^{\prime}} t_{i}\left[\binom{n-\alpha+r^{\prime}-m}{i+1-m}-\binom{\beta}{\beta} \sum_{l=\beta}^{\beta}(-1)^{l-\beta}\binom{\beta-\beta}{l-\beta}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right. \\
& -\binom{\beta}{\beta-1} \sum_{l=\beta-1}^{\beta}(-1)^{l-(\beta-1)}\binom{\beta-(\beta-1)}{l-(\beta-1)}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l} \\
& \left.-\cdots-\left(\binom{\beta}{2}-\left(\sum_{l+1 \leq i_{1}<i_{2} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{2}}\binom{t_{k}}{1}\right)\right) \sum_{l=2}^{\beta}(-1)^{l-2}\binom{\beta-2}{l-2}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right] \\
& =\prod_{i=1}^{r^{\prime}} t_{i}\left[\binom{n-\alpha+r^{\prime}-m}{i+1-m}\right. \\
& -\sum_{j=2}^{\beta}\left(\binom{\beta}{j}-\left(\begin{array}{c}
i_{j} \\
m+1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime} \\
\left.\left.\left.\sum_{k=i_{1}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\beta}(-1)^{l-j}\binom{\beta-j}{l-j}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right]
\end{array} .\right.\right.
\end{aligned}

Therefore, we compute
$f_{i}=($ number of subsets of $E$ with $i+1$ elements) $-($ number of subsets of $E$ with $i+1$ elements containing cycle but not containing multiple edges)-(number of subsets of $E$ with $i+1$ elements containing $\alpha+\beta$ multiple edges) -(number of subsets of $E$ with $i+1$ elements containing $\alpha+\beta-1$ multiple edges) $-\cdots-$ (number of subsets of $E$ with $i+1$ elements containing two edges from a multiple edge of $\mathcal{U}_{n, m}^{r}$ )
$=\binom{n}{i+1}-\prod_{i=1}^{r^{\prime}} t_{i}\left[\binom{n-\alpha+r^{\prime}-m}{i+1-m}\right.$
$\left.-\sum_{j=2}^{\beta}\left(\binom{\beta}{j}-\left(\sum_{m+1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{j}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\beta}(-1)^{l-j}\binom{\beta-j}{l-j}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right]$
$-\binom{\alpha+\beta}{\alpha+\beta} \sum_{l=\alpha+\beta}^{\alpha+\beta}(-1)^{l-(\alpha+\beta)}\binom{(\alpha+\beta)-(\alpha+\beta)}{l-(\alpha+\beta)}\binom{n-l}{i+1-l}$
$-\binom{\alpha+\beta}{\alpha+\beta-1} \sum_{l=\alpha+\beta-1}^{\alpha+\beta}(-1)^{l-(\alpha+\beta-1)}\binom{(\alpha+\beta)-(\alpha+\beta-1)}{l-(\alpha+\beta-1)}\binom{n-l}{i+1-l}$
$-\cdots-\left(\binom{\alpha+\beta}{2}-\left(\begin{array}{c}i_{j} \notin\left\{r^{\prime}+1, \ldots, m\right\} \\ \left.\left.\sum_{1 \leq i_{1}<i_{2} \leq m+r^{\prime \prime}}^{i_{2}} \prod_{k=i_{1}}^{i_{2}}\binom{t_{k}}{1}\right)\right) \sum_{l=2}^{\alpha+\beta}(-1)^{l-2}\binom{\alpha+\beta-2}{l-2}\binom{n-l}{i+1-l} ~\end{array}\right.\right.$
$=\binom{n}{i+1}-\prod_{i=1}^{r^{\prime}} t_{i}\left[\binom{n-\alpha+r^{\prime}-m}{i+1-m}\right.$
$\left.-\sum_{j=2}^{\beta}\left(\binom{\beta}{j}-\left(\sum_{m+1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime}} \prod_{k=i_{1}}^{i_{j}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\beta}(-1)^{l-j}\binom{\beta-j}{l-j}\binom{n-\alpha+r^{\prime}-m-l}{i+1-m-l}\right]$
$-\sum_{j=2}^{\alpha+\beta}\left(\binom{\alpha+\beta}{j}-\left(\begin{array}{c}i_{j} \notin\left\{r^{\prime}+1, \ldots, m\right\} \\ 1 \leq i_{1}<\ldots<i_{j} \leq m+r^{\prime \prime}\end{array} \prod_{k=i_{1}}^{i_{j}}\binom{t_{k}}{1}\right)\right) \sum_{l=j}^{\alpha+\beta}(-1)^{l-j}\binom{\alpha+\beta-j}{l-j}\binom{n-l}{i+1-l}$.

Example 3.4. Let $E=\left\{e_{11}, e_{12}, e_{13}, e_{21}, e_{31}, e_{41}, e_{42}\right\}$ be the edge set of unicyclic multigraph $\mathcal{U}_{7,3}^{2}$ having 7 edges including 2 multiple edges and a cycle of length 3, as shown in Figure 1 By cutting-down method, we obtain $s\left(\mathcal{U}_{7,3}^{2}\right)=\left\{\left\{e_{21}, e_{31}, e_{41}\right\},\left\{e_{11}, e_{31}, e_{41}\right\},\left\{e_{11}, e_{21}, e_{41}\right\},\left\{e_{12}, e_{31}, e_{41}\right\},\left\{e_{12}, e_{21}, e_{41}\right\}\right.$, $\left\{e_{13}, e_{31}, e_{41}\right\},\left\{e_{13}, e_{21}, e_{41}\right\},\left\{e_{21}, e_{31}, e_{42}\right\},\left\{e_{11}, e_{31}, e_{42}\right\},\left\{e_{11}, e_{21}, e_{42}\right\},\left\{e_{12}, e_{31}, e_{42}\right\}$, $\left.\left\{e_{12}, e_{21}, e_{42}\right\},\left\{e_{13}, e_{31}, e_{42}\right\},\left\{e_{13}, e_{21}, e_{42}\right\}\right\}$.
By definition, $f_{i}$ is the number of subsets of $E$ with $i+1$ elements not containing cycle and multiple edges. Since, $\left\{e_{11}\right\},\left\{e_{12}\right\},\left\{e_{13}\right\},\left\{e_{21}\right\},\left\{e_{31}\right\},\left\{e_{41}\right\}$ and $\left\{e_{42}\right\}$ are subsets of $E$ containing one element. It implies that $f_{0}=7$. There are $\left\{e_{11}, e_{21}\right\},\left\{e_{11}, e_{31}\right\},\left\{e_{11}, e_{41}\right\},\left\{e_{11}, e_{42}\right\},\left\{e_{12}, e_{21}\right\},\left\{e_{12}, e_{31}\right\},\left\{e_{12}, e_{41}\right\}$, $\left\{e_{12}, e_{42}\right\},\left\{e_{13}, e_{21}\right\},\left\{e_{13}, e_{31}\right\},\left\{e_{13}, e_{41}\right\},\left\{e_{13}, e_{42}\right\},\left\{e_{21}, e_{31}\right\},\left\{e_{21}, e_{41}\right\},\left\{e_{21}, e_{42}\right\}$, $\left\{e_{31}, e_{41}\right\},\left\{e_{31}, e_{42}\right\}$ subsets of $E$ containing two elements but not containing cycle and multiple edges. So, $f_{1}=17$. We know that the spanning trees of $\mathcal{U}_{7,3}^{2}$ are 2 -dimensional facets of the spanning simplicial complex $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$. Therefore, $f_{2}=14$. Thus,

$$
\chi\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right)=f_{0}-f_{1}+f_{2}=7-17+14=4
$$

Now, we compute the Euler characteristic of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$ by using Theorem 3.3. We observe that, $n=7, r^{\prime}=1, r^{\prime \prime}=1, r=2, m=3, \alpha=3, \beta=2$ and $0 \leq i \leq d$, where $d=n-\alpha-\beta+r-2=2$ is the dimension of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$.
By substituting these values in Theorem 3.3, we get
$f_{i}=\binom{7}{i+1}-3\left[\binom{2}{i+1-3}-\binom{2}{2}\binom{0}{i+1-5}\right]-\left[\binom{5}{2}-\binom{3}{1}\binom{2}{1}\right]\left(\binom{3}{0}\binom{5}{i+1-2}-\binom{3}{1}\binom{4}{i+1-3}+\right.$ $\left.\binom{3}{2}\binom{3}{i+1-4}-\binom{3}{3}\binom{2}{i+1-4}\right)-\binom{5}{3}\left(\binom{2}{0}\binom{4}{i+1-3}-\binom{2}{1}\binom{3}{i+1-4}+\binom{2}{2}\binom{2}{i+1-5}\right)-$
$\binom{5}{4}\left(\binom{1}{0}\binom{3}{i+1-4}-\binom{1}{1}\binom{2}{i+1-5}\right)-\binom{5}{5}\binom{2}{i+1-5}$.
Alternatively, we compute $\left(f_{0}, f_{1}, f_{2}\right)=(7,17,14)$ and $\chi\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right)=4$.
We compute now the Betti numbers of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$. The facet ideal of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$ is given by
$I_{\mathcal{F}}\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right)=\left\langle x_{F_{21,31,41}}, x_{F_{11,31,41}}, x_{F_{11,21,41}}, x_{F_{12,31,41}}, x_{F_{12,21,41}}, x_{F_{13,31,41}}, x_{F_{13,21,41}}\right.$, $\left.x_{F_{21,31,42}}, x_{F_{11,31,42}}, x_{F_{11,21,42}}, x_{F_{12,31,42}}, x_{F_{12,21,42}}, x_{F_{13,31,42}}, x_{F_{13,21,42}}\right\rangle$.
We consider the chain complex of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$

$$
0 \xrightarrow[\rightarrow]{\partial_{3}} C_{2} \xrightarrow[\rightarrow]{\partial_{2}} C_{1} \xrightarrow[\rightarrow]{\partial_{7}} C_{0} \xrightarrow{\partial_{0}} 0
$$

The homology groups are given by $H_{i}=\frac{\operatorname{Ker}\left(\partial_{i}\right)}{\operatorname{Im}\left(\partial_{i+1}\right)}$ with $i=0,1,2$.
Therefore, the $i$-th Betti number of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$ is given by

$$
\beta_{i}=\operatorname{rank}\left(H_{i}\right)=\operatorname{rank}\left(\operatorname{Ker}\left(\partial_{i}\right)\right)-\operatorname{rank}\left(\operatorname{Im}\left(\partial_{i+1}\right)\right) \text { with } \mathrm{i}=0,1,2 .
$$

Now, we compute rank and nullity of the matrix $\partial_{i}$ of order $f_{i} \times f_{i+1}$ with $i=0,1,2$.
The boundary homomorphism $\partial_{2}: C_{2}\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right) \rightarrow C_{1}\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right)$ can be expressed as
$\partial_{2}\left(F_{21,31,41}\right)=F_{31,41}-F_{21,41}+F_{21,31} ; \partial_{2}\left(F_{11,31,41}\right)=F_{31,41}-F_{11,41}+F_{11,31} ;$
$\partial_{2}\left(F_{11,21,41}\right)=F_{21,41}-F_{11,41}+F_{11,21} ; \partial_{2}\left(F_{12,31,41}\right)=F_{31,41}-F_{12,41}+F_{12,31} ;$
$\partial_{2}\left(F_{12,21,41}\right)=F_{21,41}-F_{12,41}+F_{12,21} ; \partial_{2}\left(F_{13,31,41}\right)=F_{31,41}-F_{13,41}+F_{13,31} ;$
$\partial_{2}\left(F_{13,21,41}\right)=F_{21,41}-F_{13,41}+F_{13,21} ; \partial_{2}\left(F_{21,31,42}\right)=F_{31,42}-F_{21,42}+F_{21,31} ;$
$\partial_{2}\left(F_{11,31,42}\right)=F_{31,42}-F_{11,42}+F_{11,31} ; \partial_{2}\left(F_{11,21,42}\right)=F_{21,42}-F_{11,42}+F_{11,21} ;$
$\partial_{2}\left(F_{12,31,42}\right)=F_{31,42}-F_{12,42}+F_{12,31} ; \partial_{2}\left(F_{12,21,42}\right)=F_{21,42}-F_{12,42}+F_{12,21} ;$
$\partial_{2}\left(F_{13,31,42}\right)=F_{31,42}-F_{13,42}+F_{13,31} ; \partial_{2}\left(F_{13,21,42}\right)=F_{21,42}-F_{13,42}+F_{13,21}$.
The boundary homomorphism $\partial_{1}: C_{1}\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right) \rightarrow C_{0}\left(\Delta_{s}\left(\mathcal{U M}_{7,3}^{2}\right)\right)$ can be written as
$\partial_{1}\left(F_{11,21}\right)=e_{21}-e_{11} ; \partial_{1}\left(F_{11,31}\right)=e_{31}-e_{11} ; \partial_{1}\left(F_{11,41}\right)=e_{41}-e_{11} ; \partial_{1}\left(F_{11,42}\right)=$ $e_{42}-e_{11} ; \partial_{1}\left(F_{12,21}\right)=e_{21}-e_{12} ; \partial_{1}\left(F_{12,31}\right)=e_{31}-e_{12} ; \partial_{1}\left(F_{12,41}\right)=e_{41}-e_{12} ;$ $\partial_{1}\left(F_{12,42}\right)=e_{42}-e_{12} ; \partial_{1}\left(F_{13,21}\right)=e_{21}-e_{13} ; \partial_{1}\left(F_{13,31}\right)=e_{31}-e_{13} ; \partial_{1}\left(F_{13,41}\right)=$ $e_{41}-e_{13} ; \partial_{1}\left(F_{13,42}\right)=e_{42}-e_{13} ; \partial_{1}\left(F_{21,31}\right)=e_{31}-e_{21} ; \partial_{1}\left(F_{21,41}\right)=e_{41}-e_{21} ;$ $\partial_{1}\left(F_{21,42}\right)=e_{42}-e_{21} ; \partial_{1}\left(F_{31,41}\right)=e_{41}-e_{31} ; \partial_{1}\left(F_{31,42}\right)=e_{42}-e_{31}$.
Then, by using MATLAB, we compute rank of $\partial_{2}=11$; nullity of $\partial_{2}=3$; rank of $\partial_{1}=6$; nullity of $\partial_{1}=11$.
Therefore, the Betti numbers are given by $\beta_{0}=\operatorname{rank}\left(\operatorname{Ker}\left(\partial_{0}\right)\right)-\operatorname{rank}\left(\operatorname{Im}\left(\partial_{1}\right)\right)=$ $7-6=1 ; \beta_{1}=\operatorname{rank}\left(\operatorname{Ker}\left(\partial_{1}\right)\right)-\operatorname{rank}\left(\operatorname{Im}\left(\partial_{2}\right)\right)=11-11=0 ; \beta_{2}=$ $\operatorname{rank}\left(\operatorname{Ker}\left(\partial_{2}\right)\right)-\operatorname{rank}\left(\operatorname{Im}\left(\partial_{3}\right)\right)=3-0=3$.
Alternatively, the Euler characteristic of $\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)$ is given by

$$
\chi\left(\Delta_{s}\left(\mathcal{U}_{7,3}^{2}\right)\right)=\beta_{0}-\beta_{1}+\beta_{2}=1-0+3=4 .
$$
