# GALOIS GROUPS OF SOME ITERATED POLYNOMIALS OVER CYCLOTOMIC EXTENSIONS

#### Abstract

$\operatorname{AbStract}$. Let $\varphi_{p}(z)=(z-1)^{p}+2-\zeta_{p}$, where $\zeta_{p} \in \overline{\mathbb{Q}}$ is a primitive $p$-th root of unity for some odd prime $p$. Building on previous work, we show that the $n$-th iterate $\varphi_{p}^{n}(z)$ has Galois group $\left[C_{p}\right]^{n}$, an iterated wreath product of cyclic groups, whenever $p$ is not a Wieferich prime.


The study of Galois groups of iterates of rational functions has gained much interest in recent years; see, for instance, $[2,3,4,8]$. However, there are very few explicit examples known when the degree of the map is at least three. In this note, we build upon recent work in [1] and prove the following:

Theorem 1. Let $p$ be an odd prime, let $\zeta_{p}$ be a primitive pth root of unity, and let

$$
\varphi_{p}(z)=(z-1)^{p}+2-\zeta_{p} .
$$

If $p$ is not $a$ Wieferich prime, i.e. $2^{p-1} \not \equiv 1\left(\bmod p^{2}\right)$, then

$$
\operatorname{Gal}_{\mathbb{Q}\left(\zeta_{p}\right)}\left(\varphi^{n}\right)=\left[C_{p}\right]^{n} \text { for all } n \geq 1
$$

Remark 1. The only known Wieferich primes are 1093 and 3511. Moreover, there are at least $O(\log X)$ non-Wieferich primes less than $X$, assuming the abc-conjecture [7].

To see how the Galois group of $\varphi_{p}^{n}$, the $n$-th iterate of $\varphi_{p}$, naturally sits inside $\left[C_{p}\right]^{n}$, see [5, Lemma 3.3]. The key new fact in this note, which does not appear in [1], is the following norm calculation:

Lemma 2. Let $p$ be an odd prime, let $\zeta_{p}$ be a primitive pth root of unity, and let

$$
\varphi_{p}(z)=(z-1)^{p}+2-\zeta_{p} .
$$

If $\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}: \mathbb{Q}\left(\zeta_{p}\right) \rightarrow \mathbb{Q}$ denotes the absolute norm, then

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{n}(1)\right) \equiv 2^{p}-1\left(\bmod p^{2}\right) \text { for all } n \geq 1
$$

Proof. We fix some notation. Let $G_{p}=\operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}\right) \cong \mathbb{Z} /(p-1) \mathbb{Z}$ and let $\mathfrak{p}$ be the principal ideal generated by $1-\zeta_{p}$ in $\mathbb{Z}\left[\zeta_{p}\right]$. It is well known that $\mathfrak{p} \cap \mathbb{Z}=p \mathbb{Z}$ is the unique prime lying over $p$ and that $p \mathbb{Z}\left[\zeta_{p}\right]=\mathfrak{p}^{p-1}$ is totally ramified. These and other standard facts regarding cyclotomic fields can be found in $[6, \S 2.9]$.

From here, Lemma 2 then follows from a more general fact:

$$
x \equiv 1(\bmod \mathfrak{p}) \text { implies } \mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}(x)\right) \equiv 2^{p}-1\left(\bmod p^{2}\right) .
$$

To see this, note that if $x \equiv 1(\bmod \mathfrak{p})$, then $(x-1)^{p}$ is in the ideal $p \cdot \mathfrak{p}$, which is Galois invariant. Hence, for any $\sigma \in \operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}\right)$ there exists $b_{\sigma} \in \mathbb{Z}\left[\zeta_{p}\right]$ such that

$$
\sigma\left((x-1)^{p}\right):=y_{\sigma}=p \cdot\left(1-\zeta_{p}\right) \cdot b_{\sigma} .
$$

Writing $a_{\sigma}=\sigma\left(2-\zeta_{p}\right)$ for $\sigma \in \operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}\right)$, we see that

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}(x)\right)=\prod_{\sigma \in G_{p}}\left(y_{\sigma}+a_{\sigma}\right) .
$$

However, expanding out this product of sums, we see that

$$
\begin{aligned}
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}(x)\right) & \equiv \sum_{\sigma \in G_{p}} y_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)+\prod_{\sigma \in G_{p}} a_{\sigma} \\
& \equiv \sum_{\sigma \in G_{p}} y_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)+N_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}(2-\zeta)\left(\bmod p^{2}\right)
\end{aligned}
$$

since any term containing more than a single $y_{\sigma}$, each of which is already divisible by $p$, must vanish $\left(\bmod p^{2}\right)$. On the other hand, substituting the relation $y_{\sigma}=p \cdot\left(1-\zeta_{p}\right) \cdot b_{\sigma}$, we see that

$$
\sum_{\sigma \in G_{p}} y_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)=p \cdot\left[\left(1-\zeta_{p}\right)\left(\sum_{\sigma \in G_{p}} b_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)\right)\right] .
$$

In particular,

$$
\begin{equation*}
\left(1-\zeta_{p}\right)\left(\sum_{\sigma \in G_{p}} b_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)\right) \tag{1}
\end{equation*}
$$

is an element of $\mathfrak{p}$. Conversely,

$$
\left(1-\zeta_{p}\right)\left(\sum_{\sigma \in G_{p}} b_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)\right)=\frac{1}{p} \sum_{\sigma \in G_{p}} y_{\sigma} \cdot\left(\prod_{\tau \neq \sigma} a_{\tau}\right)
$$

is Galois invariant. Hence, (1) is in $\mathfrak{p} \cap \mathbb{Z}=p \mathbb{Z}$. Therefore, the sum of the terms containing a single $y_{\sigma}$ must also vanish $\left(\bmod p^{2}\right)$, and we deduce that

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}(x)\right) \equiv \mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(2-\zeta_{p}\right)\left(\bmod p^{2}\right)
$$

However, if $\Phi_{p}(z)=z^{p-1}+z^{p-2}+\ldots z+1$ denotes the $p$ th cyclotomic polynomial, then

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(2-\zeta_{p}\right)=\prod_{\sigma \in G_{p}}\left(2-\sigma\left(\zeta_{p}\right)\right)=\Phi_{p}(2)=2^{p-1}+2^{p-1}+\cdots+2+1=2^{p}-1,
$$

which completes the proof of Lemma 2.
We now use a slight generalization of [2, Theorem 25]; for more details, see [1, §2].
Lemma 3. Let $p$ be an odd prime, let $\zeta_{p}$ be a primitive pth root of unity, and let

$$
\varphi_{p}(z)=(z-1)^{p}+2-\zeta_{p}
$$

Fix $n \geq 1$. If for all $1 \leq m \leq n$ there exists a prime ideal $\mathfrak{q}_{m} \subset \mathbb{Z}\left[\zeta_{p}\right]$ such that

$$
v_{\mathfrak{q}_{m}}\left(\varphi_{p}^{m}(1)\right) \not \equiv 0(\bmod p),
$$

then $\operatorname{Gal}_{\mathbb{Q}\left(\zeta_{p}\right)}\left(\varphi^{n}\right)=\left[C_{p}\right]^{n}$.

Proof. Note first that $\varphi_{p}^{n}(z)$ is Eisenstein at $\mathfrak{p}$ : the constant term of $\varphi_{p}^{n}(z)$ is $1-\zeta_{p}$, and all intermediate terms are divisible by $p$ (and hence divisible by $\mathfrak{p}$ also). In particular, $\varphi_{p}^{n}(z)$ is irreducible over $\mathbb{Q}\left(\zeta_{p}\right)$ for all $n \geq 1$.

Furthermore, note that the principal ideals in $\mathbb{Z}\left[\zeta_{p}\right]$ generated by $\varphi_{p}^{n}(1)$ and $\varphi_{p}^{m}(1)$ are coprime for all $n \neq m$ : if $\varphi_{p}^{n}(1) \in \mathfrak{q}$ and $\varphi_{p}^{m}(1) \in \mathfrak{q}$ for some prime ideal $\mathfrak{q} \subset \mathbb{Z}\left[\zeta_{p}\right]$ and some $n>m$, then $\varphi_{p}^{n-m}(0) \in \mathfrak{q}$ :

$$
\varphi_{p}^{n-m}(0) \equiv \varphi_{p}^{n-m}\left(\varphi_{p}^{m}(1)\right) \equiv \varphi_{p}^{n}(1) \equiv 0(\bmod \mathfrak{q})
$$

However, $\varphi_{p}^{s}(0)=1-\zeta_{p}$ for all $s \geq 1$, so that $\mathfrak{q}=\mathfrak{p}$. On the other hand, it is easy to check that $\varphi_{p}^{t}(1) \equiv 1(\bmod \mathfrak{p})$ for all $t \geq 0$, contradicting our assumption that $\varphi_{p}^{n}(1) \in \mathfrak{q}$ (or that $\left.\varphi_{p}^{m}(1) \in \mathfrak{q}\right)$.

In particular, Lemma 3 follows immediately from [2, Theorem 4.3], whose statement and proof can be translated verbatim to unicritical polynomials, i.e., polynomials of the form $f(z)=(z-\gamma)^{d}+c$; see $[1, \S 2]$.

Finally, we note the following characterization of Wieferich primes:
Lemma 4. Let $p$ be an odd prime. Then $p$ is Wieferich if and only if $2^{p}-1$ is a $p$-th power $\left(\bmod p^{2}\right)$.

Proof. If $p$ is Wieferich, i.e. $2^{p-1} \equiv 1\left(\bmod p^{2}\right)$, then $2^{p}-1 \equiv 1\left(\bmod p^{2}\right)$ is a $p$-th power modulo $p^{2}$. On the other hand, suppose that $2^{p}-1 \equiv x^{p}\left(\bmod p^{2}\right)$. Reducing modulo $p$, we see that $x \equiv 1(\bmod p)$. Write $x \equiv 1+t p\left(\bmod p^{2}\right)$ for some $t \in\{0,1, \ldots, p-1\}$. Then

$$
x^{p}=1+p^{2} t+\sum_{i=2}^{p}\binom{p}{i}(t p)^{i} \equiv 1\left(\bmod p^{2}\right) .
$$

Hence, $2^{p}-1 \equiv 1\left(\bmod p^{2}\right)$, from which it follows that $2^{p-1} \equiv 1\left(\bmod p^{2}\right)$.
We now use these auxiliary facts to prove our main result.
(Proof of Theorem 1). Suppose that $\operatorname{Gal}_{\mathbb{Q}\left(\zeta_{p}\right)}\left(\varphi^{n}\right) \neq\left[C_{p}\right]^{n}$ for some iterate $n \geq 1$. Then Lemma 3 implies that there exists some $m \leq n$, such that:

$$
\begin{equation*}
v_{\mathfrak{q}}\left(\varphi_{p}^{m}(1)\right) \equiv 0(\bmod p), \quad \text { for all primes } \mathfrak{q} \subset \mathbb{Z}\left[\zeta_{p}\right] \tag{2}
\end{equation*}
$$

Note first that $\varphi_{p}^{m}(1)$ cannot be a unit:

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right) \equiv 2^{p}-1 \not \equiv \pm 1\left(\bmod p^{2}\right)
$$

by Lemma 2, Lemma 4, and the fact that $p$ is not a Wieferich prime. From here, (2) implies the ideal equation:

$$
\varphi_{p}^{m}(1) \cdot \mathbb{Z}\left[\zeta_{p}\right]=\prod_{i=1}^{s} \mathfrak{q}_{i}^{e_{i}}=\prod_{i=1}^{s} \mathfrak{q}_{i}^{p \cdot r_{i}}=\left(\prod_{i=1}^{s} \mathfrak{q}_{i}^{r_{i}}\right)^{p}=(I)^{p} ;
$$

here the $\mathfrak{q}_{i}$ are prime ideals and $I=\prod \mathfrak{q}_{i}^{r_{i}}$. We now take the ideal norm [6, §3.5] of the equation above and obtain

$$
\left|\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right)\right|=\mathrm{N}\left(\varphi_{p}^{m}(1) \cdot \mathbb{Z}\left[\zeta_{p}\right]\right)=\mathrm{N}(I)^{p} .
$$

In particular, $\left|\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right)\right|= \pm \mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right)$ is a $p$ th power. However, note that the $\pm$ is irrelevant: since $p$ is odd, the -1 can be absorbed into the $p$ th power (if needed). Therefore, we deduce that

$$
\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right)=y^{p}, \quad \text { for some } y \in \mathbb{Z}
$$

However, reducing this equation $\left(\bmod p^{2}\right)$, we see that $\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right) \equiv y^{p}\left(\bmod p^{2}\right)$, a contradiction of Lemma 2, Lemma 4, and the fact that $p$ is not a Wieferich prime.

Although our proof breaks down, it is likely that the Galois groups of iterates of $\varphi_{p}$ are still as large as possible when $p$ is a Wieferich prime: otherwise, $\mathrm{N}_{\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}}\left(\varphi_{p}^{m}(1)\right)$ is a $p$ th power (in $\mathbb{Z}$, not just in $\mathbb{Z} / p^{2} \mathbb{Z}$ ) for some $m \geq 1$, which is doubtful. With this in mind, we make the following conjecture.

Conjecture 5. Let $p$ be an odd prime and let $\varphi_{p}(z)=(z-1)^{p}+2-\zeta_{p}$ be as above. Then $\operatorname{Gal}_{\mathbb{Q}\left(\zeta_{p}\right)}\left(\varphi_{p}^{n}\right)=\left[C_{p}\right]^{n}$ for all $n \geq 1$;
