A COMPARISON THEOREM FOR MW-MOTIVIC COHOMOLOGY

ABSTRACT. Let k be an infinite perfect field. We prove that $H^{n,n}_{\mathrm{MW}}(\mathrm{Spec}(L),\mathbb{Z}) = K^{\mathrm{MW}}_n(L)$ for any finitely generated field extension L/k and any $n \in \mathbb{Z}$.

Introduction

This paper is the fourth of a series of papers ([1], [2] and [4]) devoted to the study of MW-motivic cohomology, which is a generalization of ordinary motivic cohomology. Our main purpose here is to compute the MW-motivic cohomology group of a field in bidegree (n, n), namely the group $H^{n,n}_{MW}(L, \mathbb{Z})$. In [2, Theorem 4.2.3], we defined a graded ring homomorphism

$$\Phi: \mathbf{K}^{\mathrm{MW}}_* \to \bigoplus_{n \in \mathbb{Z}} \mathbf{H}^{n,n}_{\mathrm{MW}}$$

where the left-hand side is the unramified Milnor-Witt K-theory sheaf constructed in $[7, \S 3]$ and the right-hand side is the Nisnevich sheaf associated to the presheaf $U \mapsto \mathrm{H}^{n,n}_{\mathrm{MW}}(U,\mathbb{Z})$. The homomorphism Φ is obtained via a morphism of sheaves $\mathbb{G}_m^{\wedge n} \to \mathbf{H}^{n,n}_{\mathrm{MW}}$ and the right-hand side has the property to be strictly \mathbb{A}^1 -invariant $[2, \mathrm{Proposition}\ 1.2.11$, Theorem 3.2.9]. It follows that Φ is then the universal morphism described in $[7, \mathrm{Theorem}\ 3.37]$. In this article, we prove that Φ is an isomorphism. This can be checked on finitely generated field extensions of the base field k ($[7, \mathrm{Theorem}\ 1.12]$) and thus our main theorem takes the following form.

Theorem. Let L/k be a finitely generated field extension with $char(k) \neq 2$. Then, the homomorphism of graded rings

$$\Phi_L: \bigoplus_{n\in\mathbb{Z}} \mathrm{K}_n^{\mathrm{MW}}(L) \to \bigoplus_{n\in\mathbb{Z}} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z}).$$

is an isomorphism.

The isomorphism in the theorem generalizes the result on (ordinary) motivic cohomology in the sense that the diagram commutes

$$\bigoplus_{n\in\mathbb{Z}} \mathrm{K}_n^{\mathrm{MW}}(L) \xrightarrow{\Phi_L} \bigoplus_{n\in\mathbb{Z}} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$\bigoplus_{n\in\mathbb{N}} \mathrm{K}_n^{\mathrm{M}}(L) \xrightarrow{} \bigoplus_{n\in\mathbb{N}} \mathrm{H}^{n,n}(L,\mathbb{Z})$$

where the vertical homomorphisms are the "forgetful" homomorphisms and the bottom map is the isomorphism produced by Nesterenko-Suslin-Totaro. Unsurprisingly, our proof is very similar to theirs but there are some essential differences. For instance, the complex in weight one, denoted by $\tilde{\mathbb{Z}}(1)$, admits an epimorphism to \mathbf{K}_1^{MW} paralleling the epimorphism $\mathbb{Z}(1) \to \mathbf{K}_1^{\text{M}}$. However, we are not able to prove directly that the kernel of the epimorphism $\tilde{\mathbb{Z}}(1) \to \mathbf{K}_1^{\text{MW}}$ is acyclic. We are thus forced to compute by hand its cohomology at the right spot in Proposition 2.6. This result being obtained, we then prove that Φ respects transfers for finitely generated field extensions. This is obtained in Theorem 2.8 using arguments essentially identical to [6, Lemma 5.11] or [8, Lemma 9.5].

The paper is organized as follows. In Section 1, we review the basics of MW-motivic cohomology needed in the paper, adding useful results. For instance, we prove a projection formula in Theorem 1.4 which is interesting on its own. In Section 2, we proceed with the proof of our main theorem, starting with the construction to a left inverse of Φ . We then pass to the proof that Φ is an isomorphism in degree 1, which is maybe the most technical result of this work. As already mentioned above, we then conclude with the proof that Φ respects transfers, obtaining as a corollary our main result.

Conventions. The schemes are separated of finite type over some perfect field k with $\operatorname{char}(k) \neq 2$. If X is a smooth connected scheme over k, we denote by $\Omega_{X/k}$ the sheaf of differentials of X over $\operatorname{Spec}(k)$ and write $\omega_{X/k} := \det \Omega_{X/k}$ for its canonical sheaf. In general we define $\omega_{X/k}$ connected component by connected component. We use the same notation if X is the localization of a smooth scheme at any point. If k is clear from the context, we omit it from the notation. If k is a morphism of (localizations of) smooth schemes, we set k0 is a scheme and k1 is a scheme and k2. If k3 is a scheme and k3 is a scheme and k4 is denote by k5.

1. MW-motivic cohomology

The general framework of this article is the category of finite MW-correspondences as defined in [1, §4]. We briefly recall the construction of this category for the reader's convenience. If X and Y are smooth connected schemes over k, we say that a closed subset $T \subset X \times Y$ is admissible if its irreducible components (endowed with their reduced structure) are finite and surjective over X. The set A(X,Y) of

admissible subsets of $X \times Y$ can be ordered by inclusions, and we can consider it as a category. For any $T \in \mathcal{A}(X,Y)$, we can consider the Chow-Witt group

$$\widetilde{\operatorname{CH}}_T^{d_Y}(X \times Y, \omega_Y)$$

where d_Y is the dimension of Y and $\omega_Y = p_Y^* \omega_{Y/k}$ with $p_Y : X \times Y \to Y$ the projection. If $T \subset T'$ for two admissible subsets, then we consider the extension of support homomorphism

$$\widetilde{\operatorname{CH}}_{T}^{d_{Y}}(X \times Y, \omega_{Y}) \to \widetilde{\operatorname{CH}}_{T'}^{d_{Y}}(X \times Y, \omega_{Y})$$

and set $\widetilde{\operatorname{Cor}}_k(X,Y) = \lim_{T \in \mathcal{A}(X,Y)} \widetilde{\operatorname{CH}}_T^{d_Y}(X \times Y, \omega_Y)$. The composition of finite MW-correspondences is obtained using the product of cycles in Chow-Witt groups with supports ([1, §4.2]) and we obtain the category $\widetilde{\operatorname{Cor}}_k$ whose objects are smooth schemes and morphisms are $\widetilde{\operatorname{Cor}}_k(X,Y)$. The exterior product endows $\widetilde{\operatorname{Cor}}_k$ with the structure of a symmetric monoidal category.

Having this category at hand, we may define the category of MW-presheaves $\widetilde{\mathrm{PSh}}_k$ as the category of additive functors $\widetilde{\mathrm{Cor}}_k \to \mathrm{Ab}$. For any smooth scheme X, we can define the presheaf $\widetilde{\mathrm{c}}(X)$ by $Y \mapsto \widetilde{\mathrm{Cor}}_k(Y,X)$ for any Y and thus obtain the Yoneda embedding functor $\widetilde{\mathrm{c}}(_): \widetilde{\mathrm{Cor}}_k \to \widetilde{\mathrm{PSh}}_k$. The category $\widetilde{\mathrm{PSh}}_k$ is a symmetric monoidal category, with tensor product \otimes uniquely defined by the property that the Yoneda embedding is monoidal, i.e. we have $\widetilde{\mathrm{c}}(X) \otimes \widetilde{\mathrm{c}}(Y) = \widetilde{\mathrm{c}}(X \times Y)$. One can also define an internal Hom functor $\underline{\mathrm{Hom}}$ which is characterized by the property that $\underline{\mathrm{Hom}}(\widetilde{\mathrm{c}}(X),F) = F(X \times _)$ for any $F \in \widetilde{\mathrm{PSh}}_k$.

Recall next that we have a functor $\tilde{\gamma}: \mathrm{Sm}_k \to \mathrm{Cor}_k$ which is the identity on objects and associates to a morphism of schemes the finite MW-correspondence described in [1, §4.3] (which is basically the graph). This yields a functor $\tilde{\gamma}_*: \mathrm{PSh}_k \to \mathrm{PSh}_k$ where the latter is the category of presheaves (of abelian groups) on Sm_k . As usual, we say that a presheaf with MW-transfer F is a sheaf in a topology τ , and we write that F is a τ -sheaf with MW-transfers, if $\tilde{\gamma}_*(F)$ is a sheaf in this topology. Usually, we consider either the Zariski or the Nisnevich topology on Sm_k . Interestingly, the representable presheaves $\tilde{c}(X)$ are Zariski sheaves with MW-transfers ([1, Proposition 5.11]) but not Nisnevich sheaves with transfers ([1, Example 5.12]). However, one can show that the sheaf associated to $F \in \mathrm{PSh}_k$ can be endowed with a (unique) structure of a sheaf with MW-transfers ([2, Proposition 1.2.11]). Note that it is easy to check that if F is a τ -sheaf with MW-transfers, then $\mathrm{Hom}(\tilde{c}(X),F)$ is also a τ -sheaf with MW-transfers.

1.1. Motivic cohomology. Let $\tilde{\mathbb{Z}}\{1\}$ be the Zariski sheaf with MW-transfers which is the cokernel of the morphism

$$\tilde{\mathbf{c}}(k) \to \tilde{\mathbf{c}}(\mathbb{G}_{m,k})$$

induced by the unit in $\mathbb{G}_{m,k}$. For any $q \in \mathbb{Z}$, we consider next the Zariski sheaf with MW-transfer $\tilde{\mathbb{Z}}\{q\}$ defined by

$$\tilde{\mathbb{Z}}\{q\} = \begin{cases} \tilde{\mathbb{Z}}\{1\}^{\otimes q} & \text{if } q \ge 0.\\ \underline{\text{Hom}}(\tilde{\mathbb{Z}}\{1\}^{\otimes q}, \tilde{c}(k)) & \text{if } q < 0. \end{cases}$$

Let now Δ^{\bullet} be the cosimplicial object whose terms in degree n are

$$\Delta^n = \operatorname{Spec}(k[t_0, \dots, t_n]/(\sum t_i - 1))$$

and with usual face and degeneracy maps. For any presheaf $F \in \widetilde{PSh}_k$, we obtain a simplicial presheaf $\underline{\operatorname{Hom}}(\tilde{\operatorname{c}}(\Delta^{\bullet}), F)$ whose associated complex of presheaves with MW-transfers is denoted by $C^{\operatorname{sing}}_*(F)$. If F is further a τ -sheaf with MW-transfers, then $C^{\operatorname{sing}}_*F$ is a complex of sheaves with MW-transfers. In particular, $\widetilde{\mathbb{Z}}(q) := C^{\operatorname{sing}}_*\widetilde{\mathbb{Z}}\{q\}$ is such a complex and we have the following definition.

Definition 1.1. For any $p, q \in \mathbb{Z}$ and any smooth scheme X, we set

$$H^{p,q}_{MW}(X,\mathbb{Z}) = \mathbb{H}^p_{Zar}(X,\tilde{\mathbb{Z}}(q)).$$

Remark 1.2. In [2, §3.2.13, Definition 3.3.5], the motivic cohomology groups are defined using the complexes associated to the simplicial Nisnevich sheaves with MW-transfers constructed from the Nisnevich sheaves with transfers associated to the presheaves $\tilde{\mathbb{Z}}(q)$. The two definitions coincide by [4, Corollary 4.0.5].

The complexes $C_*^{sing}\tilde{\mathbb{Z}}(q)$ are in fact complexes of Zariski sheaves of $K_0^{MW}(k)$ -modules ([1, §5.3]), and it follows that the MW-motivic cohomology groups are indeed $K_0^{MW}(k)$ -modules. These modules are by construction contravariantly functorial in X. Moreover, for any $p,q\in\mathbb{Z}$, we have a homomorphism of $K_0^{MW}(k)$ -modules

$$\mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z}) \to \mathrm{H}^{p,q}(X,\mathbb{Z})$$

where the latter denotes the ordinary motivic cohomology group of X, with $H^{p,q}(X,\mathbb{Z}) = 0$ for q < 0 and the $K_0^{MW}(k)$ -module structure on the right-hand side is obtained via the rank homomorphism $K_0^{MW}(k) \to \mathbb{Z}$ ([1, §6.1]).

Even though MW-motivic cohomology is defined a priori only for smooth schemes, it is possible to extend the definition to limits of smooth schemes, following the usual procedure (described for instance in [1, §5.1]). In particular, we can consider MW-motivic cohomology groups $H^{p,q}_{MW}(L,\mathbb{Z})$ for any finitely generated field extension L/k. We will use this routinely in the sequel without further comments.

1.2. **The ring structure.** The definition of MW-motivic cohomology given in [2, Definition 3.3.5] immediately yields a (bigraded) ring structure on MW-motivic cohomology

$$\mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z}) \otimes \mathrm{H}^{p',q'}_{\mathrm{MW}}(X,\mathbb{Z}) \to \mathrm{H}^{p+p',q+q'}_{\mathrm{MW}}(X,\mathbb{Z})$$

fulfilling the following properties.

(1) The product is (bi-)graded commutative in the sense that

$$\mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z})\otimes\mathrm{H}^{p',q'}_{\mathrm{MW}}(X,\mathbb{Z})\to\mathrm{H}^{p+p',q+q'}_{\mathrm{MW}}(X,\mathbb{Z})$$

is $(-1)^{pp'}\langle (-1)^{qq'}\rangle$ -commutative. In particular, $\mathrm{H}^{0,0}_{\mathrm{MW}}(X,\mathbb{Z})$ is central and the $\mathrm{K}^{\mathrm{MW}}_{0}(k)$ -module structure is obtained via the ring homomorphism

$$\mathrm{K}_0^{\mathrm{MW}}(k) = \mathrm{H}_{\mathrm{MW}}^{0,0}(k,\mathbb{Z}) \to \mathrm{H}_{\mathrm{MW}}^{0,0}(X,\mathbb{Z}).$$

(2) The homomorphism $\mathrm{H}^{*,*}_{\mathrm{MW}}(X,\mathbb{Z}) \to \mathrm{H}^{*,*}(X,\mathbb{Z})$ is a graded ring homomorphism.

1.3. A projection formula. In this section, we prove a projection formula for finite surjective morphisms having trivial relative bundles. Let then $f: X \to Y$ be a finite surjective morphism between smooth connected schemes, and let $\chi: \mathcal{O}_X \to \omega_f = \omega_{X/k} \otimes f^* \omega_{Y/k}^{\vee}$ be a fixed isomorphism. Recall from [1, Example 4.17] that we have then a finite MW-correspondence $\alpha := \alpha(f, \chi): Y \to X$ defined as the composite

$$\mathbf{K}_0^{\mathrm{MW}}(X) \simeq \mathbf{K}_0^{\mathrm{MW}}(X, \omega_f) \overset{f_*}{\to} \widetilde{\mathrm{CH}}_{\Gamma(X)}^{d_X}(Y \times X, \omega_{Y \times X/k} \otimes \omega_{Y/k}^{\vee}) \simeq \widetilde{\mathrm{CH}}_{\Gamma(X)}^{d_X}(Y \times X, \omega_X)$$

where the first isomorphism is induced by χ , the second homomorphism is the push-forward along the (transpose of the) graph $\Gamma_f: X \to Y \times X$ and the third isomorphism is deduced from the isomorphisms of line bundles

$$\omega_{Y\times X/k}\otimes\omega_{Y/k}^{\vee}\simeq\omega_Y\otimes\omega_X\otimes\omega_{Y/k}^{\vee}\simeq\omega_X\otimes\omega_Y\otimes\omega_{Y/k}^{\vee}\simeq\omega_X$$

where the second isomorphism is $(-1)^{d_X d_Y}$ -times the switch isomorphism.

We observe that α induces a "push-forward" homomorphism $F(X) \to F(Y)$ for any $F \in \widetilde{\mathrm{PSh}}_k$ through the composite

$$F(X) = \operatorname{Hom}_{\widetilde{\mathrm{PSh}}_k}(\widetilde{\mathbf{c}}(X), F) \overset{(_) \circ \alpha}{\to} \operatorname{Hom}_{\widetilde{\mathrm{PSh}}_k}(\widetilde{\mathbf{c}}(Y), F) = F(Y).$$

In particular, we obtain homomorphisms

$$f_*: \mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z}) \to \mathrm{H}^{p,q}_{\mathrm{MW}}(Y,\mathbb{Z})$$

for any $p, q \in \mathbb{Z}$, which depend on the choice of χ .

On the other hand, f induces a finite MW-correspondence $X\to Y$ that we still denote by f and therefore a pull-back homomorphism

$$f^*: \mathrm{H}^{p,q}_{\mathrm{MW}}(Y,\mathbb{Z}) \to \mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z}).$$

We will need the following lemma to prove the projection formula.

Lemma 1.3. Let $f: X \to Y$ be a finite surjective morphism between smooth connected schemes, and let $\chi: \mathcal{O}_X \to \omega_f$ be an isomorphism. Let Δ_X (resp. Δ_Y) be the diagonal embedding $X \to X \times X$ (resp. $Y \to Y \times Y$). Then, the following diagram commutes

$$Y \xrightarrow{\Delta_Y} Y \times Y \xrightarrow{(1 \times \alpha)} Y \times X$$


$$\parallel$$

$$Y \xrightarrow{\alpha} X \xrightarrow{\Delta_X} X \times X \xrightarrow{f \times 1} Y \times X,$$

i.e.
$$(1 \times \alpha)\Delta_Y = (f \times 1)\Delta_X\alpha$$
.

Proof. It suffices to compute both compositions, and we start with the top one. The composite of these two finite MW-correspondences is given by the commutative

diagram



where the squares are Cartesian and the non-labelled arrows are projections (vertically to the first factors and horizontally to the last factors). The composite is given by the push-forward along the projection $p: Y \times Y \times Y \times Y \times X \to Y \times Y \times X$ defined by $(y_1, y_2, y_3, y_4, x) \mapsto (y_1, y_4, x)$ of the product of the respective pull-backs to $Y \times Y \times Y \times Y \times X$ of $(\Gamma_{\Delta_Y})_*(\langle 1 \rangle)$ and $(\Gamma_{(1 \times f)}^t)_*(\langle 1 \rangle)$. Using the base change formula ([1, Proposition 3.2]), we see that it amounts to push-forward the product

$$(\Gamma_{\Delta_Y} \times 1 \times 1)_*(\langle 1 \rangle) \cdot (1 \times \Gamma^t_{(1 \times f)})_*(\langle 1 \rangle).$$

Using the projection formula for Chow-Witt groups with supports ([1, Corollary 3.5]), the latter equals

$$(\Gamma_{\Delta_Y} \times 1 \times 1)_*((\Gamma_{\Delta_Y} \times 1 \times 1)^*((1 \times \Gamma_{(1 \times f)}^t)_*(\langle 1 \rangle)))$$

and the base-change formula once again shows that we have to push-forward along p the cycle

$$(\Gamma_{\Delta_Y} \times 1 \times 1)_* (\Gamma^t_{(\Delta_Y \circ f)})_* (\langle 1 \rangle)$$

Finally, the equality $p \circ (\Gamma_{\Delta_Y} \times 1 \times 1) = \text{id}$ shows that the composite $(1 \times \alpha) \circ \Delta_Y$ is given by the correspondence $(\Gamma^t_{(\Delta_Y \circ f)})_*(\langle 1 \rangle)$.

For the second composite, we consider the following commutative diagram

$$X \xrightarrow{\Gamma_{f}^{t}} Y \times X \xrightarrow{X} X$$

$$\downarrow^{1 \times \Gamma_{((f \times 1)\Delta_{X})}} \downarrow^{\Gamma_{((f \times 1)\Delta_{X})}} \downarrow^{\Gamma_{((f \times 1)\Delta_{X})}}$$

$$X \times Y \times X \xrightarrow{\Gamma_{f}^{t} \times 1 \times 1} Y \times X \times Y \times X \xrightarrow{X} X \times Y \times X \xrightarrow{Y} X$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$X \xrightarrow{\Gamma_{f}^{t}} Y \times X \xrightarrow{Y} X \xrightarrow{Y} X$$

$$\downarrow \qquad \qquad \downarrow$$

where, as before, the squares are Cartesian and the non-labelled arrows are projections (vertically to the first factors and horizontally to the last factors). Arguing as above, we find that the composite is the push-forward along the projection $q: Y \times X \times Y \times X \to Y \times Y \times X$ omitting the second factor of the product

$$(\Gamma_f^t \times 1 \times 1)_*(\langle 1 \rangle) \cdot (1 \times \Gamma_{((f \times 1)\Delta_X)})_*(\langle 1 \rangle).$$

The projection and the base-change formulas show that the latter is equal to

$$(\Gamma_f^t \times 1 \times 1)_* (\Gamma_{((f \times 1)\Delta_X)})_* (\langle 1 \rangle)$$

whose push-forward along q is $(\Gamma^t_{(\Delta_V \circ f)})_*(\langle 1 \rangle)$ as

$$q(\Gamma_f^t \times 1 \times 1)(\Gamma_{((f \times 1)\Delta_X)}) = \Gamma_{(\Delta_Y \circ f)}^t.$$

Theorem 1.4 (Projection formula). Let $f: X \to Y$ be a finite surjective morphism between smooth connected schemes, and let $\chi: \mathcal{O}_X \to \omega_f$ be an isomorphism. For any $x \in H^{p,q}_{\mathrm{MW}}(X,\mathbb{Z})$ and $y \in H^{p',q'}_{\mathrm{MW}}(Y,\mathbb{Z})$, we have

$$y \cdot f_*(x) = f_*(f^*y \cdot x)$$

in $H^{p+p',q+q'}_{MW}(Y,\mathbb{Z})$.

Proof. Let $\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)$ be the category of MW-motives ([2, §3.2]). By [2, Corollary 3.3.8], we have $\mathrm{H}^{p,q}_{\mathrm{MW}}(X,\mathbb{Z}) = \mathrm{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X), \tilde{\mathbb{Z}}\{q\}[p-q])$ for any $p,q \in \mathbb{Z}$. The product structure on MW-motivic cohomology is obtained via the tensor product as follows. If x and x' are respectively in $\mathrm{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X), \tilde{\mathbb{Z}}\{q\}[p-q])$ and $\mathrm{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X), \tilde{\mathbb{Z}}\{q'\}[p'-q'])$, we can take their tensor product to get a morphism $x \otimes x'$ in $\mathrm{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X) \otimes \tilde{M}(X), \tilde{\mathbb{Z}}\{q\} \otimes \tilde{\mathbb{Z}}\{q'\}[p+p'-q-q'])$. Now, $\tilde{M}(X) \otimes \tilde{M}(X) = \tilde{M}(X \times X)$ and the diagonal morphism $\Delta_X : X \to X \times X$ induces a morphism $\tilde{M}(X) \to \tilde{M}(X \times X)$. Composing the latter with $x \otimes x'$, we obtain a morphism $x \cdot x' \in \mathrm{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X), \tilde{\mathbb{Z}}\{q\} \otimes \tilde{\mathbb{Z}}\{q'\}[p+p'-q-q'])$ which represent the product of x and x' (after identification of $\tilde{\mathbb{Z}}\{q\} \otimes \tilde{\mathbb{Z}}\{q'\}$ with $\tilde{\mathbb{Z}}\{q+q'\}$).

This being said, let then $x \in \operatorname{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(X), \tilde{\mathbb{Z}}\{q\}[p-q])$ and let $y \in \operatorname{Hom}_{\widetilde{\mathrm{DM}}^{\mathrm{eff}}(k)}(\tilde{M}(Y), \tilde{\mathbb{Z}}\{q'\}[p'-q'])$. The product $y \cdot f_*(x)$ is then of the form $(y \otimes x) \circ (1 \otimes \alpha) \circ \Delta_Y$, while $f_*(f^*y \cdot x)$ is of the form $(y \otimes x) \circ (f \otimes 1) \circ \Delta_X \circ \alpha$. The result then follows from Lemma 1.3.


Remark 1.5. It would suffice to have a fixed isomorphism $\mathcal{L} \otimes \mathcal{L} \simeq \omega_f$ (for some line bundle \mathcal{L} on X) to get an orientation in the sense of [1, §2.2] and thus a finite MW-correspondence α as above. We let the reader make the necessary modifications in the arguments of both Lemma 1.3 and Theorem 1.4.

Remark 1.6. It follows from [2, Theorem 3.4.3] that the same formula holds for the left module structure, i.e.

$$f_*(x) \cdot y = f_*(x \cdot f^*y).$$

Example 1.7. As usual, it follows from the projection formula that the composite f_*f^* is multiplication by $f_*(\langle 1 \rangle)$. Let us now compute f^*f_* in some situations that will be used later. Let us start with the general situation, i.e. $f: X \to Y$ is a finite surjective morphism and $\chi: \mathcal{O}_X \to \omega_f$ an isomorphism. The composite f^*f_* is given by precomposition with the correspondence $f \circ \alpha(f, \chi)$ which we can compute

using the diagram



where the non-labelled vertical arrows are projections on the first factor and the non-labelled horizontal arrows are projections on the second factor. As usual, the base change formula shows that the composite is equal to the projection on $X \times X$ of

$$(\Gamma_f \times 1)_*(\langle 1 \rangle) \cdot (1 \times \Gamma_f^t)_*(\langle 1 \rangle).$$

In general the top left square is not transverse, and we can't use the base-change formula to compute the above product.

Suppose now that $f: X \to Y$ is finite and étale. In that case, we have a canonical isomorphism $f^*\omega_Y \simeq \omega_X$ yielding a canonical choice for the isomorphism

$$\chi: \mathcal{O}_X \to \omega_f$$
.

Moreover, $X \times_Y X$ decomposes as $X \times_Y X = X_1 \sqcup X_2 \sqcup \ldots \sqcup X_n$ where each term X_i is finite and étale over X with "structural" morphism $p_i: X_i \to X$. In that case, the above top right square is transverse and we see that

$$(\Gamma_f \times 1)_*(\langle 1 \rangle) \cdot (1 \times \Gamma_f^t)_*(\langle 1 \rangle) = (\Gamma_f \times 1)_*(\Delta_* \sum (p_i)_*(\langle 1 \rangle)).$$

where $\Delta: X \to X \times X$ is the diagonal map. Thus the composite $f \circ \alpha(f, \chi)$ is equal to $\Delta_* \sum (p_i)_*(\langle 1 \rangle)$. It follows immediately that we have a commutative diagram

$$\begin{array}{c|c}
H_{\mathrm{MW}}^{p,q}(X,\mathbb{Z}) & \xrightarrow{\sum p_i^*} \bigoplus_i H_{\mathrm{MW}}^{p,q}(X_i,\mathbb{Z}) \\
f_* & & & \downarrow \sum (p_i)_* \\
H_{\mathrm{MW}}^{p,q}(Y,\mathbb{Z}) & \xrightarrow{f^*} & H_{\mathrm{MW}}^{p,q}(X,\mathbb{Z})
\end{array}$$

for any $p, q \in \mathbb{Z}$.

Suppose next that $\operatorname{char}(k) = p$, that $X \subset Y \times \mathbb{A}^1$ is the set of zeroes of $t^p - a$ for some global section $a \in \mathcal{O}_Y(Y)$ (we still suppose that X is smooth over k). In that case, we see that the reduced scheme of $X \times_Y X$ is just X (but the former has nilpotent elements) and it follows that $f \circ \alpha(f, \chi)$ is a correspondence supported on the diagonal $\Delta(X) \subset X \times X$. It follows that there is an element $\sigma \in K_0^{\mathrm{MW}}(X)$

such that the following diagram commutes

$$\begin{array}{ccc} \mathbf{K}_0^{\mathrm{MW}}(X) & \longrightarrow \widetilde{\mathrm{Cor}}_k(X,X) \\ & & \downarrow & & \downarrow f \circ \alpha(f,\chi) \\ \mathbf{K}_0^{\mathrm{MW}}(X) & \longrightarrow \widetilde{\mathrm{Cor}}_k(X,X) \end{array}$$

where the horizontal arrows are induced by the push-forward map $\Delta_* : \mathbf{K}_0^{\mathrm{MW}}(X) \to \widetilde{\mathrm{CH}}_{\Delta(X)}^{d_X}(X \times X, \omega_X)$. Now, σ can be computed using the composite $\mathrm{K}_0^{\mathrm{MW}}(k(X)) \to \mathrm{K}_0^{\mathrm{MW}}(k(Y)) \to \mathrm{K}_0^{\mathrm{MW}}(k(X))$, where the first map is the push-forward (defined using χ) and the second map the pull-back. It follows essentially from [3, Lemme 6.4.6] that $\sigma = p_{\epsilon}$.

1.4. **The homomorphism.** Let L/k be a finitely generated field extension. It follows from the definition of MW-motivic cohomology that $\mathrm{H}^{p,q}_{\mathrm{MW}}(L,\mathbb{Z})=0$ provided p>q. The next step is then to identify $\mathrm{H}^{p,p}_{\mathrm{MW}}(L,\mathbb{Z})$. To this aim, we constructed in [2, Theorem 4.2.2] a graded ring homomorphism

$$\mathrm{K}^{\mathrm{MW}}_*(L) o \bigoplus_{n \in \mathbb{Z}} \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})$$

which we now recall. For $a \in L^{\times}$, we can consider the corresponding morphism $a : \operatorname{Spec}(L) \to \mathbb{G}_{m,k}$ which defines a finite MW-correspondence Γ_a in $\operatorname{Cor}_k(L, \mathbb{G}_{m,k})$. Now, we have a surjective homomorphism $\operatorname{Cor}_k(L, \mathbb{G}_{m,k}) \to \operatorname{H}^{1,1}_{\operatorname{MW}}(L, \mathbb{Z})$ and we let s([a]) be the image of Γ_a under this map. Next, consider the element

$$\eta[t] \in \mathbf{K}_0^{\mathrm{MW}}(\mathbb{G}_{m,L}) = \widetilde{\mathrm{Cor}}_k(\mathbb{G}_{m,L},k) = \widetilde{\mathrm{Cor}}_k(\mathbb{G}_{m,k} \times L,k) = \underline{\mathrm{Hom}}(\widetilde{\mathbf{c}}(\mathbb{G}_{m,k}),\widetilde{\mathbf{c}}(k))(L).$$

We define $s(\eta)$ to be its image under the projections

$$\underline{\operatorname{Hom}}(\tilde{\operatorname{c}}(\mathbb{G}_{m,k}),\tilde{\operatorname{c}}(k))(L) \to \underline{\operatorname{Hom}}(\tilde{\mathbb{Z}}\{1\},\tilde{\operatorname{c}}(k))(L) \to \operatorname{H}_{\operatorname{MW}}^{-1,-1}(L,\mathbb{Z}).$$

The following theorem is proved in [2, Theorem 4.2.2] (using computations of [4, §6]).

Theorem 1.8. The associations $[a] \mapsto s([a])$ and $\eta \mapsto s(\eta)$ induce a homomorphism of graded rings

$$\Phi_L: \mathrm{K}^{\mathrm{MW}}_*(L) \to \bigoplus_{n \in \mathbb{Z}} \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z}).$$

By construction, the above homomorphism fits in a commutative diagram of graded rings

$$\mathbf{K}^{\mathrm{MW}}_{*}(L) \xrightarrow{\Phi_{L}} \bigoplus_{n \in \mathbb{Z}} \mathbf{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})$$

$$\downarrow \qquad \qquad \downarrow$$

$$\mathbf{K}^{\mathrm{M}}_{*}(L) \xrightarrow{} \bigoplus_{n \in \mathbb{Z}} \mathbf{H}^{n,n}(L,\mathbb{Z})$$

where the vertical projections are respectively the natural map from Milnor-Witt K-theory to Milnor K-theory and the ring homomorphism of the previous section, and the bottom horizontal homomorphism is the map constructed by Totaro-Nesterenko-Suslin.

2. Main theorem

2.1. A left inverse. In this section, we construct for $q \geq 0$ a left inverse to the homomorphism Φ_L of Section 1.4. By definition,

$$\widetilde{\mathbf{c}}(\mathbb{G}_m^q)(L) := \bigoplus_{x \in (\mathbb{G}_{m,L}^q)^{(q)}} \widetilde{\mathrm{CH}}_x^q(\mathbb{G}_{m,L}^q, \omega_{\mathbb{G}_m^q}).$$

Now, for any point x in $(\mathbb{G}_{m,L}^q)^{(q)}$ with maximal ideal \mathfrak{m} , we have an exact sequence

$$\mathfrak{m}/\mathfrak{m}^2 \to \Omega_{\mathbb{G}^q_{\mathfrak{m},L}/k} \to \Omega_{L(x)/k} \to 0.$$

Using the fact that k is perfect and counting dimensions, we see that this sequence is also exact on the left. We find an isomorphism

$$\wedge^q (\mathfrak{m}/\mathfrak{m}^2)^\vee \otimes \omega_{\mathbb{G}^q_{m,L}/k} \simeq \omega_{L(x)/k}$$

Now, $\omega_{\mathbb{G}_{m,L}^q/k} \simeq p_1^* \omega_{\mathbb{G}_m^q/k} \otimes p_2^* \omega_{L/k}$ and it follows that

$$\wedge^q(\mathfrak{m}/\mathfrak{m}^2)^{\vee} \otimes \omega_{\mathbb{G}_m^q} \simeq \omega_{L(x)/k} \otimes_L \omega_{L/k}^{\vee}$$

yielding

$$\tilde{\mathbf{c}}(\mathbb{G}_m^q)(L) = \bigoplus_{x \in (\mathbb{G}_{m,L}^q)^{(q)}} \mathbf{K}_0^{\mathrm{MW}}(L(x), \omega_{L(x)/k} \otimes_L \omega_{L/k}^{\vee}).$$

Now any closed point x in $(\mathbb{G}_{m,L}^q)^{(q)}$ can be identified with a q-uple (x_1,\ldots,x_q) of elements of L(x). For any such x, we define a homomorphism

$$f_x: \mathrm{K}_0^{\mathrm{MW}}(L(x), \omega_{L(x)/k} \otimes_L \omega_{L/k}^{\vee}) \to \mathrm{K}_q^{\mathrm{MW}}(L)$$

by $f_x(\alpha) = \text{Tr}_{L(x)/L}(\alpha \cdot [x_1, \dots, x_q])$. We then obtain a homomorphism

$$f: \tilde{\mathbf{c}}(\mathbb{G}_m^q)(L) \to \mathbf{K}_q^{\mathrm{MW}}(L)$$

which is easily seen to factor through $(\tilde{\mathbb{Z}}\{q\})(L)$ since $[1] = 0 \in \mathrm{K}^{\mathrm{MW}}_1(L)$.

We now check that this homomorphism vanishes on the image of $(\tilde{\mathbb{Z}}\{q\})(\mathbb{A}^1_L)$ in $(\tilde{\mathbb{Z}}\{q\})(L)$ under the boundary homomorphism. This will follow from the next lemma.

Lemma 2.1. Let $Z \in \mathcal{A}(\mathbb{A}^1_L, \mathbb{G}^q_m)$. Let moreover $p : \mathbb{G}^q_{m,L} \to \operatorname{Spec}(L)$ and $p_{\mathbb{A}^1_L} : \mathbb{A}^1_L \times \mathbb{G}^q_m \to \mathbb{A}^1_L$ be the projections and $Z_i := p_{\mathbb{A}^1_L}^{-1}(i) \cap Z$ (endowed with its reduced structure) for i = 0, 1. Let $j_i : \operatorname{Spec}(L) \to \mathbb{A}^1_L$ be the inclusions in i = 0, 1 and let $g_i : \mathbb{G}^q_{m,L} \to \mathbb{A}^1_L \times \mathbb{G}^q_m$ be the induced maps. Then the homomorphisms

$$p_*(g_i)^*: \widetilde{\operatorname{CH}}^q_Z(\mathbb{A}^1_L \times \mathbb{G}^q_m, \omega_{\mathbb{G}^q_m}) \to \widetilde{\operatorname{CH}}^q_{Z_i}(\mathbb{G}^q_{m,L}, \omega_{\mathbb{G}^q_m}) \to \mathrm{K}^{\mathrm{MW}}_0(L)$$

are equal.

Proof. For i = 0, 1, consider the Cartesian square

$$\mathbb{G}^q_{m,L} \xrightarrow{g_i} \mathbb{A}^1_L \times \mathbb{G}^q_{m,L}$$

$$\downarrow^{p} \qquad \qquad \downarrow^{p_{\mathbb{A}^1_L}}$$

$$\operatorname{Spec}(L) \xrightarrow{j_i} \mathbb{A}^1_L$$

We have $(j_i)^*(p_{\mathbb{A}^1_L})_* = p_*(g_i)^*$ by base change. The claim follows from the fact that $(j_0)^* = (j_1)^*$ by homotopy invariance.

Proposition 2.2. The homomorphism $f: \tilde{\mathbf{c}}(\mathbb{G}_m^q)(L) \to \mathrm{K}_q^{\mathrm{MW}}(L)$ induces a homomorphism

$$\theta_L: \mathrm{H}^{q,q}_{\mathrm{MW}}(L,\mathbb{Z}) \to \mathrm{K}^{\mathrm{MW}}_q(L)$$

for any $q \geq 1$.

Proof. Observe that the group $\mathrm{H}^{q,q}_{\mathrm{MW}}(L,\mathbb{Z})$ is the cokernel of the homomorphism

$$\partial_0 - \partial_1 : \tilde{\mathbb{Z}}\{q\}(\mathbb{A}^1_L) \to \tilde{\mathbb{Z}}\{q\}(L)$$

It follows from [1, Example 4.16] that $\partial_i : \tilde{c}(\mathbb{G}_m^q)(\mathbb{A}_L^1) \to \tilde{c}(\mathbb{G}_m^q)(L)$ is induced by g_i^* . We can use the above lemma to conclude.

Corollary 2.3. The homomorphism

$$\Phi_L: \bigoplus_{n\in\mathbb{Z}} \mathrm{K}_n^{\mathrm{MW}}(L) \to \bigoplus_{n\in\mathbb{Z}} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z}).$$

is split injective.

Proof. It suffices to check that $\theta_L \Phi_L = id$, which is straightforward.

The following result will play a role in the proof of the main theorem.

Proposition 2.4. Let $n \in \mathbb{Z}$ and let F/L be a finite field extension. Then, the following diagram commutes

$$\begin{array}{c|c} \operatorname{H}^{n,n}_{\operatorname{MW}}(F,\mathbb{Z}) \xrightarrow{\theta_F} \operatorname{K}^{\operatorname{MW}}_n(F) \\ & & & \downarrow^{\operatorname{Tr}_{F/L}} \\ \operatorname{H}^{n,n}_{\operatorname{MW}}(L,\mathbb{Z}) \xrightarrow{\theta_F} \operatorname{K}^{\operatorname{MW}}_n(L). \end{array}$$

Proof. Let X be a smooth connected scheme and let $\beta \in \widetilde{\mathrm{Cor}}_k(X, \mathbb{G}_m^{\times n})$ be a finite MW-correspondence with support T (see [1, Definition 4.7] for the notion of support). Each connected component T_i of T has a fraction field $k(T_i)$ which is a finite extension of k(X) and, arguing as in the beginning of Section 2.1, we find that β can be seen as an element of

$$\bigoplus_{i} \mathrm{K}_{0}^{\mathrm{MW}}(k(T_{i}), \omega_{k(T_{i})/k} \otimes \omega_{k(X)/k}^{\vee})$$

Now, the morphism $T_i \subset X \times \mathbb{G}_m^{\times n} \to \mathbb{G}_m^{\times n}$ gives invertible global sections a_1, \ldots, a_n and we define a map

$$\theta_X: \widetilde{\mathrm{Cor}}_k(X, \mathbb{G}_m^{\times n}) \to \mathrm{K}_n^{\mathrm{MW}}(k(X))$$

by $\beta \mapsto \sum \operatorname{Tr}_{k(T_i)/k(X)}(\beta_i[a_1,\ldots,a_n])$, where β_i is the component of β in the group $\mathrm{K}_0^{\mathrm{MW}}(k(T_i),\omega_{k(T_i)/k(X)})$. This map is easily seen to be a homomorphism, and its limit at k(X) is the morphism defined at the beginning of Section 2.1.

Let now X and Y be smooth connected schemes over $k, f: X \to Y$ be a finite morphism and $\chi: \mathcal{O}_X \to \omega_f$ be an isomorphism inducing a finite MW-correspondence $\alpha(f,\chi): Y \to X$ as in Section 1.3. We claim that the diagram

$$\begin{split} \widetilde{\operatorname{Cor}}_k(X,\mathbb{G}_m^{\times n}) &\xrightarrow{\quad \theta_X \quad} \operatorname{K}_n^{\operatorname{MW}}(k(X)) \\ \circ &\alpha(f,\chi) \Big| \qquad \qquad \Big| \operatorname{Tr}_{k(X)/k(Y)} \\ \widetilde{\operatorname{Cor}}_k(Y,\mathbb{G}_m^{\times n}) &\xrightarrow{\quad \theta_Y \quad} \operatorname{K}_n^{\operatorname{MW}}(k(Y)), \end{split}$$

where the right arrow is obtained using χ , commutes. If β is as above, we have

$$\operatorname{Tr}_{k(X)/k(Y)}(\theta_X(\beta)) = \sum \operatorname{Tr}_{k(X)/k(Y)}(\operatorname{Tr}_{k(T_i)/k(X)}(\beta_i[a_1, \dots, a_n]))$$

and the latter is equal to $\sum \operatorname{Tr}_{k(T_i)/k(Y)}(\beta_i[a_1,\ldots,a_n])$ by functoriality of the transfers. On the other hand, the isomorphism $\chi:\mathcal{O}_X\to\omega_f$ can be seen as an element in $\mathbf{K}_0^{\mathrm{MW}}(X,\omega_f)$, yielding an element of $\mathrm{K}_0^{\mathrm{MW}}(k(X),\omega_f)$ that we still denote by χ . The image of $\beta\circ\alpha(f,\chi)$ can be seen as the element $\beta\cdot\chi$ of

$$\bigoplus_{i} \mathrm{K}_{0}^{\mathrm{MW}}(k(T_{i}), \omega_{k(T_{i})/k(Y)})$$

where we have used the isomorphism

$$\omega_{k(T_i)/k(X)} \otimes \omega_f = \omega_{k(T_i)/k(X)} \otimes \omega_{k(X)/k(Y)} \simeq \omega_{k(T_i)/k(Y)}$$

It is now clear that $\theta_Y(\beta \circ \alpha(f, \chi)) = \sum \operatorname{Tr}_{k(T_i)/k(Y)}(\beta_i[a_1, \dots, a_n])$ and the result follows.

2.2. **Proof of the main theorem.** In this section we prove our main theorem, namely that the homomorphism

$$\Phi_L: \bigoplus_{n\in\mathbb{Z}} \mathrm{K}_n^{\mathrm{MW}}(L) \to \bigoplus_{n\in\mathbb{Z}} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$$

is an isomorphism. We first observe that Φ_L is an isomorphism in degrees ≤ 0 . In degree 0, we indeed know from [1, §6] that both sides are $K_0^{MW}(L)$. Next, [4, Lemma 6.0.1] yields

$$\Phi_L(\langle a \rangle) = \Phi_L(1 + \eta[a]) = 1 + s(\eta)s(a) = \langle a \rangle.$$

It follows Φ_L is a homomorphism of graded $\mathrm{K}_0^{\mathrm{MW}}(L)$ -algebras and the result in degrees < 0 follows then from the fact that $\mathrm{H}_{\mathrm{MW}}^{p,p}(L,\mathbb{Z}) = W(L) = \mathrm{K}_{-p}^{\mathrm{MW}}(L)$ by [1, §6] and [2, Proposition 4.1.2].

We now prove the result in positive degrees, starting with n=1. Recall that we know from Corollary 2.3 that Φ_L is split injective, and that it therefore suffices to prove that it is surjective to conclude.

For any $d, n \geq 1$ and any field extension L/k let $M_n^{(d)}(L) \subset \widetilde{\operatorname{Cor}}_k(L, \mathbb{G}_m^{\times n})$ be the subgroup of correspondences whose support is a finite union of field extensions E/L of degree $\leq d$ (see [1, Definition 4.7] for the notion of support of a correspondence). Let $H_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})^{(d)} \subset H_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$ be the image of $M_n^{(d)}(L)$ under the surjective homomorphism

$$\widetilde{\operatorname{Cor}}_k(L, \mathbb{G}_m^{\times n}) \to \operatorname{H}^{n,n}_{\operatorname{MW}}(L, \mathbb{Z}).$$

Observe that

$$\mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})^{(d)} \subset \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})^{(d+1)} \quad \text{and} \quad \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z}) = \cup_{d \in \mathbb{N}} \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})^{(d)}.$$

Lemma 2.5. The subgroup $H^{n,n}_{MW}(L,\mathbb{Z})^{(1)} \subset H^{n,n}_{MW}(L,\mathbb{Z})$ is the image of the homomorphism

$$\Phi_L: \mathrm{K}_n^{\mathrm{MW}}(L) \to \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z}).$$

Proof. By definition, observe that the homomorphism $\mathrm{K}_n^{\mathrm{MW}}(L) \to \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$ factors through $\mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})^{(1)}$. Let then $\alpha \in \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})^{(1)}$. We may suppose that α is the image under the homomorphism $\mathrm{Cor}_k(L,\mathbb{G}_m^{\times n}) \to \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$ of a correspondence a supported on a field extension E/L of degree 1, i.e. E=L. It follows that a is determined by a form $\phi \in \mathrm{K}_0^{\mathrm{MW}}(L)$ and a n-uple a_1,\ldots,a_n of elements of L. This is precisely the image of $\Phi_L(\phi \cdot [a_1,\ldots,a_n])$ under the homomorphism $\mathrm{K}_n^{\mathrm{MW}}(L) \to \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$.

Proposition 2.6. For any $d \geq 2$, we have $H^{1,1}_{MW}(L,\mathbb{Z})^{(d)} \subset H^{1,1}_{MW}(L,\mathbb{Z})^{(d-1)}$.

Proof. By definition, $\mathrm{H}^{1,1}_{\mathrm{MW}}(L,\mathbb{Z})^{(d)}$ is generated by correspondences whose supports are field extensions E/L of degree at most d. Such correspondences are determined by an element $a \in E^{\times}$ given by the composite $\mathrm{Spec}(E) \to \mathbb{G}_{m,L} \to \mathbb{G}_m$ together with a form $\phi \in \mathrm{K}_0^{\mathrm{MW}}(E,\omega_{E/L})$ given by the isomorphism

$$\mathrm{K}^{\mathrm{MW}}_0(E,\omega_{E/L}) \to \widetilde{\mathrm{CH}}^1_{\mathrm{Spec}(E)}(\mathbb{G}_{m,L},\omega_{\mathbb{G}_{m,L}/L}).$$

We denote this correspondence by the pair (a, ϕ) . Recall from [1, Lemma 2.4] that there is a canonical orientation ξ of $\omega_{E/L}$ and thus a canonical element $\chi \in \widetilde{\mathrm{Cor}}_k(\mathrm{Spec}(L), \mathrm{Spec}(E))$ yielding the transfer map

$$\operatorname{Tr}_{E/L}: \widetilde{\operatorname{Cor}}_k(\operatorname{Spec}(E), \mathbb{G}_m) \to \widetilde{\operatorname{Cor}}_k(\operatorname{Spec}(L), \mathbb{G}_m)$$

which is just the composition with χ ([1, Example 4.17]). Now $\phi = \psi \cdot \xi$ for $\psi \in \mathrm{K}_0^{\mathrm{MW}}(E)$, and it is straightforward to check that the Chow-Witt correspondence (a,ψ) in $\widetilde{\mathrm{Cor}}_k(\mathrm{Spec}(E),\mathbb{G}_m)$ determined by $a \in E^\times$ and $\psi \in \mathrm{K}_0^{\mathrm{MW}}(E)$ satisfies $\mathrm{Tr}_{E/L}(a,\psi) = (a,\phi)$. Now $(a,\psi) \in \mathrm{H}_{\mathrm{MW}}^{1,1}(E,\mathbb{Z})^{(1)}$ and therefore belongs to the image of the homomorphism $\mathrm{K}_1^{\mathrm{MW}}(E) \to \mathrm{H}_{\mathrm{MW}}^{1,1}(E,\mathbb{Z})$. There exists thus $a_1,\ldots,a_n,b_1,\ldots,b_m \in E^\times$ (possibly equal) such that $(a,\psi) = \sum s(a_i) - \sum s(b_j)$. To prove the lemma, it suffices then to show that $\mathrm{Tr}_{E/L}(s(b)) \in \mathrm{H}_{\mathrm{MW}}^{1,1}(L,\mathbb{Z})^{(d-1)}$ for any $b \in E^\times$.

Let thus $b \in E^{\times}$. By definition, $s(b) \in \mathrm{H}^{1,1}(E,\tilde{\mathbb{Z}})$ is the class of the correspondence $\tilde{\gamma}(b)$ associated to the morphism of schemes $\mathrm{Spec}(E) \to \mathbb{G}_m$ corresponding to b. If $F(b) \subset E$ is a proper subfield, we see that $\mathrm{Tr}_{E/L}(s(b)) \in \mathrm{H}^{1,1}(F,\tilde{\mathbb{Z}})^{(d-1)}$, and we may thus suppose that the minimal polynomial p of b over F is of degree d. By definition, $\mathrm{Tr}_{E/L}(s(b))$ is then represented by the correspondence associated to the pair $(b,\langle 1 \rangle \cdot \xi)$. Consider the total residue homomorphism (twisted by the vector space $\omega_{F[t]/k} \otimes \omega_{F/k}^{\vee}$)

$$\partial: \mathrm{K}^{\mathrm{MW}}_{1}(F(t), \omega_{F(t)/k} \otimes \omega_{F/k}^{\vee}) \to \bigoplus_{x \in \mathbb{G}_{m}^{(1)}_{F}} \mathrm{K}^{\mathrm{MW}}_{0}(F(x), (\mathfrak{m}_{x}/\mathfrak{m}_{x}^{2})^{\vee} \otimes_{F[t]} \omega_{F[t]/k} \otimes \omega_{F/k}^{\vee})$$

where \mathfrak{m}_x is the maximal ideal corresponding to x. Before working further with this homomorphism, we first identify $(\mathfrak{m}_x/\mathfrak{m}_x^2)^{\vee} \otimes_{F[t]} \omega_{F[t]/k} \otimes \omega_{F/k}^{\vee}$. Consider the canonical exact sequence of F(x)-vector spaces

$$\mathfrak{m}_x/\mathfrak{m}_x^2 \to \Omega_{F[t]/k} \otimes_{F[t]} F(x) \to \Omega_{F(x)/k} \to 0.$$

A comparison of the dimensions shows that the sequence is also left exact (use the fact that F(x) is the localization of a smooth scheme of dimension d over the perfect field k), and we thus get a canonical isomorphism

$$\omega_{F[t]/k} \otimes_{F[t]} F(x) \simeq \mathfrak{m}_x/\mathfrak{m}_x^2 \otimes_{F(x)} \omega_{F(x)/k}.$$

It follows that

$$(\mathfrak{m}_x/\mathfrak{m}_x^2)^{\vee} \otimes_{F[t]} \omega_{F[t]/k} \otimes \omega_{F/k}^{\vee} \simeq \omega_{F(x)/k} \otimes_F \omega_{F/k}^{\vee}.$$

We can thus rewrite the residue homomorphism (1) as a homomorphism

$$\partial: \mathrm{K}^{\mathrm{MW}}_{1}(F(t), \omega_{F(t)/k} \otimes \omega_{F/k}^{\vee}) \to \bigoplus_{x \in (\mathbb{A}_{F}^{1} \setminus 0)^{(1)}} \mathrm{K}^{\mathrm{MW}}_{0}(F(x), \omega_{F(x)/k} \otimes_{F} \omega_{F/k}^{\vee})$$

Moreover, an easy dimension count shows that the canonical exact sequence

$$\Omega_{F/k} \otimes F[t] \to \Omega_{F[t]/k} \to \Omega_{F[t]/F} \to 0$$

is also exact on the left, yielding a canonical isomorphism $\omega_{F(t)/k} \simeq \omega_{F/k} \otimes \omega_{F(t)/F}$ and thus a canonical isomorphism $\omega_{F/k}^{\vee} \otimes \omega_{F(t)/k} \simeq \omega_{F(t)/F}$. If n is the transcendance degree of F over k, we see that the canonical isomorphism

$$\omega_{F/k}^{\vee} \otimes \omega_{F(t)/k} \simeq \omega_{F(t)/k} \otimes \omega_{F/k}^{\vee}$$

is equal to $(-1)^{n(n+1)}$ -times the switch isomorphism, i.e. is equal to the switch isomorphism. Altogether, the residue homomorphism reads as

$$\partial: \mathrm{K}^{\mathrm{MW}}_{1}(F(t), \omega_{F(t)/F}) \to \bigoplus_{x \in (\mathbb{A}_{F}^{1} \setminus 0)^{(1)}} \mathrm{K}^{\mathrm{MW}}_{0}(F(x), \omega_{F(x)/k} \otimes_{F} \omega_{F/k}^{\vee}).$$

Let now $p(t) \in F[t]$ be the minimal polynomial of b over F. Following [7, Definition 4.26] (or [1, §2]), write $p(t) = p_0(t^{l^m})$ with p_0 separable and set $\omega = p'_0(t^{l^m}) \in F[t]$ if $\operatorname{char}(k) = l$. If $\operatorname{char}(k) = 0$, set $\omega = p'(t)$. It is easy to see that the element $\langle \omega \rangle[p] \cdot dt$ of $\mathrm{K}_1^{\mathrm{MW}}(F(t), \omega_{F(t)/F})$ ramifies in $b \in \mathbb{G}_{m,F}^{(1)}$ and on (possibly) other points corresponding to field extensions of degree $\leq d-1$. Moreover, the residue at b is exactly $\langle 1 \rangle \cdot \xi$, where ξ is the canonical orientation of $\omega_{F(b)/F}$.

Write the minimal polynomial $p(t) \in F[t]$ of b as $p = \sum_{i=0}^d \lambda_i t^i$ with $\lambda_d = 1$ and $\lambda_0 \in F^\times$, and decompose $\omega = c \prod_{j=1}^n q_j^{m_j}$, where $c \in F^\times$ and $q_j \in F[t]$ are irreducible monic polynomials. Let $f = (t-1)^{d-1}(t-(-1)^d\lambda_0) \in F[t]$. Observe that f is monic and satisfies f(0) = p(0). Let F(u,t) = (1-u)p + uf. Since f and p are monic and have the same constant terms, it follows that $F(u,t) = t^d + \ldots + \lambda_0$ and therefore F defines an element of $\mathcal{A}(\mathbb{A}_F^1, \mathbb{G}_m)$. For the same reason, every q_j (seen as a polynomial in F[u,t] constant in u) defines an element in $\mathcal{A}(\mathbb{A}_F^1,\mathbb{G}_m)$. The image of $\langle \omega \rangle[F] \cdot dt \in \mathrm{K}_1^{\mathrm{MW}}(F(u,t),\omega_{F(u,t)/F(u)})$ under the residue homomorphism

$$\partial: \mathrm{K}^{\mathrm{MW}}_{1}(F(u,t),\omega_{F(u,t)/F(u)}) \to \bigoplus_{x \in (\mathbb{A}^{1}_{F} \times_{k} \mathbb{G}_{m})^{(1)}} \mathrm{K}^{\mathrm{MW}}_{0}(F(x),(\mathfrak{m}_{x}/\mathfrak{m}_{x}^{2})^{\vee} \otimes_{F[t]} \omega_{F[u,t]/F[u]})$$

is supported on the vanishing locus of F and the g_j , and it follows that it defines a finite Chow-Witt correspondence α in $\widetilde{\mathrm{Cor}}_k(\mathbb{A}^1_F,\mathbb{G}_m)$. The evaluation $\alpha(0)$ of α at u=0 consists from $\langle 1 \rangle \cdot \xi$ and correspondences supported on the vanishing locus of the q_j , while $\alpha(1)$ is supported on the vanishing locus of f and the q_j . The class of $\langle 1 \rangle \cdot \xi$ is then an element of $\mathrm{H}^{1,1}_{\mathrm{MW}}(L,\mathbb{Z})^{(d-1)}$.

Corollary 2.7. The homomorphism

$$\Phi_L: \mathrm{K}^{\mathrm{MW}}_1(L) \to \mathrm{H}^{1,1}_{\mathrm{MW}}(F,\mathbb{Z})$$

is an isomorphism for any finitely generated field extension F/k.

Proof. We know that the homomorphism is (split) injective. The above proposition shows that $H^{1,1}_{MW}(F,\mathbb{Z}) = H^{1,1}_{MW}(F,\mathbb{Z})^{(1)}$ and the latter is the image of $K^{MW}_1(L)$ under Φ_L . It follows that Φ_L is surjective.

We can now prove that θ respects transfers following [6, Lemma 5.11] and [8, Lemma 9.5].

Theorem 2.8. Let $n \in \mathbb{N}$ and let F/L be a finite field extension. Then the following diagram commutes

$$\begin{array}{c|c} \mathrm{K}_n^{\mathrm{MW}}(F) \xrightarrow{\Phi_F} \mathrm{H}_{\mathrm{MW}}^{n,n}(F,\mathbb{Z}) \\ & \downarrow^{\mathrm{Tr}_{F/L}} \\ \mathrm{K}_n^{\mathrm{MW}}(L) \xrightarrow{\Phi_L} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z}). \end{array}$$

Proof. First, we know from Proposition 2.4 that the diagram

$$\begin{array}{c|c} \operatorname{H}^{n,n}_{\operatorname{MW}}(F,\mathbb{Z}) \xrightarrow{\theta_F} \operatorname{K}^{\operatorname{MW}}_n(F) \\ & & & & \operatorname{Tr}_{F/L} \\ \operatorname{H}^{n,n}_{\operatorname{MW}}(L,\mathbb{Z}) \xrightarrow{\theta_F} \operatorname{K}^{\operatorname{MW}}_n(L). \end{array}$$

commutes. If Φ_F and Φ_L are isomorphisms, it follows from Corollary 2.3 that θ_F and θ_L are their inverses and thus that the diagram

$$\begin{array}{c|c} \mathrm{K}_n^{\mathrm{MW}}(F) \xrightarrow{\Phi_F} \mathrm{H}_{\mathrm{MW}}^{n,n}(F,\mathbb{Z}) \\ & \downarrow^{\mathrm{Tr}_{F/L}} \\ \mathrm{K}_n^{\mathrm{MW}}(L) \xrightarrow{\Phi_L} \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z}). \end{array}$$

also commutes. We may then suppose, using Corollary 2.7 that $n \geq 2$. Additionally, we may suppose that [F:L]=p for some prime number p. Following [6, Lemma 5.11], we first assume that L has no field extensions of degree prime to p. In that case, it follows from [7, Lemma 3.25] that $K_n^{\text{MW}}(F)$ is generated by elements of the form $\eta^m[a_1,a_2,\ldots,a_{n+m}]$ with $a_1\in F^\times$ and $a_i\in L^\times$ for $i\geq 2$. We conclude from the projection formula 1.4, its analogue in Milnor-Witt K-theory and the fact that Φ is a ring homomorphism that the result holds in that case.

Let's now go back to the general case, i.e. [F:L]=p without further assumptions. Let L' be the maximal prime-to-p field extension of L. Let $\alpha \in \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})$ be such that its pull-back to $\mathrm{H}^{n,n}_{\mathrm{MW}}(L',\mathbb{Z})$ vanishes. It follows then that there exists a finite field extension E/L of degree m prime to p such that the pull-back of α to $\mathrm{H}^{n,n}_{\mathrm{MW}}(E,\mathbb{Z})$ is trivial. Let $f:\mathrm{Spec}(E)\to\mathrm{Spec}(L)$ be the corresponding morphism. For any unit $b\in E^\times$, we have $\langle b\rangle\cdot f^*(\alpha)=0$ and it follows from the projection formula once again that $f_*(\langle b\rangle)\cdot f^*(\alpha))=f_*(\langle b\rangle)\cdot \alpha=0$. We claim that there is a unit $b\in E^\times$ such that $f_*(\langle b\rangle)=m_{\epsilon}$. Indeed, we can consider the factorization

 $L \subset F^{sep} \subset E$ where F^{sep} is the separable closure of L in E and the extension $F^{sep} \subset E$ is purely inseparable. If the claim holds for each extension, then it holds for $L \subset E$. We may thus suppose that the extension is either separable or purely inseparable. In the first case, the claim follows from [9, Lemme 2] while the second case follows from [3, Théorème 6.4.13]. Thus, for any $\alpha \in H^{n,n}_{MW}(L,\mathbb{Z})$ vanishing in $H^{n,n}_{MW}(L',\mathbb{Z})$ there exists m prime to l such that $m_{\epsilon}\alpha=0$.

Let now $\alpha \in \mathrm{K}_n^{\mathrm{MW}}(F)$ and $t(\alpha) = (\mathrm{Tr}_{F/L} \circ \Phi_F - \Phi_L \circ \mathrm{Tr}_{F/L})(\alpha) \in \mathrm{H}_{\mathrm{MW}}^{n,n}(L,\mathbb{Z})$. Pulling back to L' and using the previous case, we find that $m_{\epsilon}t(\alpha) = 0$. On the other hand, the above arguments show that if the pull-back of $t(\alpha)$ to F is trivial, then $p_{\epsilon}t(\alpha) = 0$ and thus $t(\alpha) = 0$ as (p,m) = 1. Thus, we are reduced to show that $f^*(t(\alpha)) = 0$ where $f : \mathrm{Spec}(F) \to \mathrm{Spec}(L)$ is the morphism corresponding to $L \subset F$.

Suppose first that F/L is purely inseparable. In that case, we know from Example 1.7 that $f^*f_*: \mathcal{H}^{n,n}_{\mathrm{MW}}(F,\mathbb{Z}) \to \mathcal{H}^{n,n}_{\mathrm{MW}}(F,\mathbb{Z})$ is multiplication by p_ϵ . The same property holds for Milnor-Witt K-theory. This is easily checked using the definition of the transfer, or alternatively using Proposition 2.4, the fact that θ_F is surjective and Example 1.7. Altogether, we see that $f^*t(\alpha) = p_\epsilon \Phi_F(\alpha) - \Phi_F(p_\epsilon \cdot \alpha)$ and therefore $f^*t(\alpha) = 0$ since Φ_F is $\mathcal{K}^{\mathrm{MW}}_0(F)$ -linear.

Suppose next that F/L is separable. In that case, we have $F \otimes_L F = \prod_i F_i$ for field extensions F_i/F of degree $\leq p-1$. We claim that the diagrams

$$K_n^{MW}(F) \longrightarrow \bigoplus_i K_n^{MW}(F_i)$$

$$\uparrow^{\text{Tr}_{F/L}} \downarrow \qquad \qquad \downarrow^{\text{Tr}_{F_i/F}}$$

$$K_n^{MW}(L) \longrightarrow K_n^{MW}(F)$$

and

$$\begin{array}{ccc} \operatorname{H}^{n,n}_{\operatorname{MW}}(F,\mathbb{Z}) & \longrightarrow & \oplus_{i} \operatorname{H}^{n,n}_{\operatorname{MW}}(F_{i},\mathbb{Z}) \\ & & & & & & & & \\ \operatorname{Tr}_{F/L} & & & & & & & \\ \operatorname{Tr}_{F/L} & & & & & & & \\ \operatorname{Tr}_{F/F} & & & & & & \\ \operatorname{H}^{n,n}_{\operatorname{MW}}(L,\mathbb{Z}) & & & & & & \\ \operatorname{H}^{n,n}_{\operatorname{MW}}(F,\mathbb{Z}) & & & & & \\ \end{array}$$

commute. The second one follows from Example 1.7 and the first one from [8, Lemma 9.4] (or alternatively from Proposition 2.4, the fact that θ_F is surjective and Example 1.7). By induction, each of the diagrams

$$K_{n}^{\mathrm{MW}}(F_{i}) \xrightarrow{\Phi_{F_{i}}} \mathrm{H}_{\mathrm{MW}}^{n,n}(F_{i},\mathbb{Z})$$

$$\mathrm{Tr}_{F_{i}/F} \downarrow \qquad \qquad \downarrow \mathrm{Tr}_{F_{i}/F}$$

$$K_{n}^{\mathrm{MW}}(F) \xrightarrow{\Phi_{F}} \mathrm{H}_{\mathrm{MW}}^{n,n}(F,\mathbb{Z}).$$

commute, and it follows that $f^*(t(\alpha)) = 0$.

Theorem 2.9. The homomorphism

$$\Phi_L: \mathrm{K}^{\mathrm{MW}}_n(L) \to \mathrm{H}^{n,n}_{\mathrm{MW}}(L,\mathbb{Z})$$

is an isomorphism for any $n \in \mathbb{Z}$ and any finitely generated field extension L/k.

Proof. As in degree 1, it suffices to prove that Φ_L is surjective. Let then $\alpha \in \widetilde{\mathrm{Cor}}_k(L,\mathbb{G}_m^n)$ be a finite Chow-Witt correspondence supported on $\mathrm{Spec}(F) \subset (\mathbb{A}^1_L)^n$.

Such a correspondence is determined by an n-uple $(a_1, \ldots, a_n) \in (F^{\times})^n$ together with a bilinear form $\phi \in \mathrm{GW}(F, \omega_{F/L})$. Arguing as in Proposition 2.6, we see that such a finite MW-correspondence is of the form $\mathrm{Tr}_{F/L}(\Phi_F(\beta))$ for some $\beta \in \mathrm{K}_n^{\mathrm{MW}}(F)$. The result now follows from Theorem 2.8.
