# On the catenarity of virtually nilpotent mod- $p$ Iwasawa algebras

#### Abstract

Let $p>2$ be a prime, $k$ a finite field of characteristic $p$, and $G$ a nilpotent-by-finite compact $p$-adic analytic group. Write $k G$ for the completed group ring of $G$ over $k$. We show that $k G$ is a catenary ring.

## Introduction

Fix a prime $p$, a commutative pseudocompact ring $k$ (e.g. $\mathbb{F}_{p}$ or $\mathbb{Z}_{p}$ ) and a compact $p$-adic analytic group $G$. (Such groups are perhaps most accessibly characterised as those groups $G$ which are isomorphic to a closed subgroup of $G L_{n}\left(\mathbb{Z}_{p}\right)$ for some $n$.) The completed group ring $k G$ (sometimes written $k[[G]]$ ) is defined by

$$
k G:=\underset{N}{\lim _{N}} k[G / N]
$$

where the inverse limit ranges over all open normal subgroups $N$ of $G$, and $k[G / N]$ denotes the ordinary group algebra of the (finite) group $G / N$ over $k$. This ring satisfies an obvious universal property [25, Lemma 2.2], and modules over it characterise continuous $k$-representations of $G$ (which has the profinite topology). When $k=\mathbb{F}_{p}, \mathbb{Z}_{p}$ or related rings, this is often called the Iwasawa algebra of $G$.

Iwasawa algebras (and related objects, such as locally analytic distribution algebras [20]) have recently become a very active research area due to their numbertheoretic interest, for instance in the p-adic Langlands programme: see [19], for example. They are also interesting objects of study in their own right, as an interesting class of noetherian rings: see 3 for a 2006 survey of what is known about these rings.

Our main result is the following.
Theorem A. Take $p>2$. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, and let $k$ be a finite field of characteristic $p$. Then $k G$ is a catenary ring.

Recall that a ring $R$ is said to be catenary if any two maximal chains of prime ideals with common endpoints have the same length, i.e. whenever

are two chains of prime ideals of $R$ which cannot be refined further (i.e. by adding an extra prime ideal $P_{i} \lesseqgtr I \lesseqgtr P_{i+1}$ or $Q_{i} \lesseqgtr I \lesseqgtr Q_{i+1}$ ), we have that $r=s$. This is a "well-behavedness" condition on the classical Krull dimension of $k G$ : it says that, whenever $P \lesseqgtr P^{\prime}$ are adjacent prime ideals and the height $h(P)$ of $P$ is finite, then we have $h\left(P^{\prime}\right)=h(P)+1$.

This result goes some way towards redressing the long-standing gap between Iwasawa algebras and similar algebraic objects; for instance, similar catenarity results had already been established for classical group rings of virtually polycyclic groups (in a special case in [17], in full generality in [11]), for universal enveloping algebras of finite-dimensional soluble Lie algebras over $\mathbb{C}[6]$ for quantised coordinate rings over $\mathbb{C}$ [27], and over [26]; for $q$-commutative power series rings [22]; and so on.

In proving this result, we crucially use the prime extension theorem, [24, Theorem A]. Before we can state this, we need to recall a few concepts.

Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group. Then 23, Theorem C] there exists a unique maximal subgroup $H$ of $G$ with the property that $H$ is an open normal subgroup of $G, H$ contains a finite normal subgroup $F$, and $H / F$ is nilpotent $p$-valuable. This $H$ is called the finite-by-(nilpotent $p$-valuable) radical of $G$, and is written $\mathbf{F} \mathbf{N}_{p}(G)$.
Given a prime ideal $P$ of $k G$, as in [2, §1.3] and [24, Introduction], we will write $P^{\dagger}$ for the kernel of the natural composite map $G \rightarrow(k G)^{\times} \rightarrow(k G / P)^{\times}$. We say that $P$ is faithful if $P^{\dagger}=1$, and $P$ is almost faithful if $P^{\dagger}$ is finite.

We now state the prime extension theorem:
Theorem. [24, Theorem A] Take $p>2$. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, and let $k$ be a finite field. Write $H=\mathbf{F N}_{p}(G)$. If $P$ is an almost faithful prime ideal of $k H$, then the ideal $P k G$ is a prime ideal of $k G$.

We will use this result to generalise Ardakov's analogue of Zalesskii's theorem [2, Theorem 8.6] to our current context.

Recall [23, Definition 1.4, Lemma 1.10] that a group $G$ is orbitally sound if, whenever $H$ is a subgroup of $G$ with finitely many $G$-conjugates, and $H^{\circ}$ is the largest normal subgroup of $G$ contained in $H$, we have $\left[H: H^{\circ}\right]<\infty$; and recall that nilpotent $p$-valuable groups are indeed orbitally sound [2, Proposition 5.9].

As in [23], we will write throughout this paper

$$
\begin{aligned}
\Delta(G) & =\left\{x \in G \mid\left[G: \mathbf{C}_{G}(x)\right]<\infty\right\} \\
\Delta^{+}(G) & =\{x \in \Delta \mid o(x)<\infty\}
\end{aligned}
$$

where $o(x)$ denotes the order of $x$. We will also often simply write $\Delta$ and $\Delta^{+}$to denote $\Delta(G)$ and $\Delta^{+}(G)$. For the basic properties of these (closed, characteristic) subgroups, see [23, Lemma 1.3 and Theorem D].

Following Roseblade [17, we say that a prime ideal $P$ of $k G$ is controlled by the normal subgroup $H$ of $G$ if the right ideal $(P \cap k H) k G$ is equal to $P$.

Theorem B. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group. Suppose $P$ is an almost faithful prime ideal of $k G$. Then $P$ is controlled by $\Delta$.

The analogous classical result, for group algebras of polycyclic-by-finite groups, was proved by Roseblade [17, Corollary H3]. Taken together with the results of [1] and 25], this also gives a precise partial answer to a question of Ardakov and Brown [3, Question G]: when $G$ is as in Theorem B, this completely describes the prime ideals of $k G$ in terms of closed normal subgroups, central elements and prime ideals of (classical) group algebras of finite groups over $k$.

This is all we need to deduce that $k G$ is catenary when $G$ is nilpotent-by-finite and orbitally sound - see Theorem 3.12 In order to pass from orbitally sound to general nilpotent-by-finite groups, we partly develop the theory of vertices and sources along the lines of [12] [13].

Theorem C. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, $P$ a prime ideal of $k G, H$ an orbitally sound open normal subgroup of $G$, and $Q$ a minimal prime ideal above $P \cap k H$. Write $N$ for the $G$-isolator [23, Definition 1.6] of $Q^{\dagger}$, and write $\nabla$ for the subgroup of $G$ containing $N$ defined by $\nabla / N=\Delta(G / N)$. Then $P$ is induced from an ideal $L$ of $k \nabla$.
For the precise meaning of induced here, see $\S 1.2$.
Theorem A then follows from Theorems B and C by adapting an argument from [11], as follows. Let $G$ be a (not necessarily orbitally sound) nilpotent-by-finite compact $p$-adic analytic group, $k$ a finite field of characteristic $p>2$, and $P$ a faithful prime ideal of $k G$. We already know [23, Theorem A] that $G$ contains an open normal orbitally sound subgroup, which we denote nio $(G)$. From Theorem C, we may deduce Corollary 3.20, that $P$ is induced from some proper open subgroup $H$ of $G$ containing nio $(G)$. If $H=\operatorname{nio}(G)$, then we can deduce from Theorem B (as above) that $k H$ is catenary, and now by Lemma 3.22 we are done. In general, $\operatorname{nio}(G) \leq H<G$, and we may not have equality: but it is easy to see that $[H: \operatorname{nio}(H)]<[G: \operatorname{nio}(G)]<\infty$, and Corollary 3.23 establishes Theorem A by induction on the index $[G: \operatorname{nio}(G)]$.

## 1 Heights of primes and Krull dimension

### 1.1 Prime and $G$-prime ideals

Definition 1.1. Let $G$ be a compact $p$-adic analytic group [5, Definition 8.14]. Suppose the group $G$ acts (continuously) on the $\operatorname{ring} R$, and that the ideal $I \triangleleft R$ is $G$-stable. Then, following [15, §14], we will say that $I$ is $G$-prime if, whenever $A, B \triangleleft R$ are $G$-stable ideals and $A B \subseteq I$, then either $A \subseteq I$ or $B \subseteq I$.

Lemma 1.2. Let $G$ be a compact $p$-adic analytic group and $H$ a closed normal subgroup.
(i) If $P$ is a prime ideal of $k G$, then $P \cap k H$ is a $G$-prime ideal of $k H$. If $H$ is open in $G$, then $P$ is a minimal prime ideal above $(P \cap k H) k G$.
(ii) Let $Q$ be a $G$-prime ideal of $k H$, and $P$ any minimal prime of $k H$ above $Q$. Then $Q=\bigcap_{x \in G} P^{x}$. Furthermore, the set of minimal primes of $k G$ above $Q$ is $\left\{P^{x} \mid x \in G\right\}$.

Proof.
(i) The former statement follows from [15, Lemma 14.1(i)], and the latter from [15, Theorem 16.2(i)].
(ii) This follows from [15, Lemma 14.2(i)(ii)].

Definition 1.3. Let $P$ be a prime ideal of a ring $R$. Then we define the height of $P$ to be the greatest integer $h(P):=r$ for which there exists a (finite) chain

$$
P_{0} \lesseqgtr P_{1} \lesseqgtr \cdots \lesseqgtr P_{r}=P
$$

of prime ideals in $R$ (or $\infty$ if no such longest finite chain exists).
Suppose instead that the group $G$ acts on $R$ by automorphisms, and $P$ is a $G$-prime ideal of $R$. Then the $G$-height of $P$ is the greatest integer $h_{G}(P):=r$ for which there exists a chain ( $\dagger$ ) of $G$-prime ideals in $R$ (or $\infty$ ).

Finally, suppose that the group $G$ acts on $R$ by automorphisms, and $P$ is a $G$-orbital prime ideal of $R$ (i.e. a prime ideal of $R$ with finite orbit under the conjugation action of $G$ ). Then the $G$-orbital height of $P$ is the greatest integer $h_{G}^{\mathrm{orb}}(P):=r$ for which there exists a chain $(\dagger)$ of $G$-orbital prime ideals in $R$ (or $\infty$ ).

We note the following immediate consequence of the correspondence of Lemma 1.2

Corollary 1.4. Let $G$ be a compact $p$-adic analytic group and $H$ an open normal subgroup. Take $P$ a prime ideal of $k G$, and let $Q$ be a minimal prime of $k H$ above $P \cap k H$. Then $h(P)=h_{G}(P \cap k H)=h(Q)$.

### 1.2 Inducing ideals

Definition 1.5. Let $H$ be an open (not necessarily normal) subgroup of $G$, and let $L$ be an ideal of $k H$. We define the induced ideal $L^{G} \triangleleft k G$ to be the largest (two-sided) ideal contained in the right ideal $L k G \underset{r}{\triangleleft} k G$. In other words, by [11, 2.1], $L^{G}$ is the annihilator of $k G / L k G$ as a right $k G$-module, or by [15, Lemma 14.4(ii)],

$$
L^{G}=\bigcap_{g \in G} L^{g} k G
$$

Lemma 1.6. Induction of ideals is transitive: if $H$ and $K$ are open subgroups of $G$ with $H \leq K \leq G$, and $L \triangleleft k H$, then $L^{G}=\left(L^{K}\right)^{G}$.

Proof. Let $N$ be an open normal subgroup of $G$ contained in $H$, and write $\overline{(\cdot)}$ to denote the quotient by $N$, so that we have $k G=k N * \bar{G}$ with $\bar{H} \leq \bar{K} \leq \bar{G}$, and we may view $L$ as an ideal of $k N * \bar{H}$. The result now follows from [13, Lemma 1.2(iii)].

### 1.3 Krull dimension

We recall some facts about Krull dimension, used here in the sense of Gabriel and Rentschler: see [7, §15].

Definition 1.7. Let $0 \neq M$ be an $R$-module, and fix some ordinal $\alpha$. We define the following notation inductively:

- $\operatorname{Kdim}(M)=0$ if $M$ is an Artinian module,
- $\operatorname{Kdim}(M) \leq \alpha$ if, for every descending chain

$$
M_{0} \geq M_{1} \geq M_{2} \geq \ldots
$$

of submodules of $M$, we have $\operatorname{Kdim}\left(M_{i} / M_{i+1}\right)<\alpha$ for all but finitely many $i$.
Of course, if there exists some $\alpha$ such that $\operatorname{Kdim}(M) \leq \alpha$, but we do not have $\operatorname{Kdim}(M) \leq \beta$ for any $\beta<\alpha$, then we write $\operatorname{Kdim}(M)=\alpha$.

Remark. $\operatorname{Kdim}(M)$ is a measure of complexity of the poset of submodules of M.
$\operatorname{Kdim}(M)$ may not be defined for some modules $M$ - that is, we may not have $\operatorname{Kdim}(M) \leq \alpha$ for any ordinal $\alpha$. However, if $M$ is a noetherian module, then $\operatorname{Kdim}(M)$ is defined [7, Lemma 15.3].
Definition 1.8. Suppose that $\operatorname{Kdim}(M)=\alpha$. We say that $M$ is $\alpha$-homogeneous if $\operatorname{Kim}(N)=\alpha$ for all nonzero submodules $N$ of $M$.

Examples 1.9.
(i) Nonzero Artinian modules are 0-homogeneous.
(ii) Prime rings $R$, as modules over themselves, are $\alpha$-homogeneous (where we set $\alpha$ equal to $\operatorname{Kdim}\left(R_{R}\right)$ ) [7, Exercise 15E].
(iii) The property of being $\alpha$-homogeneous is inherited by products [7, Corollary 15.2] and (nonzero) submodules (by definition).

We now cite and adapt some standard results on Krull dimension.

## Lemma 1.10.

(i) [11, 1.4(ii)] Let the ring $R$ be $\alpha$-homogeneous as a right $R$-module. If $x \in R$ satisfies $\operatorname{Kdim}(R / x R)<\mathrm{K} \operatorname{dim}(R)$, then $x$ is a regular element of $R$.
(ii) [10, Théorème 5.3] Suppose $B$ is a finite normalising extension of $A$, and let $M$ be a $B$-module. Then $\operatorname{Kdim}\left(M_{B}\right)$ exists if and only if $\operatorname{Kdim}\left(M_{A}\right)$ does, and if so, then they are equal.
(iii) [7, Exercise 15 R ] If $R$ is a right noetherian subring of a ring $S$ such that $S$ is finitely generated as an $R$-module, and $M$ is a finitely generated $S$-module, then $\operatorname{Kdim}\left(M_{S}\right) \leq \operatorname{Kdim}\left(M_{R}\right)$.
Corollary 1.11. Suppose $A \subseteq C \subseteq B$ are right noetherian rings, and $B$ is a finite normalising extension of $A$. Let $M$ be a finitely generated $B$-module. Then, if $\operatorname{Kdim}\left(M_{B}\right)$ exists, we have

$$
\operatorname{Kdim}\left(M_{A}\right)=\mathrm{K} \operatorname{dim}\left(M_{C}\right)=\mathrm{K} \operatorname{dim}\left(M_{B}\right) .
$$

Proof. This follows immediately from Lemma 1.10(ii) and two applications of Lemma 1.10(iii).

Lemma 1.12. Let $G$ be a compact $p$-adic analytic group, $H$ an open subgroup of $G$, and $k$ a field of characteristic $p$. Let $M$ be a finitely generated $k G$-module.
(i) $\operatorname{Kdim}\left(M_{k G}\right)=\mathrm{K} \operatorname{dim}\left(M_{k H}\right)$.
(ii) Suppose that $M=W k G$ for some submodule $W$ of $M_{k H}$. Then we have $\operatorname{Kdim}\left(M_{k G}\right)=\operatorname{Kdim}\left(W_{k H}\right)$.
(iii) $M_{k G}$ is $\alpha$-homogeneous if and only if $M_{k H}$ is $\alpha$-homogeneous.

Proof. (Adapted from [11, 1.4(iii)-(v)].)
(i) Let $N$ be the (open) largest normal subgroup of $G$ contained in $H$, so that $k G$ is a finite normalising extension of $k N$. Now apply Corollary 1.11,
(ii) Let $N$ be as in (i). Then, by (i), it suffices to prove that $\operatorname{Kdim}\left(M_{k N}\right)=\operatorname{Kdim}\left(W_{k N}\right)$. But, as a $k N$-module, $M$ is a finite sum of modules $(W g)_{k N}$ for various $g \in G$, and these are all isomorphic, so in particular have isomorphic submodule lattices and therefore the same Kdim.
(iii) It is clear from the definition that, if $M_{k H}$ is $\alpha$-homogeneous, then $M_{k G}$ is $\alpha$-homogeneous. Conversely, suppose that $M_{k G}$ is $\alpha$-homogeneous, and let $W$ be a nonzero submodule of $M_{k H}$. Then $(W k G)_{k G}$ is a nonzero submodule of $M_{k G}$, so has Krull dimension $\alpha$ by assumption, and hence also $\operatorname{Kdim}\left(W_{k H}\right)=\alpha$ by (ii).
Lemma 1.13. Let $G$ be a finite group, $H$ a subgroup, and $R * G$ a fixed crossed product. Fix a semiprime ideal $I$ of $R * G$. If $R * G / I$ is $\alpha$-homogeneous, then $R * H /(I \cap R * H)$ is $\alpha$-homogeneous.

Proof. (Adapted from [4, Lemma 4.2(i)].) Let $M$ be a nonzero right ideal of the $\operatorname{ring} R * H /(I \cap R * H)$, and write $\beta=\operatorname{Kdim}\left(M_{R * H}\right)$. We wish to show that $\beta=\alpha$.
$M$ is a right module over both $R * H$ and $R$; and $R * G / I$ is a right module over both $R * G$ and $R$. As $R * G$ and $R * H$ are both finite normalising extensions of $R$, we may apply Lemma 1.10 (ii) to both of these situations to see that

$$
\beta=\mathrm{K} \operatorname{dim}\left(M_{R * H}\right)=\mathrm{K} \operatorname{dim}\left(M_{R}\right)
$$

and

$$
\alpha=\mathrm{K} \operatorname{dim}\left((R * G / I)_{R * G}\right)=\mathrm{K} \operatorname{dim}\left((R * G / I)_{R}\right)
$$

Now, as right $R$-modules, we have

$$
R * H /(I \cap R * H) \cong(R * H+I) / I \leq R * G / I
$$

and so $M$ is isomorphic to some nonzero $R$-submodule of $R * G / I$. In particular, this means that

$$
\beta=\mathrm{K} \operatorname{dim}\left(M_{R}\right) \leq \operatorname{K} \operatorname{dim}\left((R * G / I)_{R}\right)=\alpha
$$

But now $(R * G / I)_{R}$ is $\alpha$-homogeneous by Corollary 1.11, so we must have $\beta=\alpha$.
Corollary 1.14. Let $G$ be a compact $p$-adic analytic group, $H$ be an open subgroup of $G$, and $N$ the largest open normal subgroup of $G$ contained in $H$. Take $k$ to be a field of characteristic $p$, and let $Q$ be a prime ideal of $k H$, $I=Q^{G} \cap k N$, and $\alpha=\operatorname{Kdim}(k H / Q)$. Then $k H / Q, k G / Q^{G}, k G / I k G$ are all $\alpha$-homogeneous rings.

Proof. As we observed in Example 1.9 (ii), $k H / Q$ is already $\alpha$-homogeneous, as it is prime of Krull dimension $\alpha$.

We know from Definition 1.5 that the ideal $Q^{G}$ can be written as $\bigcap_{g \in G} Q^{g} k G$, and that this intersection can be taken to be finite. Hence, as a right $k G$ module, $k G / Q^{G}$ is isomorphic to a (nonzero) submodule of the direct product of the various (finitely many) $k G / Q^{g} k G$; and each $k G / Q^{g} k G$ is generated as a $k G$-module by $k H^{g} / Q^{g}$, which is ring-isomorphic to $k H / Q$. Hence $\operatorname{Kdim}\left(k G / Q^{G}\right)=\operatorname{Kdim}(k H / Q)$ by Lemma 1.10(ii).

Finally, as $Q^{G}=\bigcap_{g \in G}(Q k G)^{g}$, we see that

$$
I=\bigcap_{g \in G}(Q k G)^{g} \cap k N=\bigcap_{g \in G}(Q k G \cap k N)^{g}=\bigcap_{g \in G}(Q \cap k N)^{g},
$$

and so, as above, $k N / I$ is a (nonzero) subdirect product of the various $k N /(Q \cap k N)^{g}$, which are all ring-isomorphic to $k N / Q \cap k N$; now Lemma 1.13 implies that $k N / Q \cap k N$ is $\alpha$-homogeneous, so $k N / I$ is also, and $k G / I k G$ is generated as a $k G$-module by $k N / I$, so finally $k G / I k G$ also inherits this property.

We borrow a result from the standard proof of Goldie's theorem.
Lemma 1.15. [21, Lemma 3.13] Suppose $R$ is a semiprime ring, satisfying the ascending chain condition on right annihilators of elements, and which does not contain an infinite direct sum of nonzero right ideals. If $I$ is an essential right ideal of $R$ (i.e. a right ideal that has nonzero intersection $I \cap J$ with each nonzero right ideal $J$ of $R$ ), then $I$ contains a regular element.

These hypotheses are satisfied when $R$ is $G$-prime and noetherian, for example.
Proposition 1.16. With notation as in Corollary 1.14 suppose $P$ is a prime ideal of $k G$ containing $Q^{G}$. If $P$ is minimal over $Q^{G}$, then $h(P)=h(Q)$.

Proof. First, set $I=Q^{G} \cap k N$. This is a $G$-prime ideal contained in $P \cap k N$.
Suppose for contradiction that the inclusion $I \subseteq P \cap k N$ is strict.
First, we will show that $P \cap k N / I$ is essential as a right ideal inside $k N / I$. Indeed, the left annihilator $L$ in $k N / I$ of $P \cap k N / I$ is a $G$-invariant ideal which annihilates the nonzero $G$-invariant ideal $P \cap k N / I$, so we must have $L=0$; and so, given any right ideal $T$ of $k N / I$ having zero intersection with $P \cap k N / I$, as we must have $T \leq L$, we conclude that $T=0$.

Hence, by Lemma 1.15, we may find an element $c \in P \cap k N \subseteq k N$ which is regular modulo $I$. As $k G / I k G$ is a free $k N / I$-module, $c$ may also be considered as an element of $P \subseteq k G$ which is regular modulo $I k G$. Hence

$$
\begin{array}{rlr}
\operatorname{Kdim}(k G & \left./\left(Q^{G}+c k G\right)\right)_{k G} & \\
& \leq \operatorname{Kim}(k G /(I k G+c k G))_{k G} & \text { as } I k G+c k G \subseteq Q^{G}+c k G \\
& <\operatorname{Kim}(k G / I k G)_{k G} & \text { by Lemma 1.10(i) } \\
& =K \operatorname{dim}\left(k G / Q^{G}\right)_{k G} & \text { by Corollary 1.14 }
\end{array}
$$

which, again by Lemma 1.10(i), shows that $c \in P$ is regular modulo $Q^{G}$.
However, we may now deduce from a reduced rank argument that $P$ cannot be minimal over $Q^{G}$, as follows. Write $\rho$ for the reduced rank [7, §11, Definition] of a right module over the semiprime noetherian (hence Goldie) ring $R=k G / Q^{G}$, and write $\overline{(\cdot)}$ for images under the map $k G \rightarrow R$. Now, $c \in P$ implies $\bar{c} R \subseteq \bar{P}$, and so by [7] Lemma 11.3] we have $\rho(R / \bar{c} R) \geq \rho(R / \bar{P}) \geq 0$. Further, if $\bar{c}$ is a
regular element of $R$, then $\bar{c} R \cong R$ as right $R$-modules, so $\rho(R / \bar{c} R)=0$, again by [7, Lemma 11.3]. But now [7, Exercise 11C] implies that $\bar{P}$ cannot be a minimal prime of $R$.

This contradicts the assumption we made at the start of the proof, and so we have shown that $P \cap k N=Q^{G} \cap k N$.

We observed during the proof of Corollary 1.14 that

$$
Q^{G} \cap k N=\bigcap_{g \in G}(Q \cap k N)^{g}
$$

But $Q$ is a prime ideal of $k H$, so $Q \cap k N$ is an $H$-prime ideal of $k N$, so may be written as

$$
Q \cap k N=\bigcap_{h \in H} Q_{0}^{h}
$$

for some prime ideal $Q_{0}$ of $k N$. Combining these two shows that

$$
P \cap k N=Q^{G} \cap k N=\bigcap_{g \in G} Q_{0}^{g} .
$$

Now, by applying [15, corollary 16.8] to both $P \cap k N$ and $Q \cap k N$, we have that

$$
h(P)=h\left(Q_{0}\right)=h(Q)
$$

as required.

## 2 Control theorem

### 2.1 The abelian case

We will require some facts about prime ideals in power series rings.
Lemma 2.1. Let $A$ be a free abelian pro- $p$ group of finite rank and $B$ a closed isolated (normal) subgroup. Take $k$ to be a field of characteristic $p$. Write $\operatorname{Spec}^{B}(k A)$ for the set of primes of $k A$ that are controlled by $B$. Then the maps

$$
\begin{aligned}
\operatorname{Spec}^{B}(k A) & \leftrightarrow \operatorname{Spec}(k B) \\
P & \mapsto P \cap k B \\
Q k A & \leftrightarrow Q
\end{aligned}
$$

are well-defined and mutual inverses, and preserve faithfulness.
Proof. If $P$ is a prime ideal of $k A$, then $P \cap k B$ is an $A$-prime ideal (and hence a prime ideal) of $k B$ by Lemma 1.2(i).

Conversely, note that, as $B$ is isolated in $A$, the quotient $A / B$ is again free abelian pro- $p$; so we may write $A=B \oplus C$, where the natural quotient map $A \rightarrow A / B$ induces an isomorphism $A / B \cong C$. Now, if $Q$ is a prime ideal of $k B$, then $k A / Q k A=(k B / Q)[[C]]$ is a power series ring with coefficients in the commutative domain $k B / Q$, and is hence itself a domain.

It follows from [1, Lemma 5.1] that $Q k A \cap k B=Q$, and by assumption, if $P$ is controlled by $B$ then we already have $(P \cap k B) k A=P$.

Now suppose the prime ideals $P \triangleleft k A$ and $Q \triangleleft k B$ correspond under these maps. Then, again viewing $A$ as $B \oplus C$, we may similarly consider $k A / P$ as the completed tensor product [25, Definition 2.3] $k B / Q \underset{k}{\hat{\otimes}} k C$. Then the map $A \rightarrow(k A / P)^{\times}$can be written as

$$
\begin{aligned}
B \oplus C & \rightarrow(k B / Q)^{\times} \oplus(k C)^{\times} \lesssim(k B / Q \underset{k}{\hat{\otimes}} k C)^{\times} \\
(b, c) & \mapsto((b+Q), c),
\end{aligned}
$$

so it is clear that $P$ is faithful if and only if $Q$ is faithful.
Lemma 2.2. Let $A, B, k$ be as in Lemma 2.1. Take two neighbouring prime ideals $P \lesseqgtr Q$ of $k A$, and suppose $B$ controls $P$. Then
(i) $h(P)+\operatorname{dim}(A / P)=r(A)$,
(ii) $h(Q)=h(P)+1$,
(iii) $h(P)=h(P \cap k B)$.

Proof.
(i) This follows from [18, Ch. VII, §10, Corollary 1].
(ii) This follows from [18, Ch. VII, §10, Corollary 2].
(iii) Under the correspondence of Lemma 2.1, any saturated chain of prime ideals $0=Q_{0} \lesseqgtr Q_{1} \lesseqgtr \cdots \lesseqgtr Q_{n}=P \cap k B$ of $k B$ extends to a chain of prime ideals $0=P_{0} \lesseqgtr P_{1} \lesseqgtr \cdots \lesseqgtr P_{n}=P$ of $k A$. As any two saturated chains of prime ideals in $k A$ have the same length [18, Ch. VII, $\S 10$, Theorem 34 and Corollary 1], we need only check that this chain is saturated.

Take two adjacent prime ideals $I_{1} \leftrightharpoons I_{2}$ of $k B$, so that $h\left(I_{2}\right)=h\left(I_{1}\right)+1$ [18, Ch. VII, $\S 10$, Corollary 2] and $I_{1} k A \not I_{2} k A$ are prime. We will show that $I_{1} k A$ and $I_{2} k A$ are adjacent by showing that their heights also differ by 1. By performing induction on $r(A / B)$, it will suffice to prove this for the case $r(A / B)=1$, i.e. $k A=k B[[X]]$.
It is clear that, when $R$ is a commutative ring, $\operatorname{dim}(R[[X]]) \geq 1+\operatorname{dim}(R)$ (where dim denotes the classical Krull dimension). But, giving $R[[X]]$ the $(X)$-adic filtration, we see that $\operatorname{gr}(R[[X]]) \cong R[x]$. By [14, 6.5.6], we have
$\operatorname{dim}(R[[X]]) \leq \operatorname{dim}(\operatorname{gr}(R[[X]]))=\operatorname{dim}(R[x])=1+\operatorname{dim}(R)$, where this last equality follows from [14, 6.5.4(i)].

Hence, for any prime ideal $I$, we have

$$
\operatorname{dim}(k A / I k A)-\operatorname{dim}(k B / I)=\operatorname{dim}((k B / I)[[X]])-\operatorname{dim}(k B / I)=1
$$

But, from (i), we see that

$$
\begin{aligned}
\operatorname{dim}(k A / I k A) & =r(A)-h(I k A) \\
\operatorname{dim}(k B / I) & =r(B)-h(I)
\end{aligned}
$$

and hence we conclude that $h(I)=h(\operatorname{IkA})$. Setting $I=I_{1}, I_{2}$ now shows that $h\left(I_{2} k A\right)=h\left(I_{1} k A\right)+1$ as required.

### 2.2 Faithful primes are controlled by $\Delta$

As in [23], if $P$ is a prime ideal of some completed group ring $k G$, we will write $P^{\dagger}:=\operatorname{ker}\left(G \rightarrow(k G / P)^{\times}\right)$, and say that $P$ is faithful if $P^{\dagger}=1$ and $P$ is almost faithful if $P^{\dagger}$ is finite.
Fix a prime $p$, which will be arbitrary until otherwise stated.
Recall the control theorem of Ardakov [2, 8.6]:
Theorem 2.3. Let $G$ be a nilpotent $p$-valued group of finite rank with centre $Z$.
(i) If $\mathfrak{p}$ is a prime ideal of $k Z$, then $\mathfrak{p k G}$ is a prime ideal of $k G$.
(ii) If $P$ is a faithful prime ideal of $k G$, then $P$ is controlled by $Z$.

Proof. This is [2, 8.4, 8.6].
Lemma 2.4. Let $G$ be finite-by-(nilpotent $p$-valuable), i.e. $G=\mathbf{F N}_{p}(G)$. Then $Z\left(G / \Delta^{+}\right)=\Delta / \Delta^{+}$.

Proof. Given $x \in G$, the two conditions $\left[G / \Delta^{+}: \mathbf{C}_{G / \Delta^{+}}\left(x \Delta^{+}\right)\right]<\infty$ and $\left[G: \mathbf{C}_{G}(x)\right]<\infty$ are equivalent, as $\Delta^{+}$is finite; this shows that we have $\Delta\left(G / \Delta^{+}\right)=\Delta / \Delta^{+}$. Take some $x \in \Delta$, so that $x$ satisfies this condition: then, given arbitrary $g \in G$, there exists some $k$ such that $g^{p^{k}} \Delta^{+} \in \mathbf{C}_{G / \Delta^{+}}\left(x \Delta^{+}\right)$, so that $\left(x^{-1} g x\right)^{p^{k}} \Delta^{+}=g^{p^{k}} \Delta^{+}$, and it now follows from [9, III, 2.1.4] that $x^{-1} g x \Delta^{+}=g \Delta^{+}$. This shows that $\Delta / \Delta^{+} \leq Z\left(G / \Delta^{+}\right)$. Conversely, we must have $Z\left(G / \Delta^{+}\right) \leq \Delta\left(G / \Delta^{+}\right)$by definition.

We extend Theorem 2.3 to:
Proposition 2.5. Let $G$ be a finite-by-(nilpotent $p$-valuable) group and $k$ a finite field of characteristic $p$.
(i) If $\mathfrak{p}$ is a $G$-prime ideal of $k \Delta$, then $\mathfrak{p k} G$ is a prime ideal of $k G$.
(ii) If $P$ is an almost faithful prime ideal of $k G$, then $P$ is controlled by $\Delta$.

Proof. Adopt the notation of [25, Lemma 1.1 and Notation 1.2]. Let $e \in \mathrm{cpi}^{\overline{k \Delta^{+}}}(\mathfrak{p})$, and write $f=\left.e\right|^{G}$. To prove (i), it suffices to prove that the ideal $f \cdot \overline{p k G} \triangleleft f \cdot \overline{k G}$ is prime. But, by the Matrix Units Lemma [25, Lemma 6.1], we have an isomorphism

$$
f \cdot \overline{k G} \cong M_{s}\left(e \cdot \overline{k G_{1}}\right)
$$

where $G_{1}$ is the stabiliser in $G$ of $e$, and under which $f \cdot \overline{\mathfrak{p} k G} \mapsto M_{s}\left(e \cdot \overline{\mathfrak{p}_{1} k G_{1}}\right)$ for some $G_{1}$-prime ideal $\mathfrak{p}_{1}$ of $k\left[\left[\Delta \cap G_{1}\right]\right]$. So, by Morita equivalence, it will suffice to show that the ideal $e \cdot \overline{\mathfrak{p}_{1} k G_{1}} \triangleleft e \cdot \overline{k G_{1}}$ is prime.

Now recall from [25, Theorems A and C] that we have an isomorphism

$$
\psi: e \cdot \overline{k G_{1}} \cong M_{t}\left(k^{\prime}\left[\left[G_{1} / \Delta^{+}\right]\right]\right)
$$

under which $e \cdot \overline{\mathfrak{p}_{1} k G_{1}} \mapsto \mathfrak{q} k^{\prime}\left[\left[G_{1} / \Delta^{+}\right]\right]$for a $\left(G_{1} / \Delta^{+}\right)$-prime ideal $\mathfrak{q}$ of $k^{\prime}\left[\left[\Delta \cap G_{1} / \Delta^{+}\right]\right]$. Hence we need now only show that $\mathfrak{q} k^{\prime} N \triangleleft k^{\prime} N$ is prime, where $N=G_{1} / \Delta^{+}$.
Note that, as $G_{1}$ is open in $G$, we have $\Delta\left(G_{1}\right)=\Delta \cap G_{1}$ [23, Lemma 1.3(ii)]; and from Lemma 2.4, $\Delta\left(G_{1}\right) / \Delta^{+}=Z\left(G_{1} / \Delta^{+}\right)$. Hence, still writing $N=G_{1} / \Delta^{+}$, we see that $\mathfrak{q}$ is an $N$-prime ideal of $k^{\prime}[[Z(N)]]$, and hence a prime ideal. But now $\mathfrak{q} k^{\prime} N$ is prime by Theorem 2.3(i). This establishes part (i) of the proposition.

To show part (ii), take an almost faithful prime ideal $P$ of $k G$. We would like to show that $P$ is a minimal prime ideal above $(P \cap k \Delta) k G$. But this is clearly true when $\Delta^{+}=1$ by Theorem [2.3] and in the general case, another application of the Matrix Units Lemma [25, Lemma 6.1] and [25, Theorems A and C], as above, reduces to the case $\Delta^{+}=1$.

Hence, finally, we need only show that $(P \cap k \Delta) k G$ is prime; but $P \cap k \Delta$ is a $G$-prime ideal of $k \Delta$ (again by Lemma $1.2(\mathrm{i})$ ), so we are done by part (i) of the proposition.

Until the end of this section, we will write $(-)^{\circ}$ to mean $\bigcap_{g \in G}(-)^{g}$.
Corollary 2.6. Let $G$ be a finite-by-(nilpotent $p$-valuable) group, and $H$ an open normal subgroup of $G$ containing $\Delta$. Let $k$ be a finite field of characteristic $p$. If $P$ is an almost faithful $G$-prime ideal of $k H$, then $P k G$ is a prime ideal of $k G$.

Proof. Take a minimal prime $Q$ of $k H$ above $P$. Then we have $Q^{\circ}=P$, so $Q^{\dagger}$ is finite (as $G$ is orbitally sound [23, Definition 1.4, Corollary 2.4]). Hence $Q$ is controlled by $\Delta$, by Proposition [2.5(ii), and by applying $(-)^{\circ}$ to both sides of the equality $Q=(Q \cap k \Delta) k H$, we see that $P$ is also: $P=(P \cap k \Delta) k H$. In particular $P k G=(P \cap k \Delta) k G$. But now Proposition 2.5(i) shows that $(P \cap k \Delta) k G$ is prime.

For the following results, we need to assume that $p>2$ in order to be able to invoke [24, Theorem A].

Proposition 2.7. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$ adic analytic group, and $k$ a finite field of characteristic $p>2$. Let $H=\mathbf{F} \mathbf{N}_{p}(G)$. If $P$ is an almost faithful prime ideal of $k G$, then $P$ is controlled by $H$.

Proof. Let $Q$ be a minimal prime ideal of $k H$ above $P \cap k H$. Then $\left(Q^{\dagger}\right)^{\circ}=P^{\dagger} \cap H$ is finite, so, as $G$ is orbitally sound, $Q^{\dagger}$ is also finite. By [15, Corollary 14.8], in order to prove that $(P \cap k H) k G$ is prime, it suffices to show that $Q k S$ is prime, where $S$ is the stabiliser in $G$ of $Q$.
Let $T=\mathbf{F N}_{p}(S)$. As $H$ is a finite-by-(nilpotent $p$-valuable) open normal subgroup of $S$, we see that $H$ must be an open normal subgroup of $T$. It is also clear that $\Delta(H)=\Delta(T)=\Delta(S)=\Delta(G)$ [23, Lemma 1.3(ii) and Theorem C]. Now, by Corollary [2.6, $Q k T$ must be prime; and we have that $(Q k T)^{\dagger}$ is finite. Now, by the prime extension theorem [24, Theorem A], $(Q k T) k S=Q k S$ is prime.

Lemma 2.8. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, and let $H \geq K$ be any two closed normal subgroups of $G$. Take $P$ to be a prime ideal of $k G$. Let $Q$ be a minimal prime ideal of $k H$ above $P \cap k H$. If $P$ is controlled by $H$ and $Q$ is controlled by $K$, then $P$ is controlled by $K$.

Proof. By Lemma 1.2 (ii), we have $Q^{\circ}=P \cap k H$, and so

$$
\begin{array}{rlr}
(P \cap k K) k G & =((P \cap k H) \cap k K) k G & \\
& =\left(Q^{\circ} \cap k K\right) k G & \\
& =(Q \cap k K)^{\circ} k G & \\
& =((Q \cap k K) k H)^{\circ} k G & \\
& =Q^{\circ} k G & \\
& =(P \cap k H) k G=P & \text { as } H \text { is normal in } G \\
& \text { as } Q \text { is controlled by } K \\
& \text { as } P \text { is controlled by } H .
\end{array}
$$

Now back to:
Theorem 2.9. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, $k$ a finite field of characteristic $p>2$, and $P$ an almost faithful prime ideal of $k G$. Then $P$ is controlled by $\Delta$.

Proof. Proposition 2.7 shows that $P$ is controlled by $H$. Let $Q$ be a minimal prime of $k H$ above $P \cap k H$ : then $Q^{\circ}=P \cap k H$ by Lemma 1.2(ii), so we see that $\left(Q^{\dagger}\right)^{\circ}=P^{\dagger} \cap H$ is finite, so (as $G$ is orbitally sound) $Q^{\dagger}$ must also be finite. Hence, as $Q$ is almost faithful, Proposition 2.5 (ii) shows that it is controlled by $\Delta$. Now Lemma 2.8 applies.

### 2.3 Primes adjacent to faithful primes

We begin with a property of the "finite-by-(nilpotent $p$-valuable) radical" operator.

Lemma 2.10. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, let $N$ be a normal subgroup of $G$ which is contained in $\Delta$, and let $F$ be a finite normal subgroup of $G$. Then the following three statements hold.
(i) $\mathbf{F N}_{p}(G / F)=\mathbf{F} \mathbf{N}_{p}(G) / F$.
(ii) $\operatorname{Suppose~that~}_{\mathbf{F N}}^{p} 1\left(G / \mathrm{i}_{\Delta}(N)\right)=\mathbf{F N}_{p}(G) / \mathrm{i}_{\Delta}(N)$. Then $\mathbf{F} \mathbf{N}_{p}(G / N)=\mathbf{F N}_{p}(G) / N$.
(iii) Suppose $N$ is $\Delta$-isolated. Then we have either $\mathbf{F N}_{p}(G / N)=\mathbf{F N}_{p}(G) / N$ or $N=\Delta=\mathbf{F N}_{p}(G)$.

## Proof.

(i) This is clear from the construction of $\mathbf{F N}(G)$ (see [23, Definition 5.3]).
(ii) First, note that $\mathbf{F} \mathbf{N}_{p}(G) / N$ is a quotient of a finite-by-(nilpotent $p$-valuable) normal subgroup of $G$, and hence is still a finite-by-(nilpotent $p$-valuable) normal subgroup of $G / N$, i.e. $\mathbf{F N}_{p}(G) / N \leq \mathbf{F N}_{p}(G / N)$. As both of these are of finite index in $G$, it will suffice to show that these indices are equal.

Consider the natural surjection $\alpha: G / N \rightarrow G / \mathrm{i}_{\Delta}(N)$. We can see that

$$
\operatorname{ker} \alpha=\mathrm{i}_{\Delta}(N) / N=\Delta^{+}(\Delta / N) \leq \Delta^{+}(G / N) \leq \mathbf{F N}_{p}(G / N)
$$

is a finite normal subgroup of $G / N$, and hence from (i) we see that

$$
\frac{\mathbf{F N}_{p}(G / N)}{\mathrm{i}_{\Delta}(N) / N} \cong \mathbf{F N}_{p}\left(G / \mathrm{i}_{\Delta}(N)\right)
$$

That is, the restricted map

$$
\left.\alpha\right|_{\mathbf{F N}_{p}(G / N)}: \mathbf{F} \mathbf{N}_{p}(G / N) \rightarrow \mathbf{F N}_{p}\left(G / \mathrm{i}_{\Delta}(N)\right)
$$

is also surjective with kernel $\mathrm{i}_{\Delta}(N) / N$. Hence we have the following commutative diagram, in which the first two rows are exact, all three columns are exact, and $C_{1}$ and $C_{2}$ are the cokernels of the vertical maps.


By the Nine Lemma [8, Chapter XII, Lemma 3.4], the third row is now also exact, so that $C_{1} \cong C_{2}$. But by assumption, $C_{2} \cong G / \mathbf{F N}(G)$, and hence

$$
\left[G / N: \mathbf{F N}_{p}(G / N)\right]=\left|C_{1}\right|=\left[G: \mathbf{F} \mathbf{N}_{p}(G)\right]=\left[G / N, \mathbf{F N}_{p}(G) / N\right]
$$

as required.
(iii) Case 1. First, assume that $\Delta^{+}=1$.

Write $H=\mathbf{F N}_{p}(G)$, and $\widehat{H}$ for the preimage of $\widehat{H} / N=\mathbf{F N}_{p}(G / N)$.
If $G=\mathbf{F N}_{p}(G)$, then we clearly have $\mathbf{F N}_{p}(G / N)=\mathbf{F} \mathbf{N}_{p}(G) / N$ for any closed normal subgroup $N$. So suppose that $H \lesseqgtr \widehat{H} \leq G$, and take some $z \in \widehat{H} \backslash H$. Now conjugation by $z$ induces the automorphism $x \mapsto x^{\zeta}$ on $H / H^{\prime}$ (where $H^{\prime}$ denotes the isolated derived subgroup), and hence also on $H / H^{\prime} N$, for some $\zeta \in t\left(\mathbb{Z}_{p}^{\times}\right)$[23, Lemma 4.2] satisfying $\zeta \neq 1$ [24, Lemma 3.3].

If $H / H^{\prime} N$ has nonzero rank, we may take an element $x \in H$ whose image in $H / H^{\prime} N$ has infinite order; and now the image in $\widehat{H} / H^{\prime} N$ of $\overline{\langle x, z\rangle}$ is not finite-by-nilpotent, contradicting the definition of $\widehat{H}$. So we must have $H=\mathrm{i}_{H}\left(H^{\prime} N\right)$.

In particular, this implies that $H=\mathrm{i}_{H}\left(H^{\prime} Z\right)$, where $Z=Z(H)=\Delta(G)$, and so, by [24, Lemma 3.5], we see that $H$ is abelian, i.e. $H=\Delta$. Furthermore, this implies that $H^{\prime}=1$, and as $N$ is already $H$-isolated (because $\Delta$ is $H$-isolated), the equality $H=\mathrm{i}_{H}\left(H^{\prime} N\right)$ simplifies to give $H=N$. This is what we wanted to prove.
Case 2. Now suppose instead that $\Delta^{+} \neq 1$. As $N$ is isolated in $G$, we see that
$-\Delta^{+} \leq N$, and $N / \Delta^{+}$is isolated normal inside $G / \Delta^{+}$, contained in $\Delta / \Delta^{+}$;

$$
\begin{aligned}
& -\Delta^{+}\left(G / \Delta^{+}\right)=1 \\
& -\Delta\left(G / \Delta^{+}\right)=\Delta / \Delta^{+}=Z\left(\mathbf{F N}_{p}(G) / \Delta^{+}\right) \\
& -\mathbf{F N}_{p}\left(G / \Delta^{+}\right)=\mathbf{F N}_{p}(G) / \Delta^{+}
\end{aligned}
$$

and so the result follows by applying Case 1 to $G / \Delta^{+}$.
Remark. If $G$ is a compact $p$-adic analytic group, $H$ is a closed normal subgroup, and $Q$ is a $G$-stable ideal of $k H$, then $Q^{\dagger}=(Q+1) \cap H$ is normal in $G$.
Lemma 2.11. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, and let $k$ be a finite field of characteristic $p>2$. If $Q$ is a $G$ prime ideal of $k \Delta$, and $\mathbf{F} \mathbf{N}_{p}\left(G / Q^{\dagger}\right)=\mathbf{F N}_{p}(G) / Q^{\dagger}$, then $Q k G$ is a prime ideal of $k G$.

Remark. The hypothesis

$$
\mathbf{F N}_{p}\left(G / Q^{\dagger}\right)=\mathbf{F} \mathbf{N}_{p}(G) / Q^{\dagger}
$$

has the following consequence. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, $k$ a finite field of characteristic $p>2$, and let $P \lesseqgtr P^{\prime}$ be adjacent prime ideals of $k G$, with $P$ almost faithful. Then $P$ is controlled by $\Delta$, by Theorem [2.9. Set $Q:=P^{\prime} \cap k \Delta$. Consider $i_{\Delta}\left(Q^{\dagger}\right)$ : if this is not equal to $\Delta$, then by Lemma 2.10(ii), (iii), the hypothesis $\ddagger$ is satisfied. So suppose it is equal to $\Delta$. Now, as $Q$ contains the ideal $\operatorname{ker}\left(k G \rightarrow k\left[\left[G / Q^{\dagger}\right]\right]\right)$ (the augmentation ideal of $Q^{\dagger}$ ), if we further have that $\mathbf{F N _ { p }}(G)=\Delta$, then $k G / Q$ is a finite prime ring, which is therefore simple, and so $Q$ must be a maximal ideal of $k G$ of $\mathrm{i}_{G}(\Delta)=G$; otherwise, we again have $\ddagger$ ) by Lemma 2.10(ii), (iii).
That is, under these conditions, we always have $\ddagger$ unless $Q$ is a maximal ideal of $k G$ and $G$ is virtually abelian, in which case $Q^{\dagger}$ is open in $G$.

## Proof. Write $H=\mathbf{F N}_{p}(G)$.

As $Q$ is a $G$-prime, we may write it as $\bigcap_{g \in G} I^{g}$ for some minimal prime ideal $I$ above $Q$. Suppose the $G$-orbit of $I$ splits into distinct $H$-orbits $\mathcal{O}_{1}, \ldots, \mathcal{O}_{r}$, and write $P_{i}:=\bigcap_{A \in \mathcal{O}_{i}} A$. Then $P_{i}$ is an $H$-prime of $k \Delta$, and $\bigcap_{i=1}^{r} P_{i}=Q$. In particular, since $P_{i}$ is an $H$-prime of $k \Delta$, we have that $P_{i} k H$ is prime by Proposition 2.5(i).
It remains to show that $\left(\bigcap_{g \in G}\left(P_{i} k H\right)^{g}\right) k G$ is prime. By [15, Corollary 14.8], it suffices to show that $P_{i} k S$ is prime, where $S=\operatorname{Stab}_{G}\left(P_{i}\right)$.
Write $\mathfrak{p}=P_{i} k H$, and note that $\mathfrak{p}^{\dagger}=P_{i}^{\dagger} \leq \Delta$. Now, if $\mathbf{F N}_{p}(G) / \Delta^{+}$is nonabelian, we have $\mathbf{F N}_{p}\left(S / \mathfrak{p}^{\dagger}\right)=\mathbf{F N}_{p}(S) / \mathfrak{p}^{\dagger}$. If, on the other hand, $\mathbf{F N}_{p}(G) / \Delta^{+}$ is abelian, then we must have $Q^{\dagger} \leftrightarrows \Delta$, and as $Q^{\dagger}$ is $H$-isolated orbital, we have [ $\left.\Delta: Q^{\dagger}\right]=\infty$. But as $G$ is orbitally sound, and $Q^{\dagger}=\bigcap_{g \in G}\left(P_{i}^{\dagger}\right)^{g}$, we must have that $Q^{\dagger}$ is open in $P_{i}^{\dagger}$, so that in particular $\left[\Delta: \mathfrak{p}^{\dagger}\right]=\infty$. Hence again we have $\mathbf{F N}_{p}\left(S / \mathfrak{p}^{\dagger}\right)=\mathbf{F N}_{p}(S) / \mathfrak{p}^{\dagger}$.

Write $\overline{(\cdot)}$ for the quotient map $S \rightarrow S / \mathfrak{p}^{\dagger}$. Now, to show that $P_{i} k S=\mathfrak{p} k S$ is prime, we need only show that $\overline{\mathfrak{p}} k \bar{S}$ is prime. But $\overline{\mathfrak{p}}$ is a faithful prime ideal of $k \bar{H}$, and $\bar{H}=\mathbf{F N}_{p}(\bar{S})$, so by [24, Theorem A], we are done.

Lemma 2.12. Let $k$ be a finite field of characteristic $p>2$. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, and let $P \lesseqgtr Q$ be adjacent prime ideals of $k G$, with $P$ almost faithful. Suppose that $Q$ is not a maximal ideal of $k G$. Then $Q$ is controlled by $\Delta$.

Proof. $Q \cap k \Delta$ is a $G$-prime of $k \Delta$, and so $(Q \cap k \Delta) k G$ is prime by Lemma 2.11 and the accompanying remark. But

$$
P=(P \cap k \Delta) k G \leq(Q \cap k \Delta) k G \leq Q
$$

(with the equality as a result of Theorem 2.9), and $P$ and $Q$ are adjacent, so $(Q \cap k \Delta) k G$ must equal either $P$ or $Q$.

Let us assume for contradiction that $(Q \cap k \Delta) k G=P$. Then we must have

$$
P \cap k \Delta \leq Q \cap k \Delta \leq(Q \cap k \Delta) k G=P
$$

and by intersecting each of these with $k \Delta$, we see that $P \cap k \Delta=Q \cap k \Delta$. In particular, by taking $(\cdot)^{\dagger}$ of both sides of this equality, we see that $Q^{\dagger} \cap \Delta$ is finite (as $P$ is almost faithful).

Let $N$ be an open normal nilpotent $p$-valued subgroup of $G$, and let $Z=Z(N)$. By [23, Lemma 1.3(ii)], $Z=\Delta(N)$ is a finite-index torsion-free subgroup of $\Delta$, and so $Q^{\dagger} \cap Z=1$. Now, as $N$ is nilpotent and the normal subgroup $Q^{\dagger} \cap N$ has trivial intersection with its centre, [16, 5.2.1] implies that $Q^{\dagger} \cap N=1$, and hence $Q^{\dagger}$ must be a finite normal subgroup of $G$. So $Q^{\dagger} \leq \Delta^{+}$, and in particular $Q^{\dagger}=Q^{\dagger} \cap \Delta$, which we earlier determined is finite. Hence $Q$ is almost faithful, and must be controlled by $\Delta$ by Theorem 2.9. In particular, we must have $P \cap k \Delta \neq Q \cap k \Delta$. But this contradicts our assumption.

## 3 Catenarity

### 3.1 The orbitally sound case: plinths and a height function

Much of the material in this subsection is adapted from [17].
Unless stated otherwise, throughout this section, $G$ is an arbitrary compact $p$-adic analytic group, and $k$ is a finite field of characteristic $p$. We start by outlining our plan of attack:

Lemma 3.1. Let $R$ be a ring in which every prime ideal has finite height. Suppose we are given a function $h: \operatorname{Spec}(R) \rightarrow \mathbb{N}$ satisfying

- $h(P)=0$ whenever $P$ is a minimal prime of $R$,
- $h\left(P^{\prime}\right)=h(P)+1$ for each pair of adjacent primes $P \lesseqgtr P^{\prime}$ of $R$.

Then $R$ is a catenary ring.
Proof. Obvious.
Lemma 3.2. $k G$ has finite classical Krull dimension, i.e. the maximal length of any chain of prime ideals is bounded.

Proof. The classical Krull dimension of $k G$ is bounded above by $\operatorname{Kdim}(k G)$ by [14) Lemma 6.4.5], which is equal to $\operatorname{Kdim}\left(\mathbb{F}_{p} G\right)$ by [14, Proposition 6.6.16(ii)], and this is bounded above by the dimension (in the sense of [5, Theorem 8.36]) of $G$, which is finite by definition (see the remarks after [5, Definition 3.12]).

Definition 3.3. Let $V$ be a $\mathbb{Q}_{p} G$-module, and suppose it has finite dimension as a vector space over $\mathbb{Q}_{p}$. Take a chain

$$
0=V_{0} \lesseqgtr V_{1} \lesseqgtr \cdots \lesseqgtr V_{r}=V
$$

of $G$-orbital subspaces - that is, $\mathbb{Q}_{p}$-vector subspaces of $V$ with finitely many $G$-conjugates, or equivalently $\mathbb{Q}_{p}$-vector subspaces that are $\mathbb{Q}_{p} N$-submodules for some open subgroup $N$ of $G$. Assume further that this chain is saturated, in the sense that it cannot be made longer by the addition of some $G$-orbital subspace $V_{i} \leq V^{\prime} \leq V_{i+1}$. Such a chain is necessarily finite, as it is bounded above in length by $\operatorname{dim}_{\mathbb{Q}_{p}}(V)+1$. We call the number $r$ the $G$-plinth length of $V$, written $p_{G}(V)$. If $p_{G}(V)=1$, we say that $V$ is a plinth for $G$.
Remark. The number $r$ is independent of the $V_{i}$ chosen. Indeed, fix a longest possible chain

$$
0=V_{0} \lesseqgtr V_{1} \lesseqgtr \cdots \lesseqgtr V_{r}=V
$$

of $G$-orbital subspaces, and let $G_{0}$ be the intersection of the normalisers $\mathbf{N}_{G}\left(V_{i}\right)$, i.e. the largest subgroup of $G$ such that each $V_{i}$ is a $\mathbb{Q}_{p} G_{0}$-module. $G_{0}$ is open in $G$. Now, given any chain

$$
0=W_{0} \lesseqgtr W_{1} \lesseqgtr \cdots \lesseqgtr W_{s}=V
$$

of $G$-orbital subspaces, take $H_{0}=\bigcap_{j=1}^{s} \mathbf{N}_{G}\left(W_{j}\right)$, and note that $G_{0} \cap H_{0}$ is a finite-index open subgroup of $G$ that normalises each $V_{i}$ and $W_{j}$. Hence, by the Jordan-Hölder theorem [7] Theorem 4.11], the chain $W_{j}$ may be refined to a chain of length $r$; so if the chain $W_{j}$ is saturated, then $s=r$.
Definition 3.4. A $G$-group is a topological group $H$ endowed with a continuous action of $G$. For example, closed subgroups of $G$, and quotients of $G$ by closed normal subgroups of $G$, are $G$-groups under the action of conjugation.

Let $H$ be a nilpotent-by-finite compact $p$-adic analytic group with a continuous action of $G$. We aim to define $p_{G}(H)$. In fact, as plinths are insensitive to
finite factors, we may immediately replace $H$ by the open subgroup formed by the intersection of the (finitely many) $G$-conjugates of any given open normal nilpotent uniform subgroup of $H$. Then there is a series

$$
\begin{equation*}
1=H_{0} \triangleleft H_{1} \triangleleft \cdots \triangleleft H_{n}=H \tag{1}
\end{equation*}
$$

of $G$-subgroups such that $A_{i}=H_{i} / H_{i-1}$ is abelian for each $i=1, \ldots, n$. Let $V_{i}=A_{i} \underset{\mathbb{Z}_{p}}{\otimes} \mathbb{Q}_{p}$ for each $i=1, \ldots, n$, with $G$-action given by conjugation. In this case, we define

$$
p_{G}(H)=\sum_{i=1}^{n} p_{G}\left(V_{i}\right)
$$

Lemma 3.5. $p_{G}(H)$ is well-defined, and does not depend on the series (1).
Proof. Apply the Jordan-Hölder theorem, as in the remark above.
For our purposes, the most important property of $p_{G}$ is that it is additive on short exact sequences of $G$-groups, which also follows from the Jordan-Hölder theorem. We record this as:

Lemma 3.6. Suppose that $1 \longrightarrow A \longrightarrow B \longrightarrow C \longrightarrow 1$ is a short exact sequence of $G$-groups. Then $p_{G}(A)+p_{G}(C)=p_{G}(B)$.
We now define Roseblade's function $\lambda$. (Later, we will show that, in the case when $G$ is nilpotent-by-finite and orbitally sound, $\lambda$ is actually equal to the height function on $\operatorname{Spec}(k G)$.)

## Definition 3.7.

$$
\lambda(P)= \begin{cases}p_{G}\left(P^{\dagger}\right)+\lambda\left(P^{\pi}\right) & P^{\dagger} \neq 1 \\ h_{G}(P \cap k \Delta) & P^{\dagger}=1\end{cases}
$$

where $P^{\pi}$ is the image of $P$ under the map

$$
\pi: k G \rightarrow k G /\left(P^{\dagger}-1\right) k G \cong k\left[\left[G / P^{\dagger}\right]\right]
$$

This definition is recursive, in that if $P$ is an unfaithful prime ideal, then $\lambda(P)$ is defined with reference to $\lambda\left(P^{\pi}\right)$; but $P^{\pi}$ is then a faithful prime ideal of $k G^{\pi}$, so this process terminates after at most two steps.

We make the following remark on this definition immediately:
Lemma 3.8. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, $k$ a finite field of characteristic $p>2$, and $P$ a faithful prime of $k \Delta$. Then $\lambda(P)=h(P)$.

Proof. $\lambda(P)$ is defined to be $h_{G}(P \cap k \Delta)$. But, by Theorem 2.9 and Lemma 2.11, we see that there is a one-to-one, inclusion-preserving correspondence between faithful prime ideals of $k G$ and faithful $G$-prime ideals of $k \Delta$, so that $h_{G}(P \cap k \Delta)=h(P)$.

We return to the general case of $G$ an arbitrary compact $p$-adic analytic group.
Lemma 3.9. Let $P \lesseqgtr Q$ be neighbouring prime ideals of $k G$, and write

$$
\pi: k G \rightarrow k G /\left(P^{\dagger}-1\right) k G \cong k\left[\left[G / P^{\dagger}\right]\right] .
$$

Then

$$
\lambda(Q)-\lambda(P)=\lambda\left(Q^{\pi}\right)-\lambda\left(P^{\pi}\right)
$$

Proof. Firstly, as $P \leq Q$, we have $P^{\dagger} \leq Q^{\dagger}$, so the map

$$
\rho: k G \rightarrow k\left[\left[G / Q^{\dagger}\right]\right]
$$

factors as

$$
k G \xlongequal[\rho]{\stackrel{\pi}{\Longrightarrow} k\left[\left[G / P^{\dagger}\right]\right] \xrightarrow{\sigma}} k\left[\left[G / Q^{\dagger}\right]\right] .
$$

We now compute $\lambda(Q)-\lambda(P)$ using Definition 3.7

$$
\begin{array}{rlrl}
\lambda(Q)-\lambda(P) & =p_{G}\left(Q^{\dagger}\right)-p_{G}\left(P^{\dagger}\right)+\lambda\left(Q^{\rho}\right)-\lambda\left(P^{\pi}\right) & \\
& =p_{G}\left(\left(Q^{\dagger}\right)^{\pi}\right)+\lambda\left(Q^{\rho}\right)-\lambda\left(P^{\pi}\right) & & \text { by Lemma 3.6 } \\
& =p_{G}\left(\left(Q^{\dagger}\right)^{\pi}\right)+\lambda\left(Q^{\pi \sigma}\right)-\lambda\left(P^{\pi}\right) & & \text { by definition of } \rho \\
& =p_{G}\left(\left(Q^{\pi}\right)^{\dagger}\right)+\lambda\left(\left(Q^{\pi}\right)^{\sigma}\right)-\lambda\left(P^{\pi}\right) & & \text { as }\left(Q^{\dagger}\right)^{\pi}=\left(Q^{\pi}\right)^{\dagger} \\
& =\lambda\left(Q^{\pi}\right)-\lambda\left(P^{\pi}\right) & & \text { by Definition 3.7 }
\end{array}
$$

Remark. Suppose $G$ is a nilpotent-by-finite compact $p$-adic analytic group, and suppose we are given a subquotient $A$ of $G$ which is a plinth, with $G$ action induced from the conjugation action of $G$ on itself. Then it is easy to see that $\operatorname{dim}_{\mathbb{Q}_{p}}\left(A \underset{\mathbb{Z}_{p}}{\mathbb{Q}_{p}}\right)=1$. (Roseblade calls such plinths centric.) Indeed, suppose $A=H / K$, where $H$ and $K$ are closed normal subgroups of $G$ with $K$ contained in $H$. Then we may replace $G$ by an open normal nilpotent uniform subgroup $G^{\prime}$, and $A$ by $A^{\prime}=H^{\prime} / K^{\prime}$, where $H^{\prime}=H \cap G^{\prime}$ and $K^{\prime}=\mathrm{i}_{H^{\prime}}\left(K \cap G^{\prime}\right)$; after doing this, we still have that $A^{\prime}$ is a plinth for $G^{\prime}$, and that $\operatorname{dim}_{\mathbb{Q}_{p}}\left(A \mathbb{Z}_{p} \mathbb{Q}_{p}\right)=\operatorname{dim}_{\mathbb{Q}_{p}}\left(A^{\prime} \otimes_{\mathbb{Z}_{p}} \mathbb{Q}_{p}\right)$. But, as $G^{\prime} / K^{\prime}$ is nilpotent, and $A^{\prime}$ is a non-trivial normal subgroup, $A^{\prime}$ must meet the centre $Z\left(G^{\prime} / K^{\prime}\right)$ non-trivially; and as $A^{\prime}$ is torsion-free, we must have that $A^{\prime} \cap Z\left(G^{\prime} / K^{\prime}\right)$ is a plinth for $G^{\prime}$, and so must be equal to $A^{\prime}$. Hence $G^{\prime}$ centralises $A^{\prime}$, and its plinth length is simply equal to its rank.

Again, we will write $(-)^{\circ}$ to mean $\bigcap_{g \in G}(-)^{g}$.
Lemma 3.10. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group. Let $U$ be a $G$-prime of $k \Delta$, and write $\rho: k \Delta \rightarrow k\left[\left[\Delta / U^{\dagger}\right]\right]$. Then $h(U)=h_{G}\left(U^{\rho}\right)+p_{G}\left(U^{\dagger}\right)$.

Proof. Let $A=Z(\Delta)$, and let $U_{1}$ be a minimal prime of $k A$ above $U \cap k A$, so that $U \cap k A=U_{1}^{\circ}$. Then $h_{G}(U)=h\left(U_{1}\right)$ by Corollary 1.4 and so $h_{G}\left(U^{\rho}\right)=h\left(U_{1}^{\rho}\right)$.

Now, from Lemma2.2(i), we have $h\left(U_{1}\right)+\operatorname{dim}\left(k A / U_{1}\right)=r(A)$ and $h\left(U_{1}^{\rho}\right)+\operatorname{dim}\left(k A / U_{1}\right)=r\left(A^{\rho}\right)$, from which we may deduce that

$$
h\left(U_{1}\right)=h\left(U_{1}^{\rho}\right)+r(A)-r\left(A^{\rho}\right)
$$

But $r(A)-r\left(A^{\rho}\right)=r(A \cap \operatorname{ker} \rho)=p_{G}\left(U^{\dagger} \cap A\right)$ by the above remark. Now this is just $p_{G}\left(U^{\dagger}\right)$, as $A$ is open in $\Delta$.

Lemma 3.11. Let $G$ be arbitrary compact $p$-adic analytic. Let $H$ be a closed normal subgroup of $G$, and let $K$ be an open subgroup of $H$ which is normal in $G$. If $P$ is a $G$-prime ideal of $k H$, then $h_{G}(P)=h_{G}(P \cap k K)$.

Proof. [Adapted from [17, Lemma 29].] We know that $P=Q^{\circ}$ for some prime $Q$ of $k H$, and $Q \cap k K=\bigcap_{h \in H} V^{h}$ for some prime $V$ of $k K$. Hence $P \cap k K=V^{\circ}$. Then, writing $h_{G}^{\text {orb }}$ for the height function on $G$-orbital primes,

$$
\begin{aligned}
h_{G}(P) & =h_{G}^{\mathrm{orb}}(Q) & & \text { by Lemma } 1.2(\mathrm{ii}) \\
& =h_{G}^{\mathrm{orb}}(V) & & \text { by Lemma } 1.2(\mathrm{i}) \\
& =h_{G}(P \cap k K) & & \text { by Lemma } 1.2(\mathrm{ii}) .
\end{aligned}
$$

Here, we deduce from Theorem [2.9 and [17, proof of theorem H2] the following corollary:
Theorem 3.12. Let $G$ be a nilpotent-by-finite, orbitally sound compact $p$-adic analytic group, and $k$ a finite field of characteristic $p>2$. Then $k G$ is a catenary ring.

Proof. Let $P \lesseqgtr Q$ be neighbouring prime ideals of $k G$. We will first show that $\lambda(Q)=\lambda(P)+1$.

By passing to $k\left[\left[G / P^{\dagger}\right]\right]$, we may assume that $P$ is a faithful prime ideal, by Lemma 3.9. Hence, by Theorem 2.9 (and as $p>2$ ), we have that $(P \cap k \Delta) k G=P$. We also have either that $(Q \cap k \Delta) k G=Q$, by Lemma 2.12, or $Q^{\dagger} \geq \Delta$ by the remark of Lemma 2.11, and so, in either case, we have $P \cap k \Delta \leq Q \cap k \Delta$.
We will now show that $P \cap k \Delta$ and $Q \cap k \Delta$ are neighbouring $G$-primes of $k \Delta$. Suppose that they are not: then there must be a $G$-prime $J$ strictly between them, i.e. $P \cap k \Delta \leftrightarrows J \lesseqgtr Q \cap k \Delta$. Then, again by Lemma 2.11 and the remark made there, we see that $J k G$ is a prime ideal of $k G$. Now it is clear that $P \leq J k G \leq Q$ by the previous paragraph; and if $J k G=Q$, then intersecting both sides with $k \Delta$ shows that $J=Q \cap k \Delta$, and likewise if $J k G=P$. Hence we must have $P \lesseqgtr J k G \lesseqgtr Q$, so that $P$ and $Q$ are not neighbouring primes. But this contradicts our initial assumptions.
So we conclude that $h_{G}(Q \cap k \Delta)=h_{G}(P \cap k \Delta)+1$. The right hand side is, by definition, just equal to $\lambda(P)+1$; and we have $\lambda(Q)=\lambda\left(Q^{\rho}\right)+p_{G}\left(Q^{\dagger}\right)$, where $\rho: G \rightarrow G / Q^{\dagger}$. It remains to show that this is equal to $h_{G}(Q \cap k \Delta)$.

Case 1. $Q^{\dagger}$ is not open in $G$. Then $Q$ is controlled by $\Delta$ by Lemma 2.12 and the remark of Lemma 2.11, and so $Q^{\rho}$ is controlled by $\Delta^{\rho}$, and in particular by $\mathrm{i}_{G^{\rho}}\left(\Delta^{\rho}\right) \leq \mathrm{i}_{G^{\rho}}\left(\Delta\left(G^{\rho}\right)\right)$. Write $A=Z\left(\Delta\left(G^{\rho}\right)\right)$ and $B=A \cap \mathrm{i}_{G^{\rho}}\left(\Delta^{\rho}\right)$ : as $Q^{\rho}$ is controlled by $\mathrm{i}_{G^{\rho}}\left(\Delta^{\rho}\right)$, we have that $Q^{\rho} \cap k A$ is controlled by $B$. Furthermore, we can write $Q^{\rho} \cap k A=\mathfrak{q}^{\circ}$ for some prime $\mathfrak{q}$ of $k A$, so that $\mathfrak{q}$ is also controlled by $B$, and hence

$$
\begin{array}{rlr}
\lambda\left(Q^{\rho}\right) & =h_{G}\left(Q^{\rho} \cap k\left[\left[\Delta\left(G^{\rho}\right)\right]\right]\right) & \text { by definition } \\
& =h_{G}\left(Q^{\rho} \cap k A\right) & \text { by Lemma 3.11 } \\
& =h(\mathfrak{q}) & \\
& =h(\mathfrak{q} \cap k B) & \text { by Corollary } 1.4 \\
& =h_{G}\left(Q^{\rho} \cap k B\right) & \text { by Lemma 2.2(iii) } \\
& =h_{G}\left(Q^{\rho} \cap k\left[\left[\mathrm{i}_{G^{\rho}}\left(\Delta^{\rho}\right)\right]\right]\right) & \\
& =h_{G}\left(Q^{\rho} \cap k \Delta^{\rho}\right) & \text { by Corollary } 1.4 \\
\hline
\end{array}
$$

We also have $p_{G}\left(Q^{\dagger}\right)=p_{G}\left((Q \cap k \Delta)^{\dagger}\right)$. Hence

$$
\lambda(Q)=h_{G}\left((Q \cap k \Delta)^{\rho}\right)+p_{G}\left((Q \cap k \Delta)^{\dagger}\right)
$$

Now we are done by Lemma 3.10 .
Case 2. $Q^{\dagger}$ is open in $G$. We have already seen that this case only occurs when $G=\mathrm{i}_{G}(\Delta)$, and so $\lambda\left(Q^{\rho}\right)=\lambda(0)=0$, and $p_{G}\left(Q^{\dagger}\right)=p_{G}(G)$, and $h_{G}(Q \cap k \Delta)=h_{G}(Q \cap k A)=r(A)$. These are clearly equal, as $A$ is open in $G$.

In order to invoke Lemma 3.1, it remains only to show that $\lambda(P)=0$ when $P$ is a minimal prime. But as all minimal primes are induced from $\Delta^{+}$, this follows immediately from the definition of $\lambda$ : we will have $P^{\dagger} \leq \Delta^{+}$(and hence $p_{G}\left(P^{\dagger}\right)=0$ ), and $P^{\pi} \cap k \Delta^{\pi}$ will be a minimal $G$-prime of $k \Delta^{\pi}$ (and hence $\left.h_{G}\left(P^{\pi} \cap k \Delta^{\pi}\right)=0\right)$.

### 3.2 Vertices and sources

We now study a more general setting. Let $G$ be an arbitrary compact $p$-adic analytic group, and $P$ an arbitrary prime ideal of $k G$.
Remark. Suppose $G$ is orbitally sound and nilpotent-by-finite, $N$ is a closed normal subgroup of $G$, and $I$ is a prime ideal of $k G$ with $N \leq I^{\dagger}$ and $\left[I^{\dagger}: N\right]<\infty$. Writing $\overline{(\cdot)}$ for the natural map $k G \rightarrow k[[G / N]]$, it is clear that the prime ideal $\bar{I} \triangleleft k[[G / N]]$ is almost faithful, and so, by Theorem 2.9, is controlled by $\Delta(G / N)$, and that $I$ is the complete preimage in $k G$ of $\bar{I}$, and is therefore controlled by the preimage in $G$ of $\Delta(G / N)$.

This motivates the following definition:

Definition 3.13. Let $I$ be an ideal of $k G$, and $N$ a closed subgroup of $G$. We say that $I$ is almost faithful $\bmod N$ if $I^{\dagger}$ contains $N$ as a subgroup of finite index. We also write $\nabla_{G}(N)$ for the subgroup of $\mathbf{N}_{G}(N)$ defined by

$$
\nabla_{G}(N) / N=\Delta\left(\mathbf{N}_{G}(N) / N\right)
$$

Diagrammatically:


We will extend this notion to ideals $I$ with $I^{\dagger}$ contained in $N$ as a subgroup of finite index.

Lemma 3.14. Let $H$ be an open subgroup of $N$. Then there exists an open characteristic subgroup $M$ of $N$ contained in $H$.

Proof. (Adapted from [15, 19.2].) Let $[N: H]=n<\infty$. Now, as $N$ is topologically finitely generated, there are only finitely many continuous homomorphisms $N \rightarrow S_{n}$. where $S_{n}$ is the symmetric group. Take $M$ to be the intersection of the kernels of these homomorphisms.
Lemma 3.15. Let $N$ be a closed subgroup of $G$, and $A=\mathbf{N}_{G}(N)$. Suppose $I$ is an ideal of $k A$, and $I^{\dagger} \leq N$ with $\left[N: I^{\dagger}\right]<\infty$. Then there is a closed normal subgroup $M$ of $A$ such that $I$ is almost faithful $\bmod M$. Furthermore, this $M$ can be chosen so that $\nabla_{G}(N)=\nabla_{A}(M)$.

Proof. Set $H=I^{\dagger}$ in Lemma 3.14 then the subgroup $M$ is characteristic in $N$, hence normal in $A ; M$ contains $I^{\dagger}$; and $M$ is open in $N$, so we must have $\left[I^{\dagger}: M\right]<\infty$.
By definition, we have $\nabla_{G}(N)=\nabla_{A}(N)$. Now, $N / M$ is a finite normal subgroup of $A / M$, so is contained in $\Delta^{+}(A / M)$. Hence the preimage under the natural quotient $\operatorname{map} A / M \rightarrow A / N$ of $\Delta(A / N)$ is $\Delta(A / M)$. But this is the same as saying that $\nabla_{A}(N)=\nabla_{A}(M)$.

When $G$ is a general compact $p$-adic analytic group, we will use the following lemma to translate between prime ideals of $k G$ and prime ideals of $k A$ for certain open subgroups $A$ of $G$.

Lemma 3.16. Let $H$ be an open normal subgroup of $G$. Suppose $P$ is a prime of $k G$, and write $Q$ for a minimal prime of $k H$ above $P \cap k H$. Let $B$ be the stabiliser in $G$ of $Q$, and let $A$ be any open subgroup of $G$ containing $B$, so that

$$
H \leq B \leq A \leq G
$$

Then there is a prime ideal $T$ of $k A$ with $P=T^{G}$, and furthermore this $T$ satisfies $T \cap k H=\bigcap_{a \in A} Q^{a}$.

Proof. This follows from [15, 14.10(i)].
Definition 3.17. A prime $P \triangleleft k G$ is standard if it is controlled by $\Delta$ and we have $P \cap k \Delta=\bigcap_{x \in G} L^{x}$ for some almost faithful prime $L \triangleleft k \Delta$.
Lemma 3.18. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group and $H$ an open normal subgroup. Let $P$ be a prime ideal of $k G$, and $Q$ a minimal prime of $k H$ above $P$, so that $P \cap k H=\bigcap_{x \in G} Q^{x}$. If $Q$ is a standard prime, then $P$ is a standard prime.

Proof. (Adapted from [15, 20.4(i)].) Write $\Delta=\Delta(G), \Delta_{H}=\Delta(H)$, and

$$
P \cap k \Delta=\bigcap_{x \in G} S^{x} \quad \text { and } \quad Q \cap k \Delta_{H}=\bigcap_{y \in H} T^{y}
$$

for prime ideals $S \triangleleft k \Delta$ and $T \triangleleft k \Delta_{H}$. On the one hand,

$$
\begin{aligned}
P \cap k \Delta_{H} & =(P \cap k \Delta) \cap k \Delta_{H} \\
& =\left(\bigcap_{x \in G} S^{x}\right) \cap k \Delta_{H} \\
& =\bigcap_{x \in G}\left(S \cap k \Delta_{H}\right)^{x}
\end{aligned}
$$

but on the other hand,

$$
\begin{aligned}
P \cap k \Delta_{H} & =(P \cap k H) \cap k \Delta_{H} \\
& =\left(\bigcap_{x \in G} Q^{x}\right) \cap k \Delta_{H} \\
& =\bigcap_{x \in G}\left(Q \cap k \Delta_{H}\right)^{x} \\
& =\bigcap_{x \in G} T^{x}
\end{aligned}
$$

Now, the conjugation action of $G$ on $\Delta_{H}$ has kernel $\mathbf{C}_{G}\left(\Delta_{H}\right)$, which contains $\mathbf{C}_{G}(\Delta)$ by [23, Lemma 1.3(ii)]. But $\mathbf{C}_{G}(\Delta)=\bigcap \mathbf{C}_{G}(a)$, where the intersection runs over a set of topological generators $a$ for $\Delta$, and each $\mathbf{C}_{G}(a)$ is open in $G$ by definition of $\Delta$. Now, as $\Delta$ is topologically finally generated, we see that $\mathbf{C}_{G}(\Delta)$ and hence $\mathbf{C}_{G}\left(\Delta_{H}\right)$ are also open in $G$.
That is, the conjugation action of $G$ on $\Delta_{H}$ factors through the finite group $G / \mathbf{C}_{G}\left(\Delta_{H}\right)$, and hence the intersections above are finite, so that (by the primality of $T$ ), we have

$$
S \cap k \Delta_{H} \subseteq T^{x}
$$

for some $x \in G$.
Now, by assumption, $Q$ is standard, so $T$ is almost faithful. This means that

$$
S^{\dagger} \cap \Delta_{H} \subseteq\left(T^{\dagger}\right)^{x}
$$

is a finite group, and so, since $\left[\Delta: \Delta_{H}\right]<\infty$, we have that $S^{\dagger}$ is also finite, so $S$ is almost faithful.

It remains to show that $S^{\circ} k G=P$. By Lemma 2.11, we see that $S^{\circ} k G=P^{\prime}$ is a prime ideal of $k G$ contained in $P$. Now,

$$
\begin{aligned}
(P \cap k H) k G & =\left(\bigcap_{g \in G} Q^{g}\right) k G \\
& =\left(\bigcap_{g \in G}\left(\bigcap_{h \in H} T^{h} k H\right)^{g}\right) k G \\
& =\left(\bigcap_{g \in G} T^{g}\right) k G \\
& =\left(P \cap k \Delta_{H}\right) k G \\
& \subseteq(P \cap k \Delta) k G=P^{\prime} \subseteq P,
\end{aligned}
$$

and as $H$ is open and normal in $G$, we know from Lemma 1.2(i) that $P$ is a minimal prime above $(P \cap k H) k G$, so that $P=P^{\prime}$.

Finally, the main theorem of this subsection:
Theorem 3.19. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, $P$ a prime ideal of $k G, H$ an orbitally sound open normal subgroup of $G, Q$ a minimal prime ideal above $P \cap k H$, and $N=\mathrm{i}_{G}\left(Q^{\dagger}\right)$. Then there exists an ideal $L \triangleleft k\left[\left[\nabla_{G}(N)\right]\right]$ with $P=L^{G}$.

Remark. The subgroup $N$ is a vertex of the prime ideal $P$, and the ideal $L$ is a source of $P$ corresponding to the vertex $N$.

Proof. We follow the proof of [13, 2.3], as reproduced in [15, 20.5].
Trivially, $H$ stabilises $Q$, i.e. $H \leq B:=\operatorname{Stab}_{G}(Q)$; and $B$ normalises $Q^{\dagger}$. Set $N:=\mathrm{i}_{G}\left(Q^{\dagger}\right)$. Now we must have $\mathbf{N}_{G}\left(Q^{\dagger}\right) \leq A:=\mathbf{N}_{G}(N)$ : indeed, if $x \in G$ normalises $Q^{\dagger}$, then it permutes the (finitely many) closed orbital subgroups $K$ of $G$ containing $Q^{\dagger}$ as an open subgroup, and hence it normalises $N$, which is generated by those $K$ [23, Definition 1.6].

We are in the following situation:


Now, Lemma 3.16 shows that there is a prime ideal $T$ of $k A$ with $P=T^{G}$ and $T \cap k H=\bigcap_{a \in A} Q^{a}$. It will suffice to show the existence of a prime ideal $L$ of $k\left[\left[\nabla_{G}(N)\right]\right]$ with $T=L^{A}$, by Lemma 1.6.

Let $M$ be an open characteristic subgroup of $N$ contained in $Q^{\dagger}$, whose existence is guaranteed by Lemma 3.14. Write $\nabla=\nabla_{G}(N)$, which we know is equal to $\nabla_{A}(M)$ by Lemma 3.15 and denote by $\overline{(\cdot)}$ images under the natural map $k A \rightarrow k[[A / M]]$.
Now $Q$ is a prime ideal of $k H$ with $M \leq Q^{\dagger}$ an open subgroup, so $\bar{Q}$ is an almost faithful prime ideal of $k \bar{H}$; hence, as $\bar{H}$ is orbitally sound [23, Lemma 1.5 (ii)], we see that $\bar{Q}$ is a standard prime of $k \bar{H}$.

But $T \cap k H=\bigcap_{a \in A} Q^{a}$ clearly implies $\bar{T} \cap k \bar{H}=\bigcap_{\bar{a} \in \bar{A}} \bar{Q}^{\bar{a}}$, by the modular law. Now Lemma 3.18 implies that $\bar{T}$ is also a standard prime ideal of $k \bar{A}$ : that is, there is an almost faithful prime ideal $\bar{L}$ of $k[[\Delta(\bar{A})]]$ with $\bar{T}=\bar{L}^{\bar{A}}$. Lifting this back to $k A$, we see that we have an almost faithful $\bmod M$ prime ideal $L$ of $k \nabla$ with $T=L^{A}$ as required.

We end this subsection with an important application of this theorem. Recall
the definition of $\operatorname{nio}(G)$ from [23, Definition 2.5].
Corollary 3.20. Suppose $G$ is a nilpotent-by-finite compact $p$-adic analytic group which is not orbitally sound. Let $P$ be a faithful prime ideal of $k G$. Then $P$ is induced from some proper open subgroup of $G$ containing nio $(G)$.

Proof. Write $H=\operatorname{nio}(G)$. $H$ is orbitally sound by [23, Theorem 2.6(ii)].
Let $Q$ be a minimal prime ideal above $P \cap k H$, so that $N=\mathrm{i}_{G}\left(Q^{\dagger}\right)$ is a vertex for $P$ by Theorem 3.19. Then $P$ is induced from $\nabla_{G}(N)$, which is contained in $\mathbf{N}_{G}(N)$, and so $P$ is induced from $\mathbf{N}_{G}(N)$ itself by Lemma 1.6. But, as nio $(G)$ is orbitally sound, in particular it must normalise $N$ [23, Theorem 2.6(i)]. Hence, if $\mathbf{N}_{G}(N)$ is a proper subgroup of $G$, we are done.

Suppose instead that $\mathbf{N}_{G}(N)=G$, i.e. that $\mathrm{i}_{G}\left(Q^{\dagger}\right)$ is a normal subgroup of $G$. Then, for each $g \in G,\left(Q^{\dagger}\right)^{g}$ is a finite-index subgroup of $\mathrm{i}_{G}\left(Q^{\dagger}\right)$ [23, Proposition 1.7]; and $Q^{\dagger}$ is orbital in $G$, so there are only finitely many $\left(Q^{\dagger}\right)^{g}$, and their intersection $\left(Q^{\dagger}\right)^{\circ}$ must also have finite index in $\mathrm{i}_{G}\left(Q^{\dagger}\right)$. But $\left(Q^{\dagger}\right)^{\circ}=P^{\dagger}=1$, so in particular we have $\mathrm{i}_{G}\left(Q^{\dagger}\right)=\Delta^{+}$, and hence $P$ is induced from $\nabla_{G}(N)=\Delta$, again by Theorem 3.19. Hence, as nio $(G)$ contains $\Delta, P$ must be induced from $\operatorname{nio}(G)$ itself.

### 3.3 The general case: inducing from open subgroups

Now we will proceed to show that $k G$ is catenary.
Lemma 3.21. Let $H$ be an open subgroup of $G$, and $P$ a prime ideal of $k G$. Suppose $Q$ is an ideal of $k H$ maximal amongst those ideals $A$ of $k H$ with $A^{G} \subseteq P$. Then $Q$ is prime, and $P$ is a minimal prime ideal above $Q^{G}$.

Proof. Suppose $I$ and $J$ are ideals strictly containing $Q$ : then, by the maximality of $Q$, we see that $I^{G}$ and $J^{G}$ must strictly contain $P$. Hence $I^{G} J^{G} \subseteq(I J)^{G}$ [15], Lemma 14.5] strictly contains $P$, and so $I J$ strictly contains $Q$. Hence $Q$ is prime.
$P$ is clearly a prime ideal containing $Q^{G}$, so to show it is minimal it suffices to find any ideal $A$ of $k H$ with $P$ a minimal prime above $A^{G}$. Let $N$ be the normal core of $H$ in $G$, and take $A=(P \cap k N)^{H}$ : then by Lemma 1.6 we have $A^{G}=(P \cap k N)^{G}=(P \cap k N) k G$, and by Lemma 1.2(i), $P$ is a minimal prime above this.

Lemma 3.22. Let $H$ be an open subgroup of $G$ with $k H$ catenary. If $P \lesseqgtr P^{\prime}$ are adjacent primes of $k G$, and $P$ is induced from $k H$, then $h\left(P^{\prime}\right)=h(P)+1$.

Proof. (Adapted from [11, 3.3].) Choose an ideal $Q$ (resp. $Q^{\prime}$ ) of $k H$ which is maximal amongst those ideals $A$ of $k H$ with $A^{G} \subseteq P\left(\right.$ resp. $\left.A^{G} \subseteq P^{\prime}\right)$. Then $Q$ and $Q^{\prime}$ are prime, and $P$ (resp. $P^{\prime}$ ) is a minimal prime ideal over $Q^{G}$ (resp.
$\left.Q^{\prime G}\right)$, by Lemma 3.21 Hence, by Proposition 1.16, we see that it suffices to show that $h\left(Q^{\prime}\right)=h(Q)+1$.

Suppose not. Then there exists some prime ideal $I$ of $k H$ with $Q \lesseqgtr I \lesseqgtr Q^{\prime}$; and we may choose a prime ideal $J$ of $k G$ which is minimal over $I^{G}$. Then $P \leq J \leq P^{\prime}$. But $h(Q)<h(I)<h\left(Q^{\prime}\right)$ implies (by another application of Proposition 1.16) that $h(P)<h(J)<h\left(P^{\prime}\right)$, contradicting our assumption that $P$ and $P^{\prime}$ were adjacent primes.
Corollary 3.23. Let $G$ be a nilpotent-by-finite compact $p$-adic analytic group, and $k$ a finite field of characteristic $p>2$. Then $k G$ is a catenary ring.

Proof. (Adapted from [11, 3.3].) Take two adjacent prime ideals $P \lesseqgtr Q$ of $k G$, and assume without loss of generality that $P$ is faithful. We proceed by induction on the index $[G: \operatorname{nio}(G)]$. When this index equals 1 , we are already done by Theorem [3.12, so suppose not. Then Corollary 3.20 implies that $P$ is induced from some proper open subgroup $H$ of $G$ containing nio $(G)$. As nio $(G)$ is an orbitally sound open normal subgroup of $H$, it must be contained in nio $(H)$ (by the maximality of $\operatorname{nio}(H)$ ), and so we have $[H: \operatorname{nio}(H)]<[G: \operatorname{nio}(G)]$. By induction, $k H$ is catenary, so we may now invoke Lemma 3.22 to show that $h(Q)=h(P)+1$.
