A note on strong-consistency of componentwise ARH(1) predictors

Abstract

This paper presents a new result on strong-consistency, in the trace norm, of a diagonal componentwise parameter estimator of the autocorrelation operator of an autoregressive process of order one (ARH(1) process), allowing strong-consistency of the associated plug-in predictor. These results are derived, when the eigenvectors of the autocovariance operator are unknown, and the autocorrelation operator does not admit a diagonal spectral representation with respect to the eigenvectors of the autocovariance operator.

1. Introduction.

It is well-known that functional prediction from the ARH(1) framework (see Bosq [6] and Bosq and Blanke [7]) has become a very active research area, driven by its interesting applications in the analysis of high-dimensional data (see, for example, Álvarez-Liébana, Bosq and Ruiz-Medina [1]). Several authors have studied the asymptotic properties of componentwise estimators of the autocorrelation operator, and ARH(1) predictors, in the case of known and unknown eigenvectors of the autocovariance operator. We refer to [9, 10, 11, 12], where the efficiency, consistency and asymptotic normality of

these estimators are addressed, in a parametric framework (see also Alvarez-Liébana, Bosq and Ruiz-Medina [2], on weak consistency in the norm of Hilbert-Schmidt operators). In this paper, we pay attention to the diagonal componentwise consistent estimation of the autocorrelation operator of an ARH(1) process, from projection into the empirical eigenvectors of the autocovariance operator, when their theoretical counterparts do not diagonalize the autocorrelation operator. A suitable sample-size-dependent truncation order, according to the spectral properties of the autocovariance operator of an ARH(1) process (namely, decay velocity and distance between eigenvalues), is usually selected to obtain the desirable asymptotic properties of componentwise parameter estimators, and their associated plug-in predictors, under different setting of conditions. The usual assumption on the autocorrelation operator is its boundedness or Hilbert-Schmidt property. Hence, the error term is usually measured in both operator norms, the norm of the space of bounded linear operators and the Hilbert-Schmidt norm. In the same way, dimension reduction has been a crucial topic in the nonparametric and semiparametric frameworks. In these contexts, a kernel-based predictor is usual adopted, as early formulated in [13]. Additional covariates were incorporated in the novel semiparametric kernel-based proposal by [4], in which an extension, to the functional time series framework, of partial linear models, was firstly developed. In both frameworks, regular autocorrelation operators usually arise. Thus, the error term could be measured in the trace norm, in terms of the diagonal values, with the subsequent dimension reduction. This is the proposal of the note carried out here, which could help the usual computational limitations arising in the implementation of kernel-based estimators (see also [5]). A fractal approach was proposed in [8] to solve the curse of dimensionality, by imposing a concentration assumption about the distribution of the stochastic process. For example, in the Gaussian case, under the trace class assumption on the autocorrelation operator, we can go beyond the concentration assumption on the autocorrelation kernel values, characterizing the distributional properties of the underlying stochastic process. A diagonal design of the kernel-based estimator can then be considered, ensuring the desirable asymptotic properties.

This paper intends to focus the attention of the reader on the smoothing and regularization techniques usually applied in the functional data context, that allow to work on a trace-class autocorrelation operator context, and hence, to measure the autocorrelation operator estimation error, in the trace norm. Particularly, strong-consistency in the trace norm also implies the consistency in the norm of the space of Hilbert-Schmidt operators, as well as in the norm of bounded linear operators. Results derived in this paper are mainly motivated by this fact, allowing an important dimension reduction, in the componentwise estimation of the autocorrelation operator of an ARH(1) process, and its plug-in prediction. It is important to highlight that the distributional properties of a wide class of stochastic processes in time and/or space can be characterized in terms of stochastic evolution equations, involving trace and positive autocorrelation operators (see, for example, Anh, Leonenko and Ruiz-Medina [3], in the spatiotemporal case).

2. Preliminaries.

Let H be a real separable Hilbert space, and let $X = \{X_n, n \in \mathbb{Z}\}$ be a zero-mean ARH(1) process on the basic probability space (Ω, \mathcal{A}, P) satisfying the following equation:

$$X_n = \rho(X_{n-1}) + \varepsilon_n, \ n \in \mathbb{Z}, \tag{1}$$

where ρ is the autocorrelation operator of process X, which belongs to the space $\mathcal{L}(H)$ of bounded linear operators, such that $\|\rho^k\|_{\mathcal{L}(H)} < 1$, for $k \geq k_0$, and for some k_0 . Here, as usual, $\|\cdot\|_{\mathcal{L}(H)}$ denotes the norm in the space $\mathcal{L}(H)$. The Hilbert-valued innovation process $\varepsilon = \{\varepsilon_n, n \in \mathbb{Z}\}$ is assumed to be a strong white noise, and to be uncorrelated with the random initial condition. That is, ε is a Hilbert-valued zero-mean stationary process, with independent and identically distributed components in time, and with $\sigma_{\varepsilon}^2 = \mathbb{E}[\|\varepsilon_n\|_H^2] < \infty$, for all $n \in \mathbb{Z}$. We restrict our attention here to the case where ρ is such that $\|\rho\|_{\mathcal{L}(H)} < 1$.

Under the above-setting of conditions, involved in the introduction of equation (1), X admits the following MAH(∞) representation (see Bosq [6]):

$$X_{n} = \sum_{k=0}^{\infty} \rho^{k} \left(\varepsilon_{n-k} \right), \quad n \in \mathbb{Z},$$
(2)

that provides the unique stationary solution to equation (1). The autocovariance operator C_X of the ARH(1) process X is given by

$$C_X = E[X_n \otimes X_n] = E[X_0 \otimes X_0], \quad \forall n \in \mathbb{Z},$$

which is assumed to be a trace operator.

Let us now consider the empirical autocovariance operator C_n of the ARH(1) process $X = \{X_n, n \in \mathbb{Z}\}$, computed as follows:

$$C_n = \frac{1}{n} \sum_{i=0}^{n-1} X_i \otimes X_i, \quad n \ge 2, \tag{3}$$

from a functional sample $X_0, X_1, \ldots, X_{n-1}$, of size n, of the ARH(1) process X. The empirical eigenvalues $\{C_{n,j}, j \geq 1\}$, and eigenvectors $\{\phi_{n,j}, j \geq 1\}$ of C_n are given by (see [6], pp. 102–103):

$$C_n \phi_{n,j} = C_{n,j} \phi_{n,j}, \quad j \ge 1, \quad C_{n,1} \ge \dots \ge C_{n,n} \ge 0 = C_{n,n+1} = C_{n,n+2} = \dots$$
(4)

In the remainder, we will denote

$$X_{i,j,n} = \langle X_i, \phi_{n,j} \rangle_H, \quad i \in \mathbb{Z}, \ j \ge 1, \ n \ge 2,$$

$$\phi'_{n,j} = \operatorname{sgn} \langle \phi_{n,j}, \phi_j \rangle_H \phi_j, \quad j \ge 1, \ n \ge 2,$$
 (5)

where $\operatorname{sgn}\langle \phi_{n,j}, \phi_j \rangle_H = \mathbf{1}_{\langle \phi_{n,j}, \phi_j \rangle_H \geq 0} - \mathbf{1}_{\langle \phi_{n,j}, \phi_j \rangle_H < 0}$. Thus,

$$C_{n,j} = \frac{1}{n} \sum_{i=0}^{n-1} X_{i,j,n}^2, \quad j \ge 1, \ n \ge 2.$$
 (6)

Let us now consider the cross-covariance operator D_X given by

$$D_X = \mathbb{E}[X_i \otimes X_{i+1}] = \mathbb{E}[X_0 \otimes X_1], \quad \forall i \in \mathbb{Z},$$

which is assumed to be a trace operator. The empirical cross-covariance operator D_n is defined as follows:

$$D_n = \frac{1}{n-1} \sum_{i=0}^{n-2} X_i \otimes X_{i+1}, \quad n \ge 2.$$
 (7)

Given the empirical eigenvectors of C_n , $\{\phi_{n,j}, j \geq 1\}$, we compute

$$D_{n,j,l}^* = \langle D_n (\phi_{n,j}), \phi_{n,l} \rangle_H = \frac{1}{n-1} \sum_{i=0}^{n-2} X_{i,j,n} X_{i+1,l,n}, \ j, l \ge 1, \ n \ge 2,$$

and, in particular, we will use the notation

$$D_{n,j} = D_{n,j,j}^* = \langle D_n(\phi_{n,j}), \phi_{n,j} \rangle_H = \frac{1}{n-1} \sum_{i=0}^{n-2} X_{i,j,n} X_{i+1,j,n}, \quad j \ge 1, \ n \ge 2,$$
(8)

where the empirical projections $\{X_{i,j,n}, j \geq 1, i = 0, 1, \dots, n-1\}$ have been previously defined in equation (5).

3. Auxiliary results

The auxiliary results presented in this section allow the derivation of Theorem 2 in the next section.

Assumption A1. The random initial condition X_0 of the ARH(1) process defined in (1) satisfies

$$\mathrm{E}\left\{\left\|X_{0}\right\|_{H}^{4}\right\}<\infty.$$

Theorem 1. (see Theorem 4.1 on pp. 98–99, Corollary 4.1 on pp. 100–101 and Theorem 4.8 on pp. 116–117, in [6]). Under **Assumption A1**, for any $\beta > \frac{1}{2}$, as $n \to \infty$,

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \|C_n - C_X\|_{\mathcal{S}(H)} \to^{a.s.} 0, \quad \frac{n^{1/4}}{(\ln(n))^{\beta}} \|D_n - D_X\|_{\mathcal{S}(H)} \to^{a.s.} 0, \quad (9)$$

and, if $||X_0||_H$ is bounded,

$$||C_n - C_X||_{\mathcal{S}(H)} = \mathcal{O}\left(\left(\frac{\ln(n)}{n}\right)^{1/2}\right) \ a.s.,$$

$$||D_n - D_X||_{\mathcal{S}(H)} = \mathcal{O}\left(\left(\frac{\ln(n)}{n}\right)^{1/2}\right) \ a.s.,$$
(10)

where $\|\cdot\|_{\mathcal{S}(H)}$ denotes the norm of the Hilbert-Schmidt operators on H, and a.s. means, as usual, almost surely.

In the following, we denote by $\{C_j, j \geq 1\}$ the sequence of eigenvalues of the autocovariance operator C_X , satisfying

$$C_X(\phi_j) = C_j \phi_j, \quad j \ge 1, \tag{11}$$

with $\{\phi_j, j \geq 1\}$ being the associated system of eigenvectors.

Lemma 1. Under Assumption A1, for n sufficiently large,

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{j \ge 1} |C_{n,j} - C_j| \le \frac{n^{1/4}}{(\ln(n))^{\beta}} \|C_n - C\|_{\mathcal{S}(H)} \to^{a.s.} 0, \quad (12)$$

where $\{C_j, j \geq 1\}$ have been introduced in equation (11).

The proof of Lemma 1 is straightforward since, from Theorem 1 and n sufficiently large, C_n is a Hilbert-Schmidt operator, and in particular, it is a compact operator. Thus, applying Lemma 4.2 on p. 103 in [6], and Theorem 1, for $n \geq n_0$, with n_0 sufficiently large, we obtain

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{k \ge 1} |C_{n,k} - C_k| \le \frac{n^{1/4}}{(\ln(n))^{\beta}} ||C_n - C_X||_{\mathcal{S}(H)} \to^{a.s.} 0. \tag{13}$$

Proposition 1 below obtains the strong-consistency of $\{D_{n,j}, j \geq 1\}$, introduced in equation (8). In the derivation of these strong-consistency results, the distance between the eigenvalues of the autocovariance operator, and their rate of convergence to zero, will play a key role. Namely, if the following quantities are considered:

$$\Lambda_k = \sup_{1 \le j \le k} (C_j - C_{j+1})^{-1}, \quad k \ge 1,$$
(14)

the rate of divergence of Λ_{k_n} is crucial, as can be noted in the statements of Lemma 2 and Proposition 1 (see also Remark 1 below). Henceforth, k_n denotes a truncation parameter, which verifies

$$\lim_{n \to \infty} k_n = \infty, \quad \frac{k_n}{n} < 1, \quad k_n \ge 1.$$
 (15)

Lemma 2. Let us consider Λ_{k_n} introduced in equation (14), for a given truncation parameter k_n , as reflected in (15). Assuming that $||X_0||_H$ is bounded and $\Lambda_{k_n} = o\left(n^{1/4}(\ln(n))^{\beta-1/2}\right)$, as $n \to \infty$, under **Assumption A1**, the following limit then holds

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{1 \le j \le k_n} \|\phi'_{n,j} - \phi_{n,j}\|_{H} \to^{a.s.} 0, \quad n \to \infty,$$
 (16)

for any $\beta > 1/2$, where $\{\phi'_{n,j}, j \geq 1\}$ are introduced in equation (5).

Proof. From equation (4.44) in Lemma 4.3 on page 104 of [6], for any $n \geq 2$ and $1 \leq j \leq k_n$,

$$\|\phi'_{n,j} - \phi_{n,j}\|_{H} \le a_j \|C_n - C\|_{\mathcal{L}(H)} \le 2\sqrt{2}\Lambda_{k_n} \|C_n - C\|_{\mathcal{S}(H)}, \quad (17)$$

which implies that

$$\mathcal{P}\left(\sup_{1\leq j\leq k_n} \|\phi'_{n,j} - \phi_{n,j}\|_H \geq \eta\right) \leq \mathcal{P}\left(\|C_n - C\|_{\mathcal{S}(H)} \geq \frac{\eta}{2\sqrt{2}\Lambda_{k_n}}\right).(18)$$

Thus, since $||X_0||_H$ is bounded, from Theorem 4.2 on pp. 99–100 of [6], under **Assumption A1** for any $\eta > 0$, and $\beta > 1/2$,

$$\mathcal{P}\left(\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{1 \le j \le k_{n}} \|\phi'_{n,j} - \phi_{n,j}\|_{H} \ge \eta\right)
\le \mathcal{P}\left(\|C_{n} - C\|_{\mathcal{S}(H)} \ge \frac{\eta}{2\sqrt{2}\Lambda_{k_{n}}} \frac{(\ln(n))^{\beta}}{n^{1/4}}\right)
\le 4 \exp\left(-\frac{n\frac{\eta^{2}}{8\Lambda_{k_{n}}^{2}} \frac{(\ln(n))^{2\beta}}{n^{1/2}}}{\gamma_{1} + \delta_{1}\frac{\eta}{2\sqrt{2}\Lambda_{k_{n}}} \frac{(\ln(n))^{\beta}}{n^{1/4}}}\right)
= \mathcal{O}\left(n^{-\frac{\eta^{2}}{\gamma_{1} + \eta\delta_{1}\left(\frac{\ln(n)}{n}\right)^{1/2}}}\right), \quad n \to \infty. \tag{19}$$

Thus, taking $\eta^2 > \gamma_1 + \delta_1 \eta$, sequence (19) is summable, and applying Borel-Cantelli Lemma we arrive to the desired result.

Proposition 1. Under the conditions of Lemma 2, considering **Assumption A1**, for $\beta > \frac{1}{2}$, and n sufficiently large,

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{j \ge 1} |D_{n,j} - D_j| \to^{a.s.} 0, \quad n \to \infty,$$
 (20)

where $\{D_{n,j}, j \geq 1\}$ are defined in equation (8), and $\{D_j, j \geq 1\}$ are given by $D_j = D_X(\phi_j)(\phi_j)$, for every $j \geq 1$, with, as before, $\{\phi_j, j \geq 1\}$ being the system of eigenvectors of C_X .

Remark 1. Note that, under the conditions of Lemma 2, since $||X_0||_H$ is bounded, from Theorem 1, the rate of convergence to zero in Lemma 1 and Proposition 1 can be improved up to the value $\frac{(\ln(n))^{\beta}}{n^{\gamma}}$, for $\beta > 1/2$, and $\gamma \in (1/4, 1/2)$, allowing larger values of the truncation order k_n , given by (15), for a fixed sample size n.

Proof. From Theorem 1, there exists an n_0 such that for $n \geq n_0$, D_n is a

Hilbert-Schmidt operator. Then, for $n \geq n_0$, and for every j,

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} |D_{n,j} - D_{j}| = \frac{n^{1/4}}{(\ln(n))^{\beta}} \\
\times |D_{n}(\phi_{n,j})(\phi_{n,j}) - D_{n}(\phi_{n,j})(\phi_{j}) + D_{n}(\phi_{n,j})(\phi_{j}) \\
-D(\phi_{n,j})(\phi_{j}) + D(\phi_{n,j})(\phi_{j}) - D(\phi_{j})(\phi_{j})| \\
\leq \frac{n^{1/4}}{(\ln(n))^{\beta}} [||D_{n}(\phi_{n,j})||_{H} ||\phi_{n,j} - \phi_{j}||_{H} + ||(D_{n} - D)(\phi_{n,j})||_{H} ||\phi_{j}||_{H} \\
+ ||D(\phi_{n,j} - \phi_{j})||_{H} ||\phi_{j}||_{H}] \\
\leq \frac{n^{1/4}}{(\ln(n))^{\beta}} [||D_{n}||_{\mathcal{L}(H)} ||\phi_{n,j} - \phi_{j}||_{H} + ||D_{n} - D||_{\mathcal{L}(H)} \\
+ ||D||_{\mathcal{L}(H)} ||\phi_{n,j} - \phi_{j}||_{H}], \tag{21}$$

where, as before, $\{\phi_j, j \geq 1\}$ and $\{\phi_{n,j}, j \geq 1\}$ respectively denote the theoretical and empirical eigenvectors of C_X , and $\|\cdot\|_{\mathcal{L}(H)}$ denotes the norm in the space of bounded linear operators.

From Theorem 1,

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \|D_n - D\|_{\mathcal{L}(H)} \le \frac{n^{1/4}}{(\ln(n))^{\beta}} \|D_n - D\|_{\mathcal{S}(H)} \to^{a.s.} 0, \tag{22}$$

and, for n sufficiently large, $||D_n||_{\mathcal{L}(H)} < \infty$. Furthermore, from Lemma 2 (see equation (16)),

$$\frac{n^{1/4}}{(\ln(n))^{\beta}} \sup_{1 \le j \le k_n} \|\phi_{n,j} - \phi_j\|_{H} \to^{a.s.} 0.$$
 (23)

Hence, from equations (22) and (23), taking the supremum in j at the left-hand side of equation (21), we obtain equation (20).

4. Strong-consistency in the trace operator norm

In the subsequent developments, we assume that the eigenvectors $\{\phi_j, j \geq 1\}$ of C_X are unknown. The diagonal componentwise estimator of ρ formulated below is then defined in terms of the empirical eigenvectors.

The following condition is assumed in the remainder of this section:

Assumption A2. The empirical eigenvalue $C_{n,k_n} > 0$ a.s, where k_n is the truncation parameter satisfying the conditions established in (15).

Under **Assumption A2**, from a functional sample of size n, X_0, \ldots, X_{n-1} , the following estimator $\widehat{\rho}_{k_n}$ of ρ is formulated:

$$\widehat{\rho}_{k_n} = \sum_{j=1}^{k_n} \rho_{n,j} \phi_{n,j} \otimes \phi_{n,j} = \sum_{j=1}^{k_n} \frac{D_{n,j}}{C_{n,j}} \phi_{n,j} \otimes \phi_{n,j}, \qquad (24)$$

where, for each $j \ge 1$ and $n \ge 2$,

$$\rho_{n,j} = \frac{D_{n,j}}{C_{n,j}} = \frac{\frac{1}{n-1} \sum_{i=0}^{n-2} \langle X_i, \phi_{n,j} \rangle_H \langle X_{i+1}, \phi_{n,j} \rangle_H}{\frac{1}{n} \sum_{i=0}^{n-1} \left[\langle X_i, \phi_{n,j} \rangle_H \right]^2} = \frac{n}{n-1} \frac{\sum_{i=0}^{n-2} X_{i,j,n} X_{i+1,j,n}}{\sum_{i=0}^{n-1} X_{i,j,n}^2}.$$
(25)

The strong-consistency of $\widehat{\rho}_{k_n}$, in the trace norm, is derived in the following result under suitable conditions.

Theorem 2. Under **Assumption A2**, and the conditions assumed in Lemma 2, if ρ is a positive trace operator, then, $\widehat{\rho}_{k_n}$, introduced in equations (24)–(25), is strongly-consistent in the trace norm, i.e.,

$$\|\rho - \widehat{\rho}_{k_n}\|_1 \to^{a.s.} 0, \quad n \to \infty,$$
 (26)

for $k_n = o\left(\frac{n^{1/4}}{(\ln(n))^{\beta}}\right)$, as $n \to \infty$. Here, $\|\cdot\|_1$ denotes the trace operator norm. Consequently, $\widehat{\rho}_{k_n}$ is also strongly-consistent in the spaces $\mathcal{S}(H)$ and $\mathcal{L}(H)$.

Proof. From Theorem 1, we have, for n sufficiently large,

$$||D_{n}C_{n}^{-1} - D_{X}C_{X}^{-1}||_{\mathcal{S}(H)}$$

$$= ||D_{n}C_{n}^{-1} - D_{X}C_{n}^{-1} + D_{X}C_{n}^{-1} - D_{X}C_{X}^{-1}||_{\mathcal{S}(H)}$$

$$\leq ||D_{n}C_{n}^{-1} - D_{X}C_{n}^{-1}||_{\mathcal{S}(H)} + ||D_{X}C_{n}^{-1} - D_{X}C_{X}^{-1}||_{\mathcal{S}(H)}$$

$$= ||(D_{n} - D_{X})C_{n}^{-1}||_{\mathcal{S}(H)} + ||D_{X}(C_{n}^{-1} - C_{X}^{-1})||_{\mathcal{S}(H)},$$
(27)

since from such a theorem, $D_X C_n^{-1} \in \mathcal{S}(H)$ for n sufficiently large. Again, from Theorem 1, equation (27) tends to zero as $n \to \infty$, a.s., which means that $||D_n C_n^{-1} - D_X C_X^{-1}||_{\mathcal{S}(H)}$ also converges to zero a.s. From Theorem 1 and equation (27), we also have that there exists an $n_0 \in \mathbb{N}$ such that, for $n \geq n_0$,

 $D_n C_n^{-1}$ is a positive trace operator almost surely. Considering now $n \geq n_0$, for any orthonormal basis $\{\varphi_j, j \geq 1\}$ on H,

$$||D_n C_n^{-1}||_1 = \sum_{j=1}^{\infty} \langle D_n C_n^{-1}(\varphi_j), \varphi_j \rangle_H.$$
 (28)

Note also that

$$||D_X C_X^{-1}||_1 = \sum_{j=1}^{\infty} \langle D_X C_X^{-1}(\varphi_j), \varphi_j \rangle_H.$$

Furthermore, from Lemma 1, as $n \to \infty$, $C_{n,j}^{-1}$ converges a.s. to C_j^{-1} , uniformly in j, with convergence rate at least $\frac{(\ln(n))^{\beta}}{n^{1/4}}$, for $\beta > 1/2$. The same assertion holds for the uniform a.s. convergence of $D_{n,j}$ to D_j , as $n \to \infty$, from Proposition 1. Consequently, for every j, as $n \to \infty$, $D_{n,j}C_{n,j}^{-1}$ converges a.s. to $D_jC_j^{-1}$, with uniform a.s. rate of convergence at least $\frac{(\ln(n))^{\beta}}{n^{1/4}}$, for $\beta > 1/2$. Equivalently, from equation (12) in Lemma 1, and equation (20) in Proposition 1,

$$\|\widehat{\rho}_{k_n}\|_1 = \sum_{j=1}^{k_n} D_{n,j} C_{n,j}^{-1}$$

$$\leq f(n) = \mathcal{O}\left(k_n \frac{(\ln(n))^{\beta}}{n^{1/4}} + \sum_{j=1}^{\infty} D_j C_j^{-1}\right), \ n \to \infty \text{ a.s. } (29)$$

Since $k_n = o\left(\frac{n^{1/4}}{(\ln(n))^{\beta}}\right)$, equation (29) converges a.s., when $n \to \infty$, to

$$||D_X C_X^{-1}||_1 = \sum_{j=1}^{\infty} D_j C_j^{-1} = \sum_{j=1}^{\infty} D_X(\phi_j)(\phi_j) [C_X(\phi_j)(\phi_j)]^{-1} = ||\rho||_1.$$
 (30)

For two positive trace operators, \mathcal{K} and \mathcal{T} , the following identities are satisfied, for any orthonormal basis $\{\varphi_j, j \geq 1\}$ on H,

$$\begin{split} \|\mathcal{K} - \mathcal{T}\|_{1} &= \operatorname{trace}(|\mathcal{K} - \mathcal{T}|) = \max(\|\mathcal{K}\|_{1}, \|\mathcal{T}\|_{1}) - \min(\|\mathcal{K}\|_{1}, \|\mathcal{T}\|_{1}) \\ \|\mathcal{K}\|_{1} &= \sum_{j=1}^{\infty} \left\langle \mathcal{K}(\varphi_{j}), \varphi_{j} \right\rangle_{H}, \quad \|\mathcal{T}\|_{1} = \sum_{j=1}^{\infty} \left\langle \mathcal{T}(\varphi_{j}), \varphi_{j} \right\rangle_{H}. \end{split}$$

In particular, for $n \geq n_0$,

$$\|\rho - \widehat{\rho}_{k_n}\|_1 = \max\left(\|\rho\|_1, \|\widehat{\rho}_{k_n}\|_1\right) - \min\left(\|\rho\|_1, \|\widehat{\rho}_{k_n}\|_1\right). \tag{31}$$

The limit (26) then follows from equations (29)-(31).

The strong consistency in H of the associated ARH(1) plug-in predictor $\widehat{\rho}_{k_n}(X_{n-1})$ of X_n is now derived.

Corollary 1. Under the conditions of Theorem 2

$$\|\widehat{\rho}_{k_n}(X_{n-1}) - \rho(X_{n-1})\|_H \to^{a.s.} 0, \quad n \to \infty.$$
 (32)

Proof. The proof directly follows from Theorem 2, keeping in mind that the convergence in the trace norm implies the convergence in the space $\mathcal{L}(H)$ of bounded linear operators. Moreover,

$$\|\widehat{\rho}_{k_n}(X_{n-1}) - \rho(X_{n-1})\|_H \le \|\widehat{\rho}_{k_n} - \rho\|_{\mathcal{L}(H)} \|X_{n-1}\|_H \to^{a.s.} 0, \ n \to \infty,$$

since $||X_{n-1}||_H < \infty$.

Remark 2. Note that, when ρ is Hilbert-Schmidt, but it is not positive trace operator, under the conditions of Lemma 2, and if **Assumption A2** holds, the following a.s. inequality is satisfied, as $n \to \infty$,

$$\|\widehat{\rho}_{k_n} - \rho\|_{\mathcal{S}(H)}^2 \le \|\rho\|_{\mathcal{S}(H)}^2 - \sum_{j=1}^{\infty} [\rho(\phi_j)(\phi_j)]^2 = \sum_{j\neq k}^{\infty} \left[\frac{D_X(\phi_j)(\phi_k)}{C_j} \right]^2 < \infty.$$
 (33)
