# Bias Correction with Jackknife, Bootstrap, and Taylor Series

#### Abstract

We analyze bias correction methods using jackknife, bootstrap, and Taylor series. We focus on the binomial model, and consider the problem of bias correction for estimating $f(p)$, where $f \in C[0,1]$ is arbitrary. We characterize the supremum norm of the bias of general jackknife and bootstrap estimators for any continuous functions, and demonstrate the in delete- $d$ jackknife, different values of $d$ may lead to drastically different behaviors in jackknife. We show that in the binomial model, iterating the bootstrap bias correction infinitely many times may lead to divergence of bias and variance, and demonstrate that the bias properties of the bootstrap bias corrected estimator after $r-1$ rounds are of the same order as that of the $r$-jackknife estimator if a bounded coefficients condition is satisfied.


Index Terms-Bootstrap, Jackknife, Bias correction, Functional estimation, Approximation theory

## I. Introduction

One of the classic problems in statistics is to design procedures to reduce the bias of estimators. General bias correction methods such as the bootstrap, the jackknife, and the Taylor series have been widely employed and well studied in the literature. See [1]-[14] and the references therein. The jackknife idea is also closely related to the ensemble method in estimation [15]-[17].

A close inspection of the literature on those general bias correction methods show that they usually rely on certain expansion (differentiability) properties of the expectation of the estimator one would like to correct the bias for, and the analysis is pointwise asymptotics [7], [9], [13].

One motivation for this work is that the methods based on series expansions and differentiability assumptions

[^0]may not suffice in the analysis of bootstrap and jackknife even in the simplest statistical models, and the practical implementations of bootstrap and jackknife do not require those differentiability conditions. The Taylor series itself, by definition, is a series expansion method which we include here for comparison with bootstrap and jackknife.

To illustrate our point, consider one of the simplest statistical models, the binomial model, where $n \cdot \hat{p}_{n} \sim$ $\mathrm{B}(n, p)$. For any function $f:[0,1] \mapsto \mathbb{R}$, we would like to correct the bias of $f\left(\hat{p}_{n}\right)$ as an estimator of $f(p)$. Let $e_{1, n}(p)=f(p)-\mathbb{E}_{p} f\left(\hat{p}_{n}\right)$ be the bias term. The expectation of the jackknife bias corrected estimator $\hat{f}_{2}$ satisfies

$$
\begin{equation*}
\mathbb{E}\left[\hat{f}_{2}\right]=\mathbb{E}\left[n f\left(\hat{p}_{n}\right)-(n-1) f\left(\hat{p}_{n-1}\right)\right] \tag{1}
\end{equation*}
$$

where $(n-1) \cdot \hat{p}_{n-1} \sim \mathrm{~B}(n-1, p)$. The textbook argument of the bias reduction property of the jackknife is the following [13]. Suppose that

e_{1, n}(p)=\frac{a(p)}{n}+\frac{b(p)}{n^{2}}+O_{p}\left(\frac{1}{n^{3}}\right) \tag{2}
\end{equation*}
$$

where $a(p), b(p)$ are unknown functions of $p$ which do no depend on $n$, and $O_{p}\left(a_{n}\right)$ is a sequence that is elementwise upper bounded by $a_{n}$ up to a multiplicative constant for fixed $p$. We also have

$$
\begin{equation*}
e_{1, n-1}(p)=\frac{a(p)}{n-1}+\frac{b(p)}{(n-1)^{2}}+O_{p}\left(\frac{1}{(n-1)^{3}}\right) . \tag{3}
\end{equation*}
$$

Hence, the overall bias of $\hat{f}_{2}$ is:

$$
\begin{align*}
f(p)-\mathbb{E}_{p} \hat{f}_{2} & =n e_{1, n}(p)-(n-1) e_{1, n-1}(p)  \tag{4}\\
& =\frac{b(p)}{n}-\frac{b(p)}{n-1}+O_{p}\left(\frac{1}{n^{2}}\right)  \tag{5}\\
& =-\frac{b(p)}{n(n-1)}+O_{p}\left(\frac{1}{n^{2}}\right), \tag{6}
\end{align*}
$$

which seems to suggest that the bias has been reduced to order $\frac{1}{n^{2}}$ instead of order $\frac{1}{n}$. However, if we particularize 2 to $f(p)=p \ln (1 / p)$, which relates to the Shannon
entropy [18], we have [19]

$$
\begin{equation*}
e_{1, n}(p)=\frac{1-p}{2 n}+\frac{1}{12 n^{2}}\left(\frac{1}{p}-p\right)+O_{p}\left(\frac{1}{n^{3}}\right) \tag{7}
\end{equation*}
$$

One immediately sees that it may not be reasonable to claim that the jackknife has reduced the bias upon looking at (7) and (6). Indeed, the bias of the jackknife estimator is uniformly upper bounded by $O(n)$, but the right hand side of (7) and (6) explodes to infinity as $p \rightarrow 0$. It shows that one cannot ignore the dependence on $p$ in the $O_{p}(\cdot)$ notation, but even doing higher order of Taylor expansion does not help. In fact, it was shown first in [20] that for $f(p)=p \ln (1 / p)$, there exist universal constants $C_{1}>0, C_{2}>0$ such that for any $n \geq 1$,

\begin{array}{r}
\sup _{p \in[0,1]}\left|e_{1, n}(p)\right| \leq \frac{C_{1}}{n} \\
\sup _{p \in[0,1]}\left|f(p)-\mathbb{E}_{p}\left[\hat{f}_{2}\right]\right| \geq \frac{C_{2}}{n} \tag{9}
\end{array}
$$

In other words, the jackknife does not change the bias order at all. There exist other estimators that achieve a smaller order of bias. Indeed, the estimators [21]-[24] that achieve the optimal minimax sample complexity for Shannon entropy estimation used best approximation polynomials to reduce the bias of of each symbol from $\frac{1}{n}$ to $\frac{1}{n \ln n}$.

In this paper, we connect the jackknife and bootstrap to the theory of approximation, and provide a systematic treatment of the problem of correcting the bias for $f\left(\hat{p}_{n}\right)$ as an estimator of $f(p)$ for $f \in C[0,1]$ and $n \cdot \hat{p}_{n} \sim$ $\mathrm{B}(n, p)$. Compared with existing literature, we choose to simplify the statistical model to the extreme, but consider arbitrary functions $f$. We believe it is an angle worth investigating due to the following reasons. First of all, it directly leads to analysis of the bias correction properties of jackknife and bootstrap for important statistical questions such as the Shannon entropy estimation, which existing theory proves insufficient of handling. Second, even in this simplest statistical model the analysis of jackknife and bootstrap is far non-trivial, and there still exist abundant open problems as we discuss in this paper. One message we would like to convey in this work is that the analysis of jackknife and bootstrap in simple statistical models but general functions could lead to interesting and deep mathematical phenomena that remain fertile ground for research. We mention that most of the results in this paper could be generalized to the case of natural exponential family of quadratic variance functions [25], [26], which comprises of six families: Gaussian, Poisson, binomial, negative binomial, gamma, and generalized hyperbolic secant. Coincidentally, these
distribution families were also identified as special in approximation theory literature, where they were named operators of the exponential-type [27], [28].

We introduce some notations below. The $r$-th symmetric difference of a function $f:[0,1] \mapsto \mathbb{R}$ is given by

\Delta_{h}^{r} f(x)=\sum_{k=0}^{r}(-1)^{k}\binom{r}{k} f(x+r(h / 2)-k h) \tag{10}
\end{equation*}
$$

where $\Delta_{h}^{r} f(x)=0$ if $x+r h / 2$ or $x-r h / 2$ is not in $[0,1]$. We introduce the $r$-th Ditzian-Totik modulus of smoothness of a function $f:[0,1] \mapsto \mathbb{R}$ as

$$
\begin{equation*}
\omega_{\varphi}^{r}(f, t)=\sup _{0<h \leq t}\left\|\Delta_{h \varphi(x)}^{r} f\right\| \tag{11}
\end{equation*}
$$

where $\varphi(x)=\sqrt{x(1-x)}$, and the norm is the supremum norm.

The $\omega_{\varphi}^{r}(f, t)$ modulus satisfies the following properties.

Lemma 1. [29, Chap. 4] The Ditzian-Totik modulus of smoothness $\omega_{\varphi}^{r}(f, t)$ in 11) satisfies the following:

1) $\omega_{\varphi}^{r}(f, t)$ is a nondecreasing function of $t$.
2) There exist universal constants $K>0, t_{0}>0$ such that $\omega_{\varphi}^{r}(f, \lambda t) \leq K \lambda^{r} \omega_{\varphi}^{r}(f, t)$ for $\lambda \geq 1$, and $\lambda t \leq$ $t_{0}$.
3) There exist universal constants $K>0, t_{0}>0$ such that $\omega_{\varphi}^{r+1}(f, t) \leq K \omega_{\varphi}^{r}(f, t)$ for $0<t \leq t_{0}$.
4) There exists a universal constant $K>0$ such that $\omega_{\varphi}^{r}(f, t) \leq K \sup _{x \in[0,1]}\left|f^{(r)}(x)\right| t^{r}$.
5) $\lim _{t \rightarrow 0^{+}} \frac{\omega_{\varphi}^{r}(f, t)}{t^{r}}=0 \Rightarrow f$ is a polynomial with degree $r-1$. ( $f$ is a polynomial of degree $r-1 \Rightarrow$ $\left.\omega_{\varphi}^{r}(f, t)=0\right)$.
6) $\omega_{\varphi}^{r}(f, t)=O\left(t^{r}\right)$ for fixed $f, r$ if and only if $f^{(r-1)} \in$ A.C. ${ }_{\text {loc }}$ and $\left\|\varphi^{r} f^{(r)}\right\|<\infty$,
where $f^{(r-1)} \in$ A.C.loc means that $f$ is $r-1$ times differentiable and $f^{(r-1)}$ is absolutely continuous in every closed finite interval $[c, d] \subset(0,1)$.

We emphasize that Ditzian-Totik modulus of smoothness is easy to compute for various functions. For example, for $f(x)=x^{\delta}|\ln x / 2|^{\gamma}, x \in(0,1)$. Then for $r \geq 2 \delta$, we have [29, Section 3.4]:

\omega_{\varphi}^{r}(f, t) \asymp_{r, \delta, \gamma} \begin{cases}t^{2 \delta}|\ln t|^{\gamma} & \delta \notin \mathbb{Z}, \delta \geq 0, \gamma \geq 0  \tag{12}\\ t^{2 \delta}|\ln t|^{\gamma-1} & \delta \in \mathbb{Z}, \delta \geq 0, \gamma \geq 1\end{cases}
$$

An intuitive understanding of $\omega_{\varphi}^{r}(f, t)$ is the following. If the function $f$ is "smoother", the modulus is smaller. However, a non-zero $\omega_{\varphi}^{r}(f, t)$ cannot vanish faster than the order $t^{r}$ for any fixed $f$.

Notation: All the norms in this paper refer to the supremum norm. Concretely $\|f\|=\sup _{x}|f(x)|$. For non-negative sequences $a_{\gamma}, b_{\gamma}$, we use the notation $a_{\gamma} \lesssim \alpha b_{\gamma}$ to denote that there exists a universal constant $C$ that only depends on $\alpha$ such that $\sup _{\gamma} \frac{a_{\gamma}}{b_{\gamma}} \leq C$, and $a_{\gamma} \gtrsim \alpha b_{\gamma}$ is equivalent to $b_{\gamma} \lesssim_{\alpha} a_{\gamma}$. Notation $a_{\gamma} \asymp_{\alpha} b_{\gamma}$ is equivalent to $a_{\gamma} \lesssim \alpha b_{\gamma}$ and $b_{\gamma} \lesssim \alpha a_{\gamma}$. We write $a_{\gamma} \lesssim b_{\gamma}$ if the constant is universal and does not depend on any parameters. Notation $a_{\gamma} \gg b_{\gamma}$ means that $\liminf _{\gamma} \frac{a_{\gamma}}{b_{\gamma}}=\infty$, and $a_{\gamma} \ll b_{\gamma}$ is equivalent to $b_{\gamma} \gg a_{\gamma}$. We write $a \wedge b=\min \{a, b\}$ and $a \vee b=\max \{a, b\}$. Moreover, poly ${ }_{n}^{d}$ denotes the set of all $d$-variate polynomials of degree of each variable no more than $n$, and $E_{n}[f ; I]$ denotes the distance of the function $f$ to the space poly ${ }_{n}^{d}$ in the uniform norm $\|\cdot\|_{\infty, I}$ on $I \subset \mathbb{R}^{d}$. The space poly ${ }_{n}^{1}$ is also abbreviated as poly ${ }_{n}$. All logarithms are in the natural base. The notation $\mathbb{E}_{\theta}[X]$ denotes the mathematical expectation of the random variable $X$ whose distribution is indexed by the parameter $\theta$. The $s$-backward difference of a function defined over integers $G_{n}$ is

$$
\begin{equation*}
\Delta^{s} G_{n} \triangleq \sum_{k=0}^{s}(-1)^{k}\binom{s}{k} G_{n-k} \tag{13}
\end{equation*}
$$

Remark 1 (Operator view of bias reduction). It was elaborated in [30] that for any statistical model, the quantity $\mathbb{E}_{\theta} F(\theta)$ could be viewed as an operator that maps the function $F(\cdot)$ to another function of $\theta$. The operator is obviously linear in $F$, and is also positive in the sense that if $F \geq 0$ everywhere it is also everywhere non-negative. If we view $\mathbb{E}_{\theta} F(\hat{\theta})$ as an approximation of $F(\theta)$, then analyzing the bias of the estimator $F(\hat{\theta})$ is equivalent to analyzing the approximation error of $\mathbb{E}_{\theta} F(\hat{\theta})$.

Casting the bias analysis problem as an approximation problem, a key observation of this work is that the bootstrap bias correction could be viewed as the iterated Boolean sum approximation, and the jackknife bias correction could be viewed as a linear combination approximation, and the Taylor series bias correction corresponds to the Taylor series approximation. The main tool we use to handle these approximation theoretic questions is the $K$-functional, which we introduce in Appendix A

We now summarize our main results for jackknife, bootstrap, and Taylor series bias correction.

## A. Jackknife bias correction

The jackknife is a subsampling technique [13] that aims at making the biases of estimators with different
sample sizes cancel each other. Before we introduce the jackknife estimator, we recall the definition of $U$ statistic.

Definition 1 ( $U$-statistic). Let $g: \mathbb{R}^{r} \mapsto \mathbb{R}$ be a realvalued function of $r$ variables. For each $n \geq r$ the associated $U$-statistic $\mathbb{U}_{n}[g]: \mathbb{R}^{n} \mapsto \mathbb{R}$ is defined as
$\mathbb{U}_{n}[g]\left(X_{1}, X_{2}, \ldots, X_{n}\right)=\frac{\sum_{\beta} g\left(X_{\beta_{1}}, X_{\beta_{2}}, \ldots, X_{\beta_{r}}\right)}{\binom{n}{r}}$,
which is the average over ordered samples $\left(\beta_{1}, \beta_{2}, \ldots, \beta_{r}\right)$ of size $r$ of the sample values $g\left(X_{\beta_{1}}, X_{\beta_{2}}, \ldots, X_{\beta_{r}}\right)$.

Definition 2 ( $r$-jackknife estimator). Fix $r \geq 1, r \in \mathbb{Z}$. Fix $K>0$ such that $K$ does not scale with $n$. For a given function $f \in C[0,1]$ and any positive integer $m$, define function $g_{m}: \mathbb{R}^{m} \mapsto \mathbb{R}$ as

$$
\begin{equation*}
g_{m}\left(x_{1}, x_{2}, \ldots, x_{m}\right) \triangleq f\left(\frac{\sum_{i=1}^{m} x_{i}}{m}\right) \tag{15}
\end{equation*}
$$

For a collection of sample sizes $n_{1}<n_{2}<n_{3}<$ $\ldots<n_{r} \leq K n_{1}=n$, under the binomial model the general $r$-jackknife estimator is defined as

$$
\begin{equation*}
\hat{f}_{r}=\sum_{i=1}^{r} C_{i} \mathbb{U}_{n}\left[g_{m}\right]\left(X_{1}, X_{2}, \ldots, X_{n}\right) \tag{16}
\end{equation*}
$$

where $X_{1}, X_{2}, \ldots, X_{n} \stackrel{\text { i.i.d. }}{\sim} \operatorname{Bern}(p)$. The coefficients $\left\{C_{i}\right\}$ are given by

$$
\begin{equation*}
C_{i}=\prod_{j \neq i} \frac{n_{i}}{n_{i}-n_{j}}, 1 \leq i \leq r \tag{17}
\end{equation*}
$$

If $n_{r}=n, n_{i}-n_{i-1}=d$, then it is called the delete- $d$ $r$-jackknife estimator.

Note that the standard jackknife in (1) corresponds to $n_{1}=n-1, n_{2}=n$, whose corresponding coefficients are $C_{1}=-(n-1), C_{2}=n$. As shown in Lemma 13 in Appendix B the coefficients $\left\{C_{i}\right\}_{1 \leq i \leq r}$ in 17 satisfy the following:

\begin{align*}
\sum_{i=1}^{r} C_{i} & =1 \\
\sum_{i=1}^{r} \frac{C_{i}}{n_{i}^{\rho}} & =0, \quad 1 \leq \rho \leq r-1, \rho \in \mathbb{Z} \tag{18}
\end{align*}
$$

The intuition behind this condition is clear: only through these equations can one completely cancel any bias terms of order $1 / n^{\rho}, \rho \leq r-1$. It is also clear that (18) corresponds to solving a linear system with the Vandermonde matrix, for which the solution given in (17) is the unique solution due to the fact that all
the $n_{i}$ 's are distinct. The rationale above also appeared in [31], and the corresponding coefficients $C_{i}$ were given in the form of determinants. Equation 17] shows that in this special case the coefficients admit a simple expression.

1) Jackknife with the bounded coefficients condition: We introduce the following condition on $\left\{C_{i}\right\}_{1 \leq i \leq r}$ which turns out to be crucial for the bias and variance properties of the general $r$-jackknife.

Condition 1 (Bounded coefficients condition). We say that the jackknife coefficients $C_{i}$ in satisfy the bounded coefficients condition with parameter $C$ if there exists a constant $C$ that only depends on $r$ such that

$$
\begin{equation*}
\sum_{i=1}^{r}\left|C_{i}\right| \leq C \tag{19}
\end{equation*}
$$

One motivation for Condition 1 is the following. Observe that

$$
\begin{equation*}
\mathbb{E}_{p} \hat{f}_{r}=\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left[f\left(\hat{p}_{n_{i}}\right)\right] \tag{20}
\end{equation*}
$$

Viewing $\mathbb{E}_{p}\left[f\left(\hat{p}_{n_{i}}\right)\right]$ as an operator that maps $f$ to a polynomial, it is an approximation to $f(p)$, which is the Bernstein polynomial [32, Chapter 10]. It follows from the Bernstein theorem [33, Chap. 7] that $\lim _{n \rightarrow \infty}\left\|\mathbb{E}_{p} f\left(\hat{p}_{n}\right)-f(p)\right\|_{\infty}=0$ for any continuous function $f$ on $[0,1]$. Then, one can view the $r$-jackknife as a linear combination of operators. In this sense, Condition 1 assures that the linear combination as a new operator has bounded norm that is independent of $n$.

The following theorem quantifies the performance of the general $r$-jackknife under the bounded coefficients condition in Condition 1

Theorem 1. Suppose $\left\{C_{i}\right\}_{1 \leq i \leq r}$ satisfies Condition 1 with parameter $C$. Suppose $r \geq 1$ is a fixed integer. Let $\hat{f}_{r}$ denote the general $r$-jackknife in 16. Then, for any $f \in C[0,1]$, the following is true.
1)

$$
\begin{equation*}
\left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \lesssim_{r, C} \omega_{\varphi}^{2 r}(f, 1 / \sqrt{n})+n^{-r}\|f\| \tag{21}
\end{equation*}
$$

2) Fixing $0<\alpha<2 r$,

$$
\begin{align*}
& \left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \lesssim_{\alpha, r, C} n^{-\alpha / 2} \\
& \quad \Leftrightarrow \omega_{\varphi}^{2 r}(f, t) \lesssim_{\alpha, r, C} t^{\alpha} . \tag{22}
\end{align*}
$$

3) Suppose there is a constant $D<2^{2 r}$ for which

$$
\begin{equation*}
\omega_{\varphi}^{2 r}(f, 2 t) \leq D \omega_{\varphi}^{2 r}(f, t) \quad \text { for } t \leq t_{0} \tag{23}
\end{equation*}
$$

Then,

$$
\begin{equation*}
\left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \asymp_{r, C, D} \omega_{\varphi}^{2 r}(f, 1 / \sqrt{n}) . \tag{24}
\end{equation*}
$$

4) For $r=1$,

$$
\begin{equation*}
\left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \asymp \omega_{\varphi}^{2 r}(f, 1 / \sqrt{n}) \tag{25}
\end{equation*}
$$

The following corollary of Theorem 1 is immediate given (12).

Corollary 1. Under the conditions in Theorem 1, if $f=$ $-p \ln p$, then

$$
\begin{equation*}
\left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \asymp_{r, C} \frac{1}{n} \tag{26}
\end{equation*}
$$

If $f(p)=p^{\alpha}, 0<\alpha<1$, then,

$$
\begin{equation*}
\left\|f(p)-\mathbb{E}_{p} \hat{f}_{r}\right\| \asymp_{r, C} \frac{1}{n^{\alpha}} . \tag{27}
\end{equation*}
$$

Corollary 11 implies that the $r$-jackknife estimator for fixed $r$ does not improve the bias of $f\left(\hat{p}_{n}\right)$ for $f(p)=p \ln (1 / p)$, which makes it incapable of achieving the minimax rates of Shannon entropy estimation [23], [24].
2) Jackknife without the bounded coefficients condition: Theorem 1 has excluded the case that $n_{1}=$ $n-1, n_{2}=n$. Clearly, to satisfy the assumptions of Theorem 11 we need to require $\left|n_{i}-n_{i-1}\right| \gtrsim n_{1}$, which puts a minimum gap between the different sample sizes we can use. This begs the question: is this condition necessary to Theorem 1 to hold? If not, what bad consequences it will lead to?

From a computational perspective, taking $d$ small in the delete- $d$ jackknife may reduce the computational burden. However, as we now show, the usual delete1 jackknife does not satisfy Theorem 1 in general and exhibits drastically different bias and variance properties.

We now show that the delete-1 jackknife may have bias and variance both diverging to infinity in the worst case.

Theorem 2. Let $\hat{f}_{r}$ denote the delete-1 $r$-jackknife estimator. There exists a fixed function $f \in C(0,1]$ that satisfies $\|f\| \leq 1$ such that

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{r}-f(p)\right\| \gtrsim n^{r-1} \tag{28}
\end{equation*}
$$

If we allow the function $f$ to depend on $n$, then one can

[^1]have $f \in C[0,1]$. ${ }^{2}$
Meanwhile, for any $n \geq 4$, there exists a function $f \in C[0,1]$ depending on $n$ such that
\[

$$
\begin{equation*}
\left\|\operatorname{Var}_{p}\left(\hat{f}_{2}\right)\right\| \geq \frac{n^{2}}{e} \tag{32}
\end{equation*}
$$

\]

Theorem 2 shows that in the worst case, the delete$1 r$-jackknife may have bad performances compared to that satisfying Condition 1. Before we delve into the refined analysis of delete-1 $r$-jackknife, we illustrate the connection between various types of $r$-jackknife estimators. It turns out that the jackknife is intimately related to the divided differences of functions.

Definition 3 (Divided difference). The divided difference $f\left[x_{1}, x_{2}, \ldots, x_{n}\right]$ of a function $f$ over $n$ distinct points $\left\{x_{1}, x_{2}, \ldots, x_{n}\right\}$ is defined as

$$
\begin{equation*}
f\left[x_{1}, x_{2}, \ldots, x_{n}\right]=\sum_{i=1}^{n} \frac{f\left(x_{i}\right)}{\prod_{j \neq i}\left(x_{i}-x_{j}\right)} . \tag{33}
\end{equation*}
$$

It follows from 20, 17) and Lemma 13 in Appendix B that the bias of a general $r$-jackknife estimator $\hat{f}_{r}$ can be written as

$$
\begin{align*}
\mathbb{E}_{p}\left[\hat{f}_{r}\right]-f(p) & =\sum_{i=1}^{r} \prod_{j \neq i} \frac{n_{i}}{n_{i}-n_{j}}\left(\mathbb{E}_{p}\left[f\left(\hat{p}_{n_{i}}\right)\right]-f(p)\right)  \tag{34}\\
& =\sum_{i=1}^{r} \frac{n_{i}^{r-1}\left(\mathbb{E}_{p}\left[f\left(\hat{p}_{n_{i}}\right)\right]-f(p)\right)}{\prod_{j \neq i}\left(n_{i}-n_{j}\right)} \tag{35}
\end{align*}
$$

Define $G_{n, f, p}=n^{r-1}\left(\mathbb{E}_{p}\left[f\left(\hat{p}_{n}\right)\right]-f(p)\right)$. Then, the bias of $\hat{f}_{r}$ can be written as the divided difference of function $G_{\cdot, f, p}$ :

$$
\begin{equation*}
\mathbb{E}_{p}\left[\hat{f}_{r}\right]-f(p)=G_{\cdot, f, p}\left[n_{1}, n_{2}, \ldots, n_{r}\right] . \tag{36}
\end{equation*}
$$

It follows from the mean value theorem of divided differences defined over integers in Lemma 11 of Ap-

& \begin{aligned}
\left|\sum_{i=1}^{r} C_{i} \mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)-f(p)\right| & =\left|\sum_{i=1}^{r} C_{i}\left(\mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)-f(p)\right)\right| \\
& \leq \sum_{i=1}^{r}\left|C_{i}\right|\left\|\mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)-f(p)\right\|,
\end{aligned}
\end{align*}
$$

It follows from the Bernstein theorem [33 Chap. 7] that $\lim _{n \rightarrow \infty}\left\|\mathbb{E}_{p} f\left(\hat{p}_{n}\right)-f(p)\right\|=0$ for any continuous function $f$ on $[0,1]$. Hence, for any $f \in C[0,1]$ one has

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{r}-f(p)\right\|=o\left(n^{r-1}\right) \tag{31}
\end{equation*}
$$

since $\max _{1 \leq i \leq r}\left|C_{i}\right| \lesssim n^{r-1}$ for the delete-1 $r$-jackknife.
pendix B that for every $p, f$,

$$
\begin{align*}
& \left|\mathbb{E}_{p}\left[\hat{f}_{r}\right]-f(p)\right| \\
& \quad \leq \max _{n_{1} \leq n \leq n_{r}}\left|G_{\cdot, f, p}[n-r+1, n-r+2, \ldots, n-1, n]\right| \tag{37}
\end{align*}
$$

and the right hand side of (37) is nothing but the maximum of the bias of the delete-1 $r$-jackknife with varying sample sizes.

Equation 37) shows that in terms of the bias, the delete-1 jackknife might be the "worst" among all $r$ jackknife estimators. However, what is the precise performance of the delete-1 $r$-jackknife when the function $f$ is "smooth"? Does the performance improve compared to Theorem 2? We answer this question below.

Condition 2 (Condition $D_{s}$ ). A function $f:[0,1] \mapsto \mathbb{R}$ is said to satisfy the condition $D_{s}, s \geq 0, s \in \mathbb{Z}$ with parameter $L>0$ if the following is true:

1) $s=0: f$ is Lebesgue integrable on $[0,1]$ and $\sup _{x \in[0,1]}|f(x)| \leq L$.
2) $s \geq 1$ :
a) $f^{(s-1)}$ is absolutely continuous on $[0,1]$;
b) $\sup _{x \in[0,1]}\left|f^{(i)}(x)\right| \leq L, 0 \leq i \leq s$.

Remark 2. We mention that if a function $f$ satisfies condition $D_{s}$, it does not necessarily belong to the space $C^{s}[0,1]$, where $C^{s}[0,1]$ denotes the space of functions $f$ on $[0,1]$ such that $f^{(s)}$ is continuous. Indeed, the function $f(x)=x^{2} \sin (1 / x) \mathbb{1}(x \in(0,1])$ satisfies condition $D_{1}$ as a function mapping from $[0,1]$ to $\mathbb{R}$, but it does not belong to $C^{1}[0,1]$.

The performance of the delete-1 $r$-jackknife in estimating $f(p)$ satisfying condition $D_{s}$ is summarized in the following theorem.

Theorem 3. For any $r \geq 1, s \geq 0$ and $f$ satisfying condition $D_{s}$ with parameter $L$, let $\hat{f}_{r}$ be the delete-1 $r$-jackknife. Then,

$$
\left\|\mathbb{E}_{p} \hat{f}_{r}-f(p)\right\| \lesssim_{r, s, L} \begin{cases}n^{r-s-1} & \text { if } 0 \leq s \leq 2 r-2  \tag{38}\\ n^{-\left(r-\frac{1}{2}\right)} & \text { if } s=2 r-1 \\ n^{-r} & \text { if } s \geq 2 r\end{cases}
$$

Theorem 4. For $1 \leq s \leq 2 r-3$, there exists some universal constant $c>0$ such that for any $n \in \mathbb{N}$, there exists some function $f \in C^{s}[0,1]$ such that $\|f\| \leq 1,\left\|f^{\prime}\right\| \leq 1, \cdots,\left\|f^{(s)}\right\| \leq 1$, and for delete-1 $r$-jackknife $\hat{f}_{r}$ :

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right\| \geq c n^{r-1-s} \tag{39}
\end{equation*}
$$

Theorem 5. For integer $2 r-2 \leq s \leq 2 r-1$, there exists some function $f \in C^{s}[0,1]$ such that $\|f\| \leq 1,\left\|f^{\prime}\right\|_{\infty} \leq$ $1, \cdots,\left\|f^{(s)}\right\|_{\infty} \leq 1$, and for delete-1 $r$-jackknife $\hat{f}_{r}$,

$$
\begin{equation*}
\liminf _{n \rightarrow \infty} \frac{\left\|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right\|}{n^{-s / 2}}>0 \tag{40}
\end{equation*}
$$

Moreover, if $s \geq 2 r$, then

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right\|_{\infty} \gtrsim \frac{1}{n^{r}} \tag{41}
\end{equation*}
$$

Proof. The first part follows from (37) and Theorem 1 . The second part follows from taking $f(p)$ to be a polynomial of order $2 r$ with leading coefficient one.

Now we compare the performance of the $r$-jackknife estimator $\hat{f}_{r}$ with and without Condition 1 . Under Condition 1, we know from Theorem 1 that

$$
\begin{equation*}
\left|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right| \lesssim_{r, s, L, C} n^{-\min \left\{r, \frac{s}{2}\right\}} \tag{42}
\end{equation*}
$$

for $f$ satisfying condition $D_{s}$ with parameter $L 3$ where the exponent is better than that of Theorem 3 A pictorial illustration is shown in Figure 1


Fig. 1: Error exponents of "Good" and "Bad" jackknife estimators. Here "Good" refers to the $r$-jackknife satisfying Condition 1, and "Bad" refers to the delete-1 $r$-jackknife.

Remark 3. For general delete- $d r$-jackknife, the cases of $d \asymp n$ and $d=1$ exhibit drastically different behavior. It remains fertile ground for research to analyze what is the minimum $d$ needed for the delete- $d r$-jackknife to achieve the bias performance that is of the same order as those satisfying Condition 1 for a specific function $f$.

[^2]3) Specific functions: The last part of results pertaining to the jackknife investigates some specific functions $f(p)$. Here we take $f(p)=-p \ln p$ or $p^{\alpha}, 0<\alpha<1$. Those functions even do not belong to $D_{1}$ under Condition 2 . However, we show that the jackknife applied to these functions exhibits far better convergence rates than the worst case analysis in Theorem 4 predicted.

We show that for the $r$-jackknife when $r=2$, no matter whether Condition 1 is satisfied or not, the bias of the jackknife estimator can be universally controlled.
Theorem 6. Let $\hat{f}_{2}$ denote a general 2-jackknife in Definition 2. Then,

1) if $f(p)=-p \ln p$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \lesssim \frac{1}{n} \tag{43}
\end{equation*}
$$

2) if $f(p)=p^{\alpha}, 0<\alpha<1$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \lesssim \alpha \frac{1}{n^{\alpha}} \tag{44}
\end{equation*}
$$

Meanwhile, let $\hat{f}_{2}$ be either the delete-1 2-jackknife, or a 2 -jackknife that satisfies Condition 11. Then,

1) if $f(p)=-p \ln p$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \frac{1}{n} \tag{45}
\end{equation*}
$$

2) if $f(p)=p^{\alpha}, 0<\alpha<1$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \alpha \frac{1}{n^{\alpha}} \tag{46}
\end{equation*}
$$

Remark 4. We conjecture that Theorem 6 holds for any fixed $r$ instead of only $r=2$.

## B. Bootstrap bias correction

The rationale behind bootstrap bias correction is to use the plug-in rule to estimate the bias and then iterate the process [9]. Concretely, suppose we would like to estimate a function $f(\theta)$, and we have an estimator for $\theta$, denoted as $\hat{\theta}$. The estimator $\hat{\theta}\left(X_{1}^{n}\right)$ is a function of the observations $\left(X_{1}, X_{2}, \ldots, X_{n}\right)$, and $X_{i} \stackrel{\text { i.i.d. }}{\sim} P_{\theta}$. The bias of the plug-in rule $\hat{f}_{1}=f(\hat{\theta})$ is defined as

$$
\begin{equation*}
e_{1}(\theta)=f(\theta)-\mathbb{E}_{\theta} f(\hat{\theta}) \tag{47}
\end{equation*}
$$

We would like to correct this bias. The additive bootstrap bias correction does this by using the plug-in rule $e_{1}(\hat{\theta})$ to estimate $e_{1}(\theta)$, and then use $f(\hat{\theta})+e_{1}(\hat{\theta})$ to estimate $f(\theta)$, hoping that this bias corrected estimator has a smaller bias.

It is the place that the Monte Carlo approximation principle takes effect: it allows us to compute the plug-
in estimator $e_{1}(\hat{\theta})$ without knowing the concrete form of the bias function $e_{1}(\theta)$. Indeed, we have

$$
\begin{equation*}
e_{1}(\hat{\theta})=f(\hat{\theta})-\mathbb{E}_{\hat{\theta}} f\left(\hat{\theta}^{*}\right) \tag{48}
\end{equation*}
$$

where $\hat{\theta}^{*}=\hat{\theta}\left(X_{1}^{*}, X_{2}^{*}, \ldots, X_{n}^{*}\right)$, and the samples $X_{i}^{*} \stackrel{\text { i.i.d. }}{\sim} P_{\hat{\theta}}$. To compute $\mathbb{E}_{\hat{\theta}} f\left(\hat{\theta}^{*}\right)$, it suffices to draw the $n$-tuple sample $\left(X_{1}^{*}, X_{2}^{*}, \ldots, X_{n}^{*}\right)$ in total $B$ times under $P_{\hat{\theta}}$, and use the empirical average to replace the expectation, hoping that the law of large number would make the empirical average close to the expectation $\mathbb{E}_{\hat{\theta}} f\left(\hat{\theta}^{*}\right)$. This argument also shows that it takes $B$ rounds of sampling to evaluate $e_{1}(\cdot)$ at one point.

After doing bootstrap bias correction as introduced above once, we obtain $\hat{f}_{2}=f(\hat{\theta})+e_{1}(\hat{\theta})$. What about its bias? The bias of this new estimator, denoted as $e_{2}(\theta)$, is

$$
\begin{align*}
e_{2}(\theta) & =f(\theta)-\left(\mathbb{E}_{\theta} f(\hat{\theta})+\mathbb{E}_{\theta} e_{1}(\hat{\theta})\right)  \tag{49}\\
& =e_{1}(\theta)-\mathbb{E}_{\theta} e_{1}(\hat{\theta}) \tag{50}
\end{align*}
$$

Clearly, in order to compute $e_{2}(\hat{\theta})$, we need to evaluate $e_{1}(\cdot)$ in total $B$ times, which amounts to a total computation complexity $B^{2}$.

It motivates the general formula: the bias of the bootstrap bias corrected estimator after $m-1$ rounds of correction is related to that after $m-2$ rounds via

$$
\begin{equation*}
e_{m}(\theta)=e_{m-1}(\theta)-\mathbb{E}_{\theta} e_{m-1}(\hat{\theta}) \tag{51}
\end{equation*}
$$

Indeed, denoting the estimator after $m-2$ rounds of bias correction as $\hat{f}_{m-1}$, by definition we know $e_{m-1}(\theta)=$ $f(\theta)-\mathbb{E}_{\theta} \hat{f}_{m-1}$. The bias corrected estimator after $m-1$ rounds is $\hat{f}_{m}=\hat{f}_{m-1}+e_{m-1}(\hat{\theta})$, whose bias is

$$
\begin{align*}
e_{m}(\theta) & =f(\theta)-\mathbb{E}_{\theta}\left(\hat{f}_{m-1}+e_{m-1}(\hat{\theta})\right)  \tag{52}\\
& =e_{m-1}(\theta)-\mathbb{E}_{\theta} e_{m-1}(\hat{\theta}) \tag{53}
\end{align*}
$$

The bias corrected estimator after $m-1$ rounds of correction is

$$
\begin{equation*}
\hat{f}_{m}=f(\hat{\theta})+\sum_{i=1}^{m-1} e_{i}(\hat{\theta}) \tag{54}
\end{equation*}
$$

It takes $B^{m-1}$ order computations to compute $\hat{f}_{m}$ if we view the computation of $\hat{f}_{2}=f(\hat{\theta})+e_{1}(\hat{\theta})$ takes computational time $B$. We introduce an linear operator $A_{n}$ that maps the function $f$ to the same function space such that

$$
\begin{equation*}
A_{n}[f](\theta)=\mathbb{E}_{\theta} f(\hat{\theta}) \tag{55}
\end{equation*}
$$

With the help of the operator $A_{n}$, one may view the bias
of $\hat{f}_{m}$ in the following succinct way. Indeed, since

$$
\begin{align*}
e_{m}(\theta) & =e_{m-1}(\theta)-A_{n}\left[e_{m-1}\right](\theta)  \tag{56}\\
& =\left(I-A_{n}\right)\left[e_{m-1}\right](\theta) \tag{57}
\end{align*}
$$

we have

$$
\begin{align*}
\mathbb{E}_{\theta} \hat{f}_{m} & =A_{n}\left(I+\sum_{i=1}^{m-1}\left(I-A_{n}\right)^{i}\right)[f]  \tag{58}\\
& =A_{n}\left(\sum_{i=0}^{m-1}\left(I-A_{n}\right)^{i}\right)[f]  \tag{59}\\
& =\left(I-\left(I-A_{n}\right)^{m}\right)[f] \tag{60}
\end{align*}
$$

The operator $I-\left(I-A_{n}\right)^{m}$ is known as the iterated Boolean sum in the approximation theory literature [35], [36]. Indeed, defining the Boolean sum as $P \oplus Q=$ $P+Q-P Q$, we have

$$
\begin{equation*}
I-\left(I-A_{n}\right)^{m}=A_{n} \oplus A_{n} \oplus \ldots \oplus A_{n}=\oplus^{m} A_{n}, \tag{61}
\end{equation*}
$$

where there are $m$ terms on the right hand side.
Let the bias of the bootstrap bias corrected estimator after $m-1$ rounds be denoted as $e_{m}(p)$, where

$$
\begin{equation*}
e_{m}(p)=e_{m-1}(p)-\mathbb{E}_{p} e_{m-1}\left(\hat{p}_{n}\right) \tag{62}
\end{equation*}
$$

and $e_{1}(p)=f(p)-\mathbb{E}_{p}\left[f\left(\hat{p}_{n}\right)\right]$. Here $f \in C[0,1]$, and $n \cdot \hat{p}_{n} \sim \mathrm{~B}(n, p)$. Our first result on bootstrap bias correction is about the limiting behavior of $e_{m}(p)$ as $m \rightarrow \infty$. In other words, what happens when we conduct the bootstrap bias correction infinitely many times?

Theorem 7. Denote the unique polynomial of order $n$ that interpolates the function $f(p)$ at $n+1$ points $\{i / n$ : $0 \leq i \leq n\}$ by $L_{n}[f]$. Then, for any $f:[0,1] \mapsto \mathbb{R}$,

$$
\begin{equation*}
\lim _{m \rightarrow \infty} \sup _{p \in[0,1]}\left|e_{m}(p)-\left(f-L_{n}[f]\right)\right|=0 \tag{63}
\end{equation*}
$$

where $e_{m}(p)$ is defined in 62).
In other words, the bias function converges uniformly to the approximation error of the Lagrange interpolation polynomial that interpolates the function $f$ at equidistant points on $[0,1]$. This interpolating polynomial is in general known to exhibit bad approximation properties unless the function is very smooth. The Bernstein example below shows an extreme case.

Lemma 2. [37, Chap. 2, Sec. 2] [Bernstein's example] Suppose $f(p)=|p-1 / 2|$, and $L_{n}[f]$ denotes the unique polynomial that interpolates the function $f(p)$ at $n+1$ points $\{i / n: 0 \leq i \leq n\}$. Then,

$$
\begin{equation*}
\liminf _{n \rightarrow \infty}\left|L_{n}[f](p)\right|=\infty \tag{64}
\end{equation*}
$$

for all $p \in[0,1]$ except for $p=0,1 / 2$, and $1 .{ }^{4}$
For more discussions on the convergence/divergence behavior of $L_{n}[f]$, we refer the readers to [39] for more details. We emphasize that it is a highly challenging question. For example, it was shown in [40] that for any $p \in[0,1]$, we have

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left|L_{n}[f](p)-f(p)\right|=0 \tag{65}
\end{equation*}
$$

where $f(p)=-p \ln p$ or $p^{\alpha}, \alpha>0, \alpha \notin \mathbb{Z}$, and $L_{n}[f]$ is the Lagrange interpolation polynomial at equi-distant points. However, to our knowledge it is unknown that whether $\sup _{p \in[0,1]}\left|L_{n}[f](p)-f(p)\right|$ converges to zero as $n \rightarrow \infty$ for those specific functions, and if so, what the convergence rate is.

As Theorem 7 and Lemma 2 show, it may not be a wise idea to iterate the bootstrap bias correction too many times. It is both computationally prohibitive, and even may deteriorate statistically along the process. In practice, one usually conducts the bootstrap bias correction a few times. The next theorem provides performance guarantees for the first few iterations of bootstrap bias correction.

Theorem 8. Fix the number of iterations $m \geq 0$, and $0<\alpha \leq 2 m$. Then the following statements are true for any $f \in C[0,1]$. Here $e_{m}(p)$ is defined in 62.
1)

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \lesssim_{m} \omega_{\varphi}^{2 m}(f, 1 / \sqrt{n})+\|f\| n^{-m} \tag{66}
\end{equation*}
$$

2) 

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \lesssim_{\alpha, m} n^{-\alpha / 2} \Leftrightarrow \omega_{\varphi}^{2 m}(f, t) \lesssim_{\alpha, m} t^{\alpha} . \tag{67}
\end{equation*}
$$

3) 

$$
\begin{equation*}
\left\|e_{m}(p)\right\|<_{m} n^{-m} \Leftrightarrow f \text { is an affine function } \tag{68}
\end{equation*}
$$

4) Suppose there is a constant $D<2^{2 m}$ for which

$$
\begin{equation*}
\omega_{\varphi}^{2 m}(f, 2 t) \leq D \omega_{\varphi}^{2 m}(f, t) \quad \text { for } t \leq t_{0} \tag{69}
\end{equation*}
$$

Then,

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \asymp_{m, D} \omega_{\varphi}^{2 m}(f, 1 / \sqrt{n}) \tag{70}
\end{equation*}
$$

5) For $m=1$,

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \asymp \omega_{\varphi}^{2 m}(f, 1 / \sqrt{n}) \tag{71}
\end{equation*}
$$

Theorem 8 has several interesting implications. First of all, it shows that for a few iterations of the bootstrap

[^3]bias correction, we have a decent bound on the bias $\left\|e_{m}(p)\right\|$, which is intimately connected with the $2 m$-th order Ditzian-Totik modulus of smoothness evaluated at $1 / \sqrt{n}$. This bound is tight in various senses. The second statement shows that it captures the bias $\left\|e_{m}(p)\right\|$ at least up to the granularity of the exponent in $n$, and the third statement shows that it is impossible for the bootstrap bias corrected estimator to achieve bias of order lower than $n^{-m}$ except for the trivial case of affine functions, which have bias zero. The fourth statement shows that as long as the modulus $\omega_{\varphi}^{2 m}(f, t)$ is not too close to $t^{2 m}$, the DT modulus bound is tight. The fifth statement shows that when we do not do any bias correction, the DT modulus bound is tight for any function in $C[0,1]$.

The following corollary is immediate given (12).

Corollary 2. If $f(p)=-p \ln p$, then,

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \asymp_{m} \frac{1}{n} \asymp_{m}\left\|e_{1}(p)\right\| \tag{72}
\end{equation*}
$$

If $f(p)=p^{\alpha}, 0<\alpha<1$, then

$$
\begin{equation*}
\left\|e_{m}(p)\right\| \asymp_{m, \alpha} \frac{1}{n^{\alpha}} \asymp_{m, \alpha}\left\|e_{1}(p)\right\| \tag{73}
\end{equation*}
$$

which means that the bootstrap bias correction for the first few rounds does not change the order of bias at all.

We have shown that the bias of $\hat{f}_{m}$ converges to the approximation error of the Lagrange interpolation polynomial at equi-distant points when $m \rightarrow \infty$ (Theorem 77. However, we also know that for the first few iterations of the bootstrap, the bias of $\hat{f}_{m}$ can be well controlled (Theorem 8). It begs the question: how does $\left\|e_{m}(p)\right\|$ evolve as $m \rightarrow \infty$ ?

We study this problem through the example of $f(p)=$ $|p-1 / 2|$, with the sample size $n=20$. Thanks to the special structure of the Binomial functions, we are able to numerically compute $\left\|e_{m}(p)\right\|$ up to $m \approx 8.5 \times 10^{5}$. It follows from Theorem 7 that

$$
\begin{equation*}
\lim _{m \rightarrow \infty}\left\|e_{m}(p)\right\|=\left\|f-L_{n}[f]\right\| \tag{74}
\end{equation*}
$$

and for $n=20$, we numerically evaluated $\left\|f-L_{n}[f]\right\|$ to be 47.5945 .


Fig. 2: The evolution of $\left\|e_{m}(p)\right\|$ as a function of $m$ for $1 \leq m \leq 8.5 \times 10^{5}$.

Figure 2, 3, and 4 show that the behavior of $\left\|e_{m}(p)\right\|$ could be highly irregular: in fact, for the specific function $f(p)=|p-1 / 2|$, it continues to decrease until $m$ grows slightly above $2 \times 10^{3}$, and then keeps on increasing until $m$ exceeds about $1.2 \times 10^{4}$, then it continues to drop until it hits about $3 \times 10^{4}$, then it keeps on increasing again within the range of computations we conduct. It is also clear that after about $8.5 \times 10^{5}$ bootstrap iterations, which is by no means practical, $\left\|e_{m}(p)\right\|$ is still far from its limit $\left\|f-L_{n}[f]\right\|$, which is about 47.5945 as shown in Figure 4 .

Remark 5 (Connections between bootstrap and jackknife). The interested reader must have observed that the bias properties of the bootstrap bias corrected estimator after $r-1$ rounds are the same as that of the $r$-jackknife estimator satisfying Condition 1. Concretely, their biases are both dictated by the modulus $\omega_{\varphi}^{2 r}(f, 1 / \sqrt{n})$. It would be interesting to compare the rate $\omega_{\varphi}^{2 r}(f, 1 / \sqrt{n})$ with that of the best polynomial approximation, upon noting that in the binomial model, the biases of both the jackknife and bootstrap estimators are polynomial approximation errors of the function $f(p)$ with degree at most $n$. It follows [29, Thm. 7.2.1.] that for best polynomial approximation with degree $n$, the approximation error $\inf _{P \in \text { poly }_{n}} \sup _{p \in[0,1]}|f(p)-P(p)|$ is upper bounded by $\omega_{\varphi}^{k}(f, 1 / n)$ for any $k<n$. We first observe that one achieves a smaller argument ( $1 / n$ compared to $1 / \sqrt{n}$ ) in this case, but more importantly, there is essentially no restriction on the modulus order when $n$ is large. It indicates the best polynomial approximation induces a much better approximation (smaller bias) for estimating $f(p)$, which, unfortunately has been shown in [20] to fail to achieve the minimax rates in entropy estimation, since the variance explodes while the bias is very small. The estimators in [21], [23], [30] only choose to conduct best polynomial approximation in certain regimes of $f$, which reduces the bias by a logarithmic factor without increasing too much the variance.

## C. Taylor series bias correction

The Taylor series can only be applied to functions with certain global differentiablity conditions, which makes it a less versatile method compared to the bootstrap and jackknife. The Taylor series bias correction method exhibits various forms in the literature, and we discuss two of them in this section. We call one approach the iterative first order correction, and the other approach the sample splitting correction. To illustrate the main ideas behind the methods, we still use the binomial model $n \cdot \hat{p}_{n} \sim \mathrm{~B}(n, p)$.

1) Iterative first order correction: As shown in 41, Chapter 6, Section 1, Pg. 436], suppose for certain $f$, we have

\mathbb{E}_{p} f\left(\hat{p}_{n}\right)-f(p)=\frac{B_{n}(p)}{n}+O\left(\frac{1}{n^{2}}\right) \tag{75}
\end{equation*}
$$

where $B_{n}(p)=\frac{1}{2} f^{\prime \prime}(p) n \mathbb{E}_{p}\left(\hat{p}_{n}-p\right)^{2}$. Then, the Taylor series bias corrected estimator is defined as

\hat{f}_{2}=f\left(\hat{p}_{n}\right)-\frac{B_{n}\left(\hat{p}_{n}\right)}{n} \tag{76}
\end{equation*}
$$

We can generalize the approach above to conduct bias correction for multiple rounds [7]. However, the correction formula becomes increasingly more complicated as the correction order becomes higher. We start with the following lemma.

Lemma 3. Suppose function $f:[0,1] \mapsto \mathbb{R}$ satisfies condition $D_{s}$ with parameter $L$ as in Condition 2, where $s=2 k$ is a positive even integer. Then, if $n \cdot \hat{p}_{n} \sim$ $\mathrm{B}(n, p)$, there exist $k-1$ linear operators denoted as $T_{j}[f](p), 1 \leq j \leq k-1$, independent of $n$, such that

\left|\mathbb{E}_{p} f\left(\hat{p}_{n}\right)-f(p)-\sum_{j=1}^{k-1} \frac{1}{n^{j}} T_{j}[f](p)\right| \lesssim_{k, L} \frac{1}{n^{k}} \tag{77}
\end{equation*}

Here $\sup _{p \in[0,1]}\left|T_{j}[f](p)\right| \lesssim_{k, L}$ 1. Concretely, $T_{j}[f](p)$ is a linear combination of the derivatives of $f$ of order from $j+1$ to $2 j$ where the combination coefficients are polynomials of $p$ with degree no more than $2 j$.

Now we describe the Taylor series bias correction algorithm below [7].

Construction 1 (Taylor series bias correction). [7] Define $t_{i}(p)$ iteratively. Set $t_{0}(p)=f(p)$, and for $i \geq 1$ define

t_{i}(p)=-\sum_{j=1}^{i} T_{j}\left[t_{i-j}\right](p) \tag{78}
\end{equation*}

The final bias corrected estimator is

$$

\hat{f}_{k}=\sum_{i=0}^{k-1} \frac{1}{n^{i}} t_{i}\left(\hat{p}_{n}\right) \tag{79}
\end{equation*}
$$

Construction 1 may be intuitively understood as the iterative generalization of the order one Taylor series bias correction (76). Indeed, after we conduct the first order bias correction and obtain

& =t_{0}\left(\hat{p}_{n}\right)+\frac{t_{1}\left(\hat{p}_{n}\right)}{n} \tag{81}
\end{align*}
$$

we apply Lemma 3 to the function $t_{0}+\frac{t_{1}}{n}$ and obtain
the expansion up to order $\frac{1}{n^{2}}$ as

& t_{0}(p)+\frac{t_{1}(p)}{n}+\frac{T_{1}\left[t_{0}\right](p)}{n}+\frac{T_{2}\left[t_{0}\right](p)}{n^{2}}+\frac{T_{1}\left[t_{1}\right](p)}{n^{2}} \\
& \quad=t_{0}(p)+\frac{T_{2}\left[t_{0}\right](p)}{n^{2}}+\frac{T_{1}\left[t_{1}\right](p)}{n^{2}} \tag{82}
\end{align*}
$$

where we used the definition of $t_{1}=-T_{1}\left[t_{0}\right]$. It naturally leads to the further correction

t_{2}(p)=-T_{2}\left[t_{0}\right](p)-T_{1}\left[t_{1}\right](p) \tag{83}
\end{equation*}

One can repeat this process to obtain the formula in Construction 1

Now we prove that the estimator $\hat{f}_{k}$ in Construction 1 achieves bias of order $O\left(n^{-k}\right)$ if the original function $f$ satisfies condition $D_{s}$ with $s=2 k$. It can be viewed as one concrete example of [7].

Theorem 9. Suppose $f:[0,1] \mapsto \mathbb{R}$ satisfies condition $D_{s}$ with parameter $L$, and $s=2 k, k \geq 1, k \in \mathbb{Z}$. Then, the estimator in Construction 1 satisfies

$$
\begin{equation*}
\left\|\mathbb{E}_{p}\left[\hat{f}_{k}\right]-f(p)\right\| \lesssim_{k, L} \frac{1}{n^{k}} \tag{84}
\end{equation*}
$$

2) Sample splitting correction: This method was proposed in [42]. It aims at solving one disadvantage of Construction 1, which is that the bias correction formula for higher orders may not be easy to manipulate since it is defined through a recursive formula. The sampling splitting correction method provides an explicit bias correction formula which is easy to analyze with transparent proofs, but the disadvantage it has is that it only applies to certain statistical models.

The intuition of the sample splitting correction method is the following, which is taken from [42]. Suppose $f$ satisfies condition $D_{2 k}$ with parameter $L$. Instead of doing Taylor expansion of $f\left(\hat{p}_{n}\right)$ near $p$, we employ Taylor expansion of $f(p)$ near $\hat{p}_{n}$ :

$$
\begin{equation*}
f(p) \approx \sum_{i=0}^{2 k-1} \frac{f^{(i)}\left(\hat{p}_{n}\right)}{i!}\left(p-\hat{p}_{n}\right)^{i} \tag{85}
\end{equation*}
$$

Now, $f^{(i)}\left(\hat{p}_{n}\right)$ is by definition an unbiased estimator for $\mathbb{E}_{p}\left[f^{(i)}\left(\hat{p}_{n}\right)\right]$. However, the unknown $p$ in the right hand side still prevents us from using this estimator explicitly. Fortunately, this difficulty can be overcome by the standard sample splitting approach: we split samples to obtain independent $\hat{p}_{n}^{(1)}$ and $\hat{p}_{n}^{(2)}$, both of which follow the same class of distribution (with possibly different parameters) as $\hat{p}_{n}$. We remark that sample splitting can be employed for divisible distributions, including multinomial, Poisson and Gaussian models [43]. Now
our bias-corrected estimator is

$$
\begin{equation*}
\hat{f}_{k}=\sum_{i=0}^{2 k-1} \frac{f^{(i)}\left(\hat{p}_{n}^{(1)}\right)}{i!} \sum_{j=0}^{i}\binom{i}{j} S_{j}\left(\hat{p}_{n}^{(2)}\right)\left(-\hat{p}_{n}^{(1)}\right)^{i-j} \tag{86}
\end{equation*}
$$

where $S_{j}\left(\hat{p}_{n}^{(2)}\right)$ is an unbiased estimator of $p^{j}$ (which usually exists when sample splitting is doable). Now it is straightforward to show that

\mathbb{E}\left[\hat{f}_{k}\right]-f(p) & =\mathbb{E}_{p}\left[\sum_{i=0}^{2 k-1} \frac{f^{(i)}\left(\hat{p}_{n}^{(1)}\right)}{i!}\left(p-\hat{p}_{n}^{(1)}\right)^{i}-f(p)\right]  \tag{87}\\
& \lesssim \mathbb{E}_{p}\left|\frac{\left\|f^{(2 k)}\right\|}{(2 k)!}\left(\hat{p}_{n}^{(1)}-p\right)^{2 k}\right|  \tag{88}\\
& \lesssim k, L \frac{1}{n^{k}}, \tag{89}
\end{align*}
$$

where in the last step we used the property of the binomial distribution in Lemma 15

The rest of the paper is organized as follows. Section II] discusses the key proof ingredients of the results pertaining to jackknife bias correction. The proofs of main results on bootstrap bias correction are provided in Section III Appendix A reviews the $K$-functional approach for bias analysis. Appendix Bcollects auxiliary lemmas used throughout this paper. Proofs of the rest of the theorems and lemmas in the main text are provided in Appendix C, and the proofs of the auxiliary lemmas are presented in Appendix D

## II. JACKKNIFE BIAS CORRECTION

## A. Theorem 3

We first present the proof of Theorem 3. We explain the roadmap below, and the key lemmas used in roadmap are proved in Appendix C.

The first step to analyze the general $r$-jackknife for functions $f$ satisfying the Condition $D_{s}$ in Condition 2 is to use Taylor expansions. It is reflected in Lemma 4
Lemma 4. Suppose $f$ satisfies Condition 2 for fixed $s \geq$ 1 with parameter $L$. Then, for the general $r$-jackknife estimator with fixed $r \geq 1$ in Definition 2,

& +\int_{p}^{1}\left|\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}\right| d t \\
& +\int_{0}^{p}\left|\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{-}^{s-1}\right| d t \tag{90}
\end{align*}
$$

Here the coefficients $\left\{C_{i}\right\}_{1 \leq i \leq r}$ are given in Definition 2.

Lemma 4 shows that it suffices to analyze the behavior of the quantities $\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}$ and $\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{-}^{s-1}$. These quantities can be viewed as divided differences (see (36), and to analyze the worst case we analyze the following backward difference sequences.

For $t \geq p, u \geq 0, s \geq 0$, define

and consider its $s$-backward difference defined as

if $\frac{1}{n}<p \leq \frac{1}{2}$,

\left|\Delta^{s} A_{n, u}(t)\right| \leq & c_{1} \cdot\left(n^{-\left(\frac{u}{2}+s\right)} p^{\frac{u}{2}}+n^{-u} p^{u \wedge 1}\left(\frac{1}{\sqrt{n t}} \wedge 1\right)\right) \\
& \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{t}\right) \tag{94}
\end{align*}
$$

if $\frac{1}{2}<p \leq 1-\frac{1}{n}$,

\left|\Delta^{s} A_{n, u}(t)\right| \leq c_{1} \cdot\left(n^{-\left(\frac{u}{2}+s\right)}(1-p)^{\frac{u}{2}}+n^{-u}(1-p)^{u \wedge 1}\right.
$$

$$
\begin{equation*}
\left.\cdot\left(\frac{1}{\sqrt{n(1-t)}} \wedge 1\right)\right) \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{1-p}\right) \tag{95}
\end{equation*}
$$

where the universal constants $c_{1}, c_{2}>0$ only depend on $u, s$ (not on $n$ or $p$ ). Moreover, if $t>1-\frac{1}{n}$, we have

\left|\Delta^{s} A_{n, u}(t)\right| \leq c_{1}(1-t)^{u}(1-p)^{s} p^{n-s} \tag{96}
\end{equation*}

Note that in Lemma 5, the case where $p>1-\frac{1}{n}$ has already been included in the case $t>1-\frac{1}{n}$, for $t \geq p$. Hence, Lemma 5 has completely characterized an upper bound on the dependence of $\left|\Delta^{s} A_{n, u}(t)\right|$ on all $n, p$ and $t$. By symmetry, we have the following corollary regarding

$\left|\Delta^{s} A_{n, u}^{-}(t)\right| \leq c_{1} \cdot\left(n^{-(u+s-1)}(1-p)+n^{-u}(1-p)^{u \wedge 1}\right.$

$$
\begin{equation*}
\left.\cdot\left(\frac{1}{\sqrt{n(1-t)}} \wedge 1\right)\right) \cdot \exp \left(-c_{2} n(1-t)\right) \tag{98}
\end{equation*}
$$

if $\frac{1}{2} \leq p \leq 1-\frac{1}{n}$,

\begin{align*}
\left|\Delta^{s} A_{n, u}^{-}(t)\right| \leq & c_{1} \cdot\left(n^{-\left(\frac{u}{2}+s\right)}(1-p)^{\frac{u}{2}}+n^{-u}(1-p)^{u \wedge 1}\right. \\
& \left.\cdot\left(\frac{1}{\sqrt{n(1-t)}} \wedge 1\right)\right) \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{1-t}\right) \tag{99}
\end{align*}
$$

if $\frac{1}{n} \leq p<\frac{1}{2}$,

\left|\Delta^{s} A_{n, u}^{-}(t)\right| \leq & c_{1} \cdot\left(n^{-\left(\frac{u}{2}+s\right)} p^{\frac{u}{2}}+n^{-u} p^{u \wedge 1}\left(\frac{1}{\sqrt{n t}} \wedge 1\right)\right) \\
& \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{p}\right) \tag{100}
\end{align*}

where the universal constants $c_{1}, c_{2}>0$ only depend on $u, s$ (not on $n$ or $p$ ). Moreover, if $t<\frac{1}{n}$, we have

Furthermore, in most cases we do not need the dependence on $p$, and Lemma 5 implies the following corollary.

&\left.+n^{-\left(u+\frac{1}{2}\right)} \cdot \frac{1}{\sqrt{1-t^{\prime}+n^{-1}}} \exp \left(-\frac{c_{2} n\left(t^{\prime}-p\right)^{2}}{1-t}\right)\right) \tag{103}
\end{align*}

where the universal constants $c_{1}, c_{2}>0$ only depend on $u, s$ (not on $n$ or $p$ ).

Now we can start the proof of Theorem 3

Proof of Theorem 3 We split into three cases. When $s=0$, we use the triangle inequality to conclude that

For $t \geq p$, it follows from Corollary 4 that there exist universal constants $c_{1}, c_{2}$ depending on $r, s$ only such that

& \left.+e^{-c_{2} n(t-p)^{2}}\right) \cdot n^{-\min \left\{\frac{s-1}{2}+j, s-\frac{1}{2}\right\}}  \tag{111}\\
& \lesssim_{r, s}\left(\frac{1}{\sqrt{t+n^{-1}}} e^{-\frac{c_{2} n(t-p)^{2}}{t}}+e^{-c_{2} n(t-p)^{2}}\right) \\
& \text { • } n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}} \text {. } \tag{112}
\end{align*}

As a result of Lemma 11 ,

&=\left|B_{\cdot, r, s}\left[n_{1}, \cdots, n_{r}\right](t)\right|  \tag{114}\\
& \leq \frac{1}{(r-1)!} \max _{m \in\left[n_{1}, n_{r}\right]}\left|\Delta^{r} B_{m, r, s}(t)\right|  \tag{115}\\
& \lesssim_{r, s}\left(\frac{1}{\sqrt{t+n^{-1}}} e^{-\frac{c_{2} n(t-p)^{2}}{t}}+e^{-c_{2} n(t-p)^{2}}\right) \\
& \cdot n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}} . \tag{116}
\end{align*}

Using this inequality, finally we arrive at

& \lesssim_{r, s} \int_{p}^{1}\left(\frac{1}{\sqrt{t+n^{-1}}} e^{-\frac{c_{2} n(t-p)^{2}}{t}}+e^{-c_{2} n(t-p)^{2}}\right) \\
& \quad \cdot n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}} d t  \tag{117}\\
& \leq n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}}\left(\int_{0}^{\infty} \frac{1}{\sqrt{u+p+n^{-1}}}\right. \\
& \left.\quad \cdot e^{-\frac{c_{2} n u^{2}}{u+p}} d u+\int_{0}^{\infty} e^{-c_{2} n u^{2}} d u\right)  \tag{118}\\
& \leq n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}}\left(\int_{0}^{p} \frac{1}{\sqrt{p}} e^{-\frac{c_{2} n u^{2}}{2 p}} d u\right. \\
& \left.\quad+\int_{p}^{\infty} \sqrt{n} e^{-\frac{c_{2} n u}{2}} d u+\int_{0}^{\infty} e^{-c_{2} n u^{2}} d u\right)  \tag{119}\\
& \leq n^{-\min \left\{\frac{s-1}{2}, s-r+\frac{1}{2}\right\}}\left(\frac{1}{\sqrt{p}} \int_{0}^{\infty} e^{-\frac{c_{2} n u^{2}}{2 p}} d u\right. \\
& \left.\quad+\sqrt{n} \int_{0}^{\infty} e^{-\frac{c_{2} n u}{2}} d u+\int_{0}^{\infty} e^{-c_{2} n u^{2}} d u\right)  \tag{120}\\
& \vdots r, s n^{-\min \left\{\frac{s}{2}, s-r+1\right\}} \tag{121}
\end{align*}
$$

as desired. The remaining part can be dealt with analogously.

When $s \geq 2 r$, the desired result follows from applying Lemma 4 with $s=2 r$.

## B. Theorem 4

We consider the case where $s>0$ and $s \leq 2 r-3$. To come up with an example which matches the upper bound in Theorem 3, we first need to prove a "converse" of Lemma 5. Recall that for $t \geq p$,

A_{n, u}(t)=\mathbb{E}_{p}\left(\hat{p}_{n}-t\right)_{+}^{u} \tag{122}
\end{equation*}
$$

Lemma 6. For any $0 \leq u \leq 2(s-1)$, there exists some $p_{0}>0$ such that for any $0<p<\min \left\{p_{0}, \frac{1}{4 s}\right\}$ and any $n \geq \frac{1}{p^{2}}$, whenever $t \in\left[p, p+\frac{1}{\sqrt{n}}\right]$ satisfies

1) $\frac{k}{n-s+1}<t<\frac{k-p}{n-s}$ for some $k \in \mathbb{N}$ if $u<s$;
2) $\frac{k}{n-s}<t<\frac{k+p}{n-s}$ for some $k \in \mathbb{N}$ if $u \geq s$,
we have

$$
\begin{equation*}
\left|\Delta^{s} A_{n, u}(t)\right| \geq c n^{-\left(u+\frac{1}{2}\right)} \tag{123}
\end{equation*}
$$

where $c>0$ is a universal constant which only depends on $u, s$ and $p$.

Now we start the proof of Theorem 4. The basic idea of the proof is to construct functions $f$ such that Lemma 4 is nearly tight.

Proof of Theorem 4 Pick an arbitrary $p>0$ which satisfies Lemma 6, and we define

$$
\begin{equation*}
g(t)=\operatorname{sign}\left(\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}\right) \cdot \mathbb{1}(t \geq p) \tag{124}
\end{equation*}
$$

Note that $g$ is not continuous, but we can find some $h \in C[0,1]$ such that $\|g-h\|_{1} \leq n^{-2 r}$. Now choose any $f$ with $f^{(s)}=h$, we know that $f \in C^{s}[0,1]$, and the norm conditions are satisfied under proper scaling.

It follows from Lemma 4 that

$$
\begin{align*}
& \left|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right| \\
\asymp & O\left(n^{-r}\right)+\int_{p}^{1} h(t)\left(\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}\right) d t \\
& +\int_{0}^{p} h(t)\left(\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{-}^{s-1}\right) d t  \tag{125}\\
= & O\left(n^{-r}\right)+\int_{0}^{1} g(t)\left(\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}\right) d t \\
& +O\left(\|g-h\|_{1}\right) \cdot \sum_{i=1}^{r}\left|C_{i}\right|  \tag{126}\\
= & O\left(n^{-r}\right)+\int_{p}^{1}\left|\sum_{i=1}^{r} C_{i} \mathbb{E}_{p}\left(\hat{p}_{n_{i}}-t\right)_{+}^{s-1}\right| d t  \tag{127}\\
= & o\left(n^{r-1-s}\right)+\int_{p}^{1}\left|\sum_{i=1}^{r} C_{i} A_{n_{i}, s-1}(t)\right| d t  \tag{128}\\
\geq & o\left(n^{r-1-s}\right)+\int_{G}\left|\sum_{i=1}^{r} C_{i} A_{n_{i}, s-1}(t)\right| d t \tag{129}
\end{align*}
$$

where $G \subset\left[p, p+\frac{1}{\sqrt{n}}\right]$ is the set of all "good" $t$ 's which satisfy the condition of Lemma 6. It's easy to see

$$
\begin{equation*}
m(G) \asymp n^{-\frac{1}{2}} \tag{130}
\end{equation*}
$$

where $m(\cdot)$ denotes the Lebesgue measure. Moreover, by our choice of delete- 1 jackknife, for $t \in G$ we have

$$
\begin{align*}
&\left|\sum_{i=1}^{r} C_{i} A_{n_{i}, s-1}(t)\right| \\
&=\left|\Delta^{r-1}\left(n^{r-1} A_{n, s-1}(t)\right)\right| \\
& \gtrsim n^{r-1}\left|\Delta^{r-1} A_{n, s-1}(t)\right| \\
& \quad-\sum_{1 \leq i \leq r-1,0 \leq j \leq r-1, i+j \geq r-1}\left|\Delta^{i} n^{r-1}\right| \cdot\left|\Delta^{j} A_{n, s-1}(t)\right|  \tag{132}\\
& \gtrsim n^{r-1-\left(s-\frac{1}{2}\right)}-\sum_{1 \leq i \leq r-1,0 \leq j \leq r-1}^{i+j \geq r-1}, \tag{133}
\end{align*}
$$

$\gtrsim n^{r-s-\frac{1}{2}}$
where we have used Lemma 5] Lemma 6 and the assumption that $0 \leq s-1 \leq 2(r-2)$. As a result, we conclude that

$$
\begin{align*}
& \left|\mathbb{E}_{p} \hat{f}_{r}\left(\hat{p}_{n}\right)-f(p)\right| \\
\gtrsim & o\left(n^{r-1-s}\right)+\int_{G}\left|\sum_{i=1}^{r} C_{i} A_{n_{i}, s-1}(t)\right| d t  \tag{135}\\
\gtrsim & o\left(n^{r-1-s}\right)+m(G) \cdot n^{r-s-\frac{1}{2}}  \tag{136}\\
\gtrsim & n^{r-s-1} \tag{137}
\end{align*}
$$

as desired.

## C. Theorem 6

The following lemma characterizes the difference $\mathbb{E}_{p} f\left(\hat{p}_{n}\right)-\mathbb{E}_{p} f\left(\hat{p}_{n-1}\right)$ for certain functions.

Lemma 7. [44] Suppose $f(p)=-p \ln p, p \in[0,1]$. Then,

$$
\begin{equation*}
0 \leq \mathbb{E}_{p} f\left(\hat{p}_{n}\right)-\mathbb{E}_{p} f\left(\hat{p}_{n-1}\right) \leq \frac{1-p^{n}-(1-p)^{n}}{n(n-1)} \tag{138}
\end{equation*}
$$

Suppose $f(p)=p^{\alpha}, p \in[0,1], 0<\alpha<1$. Then,

$$
\begin{align*}
0 & \leq \mathbb{E}_{p} f\left(\hat{p}_{n}\right)-\mathbb{E}_{p} f\left(\hat{p}_{n-1}\right) \\
& \leq \frac{(1-\alpha)\left(1-p^{n}-(1-p)^{n}\right)}{n(n-1)^{\alpha}} \tag{139}
\end{align*}
$$

The next lemma characterizes the lower bound for the bias of the jackknife estimate $\hat{f}_{2}$.
Lemma 8. Suppose $\hat{f}_{2}$ is the delete-1 2-jackknife. Then,

1) for $f(p)=-p \ln p$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \frac{1}{n} \tag{140}
\end{equation*}
$$

2) for $f(p)=p^{\alpha}, 0<\alpha<1$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \frac{1}{n^{\alpha}} \tag{141}
\end{equation*}
$$

Suppose $\hat{f}_{2}$ is a 2-jackknife that satisfies Condition 1 . Then,

1) for $f(p)=-p \ln p$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \frac{1}{n} \tag{142}
\end{equation*}
$$

2) for $f(p)=p^{\alpha}, 0<\alpha<1$,

$$
\begin{equation*}
\left\|\mathbb{E}_{p} \hat{f}_{2}-f(p)\right\| \gtrsim \frac{1}{n^{\alpha}} \tag{143}
\end{equation*}
$$

Now we can start the proof of Theorem 6

Proof of Theorem 6 The lower bounds follow from Lemma 8 Now we prove the upper bounds.

For a general 2-jackknife and general function $f$, we have

$$
\begin{align*}
\mathbb{E}_{p}\left[\hat{f}_{2}\right]-f(p)= & \frac{n_{1}}{n_{1}-n_{2}}\left(\mathbb{E}_{p}\left[f\left(\hat{p}_{n_{1}}\right)\right]-f(p)\right) \\
& +\frac{n_{2}}{n_{2}-n_{1}}\left(\mathbb{E}_{p}\left[f\left(\hat{p}_{n_{2}}\right)\right]-f(p)\right) . \tag{144}
\end{align*}
$$

Define $H_{n}=\mathbb{E}_{p}\left[f\left(\hat{p}_{n}\right)\right]-f(p)$. Then,

$$
\begin{align*}
\mathbb{E}_{p}\left[\hat{f}_{2}\right]-f(p) & =\frac{n_{2} H_{n_{2}}-n_{1} H_{n_{1}}}{n_{2}-n_{1}}  \tag{145}\\
& =H_{n_{2}}+\frac{n_{1}}{n_{2}-n_{1}}\left(H_{n_{2}}-H_{n_{1}}\right) \tag{146}
\end{align*}
$$

For any $f \in C[0,1]$, we have $\lim _{n \rightarrow \infty} H_{n}=0$, which implies

$$
\begin{align*}
H_{n_{2}} & =H_{n_{2}}-H_{\infty}  \tag{147}\\
& =\sum_{j=n_{2}}^{\infty}\left(H_{j}-H_{j+1}\right) \tag{148}
\end{align*}
$$

and

$$
\begin{equation*}
H_{n_{2}}-H_{n_{1}}=\sum_{j=n_{1}+1}^{n_{2}}\left(H_{j}-H_{j-1}\right) \tag{149}
\end{equation*}
$$

It follows from Lemma 8 that for $f(p)=-p \ln p, 0 \leq$ $H_{j}-H_{j-1} \lesssim \frac{1}{j^{2}}$. Hence,

$$
\begin{align*}
\left\|\mathbb{E}_{p}\left[\hat{f}_{2}\right]-f(p)\right\| & \lesssim \sum_{j=n_{2}}^{\infty} \frac{1}{j^{2}}+\frac{n_{1}}{n_{2}-n_{1}} \cdot\left(\sum_{j=n_{1}+1}^{n_{2}} \frac{1}{j^{2}}\right)  \tag{150}\\
& \lesssim \frac{1}{n_{2}}+\frac{n_{1}}{n_{2}-n_{1}}\left(\frac{1}{n_{1}}-\frac{1}{n_{2}}\right)  \tag{151}\\
& \lesssim \frac{1}{n_{2}}  \tag{152}\\
& \lesssim \frac{1}{n} \tag{153}
\end{align*}
$$

where in the last step we used Definition 2
The case of $f(p)=p^{\alpha}, 0<\alpha<1$ can be proved analogously.

## III. Bootstrap bias correction

## A. Theorem 7

Define the Bernstein operator $B_{n}: C[0,1] \mapsto C[0,1]$ as

$$
\begin{equation*}
B_{n}[f](p)=\sum_{i=0}^{n} f\left(\frac{i}{n}\right)\binom{n}{i} p^{i}(1-p)^{n-i} \tag{154}
\end{equation*}
$$

Theorem 7 can be proved using the eigenstructure of the Bernstein operator [45]. We give a concrete proof as follows.

It was shown in [46] that the Bernstein operator $B_{n}[f]$ admits a clean eigenstructure. Concretely, it has $n+1$ linearly independent eigenfunctions $p_{k}^{(n)}, 0 \leq k \leq n$, which are polynomials with order $k$, with $k$ simple zeros on $[0,1]$. The corresponding eigenvalues are $\lambda_{k}^{(n)}=$ $\frac{1}{n^{k}} \frac{n!}{(n-k)!}$. The Bernstein operator is also degree reducing in the sense that it maps a $k$-degree polynomial to another polynomial with degree no more than $k$.

Decomposing $f(p)$ as $f(p)=L_{n}[f](p)+g(p)$. It follows the definition of $L_{n}[f]$ that $g(i / n)=0,0 \leq i \leq n$. Hence, $B_{n}[g] \equiv 0$.

Since $L_{n}[f](p)$ is a polynomial with degree no more than $n$, it admits a unique expansion

$$
\begin{equation*}
L_{n}[f](p)=\sum_{k=0}^{n} a_{k} p_{k}^{(n)} \tag{155}
\end{equation*}
$$

Applying $I-B_{n}$ on the decomposition of $f$, we have

$$
\begin{align*}
\left(I-B_{n}\right)[f] & =f-B_{n}[f]  \tag{156}\\
& =\sum_{k=0}^{n} a_{k} p_{k}^{(n)}+g-\sum_{k=0}^{n} a_{k} \lambda_{k}^{(n)} p_{k}^{(n)}  \tag{157}\\
& =\sum_{k=0}^{n} a_{k}\left(1-\lambda_{k}^{(n)}\right) p_{k}^{(n)}+g \tag{158}
\end{align*}
$$

It follows by induction that

$$
\begin{equation*}
e_{m}(p)=\sum_{k=0}^{n} a_{k}\left(1-\lambda_{k}^{(n)}\right)^{m} p_{k}^{(n)}+g \tag{159}
\end{equation*}
$$

We have

$$
\begin{align*}
\sup _{p}\left|e_{m}(p)-g\right| & \leq \sum_{k=0}^{n}\left(1-\lambda_{k}^{(n)}\right)^{m}\left|a_{k}\right| \sup _{p}\left|p_{k}^{(n)}\right|  \tag{160}\\
& \rightarrow 0 \quad \text { as } m \rightarrow \infty \tag{161}
\end{align*}
$$

Note that $\lambda_{k}^{(n)}=1 \cdot\left(1-\frac{1}{n}\right) \ldots\left(1-\frac{k-1}{n}\right), k \geq 2$, and $\lambda_{k}^{(n)}=1$ when $k=0,1$. Hence, the smallest $\lambda_{k}^{(n)}$, which is the slowest to vanish corresponds to $k=n$. Since

$$
\begin{equation*}
\lambda_{n}^{(n)}=\frac{n!}{n^{n}} \approx \frac{\sqrt{2 \pi n}}{e^{n}} \tag{162}
\end{equation*}
$$

it takes $m \gtrsim \frac{e^{n}}{\sqrt{n}}$ rounds of iteration to make $\left(1-\lambda_{n}^{(n)}\right)^{m}$ vanish, which is a prohibitively large number in practice.

## Appendix A

The $K$-FUnctional approach to bias analysis
We introduce the $r$-th modulus of smoothness of a function $f:[0,1] \mapsto \mathbb{R}$ as

$$
\begin{equation*}
\omega^{r}(f, t)=\sup _{0<h \leq t}\left\|\Delta_{h}^{r} f\right\| \tag{163}
\end{equation*}
$$

where $\Delta_{h}^{r} f$ is defined in 10 . The $r$-th Ditzian-Totik modulus of smoothness of a function $f:[0,1] \mapsto \mathbb{R}$ is defined in 11.

Intuitively, the smoother the function is, the smaller is its moduli of smoothness. For $f \in C[0,1]$, we define the $K$-functional $K_{r}\left(f, t^{r}\right)$ as follows:

$$
\begin{gather*}
K_{r}\left(f, t^{r}\right)=\inf _{g}\left\{\|f-g\|+t^{r}\left\|g^{(r)}\right\|:\right. \\
\left.g^{(r-1)} \in \text { A.C.loc }\right\} \tag{164}
\end{gather*}
$$

and the $K$-functional $K_{r, \varphi}\left(f, t^{r}\right)$ as

$$
\begin{gather*}
K_{r, \varphi}\left(f, t^{r}\right)=\inf _{g}\left\{\|f-g\|+t^{r}\left\|\varphi^{r} g^{(r)}\right\|:\right. \\
\left.g^{(r-1)} \in \text { A.C.loc }\right\}, \tag{165}
\end{gather*}
$$

where $g^{(r-1)} \in$ A.C.loc means that $g$ is $r-1$ times differentiable and $g^{(r-1)}$ is absolutely continuous in every closed finite interval $[c, d] \subset(0,1)$.

The remarkable fact is, the $K$-functionals are equivalent to the corresponding moduli of smoothness for any function $f \in C[0,1]$. Concretely, we have the following lemma:

Lemma 9. [32, Chap. 6, Thm. 2.4, Thm. 6.2] [29, Thm. 2.1.1.] There exist constants $c_{1}>0, c_{2}>0$ which depend only on $r$ such that for all $f \in C[0,1]$,

$$
\begin{equation*}
c_{1} \omega^{r}(f, t) \leq K_{r}\left(f, t^{r}\right) \leq c_{2} \omega^{r}(f, t) \quad \text { for all } t>0 \tag{166}
\end{equation*}
$$

$c_{1} \omega_{\varphi}^{r}(f, t) \leq K_{r, \varphi}\left(f, t^{r}\right) \leq c_{2} \omega_{\varphi}^{r}(f, t) \quad$ for all $t \leq t_{0}$,
where $t_{0}>0$ is a constant that only depends on $r$.
We emphasize that the $K$-functionals and moduli of smoothness introduced here are tailored for the interval $[0,1]$ and the supremum norm, which can be generalized to general finite intervals and infinite intervals, and $L_{p}$ norms. The corresponding equivalence results also hold in those settings. We refer the interested readers to [32, Chap. 6] and [29. Chap. 2] for details. For other use of $K$-functionals in statistics and machine learning, we refer the readers to the theory of Besov spaces as interpolation spaces [48] and distribution testing [49].

Now we illustrate the $K$-functional approach to bias analysis, which is well known in the approximation theory literature, see, e.g. [50]. Suppose $X$ is a random variable taking values in $[0,1]$, and we would like to bound the quantity $|\mathbb{E}[f(X)]-f(\mathbb{E}[X])|$ for any $f \in C[0,1]$. Clearly, $f$ may not be differentiable, so we introduce another function $g \in C[0,1]$ such that $g^{(1)} \in$ A.C. ${ }_{\text {loc }}$. We proceed as follows:

$$
\begin{align*}
& |\mathbb{E}[f(X)]-f(\mathbb{E}[X])| \\
= & \mid \mathbb{E}[f(X)-g(X)+g(X)-g(\mathbb{E} X) \\
& +g(\mathbb{E} X)-f(\mathbb{E} X)] \mid  \tag{168}\\
\leq & 2\|f-g\|+|\mathbb{E}[g(X)-g(\mathbb{E} X)]|  \tag{169}\\
\leq & 2\|f-g\|+\frac{1}{2}\left\|g^{\prime \prime}\right\| \operatorname{Var}(X)  \tag{170}\\
= & 2\left(\|f-g\|+t^{2}\left\|g^{\prime \prime}\right\|\right), \tag{171}
\end{align*}
$$

where $t^{2}=\frac{\operatorname{Var}(X)}{4}$. Since $g^{(1)} \in$ A.C.loc is arbitrary, we know

$$
\begin{align*}
|\mathbb{E}[f(X)]-f(\mathbb{E}[X])| & \leq 2 \inf _{g}\left\{\|f-g\|+t^{2}\left\|g^{\prime \prime}\right\|\right\} \\
& =2 K_{2}\left(f, t^{2}\right)  \tag{172}\\
& =2 K_{2}\left(f, \frac{\operatorname{Var}(X)}{4}\right)  \tag{174}\\
& \leq 2 c_{2} \omega^{2}\left(f, \frac{\sqrt{\operatorname{Var}(X)}}{2}\right) \tag{175}
\end{align*}
$$

where the constant $c_{2}$ is introduced in Lemma 9
It was shown in [32, Chap. 2, Sec. 9, Example 1] that if $f(x)=x \ln x, x \in[0,1]$, then $\omega^{2}(f, t) \leq 2(\ln 2) t$. Hence, we have shown that for any random variable $X \in$ $[0,1]$,

$$
\begin{equation*}
|\mathbb{E}[X \ln X]-\mathbb{E}[X] \ln (\mathbb{E}[X])| \lesssim \sqrt{\operatorname{Var}(X)} \tag{176}
\end{equation*}
$$

Specializing to the case where $X=\hat{p}_{n}$, where $n \cdot \hat{p}_{n} \sim$ $\mathrm{B}(n, p)$, we have proved that for $f(p)=-p \ln p$, we have

$$
\begin{equation*}
\left|\mathbb{E}\left[f\left(\hat{p}_{n}\right)\right]-p \ln p\right| \lesssim \sqrt{\frac{p(1-p)}{n}} \tag{177}
\end{equation*}
$$

The upper bound $\sqrt{\frac{p(1-p)}{n}}$ is a pointwise bound that becomes smaller when $p$ is close to 0 or 1 . When $p$ lies in the middle of the interval $[0,1]$, say $p \approx \frac{1}{2}$, the bound is of scale $\frac{1}{\sqrt{n}}$. We now show that using the $K$-functional $K_{r, \varphi}$ instead of $K_{r}$ results in a better uniform bound in
this case, which is of order $\frac{1}{n} \cdot{ }^{5}$
For any $f \in C[0,1], n \cdot \hat{p}_{n} \sim \mathrm{~B}(n, p)$, and any $g \in$ $C[0,1]$ such that $g^{(1)} \in$ A.C. ${ }_{\text {loc }}$, we have

$$
\begin{align*}
& \left|\mathbb{E}_{p}\left[f\left(\hat{p}_{n}\right)\right]-f(p)\right| \\
\leq & \mid \mathbb{E}_{p}\left[f\left(\hat{p}_{n}\right)-g\left(\hat{p}_{n}\right)+g\left(\hat{p}_{n}\right)-g(p)+g(p)-f(p) \mid\right. \\
= & 2\|f-g\|+\left|\mathbb{E}_{p} g\left(\hat{p}_{n}\right)-g(p)\right|  \tag{179}\\
= & 2\|f-g\|+\mid \mathbb{E}_{p}\left[g^{\prime}(p)\left(\hat{p}_{n}-p\right)\right. \\
& \left.+\int_{p}^{\hat{p}_{n}}\left(\hat{p}_{n}-t\right) g^{\prime \prime}(t) d t\right] \mid  \tag{180}\\
= & 2\|f-g\|+\left|\mathbb{E}_{p}\left[\int_{p}^{\hat{p}_{n}}\left(\hat{p}_{n}-t\right) g^{\prime \prime}(t) d t\right]\right|  \tag{181}\\
\leq & 2\|f-g\|+\mathbb{E}_{p}\left|\int_{p}^{\hat{p}_{n}}\right| \frac{\hat{p}_{n}-t}{t(1-t)}|\cdot| t(1-t) g^{\prime \prime}(t)|d t| \\
= & 2\|f-g\|+\mathbb{E}_{p}\left|\int_{p}^{\hat{p}_{n}} \frac{\left|\hat{p}_{n}-p\right|}{p(1-p)}\right| t(1-t) g^{\prime \prime}(t)|d t| \tag{182}
\end{align*}
$$

where $\varphi(t)=\sqrt{t(1-t)}$, and we used the elementary inequality that $\frac{\left|\hat{p}_{n}-t\right|}{t(1-t)} \leq \frac{\left|\hat{p}_{n}-p\right|}{p(1-p)}$ for any $t$ between $p$ and $\hat{p}_{n}$. Taking the infimum over all $g$, we have

\end{align*}

It follows from [30] that for $f(p)=-p \ln p, \omega_{\varphi}^{2}(f, t) \asymp$ $t^{2}$, which implies that

The functional $\operatorname{Ent}(X) \triangleq \mathbb{E}[X \ln X]-\mathbb{E}[X] \ln (\mathbb{E}[X])$, which is also called entropy, plays a crucial role in the theory of concentration inequalities. Concretely, the Herbst argument [52] shows that if $\operatorname{Ent}\left(e^{\lambda f(X)}\right) \leq$ $\frac{\lambda^{2}}{2} \mathbb{E}\left[e^{\lambda f(X)}\right]$, we have sub-Gaussian type concentration $\mathbb{P}(f(X)-\mathbb{E}[f(X)] \geq t) \leq e^{-t^{2} / 2}$. Due to the significance of the functional $\operatorname{Ent}(X)$, we now present a theo-

[^4]rem providing upper and lower bounds of $\operatorname{Ent}(X)$. The key idea in the following proof is to relate the $\operatorname{Ent}(X)$ functional to the KL divergence, whose functional inequalities have been well studied in the literature. Conceivably, they are stronger bounds than those obtained using the general $K$-functional approach (Lemma 17 in Appendix B.

Theorem 10. Suppose $X$ is a non-negative random variable. Denote $\operatorname{Ent}(X)=\mathbb{E}[X \ln X]-\mathbb{E}[X] \ln (\mathbb{E}[X])$. Then,

& \operatorname{Ent}(X) \leq \mathbb{E}[X] \ln \left(1+\frac{\operatorname{Var}(X)}{(\mathbb{E}[X])^{2}}\right) \leq \sqrt{\operatorname{Var}(X)} \\
& \operatorname{Ent}(X) \geq 2(\mathbb{E}[X]-\sqrt{\mathbb{E}[X] \mathbb{E}[\sqrt{X}]}) \geq \operatorname{Var}(\sqrt{X})  \tag{190}\\
& \operatorname{Ent}(X) \geq \frac{1}{2} \mathbb{E}[X]\left(\mathbb{E}\left|\frac{X}{\mathbb{E}[X]}-1\right|\right)^{2} \tag{191}
\end{align*}
$$

Remark 6. It was shown in 53] that $\operatorname{Ent}(X) \geq$ $\operatorname{Var}(\sqrt{X})$. Theorem 10 strengthens [53].

Proof. Without loss of generality we assume $\mathbb{E}[X]>0$. Then, we have

Denote the distribution of $X$ as $Q$, and introduce a new probability measure $P$ via the Radon-Nikodym derivative

\end{equation*}
$$

we have

\begin{align*}
\operatorname{Ent}(X) & =\mathbb{E}_{Q}[X] \mathbb{E}_{Q}\left[\frac{d P}{d Q} \ln \frac{d P}{d Q}\right]  \tag{196}\\
& =\mathbb{E}_{Q}[X] \cdot D(P, Q) \tag{197}
\end{align*}
$$

where $D(P, Q)$ is the KL divergence between $P$ and $Q$.
Applying Lemma 18 in Appendix B, we have

$$
\begin{align*}
\operatorname{Ent}(X) & \leq \mathbb{E}_{Q}[X] \cdot \ln \left(\mathbb{E}_{Q}\left(\frac{X}{\mathbb{E}_{Q}[X]}\right)^{2}\right)  \tag{198}\\
& =\mathbb{E}[X] \cdot \ln \left(1+\frac{\operatorname{Var}(X)}{(\mathbb{E}[X])^{2}}\right) \tag{199}
\end{align*}
$$

where in the last step we used the fact that $\operatorname{Var}(X)=$ $\mathbb{E}\left[X^{2}\right]-(\mathbb{E}[X])^{2}$. Using the fact that $\sup _{x \geq 0} \frac{\ln (1+x)}{\sqrt{x}}<$

1, we have

\begin{equation*}
\operatorname{Ent}(X) \leq \sqrt{\operatorname{Var}(X)} \tag{200}
\end{equation*}
$$

Now we prove the lower bounds. Applying the Hellinger distance part of Lemma 18 in Appendix B. we have

\operatorname{Ent}(X) & \geq \mathbb{E}_{Q}[X] \cdot H^{2}(P, Q)  \tag{201}\\
& =\mathbb{E}_{Q}[X] \cdot \mathbb{E}_{Q}\left(\sqrt{\frac{X}{\mathbb{E}_{Q}[X]}}-1\right)^{2}  \tag{202}\\
& \geq 2\left(\mathbb{E}_{Q}[X]-\sqrt{\mathbb{E}_{Q}[X]} \mathbb{E}_{Q}[\sqrt{X}]\right)  \tag{203}\\
& \geq \mathbb{E}_{Q}[X]-\left(\mathbb{E}_{Q}[\sqrt{X}]\right)^{2}  \tag{204}\\
& =\operatorname{Var}(\sqrt{X}) \tag{205}
\end{align*}
$$

Here in the last inequality we used the fact that $\mathbb{E}[X]+$ $(\mathbb{E}[\sqrt{X}])^{2}-2 \sqrt{\mathbb{E}[X]} \mathbb{E}[\sqrt{X}] \geq 0$.

Applying the total variation distance part of Lemma 18 in Appendix B we have

\operatorname{Ent}(X) & \geq \mathbb{E}_{Q}[X] \cdot 2 V^{2}(P, Q)  \tag{206}\\
& =\frac{1}{2} \mathbb{E}_{Q}[X] \cdot\left(\mathbb{E}_{Q}\left|\frac{X}{\mathbb{E}_{Q}[X]}-1\right|\right)^{2} \tag{207}
\end{align*}
$$

## Appendix B

AUXILIARY LEMMAS

Define $T_{n, s}(p)=n^{s} \mathbb{E}_{p}\left(\hat{p}_{n}-p\right)^{s}, n=1,2, \ldots, s=$ $0,1, \ldots$. We have $T_{n, 0}=1, T_{n, 1}=0$. Upon observing the recurrence relation

Lemma 16 (Chernoff bound). [54] Let $X_{1}, X_{2}, \ldots, X_{n}$ be independent $\{0,1\}$ valued random variables with $\mathbb{P}\left(X_{i}=1\right)=p_{i}$. Denote $X=\sum_{i=1}^{n} X_{i}, \mu=\mathbb{E}[X]$. Then,

& \mathbb{P}(X \geq(1+\beta) \mu) \leq \begin{cases}e^{-\frac{\beta^{2} \mu}{2+\beta}} \leq e^{-\frac{\beta \mu}{3}} & \beta>1 \\
e^{-\frac{\beta^{2} \mu}{3}} & 0<\beta \leq 1\end{cases} \tag{222}
\end{align*}

Lemma 17. [44] For any continuous function $f: \mathbb{R} \mapsto$ $\mathbb{R}$ and any random variable $X$ taking values in $\mathbb{R}$, we have

Here $\omega^{r}(f, t) \triangleq \sup _{0<h \leq t}\left\|\Delta_{h}^{r} f\right\|$, where $\Delta_{h}^{r} f(x)=\sum_{k=0}^{r}(-1)^{k}\binom{r}{k} f(x+r(h / 2)-k h)$, and $\Delta_{h}^{r} f(x)=0$ if $x+r h / 2$ or $x-r h / 2$ is not inside the domain of $f$.
Lemma 18. [55, Section 2.4] Suppose $P, Q$ are both probability measures, and $P \ll Q$. Introduce the following divergence functionals:

1) Total variation distance:

## Appendix C

PROOFS OF MAIN THEOREMS AND LEMMAS

## A. Proof of Theorem 1

Recognizing $\mathbb{E}_{p} \hat{f}_{r}$ as linear combination of operators, the first and second parts of Theorem 1 follow from [29, Theorem 9.3.2.], the third part follows from [29, Corollary 9.3.8.], and the last part follows from [51].

## B. Proof of Theorem 2

Define $f \in C(0,1]$ to be the piecewise linear interpolation function at nodes $\left\{\left(m^{-1}, \frac{1+(-1)^{m}}{2}\right), m \in \mathbb{N}_{+}\right\}$. Clearly $f\left(m^{-1}\right)=1$ when $m$ is even, $f\left(m^{-1}\right)=0$ when $m$ is odd, and $\|f\| \leq 1$. We set $f(0)=0$.

We have

\geq & \left|\sum_{n+i-r \text { is even }} C_{i} \mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)\right| \\
& -\left|\sum_{n+i-r \text { is odd }} C_{i} \mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)\right|-|f(p)|  \tag{233}\\
\geq & \sum_{n+i-r \text { is even }}\left|C_{i}\right| \mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right) \\
& -\sum_{n+i-r \text { is odd }}\left|C_{i}\right| \mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right)-1 \tag{234}
\end{align*}
$$

where in the last step we have used the fact that $C_{1}, \cdots, C_{r}$ have alternating signs, and $f \geq 0$.

When $n+i-r$ is even and $p=n^{-1}$,
$\mathbb{E}_{p} f\left(\hat{p}_{n+i-r}\right) \geq f\left(\frac{1}{n+i-r}\right) \cdot \mathbb{P}(\mathrm{B}(n+i-r, p)=1)$

$$
\begin{align*}
& =(n+i-r) p(1-p)^{n+i-r-1}  \tag{236}\\
& \geq \frac{1}{e}(1-o(1))
\end{align*}
$$

When $n+i-r$ is odd and $p=n^{-1}$, noting that $f(0)=f\left(\frac{1}{n+i-r}\right)=0$, we have

Since $\sum_{i=1}^{r} C_{i}=1$, we have $\sum_{n+i-r \text { is odd }}\left|C_{i}\right|=$ $(1+o(1)) \sum_{n+i-r}$ is even $\left|C_{i}\right| \asymp n^{r-1}$. Combining these together, we arrive at

which completes the proof of the first claim.
As for the second claim, it suffices to replace the function $f$ on interval $[0,1 / n]$ by the linear interpolation function interpolating $f(0)=0$ and $f(1 / n)=\frac{1+(-1)^{n}}{2}$ and keep other parts of the function intact. Consequently, after this modification $f \in C[0,1]$.

Now we prove the variance part.
Construct $f \in C[0,1]$ to be a piecewise linear interpolation function at the following nodes: $f(0)=$ $0, f\left(\frac{1}{n}\right)=f\left(\frac{2}{n-1}\right)=1, f\left(\frac{1}{n-1}\right)=f\left(\frac{2}{n}\right)=$ $-1, f(1)=0$.
It follows from straightforward algebra and Lemma 12 that

\geq & \inf _{a}\left(\mathbb{P}(\mathrm{~B}(n, p)=1)\left(2 n-2+n^{-1}-a\right)^{2}\right. \\
& \left.+\mathbb{P}(\mathrm{B}(n, p)=2)(-2 n+5-4 / n-a)^{2}\right)  \tag{245}\\
= & \inf _{a}\left(n p(1-p)^{n-1}\left(2 n-2+n^{-1}-a\right)^{2}\right. \\
& \left.+\frac{n(n-1)}{2} p^{2}(1-p)^{n-2}(-2 n+5-4 / n-a)^{2}\right) \tag{246}
\end{align*}
$$

Setting $p=1 / n$, we have

& \left.+(-2 n+5-4 / n-a)^{2}\right) \tag{247}
\end{align*}
$$

The infimum is achieved when

a & =\frac{\left(2 n-2+n^{-1}\right)+(-2 n+5-4 / n)}{2}  \tag{248}\\
& =\frac{3}{2}\left(1-\frac{1}{n}\right) . \tag{249}
\end{align*}
$$

Hence,

\geq & \left(1-\frac{1}{n}\right)^{n-1} n^{2}  \tag{251}\\
\geq & \frac{n^{2}}{e} \tag{252}
\end{align*}
$$

where we have used $n \geq 4$ and $\left(1-\frac{1}{n}\right)^{n-1} \geq e^{-1}$.

& \leq \frac{p}{n^{k-1}}\left(\frac{(2-t) p}{(1-p) t}\right)^{\frac{n t}{2}} \cdot\left(\frac{1-p}{1-\frac{t}{2}}\right)^{n} \tag{310}
\end{align*}
$$

$$
\begin{equation*}
\leq \frac{p}{n^{k-1}} \exp \left(-n D\left(\frac{t}{2} \| p\right)\right) \tag{311}
\end{equation*}
$$

$$
\begin{equation*}
\leq \frac{p}{n^{k-1}} \exp \left(-\frac{c_{2} n(t-p)^{2}}{t}\right) \tag{312}
\end{equation*}
$$

as desired. When $p<t \leq \frac{2 k}{n}$, we have $\frac{c_{2} n(t-p)^{2}}{t}=$ $O(1)$, and (302) follows from

& \left.\cdot\left|\hat{p}_{n-s}+p\right|^{t(i)-v(i)}\right] \\

& \quad=\sum_{i \in I_{j}} c(i) n^{-(u+s-1)} p \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{t}\right)  \tag{321}\\
& \quad \lesssim u, s n^{-(u+s-1)} p \cdot \exp \left(-\frac{c_{2} n(t-p)^{2}}{t}\right)

2) The remainder term $B_{u}$ : By our convention on $g_{u, t}^{(u)}(\cdot)$ we observe that $g_{u, t}^{(u)}\left(\xi_{k}\right)-g_{u, t}^{(u)}\left(\hat{p}_{n-s}\right)$ is nonzero only if

First we consider the case where $p \leq \frac{1}{2}$, and consider any good path $L$. The idea is that, each good path $L$ gives rise to a realization of $B_{u}$, and $\mathbb{E}_{p} B_{u}$ is the expectation averages over all good paths. Hence, to evaluate $\mathbb{E}_{p} B_{u}$, it suffices to compute the value of $B_{u}$ given $L$, and the probability of the path $L$. Denote by $r, l$ the number of right and left steps in $L$, and by $q$ the starting point of $L$, it is easy to see that the probability of this path is

\leq & \frac{1}{\sqrt{n q(1-q)}} \cdot \exp \left(-\frac{n(q-p)_{+}^{2}}{2 q}\right) \tag{334}

By the proof of Lemma 5 , the non-remainder terms in the Taylor expansion is at most $O\left(n^{-\left(\frac{u}{2}+s\right)}\right)=o\left(n^{-\left(u+\frac{1}{2}\right)}\right)$, and by our coupling the remainder term is non-zero only if $\hat{p}_{n-s} \in A$, we conclude that

\end{align*}
$$

$$
\begin{align*}
& \cdot \mathbb{P}\left(\hat{p}_{n-j}=\frac{k+i}{n-j}, \hat{p}_{n-s} \in A\right)  \tag{360}\\
& =q(1+o(1)) \left\lvert\,(-1)^{s}\left(\frac{p}{n}\right)^{u}+\sum_{i=1}^{s-j} \sum_{j=0}^{s} \sum_{m=0}^{s-i-j}(-1)^{j}\right. \\
& \left.\cdot\binom{s}{j}\binom{s-j}{m+i} p^{m+i}(1-p)^{s-j-m-i}\left(\frac{k+i}{n-j}-t\right)^{u} \right\rvert\,  \tag{361}\\
& =q(1+o(1)) \left\lvert\,(-1)^{s}\left(\frac{p}{n}\right)^{u}+\sum_{i=1}^{s} \sum_{m=0}^{s-i}\binom{s}{m+i} p^{m+i}\right. \\

= & \frac{p^{s}(1+O(p))}{n^{u+\frac{1}{2}}} \cdot\left|\Delta^{s} \sum_{i=1}^{r} i^{u}\right| . \tag{372}

Since $\sum_{i=1}^{r} i^{u}$ is a polynomial of $r$ with degree $u+1>$ $s$, its $s$-backward difference is not zero, and thus the desired result also follows by choosing $p_{0}$ small enough.

Repeating this process, there must be some $x \in\left[x_{0}, x_{r}\right]$ such that $(-1)^{r} \Delta^{r} g(x) \geq 0$. Note that $p(x)$ is a degree- $r$ polynomial with leading coefficient $f\left[x_{0}, \cdots, x_{r}\right]$, we conclude that

where $K_{h}=\frac{1}{h} \mathbb{1}(x \in[-h / 2, h / 2])$ is the box kernel, and the operation $*$ denotes convolution.

The Steklov functions have the following nice properties [58, Chap. V, Sec. 83]:

f(x)-f_{h h}(x)= & \frac{1}{h^{2}} \int_{0}^{h / 2} \int_{0}^{h / 2}[4 f(x)-f(x+s+t) \\
& -f(x+s-t)-f(x-s+t) \\
& -f(x-s-t)] d s d t  \tag{435}\\
f_{h h}^{\prime \prime}(x)= & \frac{1}{h^{2}}(f(x+h)+f(x-h)-2 f(x)) \tag{436}

& +|2 f(x)-f(x+s-t)-f(x-s+t)|] d s d t \tag{437}
\end{align*}

$\leq \frac{1}{h^{2}} \int_{0}^{h / 2} \int_{0}^{h / 2}\left[2 \omega^{2}(f, h)\right] d s d t$
$=\frac{1}{2} \omega^{2}(f, h)$,
and

\left\|f_{h h}^{\prime \prime}(x)\right\| \leq \frac{1}{h^{2}} \omega^{2}(f, h) \tag{440}

\leq & 2\left\|f-f_{h h}\right\|+\left|\mathbb{E}\left[f_{h h}(X)\right]-f_{h h}(\mathbb{E}[X])\right|  \tag{442}\\
\leq & 2\left\|f-f_{h h}\right\|+\frac{1}{2}\left\|f_{h h}^{\prime \prime}\right\| \operatorname{Var}(X)  \tag{443}\\
\leq & \omega^{2}(f, h)+\frac{1}{2 h^{2}} \omega^{2}(f, h) \operatorname{Var}(X) \tag{444}

where $h=\frac{\sqrt{\operatorname{Var}(X)}}{2}$.
Now we argue that when the domain of $f$ is an interval $[a, b]$ that is a strict subset of $\mathbb{R}$, we can replace the constant 3 by 15. Indeed, as argued in [59. Sec. 3.5.71, pg. 121], for any continuous function $f \in[a, b]$, one can extend $\phi(x)=f(x)-\frac{f(b)-f(a)}{b-a}(x-a)-f(a)$ to the whole real line while ensuring the second order modulus of the extension is upper bounded by five times the $\omega^{2}(f, t)$ of the original function $f$. Indeed, one achieves this by extending $\phi$ so as to be odd with respect to the ends of the $[a, b]$ and then periodically with period $2(b-a)$ on the whole real line.
