# RELATIVE PERTURBATION BOUNDS FOR THE JOINT SPECTRUM OF COMMUTING TUPLE OF MATRICES

#### Abstract

In this paper, we study the relative perturbation bounds for joint eigenvalues of commuting tuples of normal $n \times n$ matrices. Some HoffmanWielandt type relative perturbation bounds are proved using the Clifford algebra technique. A result is also extended for diagonalizable matrices which improves a relative perturbation bound for single matrices.


## 1. Introduction

Let $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ be an $m$-tuple commuting $n \times n$ matrices acting on $\mathbb{C}^{n}$. A joint eigenvalue of $A$ is an element $\lambda=\left(\lambda^{(1)}, \lambda^{(2)}, \cdots, \lambda^{(m)}\right) \in \mathbb{C}^{m}$ such that,

$$
A^{(j)} x=\lambda^{(j)} x \text { for } j=1,2, \cdots, m
$$

holds for some non-zero vector $x \in \mathbb{C}^{n}$. The vector $x$ is called joint eigenvector. The set of all joint eigenvalues of $A$ is called the joint spectrum of $A$.

The main concern of perturbation theory of matrix eigenvalues is to estimate the error when the eigenvalues of a matrix are approximated by the eigenvalues of a perturbed matrix. Let $A$ and $B$ are two $n \times n$ matrix and $\left\{\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right\}$ and $\left\{\mu_{1}, \mu_{2}, \cdots, \mu_{n}\right\}$ are their eigenvalues respectively. An important result in the direction of absolute type perturbation bound is Hoffman-Weildant Theorem (4). Which states that, if $A$ and $B$ are normal matrices, then there exist a permutation $\pi$ of $\{1,2, \cdots, n\}$ such that,

$$
\left(\sum_{i=1}^{n}\left|\lambda_{i}-\mu_{\pi(i)}\right|^{2}\right)^{\frac{1}{2}} \leq\|A-B\|_{F}
$$

where $\|\cdot\|_{F}$ denotes the Frobenius Norm. Many researchers generalized this result in several directions. In 1993 Bhatia and Bhattacharyya [1] generalized the HoffmanWeildant Theorem for joint eigenvalues of $m$-tuple of commuting normal matrices. More results on absolute type perturbation bounds for joint eigenvalues can be found in [3, 8.

In 1998, relative perturbation bounds for eigenvalues of diagonalizable matrices were studied by Eisenstat and Ipsen [2]. It was proved in [2] that, if $A$ and $B$ both are diagonalizable and $A$ is non-singular, then there exists a permutation $\pi$ of $\{1,2, \cdots, n\}$ such that,

\left(\sum_{i=1}^{n}\left|\frac{\lambda_{i}-\mu_{\pi(i)}}{\lambda_{i}}\right|^{2}\right)^{\frac{1}{2}} \leq \kappa(X) \kappa(\tilde{X})\left\|A^{-1}(A-B)\right\|_{F}
$$

[^0]where $X$ and $\tilde{X}$ are the invertible matrices which diagonalize $A$ and $B$ respectively and $\kappa(X)=\|X\|\left\|X^{-1}\right\|$ be the condition number of the matrix $X$. Furthermore, Li and Sun [6] obtained bounds for a normal non-singular matrix and a arbitrary matrix and Li and Chen [5] generalized it for diagonalizable matrices.

In this paper, we have proved some relative perturbation bounds for joint eigenvalues of $m$-tuple of commuting normal and diagonalizable matrices using the Clifford algebra technique proposed by McIntosh and Pryde 7 ]

## 2. The Clifford Algebra Technique

For the convenience of the reader we briefly discuss the Clifford algebra technique. Let $\mathbb{R}^{m}$ be the real vector space of dimension $m$ and let $e_{1}, e_{2}, \cdots, e_{m}$ be the basis. The Clifford algebra is an algebra generated by $e_{1}, e_{2}, \cdots, e_{m}$ with the following relations

$$
e_{i} e_{j}=-e_{j} e_{i} \text { for } i \neq j \text { and } e_{i}^{2}=-1 \text { for all } i
$$

and it is denoted by $\mathbb{R}_{(m)}$. Then $\mathbb{R}_{(m)}$ is an algebra over $\mathbb{R}$ of dimension $2^{m}$. Let $S$ be a subset of $\{1, \cdots, m\}$ such that $S=\left\{s_{1}, s_{2}, \cdots, s_{k}\right\}$ with $1 \leq s_{1}<s_{2}<\cdots<$ $s_{k} \leq m$. Then the elements $e_{S}=e_{s_{1}} e_{s_{2}} \cdots e_{s_{k}}$ form a basis of $\mathbb{R}_{(m)}$ where $S$ runs over the all subsets of $\{1, \cdots, m\}$ with $e_{\phi}=1$. An element $\alpha$ of $\mathbb{R}_{(m)}$ is of the form $\alpha=\sum_{S} \alpha_{S} e_{S}$ where $\alpha_{S} \in \mathbb{R}$. If $\beta=\sum_{S} \beta_{S} e_{S}, \beta_{S} \in \mathbb{R}$ be another element of $\mathbb{R}_{(m)}$, the inner product of $\alpha$ and $\beta$ is defined as,

\langle\alpha, \beta\rangle=\sum_{S} \alpha_{S} \beta_{S}
$$

Under this inner product $\mathbb{R}_{(m)}$ becomes an Hilbert space with the orthonormal basis $e_{S}$. Now the tensor product $\mathbb{C}^{n} \otimes \mathbb{R}_{(m)}$ where

$$
\mathbb{C}^{n} \otimes \mathbb{R}_{(m)}=\left\{\sum_{S} x_{S} \otimes e_{S}: x_{S} \in \mathbb{C}^{n}\right\}
$$

is a Hilbert space under the inner product

$$
\langle x, y\rangle=\left\langle\sum_{S} x_{S} \otimes e_{S}, \sum_{S} y_{S} \otimes e_{S}\right\rangle=\sum_{S}\left\langle x_{S}, y_{S}\right\rangle
$$

where $x_{S}, y_{S} \in \mathbb{C}^{n}$ and the inner product in the right hand side be the usual inner product in $\mathbb{C}^{n}$. Therefore the norm on $\mathbb{C}^{n} \otimes \mathbb{R}_{(m)}$ is defined by,

$$
\left\|\sum_{S} x_{S} \otimes e_{S}\right\|=\left(\sum_{S}\left\|x_{S}\right\|^{2}\right)^{\frac{1}{2}}
$$

where the norm in the right hand side is the usual norm in $\mathbb{C}^{n}$. Let $M_{n}$ be the space of $n \times n$ matrices of complex entries. Then $M_{n} \otimes \mathbb{R}_{(m)}$ is a linear space and for $A \in M_{n} \otimes \mathbb{R}_{(m)}, A$ is of the form $A=\sum_{S} A_{S} \otimes e_{S}$, where $A_{S} \in M_{n}$. Each element $A=\sum_{S} A_{S} \otimes e_{S} \in M_{n} \otimes \mathbb{R}_{(m)}$ acts on the elements $x=\sum_{T} x_{T} \otimes e_{T} \in \mathbb{C}^{n} \otimes \mathbb{R}_{(m)}$ by

A x=\left(\sum_{S} A_{S} \otimes e_{S}\right)\left(\sum_{T} x_{T} \otimes e_{T}\right)=\sum_{S, T} A_{S} x_{T} \otimes e_{S} e_{T}
$$

For an $m$-tuple $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ of $n \times n$ complex matrices, the corresponding Clifford operator $\operatorname{Cliff}(A) \in M_{n} \otimes \mathbb{R}_{(m)}$ is defined by,

$$
\operatorname{Cliff}(A)=i \sum_{j=1}^{m} A^{(j)} \otimes e_{j}
$$

## 3. Relative perturbation bounds

Throughout this paper, $S_{n}$ be the set of all $n$ ! permutations of $\{1,2, \cdots, n\}$ and $\|\cdot\|_{F},\|\cdot\|$ denote the Frobenius norm and the usual operator norm respectively. $\Re(z)$ denotes the real part of a complex number $z$. A square matrix of non-negative real numbers is called a doubly stochastic matrix if each row and each column sum is 1 . A permutation matrix is a square matrix such that every row and column contains exactly one entry 1 and 0 everywhere else.
Lemma 3.1. ([1, Lemma 1]) Let $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ be any $m$-tuple of operators in $\mathbb{C}^{n}$ and let $\operatorname{Clif} f(A)$ be the corresponding Clifford operator. Then

\|\operatorname{Cliff}(A)\|_{F}^{2}=2^{m} \sum_{k=1}^{m}\left\|A^{(k)}\right\|_{F}^{2}
$$

Lemma 3.2. ([1]) If $P$ is any operator of $\mathbb{C}^{n}$. Then
(i) $\operatorname{trace}\left(P \otimes e_{T}\right)=0$ for any non empty subset $T$ of $\{1,2, \cdots, m\}$,
(ii) $\operatorname{trace}\left(P \otimes e_{\phi}\right)=2^{m}$ trace $P$.

Let $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ and $B=\left(B^{(1)}, B^{(2)}, \cdots, B^{(m)}\right)$ are two $m$-tuple of normal $n \times n$ matrices such that $B=A+E$, where $E=\left(E^{(1)}, E^{(2)}, \cdots, E^{(m)}\right)$ is the perturbation given to $A$. Also let $\alpha_{i}=\left(\alpha_{i}^{(1)}, \alpha_{i}^{(2)}, \cdots, \alpha_{i}^{(m)}\right)$ and $\beta_{i}=$ $\left(\beta_{i}^{(1)}, \beta_{i}^{(2)}, \cdots, \beta_{i}^{(m)}\right)$ are the joint eigenvalues of $A$ and $B$ respectively.

Theorem 3.3. If $A$ and $B=A+E$ are $m$-tuple of normal matrices as mentioned above and for $k=1,2, \cdots m$, each $A^{(k)}$ is non-singular, then there exists a permutation $\pi$ of $S_{n}$ such that

$$
\sum_{j=1}^{n} \sum_{k=1}^{m}\left|\frac{\alpha_{j}^{(k)}-\beta_{\pi(j)}^{(k)}}{\alpha_{j}^{(k)}}\right|^{2} \leq \sum_{k=1}^{m}\left\|A^{(k)^{-1}} E^{(k)}\right\|_{F}^{2}
$$

Proof. Since $E=B-A$ therefore

$$
\begin{equation*}
E^{(k)}=B^{(k)}-A^{(k)} \Rightarrow A^{(k)^{-1}} E^{(k)}=A^{(k)^{-1}} B^{(k)}-I \tag{3.1}
\end{equation*}
$$

for $k=1,2, \cdots m$.
Let $C=\left(A^{(1)^{-1}} B^{(1)}, \cdots, A^{(m)^{-1}} B^{(m)}\right), D=\left(A^{(1)^{-1}} E^{(1)}, \cdots, A^{(m)^{-1}} E^{(m)}\right)$.
Also let $\tilde{I}=(I, I, \cdots, I)$ be the $m$-tuple of identity matrices of order $n \times n$. Then from (3.1) we have

C-\tilde{I}=D \tag{3.2}
\end{equation*}
$$

We can choose orthonormal bases $\left\{u_{1}, u_{2}, \cdots, u_{n}\right\}$ and $\left\{v_{1}, v_{2}, \cdots, v_{n}\right\}$ of $\mathbb{C}^{n}$ such that,

$$
A^{(k)} u_{j}=\alpha_{j}^{(k)} u_{j}, \quad B^{(k)} v_{j}=\beta_{j}^{(k)} v_{j}, \quad \text { for } \quad j=1,2, \cdots, n \text { and } k=1,2, \cdots, m
$$

Let $P_{j}$ and $Q_{j}$ denotes the orthogonal projection operator to spaces spanned by $u_{j}$ and $v_{j}$ respectively. Then for $k=1,2, \cdots, m$,

A^{(k)}=\sum_{j=1}^{n} \alpha_{j}^{(k)} P_{j}, \quad B^{(k)}=\sum_{l=1}^{n} \beta_{l}^{(k)} Q_{l} .
$$

Now,

\operatorname{Cliff}(C) & =i \sum_{k=1}^{m} A^{(k)^{-1}} B^{(k)} \otimes e_{k} \\
& =i \sum_{k=1}^{m}\left(\sum_{j=1}^{n} \sum_{l=1}^{n} \alpha_{j}^{(k)^{-1}} P_{j} \beta_{l}^{(k)} Q_{l}\right) \otimes e_{k} \\
& =i \sum_{j, l=1}^{n}\left(\sum_{k=1}^{m} \alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)} I \otimes e_{k}\right)\left(P_{j} Q_{l} \otimes e_{\phi}\right) .
\end{aligned}
$$

Similarly

\operatorname{Cliff}(\tilde{I})=i \sum_{r=1}^{n}\left(\sum_{t=1}^{m} I \otimes e_{t}\right)\left(Q_{r} \otimes e_{\phi}\right)

= & - \text { trace }\left[\sum_{j, l, r=1}^{n}\left(\sum_{t=1}^{m} I \otimes e_{t}\right)\left(\sum_{k=1}^{m} \overline{\alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)}} I \otimes e_{k}\right)\left(Q_{r} \otimes e_{\phi}\right)\left(Q_{l} P_{j} \otimes e_{\phi}\right)\right] \\
= & - \text { trace }\left[\sum _ { j , l , r = 1 } ^ { n } ( \sum _ { t = 1 } ^ { m } I \otimes e _ { t } ) \left(\sum_{k=1}^{m} \overline{\left.\left.\alpha_{j}^{(k)^{-1} \beta_{l}^{(k)}} I \otimes e_{k}\right)\left(Q_{r} Q_{l} P_{j} \otimes e_{\phi}\right)\right]}\right.\right. \\
= & -\operatorname{trace} \sum_{j, l, r=1}^{n}\left[-\left(\sum_{k=1}^{m} \overline{\alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)}}\right)\left(Q_{r} Q_{l} P_{j} \otimes e_{\phi}\right)\right] \\
& -\operatorname{trace} \sum_{j, l, r=1}^{n}\left[\sum_{k, t=1}^{m}\left(\overline{\alpha_{k \neq t}^{(k)^{-1}} \beta_{l}^{(k)}}-\overline{\alpha_{j}^{(t)^{-1}} \beta_{l}^{(t)}}\right)\left(Q_{r} Q_{l} P_{j} \otimes e_{t} e_{k}\right)\right] \\
= & \sum_{j, l, r=1}^{n} \sum_{k=1}^{m} \frac{\alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)}}{\operatorname{trace}\left(Q_{r} Q_{l} P_{j} \otimes e_{\phi}\right)} \\
= & 2^{m} \sum_{j, l=1}^{n} \sum_{k=1}^{m} \frac{\alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)}}{\operatorname{trace}\left(Q_{l} P_{j}\right)=2^{m} \sum_{j, l=1}^{n} \sum_{k=1}^{m} \overline{\alpha_{j}^{(k)-1} \beta_{l}^{(k)}} \operatorname{trace}\left(P_{j} Q_{l}\right) .}

& =2^{m} \sum_{k=1}^{m} \sum_{j, l, r=1}^{n} \alpha_{j}^{(k)^{-1}} \beta_{l}^{(k)} \alpha_{r}^{(k)^{-1}} \beta_{l}^{(k)} \operatorname{trace}\left(P_{j} Q_{l} P_{r}\right) \\

Let $W=\left(w_{i j}\right)$ where $w_{i j}=\operatorname{trace}\left(P_{i} Q_{j}\right)$. It can be easily verified that, $W$ is a doubly stochastic matrix. Hence by well-known Birkhoff's Theorem $W$ is convex combination of permutation matrices. Therefore

$$
W=\sum_{s=1}^{n!} t_{s} P_{s}, t_{s} \geq 0, \sum_{s=1}^{n!} t_{s}=1
$$

where $P_{s}$ are the permutation matrices and let $\pi_{s}$ be the corresponding permutation. Finally from (3.2) we have,

\|\operatorname{Cliff}(D)\|_{F}^{2} & =\|\operatorname{Cliff}(C-\tilde{I})\|_{F}^{2} \\
& =\|\operatorname{Cliff}(C)\|_{F}^{2}+\|\operatorname{Cliff}(\tilde{I})\|_{F}^{2}-2 \Re\left(\operatorname{trace}\left(\operatorname{Cliff}(C)^{*} \operatorname{Cliff}(\tilde{I})\right)\right) \\
& =2^{m} \sum_{s=1}^{n!} t_{s} \sum_{k=1}^{m} \sum_{j=1}^{n}\left[1+\left|\alpha_{j}^{(k)^{-1}} \beta_{\pi_{s}(j)}^{(k)}\right|^{2}-2 \Re\left(\overline{\alpha_{j}^{(k)^{-1}} \beta_{\pi_{s}(j)}^{(k)}}\right)\right] \\
& \geq 2^{m} \min _{s} \sum_{k=1}^{m} \sum_{j=1}^{n}\left[1+\left|\alpha_{j}^{(k)^{-1}} \beta_{\pi_{s}(j)}^{(k)}\right|^{2}-2 \Re\left(\overline{\left.\left.\alpha_{j}^{(k)^{-1} \beta_{\pi_{s}(j)}^{(k)}}\right)\right]}\right.\right. \\
& =2^{m} \sum_{j=1}^{n} \sum_{k=1}^{m}\left|\frac{\alpha_{j}^{(k)}-\beta_{\pi(j)}^{(k)}}{\alpha_{j}^{(k)}}\right|^{2}
\end{aligned}
$$

Hence the result is proved.
Remark 3.4. Sun [10] has generalized the Hoffman-Wielandt inequality for the case when one matrix is normal and other is arbitrary. Similarly, Theorem 3.3 can be
extended when one tuple of matrices are arbitrary. Let $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ and $B=\left(B^{(1)}, B^{(2)}, \cdots, B^{(m)}\right)$ are two $m$-tuples of commuting matrices in $M_{n}$ with joint eigenvalues $\alpha_{i}=\left(\alpha_{i}^{(1)}, \alpha_{i}^{(2)}, \cdots, \alpha_{i}^{(m)}\right)$ and $\beta_{i}=\left(\beta_{i}^{(1)}, \beta_{i}^{(2)}, \cdots, \beta_{i}^{(m)}\right)$ such that each $A^{(k)}$ is normal and non-singular. Since $B^{(1)}, B^{(2)}, \cdots, B^{(m)}$ are commuting so they can be reduced to upper triangular form by a single unitary matrix. Then Using Theorem 3.3 and the proof of Theorem 1.1 of [10] it can be established that, if $A, B(=A+E)$ are two $m$-tuple of commuting matrices as mentioned above, then there exists a permutation $\sigma$ in $S_{n}$ such that

$$
\sum_{j=1}^{n} \sum_{k=1}^{m}\left|\frac{\alpha_{j}^{(k)}-\beta_{\sigma(j)}^{(k)}}{\alpha_{j}^{(k)}}\right|^{2} \leq n \sum_{k=1}^{m}\left\|A^{(k)^{-1}}\right\|^{2}\left\|E^{(k)}\right\|_{F}^{2}
$$

When we relax the normality condition on each $B^{(k)}$, the constant $n$ appears on the right hand side of the above inequality. This constant $n$ is best possible. We can verify it by considering the following $n \times n$ matrices

$$
A^{(k)}=\left[\begin{array}{ccccc}
0 & k & 0 & \cdots & 0 \\
0 & 0 & k & \cdots & 0 \\
\vdots & \vdots & \vdots & & \vdots \\
0 & 0 & 0 & \cdots & k \\
k & 0 & 0 & \cdots & 0
\end{array}\right], \quad B^{(k)}=\left[\begin{array}{ccccc}
0 & k & 0 & \cdots & 0 \\
0 & 0 & k & \cdots & 0 \\
\vdots & \vdots & \vdots & & \vdots \\
0 & 0 & 0 & \cdots & k \\
0 & 0 & 0 & \cdots & 0
\end{array}\right]
$$

where $k$ runs over $1,2, \cdots, m$.
Now we prove the following diagonalizable analogue of Theorem 3.3.
Theorem 3.5. If $A$ and $B$ are $m$-tuple of diagonalizable matrices and for $k=$ $1,2, \cdots m$, each $A^{(k)}$ is non-singular, then there exists a permutation $\pi$ of $S_{n}$ such that

$$
\sum_{j=1}^{n} \sum_{k=1}^{m}\left|\frac{\alpha_{j}^{(k)}-\beta_{\pi(j)}^{(k)}}{\alpha_{j}^{(k)}}\right|^{2} \leq \kappa(P)^{2} \kappa(Q)^{2} \sum_{k=1}^{m}\left\|A^{(k)^{-1}}\left(B^{(k)}-A^{(k)}\right)\right\|_{F}^{2}
$$

where $\kappa(P)=\|P\|\left\|P^{-1}\right\|$ be the condition number of $P$. To prove this theorem, first we need to prove the following lemma which is slightly different from the result proved in [9, p. 216].

Lemma 3.6. If $M$ and $N$ are normal matrices and $\Sigma=\operatorname{diag}\left(\sigma_{1}, \sigma_{2}, \cdots, \sigma_{n}\right)$ with $\sigma_{1} \geq \sigma_{2} \geq \cdots \geq \sigma_{n} \geq 0$ then

$$
\|M \Sigma N-\Sigma\|_{F} \geq \sigma_{n}\|M N-I\|_{F}
$$

Proof. To prove this, set $\Omega=\Sigma-\sigma_{n} I$. Clearly the diagonal elements of $\Omega$ are non-negative. Now

& =\left\|(M \Omega N-\Omega)+\sigma_{n}(M N-I)\right\|_{F}^{2}-\sigma_{n}^{2}\|M N-I\|_{F}^{2} \\
& =\|(M \Omega N-\Omega)\|_{F}^{2}+2 \sigma_{n} \Re\left\{\operatorname{trace}\left[(M \Omega N-\Omega)^{*}(M N-I)\right]\right\} \\
& =\|(M \Omega N-\Omega)\|_{F}^{2}+\sigma_{n} \operatorname{trace}\left\{\Omega\left[(M N-I)^{*}(M N-I)+(M N-I)(M N-I)^{*}\right]\right\} \\
& \geq 0
\end{aligned}
$$

Proof of Theorem 3.5. Given $A=\left(A^{(1)}, A^{(2)}, \cdots, A^{(m)}\right)$ and $B=\left(B^{(1)}, B^{(2)}, \cdots, B^{(m)}\right)$ are two $m$-tuple of commuting diagonalizable matrices. Then $\alpha_{i}=\left(\alpha_{i}^{(1)}, \alpha_{i}^{(2)}, \ldots, \alpha_{i}^{(m)}\right)$ and $\beta_{i}=\left(\beta_{i}^{(1)}, \beta_{i}^{(2)}, \cdots, \beta_{i}^{(m)}\right)$ are joint eigenvalues of $A$ and $B$ respectively since there are two non-singular matrices $P$ and $Q$ such that for $k=1,2, \cdots, m$

$$
\begin{aligned}
& P A^{(k)} P^{-1}=D_{1}^{(k)}=\operatorname{diag}\left(\alpha_{1}^{(k)}, \alpha_{2}^{(k)}, \cdots, \alpha_{n}^{(k)}\right) \\
& Q B^{(k)} Q^{-1}=D_{2}^{(k)}=\operatorname{diag}\left(\beta_{1}^{(k)}, \beta_{2}^{(k)}, \cdots, \beta_{n}^{(k)}\right)
\end{aligned}
$$

Now $\left\|A^{(k)^{-1}}\left(B^{(k)}-A^{(k)}\right)\right\|_{F}^{2}=\left\|A^{(k)^{-1}} B^{(k)}-I\right\|_{F}^{2}$

$$
=\left\|P^{-1} D_{1}^{(k)^{-1}} P Q^{-1} D_{2}^{(k)} Q-I\right\|_{F}^{2}
$$

$$
\geq\|P\|^{-2}\left\|Q^{-1}\right\|^{-2}\left\|D_{1}^{(k)-1} P Q^{-1} D_{2}^{(k)}-P Q^{-1}\right\|_{F}^{2}
$$

Let $U \Sigma V^{*}$ be the singular value decomposition of $P Q^{-1}$ and $\sigma_{n}$ be the smallest diagonal element of $\Sigma$, then from above relation we have

$$
\begin{aligned}
\left\|A^{(k)^{-1}}\left(B^{(k)}-A^{(k)}\right)\right\|_{F}^{2} & \geq\|P\|^{-2}\left\|Q^{-1}\right\|^{-2}\left\|D_{1}^{(k)^{-1}} U \Sigma V^{*} D_{2}^{(k)}-U \Sigma V^{*}\right\|_{F}^{2} \\
& \geq\|P\|^{-2}\left\|Q^{-1}\right\|^{-2} \|\left(U^{*} D_{1}^{(k)}-1\right. \\
) & \Sigma\left(V^{*} D_{2}^{(k)} V\right)-\Sigma \|_{F}^{2} \\
& =\|P\|^{-2}\left\|Q^{-1}\right\|^{-2} \| M^{(k)^{-1} \Sigma N^{(k)}-\Sigma \|_{F}^{2}}
\end{aligned}
$$

where $M^{(k)}=U^{*} D_{1}^{(k)} U$ and $N^{(k)}=V^{*} D_{2}^{(k)} V$ and for each $k, M^{(k)}$ and $N^{(k)}$ are normal. Then from Lemma 3.6

$$
\left\|A^{(k)^{-1}}\left(B^{(k)}-A^{(k)}\right)\right\|_{F}^{2} \geq \sigma_{n}^{2}\|P\|^{-2}\left\|Q^{-1}\right\|^{-2}\left\|M^{(k)^{-1}} N^{(k)}-I\right\|_{F}^{2} .
$$

Finally we have

$$
\left\|M^{(k)^{-1}}\left(N^{(k)}-M^{(k)}\right)\right\|_{F}^{2} \leq \kappa(P)^{2} \kappa(Q)^{2}\left\|A^{(k)^{-1}}\left(B^{(k)}-A^{(k)}\right)\right\|_{F}^{2}
$$

Now applying Theorem 3.3 for the commuting tuples of normal matrices $M=$ $\left(M^{(1)}, M^{(2)}, \cdots, M^{(m)}\right)$ and $N=\left(N^{(1)}, N^{(2)}, \cdots, N^{(m)}\right)$ from above relation we have the required result.

Remark 3.7. Corollary 5.2 of [2] is a special case of Theorem 3.5 for $m=1$.
