# ON THE MODULE STRUCTURE OVER THE STEENROD ALGEBRA OF THE DICKSON ALGEBRA

#### Abstract

Let $p$ be an odd prime number. We study the problem of determining the module structure over the mod $p$ Steenrod algebra $\mathcal{A}(p)$ of the Dickson algebra $D_{n}$ consisting of all modular invariants of general linear group $G L\left(n, \mathbb{F}_{p}\right)$. Here $\mathbb{F}_{p}$ denotes the prime field of $p$ elements. In this paper, we give an explicit answer for $n=2$. More precisely, we explicitly compute the action of the Steenrod-Milnor operations $S t^{S, R}$ on the generators of $D_{n}$ for $n=2$ and for either $S=\emptyset, R=(i)$ or $S=(s), R=(i)$ with $s, i$ arbitrary nonnegative integers.


## 1. Introduction

Let $p$ be an odd prime number and let $G L_{n}=G L\left(n, \mathbb{F}_{p}\right)$ be the general linear group over the prime field $\mathbb{F}_{p}$ of $p$ elements. This group acts naturally on the algebra $P_{n}:=E\left(x_{1}, x_{2}, \ldots, x_{n}\right) \otimes P\left(y_{1}, y_{2}, \ldots, y_{n}\right)$. Here and in what follows, $E(., ., \ldots)$ and $P(., ., \ldots)$ are the exterior and polynomial algebras over $\mathbb{F}_{p}$ generated by the indicated variables. We grade $P_{n}$ by assigning $\operatorname{deg} x_{i}=1$ and $\operatorname{deg} y_{i}=2$.

Dickson showed in [1] that the invariant algebra $P\left(y_{1}, y_{2}, \ldots, y_{n}\right)^{G L_{n}}$ is a polynomial algebra over $\mathbb{F}_{p}$ generated by the Dickson invariants $Q_{n, s}, 0 \leqslant s<n$. In [6], Huynh Mui proved that the Dickson algebra $D_{n}=P_{n}^{G L_{n}}$ of invariants is generated by the Dickson invariants $Q_{n, s}, 0 \leqslant s<n$, and Mui invariants $R_{n ; s_{1}, \ldots, s_{k}}, 0 \leqslant s_{1}<\ldots<s_{k}<n$.

It is well known that $P_{n}$ is a module over the Steenrod algebra $\mathcal{A}(p)$. The action of $\mathcal{A}(p)$ on $P_{n}$ is determined by the formulas

0, & i>1\end{cases} \right.
\end{aligned}

and subject to the Cartan formulas

$$
\begin{aligned}
\beta(x y) & =\beta(x) y+(-1)^{\operatorname{deg} x} x \beta(y) \\
P^{r}(x y) & =\sum_{i=0}^{r} P^{i}(x) P^{r-i}(y)
\end{aligned}
$$

for $x, y \in P_{n}$ and $\beta$ is the Bockstein homomorphism (see Steenrod [9]).

[^0]Since this action commutes with the one of $G L_{n}$, it induces an action of $\mathcal{A}(p)$ on Dickson algebra $D_{n}$. So $D_{n}$ is a submodule of $P_{n}$. Note that the polynomial algebra $P\left(y_{1}, y_{2}, \ldots, y_{n}\right)$ is a submodule of $P_{n}$ and $P\left(y_{1}, y_{2}, \ldots, y_{n}\right)^{G L_{n}}$ is a submodule of the algebra $D_{n}$.

Let $\tau_{s}, \xi_{i}$ be the Milnor elements of degrees $2 p^{s}-1,2 p^{i}-2$ respectively in the dual algebra $\mathcal{A}(p)^{*}$ of $\mathcal{A}(p)$. In [5], Milnor showed that as an algebra,

\mathcal{A}(p)^{*}=E\left(\tau_{0}, \tau_{1}, \ldots\right) \otimes P\left(\xi_{1}, \xi_{2}, \ldots\right)
$$

Then $\mathcal{A}(p)^{*}$ has a basis consisting of all monomials

$$
\tau_{S} \xi^{R}=\tau_{s_{1}} \ldots \tau_{s_{k}} \xi_{1}^{r_{1}} \ldots \xi_{m}^{r_{m}}
$$

with $S=\left(s_{1}, \ldots, s_{k}\right), 0 \leqslant s_{1}<\ldots<s_{k}, R=\left(r_{1}, \ldots, r_{m}\right), r_{i} \geqslant 0$. Let $S t^{S, R} \in$ $\mathcal{A}(p)$ denote the dual of $\tau_{S} \xi^{R}$ with respect to that basis. Then $\mathcal{A}(p)$ has a basis consisting of all operations $S t^{S, R}$. For $S=\emptyset, R=(r), S t^{\emptyset,(r)}$ is nothing but the Steenrod operation $P^{r}$. So, we call $S t^{S, R}$ the Steenrod-Milnor operation of type $(S, R)$.

The operations $S t^{S, R}$ have the following fundamental properties:
$-S t^{\emptyset,(0)}=1, S t^{(0),(0)}=\beta$.
$-S t^{S, R}(z)=0$ if $z \in P_{n}$ and $\operatorname{deg} z<k+2\left(r_{1}+r_{2}+\ldots+r_{m}\right)$.

- The Cartan formula

$$
S t^{S, R}(z t)=\sum_{\substack{S_{1} \cup S_{2}=S \\ R_{1}+R_{2}=R}}(-1)^{\left(\operatorname{deg} z+\ell\left(S_{1}\right)\right) \ell\left(S_{2}\right)}\left(S: S_{1}, S_{2}\right) S t^{S_{1}, R_{1}}(z) S t^{S_{2}, R_{2}}(t)
$$

where $R_{1}=\left(r_{1 i}\right), R_{2}=\left(r_{2 i}\right), R_{1}+R_{2}=\left(r_{1 i}+r_{2 i}\right), S_{1} \cap S_{2}=\emptyset, z, t \in P_{n}, \ell\left(S_{j}\right)$ means the length of $S_{j}$ and

$$
\left(S: S_{1}, S_{2}\right)=\operatorname{sign}\left(\begin{array}{cccccc}
s_{1} & \ldots & s_{h} & s_{h+1} & \ldots & s_{k} \\
s_{1,1} & \ldots & s_{1, h} & s_{2,1} & \ldots & s_{2, k-h}
\end{array}\right)
$$

with $S_{1}=\left(s_{1,1}, \ldots, s_{1, h}\right), s_{1,1}<\ldots<s_{1, h}, S_{2}=\left(s_{2,1}, \ldots, s_{2, k-h}\right), s_{2,1}<\ldots<$ $s_{2, k-h}$ (see Mui [7]).

The action of $S t^{S, R}$ on Dickson invariants $Q_{n, s}$ has partially been studied by many authors. This action for $S=\emptyset, R=(i)$ was explicitly determined by MadsenMilgram [4, Smith-Switzer [9, Hung-Minh [2], Kechagias 3], Sum [12], Wilkerson 14]. This action for either $S=(s), R=(0)$ or $S=\emptyset, R=(0, \ldots, 0,1)$ with 1 at the $i$-th place, was studied by Wilkerson [14, Neusel [8], Sum [13].

In this paper, we explicitly determine the action of the Steenrod-Milnor operations $S t^{S, R}$ on Dickson invariants $Q_{2,0}, Q_{2,1}$ and Mui invariants $R_{2 ; 0}, R_{2 ; 1}, R_{2 ; 0,1}$ for either $S=\emptyset, R=(i)$ or $S=(s), R=(i)$.

In Section 2 we recall some results on the modular invariants of the general linear group $G L_{2}$ and the action of the Steenrod-Milnor operations on the generators of $P_{2}$. In Section 3, we compute the action of the Steenrod operations on DicksonMui invariants. Finally, in Section 4, we explicitly determine the action of the Steenrod-Milnor operations $S t^{(s),(i)}$ on $Q_{2,0}, Q_{2,1}, R_{2 ; 0}, R_{2 ; 1}$ and $R_{2 ; 0,1}$.

## 2. Preliminaries

Definition 2.1. Let $u, v$ be nonnegative integers. Following Dickson [1], Mui [6], we define

y_{1}^{p^{v}} & y_{2}^{p^{v}}
\end{array}\right|, \quad[1 ; u]=\left|\begin{array}{cc}
x_{1} & x_{2} \\
y_{1}^{p^{u}} & y_{2}^{p^{u}}
\end{array}\right| .
$$

In particular, we set

$$
\begin{aligned}
L_{2} & =[0,1], \quad L_{2,0}=[1,2], \quad L_{2,1}=[0,2], \\
M_{2 ; 0} & =[1 ; 1], \quad M_{2 ; 1}=[1 ; 0], \quad M_{2 ; 0,1}=x_{1} x_{2}
\end{aligned}
$$

The polynomial $[u, v]$ is divisible by $L_{2}$. Then, Dickson invariants $Q_{2,0}, Q_{2,1}$ and Mui invariants $R_{2 ; 0}, R_{2 ; 1}, R_{2 ; 0,1}$ are defined by

\begin{aligned}
& Q_{2,0}=L_{2,0} / L_{2}, Q_{2,1}=L_{2,1} / L_{2} \\
& R_{2 ; 0}=M_{2 ; 0} L_{2}^{p-2}, R_{2 ; 1}=M_{2 ; 1} L_{2}^{p-2}, R_{2 ; 0,1}=M_{2 ; 0,1} L_{2}^{p-2}
\end{aligned}
$$

Now we prepare some data in order to prove our main results. First, we recall the following which will be needed in the next sections.

Let $\alpha_{i}(a)$ denote the $i$-th coefficient in $p$-adic expansion of a non-negative integer $a$. That means

a=\alpha_{0}(a) p^{0}+\alpha_{1}(a) p^{1}+\alpha_{2}(a) p^{2}+\ldots,
$$

for $0 \leqslant \alpha_{i}(a)<p, i \geqslant 0$.
Denote by $I(u, v)$ the set of all integers $a$ satisfying

$$
\begin{aligned}
& \alpha_{i}(a)+\alpha_{i+1}(a) \leqslant 1, \text { for any } i, \\
& \alpha_{i}(a)=0, \text { for either } i<u \text { or } i \geqslant v-2 .
\end{aligned}
$$

Proposition 2.2 (Sum [13]). Under the above notations, we have

$$
[u, v]=\sum_{a \in I(u, v)}(-1)^{a} L_{2}^{p^{u}+p(p-1) a} Q_{2,1}^{\frac{p^{v-1}-p^{u}}{p-1}}-(p+1) a
$$

Lemma 2.3 (Sum [12). Let b be a nonnegative integer and $\varepsilon=0,1$. We have

$$
S t^{S, R}\left(x_{k}^{\varepsilon} y_{\ell}^{b}\right)= \begin{cases}\binom{b}{R} x_{k}^{\varepsilon} y_{\ell}^{b+|R|}, & S=\emptyset \\ \varepsilon\binom{b}{R} y_{k}^{p^{s}} y_{\ell}^{b+|R|}, & S=(s), s \geqslant 0 \\ 0, & \text { otherwise }\end{cases}
$$

$\operatorname{Here}\binom{b}{R}=\frac{b!}{\left(b-r_{1}-r_{2}-\ldots-r_{m}\right)!r_{1}!\ldots r_{m}!}$ for $r_{1}+r_{2}+\ldots+r_{m} \leqslant b$ and $\binom{b}{R}=0$ for $r_{1}+r_{2}+\ldots+r_{m}>b$ and $|R|=(p-1) r_{1}+\left(p^{2}-1\right) r_{2}+\ldots+\left(p^{m}-1\right) r_{m}$.

Note that for $R=(i),\binom{b}{R}=\binom{b}{i}$ is the binomial coefficient. By convention, we set $\binom{b}{i}=0$ for $i<0$.

Applying Lemma 2.3 to $P^{i}=S t^{\emptyset,(i)}$, we get
Corollary 2.4 (Steenrod [10]). Let $b, i$ be nonnegative integers. Then we have

$$
P^{i} y_{k}^{b}=\binom{n}{i} y_{k}^{b+(p-1) i}
$$

Since $\binom{p^{e}}{i}=0$ in $\mathbb{F}_{p}$ for $1<i<p^{e}$, we get
Corollary 2.5. For any nonnegative integers $e, i$,

$$
P^{i} y_{k}^{p^{e}}= \begin{cases}y_{k}^{p^{e}}, & i=0, \\ y_{k}^{p^{e+1}}, & i=p^{e}, \\ 0, & \text { otherwise }\end{cases}
$$

Applying Corollary 2.5 and the Cartan formula to $[u, v]=y_{1}^{p^{u}} y_{2}^{p^{v}}-y_{1}^{p^{v}} y_{2}^{p^{u}}$, we obtain

Lemma 2.6 (Mui [6). Let $u, v, i$ be nonnegative integers. Then we have

$$
P^{i}[u, v]= \begin{cases}{[u, v],} & i=0 \\ {[u+1, v],} & i=p^{u} \\ {[u, v+1],} & i=p^{v}, \\ {[u+1, v+1],} & i=p^{u}+p^{v} \\ 0, & \text { otherwise }\end{cases}
$$

Since $L_{2}=[0,1], L_{2,0}=[1,2], L_{2,1}=[0,2]$, from Lemma 2.6, we get
Corollary 2.7. For any nonnegative integers $i$,

$$
\begin{aligned}
& P^{i} L_{2}= \begin{cases}L_{2}, & i=0, \\
L_{2} Q_{2,1}, & i=p, \\
L_{2} Q_{2,0}, & i=p+1, \\
0, & \text { otherwise },\end{cases} \\
& P^{i} L_{2,0}= \begin{cases}{[0,1]=L_{2} Q_{2,0},} & i=0, \\
{[1,3]=L_{2} Q_{2,0} Q_{2,1}^{p},} & i=p^{2}, \\
{[2,3]=L_{2} Q_{2,0}^{p+1},} & i=p^{2}+p, \\
0, & \text { otherwise },\end{cases} \\
& P^{i} L_{2,1}= \begin{cases}{[0,2]=L_{2} Q_{2,1},} & i=0, \\
{[1,2]=L_{2} Q_{2,0},} & i=1, \\
{[0,3]=L_{2}\left(Q_{2,1}^{p+1}-Q_{2,0}^{p}\right),} & i=p^{2}, \\
{[1,3]=L_{2} Q_{2,0} Q_{2,1}^{p},} & i=p^{2}+1, \\
0, & \text { otherwise. }\end{cases}
\end{aligned}
$$

Combining Lemma 2.3. Corollary 2.5 and the Cartan formula gives
Lemma 2.8. Let $s, i$ be nonnegative integers. Then we have

$$
S t^{(s),(i)}[1 ; u]= \begin{cases}{[s, u],} & i=0 \\ {[s, u+1],} & i=p^{u} \\ 0, & \text { otherwise }\end{cases}
$$

Applying Lemma 2.3 and Corollary 2.5 to $M_{2 ; 0}=[1 ; 1], M_{2 ; 1}=[1 ; 0]$, we obtain

Corollary 2.9. For any nonnegative integer $i$,

$$
\begin{aligned}
& P^{i}\left(M_{2 ; 0}\right)= \begin{cases}{[1 ; 1]=M_{2 ; 0},} & i=0, \\
{[1 ; 2]=M_{2 ; 0} Q_{2,1}-M_{2 ; 1} Q_{2,0},} & i=p \\
0, & \text { otherwise },\end{cases} \\
& P^{i}\left(M_{2 ; 1}\right)= \begin{cases}{[1 ; 0]=M_{2 ; 1},} & i=0, \\
{[1 ; 1]=M_{2 ; 0},} & i=1, \\
0, & \text { otherwise. }\end{cases}
\end{aligned}
$$

3. The action of the Steenrod operations on Dickson-Mui invariants

First of all, we prove the following which was proved in Hung-Minh [2], by another method.

Theorem 3.1 (Hung-Minh [2]). For any nonnegative integer $i$ and $s=0,1$, we have

$$
P^{i} Q_{2, s}= \begin{cases}(-1)^{k}\binom{k+s}{r} Q_{2,0}^{r+1-s} Q_{2,1}^{k+s-r}, & i=k p+r, 0 \leqslant r-s \leqslant k<p \\ 0, & \text { otherwise }\end{cases}
$$

Proof. Recall that $\operatorname{deg} Q_{2, s}=2\left(p^{2}-p^{s}\right)<2 p^{2}$. Hence, $P^{i} Q_{2, s}=0$ for $i \geqslant p^{2}$. Suppose that $i<p^{2}$. Then, using the $p$-adic expansion of $i$, we have

$$
i=k p+r \text { for } 0 \leqslant k, r<p
$$

We prove the theorem by induction on $k$. We have $P^{0} Q_{2, s}=Q_{2, s}$. According to Corollary 2.7,

$$
\begin{aligned}
& 0=P^{1} L_{2,0} \\
&=P^{1}\left(L_{2} Q_{2,0}\right)=L_{2} P^{1} Q_{2,0} \\
& L_{2} Q_{2,0}=P^{1} L_{2,1}=P^{1}\left(L_{2} Q_{2,1}\right)=L_{2} P^{1} Q_{2,1}
\end{aligned}
$$

These equalities imply $P^{1} Q_{2,0}=0, P^{1} Q_{2,1}=Q_{2,0}$. For $1<r<p, P^{r} L_{2, s}=0$ and $P^{r} L_{2}=0$. Using the Cartan formula and Corollary 2.7, we have

$$
0=P^{r} L_{2, s}=P^{r}\left(L_{2} Q_{2, s}\right)=L_{2} P^{r} Q_{2, s}
$$

This implies $P^{r} Q_{2, s}=0$. So the theorem holds for $k=0$ and any $0 \leqslant r<p$. Suppose $0<k<p$ and the theorem is true for $k-1$ and any $0 \leqslant r<p$. Using the Cartan formula, Corollary 2.7 and the inductive hypothesis, we get

$$
\begin{aligned}
& 0=P^{i} L_{2, s}=P^{i}\left(L_{2} Q_{2, s}\right) \\
& =L_{2} P^{i} Q_{2, s}+L_{2} Q_{2,1} P^{i-p} Q_{2, s}+L_{2} Q_{2,0} P^{i-p-1} Q_{2,0} \\
& =L_{2} P^{i} Q_{2, s}+L_{2} Q_{2,1}(-1)^{k-1}\binom{k-1+s}{r} Q_{2,0}^{r+1-s} Q_{2,1}^{k+s-r-1} \\
& \\
& \qquad \quad+L_{2} Q_{2,0}(-1)^{k-1}\binom{k-1+s}{r-1} Q_{2,0}^{r-s} Q_{2,1}^{k+s-r} \\
& = \\
& =L_{2} P^{i} Q_{2, s}+(-1)^{k-1}\left(\binom{k-1+s}{r}+\binom{k-1+s}{r-1}\right) L_{2} Q_{2,0}^{r+1-s} Q_{2,1}^{k+s-r} .
\end{aligned}
$$

From this equality and the relation $\binom{k-1+s}{r}+\binom{k-1+s}{r-1}=\binom{k+s}{r}$, we see that the theorem holds for $k$. The proof is completed.

To compute the action of $P^{i}$ on $R_{2 ; 0}, R_{2 ; 1}, R_{2 ; 0,1}$ we need the following
Lemma 3.2. Let $i$ be a nonnegative integer. Then we have

$$
P^{i} L_{2}^{p-2}= \begin{cases}(-1)^{k}(k+1)\binom{k}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r}, & i=k p+r, 0 \leqslant r \leqslant k<p \\ 0, & \text { otherwise }\end{cases}
$$

Proof. Note that $\operatorname{deg} L_{2}^{p-2}=2(p-2)(p+1)<2 p^{2}$. So $P^{i} L_{2}^{p-2}=0$ for $i \geqslant p^{2}$. Hence, it suffices to prove the theorem for $i=k p+r$ with $0 \leqslant k, r<p$.

Since $P^{0}=1$, we have $P^{0} L_{2}^{p-2}=L_{2}^{p-2}$. If $0<r<p$ then from Theorem 3.1 the Cartan formula and the relation $Q_{2,0}=L_{2}^{p-1}=L_{2} L_{2}^{p-2}$, we get

$$
0=P^{r} Q_{2,0}=L_{2} P^{r} L_{2}^{p-2}
$$

This implies $P^{r} L_{2}^{p-2}=0$. The lemma is true for $k=0$ and $0 \leqslant r<p$.
Suppose that $0<k<p$ and the lemma holds for $k-1$ and any $0 \leqslant r<p$. Using the Cartan formula, Theorem 3.1, Corollary 2.7 and the inductive hypothesis, we have

$$
\begin{aligned}
(-1)^{k}\binom{k}{r} Q_{2,0}^{r+1} Q_{2,1}^{k-r}= & P^{i} Q_{2,0}=P^{i}\left(L_{2} L_{2}^{p-2}\right) \\
= & L_{2} P^{i} L_{2}^{p-2}+L_{2} Q_{2,1} P^{i-p} L_{2}^{p-2}+L_{2} Q_{2,0} P^{i-p-1} L_{2}^{p-2} \\
= & L_{2} P^{i} L_{2}^{p-2}+L_{2} Q_{2,1}(-1)^{k-1} k\binom{k-1}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r-1} \\
& +L_{2} Q_{2,0}(-1)^{k-1} k\binom{k-1}{r-1} L_{2}^{p-2} Q_{2,0}^{r-1} Q_{2,1}^{k-r} \\
= & L_{2} P^{i} L_{2}^{p-2}+(-1)^{k-1} k\left(\binom{k-1}{r}+\binom{k-1}{r-1}\right) Q_{2,0}^{r+1} Q_{2,1}^{k-r}
\end{aligned}
$$

This equality and the relation $\binom{k-1}{r}+\binom{k-1}{r-1}=\binom{k}{r}$ imply the lemma for $k$ and any $0 \leqslant r<p$.

Theorem 3.3. Let $i$ be a nonnegative integer. We have

$$
P^{i} R_{2 ; 0}=\left\{\begin{array}{lc}
(-1)^{k}\left((r+1)\binom{k}{r} R_{2 ; 0} Q_{2,0}^{r} Q_{2,1}^{k-r}+k\binom{k-1}{r} R_{2 ; 1} Q_{2,0}^{r+1} Q_{2,1}^{k-r-1}\right) \\
0, & i=k p+r, 0 \leqslant r \leqslant k<p \\
\text { otherwise }
\end{array}\right.
$$

Proof. Note that $\operatorname{deg} R_{2 ; 0}=2 p^{2}-3<2 p^{2}$. So $P^{i} R_{2 ; 0}=0$ for $i \geqslant p^{2}$. We prove the theorem for $i=k p+r$ with $0 \leqslant k, r<p$.

For $k=r=0, P^{0} R_{2 ; 0}=R_{2 ; 0}$. For $k=0,0<r<p$, applying the Cartan formula and Corollary 2.9, we get

$$
P^{r} R_{2 ; 0}=P^{r}\left(M_{2 ; 0} L_{2}^{p-2}\right)=M_{2 ; 0} P^{r} L_{2}^{p-2}=0
$$

The theorem holds for $k=0$ and $0 \leqslant r<p$.

Suppose that $0<k<p$. Using the Cartan formula, Corollary 2.9 and Lemma 3.2. we obtain

$$
\begin{aligned}
P^{i} R_{2 ; 0}= & P^{i}\left(M_{2 ; 0} L_{2}^{p-2}\right)=P^{0} M_{2 ; 0} P^{i} L_{2}^{p-2}+P^{p} M_{2 ; 0} P^{i-p} L_{2}^{p-2} \\
= & M_{2 ; 0} P^{i} L_{2}^{p-2}+\left(M_{2 ; 0} Q_{2,1}-M_{2 ; 1} Q_{2,0}\right) P^{i-p} L_{2}^{p-2} \\
= & M_{2 ; 0}(-1)^{k}(k+1)\binom{k}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r} \\
& +\left(M_{2 ; 0} Q_{2,1}-M_{2 ; 1} Q_{2,0}\right)(-1)^{k-1} k\binom{k-1}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r-1} \\
= & (-1)^{k}\left(\left((k+1)\binom{k}{r}-k\binom{k-1}{r}\right) R_{2 ; 0} Q_{2,0}^{r} Q_{2,1}^{k-r}\right. \\
& \left.+k\binom{k-1}{r} R_{2 ; 1} Q_{2,0}^{r+1} Q_{2,1}^{k-r-1}\right)
\end{aligned}
$$

This equality and the relation $(k+1)\binom{k}{r}-k\binom{k-1}{r}=(r+1)\binom{k}{r}$ imply the theorem for $k$ and $0 \leqslant r<p$.

By an analogous argument as given in the proof of Theorem 3.3, we can easily obtain the following

Theorem 3.4. For any nonnegative integer $i$, we have

$$
\begin{aligned}
P^{i} R_{2 ; 1} & = \begin{cases}\left.(-1)^{k}(k+1)\binom{k}{r} R_{2 ; 1} Q_{2,0}^{r} Q_{2,1}^{k-r}+\binom{k}{r-1} R_{2 ; 0} Q_{2,0}^{r-1} Q_{2,1}^{k-r+1}\right), \\
0, & i=k p+r, 0 \leqslant r \leqslant k<p,\end{cases} \\
P^{i} R_{2 ; 0,1} & = \begin{cases}(-1)^{k}(k+1)\binom{k}{r} R_{2 ; 0,1} Q_{2,0}^{r} Q_{2,1}^{k-r}, & i=k p+r, 0 \leqslant r \leqslant k<p, \\
0, & \text { otherwise. } .\end{cases}
\end{aligned}
$$

## 4. On the action of the Steenrod-Milnor operations on Dickson-Mui invariants

In this section, we compute the action of $S t^{(s),(i)}$ on Dickson-Mui invariants. It is easy to see that $S t^{(s),(i)} Q_{2, s}=0$. So we need only to compute the action of $S t^{(s),(i)}$ on $R_{2 ; 0}, R_{2 ; 1}$ and $R_{2 ; 0,1}$.

First, we recall the following
Lemma 4.1 (Sum [11]). For any nonnegative integers $s, i$,

$$
S t^{(s),(i)}\left(M_{2 ; 0}\right)=\left\{\begin{array}{ll}
{[s, 1],} & i=0, \\
{[s, 2],} & i=p, \\
0, & \text { otherwise },
\end{array} \quad S t^{(s),(i)}\left(M_{2 ; 1}\right)= \begin{cases}{[s, 0],} & i=0 \\
{[s, 1],} & i=1 \\
0, & \text { otherwise }\end{cases}\right.
$$

This lemma can easily be proved by using the Cartan formula and Lemma 2.3

Theorem 4.2. Let $s, i$ be nonnegative integers. Then we have

$$
S t^{(s),(i)} R_{2 ; 0}= \begin{cases}(-1)^{k}(r+1)\binom{k}{r} Q_{2,0}^{k+1} Q_{2,1}^{k-r}, & s=0, i=k p+r, 0 \leqslant r \leqslant k<p, \\
(-1)^{k+1} k\binom{k-1}{r} Q_{2,0}^{r+2} Q_{2,1}^{k-1-r}, & s=1, i=k p+r, 0 \leqslant r<k<p \\
(-1)^{k+1}(k+1)\binom{k}{r} Q_{2,0}^{r+2} Q_{2,1}^{k-r}, & s=2, i=k p+r, 0 \leqslant r \leqslant k<p \\
(-1)^{k+1}\binom{k}{r}\left(\begin{array}{l}
(k+1) \sum_{a \in I(1, s)}(-1)^{a} Q_{2,0}^{p a+r+2} Q_{2,1}^{\frac{p^{s-1}-p}{p-1}-(p+1) a+k-r} \\
-(k-r) \sum_{a \in I(2, s)}(-1)^{a} Q_{2,0}^{p(a+1)+r+2} Q_{2,1}^{\frac{p^{s-1}-p^{2}}{p-1}-(p+1) a+k-r-1} \\
0,
\end{array}\right. \\
& s>2, i=k p+r, 0 \leqslant r \leqslant k<p, \\
\text { otherwise. }\end{cases}
$$

Proof. Since $\operatorname{deg} R_{2 ; 0}=2 p^{2}-3, S t^{(s),(i)} R_{2 ; 0}=0$ for $i \geqslant p^{2}$. Suppose $i<p^{2}$, then using the $p$-adic expansion of $i$, we have $i=k p+r$ for $0 \leqslant k, r<p$.

We have $S t^{(s),(0)} R_{2 ; 0}=S t^{(s),(0)}\left(M_{2 ; 0} L_{2}^{p-2}\right)=S t^{(s),(0)} M_{2 ; 0} P^{0} L_{2}^{p-2}=[s, 1] L_{2}^{p-2}$. For $0<r<p$, using the Cartan formula, Lemma 3.2 and Lemma 4.1] we get

$$
S t^{(s),(r)} R_{2 ; 0}=S t^{(s),(r)}\left(M_{2 ; 0} L_{2}^{p-2}\right)=S t^{(s),(0)}\left(M_{2 ; 0}\right) P^{r} L_{2}^{p-2}=0
$$

The above equalities and Proposition 2.2 imply the theorem for $k=0$.
For $0<k<p$, using the Cartan formula, Lemma 3.2 and Lemma 4.1 we obtain

$$
\begin{aligned}
S t^{(s),(i)} R_{2 ; 0}= & S t^{(s),(i)}\left(M_{2 ; 0} L_{2}^{p-2}\right) \\
= & S t^{(s),(0)} M_{2 ; 0} P^{i} L_{2}^{p-2}+S t^{(s),(p)} M_{2 ; 0} P^{i-p} L_{2}^{p-2} \\
= & {[s, 1](-1)^{k}(k+1)\binom{k}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r} } \\
& +[s, 2](-1)^{k-1} k\binom{k-1}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r-1} .
\end{aligned}
$$

Combining this equality and Proposition 2.2, we obtain the theorem.
Theorem 4.3. For any nonnegative integers $s, i$,
$S t^{(s),(i)} R_{2 ; 1}=\left\{\begin{array}{l}(-1)^{k}(k+1)\binom{k}{r-1} Q_{2,0}^{r} Q_{2,1}^{k-r+1}, \quad s=0, i=k p+r, 0 \leqslant r \leqslant k<p, \\ (-1)^{k+1}(k+1)\binom{k}{r} Q_{2,0}^{r+1} Q_{2,1}^{k-r}, \quad s=1, i=k p+r, 0 \leqslant r \leqslant k<p, \\ (-1)^{k+1}(k+1)\left(\binom{k}{r} \sum_{a \in I(0, s)}(-1)^{a} Q_{2,0}^{p a+r+1} Q_{2,1}^{\frac{p^{s-1}-1}{p-1}-(p+1) a+k-r}\right. \\ \left.+\binom{k}{r-1} \sum_{a \in I(1, s)}(-1)^{a} Q_{2,0}^{p a+r+1} Q_{2,1}^{\frac{p^{s-1}-p}{p-1}-(p+1) a+k-r+1}\right), \\ 0, \\ s>1, i=k p+r, 0 \leqslant r \leqslant k<p, \\ \text { otherwise. }\end{array}\right.$
Proof. Since deg $R_{2 ; 1}=2\left(p^{2}-p\right)-1, S t^{(s),(i)} R_{2 ; 1}=0$ for $i \geqslant p^{2}$. Suppose $i<p^{2}$ and $i=k p+r$ with $0 \leqslant k, r<p$. Using the Cartan formula and Lemma 4.1, we have

$$
S t^{(s),(0)} R_{2 ; 1}=S t^{(s),(0)}\left(M_{2 ; 1}\right) L_{2}^{p-2}=[s, 0] L_{2}^{p-2}
$$

From this and Proposition [2.2, we see that the theorem is true for $i=0$.
For $i>0$, using the Cartan formula, Lemma 4.1 and Lemma 3.2, we obtain

$$
\begin{aligned}
S t^{(s),(i)} R_{2 ; 1}= & S t^{(s),(0)} M_{2 ; 1} P^{i} L_{2}^{p-2}+S t^{(s),(1)} M_{2 ; 1} P^{i-1} L_{2}^{p-2} \\
= & {[s, 0](-1)^{k}(k+1)\binom{k}{r} L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r} } \\
& \quad+[s, 1](-1)^{k}(k+1)\binom{k}{r-1} L_{2}^{p-2} Q_{2,0}^{r-1} Q_{2,1}^{k-r+1} \\
= & (-1)^{k}(k+1)\left(\binom{k}{r}[s, 0] L_{2}^{p-2} Q_{2,0}^{r} Q_{2,1}^{k-r}\right. \\
& \left.\quad+\binom{k}{r-1}[s, 1] L_{2}^{p-2} Q_{2,0}^{r-1} Q_{2,1}^{k-r+1}\right)
\end{aligned}
$$

Now the theorem follows from this equality and Proposition 2.2
Theorem 4.4. Suppose $s, i$ are nonnegative integers. We have

$$
S t^{(s),(i)} R_{2 ; 0,1}=\left\{\begin{array}{c}
(-1)^{k+1}(k+1)\binom{k}{r} R_{2 ; 1} Q_{2,0}^{r} Q_{2,1}^{k-r}, \\
(-1)^{k+1}(k+1)\binom{k}{r} R_{2 ; 0} Q_{2,0}^{r} Q_{2,1}^{k-r}, \\
s=0, i=k p+r, 0 \leqslant r \leqslant k<p, i=k p+r, 0 \leqslant r \leqslant k<p, \\
(-1)^{k}(k+1)\binom{k}{r}\left(R_{2 ; 1} \sum_{a \in I(1, s)}(-1)^{a} Q_{2,0}^{p a+1+r} Q_{2,1}^{\frac{p^{s-1}-p}{p-1}-(p+1) a+k-r}\right. \\
-R_{2 ; 0} \sum_{a \in I(0, s)}(-1)^{a} Q_{2,0}^{p a+r} Q_{2,1}^{\frac{p^{s-1}-1}{p-1}-(p+1) a+k-r} \\
\\
s>1, i=k p+r, 0 \leqslant r \leqslant k<p, \\
\text { otherwise. }
\end{array}\right.
$$

Proof. Since deg $R_{2 ; 0,1}=(p-2)(p+1)+2, S t^{(s),(i)} R_{2 ; 0,1}=0$ for $i \geqslant p^{2}$. Suppose $i<p^{2}$ and $i=k p+r$ with $0 \leqslant k, r<p$. Using the Cartan formula and Lemma 2.3 we have

$$
S t^{(s),(0)}\left(x_{1} x_{2}\right)=y_{1}^{p^{s}} x_{2}-x_{1} y_{2}^{p^{s}}=-[1 ; s]=\left(M_{2 ; 1}[1, s]-M_{2 ; 0}[0, s]\right) / L_{2} .
$$

Since $R_{2 ; 0,1}=x_{1} x_{2} L_{2}^{p-2}$, using the Cartan formula, the above equality and Lemma 3.2. we get

$$
\begin{aligned}
S t^{(s),(i)} R_{2 ; 0.1} & =S t^{(s),(0)}\left(x_{1} x_{2}\right) P^{i} L_{2}^{p-2} \\
& =\left(M_{2 ; 1}[1, s]-M_{2 ; 0}[0, s]\right)(-1)^{k}(k+1)\binom{k}{r} L_{2}^{p-3} Q_{2,0}^{r} Q_{2,1}^{k-r}
\end{aligned}
$$

Combining this equality and Proposition [2.2, we get the theorem.
