# Almost complex structures on connected sums of complex projective spaces

#### Abstract

We show that the $m$-fold connected sum $m \# \mathbb{C P}^{2 n}$ admits an almost complex structure if and only if $m$ is odd.


## 1 Introduction

A complex structure on a real vector bundle $F$ over a connected CW complex $X$ is a complex vector bundle $E$ over $X$ such that its underlying real vector bundle $E_{\mathbb{R}}$ is isomorphic to $F$. A stable complex structure on $F$ is a complex structure on $F \oplus \varepsilon^{d}$, where $\varepsilon^{d}$ is the $d$ dimensional trivial real vector bundle over $X$. For $X$ a manifold we say that $X$ has an almost complex structure (respectively stable almost complex structure) if its tangent bundle admits an complex structure (respectively stable complex structure). Motivated by the question in [6] we consider in this paper the $m$-fold connected sum of complex projective spaces $m \# \mathbb{C P}{ }^{2 n}$.

As shown by Hirzebruch [4, Kommentare, p. 777], a necessary condition for the existence of an almost complex structure on a $4 n$-dimensional compact manifold $M$ is the congruence $\chi(M) \equiv(-1)^{n} \sigma(M) \bmod 4$, where $\chi(M)$ is the Euler characteristic and $\sigma(M)$ the signature of $M$. Thus, for even $m$, the connected sums above cannot carry an almost complex structure. We will show that for odd $m$ they do admit almost complex structures, thus showing

Theorem 1.1. The $m$-fold connected sum $m \# \mathbb{C P}^{2 n}$ admits an almost complex structure if and only if $m$ is odd.

In odd complex dimensions, the connected sums $m \# \mathbb{C P}^{2 n+1}$ are Kähler, since $\mathbb{C P}^{2 n+1}$ admits an orientation reversing diffeomorphism and therefore $m \# \mathbb{C P}^{2 n+1}$ is diffeomorphic to $\mathbb{C P}^{2 n+1} \#(m-1) \overline{\mathbb{C P}^{2 n+1}}$ which is a blow-up of $\mathbb{C P}^{2 n+1}$ in $m-1$ points, hence Kähler. Furthermore Theorem 1.1 is known for $n=1$ and $n=2$, see 1] and [10 respectively. In both cases the authors use general results on the existence of almost complex structures on manifolds of dimension 4 and 8 respectively.

We will prove Theorem 1.1 as follows. In [12, Theorem 1.1] or in [14, Theorem 1.7] the authors showed

Theorem 1.2. Let $M$ be a closed smooth 2d-dimensional manifold. Then TM admits an almost complex structure if and only if it admits a stable almost complex structure E such that $c_{d}(E)=e(M)$, where $c_{d}$ is the d-th Chern class of $E$ and $e(M)$ is the Euler class of $M$.

In Section 2 we will describe the full set of stable almost complex structures in the reduced $K$-theory of $m \# \mathbb{C P}^{2 n}$. In Section 3 we give, for odd $m$, an explicit example of a stable almost

[^0]complex structure to which Theorem 1.2 applies.

## 2 Stable almost complex structures on $m \# \mathbb{C P}^{2 n}$

For a CW complex $X$ let $K(X)$ and $K O(X)$ denote the complex and real $K$-groups respectively. Moreover we denote by $\widetilde{K}(X)$ and $\widetilde{K O}(X)$ the reduced groups. Let $r: K(X) \rightarrow K O(X)$ denote the real reduction map, which can be restricted to a map $\widetilde{K}(X) \rightarrow \widetilde{K O}(X)$. We denote the restricted map again with $r$. A real vector bundle $F$ over $X$ has a stable almost complex structure if there is a an element $y \in \widetilde{K}(X)$ such that $r(y)=F-\operatorname{dim} F$. Since $r$ is a group homomorphism, the set of all stable complex vector bundles, such that the underlying real vector bundle is stably isomorphic to $F$, is given by

$$
y+\operatorname{ker} r \subset \tilde{K}(X),
$$

where $y$ is such that $r(y)=F-\operatorname{dim} F$. Let $c: K O(X) \rightarrow K(X)$ denote the complexification map and $t: K(X) \rightarrow K(X)$ the map which is induced by complex conjugation of complex vector bundles. The maps $t$ and $c$ are ring homomorphisms, but $r$ preserves only the group structure. The following idendities involving the maps $r, c$ and $t$ are well known

$$
\begin{aligned}
& c \circ r=1+t: K(X) \rightarrow K(X), \\
& r \circ c=2: K O(X) \rightarrow K O(X) .
\end{aligned}
$$

We will write $\bar{y}=t(y)$ for an element $y \in K(X)$.
For two oriented manifolds $M$ and $N$ of same dimension $d$, we denote by $M \# N$ the connected sum of $M$ with $N$ which inherits an orientation from $M$ and $N$. First, let us characterise the stable tangent bundle of $M \# N$ by

Lemma 2.1. Let $p_{M}: M \# N \rightarrow M$ and $p_{N}: M \# N \rightarrow N$ be collapsing maps to each factor of $M \# N$. Then we have

$$
p_{M}^{*}(M) \oplus p_{N}^{*}(N) \cong T(M \# N) \oplus \varepsilon^{d} .
$$

Proof. Let $D_{M} \subset M$ and $D_{N} \subset N$ be embedded closed disks and $W_{M}$ and $W_{N}$ collar neighborhoods of $\partial\left(M \backslash \stackrel{\circ}{D}_{M}\right)$ and $\partial\left(N \backslash \dot{D}_{N}\right)$ respectively, where $D$ denotes the interior of $D$. Thus $W_{M} \cong S^{d-1} \times[-2,0]$ and $W_{N} \cong S^{d-1} \times[0,2]$. The manifold $M \# N$ is obtained by identifying $S^{d-1} \times 0 \subset W_{M}$ with $S^{d-1} \times 0 \subset W_{N}$ by the identity map. Set $W:=W_{M} \cup W_{N} \subset M \# N$ and note that $V_{1}:=p_{M}^{*}(M) \oplus p_{N}^{*}(N)$ as well as $V_{2}:=T(M \# N) \oplus \varepsilon^{n}$ are trivial over $W$. Moreover let $U_{M} \subset M \# N$ be the open set diffeomorphic to $\left(M \backslash W_{M}\right) \cup\left(S^{d-1} \times[-2,-1[)\right.$ and analogous for $U_{N} \subset M \# N$.

Now, since $\left.V_{1}\right|_{U_{M}} \cong p_{M}^{*}(T M) \oplus \varepsilon^{d}$ and $\left.p_{M}^{*}(T M)\right|_{U_{M}}=\left.T(M \# N)\right|_{U_{M}}$ we have an isomorphism given by $\Phi_{M}:\left.\left.V_{2}\right|_{U_{M}} \rightarrow V_{1}\right|_{U_{M}},(\xi, w) \mapsto\left(\left(p_{M}\right)_{*}(\xi), w\right)$. For $\Phi_{N}:\left.\left.V_{2}\right|_{U_{N}} \rightarrow V_{1}\right|_{U_{N}}$, we set $\Phi_{N}(\eta, w)=\left(w,-\left(p_{N}\right)_{*}(\eta)\right)$. Moreover both vector bundles $V_{1}$ and $V_{2}$ are trivial over $W$ and it is possible to choose trivializations of $V_{1}$ and $V_{2}$ over $W$ such that $\Phi_{M}$ is given by $(v, w) \mapsto(v, w)$ over $W_{M}$ and such that $\Phi_{N}$ is represented by $(v, w) \mapsto(w,-v)$ over $W_{N}$. Over $S^{d-1} \times[-1,1]$ we can interpolate these isomorphisms by

$$
\binom{v}{w} \mapsto\left(\begin{array}{cc}
\cos \left(\frac{\pi}{4}(t+1)\right) & \sin \left(\frac{\pi}{4}(t+1)\right) \\
-\sin \left(\frac{\pi}{4}(t+1)\right) & \cos \left(\frac{\pi}{4}(t+1)\right)
\end{array}\right)\binom{v}{w}
$$

for $t \in[-1,1]$. Using this interpolation we can glue $\Phi_{M}$ and $\Phi_{N}$ to a global isomorphism $V_{2} \rightarrow V_{1}$.

Hence $T(M \# N)-d=T M+T N-2 d$ in $\widetilde{K O}(M \# N)$, where $T M$ and $T N$ denote the elements in $\widetilde{K O}(M \# N)$ induced by $p_{M}^{*}(T M)$ and $p_{N}^{*}(T N)$ respectively. This shows that if $M$ and $N$ admit stable almost complex structures so does $M \# N$ (cf. [5]). For $M=N=\mathbb{C P}{ }^{2 n}$ we consider the natural orientation induced by the complex structure of $\mathbb{C P}^{2 n}$.

We proceed with recalling some basic facts on complex projective spaces. Let $H$ be the tautological line bundle over $\mathbb{C P}^{d}$ and let $x \in H^{2}\left(\mathbb{C P}^{d} ; \mathbb{Z}\right)$ be the generator, such that the total Chern class $c(H)$ is given by $1+x$. The cohomology ring of $\mathbb{C} \mathbb{P}^{d}$ is isomorphic to $\mathbb{Z}[x] /\left\langle x^{d+1}\right\rangle$. The $K$ and $K O$ theory of $\mathbb{C P}^{d}$ are completely understood. Let $\eta:=H-1 \in \widetilde{K}\left(\mathbb{C P}^{d}\right)$ and $\eta_{R}:=r(\eta) \in \widetilde{K O}\left(\mathbb{C P}^{d}\right)$. Then we have

Theorem 2.2 (cf. [11, Theorem 3.9], [2, Lemma 3.5], [8, p. 170] and [13, Proposition 4.3]).
(a) $K\left(\mathbb{C P}^{d}\right)=\mathbb{Z}[\eta] /\left\langle\eta^{d+1}\right\rangle$. The following sets of elements are an integral basis of $K\left(\mathbb{C P}^{d}\right)$
(i) $1, \eta, \eta(\eta+\bar{\eta}), \ldots, \eta(\eta+\bar{\eta})^{n-1},(\eta+\bar{\eta}), \ldots,(\eta+\bar{\eta})^{n}$, and also, in case $d$ is odd, $\eta^{2 n+1}=\eta(\eta+\bar{\eta})^{n}$.
(ii) $1, \eta, \eta(\eta+\bar{\eta}), \ldots, \eta(\eta+\bar{\eta})^{n-1},(\eta-\bar{\eta})(\eta+\bar{\eta}), \ldots,(\eta-\bar{\eta})(\eta+\bar{\eta})^{n-1}$, and also, in case $d$ is odd, $\eta^{2 n+1}$
where $n$ is the largest integer $\leq d / 2$.
(b) (i) if $d=2 n$ then $K O\left(\mathbb{C P}^{d}\right)=\mathbb{Z}\left[\eta_{R}\right] /\left\langle\eta_{R}^{n+1}\right\rangle$
(ii) if $d=4 n+1$ then $K O\left(\mathbb{C P}^{d}\right)=\mathbb{Z}\left[\eta_{R}\right] /\left\langle\eta_{R}^{2 n+1}, 2 \eta_{R}^{2 n+2}\right\rangle$
(iii) if $d=4 n+3$ then $K O\left(\mathbb{C P}^{d}\right)=\mathbb{Z}\left[\eta_{R}\right] /\left\langle\eta_{R}^{2 n+2}\right\rangle$.
(c) The complex stable tangent bundle is given by $(2 n+1) \bar{\eta} \in \tilde{K}\left(\mathbb{C P}^{2 n}\right)$ and the real stable tangent bundle is given by $r((2 n+1) \bar{\eta})) \in \widetilde{K O}\left(\mathbb{C P}^{2 n}\right)$.
(d) The kernel of the real reduction map $r: \widetilde{K}\left(\mathbb{C P}^{d}\right) \rightarrow \widetilde{K O}\left(\mathbb{C P}^{d}\right)$ is freely generated by the elements
(i) $\eta-\bar{\eta},(\eta-\bar{\eta})(\eta+\bar{\eta}), \ldots,(\eta-\bar{\eta})(\eta+\bar{\eta})^{\frac{d}{2}-1}$, if $d$ is even,
(ii) $\eta-\bar{\eta},(\eta-\bar{\eta})(\eta+\bar{\eta}), \ldots,(\eta-\bar{\eta})(\eta+\bar{\eta})^{2 n-1}, 2 \eta^{d}$, if $d=4 n+1$,
(iii) $\eta-\bar{\eta},(\eta-\bar{\eta})(\eta+\bar{\eta}), \ldots,(\eta-\bar{\eta})(\eta+\bar{\eta})^{2 n}, \eta^{d}$, if $d=4 n+3$.

Next we would like to describe the integer cohomology ring of $m \# \mathbb{C P}^{2 n}$. For that we introduce the following notation: Let $\Lambda$ denote either $\mathbb{Z}$ or $\mathbb{Q}$. We define an ideal $R_{d}\left(X_{1}, \ldots, X_{m}\right)$ in $\Lambda\left[X_{1}, \ldots, X_{m}\right]$, where $X_{1}, \ldots, X_{m}$ are indeterminants, as the ideal generated by the following elements

$$
\begin{aligned}
X_{i} \cdot X_{j}, & i \neq j \\
X_{i}^{d}-X_{j}^{d}, & i \neq j \\
X_{j}^{d+1}, & j=1, \ldots, m
\end{aligned}
$$

Hence we have

$$
\begin{equation*}
H^{*}\left(m \# \mathbb{C P}^{d} ; \Lambda\right) \cong \Lambda\left[x_{1}, \ldots, x_{m}\right] / R_{d}\left(x_{1}, \ldots, x_{m}\right) \tag{1}
\end{equation*}
$$

where $x_{j}=p_{j}^{*}(x) \in H^{2}\left(m \# \mathbb{C P}^{d} ; \Lambda\right)$, for $x \in H^{2}\left(\mathbb{C P}^{d} ; \Lambda\right)$ defined as above and $p_{j}: m \# \mathbb{C P}^{d} \rightarrow$ $\mathbb{C P}^{d}$ the projection onto the $j$-th factor. Note that $p_{j}$ induces an monomorphism on cohomology. The stable tangent bundle of $m \# \mathbb{C P}^{2 n}$ in $\widetilde{K O}\left(m \# \mathbb{C P}^{2 n}\right)$ is represented by

$$
(2 n+1) \sum_{j=1}^{m} r\left(\bar{\eta}_{j}\right)
$$

where $\eta_{j}:=p_{j}^{*}(\eta) \in \widetilde{K}\left(\mathbb{C P}^{2 n}\right)$ and $r: \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \rightarrow \widetilde{K O}\left(m \# \mathbb{C P}^{2 n}\right)$ is the real reduction map. Hence the set of stable almost complex structures on $m \# \mathbb{C P}^{2 n}$ is given by

$$
\begin{equation*}
(2 n+1) \sum_{j=1}^{m} \bar{\eta}_{j}+\operatorname{ker} r \tag{2}
\end{equation*}
$$

For $k \in \mathbb{N}$ and $j=1, \ldots, m$, set $w_{j}^{k}=p_{j}^{*}(H)^{k}-p_{j}^{*}(H)^{-k}, e_{j}^{n-1}=\eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right)^{n-1}$ and $\omega=\eta_{1}^{2 n}$.
Proposition 2.3. The kernel of $r: \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \rightarrow \widetilde{K O}\left(m \# \mathbb{C P}^{2 n}\right)$ is freely generated by
(a) $\left\{w_{j}^{k}: k=1, \ldots, n-1, j=1, \ldots, m\right\} \cup\left\{e_{1}^{n-1}-e_{j}^{n-1}: j=2, \ldots, m\right\} \cup\left\{2 e_{1}^{n-1}-\omega\right\}$, for $n$ even,
(b) $\left\{w_{j}^{k}: k=1, \ldots, n, j=1, \ldots, m\right\}$, for $n$ odd.

Proof. Consider the cofiber sequence

$$
\begin{equation*}
\bigvee_{j=1}^{m} \mathbb{C P}^{2 n-1} \xrightarrow{i} m \# \mathbb{C P}^{2 n} \xrightarrow{\pi} S^{4 n} \tag{3}
\end{equation*}
$$

Note that the line bundle $i^{*} p_{j}^{*}(H)$ is the tautological line bundle over the $j$-th summand of $\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}$ and the trivial bundle on the other summands, since the first Chern classes are the same. For the reduced groups we have

$$
\widetilde{K}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right) \cong \bigoplus_{j=1}^{m} \widetilde{K}\left(\mathbb{C P}^{2 n-1}\right)
$$

and $i^{*} p_{j}^{*}(\eta)$ generates the $j$-th summand of the above sum according to Theorem 2.2. The long exact sequence in $K$-theory of the cofibration (3) is given by

$$
\begin{equation*}
\cdots \rightarrow \widetilde{K}^{-1}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right) \rightarrow \widetilde{K}\left(S^{4 n}\right) \rightarrow \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \rightarrow \widetilde{K}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right) \rightarrow \widetilde{K}^{1}\left(S^{4 n}\right) \rightarrow \cdots \tag{4}
\end{equation*}
$$

From Theorem 2 in [3] we have $\widetilde{K}^{-1}\left(\mathbb{C P}^{2 n-1}\right)=0$, hence $\widetilde{K}^{-1}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right)=0$ and from Bott periodicity we deduce $\widetilde{K}^{1}\left(S^{4 n}\right)=\widetilde{K}^{-1}\left(S^{4 n}\right)=0$. So we obtain a short exact sequence

$$
0 \longrightarrow \widetilde{K}\left(S^{4 n}\right) \xrightarrow{\pi^{*}} \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \xrightarrow{i^{*}} \widetilde{K}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right) \longrightarrow 0
$$

which splits, since the involving groups are finitely generated, torsion free abelian groups. Let $\omega_{\mathbb{C}}$ be the generator of $\widetilde{K}\left(S^{4 n}\right)$, then the set

$$
\left\{\pi^{*}\left(\omega_{\mathbb{C}}\right)\right\} \cup\left\{\eta_{j}^{k}: j=1, \ldots, m, k=1, \ldots, 2 n-1\right\}
$$

is an integral basis of $\widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)$. We claim that $\eta_{j}^{2 n}=\pi^{*}\left(\omega_{\mathbb{C}}\right)$ for all $j$. Indeed, the elements $\eta_{j}^{2 n}$ lie in the kernel of $i^{*}$, hence there are $k_{j} \in \mathbb{Z}$ such that $\eta_{j}^{2 n}=k_{j} \cdot \pi^{*}\left(\omega_{\mathbb{C}}\right)$.

Let $\widetilde{c h}: \widetilde{K}(X) \rightarrow \widetilde{H}(X ; \mathbb{Q})$ denote the Chern character for a finite CW complex $X$, then $\widetilde{c h}$ is a monomorphism for $X=m \# \mathbb{C} \mathbb{P}^{d}$ (since $\tilde{H}^{*}\left(m \# \mathbb{C} \mathbb{P}^{d} ; \mathbb{Z}\right)$ has no torsion, cf. 7]) and an isomorphism for $X=S^{d}$ onto $\widetilde{H}^{*}\left(S^{d} ; \mathbb{Z}\right)$ embedded in $\widetilde{H}^{*}\left(S^{d} ; \mathbb{Q}\right)$. Using the notation of (1) we have

$$
\widetilde{c h}\left(\eta_{j}^{2 n}\right)=\left(e^{x_{j}}-1\right)^{2 n}=x_{j}^{2 n}
$$

and using the naturality of $\widetilde{c h}$

$$
\widetilde{c h}\left(\pi^{*}\left(\omega_{\mathbb{C}}\right)\right)=\pi^{*}\left(\widetilde{c h}\left(\omega_{\mathbb{C}}\right)\right)= \pm x_{j}^{2 n}
$$

since $\pi^{*}$ is an isomorphism on cohomology in dimension $2 n$. We can choose $\omega_{\mathbb{C}}$ such that $\widetilde{c h}\left(\pi^{*}\left(\omega_{\mathbb{C}}\right)\right)=x_{j}^{2 n}$. This shows $k_{j}=1$ for all $j$ and $\widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)$ is freely generated by

$$
\left\{\eta_{j}^{k}: j=1, \ldots, m, k=1, \ldots, 2 n-1\right\} \cup\left\{\eta_{1}^{2 n}=\cdots=\eta_{m}^{2 n}\right\} .
$$

Hence $K\left(m \# \mathbb{C P}^{2 n}\right)=\mathbb{Z}\left[\eta_{1}, \ldots, \eta_{m}\right] / R_{2 n}\left(\eta_{1}, \ldots, \eta_{m}\right)$. Since $p_{j}^{*}(H) \otimes p_{j}^{*}(\bar{H})$ is the trivial bundle we compute the identity

$$
\bar{\eta}_{j}=\frac{-\eta_{j}}{1+\eta_{j}}=-\eta_{j}+\eta_{j}^{2}-\cdots+\eta_{j}^{2 n} .
$$

The ring $\mathbb{Z}\left[\eta_{1}, \ldots, \eta_{m}\right] / R_{2 n}\left(\eta_{1}, \ldots, \eta_{m}\right)$ is isomorphic to

$$
\left(\bigoplus_{j=1}^{m} \mathbb{Z}\left[\eta_{j}\right] /\left\langle\eta_{j}^{2 n+1}\right\rangle\right) /\left\langle\eta_{j}^{2 n}-\eta_{i}^{2 n}: j \neq i\right\rangle
$$

and from Theorem [2.2 the set $\Gamma_{j}$ which contains the elements

$$
\begin{aligned}
& \eta_{j}, \eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right), \ldots, \eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right)^{n-1} \\
& \eta_{j}-\bar{\eta}_{j},\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right), \ldots,\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right)^{n-1}
\end{aligned}
$$

together with $\{1\}$ is an integral basis of $\mathbb{Z}\left[\eta_{j}\right] /\left\langle\eta_{j}^{2 n+1}\right\rangle$. Thus the set $\Gamma_{1} \cup \ldots \cup \Gamma_{m} \subset \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)$ generates the group $\widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)$. Observe that

$$
\begin{equation*}
\left(\eta_{j}+\bar{\eta}_{j}\right)^{k}=2 \eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right)^{k-1}-\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right)^{k-1}, \tag{5}
\end{equation*}
$$

thus

$$
\begin{equation*}
\eta_{j}^{2 n}=\left(\eta_{j}+\bar{\eta}_{j}\right)^{n}=2 \eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right)^{n-1}-\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right)^{n-1} . \tag{6}
\end{equation*}
$$

We set $\omega:=\eta_{j}^{2 n}$ for any $j=1, \ldots, m$ and

$$
\begin{aligned}
e_{j}^{k} & :=\eta_{j}\left(\eta_{j}+\bar{\eta}_{j}\right)^{k}, \quad j=1, \ldots, m, \quad k=0, \ldots, n-1 \\
f_{j}^{k} & :=\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right)^{k}, \quad j=1, \ldots, m, \quad k=0, \ldots, n-1
\end{aligned}
$$

and in virtue of relation (6) the set

$$
B:=\{\omega\} \cup\left\{e_{j}^{k}: j=1, \ldots, m, k=0, \ldots, n-1\right\} \cup\left\{f_{j}^{k}: j=1, \ldots, m, k=0, \ldots, n-2\right\}
$$

is an integral basis of $\widetilde{K}\left(m \# \mathbb{C} \mathbb{P}^{2 n}\right)$.
We proceed with the computation of $K O\left(m \# \mathbb{C P}^{2 n}\right)$. We have a long exact sequence for $\widetilde{K O}$-theory like in (4). From Theorem 2 in [3] we deduce $\widetilde{K O}^{-1}\left(\mathbb{C P}^{2 n}\right)=0$ and therefore
$\widetilde{K O}^{-1}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n}\right)=0$. Moreover $\widetilde{K O}^{1}\left(S^{4 n}\right)=\widetilde{K O}^{-7}\left(S^{4 n}\right)=\widetilde{K O}\left(S^{4 n+7}\right)=0$ by Bott periodicity. Hence we obtain a short exact sequence

$$
\begin{equation*}
0 \longrightarrow \widetilde{K O}\left(S^{4 n}\right) \longrightarrow \widetilde{K O}\left(m \# \mathbb{C} \mathbb{P}^{2 n}\right) \longrightarrow \widetilde{K O}\left(\vee_{j=1}^{m} \mathbb{C P}^{2 n-1}\right) \longrightarrow 0 \tag{7}
\end{equation*}
$$

Now we have to distinguish between the cases where $n$ is even or odd. We first assume that $n=$ 2l. In that case the ring $K O\left(\mathbb{C P}^{2 n-1}\right)$ is isomorphic to $\mathbb{Z}\left[\eta_{R}\right] /\left\langle\eta_{R}^{n}\right\rangle$, see Theorem 2.2 (b). Hence all groups in (7) are torsion free. Therefore the kernel of $r: \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \rightarrow \widetilde{K O}\left(m \# \mathbb{C P}^{2 n}\right)$ is the same as the kernel of

$$
\varphi:=c \circ r=1+t: \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right) \rightarrow \widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)
$$

since $r \circ c=2$ and thus $c$ is a monomorphism of the torsion free part of $\widetilde{K O}\left(m \# \mathbb{C P}^{2 n}\right)$.
Next we compute a basis of ker $\varphi$. Using relation (5) we have $\varphi(\omega)=2 \omega, \varphi\left(e_{j}^{k}\right)=2 e_{j}^{k}-f_{j}^{k}$ and $\varphi\left(f_{j}^{k}\right)=0$, thus if

$$
y=\lambda \omega+\sum_{j=1}^{m} \sum_{k=0}^{n-1} \lambda_{j}^{k} e_{j}^{k}
$$

then

$$
\varphi(y)=2 \lambda \omega+\sum_{j=1}^{m} \sum_{k=0}^{n-1} \lambda_{j}^{k}\left(2 e_{j}^{k}-f_{j}^{k}\right)=\left(2 \lambda+\sum_{j=1}^{m} \lambda_{j}^{n-1}\right) \omega+\sum_{j=1}^{m} \sum_{k=0}^{n-2} \lambda_{j}^{k}\left(2 e_{j}^{k}-f_{j}^{k}\right)
$$

where we used that $f_{j}^{n-1}=2 e_{j}^{n-1}-\omega$ by Equation (6). As $\omega$ and $2 e_{j}^{k}-f_{j}^{k}, j=1, \ldots, m$, $k=0, \ldots, n-2$, are linearly independent, we conclude that $\varphi(y)=0$ if and only if $\lambda_{j}^{k}=0$ for $j=1, \ldots, m, k=1, \ldots, n-2$ and

$$
\sum_{j=1}^{m} \lambda_{j}^{n-1}+2 \lambda=0
$$

This implies that the set

$$
\left\{f_{j}^{k}: j=1, \ldots, m, \quad k=0, \ldots, n-2\right\} \cup\left\{e_{1}^{n-1}-e_{j}^{n-1}: j=2, \ldots, m\right\} \cup\left\{2 e_{1}^{n-1}-\omega\right\}
$$

is an integral basis of $\operatorname{ker} \varphi$. Note that from (6) we have $2 e_{1}^{n-1}-\omega=\left(\eta_{1}-\bar{\eta}_{1}\right)\left(\eta_{1}+\bar{\eta}_{1}\right)^{n-1}$. By an inductive argument we see that

$$
\begin{equation*}
\left(\eta_{j}-\bar{\eta}_{j}\right)\left(\eta_{j}+\bar{\eta}_{j}\right)^{k}=w_{j}^{k+1}+\text { linear combinations of } w_{j}^{1}, \ldots, w_{j}^{k} \tag{8}
\end{equation*}
$$

and

$$
e_{1}^{n-1}-e_{j}^{n-1}=\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}
$$

Thus an integral basis of the kernel, in case $n$ is even, is given by

$$
\left\{w_{j}^{k}: j=1, \ldots, m, k=1, \ldots, n-1\right\} \cup\left\{w_{1}^{n}\right\} \cup\left\{\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}: j=2, \ldots, m\right\}
$$

Now let us assume that $n=2 l+1$. Consider the commutative diagram


The map $r_{S}: \widetilde{K}\left(S^{8 l+4}\right) \rightarrow \widetilde{K O}\left(S^{8 l+4}\right)$ is an isomorphism and therefore $\left.i^{*}\right|_{\text {ker } r_{\#}}: \operatorname{ker} r_{\#} \rightarrow$ ker $r_{\vee}$ is an isomorphism, hence the rank of $\operatorname{ker} r_{\#}$ is $m n$. We see that the set

$$
\left\{f_{j}^{k}: j=1, \ldots, m, k=0, \ldots, n-2\right\} \cup\left\{2 e_{j}^{n-1}: j=1, \ldots, m\right\} \cup\{\omega\}
$$

is an integral basis of $\left(i^{*}\right)^{-1}\left(\operatorname{ker} r_{\vee}\right)$, which follows because $e_{j}^{n-1}=\eta_{j}^{2 n-1}-(n-1) \omega$ and the structure of the kernel of $r_{\vee}$, see Theorem [2.2 (d) (ii). The elements $f_{j}^{k}$ for $j=1, \ldots, m$ and $k=0, \ldots, n-2$ lie in the kernel of $r_{\#}$. Let

$$
y=\lambda \omega+\sum_{j=1}^{m} \lambda_{j}^{n-1} 2 e_{j}^{n-1}
$$

for $\lambda, \lambda_{j}^{n-1} \in \mathbb{Z}$ and suppose $r_{\#}(y)=0$. From $\varphi(\omega)=2 \omega$ and $\varphi\left(e_{j}^{n-1}\right)=\left(\eta_{j}+\bar{\eta}_{j}\right)^{n}=\eta_{j}^{2 n}=\omega$ it follows that

$$
\lambda+\sum_{j=1}^{m} \lambda_{j}^{n-1}=0 .
$$

Hence ker $r_{\#}$ is freely generated by the elements $f_{j}^{k}$ and $2 e_{j}^{n-1}-\omega$. Observe from (6) that $2 e_{j}^{n-1}-\omega=(\eta-\bar{\eta})(\eta+\bar{\eta})^{n-1}$. Thus in case of $n$ odd we deduce like in (8) that the kernel of $r_{\#}$ is freely generated by $w_{j}^{k}$ for $j=1, \ldots, m$ and $k=1, \ldots, n$.

Hence by Equation (2), stable almost complex structures of $m \# \mathbb{C P}^{2 n}$ for $n$ even are given by elements of the form

$$
\begin{equation*}
y=(2 n+1) \sum_{i=1}^{m} \bar{\eta}_{j}+\sum_{j=1}^{m} \sum_{k=1}^{n-1} a_{j}^{k} w_{j}^{k}+a_{1}^{n} w_{1}^{n}+\sum_{j=2}^{m} b_{j}\left(\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}\right) . \tag{9}
\end{equation*}
$$

and for $n$ odd

$$
\begin{equation*}
y=(2 n+1) \sum_{i=1}^{m} \bar{\eta}_{j}+\sum_{j=1}^{m} \sum_{k=1}^{n} a_{j}^{k} w_{j}^{k} \tag{10}
\end{equation*}
$$

for $a_{j}^{k}, b_{j} \in \mathbb{Z}$. For Theorem 1.2 we have to compute the $2 n$-th Chern class $c_{2 n}(E)$ of a vector bundle $E$ representing an element of the form (19) and (10). Let $\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}$ denote also a vector bundle over $m \# \mathbb{C P}^{2 n}$ which represents the element $\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}$ in $\widetilde{K}\left(m \# \mathbb{C P}^{2 n}\right)$. The total Chern class of $\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}$ can be computed through the Chern character: We have

$$
\widetilde{c h}\left(\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}\right)=\widetilde{c h}\left(\eta_{1}\right)^{2 n-1}-\widetilde{c h}\left(\eta_{j}\right)^{2 n-1}=x_{1}^{2 n-1}-x_{j}^{2 n-1} .
$$

The elements of degree $k$ in the Chern character are given by $\nu_{k}\left(c_{1}, \ldots, c_{k}\right) / k$ ! where $\nu_{k}$ are the Newton polynomials. The coefficient in front of $c_{k}$ in $\nu_{k}\left(c_{1}, \ldots, c_{k}\right)$ is $k$ (see 9], p. 195) and the other terms are products of Chern classes of lower degree, hence the only non vanishing Chern class is given by

$$
c_{2 n-1}\left(\eta_{1}^{2 n-1}-\eta_{j}^{2 n-1}\right)=(2 n-2)!\left(x_{1}^{2 n-1}-x_{j}^{2 n-1}\right)
$$

Thus the total Chern class of a vector bundle $E$ representing an element of the form (9) is given by

$$
\begin{aligned}
c(E)= & \left(1-\left(x_{1}+\ldots+x_{m}\right)\right)^{2 n+1} \\
& \cdot\left(\frac{1+n x_{1}}{1-n x_{1}}\right)^{a_{1}^{n}} \prod_{j=2}^{m}\left(1+(2 n-2)!\left(x_{1}^{2 n-1}-x_{j}^{2 n-1}\right)\right)^{b_{j}} \prod_{j=1}^{m} \prod_{k=1}^{n-1}\left(\frac{1+k x_{j}}{1-k x_{j}}\right)^{a_{j}^{k}}
\end{aligned}
$$

and for (10)

$$
c(E)=\left(1-\left(x_{1}+\ldots+x_{m}\right)\right)^{2 n+1} \prod_{j=1}^{m} \prod_{k=1}^{n}\left(\frac{1+k x_{j}}{1-k x_{j}}\right)^{a_{j}^{k}}
$$

where the coefficient in front of $x_{1}^{2 n}=\ldots=x_{m}^{2 n}$ is equal to $c_{2 n}(E)$.
Remark 2.4. Note that for $m=1$ (and complex projective spaces of arbitrary dimension) this total Chern class was already computed by Thomas, see [13, p. 130].

## 3 Almost complex structures on $m \# \mathbb{C P}^{2 n}$

We now describe an explicit stable almost complex structure on $m \# \mathbb{C P}^{2 n}$, where $m=2 u+1$, for which the assumptions of Theorem 1.2 are satisfied, thereby producing an almost complex structure on $m \# \mathbb{C P}^{2 n}$. We choose, in the notation of (9) and (10), $a_{j}^{k}=2$ for $j=1, \ldots, u$ and $k=1$, and all other coefficients 0 . Then the top Chern class is as desired:

Proposition 3.1. Let $m=2 u+1$ be an odd number. In the cohomology ring of $m \# \mathbb{C P}^{2 n}$, the coefficient $c_{2 n}$ of $x_{1}^{2 n}=\cdots=x_{m}^{2 n}$ of the class

$$
c=\left(1-\left(x_{1}+\cdots+x_{2 u+1}\right)\right)^{2 n+1} \prod_{r=1}^{u}\left(\frac{1+x_{r}}{1-x_{r}}\right)^{2}
$$

is

$$
c_{2 n}=m(2 n-1)+2=\chi\left(m \# \mathbb{C P}^{2 n}\right)
$$

Proof. As $x_{i} \cdot x_{j}=0$ for $i \neq j$, we have

$$
\begin{aligned}
\left(1-\left(x_{1}+\cdots+x_{2 u+1}\right)\right)^{2 n+1} & =\sum_{j_{0}=0}^{2 n+1}(-1)^{j_{0}}\binom{2 n+1}{j_{0}}\left(x_{1}^{j_{0}}+\cdots+x_{2 u+1}^{j_{0}}\right) \\
& =\sum_{r=1}^{2 u+1} \sum_{j_{0}=0}^{2 n+1}(-1)^{j_{0}}\binom{2 n+1}{j_{0}} x_{r}^{j_{0}}
\end{aligned}
$$

Thus,

$$
c=\prod_{r=1}^{u}\left(1-x_{r}\right)^{2 n-1}\left(1+x_{r}\right)^{2} \prod_{s=u+1}^{2 u+1}\left(1-x_{s}\right)^{2 n+1}
$$

The factors $\left(1-x_{s}\right)^{2 n+1}$ contribute $2 n+1$ to $c_{2 n}$, whereas the factors $\left(1-x_{r}\right)^{2 n-1}\left(1+x_{r}\right)^{2}$ contribute $2 n-3$. Thus,

$$
c_{2 n}=u(2 n-3)+(u+1)(2 n+1)=(2 u+1)(2 n-1)+2=\chi\left((2 u+1) \# \mathbb{C P}^{2 n}\right)
$$
