DEPTH AND STANLEY DEPTH OF THE EDGE IDEALS OF THE POWERS OF PATHS AND CYCLES

ABSTRACT. Let k be a positive integer. We compute depth and Stanley depth of the quotient ring of the edge ideal associated to the k^{th} power of a path on n vertices. We show that both depth and Stanley depth have the same values and can be given in terms of k and n. For $n \ge 2k + 1$, let $n \equiv 0, k + 1, k + 2, \ldots, n - 1(\text{mod}(2k + 1))$. Then we give values of depth and Stanley depth of the quotient ring of the edge ideal associated to the k^{th} power of a cycle on n vertices and tight bounds otherwise, in terms of n and k. We also compute lower bounds for the Stanley depth of the edge ideals associated to the k^{th} power of a path and a cycle and prove a conjecture of Herzog presented in [7] for these ideals.

1. INTRODUCTION

Let K be a field and $S := K[x_1, \ldots, x_n]$ the polynomial ring over K. Let M be a finitely generated \mathbb{Z}^n -graded S-module. A Stanley decomposition of M is a presentation of K-vector space M as a finite direct sum

$$\mathcal{D}: M = \bigoplus_{i=1}^{s} v_i K[W_i],$$

where $v_i \in M$, $W_i \in \{x_1, \ldots, x_n\}$ such that $v_i K[W_i]$ denotes the K-subspace of M, which is generated by all elements $v_i w$, where w is a monomial in $K[W_i]$. The \mathbb{Z}^n -graded K-subspace $v_i K[W_i] \subset M$ is called a Stanley space of dimension $|W_i|$, if $v_i K[W_i]$ is a free $K[W_i]$ -module, where $|W_i|$ denotes the cardinality of W_i . Define

$$\operatorname{sdepth}(\mathcal{D}) = \min\{|W_i| : i = 1, \dots, s\},\$$

and

 $sdepth(M) = max{sdepth(\mathcal{D}) : \mathcal{D} is a Stanley decomposition of M}.$

The number $\operatorname{sdepth}(\mathcal{D})$ is called the Stanley depth of decomposition \mathcal{D} and $\operatorname{sdepth}(M)$ is called the Stanley depth of M. Stanley conjectured in [22] that $\operatorname{sdepth}(M) \ge \operatorname{depth}(M)$ for any \mathbb{Z}^n graded S-module M. This conjecture was disproved by Duval et al. in [6] as was expected due to different natures of both the invariants. However, the relation between Stanley depth and some other invariants has already been established see [9, 10, 19, 24]. In [9], Herzog, Vladoiu and Zheng proved that the Stanley depth of M can be computed in a finite number of steps, if M = J/I, where $I \subset J \subset S$ are monomial ideals. But practically it is too hard to compute Stanley depth by using this method see for instance, [1, 3, 13, 14]. For computing Stanley depth for some classes of modules we refer the reader to [12, 18, 20, 21]. In this paper we attempt to find values and reasonable bounds for depth and Stanley depth of I and S/I, where I is the edge ideal of a power of a path or a cycle. We also compare the values of $\operatorname{sdepth}(I)$ and $\operatorname{sdepth}(S/I)$ and give positive answers to the following conjecture of Herzog.

Conjecture 1.1. [7] Let $I \subset S$ be a monomial ideal then

$$\operatorname{sdepth}(I) \ge \operatorname{sdepth}(S/I).$$

The above conjecture has been proved in some special cases see [11, 14, 18, 21]. The paper is organized as follows: First two sections are devoted to introduction, definitions, notations, and discussion of some known results. In third section, we compute depth and Stanley depth of $S/I(P_n^k)$ as Theorems (3.7 and 3.11), where $I(P_n^k)$ denotes the edge ideal of the k^{th} power of a path P_n on n vertices. These theorems prove that

$$\operatorname{depth}(S/I(P_n^k)) = \operatorname{sdepth}(S/I(P_n^k)) = \lceil \frac{n}{2k+1} \rceil.$$

Let $I(C_n^k)$ be the edge ideal of the k^{th} power of a cycle C_n on n vertices. In fourth section we give some lower bounds for depth and Stanley depth of $S/I(C_n^k)$ as Theorems (4.4 and 4.6). For $n \ge 2k + 1$, our Corollaries (4.5 and 4.7) show that

$$depth(S/I(C_n^k)) = sdepth(S/I(C_n^k)) = \lceil \frac{n}{2k+1} \rceil, \text{ if } n \equiv 0, k+1, \dots, n-1(\text{mod}(2k+1));$$
$$\lceil \frac{n}{2k+1} \rceil - 1 \leq depth(S/I(C_n^k)), sdepth(S/I(C_n^k)) \leq \lceil \frac{n}{2k+1} \rceil, \text{ if } n \equiv 1, 2, \dots, k(\text{mod}(2k+1)).$$

Last section is devoted to Conjecture 1.1 for $I(P_n^k)$ and $I(C_n^k)$. By our Theorem 5.2 we have

$$\operatorname{sdepth}(I(P_n^k)) \ge \lceil \frac{n}{2k+1} \rceil + 1,$$

which shows that $I(P_n^k)$ satisfies Conjecture 1.1. Let $n \ge 2k + 1$, Proposition 5.3 gives a lower bound for $I(C_n^k)/I(P_n^k)$ that is

$$\operatorname{sdepth}(I(C_n^k)/I(P_n^k)) \ge \lceil \frac{n+k+1}{2k+1} \rceil.$$

Corollary 5.5 of this paper proves that $I(C_n^k)$ satisfies Conjecture 1.1. The above results are proved in [11] when k = 2.

2. Definitions and notation

Throughout this paper, \mathfrak{m} denotes the unique maximal graded ideal (x_1, x_2, \ldots, x_n) of S. We set $S_m := K[x_1, x_2, \ldots, x_m]$, $\operatorname{supp}(v) := \{i : x_i | v\}$ and $\operatorname{supp}(I) := \{i : x_i | u, \text{ for some } u \in \mathcal{G}(I)\}$, where $\mathcal{G}(I)$ denotes the unique minimal set of monomial generators of the monomial ideal I. Let $I \subset S$ be an ideal then we write I instead of IS. Thus every ideal will be considered an ideal of S unless otherwise stated. Let I and J be monomial ideals of S, then for I + J we write (I, J).

Definition 2.1. Let G be a simple graph, for a positive integer k the k^{th} power of graph G is another graph G^k on the same set of vertices, such that two vertices are adjacent in G^k when their distance in G is at most k.

In the whole paper we label the vertices of the graph G by 1, 2, ..., n. We denote the set of vertices of G by $[n] := \{1, 2, ..., n\}$. We assume that all graphs and their powers are simple graphs. We also assume that all graphs have at least two vertices and a non-empty edge set.

Definition 2.2. Let G be a graph then the edge ideal I(G) associated to G is the square free monomial ideal of S that is

$$I(G) = (x_i x_j : \{i, j\} \in E(G)).$$

Definition 2.3. Let G be a graph, then G is called a path if $E(G) = \{\{i, i+1\} : i \in [n-1]\}$. A path on n vertices is usually denoted by P_n .

Definition 2.4. Let $n \ge 3$, a graph G is called a cycle if $E(G) = \{\{i, i+1\} : i \in [n-1]\} \cup \{1, n\}$. A cycle on n vertices is usually denoted by C_n .

Definition 2.5. For $n \ge 2$, the k^{th} power of a path, denoted by P_n^k , is a graph such that for all $1 \le i < j \le n$, $\{i, j\} \in E(P_n^k)$ if and only if $0 < j - i \le k$. That is the edge set of P_n^k is:

(1): If $n \le k+1$, then $E(P_n^k) = \{\{i, j\} : 1 \le i < j \le n\}.$

(2): If $n \ge k + 2$, then

$$E(P_n^k) = \bigcup_{i=1}^{n-k} \left\{ \{i, i+1\}, \{i, i+2\}, \dots, \{i, i+k\} \right\} \bigcup \bigcup_{j=n-k+1}^{n-1} \left\{ \{j, j+1\}, \{j, j+2\}, \dots, \{j, n\} \right\}.$$

Definition 2.6. For $n \ge 3$, the k^{th} power of a cycle, denoted by C_n^k , is a graph such that for all vertices $1 \le i, j \le n$, $\{i, j\} \in E(C_n^k)$ if and only if $|j-i| \le k$ or $|j-i| \ge n-k$. The edge set of C_n^k is:

(1): If $n \le 2k + 1$, then $E(C_n^k) = \{\{i, j\} : 1 \le i < j \le n\}$. (2): If $n \ge 2k + 2$, then

$$E(C_n^k) = E(P_n^k) \bigcup \bigcup_{l=1}^k \left\{ \{l, l+n-k\}, \{l, l+n-k+1\}, \{l, l+n-k+2\}, \dots, \{l, n\} \right\}.$$

The minimal generating set for the edge ideal of P_n^k is:

(1): If $n \leq k + 1$, then $\mathcal{G}(I(P_n^k)) = \{x_i x_j : 1 \leq i < j \leq n\}$. That is $I(P_n^k)$ is a square free Veronese ideal of degree 2 in variables x_1, x_2, \ldots, x_n .

(2): If $n \ge k + 2$, then

$$\mathcal{G}(I(P_n^k)) = \bigcup_{i=1}^{n-k} \{x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{i+k}\} \bigcup \bigcup_{j=n-k+1}^{n-1} \{x_j x_{j+1}, x_j x_{j+2}, \dots, x_j x_n\}.$$

The minimal generating set for the edge ideal of C_n^k is:

(1): If $n \leq 2k + 1$, then $\mathcal{G}(I(C_n^k)) = \{x_i x_j : 1 \leq i < j \leq n\}$. That is $I(C_n^k)$ is a square free Veronese ideal of degree 2 in variables x_1, x_2, \ldots, x_n .

(2): If $n \ge 2k + 2$, then

$$\mathcal{G}(I(C_n^k)) = \mathcal{G}(I(P_n^k)) \bigcup \bigcup_{l=1}^k \{x_l x_{l+n-k}, x_l x_{l+n-k+1}, \dots, x_l x_n\}.$$

Lemma 2.7. [15, Lemma 3] For $n \ge k+1$, $|\mathcal{G}(I(P_n^k))| = nk - \frac{k(k+1)}{2}$.

Remark 2.8. If $n \ge 2k+1$, then $|\mathcal{G}(I(C_n^k))| = nk$.

Definition 2.9. Let G be a graph and let $i \in [n]$, then we define

$$N_G(x_i) := \{x_j : x_i x_j \in \mathcal{G}(I(G))\}$$

where $j \in [n] \setminus \{i\}$.

Let $k \ge 2, 0 \le i \le k-1$ and $n \ge 2k+2$, then in the following we introduce some particular monomial prime ideals of S.

$$A_{n-k+i} := (x_{n-k}, x_{n-k+1}, \dots, x_{n-k+i}).$$

(We set $A_{n-k-1} = (0)$).

$$B_{n-k+i} := \left(N_{P_n^k}(x_{n-k+i}) \right) = (x_{n-2k+i}, x_{n-2k+i+1}, \dots, x_{n-k+i-1}, x_{n-k+i+1}, \dots, x_n).$$

and

$$D_{n-k+i} := \left(N_{C_n^k}(x_{n-k+i}) \right)$$

=
$$\begin{cases} (x_{n-2k}, x_{n-2k+1}, \dots, x_{n-k-1}, x_{n-k+1}, \dots, x_n), & \text{if } i = 0; \\ (x_{n-2k+i}, x_{n-2k+i+1}, \dots, x_{n-k+i-1}, x_{n-k+i+1}, \dots, x_n, x_1, x_2, \dots, x_i), & \text{if } 1 \le i \le k-1. \end{cases}$$

These monomial prime ideals and the following function play important role in the proof of our main theorems. Let $k \ge 2$, $0 \le i \le k-1$ and $2k+2 \le n \le 3k+1$, we define a function

$$f: \{n-k, n-k+1, \dots, n-k+i, \dots, n-1\} \longrightarrow \mathbb{Z}^+ \cup \{0\},$$
 by

$$f(n-k+i) = \begin{cases} k, & \text{if } n-2k-1+i \ge k+1; \\ n-2k-2+i, & \text{if } 2 \le n-2k-1+i < k+1. \end{cases}$$

In the following we recall some known results that we refer several times in this paper.

Lemma 2.10. (Depth Lemma) If $0 \longrightarrow U \longrightarrow M \longrightarrow N \longrightarrow 0$ is a short exact sequence of modules over a local ring S, or a Noetherian graded ring with S_0 local, then

- (1) depth $M \ge \min\{\operatorname{depth} N, \operatorname{depth} U\}.$
- (2) depth $U \ge \min\{\operatorname{depth} M, \operatorname{depth} N+1\}.$
- (3) depth $N \ge \min\{\operatorname{depth} U 1, \operatorname{depth} M\}.$

Lemma 2.11. [21] Let $0 \longrightarrow U \longrightarrow V \longrightarrow W \longrightarrow 0$ be a short exact sequence of \mathbb{Z}^n -graded S-modules. Then

 $sdepth(V) \ge min\{sdepth(U), sdepth(W)\}.$

Lemma 2.12. [11] Let $I \subset S$ be a squarefree monomial ideal with $\operatorname{supp}(I) = [n]$, let $v := x_{i_1}x_{i_2}\cdots x_{i_q} \in S/I$, such that $x_jv \in I$, for all $j \in [n] \setminus \operatorname{supp}(v)$. Then $\operatorname{sdepth}(S/I) \leq q$.

3. DEPTH AND STANLEY OF CYCLIC MODULES ASSOCIATED TO THE EDGE IDEALS OF THE POWERS OF A PATH

In this section, we compute depth and Stanley depth of $S/I(P_n^k)$. We start this section with the following elementary lemma:

Lemma 3.1. Let $a \ge 2$ be an integer, $\{E_i : 1 \le i \le a\}$ and $\{G_i : 0 \le i \le a\}$ be sequences of \mathbb{Z}^n -graged S modules, and we have the following short exact sequences:

$$0 \longrightarrow E_1 \longrightarrow G_0 \longrightarrow G_1 \longrightarrow 0 \tag{1}$$

$$0 \longrightarrow E_2 \longrightarrow G_1 \longrightarrow G_2 \longrightarrow 0 \tag{2}$$

$$0 \longrightarrow E_{a-1} \longrightarrow G_{a-2} \longrightarrow G_{a-1} \longrightarrow 0 \qquad (a-1)$$

$$0 \longrightarrow E_a \longrightarrow G_{a-1} \longrightarrow G_a \longrightarrow 0 \tag{a}$$

such that $\operatorname{depth}(G_a) \geq \operatorname{depth}(E_a)$ and $\operatorname{depth}(E_i) \geq \operatorname{depth}(E_{i-1})$, for all $2 \leq i \leq a$, then $\operatorname{depth}(G_0) = \operatorname{depth}(E_1)$.

÷

Proof. By assumption depth $(G_a) \ge \text{depth}(E_a)$, applying Depth Lemma on the exact sequence (a) we get depth $(G_{a-1}) = \text{depth}(E_a)$. We also have by assumption

 $\operatorname{depth}(G_{a-1}) = \operatorname{depth}(E_a) \ge \operatorname{depth}(E_{a-1}),$

applying Depth Lemma to the exact sequence (a-1) we have $\operatorname{depth}(G_{a-2}) = \operatorname{depth}(E_{a-1})$. We repeat the same steps on all exact sequences one by one from bottom to top and we get $\operatorname{depth}(G_{i-1}) = \operatorname{depth}(E_i)$ for all *i*. Thus if i = 1 then we have $\operatorname{depth}(G_0) = \operatorname{depth}(E_1)$.

Lemma 3.2. Let $k \ge 2$ and $n \ge 2k+2$, then $S/(I(P_n^k), A_{n-1}) \cong S_{n-k-1}/I(P_{n-k-1}^k)[x_n]$.

Proof. We have

$$\mathcal{G}(I(P_n^k)) = \bigcup_{i=1}^{n-k} \{x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{i+k}\} \bigcup \bigcup_{i=n-k+1}^{n-1} \{x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_n\}.$$

Then

$$I(P_n^k) + A_{n-1} = \left[\sum_{i=1}^{n-2k-1} (x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{i+k}) + \sum_{i=n-2k}^{n-k} (x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{i+k}) + \sum_{i=n-2k}^{n-1} (x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_n)\right] + A_{n-1}$$

$$= \sum_{i=1}^{n-2k-1} (x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{i+k}) + \sum_{i=n-2k}^{n-k-2} (x_i x_{i+1}, x_i x_{i+2}, \dots, x_i x_{n-k-1}) + A_{n-1} = I(P_{n-k-1}^k) + A_{n-1}$$

Thus the required result follows.

Lemma 3.3. Let $k \ge 2, \ 0 \le i \le k-1$ and $n \ge 3k+2$, then $S/(I(P_n^k): x_{n-k+i}) \cong S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)[x_{n-k+i}].$

Proof. It is enough to prove that $(I(P_n^k): x_{n-k+i}) = (I(P_{n-2k-1+i}^k), B_{n-k+i})$. Clearly

 $I(P_{n-2k-1+i}^k) \subset I(P_n^k) \subset (I(P_n^k) : x_{n-k+i}).$

Let $u \in B_{n-k+i}$, then by definition of $I(P_n^k)$, $ux_{n-k+i} \in I(P_n^k)$ that is $u \in (I(P_n^k) : x_{n-k+i})$. Thus $B_{n-k+i} \subset (I(P_n^k) : x_{n-k+i})$ and we have $(I(P_{n-2k-1+i}^k), B_{n-k+i}) \subset (I(P_n^k) : x_{n-k+i})$. Now for the other inclusion, let w be a monomial generator of $(I(P_n^k) : x_{n-k+i})$, then $w = \frac{v}{gcd(v,x_{n-k+i})}$, where $v \in \mathcal{G}(I(P_n^k))$. If $supp(v) \cap \mathcal{G}(B_{n-k+i}) \neq \emptyset$, then we have $w \in \mathcal{G}(B_{n-k+i})$ and if $supp(v) \cap \mathcal{G}(B_{n-k+i}) = \emptyset$ then

$$w \in \mathcal{G}(I(P_n^k)) \cap K[x_1, x_2, \dots, x_{n-2k-1+i}] = \mathcal{G}(I(P_{n-2k-1+i}^k)).$$

Lemma 3.4. Let $n \ge 3k+2$ and $0 \le i \le k-1$, then we have

$$S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \cong S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)[x_{n-k+i}].$$

Proof. Clearly $((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) = ((I(P_n^k) : x_{n-k+i}), A_{n-k+(i-1)})$. Now using the proof of Lemma 3.3

$$\left((I(P_n^k) : x_{n-k+i}), A_{n-k+(i-1)} \right) = \left(I(P_{n-2k-1+i}^k), B_{n-k+i}, A_{n-k+(i-1)} \right) = \left(I(P_{n-2k-1+i}^k), B_{n-k+i} \right)$$
as $A_{n-k+(i-1)} \subset B_{n-k+i}$. Thus the required result follows by Lemma 3.3. \Box

Remark 3.5. Let $m \ge 2$ and $I(P_m^{m-1}) \subset S_m = K[x_1, x_2, \ldots, x_m]$ be the edge ideal of the $(m-1)^{th}$ power of path P_m , then $I(P_m^{m-1})$ is a squarefree Veronese ideal of degree 2 in variables x_1, x_2, \ldots, x_m . Thus by [8, Corollary 10.3.7] and [3, Theorem 1.1]

$$epth(S_m/I(P_m^{m-1})) = sdepth(S_m/I(P_m^{m-1})) = 1.$$

Remark 3.6. Let $k \ge 2$ and $2k + 2 \le n \le 3k + 1$, then it is easy to see that

(1): If
$$n = 2k+2$$
, then $S/(I(P_n^k): x_{n-k}) = S/(x_2, \dots, x_{n-k-1}, x_{n-k+1}, \dots, x_n) \cong K[x_1, x_{n-k}]$
(2): If $0 \le i \le k-1$ and $n > 2k+2$, then

$$\begin{split} S/(I(P_n^k):x_{n-k+i}) &= S/((I(P_n^k),A_{n-k+(i-1)}):x_{n-k+i}) \\ &\cong S_{n-2k-1+i}/I(P_{n-2k-1+i}^{f(n-k+i)}) = \begin{cases} S_{n-2k-1+i}/I(P_{n-2k-1+i}^k), & \text{if } n-2k-1+i \ge k+1; \\ \\ S_{n-2k-1+i}/I(P_{n-2k-1+i}^{n-2k-2+i}), & \text{otherwise.} \end{cases} \end{split}$$

Theorem 3.7. Let $n \ge 2$, then depth $(S/I(P_n^k)) = \lceil \frac{n}{2k+1} \rceil$.

Proof. (a): Let $n \leq k+1$, then $I(P_n^k)$ is a square free Veronese ideal thus by Remark 3.5, $\operatorname{depth}(S/I(P_n^k)) = 1 = \lceil \frac{n}{2k+1} \rceil.$

(b): Let $n \ge k + 2$, we consider the following cases:

(1): If k = 1, then by [16, Lemma 2.8] we have depth $(S/I(P_n^1)) = \lceil \frac{n}{3} \rceil = \lceil \frac{n}{2k+1} \rceil$. (2): If $k \ge 2, k+2 \le n \le 2k+1$, then we have depth $(S/I(P_n^k)) \ge 1$ as $\mathfrak{m} \notin \operatorname{Ass}(S/I(P_n^k))$. Since $x_{k+1} \notin I(P_n^k)$ and $x_s x_{k+1} \in \mathcal{G}(I(P_n^k))$ for all $s \in \{1, \ldots, k, k+2, \ldots, n\}$, therefore

 $(I(P_n^k): x_{k+1}) = (x_1, \dots, x_k, x_{k+2}, \dots, x_n).$

By [21, Corollary 1.3], we have

 $depth(S/I(P_n^k)) \le depth(S/(I(P_n^k):x_{k+1})) = depth(S/(x_1, \dots, x_k, x_{k+2}, \dots, x_n)) = 1.$ Thus depth $(S/I(P_n^k)) = 1 = \lceil \frac{n}{2k+1} \rceil$.

(3): If $k \ge 2$, $2k + 2 \le n \le 3k + 1$, now consider the following short exact sequences:

$$0 \longrightarrow S/(I(P_n^k) : x_{n-k}) \xrightarrow{x_{n-k}} S/I(P_n^k) \longrightarrow S/(I(P_n^k), x_{n-k}) \longrightarrow 0$$
$$0 \longrightarrow S/((I(P_n^k), A_{n-k}) : x_{n-k+1}) \xrightarrow{x_{n-k+1}} S/(I(P_n^k), A_{n-k}) \longrightarrow S/(I(P_n^k), A_{n-k+1}) \longrightarrow 0$$

$$0 \longrightarrow S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \xrightarrow{\cdot x_{n-k+i}} S/(I(P_n^k), A_{n-k+(i-1)}) \longrightarrow S/(I(P_n^k), A_{n-k+i}) \longrightarrow 0$$

$$0 \longrightarrow S/((I(P_n^k), A_{n-2}) : x_{n-1}) \xrightarrow{\cdot x_{n-1}} S/(I(P_n^k), A_{n-2}) \longrightarrow S/(I(P_n^k), A_{n-1}) \longrightarrow 0.$$

By Lemma 3.2, $S/(I(P_n^k), A_{n-1}) \cong S_{n-k-1}/I(P_{n-k-1}^k)[x_n]$. Since $k+1 \le n-k-1 \le n$ 2k, thus if n-k-1 = k+1 then by case(a) and [9, Lemma 3.6], otherwise by case(b)(2) and [9, Lemma 3.6] we have

$$\operatorname{depth}\left(S/(I(P_n^k), A_{n-1})\right) = 2$$

Now we show that depth $\left(S/(I(P_n^k):x_{n-k})\right) = 2$, for this we consider two cases: If n = 2k + 2, then by Remark 3.6

$$S/(I(P_n^k):x_{n-k}) = S/(x_2, x_3, \dots, x_{n-k-1}, x_{n-k+1}, \dots, x_n) \cong K[x_1, x_{n-k}],$$

and thus depth $\left(S/(I(P_n^k):x_{n-k})\right) = 2.$ If n > 2k + 2, by Remark 3.6 we have

$$S/(I(P_n^k):x_{n-k}) \cong S_{n-2k-1}/I(P_{n-2k-1}^{n-2k-2})[x_{n-k}],$$

where $2 \le n - 2k - 1 \le k$. Thus by Remark 3.5 and [9, Lemma 3.6] we get

$$\operatorname{depth}\left(S/(I(P_n^k):x_{n-k})\right) = 2$$

Now let $1 \le i \le k - 1$, by Remark 3.6

$$S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) = S/(I(P_n^k) : x_{n-k+i}) \cong S_{n-2k-1+i}/I(P_{n-2k-1+i}^{f(n-k+i)})[x_{n-k+i}].$$

- Let $T := S_{n-2k-1+i}/I(P_{n-2k-1+i}^{f(n-k+i)})[x_{n-k+i}]$, we consider the following cases: (i): If k+1 = n-2k-1+i, then $T = S_{k+1}/I(P_{k+1}^k)[x_{n-k+i}]$, thus by case(a) and [9, Lemma 3.6] we have depth(T) = 2.
 - (ii): If k + 1 < n 2k 1 + i, then $T = S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)[x_{n-k+i}]$. Since $k+2 \le n-2k-1+i \le 2k-1$, thus by case(b)(2) and [9, Lemma 3.6] we have depth(T) = 2.

(iii): If $2 \le n - 2k - 1 + i < k + 1$, then $T = S_{n-2k-1+i}/I(P_{n-2k-1+i}^{n-2k-2+i})[x_{n-k+i}]$, by Remark 3.5 and [9, Lemma 3.6] we have depth(T) = 2.

Thus by Lemma 3.1 we have $depth(S/I(P_n^k)) = 2$.

(4): If
$$k \ge 2, n \ge 3k + 2$$
, then we consider the family of short exact sequences:

$$0 \longrightarrow S/(I(P_n^k) : x_{n-k}) = S/((I(P_n^k), A_{n-k-1}) : x_{n-k})) \xrightarrow{\cdot x_{n-k}} S/I(P_n^k) \longrightarrow S/(I(P_n^k), A_{n-k}) \longrightarrow 0$$

$$0 \longrightarrow S/((I(P_n^k), A_{n-k}) : x_{n-k+1}) \xrightarrow{\cdot x_{n-k+1}} S/(I(P_n^k), A_{n-k}) \longrightarrow S/(I(P_n^k), A_{n-k+1}) \longrightarrow 0$$
:

$$0 \longrightarrow S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \xrightarrow{:x_{n-k+i}} S/(I(P_n^k), A_{n-k+(i-1)}) \longrightarrow S/(I(P_n^k), A_{n-k+i}) \longrightarrow 0$$

$$0 \longrightarrow S/((I(P_n^k), A_{n-2}) : x_{n-1}) \xrightarrow{\cdot x_{n-1}} S/(I(P_n^k), A_{n-2}) \longrightarrow S/(I(P_n^k), A_{n-1}) \longrightarrow 0.$$

By Lemma 3.2, $S/(I(P_n^k), A_{n-1})) \cong S_{n-k-1}/I(P_{n-k-1}^k)[x_n]$. Thus by induction on n and [9, Lemma 3.6] we have

$$\operatorname{depth}(S/(I(P_n^k), A_{n-1})) = \lceil \frac{n-k-1}{2k+1} \rceil + 1.$$

Let $0 \le i \le k - 1$, by Lemma 3.4 we have

 $S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \cong S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)[x_{n-k+i}].$ Thus by induction on n and [9, Lemma 3.6] we have

$$depth(S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i})) = \lceil \frac{n-2k-1+i}{2k+1} \rceil + 1$$

We can see that

 $depth(S/(I(P_n^k), A_{n-1})) = \lceil \frac{n-k-1}{2k+1} \rceil + 1 \ge \lceil \frac{n-k-2}{2k+1} \rceil + 1 = depth(S/(I(P_n^k), A_{n-2}) : x_{n-1})).$ And for all $1 \le i \le k-1$,

$$depth(S/((I(P_n^k), A_{n-k+(i-1)}) : x_{n-k+i})) = \lceil \frac{n-2k-1+i}{2k+1} \rceil + 1 \ge \\ \lceil \frac{n-2k-2+i}{2k+1} \rceil + 1 = depth(S/((I(P_n^k), A_{n-k+(i-2)}) : x_{n-k+(i-1)})).$$

Thus by Lemma 3.1 we have

$$\operatorname{depth}(S/I(P_n^k)) = \lceil \frac{n-2k-1}{2k+1} \rceil + 1 = \lceil \frac{n}{2k+1} \rceil.$$

Lemma 3.8. [23, Lemma 4] Let $n \ge 2$, then sdepth $(S/I(P_n^1)) = \lceil \frac{n}{3} \rceil$.

Example 3.9. Let $n \ge 2$, and $n \le 2k + 1$, then sdepth $(S/I(P_n^k)) = 1$.

Proof. If $n \leq k+1$, then by [3, Theorem 1.1] sdepth $(S/I(P_n^k)) = 1$. Now let $k+2 \leq n \leq 2k+1$, then depth $(S/I(P_n^k)) \geq 1$ as $\mathfrak{m} \notin \operatorname{Ass}(S/I(P_n^k))$, thus by [5, Theorem 1.4] sdepth $(S/I(P_n^k)) \geq 1$. Since $x_{k+1} \notin I(P_n^k)$ and $x_i x_{k+1} \in \mathcal{G}(I(P_n^k))$ for all $i \in \{1, \ldots, k, k+2, \ldots, n\}$, therefore

$$(I(P_n^k): x_{k+1}) = (x_1, \dots, x_k, x_{k+2}, \dots, x_n).$$

Thus by [2, Proposition 2.7]

$$sdepth(S/I(P_n^k)) \le sdepth(S/(I(P_n^k):x_{k+1})) = sdepth(S/(x_1,\ldots,x_k,x_{k+2},\ldots,x_n)) = 1.$$

Proposition 3.10. Let $k \ge 2$ and $n \ge 2k+2$, then sdepth $(S/I(P_n^k)) \ge \lceil \frac{n}{2k+1} \rceil$.

Proof. (1): If $2k + 2 \le n \le 3k + 1$, then we apply Lemma 2.11 on the exact sequences in case(b)(3) of Theorem 3.7 and we get sdepth $(S/I(P_n^k)) \ge 2 = \lceil \frac{n}{2k+1} \rceil$.

(2): If $n \ge 3k + 2$, then the proof is similar to Theorem 3.7. We apply Lemma 2.11 on the exact sequences in case(b)(4) of Theorem 3.7 we get

$$\operatorname{sdepth}(S/I(P_n^k)) \ge \min\left\{\operatorname{sdepth}(S/(I(P_n^k):x_{n-k})), \operatorname{sdepth}(S/(I(P_n^k),A_{n-1})), \\ \min_{i=1}^{k-1} \left\{\operatorname{sdepth}(S/((I(P_n^k),A_{n-k+(i-1)}):x_{n-k+i}))\right\} \ge \lceil \frac{n}{2k+1} \rceil.$$

Theorem 3.11. Let $n \ge 2$, then sdepth $(S/I(P_n^k)) = \lceil \frac{n}{2k+1} \rceil$.

Proof. By Lemma 3.8, Example 3.9 and Proposition 3.10, it is enough to prove, if $k \ge 2$ then

$$\operatorname{sdepth}(S/I(P_n^k)) \leq \lceil \frac{n}{2k+1} \rceil$$
, for $n \geq 2k+2$.

We consider the following three cases:

(1): Let n = (2k+1)l, where $l \ge 1$. We see that

 $v = x_{k+1}x_{3k+2}x_{5k+3}\cdots x_{(2k+1)l-k} \in S \setminus I(P_n^k),$

but $x_{t_1}v \in I(P_n^k)$, for all $t_1 \in [n] \setminus \operatorname{supp}(v)$, by Lemma 2.12, $\operatorname{sdepth}(S/I(P_n^k)) \le l = \lceil \frac{n}{2k+1} \rceil$.

(2): Let n = (2k+1)l + r, where $r \in \{1, 2, 3, \dots, k+1\}$ and $l \ge 1$. We have

$$v = x_{k+1}x_{3k+2}x_{5k+3}\cdots x_{(2k+1)l-k}x_{(2k+1)l+r} \in S \setminus I(P_n^k),$$

but $x_{t_2}v \in I(P_n^k)$, for all $t_2 \in [n] \setminus \text{supp}(v)$, by Lemma 2.12,

$$sdepth(S/I(P_{n}^{k})) \leq l+1 = \lceil \frac{n}{2k+1} \rceil.$$
(3): Let $n = (2k+1)l + s$, where $s \in \{k+2, k+3, \dots, 2k\}$ and $l \geq 1$. Since $v = x_{k+1}x_{3k+2}x_{5k+3}\cdots x_{(2k+1)l+k+1} \in S \setminus I(P_{n}^{k}),$
but $x_{t_{3}}v \in I(P_{n}^{k})$, for all $t_{3} \in [n] \setminus supp(v)$, by Lemma 2.12,
 $sdepth(S/I(P_{n}^{k})) \leq l+1 = \lceil \frac{n}{2k+1} \rceil.$

4. Dept and Stanley depth of cyclic modules associated to the edge ideals of the powers of a cycle

In this section, we compute bounds for depth and Stanley depth for cyclic modules associated to the edge ideals of powers of a cycle.

Lemma 4.1. Let $k \ge 2$ and $n \ge 3k + 2$, then $S/(I(C_n^k), A_{n-1}) \cong S_{n-k}/I(P_{n-k}^k)$.

Proof. We have

$$\mathcal{G}(I(C_n^k)) = \mathcal{G}(I(P_n^k)) \bigcup \bigcup_{l=1}^{k-1} \{x_l x_{l+n-k}, x_l x_{l+n-k+1}, \dots, x_l x_{n-1}\} \bigcup \{x_1 x_n, x_2 x_n, \dots, x_k x_n\}.$$

Then

$$I(C_n^k) + A_{n-1} = I(P_n^k) + \sum_{l=1}^{k-1} (x_l x_{l+n-k}, x_l x_{l+n-k+1}, \dots, x_l x_{n-1}) + (x_1 x_n, x_2 x_n, \dots, x_k x_n) + A_{n-1}.$$

Thus by the proof of Lemma 3.2, we have

$$I(P_n^k) + A_{n-1} = I(P_{n-k-1}^k) + A_{n-1}$$

And

$$\sum_{l=1}^{k-1} (x_l x_{l+n-k}, x_l x_{l+n-k+1}, \dots, x_l x_{n-1}) + A_{n-1} = A_{n-1}.$$

Therefore

$$S/(I(C_n^k), A_{n-1}) = S/(I(P_{n-k-1}^k), A_{n-1}, (x_1x_n, x_2x_n, \dots, x_kx_n))$$

$$\cong K[x_1, x_2, \dots, x_{n-k-1}, x_n]/(I(P_{n-k-1}^k), (x_1x_n, x_2x_n, \dots, x_kx_n)).$$

After renumbering the variables, we have

$$K[x_1, x_2, \dots, x_{n-k-1}, x_n] / \left(I(P_{n-k-1}^k), (x_1 x_n, x_2 x_n, \dots, x_k x_n) \right) \cong S_{n-k} / I(P_{n-k}^k).$$

Lemma 4.2. Let $k \ge 2$ and $n \ge 3k+2$ and $0 \le i \le k-1$, then

$$S/(I(C_n^k): x_{n-k+i}) \cong S_{n-2k-1}/I(P_{n-2k-1}^k)[x_{n-k+i}].$$

Proof. Let w be a monomial generator of $(I(C_n^k) : x_{n-k+i})$, then $w = \frac{v}{\gcd(v, x_{n-k+i})}$, where $v \in V$ $\mathcal{G}(I(C_n^k))$. If $\operatorname{supp}(v) \cap \mathcal{G}(D_{n-k+i}) \neq \emptyset$, then we have $w \in \mathcal{G}(D_{n-k+i})$ and if $\operatorname{supp}(v) \cap \mathcal{G}(D_{n-k+i}) = \emptyset$ then

 $w \in E := \mathcal{G}(I(C_n^k)) \cap K[x_{i+1}, x_{i+2}, \dots, x_{n-2k-1+i}].$

So we get

$$(I(C_n^k): x_{n-k+i}) \subset E + D_{n-k+i},$$

the other inclusion being trivial we get that $(I(C_n^k) : x_{n-k+i}) = E + D_{n-k+i}$. Thus we have $S/(I(C_n^k) : x_{n-k+i}) = S/(E + D_{n-k+i})$. After renumbering the variables, we have

$$S/(I(C_n^k): x_{n-k+i}) = S/(E, D_{n-k+i}) \cong S_{n-2k-1}/I(P_{n-2k-1}^k)[x_{n-k+i}].$$

Lemma 4.3. Let $k \ge 2$, $n \ge 3k + 2$ and $0 \le i \le k - 1$, then we have

$$S/((I(C_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \cong S_{n-2k-1}/I(P_{n-2k-1}^k)[x_{n-k+i}].$$

Proof. Clearly $((I(C_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) = ((I(C_n^k) : x_{n-k+i}), A_{n-k+(i-1)})$. By using the same arguments as in the proof of Lemma 4.2 we have

$$\left((I(C_n^k) : x_{n-k+i}), A_{n-k+(i-1)} \right) = \left(E, D_{n-k+i}, A_{n-k+(i-1)} \right) = \left(E, D_{n-k+i} \right)$$

as $A_{n-k+(i-1)} \subset D_{n-k+i}$. Thus the required result follows by Lemma 4.2.

Theorem 4.4. Let $n \geq 3$, then

$$\begin{aligned} \operatorname{depth}(S/I(C_n^k)) &= 1, \quad \text{if } n \leq 2k+1; \\ \operatorname{depth}(S/I(C_n^k)) &\geq \lceil \frac{n-k}{2k+1} \rceil, \quad \text{if } n \geq 2k+2. \end{aligned}$$

(a): Let $n \leq 2k + 1$, then by [8, Corollary 10.3.7], depth $(S/I(C_n^k)) = 1$. Proof.

(b): Let $n \ge 2k + 2$, we consider the following cases:

- (1): If k = 1, then by [4, Proposition 1.3] depth $(S/I(C_n^1)) = \lceil \frac{n-1}{3} \rceil$. (2): If $k \ge 2$ and $2k + 2 \le n \le 3k + 1$, then we have depth $(S/I(C_n^k)) \ge 1 = \lceil \frac{n-k}{2k+1} \rceil$ as $\mathfrak{m} \notin \operatorname{Ass}(S/I(C_n^k))$.

(3): If $k \ge 2$ and $n \ge 3k + 2$, consider the family of short exact sequences:

$$0 \longrightarrow S/(I(C_n^k) : x_{n-k}) = S/((I(C_n^k), A_{n-k-1}) : x_{n-k}) \xrightarrow{\cdot x_{n-k}} S/I(C_n^k) \longrightarrow S/(I(C_n^k), A_{n-k}) \longrightarrow 0$$
$$0 \longrightarrow S/((I(C_n^k), A_{n-k}) : x_{n-k+1}) \xrightarrow{\cdot x_{n-k+1}} S/(I(C_n^k), A_{n-k}) \longrightarrow S/(I(C_n^k), A_{n-k+1}) \longrightarrow 0$$
$$\cdot$$

$$0 \longrightarrow S/((I(C_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \xrightarrow{\cdot x_{n-k+i}} S/(I(C_n^k), A_{n-k+(i-1)}) \longrightarrow S/(I(C_n^k), A_{n-k+i}) \longrightarrow 0$$

:

 $0 \longrightarrow S/((I(C_n^k), A_{n-2}) : x_{n-1}) \xrightarrow{\cdot x_{n-1}} S/(I(C_n^k), A_{n-2}) \longrightarrow S/(I(C_n^k), A_{n-1}) \longrightarrow 0$ By Lemma 4.1 we have

$$S/(I(C_n^k), A_{n-1})) \cong S_{n-k}/I(P_{n-k}^k).$$

Let $0 \le i \le k - 1$, then by Lemma 4.3, we have

$$S/((I(C_n^k), A_{n-k+(i-1)}) : x_{n-k+i}) \cong S_{n-2k-1}/I(P_{n-2k-1}^k)[x_{n-k+i}].$$

By Theorem 3.7 and [9, Lemma 3.6], we have

$$depth(S/((I(C_n^k), A_{n-k+(i-1)}) : x_{n-k+i})) = \lceil \frac{n-2k-1}{2k+1} \rceil + 1 = \lceil \frac{n}{2k+1} \rceil.$$

Again by Theorem 3.7, we have

$$depth(S/(I(C_n^k), A_{n-1})) = \lceil \frac{n-k}{2k+1} \rceil$$

Thus by Depth Lemma depth $(S/I(C_n^k)) \ge \lceil \frac{n-k}{2k+1} \rceil$.

Corollary 4.5. Let $n \ge 3$, if $n \le 2k + 1$, then $\operatorname{depth}(S/I(C_n^k)) = 1$. If $n \ge 2k + 2$, then $\operatorname{depth}(S/I(C_n^k)) = \lceil \frac{n}{2k+1} \rceil$, if $n \equiv 0, k+1, \dots, n-1 \pmod{(2k+1)}$; $\lceil \frac{n}{2k+1} \rceil - 1 \le \operatorname{depth}(S/I(C_n^k)) \le \lceil \frac{n}{2k+1} \rceil$, if $n \equiv 1, \dots, k \pmod{(2k+1)}$.

Proof. By Theorem 4.4, it is enough to prove that depth $(S/I(C_n^k)) \leq \lceil \frac{n}{2k+1} \rceil$, for $k \geq 2$ and $n \geq 2k+2$. Since $x_{n-k} \notin I(C_n^k)$, thus by [21, Corollary 1.3] we have

$$\operatorname{depth}(S/I(C_n^k)) \le \operatorname{depth}(S/(I(C_n^k):x_{n-k}))$$

Now we consider two cases:

(1): Let $2k + 2 \le n \le 3k + 1$, then $S/(I(C_n^k) : x_{n-k}) = S/(I(P_n^k) : x_{n-k})$ so by the proof of Theorem 3.7 we have depth $(S/(I(P_n^k) : x_{n-k})) = 2 = \lceil \frac{n}{2k+1} \rceil$. Therefore

$$\operatorname{depth}(S/I(C_n^k)) \le \operatorname{depth}(S/(I(C_n^k):x_{n-k})) = 2 = \lceil \frac{n}{2k+1} \rceil$$

(2): Let $n \ge 3k+2$, then by Lemma 4.2, $S/(I(C_n^k):x_{n-k}) \cong S_{n-2k-1}/I(P_{n-2k-1}^k)[x_{n-k}]$. By [9, Lemma 3.6] and Theorem 3.7, depth $(S_{n-2k-1}/I(P_{n-2k-1}^k))[x_{n-k}]) = \lceil \frac{n}{2k+1} \rceil$. Thus

$$\operatorname{depth}(S/I(C_n^k)) \le \operatorname{depth}(S/(I(C_n^k):x_{n-k})) = \lceil \frac{n}{2k+1} \rceil.$$

Theorem 4.6. Let $n \geq 3$, then

$$\begin{aligned} \mathrm{sdepth}(S/I(C_n^k)) &= 1, \quad if \ n \leq 2k+1; \\ \mathrm{sdepth}(S/I(C_n^k)) &\geq \lceil \frac{n-k}{2k+1} \rceil, \quad if \ n \geq 2k+2. \end{aligned}$$

Proof. (a): Let $n \le 2k + 1$, then sdepth $(S/I(C_n^k)) = 1$ by [3, Theorem 1.1]. (b): Let $n \ge 2k + 2$, consider the following cases:

 \square

- (1): If k = 1, then by [4, Proposition 1.8] sdepth $(S/I(C_n^1)) \ge \lceil \frac{n-1}{3} \rceil$.
- (2): If $k \ge 2$, $2k+2 \le n \le 3k+1$, then depth $(S/I(C_n^k)) \ge 1$ as $\mathfrak{m} \notin \operatorname{Ass}(S/I(C_n^k))$, thus by [5, Theorem 1.4], sdepth $(S/I(C_n^k)) \ge 1 = \lceil \frac{n-k}{2k+1} \rceil$.

(3): If $k \ge 2$, $n \ge 3k + 2$, this theorem can be proved by using similar arguments of Theorem 4.4. We apply Lemma 2.11 on the exact sequences of Theorem 4.4 we get

$$sdepth(S/I(C_{n}^{k})) \ge \min \left\{ sdepth(S/(I(C_{n}^{k}):x_{n-k})), sdepth(S/(I(C_{n}^{k}),A_{n-1})), \\ \min_{i=1}^{k-1} \left\{ sdepth(S/((I(C_{n}^{k}),A_{n-k+(i-1)}):x_{n-k+i})) \right\} \right\} \ge \lceil \frac{n-k}{2k+1} \rceil.$$

Corollary 4.7. Let $n \ge 3$, if $n \le 2k + 1$, then $\operatorname{sdepth}(S/I(C_n^k)) = 1$. If $n \ge 2k + 2$, then $\operatorname{sdepth}(S/I(C_n^k)) = \lceil \frac{n}{2k+1} \rceil$, if $n \equiv 0, k+1, \dots, n-1 \pmod{(2k+1)}$; $\lceil \frac{n}{2k+1} \rceil - 1 \le \operatorname{sdepth}(S/I(C_n^k)) \le \lceil \frac{n}{2k+1} \rceil$, if $n \equiv 1, \dots, k \pmod{(2k+1)}$.

Proof. When k = 1, then by [4, Theorem 1.9], $\operatorname{sdepth}(S/I(C_n^k)) \leq \lceil \frac{n}{3} \rceil$. By Theorem 4.6 it is enough to prove that $\operatorname{sdepth}(S/I(C_n^k)) \leq \lceil \frac{n}{2k+1} \rceil$, for $k \geq 2$ and $n \geq 2k+2$. The proof of Corollary 4.5 also works for Stanley depth by using [2, Proposition 2.7] instead of [21, Corollary 1.3] and Theorem 3.11 instead of Theorem 3.7.

5. Lower bounds for Stanley depth of edge ideals of k^{th} powers of paths and cycles and a conjecture of Herzog

In this section we compute some lower bounds for Stanley depth of $I(P_n^k)$ and $I(C_n^k)$. These bounds are good enough to prove that Conjecture 1.1 is true for $I(P_n^k)$ and $I(C_n^k)$. Let $0 \le i \le k-1$, define

$$R_{n-k+i} := K[\{x_1, x_2, \dots, x_n\} \setminus \{x_{n-k}, x_{n-k+1}, \dots, x_{n-k+i}\}]$$

and

 $B'_{n-k+i} := (N_{P_n^k}(x_{n-k+i}) \setminus \{x_{n-k}, x_{n-k+1}, \dots, x_{n-k+(i-1)}\}),$

where R_{n-k+i} is a subring of S and B'_{n-k+i} is a monomial prime ideal of S generated by

 $N_{P_n^k}(x_{n-k+i}) \setminus \{x_{n-k}, x_{n-k+1}, \dots, x_{n-k+(i-1)}\}.$

Let $I \subset Z = K[x_{i_1}, x_{i_1}, \dots, x_{i_r}]$ be a monomial ideal and let $Z' := Z[x_{i_r+1}]$, then we write $IZ' = I[x_{i_r+1}]$. We recall in the following a useful remark of Cimpoeas.

Remark 5.1. [2, Remark 1.7] Let I be a monomial ideal of S, and $I' = (I, x_{n+1}, x_{n+2}, \ldots, x_{n+m})$ be a monomial ideal of $S' = S[x_{n+1}, x_{n+2}, \ldots, x_{n+m}]$, then

$$\operatorname{sdepth}_{S'}(I') \ge \min\{\operatorname{sdepth}_S(I) + m, \operatorname{sdepth}_S(S/I) + \lceil \frac{m}{2} \rceil\}.$$

Theorem 5.2. Let $n \ge 2$, then sdepth $(I(P_n^k)) \ge \lceil \frac{n}{2k+1} \rceil + 1$.

- *Proof.* (a): Let $n \leq 2k + 1$, since the minimal generators of $I(P_n^k)$ have degree 2, so by [13, Lemma 2.1] sdepth $(I(P_n^k)) \geq 2 = \lceil \frac{n}{2k+1} \rceil + 1$.
 - (b): Let $n \ge 2k+2$, if k = 1, then by [17, Theorem 2.3] we have sdepth $(I(P_n^1)) \ge n \lfloor \frac{n-1}{2} \rfloor = \lceil \frac{n-1}{2} \rceil + 1 \ge \lceil \frac{n}{3} \rceil + 1$. Now let $k \ge 2$, we prove this result by induction on n. We consider the following decomposition of $I(P_n^k)$ as a vector space:

$$I(P_n^k) = I(P_n^k) \cap R_{n-k} \bigoplus x_{n-k} (I(P_n^k) : x_{n-k})S.$$

Similarly, we can decompose $I(P_n^k) \cap R_{n-k}$ by the following:

$$I(P_n^k) \cap R_{n-k} = I(P_n^k) \cap R_{n-k+1} \bigoplus x_{n-k+1} (I(P_n^k) \cap R_{n-k} : x_{n-k+1}) R_{n-k}.$$

Continuing in the same way for $1 \le i \le k-1$ we have

$$I(P_n^k) \cap R_{n-k+i} = I(P_n^k) \cap R_{n-k+(i+1)} \bigoplus x_{n-k+(i+1)} (I(P_n^k) \cap R_{n-k+i} : x_{n-k+(i+1)}) R_{n-k+i}.$$

Finally we get the following decomposition of $I(P_n^k)$:

$$I(P_n^k) = I(P_n^k) \cap R_{n-1} \bigoplus \bigoplus_{i=1}^{k-1} x_{n-k+i} (I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i}) R_{n-k+i}$$
$$\bigoplus x_{n-k} (I(P_n^k) : x_{n-k}) S_{n-k-k-i} (I(P_n^k) : x_{n-k-k-i}) S_$$

Therefore

$$sdepth(I(P_n^k)) \ge \min\left\{sdepth(I(P_n^k) \cap R_{n-1}), sdepth((I(P_n^k) : x_{n-k})S), \\ \min_{i=1}^{k-1} \{sdepth((I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i})R_{n-k+i})\}\right\} (5.1)$$

Now

$$I(P_n^k) \cap R_{n-1} = \mathcal{G}(I(P_{n-k-1}^k))[x_n],$$

thus by induction on n and [9, Lemma 3.6] we have

$$sdepth(I(P_n^k) \cap R_{n-1}) \ge \lceil \frac{n-k-1}{2k+1} \rceil + 1 + 1 \ge \lceil \frac{n}{2k+1} \rceil + 1.$$

Now we need to show that

$$sdepth((I(P_n^k):x_{n-k})S) \ge \lceil \frac{n}{2k+1} \rceil + 1$$

and

$$sdepth((I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i})R_{n-k+i}) \ge \lceil \frac{n}{2k+1} \rceil + 1.$$

For this we consider the following cases:

(1): Let $2k + 2 \le n \le 3k + 1$.

If n = 2k + 2, then $(I(P_n^k) : x_{n-k})S = (x_2, \dots, x_{n-k-1}, x_{n-k+1}, \dots, x_n)S$, thus by [1, Theorem 2.2] and [9, Lemma 3.6] we have

$$sdepth((I(P_n^k):x_{n-k})S) = \lceil \frac{n-2}{2} \rceil + 2 \ge \lceil \frac{n}{2k+1} \rceil + 1.$$

If $2k+3 \le n \le 3k+1$, then by Remark 3.6 $(I(P_n^k): x_{n-k})S = (\mathcal{G}(I(P_{n-2k-1}^{f(n-k)})), B_{n-k})[x_{n-k}]$. Since sdepth $(I(P_{n-2k-1}^{f(n-k)})) + |\mathcal{G}(B_{n-k})| \ge 2$, by Remark 3.5 we have

$$\operatorname{sdepth}(S_{n-2k-1}/I(P_{n-2k-1}^{f(n-k)})) + \lceil \frac{|\mathcal{G}(B_{n-k})|}{2} \rceil \ge 2,$$

then by Remark 5.1,

$$\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1}^{f(n-k)})), B_{n-k}) \ge 2,$$

and by [9, Lemma 3.6] we have

$$\operatorname{sdepth}((I(P_n^k): x_{n-k})S) \ge 3 = \lceil \frac{n}{2k+1} \rceil + 1.$$

Now since

$$(I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i})R_{n-k+i}) = (\mathcal{G}(I(P_{n-2k-1+i}^{f(n-k+i)})), B'_{n-k+i})[x_{n-k+i}].$$

So by the same arguments we have

$$sdepth((I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i})R_{n-k+i}) \ge 3 = \lceil \frac{n}{2k+1} \rceil + 1.$$

(2): Let $n \ge 3k + 2$, then by the proof of Lemma 3.3

$$(I(P_n^k): x_{n-k})S = (\mathcal{G}(I(P_{n-2k-1}^k)), B_{n-k})[x_{n-k}]$$

and

$$(I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i})R_{n-k+i} = (\mathcal{G}(I(P_{n-2k-1+i}^k)), B'_{n-k+i})[x_{n-k+i}].$$

By Remark 5.1 we have

 $\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1}^k)), B_{n-k}) \ge$

 $\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1+i}^k)), B'_{n-k+i}) \geq$

 $\min \Big\{ \operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1}^k))) + |\mathcal{G}(B_{n-k})|, \operatorname{sdepth}(S_{n-2k-1}/I(P_{n-2k-1}^k)) + \lceil \frac{|\mathcal{G}(B_{n-k})|}{2} \rceil \Big\}.$

By induction on n we have sdepth $(\mathcal{G}(I(P_{n-2k-1}^k))) \ge \lceil \frac{n-2k-1}{2k+1} \rceil + 1 = \lceil \frac{n}{2k+1} \rceil$, and by Theorem 3.11 we have sdepth $(S_{n-2k-1}/I(P_{n-2k-1}^k)) = \lceil \frac{n}{2k+1} \rceil - 1$. Therefore

$$\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1}^k)), B_{n-k}) \ge \lceil \frac{n}{2k+1} \rceil + 1.$$

Thus by [9, Lemma 3.6] we have sdepth $((I(P_n^k) : x_{n-k})S) > \lceil \frac{n}{2k+1} \rceil + 1.$ Now using Remark 5.1 again, we get

 $\min\Big\{\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1+i}^k))) + |\mathcal{G}(B_{n-k+i}')|, \operatorname{sdepth}(S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)) + \lceil \frac{|\mathcal{G}(B_{n-k+i}')|}{2}\rceil\Big\}.$

By induction on *n* we have $\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1+i}^k))) \ge \lceil \frac{n-2k-1+i}{2k+1} \rceil + 1$, and by Theorem 3.11 we have $\operatorname{sdepth}(S_{n-2k-1+i}/I(P_{n-2k-1+i}^k)) = \lceil \frac{n-2k-1+i}{2k+1} \rceil$. Therefore

$$\operatorname{sdepth}(\mathcal{G}(I(P_{n-2k-1+i}^k)), B'_{n-k+i}) \ge \lceil \frac{n-2k-1+i}{2k+1} \rceil + 1$$

Thus by [9, Lemma 3.6], sdepth $((I(P_n^k) \cap R_{n-k+(i-1)} : x_{n-k+i}) R_{n-k+i}) \ge \lceil \frac{n}{2k+1} \rceil + 1.$ This completes the proof.

Proposition 5.3. Let $n \ge 2k+1$, then sdepth $(I(C_n^k)/I(P_n^k)) \ge \lceil \frac{n+k+1}{2k+1} \rceil$.

Proof. When k = 1, then by [4, Proposition 1.10] we have the required result. Now assume that $k \geq 2$ and consider the following cases:

(1): If 2k + 1 ≤ n ≤ 3k + 1. Since I(C^k_n) is a monomial ideal generated by degree 2 so by [9, Theorem 2.1] sdepth(I(C^k_n)/I(P^k_n)) ≥ 2 = [^{n+k+1}/_{2k+1}].
(2): When 3k+2 ≤ n ≤ 4k+1, then we use [9] to show that there exist Stanley decompositions

of desired Stanley depth. Let $s \in \{1, 2, \dots, k\}$, $j_s \in \{1, 2, \dots, k+1-s\}$ and

$$L := \bigoplus_{s=1}^{k} \Big(\bigoplus_{j_s=1}^{k+1-s} x_{j_s} x_{n+1-s} K[x_{j_s}, x_{j_s+k+1}, x_{n+1-s}] \Big).$$

It is easy to see that $L \subset I(C_n^k) \setminus I(P_n^k)$. Now let $u_i \in I(C_n^k) \setminus I(P_n^k)$ be a squarefree monomial such that $u_i \notin L$ then clearly $\deg(u_i) \geq 3$. Since

$$I(C_n^k)/I(P_n^k) \cong L \bigoplus_{u_i} u_i K[\operatorname{supp}(u_i)]$$

Thus sdepth $(I(C_n^k)/I(P_n^k)) \ge 3 = \lceil \frac{n+k+1}{2k+1} \rceil$ as required. (3): Now, assume that $n \ge 4k+2$. We have the following K-vector space isomorphism:

$$I(C_n^k)/I(P_n^k) \cong \bigoplus_{j_1=1}^k x_{j_1} x_n \frac{K[x_{j_1+k+1}, x_{j_1+k+2}, \dots, x_{n-k-1}]}{(x_{j_1+k+1}x_{j_1+k+2}, x_{j_1+k+1}x_{j_1+k+3}, \dots, x_{n-k-2}x_{n-k-1})} [x_{j_1}, x_n]$$

$$\bigoplus_{j_{2}=1}^{k-1} x_{j_{2}} x_{n-1} \frac{K[x_{j_{2}+k+1}, x_{j_{2}+k+2}, \dots, x_{n-k-2}]}{(x_{j_{2}+k+1}x_{j_{2}+k+2}, x_{j_{2}+k+1}x_{j_{1}+k+3}, \dots, x_{n-k-3}x_{n-k-2})} [x_{j_{2}}, x_{n-1}] \bigoplus_{\dots} \\
\bigoplus_{j_{k-1}=1}^{2} x_{j_{k-1}} x_{n-(k-2)} \frac{K[x_{j_{k-1}+k+1}, x_{j_{k-1}+k+2}, \dots, x_{n-2k+1}]}{(x_{j_{k-1}+k+1}x_{j_{k-1}+k+2}, x_{j_{k-1}+k+1}x_{j_{k-1}+k+3}, \dots, x_{n-2k}x_{n-2k+1})} [x_{j_{k-1}}, x_{n-k+2}]$$

$$\bigoplus x_1 x_{n-(k-1)} \frac{K[x_{k+2}, x_{k+3}, \dots, x_{n-2k}]}{(x_{k+2} x_{k+3}, x_{k+2} x_{k+4}, \dots, x_{n-2k-1} x_{n-2k})} [x_1, x_{n-(k-1)}].$$

Thus

$$I(C_n^k)/I(P_n^k) \cong \bigoplus_{s=1}^k \Big(\bigoplus_{j_s=1}^{k+1-s} x_{j_s} x_{n+1-s} \big(S_{j_s+k+1,n-s-k}/\big(\mathcal{G}(I(P_n^k)) \cap S_{j_s+k+1,n-s-k}\big) [x_{j_s}, x_{n+1-s}] \Big),$$

where $S_{j_s+k+1,n-s-k} = K[x_{j_s+k+1}, x_{j_s+k+2}, \ldots, x_{n-s-k}]$. Indeed, if $u \in I(C_n^k)$ such that $u \notin I(P_n^k)$ then $(x_{j_s}x_{n+1-s})|u$, for only one pair of s and j_s . If $(x_{j_s}x_{n+1-s})|u$, then $u = x_{j_s}^{\gamma} x_{n+1-s}^{\delta} v, v \in S_{j_s+k+1,n-s-k}$, since $v \notin I(P_n^k)$, it follows that $v \notin \mathcal{G}(I(P_n^k)) \cap S_{j_s+k+1,n-s-k}$. Clearly,

 $S_{j_s+k+1,n-s-k}/\mathcal{G}(I(P_n^k)) \cap S_{j_s+k+1,n-s-k} \cong S_{n-(j_s+2k+s)}/I(P_{n-(j_s+2k+s)}^k).$

Thus by Theorem 3.11 and [9, Lemma 3.6], we have

sdepth
$$(I(C_n^k)/I(P_n^k)) \ge \min_{s=1}^k \{\lceil \frac{n - (j_s + s + 2k)}{2k + 1} \rceil + 2\}.$$

It is easy to see that $\max\{j_s + s\} = k + 1$. Therefore

$$sdepth(I(C_n^k)/I(P_n^k)) \ge \lceil \frac{n-(3k+1)}{2k+1} \rceil + 2 = \lceil \frac{n+k+1}{2k+1} \rceil.$$

Theorem 5.4. Let $n \geq 3$, then

sdepth
$$(I(C_n^k)) \ge 2$$
, if $n \le 2k+1$;
sdepth $(I(C_n^k)) \ge \lceil \frac{n-k}{2k+1} \rceil + 1$, if $n \ge 2k+2$.

Proof. (a): Let $n \leq 2k + 1$, since the minimal generators of $I(C_n^k)$ have degree 2, so by [13, Lemma 2.1] sdepth $(I(C_n^k)) \geq 2$.

(b): Let $n \ge 2k + 2$, consider the short exact sequence

$$0 \longrightarrow I(P_n^k) \longrightarrow I(C_n^k) \longrightarrow I(C_n^k)/I(P_n^k) \longrightarrow 0,$$

then by Lemma 2.11,

$$sdepth(I(C_n^k)) \ge \min\{sdepth(I(P_n^k)), sdepth(I(C_n^k)/I(P_n^k))\}.$$

By Theorem 5.2,

$$\operatorname{sdepth}(I(P_n^k)) \ge \lceil \frac{n}{2k+1} \rceil + 1,$$

and by Proposition 5.3, we have

$$\operatorname{sdepth}(I(C_n^k)/I(P_n^k)) \ge \lceil \frac{n+k+1}{2k+1} \rceil = \lceil \frac{n-k}{2k+1} \rceil + 1,$$

this finishes the proof.

Corollary 5.5. Let $n \ge 3$, if $n \le 2k+1$, then

$$\operatorname{sdepth}(I(C_n^k)) \ge 2 = \operatorname{sdepth}(S/I(C_n^k)) + 1.$$

If $n \geq 2k+2$, then

 $sdepth(I(C_n^k)) \geq sdepth(S/I(C_n^k)), \text{ if } n \equiv 1, \dots, k \pmod{(2k+1)};$ $sdepth(I(C_n^k)) \geq sdepth(S/I(C_n^k)) + 1, \text{ if } n \equiv 0, k+1, \dots, n-1 \pmod{(2k+1)}.$

Proof. Proof follows by Corollary 4.7 and Theorem 5.4.
