# PROJECTIVE RECONSTRUCTION IN ALGEBRAIC VISION 

ATSUSHI ITO, MAKOTO MIURA, AND KAZUSHI UEDA


#### Abstract

We discuss the geometry of rational maps from a projective space of an arbitrary dimension to the product of projective spaces of lower dimensions induced by linear projections. In particular, we give an algebro-geometric variant of the projective reconstruction theorem by Hartley and Schaffalitzky HS09.


## 1. Introduction

Let $r$ be a positive integer and $\boldsymbol{m}=\left(m_{1}, \ldots, m_{r}\right)$ be a sequence of positive integers. For each $i=1, \ldots, r$, take a vector space $W_{i}$ of dimension $m_{i}+1$ over a field $\mathbf{k}$, which we assume to be an algebraically closed field of characteristic zero unless otherwise stated. Let further $V$ be a vector space satisfying $n:=\operatorname{dim} V-1>m_{i}$ for any $i=1, \ldots, r$. A sequence $\boldsymbol{s}=\left(s_{1}, \ldots, s_{r}\right)$ of surjective linear maps

induce rational maps

$$
\begin{equation*}
\varphi_{i}: \mathbb{P}^{n} \longrightarrow \mathbb{P}^{m_{i}}, \quad i=1, \ldots, r \tag{1.2}
\end{equation*}
$$

from $\mathbb{P}^{n}:=\mathbb{P}(V)$ to $\mathbb{P}^{m_{i}}:=\mathbb{P}\left(W_{i}\right)$. We call these rational maps cameras, with the model of a pinhole camera as a linear projection in mind. Correspondingly, the loci

Z_{i}:=\mathbb{P}\left(\operatorname{ker} s_{i}\right) \subset \mathbb{P}^{n}, \quad i=1, \ldots, r \tag{1.3}
\end{equation*}

of indeterminacy are called the focal loci of the cameras. The closure $X$ of the image of the rational map

\varphi:=\left(\varphi_{1}, \ldots, \varphi_{r}\right): \mathbb{P}^{n} \longrightarrow \mathbb{P}^{m}:=\prod_{i=1}^{r} \mathbb{P}^{m_{i}} \tag{1.4}
\end{equation*}
$$

is called the multiview variety in the case $n=3$ and $\boldsymbol{m}=\left(2^{r}\right)$ in AST13], and we use the same terminology for arbitrary $n$ and $\boldsymbol{m}$. In this section, we assume $|\boldsymbol{m}|:=m_{1}+\cdots+m_{r} \geq n+1$, so that the multiview variety $X$ is a proper subvariety of $\mathbb{P}^{m}$. Basic properties of multiview varieties are studied in [Li], where formulas for dimensions, multidegrees, and Hilbert polynomials are obtained and the Cohen-Macaulay property is proved.

The projective reconstruction problem asks if $\boldsymbol{\varphi}$ is determined uniquely from $X$, up to the inevitable ambiguity by the action of $\operatorname{PGL}(n+1, \mathbf{k})$. In real-life applications where $\mathbf{k}=\mathbb{R}, n=3$, and $\boldsymbol{m}=\left(2^{r}\right)$, this problem may be phrased as follows: Assume that one is given multiple pictures of one place, taken with various cameras whose positions and angles are not known at the beginning. A point correspondence is a collection of points in the pictures, consisting of one point in every picture, which is the image of the same point in the place. The set of point correspondences form an open subset of $X$. Assume that one can tell sufficiently many point correspondences, say, from the features of the objects, so that one can fix $X$ uniquely. Now the problem is whether one can 'reconstruct' the 3-dimensional configuration of objects in the place appearing on the pictures, together with the configuration of the cameras.

[^0]Each camera $\varphi_{i}: \mathbb{P}^{n} \rightarrow \mathbb{P}^{m_{i}}$ is parametrized by an open subset of the projective space $\mathbb{P}\left(V^{\vee} \otimes W_{i}\right)$, where the corresponding linear map $s_{i}$ has the full rank. Let

\begin{equation*}
\Phi: \prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right) \rightarrow \operatorname{Hilb}\left(\mathbb{P}^{m}\right) \tag{1.5}
\end{equation*}
$$

be the rational map sending a camera configuration $\varphi$ to the multiview variety $X$ considered as a point in the Hilbert scheme Hilb $\left(\mathbb{P}^{m}\right)$ of subschemes of $\mathbb{P}^{m}$. The natural right action of Aut $\left(\mathbb{P}^{n}\right)=$ $\operatorname{PGL}(n+1, \mathbf{k})$ on each $\mathbb{P}\left(V^{\vee} \otimes W_{i}\right)$ induces the diagonal action on the product $\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)$. The main result of this paper is the following:

Theorem 1.1. (1) If $\boldsymbol{m} \neq\left(1^{n+1}\right):=(1, \ldots, 1)$, then a general fiber of $\Phi$ consists of a single $\operatorname{PGL}(n+1, \mathbf{k})$-orbit.
(2) If $\boldsymbol{m}=\left(1^{n+1}\right)$, then a general fiber of $\Phi$ consists of two $\operatorname{PGL}(n+1, \mathbf{k})$-orbits.
(3) If $|\boldsymbol{m}| \geq 2 n-1$, then $\Phi$ is dominant onto an irreducible component of $\operatorname{Hilb}\left(\mathbb{P}^{\boldsymbol{m}}\right)$.

As we see in Section 6, Theorem 1.1.(11),(2) is an algebro-geometric variant of the projective reconstruction theorem by Hartley and Schaffalitzky [HS09, with a new purely algebro-geometric proof. A result closely related to Theorem 1.1)(3) for $n=3$ and $\boldsymbol{m}=\left(2^{r}\right)$ is proved in AST13, Theorem 6.3]. They use the rational map

\begin{equation*}
\gamma: G\left(n+1, \bigoplus_{i=1}^{r} W_{i}\right) / / \mathbb{G}_{m}^{r} \rightarrow \mathcal{H}_{n, \boldsymbol{m}} \tag{1.6}
\end{equation*}
$$

instead of (1.5), where $G\left(n+1, \bigoplus_{i=1}^{r} W_{i}\right) / / \mathbb{G}_{m}^{r}$ denotes a GIT quotient of the Grassmannian of $(n+1)$-dimensional subspaces in $\bigoplus_{i} W_{i}$ by an algebraic torus, and $\mathcal{H}_{n, m}$ denotes the multigraded Hilbert scheme parametrizing $\mathbb{Z}^{r}$-homogeneous ideals in the homogeneous coordinate ring of $\mathbb{P}^{m}$. Their result states that the rational map $\gamma$ dominates an irreducible component of $\mathcal{H}_{n, m}$. The bound $|\boldsymbol{m}| \geq 2 n-1$ is sharp in this case. The embedding of the space of cameras into $\operatorname{Hilb}\left(\mathbb{P}^{\boldsymbol{m}}\right)$ for $\boldsymbol{m}=\left(2^{r}\right)$ is also discussed in [V].

Note that a real configuration of cameras can naturally be viewed as a complex configuration of cameras, and a pair of real configurations of cameras are related by an action of $\operatorname{PGL}(n+1, \mathbb{R})$ if and only if they are related by an action of $\operatorname{PGL}(n+1, \mathbb{C})$. It follows that the reconstruction over $\mathbb{C}$ in Theorem 1.1.(1) implies the reconstruction over $\mathbb{R}$. See also Remark 4.5 for the fact that Theorem 1.1.(2) also holds over $\mathbb{R}$.

This paper is organized as follows: In Section 2, we collect basic facts about linear projections. The statements (1), (2), and (3) in Theorem 1.1 are proved in Sections 3, 4, and 5respectively. In Section 6, we clarify the relation of Theorem 1.1 to results by Hartley and Schaffalitzky.

## 2. The geometry of linear projections

Let $V$ and $W$ be vector spaces of dimensions $n+1$ and $m+1$ respectively with $n>m$, and set $\mathbb{P}^{n}:=\mathbb{P}(V)$ and $\mathbb{P}^{m}:=\mathbb{P}(W)$. Let further $p: \mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{n}$ and $q: \mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{m}$ be the projections to the first and the second factors. A surjective linear map $s: V \rightarrow W$ induces a linear projection

$$
\begin{equation*}
\varphi: \mathbb{P}^{n} \longrightarrow \mathbb{P}^{m} \tag{2.1}
\end{equation*}
$$

which is a dominant rational map from $\mathbb{P}^{n}$ to $\mathbb{P}^{m}$.
The locus $Z:=\mathbb{P}(\operatorname{ker} s) \subset \mathbb{P}^{n}$ of indeterminacy of $\varphi$ can be eliminated by the blow-up

\begin{equation*}
\widetilde{p}: \widetilde{X}:=\mathrm{Bl}_{Z} \mathbb{P}^{n} \rightarrow \mathbb{P}^{n} \tag{2.2}
\end{equation*}
$$

along $Z$, i.e., there exists a morphism $\widetilde{q}: \widetilde{X} \rightarrow \mathbb{P}^{m}$ making the diagram

commutative.
The exceptional divisor $E:=\widetilde{p}^{-1}(Z) \subset \widetilde{X}$ is the $\mathbb{P}^{m}$-bundle over $Z$ obtained as the projectivization of the normal bundle $N_{Z / \mathbb{P}^{n}} \cong \mathcal{O}_{\mathbb{P}^{n}}(1)^{\oplus m+1}$ of $Z$ in $\mathbb{P}^{n}$. For a hyperplane $H \subset \mathbb{P}^{n}$ containing $Z$, the closure of the image of $H$ by $\varphi$ is a hyperplane $H^{\prime}$ in $\mathbb{P}^{m}$. Since $\widetilde{p}^{*} H=\widetilde{q}^{*} H^{\prime}+E$, we have

\mathcal{O}_{\tilde{X}}(E) \cong \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(H) \otimes \widetilde{q}^{*} \mathcal{O}_{\mathbb{P}^{m}}\left(-H^{\prime}\right) \cong \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}^{*} \mathcal{O}_{\mathbb{P}^{m}}(-1) . \tag{2.4}
\end{equation*}
$$

The morphism

$$
\begin{equation*}
\widetilde{p} \times \widetilde{q}: \widetilde{X} \rightarrow \mathbb{P}^{n} \times \mathbb{P}^{m} \tag{2.5}
\end{equation*}
$$

is an embedding, which allows one to identify $\widetilde{X}$ with the closure of the graph of the rational map $\varphi$. Under this embedding, the morphisms $\widetilde{p}$ and $\widetilde{q}$ are restrictions of the projections $p$ and $q$ respectively.

The Euler sequence

$$
\begin{equation*}
0 \rightarrow \mathcal{O}_{\mathbb{P}^{m}}(-1) \rightarrow W \otimes \mathcal{O}_{\mathbb{P}^{m}} \rightarrow T_{\mathbb{P}^{m}}(-1) \rightarrow 0 \tag{2.6}
\end{equation*}
$$

gives $H^{0}\left(T_{\mathbb{P}^{m}}(-1)\right) \cong W$, which together with $H^{0}\left(\mathcal{O}_{\mathbb{P}^{n}}(1)\right) \cong V^{\vee}$ shows

$$
\begin{equation*}
H^{0}\left(p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes q^{*} T_{\mathbb{P}^{m}}(-1)\right) \cong H^{0}\left(\mathcal{O}_{\mathbb{P}^{n}}(1)\right) \otimes H^{0}\left(T_{\mathbb{P}^{m}}(-1)\right) \cong V^{\vee} \otimes W . \tag{2.7}
\end{equation*}
$$

Let $s_{\mathbb{P}}$ be the element of $H^{0}\left(p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes q^{*} T_{\mathbb{P}^{m}}(-1)\right)$ corresponding to $s \in V^{\vee} \otimes W$ under the isomorphism (2.7). Since $T_{\mathbb{P}^{m}}(-1)$ is the universal quotient bundle on $\mathbb{P}^{m}$, a point $\left(\ell_{1}, \ell_{2}\right) \in \mathbb{P}^{n} \times \mathbb{P}^{m}$ (i.e., a pair of one-dimensional subspaces $\ell_{1} \subset V$ and $\ell_{2} \subset W$ ) is in $s_{\mathbb{P}}^{-1}(0)$ if and only if $s\left(\ell_{1}\right) \subset \ell_{2}$. In other words, the zero locus of $s_{\mathbb{P}}$ is precisely the graph $\widetilde{X}$ of $\varphi$;

$$
\begin{equation*}
s_{\mathbb{P}}^{-1}(0)=\widetilde{X} \subset \mathbb{P}^{n} \times \mathbb{P}^{m} \tag{2.8}
\end{equation*}
$$

The pull-back of the Euler sequence (2.6) to $\widetilde{X}$ tensored with $\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1)$ gives

$$
\begin{equation*}
0 \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}^{*} \mathcal{O}_{\mathbb{P}^{m}}(-1) \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}^{*} T_{\mathbb{P}^{m}}(-1) \rightarrow 0 \tag{2.9}
\end{equation*}
$$

Let $s_{\tilde{X}} \in H^{0}\left(\widetilde{X}, \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W\right)$ be the section corresponding to $s \in V^{\vee} \otimes W$ under the isomorphism

$$
\begin{align*}
H^{0}\left(\tilde{X}, \tilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W\right) & \cong H^{0}\left(\mathbb{P}^{n}, \widetilde{p}_{*} \tilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1)\right) \otimes W  \tag{2.10}\\
& \cong H^{0}\left(\mathbb{P}^{n}, \mathcal{O}_{\mathbb{P}^{n}}(1)\right) \otimes W  \tag{2.11}\\
& \cong V^{\vee} \otimes W \tag{2.12}
\end{align*}
$$

The section $s_{\tilde{X}}$ lies in the image of the injection

$$
\begin{equation*}
H^{0}\left(\widetilde{X}, \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}^{*} \mathcal{O}_{\mathbb{P}^{m}}(-1)\right) \hookrightarrow H^{0}\left(\widetilde{X}, \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W\right) \tag{2.13}
\end{equation*}
$$

induced by (2.9), since its image by the map

$$
\begin{equation*}
H^{0}\left(\widetilde{X}, \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W\right) \rightarrow H^{0}\left(\widetilde{X}, \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}^{*} T_{\mathbb{P}^{m}}(-1)\right) \tag{2.14}
\end{equation*}
$$

induced by (2.9) is zero by (2.8). It follows from (2.4) and $h^{0}\left(\mathcal{O}_{\tilde{X}}(E)\right)=1$ that $s_{\tilde{X}}^{-1}(0)=E$.

## 3. Projective reconstruction in the case $\boldsymbol{m} \neq\left(1^{n+1}\right)$

We keep the same notations as in Section 1, and write the projections as $p: \mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{n}$, $q_{i}: \mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{m_{i}}, \boldsymbol{q}:=\left(q_{1}, \ldots, q_{r}\right): \mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{m}$ and $\varpi_{i}: \mathbb{P}^{m} \rightarrow \mathbb{P}^{m_{i}}$. We do not assume $|\boldsymbol{m}| \geq n+1$ unless otherwise stated. The Euler sequence

$$
\begin{equation*}
0 \rightarrow \mathcal{O}_{\mathbb{P}^{m_{i}}}(-1) \rightarrow W_{i} \otimes \mathcal{O}_{\mathbb{P}^{m_{i}}} \rightarrow T_{\mathbb{P}^{m_{i}}}(-1) \rightarrow 0 \tag{3.1}
\end{equation*}
$$

gives $H^{0}\left(T_{\mathbb{P}^{m}}(-1)\right)=W_{i}$, which together with $H^{0}\left(\mathcal{O}_{\mathbb{P}^{n}}(1)\right)=V^{\vee}$ shows

\begin{equation*}
H^{0}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}, \bigoplus_{i=1}^{r} p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes q_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)\right)=\bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i} \cong \bigoplus_{i=1}^{r} \operatorname{Hom}\left(V, W_{i}\right) \tag{3.2}
\end{equation*}
$$

We abuse notation and identify $s \in \bigoplus_{i=1}^{r} \operatorname{Hom}\left(V, W_{i}\right)$ with the corresponding global section of $\bigoplus_{i=1}^{r} p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes q_{i}^{*} T_{\mathbb{P}^{m}}(-1)$ on $\mathbb{P}^{n} \times \mathbb{P}^{m}$. Let $\widetilde{X} \subset \mathbb{P}^{n} \times \mathbb{P}^{m}$ be the closure of the graph of the rational map $\boldsymbol{\varphi}: \mathbb{P}^{n} \rightarrow \mathbb{P}^{m}$, and set $\widetilde{p}:=\left.p\right|_{\tilde{X}}, \widetilde{q}_{i}:=\left.q_{i}\right|_{\tilde{X}}$, and $\widetilde{\boldsymbol{q}}:=\left.\boldsymbol{q}\right|_{\tilde{X}}$, so that we have the diagram


In all the statements, such as lemmas, propositions, and theorems, through the rest of this paper, we assume that the section $s$ is general.
Lemma 3.1. Let $Z_{s} \subset \mathbb{P}^{n} \times \mathbb{P}^{m}$ be the zero locus of the section $\boldsymbol{s}$ in (3.2). For $z \in \mathbb{P}^{n}$, one has

\begin{equation*}
Z_{s} \cap p^{-1}(z)=\{z\} \times \prod_{i: z \notin Z_{i}} \varphi_{i}(z) \times \prod_{i: z \in Z_{i}} \mathbb{P}^{m_{i}} . \tag{3.4}
\end{equation*}
$$

Proof. Let $v \in V$ be a vector corresponding to $z \in \mathbb{P}^{n}=\mathbb{P}(V)$. Then $Z_{s} \cap p^{-1}(z) \subset\{z\} \times \mathbb{P}^{m}$ coincides with the zero locus of the section

$$
\begin{equation*}
\left(s_{1}(v), \ldots, s_{r}(v)\right) \in \bigoplus_{i=1}^{r} W_{i} \cong H^{0}\left(\mathbb{P}^{m}, \bigoplus_{i=1}^{r} \varpi_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)\right) \tag{3.5}
\end{equation*}
$$

For each $i$, the zero locus of $s_{i}(v) \in H^{0}\left(\mathbb{P}^{m_{i}}, T_{\mathbb{P}^{m_{i}}}(-1)\right)$ is $\varphi_{i}(z)$ (resp. $\left.\mathbb{P}^{m_{i}}\right)$ if $s_{i}(v) \neq 0$ (resp. $s_{i}(v)=0$ ). Since $s_{i}(v)=0$ if and only if $z \in Z_{i}$, we have (3.4).

Lemma 3.2. The zero locus $Z_{s}$ coincides with $\widetilde{X}$.
Proof. Since $\mathbb{P}^{n}$ is irreducible, the closure $\widetilde{X}$ of the graph of $\varphi$ is irreducible of dimension $n$. By Lemma 3.1, the generic point of $\widetilde{X}$ and hence $\widetilde{X}$ itself are contained in $Z_{s}$. Euler sequences show that $T_{\mathbb{P}^{m_{i}}}(-1)$ are globally generated, and hence so is $\bigoplus_{i=1}^{r} p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes q_{i}^{*} T_{\mathbb{P}^{m}}(-1)$. Since $\boldsymbol{s}$ is a general section of a globally generated bundle, the zero of $s$ is smooth of dimension $n$ by a generalization of the theorem of Bertini [Muk92, Theorem 1.10]. Since $Z_{s}$ is smooth and all fibers of $Z_{s} \rightarrow \mathbb{P}^{n}$ are irreducible by Lemma 3.1, $Z_{s}$ is irreducible as well. It follows that $\widetilde{X}$ and $Z_{s}$ are equal, since $\widetilde{X} \subset Z_{s}$ and they are irreducible of the same dimension.

We regard the section $\boldsymbol{q}_{*} s \in H^{0}\left(\mathbb{P}^{m}, V^{\vee} \otimes \bigoplus_{i=1}^{r} \varpi_{i}^{*} T_{\mathbb{P}} m_{i}(-1)\right)$ as a morphism

\begin{equation*}
V \otimes \mathcal{O}_{\mathbb{P}^{m}} \rightarrow \bigoplus_{i=1}^{r} \varpi_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1) \tag{3.6}
\end{equation*}
$$

on $\mathbb{P}^{m}$. It follows from the definition of $Z_{s}=\widetilde{X}$ that

$$
\begin{equation*}
\widetilde{\boldsymbol{q}}^{-1}(x)=\mathbb{P}\left(\operatorname{ker}\left(\boldsymbol{q}_{*} \boldsymbol{s} \otimes k(x)\right)\right) \times\{x\} \subset \mathbb{P}^{n} \times \mathbb{P}^{m} \tag{3.7}
\end{equation*}
$$

for any $x \in \mathbb{P}^{m}$, where

$$
\boldsymbol{q}_{*} \boldsymbol{s} \otimes k(x): V \rightarrow \bigoplus_{\substack{i=1 \\ 4}}^{r} \varpi_{i}^{*} T_{\mathbb{P} m_{i}}(-1) \otimes k(x)
$$

is the induced linear map tensoring by $k(x)$. For $0 \leq j \leq \min \{n+1,|\boldsymbol{m}|\}$, let $X_{j} \subset \mathbb{P}^{\boldsymbol{m}}$ be the $j$-th degeneracy locus of $\boldsymbol{q}_{*} s$ defined as the zero of

\left(\boldsymbol{q}_{*} s\right)^{\wedge(j+1)}: \bigwedge^{j+1} V \otimes \mathcal{O}_{\mathbb{P}^{m}} \rightarrow \bigwedge_{j+1}^{\bigoplus_{i=1}^{r}} \varpi_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1) \tag{3.8}
\end{equation*}
$$

that is, the locus where the rank of $\boldsymbol{q}_{*} s$ is at most $j$. Hence one has

$$
\begin{equation*}
\operatorname{dim} \operatorname{ker}\left(\boldsymbol{q}_{*} \boldsymbol{s} \otimes k(x)\right)=n+1-j \tag{3.9}
\end{equation*}
$$

for $x \in X_{j} \backslash X_{j-1}$. In particular, one has

$$
\begin{equation*}
X=X_{n} . \tag{3.10}
\end{equation*}
$$

As $T_{\mathbb{P}^{m_{i}}}(-1)$ is globally generated, so is $V^{\vee} \otimes \bigoplus_{i=1}^{r} \varpi_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)$. Since $\boldsymbol{q}_{*} \boldsymbol{s}$ is a general section of a globally generated vector bundle, one has $X_{j}=\emptyset$ or

$$
\begin{equation*}
\operatorname{codim}\left(X_{j} / \mathbb{P}^{\boldsymbol{m}}\right)=(n+1-j)(|\boldsymbol{m}|-j) \tag{3.11}
\end{equation*}
$$

by [Ott95, Theorem 2.8]. If $|\boldsymbol{m}| \geq n+1$, the dimension of $X_{n-1}$ is at most

$$
\begin{align*}
|\boldsymbol{m}|-(n+1-(n-1))(|\boldsymbol{m}|-(n-1)) & =|\boldsymbol{m}|-2(|\boldsymbol{m}|-n+1)  \tag{3.12}\\
& =2 n-|\boldsymbol{m}|-2  \tag{3.13}\\
& \leq n-3 . \tag{3.14}
\end{align*}
$$

Since $\widetilde{\boldsymbol{q}}: \widetilde{X} \rightarrow X$ is an isomorphism over $X \backslash X_{n-1}$ by (3.7) and $\widetilde{X}$ is smooth, $X \backslash X_{n-1}$ is smooth. Thus $X=X_{n}$ is smooth in codimension one. Since $X_{n}$ is Cohen-Macaulay by ACGH85, Chapter II], $X$ is normal.

A morphism is said to be small if it is an isomorphism in codimension one.
Lemma 3.3. If $|\boldsymbol{m}| \geq n+1$, the morphism $\widetilde{\boldsymbol{q}}: \widetilde{X} \rightarrow X$ is small.
Proof. It follows from (3.7) that $\widetilde{\boldsymbol{q}}$ is an isomorphism over $X_{n} \backslash X_{n-1}$ and

$$
\begin{align*}
\operatorname{dim} \widetilde{\boldsymbol{q}}^{-1}\left(X_{n-1}\right) & =\max \left\{\operatorname{dim}\left(X_{j} \backslash X_{j-1}\right)+n-j \mid 0 \leq j \leq n-1\right\}  \tag{3.15}\\
& \leq \max \{|\boldsymbol{m}|-(n+1-j)(|\boldsymbol{m}|-j)+n-j \mid 0 \leq j \leq n-1\}  \tag{3.16}\\
& =\max \{j-(n-j)(|\boldsymbol{m}|-j-1) \mid 0 \leq j \leq n-1\}  \tag{3.17}\\
& =2 n-|\boldsymbol{m}|-1  \tag{3.18}\\
& \leq n-2, \tag{3.19}
\end{align*}
$$

hence $\widetilde{\boldsymbol{q}}$ is small.
Since $s_{i}: p^{*} \mathcal{O}_{\mathbb{P}^{n}}(-1) \rightarrow q_{i}^{*} T_{\mathbb{P}^{m}}(-1)$ is zero on $\widetilde{X}$, we see by a similar argument in Section 2 that its restriction $\left.s_{i}\right|_{\tilde{X}}$ is a global section of $\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} \mathcal{O}_{\mathbb{P}^{m}}(-1)$ by the exact sequence on $\widetilde{X}$

$$
\begin{equation*}
0 \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} \mathcal{O}_{\mathbb{P}^{m} m_{i}}(-1) \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W_{i} \rightarrow \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1) \rightarrow 0 \tag{3.20}
\end{equation*}
$$

Let $E_{i} \subset \widetilde{X}$ be the Cartier divisor defined by this section.
By (2.8), $\mathrm{Bl}_{Z_{i}} \mathbb{P}^{n} \subset \mathbb{P}^{n} \times \mathbb{P}^{m_{i}}$ is the zero locus of $\left(s_{i}\right)_{\mathbb{P}}$, where we use the notation in Section 2, Since $\widetilde{X}$ is the zero locus of $\boldsymbol{s}=\left(s_{1}, \ldots, s_{r}\right), \widetilde{p}: \widetilde{X} \rightarrow \mathbb{P}^{n}$ factors as $\widetilde{X} \rightarrow \mathrm{Bl}_{z_{i}} \mathbb{P}^{n} \rightarrow \mathbb{P}^{n}$ by projections $\mathbb{P}^{n} \times \mathbb{P}^{m} \rightarrow \mathbb{P}^{n} \times \mathbb{P}^{m_{i}} \rightarrow \mathbb{P}^{n}$. As in the last paragraph in Section 2, $s_{i}$ induces a global section $\left(s_{i}\right)_{\mathrm{Bl}_{z_{i}} \mathbb{P}^{n}}$ on $\mathrm{Bl}_{Z_{i}} \mathbb{P}^{n}$ whose zero locus in the exceptional divisor, and $\left.s_{i}\right|_{\tilde{X}}$ is nothing but the pullback of $\left(s_{i}\right)_{\mathrm{Bl}_{z_{i}} \mathbb{P}^{n}}$. Hence $E_{i}$ is the total transform of the exceptional divisor of $\mathrm{Bl}_{Z_{i}} \mathbb{P}^{n}$. In particular, $E_{i}=\widetilde{p}^{-1}\left(Z_{i}\right)$ holds.

Lemma 3.4. (1) The restriction of $\widetilde{p}$ to $\widetilde{X} \backslash \bigcup_{i=1}^{r} E_{i}$ is an isomorphism onto $\mathbb{P}^{n} \backslash \bigcup_{i=1}^{r} Z_{i}$.
(2) For each $i=1, \ldots, r$, the divisor $E_{i}$ is irreducible.
(3) One has $\widetilde{\boldsymbol{q}}\left(E_{1}\right)=\mathbb{P}^{m_{1}} \times \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)}$, and similarly for $\widetilde{\boldsymbol{q}}\left(E_{i}\right)$ for $i=2, \ldots, r$.

Proof. (1) holds since the rational map $\varphi$ is defined on $\mathbb{P}^{n} \backslash \bigcup_{i=1}^{r} Z_{i}$ and $\widetilde{X}$ is the graph of $\boldsymbol{\varphi}$.
(2) It follows from Lemma 3.1 that $\widetilde{p}^{-1}\left(Z_{i} \backslash \bigcup_{j \neq i} Z_{j}\right)$ is irreducible of dimension $n-1$ and $\operatorname{dim} \widetilde{p}^{-1}\left(Z_{i} \cap\right.$ $\left.\bigcup_{j \neq i} Z_{j}\right)<n-1$. Since $E_{i}$ is a Cartier divisor, all irreducible components are $n$-1-dimensional, and hence $E_{i}$ is irreducible.
(3) By Lemma 3.1 and Lemma 3.2, $\widetilde{p}^{-1}(z)=\widetilde{X} \cap p^{-1}(z)$ coincides with

$$
\{z\} \times \mathbb{P}^{m_{1}} \times \varphi_{2}(z) \times \cdots \times \varphi_{r}(z)
$$

for all $z \in Z_{1} \backslash \bigcup_{j \neq 1} Z_{j}$. Hence the image of $\widetilde{p}^{-1}\left(Z_{1} \backslash \bigcup_{j \neq 1} Z_{j}\right)$ by $\widetilde{\boldsymbol{q}}$ is $\mathbb{P}^{m_{1}} \times\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1} \backslash \bigcup_{j \neq 1} Z_{j}\right)$. Since $\widetilde{p}^{-1}\left(Z_{1} \backslash \bigcup_{j \neq 1} Z_{j}\right)$ is dense in $E_{1}$, we have (3).

From now on, we assume $|\boldsymbol{m}| \geq n+1$. Lemma 3.3 implies that $\widetilde{\boldsymbol{q}}\left(E_{i}\right)$ is a prime Weil divisor on $X$. We set

$$
\begin{equation*}
L_{i}:=\left.\varpi_{i}^{*} \mathcal{O}_{\mathbb{P}^{m_{i}}}(1)\right|_{X} \tag{3.21}
\end{equation*}
$$

for $i=1, \ldots, r$.
Lemma 3.5. The rational map defined by $\left|\mathcal{O}_{X}\left(\widetilde{\boldsymbol{q}}\left(E_{1}\right)\right) \otimes L_{1}\right|$ is inverse to the rational map $\varphi: \mathbb{P}^{n} \rightarrow$ $X$ up to $\operatorname{Aut}\left(\mathbb{P}^{n}\right)$.

Proof. For a linear system $\Lambda$, we let $\phi_{\Lambda}$ denote the rational map defined by $\Lambda$.
Since $X$ is normal and $\widetilde{\boldsymbol{q}}$ is small, we have

$$
\begin{equation*}
H^{0}\left(X, \mathcal{O}_{X}\left(\widetilde{\boldsymbol{q}}\left(E_{1}\right)\right) \otimes L_{1}\right)=H^{0}\left(\widetilde{X}, \mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}^{m_{1}}}(1)\right) \tag{3.22}
\end{equation*}
$$

and the rational map $\phi_{\left|\mathcal{O}_{X}\left(\widetilde{\boldsymbol{q}}\left(E_{1}\right)\right) \otimes L_{1}\right|}$ coincides with the composite map $\phi_{\left|\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}}^{m_{1}}(1)\right|} \circ \widetilde{\boldsymbol{q}}^{-1}$.
Since $\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \cong \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}^{m}}(-1)$, we have $\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}^{m}}(1) \cong \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1)$. Thus the rational map $\phi_{\left|\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}^{m_{1}}(1) \mid}\right|}$ coincides with $\phi_{\left|\widetilde{p}^{*} \mathcal{O}_{\mathbb{P} n}(1)\right|}=\widetilde{p}$ up to $\operatorname{Aut}\left(\mathbb{P}^{n}\right)$. Hence $\phi_{\left|\mathcal{O}_{X}\left(\widetilde{\boldsymbol{q}}\left(E_{1}\right)\right) \otimes L_{1}\right|}=$ $\phi_{\left|\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}} m_{1}(1)\right|} \circ \widetilde{\boldsymbol{q}}^{-1}$ coincides with $\widetilde{p} \circ \widetilde{\boldsymbol{q}}^{-1}=\boldsymbol{\varphi}^{-1}$ up to $\operatorname{Aut}\left(\mathbb{P}^{n}\right)$.

Lemma 3.5 shows that we can reconstruct $\varphi$ up to $\operatorname{Aut}\left(\mathbb{P}^{n}\right)$ from $X$ and $\widetilde{\boldsymbol{q}}\left(E_{1}\right)$. Lemma 3.6 below shows that $\widetilde{\boldsymbol{q}}\left(E_{1}\right)$ is uniquely determined by $X \subset \mathbb{P}^{\boldsymbol{m}}$ if $|\boldsymbol{m}| \geq n+2$ or $|\boldsymbol{m}|=n+1$ and $m_{1} \geq 2$.
Lemma 3.6. Assume $|\boldsymbol{m}| \geq n+2$ or $|\boldsymbol{m}|=n+1$ and $m_{1} \geq 2$. Then $\widetilde{\boldsymbol{q}}\left(E_{1}\right)$ is the unique Weil divisor on $X$ of the form $\mathbb{P}^{m_{1}} \times Y$ for some $Y \subset \prod_{i \neq 1} \mathbb{P}^{m_{i}}$.
Proof. By Lemma 3.4 (3), $\widetilde{\boldsymbol{q}}\left(E_{1}\right)$ is a Weil divisor of such form.
Assume there exists a subvariety $Y \subset \prod_{i \neq 1} \mathbb{P}^{m_{i}}$ of dimension $n-1-m_{1}$ such that $D=\mathbb{P}^{m_{1}} \times Y$ is contained in $X$ and $D \neq \widetilde{\boldsymbol{q}}\left(E_{1}\right)$. Let $\widetilde{X}^{\dagger} \subset \mathbb{P}^{n} \times \prod_{i \neq 1} \mathbb{P}^{m_{i}}$ and $X^{\dagger} \subset \prod_{i \neq 1} \mathbb{P}^{m_{i}}$ be the subvarieties obtained from $\left(s_{2}, \ldots, s_{r}\right)$ in the same way as $\widetilde{X}$ and $X$. Consider the diagram

where $\pi, \tilde{\pi}, \widetilde{\boldsymbol{q}}^{\dagger}$ are induced by the natural projections. Lemma 3.4 shows that $E_{1}$ is the unique divisor contracted by $\tilde{\pi}$. Since $\widetilde{\boldsymbol{q}}$ is small and $D \neq \widetilde{\boldsymbol{q}}\left(E_{1}\right)$, we have a divisor $\widetilde{D}^{\dagger} \subset \widetilde{X}^{\dagger}$, which is the strict transform of $D$ by the birational map $\tilde{\pi} \circ \widetilde{\boldsymbol{q}}^{-1}$. Since $D=\mathbb{P}^{m_{1}} \times Y$, one has $\pi(D)=Y$ and hence $\widetilde{\boldsymbol{q}}^{\dagger}\left(\widetilde{D}^{\dagger}\right)=Y$.

Since $\operatorname{dim} \widetilde{D}^{\dagger}-\operatorname{dim} Y=m_{1}$, it follows from (3.7) and (3.9) for $\widetilde{\boldsymbol{q}}^{\dagger}, \widetilde{X}^{\dagger}, X^{\dagger}$ that $Y$ must be contained in $X_{n-m_{1}}^{\dagger}$, where we define the degeneracy locus $X_{n-m_{1}}^{\dagger}$ in the same way as $X_{j}$. On the other hand, the dimension of $X_{n-m_{1}}^{\dagger}$ is at most

$$
\begin{equation*}
\sum_{i \neq 1} m_{i}-\left(n+1-\left(n-m_{1}\right)\right)\left(\sum_{i \neq 1} m_{i}-\left(n-m_{1}\right)\right)=\sum_{i \neq 1} m_{i}-\left(m_{1}+1\right)(|\boldsymbol{m}|-n) . \tag{3.24}
\end{equation*}
$$

Hence we have

$$
\begin{equation*}
n-1-m_{1}=\operatorname{dim} Y \leq \operatorname{dim} X_{n-m_{1}}^{\dagger} \leq \sum_{i \neq 1} m_{i}-\left(m_{1}+1\right)(|\boldsymbol{m}|-n), \tag{3.25}
\end{equation*}
$$

which implies $m_{1}(|\boldsymbol{m}|-n) \leq 1$. This contradicts the assumption $|\boldsymbol{m}| \geq n+2$ or $|\boldsymbol{m}|=n+1$ and $m_{1} \geq 2$.
Proof of Theorem [1.1. (1). Let $X$ be the multiview variety for general $\varphi$. To show that $X \subset \mathbb{P}^{m}$ determines the rational map $\varphi$ uniquely up to the action of $\operatorname{Aut}\left(\mathbb{P}^{n}\right) \cong \operatorname{PGL}(n+1, \mathbf{k})$, it suffices to see that the inverse $\boldsymbol{\varphi}^{-1}$ is uniquely determined by $X \subset \mathbb{P}^{m}$ up to $\operatorname{PGL}(n+1, \mathbf{k})$.

Assume $|\boldsymbol{m}| \geq n+1$ and $\boldsymbol{m} \neq\left(1^{n+1}\right):=(1, \ldots, 1)$. Relabeling the indexes of $m_{i}$ if necessary, we may assume that $|\boldsymbol{m}| \geq n+2$ or $|\boldsymbol{m}|=n+1$ and $m_{1} \geq 2$. Then Lemma 3.6 states that $X \subset \mathbb{P}^{\boldsymbol{m}}$ uniquely determines $\widetilde{\boldsymbol{q}}\left(E_{1}\right) \subset X$ without using $\boldsymbol{\varphi}, \widetilde{\boldsymbol{q}}$, etc. Hence $X \subset \mathbb{P}^{m}$ uniquely determines $\boldsymbol{\varphi}^{-1}$ by Lemma 3.5. The inevitable ambiguity by the action of $\operatorname{PGL}(n+1, \mathbf{k})$ comes from the identification of $\phi_{\left|\mathcal{O}_{\tilde{X}}\left(E_{1}\right) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}} m_{1}(1)\right|}$ with $\phi_{\left|\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}}(1)\right|}=\widetilde{p}$.

## 4. Projective reconstruction in the case $\boldsymbol{m}=\left(1^{n+1}\right)$

Assume $r=n+1$ and $m_{i}=1$ for any $1 \leq i \leq n+1$. Note that $\mathbb{P}\left(W_{i}\right)$ can be canonically identified with $\mathbb{P}\left(W_{i}^{\vee}\right)$ since $\operatorname{dim} W_{i}=2$. Set

$$
\begin{equation*}
V^{\prime}:=(\operatorname{coker} \boldsymbol{s})^{\vee}, \tag{4.1}
\end{equation*}
$$

which is $(n+1)$-dimensional since $s=\left(s_{1}, \ldots, s_{n+1}\right): V \rightarrow \bigoplus_{i=1}^{n+1} W_{i}$ is general. The canonical inclusion

$$
\begin{equation*}
\boldsymbol{s}^{\prime}: V^{\prime} \rightarrow\left(\bigoplus_{i=1}^{n+1} W_{i}\right)^{\vee}=\bigoplus_{i=1}^{n+1} W_{i}^{\vee} \tag{4.2}
\end{equation*}
$$

defines a hypersurface

$$
\begin{equation*}
X^{\prime} \subset \prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}^{\vee}\right)=\left(\mathbb{P}^{1}\right)^{n+1} \tag{4.3}
\end{equation*}
$$

in the same way as $X$. We also define $\widetilde{X}^{\prime}, E_{i}^{\prime}, \widetilde{\boldsymbol{q}}^{\prime}$, etc. in the same way as $X$.
Lemma 4.1. The hypersurfaces $X$ and $X^{\prime}$ coincide under the canonical identifications $\mathbb{P}\left(W_{i}\right)=$ $\mathbb{P}\left(W_{i}^{\vee}\right)$ for $i=1, \ldots, n+1$.
Proof. On $\prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)$, we have a diagram


A point $x \in \prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)$ is contained in $X=X_{n}$ if and only if the rank of the linear map

$$
\begin{equation*}
\boldsymbol{q}_{*} \boldsymbol{s} \otimes k(x): V \rightarrow \bigoplus_{i=1}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \otimes k(x) \tag{4.5}
\end{equation*}
$$

is at most $n$, that is, $\boldsymbol{q}_{*} \boldsymbol{s} \otimes k(x)$ is not injective. By (4.4), this is equivalent to the condition that

$$
\begin{equation*}
s(V) \cap \bigoplus_{i=1}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(-1) \otimes k(x) \neq\{0\} \tag{4.6}
\end{equation*}
$$

where we take the intersection as subspaces of $\bigoplus_{i=1}^{n+1} W_{i}$. By (4.4) again, this is equivalent to the condition that the rank of the linear map

$$
\begin{equation*}
\bigoplus_{i=1}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(-1) \otimes k(x) \rightarrow\left(V^{\prime}\right)^{\vee} \tag{4.7}
\end{equation*}
$$

is at most $n$. Under the identification $\mathbb{P}\left(W_{i}^{\vee}\right)=\mathbb{P}\left(W_{i}\right)$, the sheaf $T_{\mathbb{P}\left(W_{i}^{\vee}\right)}(-1)$ is identified with $\mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1)$. Hence the rank of the linear map (4.7) is at most $n$ if and only if $x$ is contained in $X^{\prime}$. Thus $X=X^{\prime}$ holds.

Recall from Lemma 3.4 that $\widetilde{\boldsymbol{q}}\left(E_{1}\right)=\mathbb{P}\left(W_{1}\right) \times \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)}$. Similarly, one has $\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)=$ $\mathbb{P}\left(W_{1}^{\vee}\right) \times \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$.
Lemma 4.2. The closure $\overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)} \subset \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$ is the $(n-2)$-th degeneracy locus of the composite map

$$
\begin{equation*}
\left(\operatorname{ker} s_{1}\right) \otimes \mathcal{O}_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)} \hookrightarrow V \otimes \mathcal{O}_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)} \xrightarrow{\left(s_{2}, \ldots, s_{n+1}\right)} \bigoplus_{i=2}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \tag{4.8}
\end{equation*}
$$

where we use the same letter $\varpi_{i}$ for the projection $\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right) \rightarrow \mathbb{P}\left(W_{i}\right)$. On the other hand, the closure $\overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)} \subset \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}^{\vee}\right)=\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$ is the $(n-1)$-th degeneracy locus of

$$
\begin{equation*}
\left(s_{2}, \ldots, s_{n+1}\right): V \otimes \mathcal{O}_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)} \rightarrow \bigoplus_{i=2}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \tag{4.9}
\end{equation*}
$$

Proof. The first statement follows by applying (3.10) to $\left.\left(\varphi_{2}, \ldots, \varphi_{r}\right)\right|_{Z_{1}}: Z_{1}=\mathbb{P}\left(\operatorname{ker} s_{1}\right) \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$. Since $s_{1}: V \rightarrow W_{1}$ is surjective, we have an exact sequence

$$
\begin{equation*}
0 \rightarrow \operatorname{ker} s_{1} \rightarrow \bigoplus_{i=2}^{n+1} W_{i} \rightarrow\left(V^{\prime}\right)^{\vee} \rightarrow 0 \tag{4.10}
\end{equation*}
$$

which gives a diagram

on $\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$. By an argument similar to that in the proof of Lemma 4.1, we see that the $(n-2)$-th degeneracy locus of (4.8) coincides with the $(n-1)$-th degeneracy locus of $\bigoplus_{i=2}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(-1) \rightarrow$ $\left(V^{\prime}\right)^{\vee} \otimes \mathcal{O}$, that is, the $(n-1)$-th degeneracy locus of $V^{\prime} \otimes \mathcal{O} \rightarrow \bigoplus_{i=2}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1)$ on $\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$.

By replacing $X$ with $X^{\prime}$, we see that $\overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)} \subset \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$ is the $(n-1)$-th degeneracy locus of (4.9) since $V^{\prime}$ and $\varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1)$ are replaced by $V$ and $\varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1)$ respectively.

We note that (4.9) does not depend on $s_{i}$, hence neither does $\overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$.
Lemma 4.3. One has $\widetilde{\boldsymbol{q}}\left(E_{1}\right) \neq \widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)$.
Proof. It suffices to see $\overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)} \neq \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$. Take a general point $y \in \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$. By Lemma 4.2, the rank of

$$
\begin{equation*}
\left(s_{2}, \ldots, s_{n+1}\right)_{y}: V \rightarrow \bigoplus_{i=2}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \otimes k(y) \tag{4.12}
\end{equation*}
$$

is $n-1$ since $s_{2}, \ldots, s_{n+1}$ and $y$ are general. Hence $\operatorname{ker}\left(s_{2}, \ldots, s_{n+1}\right)_{y} \subset V$ is two-dimensional. Then $\operatorname{ker}\left(s_{2}, \ldots, s_{n+1}\right)_{y} \cap \operatorname{ker} s_{1}=\{0\} \subset V$ since $\operatorname{ker} s_{1} \subset V$ is of codimension two and general. This means that (4.8) has rank $n-1$ at $y$. By Lemma 4.2, we have $y \notin \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)}$.

Lemma 4.3 and Lemma 4.4 below show that we have exactly two reconstructions:
Lemma 4.4. The exceptional locus of the birational morphism $X \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$ is the union of $\widetilde{\boldsymbol{q}}\left(E_{1}\right)$ and $\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)$.

Proof. Since $X \subset \mathbb{P}\left(W_{1}\right) \times \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$, the exceptional locus of $X \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$ is

$$
\begin{equation*}
\mathbb{P}\left(W_{1}\right) \times\left\{y \in \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right) \mid \mathbb{P}\left(W_{1}\right) \times\{y\} \subset X\right\} \subset X \tag{4.13}
\end{equation*}
$$

Hence we need to show

$$
\begin{equation*}
\left\{y \in \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right) \mid \mathbb{P}\left(W_{1}\right) \times\{y\} \subset X\right\}=\overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)} \cup \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)} \tag{4.14}
\end{equation*}
$$

Since $\widetilde{\boldsymbol{q}}\left(E_{1}\right)=\mathbb{P}\left(W_{1}\right) \times \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)}$ and $\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)=\mathbb{P}\left(W_{1}^{\vee}\right) \times \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$, the inclusion $\supset$ in (4.14) is clear. To show the converse inclusion, we take $y \notin \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)} \cup \overline{\left(\varphi_{2}^{\prime}, \ldots, \varphi_{r}^{\prime}\right)\left(Z_{1}^{\prime}\right)}$ and show $\mathbb{P}\left(W_{1}\right) \times\{y\} \not \subset X$. By Lemma 4.2, the linear map

$$
\begin{equation*}
\left(s_{2}, \ldots, s_{n+1}\right)_{y}: V \rightarrow U:=\bigoplus_{i=2}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \otimes k(y) \tag{4.15}
\end{equation*}
$$

has rank $n$ and the restriction $\left.\left(s_{2}, \ldots, s_{n+1}\right)_{y}\right|_{\text {ker } s_{1}}$ has rank $n-1$. Recall that the dimensions of $V, U$, and $\operatorname{ker} s_{1}$ are $n+1, n$, and $n-1$ respectively. Hence $\operatorname{ker}\left(s_{2}, \ldots, s_{n+1}\right)_{y} \subset V$ is one-dimensional and $\operatorname{ker}\left(s_{2}, \ldots, s_{n+1}\right)_{y} \cap \operatorname{ker} s_{1}=\{0\} \subset V$. Let $K \subset W_{1}$ be the image of $\operatorname{ker}\left(s_{2}, \ldots, s_{n+1}\right)_{y}$ by $s_{1}: V \rightarrow W_{1}$. Then we have a diagram

on $\mathbb{P}\left(W_{1}\right) \times\{y\}$, where $c: K \otimes \mathcal{O} \hookrightarrow W_{1} \otimes \mathcal{O} \rightarrow T_{\mathbb{P}\left(W_{1}\right)}(-1)$ is the canonical map. Then $(c, 0)$ is injective outside of the point $x_{0} \in \mathbb{P}\left(W_{1}\right)$ corresponding to the one-dimensional subspace $K \subset W_{1}$. Hence the rank of $\left.\boldsymbol{s}\right|_{\mathbb{P}\left(W_{1}\right) \times\{y\}}$ is $n+1$ at any $x_{1} \neq x_{0} \in \mathbb{P}\left(W_{1}\right)$, which means that $\left(\mathbb{P}\left(W_{1}\right) \backslash\left\{x_{0}\right\}\right) \times\{y\}$ is not contained in $X$. Thus $y$ is not contained in the left-hand side of (4.14).

Proof of Theorem 1.1 (2). Lemmas 4.3 and 4.4 show that $\widetilde{\boldsymbol{q}}\left(E_{1}\right) \subset X$ is one of the exceptional prime divisors of the birational morphism $X \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)$. If we choose one of such divisors, we can reconstruct $\varphi^{-1}$ or $\varphi^{\prime-1}$ by Lemma 3.5 as in the proof of Theorem 1.1 (1).

Remark 4.5. If $\varphi$ is defined over $\mathbb{R}$, so is $\varphi^{\prime}$. This follows from the construction of $\boldsymbol{s}^{\prime}$ in (4.2).

We have the diagram


In the rest of this section, we describe the birational map $\varphi^{\prime-1} \circ \varphi: \mathbb{P}(V) \rightarrow \mathbb{P}\left(V^{\prime}\right)$. Recall the definition of $L_{i}$ from (3.21).
Lemma 4.6. The divisor $\widetilde{\boldsymbol{q}}\left(E_{1}\right)+\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)$ on $X$ is linearly equivalent to $-L_{1}+\sum_{i=2}^{n+1} L_{i}$.
Proof. Since the exceptional locus of the birational morphism

$$
\begin{equation*}
\left.\left(\varpi_{2}, \ldots, \varpi_{n+1}\right)\right|_{X}: X \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right) \tag{4.18}
\end{equation*}
$$

is $\widetilde{\boldsymbol{q}}\left(E_{1}\right) \cup \widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)$ by Lemma 4.4, we can write

$$
\begin{equation*}
K_{X}=\left(\varpi_{2}, \ldots, \varpi_{n+1}\right)^{*} K_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)}+a \widetilde{\boldsymbol{q}}\left(E_{1}\right)+a^{\prime} \widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right) \tag{4.19}
\end{equation*}
$$

for some integers $a$ and $a^{\prime}$. By the birational map

$$
\begin{equation*}
\left(\varphi_{2}, \ldots, \varphi_{n+1}\right): \mathbb{P}(V) \rightarrow \prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right) \tag{4.20}
\end{equation*}
$$

the birational morphism (4.18) can be identified with the blow-up $\mathrm{Bl}_{Z_{1}} \mathbb{P}(V) \rightarrow \mathbb{P}(V)$ over the generic point of $Z_{1}$. Hence the integer $a$ in (4.19), which is the coefficient of $\widetilde{\boldsymbol{q}}\left(E_{1}\right)=\mathbb{P}\left(W_{1}\right) \times \overline{\left(\varphi_{2}, \ldots, \varphi_{r}\right)\left(Z_{1}\right)}$, is one. Similarly one has $a^{\prime}=1$, and

$$
\begin{equation*}
\widetilde{\boldsymbol{q}}\left(E_{1}\right)+\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)=K_{X}-\left(\varpi_{2}, \ldots, \varpi_{n+1}\right)^{*} K_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)} \tag{4.21}
\end{equation*}
$$

holds. By (3.8), the divisor $X=X_{n} \subset \prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)$ is the zero locus of

$$
\begin{equation*}
\left(\boldsymbol{q}_{*} s\right)^{\wedge(n+1)}: \mathcal{O}_{\prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)} \simeq \bigwedge^{n+1} V \otimes \mathcal{O}_{\prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)} \rightarrow \bigwedge_{n}^{n+1} \bigoplus_{i=1}^{n+1} \varpi_{i}^{*} T_{\mathbb{P}\left(W_{i}\right)}(-1) \simeq \bigotimes_{i=1}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1) \tag{4.22}
\end{equation*}
$$

Thus $X$ is linearly equivalent to $\sum_{i=1}^{n+1} \varpi_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1)$ on $\prod_{i=1}^{n+1} \mathbb{P}\left(W_{i}\right)$. Hence we have $K_{X}=-\sum_{i=1}^{n+1} L_{i}$ by the adjunction formula. Since $\left(\varpi_{2}, \ldots, \varpi_{n+1}\right)^{*} K_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)}=-2 \sum_{i=2}^{n+1} L_{i}$, one has

$$
\begin{equation*}
\widetilde{\boldsymbol{q}}\left(E_{1}\right)+\widetilde{\boldsymbol{q}}^{\prime}\left(E_{1}^{\prime}\right)=K_{X}-\left(\varpi_{2}, \ldots, \varpi_{n+1}\right)^{*} K_{\prod_{i=2}^{n+1} \mathbb{P}\left(W_{i}\right)}=-L_{1}+\sum_{i=2}^{n+1} L_{i} \tag{4.23}
\end{equation*}
$$

and Lemma 4.6 is proved.
For each $i=1, \ldots, n+1$, let $F_{i} \subset \widetilde{X}$ be the strict transform of the divisor $\widetilde{\boldsymbol{q}}^{\prime}\left(E_{i}^{\prime}\right) \subset X^{\prime}=X$.
Lemma 4.7. The divisor $F_{1}$ is linearly equivalent to $\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(n-1)-\sum_{i=2}^{n+1} E_{i}$.
Proof. This is an immediate consequence of Lemma 4.6 and the linear equivalences $\widetilde{q}_{i}^{*} \mathcal{O}_{\mathbb{P}\left(W_{i}\right)}(1) \sim$ $\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(1)-E_{i}$ for $1 \leq i \leq n+1$.

Corollary 4.8. (1) The birational map $\varphi^{\prime-1} \circ \varphi: \mathbb{P}(V) \rightarrow \mathbb{P}\left(V^{\prime}\right)$ is obtained by the linear system $\left|\mathcal{O}_{\mathbb{P}(V)}(n) \otimes I_{\bigcup_{i=1}^{n+1} Z_{i}}\right|$.
(2) For each $i$, the image $\widetilde{p}\left(F_{i}\right) \subset \mathbb{P}(V)$ is the unique hypersurface of degree $n-1$ containing $Z_{j}$ for all $j \in\{1, \ldots, n+1\} \backslash\{i\}$.
(3) The birational map $\boldsymbol{\varphi}^{\prime-1} \circ \boldsymbol{\varphi}$ contracts the hypersurface $\widetilde{p}\left(F_{i}\right)$ to $Z_{i}^{\prime}$ for each $i$.
 which is identified with $\left|\mathcal{O}_{\widetilde{X}}(F) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}\left(W_{1}\right)}(1)\right|$ by $\widetilde{\boldsymbol{q}}$. Since

$$
\begin{align*}
F_{1}+\widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}\left(W_{1}\right)}(1) & \sim \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(n-1)-\sum_{i=2}^{n+1} E_{i}+\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(1)-E_{1}  \tag{4.24}\\
& =\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(n)-\sum_{i=1}^{n+1} E_{i} \tag{4.25}
\end{align*}
$$

follows from Lemma 4.7, $\left|\mathcal{O}_{\tilde{X}}(F) \otimes \widetilde{q}_{1}^{*} \mathcal{O}_{\mathbb{P}\left(W_{1}\right)}(1)\right|$ is identified with $\left|\mathcal{O}_{\mathbb{P}(V)}(n) \otimes I_{\bigcup_{i=1}^{n+1} Z_{i}}\right|$ by $\widetilde{p}$. Hence $\boldsymbol{\varphi}^{\prime-1} \circ \boldsymbol{\varphi}=\boldsymbol{\varphi}^{\prime-1} \circ \widetilde{\boldsymbol{q}} \circ \widetilde{p}^{-1}$ is obtained by $\left|\mathcal{O}_{\mathbb{P}(V)}(n) \otimes I_{\bigcup_{i=1}^{n+1} Z_{i}}\right|$.
(2) It suffices to show this statement for $i=1$. The linear system on $\mathbb{P}(V)$ consisting of divisors of degree $n-1$ containing $Z_{2}, \ldots, Z_{n+1}$ is identified with $\left|\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(n-1)-\sum_{i=2}^{n+1} E_{i}\right|$ on $\widetilde{X}$ by $\widetilde{p}$. By Lemma 4.7, we have $\left|\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}(V)}(n-1)-\sum_{i=2}^{n+1} E_{i}\right|=\left|F_{1}\right|$, which in turn is identified with the linear system $\left|E_{1}^{\prime}\right|$ on $\widetilde{X}^{\prime}$. The linear system $\left|E_{1}^{\prime}\right|$ is 0-dimensional since $E_{1}^{\prime}$ is an exceptional divisor. Hence $\widetilde{p}\left(F_{1}\right)$ is the unique such divisor.
(3) This statement holds since each $E_{i}^{\prime} \subset \widetilde{X}^{\prime}$ is contracted to $Z_{i}^{\prime}$.

## 5. Dominance for $|\boldsymbol{m}| \geq 2 n-1$

We use the same notation as in Section 3.
Lemma 5.1. The rational map

$$
\begin{equation*}
\widetilde{\Phi}: \prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right) \rightarrow \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right), \quad \varphi=\left(\varphi_{1}, \ldots, \varphi_{r}\right) \mapsto[\widetilde{X}] \tag{5.1}
\end{equation*}
$$

is birational onto an irreducible component.
Proof. Since we can recover $\varphi$ from the graph $\widetilde{X}$ of $\boldsymbol{\varphi}$, the rational map $\widetilde{\Phi}$ is generically injective. Hence it suffices to show that for general $\varphi$, $\operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)$ is smooth at $\widetilde{\Phi}(\varphi)$ and the dimension of Hilb $\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)$ at $\widetilde{\Phi}(\boldsymbol{\varphi})$ is equal to that of $\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)$.

Consider the differential

$$
\begin{equation*}
(d \widetilde{\Phi})_{\varphi}: T_{\varphi}\left(\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)\right) \rightarrow T_{[\tilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \tag{5.2}
\end{equation*}
$$

Let $\operatorname{Im}(\widetilde{\Phi}) \subset \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)$ be the closure of the image of $\widetilde{\Phi}$ with reduced structure. Then $(d \widetilde{\Phi})_{\varphi}$ factors as

$$
\begin{equation*}
T_{\varphi}\left(\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)\right) \rightarrow T_{[\widetilde{X}]} \operatorname{Im}(\widetilde{\Phi}) \subset T_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \tag{5.3}
\end{equation*}
$$

We note that if $\boldsymbol{\varphi}$ is general, $\operatorname{Im}(\widetilde{\Phi})$ is smooth at $[\widetilde{X}]$ and $T_{\varphi}\left(\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)\right) \rightarrow T_{[\widetilde{X}]} \operatorname{Im}(\widetilde{\Phi})$ is surjective. Thus, for general $\boldsymbol{\varphi}$, we have

$$
\begin{equation*}
\operatorname{rank}(d \widetilde{\Phi})_{\varphi}=\operatorname{dim} \operatorname{Im}(\widetilde{\Phi}) \leq \operatorname{dim}_{[\tilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \leq \operatorname{dim} T_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \tag{5.4}
\end{equation*}
$$

If $(d \widetilde{\Phi})_{\varphi}$ is surjective, $\operatorname{rank}(d \widetilde{\Phi})_{\varphi}=\operatorname{dim} T_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)$, and hence

$$
\begin{equation*}
\operatorname{rank}(d \widetilde{\Phi})_{\varphi}=\operatorname{dim} \operatorname{Im}(\widetilde{\Phi})=\operatorname{dim}_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{\boldsymbol{m}}\right)=\operatorname{dim} T_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \tag{5.5}
\end{equation*}
$$

holds. From the last equality of (5.5), $\operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)$ is smooth at $[\widetilde{X}]=\widetilde{\Phi}(\boldsymbol{\varphi})$. Furthermore, $\operatorname{dim}_{[\tilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right)=\operatorname{dim} \operatorname{Im}(\widetilde{\Phi})=\operatorname{dim} \prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)$ since $\widetilde{\Phi}$ is generically injective. Thus this lemma follows from the surjectivity of $(d \widetilde{\Phi})_{\varphi}$ for general $\boldsymbol{\varphi}$.

In the rest of the proof, we show the surjectivity of $(d \widetilde{\Phi})_{\varphi}$ for general $\varphi$. Recall that $\widetilde{X} \subset$ $\mathbb{P}^{n} \times \mathbb{P}^{m}$ is the zero locus of a general section $\boldsymbol{s} \in H^{0}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}, \mathcal{E}\right)$, where $\mathcal{E}=\bigoplus_{i=1}^{r} p^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes$ $q_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)$. Hence $\widetilde{X}$ is smooth with $\operatorname{codim}\left(X, \mathbb{P}^{n} \times \mathbb{P}^{m}\right)=\operatorname{rank} \mathcal{E}$, and the normal bundle $N_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}}$ is isomorphic to $\left.\mathcal{E}\right|_{\tilde{X}}=\bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m}}(-1)$. We note that the isomorphism $N_{\widetilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}}^{V}=$ $I_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}} /\left.I_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}}^{2} \cong \mathcal{E}^{\vee}\right|_{\tilde{X}}$ is induced from the surjective homomorphism $\mathcal{E}^{\vee} \rightarrow I_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}} \subset \mathcal{O}_{\mathbb{P}^{n} \times \mathbb{P}^{m}}$ defined by $\boldsymbol{s}$.

From the Euler sequences on $\mathbb{P}^{m_{i}}$ 's, we have an exact sequence on $\widetilde{X}$

$$
\begin{equation*}
0 \rightarrow \bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} \mathcal{O}_{\mathbb{P}^{m_{i}}}(-1) \rightarrow \bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W_{i} \rightarrow \bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1) \rightarrow 0 \tag{5.6}
\end{equation*}
$$

Since $\widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} \mathcal{O}_{\mathbb{P}^{m_{i}}}(-1) \simeq \mathcal{O}_{\tilde{X}}\left(E_{i}\right)$ and $h^{1}\left(\widetilde{X}, \mathcal{O}_{\tilde{X}}\left(E_{i}\right)\right)=0$, we see that the linear map

$$
\begin{equation*}
\bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i}=H^{0}\left(\tilde{X}, \bigoplus_{i=1}^{r} \tilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes W_{i}\right) \rightarrow H^{0}\left(\tilde{X}, \bigoplus_{i=1}^{r} \tilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)\right) \tag{5.7}
\end{equation*}
$$

is surjective with the kernel $\bigoplus_{i=1}^{r} H^{0}\left(\widetilde{X}, \mathcal{O}_{\tilde{X}}\left(E_{i}\right)\right)=\bigoplus_{i=1}^{r} \mathbf{k} s_{i}$. The induced isomorphism

$$
\begin{equation*}
\bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i} / \mathbf{k} s_{i} \xrightarrow{\sim} H^{0}\left(\tilde{X}, \bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)\right) \tag{5.8}
\end{equation*}
$$

of vector spaces is identified with the differential (5.2) under the isomorphisms

$$
\begin{equation*}
T_{\varphi}\left(\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)\right) \cong\left(\bigoplus_{i=1}^{r}\left(V^{\vee} \otimes W_{i} / \mathbf{k} s_{i}\right) \otimes\left(\mathbf{k} s_{i}\right)^{\vee}\right) \stackrel{\sim}{\rightarrow} \bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i} / \mathbf{k} s_{i} \tag{5.9}
\end{equation*}
$$

and

$$
\begin{equation*}
T_{[\widetilde{X}]} \operatorname{Hilb}\left(\mathbb{P}^{n} \times \mathbb{P}^{m}\right) \cong H^{0}\left(\widetilde{X}, N_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}}\right) \xrightarrow{\hookrightarrow} H^{0}\left(\widetilde{X}, \bigoplus_{i=1}^{r} \widetilde{p}^{*} \mathcal{O}_{\mathbb{P}^{n}}(1) \otimes \widetilde{q}_{i}^{*} T_{\mathbb{P}^{m_{i}}}(-1)\right) \tag{5.10}
\end{equation*}
$$

induced by $s_{i}$ 's. This is a special case of the following general fact: Let $Y$ be a projective variety, $E$ be a vector bundle on $Y, s$ be a global section of $E$, and $Z=s^{-1}(0)$ be the zero locus of $s$. When $Z$ is a complete intersection (i.e., when $\operatorname{codim} Z=\operatorname{rank} E$ ), the differential of

$$
\mathbb{P}\left(H^{0}(E)\right) \longrightarrow \operatorname{Hilb}(Y): s \mapsto[Z]
$$

can be identified with the natural morphism

$$
H^{0}(E) / \mathbf{k} s \rightarrow H^{0}\left(\left.E\right|_{Z}\right)
$$

Proof of Theorem 1.1. (3). Take general $\varphi$. We study the tangent space of $\operatorname{Hilb}\left(\mathbb{P}^{m}\right)$ at $[X]$, which is isomorphic to $H^{0}\left(X, N_{X / \mathbb{P} \boldsymbol{m}}\right)$. By $|\boldsymbol{m}| \geq 2 n-1$ and (3.13), $\widetilde{\boldsymbol{q}}: \widetilde{X} \rightarrow X$ is an isomorphism in this case. The diagram

induces an exact sequence

$$
\begin{equation*}
0 \rightarrow \widetilde{p}^{*} T_{\mathbb{P}^{n}} \rightarrow N_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}} \rightarrow \widetilde{\boldsymbol{q}}^{*} N_{X / \mathbb{P}^{m}} \rightarrow 0 \tag{5.12}
\end{equation*}
$$

on $\widetilde{X}$. Since

$$
\begin{equation*}
H^{0}\left(\widetilde{X}, \widetilde{p}^{*} T_{\mathbb{P}^{n}}\right) \cong H^{0}\left(\mathbb{P}^{n}, T_{\mathbb{P}^{n}}\right) \cong V^{\vee} \otimes V / \operatorname{kid}_{V} \tag{5.13}
\end{equation*}
$$

for $\operatorname{id}_{V} \in \operatorname{Hom}(V, V) \cong V^{\vee} \otimes V$ and $h^{1}\left(\widetilde{X}, \widetilde{p}^{*} T_{\mathbb{P}^{n}}\right)=0$, we have an exact sequence

$$
\begin{equation*}
0 \rightarrow V^{\vee} \otimes V / \mathbf{k} \operatorname{id}_{V} \rightarrow \bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i} / \mathbf{k} s_{i} \xrightarrow{d} H^{0}\left(X, N_{X / \mathbb{P} m}\right) \rightarrow 0, \tag{5.14}
\end{equation*}
$$

where the middle term

$$
\begin{equation*}
H^{0}\left(\widetilde{X}, N_{\tilde{X} / \mathbb{P}^{n} \times \mathbb{P}^{m}}\right) \cong \bigoplus_{i=1}^{r} V^{\vee} \otimes W_{i} / \mathbf{k} s_{i} \tag{5.15}
\end{equation*}
$$

can be identified with $T_{\varphi}\left(\prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)\right)$ as in the proof of Lemma 5.1. Then the map $d$ in (5.14) can be identified with $(d \Phi)_{\varphi}$, and $V^{\vee} \otimes V / \mathbf{k i d}_{V}$ can be identified with the tangent space of the $\operatorname{PGL}(n+1, \mathbf{k})$-orbit of $\boldsymbol{\varphi}$. By Theorem(1.1.(1), (21), a general fiber of $\Phi$ consists of at most two PGL( $n+$ $1, \mathbf{k})$-orbits. Note that the dimension of the $\operatorname{PGL}(n+1, \mathbf{k})$-orbits is equal to that of $\operatorname{PGL}(n+1, \mathbf{k})$ since $\boldsymbol{\varphi}$ is birational. Hence we have $\operatorname{dim} \operatorname{Im}(\Phi)=\operatorname{dim} \prod_{i=1}^{r} \mathbb{P}\left(V^{\vee} \otimes W_{i}\right)-\operatorname{dim} \operatorname{PGL}(n+1, \mathbf{k})$. Thus $\operatorname{dim} \operatorname{Im}(\Phi)$ is equal to $h^{0}\left(X, N_{X / \mathbb{P}^{m}}\right)$ by (5.14), which is the dimension of the tangent space of Hilb $\left(\mathbb{P}^{m}\right)$ at $[X]$. This means that $\operatorname{Hilb}\left(\mathbb{P}^{m}\right)$ is smooth at $[X]$ of dimension $h^{0}\left(X, N_{X / \mathbb{P}^{m}}\right)=\operatorname{dim} \operatorname{Im}(\Phi)$. Hence $\Phi$ is dominant onto an irreducible component.

Remark 5.2. In the case $n=3$ and $\boldsymbol{m}=\left(2^{r}\right)$, the condition $|\boldsymbol{m}| \geq 2 n-1$ is $2 r \geq 5$, that is $r \geq 3$. As in [AST13, Section 6], the closure of the image of $\Phi$ is a cubic hypersurface in an irreducible component $\mathbb{P}^{8}=\mathbb{P}\left(W_{1}^{\vee} \otimes W_{2}^{\vee}\right) \subset \operatorname{Hilb}\left(\mathbb{P}^{m}\right)$ for $r=2$, so this is sharp in this case. We do not know whether the condition $|\boldsymbol{m}| \geq 2 n-1$ is sharp or not in general.

## 6. Grassmann tensors as Chow forms

We recall the standard methods for projective reconstruction from a geometric point of view. Define an index set

$$
\begin{equation*}
B(n, \boldsymbol{m}):=\left\{\boldsymbol{\alpha}=\left(\alpha_{1}, \ldots, \alpha_{r}\right) \in \mathbb{N}^{r} \mid 1 \leq \alpha_{i} \leq m_{i} \text { for any } i=1, \ldots, r \text { and } \sum_{i=1}^{r} \alpha_{i}=n+1\right\} \tag{6.1}
\end{equation*}
$$

For an $n$-dimensional variety $X \subset \mathbb{P}^{m}$ and $\boldsymbol{\alpha} \in B(n, \boldsymbol{m})$, let

$$
\begin{equation*}
\mathcal{Z}(X) \subset G\left(\boldsymbol{m}-\boldsymbol{\alpha}, \mathbb{P}^{\boldsymbol{m}}\right):=\prod_{i=1}^{r} G\left(m_{i}-\alpha_{i}, \mathbb{P}\left(W_{i}\right)\right) \tag{6.2}
\end{equation*}
$$

denote the set of points in $G\left(\boldsymbol{m}-\boldsymbol{\alpha}, \mathbb{P}^{\boldsymbol{m}}\right)$ corresponding to $r$-tuples $\left(U_{1}, \ldots U_{r}\right)$ of linear subvarieties $U_{i} \subset \mathbb{P}\left(W_{i}\right)$ of codimension $\alpha_{i}$ such that

$$
\begin{equation*}
X \cap \prod_{i=1}^{r} U_{i} \neq \emptyset \tag{6.3}
\end{equation*}
$$

Here, $G\left(m_{i}-\alpha_{i}, \mathbb{P}\left(W_{i}\right)\right)$ is the Grassmannian of $\left(m_{i}-\alpha_{i}\right)$-planes in $\mathbb{P}\left(W_{i}\right)$, which is embedded in $\mathbb{P}\left(\bigwedge^{m_{i}+1-\alpha_{i}} W_{i}\right)=\mathbb{P}\left(\bigwedge^{\alpha_{i}} W_{i}^{\vee}\right)$ by the Plücker embedding for $i=1, \ldots, r$.

Theorem 6.1 ([HS09, Theorem 3.1], [NHT14, Theorem 2]). Assume that $\boldsymbol{\varphi}$ is generic. For $\alpha \in$ $B(n, \boldsymbol{m})$ and the multiview variety $X \subset \mathbb{P}^{\boldsymbol{m}}$, the set $\mathcal{Z}(X) \subset G\left(\boldsymbol{m}-\boldsymbol{\alpha}, \mathbb{P}^{\boldsymbol{m}}\right)$ is a hypersurface defined by the multilinear equation

$$
\begin{equation*}
\sum_{\sigma_{1}, \ldots, \sigma_{r}} A^{\sigma_{1}, \ldots, \sigma_{r}} p_{\sigma_{1}}^{1} \ldots p_{\sigma_{r}}^{r}=0 \tag{6.4}
\end{equation*}
$$

in $G\left(\mathbb{P}^{m}, \boldsymbol{\alpha}\right)$, where $p^{i}=\left[p_{\sigma_{i}}^{i} \mid \sigma_{i}=\left(\sigma_{i, 1}, \ldots, \sigma_{i, \alpha_{i}}\right), 1 \leq \sigma_{i, 1}<\cdots<\sigma_{i, \alpha_{i}} \leq m_{i}+1\right]$ is the Plücker coordinates of the Grassmannian $G\left(m_{i}-\alpha_{i}, \mathbb{P}\left(W_{i}\right)\right)$ for each $i=1, \ldots, r$. Moreover, the tensor

$$
\begin{equation*}
A:=\left(A^{\sigma_{1}, \ldots, \sigma_{r}}\right) \in \bigotimes_{i=1}^{r} \bigwedge^{\alpha_{i}} W_{i} \tag{6.5}
\end{equation*}
$$

is uniquely determined up to scalar from sufficiently many subspace correspondences. 2
The tensor $A$, called the Grassmann tensor of profile $\alpha$ for a camera configuration $\varphi$ in computer vision, is an analog of the Chow form of the multiview variety $X \subset \mathbb{P}^{m}$ (see, e.g., GKZ08, Section $3.2])$. Note that the Grassmann tensors of profile (2,2), (2, 1, 1), and $(1,1,1,1)$ are classically known as the fundamental matrix, the trifocal tensor, and the quadrifocal tensor, respectively.

The projective reconstruction theorem by Hartley and Schaffalitzky can be stated as follows:
Theorem 6.2 ([HS09, Section 5]). Assume that $\boldsymbol{\varphi}$ is generic. Fix $\alpha \in B(n, \boldsymbol{m})$ and let $A$ be a Grassmann tensor of profile $\alpha$.
(1) If $\boldsymbol{m} \neq\left(1^{n+1}\right)$, then $\boldsymbol{\varphi}$ is uniquely determined by $A$ up to the actions of $\operatorname{PGL}(n+1, \mathbf{k})$.
(2) If $\boldsymbol{m}=\left(1^{n+1}\right)$, then two candidates of $\boldsymbol{\varphi}$ are obtained by $A$ up to the actions of $\operatorname{PGL}(n+1, \mathbf{k})$.

Since the multiview variety $X$ determines its associated hypersurface $\mathcal{Z}(X)$ and the Grassmannian tensor $A$, Theorem 6.2 implies Theorem 1.1.(1),(2).

An algorithm for the projective reconstruction for general $n$ and $\boldsymbol{m}$ using Grassmann tensors has been implemented in HS09, and applied to the analysis of dynamic scenes [WS02, HV08. In contrast, our proof of the projective reconstruction theorem is based on the analysis of divisors on the multiview variety, and it is an interesting problem to see if it can lead to a new algorithm for the reconstruction.

As we mention later in this section, the reconstruction theorem for $\mathbf{k}=\mathbb{R}$ follows from the reconstruction theorem for $\mathbf{k}=\mathbb{C}$.
