# Heat trace asymptotics for wedge-like singularity.

#### Abstract

In this note we consider a heat trace expansion on a manifold with wedge-like singularity. We show that there are two terms in the expansion that contain information about the presence of the singularity, namely the logarithmic term $c t^{-1 / 2} \log t$ and the half power term $+b t^{-1 / 2}$. We also give a geometric expression for $c$.

## 1 Geometric setup

Consider a Riemannian manifold, $(M, g)$, of dimension $m$ such that $M=$ $M_{1} \cup U$, where $M_{1}$ is a compact manifold with boundary and $U=(0,1) \times N$ has a fibration $(0,1) \times F \rightarrow U \rightarrow(0,1) \times \Sigma$, where $N, \Sigma$ are compact. This fibration induces a vertical bundle of tangents to the fibres $T_{V} N \subset T N$ and a horizontal cotangent subbundle $T_{H}^{*} N$ of cotangents annihilating $T_{V} N$. We take a complementary tangent subbundle $T_{H} N \subset T N$, inducing a vertical $T_{V}^{*} N$ that annihilates $T_{H} N$ such that $T N=T_{V} N \oplus T_{H} N$.

The metric on $U$ is

$$
g_{U}=d r^{2}+g_{H}+r^{2} g_{V}(s), \quad r \in(0,1),
$$

where $g_{H}$ is induced from a metric on $\Sigma$ and $g_{V}(s)$ is a family of metrics on the fibres, $s \in \Sigma$.

Assume now that $\operatorname{dim} \Sigma=1$, i.e. it is a circle. Assume furthermore that metric on the fibres does not depend on $s$, i.e. $g_{V}(s)=g_{V}$.

$$
g_{\text {wedge }}=d r^{2}+d \theta^{2}+r^{2} g_{V}, \quad r \in(0,1),
$$

We call such singularity a wedge-like singularity.

## 2 Curvature tensors near the singularity

In this section we give explicit formulas for the curvature tensors in ( $U, g_{\text {wedge }}$ ) in terms of the curvature tensors on fibers. For the latter we use the classical tensor notations and for the tensors on ( $U, g_{\text {wedge }}$ ) we use classical notations but with tilde.

Let $\left(x^{1}, \ldots, x^{m-2}\right)$ be local coordinates on a fiber $F$ and $p=\left(r, \theta, x^{1}, \ldots, x^{m-2}\right) \in U$. For $i, j \in\{r, \theta, 1, \ldots, m-2\}$ denote by $\tilde{g}_{i j}$ the components of the metric tensor on $g_{\text {wedge }}$, and by $g_{i j}$ for $i, j \in\{1, \ldots, m-2\}$ the components of the metric tensor $g_{V}$. Then

$$
\tilde{g}_{r r}=\tilde{g}_{\theta \theta}=1,
$$

$\tilde{g}_{i r}=\tilde{g}_{r i}=\tilde{g}_{j \theta}=\tilde{g}_{\theta j}=0$, for $i \in\{\theta, 1, \ldots, m-2\}$ and $j \in\{r, 1, \ldots, m-2\}$ and

$$
\tilde{g}_{i j}=r^{2} g_{i j}, \text { for } i, j \in\{1, \ldots, m-2\} .
$$

Then

$$
\tilde{g}_{i j, k}(r, \theta, x)= \begin{cases}2 r g_{i j}(x), & \text { if } k=r \\ 0 & \text { if } k=\theta \\ r^{2} g_{i j, k}(x) & \text { otherwise }\end{cases}
$$

The Christoffel symbols are of course

$$
\tilde{\Gamma}_{j k}^{i}=\frac{1}{2} \tilde{g}^{i m}\left(\tilde{g}_{m j, k}+\tilde{g}_{m k, j}-\tilde{g}_{j k, m}\right),
$$

and now we express them in terms of the Christoffel symbols $\Gamma_{j k}^{i}$ and the metric tensor $g_{i j}$.

Let $i=r$, then

$$
\tilde{\Gamma}_{j k}^{r}=\left\{\begin{array}{l}
0, \quad \text { if } j=r \text { or } k=r \text { or } j=\theta \text { or } k=\theta, \\
-r g_{j k} \text { otherwise. }
\end{array}\right.
$$

Let $i \notin\{r, \theta\}$ and $j=r$, then

$$
\tilde{\Gamma}_{r k}^{i}=\tilde{\Gamma}_{k r}^{i}=\left\{\begin{array}{l}
0, \\
\text { if } k=r \text { or } i=\theta \text { or } k=\theta, \\
r^{-1} \delta_{k}^{i} \text { otherwise }
\end{array}\right.
$$

Assume that $i, j, k \notin\{r, \theta\}$, then $\tilde{\Gamma}_{j k}^{i}=\Gamma_{j k}^{i}$. Finally $\tilde{\Gamma}_{j k}^{\theta}=\tilde{\Gamma}_{\theta k}^{i}=\tilde{\Gamma}_{k \theta}^{i}=0$. The scalar curvature $\operatorname{Scal}(p)$ can be expressed in the following way

$$
\begin{align*}
\operatorname{Scal}(p) & =\tilde{g}^{i j}\left(\tilde{\Gamma}_{i j, m}^{m}-\tilde{\Gamma}_{i m, j}^{m}+\tilde{\Gamma}_{i j}^{l} \tilde{\Gamma}_{m l}^{m}-\tilde{\Gamma}_{i m}^{l} \tilde{\Gamma}_{j l}^{m}\right)  \tag{2.1}\\
& =r^{-2}(\operatorname{Scal}(x)-(m-2)(m-3)),
\end{align*}
$$

where $p=(r, \theta, x) \in U, x \in F$ and $\operatorname{Scal}(p)$ is the scalar curvature on ( $U, g_{\text {wedge }}$ ), and $\operatorname{Scal}(x)$ is the scalar curvature on $\left(F, g_{V}\right)$.

If $i, j, k, l \notin\{r, \theta\}$, we obtain

$$
\begin{equation*}
\tilde{\mathrm{R}}_{i j k l}(p)=r^{-2}\left(\mathrm{R}_{i j k l}(x)-g_{i p}(x) g_{j m}(x)\left(\delta_{k}^{p} \delta_{l}^{m}-\delta_{l}^{p} \delta_{k}^{m}\right)\right) . \tag{2.2}
\end{equation*}
$$

Similarly, for the tensor Ricci

$$
\begin{equation*}
\tilde{\operatorname{Ric}}_{i j}(p)=r^{-2}\left(\operatorname{Ric}_{i j}(x)-(m-3) g_{i j}(x)\right) . \tag{2.3}
\end{equation*}
$$

## 3 Resolvent expansion

Let $\Delta$ be the Friedrichs extension of the Laplace-Beltrami operator on $U$

$$
\Delta=-\partial_{r}^{2}+\Delta_{\Sigma}+r^{-2} A(s),
$$

where $\Delta_{\Sigma}$ is the Laplace operator on the singular stratum $\Sigma, A(s), s \in \Sigma$ is a smooth family of elliptic operators on functions on fibers $F$. In the case of the wedge-like singularity, we have $\Delta_{\Sigma}=-\partial_{\theta}^{2}$, and $A(s)=\Delta_{F}+$ $\left(\frac{m-2}{2}\left(\frac{m-2}{2}-1\right)\right)$, where $\Delta_{F}$ is the Laplace-Beltrami operator on the fiber $F$.

Let $\varphi(r, \theta)$ be a cutoff function supported near $r=0$, by [BS, Theorem 5.2], for $d>m / 2$ the resolvent $\left(\Delta+z^{2}\right)^{-d}$ is trace class and the following is true

$$
\left.\operatorname{tr}\left(\varphi(r, \theta)\left(\Delta+z^{2}\right)^{-d}\right)\right)=\int_{0}^{\infty} \varphi(r, \theta) \sigma(r, r z) d r,
$$

where $\sigma(r, r z):=\sigma(r, \theta, r z):=\operatorname{tr}_{L^{2}(F)}\left(\Delta+z^{2}\right)^{-d}$.
From the local heat kernel expansion of heat kernel away from the singularity we know, see [S, (3.6), (3.17)], that

$$
\begin{aligned}
& \operatorname{tr}_{L^{2}(F)}\left(\Delta+\zeta^{2} / r^{2}\right)^{-d} \sim_{\zeta \rightarrow \infty} \\
& (4 \pi)^{-\frac{m}{2}} \sum_{j=0}^{\infty}(\zeta / r)^{-2 d+m-2 j} \frac{\Gamma\left(-\frac{m}{2}+d+j\right)}{(d-1)!} \int_{F} r^{m-2} u_{j}(p) \operatorname{dvol}_{F} .
\end{aligned}
$$

Above $u_{j}(p)$ are polynomials in the curvature tensors at $p \in M$ that come from the local heat kernel expansion away from the singularity, in particular $u_{0}(p) \equiv 1, u_{1}(p)=\operatorname{Scal}(p)$ and

$$
u_{2}(p)=\frac{1}{360}\left(12 \Delta \operatorname{Scal}(p)+5 \operatorname{Scal}(p)^{2}-2|\operatorname{Ric}(p)|^{2}+2|\mathrm{R}(p)|^{2}\right)
$$

Hence

$$
\begin{equation*}
\sigma(r, \zeta) \sim_{\zeta \rightarrow \infty} \sum_{j=0}^{\infty} \zeta^{-2 d+m-2 j} \sigma_{j}(r) \tag{3.1}
\end{equation*}
$$

where

$$
\begin{align*}
\sigma_{j}(r) & =(4 \pi)^{-\frac{m}{2}} r^{2 d-m+2 j} \int_{F} r^{m-2} u_{j}(p) \operatorname{dvol}_{N} \frac{\Gamma\left(-\frac{m}{2}+d+j\right)}{(d-1)!} \\
& =(4 \pi)^{-\frac{m}{2}} r^{2 d-2+2 j} \int_{F} u_{j}(p) \operatorname{dvol}_{N} \frac{\Gamma\left(-\frac{m}{2}+d+j\right)}{(d-1)!} . \tag{3.2}
\end{align*}
$$

We can apply the Singular Asymptotics Lemma to obtain an asymptotic expansion of the resolvent trace, see [BS, p. 287],

## Proposition 3.1.

$$
\begin{align*}
\int_{0}^{\infty} \varphi(r, \theta) \sigma(r, \zeta) d r & \left.\sim \sum_{l=0}^{\infty} z^{-l-1} \frac{1}{l!} f_{0}^{\infty} \int_{\Sigma} \zeta^{l} \partial_{r}^{l}(\sigma(r, \zeta) \varphi(r, \theta))\right|_{r=0} d \theta d \zeta  \tag{3.3}\\
& +\sum_{j=0}^{\infty} f_{0}^{\infty} \int_{\Sigma} \sigma_{j}(r)(r z)^{-2 d+m-2 j} \varphi(r) d \theta d r  \tag{3.4}\\
& +\sum_{l=\frac{m}{2}-d+1}^{\infty} z^{-2 d+m-2 l} \log z \int_{\Sigma} \frac{\left.\partial_{r}^{2 d-m+2 l-1}\left(\sigma_{l}(r) \varphi(r, \theta)\right)\right|_{r=0}}{(2 d-m+2 l-1)!} d \theta \tag{3.5}
\end{align*}
$$

Assume $\varphi(r, \theta) \equiv 1$ near $r=0$ and consider the last sum in the expansion

$$
\begin{aligned}
L:= & \sum_{l=\frac{m}{2}-d+1}^{\infty} z^{-2 d+m-2 l} \log z \int_{\Sigma} \frac{\left.\partial_{r}^{2 d-m+2 l-1}\left(\sigma_{l}(r) \varphi(r, \theta)\right)\right|_{r=0}}{(2 d-m+2 l-1)!} d \theta \\
= & \sum_{j=\frac{m}{2}-d+1}^{\infty} z^{-2 d+m-2 j} \log z \frac{\Gamma\left(-\frac{m}{2}+d+j\right) \operatorname{vol}(\Sigma)}{(d-1)!(2 d-m+2 j-1)!} \times \\
& \times\left.(4 \pi)^{-\frac{m}{2}} \partial_{r}^{2 d-m+2 j-1}\left(r^{2 d-2+2 j} \int_{F} u_{j}(p) \operatorname{dvol}_{N}\right)\right|_{r=0} .
\end{aligned}
$$

To continue the computation we note that for $j \geq m / 2$ we have

$$
\begin{array}{r}
\left.\partial_{r}^{2 d-m+2 j-1}\left(r^{2 d-2+2 j} \int_{F} u_{j}(p) \operatorname{dvol}_{N}\right)\right|_{r=0} \\
\quad=\left.\partial_{r}^{2 j-m+1}\left(r^{2 j} \int_{F} u_{j}(p) \operatorname{dvol}_{N}\right)\right|_{r=0}
\end{array}
$$

this makes sense only for $j \geq \frac{m-1}{2}$, therefore

$$
\begin{aligned}
L= & \sum_{j \geq \frac{m-1}{2}} z^{-2 d+m-2 j} \log z \frac{\Gamma\left(-\frac{m}{2}+d+j\right) \operatorname{vol}(\Sigma)}{(d-1)!(2 d-m+2 j-1)!} \times \\
& \times\left.(4 \pi)^{-\frac{m}{2}} \partial_{r}^{2 j-m+1}\left(r^{2 j} \int_{F} u_{j}(p) \operatorname{dvol}_{F}\right)\right|_{r=0} \\
= & \sum_{l=0}^{\infty} z^{-2 d-2 l+1} \log z \frac{\Gamma\left(d+l-\frac{1}{2}\right) \operatorname{vol}(\Sigma)}{(d-1)!(2 d+2 l-2)!} \times \\
& \times\left.(4 \pi)^{-\frac{m}{2}} \partial_{r}^{2 l}\left(r^{m+2 l-1} \int_{F} u_{\frac{m-1}{2}+l}(p) \operatorname{dvol}_{F}\right)\right|_{r=0} \\
= & z^{-2 d+1} \log z \frac{\Gamma\left(d-\frac{1}{2}\right) \operatorname{vol}(\Sigma)}{(d-1)!(2 d-2)!} \times \\
& \times\left.(4 \pi)^{-\frac{m}{2}}\left(r^{m-1} \int_{F} u_{\frac{m-1}{2}}(p) \operatorname{dvol}_{F}\right)\right|_{r=0} .
\end{aligned}
$$

The last equality is due to the fact that $r^{m-1+2 l} u_{\frac{m-1}{2}+l}(p)$ is a smooth function with respect to $r$.

By [S, p.47], the logarithmic part in the heat trace expansion coming from this term is

$$
\begin{equation*}
-(4 \pi)^{-\frac{m}{2}} t^{-\frac{1}{2}} \log t \times\left.\frac{1}{2} \operatorname{vol}(\Sigma)\left(r^{m-1} \int_{F} u_{\frac{m-1}{2}}(p) \operatorname{dvol}_{F}\right)\right|_{r=0} \tag{3.6}
\end{equation*}
$$

## 4 Heat trace expansion

From Proposition 3.1 and (3.6) we obtain

$$
\begin{equation*}
\operatorname{tr} e^{-t \Delta} \sim_{t \rightarrow 0+}(4 \pi t)^{-\frac{m}{2}} \sum_{j=0}^{\infty} \tilde{a}_{j} t^{j}+b t^{-1 / 2}+c t^{-1 / 2} \log t \tag{4.1}
\end{equation*}
$$

where

$$
\tilde{a}_{j}= \begin{cases}\int_{M} u_{j} \operatorname{dvol}_{M} & \text { for } j \leq m / 2-1, \\ f_{M} u_{j} \operatorname{dvol}_{M} & \text { for } j>m / 2-1\end{cases}
$$

and

$$
c=\left.\frac{1}{2} \operatorname{vol}(\Sigma)\left(r^{m-1} \int_{F} u_{\frac{m-1}{2}}(p) \operatorname{dvol}_{F}\right)\right|_{r=0},
$$

$b$ is to be computed.
Note that if $m$ is even, the logarithmic term is zero.

### 4.1 Logarithmic term in low dimensional cases

Let $\operatorname{dim} M=3$, then $c=\frac{1}{12} \operatorname{vol}(\Sigma) \operatorname{Scal}(x)=0$, so the logarithmic term is always zero in this case.

Let $\operatorname{dim} M=5$, then

$$
\begin{aligned}
c & =\frac{1}{2} \operatorname{vol}(\Sigma) \int_{F}\left(\frac{1}{360}\left(5 \operatorname{Scal}(p)^{2}-2|\operatorname{Ric}(p)|^{2}+2|\mathrm{R}(p)|^{2}\right)\right) \mathrm{dvol}_{F} \\
& =-\frac{\operatorname{vol}(\Sigma)}{720}(4 \pi)^{-2} \int_{F}\left(3(\operatorname{Scal}(x)-6)^{2}+6\left(\operatorname{Ric}_{i j}(x)-2 g_{i j}\right)^{2}\right) \mathrm{d} \operatorname{vol}_{F} .
\end{aligned}
$$

The above expression is equal to zero if and only if $\operatorname{Scal}(x) \equiv 6$ and $\operatorname{Ric}_{i j}(x)=$ $2 g_{i j}(x)$; equivalently if and only if the sectional curvature of the fiber ( $F, g_{V}$ ) is equal to one. Therefore the logarithmic term in this case is equal to zero if and only if the fiber $\left(F, g_{V}\right)$ is isometric to a spherical space form.
