# CHUDNOVSKY-RAMANUJAN TYPE FORMULAE FOR THE LEGENDRE FAMILY

#### Abstract

We apply the method established in our previous work to derive a Chudnovsky-Ramanujan type formula for the Legendre family of elliptic curves. As a result, we prove two identities for $1 / \pi$ in terms of hypergeometric functions.

## 1. Introduction

In [8], Ramanujan derived a number of rapidly converging series for $1 / \pi$. Later, Chudnovsky and Chudnovsky [5, [6] derived an addtional such series based on the modular $j$-function, which is often used in practice for the computation of the digits of $\pi$. In [4], we generalized the method of [5], [6] to derive a complete list of Chudnovsky-Ramanujan type formulae for the modular $j$-function. The method is systematic, and in principle applicable to any family of elliptic curves parametrized by a triangular Fuchsian group of genus zero.

The purpose of this paper is to illustrate the method of [4] in another case. Consider the Legendre family of elliptic curves given by

$$
C_{\lambda}: y^{2}=x(x-1)(x-\lambda)
$$

which is parametrized by the modular $\lambda$ function. The Picard-Fuchs differential equation for this family is well known and given by

$$
\begin{equation*}
\lambda(1-\lambda) \frac{d^{2} P}{d \lambda^{2}}+(1-2 \lambda) \frac{d P}{d \lambda}-\frac{P}{4}=0 \tag{1}
\end{equation*}
$$

[^0]which is a hypergeometric differential equation with parameters $a=1 / 2, b=1 / 2$, $c=1$, and it has three regular singular points: $0,1, \infty$.

Let ${ }_{2} F_{1}(a, b ; c ; z)$ denote the hypergeometric function. Kummer's method yields six distinct hypergeometric solutions of the form

$$
\lambda^{\alpha}(1-\lambda)^{\beta}{ }_{2} F_{1}(a, b ; c ; \nu(\lambda)),
$$

where $\nu(\lambda)$ is one of

$$
\lambda, \quad 1-\lambda, \quad \frac{1}{\lambda}, \quad \frac{1}{1-\lambda}, \quad \frac{\lambda}{\lambda-1}, \quad \frac{\lambda-1}{\lambda} .
$$

In particular, we have the solutions:
Around $\lambda=0$ :

$$
\begin{array}{r}
{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right), \\
(1-\lambda)^{-1 / 2}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{\lambda}{\lambda-1}\right) .
\end{array}
$$

Around $\lambda=1$ :

$$
\begin{array}{r}
{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; 1-\lambda\right), \\
\lambda^{-1 / 2}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{\lambda-1}{\lambda}\right)
\end{array}
$$

Around $\lambda=\infty$ :

$$
\begin{array}{r}
\lambda^{-1 / 2}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{1}{\lambda}\right) \\
(1-\lambda)^{-1 / 2}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{1}{1-\lambda}\right)
\end{array}
$$

We can restrict out attention to only the first solution of each pair above because the second solution of each pair is obtained from the first by a Pfaff transformation.

Each of these solutions will be valid near one of the singular points $\lambda=0,1, \infty$ and will give rise to an expression of the period $P_{1}(\lambda)$ in terms of a hypergeometric function and $\lambda$.

Using the method of 4, we turn one of these period expressions into a ChudnovskyRamanujan type formulae valid near $\lambda=0$. As a result, we derive the following identities for $1 / \pi$ in terms of hypergeometric functions:

$$
\begin{align*}
& \frac{8}{\pi}={ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{1}{2}\right){ }_{2} F_{1}\left(\frac{3}{2}, \frac{3}{2} ; 2 ; \frac{1}{2}\right)  \tag{2}\\
& \frac{1}{\pi}={ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ;-1\right)^{2}-{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ;-1\right){ }_{2} F_{1}\left(\frac{3}{2}, \frac{3}{2} ; 2 ;-1\right) \tag{3}
\end{align*}
$$

Remark. Although the above identities could be verified by other means, the purpose of this work is to illustrate how systematic the method in [4] is to discover and derive such formulae.

## 2. Periods and families of elliptic curves

Let $C_{\lambda}: y^{2}=x(x-1)(x-\lambda)$ be the Legendre family. We first explain how to specify periods and quasi-periods for $C_{\lambda}$. Suppose
(1) $\alpha_{1}(\lambda)$ is a simple loop which encircles 0 and 1 , and does not pass through $\lambda$;
(2) $\alpha_{2}(\lambda)$ is a simple loop which encircles 1 and $\lambda$, and does not pass through 0 .

Then $\left\{\alpha_{1}(\lambda), \alpha_{2}(\lambda)\right\}$ forms a $\mathbb{Z}$-basis for $H_{1}\left(E_{\lambda}, \mathbb{Z}\right)$ as depicted in [9, Chapter VI, Section 1, Figure 6.5], and it is possible to choose $\alpha_{i}(\lambda), i=1,2$, so they vary continuously for $\lambda$ in a simply connected open subset of $\mathbb{P}^{1}(\mathbb{C}) \backslash\{0,1, \infty\}$. See [4] for details.

We then define the periods $P_{i}$ and quasi-periods $Q_{i}$ for $C_{\lambda}$ as:

$$
\begin{aligned}
P_{i} & =\int_{\alpha_{i}} \frac{d x}{y} \\
Q_{i} & =-\int_{\alpha_{i}} x \frac{d x}{y} .
\end{aligned}
$$

Up to a modification of the $\mathbb{Z}$-basis $\left\{\alpha_{1}(\lambda), \alpha_{2}(\lambda)\right\}$ for $H_{1}\left(C_{\lambda}, \mathbb{Z}\right)$, that is, a transformation in $\operatorname{SL}_{2}(\mathbb{Z})$, we obtain another $\mathbb{Z}$-basis $\left\{\gamma_{1}(\lambda), \gamma_{2}(\lambda)\right\}$ such that $\tau=P_{2} / P_{1}$ is in the fundamental domain for $\Gamma(2)$, and is near the points $0,1, \infty$ in the sense that $\lambda(\tau), 1-\lambda(\tau), 1 /(1-\lambda(\tau))$ have absolute value less than unity, respectively.

Under the change of variables

$$
\begin{aligned}
& x \mapsto x+\frac{\lambda+1}{3} \\
& y \mapsto \frac{y}{2}
\end{aligned}
$$

the Legendre family is put into the Weierstrass form:

$$
\begin{aligned}
E_{\lambda}: y^{2} & =4 x^{3}-\frac{4}{3}\left(\lambda^{2}-\lambda+1\right) x-\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2) \\
& =4\left(x-e_{0}\right)\left(x-e_{1}\right)\left(x-e_{\lambda}\right)
\end{aligned}
$$

where

$$
e_{0}=-\frac{1+\lambda}{3}, \quad e_{1}=\frac{2-\lambda}{3}, \quad e_{\lambda}=\frac{2 \lambda-1}{3}
$$

This defines an isomorphism $\pi: E_{\lambda} \rightarrow C_{\lambda}$.
The normalized $j$-invariant $J=j / 12^{3}$ of $C_{\lambda}$ is given by

$$
J=\frac{4}{27} \frac{\left(\lambda^{2}-\lambda+1\right)^{3}}{\lambda^{2}(1-\lambda)^{2}}
$$

The map $\lambda \mapsto J(\lambda)$ gives the covering map $X(2) \rightarrow X(1)$, where $X(n)$ denotes the modular curve with full level $n$-structure.

The choice of $P_{i}$ and $Q_{i}$ for $C_{\lambda}$ above fixes the periods and quasi-periods of $E_{\lambda}$, which we denote by $\Omega_{i}$ and $\mathrm{H}_{i}$, respectively. In fact, we have that

$$
\begin{aligned}
P_{i} & =2 \Omega_{i} \\
Q_{i} & =2 \mathrm{H}_{i}-\frac{1+\lambda}{3} P_{i}
\end{aligned}
$$

Fix an elliptic curve $E: y^{2}=4 x^{3}-g_{2} x-g_{3}$. For $u \neq 0$, the map $\varphi_{u}:(x, y) \mapsto$ $\left(u^{2} x, u^{3} y\right)$ gives an isomorphism $\varphi_{u}: E \stackrel{\cong}{\Longrightarrow} E^{\prime}$ from an elliptic $E$ over $\mathbb{C}$ to the
elliptic curve $E^{\prime}$ over $\mathbb{C}$, where

$$
E: y^{2}=4 x^{3}-g_{2} x-g_{3} \quad \text { and } \quad E^{\prime}: y^{2}=4 x^{3}-g_{2}^{\prime} x-g_{3}^{\prime}
$$

and

$$
\left\{\begin{align*}
g_{2}^{\prime} & =u^{4} g_{2}  \tag{4}\\
g_{3}^{\prime} & =u^{6} g_{3} \\
\Delta\left(E^{\prime}\right) & =u^{12} \Delta(E)
\end{align*}\right.
$$

By the uniformization theorem, $E(\mathbb{C})=E_{\Lambda}(\mathbb{C})$ for some lattice $\Lambda \subset \mathbb{C}$. It then follows that $E^{\prime}(\mathbb{C})=E_{u^{-1} \Lambda}(\mathbb{C})$, and we have the following commutative diagram:

so that the isomorphism $\varphi_{u}$ corresponds to scaling $\Lambda$ by $u^{-1}$.
We now introduce three families of elliptic curves: $E, E_{\tau}, E_{\lambda}$, and compare their discriminants, associated lattices, and periods.

Consider the elliptic curve $E$ over $\mathbb{C}$ given by

$$
E: y^{2}=4 x^{3}-g_{2} x-g_{3}, \quad \Delta(E)=\Delta=g_{2}^{3}-27 g_{3}^{2}, \quad \Lambda(E)=\mathbb{Z} \omega_{1}+\mathbb{Z} \omega_{2}
$$

Taking $u=\omega_{1}$, and using (4) we see that $E$ is isomorphic to
$E_{\tau}: y^{2}=4 x^{3}-g_{2}(\tau) x-g_{3}(\tau), \quad \Delta\left(E_{\tau}\right)=\Delta(\tau)=g_{2}(\tau)^{3}-27 g_{3}(\tau)^{2}, \quad \Lambda_{\tau}=\mathbb{Z}+\mathbb{Z} \tau$, where $\tau=\omega_{2} / \omega_{1}$.

To find a $u$ so that $E$ is isomorphic to $E_{\lambda}$, we claim that it is necessary to set

$$
\left\{\begin{aligned}
u^{4} g_{2} & =\frac{4}{3}\left(\lambda^{2}-\lambda+1\right) \\
u^{6} g_{3} & =\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2)
\end{aligned}\right.
$$

Dividing the second equation by the first, we obtain

$$
u^{2} \frac{g_{3}}{g_{2}}=\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}
$$

or

$$
u=\sqrt{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)} \frac{g_{2}}{g_{3}}}
$$

The above is a necessary condition for $u$. To show sufficiency, observe that

$$
\begin{aligned}
u^{4} g_{2} & =g_{2} \frac{g_{2}^{2}}{g_{3}^{2}}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{2} \\
& =\frac{9 g_{2}}{4} \frac{12}{J^{1 / 3} \Delta^{1 / 3}} \frac{J-1}{J}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{2} \\
& =\frac{27 J}{J-1}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{2} \\
& =\frac{4}{3}\left(\lambda^{2}-\lambda+1\right),
\end{aligned}
$$

and

$$
\begin{aligned}
u^{6} g_{3} & =g_{3} \frac{g_{2}^{3}}{g_{3}^{3}}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{3} \\
& =\frac{27 g_{3}}{8} \frac{12^{3 / 2}}{\sqrt{J} \sqrt{\Delta}} \frac{J^{3 / 2}}{(J-1)^{3 / 2}}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{3} \\
& =\frac{27}{8} \frac{J^{3 / 2}}{(J-1)^{3 / 2}} \sqrt{\frac{J-1}{27}}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{3} \\
& =\frac{12^{3 / 2} \sqrt{27}}{8} \frac{J}{J-1}\left\{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)}\right\}^{3} \\
& =\frac{12^{3 / 2} \sqrt{27}}{8} \frac{4}{729}(\lambda+1)(2 \lambda-1)(\lambda-2) \\
& =\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2)
\end{aligned}
$$

Thus, taking

$$
u=\sqrt{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)} \frac{g_{2}}{g_{3}}}
$$

and using (4), we see that $E$ is isomorphic to

$$
\begin{aligned}
E_{\lambda}: y^{2} & =4 x^{3}-\frac{4}{3}\left(\lambda^{2}-\lambda+1\right) x-\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2), \\
\Delta\left(E_{\lambda}\right) & =16 \lambda^{2}(1-\lambda)^{2}, \quad \Lambda\left(E_{\lambda}\right)=\mathbb{Z} \Omega_{1}+\mathbb{Z} \Omega_{2} .
\end{aligned}
$$

Taking

$$
u=\sqrt{\frac{(\lambda+1)(2 \lambda-1)(\lambda-2)}{9\left(\lambda^{2}-\lambda+1\right)} \frac{g_{2}(\tau)}{g_{3}(\tau)}}
$$

we see that $E_{\tau}$ is isomorphic to $E_{\lambda}$. Hence, we have that $\Lambda\left(E_{\lambda}\right)=\mu(\tau) \Lambda_{\tau}$, where

$$
\left\{\begin{align*}
\mu(\tau) & =\sqrt{\frac{9\left(\lambda^{2}-\lambda+1\right)}{(\lambda+1)(2 \lambda-1)(\lambda-2)} \frac{g_{3}(\tau)}{g_{2}(\tau)}}  \tag{5}\\
& =\frac{\Delta(\tau)^{1 / 12}}{J^{1 / 6}} \frac{(J-1)^{1 / 4}}{27^{1 / 4}} \sqrt{\frac{9\left(\lambda^{2}-\lambda+1\right)}{(\lambda+1)(2 \lambda-1)(\lambda-2)}} \\
& =\frac{2^{1 / 3}}{27} \frac{\Delta(\tau)^{1 / 12}}{(\lambda(1-\lambda))^{1 / 6}} .
\end{align*}\right.
$$

## 3. Limit values of the modular $\lambda$ function

It is well known that for $\tau$ in the upper half-plane we have

$$
\lambda(\tau)=16 q^{1 / 2}-128 q+704 q^{3 / 2}-O\left(q^{2}\right), \quad q=e^{2 \pi i \tau}
$$

or with $x=\sqrt{q}$,

$$
\lambda(\tau)=16 x-128 x^{2}+704 x^{3}-O\left(x^{4}\right), \quad x=\sqrt{q} .
$$

In what follows and throughout the paper, the notation $\tau \rightarrow \infty$ will be synonymous with $\operatorname{Im}(\tau) \rightarrow \infty$. Therefore, we have

$$
\lim _{\tau \rightarrow \infty} \lambda(\tau)=\lim _{x \rightarrow 0}\left(16 x-128 x^{2}+704 x^{3}-O\left(x^{4}\right)\right)=0
$$

Moreover, in view of $\lambda(-1 / \tau)=1-\lambda(\tau)$, we see that

$$
\lim _{\tau \rightarrow 0} \lambda(\tau)=\lim _{\tau \rightarrow \infty} \lambda(-1 / \tau)=\lim _{\tau \rightarrow \infty}(1-\lambda(\tau))=1
$$

Furthermore, using $\lambda(\tau+1)=\lambda(\tau) /(\lambda(\tau)-1)$ together with $\lambda(-1 / \tau)=1-\lambda(\tau)$, we find that

$$
\lim _{\tau \rightarrow 1} \lambda(\tau)=\lim _{\tau \rightarrow \infty} \lambda(1-1 / \tau)=\lim _{\tau \rightarrow \infty} \frac{\lambda(-1 / \tau)}{\lambda(-1 / \tau)-1}=\lim _{\tau \rightarrow \infty} \frac{\lambda(\tau)-1}{\lambda(\tau)}=\infty
$$

Below is the table summarizing these limit values.

| $\tau$ | $\lambda(\tau)$ |
| :---: | :---: |
| $\infty$ | 0 |
| 0 | 1 |
| 1 | $\infty$ |

Table 1: Limit values of $\lambda(\tau)$

## 4. Hypergeometric representations of $\Omega_{1}$

Recall that the first solution of (1) around $\lambda=0$ is

$$
{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right) .
$$

Following the method in [1] with the homothety factor $\mu(\tau)$ in (5), we have that

$$
{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right)=\frac{(A+B \tau) \eta(\tau)^{2}}{(\lambda(1-\lambda))^{1 / 6}} .
$$

Replacing $\tau$ by $\tau+2$ leaves $\lambda(\tau)$ invariant but changes $\eta(\tau)^{2}$ by $\zeta \eta(\tau)^{2}$, where $\zeta=e^{\pi i / 3}$. Hence, we get the identity

$$
(A+B \tau) \frac{\eta(\tau)^{2}}{(\lambda(1-\lambda))^{1 / 6}}=(A+B(\tau+2)) \frac{\zeta \eta(\tau)^{2}}{(\lambda(1-\lambda))^{1 / 6}}
$$

valid for $\tau$ around $\infty$. Since both sides are nonzero for $\tau$ around $\infty$, we obtain

$$
A+B \tau=(A+B(\tau+2)) \zeta
$$

for $\tau$ around $\infty$. Upon solving for $B / A$ and taking the limit as $\tau \rightarrow \infty$, shows that $B=0$. Recalling that

$$
\lambda(\tau)=16 q^{1 / 2}-128 q+704 q^{3 / 2}-O\left(q^{2}\right), \quad q=e^{2 \pi i \tau}
$$

we find that $A=16^{1 / 6}=4^{1 / 3}$, and thus we have the identity

$$
{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right)=4^{1 / 3} \frac{\eta(\tau)^{2}}{(\lambda(1-\lambda))^{1 / 6}}
$$

We thus obtain the following period expression.
Theorem 4.1. For $\tau$ around $\infty$, we have

$$
\omega_{1}=2^{1 / 3} \pi(\lambda(1-\lambda))^{1 / 6} \Delta(E)^{-1 / 12}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right)
$$

Proof. Since $\Delta(\tau)=(2 \pi)^{12} \eta(\tau)^{24}$ and $\Delta(\tau)=\omega_{1}^{12} \Delta$, the result following from the identity above.

We state the above period expression for $E$, but if $E=E_{\lambda}$, then the period expression becomes the classical relation:

$$
\begin{equation*}
P_{1}=2 \pi_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \lambda\right) \tag{6}
\end{equation*}
$$

where $P_{1}=2 \Omega_{1}$, because $\Delta\left(E_{\lambda}\right)=16 \lambda^{2}(1-\lambda)^{2}$.
Now, we use the fact that the Galois covering $X(2) \rightarrow X(1)$ has Galois group $\mathrm{GL}_{2}\left(\mathbb{F}_{2}\right)$, which is isomorphic to $S_{3}$. Explicitly, we have generators:

$$
\left\{\begin{array}{l}
\lambda(\tau \pm 1)=\frac{\lambda(\tau)}{\lambda(\tau)-1}  \tag{7}\\
\lambda(-1 / \tau)=1-\lambda(\tau)
\end{array}\right.
$$

Applying these transformations to the above period expression around $\lambda=0$ gives all period expressions around $\lambda=0,1, \infty$. We also require the following functional equations of the Dedekind eta function:

$$
\left\{\begin{array}{l}
\eta(\tau \pm 1)=e^{ \pm \pi i / 12} \eta(\tau)  \tag{8}\\
\eta(-1 / \tau)=\eta(\tau) \sqrt{-i \tau}
\end{array}\right.
$$

Theorem 4.2. For $\tau$ around 0 , we have

$$
\omega_{1}=2^{1 / 3} \frac{\pi i}{\tau}(\lambda(1-\lambda))^{1 / 6} \Delta(E)^{-1 / 12}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; 1-\lambda\right)
$$

Proof. This is proven by applying the transformation $\tau \rightarrow-1 / \tau$ in Theorem 4.1 and using (7) and (8).

Theorem 4.3. For $\tau$ around 1, we have

$$
\omega_{1}=2^{1 / 3} \frac{\pi i}{(\tau+1) \sqrt{1-\lambda}}(\lambda(1-\lambda))^{1 / 6} \Delta(E)^{-1 / 12}{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2} ; 1 ; \frac{1}{1-\lambda}\right)
$$

Proof. This is proven by applying the transformation $\tau \rightarrow \tau+1$ in Theorem 4.2 and using (7) and (8).

## 5. Complex multiplication and quasi-PERIod RELATIONS

Suppose $\tau$ satisfies $a \tau^{2}+b \tau+c=0$ for mutually coprime integers $a, b, c$ such that $a>0$ and $-d=b^{2}-4 a c$, that is,

$$
\begin{equation*}
\tau=\frac{-b+\sqrt{-d}}{2 a} \tag{9}
\end{equation*}
$$

Let $q=e^{2 \pi i \tau}$ with $\operatorname{Im}(\tau)>0$, and define

$$
s_{2}(\tau)=\frac{E_{4}(\tau)}{E_{6}(\tau)}\left(E_{2}(\tau)-\frac{3}{\pi \operatorname{Im}(\tau)}\right)
$$

where

$$
\begin{aligned}
& E_{2}(\tau)=1-24 \sum_{n=1}^{\infty} n \frac{q^{n}}{1-q^{n}} \\
& E_{4}(\tau)=1+240 \sum_{n=1}^{\infty} n^{3} \frac{q^{n}}{1-q^{n}} \\
& E_{6}(\tau)=1-504 \sum_{n=1}^{\infty} n^{5} \frac{q^{n}}{1-q^{n}}
\end{aligned}
$$

Then we have from [4] that

$$
\begin{equation*}
\Omega_{1} \mathrm{H}_{1} \operatorname{Im}(\tau)-\Omega_{1}^{2}\left[\operatorname{Im}(\tau) \frac{3 g_{3}}{2 g_{2}} s_{2}(\tau)\right]=\pi \tag{10}
\end{equation*}
$$

by taking $E=E_{\lambda}$ so that $\omega_{i}=\Omega_{i}$ and $\eta_{i}=\mathrm{H}_{i}$.

## 6. A Chudnovsky-Ramanujan type formula

Using the differential relations derived by Bruns [3, pp. 237-238] with

$$
\begin{aligned}
g_{2} & =\frac{4}{3}\left(\lambda^{2}-\lambda+1\right), \\
g_{3} & =\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2),
\end{aligned}
$$

we obtain

$$
\begin{aligned}
\frac{d \Omega_{1}}{d \lambda} & =-\frac{\mathrm{H}_{1}}{2 \lambda(\lambda-1)}-\frac{2 \lambda-1}{6 \lambda(\lambda-1)} \Omega_{1} \\
\frac{d \mathrm{H}_{1}}{d \lambda} & =\frac{\lambda^{2}-\lambda+1}{18 \lambda(\lambda-1)} \Omega_{1}+\frac{2 \lambda-1}{6 \lambda(\lambda-1)} \mathrm{H}_{1} .
\end{aligned}
$$

Remark. These relations can also be obtained by using Fricke's and Klein's method of deriving the Picard-Fuchs differential [7] pp. 33-34] if applied to $E_{\lambda}$.

Using the first differential relation above, together with a period expression, yields a Chudnovsky-Ramanujan type formula.

Theorem 6.1. If $\tau$ satisfies (9) and is around $\infty$, and

$$
\begin{aligned}
g_{2} & =\frac{4}{3}\left(\lambda^{2}-\lambda+1\right) \\
g_{3} & =\frac{4}{27}(\lambda+1)(2 \lambda-1)(\lambda-2),
\end{aligned}
$$

then we have that

$$
-F^{2}\left[\frac{2 \lambda-1}{3}+\frac{3 g_{3}}{2 g_{2}} s_{2}(\tau)\right]+\lambda(1-\lambda) \frac{d F^{2}}{d \lambda}=\frac{2 a}{\pi \sqrt{d}}
$$

where $\lambda=\lambda(\tau)$ and $F={ }_{2} F_{1}(1 / 2,1 / 2 ; 1 ; \lambda)$.
Proof. The first differential relation is equivalent to

$$
\begin{equation*}
\mathrm{H}_{1}=-2 \lambda(\lambda-1) \frac{d \Omega_{1}}{d \lambda}-\frac{2 \lambda-1}{3} \Omega_{1} \tag{11}
\end{equation*}
$$

Substitute (11) into (10) to get

$$
\begin{aligned}
\frac{2 \pi a}{\sqrt{d}} & =-\Omega_{1}\left[2 \lambda(\lambda-1) \frac{d \Omega_{1}}{d \lambda}+\frac{2 \lambda-1}{3} \Omega_{1}+\Omega_{1} \frac{3 g_{3}}{2 g_{2}} s_{2}(\tau)\right] \\
& =-\Omega_{1}^{2}\left[\frac{2 \lambda-1}{3}+\frac{3 g_{3}}{2 g_{2}} s_{2}(\tau)\right]+2 \lambda(1-\lambda) \Omega_{1} \frac{d \Omega_{1}}{d \lambda}
\end{aligned}
$$

Then, substituting $\Omega_{1}=\pi F$ from (6), where $F={ }_{2} F_{1}(1 / 2,1 / 2 ; 1 ; \lambda)$, into the above, we obtain

$$
\frac{2 a}{\pi \sqrt{d}}=-F^{2}\left[\frac{2 \lambda-1}{3}+\frac{3 g_{3}}{2 g_{2}} s_{2}(\tau)\right]+\lambda(1-\lambda) \frac{d F^{2}}{d \lambda}
$$

Under the covering $X(2) \rightarrow X(1)$ given by

$$
J=\frac{4}{27} \frac{\left(\lambda^{2}-\lambda+1\right)^{3}}{\lambda^{2}(1-\lambda)^{2}}
$$

the only values for $\tau$ for which $\lambda(\tau) \in \mathbb{Q}$ correspond to $J=1$ and $\lambda=2,1 / 2,-1$, each with ramification index 2 . In the fundamental domain for $\Gamma(2)$, we have

$$
\begin{aligned}
\lambda\left(\frac{i \pm 1}{2}\right) & =2 \\
\lambda(i) & =\frac{1}{2} \\
\lambda(i+1) & =-1 .
\end{aligned}
$$

Using

$$
\frac{3 g_{3}}{2 g_{2}}=\Omega_{1}^{2} \frac{\pi^{2}}{3} \frac{E_{6}(\tau)}{E_{4}(\tau)}
$$

in Theorem 6.1 yields

$$
\frac{2 a}{\pi \sqrt{d}}=-F^{2}\left[\frac{2 \lambda-1}{3}+\frac{\pi^{4}}{3}\left\{E_{2}(\tau)-\frac{3}{\pi \operatorname{Im}(\tau)}\right\} F^{2}\right]+\lambda(1-\lambda) \frac{d F^{2}}{d \lambda}
$$

which can be evaluated at $\tau=i$. Recall that $E_{2}(\tau)$ is a quasi-modular form, and $E_{2}(-1 / \tau)=\tau^{2} E_{2}(\tau)-6 i \tau / \pi$ for $\tau$ in the upper half-plane. Setting $\tau=i$, shows that $E_{2}(i)=3 / \pi$, and we obtain (2). Furthermore, it is evident that $E_{2}(\tau+1)=E_{2}(\tau)$ because $q(\tau+1)=q(\tau)$. Thus, setting $\tau=i+1$, we obtain (3).
