# Bootstrap for change point detection

## 1 Introduction

The problem of change point detection appears each time one needs to explore a set of random data and make a decision about homogeneity of its structure. In other words, the problem can be stated as two following questions: were there any structural changes in the nature of observed data? At which moments, if so? The present work mainly focuses on the sequential or online change point detection. In this case the data is aggregated from running random process. Formally a time moment $\tau$ is a change point, if stochastic properties of the observed signal $\left\{Y_{t}\right\}_{t=1}^{n}$ have undergone changes in its distribution:

\begin{cases}Y_{t} \backsim \mathbb{P}_{1} & t<\tau, \\ Y_{t} \backsim \mathbb{P}_{2} & t \geq \tau .\end{cases}
$$

The goal is to find such structural breaks as soon as possible. Such problem arises across many scientific areas: quality control Lai (1995), cybersecurity Blazek and Kim (2001), Wang et al. (2004), econometrics Spokoiny (2009), Mikosch and Starica (2004), geodesy e.t.c. Article Shiryaev (1963) describes classical results in change point detection theory. Overview of the state-of-art methods are presented in Polunchenko and Tartakovsky (2011) and Shiryaev (2010).

This research considers sequential hypothesis testing, in which each hypothesis $\left(\mathbb{P}_{1}=\mathbb{P}_{2}\right)$ monitors the presence of change point through Likelihood Ratio Test (LRT) using sliding window. At each time step the procedure extracts a data slice, splits it in two parts of equal size and executes LRT on it. High values of LRT indicate possible distribution difference in the window parts $\left(\mathbb{P}_{1} \neq \mathbb{P}_{2}\right)$. Procedures with LRT are rather popular in related literature. The work Quandt (1960) proposes application of LRT for detection of breaks in linear regression model. It was further developed by many authors, e.g. Haccou et al. (1987), Srivastava and Worsley (1986). Papers Liu et al. (2008), Zou et al. (2007) investigate LRT for change point detection for nonparametric case. Nonparametric approaches are easily adaptable for complex data but in general they need more information for model building than their parametric alternatives. Introduction of parametric assumption: $\mathbb{P}_{1}, \mathbb{P}_{2} \in\left\{\mathbb{P}(\theta): \theta \in \mathbb{R}^{p}\right\}$ allows to reduce the suffisient number of observations as soon as $\mathbb{P}(\theta)$ has less degrees of freedom than nontapametric model. The state-of-the-art review of parametric models based on LRT and its application to economics and bio-informatics are presented by Chen and Gupta (2012). The paper Gombay (2000) explores how LRT can be used for sequential change point detection in case $\mathbb{P}(\theta)$ is exponential family.

The LRT statistic requires its quantiles or critical values to be set from the signal data $\left\{Y_{t}\right\}_{t=1}^{n}$. Many works are dedicated to asymptotic behaviour of LRT, e.g. Jandhyala and Fotopoulos (1999) obtains lower and upper bounds for distribution of asymptotic maximum likelihood estimator. The work Kim (1994) provides a very detailed study of its asymptotic behaviour in linear regression models. Similar results for change in mean of a Gaussian process are given in Fotopoulos et al.
(2010). In Biau et al. (2016) an approach with Wiener process and Donsker-Prohorov Theorem describes relatively general method for LRT-like statistics distribution approximation.

Instead of asymptotic distribution for LRT one may find a benefit of resampling and bootstrap. This technique is popular, e.g. Frick et al. (2014), Spokoiny (2009), since it provides a way to simulate a complex distribution of LRT statistic (for wide family of $\mathbb{P}(\theta)$ ) through empirical data distribution. Using bootstrap one can generate $\mathrm{LRT}^{b}$ statistic multiple times in order to obtain quantile distribution of the initial LRT. Both LRT and LRT ${ }^{b}$ statistics have (ref. Sections 5.2. and 5.3.) approximation with the following forms with high probability

\mathrm{LRT} \approx\|\boldsymbol{\xi}+\Delta\|, \quad \mathrm{LRT}^{b} \approx\left\|\boldsymbol{\xi}^{b}+\Delta^{b}\right\| \tag{Qf}
\end{equation*}

Larger $\Delta$ values correspond to more pronounced hypothesis rejection (more apparent changes in data sequence). Argument $\boldsymbol{\xi}$ could be treated as a noise component. For LRT critical value calibration one requires data without change points and consequently with $\Delta=0$. Section 2 contains description of a modified LRT which enable the calibration even if data contains change points.

The cornerstone of the novel change point detection procedure is the concept of change-point pattern. The geometry of a pattern depends on a type of transition region between two distributions that the data obeys before and after a change respectively. Three examples are presented at the Fig. 1. The triangle (spades) pattern appears in case of an abrupt transition from $\mathbb{P}\left(\theta_{1}\right)$ to $\mathbb{P}\left(\theta_{2}\right)$. A smooth transition between two distributions entails trapezium change-point pattern. And a horn pattern appears due to an abrupt change in variance. Processing of a change-point pattern instead of a single LRT-value allows to reduce noise influence $\xi(t)$ and false-alarm rate. The presence of change-point patterns is the corollary of (Qf) representation.


Figure 1: Types of change point and the geometry of change-point patterns: triangle pattern - abrupt mean transition, trapezium pattern - smooth mean transition, horn pattern - abrupt variance transition.

In case of a single change point one may find the pattern position by maximising convolution with a pattern function $P_{\tau}(t)$ (ref. Section 2 for details):

$$
\underset{\tau}{\operatorname{argmax}} \sum_{t} P_{\tau}(t)\|\boldsymbol{\xi}(t)+\Delta(t)\| .
$$

In order to set critical value correctly quantiles of the statistic $\max _{\tau} \sum_{t} P_{\tau}(t)\|\boldsymbol{\xi}(t)\|$ should be close in distribution to quantiles of $\max _{\tau} \sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}^{b}(t)\right\|$. Assuming that $\boldsymbol{\xi}(t) \approx \sum_{i=t-h}^{t+h} \boldsymbol{\xi}_{i}$
(independent random vectors sum), we have made probability measures comparison using technique from article Chernozhukov et al. (2013b). In Section 5.8. we prove Bootstrap approximation illustrating on the way useful mathematical concepts such as Linderberg telescoping sums, anticoncentration of normal vector, Slepian bridge and empirical covariance matrix deviations. Section 5.9. extends the statements for statistics of type $\max _{t} Q_{t}(\boldsymbol{\xi})$ (in particular $\max _{\tau} \sum_{t} P_{\tau}(t)\|\boldsymbol{\xi}(t)\|$, Section 5.10.).

The last part of this paper (Section 5.11.) contains some specification for aforementioned results with generalised linear models (GLM).

## 2 Procedure

This section provides description of the Change Point Detection algorithm which employs Likelihood Ratio Test (LRT). Let $\left(\mathbb{P}(\theta), \theta \in \mathbb{R}^{p}, L(\theta)=\log \left(\partial^{n} \mathbb{P}(\theta) / \partial Y\right)\right)$ be a parametric assumption about the nature of data inside the window $\left(Y_{t-h}, \ldots, Y_{t+h-1}\right)$ with central point $t$ and size $2 h$. Here and further we assume, that the observations $\left\{Y_{i}\right\}_{i=1}^{n}$ are independent, so

$$
\begin{equation*}
L(\theta, \mathbb{Y})=\sum_{i} l_{i}(\theta) \tag{L}
\end{equation*}
$$

Denote argmax of the Likelihood function and the "real" model parameter value as follows

$$
\widehat{\theta}=\underset{\theta}{\operatorname{argmax}} L(\theta, \mathbb{Y}), \quad \theta^{*}=\underset{\theta}{\operatorname{argmax}} \mathbb{E} L(\theta, \mathbb{Y}) .
$$

The algorithm sequentially computes LRT statistic $\left(T_{h}(t)\right)$ for each $t$ in the sliding window procedure. The LRT statistic itself corresponds to the gain from window split into two parts $\left(\mathbb{Y}_{l}, \mathbb{Y}_{r}\right)$ :

$$
\begin{gather*}
T_{h}(t)=L\left(\widehat{\theta}_{l}, \mathbb{Y}_{l}\right)+L\left(\widehat{\theta}_{r} ; \mathbb{Y}_{r}\right)-L(\widehat{\theta}, \mathbb{Y}),  \tag{T}\\
\mathbb{Y}_{l}=\left(Y_{t-h}, \ldots, Y_{t-1}\right), \quad \mathbb{Y}_{r}=\left(Y_{t}, \ldots, Y_{t+h-1}\right), \\
\widehat{\theta}_{l}=\underset{\theta}{\operatorname{argmax}} L\left(\theta, \mathbb{Y}_{l}\right), \quad \widehat{\theta}_{r}=\underset{\theta}{\operatorname{argmax}} L\left(\theta, \mathbb{Y}_{r}\right)
\end{gather*}
$$

According to the Theorem 3, encountering change point, statistic $2 T_{h}(t) \approx\|\boldsymbol{\xi}(t)+\Delta(t)\|^{2}$ starts growing according to change point pattern type (for example spades, trapezium, horn, ref. the Figure 1). In order to match pattern positions, the procedure monitors $2 h$ values of the LRT simultaneously and convolves them with each of the predefined pattern functions $P_{\tau}(t)$ :

\mathrm{TP}_{h}(\tau)=\sum_{t} P_{\tau}(t) \sqrt{2 T_{h}(t)} \tag{TP}
\end{equation*}

High values of $\mathrm{TP}_{h}(\tau)$ correspond to a sufficient correlation of $\sqrt{2 T_{h}}$ and $P_{\tau}$ (similar to the dependence on $t$ ). The algorithm marks a time moment $\tau$ at a scale $h$ as a change point, if the test statistic $\mathrm{TP}_{h}(\tau)$ exceeds a calibrated (by bootstrap procedure) critical value $z_{h}$ :

$$
\{\tau \text { is a change point }\} \Leftrightarrow\left\{\exists h: \operatorname{TP}_{h}(\tau)>z_{h}\right\} .
$$

The greater window size $h$ is chosen, the more probably the algorithm will mark $\tau$ as a change point. Again, small windows may mark $\tau$ faster.

Weighted bootstrap procedure enables resampling of the statistic $\max _{1 \leq \tau \leq n} \mathrm{TP}_{h}(\tau)$ and thus calculation of the critical value $z_{h}$ for the window size $2 h$. It generates a sequence of weighted likelihood functions, where each element is a convolution of independent likelihood components and weight vector $\left(u_{1}^{b}, \ldots, u_{n}^{b}\right)$ :

L^{b}(\theta, \mathbb{Y})=\sum_{i} u_{i}^{b} l_{i}(\theta), \tag{Lb}
\end{equation*}

where $\left\{u_{i}^{b}\right\}_{i=1}^{n}$ are i.i.d. and $u_{i}^{b} \in \mathcal{N}(1,1)$. At each weights generation one gets a new value of $L^{b}(\theta)$ and its optimal parameter $\theta^{b}$ and thus bootstrap procedure enables to estimate $L(\widehat{\theta})$ fluctuations. The corresponding bootstrap LRT statistic is

\begin{gather*}
T_{h}^{b}(t)=L^{b}\left(\theta_{l}^{b}, \mathbb{Y}_{l}\right)+L^{b}\left(\theta_{r}^{b}, \mathbb{Y}_{r}\right)-\sup _{\theta}\left\{L^{b}\left(\theta, \mathbb{Y}_{l}\right)+L^{b}\left(\theta+\widehat{\theta}_{r}-\widehat{\theta}_{l}, \mathbb{Y}_{r}\right)\right\}  \tag{Tb}\\
\theta^{b}=\underset{\theta}{\operatorname{argmax}} L^{b}(\theta, \mathbb{Y})
\end{gather*}
$$

Parameter $\left(\widehat{\theta}_{r}-\widehat{\theta}_{l}\right)$ is required for condition $T_{h}^{b} \approx\left\|\xi^{b}\right\|$ (ref. Theorem 6). In this case one can estimate $\max _{1 \leq \tau \leq n} \operatorname{TP}_{h}^{b}(\tau)$ quantiles under the null hypothesis $\left(\Delta^{b}(t) \propto \widehat{\theta}_{r}(t)-\widehat{\theta}_{l}(t)\right)$ instead of the false assumption ( $\left.\Delta^{b}(t)=0\right)$.

Empirical bootstrap version generates subsamples of data $\left\{Y_{k}\right\}$ from the complete dataset with random independent indexes of size $n$. In this case

$$
\begin{equation*}
L^{\epsilon}(\theta, \mathbb{Y})=\sum_{i} l_{k(i)}(\theta), \tag{Le}
\end{equation*}
$$

where $\{k(i)\}_{i=1}^{n}$ are i.i.d. and $k(i) \in\{1, \ldots, n\}$. For all window positions $\widehat{\theta}_{r}=\widehat{\theta}_{l}=\widehat{\theta}$ and here bias correction is not required. So the corresponding LRT statistic is like (T):

\begin{gather*}
T_{h}^{\epsilon}(t)=L^{\epsilon}\left(\theta_{l}^{\epsilon}, \mathbb{Y}_{l}\right)+L^{\epsilon}\left(\theta_{r}^{\epsilon}, \mathbb{Y}_{r}\right)-L^{\epsilon}\left(\theta^{\epsilon}, \mathbb{Y}\right),  \tag{Te}\\
\theta^{\epsilon}=\underset{\theta}{\operatorname{argmax}} L^{\epsilon}(\theta, \mathbb{Y}) .
\end{gather*}
$$

Empirical bootstrap works better in the application but less suitable for theoretical investigations (the distribution is discontinuous).

## 3 Main results

Below we present the Theorems that describes difference between probabilistic measures of $\mathrm{TP}_{h}(\tau)$ and $\mathrm{TP}_{h}^{\mathrm{b}}(\tau)$ (precision of the bootstrap calibration) and LRT sensitivity to parameter $\theta^{*}$ transition at change point. In independent models each noise vector $\boldsymbol{\xi}_{l r}(t)=\boldsymbol{\xi}(t) \in \mathbb{R}^{p}$ is a sum of independent vectors (ref. Section 5.2. for $\boldsymbol{\xi}_{l r}(t)$ definition)

$$
\boldsymbol{\xi}_{l r}(t)=\sum_{i=t-h}^{t-1} \boldsymbol{\xi}_{i}-\sum_{i=t}^{t+h-1} \boldsymbol{\xi}_{i}, \quad \boldsymbol{\xi}_{i} \propto \nabla l_{i}\left(\theta^{*}\right)
$$

Aggregate all $\boldsymbol{\xi}_{i}$ into one vector

$$
\boldsymbol{\xi}^{T}=\left(\boldsymbol{\xi}_{1}^{T}, \ldots, \boldsymbol{\xi}_{n}^{T}\right)
$$

Theorem 1. Let dataset size be $n$ and the window equal to $h$. Include conditions from lemmas 3,6 and 9 . Then for each fixed $z$

& \Delta_{T V}=C_{1} \mu_{Z}+C_{2}\left\|\operatorname{Var}\left(\boldsymbol{\xi}_{l r}\right)-\operatorname{Var}^{\mathrm{b}}\left(\boldsymbol{\xi}_{l r}^{\mathrm{b}}\right)\right\|_{\infty}^{1 / 2}+7 C_{A}\left(\diamond+\diamond^{\mathrm{b}}\right),

where

Constants $C_{\mu} \sim \log ^{2}(n), C_{\Sigma} \sim \log (n)$ and $C_{A} \approx p^{3 / 2} \log (n)$ are described in Section 5.10..
The proof is a direct consequence of Theorems 3, 6 and 9.
Remark. 1. Parameters asymptotic

2. For quantile estimation of the statistic $\max _{1 \leq \tau \leq n} \operatorname{TP}_{h}(\tau)$ with quantile of $\max _{1 \leq \tau \leq n} \operatorname{TP}_{h}^{\mathrm{b}}(\tau)$ one has to show that

\left|\mathbb{P}\left(\max _{1 \leq \tau \leq n} \mathrm{TP}_{h}(\tau)>z^{b}(\alpha)\right)-\alpha\right| \leq \Delta_{T V}

for $z^{b}(\alpha)$ defined by equation

$$
\mathbb{P}^{b}\left(\max _{1 \leq \tau \leq n} \operatorname{TP}_{h}^{b}(\tau)>z^{b}(\alpha)\right)=\alpha
$$

This statement is a consequence of the Theorem (1) but not a direct one since the argument $z^{b}(\alpha)$ is random and depends on $\max _{1 \leq \tau \leq n} \mathrm{TP}_{h}(\tau)$. Involving sandwich Lemma 21 fulfills this issue.

The next part of this Section evaluates the smallest parameter $\theta^{*}$ transition that is sufficient for change point detection in a fixed position $\tau$ and window size $2 h$. Let $z_{h}(\alpha)$ be a quantile of $\sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}_{l r}(t)\right\|$ such that

\mathbb{P}\left(\sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}_{l r}(t)\right\|>z_{h}(\alpha)\right)=\alpha \leq \frac{\operatorname{Var}\left(\sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}_{l r}(t)\right\|\right)}{\left(z_{h}(\alpha)-\sum_{t} P_{\tau}(t) \mathbb{E}\left\|\boldsymbol{\xi}_{l r}(t)\right\|\right)^{2}}

Section 5.17. provides upper bound for $\alpha$ and is summarized in following statement.
Theorem 2. Let $\sum_{t} P_{\tau}(t)=0$ and $\mathbb{E}\left\|\boldsymbol{\xi}_{l r}(t)\right\|=\sqrt{p}$. The sufficient condition for abrupt type change point detection of size $\Delta$ with probability $1-e^{-\mathrm{x}}$ in position $\tau$ using triangle pattern ( P ) is

where matrix $D_{l r}$ is defined in Theorem 3.

## 4 Experiments

In order to substantiate patterns utility we compare procedure from Section 2 with the similar one but without pattern (i.e. $P_{\tau}(t)=\mathbb{I}[\tau=t]$ ). The experiment scenario is follows. The dataset $\left\{Y_{i}\right\}$ consists of 500 normal random vectors from $\mathbb{R}^{5}$ with one change point at position $\tau^{*}=250$.

The procedure searches for change point location as $\widehat{\tau}=\operatorname{argmax}_{\tau} \mathrm{TP}_{h}(\tau)$. Then the quality of the detection is measured by average error $\left|\widehat{\tau}-\tau^{*}\right|$ (c.p. position error) and fraction of the detected change points (POWER) (ref. Figure 2).


Figure 2: Change point localisation test and power test for the procedure from Section 2. One case with triangle pattern and the other case without pattern.

The second experiment describes bootstrap convergence depending on window size ( $2 h$ ). We set bootstrap confidence level equal to 0.1 and compute p-value from real distribution with bootstrap quantile $z^{b}$.

From the plot below (ref. Figure 3) one can observe that

$$
\beta>\frac{1}{2},
$$

which suppose better convergence in comparison with the theoretical study (ref. Theorem 1), where $\beta=1 / 6$.


Figure 3: Bootstrap convergence. Homogeneous data: $Y_{i} \in \mathcal{N}\left(0, I_{p}\right), 0 \leq i<6 h$, data with change point: $Y_{i} \in \mathcal{N}\left(0, I_{p}\right), 0 \leq i<3 h, \quad Y_{i} \in \mathcal{N}\left(0.3, I_{p}\right), 3 h \leq i<6 h$. The parameters are $p=30$, $h \in\{10,20,30,40,50\}$.

The last experimental part presents results of the comparison of the proposed algorithm of change point detection (LRTOffline) 2 with two other methods: Bayesian online changepoint
detection (BOCPD) from Adams and MacKay (2007) and cpt.meanvar(PELT,...) (RMeanVar) from R package. The first method is constructed for online inference, but so far as it returns CP location with each CP signal, it is also applicable for offline testing scenario. The idea of this method is predictive filtering: its forecasts a new data point using only the information have been observed already, where the distribution family is fixed (Normal for the tests in this paper). Bayesian inference calculates the length of the observed data (from the last CP). The second algorithm also uses preliminary specified model. Its design focuses into finding multiple changes in mean and variance in Normally (another distributions also supported) distributed data. The returned set of change points is the result of sequential testing $H_{0}$ (existing number of change points) against $H_{1}$ (one extra change point) applying the likelihood ratio statistic of the whole data coupled with the penalty for CP count. RMeanVar performs better than well known method CUSUM due to synchronous changes in both data parameters mean and variance.

Quality of measurements uses Normalised Mutual Information (NMI). The next equation defines NMI measure of two partitions $(X, Y)$ of time range by change points

\operatorname{NMI}(X, Y)=2 \frac{H(X)+H(Y)-H(X, Y)}{H(X)+H(Y)}
$$

$H(X)$ and $H(X, Y)$ and entropy functions. Higher NMI values (they are in $[0,1])$ correspond to better quality.

Synthetic test data have been generated with different values of the distribution parameter transition ( $\Delta$ ). Each $\Delta$ value corresponds to 10 sampled data sequences over which one compute measure average. Each data sequence has two, one or none change points. The data has two distributions: normal $(\mathcal{N}(\theta(1), \theta(2)))$ and Poisson $(\operatorname{Po}(\theta))$. Parametric assumption for all methods is $\mathcal{N}(\theta(1), \theta(2))$, so Poisson data corresponds to misspecification scenario.


Figure 4: First data: $\mathcal{N}(\theta(1), \theta(2))$, second data: $\operatorname{Po}(\theta)$, data size $=340$, parametric assumption for all methods is $\mathcal{N}(\theta(1), \theta(2))$, NMI - Normalized Mutual Information between predicted and reference partitions of time interval with change points, change points count per test $\{0,1,2\}$.

In the tests with normal data all the methods achieves similar NMI scores. In the tests with Poisson data (misspecification) RMeanVar has relatively low quality and LRTOffline outperforms slightly BOCPD method.

## 5 Appendix

### 5.1. Likelihood function restrictions

Assume that for each data subset $\mathbb{Y}=\left\{Y_{i}\right\}_{i=t}^{t+h}$ the likelihood function $L(\theta)=L(\theta, \mathbb{Y})$ has rather precise approximation by its quadratic Tailor expansion in a local region $\Theta(r)$ with central point $\theta^{*}$ :

L(\theta) \approx L\left(\theta^{*}\right)+\boldsymbol{\xi}^{T} D\left(\theta-\theta^{*}\right)-\frac{1}{2}\left\|D\left(\theta-\theta^{*}\right)\right\|^{2},

Approximation of $T_{h}(t)$ by its quadratic form splits noise and deterministic parts, such that $2 T_{h}(t) \approx\left\|D\left(\theta_{r}^{*}-\theta_{l}^{*}\right)+\boldsymbol{\xi}_{l r}\right\|^{2}$. In the fixed window position the likelihood function has view

### 5.3. Bootstrap Wilks and Fisher expansions

As it was mentioned in Section 2 the bootstrap procedure allows to yield likelihood function with two options: each likelihood component is multiplied by weight (weighted bootstrap) or new data is resampled (empirical bootstrap). The likelihood function in weighted bootstrap case is a zipped sum with i.i.d weights $\left(u_{1}^{b}, \ldots, u_{n}^{b}\right)$ and independent $\left\{l_{i}(\theta)\right\}_{i=1}^{n}$ :

Each weight element has $\operatorname{Var}^{b} u_{i}^{b}=1$ and $\mathbb{E}^{b} u_{i}^{b}=1$, which is made with a view

It is expected that $\operatorname{Var}^{b} \nabla L^{b}(\theta)$ is close to $\operatorname{Var} \nabla L(\theta)$, which depends on $\mathbb{E} \nabla l_{i}(\theta)$ values. For example in i.i.d models $\mathbb{E} \nabla l_{i}\left(\theta^{*}\right)=0$ and $\mathbb{E} \nabla l_{i}(\theta)$ is close to zero in $\Theta(r)$.

### 5.4. Bootstrap measure approximation scheme

Approximation of $\mathbb{P}$ measure and variable $f(X)$ ( $f$ is non-random) by corresponded bootstrap (empirical) measure $\mathbb{P}^{b}$ and variable $f\left(X^{b}\right)$ could be done in three steps: 1 ) approximate $f(\cdot)$ by smooth function $f_{\triangle}(\cdot)$ and II by smooth indicator; 2 ) make Gaussian approximation and Gaussian comparison for variables $f_{\triangle}(X)$ and $\left.f_{\Delta}\left(X^{b}\right) ; 3\right)$ find anti-concentration bound for $\mathbb{P}(f(\widetilde{X})<x)$.


### 5.5. Anti-concentration

Anti-concentration property can be interpreted as an asymptotic of probability measure depending on event size, tending to zero. Denote by $A_{\varepsilon} \backslash A$ a region of size $\varepsilon$ around event $A$. Then anti-concentration is higher when probability of $A_{\varepsilon} \backslash A$ is lower. The next lemma deals with anti-concentration in one dimensional case where the random variable is maximum of a Gaussian vector.

The goal of Gaussian approximation is to measure the difference between a distribution of independent random vectors sum and distribution of the closest Gaussian vector. It makes sequential replacement of random arguments in function $\mathbb{E} f\left(X_{1}+\ldots+X_{n}\right)$ by its normal duplicates with the same moments:

\end{gather*}

Consider linear forms $(A X)$ with sparse-row matrices and random vector $X=\left(X_{1}, \ldots, X_{n}\right)$ with independent elements (sub-vectors). In order to make approximation by Gaussian vector $A \widetilde{X}$ one have to group $\left(X_{1}, \ldots, X_{n}\right)$ such that elements in one group has no common non-zero coefficients in each row of matrix $A$. This allows following representation

A X=Z=Z_{1}+\ldots+Z_{h}, \quad Z_{i}=A F_{i} X
$$

vectors $\left\{Z_{i}\right\}$ are independent and $F_{i}$ is a filter for the $i$-th group that sets matrix columns to 0 related to the other groups. In case each row of the matrix $A$ has no more than $h$ non-zero elements then minimal groups count equals to $h$. The next statement confirms it.

Lemma 4. Let each element in a set of subsets $\left\{\mathcal{M}_{s}\right\}$ has size $h$. Then subsets $\left\{\mathcal{Z}_{1}, \ldots, \mathcal{Z}_{h}\right\}$ exist with properties

Proof. Build subsets $\left\{\mathcal{Z}_{1}, \ldots, \mathcal{Z}_{h}\right\}$ constructively. Take one element from $\bigcup_{s} \mathcal{M}_{s}$. Exclude this element from all $\left\{\mathcal{M}_{s}\right\}$ and add it to $\mathcal{Z}_{1}$. Mark subsets which contain this element as $\left\{\mathcal{M}_{s}^{\prime}\right\}$. Take another element from $\bigcup_{s} \mathcal{M}_{s} \backslash \bigcup_{s} \mathcal{M}_{s}^{\prime}$ and add it to $\mathcal{Z}_{1}$. Repeat this procedure until $\left|\bigcup_{s} \mathcal{M}_{s} \backslash \bigcup_{s} \mathcal{M}_{s}^{\prime}\right|=0$. Then do the same steps for $\bigcup_{s} \mathcal{M}_{s} \backslash \mathcal{Z}_{1}$ and obtain $\mathcal{Z}_{2}$ with the required properties by construction.

Summarise results of this Section. Apply equation (ErrG) to $Z_{i}$ instead of $X_{i}$.
Lemma 5. Let matrix $A$ has at most $h$ non-zero elements in each row and non-zero elements correspond to independent elements in vector $X=\left(X_{1}, \ldots, X_{n}\right)$. Then Gaussian approximation with vector $\widetilde{X}$ has following upper bound

\end{aligned}

### 5.7. Gaussian comparison

This Section deals with extension of the Gaussian approximation (ref. Section5.6.) for the case when the second moments of $\operatorname{Var} X$ and $\operatorname{Var} \widetilde{X}$ are slightly different. Let as previously $X=\sum_{i=1}^{n} X_{i}$ and

Then after sequential replacement $X_{i} \rightarrow \widetilde{X}_{i}$ the approximation bound term will be

while

\|\operatorname{Var} X-\operatorname{Var} \tilde{X}\|_{\infty} \sim \frac{1}{\sqrt{n}} .

The next lemma resolves this problem. At first one is able to make Gaussian approximation with equal variances $(\operatorname{Var} X=\operatorname{Var} \widetilde{X})$, and then compare two Gaussian vectors with different variances.

Lemma 6. Let $X$ and $Y$ be two zero mean Gaussian vectors with $\Sigma_{X}=\operatorname{Var}(X)$ and $\Sigma_{Y}=$ $\operatorname{Var}(Y)$. Let also $f(X)$ be a smooth function. Then

Proof. Without loss of generality assume that $X$ and $Y$ are given on the same probability space and independent. For each $t \in[0,1]$, define

\epsilon=|\Psi(1)-\Psi(0)|=\left|\int_{0}^{1} \Psi^{\prime}(t) d t\right| \\
\Psi^{\prime}(t)=\mathbb{E}\left[\nabla f(Z(t))^{\top} Z^{\prime}(t)\right]=\frac{1}{2} \mathbb{E}\left[\left\{t^{-1 / 2} X-(1-t)^{-1 / 2} Y\right\}^{\top} \nabla f(Z(t))\right]
\end{gathered}
$$

To compute this expectation, we apply the Stein identity. Let $W$ be a zero mean Gaussian vector. Then for any $C^{1}$ vector function $s$ it holds

\left|\Psi^{\prime}(t)\right| \leq \frac{1}{2}\left|\operatorname{tr}\left\{\left(\Sigma_{X}-\Sigma_{Y}\right) \mathbb{E}\left[\nabla^{2} f(Z(t))\right]\right\}\right| \\
\leq \frac{1}{2}\left\|\Sigma_{X}-\Sigma_{Y}\right\|_{\infty}\left\|\mathbb{E}\left[\nabla^{2} f(Z(t))\right]\right\|_{1} \leq \frac{1}{2}\left\|\Sigma_{X}-\Sigma_{Y}\right\|_{\infty} \mathbb{E}\left\|\nabla^{2} f\right\|_{1} .
\end{gathered}
$$

Find an upper bound for distribution difference

$$
E_{G C}=|\mathbb{P}(H(X) \leq z)-\mathbb{P}(H(Y) \leq z)|
$$

Identically to Section 5.6. consider a composition of a smooth indicator $g_{\triangle}$ and a differentiable smooth approximation $h$ for function $H$. The approximation satisfies condition (SmAprx). Assume that $g_{\Delta}$ grows from 0 to 1 in interval $[z, z+\Delta]$. So $g_{\Delta}^{\prime}=0$ outsize $[z, z+\triangle]$. Assume following restriction for the second derivative of the function $f=g_{\triangle} \circ h$ and define $C_{\Sigma}$ :

& \leq\left\|\nabla^{2} g_{\triangle} \circ h\right\|_{1} \mathbb{E} \mathbb{I}[h(X) \in[z, z+\triangle]]\left\|\Sigma_{X}-\Sigma_{Y}\right\|_{\infty}, \\
& \leq \frac{1}{\triangle^{2}} C_{\Sigma} \mathbb{E} \mathbb{I}[H(X) \in[z, z+2 \Delta]]\left\|\Sigma_{X}-\Sigma_{Y}\right\|_{\infty} .
\end{aligned}
$$

Following the logic from Section 5.6. the anti-concentration (ref. Section 5.5.) property allows $2 \triangle$-shift elimination and provides an upper bound for $\mathbb{E} \mathbb{I}[H(X) \in[z, z+2 \triangle]]$.

Optimize over $\triangle$ values

E_{G C} \leq 4 C_{\Sigma}^{1 / 2} C_{A}\left\|\Sigma_{X}-\Sigma_{Y}\right\|_{\infty}^{1 / 2} .

Summarise the discussion related to $E_{G C}$ bound.
Lemma 7. Let function $H(X)$ with Gaussian argument satisfies anti-concentration with $C_{A}$ constant, $X$ and $Y$ be two zero mean Gaussian vectors with $\Sigma_{X}=\operatorname{Var}(X)$ and $\Sigma_{Y}=\operatorname{Var}(Y)$. Then under condition (SmAprx)

Consider a random vector $X=\left(X_{1}, \ldots, X_{n}\right)$ with independent sub-vectors $\left\{X_{i}\right\}$ and matrix $A$ which consists of blocks of size $[p \times p], p=\operatorname{dim}\left(X_{i}\right)$. Define also a bootstrap vector with independent random weights $\left\{\varepsilon_{i}^{b}\right\}$, such that $X^{b}=\left(\varepsilon_{1}^{b} X_{1}, \ldots, \varepsilon_{n}^{b} X_{n}\right)$.

A=\left(\begin{array}{ccc}
a_{11} I_{p} & \ldots & a_{1 n} I_{p} \\
& \ldots & \\
a_{n 1} I_{p} & \ldots & a_{n n} I_{p}
\end{array}\right) .
$$

The next comparison of $H(A X)$ and $H\left(A X^{b}\right)$ my means of (ErrGC) require upper bound for the maximal element of the covariance matrices difference.

$$
\left\|\Sigma_{A X}-\Sigma_{A X}^{b}\right\|_{\infty}=\max _{a^{T}, b^{T} \in \text { rows } A}\left|a^{T}\left(\Sigma-\Sigma^{b}\right) b\right| .
$$

Let for a fixed rows $a, b$ with probability $1-e^{-\mathrm{x}}$

Note that elements in sum $\left(a_{i} b_{i} X_{i} X_{j}\right)$ are independent due to the specific block structure of matrix $A$. Then the joint bound with probability $1-e^{-\mathrm{x}}$ is

where $\mathrm{v}_{\varepsilon \varepsilon}=\delta \sqrt{\|\Sigma\|_{\infty}}(3+\|b\|)$,

V \delta=\|A\|_{\infty}, \quad V^{2}=\sum_{i j} a_{i} b_{j} \Sigma_{i j} \leq\|A\|^{2}\|\Sigma\|_{\infty}, \quad\|b\|^{2}=\sum_{i: a_{i}>0} \mathbb{E} X_{i}^{2}
$$

Finally under assumption $\frac{2}{3} R_{\varepsilon \varepsilon} \mathrm{x}<\mathrm{v}_{\varepsilon \varepsilon} \sqrt{5 \mathrm{x}}$ with probability $1-1 / n$

\left\|\Sigma_{A X}-\Sigma_{A X}^{b}\right\|_{\infty} \leq 10 \sqrt{\log (n p)}\|A\|\|A\|_{\infty}\|\Sigma\|_{\infty}(3+\|b\|)+\|A\|_{\infty}^{2}\|b\|^{2} . \tag{dSA}
\end{equation*}

### 5.8. Smooth-max properties

Denote by $h(x)$ a smooth maximum function which converges to $\max _{i} x_{i}$ when $\beta \rightarrow \infty$.

h(x)=\beta^{-1} \log u(x), \quad u(x)=\sum_{i} e^{\beta x_{i}}, \quad x=\left(x_{1}, x_{2}, \ldots\right) .
$$

Characterize its derivatives which will be used further in Tailor expansions.
Lemma 8. All derivatives of $h(x)$ of order $m=\{1,2,3\}$ have following upper bounds $\forall x$

\left\|\nabla^{(m)} h(x)\right\|_{1} \leq \beta^{m-1}
$$

Proof.

\begin{aligned}
\nabla h(x) & =\beta^{-1} \frac{\nabla u}{u} \\
\nabla^{2} h(x) & =\beta^{-1}\left(\frac{\nabla \otimes \nabla u}{u}-\frac{\nabla u \otimes \nabla u}{u^{2}}\right), \\
\nabla^{3} h(x) & =\beta^{-1}\left(\frac{\nabla \otimes \nabla \otimes \nabla u}{u}-\frac{\nabla \otimes \nabla u \otimes \nabla u}{u^{2}}-\frac{\nabla \otimes(\nabla u \otimes \nabla u)}{u^{2}}+2 \frac{\nabla u \otimes \nabla u \otimes \nabla u}{u^{3}}\right) .
\end{aligned}
$$

Define $p_{i}=\frac{\nabla u}{u}(i)$ that satisfies condition $\sum_{i} p_{i}=1$. The first tensor norm equals to the convolution maximum with vectors $\alpha, \phi, \gamma$ under restriction $\|\alpha\|_{\infty}=1,\|\phi\|_{\infty}=1,\|\gamma\|_{\infty}=1$.

$$
\begin{aligned}
\alpha^{T} \nabla^{2} h(x) \gamma & =\beta\left(\sum p_{i} \alpha_{i} \gamma_{i}-\sum p_{i} \alpha_{i} \sum p_{j} \gamma_{j}\right) \\
& =\beta(\mathbb{E} \alpha \gamma-\mathbb{E} \alpha \mathbb{E} \beta \gamma)=\beta \mathbb{E} \alpha \gamma \gamma \beta\|\alpha\|_{\infty}\|\gamma\|_{\infty}, \\
\sum_{i j k} \nabla_{i j k}^{3} h(x) \alpha_{i} \phi_{j} \gamma_{k} & =\beta^{2}(\mathbb{E} \alpha \phi \gamma-\mathbb{E} \alpha \mathbb{E} \phi \gamma-\mathbb{E} \alpha \phi \mathbb{E} \gamma-\mathbb{E} \alpha \gamma \mathbb{E} \phi+2 \mathbb{E} \alpha \mathbb{E} \phi \mathbb{E} \gamma) \\
& =\beta^{2}\left(\mathbb{E}^{o} \alpha \stackrel{o}{o} \gamma\right) \leq \beta^{2}\|\alpha\|_{\infty}\|\phi\|_{\infty}\|\gamma\|_{\infty} .
\end{aligned}

Taking maximum provides the required restriction for L1 tensor norms.

The next property of $h(x)$ with $x \in \mathbb{R}^{p}$ characterise the error of smooth maximum approximation

\left\|\nabla^{3} h(q(X))\right\|_{1} \leq\left\|\nabla^{3} h\right\|_{1}\left\|\nabla q_{t}\right\|_{1}^{3}+3\left\|\nabla^{2} h\right\|_{1}\left\|\nabla^{2} q_{t}\right\|_{1}\left\|\nabla q_{t}\right\|_{1}+\|\nabla h\|_{1}\left\|\nabla^{3} q_{t}\right\|_{1} \\
\leq \frac{1}{\triangle^{2}}\left(\log ^{2} T+3 C_{q} \log T+C_{q}^{2}\right) .
\end{gathered}

So one can override the constants used in (ErrG) and (ErrGC) for the case $H(X)=\max _{1 \leq t \leq T} Q_{t}(X)$ :

### 5.10. LRT bootstrap precision

Consider statistic $\mathrm{TP}_{h}(\tau)$ and the corresponded bootstrap analogy $\mathrm{TP}_{h}^{\mathrm{b}}(\tau)$ defined in Section 2. One could also repeat the further logic for empirical bootstrap $\operatorname{TP}_{h}^{\epsilon}(\tau)$. Describe the bootstrap approximation for the quadratic form of the statistic $\mathrm{TP}_{h}(\tau)$ on the grounds of Theorems 3 and 6 . The quadratic form of $\mathrm{TP}_{h}(\tau)$ is

\max _{1 \leq \tau \leq n}\left\{\sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}_{l r}(t)\right\|\right\} . \tag{TPQ}
\end{equation*}
$$

The corresponded bootstrap quadratic form is

\max _{1 \leq \tau \leq n}\left\{\sum_{t} P_{\tau}(t)\left\|\boldsymbol{\xi}_{l r}^{b}(t)\right\|\right\}
$$

Our aim is to show that these two forms are close by distribution. For simplification assume that for all window positions the true model parameter is fixed $\theta_{l}^{*}=\theta_{r}^{*}=\theta^{*}$. Then $\boldsymbol{\xi}_{l r}(t)$ doesn't pay attention on parameter changes and

### 5.11. Generalized linear model case

Generalized linear models (GLM) are frequently used for modeling the data with special structure: categorical data, binary data, Poisson and exponential data, volatility models, etc. All these examples can be treated in a unified way by a GLM approach. This section specifies the results and conditions to this case. Let $\mathbb{Y}=\left(Y_{1}, \ldots, Y_{n}\right) \sim \mathbb{P}$ be a sample of independent r.v.'s. The parametric GLM is given by $Y_{i} \sim \mathbb{P}_{\psi_{i}^{T} \theta}$, where $\psi_{i}$ are given factors in $\mathbb{R}^{p}$. Generalised linear model may be presented in form

L(\theta)=S^{T} \theta-A(\theta)
$$

where

$$
A(\theta)=\sum_{i=1}^{n} g\left(\psi_{i}^{T} \theta\right), \quad S=\sum_{i=1}^{n} Y_{i} \psi_{i} .
$$

This model has following properties (ref. Section 5.1.)

-\nabla^{2} \mathbb{E} L(\theta)=D^{2}(\theta)=\sum_{i=1}^{n} g^{\prime \prime}\left(\psi_{i}^{T} \theta\right) \psi_{i} \psi_{i}^{T} \\
\delta(r)=a_{g} \delta_{\psi} r
\end{gathered}
$$

where

a_{g}=\max _{x} \frac{g^{\prime \prime \prime}(x)}{g^{\prime \prime}(x)}, \quad \delta_{\psi}=\max _{i}\left\|D^{-1} \psi_{i}\right\| .
$$

As $g(\cdot)$ is convex, it holds $g^{\prime \prime}(u) \geq 0$ for any $u$ and thus $D^{2}(\theta) \geq 0$. An important feature of a GLM is that the stochastic component $\zeta(\theta)$ of $L(\theta)$ is linear in $\theta$ : with $\varepsilon_{i}=Y_{i}-\mathbb{E} Y_{i}$

\zeta(\theta)=\sum_{i=1}^{n} \varepsilon_{i} \psi_{i}^{\top} \theta, \quad \boldsymbol{\xi}=D^{-1} \sum_{i=1}^{n} \varepsilon_{i} \psi_{i} .
$$

Linearity in $\theta$ of the stochastic component $\zeta(\theta)$ and concavity of the deterministic part $\mathbb{E} L(\theta)$ allow for a simple and straightforward proof of the result about localisation of the MLE $\widehat{\theta}$ in the region $\Theta\left(r_{0}\right)$ (ref. condition L and Theorem 2.1 in Spokoiny (2012)).

Theorem 10. If for some $\mathrm{r}_{0}>0, D(\theta)$ fulfils dD condition with $\delta\left(\mathrm{r}_{0}\right)<1$, and if $\boldsymbol{\xi}$ is a sub-Gaussian vector (SG) with variance matrix $B$ then

&= \boldsymbol{\xi}^{\top} D_{0}\left(\theta-\theta^{*}\right)+\frac{1-\delta\left(\mathrm{r}_{0}\right)}{2} \mathrm{r}_{0}^{2} \geq-\|\boldsymbol{\xi}\| \mathrm{r}_{0}+\frac{1-\delta\left(\mathrm{r}_{0}\right)}{2} \mathrm{r}_{0}^{2} .
\end{aligned}

If $\|\boldsymbol{\xi}\| \leq \mathrm{r}_{0}\left\{1-\delta\left(\mathrm{r}_{0}\right)\right\} / 2$, then this implies $L\left(\theta^{*}\right)-L(\theta)>0$, and the result follows. Theorem 16 gives a probabilistic restriction for $\|\boldsymbol{\xi}\|$ :

$$

Analogically divide $\varepsilon$ into mean and stochastic parts

\varepsilon=\mathbb{E} \varepsilon+(\varepsilon-\mathbb{E} \varepsilon)=B+\zeta
$$

Then initial term includes three parts:

& +\mathcal{U} \text { blockDiag }\left(\zeta \zeta^{T}-\Sigma\right) \mathcal{U}^{\top} .

Estimate successively each component.

\log \mathbb{E} \exp \left\{\left\|\mathcal{U}_{i} A_{i j} \mathcal{U}_{j}^{T}\right\|_{\mathrm{op}}\right\}=\log \mathbb{E} \exp \left\{\sup _{u_{i}, u_{j}} u_{i}^{T} A_{i j} u_{j}\right\}, \quad\left\|u_{i}\right\|^{2},\left\|u_{j}\right\|^{2} \leq \delta^{2}
$$

Sub-Gaussian properties for exponential moments (Lemma 17) lead to $\exists M_{\zeta \zeta}, M_{\zeta B}$ :

& \leq S G\left\{\|\xi\|^{2}, 2 \delta^{2}\left\|\Sigma_{i i}\right\|_{\mathrm{op}} / M_{\zeta \zeta}\right\}-\frac{2 \delta^{2}}{M_{\zeta \zeta}} \lambda_{\min }\left(\Sigma_{i i}\right) \leq \log (2) \\

Define short notation for upper bounds of such characteristics

\log \mathbb{E} \exp (\lambda X) \leq S G(X, \lambda)
$$

For ease of presentation, assume below that g is sufficiently large, namely, $0.3 \mathrm{~g} \geq \sqrt{p}$. In typical examples of an i.i.d. sample, $\mathrm{g} \asymp \sqrt{n}$. Define $\mathrm{x}_{c}=\mathrm{g}^{2} / 4$.

Lemma 15. Let (SG) hold and $0.3 \mathrm{~g} \geq \sqrt{p}$. Then for each $\mathrm{x}>0$

z_{c}^{2} \stackrel{\text { def }}{=} \mathrm{p}+\mathrm{vg}+\lambda \mathrm{g}^{2} / 2, \\
\mathrm{~g}_{c} \stackrel{\text { def }}{=} \frac{\sqrt{\mathrm{p} / \lambda+\mathrm{gv} / \lambda+\mathrm{g}^{2} / 2}}{1+\mathrm{v} /(\lambda \mathrm{g})}
\end{gathered}
$$

Lemma 16. Let (SG) hold and $0.3 \mathrm{~g} \geq \sqrt{\mathrm{p} / \lambda}$. Then for each $\mathrm{x}>0$

The upper quantile $z(B, \mathrm{x})=\sqrt{\mathrm{p}+2 \mathrm{vx}^{1 / 2}+2 \lambda \mathrm{x}}$ can be upper bounded by $\sqrt{\mathrm{p}}+\sqrt{2 \lambda \mathrm{x}}$ :

Lemma 18. Suppose (SG) and $\|B\|_{\mathrm{op}}=1$. For any $\mu<1$ with $\mathrm{g}^{2} / \mu \geq \mathrm{p}$, it holds

\mathbb{E} \exp \left(\mu\left\|B^{1 / 2} \xi\right\|^{2} / 2\right) \mathbb{I}(\|B \xi\| \leq \mathrm{g} / \mu-\sqrt{\mathrm{p} / \mu}) \leq 2 \operatorname{det}\left(I_{p}-\mu B\right)^{-1 / 2} \tag{8}
\end{equation*}
$$

Proof. With $c_{p}(B)=(2 \pi)^{-p / 2} \operatorname{det}\left(B^{-1 / 2}\right)$

\begin{aligned}
& c_{p}(B) \int \exp \left(\gamma^{\top} \xi-\frac{1}{2 \mu}\left\|B^{-1 / 2} \gamma\right\|^{2}\right) \mathbb{I}(\|\gamma\| \leq \mathrm{g}) d \gamma \\
& \quad=c_{p}(B) \exp \left(\frac{\mu\left\|B^{1 / 2} \xi\right\|^{2}}{2}\right) \int \exp \left(-\frac{1}{2}\left\|\mu^{1 / 2} B^{1 / 2} \xi-\mu^{-1 / 2} B^{-1 / 2} \gamma\right\|^{2}\right) \mathbb{I}(\|\gamma\| \leq \mathrm{g}) d \gamma \\
& \quad=\mu^{p / 2} \exp \left(\frac{\mu\left\|B^{1 / 2} \xi\right\|^{2}}{2}\right) \mathbb{P}_{\boldsymbol{\xi}}\left(\left\|\mu^{-1 / 2} B^{1 / 2} \varepsilon+B^{1 / 2} \xi\right\| \leq \mathrm{g} / \mu\right),
\end{aligned}

where $\varepsilon$ denotes a standard normal vector in $\mathbb{R}^{p}$ and $\mathbb{P}_{\xi}$ means the conditional probability given $\xi$. Moreover, for any $u \in \mathbb{R}^{p}$ and $\mathrm{r} \geq \mathrm{p}^{1 / 2}+\|u\|$, it holds in view of $\mathbb{P}\left(\left\|B^{1 / 2} \varepsilon\right\|^{2}>\mathrm{p}\right) \leq 1 / 2$

\mathbb{P}\left(\left\|B^{1 / 2} \varepsilon-u\right\| \leq \mathrm{r}\right) \geq \mathbb{P}\left(\left\|B^{1 / 2} \varepsilon\right\| \leq \sqrt{\mathrm{p}}\right) \geq 1 / 2
$$

This implies

& \exp \left(\mu\left\|B^{1 / 2} \xi\right\|^{2} / 2\right) \mathbb{I}(\|B \xi\| \leq \mathrm{g} / \mu-\sqrt{\mathrm{p} / \mu}) \\
& \quad \leq 2 \mu^{-p / 2} c_{p}(B) \int \exp \left(\gamma^{\top} \xi-\frac{1}{2 \mu}\left\|B^{-1 / 2} \gamma\right\|^{2}\right) \mathbb{I}(\|\gamma\| \leq \mathrm{g}) d \gamma
\end{aligned}
$$

Further, by (SG)

& c_{p}(B) \mathbb{E} \int \exp \left(\gamma^{\top} \xi-\frac{1}{2 \mu}\left\|B^{-1 / 2} \gamma\right\|^{2}\right) \mathbb{I}(\|\gamma\| \leq \mathrm{g}) d \gamma \\
& \quad \leq c_{p}(B) \int \exp \left(\frac{\|\gamma\|^{2}}{2}-\frac{1}{2 \mu}\left\|B^{-1 / 2} \gamma\right\|^{2}\right) d \gamma \\
& \quad \leq \operatorname{det}\left(B^{-1 / 2}\right) \operatorname{det}\left(\mu^{-1} B^{-1}-I_{p}\right)^{-1 / 2}=\mu^{p / 2} \operatorname{det}\left(I_{p}-\mu B\right)^{-1 / 2}
\end{aligned}
$$

and (??) follows.
The next object of interest in this topic is $\mathbb{E}\|\xi\|^{r} \mathbb{I}(\|\xi\|>t)$. Rather useful form of it is

\mathbb{E}\|\xi\|^{r} \mathbb{I}(\|\xi\|>t)=\mathbb{P}(\|\xi\|>t) t^{r}+r \int_{t}^{+\infty} \mathbb{P}(\|\xi\|>t) t^{r-1} d t

With $x_{0}=(t-\sqrt{p})^{2} / 2$

$$
\int_{t}^{+\infty} \mathbb{P}(\|\xi\|>t) t^{r-1} d t=\int_{x_{0}}^{+\infty} 2 e^{-x}(\sqrt{2 x}+\sqrt{p})^{r-1} d \sqrt{2 x} \leq \frac{2 e^{-x_{0}} t^{r-1}}{1-(r-1) \log \left(x_{0}\right) / x_{0}}
$$

Consequently, if $(r-1) \log \left(x_{0}\right) / x_{0} \leq 1 / 2$, than

Analogically one is able to restrict moment with exponent part and $r \log \left(x_{0}\right) / x_{0}+\alpha \leq 1 / 2$

\mathbb{E}\|\xi\|^{r} e^{\alpha\|\xi\|} \mathbb{I}(\|\xi\|>t) \leq 4 e^{-(t-\sqrt{p})^{2} / 2+\alpha t}\left(t^{r}+r t^{r-1}\right) \tag{SGIexp}
\end{equation*}
$$

### 5.15. Gaussian quadratic forms

The next result explains the concentration effect of $\gamma^{\top} B \gamma$ for a standard Gaussian vector $\gamma$ and a symmetric matrix $B$. We use a version from Laurent and Massart (2000) with a complete proof.

Theorem 17. Let $\gamma$ be a standard normal Gaussian vector and $B$ be symmetric positively definite $p \times p$-matrix. Then with $\mathrm{p}=\operatorname{tr}(B), \mathrm{v}^{2}=\operatorname{tr}\left(B^{2}\right)$, and $\lambda=\|B\|_{\mathrm{op}}$, it holds for each $\mathrm{x} \geq 0$

$$
\begin{align*}
\mathbb{P}\left(\gamma^{\top} B \gamma>z^{2}(B, \mathrm{x})\right) \leq \mathrm{e}^{-\mathrm{x}}  \tag{9}\\
z(B, \mathrm{x}) \stackrel{\text { def }}{=} \sqrt{\mathrm{p}+2 \mathrm{vx} \mathrm{x}^{1 / 2}+2 \lambda \mathrm{x}}
\end{align*}
$$

In particular, it implies

$$
\mathbb{P}\left(\left\|B^{1 / 2} \gamma\right\|>\mathrm{p}^{1 / 2}+(2 \lambda \mathrm{x})^{1 / 2}\right) \leq \mathrm{e}^{-\mathrm{x}}
$$

Also

$$
\begin{equation*}
\mathbb{P}\left(\gamma^{\top} B \gamma<\mathrm{p}-2 \mathrm{vx}^{1 / 2}\right) \leq \mathrm{e}^{-\mathrm{x}} \tag{10}
\end{equation*}
$$

If $B$ is symmetric but non necessarily positive then

$$
\mathbb{P}\left(\left|\gamma^{\top} B \gamma-\mathrm{p}\right|>2 \mathrm{vx}^{1 / 2}+2 \lambda \mathrm{x}\right) \leq 2 \mathrm{e}^{-\mathrm{x}}
$$

Proof. Normalisation by $\lambda$ reduces the statement to the case with $\lambda=1$. Further, the standard rotating arguments allow to reduce the Gaussian quadratic form $\|\gamma\|^{2}$ to the chi-squared form:

\gamma^{\top} B \gamma=\sum_{j=1}^{p} \lambda_{j} \nu_{j}^{2}
$$

with independent standard normal r.v.'s $\nu_{j}$. Here $\lambda_{j} \in[0,1]$ are eigenvalues of $B$, and $\mathrm{p}=$ $\lambda_{1}+\ldots+\lambda_{p}, \mathrm{v}^{2}=\lambda_{1}^{2}+\ldots+\lambda_{p}^{2}$. One can easily compute the exponential moment of $\left(\gamma^{\top} B \gamma-\mathrm{p}\right) / 2$ : for each positive $\mu<1$

$$
\begin{equation*}
\log \mathbb{E} \exp \left\{\mu\left(\gamma^{\top} B \gamma-\mathrm{p}\right) / 2\right\}=\frac{1}{2} \sum_{j=1}^{p}\left\{-\mu \lambda_{j}-\log \left(1-\mu \lambda_{j}\right)\right\} . \tag{11}
\end{equation*}
$$

Lemma 19. Let $\mu \lambda_{j}<1$ and $\lambda_{j} \leq 1$. Then

$$
\frac{1}{2} \sum_{j=1}^{p}\left\{-\mu \lambda_{j}-\log \left(1-\mu \lambda_{j}\right)\right\} \leq \frac{\mu^{2} \mathrm{v}^{2}}{4(1-\mu)}
$$

Proof. In view of $\mu \lambda_{j}<1$, it holds for every $j$

$$
\begin{aligned}
-\mu \lambda_{j}-\log \left(1-\mu \lambda_{j}\right) & =\sum_{k=2}^{\infty} \frac{\left(\mu \lambda_{j}\right)^{k}}{k} \\
& \leq \frac{\left(\mu \lambda_{j}\right)^{2}}{2} \sum_{k=0}^{\infty}\left(\mu \lambda_{j}\right)^{k} \leq \frac{\left(\mu \lambda_{j}\right)^{2}}{2\left(1-\mu \lambda_{j}\right)} \leq \frac{\left(\mu \lambda_{j}\right)^{2}}{2(1-\mu)}
\end{aligned}
$$

and thus

$$
\frac{1}{2} \sum_{j=1}^{p}\left\{-\mu \lambda_{j}-\log \left(1-\mu \lambda_{j}\right)\right\} \leq \sum_{j=1}^{p} \frac{\left(\mu \lambda_{j}\right)^{2}}{4(1-\mu)} \leq \frac{\mu^{2} \mathrm{v}^{2}}{4(1-\mu)}
$$

The next technical lemma is helpful.
Lemma 20. For each $v>0$ and $\mathrm{x}>0$, it holds

$$
\inf _{\mu>0}\left\{-\mu\left(\mathrm{vx}^{1 / 2}+\mathrm{x}\right)+\frac{\mu^{2} \mathrm{v}^{2}}{4(1-\mu)}\right\} \leq-\mathrm{x}
$$

Proof. Let pick up

$$
\mu=1-\frac{1}{2 \mathrm{x}^{1 / 2} / \mathrm{v}+1}=\frac{\mathrm{x}^{1 / 2}}{\mathrm{x}^{1 / 2}+\mathrm{v} / 2}
$$

so that $\mu /(1-\mu)=2 x^{1 / 2} / v$. Then

$$
\begin{aligned}
& -\mu\left(\mathrm{vx}^{1 / 2}+\mathrm{x}\right)+\frac{\mu^{2} \mathrm{v}^{2}}{4(1-\mu)} \\
& \quad=-\mu\left(\mathrm{vx}^{1 / 2}+\mathrm{x}+\mathrm{v}^{2} / 4\right)+\frac{\mu \mathrm{v}^{2}}{4(1-\mu)} \\
& \quad=-\frac{\mathrm{x}^{1 / 2}}{\mathrm{x}^{1 / 2}+\mathrm{v} / 2}\left(\mathrm{x}^{1 / 2}+\mathrm{v} / 2\right)^{2}+\frac{2 \mathrm{x}^{1 / 2} \mathrm{v}}{4}=-\mathrm{x}
\end{aligned}
$$

and the result follows.
Now we apply the Markov inequality

$$
\begin{aligned}
\log & \mathbb{P}\left(\gamma^{\top} B \gamma>\mathrm{p}+2 \mathrm{vx}^{1 / 2}+2 \mathrm{x}\right)=\log \mathbb{P}\left(\left(\gamma^{\top} B \gamma-\mathrm{p}\right) / 2>\mathrm{vx}^{1 / 2}+\mathrm{x}\right) \\
& \leq \inf _{\mu>0}\left\{-\mu\left(\mathrm{vx}^{1 / 2}+\mathrm{x}\right)+\log \mathbb{E} \exp \left\{\mu\left(\gamma^{\top} B \gamma-\mathrm{p}\right) / 2\right\}\right\} \\
& \leq \inf _{\mu>0}\left\{-\mu\left(\mathrm{vx}^{1 / 2}+\mathrm{x}\right)+\frac{\mu^{2} \mathrm{v}^{2}}{4(1-\mu)}\right\} \leq-\mathrm{x}
\end{aligned}
$$

and the first assertion (??) follows. The second statement follows from the first one by $\operatorname{tr}\left(B^{2}\right) \leq$ $\|B\|_{\mathrm{op}} \operatorname{tr}(B)=\lambda \mathrm{p}$.

Similarly for any $\mu>0$

$$
\mathbb{P}\left(\gamma^{\top} B \gamma-\mathrm{p}<-2 \mathrm{v} \sqrt{\mathrm{x}}\right) \leq \exp (-\mu \mathrm{v} \sqrt{\mathrm{x}}) \mathbb{E} \exp \left(-\frac{\mu}{2}\left(\gamma^{\top} B \gamma-\mathrm{p}\right)\right)
$$

By (??)

$$
\log \mathbb{E} \exp \left\{-\mu\left(\gamma^{\top} B \gamma-\mathrm{p}\right) / 2\right\}=\frac{1}{2} \sum_{j=1}^{p}\left\{\mu \lambda_{j}-\log \left(1+\mu \lambda_{j}\right)\right\} .
$$

and

$$
\frac{1}{2} \sum_{j=1}^{p}\left\{\mu \lambda_{j}-\log \left(1+\mu \lambda_{j}\right)\right\}=\frac{1}{2} \sum_{j=1}^{p} \sum_{k=2}^{\infty} \frac{\left(-\mu \lambda_{j}\right)^{k}}{k} \leq \sum_{j=1}^{p} \frac{\left(\mu \lambda_{j}\right)^{2}}{4}=\frac{\mu^{2} \mathrm{v}^{2}}{4}
$$

Here the choice $\mu=2 \sqrt{\mathrm{x}} / \mathrm{v}$ yields (??).
One can put together the arguments used for obtaining the lower and the upper bound for getting a bound for a general quadratic form $\gamma^{\top} B \gamma$, where $B$ is symmetric but not necessarily positive.

### 5.16. Sandwich lemma

Lemma 21. Let differentiable measure $\mathbb{P}^{b}$ depends on r.v. from a continuous measure $\mathbb{P}, z=$ $\left(z_{1}, \ldots, z_{K}\right)$ is a multivariate quantile. Assume following error in total variation distance between measures

$$
\left|\mathbb{P}\left(z_{1}, \ldots, z_{K}\right)-\mathbb{P}^{b}\left(z_{1}, \ldots, z_{K}\right)\right|<\delta
$$

Then each quantile $z_{k}^{b}(\alpha), 1 \leq k \leq K$ from measure $\mathbb{P}^{b}$ may be bounded by quantile from measure $\mathbb{P}$ :

$$
z_{k}(\alpha+\delta) \leq z_{k}^{b}(\alpha) \leq z_{k}(\alpha-\delta)
$$

where

$$
\mathbb{P}\left(z_{k}(\alpha)\right)=1-\alpha, \quad \mathbb{P}^{b}\left(z_{k}^{b}(\alpha)\right)=1-\alpha .
$$

And if $q^{b}$ is the multiplicity correction parameter such that

$$
\mathbb{P}^{b}\left(z_{1}\left(q^{b} \alpha\right), \ldots, z_{K}\left(q^{b} \alpha\right)\right)=1-\alpha
$$

then

$$
\left|\mathbb{P}\left(z^{b}\left(q^{b} \alpha\right)\right)-(1-\alpha)\right| \leq(2 K+1) \delta .
$$

Proof. Define two sets

$$
\begin{aligned}
& \mathbb{Z}_{+}(\delta)=\{z: \mathbb{P}(z) \leq 1-\alpha+\delta\} \\
& \mathbb{Z}_{-}(\delta)=\{z: \mathbb{P}(z) \geq 1-\alpha-\delta\}
\end{aligned}
$$

For all points $z$ from $\mathbb{Z}_{+} \cap \mathbb{Z}_{-}$it holds that $|\mathbb{P}(z)-(1-\alpha)| \leq \delta$. If $\mathbb{P}^{b}\left(z^{b}\right)=1$ then $z^{b} \in \mathbb{Z}_{+}$since for all fixed $z \in \mathbb{R}^{K} \backslash \mathbb{Z}_{+}: \mathbb{P}^{b}(z)>\mathbb{P}(z)-\delta \geq 1-\alpha$. Analogically $z^{b} \in \mathbb{Z}_{-}$and $z^{b} \in \mathbb{Z}_{+} \cap \mathbb{Z}_{-}$.

In case $K=1$ one can choose non-random quantiles in the border of $\mathbb{Z}_{+} \cap \mathbb{Z}_{-}$which will bound $z^{b}$. So each component of $z^{b}$ could be bounded in the same way:

$$
z_{k}(\alpha+\delta) \leq z^{b}(\alpha) \leq z_{k}(\alpha-\delta)
$$

In case $K>1$ the these bounds become random because of multiplicity correction which involves random multiplier $q^{b}$. We have to bound $z_{k}\left(q^{b} \alpha+\delta\right)$ by a non-random quantile in order to use it as an argument for measure $\mathbb{P}$.

$$
\begin{aligned}
z(\alpha+\delta) \leq z^{b}(\alpha) & \leq z(\alpha-\delta) \\
z^{b}\left(q^{b} \alpha\right) & \leq z\left(q^{b} \alpha-\delta\right) \leq z^{b}\left(q^{b} \alpha-2 \delta\right) \\
1-\alpha & \leq \mathbb{P}^{b}\left(z\left(q^{b} \alpha-\delta\right)\right) \leq \mathbb{P}^{b}\left(z^{b}\left(q^{b} \alpha-2 \delta\right)\right)
\end{aligned}
$$

Lemma 22. For differentiable measure $\mathbb{P}(\xi<x)$ and event $A$ :

$$
\begin{gathered}
\frac{\mathbb{P}(\xi<x, A)_{x}^{\prime}}{\mathbb{P}(\xi<x)_{x}^{\prime}} \leq 1 . \\
\mathbb{P}^{b}\left(z^{b}\left(q^{b} \alpha-2 \delta\right)\right)=\mathbb{P}^{b}\left(z^{b}\left(q^{b} \alpha\right)\right)+\sum_{i}\left(\mathbb{P}^{b}\right)_{z_{k}^{b}}^{\prime}\left(z_{k}^{b}\right)^{\prime} 2 \delta, \\
\left(\mathbb{P}^{b}\right)_{z_{k}}^{\prime}\left(z_{k}^{b}\right)^{\prime}=\frac{\left(\mathbb{P}^{b}\left(z_{1}^{b}, \ldots, z_{k}^{b}, \ldots, z_{K}^{b}\right)\right)_{z_{k}^{b}}^{\prime}}{\left(\mathbb{P}^{b}\left(z_{k}^{b}\right)\right)_{z_{k}^{b}}^{\prime}} 1, \\
\mathbb{P}^{b}\left(z^{b}\left(q^{b} \alpha-2 \delta\right)\right) \leq 1-\alpha+2 K \delta . \\
1-\alpha \leq \mathbb{P}^{b}\left(z\left(q^{b} \alpha-\delta\right)\right) \leq 1-\alpha+2 K \delta, \\
1-\alpha-2 K \delta \leq \mathbb{P}^{b}\left(z\left(q^{b} \alpha+\delta\right)\right) \leq 1-\alpha .
\end{gathered}
$$

According to the arguments from the beginning of the proof $z\left(q^{b} \alpha-\delta\right)$ and $z\left(q^{b} \alpha-\delta\right)$ belongs to $\mathbb{Z}_{+}(2 K \delta+\delta) \cap \mathbb{Z}_{-}(2 K \delta+\delta)$. Due to one dimensional parametrization if $z\left(q^{b} \alpha-\delta\right)$ there exist two fixed points on the border of $\mathbb{Z}_{+}(2 K \delta+\delta) \cap \mathbb{Z}_{-}(2 K \delta+\delta)$ such that

$$
z_{+}=\max z\left(q^{b} \alpha-\delta\right), \quad z_{-}=\min z\left(q^{b} \alpha+\delta\right) .
$$

Finally,

$$
z_{-} \leq z\left(q^{b} \alpha+\delta\right) \leq z^{b}\left(q^{b} \alpha\right) \leq z\left(q^{b} \alpha-\delta\right) \leq z_{+},
$$

and subsequently

$$
1-\alpha-(2 K+1) \delta \geq \mathbb{P}\left(z_{-}\right) \leq \mathbb{P}\left(z^{b}\left(q^{b} \alpha\right)\right) \leq \mathbb{P}\left(z_{+}\right) \leq 1-\alpha+(2 K+1) \delta
$$

### 5.17. TP variance

Assume here that $\sum_{t} P_{\tau}(t)=0$ and $\mathbb{E}\left\|\xi_{l r}(t)\right\|=\sqrt{p}$ then $\sum_{t} P_{\tau}(t) \mathbb{E}\left\|\xi_{l r}(t)\right\|=0$ and

$$
\begin{aligned}
& \operatorname{Var}\left(\sum_{t} P_{\tau}(t)\left\|\xi_{l r}(t)\right\|\right) \leq \sum_{t=1}^{2 h} P_{\tau}^{2}(t) \operatorname{Var}\left(\sqrt{\sum_{t=1}^{2 h}\left\|\xi_{l r}(t)\right\|^{2}}\right) . \\
& \operatorname{Var}\left(\sqrt{\sum_{t=1}^{2 h}\left\|\xi_{l r}(t)\right\|^{2}}\right)=2 h p-\left(\mathbb{E} \sqrt{\sum_{t=1}^{2 h}\left\|\xi_{l r}(t)\right\|^{2}}\right)^{2} .
\end{aligned}
$$

Since each $\left\|\xi_{l r}(t)\right\|^{2}$ is close to normal random vector norm, its lower bound may be taken from Theorem 17. So with probability $e^{-\mathrm{x}}$ for all $1 \leq t \leq 2 h$

$$
\left\|\xi_{l r}(t)\right\|^{2}>p-2 \sqrt{p}(\mathrm{x}+\log (2 h))^{1 / 2}
$$

Then with probability $e^{-x}$

$$
\operatorname{Var}\left(\sqrt{\sum_{t=1}^{2 h}\left\|\xi_{l r}(t)\right\|^{2}}\right) \leq 4 h \sqrt{p}(\mathrm{x}+\log (2 h))^{1 / 2}
$$

Consider triangle pattern example

$$
P_{\tau}(t)= \begin{cases}0, & t<\tau-h  \tag{P}\\ (t-\tau) / h+1 / 2, & \tau-h \leq t \leq \tau \\ (\tau-t) / h+1 / 2, & \tau \leq t \leq \tau+h \\ 0, & t>\tau+h\end{cases}
$$

In this case through integral sum one get

$$
\sum_{t=1}^{2 h} P_{\tau}^{2}(t) \approx \frac{1}{6} h
$$

Finally

$$
\operatorname{Var}\left(\sum_{t} P_{\tau}(t)\left\|\xi_{l r}(t)\right\|\right) \leq \frac{2}{3} h^{2} \sqrt{p}(\mathrm{x}+\log (2 h))^{1 / 2}
$$

and

$$
z_{h}(\mathrm{x}) \leq \sqrt{\frac{2}{3}} h p^{1 / 4}(\mathrm{x}+\log (2 h))^{1 / 4} e^{\mathrm{x} / 2}
$$

The abrupt type change point statistic without noise component has view

$$
\sqrt{2 T_{h}(t)}=\left(P_{\tau}(t)+1 / 2\right) \Delta \pm 7 \diamond, \quad \tau-h \leq t \leq \tau+h
$$

The sufficient condition for change point detection of size $\Delta$ in position $\tau$ is

$$
\sum_{t=\tau-h}^{\tau+h} P_{\tau}(t) \sqrt{2 T_{h}(t)}>z_{h}(\mathrm{x})
$$

Equivalently

$$
\frac{1}{6} \Delta h+\frac{7}{2} h \diamond>\sqrt{\frac{2}{3}} h p^{1 / 4}(\mathrm{x}+\log (2 h))^{1 / 4} e^{\mathrm{x} / 2}
$$
