# Iterated and Mixed Weak Norms with Applications to Geometric Inequalities*

#### Abstract

In this paper, we consider a new weak norm, iterated weak norm in Lebesgue spaces with mixed norms. We study properties of the mixed weak norm and the iterated weak norm and present the relationship between the two weak norms. Even for the ordinary Lebesgue spaces, the two weak norms are not equivalent and any one of them can not control the other one. We give some convergence and completeness results for the two weak norms respectively. We study the convergence in truncated norm, which is a substitution of the convergence in measure for mixed Lebesgue spaces. And we give a characterization of the convergence in truncated norm. We show that Hölder's inequality is not always true on mixed weak spaces and we give a complete characterization of indices which admit Hölder's inequality. As applications, we establish some geometric inequalities related to fractional integrals in mixed weak spaces and in iterated weak spaces respectively, which essentially generalize the Hardy-Littlewood-Sobolev inequality.


Key words. Lebesgue spaces, mixed norms, weak norms, Hardy-Littlewood-Sobolev inequality

## 1 Introduction

For $\vec{p}=\left(p_{1}, \ldots, p_{r}\right)$ and a measurable function $f$ defined on $\mathbb{R}^{n_{1}} \times \ldots \times \mathbb{R}^{n_{r}}$, where $p_{i}$ are positive numbers and $n_{i}$ are positive integers, $1 \leq i \leq r$, we define the $L^{\vec{p}}$ norm of $f$ by

$$
\|f\|_{L^{\vec{p}}}:=\| \| f\left\|_{L_{x_{1}}^{p_{1}}} \cdots\right\|_{L_{x_{r}}^{p_{r}}} .
$$

The Lebesgue space $L^{\vec{p}}\left(\mathbb{R}^{n_{1}} \times \ldots \times \mathbb{R}^{n_{r}}\right)$ with mixed norms consists of all measurable functions $f$ for which $\|f\|_{L^{\vec{p}}}<\infty$. For $\vec{p}=\left(p_{1}, p_{2}\right)$, we also write $L^{\vec{p}}$ as $L^{p_{2}}\left(L^{p_{1}}\right)$.

Lebesgue spaces with mixed norms were first studied by Benedek and Panzone in [5], where many fundamental properties were proved. In particular, they showed that such spaces possess similar properties as usual Lebesgue spaces. See also related works

[^0]by Benedek, Calderón and Panzone [4], Rubio de Francia, Ruiz and Torrea [23], and Fernandez [15].

Recently, many works have been done for Lebesgue spaces with mixed norms. For example, Kurtz [20] proved that some classical operators, which include the strong maximal function, the double Hilbert transform and singular integral operators, are bounded on weighted Lebesgue spaces with mixed norms. Torres and Ward [26] gave Calderón's reproducing formula and wavelet characterization of such spaces. In recent works by Cleanthous, Georgiadis, and Nielsen [11] and Huang, Liu, Yang and Yuan [19] anisotropic mixed-norm Hardy spaces were also studied. In this paper, we focus on weak norms.

Recall that the Hardy-Littlewood-Sobolev inequality says that for any $f \in L^{p_{1}}\left(\mathbb{R}^{n}\right)$ and $g \in L^{p_{2}}\left(\mathbb{R}^{n}\right)$, where $1<p_{1}, p_{2}<\infty$ with $1 / p_{1}+1 / p_{2}>1$, we have

$$
\begin{equation*}
\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \frac{f(x) g(y)}{|x-y|^{n\left(2-1 / p_{1}-1 / p_{2}\right)}} d x d y \leq C_{\vec{p}, n}\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}} . \tag{1.1}
\end{equation*}
$$

See the works by Beckner [1, 2, 3], Burchard [6], Carlen and Loss [7], Lieb [21], Wu, Shi and Yan [28] and see also Lieb's [22] and Stein's [24] books for the Hardy-Littlewoood-Sobolev inequality and the sharp versions. The multilinear analogues of the Hardy-LittlewoodSobolev inequality were studied by Beckner [1], Gressman [18], and Valdimarsson [27]. Besides, we refer to Christ 9, 10, Dury [12, 13, 14, and Gressman [17, Tao and Wright [25] for some related works regarding the $k$-plane transform and the restriction of the Fourier transform.

Observe that $\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}}=\|f \otimes g\|_{L^{\vec{p}}}$, where $f \otimes g(x, y):=f(x) g(y)$ and $\vec{p}=\left(p_{1}, p_{2}\right)$. Define

$$
L_{\gamma} f(x, y)=\frac{f(x, y)}{|x-y|^{\gamma}}, \gamma>0
$$

For $\gamma=n\left(2-1 / p_{1}-1 / p_{2}\right)$, (1.1) says that

$$
\left\|L_{\gamma} f \otimes g\right\|_{L^{\overrightarrow{1}}} \lesssim\|f \otimes g\|_{L^{\vec{p}}}, \quad f \in L^{p_{1}}\left(\mathbb{R}^{n}\right), g \in L^{p_{2}}\left(\mathbb{R}^{n}\right) .
$$

It is natural to ask if the above inequality is still true whenever $f \otimes g$ is replaced by a general function in $L^{\vec{p}}\left(\mathbb{R}^{n} \times \mathbb{R}^{n}\right)$ ? More precisely, do we have

$$
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}} \lesssim\|f\|_{L^{\vec{p}}}, \quad \forall f \in L^{\vec{p}}\left(\mathbb{R}^{n} \times \mathbb{R}^{n}\right)
$$

for appropriate $\vec{p}, \vec{q}$ and $\gamma$ ?
The answer is false in general. Fortunately, the above inequality is true if the $L^{\vec{p}}$ and $L^{\vec{q}}$ norms are replaced with some other mixed norms, respectively. For example, for appropriate indices, we have

$$
\left\|L_{\gamma} f\right\|_{L^{p_{2}}\left(L^{r, \infty}\right)} \leq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)},
$$

where $\|f\|_{L^{p_{2}}\left(L^{\left.p_{1}, \infty\right)}\right.}:=\| \| f(x, y)\left\|_{L_{x}^{p_{1}, \infty}}\right\|_{L_{y}^{p_{2}}}$. For a complete characterization of $L_{\gamma}$ with respect to various choices of indices and mixed norms, we refer to Theorem 3.7,

Next we consider another variant of (1.1).
By replacing $g$ with $g(-\cdot)$ and a change of variable, we get

$$
\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \frac{f(x) g(y)}{|x+y|^{n\left(2-1 / p_{1}-1 / p_{2}\right)}} d x d y \leq C_{\vec{p}, n}\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}} .
$$

Observe that

$$
\frac{1}{(|x+y|+|x-y|)^{\gamma}} \leq \frac{1}{|x+y|^{\gamma}}+\frac{1}{|x-y|^{\gamma}} .
$$

This prompts us to consider the following operator

$$
T_{\gamma} f(x, y)=\frac{f(x, y)}{(|x+y|+|x-y|)^{\gamma}}, \quad \gamma>0 .
$$

We see from (1.1) that for $\gamma=n\left(2-1 / p_{1}-1 / p_{2}\right)$,

$$
\left\|T_{\gamma} f \otimes g\right\|_{L^{\overrightarrow{1}}} \lesssim\|f \otimes g\|_{L^{\vec{p}}} .
$$

We ask if the following inequality

$$
\left\|T_{\gamma} f\right\|_{L^{\vec{q}}} \lesssim\|f\|_{L^{\vec{p}}}, \quad \forall f \in L^{\vec{p}}
$$

is true for some $\vec{p}$ and $\vec{q}$ ?
The answer is again negative. In fact, since $(|x+y|+|x-y|)^{-\gamma} \notin L^{\vec{r}}$ for any $\vec{r}$ with $0<r_{1}, r_{2} \leq \infty$, the above inequality is false. Moreover, the following inequality

$$
\begin{equation*}
\left\|T_{\gamma} f\right\|_{L^{\vec{q}}, \infty} \leq C_{\vec{p}, \vec{q}, n, \gamma}\|f\|_{L^{\vec{p}, \infty}} \tag{1.2}
\end{equation*}
$$

or

$$
\begin{equation*}
\left\|T_{\gamma} f\right\|_{L \vec{q}, \infty} \leq C_{\vec{p}, \vec{q}, n, \gamma}\|f\|_{L_{\vec{p}}} \tag{1.3}
\end{equation*}
$$

is also false in general, where

$$
\|f\|_{L^{\vec{p}, \infty}}:=\sup _{\lambda>0} \lambda\left\|\chi_{\{|f|>\lambda\}}\right\|_{L^{\vec{p}}}
$$

is the mixed weak $L^{\vec{p}}$ norm of $f$.
When the mixed weak norm is replaced by the iterated weak norm defined by

$$
\|f\|_{L^{\left(p_{2}, \infty\right)}\left(L^{\left(p_{1}, \infty\right)}\right)}:=\| \| f(x, y)\left\|_{L_{x}^{p_{1}, \infty}}\right\|_{L_{y}^{p_{2}, \infty}},
$$

we get a positive conclusion. Specifically, for all $0<q_{1} \leq p_{1} \leq \infty$ and $0<q_{2} \leq p_{2} \leq \infty$ satisfying the homogeneity condition

$$
\frac{1}{q_{1}}+\frac{1}{q_{2}}=\frac{1}{p_{1}}+\frac{1}{p_{2}}+\frac{\gamma}{n},
$$

we have

$$
\begin{equation*}
\left\|T_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} . \tag{1.4}
\end{equation*}
$$

We show in Corollary 3.3 that for $\vec{p}=(\infty, \infty)$, (1.4) implies the following geometric inequality studied in [8],

$$
\begin{equation*}
\|f\|_{q_{1}}\|g\|_{q_{2}} \lesssim \sup |f(x) g(y)| \cdot|x-y|^{n / q_{1}+n / q_{2}} . \tag{1.5}
\end{equation*}
$$

When $f=g=\chi_{E}, E \subset \mathbb{R}^{n}$, (1.5) becomes

$$
|E|^{1 / n} \lesssim \sup _{x, y \in E}|x-y|,
$$

which is a well known geometric extremal problem named isodiametric inequality: amongst all sets with given diameter the ball has the maximal volume.

We show in Section 3 that the inverse version of (1.4) implies the forward and inverse Hardy-Littlewood-Sobolev inequalities. Therefore, it is a generalization of the Hardy-Littlewood-Sobolev inequalities. Moreover, our approach gives a new method to prove the boundedness of the fractional integral

$$
I_{\alpha} f(x):=\int_{\mathbb{R}^{n}} \frac{f(y)}{|x-y|^{n-\alpha}} d y
$$

from $L^{p_{1}}$ to $L^{q_{1}}$, where $1 / q_{1}=1 / p_{1}-\alpha / n$.
Since (1.4) is true and (1.2) is false in general, it is interesting to investigate these two weak norms. We show in Section 2 that the two weak norms are not equivalent even if $p_{1}=p_{2}$. Moreover, one of them can not control the other one.

The paper is organized as follows. In Section 2 we study various aspects of the two weak norms. In particular, we give the relationship between the two weak norms. We give some convergence and completeness results for both weak norms respectively. We study the convergence in truncated norm, which is a substitution of the convergence in measure for mixed Lebesgue spaces. We give a characterization of the convergence in truncated norm. We prove that Hölder's inequality holds for iterated weak spaces but it might be false in mixed weak spaces. We give a complete characterization of indices for which Hölder's inequality is true in mixed weak spaces. Besides, we give some interpolation properties in their respective spaces. In Section 3 we establish some geometric inequalities.

Throughout the paper, $A \lesssim B$ means that $A \leq C B$, and the letter $C$ stands for positive constants that are not necessarily the same at each occurrence but that are independent of the essential variables. $A \gtrsim B$ and $A \approx B$ are defined similarly.

## 2 Weak Norms

In this section, we study various aspects of weak norms, which include the relationship between the two weak norms, Hölder's inequality, the interpolation formula, and the convergence of sequences of functions in weak norms.

### 2.1 Comparison between two weak norms

For simplicity, we consider only the case of $\vec{p}=\left(p_{1}, p_{2}\right)$. In this case, the iterated weak norm on $\mathbb{R}^{n} \times \mathbb{R}^{m}$ is

$$
\begin{aligned}
\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} & =\| \| f\left\|_{L_{x}^{p_{1}, \infty}}\right\|_{L_{y}^{p_{2}, \infty}} \\
& =\sup _{\gamma>0} \gamma\left|\left\{y: \sup _{\lambda>0} \lambda|\{x:|f(x, y)|>\lambda\}|^{1 / p_{1}}>\gamma\right\}\right|^{1 / p_{2}} \\
& =\sup _{\gamma>0} \gamma\left|\left\{y: \sup _{\lambda>0} \lambda\left|E_{y, \lambda}\right|^{1 / p_{1}}>\gamma\right\}\right|^{1 / p_{2}},
\end{aligned}
$$

where

$$
\begin{equation*}
E_{y, \lambda}:=\{x:|f(x, y)|>\lambda\} . \tag{2.1}
\end{equation*}
$$

And the mixed weak norm is

$$
\|f\|_{L^{\vec{p}, \infty}}=\sup _{\lambda>0} \lambda\left\|\chi_{\{|f|>\lambda\}}\right\|_{L^{\vec{p}}}=\sup _{\lambda>0} \lambda\left(\int\left|E_{y, \lambda}\right|^{p_{2} / p_{1}} \mathrm{~d} y\right)^{1 / p_{2}} .
$$

It is well known that for $q>0$,

$$
\begin{equation*}
\|f\|_{L^{q, \infty}} \leq\|f\|_{L^{q}} \tag{2.2}
\end{equation*}
$$

Hence

$$
\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} \leq\|f\|_{L_{\vec{p}}}
$$

Next we compare the two weak norms. The following lemma could be known. Since we do not find a proof, we include a proof here.

Lemma 2.1 Suppose that $0<q<\infty$ and $f \in L^{q}\left(\mathbb{R}^{n}\right)$. Then the equality in (2.2) holds if and only if $|f|=C \chi_{E}$ for some constant $C$ and $E \subset \mathbb{R}^{n}$.

Proof. Assume that $|f|$ is not of the form $C \chi_{E}$. Then there exist positive numbers $a<b$ such that $|\{0<|f|<a\}|>0$ and $|\{|f|>b\}|>0$.

For $0<\lambda<a$, we have

$$
\begin{aligned}
\lambda^{q}|\{|f|>\lambda\}| & =\int_{\{|f|>\lambda\}} \lambda^{q} \\
& \leq \int_{\{\lambda<|f|<b\}}|f|^{q}+\int_{\{|f| \geq b\}}\left(|f|^{q}-b^{q}+a^{q}\right) \\
& \leq\|f\|_{q}^{q}-\left(b^{q}-a^{q}\right)|\{|f| \geq b\}| .
\end{aligned}
$$

And for $\lambda \geq a$, we have

$$
\lambda^{q}|\{|f|>\lambda\}|=\int_{\{|f|>\lambda\}} \lambda^{q} \leq\|f\|_{q}^{q}-\left\|f \cdot \chi_{\{0<|f|<a\}}\right\|_{q}^{q} .
$$

Hence

$$
\|f\|_{L^{q, \infty}}=\sup _{\lambda>0} \lambda|\{|f|>\lambda\}|^{1 / q}<\|f\|_{L^{q}} .
$$

This completes the proof.
Next we illustrate that iterated weak norms are order dependent. Moreover, the mixed weak norm and the iterated weak norm are not equivalent and any one of them can not control the other one. Specifically, we have the following.

Theorem 2.2 Suppose that $0<p_{1}, p_{2}<\infty$ and $m$ and $n$ are positive integers. We have
(i). $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right) \not \subset L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right)$ and $L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right) \not \subset L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)\left(\mathbb{R}^{n} \times\right.$ $\left.\mathbb{R}^{m}\right)$.
(ii). $L_{x}^{p_{1}, \infty}\left(L_{y}^{p_{2}, \infty}\right) \not \subset L_{y}^{p_{2}, \infty}\left(L_{x}^{p_{1}, \infty}\right)$ and $L_{y}^{p_{2}, \infty}\left(L_{x}^{p_{1}, \infty}\right) \not \subset L_{x}^{p_{1}, \infty}\left(L_{y}^{p_{2}, \infty}\right)$.
(iii). $L^{\vec{p}} \subsetneq L^{\vec{p}, \infty} \bigcap L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$.

Proof. (i). First, we consider the function $F(x, y)=1 /\left(|x|^{n / p_{1}}|y|^{m / p_{2}}\right)$. It is easy to see that

$$
\|\left. F\right|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=v_{n}^{1 / p_{1}} v_{m}^{1 / p_{2}},
$$

where $v_{n}$ and $v_{m}$ are the volumes of unit balls in $\mathbb{R}^{n}$ and $\mathbb{R}^{m}$, respectively.
On the other hand, for any $\lambda>0$,

$$
\left\|\chi_{\{F>\lambda\}}\right\|_{L^{\vec{p}}}=\left(\int_{|y|>0} \frac{v_{n}^{p_{2} / p_{1}}}{\lambda^{p_{2}}|y|^{m}} d y\right)^{1 / p_{2}}=\infty .
$$

Hence $\|F\|_{L^{\vec{p}, \infty}}=\infty$. This proves $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right) \not \subset L^{\vec{p}, \infty}$.
Next we consider the function $G(x, y)=a^{|y|^{m}} \chi_{\left[0, a^{\left.-p_{1}|y|^{m / n}\right]}\right.}(|x|)$, where $a>1$ is a constant. For any $\lambda>0$, we have

$$
|\{x: G(x, y)>\lambda\}|= \begin{cases}v_{n} a^{-p_{1}|y|^{m}}, & \lambda<a^{|y|^{m}}, \\ 0, & \text { others } .\end{cases}
$$

Hence

$$
\|G(\cdot, y)\|_{L^{p_{1}, \infty}}=v_{n}^{1 / p_{1}}, \quad|y|>0 .
$$

Therefore,

$$
\|G\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=\infty .
$$

On the other hand,

$$
\begin{aligned}
\left(\int_{\mathbb{R}^{m}}|\{x: G(x, y)>\lambda\}|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} & =\left(\int_{a^{|y| m}>\lambda} v_{n}^{p_{2} / p_{1}} a^{-p_{2}|y|^{m}} d y\right)^{1 / p_{2}} \\
& =\frac{v_{n}^{1 / p_{1}} v_{m}^{1 / p_{2}}}{\left(p_{2} \ln a\right)^{1 / p_{2} \lambda}} .
\end{aligned}
$$

Hence

$$
\|G\|_{L^{\vec{p}, \infty}}=\frac{v_{n}^{1 / p_{1}} v_{m}^{1 / p_{2}}}{\left(p_{2} \ln a\right)^{1 / p_{2}}} .
$$

Therefore, $G \in L^{\vec{p}, \infty} \backslash L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$.
(ii). Consider the previous function $G(x, y)$ defined in (i). Fix some $\lambda>0$ and $x \in \mathbb{R}^{n}$ with $|x|<1$. We have

$$
\{y: G(x, y)>\lambda\}=\left\{y: \frac{\ln \lambda}{\ln a}<|y|^{m} \leq \frac{-n \ln |x|}{p_{1} \ln a}\right\} .
$$

Hence

$$
|\{y: G(x, y)>\lambda\}|= \begin{cases}v_{m}\left(\frac{-n \ln |x|}{p_{1} \ln a}-\frac{\ln \lambda}{\ln a}\right), & \lambda<\frac{1}{|x|^{n / p_{1}}}, \\ 0, & \text { others } .\end{cases}
$$

Therefore,

$$
\sup _{\lambda>0} \lambda|\{y: G(x, y)>\lambda\}|^{1 / p_{2}}= \begin{cases}\left(\frac{v_{m}}{p_{2} e \ln a}\right)^{1 / p_{2}} \frac{1}{|x|^{n / p_{1}}}, & |x|<1, \\ 0, & \text { others. }\end{cases}
$$

Consequently,

$$
\|G\|_{L_{x}^{p_{1}, \infty}\left(L_{y}^{p_{2}, \infty}\right)}=\frac{v_{m}^{1 / p_{2}} v_{n}^{1 / p_{1}}}{\left(p_{2} e \ln a\right)^{1 / p_{2}}}<\infty .
$$

In other words, $G \in L_{x}^{p_{1}, \infty}\left(L_{y}^{p_{2}, \infty}\right) \backslash L_{y}^{p_{2}, \infty}\left(L_{x}^{p_{1}, \infty}\right)$. Replacing $G(x, y)$ with $G(y, x)$ we get $L_{y}^{p_{2}, \infty}\left(L_{x}^{p_{1}, \infty}\right) \backslash L_{x}^{p_{1}, \infty}\left(L_{y}^{p_{2}, \infty}\right) \neq \emptyset$.
(iii). It is obvious that the left-hand side of (iii) is a subset of the right-hand side. So we only need to show that it is a proper subset.

Take some $w \in L^{p_{2}}\left(\mathbb{R}^{m}\right) \backslash\{0\}$. Let $F(x, y)=w(y) /|x|^{n / p_{1}}$. Then we have $F \notin L^{\vec{p}}$.
For any $\lambda>0$, we have

$$
|\{x:|F(x, y)|>\lambda\}|=v_{n} \frac{|w(y)|^{p_{1}}}{\lambda^{p_{1}}} .
$$

Hence

$$
\left(\int_{\mathbb{R}^{m}}|\{x:|F(x, y)|>\lambda\}|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}}=\frac{v_{n}^{1 / p_{1}}\|w\|_{p_{2}}}{\lambda}
$$

Therefore, $\|F\|_{L^{\vec{p}, \infty}} \leq v_{n}^{1 / p_{1}}\|w\|_{p_{2}}$. On the other hand, it is easy to see that $\|F\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=$ $\left\|1 /|x|^{n / p_{1}}\right\|_{L^{p_{1}, \infty}}\|w\|_{L^{p_{2}, \infty}} \leq v_{n}^{1 / p_{1}}\|w\|_{p_{2}}$.

It is easy to see that $f \otimes g \in L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right) \backslash\{0\}$ if and only if $f \in L^{p_{1}, \infty} \backslash\{0\}$ and $g \in L^{p_{2}, \infty} \backslash\{0\}$. Next we consider the conditions for $f \otimes g \in L^{\vec{p}, \infty}$.

Theorem 2.3 Suppose that $0<p_{1}, p_{2}<\infty$ and $m$ and $n$ are positive integers. We have
(i). If $f \in L^{p_{1}, \infty}\left(\mathbb{R}^{n}\right)$ and $g \in L^{p_{2}}\left(\mathbb{R}^{m}\right)$, then $f \otimes g \in L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right)$.
(ii). If $f \in L^{p_{1}}, g \in L^{p_{2}, \infty}$ and $p_{1} \leq p_{2}$, then $f \otimes g \in L^{\vec{p}, \infty}$.
(iii). If $f \otimes g \in L^{\vec{p}, \infty}$ and $f, g \neq 0$, then $f \in L^{p_{1}, \infty}$ and $g \in L^{p_{2}, \infty}$. But $g$ need not to be in $g \in L^{p_{2}}$.

Proof. First, we show that $\|F\|_{L^{\vec{p}, \infty}}=\left\||F|^{p_{1}}\right\|_{L^{\left.1, p_{2} / p_{1}\right), \infty}}^{1 / p_{1}}$ for any measurable function $F$ defined on $\mathbb{R}^{n} \times \mathbb{R}^{m}$ and $\|g\|_{L^{p_{2}, \infty}}=\left\||g|^{p_{1}}\right\|_{L^{p_{2} / p_{1}, \infty}}^{1 / p_{1}}$ for any measurable function $g$ defined on $\mathbb{R}^{m}$.

In fact, a simple computation shows that

$$
\begin{align*}
\|F\|_{L^{p, \infty}}^{p_{1}} & =\sup _{\lambda>0} \lambda^{p_{1}}\left(\int_{\mathbb{R}^{m}}|\{x:|F(x, y)|>\lambda\}|^{p_{2} / p_{1}} d y\right)^{p_{1} / p_{2}} \\
& =\sup _{\lambda>0} \lambda^{p_{1}}\left(\int_{\mathbb{R}^{m}}\left|\left\{x:|F(x, y)|^{p_{1}}>\lambda^{p_{1}}\right\}\right|^{p_{2} / p_{1}} d y\right)^{p_{1} / p_{2}} \\
& =\left\||F|^{p_{1}}\right\|_{L^{\left(1, p_{2} / p_{1}\right), \infty}} . \tag{2.3}
\end{align*}
$$

Similarly we can prove that $\|g\|_{L^{p_{2}, \infty}}=\left\||g|^{p_{1}}\right\|_{L^{p_{2} / p_{1}, \infty}}^{1 / p_{1}}$.
(i). For any $\lambda>0$,

$$
|\{x: f(x) g(y)>\lambda\}|^{1 / p_{1}} \leq \frac{\|f\|_{L^{p_{1}, \infty}}|g(y)|}{\lambda} .
$$

Hence

$$
\left(\int_{\mathbb{R}^{m}}|\{x: f(x) g(y)>\lambda\}|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \leq \frac{\|f\|_{L^{p_{1}, \infty}}\|g\|_{L^{p_{2}}}}{\lambda} .
$$

Consequently,

$$
\|f \otimes g\|_{L^{\vec{p}, \infty}} \leq\|f\|_{L^{p_{1}, \infty},}\|g\|_{L^{p_{2}}}
$$

(ii). By (2.3), it suffices to consider the case of $p_{1}=1 \leq p_{2}$. For any $\lambda>0$, since

$$
\{(x, y):|f(x) g(y)|>\lambda\} \subset \bigcup_{k \in \mathbb{Z}}\left\{(x, y): 2^{k} \leq|f(x)|<2^{k+1},|g(y)|>2^{-k-1} \lambda\right\}
$$

we have

$$
\begin{aligned}
& \lambda\left\|\chi_{\{(x, y):|f(x) g(y)|>\lambda\}}\right\|_{L^{\left(1, p_{2}\right)}} \\
& \quad \leq \lambda \sum_{k \in \mathbb{Z}}\left\|\chi_{\left\{x: 2^{k} \leq|f(x)|<2^{k+1}\right\}}(x) \chi_{\left\{y:|g(y)|>2^{-k-1} \lambda\right\}}(y)\right\|_{L^{\left(1, p_{2}\right)}} \\
& \quad=\sum_{k \in \mathbb{Z}} 2^{k}\left|\left\{x: 2^{k} \leq|f(x)|<2^{k+1}\right\}\right| \cdot 2^{-k} \lambda\left|\left\{y:|g(y)|>2^{-k-1} \lambda\right\}\right|^{1 / p_{2}} \\
& \quad \leq 2\|f\|_{1}\|g\|_{L^{p_{2}, \infty}} .
\end{aligned}
$$

(iii). Now we suppose that $f \otimes g \in L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right)$. For any $\alpha, \beta>0$, we have

$$
\{x:|f(x)|>\alpha\} \times\{y:|g(y)|>\beta\} \subset\{(x, y):|f(x) g(y)|>\alpha \beta\} .
$$

Hence

$$
\alpha|\{x:|f(x)|>\alpha\}|^{1 / p_{1}} \cdot \beta|\{y:|g(y)|>\beta\}|^{1 / p_{2}} \leq \alpha \beta\left\|\chi_{\{(x, y):|f(x) g(y)|>\alpha \beta\}}\right\|_{L^{\vec{p}}} .
$$

Taking supremums on both sides, we get

$$
\|f\|_{L^{p_{1}, \infty},}\|g\|_{L^{p_{2}, \infty}} \leq\|f \otimes g\|_{L^{\vec{p}, \infty}}
$$

Hence $f \in L^{p_{1}, \infty}$ and $g \in L^{p_{2}, \infty}$.
Finally, we show that for $f \otimes g \in L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{m}\right), g$ need not to be in $L^{p_{2}}$. Set $f(x)=1 /|x|^{2 n / p_{1}} \chi_{(1, \infty)}(|x|)$ and $g(y)=1 /|y|^{m / p_{2}}$ for $y \neq 0$.

Fix some $\lambda>0$. We have

$$
\begin{aligned}
|\{x:|f(x) g(y)|>\lambda\}| & =\left|\left\{x:|x|>1,|x|^{2 n / p_{1}}<\frac{1}{\lambda|y|^{m / p_{2}}}\right\}\right| \\
& = \begin{cases}v_{n}\left(\left(\frac{1}{\lambda|y|^{m / p_{2}}}\right)^{p_{1} / 2}-1\right), & |y|<\frac{1}{\lambda^{p_{2} / m}} \\
0, & \text { others. }\end{cases}
\end{aligned}
$$

Hence

$$
\begin{aligned}
\|f \otimes g\|_{L^{p, \infty}}^{p_{2}} & =\sup _{\lambda>0} \lambda^{p_{2}} \int_{\mathbb{R}^{m}}|\{x:|f(x) g(y)|>\lambda\}|^{p_{2} / p_{1}} d y \\
& =\sup _{\lambda>0} \lambda^{p_{2}} v_{n}^{p_{2} / p_{1}} \int_{|y|<\frac{1}{\lambda^{p_{2} / m}}}\left(\left(\frac{1}{\lambda|y|^{m / p_{2}}}\right)^{p_{1} / 2}-1\right)^{p_{2} / p_{1}} d y \\
& \leq \sup _{\lambda>0} 2 \lambda^{p_{2}} v_{n}^{p_{2} / p_{1}} \int_{|y|<\frac{1}{\lambda^{p_{2} / m}}}\left(\frac{1}{\lambda^{p_{2} / 2}|y|^{m / 2}}-1\right) d y \\
& =2 v_{n}^{p_{2} / p_{1}} v_{m}<\infty
\end{aligned}
$$

where we use the fact that $(u-1)^{\alpha} \leq 2 u^{\alpha}-1$ for any $u>1$ and $\alpha>0$. This completes the proof.

Given $\vec{p}=\left(p_{1}, p_{2}\right)$, we compare the three mixed norms $L^{p_{2}, \infty}\left(L^{p_{1}}\right), L^{p_{2}}\left(L^{p_{1}, \infty}\right)$, and $L^{\vec{p}, \infty}$.

Theorem 2.4 Suppose that $\vec{p}=\left(p_{1}, p_{2}\right)$. We have
(i). For any measurable function $f$ defined on $\mathbb{R}^{n} \times \mathbb{R}^{m}$, we have

$$
\|f\|_{L^{\vec{p}, \infty}} \leq\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)} .
$$

(ii). $L^{p_{2}, \infty}\left(L^{p_{1}}\right) \not \subset L^{\vec{p}, \infty}$ and $L^{\vec{p}, \infty} \not \subset L^{p_{2}, \infty}\left(L^{p_{1}}\right)$.

Proof. (i). Let $E_{y, \lambda}$ be defined by (2.1). Then we have

$$
\|f\|_{L^{\vec{p}, \infty}}=\sup _{\lambda>0}\left\|\left|E_{y, \lambda}\right|^{1 / p_{1}}\right\|_{L_{y}^{p_{2}}} \leq\left\|\sup _{\lambda>0}\left|E_{y, \lambda}\right|^{1 / p_{1}}\right\|_{L_{y}^{p_{2}}}=\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)} .
$$

(ii). Take some $f \in L^{p_{1}, \infty} \backslash L^{p_{1}}$ and $g \in L^{p_{2}} \backslash\{0\}$. We see from Theorem [2.3(i) that $f \otimes g \in L^{\vec{p}, \infty} \backslash L^{p_{2}, \infty}\left(L^{p_{1}}\right)$.

On the other hand, set $F=\chi_{E}$, where $E=\left\{(x, y):|x|^{n} \leq|y|^{-m p_{1} / p_{2}}\right\}$. We have

$$
\|F\|_{L^{p_{2}, \infty}\left(L^{p_{1}}\right)} \approx\left\|\frac{1}{|y|^{m / p_{2}}}\right\|_{L^{p_{2}, \infty}}<\infty
$$

and

$$
\|F\|_{L^{\vec{p}, \infty}}=\left\|\chi_{E}\right\|_{L^{\vec{p}}} \approx\left\|\frac{1}{|y|^{m / p_{2}}}\right\|_{L^{p_{2}}}=\infty .
$$

Hence $F \in L^{p_{2}, \infty}\left(L^{p_{1}}\right) \backslash L^{\vec{p}, \infty}$.

### 2.2 Convergence in weak norms

In this subsection, we prove the completeness of both weak spaces.
First, we show that the Lebesgue monotone convergence theorem and Fatou's Lemma are true for weak norms. However, Lebesgue's dominated convergence theorem fails for weak norms.

Theorem 2.5 Let $W$ be either $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq$ $\infty$. Suppose that $\left\{f_{k}: k \geq 1\right\}$ is a sequence of non-negative measurable functions such that $f_{k}(x, y) \leq f_{k+1}(x, y)$, a.e., $k \geq 1$. Then we have

$$
\left\|\lim _{k \rightarrow \infty} f_{k}\right\|_{W}=\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{W} .
$$

Proof. It suffices to prove the convergence in $L^{\vec{p}, \infty}$, since it implies the convergence in iterated weak spaces.

Denote $f(x, y)=\lim _{k \rightarrow \infty} f_{k}(x, y)$. We consider only the case of $p_{1}, p_{2}<\infty$. Other cases can be proved similarly.

First, we assume that $\|f\|_{L^{\vec{p}, \infty}}<\infty$. For any $\varepsilon>0$, there exists some $\lambda_{0}>0$ such that

$$
\lambda_{0}\left\|\chi_{\left\{|f|>\lambda_{0}\right\}}\right\|_{L^{\vec{p}}} \geq(1-\varepsilon)\|f\|_{L^{\vec{p}}, \infty} .
$$

Since $\left\{f_{k}: k \geq 1\right\}$ is increasing, we have

$$
\lim _{k \rightarrow \infty} \lambda_{0}\left\|\chi_{\left\{\left|f_{k}\right|>\lambda_{0}\right\}}\right\|_{L^{\vec{p}}}=\lambda_{0}\left\|\chi_{\left\{|f|>\lambda_{0}\right\}}\right\|_{L^{\vec{p}}} \geq(1-\varepsilon)\|f\|_{L^{\vec{p}}, \infty} .
$$

Hence for $k$ sufficiently large, we have

$$
\lambda_{0}\left\|\chi_{\left\{\left|f_{k}\right|>\lambda_{0}\right\}}\right\|_{L^{\vec{p}}} \geq(1-\varepsilon)^{2}\|f\|_{L^{\vec{p}}, \infty} .
$$

Therefore,

$$
\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}}, \infty} \geq(1-\varepsilon)^{2}\|f\|_{L^{\vec{p}}, \infty}
$$

By letting $\varepsilon \rightarrow 0$, we get

$$
\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}} \geq\|f\|_{L^{\vec{p}}, \infty}
$$

On the other hand, since $\left|f_{k}\right| \leq|f|$ almost everywhere, the reverse inequality is obvious. Hence $\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}}=\|f\|_{L^{\vec{p}}, \infty}$. The case $\|f\|_{L^{\vec{p}}, \infty}=\infty$ can be proved similarly.

With the above theorem, we can prove Fatou's lemma for weak norms, which improves [16, Exercise 1.1.12 (d)] slightly (we remove an extra constant).

Theorem 2.6 Let $W$ be either $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq$ $\infty$. Let $\left\{f_{k}: k \geq 1\right\}$ be a sequence of non-negative measurable functions. Then we have

$$
\left\|\liminf _{k \rightarrow \infty} f_{k}\right\|_{W} \leq \liminf _{k \rightarrow \infty}\left\|f_{k}\right\|_{W} .
$$

Proof. Let $g_{k}=\inf _{l \geq k} f_{l}$. Then $\left\{g_{k}: k \geq 1\right\}$ is increasingly convergent to $\lim \inf _{k \rightarrow \infty} f_{k}$. It follows from the monotone convergence theorem that

$$
\left\|\liminf _{k \rightarrow \infty} f_{k}\right\|_{W}=\left\|\lim _{k \rightarrow \infty} g_{k}\right\|_{W}=\liminf _{k \rightarrow \infty}\left\|g_{k}\right\|_{W} \leq \liminf _{k \rightarrow \infty}\left\|f_{k}\right\|_{W}
$$

However, the dominated convergence theorem fails in weak norm spaces. For example, set $f_{0}(x)=1 /|x|^{n / p_{1}}$ and $f_{k}(x)=f_{0}(x) \chi_{[k, \infty]}(|x|)$. Take some $g \in L^{p_{2}} \backslash\{0\}$. We have $\lim _{k \rightarrow \infty} f_{k} \otimes g(x, y)=0$. Moreover, we see from Theorem 2.3 that $f_{k} \otimes g \leq f_{0} \otimes g \in$ $L^{\vec{p}, \infty} \cap L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$. But

$$
\left\|f_{k} \otimes g\right\|_{L^{\vec{p}, \infty}}=\left\|f_{k} \otimes g\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=v_{n}^{1 / p_{1}}\|g\|_{L^{p_{2}}}, k \geq 1 .
$$

### 2.2.1 Convergence in measure and almost everywhere

It is known that if $\left\{f_{k}: k \geq 1\right\}$ is convergent in $L^{p}$ or $L^{p, \infty}$, then it is convergent in measure. However, it is not true for mixed norm. Specifically, neither the strong convergence nor the weak convergence in mixed norm spaces implies the convergence in measure.

For example, set $f_{k}=\chi_{E_{k}}$, where

$$
E_{k}= \begin{cases}\left\{(x, y):|x|^{n}<1 /|y|^{m}, 0<|y|<1 / k\right\}, & p_{1}>p_{2} \\ \left\{(x, y):|x|^{n}<1 /|y|^{m},|y|>k\right\}, & p_{1}<p_{2}\end{cases}
$$

Then we have $\left\|f_{k}\right\|_{L^{\vec{p}}} \rightarrow 0$. Therefore,

$$
\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}}=\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=0 .
$$

However, for any $0<\varepsilon<1,\left|\left\{(x, y):\left|f_{k}(x, y)\right|>\varepsilon\right\}\right|=\infty$.
Nevertheless, it was shown in [5, Theorem 1] that if $\left\{f_{k}: k \geq 1\right\}$ is convergent to $f$ in $L^{\vec{p}}$, then it contains a subsequence convergent almost everywhere to $f$. We show that the same is true for weak norms.

Theorem 2.7 Let $\left\{f_{k}: k \geq 1\right\}$ be a sequence of measurable functions which is convergent to some $f$ in $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq \infty$. Then it contains a subsequence convergent almost everywhere to $f$.

Proof. (i). First we assume that $\lim _{k \rightarrow \infty}\left\|f_{k}-f\right\|_{L^{\vec{p}, \infty}}=0$. For any $\lambda>0$, we have

$$
\lim _{k \rightarrow \infty}\left\|\chi_{\left\{\left|f_{k}-f\right|>\lambda\right\}}\right\|_{L^{\vec{p}}}=0
$$

where $\{|f|>\lambda\}$ stands for $\{(x, y):|f(x, y)|>\lambda\}$. By [5. Theorem 1], there is some subsequence of $\left\{f_{k}: k \geq 1\right\}$, denoted by $\left\{f_{1, k}: k \geq 1\right\}$, such that

$$
\lim _{k \rightarrow \infty} \chi_{\left\{\left|f_{1, k}-f\right|>\lambda\right\}}(x, y)=0, \quad(x, y) \in \mathbb{R}^{n} \times \mathbb{R}^{m} \backslash E_{\lambda},
$$

where $\left|E_{\lambda}\right|=0$. Consequently,

$$
\limsup _{k \rightarrow \infty}\left|f_{1, k}(x, y)-f(x, y)\right| \leq \lambda, \quad(x, y) \in \mathbb{R}^{n} \times \mathbb{R}^{m} \backslash E_{\lambda} .
$$

By setting $\lambda=1,1 / 2, \ldots, 1 / 2^{l}, \ldots$, we get a sequence of zero measured sets $\left\{E_{l}: l \geq 1\right\}$ and subsequences $\left\{f_{l, k}: k \geq 1\right\}$ of $\left\{f_{k}: k \geq 1\right\}$, such that $\left\{f_{l, k}: k \geq 1\right\}$ is a subsequence of $\left\{f_{l-1, k}: k \geq 1\right\}$ for $l \geq 2$ and for each $l \geq 1$,

$$
\limsup _{k \rightarrow \infty}\left|f_{l, k}(x, y)-f(x, y)\right| \leq \frac{1}{2^{l}}, \quad(x, y) \in \mathbb{R}^{n} \times \mathbb{R}^{m} \backslash E_{l} .
$$

Set $E=\cup_{l \geq 1} E_{l}$. Then for $(x, y) \notin E$, we have

$$
\limsup _{k \rightarrow \infty}\left|f_{k, k}(x, y)-f(x, y)\right| \leq \frac{1}{2^{l}}, \quad \forall l \geq 1 .
$$

Hence

$$
\lim _{k \rightarrow \infty}\left|f_{k, k}(x, y)-f(x, y)\right|=0, \quad(x, y) \in \mathbb{R}^{n} \times \mathbb{R}^{m} \backslash E
$$

This proves the conclusion for the mixed weak norm.
(ii). Next we assume that $\lim _{k \rightarrow \infty}\left\|f_{k}-f\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=0$. We consider only the case of $0<p_{1}, p_{2}<\infty$. Other cases can be proved similarly.

For any $\alpha, \beta>0$, we have

$$
\begin{aligned}
\mid\{y: \mid & \left.\left|\left\{x:\left|f_{k}(x, y)-f(x, y)\right|>\alpha\right\}\right|^{p_{2} / p_{1}}>\beta\right\} \mid \\
& \leq\left|\left\{y:\left\|f_{k}(x, y)-f(x, y)\right\|_{L^{p_{1}, \infty}}>\alpha \beta^{1 / p_{2}}\right\}\right| \\
& \leq \frac{1}{\alpha^{p_{2}}}\left\|f_{k}-f\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}^{p_{2}} \\
& \rightarrow 0, \quad \text { as } k \rightarrow \infty .
\end{aligned}
$$

Hence there is a subsequence $\left\{f_{k_{l}}: l \geq 1\right\}$ such that

$$
\left|\left\{y:\left|\left\{x:\left|f_{k_{l}}(x, y)-f(x, y)\right|>\frac{1}{2^{l}}\right\}\right|^{p_{2} / p_{1}}>\frac{1}{2^{l p_{2} / p_{1}}}\right\}\right|<\frac{1}{2^{l}}, \quad l \geq 1 .
$$

Let $E=\cap_{i \geq 1} E_{i}$ and $F=\cap_{i \geq 1} F_{i}$, where

$$
\begin{aligned}
& E_{i}=\bigcup_{l=i}^{\infty}\left\{y:\left|\left\{x:\left|f_{k_{l}}(x, y)-f(x, y)\right|>\frac{1}{2^{l}}\right\}\right|^{p_{2} / p_{1}}>\frac{1}{2^{l p_{2} / p_{1}}}\right\}, \\
& F_{i}=\bigcup_{l=i}^{\infty}\left\{(x, y):\left|f_{k_{l}}(x, y)-f(x, y)\right|>\frac{1}{2^{l}}\right\} .
\end{aligned}
$$

Then we have $\left|E_{i}\right| \leq 1 / 2^{i-1}$ and therefore $|E|=0$.
Take some $y \notin E$. Then there is some $i \geq 1$ such that $y \notin E_{i}$. Consequently, for $l \geq i$,

$$
\left|\left\{x:\left|f_{k_{l}}(x, y)-f(x, y)\right|>\frac{1}{2^{l}}\right\}\right| \leq \frac{1}{2^{l}} .
$$

Hence $\left|\left\{x:(x, y) \in F_{j}\right\}\right| \leq 1 / 2^{j-1}$ for $j \geq i$. Therefore,

$$
|\{x:(x, y) \in F\}|=0
$$

It follows that

$$
|F|=\iint_{\mathbb{R}^{n} \times \mathbb{R}^{m}} \chi_{F}(x, y) d x d y=\int_{\mathbb{R}^{m} \backslash E} d y \int_{\mathbb{R}^{n}} \chi_{F}(x, y) d x=0 .
$$

For $(x, y) \notin\left(\mathbb{R}^{n} \times E\right) \cup F$, there is some $i \geq 1$ such that $(x, y) \notin F_{i}$. Hence

$$
\left|f_{k_{l}}(x, y)-f(x, y)\right| \leq \frac{1}{2^{l}}, \quad l \geq i
$$

That is, $\left\{f_{k_{l}}: l \geq 1\right\}$ converges to $f$ almost everywhere.

### 2.2.2 Completeness of weak norm spaces

It is known that both $L^{p}$ and weak $L^{p}$ are complete [16]. We show that the same is true for weak norms in mixed spaces.

Theorem 2.8 Let $W$ be either $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq$ $\infty$. Let $\left\{f_{k}: k \geq 1\right\}$ be a Cauchy sequence in $W$, that is,

$$
\lim _{k, l \rightarrow \infty}\left\|f_{k}-f_{l}\right\|_{W}=0
$$

Then there is some $f \in W$ such that $\lim _{k \rightarrow \infty}\left\|f-f_{k}\right\|_{W}=0$.
Before giving a proof of the above theorem, we introduce a preliminary result.
Lemma 2.9 Let $a_{i}, \tilde{a}_{i}, b_{i}$ and $c_{i}$ be positive numbers, $1 \leq i \leq k \leq \infty$, such that $\sum_{i=1}^{k} a_{i}=$ $\sum_{i=1}^{k} \tilde{a}_{i}=1, b_{1}=\ldots=b_{k}=1$ for $1 \leq p_{1} \leq \infty$ and $\sum_{i=1}^{k} b_{i}^{p_{1} /\left(1-p_{1}\right)} \leq 1$ for $0<p_{1}<1$, and $c_{1}=\ldots=c_{k}=1$ for $1 \leq p_{2} \leq \infty$ and $\sum_{i=1}^{k} c_{i}^{p_{2} /\left(1-p_{2}\right)} \leq 1$ for $0<p_{2}<1$. Then we have

$$
\begin{aligned}
\left\|f_{1}+\ldots+f_{k}\right\|_{L^{\vec{p}, \infty}} & \leq \sum_{i=1}^{k} \frac{1}{a_{i} b_{i} c_{i}}\left\|f_{i}\right\|_{L^{\vec{p}, \infty}} \\
\left\|f_{1}+\ldots+f_{k}\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} & \leq \sum_{i=1}^{k} \frac{1}{a_{i} \tilde{a}_{i} b_{i} c_{i}}\left\|f_{i}\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}
\end{aligned}
$$

Proof. We prove only the first inequality. The second one can be proved similarly. For any $\lambda>0$, we have

$$
\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\} \subset\left\{\left|f_{1}\right|>a_{1} \lambda\right\} \cup \ldots \cup\left\{\left|f_{k}\right|>a_{k} \lambda\right\}
$$

Hence

$$
\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}} \leq \sum_{i=1}^{k} \chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}
$$

If $p_{1} \geq 1$, then

$$
\left\|\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}}\right\|_{L_{x}^{p_{1}}} \leq \sum_{i=1}^{k}\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L_{x}^{p_{1}}}
$$

If $0<p_{1}<1$, then

$$
\left\|\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}}\right\|_{L_{x}^{p_{1}}}^{p_{1}} \leq \sum_{i=1}^{k}\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L_{x}^{p_{1}}}^{p_{1}}
$$

Set $q_{1}=1 / p_{1}$. We see from Hölder's inequality that

$$
\begin{aligned}
\left\|\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}}\right\|_{L_{x}^{p_{1}}} & \leq\left(\sum_{i=1}^{k}\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L_{x}^{p_{1}}}^{p_{1}}\right)^{q_{1}} \\
& \leq\left(\sum_{i=1}^{k} \frac{1}{b_{i}}\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L_{x}^{p_{1}}}\right)\left(\sum_{i=1}^{k} b_{i}^{q_{1}^{\prime} / q_{1}}\right)^{q_{1} / q_{1}^{\prime}}
\end{aligned}
$$

$$
\begin{equation*}
\leq \sum_{i=1}^{k} \frac{1}{b_{i}}\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L_{x}^{p_{1}}} \tag{2.4}
\end{equation*}
$$

With similar arguments we get

$$
\left\|\left\|\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}}\right\|_{L_{x}^{p_{1}}}\right\|_{L_{y}^{p_{2}}} \leq \sum_{i=1}^{k} \frac{1}{b_{i} c_{i}}\| \| \chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\left\|_{L_{x}^{p_{1}}}\right\|_{L_{y}^{p_{2}}} .
$$

Hence

$$
\lambda\left\|\chi_{\left\{\left|f_{1}+\ldots+f_{k}\right|>\lambda\right\}}\right\|_{L^{\vec{p}}} \leq \sum_{i=1}^{k} \frac{1}{b_{i} c_{i}} \lambda\left\|\chi_{\left\{\left|f_{i}\right|>a_{i} \lambda\right\}}\right\|_{L^{\vec{p}}} .
$$

Taking supremums on both sides, we get the conclusion as desired.
Proof of Theorem [2.8, We prove the conclusion only for $W=L^{\vec{p}, \infty}$. The other case can be proved similarly.

For $k \geq 1$, let

$$
b_{k}=\left\{\begin{array}{ll}
1, & p_{1} \geq 1, \\
\frac{b_{0}}{2^{k}}, & 0<p_{1}<1,
\end{array} \quad c_{k}= \begin{cases}1, & p_{2} \geq 1, \\
\frac{c_{0}}{2^{k}}, & 0<p_{2}<1,\end{cases}\right.
$$

where $b_{0}$ and $c_{0}$ are constants such that $\sum_{k=1}^{\infty} b_{k}^{p_{1} /\left(1-p_{1}\right)}=\sum_{k=1}^{\infty} c_{k}^{p_{2} /\left(1-p_{2}\right)}=1$ for $0<$ $p_{1}, p_{2}<1$.

We see from the hypothesis that there is a subsequence of $\left\{f_{k}: k \geq 1\right\}$, say $\left\{f_{k_{l}}: l \geq\right.$ $1\}$, such that

$$
\left\|f_{k_{l+1}}-f_{k_{l}}\right\|_{L^{\vec{p}, \infty}} \leq \frac{b_{l} c_{l}}{2^{2 l}} .
$$

Let

$$
g_{i}=\sum_{l=i}^{\infty}\left|f_{k_{l+1}-f_{k_{l}}}\right| .
$$

We see from Lemma 2.9 that

$$
\left\|g_{i}\right\|_{L^{\vec{p}, \infty}} \leq \sum_{l=i}^{\infty} \frac{2^{l}}{b_{l} c_{l}}\left\|f_{k_{l+1}-f_{k_{l}}}\right\|_{L^{\vec{p}, \infty}} \leq \frac{1}{2^{i-1}} \rightarrow 0 .
$$

By Theorem[2.7, $\left\{g_{i}: i \geq 1\right\}$ contains a subsequence convergent almost everywhere. Since $\left\{g_{i}: i \geq 1\right\}$ is decreasing, it is convergent to zero almost everywhere.

Suppose that for some $(x, y), g_{i}(x, y)$ tends to zero as $i$ tends to the infinity. Since

$$
\left|f_{k_{m}}(x, y)-f_{k_{l}}(x, y)\right| \leq g_{i}(x, y), \quad m>l \geq i
$$

$\left\{f_{k_{l}}(x, y): l \geq 1\right\}$ is a Cauchy sequence in $\mathbb{R}$ for almost all $(x, y) \in \mathbb{R}^{2 n}$. Denote $f(x, y)=$ $\lim _{l \rightarrow \infty} f_{k_{l}}(x, y)$. Then $f$ is well defined almost everywhere.

For any $i \geq 1$, we have

$$
\left\|f_{k_{i}}-f\right\|_{L^{\vec{p}, \infty}} \leq\left\|g_{i}\right\|_{L^{\vec{p}, \infty}} \leq \frac{1}{2^{i-1}} .
$$

Hence $\lim _{i \rightarrow \infty}\left\|f_{k_{i}}-f\right\|_{L^{\vec{p}, \infty}}=0$. Since $\left\{f_{k}: k \geq 1\right\}$ is a Cauchy sequence in $L^{\vec{p}, \infty}$, it is easy to see that $\lim _{k \rightarrow \infty}\left\|f_{k}-f\right\|_{L^{\vec{p}}, \infty}=0$. This completes the proof.

It is known that if a sequence of measurable functions $\left\{f_{n}: n \geq 1\right\}$ is convergent in $L^{\vec{p}}$, then we have $\lim _{n \rightarrow \infty}\left\|f_{n}\right\|_{L^{\vec{p}}}=\|f\|_{L^{\vec{p}}}$. We show that the same is true for weak norms.

Theorem 2.10 Let $W$ be either $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<$ $p_{1}, p_{2} \leq \infty$. Suppose that $\lim _{k \rightarrow \infty}\left\|f_{k}-f\right\|_{W}=0$. Then we have $\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{W}=\|f\|_{W}$.

Proof. We prove the conclusion only for $W=L^{\vec{p}, \infty}$. The other case can be proved similarly.

For $1 \leq p_{1} \leq \infty$, set $b_{1}=b_{2}=1$. And for $0<p_{1}<1$, set $0<b_{1}<1$ and $b_{2}=\left(1-b_{1}^{p_{1} /\left(1-p_{1}\right)}\right)^{\left(1-p_{1}\right) / p_{1}}$. Define $c_{1}$ and $c_{2}$ similarly (replacing $\left(p_{1}, b_{1}, b_{2}\right)$ by $\left.\left(p_{2}, c_{1}, c_{2}\right)\right)$.

For any $0<a<1$, we see from Lemma 2.9 that

$$
\left\|f_{k}\right\|_{L^{\vec{p}, \infty}}=\left\|f_{k}-f+f\right\|_{L^{\vec{p}}, \infty} \leq \frac{1}{(1-a) b_{2} c_{2}}\left\|f_{k}-f\right\|_{L^{\vec{p}, \infty}}+\frac{1}{a b_{1} c_{1}}\|f\|_{L^{\vec{p}}, \infty} .
$$

Hence

$$
\limsup _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}} \leq \frac{1}{a b_{1} c_{1}}\|f\|_{L^{\vec{p}, \infty}} .
$$

Letting $a, b_{1}, c_{1} \rightarrow 1$, we get

$$
\limsup _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}} \leq\|f\|_{L^{\vec{p}}, \infty}
$$

On the other hand, since

$$
\|f\|_{L^{\vec{p}, \infty}}=\left\|f-f_{k}+f_{k}\right\|_{L^{\vec{p}, \infty}} \leq \frac{1}{(1-a) b_{2} c_{2}}\left\|f-f_{k}\right\|_{L^{\vec{p}, \infty}}+\frac{1}{a b_{1} c_{1}}\left\|f_{k}\right\|_{L^{\vec{p}, \infty}},
$$

by letting $k \rightarrow \infty$ and $a, b_{1}, c_{1} \rightarrow 1$ successively, we get

$$
\|f\|_{L^{\vec{p}, \infty}} \leq \liminf _{k \rightarrow \infty}\left\|f_{k}\right\|_{L^{\vec{p}, \infty},} .
$$

Now the conclusion follows.
In [5], the Riesz theorem for mixed norm Lebesgue spaces was proved. It says that if $\lim _{k \rightarrow \infty}\left\|f_{k}\right\|_{L \vec{p}}=\|f\|_{L \vec{p}}$ and $\lim _{k \rightarrow \infty} f_{k}(x, y)=f(x, y)$ almost everywhere on $\mathbb{R}^{2 n}$, where $\vec{p}=\left(p_{1}, p_{2}\right)$ with $1 \leq p_{1}, p_{2}<\infty$, then we have

$$
\lim _{k \rightarrow \infty}\left\|f_{k}-f\right\|_{L^{\vec{p}}}=0
$$

Whenever weak norms are considered, the above conclusion fails. For example, set $f_{0}(x)=1 /|x|^{n / p_{1}}$ and $f_{k}(x)=f_{0}(x) \chi_{[0, k]}(|x|)$. Take some $g \in L^{p_{2}} \backslash\{0\}$. We have

$$
\lim _{k \rightarrow \infty} f_{k} \otimes g(x, y)=f_{0}(x) g(y)
$$

and

$$
\lim _{k \rightarrow \infty}\left\|f_{k} \otimes g\right\|_{L^{\vec{p}, \infty}}=\lim _{k \rightarrow \infty}\left\|f_{k} \otimes g\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=v_{n}^{1 / p_{1}}\|g\|_{L^{p_{2}}} .
$$

However, for any $k \geq 1$,

$$
\left\|f_{k} \otimes g-f_{0} \otimes g\right\|_{L^{\vec{p}, \infty}}=\left\|f_{k} \otimes g-f_{0} \otimes g\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=v_{n}^{1 / p_{1}}\|g\|_{L^{p_{2}}} .
$$

Hence $\left\{f_{k} \otimes g: k \geq 1\right\}$ is not convergent to $f_{0} \otimes g$ in $L^{\vec{p}, \infty}$ or $L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)$.

### 2.3 Convergence in truncated norm

We see from the previous subsection that while a sequence convergent in mixed norm contains a subsequence convergent almost everywhere, it might not contain a subsequence convergent in measure. This prompts us to consider the following substitution of convergence in measure.

Definition 2.11 Suppose that $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq \infty$. We say that a sequence of measurable functions $\left\{f_{k}: k \geq 1\right\}$ is convergent to some $f$ in truncated $L^{\vec{p}}$ norm if for any $\lambda>0$,

$$
\lim _{k \rightarrow \infty}\left\|\chi_{\left\{\left|f_{k}-f\right|>\lambda\right\}}\right\|_{L^{\vec{p}}}=0 .
$$

We see from the definition that convergence in truncated $L^{\vec{p}}$ norm is the same as convergence in measure if $p_{1}=p_{2}$. However, they are not equivalent if $p_{1} \neq p_{2}$. For an example, see Subsubsection 2.2.1.

It is easy to see that if $\left\{f_{k}: k \geq 1\right\}$ is convergent to some $f$ in $L^{\vec{p}, \infty}$, then it is also convergent to $f$ in truncated norm. Moreover, we see from the proof of Theorem 2.7that a sequence convergent in truncated norm always contains a subsequence convergent almost everywhere.

The following is a characterization of convergence in truncated norm, which shows also the completeness of such convergence.

Theorem 2.12 Suppose that $\vec{p}=\left(p_{1}, p_{2}\right)$ with $0<p_{1}, p_{2} \leq \infty$. Let $\left\{f_{k}: k \geq 1\right\}$ be a sequence of measurable functions. Then $\left\{f_{k}: k \geq 1\right\}$ is convergent to some $f$ in truncated norm if and only if $\left\{f_{k}: k \geq 1\right\}$ is a Cauchy sequence in truncated norm, i.e.,

$$
\lim _{k, l \rightarrow \infty}\left\|\chi_{\left\{\left|f_{k}-f_{l}\right|>\lambda\right\}}\right\|_{L^{\vec{p}}}=0, \quad \forall \lambda>0 .
$$

Proof. First we prove the Necessity. Suppose that $\left\{f_{k}: k \geq 1\right\}$ is convergent to $f$ in truncated norm. For any $\lambda>0$, we have

$$
\left\{\left|f_{k}-f_{l}\right|>\lambda\right\} \subset\left\{\left|f_{k}-f\right|>\frac{\lambda}{2}\right\} \cup\left\{\left|f_{l}-f\right|>\frac{\lambda}{2}\right\} .
$$

Hence

$$
\chi_{\left\{\left|f_{k}-f_{l}\right|>\lambda\right\}} \leq \chi_{\left\{\left|f_{k}-f\right|>\lambda / 2\right\}}+\chi_{\left\{\left|f_{l}-f\right|>\lambda / 2\right\}} .
$$

Therefore,

$$
\begin{aligned}
& \lim _{k, l \rightarrow \infty}\left\|\chi_{\left\{\left|f_{k}-f_{l}\right|>\lambda\right\}}\right\|_{L^{\vec{p}}} \leq \lim _{k \rightarrow \infty} \frac{1}{b_{1} c_{1}}\left\|\chi_{\left\{\left|f_{k}-f\right|>\lambda / 2\right\}}\right\|_{L^{\vec{p}}} \\
& \quad+\lim _{l \rightarrow \infty} \frac{1}{b_{2} c_{2}}\left\|\chi_{\left\{\left|f_{l}-f\right|>\lambda / 2\right\}}\right\|_{L^{\vec{p}}} \\
&=0
\end{aligned}
$$

where $b_{1}, b_{2}, c_{1}$ and $c_{2}$ are defined as in the proof of Theorem 2.10,
Next we prove the sufficiency, for which we give only a sketch since it is similar to the proof of Theorem 2.8.

Define $\left\{b_{k}: k \geq 1\right\}$ and $\left\{c_{k}: k \geq 1\right\}$ as in the proof of Theorem 2.8. Then there is some subsequence $\left\{f_{k_{l}}: l \geq 1\right\}$ such that

$$
\left\|\chi_{\left\{\left|f_{k_{l+1}-f_{k_{l}}}\right|>1 / 2^{l}\right\}}\right\|_{L^{\vec{p}}} \leq \frac{b_{l} c_{l}}{2^{l}} .
$$

Let

$$
g_{i}=\sum_{l=i}^{\infty} \chi_{\left\{\left|f_{k_{l+1}-f_{k_{l}}}\right|>1 / 2^{l}\right\}} .
$$

Similar arguments as in the proof of Lemma 2.9 show that

$$
\left\|g_{i}\right\|_{L^{\vec{p}}} \leq \sum_{l=i}^{\infty} \frac{1}{b_{l} c_{l}}\left\|\chi_{\left\{\left|f_{k_{l+1}-f_{k_{l}}}\right|>1 / 2^{l}\right\}}\right\|_{L^{\vec{p}}} \leq \frac{1}{2^{i-1}} \rightarrow 0 .
$$

Hence $\left\{g_{i}: i \geq 1\right\}$ contains a subsequence convergent almost everywhere. Since $\left\{g_{i}: i \geq\right.$ $1\}$ is decreasing, it is convergent to zero almost everywhere.

Suppose that for some $(x, y), g_{i}(x, y)$ tends to zero as $i$ tends to the infinity. Then for $i$ sufficiently large, $g_{i}(x, y)<1 / 2$. In other words,

$$
\left|f_{k_{l+1}}(x, y)-f_{k_{l}}(x, y)\right| \leq \frac{1}{2^{l}}, \quad l \geq i
$$

Hence $\left\{f_{k_{l}}(x, y): l \geq 1\right\}$ is a Cauchy sequence in $\mathbb{R}$. Denote $f(x, y)=\lim _{l \rightarrow \infty} f_{k_{l}}(x, y)$. Then $f$ is well defined almost everywhere.

Fix some $\lambda>0$. Whenever $1 / 2^{i-1}<\lambda$, we have

$$
\left\{\left|f_{k_{i}}-f\right|>\lambda\right\} \subset \bigcup_{l=i}^{\infty}\left\{\left|f_{k_{l+1}}-f_{k_{l}}\right|>\frac{1}{2^{l}}\right\}
$$

Similarly to (2.4) we get

$$
\left\|\chi_{\left\{\left|f_{k_{i}}-f\right|>\lambda\right\}}\right\|_{L^{\vec{p}}} \leq \sum_{l=i}^{\infty} \frac{1}{b_{l} c_{l}}\left\|\chi_{\left\{\left|f_{k_{l+1}}-f_{k_{l}}\right|>1 / 2^{l}\right\}}\right\|_{L^{\vec{p}}} \leq \frac{1}{2^{i-1}} .
$$

Hence $\left\{f_{k_{l}}: l \geq 1\right\}$ is convergent to $f$ in truncated norm. Since $\left\{f_{k}: k \geq 1\right\}$ is a Cauchy sequence, it is easy to see that $\left\{f_{k}: k \geq 1\right\}$ is also convergent to $f$ in truncated norm.

### 2.4 Hölder's inequality

It is well known that Hölder's inequality holds for both $L^{p}$ and $L^{p, \infty}$. For mixed norms, it was shown in [5] that if $1 \leq p_{i} \leq \infty, i=1,2$, then we have

$$
\|f g\|_{L^{\overrightarrow{1}}} \leq\|f\|_{L^{\vec{p}}}\|g\|_{\vec{p}^{\vec{p}}}
$$

where $\vec{p}^{\prime}=\left(p_{1}^{\prime}, p_{2}^{\prime}\right)$.
Suppose that

$$
\frac{1}{r_{i}}=\frac{1}{p_{i}}+\frac{1}{q_{i}}, \quad i=1,2
$$

The previous inequality can be rewritten as

$$
\begin{equation*}
\|f g\|_{L^{\vec{r}}} \leq\|f\|_{L_{\vec{p}}}\|g\|_{\vec{q}} \tag{2.5}
\end{equation*}
$$

where $f$ and $g$ are arbitrary measurable functions.
Using Hölder's inequality for weak spaces [16, Exercise 1.1.15], we get Hölder's inequality for iterated weak norms, for which we omit the proof.

Theorem 2.13 Suppose that $0<p_{i}, q_{i}, r_{i} \leq \infty$ and that $1 / r_{i}=1 / p_{i}+1 / q_{i}, i=1,2$. Then we have

$$
\|f g\|_{L^{r_{2}, \infty}\left(L^{r_{1}, \infty}\right)} \leq C_{\vec{p}, \vec{q}}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}\|g\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)}
$$

where $C_{\vec{p}, \vec{q}}=\prod_{i=1}^{2}\left(p_{i} / r_{i}\right)^{1 / p_{i}}\left(q_{i} / r_{i}\right)^{1 / q_{i}}$ with suitable changes for $p_{i}=\infty$ or $q_{i}=\infty$.
However, for mixed weak norms, Hölder's inequality is true only for very special cases. The following is a complete characterization of indices for which Hölder's inequality is true on mixed weak spaces.

Theorem 2.14 Suppose that $1 / r_{i}=1 / p_{i}+1 / q_{i}, i=1,2$, where $0<p_{1}, p_{2}, q_{1}, q_{2} \leq \infty$. Then there exists some constant $C_{\vec{p}, \vec{q}}<\infty$ such that

$$
\|f g\|_{L^{\vec{r}}, \infty} \leq C_{\vec{p}, \vec{q}}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}, \infty},}, \quad \forall f, g,
$$

if and only if $p_{1} q_{2}=p_{2} q_{1}$.
When the condition is true, we have

$$
C_{\vec{p}, \vec{q}}= \begin{cases}\max \left\{1,2^{1 / r_{1}-1 / r_{2}}\right\} \frac{p_{2}^{1 / p_{2}} q_{2}^{1 / q_{2}}}{r_{1}^{1 / r_{2}}}, & 0<p_{1}, p_{2}, q_{1}, q_{2}<\infty, \\ \max \left\{1,2^{1 / r_{1}-1}\right\} \frac{p_{1}^{r_{1} / p_{1}} q_{1}^{r_{1} / q_{1}}}{r_{1}}, & p_{2}=q_{2}=\infty, 0<p_{1}, p_{2}<\infty, \\ \frac{p_{2}^{1 / p_{2}} q_{2}^{1 / q_{2}}}{r_{2}^{1 / r_{2}}}, & p_{1}=q_{1}=\infty, 0<p_{2}, q_{2}<\infty, \\ 1, & \vec{p}=(\infty, \infty) \text { or } \vec{q}=(\infty, \infty) .\end{cases}
$$

To prove Hölder's inequality, we need the following preliminary result, for which we omit the proof.

Lemma 2.15 (i). For any $\alpha>0$ and $a, b>0$, we have

$$
(a+b)^{\alpha} \leq \max \left\{2^{\alpha-1}, 1\right\}\left(a^{\alpha}+b^{\alpha}\right)
$$

(ii). For $0 \leq \theta \leq 1$ and $a, b \geq 0$, we have

$$
a+b \geq \frac{a^{\theta} b^{1-\theta}}{\theta^{\theta}(1-\theta)^{1-\theta}},
$$

and the equality is true if and only if $a / \theta=b /(1-\theta)$.

Proof of Theorem 2.14. We prove only the sufficiency. The necessity can be found in Example 2.16

First, we consider the case of $0<p_{1}, p_{2}, q_{1}, q_{2}<\infty$ with $p_{1} / q_{1}=p_{2} / q_{2}$. For any $\lambda, a>0$, we have

$$
\begin{equation*}
\{(x, y): f(x, y) g(x, y)>\lambda\} \subset\left\{(x, y): f(x, y)>\frac{\lambda}{a}\right\} \bigcup\{(x, y): g(x, y)>a\} \tag{2.6}
\end{equation*}
$$

Denote $E_{y, \lambda, f}=\{x: f(x, y)>\lambda\}$. We see from the above formula that $E_{y, \lambda, f g} \subset$ $E_{y, \lambda / a, f} \cup E_{y, a, g}$. Hence

$$
\begin{equation*}
\left|E_{y, \lambda, f g}\right| \leq\left|E_{y, \lambda / a, f}\right|+\left|E_{y, a, g}\right| \tag{2.7}
\end{equation*}
$$

Note that $r_{2} / r_{1}=p_{2} / p_{1}=q_{2} / q_{1}$. We see from Lemma 2.15 that there is some constant $C_{p_{2} / p_{1}}$ such that

$$
\left|E_{y, \lambda, f g}\right|^{r_{2} / r_{1}} \leq C_{p_{2} / p_{1}}\left(\left|E_{y, \lambda / a, f}\right|^{p_{2} / p_{1}}+\left|E_{y, a, g}\right|^{q_{2} / q_{1}}\right) .
$$

Hence

$$
\int_{\mathbb{R}^{m}}\left|E_{y, \lambda, f g}\right|^{r_{2} / r_{1}} d y \leq C_{p_{2} / p_{1}}\left(\int_{\mathbb{R}^{m}}\left|E_{y, \lambda / a, f}\right|^{p_{2} / p_{1}} d y+\int_{\mathbb{R}^{m}}\left|E_{y, a, g}\right|^{q_{2} / q_{1}} d y\right) .
$$

Observe that

$$
\begin{aligned}
\int_{\mathbb{R}^{m}}\left|E_{y, \lambda / a, f}\right|^{p_{2} / p_{1}} d y & =\left(\frac{a}{\lambda}\right)^{p_{2}}\left(\frac{\lambda}{a}\left(\int_{\mathbb{R}^{m}}\left|E_{y, \lambda / a, f}\right|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}}\right)^{p_{2}} \\
& \leq\left(\frac{a}{\lambda}\right)^{p_{2}}\|f\|_{L^{p}, \infty}^{p_{2}} .
\end{aligned}
$$

Similarly we get that

$$
\int_{\mathbb{R}^{m}}\left|E_{y, a, g}\right|^{q_{2} / q_{1}} d y \leq \frac{1}{a^{q_{2}}}\|g\|_{L^{q, \infty}}^{q_{2}}
$$

Hence

$$
\begin{equation*}
\int_{\mathbb{R}^{m}}\left|E_{y, \lambda, f g}\right|^{r_{2} / r_{1}} d y \leq C_{p_{2} / p_{1}}\left(\left(\frac{a}{\lambda}\right)^{p_{2}}\|f\|_{L^{\tilde{p}, \infty}}^{p_{2}}+\frac{\|g\|_{L^{\tilde{q}, \infty}}^{q_{2}}}{a^{q_{2}}}\right) . \tag{2.8}
\end{equation*}
$$

Take some $a_{0}>0$ such that

$$
\frac{\left(a_{0} / \lambda\right)^{p_{2}}\|f\|_{L^{\vec{p}, \infty}}^{p_{2}}}{r_{2} / p_{2}}=\frac{\left(1 / a_{0}\right)^{q_{2}}\|g\|_{L^{\vec{q}, \infty}}^{q_{2}}}{r_{2} / q_{2}} .
$$

We see from Lemma 2.15 (ii) that

$$
\left(\frac{a_{0}}{\lambda}\right)^{p_{2}}\|f\|_{L^{\vec{p}, \infty}}^{p_{2}}+\frac{\|g\|_{L^{q}, \infty}^{q_{2}}}{a_{0}^{q_{2}}}=\left(\frac{p_{2}}{r_{2}}\right)^{r_{2} / p_{2}}\left(\frac{q_{2}}{r_{2}}\right)^{r_{2} / q_{2}} \cdot \frac{1}{\lambda^{r_{2}}}\|f\|_{L^{\vec{p}, \infty}}^{r_{2}}\|g\|_{L^{\vec{q}, \infty}}^{r_{2}} .
$$

By (2.8), we have

$$
\lambda\left(\int_{\mathbb{R}^{m}}\left|E_{y, \lambda, f g}\right|^{r_{2} / r_{1}} d y\right)^{1 / r_{2}} \leq C_{p_{2} / p_{1}}^{1 / r_{2}}\left(\frac{p_{2}}{r_{2}}\right)^{1 / p_{2}}\left(\frac{q_{2}}{r_{2}}\right)^{1 / q_{2}}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}, \infty}}
$$

Taking the supremum over $\lambda$, we get the conclusion as desired.
Next we consider the case of $p_{2}=q_{2}=\infty$. In this case, $r_{2}=\infty$. If $p_{1}=\infty$ or $q_{1}=\infty$, the conclusion is obvious. For the case of $0<p_{1}, q_{1}<\infty$, we see from (2.7) that

\left|E_{y, \lambda, f g}\right|^{1 / r_{1}} \leq C_{1 / r_{1}}\left(\left|E_{y, \lambda / a, f}\right|^{1 / r_{1}}+\left|E_{y, a, g}\right|^{1 / r_{1}}\right)

\left.\begin{array}{rl}
\left\|\left|E_{y, \lambda, f g}\right|^{1 / r_{1}}\right\|_{L_{y}^{\infty}} & \leq C_{1 / r_{1}}\left(\left\|\left|E_{y, \lambda / a, f}\right|^{1 / r_{1}}\right\|_{L_{y}^{\infty}}+\left\|\left|E_{y, a, g}\right|^{1 / r_{1}}\right\|_{L_{y}^{\infty}}\right) \\
& =C_{1 / r_{1}}\left(\left\|\left|E_{y, \lambda / a, f}\right|^{1 / p_{1}}\right\|_{L_{y}^{\infty}}^{p_{1} / r_{1}}+\left\|\left|E_{y, a, g}\right|^{1 / q_{1}}\right\|_{L_{y}^{\infty}}^{q_{1} / r_{1}}\right.
\end{array}\right) .
$$

Since

$$
\begin{aligned}
\left\|\left|E_{y, \lambda / a, f}\right|^{1 / p_{1}}\right\|_{L_{y}^{\infty}}^{p_{1} / r_{1}} & =\left(\frac{a}{\lambda}\right)^{p_{1} / r_{1}}\left\|\frac{\lambda}{a}\left|E_{y, \lambda / a, f}\right|^{1 / p_{1}}\right\|_{L_{y}^{\infty}}^{p_{1} / r_{1}} \\
& \leq\left(\frac{a}{\lambda}\right)^{p_{1} / r_{1}}\|f\|_{L^{p, \infty}}^{p_{1} / r_{1}}
\end{aligned}
$$

and

$$
\left\|\left|E_{y, a, g}\right|^{1 / q_{1}}\right\|_{L_{y}^{\infty}}^{q_{1} / r_{1}} \leq \frac{1}{a^{q_{1} / r_{1}}}\|g\|_{L^{q, \infty}}^{q_{1} / r_{1}}
$$

with similar arguments as the previous case we get

$$
\|f g\|_{L^{\vec{r}}, \infty} \leq C_{1 / r_{1}}\left(\frac{p_{1}}{r_{1}}\right)^{r_{1} / p_{1}}\left(\frac{q_{1}}{r_{1}}\right)^{r_{1} / q_{1}}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}, \infty}}
$$

For $p_{1}=q_{1}=\infty$, we see from (2.6) that

$$
\left\|\chi_{E_{y, \lambda, f g}}\right\|_{L_{x}^{\infty}} \leq\left\|\chi_{E_{y, \lambda / a, f}}\right\|_{L_{x}^{\infty}}+\left\|\chi_{E_{y, a, g}}\right\|_{L_{x}^{\infty}}
$$

Since every term in the above inequality is either 0 or 1 , we have

$$
\left\|\chi_{E_{y, \lambda, f g}}\right\|_{L_{x}^{\infty}}^{r_{2}} \leq\left\|\chi_{E_{y, \lambda / a, f}}\right\|_{L_{x}^{\infty}}^{p_{2}}+\left\|\chi_{E_{y, a, g}}\right\|_{L_{x}^{\infty}}^{q_{2}} .
$$

Hence

$$
\begin{align*}
\int_{\mathbb{R}^{m}}\left\|\chi_{E_{y, \lambda, f} g}\right\|_{L_{x}^{\infty}}^{r_{2}} d y \leq & \int_{\mathbb{R}^{m}}\left\|\chi_{E_{y, \lambda / a, f}}\right\|_{L_{x}^{\infty}}^{p_{2}} d y+\int_{\mathbb{R}^{m}}\left\|\chi_{E_{y, a, g}}\right\|_{L_{x}^{\infty}}^{q_{2}} d y \\
= & \left(\frac{a}{\lambda}\right)^{p_{2}} \int_{\mathbb{R}^{m}}\left\|\frac{\lambda}{a} \chi_{E_{y, \lambda / a, f}}\right\|_{L_{x}^{\infty}}^{p_{2}^{\infty}} d y \\
& +\frac{1}{a^{q_{2}}} \cdot \int_{\mathbb{R}^{m}}\left\|a \chi_{E_{y, a, g}}\right\|_{L_{x}^{\infty}}^{q_{2}} d y \\
\leq & \left(\frac{a}{\lambda}\right)^{p_{2}}\|f\|_{L^{\tilde{p}, \infty}}^{p_{2}}+\frac{1}{a^{q_{2}}}\|g\|_{L^{\bar{q}, \infty}}^{q_{2}} . \tag{2.9}
\end{align*}
$$

Take some $a>0$ such that

$$
\frac{(a / \lambda)^{p_{2}}\|f\|_{L^{\vec{p}, \infty}}^{p_{2}}}{r_{2} / p_{2}}=\frac{(1 / a)^{q_{2}}\|g\|_{L^{\vec{q}, \infty}}^{q_{2}}}{r_{2} / q_{2}}
$$

We see from Lemma 2.15 (ii) and (2.9) that

$$
\int_{\mathbb{R}^{m}}\left\|\chi_{E_{y, \lambda, f g}}\right\|_{L_{x}^{\infty}}^{r_{2}} d y \leq\left(\frac{p_{2}}{r_{2}}\right)^{r_{2} / p_{2}}\left(\frac{q_{2}}{r_{2}}\right)^{r_{2} / q_{2}} \frac{1}{\lambda^{r_{2}}}\|f\|_{L^{p, p}, \infty}^{r_{2}}\|g\|_{L^{\tilde{q}, \infty}}^{r_{2}}
$$

Hence

$$
\lambda\left(\int_{\mathbb{R}^{m}}\left\|\chi_{E_{y, \lambda, f g}}\right\|_{L_{x}^{\infty}}^{r_{2}} d y\right)^{1 / r_{2}} \leq\left(\frac{p_{2}}{r_{2}}\right)^{1 / p_{2}}\left(\frac{q_{2}}{r_{2}}\right)^{1 / q_{2}}\|f\|_{L^{\vec{p}}, \infty}\|g\|_{L^{\vec{q}, \infty},} .
$$

Therefore,

$$
\|f g\|_{L^{\vec{r}, \infty}} \leq\left(\frac{p_{2}}{r_{2}}\right)^{1 / p_{2}}\left(\frac{q_{2}}{r_{2}}\right)^{1 / q_{2}}\|f\|_{L^{\vec{r}, \infty}}\|g\|_{L^{\vec{q}, \infty}}
$$

Finally, the case of $\vec{p}=(\infty, \infty)$ or $\vec{q}=(\infty, \infty)$ is obvious. This completes the proof.
The following examples show the necessity part in Theorem 2.14. In other words, whenever $p_{1} q_{2} \neq p_{2} q_{1}$, Hölder's inequality does not hold.

Example 2.16 Suppose that $1 / r_{i}=1 / p_{i}+1 / q_{i}, i=1,2$.
(i). For $0<q_{1}, q_{2} \leq \infty$ and $g(x, y)=\left(|x|^{n}+|y|^{m}\right)^{-\gamma}$ with $\gamma=1 / q_{1}+1 / q_{2}$, we have $g \in L^{\vec{q}, \infty}$.
(ii). For $q_{1}=\infty, 0<p_{2} \leq \infty$ and $0<p_{1}, q_{2}<\infty$, set $\gamma=1 / q_{2}$ and $\alpha=p_{1} / p_{2}+p_{1} / q_{2}$.

Let $f(x, y)=\left(|x|^{n}+|y|^{m}\right)^{\gamma} \chi_{E}(x, y)$ and $g(x, y)=\left(|x|^{n}+|y|^{m}\right)^{-\gamma}$, where $E=\{(x, y)$ : $\left.0<|x|^{n}<|y|^{-m \alpha}, 1 \leq|y| \leq N\right\}$. Then we have

$$
\lim _{N \rightarrow \infty} \frac{\|f g\|_{L^{\vec{r}, \infty}}}{\|f\|_{L^{\vec{r}, \infty},}\|g\|_{L^{\vec{q}, \infty}}}=\infty .
$$

(iii). For $q_{2}=\infty, 0<p_{1} \leq \infty$ and $0<p_{2}, q_{1}<\infty$, set $\gamma=n / q_{1}$. Let $f(x, y)=$ $|x|^{\gamma} \chi_{E}(x, y)$ and $g(x, y)=|x|^{-\gamma}$, where $E=\left\{(x, y):|x|^{n} \leq|y|^{-m r_{1} / r_{2}}\right\}$. Then we have

$$
\|f g\|_{L^{\vec{r}}, \infty} \mathbb{Z}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}}, \infty} .
$$

(iv). For $0<p_{1}, p_{2}, q_{1}, q_{2}<\infty$ with $p_{2} / q_{2}>p_{1} / q_{1}$, set

$$
\frac{\alpha}{m}=\frac{1}{q_{2}}-\frac{\beta}{q_{1}}, \quad \beta=\frac{1 / p_{2}+1 / q_{2}}{1 / p_{1}+1 / q_{1}},
$$

$f(x, y)=|y|^{\alpha} \chi_{E}(x, y)$ and $g(x, y)=|y|^{-\alpha} \chi_{E}(x, y)$, where $E=\left\{(x, y):|x|^{n} \leq\right.$ $\left.|y|^{-m \beta}\right\}$. Then we have

$$
\|f g\|_{L^{\vec{r}, \infty},} \mathbb{Z}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}, \infty}}
$$

(v). For $0<p_{1}, p_{2}, q_{1}, q_{2}<\infty$ with $p_{2} / q_{2}<p_{1} / q_{1}$, set

$$
\frac{\alpha}{m}=\frac{1}{p_{2}}-\frac{\beta}{p_{1}}, \quad \beta=\frac{1 / p_{2}+1 / q_{2}}{1 / p_{1}+1 / q_{1}},
$$

$f(x, y)=|y|^{-\alpha} \chi_{E}(x, y)$ and $g(x, y)=|y|^{\alpha} \chi_{E}(x, y)$, where $E=\left\{(x, y):|x|^{n} \leq\right.$ $\left.|y|^{-m \beta}\right\}$. Then we have

$$
\|f g\|_{L^{\vec{r}}, \infty} \mathbb{Z}\|f\|_{L^{\vec{p}, \infty}}\|g\|_{L^{\vec{q}}, \infty} .
$$

Proof. (i). First, we assume that $0<q_{1}, q_{2}<\infty$. Denote $E_{1}=\left\{y:|y|^{m}<\lambda^{-1 / \gamma}\right\}$. For any $y \in E_{1}$,

$$
\begin{equation*}
\left|\left\{x: \frac{1}{\left(|x|^{n}+|y|^{m}\right)^{\gamma}}>\lambda\right\}\right| \lesssim n \frac{1}{\lambda^{1 / \gamma}} \tag{2.10}
\end{equation*}
$$

And for $y \notin E_{1}$,

$$
\begin{equation*}
\left|\left\{x: \frac{1}{\left(|x|^{n}+|y|^{m}\right)^{\gamma}}>\lambda\right\}\right|=0 \tag{2.11}
\end{equation*}
$$

So

$$
\begin{align*}
\left(\int_{\mathbb{R}^{m}} \mid\{x:\right. & \left.\left.\frac{1}{\left(|x|^{n}+|y|^{m}\right)^{\gamma}}>\lambda\right\}\left.\right|^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \leq C_{n}\left(\int_{E_{1}} \frac{1}{\lambda^{q_{2} /\left(\gamma q_{1}\right)}} d y\right)^{1 / q_{2}} \\
& =C_{n, m} \frac{1}{\lambda^{1 /\left(\gamma q_{1}\right)+1 /\left(\gamma q_{2}\right)}} \tag{2.12}
\end{align*}
$$

Hence for $\gamma=1 / q_{1}+1 / q_{2}$, we have $g \in L^{\vec{q}, \infty}$. With suitable modification of the above arguments we see that the conclusion is also true if $q_{1}=\infty$ or $q_{2}=\infty$.
(ii). For $0<p_{2}<\infty$, a simple computation shows that

$$
\begin{aligned}
\|f g\|_{L^{\vec{r}, \infty}} & =\left\|\chi_{E}\right\|_{L^{\vec{r}}} \approx\left(\int_{1 \leq|y| \leq N}|y|^{-m \alpha r_{2} / r_{1}} d y\right)^{1 / r_{2}} \\
& \approx\left(\int_{1}^{N} t^{-m \alpha r_{2} / r_{1}+m-1} d t\right)^{1 / r_{2}}
\end{aligned}
$$

and

$$
\begin{aligned}
\|f\|_{L^{\vec{p}}} & \leq\left(\int_{1 \leq|y| \leq N}|y|^{m \gamma p_{2}-m \alpha p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \lesssim\left(\int_{1}^{N} t^{m \gamma p_{2}-m \alpha p_{2} / p_{1}+m-1} d y\right)^{1 / p_{2}} .
\end{aligned}
$$

Since $\alpha=p_{1} / p_{2}+p_{1} / q_{2}$ and $p_{1}=r_{1}$, we have $\alpha r_{2} / r_{1}=1$. Moreover,

$$
\gamma p_{2}-\frac{\alpha p_{2}}{p_{1}}+1=\frac{p_{2}}{q_{2}}-\frac{p_{2}}{p_{1}}\left(\frac{p_{1}}{p_{2}}+\frac{p_{1}}{q_{2}}\right)+1=0
$$

Hence

$$
\|f g\|_{L_{\vec{r}, \infty}} \approx(\ln N)^{1 / r_{2}} \text { and }\|f\|_{L^{\vec{p}}} \lesssim(\ln N)^{1 / p_{2}}
$$

And for $p_{2}=\infty$, it is easy to see that

$$
\|f g\|_{L^{\vec{r}, \infty}} \approx(\ln N)^{1 / r_{2}} \text { and }\|f\|_{L^{\vec{p}}} \lesssim 1
$$

By (i), $\|g\|_{L^{\vec{q}, \infty}}<\infty$. Since $p_{2}>r_{2}$ and

$$
\frac{\|f g\|_{L^{\vec{r}}, \infty}}{\|f\|_{L^{\vec{p}}, \infty}\|g\|_{L^{\vec{q}, \infty}}} \geq \frac{\|f g\|_{L^{\vec{r}}, \infty}}{\|f\|_{L^{\vec{p}}}\|g\|_{L^{\vec{q}, \infty}}} \gtrsim(\ln N)^{1 / r_{2}-1 / p_{2}}
$$

we get the conclusion as desired.
(iii). It is easy to see

$$
\|f g\|_{L^{r}, \infty}=\left\|\chi_{E}\right\|_{L^{\vec{r}}} \approx\left(\int_{\mathbb{R}^{m}}|y|^{-m} d y\right)^{1 / r_{2}}=\infty .
$$

On the other hand, for $0<p_{1}<\infty$,

$$
\begin{aligned}
\|f\|_{L^{\vec{p}, \infty}} & =\sup _{\lambda>0} \lambda\left(\int_{\mathbb{R}^{m}}|\{x:|f(x, y)|>\lambda\}|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& =\sup _{\lambda>0} \lambda\left(\int_{\mathbb{R}^{m}}\left|\left\{x: \lambda^{n / \gamma}<|x|^{n} \leq|y|^{-m r_{1} / r_{2}}\right\}\right|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{|y|<\lambda^{-n r_{2} /\left(m \gamma r_{1}\right)}}\left(|y|^{-m r_{1} / r_{2}}-\lambda^{n / \gamma}\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{|y|<\lambda^{-n r_{2} /\left(m \gamma r_{1}\right)}}\left(|y|^{-m r_{1} / r_{2}}\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \lesssim 1 .
\end{aligned}
$$

And for $p_{1}=\infty$, we also have $\|f\|_{L^{p}, \infty} \lesssim 1$.
Observe that

$$
\begin{aligned}
\|g\|_{L^{q}, \infty} & =\sup _{\lambda>0} \lambda\left\|\left|\left\{x:|x|^{-\gamma}>\lambda\right\}\right|^{1 / q_{1}}\right\|_{L_{y}^{\infty}} \\
& =\sup _{\lambda>0} \lambda\left\|\left|\left\{x:|x|<\lambda^{-1 / \gamma}\right\}\right|^{1 / q_{1}}\right\|_{L_{y}^{\infty}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\lambda^{-n / \gamma}\right)^{1 / q_{1}}=1 .
\end{aligned}
$$

We get the conclusion as desired.
(iv). We see from the definition of $\alpha$ and $\beta$ that

$$
\frac{1}{q_{2}}=\frac{\alpha}{m}+\frac{\beta}{q_{1}}, \quad \frac{\beta}{p_{1}}=\frac{\alpha}{m}+\frac{1}{p_{2}} .
$$

First, we show that $\alpha>0$, which is equivalent to

$$
\frac{q_{1}}{q_{2}}>\frac{1 / p_{2}+1 / q_{2}}{1 / p_{1}+1 / q_{1}} .
$$

Or equivalently,

$$
\frac{q_{1}}{p_{1}}>\frac{q_{2}}{p_{2}}
$$

which is true by the hypothesis.
Next we show that $f \in L^{\vec{p}, \infty}$. In fact,

$$
\begin{aligned}
\|f\|_{L^{\vec{p}, \infty}} & =\sup _{\lambda>0} \lambda\left(\int_{\mathbb{R}^{m}}\left|\left\{x:|y|^{\alpha} \chi_{E}(x, y)>\lambda\right\}\right|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{|y|>\lambda^{1 / \alpha}}|y|^{-m \beta p_{2} / p_{1}} d y\right)^{1 / p_{2}}
\end{aligned}
$$

$$
\begin{aligned}
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{\lambda^{1 / \alpha}}^{\infty} t^{-m \beta p_{2} / p_{1}+m-1} d t\right)^{1 / p_{2}} \\
& =\sup _{\lambda>0} \lambda \lambda^{-1}=1
\end{aligned}
$$

Similarly, we prove that $g \in L^{\vec{q}, \infty}$.

$$
\begin{aligned}
\|g\|_{L^{\bar{q}, \infty}} & =\sup _{\lambda>0} \lambda\left(\int_{\mathbb{R}^{m}}\left|\left\{x:|y|^{-\alpha} \chi_{E}(x, y)>\lambda\right\}\right|^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{|y|<\lambda-1 / \alpha}|y|^{-m \beta q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \lesssim \sup _{\lambda>0} \lambda\left(\int_{0}^{\lambda^{-1 / \alpha}} t^{-m \beta q_{2} / q_{1}+m-1} d t\right)^{1 / q_{2}} \\
& \lesssim 1 .
\end{aligned}
$$

However,

$$
\|f g\|_{L^{\vec{r}, \infty}}=\left\|\chi_{E}\right\|_{L^{\vec{r}}}=\left(\int_{\mathbb{R}^{m}}|y|^{-m \beta r_{2} / r_{1}} d y\right)^{1 / r_{2}}=\infty .
$$

Hence $\|f g\|_{L^{\vec{r}, \infty}} \mathbb{Z}\|f\|_{L^{\vec{r}, \infty}}\|g\|_{L^{\vec{q}, \infty}}$.
(v). By an interchange of $f$ and $g$ in (iv), we get (v).

### 2.5 Interpolation

It is well known that for $p<r<q$, we have $L^{p} \cap L^{q} \subset L^{r}$. The same is true for weak Lebesgue spaces. Moreover, we have the following interpolation formula.

Proposition 2.17 ([16, Propisition 1.1.14]) Let $p<q \leq \infty$ and $f \in L^{p, \infty} \cap L^{q, \infty}$. Then $f$ is in $L^{r}$ for all $p<r<q$ and

$$
\|f\|_{L^{r}} \leq\left(\frac{r}{r-p}+\frac{r}{q-r}\right)^{1 / r}\|f\|_{L^{p, \infty}}^{\theta}\|f\|_{L^{q, \infty}}^{1-\theta}
$$

with the suitable interpretation when $q=\infty$, where $0<\theta<1$ satisfies $1 / r=\theta / p+(1-\theta) / q$.
However, the above proposition is not true in general if $p, q, r$ are replaced with vector indices.

Theorem 2.18 Suppose that $\vec{p}=\left(p_{1}, p_{2}\right), \vec{q}=\left(q_{1}, q_{2}\right)$ and $\vec{r}=\left(r_{1}, r_{2}\right)$ satisfy that

$$
\begin{equation*}
\frac{1}{r_{i}}=\frac{\theta}{p_{i}}+\frac{1-\theta}{q_{i}}, \quad i=1,2, \tag{2.13}
\end{equation*}
$$

where $0<\theta<1$ is a constant. Then we have

$$
\begin{aligned}
\|f\|_{L^{\vec{r}, \infty}} & \leq\|f\|_{L^{\vec{p}, \infty}}^{\theta}\|f\|_{L^{\vec{q}, \infty}}^{1-\theta}, \\
\|f\|_{L^{\vec{r}}} & \leq\left(\frac{r_{1}}{r_{1}-p_{1}}+\frac{r_{1}}{q_{1}-r_{1}}\right)^{1 / r_{1}}\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)}^{\theta}\|f\|_{L^{q_{2}}\left(L^{q_{1}, \infty}\right)}^{1-\theta} .
\end{aligned}
$$

However, if $1 / p_{1}+1 / p_{2}=1 / q_{1}+1 / q_{2}$, then for any multiple index $\vec{r}, L^{\vec{p}, \infty} \cap L^{\vec{q}, \infty} \not \subset L^{\vec{r}}$.

Proof. Fix some function $f$ and $\lambda>0$. We see from Hölder's inequality that

$$
\begin{aligned}
\lambda\left\|\chi_{\{|f|>\lambda\}}\right\|_{L^{\vec{r}}} & \leq \lambda^{\theta}\left\|\chi_{\{|f|>\lambda\}}\right\|_{L^{\vec{p} / \theta}} \cdot \lambda^{1-\theta}\left\|\chi_{\{|f|>\lambda\}}\right\|_{L^{\vec{q} /(1-\theta)}} \\
& \leq\|f\|_{L^{\vec{p}, \infty},}^{\theta}\|f\|_{L^{\vec{q}, \infty}}^{1-\theta} .
\end{aligned}
$$

Hence $\|f\|_{L^{\vec{r}, \infty}} \leq\|f\|_{L_{\vec{p}, \infty}}^{\theta}\|f\|_{L^{\vec{q}, \infty}}^{1-\theta}$.
On the other hand, we see from Proposition 2.17 that

$$
\|f(\cdot, y)\|_{L_{x}^{r_{1}}} \leq\left(\frac{r_{1}}{r_{1}-p_{1}}+\frac{r_{1}}{q_{1}-r_{1}}\right)^{1 / r_{1}}\|f(\cdot, y)\|_{L_{x}^{p_{1}, \infty}}^{\theta}\|f(\cdot, y)\|_{L_{x}^{q_{1}, \infty}}^{1-\theta} .
$$

By Hölder's inequality, we get

$$
\begin{aligned}
\|f\|_{L^{\vec{r}}} & \leq\left(\frac{r_{1}}{r_{1}-p_{1}}+\frac{r_{1}}{q_{1}-r_{1}}\right)^{1 / r_{1}}\| \| f\left\|_{L_{x}^{p_{1}, \infty}}^{\theta}\right\|_{L_{y}^{p_{2} / \theta}}\| \| f(\cdot, y)\left\|_{L_{x}^{q_{1}}, \infty}^{1-\theta}\right\|_{L_{y}^{q_{2} /(1-\theta)}} \\
& =\left(\frac{r_{1}}{r_{1}-p_{1}}+\frac{r_{1}}{q_{1}-r_{1}}\right)^{1 / r_{1}}\|f\|_{L^{p_{2}\left(L^{p_{1}, \infty}\right)} \boldsymbol{\theta}}\|f\|_{L^{q_{2}}\left(L^{q_{1}, \infty}\right)}^{1-\theta} .
\end{aligned}
$$

Next we show that $L^{\vec{p}, \infty} \cap L^{\vec{q}, \infty} \not \subset L^{\vec{r}}$. Set $f(x, y)=\left(|x|^{n}+|y|^{m}\right)^{-\gamma}$, where $\gamma>0$. For $\gamma=1 / q_{1}+1 / q_{2}=1 / p_{1}+1 / p_{2}$, we see from Example 2.16(i) that $f \in L^{\vec{p}, \infty} \cap L^{\vec{q}, \infty}$.

It remains to show that $f \notin L^{\vec{r}}$. We have

$$
\begin{aligned}
\int_{\mathbb{R}^{n}}|f(x, y)|^{r_{1}} d x & \geq \int_{|x|^{n}<|y|^{m}}|f(x, y)|^{r_{1}} d x+\int_{|x|^{n} \geq|y|^{m}}|f(x, y)|^{r_{1}} d x \\
& \geq \int_{|x|^{n}<|y|^{m}} \frac{1}{2^{\gamma r_{1}}|y|^{m \gamma r_{1}}} d x+\int_{|x|^{n} \geq|y|^{m}} \frac{1}{2^{\gamma r_{1}}|x|^{n \gamma r_{1}}} d x .
\end{aligned}
$$

Hence for $\gamma r_{1} \leq 1$, we have $\|f(\cdot, y)\|_{L_{x}^{r_{1}}}=\infty$. And for $\gamma r_{1}>1$, we have

$$
\int_{\mathbb{R}^{n}}|f(x, y)|^{r_{1}} d x \geq C_{n, r_{1}} \frac{1}{|y|^{m \gamma r_{1}-m}}
$$

In both cases, we have $\|f\|_{L^{\vec{r}}}=\infty$.
When the iterated weak norms are invoked, we get again an interpolation theorem. However, four iterated weak norms are invoked.

Theorem 2.19 Suppose that

$$
\begin{aligned}
& \frac{1}{r_{1}}=\frac{\theta}{p_{1}}+\frac{1-\theta}{q_{1}} \\
& \frac{1}{r_{2}}=\frac{\theta \xi}{p_{21}}+\frac{(1-\theta) \xi}{p_{22}}+\frac{\theta(1-\xi)}{q_{21}}+\frac{(1-\theta)(1-\xi)}{q_{22}},
\end{aligned}
$$

where $0<\theta, \xi<1$ are constants. Then we have

$$
\|f\|_{L^{\vec{r}}} \leq C\|f\|_{L^{p_{21}, \infty}\left(L^{p_{1}, \infty}\right)}^{\theta \xi}\|f\|_{L^{p_{22}, \infty}\left(L^{q_{1}, \infty}\right)}^{(1-\theta) \xi}\|f\|_{L^{q_{21}, \infty}\left(L^{p_{1}, \infty}\right)}^{\theta(1-\xi)}\|f\|_{L^{q_{22}, \infty}\left(L^{q_{1}, \infty}\right)}^{(1-\theta)(1-\xi)} .
$$

Proof. We see from Proposition 2.17 that

$$
\|f(\cdot, y)\|_{L_{x}^{r_{1}}} \leq\left(\frac{r_{1}}{r_{1}-p_{1}}+\frac{r_{1}}{q_{1}-r_{1}}\right)^{1 / r_{1}}\|f(\cdot, y)\|_{L_{x}^{p_{1}, \infty}}^{\theta}\|f(\cdot, y)\|_{L_{x}^{q_{1}}, \infty}^{1-\theta} .
$$

Set

$$
\frac{1}{p_{2}}=\frac{\theta}{p_{21}}+\frac{1-\theta}{p_{22}} \quad \text { and } \quad \frac{1}{q_{2}}=\frac{\theta}{q_{21}}+\frac{1-\theta}{q_{22}} .
$$

Then we have $1 / r_{2}=\xi / p_{2}+(1-\xi) / q_{2}$. Using Proposition 2.17 again we get

$$
\begin{aligned}
\|f\|_{L^{\vec{r}}} \leq & C\left\|\|f(\cdot, y)\|_{L_{x}^{p_{1}, \infty}}^{\theta}\right\| f(\cdot, y)\left\|_{L_{x}^{q_{1}}, \infty}^{1-\theta}\right\|_{L_{y}^{p_{2}, \infty}}^{\xi} \\
& \times\| \| f(\cdot, y)\left\|_{L_{x}^{p_{1}, \infty}}^{\theta}\right\| f(\cdot, y)\left\|_{L_{x}^{q_{1}, \infty}}^{1-\theta}\right\|_{L_{y}^{q_{2}, \infty}}^{1-\xi} .
\end{aligned}
$$

Now we see from Hölder's inequality for weak norms that

$$
\begin{align*}
\|f\|_{L^{\vec{r}}} \leq & C\left\|\|f(\cdot, y)\|_{L_{x}^{p_{1}, \infty}}^{\theta}\right\|_{L_{y}^{p_{21} / \theta, \infty}}^{\xi}\| \| f(\cdot, y)\left\|_{L_{x}^{q_{1}, \infty}}^{1-\theta}\right\|_{L_{y}^{p_{22} /(1-\theta), \infty}}^{\xi} \\
& \quad \times\| \| f(\cdot, y)\left\|_{L_{x}^{p_{1}, \infty}}^{\theta}\right\|_{L_{y}^{q_{21} / \theta, \infty}}^{1-\xi}\| \| f(\cdot, y)\left\|_{L_{x}^{q_{1}, \infty}}^{1-\theta}\right\|_{L_{y}^{q_{22}} /(1-\theta), \infty}^{1-\xi} \\
= & C\|f\|_{L^{p_{21}, \infty}\left(L^{p_{1}, \infty}\right)}^{\theta}\|f\|_{L^{p_{22}, \infty}\left(L^{q_{1}, \infty}\right)}^{(1-\theta)}\|f\|_{L^{q_{21}, \infty}\left(L^{p_{1}, \infty}\right)}^{\theta(1-\xi)}\|f\|_{L^{q_{22}, \infty}\left(L^{q_{1}, \infty}\right)}^{(1-\theta)(1-\xi)} . \tag{2.14}
\end{align*}
$$

The above results can be restated as follows. Denote $\vec{p}_{a}=\left(p_{1}, p_{21}\right), \vec{p}_{b}=\left(p_{1}, q_{21}\right), \vec{q}_{a}=$ $\left(q_{1}, p_{22}\right)$ and $\vec{q}_{b}=\left(q_{1}, q_{22}\right)$. Let $\left(1 / r_{1}, 1 / r_{2}\right)$ be a point in the interior of the quadrilateral determined by the four points $\left(1 / p_{1}, 1 / p_{21}\right),\left(1 / p_{1}, 1 / q_{21}\right),\left(1 / q_{1}, 1 / p_{22}\right),\left(1 / q_{1}, 1 / q_{22}\right)$ as shown in Figure 1. Then we have

## 3 Geometric Inequalities Related to Fractional Integration

In this section, we study the boundedness of $T_{\gamma}$ and $L_{\gamma}$ from $L^{\vec{p}}$ to $L^{\vec{q}}$. First, we consider $T_{\gamma}$ with $\vec{p}=(\infty, \infty)$. In this case, it is more convenient to rewrite the inequality in the following form,

$$
\|F\|_{X} \lesssim \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}
$$

where $X$ stands for some norm defined on $\mathbb{R}^{2 n}$. Recall that $L^{\vec{p}}=L^{\infty}$ whenever $\vec{p}=(\infty, \infty)$.
First, we point out that the following inequality

$$
\begin{equation*}
\|F\|_{L^{\vec{p}, \infty}} \leq C_{\vec{p}, n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)|x-y|^{n / p_{1}+n / p_{2}} \tag{3.1}
\end{equation*}
$$

if false, even for characteristic functions. This is because for any $s>0$,

$$
|\{(x, y):|x-y|<s\}|=\infty .
$$

Now we turn to study its fractional form as follows.
Theorem 3.1 Let $F$ be a nonnegative measurable function defined on $\mathbb{R}^{2 n}$. Then for all $0<q_{1}, q_{2} \leq \infty$, we have

$$
\begin{gather*}
\|F\|_{L^{\vec{q}, \infty}} \leq C_{\vec{q}, n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}},  \tag{3.2}\\
\|F\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} \leq C_{\vec{q}, n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}} . \tag{3.3}
\end{gather*}
$$

However, for $\vec{q} \neq(\infty, \infty)$, we have

$$
\begin{equation*}
\|F\|_{L^{\vec{q}}} \leq C_{\vec{q}, n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}} \tag{3.4}
\end{equation*}
$$

is not true for all $F \in L^{\vec{q}}\left(\mathbb{R}^{2 n}\right)$.
Proof. (i). First, we prove (3.2). For $0<q_{1}, q_{2}<\infty$, suppose that

$$
\sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}=s<\infty .
$$

Denote $E_{y, \lambda}=\{x:|F(x, y)|>\lambda\}$. For any $\lambda>0$,

$$
\left\|\left|E_{y, \lambda}\right|^{1 / q_{1}}\right\|_{L^{q_{2}}} \leq\left(\int_{\mathbb{R}^{n}}\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}<\frac{s}{\lambda}\right\}\right|^{q_{2} / q_{1}} d y\right)^{1 / q_{2}}
$$

Denote $E_{1}=\left\{y:|y|<(1 / 2)(s / \lambda)^{q_{1} q_{2} /\left(n q_{1}+n q_{2}\right)}\right\}$. For any $y \in E_{1}$,

$$
\begin{equation*}
\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}<\frac{s}{\lambda}\right\}\right| \lesssim_{n}\left(\frac{s}{\lambda}\right)^{q_{1} q_{2} /\left(q_{1}+q_{2}\right)} \tag{3.5}
\end{equation*}
$$

And for $y \notin E_{1}$,

$$
\begin{equation*}
\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}<\frac{s}{\lambda}\right\}\right|=0 \tag{3.6}
\end{equation*}
$$

So

$$
\begin{aligned}
\left(\int_{\mathbb{R}^{n}} \mid\{x:\right. & \left.\left.(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}<\frac{s}{\lambda}\right\}\left.\right|^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \leq C_{\vec{q}, n}\left(\int_{E_{1}}\left(\left(\frac{s}{\lambda}\right)^{q_{1} q_{2} /\left(q_{1}+q_{2}\right)}\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& =C_{\vec{q}, n}\left(\frac{s}{\lambda}\right)^{q_{2} /\left(q_{1}+q_{2}\right)}\left(\int_{E_{1}} d y\right)^{1 / q_{2}} \\
& =C_{\vec{q}, n} \frac{s}{\lambda} .
\end{aligned}
$$

Therefore,

$$
\|F\|_{L^{\vec{q}, \infty}}=\sup _{\lambda>0} \lambda\left\|\left|E_{y, \lambda}\right|^{1 / q_{1}}\right\|_{L^{q_{2}}} \lesssim_{n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}} .
$$

Now we consider the case of endpoints. Since the case of $q_{1}=q_{2}=\infty$ is obvious, we assume that one of $q_{1}$ and $q_{2}$ is finite.

For $q_{2}=\infty$, we have

$$
\|F\|_{L^{\vec{q}, \infty}}=\sup _{\lambda>0} \lambda\left\|\left|E_{y, \lambda}\right|^{1 / q_{1}}\right\|_{L^{\infty}} .
$$

Taking similar calculation gives for any $\lambda>0$,

$$
\left\|\left|E_{y, \lambda}\right|^{1 / q_{1}}\right\|_{L^{\infty}} \leq\left\|\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}}<\frac{s}{\lambda}\right\}\right|^{1 / q_{1}}\right\|_{L^{\infty}} \leq C_{q_{1}, n} \frac{s}{\lambda} .
$$

Hence

$$
\|F\|_{L^{\vec{q}, \infty}}=\sup _{\lambda>0} \lambda\left\|\left|E_{y, \lambda}\right|^{1 / q_{1}}\right\|_{L^{\infty}} \leq C_{q_{1}, n} s .
$$

For $q_{1}=\infty$, we have

$$
\|F\|_{L^{\vec{q}, \infty}}=\sup _{\lambda>0} \lambda\| \| \chi_{E_{y, \lambda}}\left\|_{L^{\infty}}\right\|_{L^{q_{2}}} .
$$

Note that for any $\lambda>0$,

$$
\chi_{E_{y, \lambda}} \leq \chi_{\left\{x:(|x+y|+|x-y|)^{\left.n / q_{2}<s / \lambda\right\}}\right.} .
$$

If $|y|<(1 / 2)(s / \lambda)^{q_{2} / n},\left\|\chi_{E_{y, \lambda}}\right\|_{L^{\infty}} \leq 1$; if $|y| \geq(1 / 2)(s / \lambda)^{q_{2} / n},\left\|\chi_{E_{y, \lambda}}\right\|_{L^{\infty}}=0$. Hence

$$
\left\|\left\|\chi_{E_{y, \lambda}}\right\|_{L^{\infty}}\right\|_{L^{q_{2}}} \leq C_{q_{2}, n} \frac{s}{\lambda} .
$$

Therefore,

$$
\|F\|_{L^{\vec{q}, \infty}}=\sup _{\lambda>0} \lambda\| \| \chi_{E_{y, \lambda}}\left\|_{L^{\infty}}\right\|_{L^{q_{2}}} \leq C_{q_{2}, n} s .
$$

(ii). Next we prove (3.3). As in the previous arguments, we consider first the case of $q_{1}, q_{2}<\infty$.

As in the proof of (3.2), suppose that $\sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}=$ $s<\infty$. Then we see from (3.5) and (3.6) that for any $y \neq 0$,

$$
\begin{aligned}
\sup _{\lambda>0} \lambda \mid & \left.\{x:|F(x, y)|>\lambda\}\right|^{1 / q_{1}} \\
& \leq \sup _{\lambda>0} \lambda\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}}<\frac{s}{\lambda}\right\}\right|^{1 / q_{1}} \\
& =C_{\vec{q}, n} s|y|^{-n / q_{2}} .
\end{aligned}
$$

Hence

$$
\begin{aligned}
\|F\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} & =\| \| F\left\|_{L_{x}^{q_{1}, \infty}}\right\|_{L_{y}^{q_{2}, \infty}} \\
& =\sup _{\beta>0} \beta\left|\left\{y: \sup _{\lambda>0} \lambda|\{x:|F(x, y)|>\lambda\}|^{1 / q_{1}}>\beta\right\}\right|^{1 / q_{2}} \\
& \leq \sup _{\beta>0} \beta\left|\left\{y: C_{\vec{q}, n} s|y|^{-n / q_{2}}>\beta\right\}\right|^{1 / q_{2}} \\
& \leq \sup _{\beta>0} \beta C_{\vec{q}, n} s \beta^{-1}=C_{\vec{q}, n} s .
\end{aligned}
$$

It remains to see the endpoint cases. For $q_{2}=\infty$,

$$
\|F\|_{L^{\infty}\left(L^{q_{1}, \infty}\right)}=\| \| F\left\|_{L_{x}^{q_{1}, \infty}}\right\|_{L_{y}^{\infty}}
$$

For any $\lambda>0$ and $y \in \mathbb{R}^{n}$,

$$
\begin{aligned}
\lambda|\{x:|F(x, y)|>\lambda\}|^{1 / q_{1}} & \leq \lambda\left|\left\{x:(|x+y|+|x-y|)^{n / q_{1}}<\frac{s}{\lambda}\right\}\right|^{1 / q_{1}} \\
& \leq C_{q_{1}, n} s .
\end{aligned}
$$

Hence

\|F\|_{L^{\infty}\left(L^{q_{1}, \infty}\right)}=\| \| F\left\|_{L_{x}^{q_{1}, \infty}}\right\|_{L_{y}^{\infty}} \leq C_{q_{1}, n} s
$$

For $q_{1}=\infty$,

\|F\|_{L^{q_{2}, \infty}\left(L^{\infty}\right)}=\| \| F\left\|_{L_{x}^{\infty}}\right\|_{L_{y}^{q_{2}, \infty}}
$$

Since

F(x, y) \leq s(|x+y|+|x-y|)^{-n / q_{2}} \leq s(2|y|)^{-n / q_{2}}
$$

we get for all $y$,

Finally, we use a counterexample to show that (3.4) is false. We consider only the case of $q_{1}, q_{2}<\infty$. Other cases can be found in Theorem 3.2,

\left\|F_{N}\right\|_{L^{\vec{q}}}=\left(\int_{\{y: 1 \leq|y| \leq N\}}\left(\int_{\{x:|x| \geq|y|\}} \frac{1}{(|x|+|y|)^{n+n q_{1} / q_{2}}} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}}
$$

By polar coordinates, we have

\begin{aligned}
\left\|F_{N}\right\|_{L^{\vec{q}}} & =C\left(\int_{\{y: 1 \leq|y| \leq N\}}\left(\int_{|y|}^{\infty} \frac{r^{n-1}}{(r+|y|)^{n+n q_{1} / q_{2}}} d r\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \geq C^{\prime}\left(\int_{\{y: 1 \leq|y| \leq N\}}\left(\int_{|y|}^{\infty} \frac{r^{n-1}}{r^{n+n q_{1} / q_{2}}} d r\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& =C_{\vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq N\}}|y|^{-n} d y\right)^{1 / q_{2}} \\
& =C_{\vec{q}, n}(\ln N)^{1 / q_{2}} .
\end{aligned}
$$

Letting $N \rightarrow \infty$, we get

does not hold.
Meanwhile, we present all the endpoint cases. For any $C_{\vec{q}, n}>0$,

& \|F\|_{L^{q_{1}}\left(L^{\infty}\right)} \not \not \not \leq C_{\vec{q}, n} \sup _{x, y \in \mathbb{R}^{n}} F(x, y)(|x+y|+|x-y|)^{n / q_{1}} . \tag{3.10}
\end{align*}

For the remaining endpoint cases, we have

\leq & s\left(\int_{M_{y}}\left(\frac{1}{2|y|}\right)^{n+n q_{1} / q_{2}} d x+\int_{N_{y}}\left(\frac{1}{2|x|}\right)^{n+n q_{1} / q_{2}} d x\right)^{1 / q_{1}} \\
= & C_{\vec{q}, n} s|y|^{-n / q_{2}} .
\end{aligned}
$$

Therefore,

\|F\|_{L^{q_{2}, \infty}\left(L^{q_{1}}\right)} & =\| \| F\left\|_{L_{x}^{q_{1}}}\right\|_{L_{y}^{q_{2}, \infty}} \\
& \leq \sup _{\alpha>0} \alpha\left|\left\{y: C_{\vec{q}, n} s|y|^{-n / q_{2}}>\alpha\right\}\right|^{1 / q_{2}} \leq C_{\vec{q}, n} s .
\end{aligned}
$$

(2) We consider

F_{N}(x, y)=\left(\frac{1}{|x|+|y|}\right)^{n / q_{1}+n / q_{2}} \chi_{\{(x, y): 1 \leq|y| \leq N\}}, \quad N \in \mathbb{N} .
$$

Clearly,

\sup _{x, y \in \mathbb{R}^{n}} F_{N}(x, y)(|x+y|+|x-y|)^{n / q_{1}+n / q_{2}} \leq 2^{n / q_{1}+n / q_{2}} .
$$

On the other hand,

\begin{aligned}
& \sup _{\alpha>0} \alpha\left|\left\{x:\left|F_{N}(x, y)\right|>\alpha\right\}\right|^{1 / q_{1}}=\sup _{\alpha>0} \alpha\left|\left\{x:(|x|+|y|)^{n / q_{1}+n / q_{2}}<\frac{1}{\alpha}\right\}\right|^{1 / q_{1}} \\
&=\sup _{\alpha>0} \alpha\left|\left\{x:|x|<\left(\frac{1}{\alpha}\right)^{q_{1} q_{2} /\left(n q_{1}+n q_{2}\right)}-|y|\right\}\right|^{1 / q_{1}}
\end{aligned}
$$

Choosing $\alpha=\left(\frac{1}{2|y|}\right)^{n / q_{1}+n / q_{2}}$, we have

\left\|F_{N}\right\|_{L_{x}^{q_{1}}} & =\left(\int_{\{x: 1 \leq|x| \leq N\}} \frac{d x}{(|x|+|y|)^{n}}\right)^{1 / q_{1}} \\
& \geq\left(\int_{\{x:|y| \leq|x| \leq N\}} \frac{d x}{2^{n}|x|^{n}}\right)^{1 / q_{1}}=C_{q_{1}, n}(\ln N-\ln |y|)^{1 / q_{1}}
\end{aligned}
$$

and

$$
\left\|F_{N}\right\|_{L_{x}^{\infty}}=(1+|y|)^{-n / q_{1}} .
$$

Consequently,

\left\|F_{N}\right\|_{L^{\infty}\left(L^{q_{1}}\right)}=\| \| F_{N}\left\|_{L_{x}^{q_{1}}}\right\|_{L_{y}^{\infty}} \gtrsim_{q_{1}, n}(\ln N)^{1 / q_{1}}
$$

and

\begin{aligned}
\left\|F_{N}\right\|_{L^{q_{1}}\left(L^{\infty}\right)} & =\| \| F_{N}\left\|_{L_{x}^{\infty}}\right\|_{L_{y}^{q_{1}}} \\
& =\left(\int_{\{y: 1 \leq|y| \leq N\}} \frac{1}{(1+|y|)^{n}} d y\right)^{1 / q_{1}} \\
& \geq\left(\int_{\{y: 1 \leq|y| \leq N\}} \frac{1}{(2|y|)^{n}} d y\right)^{1 / q_{1}}=C_{q_{1}, n}(\ln N)^{1 / q_{1}} .
\end{aligned}

Letting $N \rightarrow \infty$ we have a contradiction. That gives the endpoint cases (3.9) and (3.10). Obviously, the other two endpoint cases (3.11) and (3.12) follow from the endpoint cases of (3.3).

By interpolation, it is known that for all $0<p_{1}<r<p_{2} \leq \infty$,

\|f\|_{r} \leq C_{\vec{p}, r}\|f\|_{p_{1}, \infty}^{\theta}\|f\|_{p_{2}, \infty}^{1-\theta} \tag{3.15}
\end{equation*}
$$

where

\frac{1}{r}=\frac{\theta}{p_{1}}+\frac{1-\theta}{p_{2}}
$$

Denote $\gamma=n / p_{1}+n / p_{2}$. It follows from (3.3) that

& \leq C_{\vec{p}, n} \sup _{x, y \in \mathbb{R}^{n}} f(x) g(y)(|x+y|+|x-y|)^{n / p_{1}+n / p_{2}}
\end{aligned}

From the rearrangement inequality [8, Theorem 4.1] we have

= & \frac{1}{2} \sup _{x, y \in \mathbb{R}^{n}} f^{*}(x) g^{*}(y)|x-y|^{n / p_{1}+n / p_{2}}+\frac{1}{2} \sup _{x, y \in \mathbb{R}^{n}} f^{*}(x) g^{*}(y)|x+y|^{n / p_{1}+n / p_{2}} \\
\geq & \frac{1}{2} \sup _{x, y \in \mathbb{R}^{n}} f^{*}(x) g^{*}(y)\left(|x+y|^{n / p_{1}+n / p_{2}}+|x-y|^{n / p_{1}+n / p_{2}}\right)
\end{aligned}
$$

$$
\geq C_{\vec{p}, n} \sup _{x, y \in \mathbb{R}^{n}} f^{*}(x) g^{*}(y)(|x+y|+|x-y|)^{n / p_{1}+n / p_{2}}
$$

where $f^{*}$ is the symmetric decreasing rearrangement of $f$. Therefore, from

\left\|f^{*}\right\|_{L^{p_{1}}}\left\|g^{*}\right\|_{L^{p_{2}}} \leq C_{\vec{p}, n} \sup _{x, y \in \mathbb{R}^{n}} f^{*}(x) g^{*}(y)(|x+y|+|x-y|)^{n / p_{1}+n / p_{2}}
$$

together with the fact that

\end{equation*}
$$

(ii). For all $0<p_{1} \leq q_{1} \leq \infty$ and $0<p_{2} \leq q_{2} \leq \infty$ satisfying the homogeneity condition

\begin{equation*}
\frac{1}{p_{1}}+\frac{1}{p_{2}}=\frac{1}{q_{1}}+\frac{1}{q_{2}}+\frac{\gamma}{n}, \tag{3.18}
\end{equation*}
$$

we have

\begin{equation*}
\left\|T_{\gamma}^{-1} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} \geq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} . \tag{3.19}
\end{equation*}
$$

(iii). For all $0<q_{1} \leq p_{1} \leq \infty$ and $0<q_{2} \leq p_{2} \leq \infty$ satisfying $p_{1} q_{2}=p_{2} q_{1}$ and the homogeneity condition (3.16), we have

\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty}} \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{\vec{p}, \infty}} . \tag{3.20}
\end{equation*}

(iv). For all $0<p_{1} \leq q_{1} \leq \infty$ and $0<p_{2} \leq q_{2} \leq \infty$ satisfying $p_{1} q_{2}=p_{2} q_{1}$ and the homogeneity condition (3.18), we have

It remains to verify the case when $0<r_{1}, r_{2}<\infty$. If $|y|<\alpha^{-1 / \gamma}$,

\alpha|\{x:|g(x, y)|>\alpha\}|^{1 / r_{1}} \leq C_{r_{1}, n} \alpha^{1-n /\left(\gamma r_{1}\right)}
$$

If $|y| \geq \alpha^{-1 / \gamma}$, it is not hard to see that $\alpha|\{x:|g(x, y)|>\alpha\}|^{1 / r_{1}}=0$. Thus for any $y \neq 0$,

\sup _{\alpha>0} \alpha|\{x:|g(x, y)|>\alpha\}|^{1 / r_{1}} \leq C_{r_{1}, n}|y|^{n / r_{1}-\gamma}
$$

Then by definition,

\|g\|_{L^{r_{2}, \infty}\left(L^{r_{1}, \infty}\right)} & =\| \| g\left\|_{L_{x}^{r_{1}, \infty}}\right\|_{L_{y}^{r_{2}, \infty}} \\
& =\sup _{\beta>0} \beta\left|\left\{y: \sup _{\alpha>0} \alpha|\{x:|g(x, y)|>\alpha\}|^{1 / r_{1}}>\beta\right\}\right|^{1 / r_{2}} \\
& \leq \sup _{\beta>0} \beta\left|\left\{y: C_{r_{1}, n}|y|^{n / r_{1}-\gamma}>\beta\right\}\right|^{1 / r_{2}}=C_{\vec{r}, n}
\end{aligned}
$$

Hence (3.17) is true.
On the other hand, we see from (3.17) that

\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}=\left\|T_{\gamma} T_{\gamma}^{-1} f\right\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} \lesssim\left\|T_{\gamma}^{-1} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)}
$$

Hence (3.19) is also true.
(ii). Next we prove (3.20) and (3.21). Suppose that $0<p_{1}, p_{2}, q_{1}, q_{2}<\infty$ and $1 / q_{1}+$ $1 / q_{2}=1 / p_{1}+1 / p_{2}+\gamma / n$. Then there always exist $r_{1}, r_{2}$ satisfying $1 / r_{1}+1 / r_{2}=\gamma / n$ such that $p_{1} / p_{2}=r_{1} / r_{2}$.

In retrospect, it follows from the proof of Theorem 2.18 that for all $\vec{r}=\left(r_{1}, r_{2}\right)$ satisfying $1 / r_{1}+1 / r_{2}=\gamma / n$,

$$
(|x+y|+|x-y|)^{-\gamma} \in L^{\vec{r}, \infty} .
$$

By Hölder's inequality in Theorem 2.14.

$$
\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty}} \lesssim_{\vec{p}, \vec{q}, n}\|f\|_{L^{\vec{p}, \infty}}\left\|(|x+y|+|x-y|)^{-\gamma}\right\|_{L^{\vec{r}, \infty}},
$$

which gives (3.20). When $p_{1}=q_{1}=\infty, p_{2}=q_{2}=\infty$, or $p_{1}=p_{2}=\infty$, as shown in Theorem 2.14, Hölder's inequality still holds for these cases. Taking similar arguments we conclude (3.20).

Likewise, it follows from (3.20) that

Remark 3.5 We point out that the condition $1 / q_{1}+1 / q_{2}=1 / p_{1}+1 / p_{2}+\gamma / n$ follows from the homogeneity.

Suppose that (3.17) is true. Then we consider functions $f(\dot{\bar{R}}, \dot{\bar{R}})$ for $R>0$. On the one hand,

& \sup _{\alpha>0} \alpha\left|\left\{x: f\left(\frac{x}{R}, \frac{y}{R}\right)(|x+y|+|x-y|)^{-\gamma}>\alpha\right\}\right|^{1 / q_{1}} \\
= & \sup _{\alpha>0} \alpha\left|\left\{x: f\left(\frac{x}{R}, \frac{y}{R}\right)\left(\left|\frac{x}{R}+\frac{y}{R}\right|+\left|\frac{x}{R}-\frac{y}{R}\right|\right)^{-\gamma}>R^{\gamma} \alpha\right\}\right|^{1 / q_{1}} \\
= & \sup _{\alpha>0} \alpha R^{n / q_{1}}\left|\left\{x: f\left(x, \frac{y}{R}\right)\left(\left|x+\frac{y}{R}\right|+\left|x-\frac{y}{R}\right|\right)^{-\gamma}>R^{\gamma} \alpha\right\}\right|^{1 / q_{1}} \\
= & R^{n / q_{1}-\gamma} \sup _{\alpha>0} \alpha\left|\left\{x: f\left(x, \frac{y}{R}\right)\left(\left|x+\frac{y}{R}\right|+\left|x-\frac{y}{R}\right|\right)^{-\gamma}>\alpha\right\}\right|^{1 / q_{1}} \\
= & R^{n / q_{1}-\gamma}\left\|T_{\gamma} f\left(\cdot, \frac{y}{R}\right)\right\|_{L_{x}^{q_{1}, \infty}} .
\end{aligned}
$$

Hence

$$
\begin{aligned}
& \left\|T_{\gamma} f\left(\frac{\dot{\bar{R}}}{R}, \dot{\bar{R}}\right)\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} \\
& \quad=R^{n / q_{1}-\gamma} \sup _{\beta>0} \beta\left|\left\{y:\left\|T_{\gamma} f\left(\cdot, \frac{y}{R}\right)\right\|_{L_{x}^{q_{1}, \infty}}>\beta\right\}\right|^{1 / q_{2}} \\
& \quad=R^{n / q_{1}+n / q_{2}-\gamma} \sup _{\beta>0} \beta\left|\left\{y:\left\|T_{\gamma} f(\cdot, y)\right\|_{L_{x}^{q_{1}, \infty}}>\beta\right\}\right|^{1 / q_{2}}
\end{aligned}
$$

$$
=R^{n / q_{1}+n / q_{2}-\gamma}\left\|T_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} .
$$

These imply that for all $R>0$,

R^{n / q_{1}+n / q_{2}-\gamma} \lesssim R^{n / p_{1}+n / p_{2}},
$$

which gives the condition

Remark 3.6 We illustrate that (3.20) might be false if $p_{1} q_{2} \neq p_{2} q_{1}$.

\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty}} & =\left\|\chi_{E}\right\|_{L^{\vec{q}}}=\left(\int_{1 \leq|y| \leq N}|y|^{-n \alpha q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \approx\left(\int_{1}^{N} t^{-n \alpha q_{2} / q_{1}+n-1} d t\right)^{1 / q_{2}}
\end{aligned}
$$

and

$$
\|f\|_{L^{\vec{p}}} \leq\left(\int_{1 \leq|y| \leq N}|y|^{\gamma p_{2}-n \alpha p_{2} / p_{1}} d y\right)^{1 / p_{2}} \lesssim\left(\int_{1}^{N} t^{\gamma p_{2}-n \alpha p_{2} / p_{1}+n-1} d t\right)^{1 / p_{2}}
$$

Set $\alpha=p_{1}\left(\gamma / n+1 / p_{2}\right)$. We have

$$
\frac{\alpha}{p_{1}}=\frac{\gamma}{n}+\frac{1}{p_{2}}=\frac{1}{q_{1}}+\frac{1}{q_{2}}-\frac{1}{p_{1}}=\frac{1}{q_{2}}
$$

Therefore, $\alpha q_{2} / q_{1}=1$. It follows that

\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty}} \approx(\ln N)^{1 / q_{2}} \text { and }\|f\|_{L^{\vec{p}}} \approx(\ln N)^{1 / p_{2}}
$$

Hence

\lim _{N \rightarrow \infty} \frac{\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty},}}{\|f\|_{L^{\vec{p}}}}=\infty
$$

(ii). $p_{2}=q_{2}$ and $p_{1}>q_{1}$.

In this case, we have

In fact, there is some constant $C$ such that

However, (3.20) is not true. To see this, let

where

E=\left\{(x, y): 0<|y|<1,|x| \leq|y|^{-\beta}-|y|\right\}, \quad \beta=\frac{q_{1}}{q_{2}} .
$$

Then

$$
\begin{aligned}
\left\|T_{\gamma} f\right\|_{L^{\vec{q}, \infty}} & =\left\|\chi_{E}\right\|_{L^{\vec{r}}} \\
& \gtrsim\left(\int_{0<|y|<1 / 2}\left(|y|^{-\beta}-1\right)^{n q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \gtrsim\left(\int_{0<|y|<1 / 2}|y|^{-\beta n q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& =\infty
\end{aligned}
$$

and

$$
\begin{aligned}
\|f\|_{L^{\vec{p}, \infty}} & =\sup _{\lambda>0} \lambda \int_{|y|<1}\left(\left|\left\{x:(|x+y|+|x-y|)^{\gamma} \chi_{E}(x, y)>\lambda\right\}\right|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq \sup _{\lambda>0} \lambda\left(\int_{|y|<1}\left|\left\{x:(|x|+|y|) \chi_{E}(x, y)>2^{-1} \lambda^{1 / \gamma}\right\}\right|^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq \sup _{\lambda>0} \lambda\left(\int_{|y|-\beta>2^{-1} \lambda^{1 / \gamma}}|y|^{-\beta n p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, n, \gamma} \sup _{\lambda>0} \lambda \lambda^{n /\left(p_{1} \gamma\right)-n /\left(\beta p_{2} \gamma\right)} .
\end{aligned}
$$

Note

\beta=\frac{q_{1}}{q_{2}}=\frac{n p_{1}}{n p_{2}+p_{1} p_{2} \gamma}
$$

So

\frac{n}{p_{1} \gamma}-\frac{n}{\beta p_{2} \gamma}=-1

Thus we have $f \in L^{\vec{p}, \infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{n}\right)$. Therefore, (3.20) is false is this case.
Next we study the boundedness of $L_{\gamma}$. Observe that

\left\|L_{\gamma} f\right\|_{L^{p_{2}}\left(L^{r, \infty}\right)} & \leq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)},  \tag{3.23}\\
\left\|L_{\gamma} f\right\|_{L^{p_{2}, \infty}\left(L^{r, \infty}\right)} & \leq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} \tag{3.24}
\end{align*}
$$

And for all $0<p_{1}<r \leq \infty$ and $0<p_{2} \leq \infty$ satisfying the homogeneity condition $1 / p_{1}=1 / r+\gamma / n$,

$$
\begin{align*}
\left\|L_{\gamma}^{-1} f\right\|_{L^{p_{2}}\left(L^{r, \infty}\right)} & \geq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}\left(L^{p_{1}, \infty}\right)}}  \tag{3.25}\\
\left\|L_{\gamma}^{-1} f\right\|_{L^{p_{2}, \infty}\left(L^{r, \infty}\right)} & \geq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} \tag{3.26}
\end{align*}
$$

However, for any multiple indices $\vec{p}$ and $\vec{q}$,

\begin{align*}
\left\|L_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}}\right)} & \not \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}}\right)} ;  \tag{3.27}\\
\left\|L_{\gamma} f\right\|_{L^{q_{2}}\left(L^{q_{1}, \infty}\right)} & \not \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)} \text { unless } p_{2}=q_{2} ;  \tag{3.28}\\
\left\|L_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} & \not \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)} \text { unless } p_{2}=q_{2} ;  \tag{3.29}\\
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}} & \not \leq C_{\vec{p}, \vec{q}, n}\|f\|_{L_{\vec{p}}}, \tag{3.30}
\end{align*}
$$

Proof. (i). First, we prove (3.23)-(3.26). As before, the condition $1 / r=1 / p_{1}+\gamma / n$ follows from the homogeneity. Let $h(x, y)=|x-y|^{-\gamma}$. Observe that

\end{equation*}
$$

And for $p_{1}=\infty,\left\|L_{\gamma} f(\cdot, y)\right\|_{L_{x}^{n / \gamma, \infty}} \leq\|f(\cdot, y)\|_{L_{x}^{\infty}}\|h(\cdot, y)\|_{L_{x}^{n / \gamma, \infty}}$. It follows that for all $0<p_{2} \leq \infty$,

$$
\begin{aligned}
\left\|\left\|L_{\gamma} f\right\|_{L_{x}^{r, \infty}}\right\|_{L_{y}^{p_{2}}} & =\| \| L_{\gamma} f\left\|_{L_{x}^{r, \infty}}\right\|_{L_{y}^{p_{2}}} \\
& \lesssim p_{1}, r, n \\
& \leq\| \| f\left\|_{L_{x}^{p_{1}, \infty}}\right\| h\left\|_{L_{x}^{n / \gamma, \infty}}\right\|_{L_{y}^{p_{2}}} \\
& \leq\| \|_{L_{x}^{p_{1}, \infty}}\left\|_{L_{y}^{p_{2}}}\right\|\|h\|_{L_{x}^{n / \gamma, \infty}} \|_{L_{y}^{\infty}} .
\end{aligned}
$$

That is,

$$
\left\|L_{\gamma} f\right\|_{L^{p_{2}}\left(L^{r, \infty}\right)} \leq C_{\vec{p}, r, n}\|f\|_{L^{p_{2}}\left(L^{p_{1}, \infty}\right)}\|h\|_{L^{\infty}\left(L^{n / \gamma, \infty}\right)}
$$

Meanwhile, by Hölder's inequality we also obtain

Furthermore, applying the similar arguments as in the proof of (3.19) we get their reverse versions (3.25) and (3.26).
(ii). Next we prove (3.27).

First, we assume that $p_{2}>q_{2}$. Let $M>0$ and consider

And for $0<\gamma \leq n / q_{1}$, since $p_{2}>q_{2}$, we have $n / q_{1}-\gamma<n / p_{1}$. It follows that

& \left(\int_{\{|x| \leq M\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{1 / p_{1}} \\
& \quad \leq\left(\sum_{2^{j} \leq M} \int_{\left\{x: 2^{j}<|x-y| \leq 2^{j+1}\right\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{1 / p_{1}} \\
& \quad \leq C_{n, \gamma, p_{2}}\left(\sum_{2^{j} \leq M} \frac{2^{j n}}{2^{j\left(n / q_{1}-\gamma\right) p_{1}}}\right)^{1 / p_{1}}<\infty .
\end{aligned}
$$

Hence $\|f\|_{L^{p_{1}, \infty}\left(L^{p_{2}}\right)}<\infty$.
On the other hand, observe that

$$
\left\|L_{\gamma} f\right\|_{L_{x}^{q_{1}}}=\left(\int_{\{|x| \leq M\}} \frac{1}{|x-y|^{n}} d x\right)^{1 / q_{1}}=\infty .
$$

We have $\left\|L_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}}\right)}=\infty$. This proves (3.27) for $p_{2}>q_{2}$.
For the case of $p_{2} \leq q_{2}$, consider

Again, we get $\left\|L_{\gamma} f\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}}\right)}=\infty$ and $\|f\|_{L^{p_{2}, \infty}\left(L^{p_{1}}\right)}<\infty$.

& =\sup _{\alpha>0} \alpha\left|\left\{x:|x-y|<(1 / \alpha)^{p_{1} / n}\right\}\right|^{1 / p_{1}} \chi_{[0,1]}(|y|) \\
& =C_{p_{1}, n} \chi_{[0,1]}(|y|) .
\end{aligned}
$$

On the other hand, we have

$$
\begin{aligned}
\left\|L_{\gamma} f\right\|_{L_{x}^{q_{1}, \infty}} & =\sup _{\alpha>0} \alpha\left|\left\{x:|x-y|^{-n / p_{1}}|x-y|^{-\gamma}>\alpha\right\}\right|^{1 / q_{1}} \chi_{[0,1]}(|y|) \\
& =\sup _{\alpha>0} \alpha(1 / \alpha)^{n p_{1} /\left(n q_{1}+\gamma p_{1} q_{1}\right)} \chi_{[0,1]}(|y|) \\
& =\sup _{\alpha>0} \alpha^{1-n p_{1} /\left(n q_{1}+\gamma p_{1} q_{1}\right)}=\infty, \quad|y|<1,
\end{aligned}
$$

unless

$$
n p_{1} /\left(n q_{1}+\gamma p_{1} q_{1}\right)=1 \text {, i.e., } p_{2}=q_{2} .
$$

(iv). Finally, we prove (3.30). First, we see from the homogeneity that it suffices to consider the case

$$
\frac{1}{q_{1}}+\frac{1}{q_{2}}=\frac{1}{p_{1}}+\frac{1}{p_{2}}+\frac{\gamma}{n} .
$$

There are two cases.
(a) $\left(\gamma-n / q_{1}\right) p_{1}>-n$.

In this case, set

$$
f(x, y)=|x-y|^{\gamma-n / q_{1}} \chi_{\{(x, y):|y| \leq|x| \leq N, 1 \leq|y| \leq 2\}}, \quad N>10 .
$$

If $\left(\gamma-n / q_{1}\right) p_{1} \geq 0$, then

$$
\begin{aligned}
\|f\|_{L_{\vec{p}}} & =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x:|y| \leq|x| \leq N\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(N^{\left(\gamma-n / q_{1}\right) p_{1}+n}\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n} N^{n / q_{2}-n / p_{2}}
\end{aligned}
$$

while

$$
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}}=\left(\int_{\{1 \leq|y| \leq 2\}}\left(\int_{\{x:|y| \leq|x| \leq N\}}|x-y|^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}}=\infty
$$

If $-n<\left(\gamma-n / q_{1}\right) p_{1}<0$, then

$$
\begin{aligned}
\|f\|_{L^{\vec{p}}} & =\left(\int_{\{1 \leq|y| \leq 2\}}\left(\int_{\{x:|y| \leq|x| \leq N\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq\left(\int_{\{1 \leq|y| \leq 2\}}\left(\sum_{2^{j} \leq N} \int_{\left\{x: 2^{j} \leq|x-y| \leq 2^{j+1}\right\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n}\left(\int_{\{1 \leq|y| \leq 2\}}\left(\sum_{2^{j} \leq N} 2^{j n+j\left(\gamma-n / q_{1}\right) p_{1}}\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& <\infty .
\end{aligned}
$$

On the other hand,

$$
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}}=\left(\int_{1 \leq|y| \leq 2}\left(\int_{|y| \leq|x| \leq N}|x-y|^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}}=\infty
$$

(b) $\left(\gamma-n / q_{1}\right) p_{1} \leq-n$.

In this case, we consider the function

$$
f(x, y)=|x-y|^{\gamma-n / q_{1}} \chi_{\{(x, y): 2|y| \leq|x| \leq N, 1 \leq|y| \leq 2\}}, \quad N>10 .
$$

If $\left(\gamma-n / q_{1}\right) p_{1}<-n$, it is not hard to see

$$
\begin{aligned}
\|f\|_{L^{\vec{p}}} & =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}(|x|-|y|)^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \lesssim\langle\vec{p}, \vec{q}, n \\
& \left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left((2|y|)^{\left(\gamma-n / q_{1}\right) p_{1}+n}-N^{\left(\gamma-n / q_{1}\right) p_{1}+n}\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n} .
\end{aligned}
$$

However,

$$
\begin{aligned}
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}} & =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x-y|^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \geq\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}(|x|+|y|)^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}}
\end{aligned}
$$

$$
\begin{aligned}
& \geq C_{\vec{p}, \vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x|^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& =C_{\vec{p}, \vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq 2\}}(\ln N-\ln (2|y|))^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \geq C_{\vec{p}, \vec{q}, n}(\ln N)^{1 / q_{1}} .
\end{aligned}
$$

Letting $N \rightarrow \infty$ we get a contradiction.
If $\left(\gamma-n / q_{1}\right) p_{1}=-n$, then $p_{2}=q_{2}$ and $p_{1}>q_{1}$. We have already obtained

$$
\begin{aligned}
\left\|L_{\gamma} f\right\|_{L^{\vec{q}}} & =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x-y|^{-n} d x\right)^{q_{2} / q_{1}} d y\right)^{1 / q_{2}} \\
& \geq C_{\vec{p}, \vec{q}, n}(\ln N)^{1 / q_{1}} .
\end{aligned}
$$

On the other hand, in this case

$$
\begin{aligned}
\|f\|_{L^{\vec{p}}} & =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x-y|^{\left(\gamma-n / q_{1}\right) p_{1}} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& =\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x-y|^{-n} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}(|x|-|y|)^{-n} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq 2\}}\left(\int_{\{x: 2|y| \leq|x| \leq N\}}|x|^{-n} d x\right)^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& =C_{\vec{p}, \vec{q}, n}\left(\int_{\{y: 1 \leq|y| \leq 2\}}(\ln N-\ln (2|y|))^{p_{2} / p_{1}} d y\right)^{1 / p_{2}} \\
& \leq C_{\vec{p}, \vec{q}, n}(\ln N)^{1 / p_{1}} .
\end{aligned}
$$

Note $p_{1}>q_{1}$. By letting $N \rightarrow \infty$, we get a contradiction.
At the end of this paper, we show that Theorem 3.4 implies the classical Hardy-Littlewood-Sobolev inequality and its reverse version as follows.

Corollary 3.8 For $1<p_{1}, p_{2}<\infty$ with $1 / p_{1}+1 / p_{2}>1$,

$$
\begin{equation*}
\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f(x) g(y)|x-y|^{-n\left(2-1 / p_{1}-1 / p_{2}\right)} d x d y \leq C_{\vec{p}, n}\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}} \tag{3.32}
\end{equation*}
$$

holds for all nonnegative functions $f \in L^{p_{1}}, g \in L^{p_{2}}$.
For $0<p_{1}, p_{2}<1$ and all nonnegative functions $f \in L^{p_{1}}, g \in L^{p_{2}}$,

$$
\begin{equation*}
\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f(x) g(y)|x-y|^{n\left(1 / p_{1}+1 / p_{2}-2\right)} d x d y \geq C_{\vec{p}, n}\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}} . \tag{3.33}
\end{equation*}
$$

Proof. It is known that the Hardy-Littlewood-Sobolev inequality and the reverse Hardy-Littlewood-Sobolev inequality are equivalent [18]. It suffices to show one of them is true. Below show that Theorem 3.4 implies (3.33).

Denote $\gamma=n / p_{1}+n / p_{2}-2 n$. It follows from Theorem 3.4 that

$$
\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{q_{2}, \infty}\left(L^{q_{1}, \infty}\right)} \geq C_{\vec{p}, \vec{q}, n}\|(f \otimes g)\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}
$$

holds for all $0<p_{1} \leq q_{1} \leq \infty$ and $0<p_{2} \leq q_{2} \leq \infty$ satisfying $1 / p_{1}+1 / p_{2}=1 / q_{1}+1 / q_{2}+$ $\gamma / n$. Hence for all $0<p_{1}, p_{2} \leq 1$ with $1 / p_{1}+1 / p_{2}=2+\gamma / n$,

$$
\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1}\left(L^{1}\right)} \geq\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1, \infty}\left(L^{1, \infty}\right)} \geq C_{\vec{p}, n}\|f \otimes g\|_{L^{p_{2}, \infty}\left(L^{p_{1}, \infty}\right)}
$$

holds, which gives

$$
\begin{equation*}
\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1}\left(L^{1}\right)} \geq C_{\vec{p}, n}\|f\|_{L^{p_{1}, \infty}}\|g\|_{L^{p_{2}, \infty}} . \tag{3.34}
\end{equation*}
$$

As said in (3.15), by interpolation, we have for all $0<p_{1}<r<p_{2} \leq \infty$,

$$
\begin{equation*}
\|f\|_{r} \leq C_{\vec{p}, r}\|f\|_{p_{1}, \infty}^{\theta}\|f\|_{p_{2}, \infty}^{1-\theta}, \tag{3.35}
\end{equation*}
$$

where

$$
\frac{1}{r}=\frac{\theta}{p_{1}}+\frac{1-\theta}{p_{2}} .
$$

It follows from (3.34) that for all $0<s_{1}, s_{2}, t_{1}, t_{2} \leq 1$ satisfying $1 / s_{1}+1 / t_{1}=1 / s_{2}+1 / t_{2}=$ $2+\gamma / n$,

$$
\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1}\left(L^{1}\right)} \geq C_{\gamma, n}\|f\|_{L^{s_{1}, \infty},}\|g\|_{L^{t_{1}, \infty}}
$$

and

$$
\left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1}\left(L^{1}\right)} \geq C_{\gamma, n}\|f\|_{s_{2}, \infty}\|g\|_{L^{t_{2}, \infty}} .
$$

We choose $s_{1}, s_{2}, t_{1}, t_{2}$ such that

$$
\frac{1}{p_{1}}=\frac{\theta}{s_{1}}+\frac{1-\theta}{s_{2}}, \quad 0<\theta<1 .
$$

Then

$$
\frac{1}{p_{2}}=2+\frac{\gamma}{n}-\frac{1}{p_{1}}=\frac{\theta}{t_{1}}+\frac{1-\theta}{t_{2}} .
$$

Therefore, we see from (3.35) that

$$
\begin{align*}
& \left\|T_{\gamma}^{-1}(f \otimes g)\right\|_{L^{1}\left(L^{1}\right)}=\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f(x) g(y)(|x+y|+|x-y|)^{n\left(1 / p_{1}+1 / p_{2}-2\right)} d x d y \\
& \quad \geq C_{\vec{p}, n}\|f\|_{L^{s_{1}, \infty}}\|f\|_{L^{s_{2}, \infty}}^{1-\theta}\|g\|_{L^{t_{1}, \infty}}^{\theta}\|g\|_{L^{t_{2}, \infty}}^{1-\theta} \\
& \quad \geq C_{\vec{p}, n}\|f\|_{L^{p_{1}}}\|g\|_{L^{p_{2}}} . \tag{3.36}
\end{align*}
$$

Let $f^{*}$ and $g^{*}$ be the symmetric decreasing rearrangements of $f$ and $g$, respectively. We see from the rearrangement inequality [22, Theorem 3.7] that

$$
\int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f(x) g(y)|x-y|^{n\left(1 / p_{1}+1 / p_{2}-2\right)} d x d y
$$

$$
\begin{aligned}
& \geq \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f^{*}(x) g^{*}(y)|x-y|^{n\left(1 / p_{1}+1 / p_{2}-2\right)} d x d y \\
& =\frac{1}{2} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f^{*}(x) g^{*}(y)\left(|x-y|^{n\left(1 / p_{1}+1 / p_{2}-2\right)}+|x+y|^{n\left(1 / p_{1}+1 / p_{2}-2\right)}\right) d x d y \\
& \geq C_{\vec{p}, n} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} f^{*}(x) g^{*}(y)(|x+y|+|x-y|)^{n\left(1 / p_{1}+1 / p_{2}-2\right)} d x d y \\
& \geq C_{\vec{p}, n}\left\|f^{*}\right\|_{L^{p_{1}}}\left\|g^{*}\right\|_{L^{p_{2}}},
\end{aligned}
$$

where we use (3.36) in the last step. This together with the fact that

$$
\|f\|_{L^{p_{1}}}=\left\|f^{*}\right\|_{L^{p_{1}}} \quad \text { and } \quad\|g\|_{L^{p_{2}}}=\left\|g^{*}\right\|_{L^{p_{2}}}
$$

gives (3.33).
