# ISOMORPHISMS OF GRADED PATH ALGEBRAS 

JASON GADDIS


#### Abstract

We prove that if two path algebras with homogeneous relations are isomorphic as algebras, then they are isomorphic as graded path algebras. This extends a result by Bell and Zhang in the connected case.


Given a family of (noncommutative) algebras, the isomorphism problem is to determine under what conditions there exists an isomorphism between two members of that family. See [1, 2, 3, 6, 7, 8, 10, 12.

In this note, we study the isomorphism problem for path algebras of quivers modulo homogeneous relations. Such algebras appear naturally in the study of (twisted) Calabi-Yau algebras [4, 5, 1, 13, 14. In particular, we show that any isomorphism between two such algebras reduces to an isomorphism that respects the path-length filtration.

Throughout, $\mathbb{k}$ is a field, all algebras are $\mathbb{k}$-algebras, and $\operatorname{dim}=\operatorname{dim}_{\mathbb{k}}$. An algebra $A$ is $\mathbb{N}$-graded if it has a $\mathbb{k}$-vector space decomposition $A=\bigoplus_{n=0}^{\infty} A_{n}$ such that $A_{m} \cdot A_{n} \subset A_{m+n}$. Suppose $B$ is another $\mathbb{N}$-graded algebra with decomposition $B=\bigoplus_{n=0}^{\infty} B_{n}$. We say $A$ and $B$ are isomorphic as graded algebras if there exists an algebra isomorphism $\phi: A \rightarrow B$ such that $\phi\left(A_{n}\right)=B_{n}$. The next theorem is a powerful tool in the study of isomorphism problems for graded algebras.
Theorem (Bell, Zhang [2, Theorem 0.1]). Let $A$ and $B$ be two connected graded algebras finitely generated over $\mathbb{k}$ in degree 1 . If $A \cong B$ as ungraded algebras, then $A \cong B$ as graded algebras.

A quiver $Q=\left(Q_{0}, Q_{1}\right)$ is a directed graph where $Q_{0}$ is the set of vertices and $Q_{1}$ is the set of arrows. We assume throughout that $\left|Q_{0}\right|,\left|Q_{1}\right|<\infty$. For $a \in Q_{1}$, we denote by $s(a)$ and $t(a)$ the source and target of $a$, respectively. The $(u, v)$-entry of the adjacency matrix $M_{Q}$ of $Q$ records the number of arrows from vertex $u$ to vertex $v$. A path in $Q$ is a collection of arrows $p=a_{0} a_{1} \cdots a_{n}$ such that $s\left(a_{k}\right)=t\left(a_{k-1}\right)$ for $k=1, \ldots, n$. In this case, $s(p)=s\left(a_{0}\right)$ and $t(p)=t\left(a_{n}\right)$. The path $p$ is said to be a cycle if $s(p)=t(p)$. Note that the number of paths in $Q$ from vertex $u$ to vertex $v$ of length $\ell$ is the $(u, v)$-entry of $\left(M_{Q}\right)^{\ell}$.

At each vertex $v \in Q_{0}$ there is a trivial path $e_{v}$ with $s\left(e_{v}\right)=t\left(e_{v}\right)=v . \quad$ A quiver is a semigroup under the operation of concatenation. That is, given paths $p=a_{0} a_{1} \cdots a_{n}$ and $q=b_{0} b_{1} \cdots b_{m}, p \cdot q=a_{0} \cdots a_{n} b_{0} \cdots b_{m}$ if $s(q)=t(p)$ and $p \cdot q=0$ otherwise. The path algebra $\mathbb{k} Q$ is the set of finite linear combinations of paths with multiplication extended linearly and identity element $1=\sum_{v \in Q_{0}} e_{v}$. This implies that the trivial paths form a complete set of orthogonal idempotents.

If $\mathfrak{I}$ is an ideal of $\mathbb{k} Q$ generated by elements of homogeneous path length at least one, then $A=\mathbb{k} Q / \mathfrak{I}$ has the structure of an $\mathbb{N}$-graded algebra when we assign $\operatorname{deg}(a)=1$ for all $a \in Q_{1}$. We say the ideal $\mathfrak{I}$ is homogeneous if it is generated

[^0]by homogeneous elements. However, this grading ignores some of a path algebra's most significant structural properties. Suppose $p \in \mathfrak{I}$ is a homogeneous relation in path length. Then we decompose $p$ as $p=\sum_{u, v \in Q_{0}} e_{u} p e_{v}$ where each summand $e_{u} p e_{v} \in \mathfrak{I}$. It will be convenient in this exposition to regard an element $r \in \mathbb{k} Q$ as homogeneous if all summands of $r$ have the same (path) length, source, and target.

Remark 1. If $\mathfrak{I}$ is a homogeneous ideal of $\mathbb{k} Q$ with a degree zero relation, then necessarily $\mathfrak{I}$ contains $e_{v}$ for some trivial path $e_{v}$. Furthermore, $\mathfrak{I}$ contains any path passing through vertex $v$. Then $\mathbb{k} Q / \mathfrak{I} \cong \mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ where $Q^{\prime}$ is obtained from $Q$ by removing vertex $v$ and any path through it, and $\mathfrak{I}^{\prime}$ is the induced ideal on $\mathbb{k} Q^{\prime}$. Similarly, if $\mathfrak{I}$ contains a degree one relation from vertex $u$ to vertex $v$, then we may replace $Q$ by a quiver $Q^{\prime}$ wherein we remove one of the nonzero summands of that relation. Henceforth, we assume that homogeneous ideals $\mathfrak{I}$ of a path algebra $\mathbb{k} Q$ contain no degree zero or degree one relations.

Let $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ with $\mathfrak{I}, \mathfrak{I}^{\prime}$ homogeneous ideals. Set $\left(A_{k}\right)_{u v}$ to be the paths of length $k$ (modulo relations in $\mathfrak{I}$ ) from vertex $u$ to vertex $v$. Thus, we record $\operatorname{dim} A_{k}$ as a $\left(\left|Q_{0}\right| \times\left|Q_{0}\right|\right)$-matrix where the values of $\left(\operatorname{dim} A_{k}\right)_{u v}$ are $\operatorname{dim}\left(\left(A_{k}\right)_{u v}\right)$ and similarly for $B$. We say $A$ and $B$ are isomorphic as graded path algebras if $M_{Q^{\prime}}=P M_{Q} P^{-1}$ for some permutation matrix $P$ corresponding to $\sigma \in \mathcal{S}_{\left|Q_{0}\right|}$ and there exists an algebra isomorphism $\phi: A \rightarrow B$ such that $\phi\left(\left(A_{k}\right)_{u v}\right)=$ $\left(B_{k}\right)_{\sigma(u) \sigma(v)}$. In Theorem 团, we prove that if two graded path algebras $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ are isomorphic as (ungraded algebras), then they are isomorphic as graded path algebras. Theorem 8 reduces to [2, Theorem 0.1] when $\left|Q_{0}\right|=1$.

If $J$ is a not necessarily homogeneous ideal in $A$ with $\left|Q_{0}\right|=n$, then we write $\operatorname{dim} A / J=I_{n}$ when the induced map $A_{0} \rightarrow A / J$ given by $A_{0}=\mathbb{k} e_{1}+\cdots+\mathbb{k} e_{n}$ is an isomorphism. We write $\operatorname{dim} J / J^{2}=S$ where $S$ is an $n \times n$ matrix in which $S_{u v}=\operatorname{dim}\left(\left(e_{u} J e_{v}+J^{2}\right) / J^{2}\right)$.

Definition 2. Let $A=\mathbb{k} Q / \mathfrak{I}$ with $\mathfrak{I}$ homogeneous, $\left|Q_{0}\right|=n$, and let $S$ be an $n \times n$ matrix with entries in $\mathbb{N}$. An ideal $J$ of $A$ with the property $\operatorname{dim} A / J=I_{n}$ and $\operatorname{dim} J / J^{2}=S$ is a codimension $I_{n}$ ideal of tangent dimension $S$. Let $J_{S}(A)$ be the intersection of all such ideals in $A$. If this intersection is empty, then we set $J_{S}(A)=A$.

The irrelevant ideal of $A=\mathbb{k} Q / \mathfrak{I}$, generated by the image of $Q_{1}$ in $A$, is denoted $A_{+}$. Note that $A_{+}$is necessarily a codimension $I_{n}$ ideal of tangent dimension $M_{Q}$.

Given two matrices $S, S^{\prime} \in M_{n}(\mathbb{N})$, we say $S>S^{\prime}$ if $S_{u v} \geq S_{u v}^{\prime}$ for all $u, v$ and there exists $u_{0}, v_{0}$ such that $S_{u_{0} v_{0}}>S_{u_{0} v_{0}}^{\prime}$.

Next we generalize [2, Lemma 5] to the case of path algebras.
Lemma 3. Let $A=\mathbb{k} Q / \mathfrak{I}$ with $\mathfrak{I}$ homogeneous and set $M=M_{Q}$. If $S_{u v}>M_{u v}$ for some $u, v \in Q_{0}$, then $J_{S}(A)=A$ and if $\operatorname{dim} A_{+} /\left(A_{+}\right)^{2}=N$, then $J_{N}(A) \subset A_{+}$.

Proof. Let $\left\{a_{k}^{u v}\right\}$ be a set of algebra generators of $A$, where $u, v$ denotes the source and target of each particular generator. Here $u$ and $v$ range over $Q_{0}$ while $k$ ranges from 1 to $M_{u v}$.

Now if $J$ is an ideal of codimension $I_{n}$, then $J$ is generated by $\left\{x_{k}^{u v}\right\}$ where

$$
x_{k}^{u v}= \begin{cases}a_{k}^{u v} & \text { if } u \neq v \\ a_{k}^{u u}-\alpha_{k}^{u u} e_{u} & \text { if } u=v\end{cases}
$$

with $\alpha_{k}^{u u} \in \mathbb{k}$. Hence $A$ is generated by $\left\{x_{k}^{u v}\right\}$ and $J^{2}$ is generated by $\left\{x_{k}^{u v} x_{\ell}^{v w}\right\}$. It follows that $\left(\operatorname{dim}\left(J / J^{2}\right)\right)_{u v} \leq M_{u v}$ and so $\operatorname{dim} J / J^{2} \leq M$.

We will retain the notation $\left\{a_{k}^{u v}\right\}$ used in the previous lemma throughout.
For a homomorphism $\phi: A \rightarrow B$ of $\mathbb{N}$-graded algebras, we denote by $\phi_{k}(a)$ the degree $k$ component of the image $\phi(a)$. Part of the next lemma generalizes [11, Lemma 3.2].

Lemma 4. Let $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ with $\mathfrak{I}, \mathfrak{I}^{\prime}$ homogeneous ideals. If $\phi: A \rightarrow B$ is an isomorphism, then $\left|Q_{0}\right|=\left|Q_{0}^{\prime}\right|$ and $M_{Q^{\prime}}=P M_{Q} P^{-1}$ for some permutation matrix $P$.

Proof. Let $M=M_{Q}$ and $N=M_{Q^{\prime}}$. Suppose $\left|Q_{0}\right|=n$ (resp. $\left|Q_{0}^{\prime}\right|=m$ ) and denote the trivial orthogonal idempotents of $\mathbb{k} Q$ (resp. $\mathbb{k} Q^{\prime}$ ) by $e_{1}, \ldots, e_{n}$ (resp. $\left.f_{1}, \ldots, f_{m}\right)$. Suppose

$$
\phi\left(e_{u}\right)=\sum \alpha_{u v} f_{v}+\text { (higher degree paths) }
$$

where $\alpha_{u v} \in \mathbb{k}$. Then

$$
\sum \alpha_{u v} f_{v}=\phi_{0}\left(e_{1}\right)=\phi_{0}\left(e_{1}^{2}\right)=\sum_{v} \alpha_{u v}^{2} f_{v}
$$

Thus, each $\alpha_{u v}=0$ or 1 . By the grading on $A$, and because $\mathfrak{I}$ is homogeneous, it follows that at least one of the $\alpha_{u v}$ must be nonzero.

If $u \neq w$, then $0=\phi_{0}\left(e_{u} e_{w}\right)=\sum \alpha_{u v} \alpha_{w v} f_{v}$. Since there are no degree zero relations in $\mathfrak{I}$ or $\mathfrak{I}^{\prime}$, then $\phi_{0}\left(e_{u}\right)$ and $\phi_{0}\left(e_{v}\right)$ have no common nonzero summands amongst the $f_{v}$. Hence, $n \leq m$ and by considering $\phi^{-1}$ we have $m \leq n$, so $n=m$. That is, $\phi_{0}$ determines a permutation $\sigma$ on the vertices of $Q$ so that $\phi_{0}\left(e_{u}\right)=f_{\sigma(u)}$. After renumbering vertices, we may assume that $\sigma=\mathrm{id}$.

Let $a \in Q_{1}$ with source $u$ and target $v$. By the above,

$$
\begin{equation*}
\phi\left(e_{u}\right)=f_{u}+b_{1}+\cdots+b_{\ell} \tag{1}
\end{equation*}
$$

for some $b_{i} \in\left(B_{+}\right)^{i}$. Then

$$
\phi(a)=\phi\left(e_{u} a\right)=\left(f_{u}+b_{1}+\cdots+b_{\ell}\right) \phi(a)
$$

Write $\phi(a)=\phi_{0}(a)+\cdots+\phi_{d}(a)$ with $\phi_{d}(a) \neq 0$. If $b_{\ell} \phi_{d}(a) \neq 0$, then it has degree $d+\ell$, a contradiction. It follows by induction that $b_{i} \phi_{d}(a)=0$ for all $i$. Thus, $f_{u} \phi_{d}(a)=\phi_{d}(a)$. Suppose $b_{i} \phi_{k}(a)=0$ for all $i$ and some $k, 0<k \leq d$. Then $f_{u} \phi_{k}(a)=\phi_{k}(a)$. Moreover, $b_{\ell} \phi_{k-1}(a)$ has degree $\ell+k-1 \geq k$ if it is nonzero, implying $b_{\ell} \phi_{k-1}(a)=0$. As before we can now conclude that $b_{i} \phi_{k-1}(a)=0$ for all $i$. Induction again implies that $f_{u} \phi(a)=\phi(a)$. Similarly, $\phi(a) f_{v}=\phi(a)$.

Since $\phi$ is an isomorphism, then $J=\phi\left(A_{+}\right)$is a codimension $I_{n}$ ideal of $B$. By the previous paragraph, $M_{u v}=\operatorname{dim}\left(\left(f_{u} J f_{v}+J^{2}\right) / J^{2}\right)$ and so by Lemma 3, $M_{u v} \leq N_{u v}$ for all $u, v$. Reversing the argument we get $N_{u v} \leq M_{u v}$, so $N=M$.

Not every isomorphism $\phi: A \rightarrow B$ of graded path algebras necessarily takes vertices to vertices. For example, there is an automorphism $\phi$ of the quiver

defined by $\phi\left(e_{1}\right)=e_{1}+a, \phi\left(e_{2}\right)=e_{2}-a$, and $\phi(a)=a$. However, it follows from Lemma 4 that we may assume that, after reordering vertices, $\phi\left(e_{u}\right)=f_{u}$ for all $u \in Q_{0}$.

The next lemma proves the main theorem for quivers without loops.

Lemma 5. Let $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ with $\mathfrak{I}, \mathfrak{I}^{\prime}$ homogeneous ideals generated in degree at least two. Suppose $Q$ and $Q^{\prime}$ have no loops. If $A \cong B$ as (ungraded) algebras, then $A \cong B$ as graded path algebras.
Proof. By Lemma 4. $M_{Q^{\prime}}=P M_{Q} P^{-1}$ for some permutation matrix $P$. After renumbering vertices we may assume $M=M_{Q}=M_{Q^{\prime}}$. Let $\phi: A \rightarrow B$ be the given (ungraded) isomorphism. Denote by $e_{1}, \ldots, e_{n}$ (resp. $f_{1}, \ldots, f_{n}$ ) the trivial idempotents of $\mathbb{k} Q$ (resp. $\left.\mathbb{k} Q^{\prime}\right)$. For each $1 \leq u, v \leq\left|Q_{0}\right|$, let $\left\{x_{k}^{u v}\right\}$ (resp. $\left\{y_{k}^{u v}\right\}$ ) denote the subset of generators of $A_{1}$ (resp. $B_{1}$ ) that lie in $e_{u} A_{1} e_{v}$ (resp. $f_{u} B_{1} f_{v}$ ).

The proof of Lemma 4 asserts that if $a \in Q_{1}$ has source $u$ and target $v$, then for every $k$ we have that $\phi_{k}(a)$ is a linear combination of paths with source $u$ and target $v$. In particular, $f_{u} \phi_{0}(a)=\phi_{0}(a)=\phi_{0}(a) f_{v}$. If $u=v$, then $\phi_{0}(a)=\alpha f_{u}$ for some $\alpha \in \mathbb{k}$. If $u \neq v$, then $\phi_{0}(a)=0$. An identical argument may be applied to $\phi^{-1}$.

Set $J=\phi\left(A_{+}\right)$and $K=\phi^{-1}\left(B_{+}\right)$. Since $B_{+}$is generated as an ideal by the $\left\{y_{k}^{u v}\right\}$, then by the grading on $B$,

$$
B_{+} /\left(B_{+}\right)^{2}=\bigoplus_{u, v \in Q_{0}} \bigoplus_{k=1}^{M_{u v}} \mathbb{k} \overline{y_{k}^{u v}}
$$

As $K$ is a codimension $I_{n}$ ideal of tangent dimension $M$, then by a linear change of variable,

$$
K_{u v}= \begin{cases}e_{u} A\left(x_{1}^{u v}, \ldots, x_{M_{u v}}^{u v}\right) A e_{v} & \text { if } u \neq v \\ e_{u} A\left(x_{1}^{u u}, \ldots, x_{M_{u u}}^{u u_{u}}-\alpha_{u} e_{u}\right) A e_{u} & \text { if } u=v\end{cases}
$$

for some $\alpha_{u} \in \mathbb{k}$ and

$$
\left(K / K^{2}\right)_{u v}= \begin{cases}\bigoplus_{k=1}^{M_{u v}} \mathbb{k} \overline{x_{k}^{u v}} & \text { if } u \neq v \\ \bigoplus_{k=1}^{M_{u u}} \mathbb{k} \overline{x_{k}^{u u}} \oplus \mathbb{k} \overline{x_{M_{u u}}^{u u}-\alpha_{u} e_{u}} & \text { if } u=v\end{cases}
$$

Thus, $\phi$ induces a $\mathbb{k}$-linear isomorphism $\bar{\phi}: K / K^{2} \rightarrow B_{+} /\left(B_{+}\right)^{2}$.
Set

$$
\begin{aligned}
& \mathcal{X}=\left\{x_{k}^{u v}: u \neq v \text { or }\left(u=v \text { and } k \neq M_{u u}\right)\right\} \\
& \mathcal{Y}=\left\{y_{k}^{u v}: u \neq v \text { or }\left(u=v \text { and } k \neq M_{u u}\right)\right\} .
\end{aligned}
$$

Similarly, we let $\mathcal{X}^{c}=\left\{x_{M_{u u}}^{u u}\right\}$ and $\mathcal{Y}^{c}=\left\{y_{M_{u u}}^{u u}\right\}$. After reordering vertices and a linear change of variable, there exists $\left(y_{k}^{u v}\right)^{\prime} \in\left(B_{+}\right)^{2}$ such that

$$
\phi\left(x_{k}^{u v}\right)= \begin{cases}y_{k}^{u v}+\left(y_{k}^{u v}\right)^{\prime} & \text { if } x_{k}^{u v} \in \mathcal{X}  \tag{2}\\ \alpha_{u} f_{u}+y_{k}^{u v}+\left(y_{k}^{u v}\right)^{\prime} & \text { otherwise }\end{cases}
$$

In case $\alpha_{u}=0$ for some $u$, then there will be no loss in assuming $x_{M_{u u}}^{u u} \in \mathcal{X}$ and $y_{M_{u u}}^{u u} \in \mathcal{Y}$. Suppose $\alpha_{u}=0$ for all $u \in Q_{0}$. Then $J \subset B_{+}$and because $J$ has codimension $I_{n}$ we have $J=B_{+}$. Thus, $\phi$ induces a graded algebra isomorphism from $\operatorname{gr}_{A_{+}} A:=\bigoplus_{i=0}^{\infty}\left(A_{+}\right)^{i} /\left(A_{+}\right)^{i+1}$ to $\operatorname{gr}_{B_{+}} B:=\bigoplus_{i=0}^{\infty}\left(B_{+}\right)^{i} /\left(B_{+}\right)^{i+1}$, which maps $e_{u} \mapsto f_{u}$. Since $A \cong \operatorname{gr}_{A_{+}} A$ and $B \cong \operatorname{gr}_{B_{+}} B$ as graded algebras.

The proof [2, Theorem 1] relied heavily on the use of commutators. Before proving the general theorem, we modify this technique for use in path algebras.

Keep the notation introduced in Lemma 5. Let $p$ be a path from vertex $u$ to vertex $v$ and note that we allow $u=v$ here. Suppose $p$ contains some $a_{w} \in \mathcal{X}^{c}$ at a
vertex $w$ and write $p=p_{1} a_{w} p_{2}$ for paths $p_{1}, p_{2}$ where $s\left(p_{1}\right)=u, t\left(p_{1}\right)=s\left(p_{2}\right)=w$, and $t\left(p_{2}\right)=v$. We call a term of the form $a_{u} p_{1}-p_{1} a_{w}$ a $(u, w)$-commutator and denote it $\left[p_{1}\right]$. Note that there is no ambiguity in this notation because for each vertex there is at most one loop in $\mathcal{X}^{c}$ at that vertex. Moreover, $u$ and $w$ correspond to the source and target, respectively, of $p_{1}$. Assume there is a loop $a_{u} \in \mathcal{X}^{c}$ at vertex $u$. Then

$$
\begin{equation*}
p=\left(p_{1} a_{w}-a_{u} p_{1}\right) p_{2}+a_{u} p_{1} p_{2}=a_{u} p_{1} p_{2}-\left[p_{1}\right] . \tag{3}
\end{equation*}
$$

We can also build iterative $(u, w)$-commutators of the form $\left[\cdots\left[\left[p_{1}\right]\right] \cdots\right]$. Let $[\mathcal{X}]$ (resp. $[\mathcal{Y}]$ ) denote the vector space of iterative commutators of elements in $\mathcal{X}$ (resp. $\mathcal{Y})$ including trivial commutators, i.e., elements of $\mathcal{X}$.

Lemma 6. Let $p$ be a path in the $\left\{x_{k}^{u v}\right\}$ of degree $d$ with source $u$ and target $v$. Suppose there exists $a_{u} \in \mathcal{X}^{c}$ with source $u$. Then $p=\sum_{s=0}^{d} a^{s} p_{s}$ with $p_{s} \in[\mathcal{X}]$.

Proof. We may assume that $p$ contains a loop in $\mathcal{X}^{c}$ since otherwise the result is trivial. Write $p=p_{1} a_{u_{1}}^{k_{1}} p_{2} a_{u_{2}}^{k_{2}} \cdots p_{\ell} a_{u_{\ell}}^{k_{\ell}} p_{\ell+1}$ where each $p_{i} \in \mathcal{X}, a_{u_{i}} \in \mathcal{X}^{c}$, and $k_{i} \in \mathbb{N}$. Note that we allow $p_{1}$ and $p_{\ell+1}$ to be trivial but assume that all other $p_{i}$ are nontrivial.

Consider the case $\ell=1$ and write $p=p_{1} a_{w}^{k} p_{2}$ for some $p_{1}, p_{2} \in[\mathcal{X}]$. If $k=0$ then there is nothing to prove. Assume the conclusion holds for some $k \geq 0$. Applying (3) we have

$$
p=p_{1} a_{w}^{k+1} p_{2}=\left(a_{u} p_{1}-a_{u} p_{1}+p_{1} a_{w}\right) a_{w}^{k} p_{2}=\left(a_{u} p_{1}-\left[p_{1}\right]\right) a_{w}^{k} p_{2}
$$

Now we may apply the inductive hypothesis to $p_{1} a_{w}^{k} p_{2}$ and $\left[p_{1}\right] a_{w}^{k} p_{2}$.
Returning to the main result, assume the conclusion holds for some $\ell \geq 1$. Suppose $p=p_{1} a_{u_{1}}^{k_{1}} p_{2} a_{u_{2}}^{k_{2}} \cdots p_{\ell} a_{u_{\ell+1}}^{k_{\ell+1}} p_{\ell+2}$. Let $d^{\prime}$ be the degree of the path $p_{1} a_{u_{1}}^{k_{1}} p_{2} a_{u_{2}}^{k_{2}} \cdots p_{\ell}$. Then by the inductive hypothesis and after relabeling we have

$$
p=\left(\sum_{s=0}^{d^{\prime}} a_{u}^{s} \tilde{p}_{s}\right) a_{u_{\ell+1}}^{k_{\ell+1}} p_{\ell+2}
$$

for some $\tilde{p}_{s} \in[\mathcal{X}]$. Applying the previous induction to each $\tilde{p}_{s} a_{u_{\ell+1}}^{k_{\ell+1}} p_{\ell+2}$ gives the result.

In Lemma 5, we considered the case where $\alpha_{u}=0$ for all $u$. Next we consider the other extreme, where $\alpha_{u} \neq 0$ for all $u$.

Lemma 7. Let $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ with $\mathfrak{I}, \mathfrak{I}^{\prime}$ homogeneous ideals generated in degree at least two. Suppose for every vertex $u \in Q_{0}, x_{M_{u u}}^{u u} \in \mathcal{X}^{c}$. If $A \cong B$ as (ungraded) algebras, then $A \cong B$ as graded path algebras.

Proof. We maintain the notation introduced in Lemma 5. In particular, we may assume $M=M_{Q}=M_{Q^{\prime}}$ and that $\phi$ is as in (2).

If for some vertex $u$ we have $\alpha_{u} \neq 0$, then we can replace $x_{M_{u u}}^{u u}$ and $y_{M_{u u}}^{u u}$ by $\alpha_{u}^{-1} x_{M_{u u}}^{u u}$ and $\alpha_{u}^{-1} y_{M_{u u}}^{u u}$, respectively, so that $\phi\left(x_{M_{u u}}^{u u}\right)=f_{u}+y_{M_{u u}}^{u u u}+\left(y_{M_{u u}}^{u u}\right)^{\prime}$ for some $\left(y_{M_{u u}}^{u u}\right)^{\prime} \in\left(B_{+}\right)^{2}$.

Let $p$ be a path with source $u$ and target $w$ consisting of arrows in $\mathcal{X}$. Then $\phi(p)=q+q^{\prime}$ for some path $q$ consisting of arrows in $\mathcal{Y}$ and some $q^{\prime} \in\left(B_{+}\right)^{2}$.

Set $a_{u}=x_{M_{u u}}^{u u}$ (resp. $b_{u}=y_{M_{u u}}^{u u}$ ) and similarly for $a_{w}$ and $b_{w}$. By the above, $\phi\left(a_{u}\right)=f_{u}+b_{u}+b_{u}^{\prime}$ and $\phi\left(a_{w}\right)=f_{w}+b_{w}+b_{w}^{\prime}$ for some $b_{u}^{\prime}, b_{w}^{\prime} \in\left(B_{+}\right)^{2}$. Thus,

$$
\begin{equation*}
\phi([p])-[\phi(p)]=\left(f_{u} \phi(p)-\phi(p) f_{w}\right)+(\text { higher degree terms }) . \tag{4}
\end{equation*}
$$

Hence, if $\operatorname{deg}(p)=d$, then $\phi([p])-[\phi(p)] \in\left(B_{+}\right)^{d+1}$.
More generally, we write $r([\mathcal{X}])$ (resp. $r([\mathcal{Y}])$ ) for a polynomial in the $[\mathcal{X}]$ (resp. $[\mathcal{Y}])$. If $r$ is a homogeneous relation of degree $d$ in the $[\mathcal{X}]$, then by (4),

$$
\begin{equation*}
r([\mathcal{Y}])=r([\mathcal{Y}])-\phi(r([\mathcal{X}])) \in\left(B_{+}\right)^{d+1} \tag{5}
\end{equation*}
$$

Now let $r$ be any homogeneous relation in the $\left\{x_{k}^{u v}\right\}$ of path degree $d$ with source $u$ and target $v$. We claim that $r$ is also a relation in the $\left\{y_{k}^{u v}\right\}$ and hence $\operatorname{dim}\left(A_{d}\right)_{u v}=\operatorname{dim}\left(B_{d}\right)_{u v}$. This claim holds trivially for all $u, v$ when $d=0$ or 1 so assume it holds for all $n<d$.

Let $a_{u} \in \mathcal{X}^{c}$ be a loop at vertex $u$, which exists by hypothesis. By Lemma 6

$$
r=\sum_{s=0}^{d} a_{u}^{s} r_{s}([\mathcal{X}])
$$

where each $r_{s}([\mathcal{X}])$ is a homogeneous polynomial of degree $d-s$ in $[\mathcal{X}]$ with source $u$ and target $v$. Let $t$ be the largest integer for which $r_{t}([\mathcal{X}]) \neq 0$. If $t=0$, then $r$ is a relation in the $[\mathcal{X}]$ and the claim holds by (5). Assume $t>0$ so that

$$
0=\phi(r)=\sum_{s=0}^{t}\left(f_{u}+b_{u}+b_{u}^{\prime}\right)^{s} \phi\left(r_{s}([\mathcal{X}])\right)
$$

where $b_{u}=y_{M_{u u}}^{u u}$ and $b^{\prime} \in\left(B_{+}\right)^{2}$. Then $r_{t}([\mathcal{Y}]) \in\left(B_{+}\right)^{d-t+1}$ and so by homogeneity, $r_{t}([\mathcal{Y}])=0$. This implies that $r_{t}([\mathcal{Y}])$ is a relation of degree $d-t$ from vertex $u$ to vertex $v$ and by our inductive hypothesis, $\operatorname{dim}\left(A_{d-t}\right)_{u v}=\operatorname{dim}\left(B_{d-t}\right)_{u v}$. It follows that there exists a relation $r^{\prime}$ in the $\left\{x_{k}^{u v}\right\}$ of degree $d-t$ from vertex $u$ to vertex $v$ such that $r^{\prime}$ is nonzero in $\left\{y_{k}^{u v}\right\}$. This contradicts our hypothesis and so the claim holds for $n=d$.

Thus, $\operatorname{dim}\left(A_{d}\right)_{u v} \geq \operatorname{dim}\left(B_{d}\right)_{u v}$ for all $d$ and all choices of $u$ and $v$. Applying $\phi^{-1}$ we obtain the reverse inequality and so $\operatorname{dim}\left(A_{d}\right)_{u v}=\operatorname{dim}\left(B_{d}\right)_{u v}$. Hence, the $\operatorname{map} \phi: A \rightarrow B$ given by $\phi\left(x_{k}^{u v}\right)=y_{k}^{u v}$ and $\phi\left(e_{u}\right)=f_{u}$ is a graded path algebra isomorphism.

Our analysis so far has covered the two extreme cases: $\alpha_{u}=0$ for all $u \in Q_{0}$ or $\alpha_{u} \neq 0$ for all $u \in Q_{0}$. We now consider the intermediate case and prove our main theorem.

Theorem 8. Let $A=\mathbb{k} Q / \mathfrak{I}$ and $B=\mathbb{k} Q^{\prime} / \mathfrak{I}^{\prime}$ with $\mathfrak{I}, \mathfrak{I}^{\prime}$ homogeneous ideals generated in degree at least two. If $A \cong B$ as (ungraded) algebras, then $A \cong B$ as graded path algebras.

Proof. We maintain the notation introduced in Lemmas 5 and 7 Let

$$
U=\left\{u \in Q_{0}: \phi_{0}\left(x_{M_{u u}}^{u u}\right)=0\right\}
$$

and let $\bar{Q}$ be the quiver obtained by attaching to $Q$ an additional loop $a_{u}$ at each $u \in U$. The ideal $\mathfrak{I}$ of $\mathbb{k} Q$ extends to an ideal of $\mathbb{k} \bar{Q}$. Define $\bar{A}=\mathbb{k} \bar{Q} / \mathfrak{I}$. We obtain $\overline{Q^{\prime}}$ similarly by attaching a corresponding loop $b_{u}$ to $Q^{\prime}$ for each $u \in U$ and define $\bar{B}=\mathbb{k} \overline{Q^{\prime}} / \mathfrak{I}^{\prime}$.

Note that we still have $\phi: A \rightarrow B$ as in (2). We extend $\phi$ to a map $\bar{\phi}: \bar{A} \rightarrow \bar{B}$ by setting $\bar{\phi}\left(a_{u}\right)=f_{u}+b_{u}$ for each $u \in U$. Then $\bar{\phi}$ preserves the path algebra relations. For example, suppose $\bar{Q}$ has a loop $a_{v}$ at vertex $v \neq u$. Then according to Lemma 4. each summand of $\phi\left(a_{v}\right)$ has source and target $v$. Consequently, $\phi\left(a_{u} a_{v}\right)=$ $\left(f_{u}+b_{u}\right) \phi\left(a_{v}\right)=0$. Moreover, $\bar{\phi}$ (trivially) preserves the generators of $\mathfrak{I}$ so that $\bar{\phi}$ is an isomorphism $\bar{A} \rightarrow \bar{B}$.

In the notation of Lemma 5, let $\overline{\mathcal{X}}$ (resp. $\overline{\mathcal{Y}}$ ) be the set of generators in $\bar{A}$ (resp. $\bar{B}$ ) corresponding to $\mathcal{X}$ (resp. $\mathcal{Y}$ ) in $A$ (resp. $B$ ). Define $\overline{\mathcal{X}}^{c}$ and $\overline{\mathcal{Y}}^{c}$ similarly. Since $\bar{\phi}$ is an extension of $\phi$, then $\overline{\mathcal{X}}=\mathcal{X}$ and $\overline{\mathcal{Y}}=\mathcal{Y}$, while $\overline{\mathcal{X}}^{c}=\mathcal{X}^{c} \cup\left\{a_{u}\right\}_{u \in U}$ and $\overline{\mathcal{Y}}^{c}=\mathcal{Y}^{c} \cup\left\{b_{u}\right\}_{u \in U}$.

By Lemma 7 there is an isomorphism $\psi: \bar{A} \rightarrow \bar{B}$ which maps $x_{k}^{u v} \mapsto y_{k}^{u v}$. That is, $a_{u} \mapsto b_{u}$ for every $u \in U$. Restricting $\psi$ to the generators of $A$, i.e., $\mathcal{X} \cup \mathcal{X}^{c}$, it follows directly that $\psi$ is an isomorphism $\mathbb{k} Q \rightarrow \mathbb{k} Q^{\prime}$. Let $r \in \mathfrak{I}$ be a relation in the $\left\{x_{k}^{u v}\right\}$. The proof of Lemma 7 shows that $r$ is a relation in the $\left\{y_{k}^{u v}\right\}$. By definition, $r$ does not involve those $a_{u}$ with $u \in U$. Hence, restricting $\psi$ as above gives a bijection $\mathfrak{I} \rightarrow \mathfrak{I}^{\prime}$ and so $\psi$ restricts to a graded isomorphism $A \rightarrow B$.

An initial application of Theorem 8 is the Zariski cancellation problem. See [3, 12] for more background on this problem for noncommutative algebras.

Let $Q$ be a quiver with $\left|Q_{0}\right|=n$ and $A=\mathbb{k} Q / \mathfrak{I}$ a graded path algebra. Then the polynomial extension $A[t]$ is again a graded path algebra with adjacency matrix $M_{Q}+I_{n}$. The following theorem is now almost immediate from [2, Theorem 9].

Theorem 9. Let $A$ and $B$ be graded path algebras. Suppose that $\mathcal{Z}(A) \cap A_{1}=\{0\}$. If $A\left[t_{1}, \ldots, t_{n}\right] \cong B\left[s_{1}, \ldots, s_{n}\right]$ as ungraded algebras, then $A \cong B$.

Let $Q$ be the quiver below.


If $\mathfrak{I}=\left(a^{2}-d c, b^{2}-c d\right) \subset \mathbb{k} Q$, then $\mathbb{k} Q / \mathfrak{I} \cong A \# G$ where $A=\mathbb{k}\left\langle u, v: u^{2}-v^{2}\right\rangle$ and $G=\langle g\rangle$ is the cyclic group of order 2 acting on $A$ by $g(u)=u$ and $g(v)=-v$. For $q_{1}, q_{2} \in \mathbb{k}^{\times}$, set $C\left(q_{1}, q_{2}\right)=\mathbb{k} Q /\left(a d-q_{1} d b, c a-q_{2} b c\right)$. Then $C(1,1) \cong B \# G$ where $B=\mathbb{k}[u, v]$ and $G$ acts on $B$ by $g(u)=u$ and $g(v)=-v$. It follows immediately from Theorem 8 that $A \# G \neq B \# G$.

Proposition 10. Let $p_{1}, p_{2}, q_{1}, q_{2} \in \mathbb{k}^{\times}$. Then $C\left(q_{1}, q_{2}\right) \cong C\left(p_{1}, p_{2}\right)$ if and only if there exists $k \in \mathbb{k}^{\times}$such that $\left(p_{1}, p_{2}\right)=\left(k q_{1}, k q_{2}\right)$ or $\left(p_{1}, p_{2}\right)=\left(k q_{1}^{-1}, k q_{2}^{-1}\right)$.

Proof. By Theorem 8, we may assume that there is an isomorphism of graded path algebras $\phi: C\left(q_{1}, q_{2}\right) \rightarrow C\left(p_{1}, p_{2}\right)$. Thus, we have one of the following cases:
(1) $\phi(a)=k_{1} a, \phi(b)=k_{2} b, \phi(c)=k_{3} c, \phi(d)=k_{4} d$,
(2) $\phi(a)=k_{1} b, \phi(b)=k_{2} a, \phi(c)=k_{3} d, \phi(d)=k_{4} c$,
for some $k_{i} \in \mathbb{k}^{\times}$.
Suppose we are in the first case, then

$$
\begin{aligned}
\phi\left(a d-q_{1} d b\right) & =k_{4}\left(k_{1} a d-q_{1} k_{2} d b\right)=k_{4}\left(k_{1} p_{1}-k_{2} q_{1}\right) d b \\
\phi\left(c a-q_{2} b c\right) & =k_{3}\left(k_{1} c a-q_{2} k_{2} b c\right)=k_{3}\left(k_{1} p_{2}-k_{2} q_{2}\right) b c
\end{aligned}
$$

Thus, $p_{i}=\left(k_{2} / k_{1}\right) q_{i}$. The second case is similar.
