SOLUTIONS OF THE BRAID EQUATION WITH SET-TYPE SQUARE

ABSTRACT. For a family of height one orders (X, \leq) and each non-degenerate solution $r_0: X \times X \longrightarrow X \times X$ of the set-theoretic braid equation on X satisfying suitable conditions, we obtain all the non-degenerate solutions of the braid equation on the incidence coalgebra of (X, \leq) that extend r_0 .

Introduction

Let V be a vector space over a field K and let $r: V \otimes_K V \longrightarrow V \otimes_K V$ be a bijective linear operator. We say that r satisfies the *braid equation* if

 $r_{12} \circ r_{23} \circ r_{12} = r_{23} \circ r_{12} \circ r_{23},$

where r_{ij} denotes r acting on the *i*-th and *j*-th coordinates. Since the eighties many solutions of the braid equation have been found, many of them being deformations of the flip. It is interesting to obtain solutions that are not of this type, and in [6], Drinfeld proposed to study the most simple of them, namely, the set-theoretic ones, i.e. pairs (X, r_0) , where X is a set and

$$r_0\colon X\times X\longrightarrow X\times X$$

is an invertible map satisfying the braid equation. Each one of these solutions yields in an evident way a linear solution on the vector space with basis X. From a structural point of view this approach was considered first by Etingof, Schedler and Soloviev [7] and Gateva-Ivanova and Van den Bergh [8] for involutive solutions, and then by Lu, Yan and Zhu [11] and Soloviev [13] for non-degenerate not necessarily involutive solutions. In the last two decades the theory has developed rapidly, and now it is known that it has connections with bijective 1-cocycles, Bierbach groups and groups of I-type, involutive Yang-Baxter groups, Garside structures, biracks, cyclic sets, braces, Hopf algebras, matched pairs, left symmetric algebras, etcetera (see, for instance [1], [4], [3], [2], [5], [9], [12], [14]).

Suppose now that (X, \leq) is a locally finite poset and consider its incidence coalgebra D. We identify each $a \in X$ with the pair (a, a) in D. In [10] the following problem was posed:

Let $r_0: X \times X \longrightarrow X \times X$ be a non-degenerated solution of the set theoretical braid equation. Find necessary and sufficient conditions in order that r_0 is the restriction of a non-degenerate coalgebra automorphism r of $D \otimes D$, which is a solution of the braid equation, and then find all such extensions.

Let $r: D \otimes D \longrightarrow D \otimes D$ be a linear map. For $a \leq b$ and $c \leq d$ write

$$r((a,b)\otimes(c,d)) = \sum_{e\leq f}\sum_{g\leq h}\lambda_{a|b|c|d}^{e|f|g|h}(e,f)\otimes(g,h),\tag{0.1}$$

with $\lambda_{a|b|c|d}^{e|f|g|h} \in K$. Assume that r is a non-degenerate coalgebra automorphism that induces a non-degenerate solution $r_0: X \times X \longrightarrow X \times X$ of the braid equation. In [10, Proposition 4.3] we give the equations that the coefficients $\lambda_{a|b|c|d}^{e|f|g|h}$'s must satisfy in order that r is a solution of the braid equation. In Corollary 2.5 we prove that in fact it suffices to solve a relatively small subset of these equations, corresponding to lower extremal inclusions (see Definition 2.3). For instance, when $X = \{x, y\}$ with x < y, then by [10, Corollary 2.5], necessarily r_0 is the flip and the number of equations we must solve according to [10, Proposition 4.3] is 125. From these 8 are trivially true and 36 are solved by a general result in [10]. Our result shows that it suffices to solve 7 of the remaining 81 equations.

Although the general problem seems to be difficult even with this reduction, the above mentioned result allows us in Section 4 to make significant progress towards the solution of the following problem:

Given r_0 as above, find all the non-degenerate coalgebra automorphisms $r: D \otimes D \longrightarrow D \otimes D$ fulfilling the following conditions: it is a solution of the braid equation, it induces r_0 on $X \times X$ and has settype square up to height 1 (see Definition 3.4), and then determine which ones of these maps have set-type square (see Definition 3.1).

In this section we consider a height 1 poset (X, \leq) with cardinal u + v, having u minimal elements a_0, \ldots, a_{u-1} and v maximal elements b_0, \ldots, b_{v-1} such that $a_i < b_j$ for all i, j. We assume that u and v are coprime, and we consider a nondegenerate bijective set-theoretic solution r_0 of the braid equation on X. Moreover, we also assume that there exist poset automorphisms ϕ_r and ϕ_l of X such that

$$r_0(x,y) = (\phi_l(y), \phi_r(x))$$

and $\phi_r \circ \phi_l$ induces an *uv*-cycle on the set of all the pairs (a_i, b_j) . Our main result is Theorem 4.15, in which we determine all non-degenerate coalgebra automorphisms of $D \otimes D$ with set-type square up to height 1, that are solutions of the braid equation and induce r_0 on $X \times X$. This gives various infinite families of solutions of the braid equation. Finally, in Proposition 4.16, we determine which ones of these solutions have set-type square.

1 Preliminaries

A partially ordered set or poset is a pair (X, \leq) consisting of a set X endowed with a binary relation \leq , called *an order*, that is reflexive, antisymmetric and transitive. A connected component of X is an equivalence class of the equivalence relation generated by the relation $x \sim y$ if x and y are comparable. The *height* of a finite chain $a_0 < \cdots < a_n$ is n. The *height* $\mathfrak{h}(X)$ of a finite poset X is the height of its largest chain. Let $a, b \in X$. The closed interval [a, b] is the set of all the elements c of X such that $a \leq c \leq b$. We say that b covers a, and we write $a \prec b$ (or $b \succ a$), if $[a, b] = \{a, b\}$. A poset X is *locally finite* if [a, b] is finite for all $a, b \in X$.

In the sequel (X, \leq) is a locally finite poset and $Y := \{(a, b) \in X \times X : a \leq b\}$. It is well known that D := KY is a counitary coalgebra, called the *incidence coalgebra* of X, via

$$\Delta(a,b)\coloneqq \sum_{c\in[a,b]}(a,c)\otimes(c,b) \quad \text{and} \quad \epsilon(a,b)=\delta_{ab}.$$

Consider KX endowed with the coalgebra structure determined by requiring that each $x \in X$ is a group like element. The K-linear map $\iota: KX \to D$ defined by $\iota(x) \coloneqq (x, x)$ is an injective coalgebra morphism, whose image is the subcoalgebra of D spanned by its group like elements.

Recall from [7] that a map $r_0: X \times X \longrightarrow X \times X$ is called *non-degenerate* if the maps ${}^{a}(-)$ and $(-)^{b}$ from X to X, defined by $({}^{a}b, a^{b}) \coloneqq r_0(a, b)$ are bijective for all $a, b \in X$.

Let r be a coalgebra automorphism of $D\otimes D$ and let

$$\sigma \coloneqq (D \otimes \epsilon) \circ r \quad \text{and} \quad \tau \coloneqq (\epsilon \otimes D) \circ r.$$

We say that r is *non-degenerate* if the maps

$$(D \otimes \sigma) \circ (\Delta \otimes D)$$
 and $(\tau \otimes D) \circ (D \otimes \Delta)$

are isomorphisms (see [10, Subsection 1.1]).

Let $r: D \otimes D \longrightarrow D \otimes D$ be a linear map and let

$$\left(\lambda_{a|b|c|d}^{e|f|g|h}\right)_{(a,b),(c,d),(e,f),(g,h)\in Y}$$

be as in equality (0.1). In [10, Section 2 and Theorem 3.4] we prove that r is a non-degenerate coalgebra automorphism if and only if it induces by restriction a non-degenerate bijection $r_0: X \times X \longrightarrow X \times X$ and

1) for $a \leq b$ and $c \leq d$,

$$\sum_{e,g} \lambda_{a|b|c|d}^{e|e|g|g} = \delta_{ab} \delta_{cd}; \tag{1.1}$$

- 2) the maps a(-) and $(-)^b$ are automorphisms of posets;
- 3) if a and b belong to the same component of X, then a(-) = b(-) and $(-)^a = (-)^b$;
- 4) if $a \leq b, c \leq d, e \leq f, g \leq h$ and $\lambda_{a|b|c|d}^{e|f|g|h} \neq 0$, then $a^c \leq g \leq h \leq b^c$ and $a_c \leq e \leq f \leq a_d$;

5) if
$$a \leq b, c \leq d \ e \leq f, g \leq h, a^c \leq g \leq h \leq b^c$$
 and ${}^a\!c \leq e \leq f \leq {}^a\!d$, then

$$\lambda_{a|b|c|d}^{e|f|g|h} = \lambda_{a|z^{\bar{c}}|c|^{\bar{a}y}}^{e|y|g|z} \lambda_{z^{\bar{c}}|b|^{\bar{a}y}|d}^{y|f|z|h}$$
(1.2)

for each $y, z \in X$ such that $e \leq y \leq f$ and $g \leq z \leq h$.

By [10, Remark 2.1], we know that $\lambda_{x|x|y|y}^{xy|x^y|y^x} = 1$ for all $x, y \in X$. We will use freely this fact.

2 Factorization of solutions

Let $r: D \otimes D \longrightarrow D \otimes D$ be a non-degenerate coalgebra automorphism that induces a non-degenerate solution $r_0: X \times X \to X \times X$ of the braid equation.

Let $(a, b), (c, d), (e, f), (g, h), (i, j), (k, l) \in Y$ and let

$$T \coloneqq [a, b] \times [c, d] \times [e, f]$$
 and $S \coloneqq [g, h] \times [i, j] \times [k, l].$

We consider $X \times X \times X$ endowed with the product order. Note that S and T are the closed intervals [(g, i, j), (h, k, l)] and [(a, c, e), (b, d, f)] in $X \times X \times X$. Clearly $S \subseteq T$ if and only if

$$[g,h] \subseteq [a,b], \quad [i,j] \subseteq [c,d] \quad \text{and} \quad [k,l] \subseteq [e,f].$$

$$(2.1)$$

Note also that

$$\mathfrak{h}(T)=\mathfrak{h}([a,b])+\mathfrak{h}([c,d])+\mathfrak{h}([e,f]).$$

For $S \subseteq T$ as above we define

In [10, Proposition 4.3] the following result is proved:

Proposition 2.1. The map r is a solution of the braid equation if and only if

$$LBE(S,T) = RBE(S,T) \quad for \ all \ S \subseteq T.$$
 (2.2)

For each $S \coloneqq [(g, i, j), (h, k, l)]$, we set

$$\psi(S) \coloneqq ({}^{gi}k, {}^{gi}l) \otimes ({}^{g^{ik}}i^k, {}^{g^k}j^k) \otimes (g^{ik}, h^{ik}).$$

Let $\mathfrak{T} := (a, b) \otimes (c, d) \otimes (e, f)$. A direct computation shows that

$$(r \otimes D) \circ (D \otimes r) \circ (r \otimes D)(\mathfrak{T}) = \sum_{S \subseteq T} \text{LBE}(S, T) \psi(S)$$

and

$$(D \otimes r) \circ (r \otimes D) \circ (D \otimes r)(\mathfrak{T}) = \sum_{S \subseteq T} \operatorname{RBE}(S, T) \psi(S)$$

(see the proof of [10, Proposition 4.3]). Since $r \otimes D$ and $D \otimes r$ are coalgebra morphisms, this implies that

$$\delta_{ab}\delta_{cd}\delta_{ef} = (\epsilon \otimes \epsilon \otimes \epsilon)(\mathfrak{T}) = \sum_{\substack{S \subseteq T\\\mathfrak{h}(S)=0}} \text{LBE}(S,T), \tag{2.3}$$

and similarly

$$\delta_{ab}\delta_{cd}\delta_{ef} = \sum_{\substack{S \subseteq T \\ \mathfrak{h}(S) = 0}} \text{RBE}(S,T).$$
(2.4)

Assume $S \subseteq T$ and let $(p,q,s) \in S$. We define the splitting of the inclusion $S \subseteq T$ at (p,q,s) as the pair $(S_1 \subseteq T_1, S_2 \subseteq T_2)$, where

$$\begin{split} S_1 &\coloneqq [(g, i, j), (p, q, s)], \\ S_2 &\coloneqq [(p, q, s), (h, k, l)], \end{split} \qquad \begin{array}{ll} T_1 &\coloneqq [(a, c, e), (p, q, s)], \\ T_2 &\coloneqq [(p, q, s), (b, d, f)]. \end{split}$$

Theorem 2.2. The following equalities hold:

$$LBE(S,T) = LBE(S_1,T_1) LBE(S_2,T_2)$$

and

$$RBE(S,T) = RBE(S_1,T_1) RBE(S_2,T_2).$$

Proof. Since by definition we have

$$LBE(S_2, T_2) = \sum_{y \in [h, b]} \sum_{z \in [j, d]} \sum_{v \in [l, f]} \lambda_{p|b|q|d}^{pq|p_z|p^q|yq} \lambda_{p^q|y^q|s|f}^{p_s^q p^q p^q s|p^q l|p_q^{p_s^q}|p_j^{p_s^p}} \lambda_{pq|p_z|p_s^q p_v^{p_s}|p_v^{p_s^q}}^{pq|p_q|p_q^{p_s}|p_j^{p_s^p}},$$

in order to prove the first equality, it suffices to note that, by [10, Proposition 2.10], [10, Corollary 2.5] and [10, Remark 4.2], the equalities

Definition 2.3. We say that an inclusion of intervals $[\alpha, \beta] \subseteq [\gamma, \delta]$ with $\gamma < \delta$ is lower extremal if $\alpha = \beta = \gamma$ and that is upper extremal if $\alpha = \beta = \delta$.

Remark 2.4. Note that $S \subseteq T$ is extremal if either the three inclusions in (2.1) are lower extremal or the three inclusions are upper extremal.

Corollary 2.5. The map r is a solution of the braid equation if and only if identity (2.2) hold for all $S \subseteq T$ lower extremal with $\mathfrak{h}(T) \ge 1$ or S = T and $\mathfrak{h}(T) = 1$.

Proof. By Proposition 2.1 we must show that LBE(S, T) = RBE(S, T) for all $S \subseteq T$. When $\mathfrak{h}(T) = 0$ this is true since $r_0 \colon X \times X \to X \times X$ is a solution of the braid equation, while for n = 1 it is true by hypothesis. Assume now that identity (2.2) hold for $S \subseteq T$ with $\mathfrak{h}(T) \leq n$ for some $n \geq 1$ and set T = [(a, c, e), (b, d, f)] with $\mathfrak{h}(T) = n + 1$. Let $\underline{S} := [(a, c, e), (a, c, e)]$ and $\overline{S} := [(b, d, f), (b, d, f)]$. By the hypothesis, we know that (2.2) is satisfied for $S = \underline{S}$. Moreover, for $S \subseteq T$ with $S \notin \{\underline{S}, \overline{S}\}$ there exists a splitting $(S_1 \subseteq T_1, S_2 \subseteq T_2)$ of $S \subseteq T$ with $\mathfrak{h}(T_1), \mathfrak{h}(T_2) < \mathfrak{h}(T)$. Hence, in this case the result follows by induction on $\mathfrak{h}(T)$, using Theorem 2.2. Finally we have

$$\begin{split} \mathrm{LBE}(\overline{S},T) &= \sum_{\substack{S \subseteq T \\ \mathfrak{h}(S) = 0}} \mathrm{LBE}(S,T) - \sum_{\substack{S \subseteq T, \, S \neq \overline{S} \\ \overline{\mathfrak{h}}(S) = 0}} \mathrm{LBE}(S,T) \\ &= \sum_{\substack{S \subseteq T \\ \mathfrak{h}(S) = 0}} \mathrm{RBE}(S,T) - \sum_{\substack{S \subseteq T, \, S \neq \overline{S} \\ \overline{\mathfrak{h}}(S) = 0}} \mathrm{RBE}(S,T) \\ &= \mathrm{RBE}(\overline{S},T), \end{split}$$

where in the second equality we have used equalities (2.3) and (2.4).

2.1 Braid equation for lower extremal inclusions in height one orders.

Next we analyze exhaustively the meaning of equalities (2.2) when the order has height one, the sum of the lengths of the intervals [a, b], [c, d] and [e, f] is greater than 1 and the inclusions are lower extremal:

Theorem 2.6. Assume that (X, \leq) has height one and that equality (2.2) hold for all $S \subseteq T$ with $\mathfrak{h}(T) = 1$, and $S \subseteq T$ lower extremal or S = T. Then r is a solution of the braid equation if and only if

- for all $a \prec b$, $c \prec d$ and $e \in X$, the equality (2.5) is satisfied,
- for all $a \prec b, c \in X$ and $e \prec f$, the equality (2.6) is satisfied,
- for all $a \in X$, $c \prec d$ and $e \prec f$, the equality (2.7) is satisfied,
- for all $a \prec b$, $c \prec d$ and $e \prec f$, the equality (2.8) is satisfied.

Proof. By Corollary 2.5.

3 Conditions for solutions with set-type square

Let $r: D \otimes D \longrightarrow D \otimes D$ be a non-degenerate coalgebra automorphism and let $r_0: X \times X \longrightarrow X \times X$ be the map induced by r. In the sequel we assume that r_0 is a non-degenerate solution of the set-theoretical braid equation and we set $r^2 \coloneqq r \circ r$ and $Y \otimes Y \coloneqq \{a \otimes b : a, b \in Y\}$.

Definition 3.1. We say that r has set-type square if $r^2(Y \otimes_k Y) \subseteq Y \otimes_k Y$.

Remark 3.2. By [10, Remark 3.1], the map r has set-type square if and only if

$$r^{2}((a,b)\otimes(c,d)) = \left({}^{a_{c}}a^{c}, {}^{a_{c}}b^{c}\right)\otimes\left({}^{a_{c}}a^{c}, {}^{a_{d}}d^{a^{c}}\right),$$
(3.1)

for all $(a, b), (c, d) \in Y$. Consequently, if r has set-type square, then r permutes the elements of $Y \otimes_k Y$.

Remark 3.3. When a = b and c = d, then equality (3.1) holds since r_0 is a solution of the set-theoretical braid equation.

Definition 3.4. We say that r has set-type square up to height 1 if equality (3.1) holds for all the $(a, b), (c, d) \in Y$ with $\mathfrak{h}([a, b]) + \mathfrak{h}([c, d]) = 1$.

Let $(a, b), (c, d), (e, f), (g, h) \in Y$ and let

$$T \coloneqq [a, b] \times [c, d] \quad \text{and} \quad S \coloneqq [e, f] \times [g, h]. \tag{3.2}$$

We consider $X \times X$ endowed with the product order. Note that S and T are the closed intervals [(e,g), (f,h)] and [(a,c), (b,d)] in $X \times X$. Clearly $S \subseteq T$ if and only if

$$[e, f] \subseteq [a, b]$$
 and $[g, h] \subseteq [c, d]$.

Note also that $\mathfrak{h}(T) = \mathfrak{h}([a, b]) + \mathfrak{h}([c, d])$. For $S \subseteq T$ as above we define

$$\operatorname{LSQ}(S,T) \coloneqq \sum_{\substack{x \in [a,e] \\ y \in [f,b]}} \sum_{\substack{w \in [c,g] \\ z \in [h,d]}} \lambda_{a|b|c|d}^{aw|a_z|x^c|y^c} \lambda_{aw|a_z|x^c|y^c}^{awec|a_wf^c|a_gx^c|a_hx^c}$$

and

$$\mathrm{RSQ}(S,T) \coloneqq \delta_{ae} \delta_{bf} \delta_{cg} \delta_{dh}$$

Let $\mathfrak{V} \coloneqq (a, b) \otimes (c, d)$. Applying twice [10, Corollary 2.9], we obtain

$$r^{2}(\mathfrak{V}) = \sum_{\substack{[x,y] \subseteq [a,b] \\ [w,z] \subseteq [c,d] \\ [g,h] \subseteq [w,z]}} \sum_{\substack{[a,f] \subseteq [x,y] \\ [w,z] \subseteq [c,d] \\ [g,h] \subseteq [w,z]}} \lambda^{^{a}w|^{a}z|x^{c}|y^{c}}_{a|w|^{a}z|x^{c}|y^{c}} \lambda^{^{a}we^{c}|^{a}w}_{a|w|^{a}z|x^{c}|y^{c}} {}^{(awe^{c}, awf^{c})} \otimes {agx^{c}, ahx^{c}}.$$

Consequently, since by [10, Corollary 2.5]

$$\binom{{}^{a}w}{e^{c}}, {}^{a}wf^{c} \otimes \binom{{}^{a}g^{x^{c}}}{a}h^{x^{c}} = \binom{{}^{a}c}{e^{c}}, {}^{a}cf^{c} \otimes \binom{{}^{a}g^{a^{c}}}{a}h^{a^{c}},$$

we have

$$r^{2}(\mathfrak{V}) = \sum_{S \subseteq T} \mathrm{LSQ}(S, T)\phi(S), \qquad (3.3)$$

where for $S \coloneqq [e, f] \times [g, h]$ we set $\phi(S) \coloneqq ({}^{a_c}e^c, {}^{a_c}f^c) \otimes ({}^{a}g^{a^c}, {}^{a}h^{a^c})$. Since r^2 is a coalgebra morphism, this implies that

$$\delta_{ab}\delta_{cd} = (\epsilon \otimes \epsilon)(\mathfrak{V}) = \sum_{\substack{S \subseteq T \\ \mathfrak{h}(S) = 0}} \mathrm{LSQ}(S,T).$$

Let $S \subseteq T$ and let $(p,q) \in S$. We define the splitting of the inclusion $S \subseteq T$ at (p,q) as the pair $(S_1 \subseteq T_1, S_2 \subseteq T_2)$, where

$$\begin{split} S_1 &\coloneqq [(e,g),(p,q)], \\ S_2 &\coloneqq [(p,q),(f,h)], \end{split} \qquad \begin{array}{ll} T_1 &\coloneqq [(a,c),(p,q)], \\ T_2 &\coloneqq [(p,q),(b,d)]. \end{split}$$

Note that

$$\operatorname{RSQ}(S,T) = \operatorname{RSQ}(S_1,T_1)\operatorname{RSQ}(S_2,T_2)$$
(3.4)

for each splitting of $S \subseteq T$.

Proposition 3.5. Equality (3.1) is true for $(a, b) \otimes (c, d)$ if and only if

$$LSQ(S,T) = RSQ(S,T) \qquad for \ all \ S \subseteq T, \tag{3.5}$$

where $T \coloneqq [a, b] \times [c, d]$.

Proof. Since the map

$$(e,f) \otimes (g,h) \mapsto \left({}^{ac}e^{c}, {}^{ac}f^{c}\right) \otimes \left({}^{a}g^{a^{c}}, {}^{a}h^{a^{c}}\right)$$

is injective, the result follows comparing coefficients in equalities (3.1) and (3.3). \Box

Proposition 3.6. Let $S \subseteq T$, $(p,q) \in S$ and let $((S_1,T_1), (S_2,T_2))$ be the splitting of $S \subseteq T$ at (p,q). The following equality hold:

$$LSQ(S,T) = LSQ(S_1,T_1) LSQ(S_2,T_2)$$

Proof. Since, by definition

$$LSQ(S,T) = \sum_{\substack{x \in [a,e] \\ y \in [f,b] \\ z \in [h,d]}} \sum_{\substack{w \in [c,g] \\ z \in [h,d]}} \lambda_{a|b|c|d}^{aw|^{a}z|x^{c}|y^{c}} \lambda_{aw|^{a}z|x^{c}|y^{c}}^{aw e^{c}|^{aw} f^{c}|^{a}g^{x^{c}}|^{a}h^{x^{c}}},$$

$$LSQ(S_{1},T_{1}) = \sum_{x \in [a,e]} \sum_{w \in [c,g]} \lambda_{a|p|c|q}^{aw|^{a}q|x^{c}|p^{c}} \lambda_{aw|^{a}q|x^{c}|p^{c}}^{aw e^{c}|^{a}w f^{c}|^{a}g^{x^{c}}|^{a}q^{x^{c}}}$$

and

$$\mathrm{LSQ}(S_2, T_2) = \sum_{y \in [f,b]} \sum_{z \in [h,d]} \lambda_{p|b|q|d}^{pq|^p |z|p^q|y^q} \lambda_{pq|^{p_2}|p^q|y^q}^{p_q p^q|^{p_q} f^q|^{p_q} p^q|^{p_h} p^q},$$

in order to prove the first equality, it suffices to note that, by [10, Proposition 2.10] and [10, Corollary 2.5], the equalities

hold.

As in Definition 2.3 we say that $[\alpha, \beta] \subseteq [\gamma, \delta]$ with $\gamma < \delta$ is lower extremal if $\alpha = \beta = \gamma$ and that it is upper extremal if $\alpha = \beta = \delta$.

Corollary 3.7. The following assertions hold:

- (1) The map r has set-type square up to height 1 if and only if the equality LSQ(S,T) = RSQ(S,T) is true for all $S \subseteq T$ such that $\mathfrak{h}(T) = 1$, and S = T or $S \subseteq T$ is lower extremal.
- (2) The map r has set-type square if and only if it has set-type square up to height 1 and LSQ(S,T) = RSQ(S,T) for all $S \subseteq T$ lower extremal, such that $\mathfrak{h}(T) \geq 2$.

Proof. Mimic the proof of Corollary 2.5 using equality (3.4) and Proposition 3.6. \Box

For the rest of the section we will assume that (X, \leq) is connected.

Remark 3.8. By [10, Corollary 2.5] there exist order automorphisms ϕ_l and ϕ_r of X such that

$$^{b}a = \phi_{l}(a)$$
 and $a^{b} = \phi_{r}(a)$ for all $a, b \in X$.

Moreover, since $r_0: X \times X \longrightarrow X \times X$ is a solution of the set-theoretic braid equation, ϕ_l and ϕ_r commute. Consequently, r has set-type square if and only if

$$r^{2}((a,b)\otimes(c,d)) = (\varphi(a),\varphi(b))\otimes(\varphi(c),\varphi(d)) \text{ for all } (a,b),(c,d)\in Y,$$

where $\varphi \coloneqq \phi_l \circ \phi_r$.

Notation 3.9. For all $s, a, b, c, d \in X$ with $a \prec b, c \prec d$ and $i \in \mathbb{Z}$, we will write

$$s^{(i)} \coloneqq \phi_r^i(s), \qquad \qquad {}^{(i)}s \coloneqq \phi_l^i(s), \qquad (3.6)$$

$$\alpha_r(s)(a,b) \coloneqq \lambda_{a|b|s|s}^{(1)s|(1)s|a^{(1)}|b^{(1)}}, \qquad \beta_r(s)(a,b) \coloneqq \lambda_{a|b|s|s}^{(1)s|(1)s|a^{(1)}|a^{(1)}}, \qquad (3.7)$$

$$\alpha_l(s)(a,b) \coloneqq \lambda_{s|s|a|b}^{(1)a|(1)b|s^{(1)}|s^{(1)}}, \qquad \beta_l(s)(a,b) \coloneqq \lambda_{s|s|a|b}^{(1)a|s^{(1)}|s^{(1)}|s^{(1)}}, \qquad (3.8)$$

$$\Gamma_{a|b|c|d} \coloneqq \lambda_{a|b|c|d}^{(1)c|(1)c|a^{(1)}|a^{(1)}}.$$

Proposition 3.10. The map r has set-type square up to height 1 if and only if for all $a \prec b$ and $c \in X$

$$\alpha_r(c)(a,b)\alpha_l({}^{(1)}c)(a^{(1)},b^{(1)}) = 1, \qquad (3.10)$$

$$\alpha_r(c)(a,b)\beta_l({}^{(1)}c)(a{}^{(1)},b{}^{(1)}) + \beta_r(c)(a,b) = 0, \qquad (3.11)$$

$$\alpha_l(c)(a,b)\alpha_r(c^{(1)})({}^{(1)}a,{}^{(1)}b) = 1, \qquad (3.12)$$

and

$$\alpha_l(c)(a,b)\beta_r(c^{(1)})({}^{(1)}a,{}^{(1)}b) + \beta_l(c)(a,b) = 0.$$
(3.13)

 $\begin{array}{l} \textit{Proof. When } a \prec b, \, e = a, \, f = b \text{ and } c = d = g = h, \, \text{equality (3.5) becomes} \\ \lambda_{a|b|c|c}^{^{(1)}c|^{(1)}c|^{(1)}b^{(1)}} \lambda_{^{(1)}c|^{(1)}c|^{(1)}b^{(1)}}^{^{(1)}b^{(1)}|^{(1)}c^{(1)}} = 1, \end{array}$

which coincides with equality (3.10). Similarly, when
$$a = b = e = f$$
, $c \prec d$, $c = d$
and $g = h$, equality (3.5) reduce to equality (3.12). On the other hand, when
 $e = f = a \prec b$ and $c = d = g = h$ equality (3.5) gives

Corollary 3.11. If *r* has set-type square up to height 1, then $\alpha_h({}^{(1)}c^{(1)})({}^{(1)}a^{(1)}, {}^{(1)}b^{(1)}) = \alpha_l(c)(a, b)$ and $\beta_h({}^{(1)}c^{(1)})({}^{(1)}a^{(1)}, {}^{(1)}b^{(1)}) = \beta_h(c)(a, b),$ for $h \in \{r, l\}, a \prec b$ in *X* and $c \in X$.

Proof. We only consider the case h = l since the case h = r is similar. By equalities (3.10) and (3.12),

$$\alpha_l({}^{(1)}c^{(1)})({}^{(1)}a^{(1)},{}^{(1)}b^{(1)}) = \frac{1}{\alpha_r(c^{(1)})({}^{(1)}a,{}^{(1)}b)} = \alpha_l(c)(a,b),$$

which proves the first equality, and by equalities (3.11), (3.12) and (3.13),

$$\beta_l({}^{(1)}c^{(1)})({}^{(1)}a^{(1)},{}^{(1)}b^{(1)}) = \alpha_l(c)(a,b)\alpha_r(c^{(1)})({}^{(1)}a,{}^{(1)}b)\beta_l({}^{(1)}c^{(1)})({}^{(1)}a^{(1)},{}^{(1)}b^{(1)})$$

$$= -\alpha_l(c)(a,b)\beta_r(c^{(1)})({}^{(1)}a,{}^{(1)}b)$$

= $\beta_l(c)(a,b),$

which proves the second equality.

We will need the following result that complements [10, Proposition 4.5].

Proposition 3.12. Item 6) of [10, Subsection 4.1] is satisfied if and only if for all $a \prec b$ in X there exists a constant $C_m(a, b) \in K^{\times}$ such that

$$\frac{\alpha_l(s^{(1)})(a^{(1)}, b^{(1)})}{\alpha_l(s)(a, b)} = \frac{\alpha_r({}^{(1)}t)({}^{(1)}a, {}^{(1)}b)}{\alpha_r(t)(a, b)} = C_m(a, b),$$

for all $s, t \in X$.

Proof. Mimic the proof of [10, Proposition 4.5(1)].

Remark 3.13. By items 1)–4) of [10, Proposition 4.5] and Proposition 3.12, if r is a solution of the braid equation, then necessarily

$$\alpha_r(s)(a,b) = \alpha_r({}^{(1)}s{}^{(1)})(a,b), \qquad \alpha_l(s)(a,b) = \alpha_l({}^{(1)}s{}^{(1)})(a,b), \qquad (3.14)$$

$$\beta_r(s)(a,b) = \beta_r({}^{(1)}s{}^{(1)})(a,b), \qquad \beta_l(s)(a,b) = \beta_l({}^{(1)}s{}^{(1)})(a,b), \qquad (3.15)$$

and for all $a \prec b$ there exist constants $C_r(a, b)$, $C_l(a, b)$ and $C_m(a, b)$ such that

$$C_r(a,b) = \frac{\alpha_r(s^{(1)})(a^{(1)}, b^{(1)})}{\alpha_r(s)(a,b)} \quad \text{for all } s,$$
(3.16)

$$C_l(a,b) = \frac{\alpha_l({}^{(1)}s)({}^{(1)}a,{}^{(1)}b)}{\alpha_l(s)(a,b)} \quad \text{for all } s,$$
(3.17)

and

$$C_m(a,b) = \frac{\alpha_l(s^{(1)})(a^{(1)},b^{(1)})}{\alpha_l(s)(a,b)} = \frac{\alpha_r({}^{(1)}t)({}^{(1)}a,{}^{(1)}b)}{\alpha_r(t)(a,b)} \quad \text{for all } s \text{ and } t.$$
(3.18)

Assume now that r has set-type square up to height 1. Then, by Corollary 3.11,

$$C_r(a,b)C_m(a,b) = \frac{\alpha_r(s^{(1)})(a^{(1)},b^{(1)})}{\alpha_r(s)(a,b)} \frac{\alpha_r(a^{(1)}s^{(1)})(a^{(1)},a^{(1)},b^{(1)})}{\alpha_r(s^{(1)})(a^{(1)},b^{(1)})} = 1$$

and, similarly, $C_l(a, b)C_m(a, b) = 1$. So, $C_r(a, b) = C_m(a, b)^{-1} = C_l(a, b)$.

Proposition 3.14. Assume that (X, \leq) has height 1. If r has set-type square up to height 1, then r has set-type square if and only if

$$\frac{\alpha_{l}(a)(c,d)}{\alpha_{l}({}^{(1)}c)(a^{(1)},b^{(1)})}\Gamma_{{}^{(1)}c|{}^{(1)}d|a^{(1)}|b^{1})} = -\Gamma_{a|b|c|d} - \frac{\beta_{l}(b)(c,d)\beta_{l}({}^{(1)}c)(a^{(1)},b^{(1)})}{\alpha_{l}({}^{(1)}c)(a^{(1)},b^{(1)})} - \frac{\beta_{l}(a)(c,d)\beta_{l}({}^{(1)}d)(a^{(1)},b^{(1)})}{\alpha_{l}({}^{(1)}d)(a^{(1)},b^{(1)})},$$
(3.19)

for all $a, b, c, d \in X$ with $a \prec b$ and $c \prec d$.

Proof. By Corollary 3.7(2) and the definition of RSQ(S,T), we must show that the hypothesis in the statement is equivalent to the fact that LSQ(S,T) = 0 for all $T := [a, b] \times [c, d]$ with $a \prec b$ and $c \prec d$ and $S \subseteq T$ lower extremal. By the very definition of LSQ(S,T), we have

$$\begin{split} \mathrm{LSQ}(S,T) &= \lambda_{a|b|c|d}^{(1)}{}$$

$$\begin{split} &+ \lambda_{a|b|c|d}^{(1)c|(1)} d^{(1)}|b^{(1)}} \lambda_{(1)c|(1)d|a^{(1)}|(1)c^{(1)}|^{(1)}c^{(1)}|^{(1)}c^{(1)}} \\ &= \Gamma_{a|b|c|d} + \lambda_{a|b|c|d}^{(1)c|(1)c|a^{(1)}|b^{(1)}} \beta_l ({}^{(1)}c) (a^{(1)}, b^{(1)}) \\ &+ \lambda_{a|b|c|d}^{(1)c|(1)d|a^{(1)}|a^{(1)}} \beta_r (a^{(1)}) ({}^{(1)}c, {}^{(1)}d) + \lambda_{a|b|c|d}^{(1)c|(1)d|a^{(1)}|b^{(1)}} \Gamma_{(1)c|(1)d|a^{(1)}|b^{(1)}}, \end{split}$$

where the last equality follows from the definitions of Γ , β_l and β_r . Since, by (1.2) and the fact that the maps a(-) and $(-)^b$ are automorphisms of posets,

$$\begin{split} \lambda_{a|b|c|d}^{(1)c|(1)c|a^{(1)}|b^{(1)}} &= \lambda_{a|b|c|c}^{(1)c|(1)c|a^{(1)}|b^{(1)}} \lambda_{b|b|c|d}^{(1)c|(1)c|a^{(1)}|b^{(1)}} = \alpha_r(c)(a,b)\beta_l(b)(c,d) \\ \lambda_{a|b|c|d}^{(1)c|(1)d|a^{(1)}|a^{(1)}} &= \lambda_{a|a|c|d}^{(1)c|(1)d|a^{(1)}|a^{(1)}} \lambda_{a|b|d|d}^{(1)d|a^{(1)}|a^{(1)}} = \alpha_l(a)(c,d)\beta_r(d)(a,b) \end{split}$$

and

$$\lambda_{a|b|c|d}^{(1)c|(1)d|a^{(1)}|b^{(1)}} = \lambda_{a|b|c|c}^{(1)c|(1)c|a^{(1)}|b^{(1)}} \lambda_{b|b|c|d}^{(1)c|(1)d|b^{(1)}|b^{(1)}} = \alpha_r(c)(a,b)\alpha_l(b)(c,d),$$

we obtain

$$\begin{split} \mathrm{LSQ}(S,T) &= \Gamma_{a|b|c|d} + \alpha_r(c)(a,b)\beta_l(b)(c,d)\beta_l(^{(1)}c)(a^{(1)},b^{(1)}) \\ &+ \alpha_l(a)(c,d)\beta_r(d)(a,b)\beta_r(a^{(1)})(^{(1)}c,^{(1)}d) \\ &+ \alpha_r(c)(a,b)\alpha_l(b)(c,d)\Gamma_{^{(1)}c|^{(1)}d|a^{(1)}|b^{(1)}} \\ &= \Gamma_{a|b|c|d} + \frac{\beta_l(b)(c,d)\beta_l(^{(1)}c)(a^{(1)},b^{(1)})}{\alpha_l(^{(1)}c)(a^{(1)},b^{(1)})} \\ &+ \frac{\alpha_l(a)(c,d)\beta_l(^{(1)}d)(a^{(1)},b^{(1)})\beta_l(^{(1)}a^{(1)})(^{(1)}c^{(1)},^{(1)}d^{(1)})}{\alpha_l(^{(1)}d)(a^{(1)},b^{(1)})\alpha_l(^{(1)}a^{(1)})(^{(1)}c^{(1)},^{(1)}d^{(1)})} \\ &+ \frac{\alpha_l(a)(c,d)}{\alpha_l(^{(1)}c)(a^{(1)},b^{(1)})}\Gamma_{^{(1)}c|^{(1)}d|a^{(1)}|b^{(1)}} \\ &= \Gamma_{a|b|c|d} + \frac{\beta_l(b)(c,d)\beta_l(^{(1)}c)(a^{(1)},b^{(1)})}{\alpha_l(^{(1)}c)(a^{(1)},b^{(1)})} \\ &+ \frac{\beta_l(a)(c,d)\beta_l(^{(1)}d)(a^{(1)},b^{(1)})}{\alpha_l(^{(1)}d)(a^{(1)},b^{(1)})} + \frac{\alpha_l(a)(c,d)}{\alpha_l(^{(1)}c)(a^{(1)},b^{(1)})}\Gamma_{^{(1)}c|^{(1)}d|a^{(1)}|b^{(1)}}, \end{split}$$

where the second equality holds by Proposition 3.10; and the third one, by Corollary 3.11. Hence LSQ(S,T) = 0 if and only if equality (3.19) is true.

Corollary 3.15. If (X, \leq) has height 1, then r has set-type square if and only if equalities (3.10)–(3.19) are fulfilled.

Proof. This follows immediately from Propositions 3.5, 3.10 and 3.14.

4 A family of examples

In this section we assume that $u, v \in \mathbb{N}$ are coprime and for each $l \in \mathbb{N}$ we set $\mathbb{N}_l := \{0, \ldots, l-1\}$. Define on the set

$$X = \{a_0, \dots, a_{u-1}, b_0, \dots, b_{v-1}\}$$

the partial order $a_i < b_j$ for all i, j. For the rest of the paper we assume that each element of K^{\times} has uv distinct uv-th roots, and we fix a primitive uv-th root of unity w.

Let $\phi_r, \phi_l \colon X \to X$ be two commuting poset automorphisms and let

$$r_0: X \times X \longrightarrow X \times X$$

be the map defined by $r_0(x, y) := (\phi_l(y), \phi_r(x))$. It is well-known that r_0 is a nondegenerate solution of the braid equation. Moreover, by definition, ${}^x(-) = \phi_l$ and $(-)^x = \phi_r$ for all x.

Since ϕ_l and ϕ_r are poset automorphisms there exist permutations σ_a , τ_a of \mathbb{N}_u , and σ_b , τ_b of \mathbb{N}_v such that

$$\phi_l(a_i) = a_{\sigma_a(i)}, \quad \phi_l(b_j) = b_{\sigma_b(j)}, \quad \phi_r(a_i) = a_{\tau_a(i)} \quad \text{and} \quad \phi_r(b_j) = b_{\tau_b(j)}.$$
 (4.1)

Note that $\sigma_a \circ \tau_a = \tau_a \circ \sigma_a$ and $\sigma_b \circ \tau_b = \tau_b \circ \sigma_b$ because ϕ_r and ϕ_l commute. From now on we assume that $\varsigma_a := \sigma_a \circ \tau_a$ is an *u*-cycle and $\varsigma_b := \sigma_b \circ \tau_b$ is an *v*-cycle. Since gcd(u, v) = 1 from this it follows that the map $(i, j) \mapsto (\varsigma_a(i), \varsigma_b(j))$ is an *uv*-cycle.

Let $r: D \otimes D \longrightarrow D \otimes D$ be a non-degenerate coalgebra automorphism that has set-type square up to height 1 and induces r_0 by restriction.

Proposition 4.1. If r satisfies the braid equation, then

$$\begin{aligned}
\alpha_{l}(a_{i})(a_{k},b_{l}) &= \alpha_{l}(a_{0})(a_{0},b_{0}), & \alpha_{r}(a_{i})(a_{k},b_{l}) &= \alpha_{r}(a_{0})(a_{0},b_{0}), \\
\alpha_{l}(b_{j})(a_{k},b_{l}) &= \alpha_{l}(b_{0})(a_{0},b_{0}), & \alpha_{r}(b_{j})(a_{k},b_{l}) &= \alpha_{r}(b_{0})(a_{0},b_{0}), \\
\beta_{l}(a_{i})(a_{k},b_{l}) &= \beta_{l}(a_{0})(a_{0},b_{0}), & \beta_{r}(a_{i})(a_{k},b_{l}) &= \beta_{r}(a_{0})(a_{0},b_{0}), \\
\beta_{l}(b_{j})(a_{k},b_{l}) &= \beta_{l}(b_{0})(a_{0},b_{0}), & \beta_{r}(b_{j})(a_{k},b_{l}) &= \beta_{r}(b_{0})(a_{0},b_{0}), \end{aligned}$$
(4.2)

for all i, j, k and l.

Proof. Since $\varphi = \phi_l \circ \phi_r$ acts as an *u*-cycle on $\{a_0, \ldots, a_{u-1}\}$ and as an *v*-cycle on $\{b_0, \ldots, b_{v-1}\}$ and gcd(u, v) = 1, this follows by Corollary 3.11 and equalities (3.14) and (3.15).

In the sequel we assume that equalities (4.2) are fulfilled. For the sake of simplicity, from now on we write

$\alpha_{la} \coloneqq \alpha_l(a_0)(a_0, b_0),$	$\alpha_{ra} \coloneqq \alpha_r(a_0)(a_0, b_0),$
$\alpha_{lb} \coloneqq \alpha_l(b_0)(a_0, b_0),$	$\alpha_{rb} \coloneqq \alpha_r(b_0)(a_0, b_0),$
$\beta_{la} \coloneqq \beta_l(a_0)(a_0, b_0),$	$\beta_{ra} \coloneqq \beta_r(a_0)(a_0, b_0),$
$\beta_{lb} \coloneqq \beta_l(b_0)(a_0, b_0),$	$\beta_{rb} \coloneqq \beta_r(b_0)(a_0, b_0).$

By equalities (4.2) and Proposition 3.10,

$$\alpha_{ra} = \alpha_{la}^{-1}, \quad \alpha_{rb} = \alpha_{lb}^{-1}, \quad \beta_{ra} = -\beta_{la}\alpha_{la}^{-1} \quad \text{and} \quad \beta_{rb} = -\beta_{lb}\alpha_{lb}^{-1}. \tag{4.3}$$

Combining this with equality (1.2) we obtain that

$$\alpha_{la}^2 = \alpha_{lb}^2. \tag{4.4}$$

Remark 4.2. Let $C_r(a_i, b_j)$, $C_l(a_i, b_j)$ and $C_m(a_i, b_j)$ be as in Remark 3.13. By equalities (4.2), we know that $C_r(a_i, b_j) = C_l(a_i, b_j) = C_m(a_i, b_j) = 1$ for all i and j.

Notation 4.3. Set $\alpha \coloneqq \alpha_{la}$, $\beta_a \coloneqq \beta_{la}$, $\beta_b \coloneqq \beta_{lb}$ and $\Gamma_{i|j|k|l} \coloneqq \Gamma_{a_i|b_j|a_k|b_l}$.

Remark 4.4. By equalities (4.3) and equality (4.4) there exists $\varepsilon \in \{\pm 1\}$ such that the following equalities hold:

$$\alpha_{lb} = \varepsilon \alpha, \quad \alpha_{ra} = \frac{1}{\alpha}, \quad \alpha_{rb} = \frac{\varepsilon}{\alpha}, \quad \beta_{ra} = -\frac{\beta_a}{\alpha} \quad \text{and} \quad \beta_{rb} = -\frac{\varepsilon \beta_b}{\alpha}.$$
(4.5)

Proposition 4.5. Let ε , α , β_a and β_b be as above. Equality (2.2) holds for all $S \subseteq T$ such that $\mathfrak{h}(T) \leq 1$ if and only if

$$\beta_b(\alpha - 1) = \beta_a(\varepsilon \alpha - 1). \tag{4.6}$$

Proof. By [10, Proposition 4.5], Proposition 3.12 and the discussion in [10, Subsection 4.1] we know that equality (2.2) is satisfied for all $S \subseteq T$ such that $\mathfrak{h}(T) \leq 1$ if and only if the conditions in [10, Proposition 4.5], Proposition 3.12 and item 5) of [10, Subsection 4.1] are fulfilled.

Let w be a fixed primitive uv-root of unity and let ℓ_j , \wp_j , γ_r and γ_l be as in items 3) and 4) of [10, Proposition 4.5]. By Remark 4.2, we can take $\gamma_l = \gamma_r = 1$ and $\ell_j = \wp_j = 1$.

Assume that equality (2.2) hold for all $S \subseteq T$ such that $\mathfrak{h}(T) \leq 1$. By item 4) of [10, Proposition 4.5] we know that, for all i,

$$\left(\alpha_{la} - w^i, \sum_{j=0}^{uv-1} w^{ij} \beta_{la}\right) \sim \left(\alpha_{lb} - w^i, \sum_{j=0}^{uv-1} w^{ij} \beta_{lb}\right).$$
(4.7)

Taking i = 0 and using equalities (4.5), we obtain

$$(\alpha - 1, uv\beta_a) \sim (\varepsilon \alpha - 1, uv\beta_b)$$

which is equivalent to equality (4.6).

Conversely, assume that (4.6) holds. By equalities (4.2), in order to check that equality (2.2) is satisfied for all $S \subseteq T$ such that $\mathfrak{h}(T) \leq 1$ it suffices to verify item 5) of [10, Subsection 4.1] and that, for each $0 \leq i < uv$,

$$\left(\alpha_{ra} - w^{i}, \sum_{j=0}^{v-1} w^{ij} \beta_{ra}\right) \sim \left(\alpha_{rb} - w^{i}, \sum_{j=0}^{v-1} w^{ij} \beta_{rb}\right),\tag{4.8}$$

and

$$\left(\alpha_{la} - w^i, \sum_{j=0}^{\nu-1} w^{ij} \beta_{la}\right) \sim \left(\alpha_{lb} - w^i, \sum_{j=0}^{\nu-1} w^{ij} \beta_{lb}\right).$$
(4.9)

When $i \neq 0$, the second coordinate of all the vectors in (4.8) and (4.9) vanishes, so conditions (4.8) and (4.9) hold. When i = 0, the computation above shows that (4.9) is equivalent to (4.6), and similarly (4.8) is equivalent to (4.6). Finally, item 5) of [10, Subsection 4.1] holds if and only if

$$\beta_{li} + \alpha_{li}\beta_{rj} = \beta_{rj} + \alpha_{rj}\beta_{li} \quad \text{for all } i, j \in \{a, b\}.$$

But these equalities follow from a straightforward computation using (4.6).

Remark 4.6. Since $\varepsilon = \pm 1$ and $\alpha \neq 0$, equality (4.6) yields the following possible cases for the values of α , β_a and β_b :

- 1) If $\varepsilon = 1$, then $\alpha = 1$ or $\beta_a = \beta_b$.
- 2) If $\varepsilon = -1$ and char $K \neq 2$, then either $\alpha = 1$ and $\beta_a = 0$, or $\alpha \neq 1$ and $\beta_b = \beta_a \frac{1+\alpha}{1-\alpha}$.

In the expression $\Gamma_{i|j|k|l}$ the indices *i* and *k* belong to $\{0, \ldots, v-1\}$ and the indices *j* and *l* belong to $\{0, \ldots, u-1\}$. So, the first ones can be affected by the maps σ_a or τ_a , while the second one, by the maps σ_b or τ_b . Since there is not danger of confusion, we will write $\Gamma_{\tau_i|\tau_j|\tau_k|\tau_l}$ instead of $\Gamma_{\tau_a(i)|\tau_b(j)|\tau_a(k)|\tau_b(l)}$, etcetera.

Proposition 4.7. Let α , β_a and β_b be as in Notation 4.3. Recall that by Remark 4.4 there exists $\varepsilon \in \{\pm 1\}$ such that equalities (4.5) are satisfied. Then equalities (2.5)–(2.8) hold if and only if for all $i, k, m \in \{0, \ldots, u-1\}$ and $j, l, n \in \{0, \ldots, v-1\}$ the following equalities are fulfilled:

$$\alpha^{3}\Gamma_{i|j|k|l} - \alpha\Gamma_{\tau_{i}|\tau_{j}|\tau_{k}|\tau_{l}} = \beta_{a}(1 - \varepsilon\alpha)(\beta_{a} + \alpha\beta_{b}), \qquad (4.10)$$

$$\alpha^{3}\Gamma_{i|j|k|l} - \alpha\Gamma_{\tau_{i}|\tau_{j}|\tau_{k}|\tau_{l}} = \beta_{b}(1-\alpha)(\beta_{a}+\alpha\beta_{b}), \qquad (4.11)$$

$$\alpha^{3}\Gamma_{i|j|\sigma_{m}|\sigma_{n}} - \alpha\Gamma_{\tau_{i}|\tau_{j}|m|n} = \beta_{a}(\alpha\beta_{b}(1-\varepsilon) + \beta_{a}(1-\alpha^{2})), \qquad (4.12)$$

$$\beta_a \beta_b (\beta_b \varepsilon (1+\alpha) - \beta_a (1+\varepsilon \alpha)) = \alpha^2 \beta_a (1+\alpha) \Gamma_{i|j|k|l}$$

$$-\beta_b(1+\varepsilon\alpha)\Gamma_{\tau_i|\tau_j|\tau_k|\tau_l} + \alpha(\beta_b - \varepsilon\beta_a)\Gamma_{\tau_i|\tau_j|m|n} -\varepsilon\alpha^2(\beta_a - \beta_b)\Gamma_{i|j|\sigma_m|\sigma_n} - \alpha^2\beta_b(1+\varepsilon\alpha)\Gamma_{\sigma_k|\sigma_l|\sigma_m|\sigma_n}$$
(4.16)

$$+\beta_a(1+\alpha)\Gamma_{k|l|m|n}.$$

Proof. By (1.2), we have

$$\lambda_{a_i|b_j|a_k|b_l}^{(1)a_k|a_i^{(1)}|b_j^{(1)}} = \lambda_{a_i|b_j|a_k|a_k}^{(1)a_k|a_i^{(1)}|b_j^{(1)}} \lambda_{b_j|b_j|a_k|b_l}^{(1)a_k|b_j^{(1)}|a_k|b_j^{(1)}|b_j^{(1)}} = \alpha_{ra}\beta_{lb},$$

A direct computation using these facts and equalities (4.5) shows that equality (2.5) with $a \coloneqq a_i, b \coloneqq b_j, c \coloneqq a_k, d \coloneqq b_l$ and $e \coloneqq a_m$ becomes

$$\Gamma_{i|j|k|l} + \frac{\varepsilon\beta_b\beta_a}{\alpha} - \frac{\beta_a\beta_b}{\alpha^2} + \frac{\varepsilon\beta_a^2}{\alpha^2} = \frac{\beta_a^{2\prime}}{\alpha^2} - \frac{\beta_a^{2\prime}}{\alpha^2} + \frac{\beta_a^2}{\alpha^3} + \frac{1}{\alpha^2}\Gamma_{\tau_i|\tau_j|\tau_k|\tau_l}.$$

Multiplying by α^3 and reordering we see that equality (2.5) with these values of a, b, c, d and e is fulfilled if and only if

$$\alpha^{3}\Gamma_{i|j|k|l} - \alpha\Gamma_{\tau_{i}|\tau_{j}|\tau_{k}|\tau_{l}} = \alpha\beta_{a}\beta_{b} - \varepsilon\alpha^{2}\beta_{a}\beta_{b} - \varepsilon\alpha\beta_{a}^{2} + \beta_{a}^{2}$$
$$= \beta_{a}(1 - \varepsilon\alpha)(\beta_{a} + \alpha\beta_{b}),$$

as desired. Similar arguments prove that equality (2.5) with $a \coloneqq a_i, b \coloneqq b_j, c \coloneqq a_k, d \coloneqq b_l$ and $e \coloneqq b_n$ is fulfilled if and only if equality (4.11) holds, etcetera.

For the rest of the section we assume that equality (2.2) is satisfied for all $S \subseteq T$, such that $\mathfrak{h}(T) \leq 1$, or equivalently, that (4.6) holds.

Let α , β_a and β_b be as in Notation 4.3 and let $\varepsilon \in \{\pm 1\}$ be as in Remark 4.4. In order to abbreviate the expressions we write Γ instead of $\Gamma_{0|0|0|0}$.

Lemma 4.8. The right hand sides of equalities (4.10)–(4.15) are equal to

$$\beta_a \beta_b (1 - \varepsilon \alpha^2).$$

Proof. Straightforward using (4.6).

Lemma 4.9. Equalities (4.10)–(4.15) are fulfilled if and only if $\Gamma_{i|j|k|l} = \Gamma$ for all i, j, k, l and $(\alpha^2 - 1)\Gamma = \frac{\beta_\alpha \beta_b}{\alpha}(1 - \varepsilon \alpha^2)$.

Proof. Note that by Lemma 4.8, equalities (4.10), (4.12) and (4.14) yield

$$\alpha^{2}\Gamma_{i|j|k|l} - \Gamma_{\tau_{i}|\tau_{j}|\tau_{k}|\tau_{l}} = \frac{\beta_{a}\beta_{b}}{\alpha}(1 - \varepsilon\alpha^{2}), \qquad (4.20)$$

 \Rightarrow) Recall that the map $(i, j) \mapsto (\varsigma_a(i), \varsigma_b(j))$ is an *uv*-cycle. From equality (4.20) we obtain that

$$\alpha^2 \Gamma_{\sigma_i | \sigma_j | \sigma_i | \sigma_j} - \Gamma_{\varsigma_i | \varsigma_j | \varsigma_i | \varsigma_j} = \frac{\beta_a \beta_b}{\alpha} (1 - \varepsilon \alpha^2).$$

Combining this with (4.22) we deduce that $\Gamma_{\varsigma_i|\varsigma_j|\varsigma_i|\varsigma_j} = \Gamma_{i|j|i|j}$ for all *i* and *j*, which implies that

$$\Gamma_{i|j|i|j} = \Gamma \quad \text{for all } i \text{ and } j.$$
On the other hand, from equality (4.21) we obtain that

 $\alpha^2 \Gamma_{i|j|\varsigma_k|\varsigma_l} - \Gamma_{\tau_i|\tau_j|\tau_k|\tau_l} = \frac{\beta_a \beta_b}{\alpha} (1 - \varepsilon \alpha^2).$

Combining this with (4.20), we deduce that

 $\Gamma_{i|j|k|l} = \Gamma_{i|j|\varsigma_k|\varsigma_l} \quad \text{for all } i, j, k \text{ and } l.$

From this and (4.23) it follows that $\Gamma_{i|j|k|l} = \Gamma$ for all i, j, k and l. Combining this with equality (4.20) we obtain that $(\alpha^2 - 1)\Gamma = \frac{\beta_a\beta_b}{\alpha}(1 - \varepsilon\alpha^2)$, as desired. \Leftarrow) By Lemma 4.8, this is clear.

Proposition 4.10. Equalities (4.10)–(4.16) hold if and only if

 $\Gamma_{i|j|k|l} = \Gamma \quad \text{for all } i, j, k \text{ and } l, \tag{4.24}$

$$(\alpha^2 - 1)\Gamma = \frac{\beta_a \beta_b}{\alpha} (1 - \varepsilon \alpha^2) \tag{4.25}$$

and

$$\beta_a \beta_b (\beta_b \varepsilon (1+\alpha) - \beta_a (1+\varepsilon \alpha)) = \Gamma (\beta_a (1+\alpha)(1-\varepsilon \alpha + \alpha^2) - \beta_b (1+\varepsilon \alpha)(1-\alpha + \alpha^2)).$$
(4.26)

Proof. By Lemma 4.9 it suffices to prove that if equality (4.25) is fulfilled and $\Gamma_{i|j|k|l} = \Gamma$ for all i, j, k and l, then equalities (4.16) and (4.26) are equivalent, which follows by a direct computation.

Recall that X is the set $\{a_0, \ldots, a_{u-1}, b_0, \ldots, b_{v-1}\}$, where $u, v \in \mathbb{N}$ are coprime, endowed with the height one order given by $a_i < b_j$ for all i, j. Recall also that $\phi_r, \phi_l \colon X \to X$ are two commuting poset automorphisms and

$$r_0\colon X\times X\longrightarrow X\times X$$

is the map defined by $r_0(x, y) \coloneqq (\phi_l(y), \phi_r(x))$. Let $\sigma_a, \sigma_b, \tau_a$ and τ_b be as at the beginning of the section. Recall finally that $(i, j) \mapsto (\varsigma_a(i), \varsigma_b(j))$ is an *uv*-cycle. Let

$$r: D \otimes D \longrightarrow D \otimes D$$

be a non-degenerate coalgebra automorphism that has set-type square up to height 1 and induces r_0 by restriction. By Theorem 2.6 and Propositions 4.5, 4.7 and 4.10 we know that r satisfies the braid equation if and only it conditions (4.6), (4.24), (4.25) and (4.26) are fulfilled. In Remark 4.6 we described the solutions of equation (4.6). In the sequel we are going to construct the families of solutions of the braid equation corresponding to each of the cases of that remark. By condition (4.24) we assume that $\Gamma_{i|j|k|l} = \Gamma$ for all i, j, k and l.

Proposition 4.11. If $\varepsilon = 1$ and $\alpha = 1$, then r satisfies the braid equation if and only if either $\beta_a = \beta_b$, or $\beta_a \neq \beta_b$ and $2\Gamma + 2\beta_b\beta_a = 0$.

Proof. A straightforward computation shows that under the hypotheses of the statement, conditions (4.25) and (4.26) are satisfied if and only if $\beta_a = \beta_b$, or $\beta_a \neq \beta_b$ and $2\Gamma + 2\beta_b\beta_a = 0$.

Proposition 4.12. Assume that $\varepsilon = 1$, $\alpha \neq 1$ and $\beta_a = \beta_b$.

- 1) If $\alpha = -1$, then r satisfies the braid equation.
- 2) If $\alpha \neq -1$, then r satisfies the braid equation if and only if $\Gamma = -\frac{\beta_a^2}{\alpha}$.

Proof. Because under the conditions of item 1), equations (4.25) and (4.26) are always satisfied, while under the conditions of item 2), equations (4.25) and (4.26) are satisfied if and only if $\Gamma = -\beta_a^2/\alpha$.

Proposition 4.13. Assume that $\varepsilon = -1$ and char $K \neq 2$.

- 1) If $\alpha = 1$ and $\beta_a = 0$, then r satisfies the braid equation.
- 2) If $\alpha = -1$ and $\beta_b = 0$, then r satisfies the braid equation.
- 3) If $\alpha^2 \neq 1$ and $\beta_b = \beta_a \frac{1+\alpha}{1-\alpha}$, then r satisfies the braid equation if and only if $\Gamma = -\frac{\beta_a^2(1+\alpha^2)}{\alpha(1-\alpha)^2}$.

Proof. Clearly, under the conditions of item 1), equations (4.25) and (4.26) are always satisfied. Assume we are under the hypotheses of item 3). Then Equality (4.25) holds if and only if

$$\Gamma = -\frac{\beta_a \beta_b}{\alpha} \frac{1+\alpha^2}{1-\alpha^2} = -\frac{\beta_a^2 (1+\alpha^2)}{\alpha (1-\alpha)^2}.$$

Replacing Γ by this, β_b by $\beta_a \frac{1+\alpha}{1-\alpha}$ and ε by -1 in both sides of (4.26), we obtain

$$-2\beta_a^3(1+\alpha^2)\frac{1+\alpha}{1-\alpha} = -2\beta_a^3(1+\alpha^2)\frac{1+\alpha}{1-\alpha}.$$

Hence r satisfies the braid equation if and only if $\Gamma = -\frac{\beta_a^2(1+\alpha^2)}{\alpha(1-\alpha)^2}$.

For each (a, b), (c, d), (e, f) and (g, h) in Y, let $\lambda_{a|b|c|d}^{e|f|g|h}$ be as in formula (0.1).

Theorem 4.14. Let r be as above of Proposition 4.11. If r is a solution of the braid equation, then the possibly nonzero coefficients $\lambda_{a|b|c|d}^{e|f|g|h}$ depend on the parameters ε , α , β_a , β_b and Γ via the following formulas, in which we use the notation (3.6):

$$\begin{split} \lambda_{a_i|b_j|a_k|b_l}^{(1)b_l|a_i^{(1)}|b_j^{(1)}} &= -\frac{\varepsilon\beta_a}{\alpha}, \qquad \lambda_{a_i|b_j|a_k|b_l}^{(1)a_k|(1)b_l|b_j^{(1)}|b_j^{(1)}} &= \varepsilon\beta_a, \\ \lambda_{a_i|b_j|a_k|b_l}^{(1)a_k|(1)b_l|a_i^{(1)}|b_j^{(1)}} &= \varepsilon. \end{split}$$

Proof. The first equality holds because r induces r_0 . The other formulas can be obtained using (1.1), (1.2), the discussion at the beginning of Section 4, Proposition 4.1 and equalities (4.5). We prove for example that

$$\lambda_{a_i|b_j|a_k|b_l}^{(1)b_l|a_i^{(1)}|b_j^{(1)}} = -\frac{\varepsilon\beta_a}{\alpha}.$$
(4.27)

By (1.2) and the discussion at the beginning of Section 4 we know that

$$\lambda_{a_i|b_j|a_k|b_l}^{(1)b_l|a_i^{(1)}|b_j^{(1)}} = \lambda_{a_i|a_i|a_k|b_l}^{(1)b_l|a_i^{(1)}|a_i^{(1)}} \lambda_{a_i|b_j|b_l|b_l}^{(1)b_l|a_i^{(1)}|b_j|a_i^{(1)}|b_j^{(1)}} = -\beta_{la}\alpha_{rb}.$$

We finish the computation of the equality (4.27), noting that by Proposition 4.1 and equalities (4.5) we have $\beta_{la} = \beta_a$ and $\alpha_{rb}^i = \frac{\varepsilon}{\alpha}$.

Collecting the results in this section we arrive at the following complete description:

Theorem 4.15. The non-degenerate coalgebra automorphism r introduced above Proposition 4.11 is a solution of the braid equation that induces r_0 on $X \times X$ and has set-type square up to height 1 if and only if the parameters ε , α , β_a , β_b and Γ belong to one of the families given in the following table:

#	Dependent values in each family	Parameters	$\operatorname{char} K$
1. $\varepsilon = 1, \alpha = 1$	$\beta_b = \beta_a$	$\beta_a, \Gamma \in K$	arbitrary

Proposition 4.16. The solutions r of Theorem 4.15 have set-type square if and only if either $\varepsilon = -1$ and $2\Gamma = 0$ or $\varepsilon = 1$ and $2\Gamma = -\frac{2\beta_a\beta_b}{\alpha}$.

Proof. Let r be as Theorem 4.15. By Proposition 4.1 and equality (4.24) all the equations (3.19) reduce to

$$2\Gamma = -\frac{\beta_b \beta_a}{\alpha} - \frac{\beta_b \beta_a}{\varepsilon \alpha},$$

which is clearly equivalent to $\varepsilon = -1$ and $2\Gamma = 0$ or $\varepsilon = 1$ and $2\Gamma = -\frac{2\beta_a\beta_b}{\alpha}$. By Proposition 3.14 this finishes the proof.

Examples 4.17. The hypothesis of Theorems 4.14 and 4.15 are satisfied for instance in the following cases

- u = 4, v = 1, $\phi_r(a_i) = a_{i+1}$ and $\phi_l(a_i) = a_{i+2}$, where the sums are taken modulo 4.
- u and v are odd, $\phi_r(a_i) = \phi_l(a_i) = a_{i+1}$ and $\phi_r(b_i) = \phi_l(b_i) = b_{i+1}$, where the sums are taken modulo u and v respectively.
- Any example can be constructed in the following way: take an u-cycle ς_a of \mathbb{N}_u and a v-cycle ς_b of \mathbb{N}_v , and then take σ_a and τ_a any powers of ς_a such that $\sigma_a \circ \tau_a = \varsigma_a$, and take σ_b and τ_b any powers of ς_b such that $\sigma_b \circ \tau_b = \varsigma_b$. In fact, if $\varsigma_a = \sigma_a \circ \tau_a = \tau_a \circ \sigma_a$ is an u-cycle, then σ_a and τ_a are in the centralizer of ς_a in S_u which is $\langle \varsigma_a \rangle$. The same argument proves that both σ_b and τ_b are powers of ς_b . For instance, one can take $\sigma_a = \varsigma_a$, $\sigma_b = \varsigma_b$, $\tau_a = \mathrm{Id}$ and $\tau_b = \mathrm{Id}$.
