# Milnor-Orr invariants from the Kontsevich invariant.

#### Abstract

As nilpotent studies in knot theory, we focus on invariants of Milnor, Orr, and Kontsevich. We show that the Orr invariant of degree $k$ is equivalent to the tree reduction of the Kontsevich invariant of degree $<2 k$. Furthermore, we will see a close relation between the Orr invariant and the Milnor invariant, and discuss a method of computing these invariants.

## 1 Introduction

In Mi1, Mi2], Milnor defines his $\bar{\mu}$-invariants of links, which extract numerical information from the lower central series of the link groups and the link longitudes. The $\bar{\mu}$-invariants have been studied from topological viewpoints (see [IO, CDM, MY] and references therein, and [KN] for a powerful computation). Furthermore, as a homotopical approach to $\bar{\mu}$-invariants, Orr [O] introduced an invariant of "based links". This Orr invariant provides obstruction of slicing links in a nilpotent sense [O, IO]. However, since the invariant is defined as a homotopy 3-class of a homotopy group, there are few examples of the computation, and it is not clear whether the invariant is properly a generalization of the $\bar{\mu}$-invariants or not

Meanwhile, in quantum topology, a standard way to study nilpotent information is to carefully observe the tree parts of the Kontsevich invariants or LMO functor; see, e.g., [HM, GL, Ma2]. For example, the first non-vanishing term of $\bar{\mu}$-invariants is equal to that of a tree reduction of the Kontsevich invariant [HM, with a relation to the Chen integral. Concerning the mapping class group, the Johnson-Morita homomorphism and Goldmann Lie algebra can be also nilpotently studied from the LMO functor (see [Ma1, Ma2]). Furthermore, such observations of tree parts sometimes approach the fundamental homology 3-class of 3-manifolds, together with relations to Massey products GL.

In this paper, inspired by the works of Massuyeau [Ma1, Ma2], we show that the (Milnor)Orr invariant can be recovered from the Kontsevich invariant. We should note that these invariants are appropriately graded, and that, given $k \in \mathbb{N}$, the Orr invariant of degree $k$ is defined for any based link $L$ whose $\bar{\mu}$-invariants of degree $\leq k$ are zero. The theorem is as follows:

Theorem 1.1 (Corollary 3.3). Given a based link $L$ whose $\bar{\mu}$-invariants of degree $\leq k$ vanish, the Orr invariant of $L$ is equivalent to the tree-shaped reduction of the Kontsevich invariant of degree $<2 k$.

This theorem is a generalization of the above result [HM] (see Remark 5.1) and gives a topological interpretation of the tree reduction of degree $<2 k$. Moreover, it is natural for us to ask

[^0]what finite type invariants recover the Orr invariant; as a solution, we suggest a computation of the Orr invariant from HOMFLYPT polynomials (see $\S(\mathbb{A}$ ), where this computation is based on MY.

Furthermore, we will show the equivalence between the Orr invariant of degree $k$ and Milnor $\bar{\mu}$-invariants of degree $<2 k$; see Theorem [2.3. Accordingly, while the Orr invariant is a homotopy 3 -class, the 3 -class turns out to be described by the link longitudes, as is implicitly pointed out in [Ma2, K0]; see the figure below as a summary. Our result is analogous to the result Ma1 concerning the mapping class group, which claims an equivalency between "the Morita homomorphism" of degree $k$ and "the total Johnson homomorphisms" of degree $<2 k$. Thus, it can be hoped that and the tree parts of the LMO functor can be described in terms of homology 3-classes or algebraic topology.

This paper is organized as follows. Section 2 reviews Milnor-Orr invariants and states Theorem [2.3, and Section 3 describes the relation to the Kontsevich invariant. Section 4 gives the proofs. Appendix A explains the computation from HOMFLYPT polynomials.

## 2 Theorem on Milnor-Orr invariant

The first part of this section reviews the Milnor-Orr invariant, and the second part states Theorem 2.3.

### 2.1 Review of Milnor invariant and Orr invariant

We will start by reviewing string links. Let $I$ be the interval $[0,1]$, and fix $q \in \mathbb{N}$. A ( $q$ component) string link is a smooth embedding of $q$ disjoint oriented $\operatorname{arcs} A_{1}, \ldots, A_{q}$ in the 3 -cube $I^{3}$, which satisfy the boundary condition $A_{i}=\left\{p_{i}, q_{i}\right\}$, where $p_{i}=(j / 2 q, 0,0)$ and $q_{i}=(j / 2 q, 0,1) \in I^{3}$. We define $S L(q)$ to be the set of string links of $q$-components. Given two string links $T$ and $T^{\prime}$, we can define another string link, $T \cdot T^{\prime} \subset[0,1]^{2} \times[0,2] \cong I^{3}$, by connecting $q_{i}$ in $T$ and $p_{i}^{\prime}$ in $T^{\prime}$. If $T=\left\{A_{i}\right\}$ is a string link, then an oriented link $L=\left\{L_{1}, \ldots, L_{q}\right\}$ can be defined to be $L_{i}=A_{i} \cup a_{i}$, where $a_{i}$ is a semi-circle in $S^{3} \backslash L$ connecting $p_{i}$ and $q_{i}$. We call the link the closure of $T$ and denote it by $\bar{T}$; see Figure 1 ,

Next, we will describe the groups used throughout this paper. Let $F$ be the free group with generator $x_{1}, \ldots, x_{q}$. For a group $G$, we define $G_{1}$ to be $G$ and $G_{m}$ to be the commutator

$\left[G_{m-1}, G\right]$ by induction. If $G$ is the free group $G$, then the projection $p_{m-1}: F / F_{m} \rightarrow F / F_{m-1}$ implies the central extension,

0 \longrightarrow F_{m-1} / F_{m} \longrightarrow F / F_{m} \xrightarrow{p_{m-1}} F / F_{m-1} \longrightarrow 0 \quad \text { (central extension) } \tag{1}
\end{equation*}

The abelian kernel $F_{m-1} / F_{m}$ is known to be free with a finite basis.
Now let us explain the $m$-th leading terms of the Milnor invariant, according to (Mi1, IO, KN. We will suppose that the reader has elementary knowledge of knot theory, as can be found in [CDM, $\S 1$ and $\S 12$ ]. Given a $q$-component link $L$ in the 3 -sphere $S^{3}$ and $\ell \leq q$, we can uniquely define the (preferred) longitude $\mathfrak{l}_{\ell} \in \pi_{1}\left(S^{3} \backslash L\right)$ of the $\ell$-th component. In addition, let $f_{2}: \pi_{1}\left(S^{3} \backslash L\right) \rightarrow F / F_{2}=\mathbb{Z}^{q}$ be the abelianization Ab. Furthermore, for $k \in \mathbb{N}$, we assume

- Assumption $\mathfrak{A}_{k}$. There are homomorphisms $f_{s}: \pi_{1}\left(S^{3} \backslash L\right) \rightarrow F / F_{s}$ for $s$ with $s \leq k$, which satisfy the commutative diagram,


Here, we should note that if there is another extension $f_{k}^{\prime}$ instead of $f_{k}$, then $f_{k}$ equals $f_{k}^{\prime}$ up to conjugacy, by centrality. Further, we should note following proposition.

Proposition 2.1 ([Mi2]). Suppose Assumption $\mathfrak{A}_{k}$. Then, $f_{k}$ admits a lift $f_{k+1}: \pi_{1}\left(S^{3} \backslash L\right) \rightarrow$ $F / F_{k+1}$ if and only if all the Milnor invariants of length $<k$ vanish, i.e., $f_{k}\left(\mathfrak{l}_{\ell}\right)=0$.

Thus, the map $f_{k}$ sends the preferred longitude $\mathfrak{l}_{\ell}$ to the center $F_{k-1} / F_{k}$. Then, the $q$-tuple,

$$
\left(f_{k}\left(\mathfrak{l}_{1}\right), \ldots, f_{k}\left(\mathfrak{l}_{q}\right)\right) \in\left(F_{k-1} / F_{k}\right)^{q}
$$

is called the first non-vanishing Milnor $\mu$-invariant or the Milnor $\mu$-invariant of length $k-1$. Proposition 2.1 implies that $\mu$-invariant is known to be a complete obstruction for lifting $f_{m}$. The paper [KN] gives an algorithm to describe $f_{m}$ explicitly, and a method of computing the Milnor invariants.

We further review the Orr invariant [O], where $L$ satisfies Assumption $\mathfrak{A}_{k+1}$, that is, all the $\mu$-invariants of length $\leq k$ are zero; $f_{k}\left(\mathfrak{l}_{\ell}\right)=0$. Fix a homomorphism $\tau: F \rightarrow \pi_{1}\left(S^{3} \backslash L\right)$ that sends each generator $x_{\ell}$ to some meridian $\mathfrak{m}_{\ell}$ of the $\ell$-th component for $\ell \leq \# L$. This $\tau$ is called $a$ basing, and the pair $(L, \tau)$ is referred as to a based link. As examples that we will refer to later, given a string link $T$, the closure $\bar{T}$ has a canonical basing, where $\tau$ is obtained from choosing the loop circling $\{(j / 2 q, 0,1)\}$. Furthermore, for a group homomorphism $f: G \rightarrow H$, we will write $f_{*}: K(G, 1) \rightarrow K(H, 1)$ for the induced map between Eilenberg-MacLane spaces. We define the space $K_{k}$ to be the mapping cone,

$$
K_{k}:=\operatorname{Cone}\left(\left(f_{k} \circ \tau\right)_{*}: K(F, 1) \rightarrow K\left(F / F_{k}, 1\right)\right)
$$

Then, from the assumption $f_{k}\left(\mathfrak{l}_{\ell}\right)=0, f_{k}$ gives rise to a continuous map $\rho_{L}: S^{3} \rightarrow K_{k}$. It is reasonable to consider the homotopy 3 -class,

$$
\begin{equation*}
\theta_{k}(L, \tau):=\left[\rho_{L}\right] \in \pi_{3}\left(K_{k}\right), \tag{2}
\end{equation*}
$$

which we call the Orr invariant. The following is a list of known results on the invariant and $\pi_{3}\left(K_{k}\right)$.

Theorem 2.2 ([⿴囗 IO]). (I) Let $N_{h} \in \mathbb{N}$ be the rank of $H_{2}\left(F / F_{h} ; \mathbb{Z}\right)=F_{h} / F_{h+1}$. The following are isomorphisms on $\pi_{3}\left(K_{k}\right)$ and on $H_{3}\left(K_{k}\right)$ :

$$
\pi_{3}\left(K_{k}\right) \cong \bigoplus_{h=k}^{2 k-1} \mathbb{Z}^{q N_{h}-N_{h+1}}, \quad H_{3}\left(K_{k} ; \mathbb{Z}\right) \cong H_{3}\left(K\left(F / F_{k}, 1\right) ; \mathbb{Z}\right) \cong \bigoplus_{h=k}^{2 k-2} \mathbb{Z}^{q N_{h}-N_{h+1}}
$$

Furthermore, the Hurewicz homomorphism $\mathfrak{H}: \pi_{3}\left(K_{k}\right) \rightarrow H_{3}\left(K_{k} ; \mathbb{Z}\right)$ is equal to the projection according to the direct sums on the right-hand sides.
(II) The lowest summand of $\theta_{k}(L, \tau)$ is equivalent to the Milnor invariant of length $k$; see [O] or [IO, §10] for details.
(III) For any element $\kappa \in \pi_{3}\left(K_{k}\right)$, there exist a link $L$ and a homomorphism $g_{k}: \pi_{1}\left(S^{3} \backslash L\right) \rightarrow$ $F / F_{k}$ satisfying $\theta_{k}(L, \tau)=\kappa$.
(IV) The Orr invariant has additivity with respect to "band connected sums"; see [O, §3]. As a special case, for two string links $T_{1}$ and $T_{2}$ such that the closures $\bar{T}_{1}$ and $\bar{T}_{2}$ satisfy Assumption $\mathfrak{A}_{k+1}$, we have $\theta_{k}\left(\overline{T_{1} \cdot T_{2}}, \tau_{1}\right)=\theta_{k}\left(\bar{T}_{1}, \tau_{1}\right)+\theta_{k}\left(\bar{T}_{2}, \tau_{2}\right)$.
(V) Let $\iota_{k}: K_{k} \rightarrow K_{k+1}$ be the continuous map arising from the projection $F / F_{k} \rightarrow F / F_{k+1}$. The Orr invariant has functoriality. To be precise, if $L$ satisfies $\mathfrak{A}_{k+1}$, then the equality $\left(\iota_{k}\right)_{*}\left(\theta_{k}(L, \tau)\right)=\theta_{k+1}(L, \tau)$ holds in $\operatorname{Im}\left(\iota_{k}\right)_{*} \cap \pi_{3}\left(K_{k+1}\right)$.

Next, we mention the homological reduction of the Orr invariant $\theta_{k}(L)$ via the Hurewicz map $\mathfrak{H}: \pi_{3}\left(K_{k}\right) \rightarrow H_{3}\left(K_{k} ; \mathbb{Z}\right)$. Note that the inclusion $K\left(F / F_{k}, 1\right) \rightarrow K_{k}$ induces the isomorphism,

$$
P^{\mathrm{gr}}: H_{3}\left(K\left(F / F_{k}, 1\right), \sqcup^{q} K(\mathbb{Z}, 1) ; \mathbb{Z}\right) \cong H_{3}\left(K_{k} ; \mathbb{Z}\right),
$$

from the relative homology. To summarize, the value $\mathfrak{H}\left(\theta_{k}(L)\right)$ is the reduction of $\theta_{k}(L)$ without the top summand $\mathbb{Z}^{q N_{2 k-1}-N_{2 k}}$. Moreover, by definition, this $\mathfrak{H}\left(\theta_{k}(L)\right)$ can be regarded as the pushforward of the fundamental 3-class $\left[S^{3} \backslash L, \partial\left(S^{3} \backslash L\right)\right] \in H_{3}\left(S^{3} \backslash L, \partial\left(S^{3} \backslash L\right) ; \mathbb{Z}\right) \cong \mathbb{Z}$ :

$$
\begin{equation*}
P^{\mathrm{gr}} \circ\left(f_{k}\right)_{*}\left[S^{3} \backslash L, \partial\left(S^{3} \backslash L\right)\right]=\mathfrak{H}\left(\theta_{k}(L, \tau)\right) \in H_{3}\left(K_{k} ; \mathbb{Z}\right) \tag{3}
\end{equation*}
$$

The author [Nos] showed that the cohomology $H^{3}\left(K\left(F / F_{k}, 1\right)\right)$ are generated by some Massey products; thus, the reduction (3) are characterized by some Massey products of $S^{3} \backslash L$.

### 2.2 Results: Orr invariant of higher invariants

In order to state the theorem, let us briefly review the Milnor $\mu$-invariant for string links (see [HM, Ko, L1]). For a string link $T \in S L(q)$, let $y_{j} \in \pi_{1}\left([0,1]^{3} \backslash T\right)$ be an element arising from the loop circling $\{(j / 2 q, 0,1)\}$; Let $G_{m}$ be the $m$-th nilpotent quotient of $\pi_{1}\left([0,1]^{3} \backslash T\right)$. Then, as is shown [Mi2, L1], the homomorphism $F \rightarrow \pi_{1}\left([0,1]^{3} \backslash T\right)$ which sends $x_{i}$ to $y_{i}$ descends to an isomorphism between the $m$-th nilpotent quotients:

$$
\begin{equation*}
\phi_{*}: F / F_{m} \cong \pi_{1}\left([0,1]^{3} \backslash T\right) / G_{m}, \quad \text { for any } m \in \mathbb{N} \tag{4}
\end{equation*}
$$

Here, we should note that, if $T$ is a pure braid, this $\phi_{*}$ is the identity map. Furthermore, a framing of the $\ell$-th component of $T$ defines a parallel curve which determines an element, $\lambda_{\ell} \in \pi_{1}\left([0,1]^{3} \backslash T\right)$. This $\lambda_{\ell}$ is referred as to the $\ell$-th longitude of $T$. We call the reduction $\phi_{*}^{-1}\left(\lambda_{\ell}\right) \in F / F_{m}$ modulo $F_{m}$ the $\mu$-invariant of $T$ (of degree $\leq m$ ). Later, we will omit writing $\phi_{*}^{-1}$ for simplicity. We should notice, from the definitions, that the closure $\bar{T}$ of a string link $T$ satisfies $\mathfrak{A}_{k+1}$ if and only if $\lambda_{j}$ lies in $F_{k}$, and $\lambda_{j}=f_{k+1}\left(\mathfrak{l}_{j}\right) \in F_{k} / F_{k+1}$ modulo $F_{k+1}$.

Thus, for such a string link $T$, as in the paper [L1] of Levine, it is reasonable to consider the invariant, $\lambda_{j}$ modulo $F_{2 k}$. Notice that $F_{k} / F_{2 k}$ is abelian, since $\left[F_{k}, F_{k}\right] \subset F_{2 k}$. Furthermore, as can be seen from [L1, Proposition 4], we can verify that the equality,

$$
\begin{equation*}
\left[x_{1}, \lambda_{1}\right]\left[x_{2}, \lambda_{2}\right] \cdots\left[x_{q}, \lambda_{q}\right]=1 \in F, \tag{5}
\end{equation*}
$$

always holds. Thus, for $m \leq 2 k$, the sum,

$$
\sum_{j=1}^{q}\left(x_{j} \otimes \lambda_{j}\right) \in \mathbb{Z}^{q} \otimes_{\mathbb{Z}} F_{k} / F_{m} \text { modulo } F_{m}
$$

is contained in the kernel of the commuting operator,

$$
[\bullet, \bullet]_{k, m}: F / F_{2} \otimes F_{k} / F_{m} \longrightarrow F_{k+1} / F_{m+1} ; \quad x \otimes y \longmapsto x y x^{-1} y^{-1}
$$

This operation will be used in many times. Now let us show the equivalence of Milnor and Orr invariants:

Theorem 2.3 (See $\$ 5$ for the proof). (I) There is a $\mathbb{Q}$-vector isomorphism,

$$
\Phi \circ \eta^{-1}: \mathbb{Q} \otimes \operatorname{Ker}\left([\bullet, \bullet]_{k, 2 k-1}\right) \xrightarrow{\sim} H_{3}\left(F / F_{k} ; \mathbb{Q}\right),
$$

such that the following holds for any string link $T$ satisfying $\mathfrak{A}_{k+1}$ of the closure $\bar{T}$ :

$$
\Phi \circ \eta^{-1}\left(\left(x_{1} \otimes \lambda_{1}\right)+\cdots+\left(x_{q} \otimes \lambda_{q}\right)\right)=\mathfrak{H} \circ \theta_{k}(\bar{T}, \tau) .
$$

(II) Furthermore, concerning the homotopy group $\pi_{3}\left(K_{k}\right)$, there is a bijection

$$
\bar{\Phi}: \mathbb{Q} \otimes \operatorname{Ker}\left([\bullet, \bullet]_{k, 2 k}\right) \xrightarrow{\sim} \pi_{3}\left(K_{k}\right) \otimes \mathbb{Q},
$$

as an extention of $\Phi \circ \eta^{-1}$, such that a similar equality $\bar{\Phi}\left(\left(x_{1} \otimes \lambda_{1}\right)+\cdots+\left(x_{q} \otimes \lambda_{q}\right)\right)=\theta_{k}(\bar{T}, \tau)$ holds for any string link $T$ satisfying $\mathfrak{A}_{k+1}$ of the closure $\bar{T}$.

We conjecture that the bijection in (II) is an isomorphism. However, from Theorem 2.2 (III), we have the realizability result as a generalization of [L1, Proposition 5]:

Corollary 2.4. Let $\left(\alpha_{1}, \ldots, \alpha_{q}\right) \in F_{k} / F_{2 k}$ satisfy $\left[x_{1}, \alpha_{1}\right] \cdots\left[x_{q}, \alpha_{q}\right]=1 \in F / F_{2 k}$. There exists a string link with $\bar{\mu}$-invariants $\left(\lambda_{1}, \ldots, \lambda_{q}\right) \in\left(F_{k}\right)^{q}$ such that $\lambda_{j} \equiv \alpha_{j}$ modulo $F_{2 k}$.

## 3 As a tree reduction of the Kontsevich invariant

As described in the Introduction, we will relate the $\bar{\mu}$-invariants with the Kontsevich invariant.

Notation. Throughout this paper, the expression $O(n)$ will be used to denote terms of degree greater than or equal to $n$.

### 3.1 A brief review of the Kontsevich invariants of (string) links

Let us start by briefly reviewing the definition of the $\mathbb{Q}$-vector space $\mathcal{A}\left(\uparrow^{q}\right)$, where a chord diagram (of $q$-components) is a union $\left(\sqcup_{j=1}^{q}[0,1]\right) \cup \Gamma$ such that $\Gamma$ is a uni-trivalent graph, whose univalent vertices lie in the interior of $\left(\sqcup_{j=1}^{q}[0,1]\right)$, and each component of $\Gamma$ is required to have a univalent vertex. It is customary to refer to the components of $\Gamma$ as dashed. Then, $\mathcal{A}\left(\uparrow^{q}\right)$ is defined by the $\mathbb{Q}$-vector space generated by all chord diagrams subject to the STU, AS, and IHX relations. The three relations are described in Figure 2. The space $\mathcal{A}\left(\uparrow^{q}\right)$ is graded by the degree, where the degree of a diagram is half the number of vertices of $\Gamma$. We denote the subspace of $\mathcal{A}\left(\uparrow^{q}\right)$ of degree $n$ by $\mathcal{A}_{n}\left(\uparrow^{q}\right)$. By abuse of notation, we will denote the graded completion of $\mathcal{A}\left(\uparrow^{q}\right)$ by $\mathcal{A}\left(\uparrow^{q}\right)$ as well. We define $\mathcal{A}^{t}\left(\uparrow^{q}\right)$ as the subspace of $\mathcal{A}\left(\uparrow^{q}\right)$ generated by the chord diagram such that all trivalent diagrams containing a non-simply connected dashed component are considered relations. Furthermore, the stucking connection of $\left(\sqcup_{j=1}^{q}[0,1]\right)$ and $\left(\sqcup_{j=1}^{q}[0,1]\right)$ gives rise to a ring structure of $\mathcal{A}\left(\uparrow^{q}\right)$. Moreover, there is a cocommutative multiplication $\Delta: \mathcal{A}\left(\uparrow^{q}\right) \rightarrow \mathcal{A}\left(\uparrow^{q}\right)^{\otimes 2}$ (see, e.g., CDM, Chapter 4], for the details), and $\mathcal{A}\left(\uparrow^{q}\right)$ is made into a Hopf algebra.

There are several formulations of the Kontsevich invariant. In this paper, we emply the Kontsevich invariant defined for " $q$-tangles", as in [HM. Since we can chose an injection from the set of string links into the set of $q$-tangles which is invariant with respect to the composite of $(q$ - $)$ tangles, we can regard the Kontsevich invariant of $q$-tangles that of string links (Throughout this paper, we fix such an injection). In this paper, we only consider some of the properties of the Kontsevich invariant of string links $T$. Thus, while we refer the reader to, e.g., CDM, §§8-10], Ma2, §6], and references therein for the definition of the Kontsevich invariant for $q$-tangles, here are the properties that we will use later.
(I) The invariant, $Z(T)$, is defined as an element of $\mathcal{A}\left(\uparrow^{q}\right)$.
(II) $Z(T)$ is multiplicative, i.e., $Z\left(T_{1}\right) Z\left(T_{2}\right)=Z\left(T_{1} \cdot T_{2}\right)$ holds for two string links $T_{1}, T_{2}$.
(III) Every $Z(T)$ is group-like in $\mathcal{A}\left(\uparrow^{q}\right)$, i.e., $\Delta(Z(T))=Z(T) \otimes Z(T)$.
(IV) (Doubling Formula) For $i \leq q$ and $T \in \mathcal{A}\left(\uparrow^{q}\right)$, one has that

$$
\Delta_{i}(Z(T))=Z\left(D_{i}(T)\right) \in \mathcal{A}\left(\uparrow^{q+1}\right)
$$

where $D_{i}(T)$ denotes the double of $T$ along the $i$-th component, $C_{i}$, and $\Delta_{i}$ of a diagram is the sum over all lifts of vertices on $C_{i}$, to vertices on the two components over $C_{i}$.

Recalling the tree subspace $\mathcal{A}^{t}\left(\uparrow^{q}\right)$, we take the projection $p^{t}: \mathcal{A}(q) \rightarrow \mathcal{A}^{t}\left(\uparrow^{q}\right)$. We denote by $Z_{<m}^{t}(T)$ the composite $p^{t} \circ Z(T)$ subject to $O(m)$. In other words, this $Z_{<m}^{t}(T)$ is a tree reduction of the Kontsevich invariant $Z_{<m}(T)$.


Figure 2: The IHX, AS, and STU relations among chord diagrams.

Furthermore, we need to use the notion of primitive subspaces. Here, $m \in \mathcal{A}\left(\uparrow^{q}\right)$ is called primitive if $\Delta(m)=1 \otimes m+m \otimes 1$. We denote by $\mathcal{P}^{t}\left(\uparrow^{q}\right)$ the subspace of primitive elements of $\mathcal{A}^{t}\left(\uparrow^{q}\right)$, and by $\mathcal{P}_{h}^{t}\left(\uparrow^{q}\right)$ the subspace of degree $h$. As is known, $\mathcal{P}^{t}(q)$ is the graded subspace of $\mathcal{A}^{t}\left(\uparrow^{q}\right)$ generated by chord diagrams such that the the dashed graph $\Gamma$ is simply connected. Furthermore, the rank of $\mathcal{P}_{h}^{t}\left(\uparrow^{q}\right)$ is known to be $q N_{h}-N_{h+1}$; see (12) and Theorem 5.2.

### 3.2 Results

Before stating the theorem, we should mention the following easily proven lemma.
Lemma 3.1. (1) Fix $k \in \mathbb{Z}$. Every elements $a, b$ in $\oplus_{h=k}^{2 k-1} \mathcal{A}_{h}\left(\uparrow^{q}\right)$ satisfy $(1+a) \cdot(1+b) \equiv$ $1+a+b+O(2 k) \in \mathcal{A}\left(\uparrow^{q}\right)$.
(2) Let $a \in \mathcal{A}\left(\uparrow^{q}\right)$ satisfy $a=1+O(k)$, and $\Delta(a)=a \otimes a$. If we decompose $a=1+b+c$ such that $b \in \mathcal{A}_{<2 k}\left(\uparrow^{q}\right)$ and $c \in O(2 k)$, then $b$ is primitive.

As is known HM, if a string link $T$ satisfies $\mathfrak{A}_{k+1}$ of the closure $\bar{T}, Z^{t}(T)=1+O(k-1)$; thus, we can see that $Z^{t}(T)_{<2 k}-1 \in \mathcal{P}_{<2 k}^{t}(q)$ from property (III). The theorem is as follows:

Theorem 3.2. There is a linear isomorphism $R: \oplus_{j=k}^{2 k-1} \mathcal{P}_{j}^{t}(q) \rightarrow \operatorname{Ker}\left([\bullet, \bullet]_{k, 2 k} \otimes \mathbb{Q}\right)$ such that the following holds for any string link $T$ satisfying $\mathfrak{A}_{k+1}$ of the closure $\bar{T}$ :

$$
\begin{equation*}
R\left(Z_{<2 k}^{t}(T)-1\right)=x_{1} \otimes \lambda_{1}+\cdots+x_{q} \otimes \lambda_{q} . \tag{6}
\end{equation*}
$$

Since Theorem 2.3 implies that the left-hand side is equivalent to the Orr invariant, we have the following equivalence:

Corollary 3.3. For any string link $T$ satisfying $\mathfrak{A}_{k+1}$ of the closure $\bar{T}$, the Orr invariant $\theta_{k}(L, \tau)$ is equivalent to the tree reduction of the Kontsevich invariant of degree $<2 k$.

Example 3.4. As an example, we give a computation of the Boromean rings $6_{2}^{3}$. Let $P B(q+1)$ denote the pure braid group on $q+1$. Let $\sigma_{i}$ be the geometric braid formed by crossing the $i$-th string over the $(i+1)$-th one. Consider the string link $T$ presented by $\sigma_{1}^{-1} \sigma_{2} \sigma_{1}^{-1} \sigma_{2} \sigma_{1}^{-1} \sigma_{2}$. Then $\bar{T}=6_{2}^{3}$. We can easily verify $\mathfrak{A}_{3}$ and the expressions of the longitudes as

$$
\lambda_{i}=x_{i+2} x_{i} x_{i+1} x_{i}^{-1} x_{i+2}^{-1} x_{i} x_{i+1}^{-1} x_{i}^{-1}=\left[x_{i+2}, x_{i} x_{i+1} x_{i}^{-1}\right] .
$$

where $i \in \mathbb{Z} / 3$. Thus, the $\mu$-invariant forms $\sum_{i=1}^{3} x_{i} \otimes\left[x_{i+2}, x_{i} x_{i+1} x_{i}^{-1}\right]$ modulo $F_{4}$. This value can be computed as something quantitative by using Magnus expansion $\mathcal{M}_{4}$ (see $\S \mathbb{4}$ for the definition of $\mathcal{M}_{m}$ ).

## 4 Proof of Theorem 3.2

As preparation, let us review the notion of group-like expansions and look at Example 4.2. Let $\mathcal{I}_{m} \subset \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle$ be the both-sided ideal generated by polynomials of degree $\geq m$. Consider the augmentation $\varepsilon: \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle \rightarrow \mathbb{Q}$ with $\varepsilon\left(X_{i}\right)=1$, and a coproduct defined by $\Delta\left(X_{i}\right)=X_{i} \otimes 1+X_{i} \otimes 1$. Then, the involution $S: \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle \rightarrow \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle$ which sends $X_{i}$ to $-X_{i}$ makes it into a Hopf algebra. A Magnus expansion (modulo $O(m)$ ) is a group homomorphism $\theta: F \rightarrow\left(\mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m}\right)^{\times}$, that satisfies $\theta(y)=1+[y]+O(2)$
for any $y \in Y$. Furthermore, a group-like expansion is a Magnus expansion $\theta$ satisfying $\Delta(\theta(y))=\theta(y) \otimes \theta(y)$ and $\varepsilon(\theta(y))=1$ for any $y \in Y$. For example, the homomorphism $\mathcal{M}_{m}: F \rightarrow \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m}$ which sends $x_{i}$ to $1+X_{i}$ is not a group-like expansion, but a Magnus expansion.

Remark 4.1. We should mention some of the properties of these expansions (see Ka, Theorem 1.3])
(1) Given another Magnus expansion $\theta^{\prime}$, there is a ring automorphism $S_{\theta^{\prime}}$ on $\mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m}$ such that $\theta_{\text {str }}=S_{\theta^{\prime}} \circ \theta^{\prime}$.
(2) We have $\theta\left(F_{m}\right)=0$, and $\theta$ induces an injection $\theta: F / F_{m} \rightarrow \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m}$. In fact, since the above $\mathcal{M}_{m}$ is injective, the injectivity inherits every $\theta$, by (1). Furthermore, since the restriction on $F_{j} / F_{j+1}$ of $\mathcal{M}_{j+1}$ is additive by definition, that of $\theta$ is also an additive map.
(3) There is a Lie algebra isomorphism from $\mathcal{L} / \mathcal{L}_{\geq m}$ to the subspace,

$$
\begin{equation*}
\mathcal{P}\left(F / F_{m}\right):=\left\{a \in \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m} \mid \Delta(a)=a \otimes 1+1 \otimes a\right\} \tag{7}
\end{equation*}
$$

with the Lie bracket $[a, b]=a b-b a$. The restricted image $\mathcal{M}_{m}\left(F_{m} / F_{m+1}\right)$ is contained in this $\mathcal{P}\left(F / F_{m}\right)$.

Next, the isomorphism (8) below is related to another example of $\theta$ arising from the Kontsevich invariant. For an index pair $(i, j) \in\{1, \ldots, q+1\}^{2}$, let $t_{i, j} \in \mathcal{A}_{1}^{t}\left(\uparrow^{q+1}\right)$ be the Jacobi diagram with only one edge connecting the $i$-th strand to the $j$-th one. Namely,

We denote $\mathcal{A}{ }^{\rightleftharpoons}\left(\uparrow^{q}, *\right)$ by the subalgebra of $\mathcal{A}\left(\uparrow^{q+1}\right)$ generated by $t_{1, q+1}, t_{2, q+1} \ldots, t_{q, q+1}$. Let $F I$ denote the framing independence relation in $\mathcal{A}{ }^{\rightleftharpoons}\left(\uparrow^{q}, *\right)$, where any Jacobi diagram with an isolated chord on the same interval is equal to 0 . Then, as shown [Ma2, (6.2)], we can verify that the map,

$$
\begin{equation*}
\mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m} \longrightarrow \mathcal{A}^{\rightleftharpoons}\left(\uparrow^{q}, *\right) /\left(\mathcal{A}_{\geqq m}^{\rightleftharpoons}\left(\uparrow^{q}, *\right)+F I\right), \tag{8}
\end{equation*}
$$

which sends $X_{i}$ to $t_{i, q+1}$ is a Hopf algebra isomorphism.
Example 4.2 ([Ma2, Proposition 6.2]). We use notation on the pure braid group $P B(q+1)$ in Example 3.4. Let $\sigma_{j, q+1} \in P B(q+1)$ be $\sigma_{q} \sigma_{q-1} \cdots \sigma_{j+1} \sigma_{j}^{2} \sigma_{j+1}^{-1} \cdots \sigma_{j}^{-1}$; see Figure 3, As is well known, there is a semi-direct product decomposition $P B(q+1) \cong F(q) \ltimes P B(q)$, where $F(q)$ is the free group generated by $\sigma_{1, q+1}, \ldots, \sigma_{q, q+1}$, and $P B(q)$ is embedded into $P B(q+1)$ via $\beta \mapsto \beta \times \uparrow$. Thus, any element $g$ of the free group $F(q)$ can be regarded as a pure-braid $P B(q+1) \subset S L(q+1)$. Therefore, we can define $Z^{t}(g) \in \mathcal{A}^{t}\left(\uparrow^{q+1}\right)$. As is shown Ma2, $Z^{t}(g)$ lies in the subalgebra $\mathcal{A} \rightleftharpoons\left(\uparrow^{q}, *\right)$, and the composite,

$$
\begin{equation*}
\theta^{Z}: F \xrightarrow{Z} \mathcal{A}^{\rightleftharpoons}\left(\uparrow^{q}, *\right) /\left(\mathcal{A}_{\geq m}^{\rightleftharpoons}\left(\uparrow^{q+1}\right)+F I\right) \xrightarrow{(8)^{-1}} \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{m}, \tag{9}
\end{equation*}
$$

turns out to be a group-like expansion (Moreover, it was shown to be a "special expansion").

Before turning back to Theorem [3.2, we should mention (10) from [HM, Corollary 12.2]. For a pure braid $\sigma \in P B(q)$, the $\ell$-th longitude, $\lambda_{\ell} \in F(q)$, of $\sigma$ is equal to $(\sigma \times 1)^{-1} \beta_{\ell} D_{\ell}(\sigma) \beta_{\ell}^{-1}$ in $P B(q+1)$. Here, $\beta_{\ell}$ is a braid of the form $\sigma_{1} \sigma_{2} \cdots \sigma_{\ell-1} \in B_{n}$. Thus, the $\theta^{Z}\left(\lambda_{\ell}\right)$ can be computed as

$$
\begin{equation*}
\theta^{Z}\left(\lambda_{\ell}\right)=Z^{t}(\sigma \times 1)^{-1} Z^{t}\left(\beta_{\ell}\right) \Delta_{\ell}\left(Z^{t}(\sigma)\right) Z^{t}\left(\beta_{\ell}\right)^{-1} \in \mathcal{A}^{\rightleftharpoons}\left(\uparrow^{q}, *\right) \tag{10}
\end{equation*}
$$

Proof of Theorem 3.2. Inspired by (10), for $\ell \leq q$, we set up a homomorphism,
$\Upsilon_{\ell}^{(j)}: \mathcal{P}_{j}^{t}\left(\uparrow^{q}\right) \longrightarrow \mathcal{A}_{\leq j}^{\stackrel{\rightharpoonup}{j}}\left(\uparrow^{q}, *\right) / F I \cong \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{j+1} ; a \longmapsto((a+1) \times 1)^{-1} Z^{t}\left(\beta_{\ell}\right) \Delta_{\ell}(a+1) Z^{t}\left(\beta_{\ell}\right)^{-1}$.
Furthermore, we consider the linear homomorphism,

$$
\Upsilon^{(j)}: \mathcal{P}_{j}^{t}\left(\uparrow^{q}\right) \longrightarrow F / F_{2} \otimes_{\mathbb{Z}} \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{j+1} ; \quad a \longmapsto \sum_{\ell: 1 \leq \ell \leq q} x_{i} \otimes \Upsilon_{\ell}^{(j)}(a)
$$

We will show the injectivity of $\Upsilon^{(j)}$ and that the image is equal to

$$
\begin{equation*}
\left\{\sum_{1 \leq \ell \leq q} x_{\ell} \otimes S_{\theta^{z}}\left(a_{\ell}\right) \in F / F_{2} \otimes\left(\mathcal{I}_{j} / \mathcal{I}_{j+1}\right) \mid \Delta\left(a_{i}\right)=a_{i} \otimes a_{i}, \sum_{1 \leq \ell \leq q} a_{\ell} X_{\ell}-X_{\ell} a_{\ell}=0\right\} \tag{11}
\end{equation*}
$$

From Remark 4.1 (3), this subspace (11) can be identified with the kernel of $[\bullet, \bullet]_{j, j+1}$ : $F / F_{2} \otimes \mathcal{L}_{j} / \mathcal{L}_{j+1} \rightarrow \mathcal{L}_{j+1} / \mathcal{L}_{j+2}$. Thus, the rank of (11) is $q N_{j}-N_{j+1}$. As is known (see [L1, HM$]$ ), if some $\left(\alpha_{1}, \ldots, \alpha_{q}\right) \in F_{j} / F_{j+1}$ satisfies $\left[x_{1}, \alpha_{1}\right] \cdots\left[x_{q}, \alpha_{q}\right]=1 \in F / F_{j+1}$, then there exists a string link $T_{\alpha}$ with $\bar{\mu}$-invariants $\left(\lambda_{1}, \ldots, \lambda_{q}\right) \in\left(F_{j}\right)^{q}$ such that $\lambda_{j} \equiv \alpha_{j} \bmod F_{j+1}$. Therefore, by (10), the image of $\Upsilon^{(j)}$ is generated by $\Upsilon^{(j)}\left(Z_{\leq j}^{t}\left(T_{\alpha}\right)-1\right)=\sum_{i=1}^{q} x_{\ell} \otimes \theta^{Z}\left(\lambda_{\ell}\right)$, where $\alpha$ runs over a basis of $\operatorname{Ker}[\bullet, \bullet]_{j, j+1}$. Since the rank of $\mathcal{P}_{j}^{t}\left(\uparrow^{q}\right)$ is $q N_{j}-N_{j+1}, \Upsilon^{(j)}$ must be injective, and the image is (11), as required.

To complete the proof, we will construct the isomorphism $R$ and show the equality (6). Consider

$$
\mathrm{Id}_{\mathbb{Z}^{q}} \otimes \theta^{Z}: \mathbb{Z}^{q} \otimes_{\mathbb{Z}} F_{k} / F_{2 k} \longrightarrow F / F_{2} \otimes_{\mathbb{Z}} \mathbb{Q}\left\langle X_{1}, \ldots, X_{q}\right\rangle / \mathcal{I}_{2 k}
$$

which is an injective homomorphism, by Remark 4.1 (2). The image of $\operatorname{Ker}[\bullet, \bullet]_{j, j+1}$ is contained in (11). We define the isomorphism $R: \operatorname{Ker}\left([\bullet, \bullet]_{k, 2 k-1} \otimes \mathbb{Q}\right) \rightarrow \oplus_{j=k}^{2 k-1} \mathcal{P}_{j}^{t}(q)$ as a linear extension of $\left.\mathrm{Id}_{\mathbb{Z}^{q}} \otimes\left(\mathrm{id}_{\mathbb{Z}^{a}} \otimes \theta^{Z}\right) \circ \oplus_{j=k}^{2 k-1}\left(\Upsilon^{(j)}\right)^{-1}\right)$.

We now prove the equality (6) where the string $\operatorname{link} T$ is a pure braid. Noting that $Z_{<2 k}(T)-$ 1 is primitive by Lemma 3.1, we compute $\Upsilon^{(\ell)}\left(Z_{<2 k}^{t}(T)-1\right)$ as

$$
\sum_{\ell=1}^{q}\left(x_{\ell} \otimes \sum_{j=k}^{2 k-1}\left(\Upsilon_{\ell}^{(j)}\right)\left(Z_{<2 k}^{t}(T)-1\right)\right)=\sum_{\ell=1}^{q} x_{\ell} \otimes\left(\theta^{Z}\left(\lambda_{\ell}\right)\right)=\sum_{\ell=1}^{q} \theta^{Z}\left(x_{\ell}\right) \otimes\left(\theta^{Z}\left(\lambda_{\ell}\right)\right)
$$



Figure 3: The pure braid $\sigma_{j, q+1}$
which is immediately deduced from from (10). By the injectivity of $\theta^{Z}$, this equality implies the desired (6).

Finally, we will prove (6) for any string link $T$ satisfying $\mathfrak{A}_{k+1}$ of the closure $\bar{T}$. As implicitly shown in the proofs of [HM, Propositions 10.6 and Theorem 6.1], there is a pure braid $\sigma$ such that the Milnor invariants of $T$ and $\sigma$ in $F_{k} / F_{2 k}$ are equal. Thus, the invariant of $T \sigma^{-1}$ is zero. Thus, [HM, Theorem 6.1] immediately implies $Z^{t}\left(T \sigma^{-1}\right)=1+O(2 k)$, which leading to $Z^{t}(T)=Z^{t}(\sigma)$ modulo $O(2 k)$ by Lemma 3.1 (1). Hence, $R\left(Z^{t}(T)-1\right)=R\left(Z^{t}(\sigma)-1\right)$ is equal to $\sum_{i=\ell}^{q} x_{i} \otimes \lambda_{\ell}$ by the above paragraph, as desired. It completes the proof.

## 5 Proof of Theorem 2.3

### 5.1 Review of the infinitesimal Morita-Milnor homomorphism, and tree reduction

As a preliminary to prove Theorem [2.3, we review some of the results in Ma1, IO, Ko.
We will start by briefly reviewing the Lie algebra homology of $F / F_{k}$. Let $H$ be the $\mathbb{Q}$ vector space of rank $q$ with basis $X_{1}, \ldots, X_{q}$, i.e., $H=\operatorname{Span}_{\mathbb{Q}}\left\langle X_{1}, \ldots, X_{q}\right\rangle$. Let $\mathfrak{L}$ be the free Lie algebra generated by $H$. This $\mathfrak{L} \geq k^{\text {is the subspace generated by the commutator of length }}$ $\geq k$. We have the quotient Lie algebra $\mathfrak{L} / \mathfrak{L}_{\geq k}$. Then, the Koszul complex of $\mathfrak{L} / \mathfrak{L}_{\geq k}$ is the exterior tensor algebra $\Lambda^{*}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right)$ with the boundary map $\partial_{n}: \Lambda^{n}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right) \rightarrow \Lambda^{n-1}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right)$ given by

$$
\partial_{n}\left(h_{1} \wedge \cdots \wedge h_{n}\right)=\sum_{i<j}(-1)^{i+j}\left[h_{i}, h_{j}\right] \wedge h_{1} \wedge \cdots \wedge \check{h}_{i} \wedge \cdots \wedge \check{h}_{j} \wedge \cdots \wedge h_{n}
$$

Later, we will use the known isomorphism $H_{n}\left(\Lambda^{*}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right)\right) \cong H_{n}\left(F / F_{k} ; \mathbb{Q}\right)$, which is called Pickel's isomorphism; see, e.g., [IO, Ma1, SW].

Next, let us review Jacobi diagrams. A Jacobi diagram is a uni-trivalent graph whose univalent vertices are labeled by one of $\{1,2, \ldots, q\}$, where each trivalent vertex is oriented. Consider the graded $\mathbb{Q}$-vector space generated by Jacobi diagrams, where the degree of such a diagram is half the number of vertices. Let $\mathcal{J}(q)$ be the quotient space subject to the AS and IHX relations, and let $\mathcal{J}^{t}(q) \subset \mathcal{J}(q)$ be the subspace generated by Jacobi diagrams which are simply connected. As a diagrammatic analogy of the Poincaré-Birkhoff-Witt theorem, we can construct a graded vector isomorphism,

$$
\begin{equation*}
\chi_{q}: \mathcal{P}_{n}^{t}\left(\uparrow^{q}\right) \cong \mathcal{J}_{n}^{t}(q) \tag{12}
\end{equation*}
$$

See, e.g., [CDM, §5.7] for details.
Remark 5.1. Theorem 3.2 implies a generalization of the main theorem 6.1 of [HM]. In fact, recalling from Theorem 2.2 (II) the $k$-th summand of $\theta_{k}(L, \tau)$ is the Milnor invariant of length $k$, the equivalence between the Milnor invariant and $\chi_{q}\left(Z_{k}^{t}(T)-1\right)$ coincides with the theorem 6.1 of [HM exactly.

Furthermore, we consider the subspace $\mathcal{J}_{n}(q, 0)$ of $\mathcal{J}_{n}(q+1)$ generated by tree diagrams in which the label $q+1$ occurs exactly once. Given such a diagram $J \in \mathcal{J}_{n}(q, 0)$, all of its univalent vertices apart from one labeled by $r$ defines $\operatorname{comm}(J)$ in $F_{n} / F_{n+1}$ in a canonical way. For example,


Then, we can easily see that the following correspondence is an isomorphism,

$$
\operatorname{comm}: \mathcal{J}_{n}(q, 0) \longrightarrow F_{n} / F_{n+1} \otimes \mathbb{Q} .
$$

Next, we will review the infinitesimal Morita-Milnor homomorphism, $M_{k}$, defined in Ko, §5.1] (cf. the infinitesimal Morita map in Ma2]). For this, a string link $T \in S L(q)$ is of degree $k$ if the closure $\bar{T}$ satisfies Assumption $\mathfrak{A}_{k+1}$. Let $S L(q)_{k}$ be the subset consisting of string links of degree $k$. Then, we have a filtration,

$$
S L(q)=S L(q)_{0} \supset S L(q)_{1} \supset \cdots \supset S L(q)_{k} \supset \cdots
$$

Further, we recall the $\bar{\mu}$-invariants $\lambda_{\ell} \in F_{k} / F_{2 k-1}$ and expand them as $\lambda_{\ell}=\lambda_{\ell}^{(k)}+\cdots+\lambda_{\ell}^{(2 k-2)}$ with $\lambda_{\ell}^{(j)} \in F_{j} / F_{j+1}$ according to $F_{k} / F_{2 k-1} \cong \oplus_{j=k}^{2 k-2} F_{j} / F_{j+1}$. Recall that, if $L \in S L(q)_{k}$ is of degree $k$, the $\bar{\mu}$-invariants $\lambda_{\ell}$ are contained in $F_{k}$. Then, identifying $F_{j} / F_{j+1} \otimes \mathbb{Q}$ with $\mathfrak{L}_{j} / \mathfrak{L}_{j+1}$ as a $\mathbb{Q}$-vector space, let us consider a 2 -form,

$$
\begin{equation*}
\sigma_{L}:=\sum_{j=k}^{2 k-2} \sum_{\ell=1}^{q} X_{\ell} \wedge \lambda_{\ell}^{(j)} \in \Lambda^{2}\left(\mathfrak{L} / \mathfrak{L}_{\geq 2 k-1}\right) \tag{13}
\end{equation*}
$$

As is shown in $\S 5.1$ of $\left[\mathrm{KO}\right.$, there exists $t_{L} \in \Lambda^{3}\left(\mathfrak{L} / \mathfrak{L}_{\geq 2 k-1}\right)$ satisfying $\partial_{3}\left(t_{L}\right)=\sigma_{L}$. Since $\lambda_{\ell} \in F_{k}$ by Assumption $\mathfrak{A}_{k+1}$, the 2 -form $\sigma_{L}$ reduced in $\Lambda^{2}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right)$ is zero. Hence, $t_{L}$ is a 3 -cycle. It has been shown $\left[\right.$ Ko, Lemma 5.1.2] that the homology 3 -class $\left[\left\{t_{L}\right\}\right] \in H_{3}(\mathfrak{L} / \mathfrak{L} \geq k)$ is independent of the choice of $t_{L}$. To summarize, we have a map,

$$
M_{k}: S L(q)_{k} \longrightarrow H_{3}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right) ; \quad L \longmapsto\left[\left\{t_{L}\right\}\right] .
$$

Kodani [K0, §5] showed that $M_{k}$ is a monoid homomorphism and its kernel is $S L(q)_{2 k-1}$.
Now let us review the tree description of the third homology [Ma1]. Fix a tree diagram $J \in \mathcal{J}_{j}^{t}(q)$. For each trivalent vertex $r$ of $J, J$ is the union of the three tree diagrams rooted as $r$. We denote the three tree diagrams by $J_{r}^{(1)}, J_{r}^{(2)}$, and $J_{r}^{(3)}$, by clockwise rotation. Here, the numbering $1,2,3$ is according to the cyclic ordering of $r$. Furthermore, if we label a univalent $r$ by $q+1$, each $J_{r}^{(j)}$ can be regarded as an element in $\mathcal{J}^{t}(q, 0)$. Then, the fission map $\phi: \mathcal{J}_{j}^{t}(q) \rightarrow \Lambda^{3}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right)$ is defined by

$$
\phi(J)=\sum_{r: \text { trivalent vertex of } J} \operatorname{comm}\left(J_{r}^{(3)}\right) \wedge \operatorname{comm}\left(J_{r}^{(2)}\right) \wedge \operatorname{comm}\left(J_{r}^{(1)}\right) .
$$

Theorem 5.2 ([Ma1]). If $k \leq j \leq 2 k-2$, this $\phi(J)$ is a 3-cycle. Moreover, the fission map gives rise to a linear isomorphism,

$$
\Phi: \bigoplus_{j=k}^{2 k-2} \mathcal{J}_{j}^{t}(q) \xrightarrow{\sim} H_{3}\left(\mathfrak{L} / \mathfrak{L}_{\geq k}\right) .
$$

Next, let us review the isomorphism (15) below. For a Jacobi diagram $J^{(j)} \in \mathcal{J}_{j}^{t}(q)$, we define $\eta_{j}\left(J^{(j)}\right)$ to be the sum,

$$
\begin{equation*}
\sum_{v: \text { univalent vertex of } J^{(j)}}\left[x_{\operatorname{col}(v)}\right] \otimes \operatorname{comm}\left(J_{v}^{(j)}\right) \in\left(F / F_{2}\right) \otimes_{\mathbb{Q}}\left(\mathcal{L} / \mathcal{L}_{>j}\right) \tag{14}
\end{equation*}
$$

where $\operatorname{col}(v) \in\{1, \cdots, q\}$ is the label on $v$, and $J_{v}^{(j)} \in \mathcal{J}_{j}^{t}(q, 0)$ is the labelled tree obtained by replacing the label on $v$ with $q+1$. Taking the bracket $[-,-]: F / F_{2} \otimes \mathcal{L}_{j} \rightarrow \mathcal{L}_{j+1}$, which $(x, y)$ sends $x y x^{-1} y^{-1}$, we can easily verify that the sum (14) lies in the kernel. Then, this $\eta_{j}$ defines a linear homomorphism,

$$
\begin{equation*}
\eta_{j}: \mathcal{J}_{j}^{t}(q) \longrightarrow \operatorname{Ker}\left([-,-]: F / F_{2} \otimes \mathcal{L}_{j} / \mathcal{L}_{j+1} \rightarrow \mathcal{L}_{j+1} / \mathcal{L}_{j+2}\right) \tag{15}
\end{equation*}
$$

which is known to be an isomorphism; see [L2]. We denote by $\eta$ the sum of the isomorphisms $\oplus_{j=k}^{2 k-2} \eta_{j}$ for short.

### 5.2 Proof of Theorem 3.2

Then, the following lemma relates to the 3 -class $\left[t_{L}\right]$ from tree diagrams:
Lemma 5.3. For $T \in S L(q)_{k}$, the composite $\Phi \circ \eta^{-1}\left(\sum_{\ell=1}^{q} x_{\ell} \otimes \lambda_{\ell}\right)$ coincides with $M_{k}(T)=\left[t_{L}\right]$. Proof. Let $J^{(j)} \in \mathcal{J}_{j}^{t}(q)$ be $(\eta)_{j}^{-1}\left(\sum_{i=1}^{q} x_{i}^{(j)} \otimes \lambda_{i}^{(j)}\right)$. As is shown in [Ma1, Lemma 1.2], the composite $\partial_{3}\left(\phi\left(J^{(j)}\right)\right)$ is formed as

$$
\partial_{3}\left(\phi\left(J^{(j)}\right)\right)=\sum_{v \text { :univalent vertex of } J^{(j)}} X_{\operatorname{col}(v)} \wedge \operatorname{comm}\left(J^{(j)}\right) \in \wedge^{2}\left(\mathcal{L} / \mathcal{L}_{\geq 2 k}\right) .
$$

Compared with (14), this $\partial_{3}\left(\phi\left(J^{(j)}\right)\right)$ is equal to $\sigma_{L} \in \wedge^{2}\left(\mathcal{L} / \mathcal{L}_{\geq 2 k}\right)$ by definition. Thus, letting $t_{L}$ be $\sum_{j=k}^{2 k-2} \phi\left(J^{(j)}\right)$, we get a 3 -chain $t_{L}$ satisfying $\partial_{3}\left(t_{L}\right)=\sigma_{L}$, leading to the desired coincidence.

We can prove Theorem 2.3 by showing that the 3 -class $\left[t_{L}\right]$ is equal to the Orr invariant of degree $k$. For this, we will have to prove the following lemma.

Lemma 5.4. From the identification $H_{3}\left(\mathcal{L} / \mathcal{L}_{\geq k}\right) \cong H_{3}^{\mathrm{gr}}\left(F / F_{k} ; \mathbb{Q}\right)$, the homomorphism $M_{k}$ is equal to a map which sends the 3-class $t_{L}$ to $\mathfrak{H} \circ \theta_{k}(\bar{T}, \tau)$.

Before proving this lemma, we now prove Theorem 2.3.
Proof of Theorem 2.3. The proof of (I) immediately follows from Lemmas 5.3 and 5.4 .
Now let us show (II). Fix a basis $\left\{b_{s}\right\}$ of $H_{3}\left(F / F_{k} ; \mathbb{Z}\right)$, where $s$ ranges over $1 \leq s \leq$ $\operatorname{rk} H_{3}\left(F / F_{k} ; \mathbb{Z}\right)$. Thanks to Theorem [2.2 (III), we can choose a string link $L_{s}$ such that $\mathfrak{H}\left(\theta_{k}\left(\overline{L_{s}}, \tau\right)\right)=b_{s}$ and the component of $\theta_{k}\left(\overline{L_{s}}, \tau\right)$ in the kernel Ker $\mathfrak{H}$ is zero. Then, from (1), the $\bar{\mu}$-invariant of $L_{s}$ in $F_{k} / F_{2 k}$ is $\eta \circ \Phi^{-1}\left(b_{s}\right)+\sum_{j=1}^{q} x_{j} \otimes \lambda_{j, s}^{(2 k)}$ for some $\lambda_{j, s}^{(2 k)} \in F_{2 k-1} / F_{2 k} \otimes \mathbb{Q}$. Recalling the isomorphism $\operatorname{Ker} \mathfrak{H} \otimes \mathbb{Q} \cong \mathbb{Q}^{q N_{2 k-1}-N_{2 k}}$, we fix the isomorphism $\iota: \mathbb{Q}^{q N_{2 k-1}-N_{2 k}} \rightarrow$ $\operatorname{Ker}[\bullet, \bullet]_{2 k-1,2 k}$ and define the bijection,

$$
\bar{\Psi}_{k}:\left(H_{3}\left(F / F_{k} ; \mathbb{Z}\right) \oplus \operatorname{Ker} \mathfrak{H}\right) \otimes \mathbb{Q} \longrightarrow \operatorname{Ker}[\bullet, \bullet]_{k, 2 k},
$$

by setting

$$
\bar{\Psi}_{k}\left(\left(b_{s}, a\right) \otimes r\right)=r\left(\eta \circ \Phi^{-1}\left(b_{s}\right)-\left(x_{1} \otimes \lambda_{1, s}^{(2 k)}+\cdots+x_{q} \otimes \lambda_{q, s}^{(2 k)}\right)+\iota(a)\right), \quad r \in \mathbb{Q} .
$$

Let $\bar{\Phi}$ be $\bar{\Psi}_{k}^{-1}$. Then it suffices to show the desired equality $x_{1} \otimes \lambda_{1}+\cdots+x_{q} \otimes \lambda_{q}=$ $\bar{\Psi}_{k}\left(\theta_{k}(\bar{T}, \tau)\right)$ for any string link $T$ of degree $k$. Suppose $\mathfrak{H} \circ \theta_{k}(\bar{T}, \tau)=\sum_{s} \alpha_{s} b_{s}$ for some $\alpha_{s} \in \mathbb{Z}$. Then, the stucking $T \sharp\left(\sharp_{s}\left(L_{s}\right)^{-\alpha_{s}}\right)$ is of degree $k+1$. Let $\mathfrak{H}^{\prime}$ be the Hurewicz map $\pi_{3}\left(K_{k+1}\right) \rightarrow H_{3}\left(F / F_{k+1}\right)$. Using the additivity of $\theta_{k}$ and of the $\bar{\mu}$-invariants, we can compute $\bar{\Psi}_{k}\left(\theta_{k}(\bar{T}, \tau)\right)$ restricted to the kernel of $[\bullet, \bullet]: F / F_{2} \times F_{2 k-1} / F_{2 k} \rightarrow F_{2 k} / F_{2 k+1}$ as

$$
\begin{aligned}
& \bar{\Psi}_{k}\left(\theta_{k}(\bar{T}, \tau)\right)=\bar{\Psi}_{k}\left(\theta_{k}\left(\bar{T} \sharp\left(\sharp_{s}\left(L_{s}\right)^{-\alpha_{s}}\right), \tau\right)+\theta_{k}\left(\sharp_{s}\left(L_{s}\right)^{\alpha_{s}}, \tau\right)\right) \\
& =\bar{\Psi}_{k}\left(\theta_{k}\left(\bar{T} \sharp\left(\sharp_{s}\left(L_{s}\right)^{-\alpha_{s}}\right), \tau\right)\right)+\bar{\Psi}_{k}\left(\theta_{k}\left(\not \sharp_{s}\left(L_{s}\right)^{\alpha_{s}}, \tau\right)\right) \\
& =\bar{\Psi}_{k+1} \circ \mathfrak{H}^{\prime}\left(\theta_{k+1}\left(\bar{T} \sharp\left(\sharp_{s}\left(L_{s}\right)^{-\alpha_{s}}\right), \tau\right)\right)+\bar{\Psi}_{k}\left(\sum_{s} \alpha_{s}\left(b_{s}, 0\right)\right) \\
& =\sum_{j=1}^{q} X_{i} \otimes \lambda_{j}\left(T \sharp\left(\not \sharp_{s}\left(L_{s}\right)^{-\alpha_{s}}\right)+\sum_{s} \alpha_{s}\left(x_{1} \otimes \lambda_{1, s}^{(2 k)}+\cdots+x_{q} \otimes \lambda_{q, s}^{(2 k)}\right)=\sum_{j=1}^{q} x_{i} \otimes \lambda_{j}(T),\right.
\end{aligned}
$$

as desired. Here, the third equality is obtained from (II), and the last is done from additivity of $\lambda$.

Proof of Lemma 5.4. First, we set up some complexes and chain maps. In what follows, we consider only complexes over $\mathbb{Q}$ and omit writing the coefficients $\mathbb{Q}$. Let $\left(C_{*}^{\mathrm{gr}}\left(F / F_{k}\right), \partial_{*}\right)$ be the non-homogenous group complex of $F / F_{k}$. Then, on the basis of Suslin and Wodzicki's paper [SW], Massuyeau (see the proof of [Ma1, Proposition 4.3]) showed the natural existence of a chain map $\kappa: \bigwedge^{*}\left(\mathcal{L} / \mathcal{L}_{\geq k}\right) \rightarrow C_{*}^{\text {gr }}\left(F / F_{k}\right)$ that induces an isomorphism on the homology. Thus, it is enough for us to show that the 3-cycle $\kappa\left(t_{L}\right)$ is equivalent to the pushforward $\left(f_{k}\right)_{*}\left[S^{3} \backslash \bar{T}, \partial\left(S^{3} \backslash \bar{T}\right)\right]$.

To do so, we can study the 3-cycle $t_{L}$ from the viewpoint of the group complex. For $\ell \leq q$, let $K_{\ell}$ be the abelian subgroup of $F$ generated by the meridian-longitude pair $\left(\mathfrak{m}_{\ell}, \mathfrak{l}_{\ell}\right)$. Let us consider the commutative diagram,

where the right-hand sides are defined as the cokernel of $\iota_{*}$. In the subcomplex $C_{2}^{\mathrm{gr}}\left(K_{\ell}\right)$, the cross product $\mathfrak{m}_{\ell} \times \mathfrak{l}_{\ell}$ is a 2-cycle that generates $H_{2}^{\mathrm{gr}}\left(K_{\ell}\right) \cong \mathbb{Z}$. Let $\tau_{L}$ be a 2 -cycle $\sum_{\ell=1}^{q} \mathfrak{m}_{\ell} \times \mathfrak{l}_{\ell} \in \oplus_{\ell=1}^{q} C_{2}^{\mathrm{gr}}\left(K_{\ell}\right)$. Accordingly, since $H_{2}^{\mathrm{gr}}(F)=0$, we can choose a 3-cycle $\eta_{L}$ in $C_{3}^{\mathrm{gr}}\left(F, K_{1} \cup \cdots \cup K_{q}\right)$ such that $\delta_{*}\left(\eta_{L}\right)=\tau_{L}$.

Next, we will examine the diagrams subject to $F_{k}$ and $F_{2 k}$ with regard to their functoriality:


Here, the horizontal arrows are exact, and the slanting ones are the maps induced from the projection $F / F_{2 k-1} \rightarrow F / F_{k}$. Since the above quasi-isomorphism $\kappa$ was constructed from the projective resolution of the augmentation $\varepsilon: \mathbb{Q}[G] \rightarrow \mathbb{Q}$, this $\kappa$ replaces the wedge product $\wedge$ by the cross product $\times$. Therefore, recalling the isomorphism $\phi^{*}$ in (4), the 2 -cycle $\phi_{*}^{-1}\left(\tau_{L}\right)$ modulo $F_{2 k}$ is exactly equal to $\sigma_{L}$ in (13). Thus, the 3 -cycle $t_{L} \in C_{3}^{\text {gr }}\left(F / F_{2 k-1}\right)$ satisfies $P^{\mathrm{gr}}\left(t_{L}\right)=\phi_{*}^{-1}\left(\eta_{L}\right) \in H_{3}^{\mathrm{gr}}\left(F / F_{k}\right)$.

Finally, we give a relation to the link complement $S^{3} \backslash \bar{T}$. Let $E$ denote $S^{3} \backslash \bar{T}$. Similarly, let us consider the long exact sequence on the cellular homology:

$$
0 \rightarrow H_{3}^{\text {cell }}(E, \partial E ; \mathbb{Q}) \xrightarrow{\delta} H_{2}^{\text {cell }}(\partial E ; \mathbb{Q}) \longrightarrow H_{2}^{\text {cell }}(E ; \mathbb{Q}) \longrightarrow H_{2}^{\text {cell }}(E, \partial E ; \mathbb{Q})
$$

Here are some well-known facts from knot theory: The first term is $\mathbb{Q}$ generated by the fundamental 3-class $[E, \partial E]$, and the second is $\mathbb{Q}^{q}$ generated by the cross products $\mathfrak{m}_{\ell} \times \mathfrak{l}_{\ell}$. Further, the sum $\sum_{\ell=1}^{q} \mathfrak{m}_{\ell} \times \mathfrak{l}_{\ell}$ is zero in $H_{2}^{\text {cell }}(E ; \mathbb{Q})$ by relation (5). Thus, we have a cellular 3 -chain $\overline{b_{L}} \in C_{3}^{\text {cell }}(E, \partial E ; \mathbb{Q})$ such that $\left(P_{3}\right)_{*}\left[\overline{b_{L}}\right]=[E, \partial E]$ in the relative $C_{3}^{\text {cell }}(E, \partial E ; \mathbb{Q})$ and $\partial_{3}\left(\overline{b_{L}}\right)=\sum_{\ell=1}^{q} \mathfrak{m}_{\ell} \times \mathfrak{l}_{\ell}$. In particular, letting $I:[0,1]^{3} \backslash T \rightarrow S^{3} \backslash \bar{T}$ be the inclusion, we have $[E, \partial E]=I_{*}\left(\eta_{L}\right)$. Notice that $f_{k} \circ I_{*}: \pi_{1}\left([0,1]^{3} \backslash T\right) \rightarrow F / F_{k}$ is equal to the reduction $F \rightarrow F / F_{k}$. Hence, noting $\left(f_{k}\right)_{*} \circ I_{*}=\phi_{*}^{-1}$, we obtain the computation,

$$
\left(f_{k}\right)_{*}[E, \partial E]=\left(f_{k}\right)_{*} \circ I_{*}\left(\eta_{L}\right)=\phi_{*}^{-1}\left(\eta_{L}\right)=P^{\mathrm{gr}}\left(t_{L}\right) \in H_{3}^{\mathrm{gr}}\left(F / F_{k}, \cup_{\ell} K_{\ell}\right)
$$

Since $K_{\ell}$ modulo $F_{k}$ is isomorphic to $\mathbb{Z}$ from Assumption $\mathfrak{A}_{k+1}, P^{\mathrm{gr}}$ induces $H_{3}^{\mathrm{gr}}\left(F / F_{k}\right) \cong$ $H_{3}^{\mathrm{gr}}\left(F / F_{k}, \cup_{\ell} K_{\ell}\right)$. Hence, $t_{L}$ is equivalent to the pushforward $\left(f_{k}\right)_{*}[E, \partial E]$, as desired.

## A HOMFLYPT polynomials and Orr invariants

Let $T$ be a string link and $(\bar{T}, \tau)$ be the associated based link. According to Theorem [2.3, the computation of the Orr invariant of $(\bar{T}, \tau)$ is equivalent to the $\bar{\mu}$-invariant of $T$ of degree $<2 k$. In general, it is hard to get a presentation of longitudes $\lambda_{\ell}$ as a word of $x_{1}, \ldots, x_{q}$ (However, if $T$ is a pure braid, we can easily get such a presentation). Furthermore, in quantum topology, it is natural to ask what finite type invariants recover the $\bar{\mu}$-invariants. As a solution, we will show that the result of Meilhan-Yasuhara [MY] give a computation of the $\bar{\mu}$-invariants from HOMFLYPT polynomials, without having to write longitudes (Theorem A.1).

To describe the result, we should recall the HOMFLYPT polynomial and some of its properties. The HOMFLYPT polynomial $P(L ; t, z) \in \mathbb{Z}\left[t^{ \pm 1}, z^{ \pm 1}\right]$ of an oriented link $L \subset S^{3}$ is defined formulas as follows:
(I) Concerning the unknot $U$ in $S^{3}$, the polynomial $P(U ; t, z)$ is 1 .
(II) The skein relation $t \cdot P\left(L_{+} ; t, z\right)+t^{-1} \cdot P\left(L_{-} ; t, z\right)=z \cdot P\left(L_{0} ; t, z\right)$ holds, where $L_{-}, L_{+}$, and $L_{0}$ are links formed by crossing and smoothing changes on a local region of a link diagram, as indicated in Figure 4 .

Furthermore, given a $q$-component link $L$, we can expand the HOMFLYPT polynomial as

$$
P(L ; t, z)=\sum_{k=1}^{N} P_{2 k-1-q}(L ; t) z^{2 k-1-q}
$$

for some $N \in \mathbb{N}$, where $P_{2 k-1-q}(L ; t) \in \mathbb{Z}\left[t^{ \pm 1}\right]$. Consider the logarithm $\log \left(P_{0}(L, t)\right)$ as a smooth function in $C^{\infty}(\mathbb{R})$. We denote by $\left(\log \left(P_{0}(L, t)\right)^{(n)}\right.$ the $n$-th derivative of $\log \left(P_{0}(L, t)\right)$ evaluated at $t=1$.

Next, we review the notation used in MY. Let $T=\cup_{i=1}^{q} T_{i}$ be a $q$-component string link in the 3 -cube, and take an index $I=i_{1} i_{2} \cdots i_{m} \in\{1, \ldots, q\}^{m}$. Let $r_{i}$ be the cardinality $\#\left\{k \mid i_{k}=i\right\}$. We can define another link $D_{I}(T)$ of $q$-components in the following manner:
(1) Replace each string $T_{i}$ by $r_{i}$ zero-framed parallel copies of $T_{i}$. Here, we write $T_{(i, j)}$ for the $j$-th copy. If $r_{i}=0$ for some index $i$, we delete $L_{i}$.
(2) We define $D_{I}(T)$ to be the $m$-component link $\cup_{i, j} T_{(i, j)}$ with the order induced by the lexicographic order of the index $(i, j)$. This ordering defines a bijection $\{(i, j) \mid 1 \leq i \leq$ $\left.q, 1 \leq j \leq r_{i}\right\} \rightarrow\{1, \ldots, m\}$.
In addition, we define a sequence $D_{I}(T) \in\{1, \ldots, m\}^{m}$ without a repeated index as follows. First, we take a sequence of elements of $\left\{(i, j) \mid 1 \leq i \leq q, 1 \leq j \leq r_{i}\right\} \rightarrow\{1, \ldots, m\}$ by replacing each $i$ in $I$ with $(i, 1), \ldots,\left(i, r_{i}\right)$ in this order. Next, we replace each term $(i, j)$ of this sequence with $\varphi((i, j))$.

In addition, given a subsequence $H<D(I)$, we define another link $D_{I}(T)_{J}$. Let $B_{I}$ be an oriented $2 m$-gon, and denote by $p_{j}(j=1, \ldots, m)$ a set of $m$ nonadjacent edges of $B_{I}$ according to the boundary orientation. Suppose that $B_{I}$ is embedded in $S^{3}$ such that $B_{I} \cap L=\cup_{j=1}^{m} p_{j}$ and such that each $p_{j}$ is contained in $L_{i_{j}}$ with opposite orientation. We call such a disk an $I$-fusion disk of $D_{I}(L)$. For any subsequence $J$ of $D(I)$, we define the oriented link $L_{J}$ as the closure of

$$
\bigcup_{j \in\{J\}}\left(L_{j} \cap \partial B_{I}\right) \backslash\left(\bigcup_{j \in\{J\}}\left(L_{j} \cap B_{I}\right)\right),
$$

where $\{J\}$ is the subset of $\{1, \ldots, n\}$ of all indices appearing in the sequence $J$.


Figure 4: The links $L_{+}, L_{-}$, and $L_{0}$.

Consider the homomorphism $\mathcal{M}_{m}: F \rightarrow \mathbb{Z}\left[X_{1}, \ldots, X_{q}\right] / \mathcal{I}_{m}$ defined by $\mathcal{M}_{m}\left(x_{i}\right)=1+$ $X_{i}$. For a sequence in $I=i_{1} \cdots i_{m} \in\{1,2, \ldots, q\}^{m}, \mu_{I}(T)$ is defined by the coefficient of $X_{i_{1}} \cdots X_{i_{m-1}}$ in $\mathcal{M}_{m}\left(\lambda_{i_{m}}\right)$ as in [Mi2, L1, (O, MY].

Theorem A. 1 ([MY]). Let $T$ be a q-component string link which satisfies $\mathfrak{A}_{k+1}$. Assume $3 \leq m \leq 2 k+2$. Let $I$ be a sequence in $\{1,2, \ldots, q\}^{m}$ of length $m$. For any $D_{I}$-fusion disk for $D_{I}(T)$, we have

$$
\mu_{I}(T)=\frac{(-1)}{m!2^{m}} \sum_{J<D(I)}(-1)^{|J|} \log P_{0}\left(\overline{D_{I}(T)_{J}}\right)^{(m)}
$$

The original statement [MY, Theorem 1.3] dealt with only links $S^{3}$ and takes the same formula modulo some integers. However, as can be seen in their proof, after the authors proved Theorem A. 1 for string links before they proved the original statement. Thus, we do not need to give a detailed proof of Theorem A.1.
