# A NOTE ON CONSTRUCTION OF DUAL-HAMILTONIAN GRAPHS

#### Abstract

A connected simple graph is said dual-hamiltonian if its vertex set has a 2-coloring such that each color class induces a tree. We call such a coloring a hamiltonian coloring. We prove that if $G$ is a graph with a certain type of hamiltonian coloring and $T$ is a tree, then $G \times T$ is also dual-hamiltonian having the same certain type of hamiltonian coloring. This result is used to constructed a class of dual-hamiltonian graphs, which includes the hypercubes and other multidimensional grids.


Key words: dual-hamiltonian, Yutsis graph, induced tree, cocircuit, bond.
A bond in a connected graph is a minimal set with the property that its deletion results in a disconnected graph. A bond in a connected graph $G$ has at most $\|G\|-|G|+2$ edges; when a bond has this size it is a hamiltonian bond. A graph is dual-hamiltonian if it has a hamiltonian bond. Some authors call dual-hamiltonian graphs Yutsis graphs. An alternative definition for dual-hamiltonian graphs is provided by the following result:
Theorem 1. (Jaeger [3]) A subset $B \subseteq E(G)$ is a hamiltonian bond of a connected graph $G$ if and only if $G \backslash B$ has two induced trees of $G$ as connected components.

If $G$ is a planar graph with dual graph $G^{*}$, then each hamiltonian bond of $G$ corresponds to a hamiltonian cycle of $G^{*}$. Determining if a graph is dual-hamiltonian is an NP-complete problem. Indeed, it is in the NP class by the certificate provided by Theorem 1 and it is NPcomplete because determining if a planar graph is hamiltonian is an NP-complete problem [2].

The most notorious problem about dual-hamiltonian graphs is probably Jaeger's conjecture [3] that all cyclically 4 -connected cubic graphs are dual-hamiltonian. Whitney [5] proved that the planar case of this conjecture is equivalent to the Four Colors Theorem. Another motivation to study dual-hamiltonian graphs is their application in quantum mechanics (see [4] for more references).

Some necessary conditions for dual-hamiltonianicity are established in [1]. We can add one more that follows from Theorem 1 with a straightforward calculation:
Corollary 2. If G is a dual-hamiltonian graph, then each induced subgraph H of G satisfies $\|H\| \leq|H|-2+|H|^{2} / 4$.

To the best of our knowledge, in opposition to hamiltonianicity, not many sufficient conditions for dual-hamiltonianicity are established in literature. This make establishing if some important classes of graphs are dual-hamiltonian a bit hard. Our objective here is to provide some tools for constructing dual-hamiltonian graphs using cartesian product of graphs. Our results were first motivated by the conjecture of Haidong Wu and Melissa Flynn (private communication) that all hypercubes are dual-hamiltonian; the $n$-dimensional hypercube $Q_{n}$ may be defined as the graph with $\{0,1\}^{n}$ as vertex-set and such that two vertices are adjacent if and only if they differ by exactly one coordinate. We will establish that Flynn's and Wu's conjecture is true in Corollary 4 .

Before stating the main result, some definitions are necessary. Let $G$ be a graph and let $C$ be a 2-coloring of $V(G)$. We say that $C$ is a hamiltonian coloring of $G$ if each color class

[^0]of $C$ induces a tree in $G$. By Theorem 1 a 2 -coloring $C$ of $G$ is hamiltonian if and only if the set of edges with edvertices of different colors is a hamiltonian bond of $G$. If $X \subseteq V(G)$ and $C$ is a 2 -coloring of $V(G)$, we denote by $C \Delta X$ the 2 -coloring obtained from $C$ by switching the colors of the vertices in $X$. If $C$ is a hamiltonian coloring of $G$ and $I$ and $J$ are disjoint 2-subsets of $V(G)$, we say that $(I, J)$ is a quartet of $C$ if:
(Q1) both $I$ and $J$ have one vertex of each color,
(Q2) $C \Delta I$ is a hamiltonian coloring of $G$, and
(Q3) each color class of $C \Delta J$ induces a forest with exactly two connected components: one meeting $I$ and the other meeting $J$.
The cartesian product $G \times H$ of two graphs $G$ and $H$ is defined as the graph with vertex set $V(G) \times V(H)$ and edge-set as the union of $\{(u, x)(v, x): u v \in E(G)$ and $x \in V(H)\}$ and $\{(u, x)(u, y): u \in V(G)$ and $x y \in E(H)\}$. The next theorem is our main result:
Theorem 3. Let $G$ be a connected graph and $T$ be a tree. If $G$ has a hamiltonian coloring with a quartet, then $G \times T$ also has a hamiltonian coloring with a quartet.

The variation of Theorem 3 where the hamiltonian colorings do not necessarily have quartets is not valid. Indeed, let $T_{1}$ and $T_{2}$ be disjoint trees, each one having a simple path with three edges, and let $G$ be the graph obtained from $T_{1} \cup T_{2}$ by adding all possible edges linking a vertex of $T_{1}$ to a vertex of $T_{2}$. Note that $\left\{V\left(T_{1}\right), V\left(T_{2}\right)\right\}$ is the unique 2-partition of $V(G)$ such that both members induce forests in $G$. This implies that $G \times T$ is not dual-hamiltonian for each tree $T$ with at least two vertices. This paper contains only one more section, which is dedicated to proving Theorem3,

From Theorem 3 we derive the next corollary. This result was proved for $n \leq 5$ and conjectured in general in an unpublished undergraduate thesis written by Melissa Flynn under supervision of Haidong Wu.
Corollary 4. For $n \geq 2$, the $n$-dimensional hypercube $Q_{n}$ is dual-hamiltonian. Moreover, for $n \geq 3, Q_{n}$ has a hamiltonian coloring with a quartet.

We denote by $P_{n}$ the path graph with $n$ edges. It is straightforward to check that $Q_{1}$ and $Q_{2}$ are dual-hamiltonian. Since $Q_{n} \cong P_{1} \times \cdots \times P_{1}$, the second part of Corollary 4 follows by induction using Theorem 3 with the next example as initial case.
Example 5. Let $n \geq 1$. The coloring of $P_{1} \times P_{1} \times P_{n}$ in Figure 1 is hamiltonian with $\left(\left(i_{1}, i_{2}\right),\left(j_{1}, j_{2}\right)\right)$ as quartet. In particular this proves that the 3-dimensional cube has a hamiltonian coloring with a quartet.

Similarly to the class of hypercubes, using the next example we may prove that a larger class of multidimensional grids are dual-hamiltonian using the graphs in th next example as initial cases. But we do not know if all the multidimensional grids are dual-hamiltonian. We conjecture so, but we conjecture that some do not have hamiltonian colorings with quartets.
Example 6. For $m \geq 2$ and $n \geq 3$, the grid $P_{m} \times P_{n}$ has a hamiltonian coloring with a quartet $\left(\left(i_{1}, i_{2}\right),\left(j_{1}, j_{2}\right)\right)$. The coloring is exemplified in Figure 2 for odd values of $n$ and in Figure 3 for even values.

## 1. Proofs

In this section we prove Theorem3, Figures 4, 5and 6illustrate the construction used in the proof.

Consider a graph $G$ and a coloring $C: G \rightarrow$ \{red, blue $\}$. We say that an edge of $G$ is a red (resp. blue) edge of $C$ if its both endvertices have color red (resp. blue) in $C$. An edge of $G$ is monochromatic if it is red or blue.

Proof of Theorem 3: We may assume that $|T| \geq 2$. For each $x \in V(T)$, we denote by $G_{x}$ the graph $G \times T[\{x\}]$ and, for $A \subseteq V(G), A_{x}:=A \times\{x\}$.

Let $C$ be a hamiltonian coloring of $G$ with a quartet $(I, J)$ and colors in \{red, blue\}. We write $I=\left\{i_{\text {red }}, i_{\text {blue }}\right\}$ and $J=\left\{j_{\text {red }}, j_{\text {blue }}\right\}$, where the vertices are colored by $C$ with the color in their indices.

For each $x \in V(T)$, let $C_{x}$ be the coloring of $G_{x}$ such that $C_{x}(v, x):=C(v)$ for all $v \in V(G)$. Note that $C_{x}$ is a hamiltonian coloring of $G_{x}$ with quartet $\left(I_{x}, J_{x}\right)$.

Consider a leaf $r$ as root for $T$ and, for each $x \in V(T)$, let $d(x)$ denote the usual distance from $r$ to $x$ in $T$. Now, for each $x \in V(T)$, define $D_{x}:=C_{x}$ if $d(x)$ is even and $D_{x}:=$ $C_{x} \Delta\left(V\left(G_{x}\right)-I_{x}\right)$ if $d(x)$ is odd. Let $D$ be the 2 -coloring of $G \times T$ such that, for each $x \in V(T)$, the restriction of $D$ to $G_{x}$ is equal to $D_{x}$. Note that for all $x \in V(T), D\left(i_{\text {red }}, x\right)=$ red and $D\left(i_{\text {blue }}, x\right)=$ blue. Let $l$ be a leaf of $T$ other than $r$. We shall prove that $D$ is a hamiltonian coloring of $G \times T$ with $\left(J_{r}, I_{l}\right)$ as quartet. Next we check:

Claim 1. For each $\kappa \in\left\{\right.$ red, blue\} and each $x y \in E(T),\left(i_{\kappa}, x\right)\left(i_{\kappa}, y\right)$ is the unique edge of color $\kappa$ linking a vertex of $G_{x}$ to a vertex of $G_{y}$.

Indeed, by the definition of $G \times T$, such an edge must be of the form $(v, x)(v, y)$ with $v \in V(G)$. We may assume without loosing generality that $d(x)$ is even and $d(y)$ is odd. So $D_{x}=C_{x}$ and $D_{y}=C_{y} \Delta\left(V\left(G_{y}\right)-I_{y}\right)$. Thus the edge $(v, x)(v, y)$ is monochromatic if and only if $v \in I$. Moreover, this edge has color $\kappa$ if and only if $C(\nu)=\kappa$ and this implies Claim 1.

Denote $H:=G \times T$ and let $H_{\text {red }}$ be the subgraph of $H$ induced by the red vertices of $D$. Since $T$ is a tree, Claim 1 implies:

Claim 2. Let $x y \in E(G)$, then $\left(i_{\mathrm{red}}, x\right)\left(i_{\mathrm{red}}, y\right)$ is a bridge of $H_{\mathrm{red}}$.
By Claim 2, if $Z$ is a cycle of $R$, then $Z$ is a cycle of $G_{x}$ for some $x \in V(T)$. But, as $C_{x}$ is a hamiltonian coloring of $G_{x}$, it follows by (Q2) that $D_{i}$ is also a hamiltonian coloring of $G_{x}$. Thus $H_{\text {red }} \cap G_{x}$ is a tree and $H_{\text {red }}$ has no cycles. Note $G\left[\left\{i_{\text {red }}\right\}\right] \times T$ is a connected subgraph of $H_{\text {red }}$ because it is isomorphic to $T$. Each vertex of $H_{\text {red }}$ is in a subgraph of the form $H_{\text {red }} \cap G_{x}$, which is a tree with a vertex in common with $G\left[\left\{i_{\text {red }}\right\}\right] \times T$. Thus $H_{\text {red }}$ is connected and, therefore, $H_{\text {red }}$ is a tree. Analogously the same holds for the subgraph of $H$ induced by the blue vertices of $D$. This proves that $D$ is a hamiltonian coloring of $H$.

It is left to prove that $\left(J_{r}, I_{l}\right)$ is a quartet for $D$. For this we have to prove (Q1)-(Q3). By construction, both $J_{l}$ and $I_{r}$ have vertices of different colors. So (Q1) holds.

Consider the coloring $D^{\prime}:=D \Delta J_{r}$. Denote by $R^{\prime}$ the set of red vertices of $D^{\prime}$ and let $H_{\mathrm{red}}^{\prime}:=$ $H\left[R^{\prime}\right]$. Note that $H_{1}:=H_{\mathrm{red}}^{\prime}-\left(V\left(G_{r}\right) \cap V\left(H_{\mathrm{red}}^{\prime}\right)\right)=H_{\mathrm{red}}-\left(V\left(G_{r}\right) \cap V\left(H_{\mathrm{red}}\right)\right)$. Since $H_{\text {red }}$ is a tree, it follows from Claim 2 that $H_{1}$ is a tree. Now consider the restriction $D_{x}^{\prime}$ of $D^{\prime}$ to $G_{x}$. As $D_{i}=C_{i}$ is a hamiltonian coloring of $G_{r}$ with $\left(I_{r}, J_{r}\right)$ as quartet, it follows from (Q3) that the red vertices of $D_{r}^{\prime}=C_{r} \Delta J_{r}$ induce in $G_{x}$ a forest with exactly two components $T_{I}$ and $T_{J}$ such that $V\left(T_{I}\right) \cap I_{r}=\left\{\left(i_{\text {red }}, r\right)\right\}$ and $V\left(T_{J}\right) \cap J_{r}=\left\{\left(j_{\text {blue }}, r\right)\right\}$. Let $s$ be the neighbor of $r$ in $T$. It follows from Claim 1 that $\left(i_{\text {red }}, r\right)\left(i_{\text {red }}, s\right)$ and $\left(j_{\text {blue }}, r\right)\left(j_{\text {blue }}, s\right)$ are the unique edges that link $G_{x} \cap H_{\text {red }}^{\prime}$ to $H_{1}$. This implies that $H_{\text {red }}^{\prime}$ is obtained from the disjoint trees $H_{1}, T_{J}$ and $T_{J}$ by adding $\left(i_{\text {red }}, r\right)\left(i_{\text {red }}, s\right)$ linking $T_{i}$ to $H_{1}$ and adding ( $\left.j_{\text {blue }}, r\right)\left(j_{\text {blue }}, s\right)$ linking $T_{j}$ to $H_{1}$ and,
therefore, $H_{\mathrm{red}}^{\prime}$ is a tree. Analogously, the blue vertices of $D^{\prime}$ also induce a tree in $H$ and this proves (Q2).

Consider now $D^{\prime \prime}:=D \Delta I_{l}$. Let $R^{\prime \prime}$ be the set of red vertices of $D^{\prime \prime}$ and $H_{\text {red }}^{\prime \prime}:=H\left[R^{\prime \prime}\right]$. Similarly to $H_{1}, H_{2}:=H_{\text {red }}^{\prime \prime}-\left(V\left(G_{l}\right) \cap V\left(H_{\text {red }}^{\prime \prime}\right)\right)=H_{\text {red }}-\left(V\left(G_{l}\right) \cap V\left(H_{\text {red }}\right)\right)$ is a tree. By Claim 1 there is no monochromatic edge of $D^{\prime \prime}$ from $H_{2}$ to $G_{l}$. The restriction $D_{l}^{\prime \prime}$ of $D^{\prime \prime}$ to $G_{l}$ is equal to $C_{l} \Delta I_{l}$ if $d(l)$ is even and equal to $C_{l} \Delta V\left(G_{l}\right)$ if $d(l)$ is odd. Thus $D_{l}^{\prime \prime}$ is a hamiltonian coloring of $G_{l}$ and $H_{\mathrm{red}}^{\prime \prime} \cap G_{l}$ is a tree. Therefore, $H_{\mathrm{red}}^{\prime \prime}$ is a forest with $H_{2}$ and $H_{\mathrm{red}}^{\prime \prime} \cap G_{l}$ as connected components. Note that $H_{2}$ has a vertex of $J_{r}$ and $H_{\text {red }}^{\prime \prime} \cap G_{l}$ has a vertex of $I_{l}$. Since similar arguments are valid for the blue vertices, this implies that (Q3) holds and the theorem is valid.
