# Geometric construction of Gelfand-Tsetlin modules over simple Lie algebras

#### Abstract

In the present paper we describe a new class of Gelfand-Tsetlin modules for an arbitrary complex simple finite-dimensional Lie algebra $\mathfrak{g}$ and give their geometric realization as the space of ' $\delta$-functions' on the flag manifold $G / B$ supported at the 1-dimensional submanifold. When $\mathfrak{g}=\mathfrak{s l}(n)$ (or $\mathfrak{g l}(n))$ these modules form a subclass of Gelfand-Tsetlin modules with infinite dimensional weight subspaces. We discuss their properties and describe the simplicity criterion for these modules in the case of the Lie algebra $\mathfrak{s l}(3, \mathbb{C})$.

## Introduction

A study of simple weight modules for a complex reductive finite-dimensional Lie algebra $\mathfrak{g}$ is a classical problem in representation theory. Such modules have the diagonalizable action of a certain Cartan subalgebra $\mathfrak{h}$ of $\mathfrak{g}$. However, a complete classification of simple weight modules is only known for the Lie algebra $\mathfrak{s l}(2, \mathbb{C})$ when the result is obvious. A classification of simple $\mathfrak{s l}(2, \mathbb{C})$-modules was obtained in [1] and a classification of simple weight modules with finitedimensional weight spaces for any $\mathfrak{g}$ was described in [5] and [18. A larger class of weight modules containing all modules with finite-dimensional weight spaces was extensively studied by many authors during several decades for the Lie algebra $\mathfrak{g}$ of type $A$. The corresponding modules are called Gelfand-Tsetlin modules. They are defined in a similar manner as the weight modules but instead of a Cartan subalgebra $\mathfrak{h}$ of $\mathfrak{g}$ one uses a certain maximal commutative subalgebra $\Gamma$ of the universal enveloping algebra $U(\mathfrak{g})$, called the Gelfand-Tsetlin subalgebra, see [3]. Let us recall that Gelfand-Tsetlin modules are connected with the study of Gelfand-Tsetlin integrable systems [14, [17, [13, 22. Properties and explicit constructions of Gelfand-Tsetlin modules for the Lie algebra $\mathfrak{g}$ of type $A$ was studied in [4], 3], 19], [20, [12], 6], [7, [9, 8], 11], 24], 22], 23], 21] among the others.

Allowing only some generators of the Gelfand-Tsetlin subalgebra to have torsion on simple $\mathfrak{g l}(n, \mathbb{C})$-modules leads to partial Gelfand-Tsetlin modules for $\mathfrak{g l}(n, \mathbb{C})$ which were studied in 10 . These modules decompose into the direct sum of $\Gamma$-submodules parameterized by prime ideals of the Gelfand-Tsetlin subalgebra $\Gamma$.

In the present paper, we study a special class of Gelfand-Tsetlin modules for $\mathfrak{g l}(n)$ and their analogues for an arbitrary complex simple finite-dimensional Lie algebra $\mathfrak{g}$. Let $\mathfrak{h}$ be a Cartan subalgebra of $\mathfrak{g}$ and $\mathfrak{b}$ a Borel subalgebra of $\mathfrak{g}$ containing $\mathfrak{h}$. The Beilinson-Bernstein correspondence provides a geometric realization of Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$. By this correspondence, to the Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ we associate the vector space of ' $\delta$-functions' on the flag manifold $G / B$ supported at the point $e B$. From this point of view, we introduce a family of Gelfand-Tsetlin modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ as the vector space of ' $\delta$-functions' on the flag manifold $G / B$ supported at the 1-dimensional submanifold going through the point $e B$. Modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ provide first examples of Gelfand-Tsetlin modules for an arbitrary simple finite-dimensional $\mathfrak{g}$ with respect to certain commutative subalgebra $\Gamma$ of the universal enveloping algebra $U(\mathfrak{g})$.

We will not discuss this geometric approach in details, instead we describe everything from the algebraic point of view. However, geometry serves as a motivation for the purely algebraic construction of $\mathfrak{g}$-modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ considered in this paper.

The content of our article goes as follows. In Section 1, we recall a general notion of HarishChandra modules and define a class of partial Gelfand-Tsetlin modules for an arbitrary complex simple finite-dimensional Lie algebra $\mathfrak{g}$. We also introduce various tensor categories of partial Gelfand-Tsetlin modules. In Section 2 we use the geometric realization of Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ described in [16] to obtain a geometric realization of a new family of $\Gamma_{\theta}$-Gelfand-Tsetlin modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ called $\theta$-Gelfand-Tsetlin modules. We also discuss their properties, which are summarized in Table 1. Our main result is the following theorem.

Theorem. Let $\mathfrak{g}$ be a complex simple finite-dimensional Lie algebra with a Cartan subalgebra $\mathfrak{h}$ and the corresponding triangular decomposition $\mathfrak{g}=\overline{\mathfrak{n}} \oplus \mathfrak{h} \oplus \mathfrak{n}$. Let $\theta$ be the maximal root in $\Delta^{+}$and $\Delta_{\theta}^{+}=\Delta^{+} \backslash\{\theta\}$. If $\lambda \in \mathfrak{h}^{*}$, then the vector space $\mathbb{C}\left[\partial_{x_{\alpha}}, \alpha \in \Delta_{\theta}^{+}, x_{\theta}\right]$ has the structure of a cyclic $\theta$-Gelfand-Tsetlin $\mathfrak{g}$-module and every element $a \in \mathfrak{g}$ acts as the following differential operator

$$
a \mapsto-\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x)) e^{\operatorname{ad}(u(x))}}{e^{\operatorname{ad}(u(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(u(x))} a\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+2 \rho)\left(\left(e^{-\operatorname{ad}(u(x))} a\right)_{\mathfrak{h}}\right),
$$

where $[a]_{\alpha}$ denotes the $\alpha$-th coordinate of $a \in \overline{\mathfrak{n}}$ with respect to a root basis $\left\{f_{\alpha} ; \alpha \in \Delta^{+}\right\}$of $\overline{\mathfrak{n}}, x=$ $\left\{x_{\alpha} ; \alpha \in \Delta^{+}\right\}$are the corresponding linear coordinate functions on $\overline{\mathfrak{n}}$ and $u(x)=\sum_{\alpha \in \Delta^{+}} x_{\alpha} f_{\alpha}$.

Further $a_{\overline{\mathfrak{n}}}$ and $a_{\mathfrak{h}}$ are $\overline{\mathfrak{n}}$-part and $\mathfrak{h}$-part of $a \in \mathfrak{g}$ with respect to the trinagular decomposition $\mathfrak{g}=\overline{\mathfrak{n}} \oplus \mathfrak{h} \oplus \mathfrak{n}$.

Furthermore, we establish the simplicity criterion for $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ in the case of the Lie algebra $\mathfrak{s l}(3, \mathbb{C})$ (Theorem 2.16). Let us note that the notions of Gelfand-Tsetlin modules and $\theta$-GelfandTsetlin modules coincide for $\mathfrak{s l}(3, \mathbb{C})$. All such simple modules were classified in [6] (see also [9]). We also describe a relation of Gelfand-Tsetlin modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ to twisted Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)^{w}$. For the reader's convenience, we remind in Appendix A several important facts concerning the generalized eigenspace decomposition.

Throughout the article, we use the standard notation $\mathbb{Z}, \mathbb{N}$ and $\mathbb{N}_{0}$ for the set of integers, the set of natural numbers and the set of natural numbers together with zero, respectively.

## 1 Gelfand-Tsetlin modules

In this section we introduce a general notion of Harish-Chandra modules and then focus on a particular class of partial Gelfand-Tsetlin modules and their analogues for an arbitrary complex simple finite-dimensional Lie algebra.

### 1.1 Harish-Chandra modules and Gelfand-Tsetlin modules

For a commutative $\mathbb{C}$-algebra $\Gamma$ we denote by $\operatorname{Hom}(\Gamma, \mathbb{C})$ the set of all characters of $\Gamma$, i.e. $\mathbb{C}$ algebra homomorphisms from $\Gamma$ to $\mathbb{C}$. Let us note that if $\Gamma$ is finitely generated, then there is a natural identification between the set $\operatorname{Hom}(\Gamma, \mathbb{C})$ of all characters of $\Gamma$ and the set Specm $\Gamma$ of all maximal ideals of $\Gamma$, which corresponds to a complex algebraic variety.

Let $M$ be a $\Gamma$-module. For each $\chi \in \operatorname{Hom}(\Gamma, \mathbb{C})$ we set

$$
\begin{equation*}
M_{\chi}=\left\{v \in M ;(\exists k \in \mathbb{N})(\forall a \in \Gamma)(a-\chi(a))^{k} v=0\right\} \tag{1.1}
\end{equation*}
$$

and call it the $\Gamma$-weight space of $M$ with weight $\chi$. When $M_{\chi} \neq\{0\}$, we say that $\chi$ is a $\Gamma$-weight of $M$ and the elements of $M_{\chi}$ are called $\Gamma$-weight vectors with weight $\chi$. If a $\Gamma$-module $M$ satisfies

$$
\begin{equation*}
M=\bigoplus_{\chi \in \operatorname{Hom}(\Gamma, \mathbb{C})} M_{\chi} \tag{1.2}
\end{equation*}
$$

then we call $M$ a $\Gamma$-weight module. The dimension of the vector space $M_{\chi}$ will be called the $\Gamma$-multiplicity of $\chi$ in $M$. We say that a left $A$-module $M$ is a Harish-Chandra module with respect to $\Gamma$ if $M$ is a $\Gamma$-weight $A$-module.

Let $A$ be a $\mathbb{C}$-algebra and let $\Gamma$ be a commutative $\mathbb{C}$-subalgebra of $A$. Following [3] we denote by $\mathcal{H}(A, \Gamma)$ the category of all $\Gamma$-weight $A$-modules and by $\mathcal{H}_{\text {fin }}(A, \Gamma)$ the full subcategory of $\mathcal{H}(A, \Gamma)$ consisting of those $\Gamma$-weight $A$-modules $M$ satisfying $\operatorname{dim} M_{\chi}<\infty$ for all $\chi \in \operatorname{Hom}(\Gamma, \mathbb{C})$. In the case when the $\mathbb{C}$-algebra $A$ is the universal enveloping algebra $U(\mathfrak{g})$ of a complex Lie algebra $\mathfrak{g}$, we will use the notation $\mathcal{H}(\mathfrak{g}, \Gamma)$ and $\mathcal{H}_{\text {fin }}(\mathfrak{g}, \Gamma)$ instead of $\mathcal{H}(U(\mathfrak{g}), \Gamma)$ and $\mathcal{H}_{\text {fin }} f(U(\mathfrak{g}), \Gamma)$, respectively.

If $\Gamma$ and $\widetilde{\Gamma}$ are commutative $\mathbb{C}$-subalgebras of $A$ satisfying $\Gamma \subset \widetilde{\Gamma}$, then we have the following obvious inclusions

$$
\mathcal{H}_{\mathrm{fin}}(A, \Gamma) \subset \mathcal{H}_{\mathrm{fin}}(A, \widetilde{\Gamma}) \subset \mathcal{H}(A, \widetilde{\Gamma}) \subset \mathcal{H}(A, \Gamma)
$$

which are strict in general.
Finally, let us recall that a commutative $\mathbb{C}$-subalgebra $\Gamma$ of $A$ is a Harish-Chandra subalgebra if the $\Gamma$-bimodule $\Gamma a \Gamma$ is finitely generated both as left and as right $\Gamma$-module for all $a \in A$.

Example. If $\mathfrak{g}=\mathfrak{g l}(n, \mathbb{C})$ and $\Gamma$ is the Gelfand-Tsetlin subalgebra of $U(\mathfrak{g})$ then objects of $\mathcal{H}(\mathfrak{g}, \Gamma)$ are the Gelfand-Tsetlin modules studied by many authors.

Let us note that the $\Gamma$-weight spaces in the case of the Gelfand-Tsetlin subalgebra $\Gamma$ of $U(\mathfrak{g l}(n, \mathbb{C}))$ are always finite-dimensional in simple $\mathfrak{g l}(n, \mathbb{C})$-modules. This need not be the case for
other commutative $\mathbb{C}$-subalgebras of $U(\mathfrak{g l}(n, \mathbb{C}))$. However, in all known to us cases the following is true. We state it as a conjecture in general.

Conjecture. Let $\mathfrak{g}$ be a complex simple finite-dimensional Lie algebra. If $M \in \mathcal{H}(\mathfrak{g}, \Gamma)$ is a simple $\mathfrak{g}$-module and $\operatorname{dim} M_{\chi}<\infty$ for some $\Gamma$-weight $\chi$ of $M$, then $M \in \mathcal{H}_{\text {fin }}(\mathfrak{g}, \Gamma)$.
Remark. If $M$ is a simple $\mathfrak{g}$-module such that $M_{\chi} \neq\{0\}$ for some $\chi \in \operatorname{Hom}(\Gamma, \mathbb{C})$, then it is not clear (and probably not true in general) whether $M \in \mathcal{H}(\mathfrak{g}, \Gamma)$.

## $1.2 \quad \theta$-Gelfand-Tsetlin modules

In this section we introduce a class of partial Gelfand-Tsetlin modules for an arbitrary complex simple finite-dimensional Lie algebra.

Let us consider a complex simple finite-dimensional Lie algebra $\mathfrak{g}$ and let $\mathfrak{h}$ be a Cartan subalgebra of $\mathfrak{g}$. We denote by $\Delta$ the root system of $\mathfrak{g}$ with respect to $\mathfrak{h}$, by $\Delta^{+}$a positive root system in $\Delta$ and by $\Pi \subset \Delta$ the set of simple roots. Further, we denote by $\theta$ the maximal root of $\mathfrak{g}$ (by definition, the highest weight of its adjoint representation) and by $h_{\alpha} \in \mathfrak{h}$ the coroot corresponding to a root $\alpha \in \Delta$.

Definition 1.1. Let $\mathfrak{s}_{\theta}$ be the Lie subalgebra of $\mathfrak{g}$ generated by an $\mathfrak{s l}(2, \mathbb{C})$-triple $\left(e_{\theta}, h_{\theta}, f_{\theta}\right)$ associated to the maximal root $\theta$. Then we define the commutative $\mathbb{C}$-subalgebra $\Gamma_{\theta}$ of $U(\mathfrak{g})$ as a $\mathbb{C}$-subalgebra of $U(\mathfrak{g})$ generated by the Cartan subalgebra $\mathfrak{h}$ and by the center $\mathfrak{Z}\left(\mathfrak{s}_{\theta}\right)$ of $U\left(\mathfrak{s}_{\theta}\right)$.

The center $\mathfrak{Z}\left(\mathfrak{s}_{\theta}\right)$ of $U\left(\mathfrak{s}_{\theta}\right)$ is freely generated by the quadratic Casimir element $\operatorname{Cas}_{\theta}$ defined by

$$
\begin{equation*}
\operatorname{Cas}_{\theta}=e_{\theta} f_{\theta}+f_{\theta} e_{\theta}+\frac{1}{2} h_{\theta}^{2} \tag{1.3}
\end{equation*}
$$

Hence, the $\mathbb{C}$-algebra $\Gamma_{\theta}$ is freely generated by the coroots $h_{\alpha}, \alpha \in \Pi$, and by the Casimir element $\mathrm{Cas}_{\theta}$. As a consequence, we obtain that the complex algebraic variety corresponding to $\operatorname{Hom}\left(\Gamma_{\theta}, \mathbb{C}\right)$ and Specm $\Gamma_{\theta}$ is isomorphic to $\mathbb{C}^{\operatorname{rank}(\mathfrak{g})+1}$. In the next, we will focus on the category $\mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right)$. The objects of this category will be called $\theta$-Gelfand-Tsetlin modules.

## Proposition 1.2.

(i) The commutative $\mathbb{C}$-subalgebra $\Gamma_{\theta}$ of $U(\mathfrak{g})$ is a Harish-Chandra subalgebra of $U(\mathfrak{g})$.
(ii) Let $M$ be a simple $\mathfrak{g}$-module such that $M_{\chi} \neq\{0\}$ for some $\chi \in \operatorname{Hom}\left(\Gamma_{\theta}, \mathbb{C}\right)$. Then we have $M \in \mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right)$.

Proof. To prove the first statement it is sufficient to check it for the generators of the Lie algebra $\mathfrak{g}$. Let $a \in \mathfrak{g}$ be such a generator. We may assume that $a \in \mathfrak{g}_{\alpha}$ for some $\alpha \in \Delta$. If $\alpha= \pm \theta$, then we have $\left[\operatorname{Cas}_{\theta}, a\right]=0$. For $\alpha \neq \pm \theta$, let us consider the $\mathfrak{s}_{\theta}$-module

$$
\mathfrak{g}_{\alpha, \theta}=\bigoplus_{j \in \mathbb{Z}} \mathfrak{g}_{\alpha+j \theta} .
$$

Since $\mathfrak{g}_{\alpha, \theta}$ is a simple finite-dimensional $\mathfrak{s}_{\theta}$-module, we obtain that $\left[\mathrm{Cas}_{\theta}, a\right]=c_{\alpha} a$, where $c_{\alpha} \in \mathbb{C}$, which together with $[h, a]=\alpha(h) a$ implies the first and also the second statement.

We define the full subcategories $\mathcal{I}_{\theta, e}$ and $\mathcal{I}_{\theta, f}$ of the category of weight (with respect to $\mathfrak{h}$ ) $\mathfrak{g}$-modules consisting of those $\mathfrak{g}$-modules on which $e_{\theta}$ and $f_{\theta}$ is locally nilpotent, respectively. Also we set $\mathcal{I}_{\theta}=\mathcal{I}_{\theta, e} \cap \mathcal{I}_{\theta, f}$.

## Proposition 1.3.

(i) The categories $\mathcal{I}_{\theta, e}, \mathcal{I}_{\theta, f}$ and $\mathcal{I}_{\theta}$ are full subcategories of $\mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right)$.
(ii) Let $M$ be a simple weight $\mathfrak{g}$-module such that there exists an integer $n \in \mathbb{N}$ and a nonzero vector $v \in M$ satisfying $e_{\theta}^{n} v=0$ (respectively, $f_{\theta}^{n} v=0$ ). Then we have $M \in \mathcal{I}_{\theta, e}$ (respectively, $\left.M \in \mathcal{I}_{\theta, f}\right)$, and hence $M \in \mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right)$.

Proof. If $M \in \mathcal{I}_{\theta, e}$, then $\mathrm{Cas}_{\theta}$ is locally finite on $M$. This implies the first statement. The second statement follows from the simplicity of $M$ and item (i).

We will denote $\mathcal{I}_{\theta, e, \text { fin }}=\mathcal{I}_{\theta, e} \cap \mathcal{H}_{\text {fin }}\left(\mathfrak{g}, \Gamma_{\theta}\right)$, and similarly $\mathcal{I}_{\theta, f, \text { fin }}, \mathcal{I}_{\theta, \text { fin }}$. Let $\Gamma$ be a commutative $\mathbb{C}$-subalgebra of $U(\mathfrak{g})$ containing $\mathfrak{h}$ and $\mathfrak{Z}\left(\mathfrak{s}_{\theta}\right)$. Since $\mathcal{H}_{\text {fin }}\left(\mathfrak{g}, \Gamma_{\theta}\right) \subset \mathcal{H}_{\text {fin }}(\mathfrak{g}, \Gamma)$, we immediately have the following statement.

Corollary 1.4. The categories $\mathcal{I}_{\theta, e, \text { fin }}, \mathcal{I}_{\theta, f, \text { fin }}$ and $\mathcal{I}_{\theta, \text { fin }}$ are full subcategories of $\mathcal{H}_{\text {fin }}(\mathfrak{g}, \Gamma)$.
One wonders how large all these categories are. Clearly, $\mathcal{I}_{\theta, \text { fin }}$ contains all finite-dimensional $\mathfrak{g}$ modules; $\mathcal{I}_{\theta, e, \text { fin }}$ contains the whole category $\mathcal{O}$ and all parabolically induced $\mathfrak{g}$-modules when the Levi factor $\mathfrak{l}$ of the parabolic subalgebra $\mathfrak{p}=\mathfrak{l} \oplus \mathfrak{u}$ of $\mathfrak{g}$ does not contain $e_{\theta}, f_{\theta}$ and $e_{\theta} \in \mathfrak{u}$. Moreover, it was shown in [6] that certain simple non-parabolically induced Gelfand-Tsetlin $\mathfrak{s l}(3, \mathbb{C})$-modules with respect to the Gelfand-Tsetlin subalgebra belong to the categories $\mathcal{I}_{\theta, e, \text { fin }}, \mathcal{I}_{\theta, f, \text { fin }}$ and $\mathcal{I}_{\theta, \text { fin }}$. Such modules have infinite-dimensional weight spaces. Furthermore, using the parabolic induction from such simple Gelfand-Tsetlin $\mathfrak{s l}(3, \mathbb{C})$-modules one can construct simple $\mathfrak{g}$-modules respectively in categories $\mathcal{I}_{\theta, e}, \mathcal{I}_{\theta, f}$ and $\mathcal{I}_{\theta}$ for any $\mathfrak{g}$ of $\operatorname{rank} \operatorname{rank}(\mathfrak{g}) \geq 3$ (in order to have $\mathfrak{s l}(3, \mathbb{C})+\mathfrak{h}$ as a Levi factor of some parabolic subalgebra).

Let us note that $\mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right), \mathcal{H}_{\text {fin }}\left(\mathfrak{g}, \Gamma_{\theta}\right), \mathcal{I}_{\theta, e, \text { fin }}, \mathcal{I}_{\theta, f, \text { fin }}$ and $\mathcal{I}_{\theta, \text { fin }}$ are not tensor categories, except the case $\mathfrak{g}=\mathfrak{s l}(2, \mathbb{C})$ when $\mathcal{I}_{\theta, e, \text { fin }}$ (respectively, $\left.\mathcal{I}_{\theta, f, \text { fin }}\right)$ consists of extensions of highest (respectively, lowest) weight $\mathfrak{g}$-modules and their directs sums and $\mathcal{I}_{\theta, \text { fin }}$ consists of sums of finitedimensional $\mathfrak{g}$-modules. Nevertheless, we have the following statement as a consequence of the definitions.
Theorem 1.5. The categories $\mathcal{I}_{\theta, e}, \mathcal{I}_{\theta, f}$ and $\mathcal{I}_{\theta}$ are tensor categories.

## 2 Geometric construction of $\theta$-Gelfand-Tsetlin modules

### 2.1 Geometric realization of Verma modules

Let us consider a complex simple Lie algebra $\mathfrak{g}$ and let $\mathfrak{h}$ be a Cartan subalgebra of $\mathfrak{g}$. We denote by $\Delta$ the root system of $\mathfrak{g}$ with respect to $\mathfrak{h}$, by $\Delta^{+}$a positive root system in $\Delta$ and by $\Pi \subset \Delta$ the set of simple roots. The standard Borel subalgebra $\mathfrak{b}$ of $\mathfrak{g}$ is defined through $\mathfrak{b}=\mathfrak{h} \oplus \mathfrak{n}$ with the nilradical $\mathfrak{n}$ and the opposite nilradical $\overline{\mathfrak{n}}$ given by

$$
\begin{equation*}
\mathfrak{n}=\bigoplus_{\alpha \in \Delta^{+}} \mathfrak{g}_{\alpha} \quad \text { and } \quad \overline{\mathfrak{n}}=\bigoplus_{\alpha \in \Delta^{+}} \mathfrak{g}_{-\alpha} \tag{2.1}
\end{equation*}
$$

Moreover, we have a triangular decomposition

$$
\begin{equation*}
\mathfrak{g}=\overline{\mathfrak{n}} \oplus \mathfrak{h} \oplus \mathfrak{n} \tag{2.2}
\end{equation*}
$$

of the Lie algebra $\mathfrak{g}$. Furthermore, we define the height $\operatorname{ht}(\alpha)$ of $\alpha \in \Delta$ by

$$
\begin{equation*}
\operatorname{ht}\left(\sum_{i=1}^{r} a_{i} \alpha_{i}\right)=\sum_{i=1}^{r} a_{i}, \tag{2.3}
\end{equation*}
$$

where $r=\operatorname{rank}(\mathfrak{g})$ and $\Pi=\left\{\alpha_{1}, \alpha_{2}, \ldots, \alpha_{r}\right\}$. If we denote $k=\operatorname{ht}(\theta)$, where $\theta$ is the maximal root of $\mathfrak{g}$ (by definition, the highest weight of its adjoint representation), then $\mathfrak{g}$ is a $|k|$-graded Lie algebra with respect to the grading given by $\mathfrak{g}_{i}=\bigoplus_{\alpha \in \Delta, h t(\alpha)=i} \mathfrak{g}_{\alpha}$ for $0 \neq i \in \mathbb{Z}$ and $\mathfrak{g}_{0}=\mathfrak{h}$. Moreover, we have

$$
\begin{equation*}
\overline{\mathfrak{n}}=\mathfrak{g}_{-k} \oplus \cdots \oplus \mathfrak{g}_{-1}, \quad \mathfrak{h}=\mathfrak{g}_{0}, \quad \mathfrak{n}=\mathfrak{g}_{1} \oplus \cdots \oplus \mathfrak{g}_{k} \tag{2.4}
\end{equation*}
$$

together with $\mathfrak{g}_{-k}=\mathfrak{g}_{-\theta}$ and $\mathfrak{g}_{k}=\mathfrak{g}_{\theta}$. We also set

$$
\begin{equation*}
Q=\sum_{\alpha \in \Delta^{+}} \mathbb{Z} \alpha=\bigoplus_{i=1}^{r} \mathbb{Z} \alpha_{i} \quad \text { and } \quad Q_{+}=\sum_{\alpha \in \Delta^{+}} \mathbb{N}_{0} \alpha=\bigoplus_{i=1}^{r} \mathbb{N}_{0} \alpha_{i} \tag{2.5}
\end{equation*}
$$

and call $Q$ the root lattice. Let us note that for any positive root $\alpha \in \Delta^{+}$, we have $\theta-\alpha \in Q_{+}$. Furthermore, we introduce the notation $\Delta_{\theta}^{+}$to stand for $\Delta^{+} \backslash\{\theta\}$.

For $\lambda \in \mathfrak{h}^{*}$ we denote by $\mathbb{C}_{\lambda}$ the 1-dimensional representation of $\mathfrak{b}$ defined by

$$
\begin{equation*}
a v=\lambda(a) v \tag{2.6}
\end{equation*}
$$

for $a \in \mathfrak{h}, v \in \mathbb{C}_{\lambda} \simeq \mathbb{C}$ (as vector spaces) and trivially extended to a representation of $\mathfrak{b}=\mathfrak{h} \oplus \mathfrak{n}$.
Definition 2.1. Let $\lambda \in \mathfrak{h}^{*}$. Then the Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is the induced module

$$
\begin{equation*}
M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)=\operatorname{Ind}_{\mathfrak{b}}^{\mathfrak{g}} \mathbb{C}_{\lambda} \equiv U(\mathfrak{g}) \otimes_{U(\mathfrak{b})} \mathbb{C}_{\lambda} \simeq U(\overline{\mathfrak{n}}) \otimes_{\mathbb{C}} \mathbb{C}_{\lambda} \tag{2.7}
\end{equation*}
$$

where the last isomorphism of $U(\overline{\mathfrak{n}})$-modules follows from Poincaré-Birkhoff-Witt theorem.
In the next, we shall need the action of the center $\mathfrak{Z}(\mathfrak{g})$ of the universal enveloping algebra $U(\mathfrak{g})$ on Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$. Using (2.2) together with Poincaré-Birkhof-Witt theorem we obtain

$$
\begin{equation*}
U(\mathfrak{g})=U(\mathfrak{h}) \oplus(\overline{\mathfrak{n}} U(\mathfrak{g})+U(\mathfrak{g}) \mathfrak{n}) \tag{2.8}
\end{equation*}
$$

Let us consider the projection $p: U(\mathfrak{g}) \rightarrow U(\mathfrak{h})$ with respect to the direct sum decomposition (2.8) and the $\mathbb{C}$-algebra automorphism $f: U(\mathfrak{h}) \rightarrow U(\mathfrak{h})$ defined by

$$
\begin{equation*}
f(h)=h-\rho(h) 1 \tag{2.9}
\end{equation*}
$$

for all $h \in \mathfrak{h}$, where $\rho \in \mathfrak{h}^{*}$ is the Weyl vector given through

$$
\begin{equation*}
\rho=\frac{1}{2} \sum_{\alpha \in \Delta^{+}} \alpha \tag{2.10}
\end{equation*}
$$

We denote by $\gamma: \mathfrak{Z}(\mathfrak{g}) \rightarrow U(\mathfrak{h})$ the restriction of $f \circ p$ to the center $\mathfrak{Z}(\mathfrak{g})$ of $U(\mathfrak{g})$. The mapping $\gamma: \mathcal{Z}(\mathfrak{g}) \rightarrow U(\mathfrak{h})$ is a homomorphism of associative $\mathbb{C}$-algebras and does not depend on the choice of the positive root system $\Delta^{+}$. It is called the Harish-Chandra homomorphism.

A $\mathbb{C}$-algebra homomorphism from $\mathfrak{Z}(\mathfrak{g})$ to $\mathbb{C}$ is called a central character. For each $\lambda \in \mathfrak{h}^{*}$ we define a central character $\chi_{\lambda}: \mathfrak{Z}(\mathfrak{g}) \rightarrow \mathbb{C}$ by

$$
\begin{equation*}
\chi_{\lambda}(z)=(\gamma(z))(\lambda) \tag{2.11}
\end{equation*}
$$

for $z \in \mathfrak{Z}(\mathfrak{g})$, where we identify $U(\mathfrak{h}) \simeq S(\mathfrak{h})$ with the $\mathbb{C}$-algebra of polynomial functions on $\mathfrak{h}^{*}$. The action of the center $\mathfrak{Z}(\mathfrak{g})$ of $U(\mathfrak{g})$ on Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ is then given by

$$
\begin{equation*}
z v=\chi_{\lambda+\rho}(z) v \tag{2.12}
\end{equation*}
$$

for all $z \in \mathfrak{Z}(\mathfrak{g})$ and $v \in M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$.
We briefly describe the geometric realization of Verma modules given in [16. This nice geometric realization enables us to construct new interesting simple modules for the Lie algebra $\mathfrak{g}$.

Let $\left\{f_{\alpha} ; \alpha \in \Delta^{+}\right\}$be a basis of the opposite nilradical $\overline{\mathfrak{n}}$. We denote by $x=\left\{x_{\alpha} ; \alpha \in \Delta^{+}\right\}$ the corresponding linear coordinate functions on $\overline{\mathfrak{n}}$ with respect to the basis $\left\{f_{\alpha} ; \alpha \in \Delta^{+}\right\}$of $\overline{\mathfrak{n}}$. Then we have a canonical isomorphism $\mathbb{C}[\overline{\mathfrak{n}}] \simeq \mathbb{C}[x]$ of $\mathbb{C}$-algebras, and the Weyl algebra $\mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ of the vector space $\overline{\mathfrak{n}}$ is generated by $\left\{x_{\alpha}, \partial_{x_{\alpha}} ; \alpha \in \Delta^{+}\right\}$together with the canonical commutation relations. For $\lambda \in \mathfrak{h}^{*}$ there is a homomorphism

$$
\begin{equation*}
\pi_{\lambda}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} \tag{2.13}
\end{equation*}
$$

of Lie algebras given through

$$
\begin{equation*}
\pi_{\lambda}(a)=-\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x)) e^{\operatorname{ad}(u(x))}}{e^{\operatorname{ad}(u(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(u(x))} a\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(u(x))} a\right)_{\mathfrak{h}}\right) \tag{2.14}
\end{equation*}
$$

for all $a \in \mathfrak{g}$, where $[a]_{\alpha}$ denotes the $\alpha$-th coordinate of $a \in \mathfrak{\mathfrak { n }}$ with respect to the basis $\left\{f_{\alpha} ; \alpha \in \Delta^{+}\right\}$ of $\overline{\mathfrak{n}}$, further $a_{\overline{\mathfrak{n}}}$ and $a_{\mathfrak{h}}$ are $\overline{\mathfrak{n}}$-part and $\mathfrak{h}$-part of $a \in \mathfrak{g}$ with respect to the trinagular decomposition $\mathfrak{g}=\overline{\mathfrak{n}} \oplus \mathfrak{h} \oplus \mathfrak{n}$, and finally the element $u(x) \in \mathbb{C}[\overline{\mathfrak{n}}] \otimes_{\mathbb{C}} \mathfrak{g}$ is given by

$$
\begin{equation*}
u(x)=\sum_{\alpha \in \Delta^{+}} x_{\alpha} f_{\alpha} \tag{2.15}
\end{equation*}
$$

Let us note that $\mathbb{C}[\overline{\mathfrak{n}}] \otimes_{\mathbb{C}} \mathfrak{g}$ has the natural structure of a Lie algebra. Hence, we have a well-defined $\mathbb{C}$-linear mapping $\operatorname{ad}(u(x)): \mathbb{C}[\overline{\mathfrak{n}}] \otimes_{\mathbb{C}} \mathfrak{g} \rightarrow \mathbb{C}[\overline{\mathfrak{n}}] \otimes_{\mathbb{C}} \mathfrak{g}$.

In particular, we have

$$
\begin{equation*}
\pi_{\lambda}(a)=-\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x))}{e^{\operatorname{ad}(u(x))}-\mathrm{id}} a\right]_{\alpha} \partial_{x_{\alpha}} \tag{2.16}
\end{equation*}
$$

for $a \in \overline{\mathfrak{n}}$ and

$$
\begin{equation*}
\pi_{\lambda}(a)=\sum_{\alpha \in \Delta^{+}}[\operatorname{ad}(u(x)) a]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)(a) \tag{2.17}
\end{equation*}
$$

for $a \in \mathfrak{h}$. The Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ is then realized as $\mathcal{A}_{\mathfrak{n}}^{\mathfrak{g}} / \mathcal{J}_{V}$, where $\mathcal{J}_{V}$ is the left ideal of $\mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ defined by $\mathcal{J}_{\mathrm{V}}=\left(x_{\alpha}, \alpha \in \Delta^{+}\right)$, see e.g. [16]. The $\mathfrak{g}$-module structure on $\mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{V}}$ is given through the homomorphism $\pi_{\lambda+\rho}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ of Lie algebras.

In the next, we change the left ideal $\mathcal{J}_{\mathrm{V}}$ of the Weyl algebra $\mathcal{A} \mathfrak{g}$ to produce a class of $\theta$-GelfandTsetlin modules. These $\mathfrak{g}$-modules will be the subject of our interest.

### 2.2 Geometric realization of $\theta$-Gelfand-Tsetlin modules

We need to introduce a suitable basis of the Lie algebra $\mathfrak{g}$. Let $\left\{e_{\alpha} ; \alpha \in \Delta^{+}\right\}$be a root basis of the nilradical $\mathfrak{n}$ and let $\left\{f_{\alpha} ; \alpha \in \Delta^{+}\right\}$be a root basis of the opposite nilradical $\overline{\mathfrak{n}}$. If we denote by $h_{\alpha} \in \mathfrak{h}$ the coroot corresponding to a root $\alpha \in \Delta^{+}$, then $\left\{h_{\alpha} ; \alpha \in \Pi\right\}$ is a basis of the Cartan subalgebra $\mathfrak{h}$.

Let us note that the Lie subalgebra of $\mathfrak{g}$ generated by $\left\{e_{\alpha}, h_{\alpha}, f_{\alpha}\right\}$ for $\alpha \in \Delta^{+}$is isomorphic to $\mathfrak{s l}(2, \mathbb{C})$.
Definition 2.2. Let $\lambda \in \mathfrak{h}^{*}$. Then the $\mathfrak{g}$-module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is defined by

$$
\begin{equation*}
W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda) \simeq \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{GT}} \simeq \mathbb{C}\left[\partial_{x_{\alpha}}, \alpha \in \Delta_{\theta}^{+}, x_{\theta}\right], \quad \mathcal{J}_{\mathrm{GT}}=\left(x_{\alpha}, \alpha \in \Delta_{\theta}^{+}, \partial_{x_{\theta}}\right), \tag{2.18}
\end{equation*}
$$

where the $\mathfrak{g}$-module structure on $\mathcal{A} \mathfrak{g} / \mathcal{J}_{\mathrm{GT}}$ is given through the homomorphism $\pi_{\lambda+\rho}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{g}}}$ of Lie algebras.

Remark. Although, the definition of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ makes sense for any complex simple finitedimensional Lie algebra $\mathfrak{g}$, we exclude the case $\mathfrak{g}=\mathfrak{s l}(2, \mathbb{C})$. For $\mathfrak{g}=\mathfrak{s l}(2, \mathbb{C})$ the $\mathfrak{g}$-module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is isomorphic to the contragredient Verma module $M_{\bar{b}}^{\mathfrak{g}}(\lambda+2 \rho)^{*}$ for the opposite standard Borel subalgebra $\overline{\mathfrak{b}}=\mathfrak{h} \oplus \overline{\mathfrak{n}}$.

Let $M$ be an $\mathfrak{h}$-module. For each $\mu \in \mathfrak{h}^{*}$ we set

$$
\begin{equation*}
M_{\mu}=\{v \in M ;(\forall h \in \mathfrak{h}) h v=\mu(h) v\} \tag{2.19}
\end{equation*}
$$

and call it the weight space of $M$ with weight $\mu$. When $M_{\mu} \neq\{0\}$, we say that $\mu$ is a weight of $M$ and the elements of $M_{\mu}$ are called weight vectors with weight $\mu$. If an $\mathfrak{h}$-module $M$ satisfies

$$
\begin{equation*}
M=\bigoplus_{\mu \in \mathfrak{h}^{*}} M_{\mu} \tag{2.20}
\end{equation*}
$$

then we call $M$ a weight module.

Therefore, the first natural question is whether $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a weight module and how the action of the center $\mathfrak{Z}(\mathfrak{g})$ of $U(\mathfrak{g})$ on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ looks.
Lemma 2.3. Let $\lambda \in \mathfrak{h}^{*}$. Then we have

$$
\begin{align*}
\pi_{\lambda}(h) & =\sum_{\alpha \in \Delta^{+}} \alpha(h) x_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)(h) \\
& =\sum_{\alpha \in \Delta_{\theta}^{+}} \alpha(h) \partial_{x_{\alpha}} x_{\alpha}+\theta(h) x_{\theta} \partial_{x_{\theta}}+(\lambda-\rho+\theta)(h) \tag{2.21}
\end{align*}
$$

for all $h \in \mathfrak{h}$.
Proof. For $h \in \mathfrak{h}$ we have

$$
[u(x), h]=\sum_{\alpha \in \Delta^{+}} x_{\alpha}\left[f_{\alpha}, h\right]=\sum_{\alpha \in \Delta^{+}} \alpha(h) x_{\alpha} f_{\alpha}
$$

which together with (2.17) enables us to write

$$
\begin{aligned}
\pi_{\lambda}(h) & =\sum_{\alpha \in \Delta^{+}} \alpha(h) x_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)(h) \\
& =\sum_{\alpha \in \Delta_{\theta}^{+}} \alpha(h) \partial_{x_{\alpha}} x_{\alpha}+\theta(h) x_{\theta} \partial_{x_{\theta}}+(\lambda-\rho+\theta)(h)
\end{aligned}
$$

for all $h \in \mathfrak{h}$, where we used (2.10) in the second equality.
We denote by $\mathbb{Z}^{\Delta^{+}}$and $\mathbb{Z}^{\Pi}$ the set of all functions from $\Delta^{+}$to $\mathbb{Z}$ and from $\Pi$ to $\mathbb{Z}$, respectively. Since we have $\Pi \subset \Delta^{+}$, an element of $\mathbb{Z}^{\Pi}$ will be also regarded as an element of $\mathbb{Z}^{\Delta^{+}}$extended by 0 on $\Delta^{+} \backslash \Pi$. A similar notation is introduced for $\mathbb{N}_{0}^{\Delta^{+}}$and $\mathbb{N}_{0}^{\Pi}$.

For $a \in \mathbb{N}_{0}^{\Delta^{+}}$we define by

$$
\begin{equation*}
w_{\lambda, a}=\prod_{\alpha \in \Delta_{\theta}^{+}} \partial_{x_{\alpha}}^{a_{\alpha}} x_{\theta}^{a_{\theta}} \tag{2.22}
\end{equation*}
$$

a vector in $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. The subset $\left\{w_{\lambda, a} ; a \in \mathbb{N}_{0}^{\Delta^{+}}\right\}$of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ forms a basis of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. As $w_{\lambda, a}$ is a weight vector with weight

$$
\begin{equation*}
\mu_{\lambda, a}=-\sum_{\alpha \in \Delta_{\theta}^{+}} a_{\alpha} \alpha+a_{\theta} \theta+\lambda+\theta \tag{2.23}
\end{equation*}
$$

for all $a \in \mathbb{N}_{0}^{\Delta^{+}}$, as easily follows from (2.21), we obtain that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a weight module. However, we need a basis of weight spaces. Since any positive root $\alpha \in \Delta^{+}$can be expressed as

$$
\begin{equation*}
\alpha=\sum_{i=1}^{r} m_{\alpha, i} \alpha_{i} \tag{2.24}
\end{equation*}
$$

where $m_{\alpha, i} \in \mathbb{N}_{0}$ for all $i=1,2, \ldots, r$ and $\Pi=\left\{\alpha_{1}, \alpha_{2}, \ldots, \alpha_{r}\right\}$, we define $t_{\alpha} \in \mathbb{Z}^{\Delta^{+}}$for $\alpha \in \Delta^{+} \backslash \Pi$ by

$$
t_{\theta}(\beta)= \begin{cases}m_{\theta, i} & \text { for } \beta=\alpha_{i}  \tag{2.25}\\ 1 & \text { for } \beta=\theta \\ 0 & \text { for } \beta \neq \theta \text { and } \beta \notin \Pi\end{cases}
$$

and

$$
t_{\alpha}(\beta)= \begin{cases}-m_{\alpha, i} & \text { for } \beta=\alpha_{i}  \tag{2.26}\\ 1 & \text { for } \beta=\alpha \\ 0 & \text { for } \beta \neq \alpha \text { and } \beta \notin \Pi\end{cases}
$$

for $\alpha \neq \theta$. Furthermore, we define subsets $\Lambda_{+}$and $\Lambda_{+}^{\theta}$ of $\mathbb{Z}^{\Delta^{+}}$by

$$
\begin{equation*}
\Lambda_{+}=\left\{\sum_{\alpha \in \Delta^{+} \backslash \Pi} n_{\alpha} t_{\alpha} ; n_{\alpha} \in \mathbb{N}_{0} \text { for all } \alpha \in \Delta^{+} \backslash \Pi\right\} \tag{2.27}
\end{equation*}
$$

and

$$
\begin{equation*}
\Lambda_{+}^{\theta}=\left\{\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} t_{\alpha} ; n_{\alpha} \in \mathbb{N}_{0} \text { for all } \alpha \in \Delta_{\theta}^{+} \backslash \Pi\right\} \tag{2.28}
\end{equation*}
$$

respectively.
Lemma 2.4. Let $\lambda \in \mathfrak{h}^{*}$ and $a, b \in \mathbb{Z}^{\Delta^{+}}$. Then $\mu_{\lambda, a}=\mu_{\lambda, b}$ if and only if

$$
\begin{equation*}
b=a+\sum_{\alpha \in \Delta^{+} \backslash \Pi} n_{\alpha} t_{\alpha} \tag{2.29}
\end{equation*}
$$

where $n_{\alpha} \in \mathbb{Z}$ for all $\alpha \in \Delta^{+} \backslash \Pi$.
Proof. Let $\lambda \in \mathfrak{h}^{*}$ and $a, b \in \mathbb{Z}^{\Delta^{+}}$. If $b=a+\sum_{\alpha \in \Delta^{+} \backslash \Pi} n_{\alpha} t_{\alpha}$, where $n_{\alpha} \in \mathbb{Z}$ for $\alpha \in \Delta^{+} \backslash \Pi$, then we have $\mu_{\lambda, a}=\mu_{\lambda, b}$. On the other hand, let us assume that $\mu_{\lambda, a}=\mu_{\lambda, b}$. Then we set $n_{\alpha}=b_{\alpha}-a_{\alpha}$ for $\alpha \in \Delta^{+} \backslash \Pi$ and define $c=a+\sum_{\alpha \in \Delta^{+} \backslash \Pi} n_{\alpha} t_{\alpha}$. Hence, we have $c_{\alpha}=a_{\alpha}+n_{\alpha}=b_{\alpha}$ for $\alpha \in \Delta^{+} \backslash \Pi$ and $c_{\alpha_{i}}=a_{\alpha_{i}}-\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} m_{\alpha, i}+n_{\theta} m_{\theta, i}$ for $i=1,2, \ldots, r$. Further, since $\mu_{\lambda, a}=\mu_{\lambda, b}$, we may write

\mu_{\lambda, b}-\mu_{\lambda, a} & =\sum_{\alpha \in \Delta_{\theta}^{+}}\left(a_{\alpha}-b_{\alpha}\right) \alpha-\left(a_{\theta}-b_{\theta}\right) \theta \\
& =\sum_{i=1}^{r}\left(a_{\alpha_{i}}-b_{\alpha_{i}}\right) \alpha_{i}+\sum_{i=1}^{r} \sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi}\left(a_{\alpha}-b_{\alpha}\right) m_{\alpha, i} \alpha_{i}-\sum_{i=1}^{r}\left(a_{\theta}-b_{\theta}\right) m_{\theta, i} \alpha_{i} \\
& =\sum_{i=1}^{r}\left(a_{\alpha_{i}}-b_{\alpha_{i}}+\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi}\left(a_{\alpha}-b_{\alpha}\right) m_{\alpha, i}-\left(a_{\theta}-b_{\theta}\right) m_{\theta, i}\right) \alpha_{i} \\
& =\sum_{i=1}^{r}\left(a_{\alpha_{i}}-b_{\alpha_{i}}-\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} m_{\alpha, i}+n_{\theta} m_{\theta, i}\right) \alpha_{i}=0,
\end{aligned}
$$

where we used (2.24). As the set $\left\{\alpha_{1}, \alpha_{2}, \ldots, \alpha_{r}\right\}$ forms a basis of $\mathfrak{h}^{*}$, we get

$$
a_{\alpha_{i}}-b_{\alpha_{i}}-\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} m_{\alpha, i}+n_{\theta} m_{\theta, i}=0
$$

which implies that $c_{\alpha_{i}}=b_{\alpha_{i}}$ for $i=1,2, \ldots, r$. Hence, we have $c_{\alpha}=b_{\alpha}$ for all $\alpha \in \Delta^{+}$and we are done.
Proposition 2.5. Let $\lambda \in \mathfrak{h}^{*}$. Then the set of all weights of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is $\left\{\mu_{\lambda, a} ; a \in \mathbb{Z}^{\Pi}\right\}$. Moreover, we have that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a weight $\mathfrak{h}$-module with infinite dimensional weight spaces and the subset

\left\{w_{\lambda, a+n_{a} t_{\theta}+t} ; t \in \Lambda_{+}, a+n_{a} t_{\theta}+t \in \mathbb{N}_{0}^{\Delta^{+}}\right\} \tag{2.30}
\end{equation*}
$$

of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{\lambda, a}}$ forms a basis of $W_{\mathfrak{b}_{+}}^{\mathfrak{g}}(\lambda)_{\mu_{\lambda, a}}$ for all $a \in \mathbb{Z}^{\Pi}$, where $n_{a} \in \mathbb{N}_{0}$ is the smallest non-negative integer satisfying $a+n_{a} t_{\theta} \in \mathbb{N}_{0}^{\Delta^{+}}$.

Proof. From the previous considerations we know that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a weight $\mathfrak{h}$-module and that all weighs are of the form $\mu_{\lambda, a}$ for some $a \in \mathbb{Z}^{\Pi}$ as follows from (2.23). Now, let us consider $a \in \mathbb{Z}^{\Pi}$. Since $\theta-\alpha \in Q_{+}$for all $\alpha \in \Delta^{+}$, i.e. $m_{\theta, i} \neq 0$ for all $i=1,2, \ldots, r$, there exists the smallest non-negative integer $n_{a} \in \mathbb{N}_{0}$ such that $a+n_{a} t_{\theta} \in \mathbb{N}_{0}^{\Delta^{+}}$. Moreover, we have $\mu_{\lambda, a}=\mu_{\lambda, a+n_{a} t_{\theta}}$, which implies that $\mu_{\lambda, a}$ is a weight of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$, since $w_{\lambda, a+n_{a} t_{\theta}}$ is a weight vector with weight $\mu_{\lambda, a}$. Further, since $a+\left(n_{a}+n\right) t_{\theta} \in \mathbb{N}_{0}^{\Delta^{+}}$and $\mu_{\lambda, a}=\mu_{\lambda, a+\left(n_{a}+n\right) t_{\theta}}$ for all $n \in \mathbb{N}_{0}$, we obtain
that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{\lambda, a}}$ contains the subset $\left\{w_{\lambda, a+\left(n_{a}+n\right) t_{\theta}} ; n \in \mathbb{N}_{0}\right\}$, which implies that the weight space $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{\lambda, a}}$ is infinite dimensional.

Let us assume that $w_{\lambda, b} \in W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{\lambda, a}}$ for $a \in \mathbb{Z}^{\Pi}$ and $b \in \mathbb{N}_{0}^{\Delta^{+}}$. Then we have $\mu_{\lambda, a}=\mu_{\lambda, b}$. By Lemma 2.4 we get

b=a+\sum_{\alpha \in \Delta+\backslash \Pi} n_{\alpha} t_{\alpha},
$$

where $n_{\alpha} \in \mathbb{Z}$ for all $\alpha \in \Delta^{+} \backslash \Pi$. Therefore, we have $b_{\alpha}=a_{\alpha}+n_{\alpha}=n_{\alpha}$ for $\alpha \in \Delta^{+} \backslash \Pi$ and $b_{\alpha_{i}}=a_{\alpha_{i}}+n_{\theta} m_{\theta, i}-\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} m_{\alpha, i}$ for $i=1,2, \ldots, r$. Since $b_{\alpha} \in \mathbb{N}_{0}$ for $\alpha \in \Delta^{+}$, we get $n_{\alpha} \in \mathbb{N}_{0}$ for $\alpha \in \Delta^{+} \backslash \Pi$ and

$$
0 \leq a_{\alpha_{i}}+n_{\theta} m_{\theta, i}-\sum_{\alpha \in \Delta_{\theta}^{+} \backslash \Pi} n_{\alpha} m_{\alpha, i} \leq a_{\alpha_{i}}+n_{\theta} m_{\theta, i}
$$

for $i=1,2, \ldots, r$. Hence, we obtain that $n_{\theta} \in \mathbb{N}_{0}$ and $a+n_{\theta} t_{\theta} \in \mathbb{N}_{0}^{\Delta^{+}}$. If we denote by $n_{a} \in \mathbb{N}_{0}$ the smallest non-negative integer satisfying $a+n_{a} t_{\theta} \in \mathbb{N}_{0}^{\Delta^{+}}$, then we may write $n_{\theta}$ in the form $n_{\theta}=n_{a}+n_{\theta}^{\prime}$ for $n_{\theta}^{\prime} \in \mathbb{N}_{0}$. This finishes the proof.

Theorem 2.6. Let $\lambda \in \mathfrak{h}^{*}$. Then we have

z v=\chi_{\lambda+\rho}(z) v \tag{2.31}
\end{equation*}
$$

for all $z \in \mathfrak{Z}(\mathfrak{g})$ and $v \in W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$.
Proof. For $\lambda \in \mathfrak{h}^{*}$ we show that

\pi_{\lambda+\rho}(z)=\chi_{\lambda+\rho}(z)
$$

for all $z \in \mathfrak{Z}(\mathfrak{g})$, which implies the required statement. For that reason, let us consider the Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$. Then we have $z v=\chi_{\lambda+\rho}(z) v$ for all $z \in \mathfrak{Z}(\mathfrak{g})$ and $v \in M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$, which follows from (2.12). As the Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is realized as $\mathcal{A} \mathfrak{\mathfrak { n }} / \mathcal{J}_{\mathrm{V}} \simeq \mathbb{C}\left[\partial_{x_{\alpha}}, \alpha \in \Delta^{+}\right]$, where the $\mathfrak{g}$-module structure on $\mathcal{A} \frac{\mathfrak{g}}{\bar{n}} / \mathcal{J}_{\mathrm{V}}$ is given through the homomorphism $\pi_{\lambda+\rho}: \mathfrak{g} \rightarrow \mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}}$ of Lie algebras, we have

\pi_{\lambda+\rho}(z) v=\chi_{\lambda+\rho}(z) v
$$

for all $v \in \mathbb{C}\left[\partial_{x_{\alpha}}, \alpha \in \Delta^{+}\right]$. Therefore, we have $\pi_{\lambda+\rho}(z)=\chi_{\lambda+\rho}(z)$ for all $z \in \mathcal{Z}(\mathfrak{g})$.
In the following, we give an explicit form of $\pi_{\lambda}\left(\mathrm{Cas}_{\theta}\right)$ for all $\lambda \in \mathfrak{h}^{*}$. Let us recall that the Lie subalgebra of $\mathfrak{g}$ generated by $\left\{e_{\theta}, h_{\theta}, f_{\theta}\right\}$ is denoted by $s_{\theta}$.

For $\lambda \in \mathfrak{h}^{*}$ we introduce a linear mapping

\sigma_{\lambda}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} \tag{2.32}
\end{equation*}
$$

by

\begin{equation*}
\sigma_{\lambda}(a)=-\sum_{\alpha \in \Delta+}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(v(x))} a\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(v(x))} a\right)_{\mathfrak{h}}\right) \tag{2.33}
\end{equation*}
$$

for all $a \in \mathfrak{g}$, where

$$
\begin{equation*}
v(x)=\sum_{\alpha \in \Delta_{\theta}^{+}} x_{\alpha} f_{\alpha} \tag{2.34}
\end{equation*}
$$

and we use the same convention as in (2.14). In particular, we have

\begin{equation*}
\sigma_{\lambda}(a)=-\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(v(x))}{e^{\operatorname{ad}(v(x))}-\mathrm{id}} a\right]_{\alpha} \partial_{x_{\alpha}} \tag{2.35}
\end{equation*}
$$

for $a \in \overline{\mathfrak{n}}$ and

$$
\begin{equation*}
\sigma_{\lambda}(a)=\sum_{\alpha \in \Delta^{+}}[\operatorname{ad}(v(x)) a]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)(a) \tag{2.36}
\end{equation*}
$$

for $a \in \mathfrak{h}$.
Proposition 2.7. Let $\lambda \in \mathfrak{h}^{*}$. Then we have

$$
\begin{equation*}
\pi_{\lambda}\left(e_{\alpha}\right)=x_{\theta} \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)+\sigma_{\lambda}\left(e_{\alpha}\right) \tag{2.37}
\end{equation*}
$$

for $\alpha \in \Delta_{\theta}^{+}$.
Proof. Let us assume that $\alpha \in \Delta_{\theta}^{+}$. Since $u(x)=v(x)+x_{\theta} f_{\theta}$ and $\left[v(x), x_{\theta} f_{\theta}\right]=0$, we may write

& =e^{-\operatorname{ad}(v(x))}\left(e_{\alpha}-\operatorname{ad}\left(x_{\theta} f_{\theta}\right) e_{\alpha}\right)=e^{-\operatorname{ad}(v(x))}\left(e_{\theta}+x_{\theta}\left[e_{\alpha}, f_{\theta}\right]\right),
\end{aligned}
$$

which implies

\begin{equation*}
\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\mathfrak{h}}=\left(e^{-\operatorname{ad}(v(x))} e_{\alpha}\right)_{\mathfrak{h}} \tag{2.38}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\overline{\mathfrak{n}}}=\left(e^{-\operatorname{ad}(v(x))} e_{\alpha}\right)_{\overline{\mathfrak{n}}}+x_{\theta} e^{-\operatorname{ad}(v(x))}\left[e_{\alpha}, f_{\theta}\right] . \tag{2.39}
\end{equation*}
$$

Finally, using (2.14) we may write

\pi_{\lambda}\left(e_{\alpha}\right)= & -\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x)) e^{\operatorname{ad}(u(x))}}{e^{\operatorname{ad}(u(x))}-\mathrm{id}}\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\mathfrak{h}}\right) \\
= & -\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\mathrm{id}}\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(u(x))} e_{\alpha}\right)_{\mathfrak{h}}\right) \\
= & -\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(v(x))} e_{\alpha}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(v(x))} e_{\alpha}\right)_{\mathfrak{h}}\right) \\
& -\sum_{\alpha \in \Delta^{+}} x_{\theta}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}} e^{-\operatorname{ad}(v(x))}\left[e_{\alpha}, f_{\theta}\right]\right]_{\alpha} \partial_{x_{\alpha}}
\end{aligned}
$$

were we used $[u(x), a]=[v(x), a]$ for all $a \in \overline{\mathfrak{n}}$ in the second equality and the formulas (2.38) and (2.39) in the last equality. Therefore, we get

\pi_{\lambda}\left(e_{\alpha}\right)=-\sum_{\alpha \in \Delta^{+}} x_{\theta}\left[\frac{\operatorname{ad}(v(x))}{e^{\operatorname{ad}(v(x))}-\mathrm{id}}\left[e_{\alpha}, f_{\theta}\right]\right]_{\alpha} \partial_{x_{\alpha}}+\sigma_{\lambda}\left(e_{\alpha}\right)=x_{\theta} \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)+\sigma_{\lambda}\left(e_{\alpha}\right) .
$$

This finishes the proof.
Proposition 2.8. We have

& \pi_{\lambda}\left(f_{\theta}\right)=-\partial_{x_{\theta}}, \\
& \pi_{\lambda}\left(h_{\theta}\right)=\sum_{\alpha \in \Delta^{+}} \alpha\left(h_{\theta}\right) x_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(h_{\theta}\right),  \tag{2.40}\\
& \pi_{\lambda}\left(e_{\theta}\right)=x_{\theta}\left(\pi_{\lambda}\left(h_{\theta}\right)-x_{\theta} \partial_{x_{\theta}}\right)+\sigma_{\lambda}\left(e_{\theta}\right),
\end{align*}
$$

for $\lambda \in \mathfrak{h}^{*}$.

Proof. Since $f_{\theta} \in \mathfrak{z}(\overline{\mathfrak{n}})$, we have $\left[u(x), f_{\theta}\right]=0$. Hence, from (2.16) we obtain

& =e^{-\operatorname{ad}(v(x))}\left(e_{\theta}-\operatorname{ad}\left(x_{\theta} f_{\theta}\right) e_{\theta}+\frac{1}{2} \operatorname{ad}\left(x_{\theta} f_{\theta}\right)^{2} e_{\theta}\right)=e^{-\operatorname{ad}(v(x))}\left(e_{\theta}+x_{\theta} h_{\theta}-x_{\theta}^{2} f_{\theta}\right),
\end{aligned}
$$

which implies

$$
\begin{equation*}
\left(e^{-\operatorname{ad}(u(x))} e_{\theta}\right)_{\mathfrak{h}}=\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\mathfrak{h}}+x_{\theta} h_{\theta} \tag{2.41}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(e^{-\operatorname{ad}(u(x))} e_{\theta}\right)_{\bar{n}}=\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\bar{n}}+x_{\theta}\left(e^{-\operatorname{ad}(v(x))} h_{\theta}\right)_{\bar{n}}-x_{\theta}^{2} f_{\theta} \tag{2.42}
\end{equation*}
$$

Finally, using (2.14) we may write

\begin{aligned}
\pi_{\lambda}\left(e_{\theta}\right)= & -\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x)) e^{\operatorname{ad}(u(x))}}{e^{\operatorname{ad}(u(x))}-\mathrm{id}}\left(e^{-\operatorname{ad}(u(x))} e_{\theta}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(u(x))} e_{\theta}\right)_{\mathfrak{h}}\right) \\

= & -\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\mathfrak{h}}\right) \\
& -\sum_{\alpha \in \Delta^{+}} x_{\theta}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}}\left(e^{-\operatorname{ad}(v(x))} h_{\theta}\right)_{\overline{\mathfrak{n}}}\right]_{\alpha}^{\partial_{x_{\alpha}}+\sum_{\alpha \in \Delta^{+}} x_{\theta}^{2}\left[\frac{\operatorname{ad}(v(x)) e^{\operatorname{ad}(v(x))}}{e^{\operatorname{ad}(v(x))}-\operatorname{id}} f_{\theta}\right]_{\alpha} \partial_{x_{\alpha}}} \\

Hence, we have an increasing filtration $\left\{F_{k} W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)\right\}_{k \in \mathbb{N}_{0}}$ on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. As the polynomial

As $\mathbb{C}\left[x_{\theta}\right]$ is generated by one vector, we get that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a cyclic $\mathfrak{g}$-module.

As $\left\{w_{\lambda-\rho, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t} ; a \in \mathbb{Z}^{\Pi}, n_{\theta} \in \mathbb{N}_{0}, t \in \Lambda_{+}^{\theta}, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t \in \mathbb{N}_{0}^{\Delta^{+}}\right\}$forms a basis of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda-\rho)$, we get that $\pi_{\lambda}\left(\operatorname{Cas}_{\theta}\right)_{s}$ is a semisimple operator.

Since $\sigma_{\lambda}\left(f_{\theta}\right)$ is obviously a locally nilpotent operator and $\sigma_{\lambda}\left(f_{\theta}\right) \sigma_{\lambda}\left(e_{\theta}\right)=\sigma_{\lambda}\left(e_{\theta}\right) \sigma_{\lambda}\left(f_{\theta}\right)$, we obtain that $\pi_{\lambda}\left(\operatorname{Cas}_{\theta}\right)_{n}$ is also a locally nilpotent operator.

The main disadvantage of $\mathfrak{g}$-modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$, in comparison with objects of the category $\mathcal{O}$, is infinite dimensional weight spaces. However, we can enlarge the Cartan subalgebra $\mathfrak{h}$ of $\mathfrak{g}$ to a commutative subalgebra $\Gamma_{\theta}$ of $U(\mathfrak{g})$ in such a way that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ is a $\theta$-GelfandTsetlin module, i.e. $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda) \in \mathcal{H}\left(\mathfrak{g}, \Gamma_{\theta}\right)$.

Theorem 2.11. Let $\lambda \in \mathfrak{h}^{*}$. Then the $\mathfrak{g}$-module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a $\theta$-Gelfand-Tsetlin module with finite $\Gamma_{\theta}$-multiplicities, i.e. $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda) \in \mathcal{H}_{\text {fin }}\left(\mathfrak{g}, \Gamma_{\theta}\right)$.
Proof. To prove that $\Gamma_{\theta}$-weight spaces are finite-dimensional we apply Theorem A.2, For that reason, let us introduce an $\mathbb{N}_{0}$-grading on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. For $r \in \mathbb{N}_{0}$ we denote by $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}$ the vector subspace of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ consisting of all homogenous polynomials of degree $r$ in the variables $\partial_{x_{\alpha}}$, $\alpha \in \Delta_{\theta}^{+}$, and $x_{\theta}$. Moreover, we have $\operatorname{dim} W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}<\infty$ for all $r \in \mathbb{N}_{0}$. Since the polynomials $\left[\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\mathfrak{h}}\right]_{\alpha}$ and $\left[\left(e^{-\operatorname{ad}(v(x))} e_{\theta}\right)_{\bar{n}}\right]_{\alpha}$ do not contain the constant and linear term for all $\alpha \in \Delta^{+}$, we obtain, using (2.33), that

\sigma_{\lambda+\rho}\left(h_{\theta}\right)\left(W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}\right) \subset W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r} \quad \text { and } \quad \sigma_{\lambda+\rho}\left(f_{\theta}\right)\left(W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}\right) \subset W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r-1}
$$

for $r \in \mathbb{N}_{0}$, according to Proposition 2.10, gives us

$$
\pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)_{s}\left(W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}\right) \subset W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}, \quad \pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)_{s}\left(F_{r} W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)\right) \subset F_{r-2} W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)
$$

for all $r \in \mathbb{N}_{0}$. Therefore, the assumptions of Theorem A. 2 are satisfied.
Let $\chi \in \operatorname{Hom}\left(\Gamma_{\theta}, \mathbb{C}\right)$ be a $\Gamma_{\theta}$-weight of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. Let us denote $\mu=\chi_{\mid \mathfrak{h}}$ and $c=\chi\left(\operatorname{Cas}_{\theta}\right)$. Then $\mu \in \mathfrak{h}^{*}$ is an $\mathfrak{h}$-weight of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ and we have $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\chi} \subset W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu}$. By Proposition 2.5 we obtain that there exists $a \in \mathbb{Z}^{\Pi}$ such that $\mu=\mu_{\lambda, a}$. The $\mathbb{N}_{0}$-grading on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ induces the $\mathbb{N}_{0}$-grading on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}}$ defined by $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}, r}=W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}} \cap W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{r}$ for all $r \in \mathbb{N}_{0}$. Hence, by using Theorem A. 2 for the linear mapping $\pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)$ on the vector subspace $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}}$, we get that eigenvalues of $\pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)$ on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}}$ are the same as eigenvalues of $\pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)_{s}$ on $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}}$, and moreover the dimensions of generalized eigenspaces corresponding to the same eigenvalue are equal. Hence, by Proposition 2.10 there exists $n_{\theta} \in \mathbb{N}_{0}$ such that $c=c_{\lambda, a, n_{\theta}}$. Further, from Proposition 2.5 and Proposition 2.10 follows that the set

\left\{w_{\lambda, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t} ; n_{\theta} \in \mathbb{N}_{0}, t \in \Lambda_{+}^{\theta}, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t \in \mathbb{N}_{0}^{\Delta^{+}}\right\}
$$

forms a basis of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\mu_{a}}$ and $w_{\lambda, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t}$ is an eigenvectors of $\pi_{\lambda+\rho}\left(\operatorname{Cas}_{\theta}\right)_{s}$ with eigenvalue $c_{\lambda, a, n_{\theta}}$. As we have $c_{\lambda, a, n_{\theta}}=c_{\lambda, a, n_{\theta}^{\prime}}$ for $n_{\theta}, n_{\theta}^{\prime} \in \mathbb{N}_{0}$ if and only if $n_{\theta}^{\prime}=n_{\theta}$ or $n_{\theta}^{\prime}=\mu_{\lambda, a}\left(h_{\theta}\right)-$ $2 n_{a}-n_{\theta}-1$ provided $\mu_{\lambda, a}\left(h_{\theta}\right)-2 n_{a}-n_{\theta}-1 \in \mathbb{N}_{0}$, we obtain

$$
\begin{aligned}
& \operatorname{dim} W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)_{\chi}=দ\left\{a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t ; t \in \Lambda_{+}^{\theta}, a+\left(n_{a}+n_{\theta}\right) t_{\theta}+t \in \mathbb{N}_{0}^{\Delta^{+}}\right\} \\
& \quad+\natural\left\{a+\left(\mu_{\lambda, a}\left(h_{\theta}\right)-n_{a}-n_{\theta}-1\right) t_{\theta}+t ; t \in \Lambda_{+}^{\theta}, a+\left(\mu_{\lambda, a}\left(h_{\theta}\right)-n_{a}-n_{\theta}-1\right) t_{\theta}+t \in \mathbb{N}_{0}^{\Delta^{+}}\right\}
\end{aligned}
$$

which is obviously a finite number. This completes the proof.
Corollary 2.12. The $\mathfrak{g}$-module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ belongs to the category $\mathcal{I}_{\theta, f, \text { fin }}$ for all $\lambda \in \mathfrak{h}^{*}$.
Corollary 2.13. Let $\Gamma$ be any commutative subalgebra of $U(\mathfrak{g})$ containing $\Gamma_{\theta}$. Then the $\mathfrak{g}$-module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ belongs to the category $\mathcal{H}_{\text {fin }}(U(\mathfrak{g}), \Gamma)$ for all $\lambda \in \mathfrak{h}^{*}$.

Hence, the $\theta$-Gelfand-Tsetlin $\mathfrak{g}$-modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a $\Gamma$-weight module for any commutative $\Gamma$ containing $\Gamma_{\theta}$. In particular, if $\mathfrak{g}=\mathfrak{s l}(n)($ or $\mathfrak{g}=\mathfrak{g l}(n))$ and $\Gamma$ is a Gelfand-Tsetlin subalgebra of $U(\mathfrak{g})$ containing $\operatorname{Cas}_{\theta}$ then $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a Gelfand-Tsetlin module (with respect to a particular choice of a Gelfand-Tsetlin subalgebra) [3] (in this case the chain of $\mathfrak{s l}(m)$-subalgebras contains $\mathfrak{s l}(2)$ associated to the root $\theta$ ). Therefore, the $\mathfrak{g}$-modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ can be viewed as examples of GelfandTsetlin modules for an arbitrary simple finite-dimensional $\mathfrak{g}$ with respect to any $\Gamma$ containing $\Gamma_{\theta}$.

By duality we can similarly construct certain $\theta$-Gelfand-Tsetlin modules in the category $\mathcal{I}_{\theta, e, \text { fin }}$. A comparison of the basic characteristics of Verma modules and Gelfand-Tsetlin modules is given in Table 1 Their realization is given by the following theorem.

Theorem 2.14. Let $\lambda \in \mathfrak{h}^{*}$. Then the $\mathfrak{g}$-module

\mathcal{A}_{\mathfrak{n}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{GT}} \simeq \mathbb{C}\left[\partial_{x_{\alpha}}, \alpha \in \Delta_{\theta}^{+}, x_{\theta}\right], \quad \mathcal{J}_{\mathrm{GT}}=\left(x_{\alpha}, \alpha \in \Delta_{\theta}^{+}, \partial_{x_{\theta}}\right), \tag{2.47}
\end{equation*}
$$

where the $\mathfrak{g}$-module structure on $\mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{GT}}$ is given through the homomorphism $\pi_{\lambda+\rho}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ of Lie algebras with

\begin{equation*}
\pi_{\lambda}(a)=-\sum_{\alpha \in \Delta^{+}}\left[\frac{\operatorname{ad}(u(x)) e^{\operatorname{ad}(u(x))}}{e^{\operatorname{ad}(u(x))}-\mathrm{id}}\left(e^{-\operatorname{ad}(u(x))} a\right)_{\overline{\mathfrak{n}}}\right]_{\alpha} \partial_{x_{\alpha}}+(\lambda+\rho)\left(\left(e^{-\operatorname{ad}(u(x))} a\right)_{\mathfrak{h}}\right) \tag{2.48}
\end{equation*}
$$

for all $a \in \mathfrak{g}$, is a weight, cyclic $\theta$-Gelfand-Tsetlin module with finite $\Gamma_{\theta}$-multiplicities.

### 2.3 Gelfand-Tsetlin modules for $\mathfrak{s l}(3, \mathbb{C})$

In this section, we will focus more closely on the Gelfand-Tsetlin modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ over the Lie algebra $\mathfrak{s l}(3, \mathbb{C})$. In particular, we describe the irreducibility condition for these modules. We use the notation introduced in the previous section.

Let us consider the complex simple Lie algebra $\mathfrak{g}=\mathfrak{s l}(3, \mathbb{C})$. A Cartan subalgebra $\mathfrak{h}$ of $\mathfrak{g}$ is given by diagonal matrices

\mathfrak{h}=\left\{\operatorname{diag}\left(a_{1}, a_{2}, a_{3}\right) ; a_{1}, a_{2}, a_{3} \in \mathbb{C}, a_{1}+a_{2}+a_{3}=0\right\} . \tag{2.49}
\end{equation*}
$$

For $i=1,2,3$ we define $\varepsilon_{i} \in \mathfrak{h}^{*}$ by $\varepsilon_{i}\left(\operatorname{diag}\left(a_{1}, a_{2}, a_{3}\right)\right)=a_{i}$. The root system of $\mathfrak{g}$ with respect to $\mathfrak{h}$ is $\Delta=\left\{\varepsilon_{i}-\varepsilon_{j} ; 1 \leq i \neq j \leq 3\right\}$. A positive root system in $\Delta$ is $\Delta^{+}=\left\{\varepsilon_{1}-\varepsilon_{2}, \varepsilon_{2}-\varepsilon_{3}, \varepsilon_{1}-\varepsilon_{3}\right\}$ and the set of simple roots is $\Pi=\left\{\alpha_{1}, \alpha_{2}\right\}$ with $\alpha_{1}=\varepsilon_{1}-\varepsilon_{2}$ and $\alpha_{2}=\varepsilon_{2}-\varepsilon_{3}$. The remaining positive root $\alpha_{1}+\alpha_{2}=\varepsilon_{1}-\varepsilon_{3}$ is the maximal root $\theta$ of $\mathfrak{g}$.

Let us introduce a root basis of the niradical $\mathfrak{n}$ by

\end{array}\right), \quad e_{\theta}=\left(\begin{array}{ccc}
0 & 0 & 1 \\

\end{array}\right), \quad e_{\alpha_{2}}=\left(\begin{array}{ccc}
0 & 0 & 0 \\
0 & 0 & 1 \\
0 & 0 & 0
\end{array}\right)
$$

and a root basis of the opposite nilradical $\overline{\mathfrak{n}}$ through

$$
f_{\alpha_{1}}=\left(\begin{array}{ccc}
0 & 0 & 0 \\
1 & 0 & 0 \\
0 & 0 & 0
\end{array}\right), \quad f_{\theta}=\left(\begin{array}{ccc}
0 & 0 & 0 \\
0 & 0 & 0 \\
1 & 0 & 0
\end{array}\right), \quad f_{\alpha_{2}}=\left(\begin{array}{ccc}
0 & 0 & 0 \\
0 & 0 & 0 \\
0 & 1 & 0
\end{array}\right)
$$

The coroots corresponding to the positive roots are given by

$$
h_{\alpha_{1}}=\left(\begin{array}{ccc}
1 & 0 & 0 \\
0 & -1 & 0 \\
0 & 0 & 0
\end{array}\right), \quad h_{\theta}=\left(\begin{array}{ccc}
1 & 0 & 0 \\
0 & 0 & 0 \\
0 & 0 & -1
\end{array}\right), \quad h_{\alpha_{2}}=\left(\begin{array}{ccc}
0 & 0 & 0 \\
0 & 1 & 0 \\
0 & 0 & -1
\end{array}\right) .
$$

These generators fulfill, among others, the commutation relations $\left[e_{\alpha_{1}}, e_{\alpha_{2}}\right]=e_{\theta}$ and $\left[f_{\alpha_{2}}, f_{\alpha_{1}}\right]=$ $f_{\theta}$. Moreover, we have that $\left(e_{\theta}, h_{\theta}, f_{\theta}\right)$ is an $\mathfrak{s l}(2, \mathbb{C})$-triple.

Let us recall that $\left\{x_{\alpha_{1}}, x_{\alpha_{2}}, x_{\theta}\right\}$ are the linear coordinate functions on $\overline{\mathfrak{n}}$ with respect to the basis $\left\{f_{\alpha_{1}}, f_{\alpha_{2}}, f_{\theta}\right\}$ of $\overline{\mathfrak{n}}$ and that the Weyl algebra $\mathcal{A} \overline{\mathfrak{g}}$ of $\overline{\mathfrak{n}}$ is generated by $\left\{x_{\alpha_{1}}, \partial_{x_{\alpha_{1}}}, x_{\alpha_{2}}, \partial_{x_{\alpha_{2}}}, x_{\theta}, \partial_{x_{\theta}}\right\}$ together with the canonical commutation relations. For clarity, we denote $x=x_{\alpha_{1}}, y=x_{\alpha_{2}}$ and $z=x_{\theta}$.

Theorem 2.15. Let $\lambda \in \mathfrak{h}^{*}$. Then the homomorphism $\pi_{\lambda}: \mathfrak{g} \rightarrow \mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}}$ of Lie algebras is given by

\begin{aligned}
\pi_{\lambda}\left(f_{\alpha_{1}}\right) & =-\partial_{x}+\frac{1}{2} y \partial_{z}, \\
\pi_{\lambda}\left(f_{\alpha_{2}}\right) & =-\partial_{y}-\frac{1}{2} x \partial_{z}, \\
\pi_{\lambda}\left(f_{\theta}\right) & =-\partial_{z}
\end{aligned}
$$

$$
\begin{aligned}
\pi_{\lambda}\left(e_{\alpha_{1}}\right) & =z\left(\partial_{y}+\frac{1}{2} x \partial_{z}\right)+x\left(x \partial_{x}-\frac{1}{2} y \partial_{y}+\lambda_{1}+1\right)+\frac{1}{4} x^{2} y \partial_{z} \\
\pi_{\lambda}\left(e_{\alpha_{2}}\right) & =z\left(-\partial_{x}+\frac{1}{2} y \partial_{z}\right)+y\left(y \partial_{y}-\frac{1}{2} x \partial_{x}+\lambda_{2}+1\right)-\frac{1}{4} x y^{2} \partial_{z} \\
\pi_{\lambda}\left(e_{\theta}\right) & =z\left(x \partial_{x}+y \partial_{y}+z \partial_{z}+\lambda_{1}+\lambda_{2}+2\right)+\frac{1}{2} x y\left(x \partial_{x}-y \partial_{y}+\lambda_{1}-\lambda_{2}\right)+\frac{1}{4} x^{2} y^{2} \partial_{z}, \\
\pi_{\lambda}\left(h_{\alpha_{1}}\right) & =2 x \partial_{x}-y \partial_{y}+z \partial_{z}+\lambda_{1}+1, \\
\pi_{\lambda}\left(h_{\alpha_{2}}\right) & =-x \partial_{x}+2 y \partial_{y}+z \partial_{z}+\lambda_{2}+1, \\
\pi_{\lambda}\left(h_{\theta}\right) & =x \partial_{x}+y \partial_{y}+2 z \partial_{z}+\lambda_{1}+\lambda_{2}+2,
\end{aligned}

where $\lambda_{1}=\lambda\left(h_{\alpha_{1}}\right)$ and $\lambda_{2}=\lambda\left(h_{\alpha_{2}}\right)$.
Proof. It follows immediately by a straightforward computation from (2.14).
The homomorphism $\pi_{\lambda}: \mathfrak{g} \rightarrow \mathcal{A} \frac{\mathfrak{n}}{}$ of Lie algebras enables us to construct a wide class of interesting $\mathfrak{g}$-modules. The easiest way is to take a left ideal $\mathcal{J}$ of $\mathcal{A} \frac{\mathfrak{n}}{\mathfrak{n}}$. Then $\mathcal{A} \frac{\mathfrak{n}}{\mathfrak{n}} / \mathcal{J}$ has the $\mathfrak{g}$-module structure through the homomorphism $\pi_{\lambda}: \mathfrak{g} \rightarrow \mathcal{A} \mathfrak{g}$.

In the previous section, we considered only the two simplest possible left ideals of the Weyl algebra $\mathcal{A}_{\mathfrak{g}}^{\mathfrak{g}}$. The first one $\mathcal{J}_{\mathrm{V}}=(x, y, z)$ leads to the Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda) \simeq \mathcal{A}_{\mathfrak{\mathfrak { n }}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{V}}$, while the second one $\mathcal{J}_{\mathrm{GT}}=\left(x, y, \partial_{z}\right)$ leads to the Gelfand-Tsetlin modules $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda) \simeq \mathcal{A}_{\frac{\mathfrak{g}}{\mathfrak{g}}} / \mathcal{J}_{\mathrm{GT}}$. However, we have much more options, where some of them lead to the so called twisted Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)^{w}$ labeled by the elements $w \in W$ of the Weyl group $W$ of $\mathfrak{g}$, see [15].

The twisted Verma modules $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)^{w}$ for $\lambda \in \mathfrak{h}^{*}$ and $w \in W$ are realized as $\mathcal{A}_{\mathfrak{n}}^{\mathfrak{g}} / \mathcal{J}_{w}$, where $\mathcal{J}_{w}$ is the left ideal of $\mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ defined by

$$
\begin{equation*}
\mathcal{J}_{w}=\left(x_{\alpha}, \alpha \in w^{-1}\left(\Delta^{+}\right) \cap \Delta^{+}, \partial_{x_{\alpha}}, \alpha \in w^{-1}\left(-\Delta^{+}\right) \cap \Delta^{+}\right) \tag{2.50}
\end{equation*}
$$

and the $\mathfrak{g}$-module structure on $\mathcal{A} \mathfrak{g} / \mathcal{J}_{w}$ is given through the homomorphism $\pi_{\lambda+\rho}^{w}: \mathfrak{g} \rightarrow \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}}$ of Lie algebras defined by

$$
\begin{equation*}
\pi_{\lambda+\rho}^{w}=\pi_{w^{-1}(\lambda+\rho)} \circ \operatorname{Ad}\left(\dot{w}^{-1}\right) \tag{2.51}
\end{equation*}
$$

where $w^{-1}$ acts in the standard way and $\dot{w}$ is a representative of $w$ in the Lie group $G=\operatorname{SL}(3, \mathbb{C})$. The list of all possibilities looks as follows:

1) $w=e, \mathcal{J}_{e}=(x, y, z), \mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}} / I_{e} \simeq \mathbb{C}\left[\partial_{x}, \partial_{y}, \partial_{z}\right]$;
2) $w=s_{1}, \mathcal{J}_{s_{1}}=\left(\partial_{x}, y, z\right), \mathcal{A}_{\overline{\mathfrak{n}}} / \mathcal{J}_{s_{1}} \simeq \mathbb{C}\left[x, \partial_{y}, \partial_{z}\right]$;
3) $w=s_{2}, \mathcal{J}_{s_{2}}=\left(x, \partial_{y}, z\right), \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} / \mathcal{J}_{s_{2}} \simeq \mathbb{C}\left[\partial_{x}, y, \partial_{z}\right]$;
4) $w=s_{1} s_{2}, \mathcal{J}_{s_{1} s_{2}}=\left(x, \partial_{y}, \partial_{z}\right), \mathcal{A}_{\frac{\mathfrak{g}}{} / \mathcal{J}_{s_{1} s_{2}} \simeq \mathbb{C}\left[\partial_{x}, y, z\right] \text {; } ; \text {, }}$
5) $w=s_{2} s_{1}, \mathcal{J}_{s_{2} s_{1}}=\left(\partial_{x}, y, \partial_{z}\right), \mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}} / \mathcal{J}_{s_{2} s_{1}} \simeq \mathbb{C}\left[x, \partial_{y}, z\right]$;
6) $w=s_{1} s_{2} s_{1}, \mathcal{J}_{s_{1} s_{2} s_{1}}=\left(\partial_{x}, \partial_{y}, \partial_{z}\right), \mathcal{A} \mathfrak{\mathfrak { n }} / \mathcal{J}_{s_{1} s_{2} s_{1}} \simeq \mathbb{C}[x, y, z]$.

The elements $s_{1}$ and $s_{2}$ of the Weyl group $W$ denote the reflections about the hyperplanes perpendicular to $\alpha_{1}$ and $\alpha_{2}$, respectively.

In fact, we have another two possible left ideals of $\mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}}$, which look as follows:
7) $\mathcal{J}_{\mathrm{GT}}=\left(x, y, \partial_{z}\right), \mathcal{A}_{\overline{\mathfrak{n}}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{GT}} \simeq \mathbb{C}\left[\partial_{x}, \partial_{y}, z\right]$;
8) $\mathcal{J}_{\mathrm{GT}^{*}}=\left(\partial_{x}, \partial_{y}, z\right), \mathcal{A}_{\frac{\mathfrak{n}}{}} / \mathcal{J}_{\mathrm{GT}^{*}} \simeq \mathbb{C}\left[x, y, \partial_{z}\right]$.

Hence, we have the complete list of left ideals of the Weyl algebra $\mathcal{A} \frac{\mathfrak{g}}{\mathfrak{n}}$ of the given type, where we consider either $x_{\alpha}$ or $\partial_{x_{\alpha}}$ for each $\alpha \in \Delta^{+}$.
Theorem 2.16. Let $\lambda \in \mathfrak{h}^{*}$. Then $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a simple $\mathfrak{g}$-module if and only if $\lambda\left(h_{\alpha_{1}}\right), \lambda\left(h_{\alpha_{2}}\right) \notin \mathbb{N}_{0}$ and $\lambda\left(h_{\theta}\right) \notin \mathbb{Z}$.
Proof. Let $M$ be a nonzero $\mathfrak{g}$-submodule of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$. Then $M$ is a weight $\mathfrak{h}$-module, since $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda-\rho)$ is a weight $\mathfrak{h}$-module. Moreover, we have $\pi_{\lambda}\left(f_{\theta}\right)=-\partial_{z}$, which implies that $M$
contains a nonzero weight vector $v$ satisfying $\partial_{z} v=0$. Hence, the weight vector $v$ is of the form $v=\partial_{x}^{a} \partial_{y}^{b}$ for some $a, b \in \mathbb{N}_{0}$. Further, by Proposition 2.8 and Proposition 2.7 we have

$$
\pi_{\lambda}\left(e_{\theta}\right)=z\left(\pi_{\lambda}\left(h_{\theta}\right)-z \partial_{z}\right)+\sigma_{\lambda}\left(e_{\theta}\right)
$$

and

$$
\pi_{\lambda}\left(e_{\alpha}\right)=z \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)+\sigma_{\lambda}\left(e_{\alpha}\right)
$$

for $\alpha \in \Delta_{\theta}^{+}$. As we have $\left[\pi_{\lambda}\left(h_{\theta}\right), z\right]=2 z$, we may write

$$
\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \pi_{\lambda}\left(e_{\alpha}\right)=z \pi_{\lambda}\left(h_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)+\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha}\right)
$$

and

$$
\pi_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)=z\left(\pi_{\lambda}\left(h_{\theta}\right)-z \partial_{z}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)+\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)
$$

for $\alpha \in \Delta_{\theta}^{+}$. Since $\left[\pi_{\lambda}\left(f_{\theta}\right), \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)\right]=0$ for $\alpha \in \Delta_{\theta}^{+}$and $\partial_{z} v=0$, we get

$$
\begin{aligned}
\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \pi_{\lambda}\left(e_{\alpha}\right) v & =z \pi_{\lambda}\left(h_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right) v+\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha}\right) v \\
\pi_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right) v & =z \pi_{\lambda}\left(h_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right) v+\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right) v
\end{aligned}
$$

which implies that

$$
\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \pi_{\lambda}\left(e_{\alpha}\right)-\pi_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)\right) v=\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha}\right)-\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha}, f_{\theta}\right]\right)\right) v
$$

for $\alpha \in \Delta_{\theta}^{+}$. If we denote

$$
\begin{aligned}
& w_{1}=\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha_{1}}\right)-\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha_{1}}, f_{\theta}\right]\right)\right) v \\
& w_{2}=\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha_{2}}\right)-\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(\left[e_{\alpha_{2}}, f_{\theta}\right]\right)\right) v
\end{aligned}
$$

then we have $w_{1}, w_{2} \in M$ and $\pi_{\lambda}\left(f_{\theta}\right) w_{1}=0, \pi_{\lambda}\left(f_{\theta}\right) w_{2}=0$. We may write

$$
\begin{aligned}
w_{1} & =\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha_{1}}\right)+\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(f_{\alpha_{2}}\right)\right) v \\
& =\left(\left(x \partial_{x}+y \partial_{y}+\lambda_{1}+\lambda_{2}\right) x\left(x \partial_{x}-\frac{1}{2} y \partial_{y}+\lambda_{1}+1\right)-\frac{1}{2} x y\left(x \partial_{x}-y \partial_{y}+\lambda_{1}-\lambda_{2}\right) \partial_{y}\right) v \\
& =x\left(x \partial_{x}+\lambda_{1}+\lambda_{2}+1\right)\left(x \partial_{x}+\lambda_{1}+1\right) v=x\left(\partial_{x} x+\lambda_{1}+\lambda_{2}\right)\left(\partial_{x} x+\lambda_{1}\right) v
\end{aligned}
$$

and similarly

$$
\begin{aligned}
w_{2} & =\left(\left(\pi_{\lambda}\left(h_{\theta}\right)-2\right) \sigma_{\lambda}\left(e_{\alpha_{2}}\right)-\sigma_{\lambda}\left(e_{\theta}\right) \pi_{\lambda}\left(f_{\alpha_{1}}\right)\right) v \\
& =\left(\left(x \partial_{x}+y \partial_{y}+\lambda_{1}+\lambda_{2}\right) y\left(y \partial_{y}-\frac{1}{2} x \partial_{x}+\lambda_{2}+1\right)+\frac{1}{2} x y\left(x \partial_{x}-y \partial_{y}+\lambda_{1}-\lambda_{2}\right) \partial_{x}\right) v \\
& =y\left(y \partial_{y}+\lambda_{1}+\lambda_{2}+1\right)\left(y \partial_{y}+\lambda_{2}+1\right) v=y\left(\partial_{y} y+\lambda_{1}+\lambda_{2}\right)\left(\partial_{y} y+\lambda_{2}\right) v
\end{aligned}
$$

where we used Theorem 2.15 and notation $\lambda_{1}=\lambda\left(h_{\alpha_{1}}\right)$ and $\lambda_{2}=\lambda\left(h_{\alpha_{2}}\right)$. Since $v=\partial_{x}^{a} \partial_{y}^{b}$ for some $a, b \in \mathbb{N}_{0}$, we obtain

$$
w_{1}=-a\left(\lambda_{1}+\lambda_{2}-a\right)\left(\lambda_{1}-a\right) \partial_{x}^{a-1} \partial_{y}^{b} \quad \text { and } \quad w_{2}=-b\left(\lambda_{1}+\lambda_{2}-b\right)\left(\lambda_{2}-b\right) \partial_{x}^{a} \partial_{y}^{b-1}
$$

which implies that $a \partial_{x}^{a-1} \partial_{y}^{b}, b \partial_{x}^{a} \partial_{y}^{b-1} \in M$ provided $\lambda_{1}, \lambda_{2}, \lambda_{1}+\lambda_{2} \notin \mathbb{N}$. As a consequence, we get that $1 \in M$ if $\lambda_{1}, \lambda_{2}, \lambda_{1}+\lambda_{2} \notin \mathbb{N}$. Since $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is generated by the vector $1 \in W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda_{1}+\lambda_{2} \notin-\mathbb{N}_{0}$, as follows from the proof of Theorem 2.9, we obtain that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a simple $\mathfrak{g}$-module if $\lambda_{1}, \lambda_{2} \notin \mathbb{N}$ and $\lambda_{1}+\lambda_{2} \notin \mathbb{Z}$.

Now, let us assume that $\lambda_{1}+\lambda_{2} \in-\mathbb{N}_{0}$. Let $M$ be the $\mathfrak{g}$-submodule of $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ generated by the vector $1 \in W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$. For a vector $v \in M$ we may write $v=\pi_{\lambda}(u) 1$, where $u \in U(\mathfrak{g})$, which gives us $\pi_{\lambda}\left(e_{\theta}\right) v=\pi_{\lambda}\left(\left[e_{\theta}, u\right]\right) 1+\pi_{\lambda}(u) \pi_{\lambda}\left(e_{\theta}\right) 1$. Since $\operatorname{ad}\left(e_{\theta}\right)$ is locally nilpotent on $U(\mathfrak{g})$ and $\pi_{\lambda}\left(e_{\theta}\right)^{-\lambda_{1}-\lambda_{2}+1} 1=0$, we obtain that $\pi_{\lambda}\left(e_{\theta}\right)$ is locally nilpotent on $M$. However, we have
$\pi_{\lambda}\left(e_{\theta}\right)^{k} z^{-\lambda_{1}-\lambda_{2}+1}=k!z^{-\lambda_{1}-\lambda_{2}+k+1}$ for $k \in \mathbb{N}_{0}$, which implies that $z^{-\lambda_{1}-\lambda_{2}+1} \notin M$. Hence, we get that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is not a simple $\mathfrak{g}$-module.

Further, let us assume that $\lambda_{1} \in \mathbb{N}$. Then there exists a homomorphism

$$
\varphi_{\lambda}: M_{\mathfrak{b}}^{\mathfrak{g}}\left(s_{1}(\lambda+\rho)-\rho\right) \rightarrow M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)
$$

of Verma modules. As the Verma module $M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ is realized as $\mathcal{A}_{\mathfrak{n}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{V}} \simeq \mathbb{C}\left[\partial_{x}, \partial_{y}, \partial_{z}\right]$, where the $\mathfrak{g}$-module structure on $\mathcal{A} \mathfrak{g} / \mathcal{J}_{\mathrm{V}}$ is given through the homomorphism $\pi_{\lambda+\rho}: \mathfrak{g} \rightarrow \mathcal{A}_{\bar{n}}^{\mathfrak{g}}$ of Lie algebras, we have

$$
\pi_{\lambda}(a) \varphi_{\lambda}(v)=\varphi_{\lambda}\left(\pi_{s_{1} \lambda}(a) v\right)
$$

for all $v \in \mathbb{C}\left[\partial_{x}, \partial_{y}, \partial_{z}\right]$ and $a \in \mathfrak{g}$. Moreover, we have $\varphi_{\lambda}=\left(\partial_{x}+\frac{1}{2} y \partial_{z}\right)^{\lambda_{1}}$, as follows immediately from [15, Theorem 2.1], which gives us $\pi_{\lambda}(a) \circ \varphi_{\lambda}=\varphi_{\lambda} \circ \pi_{s_{1} \lambda}(a)$ in the Weyl algebra $\mathcal{A} \frac{\mathfrak{g}}{\bar{n}}$ for all $a \in \mathfrak{g}$. Therefore, we obtain a homomorphism

$$
\psi_{\lambda}: W_{\mathfrak{b}}^{\mathfrak{g}}\left(s_{1}(\lambda+\rho)-\rho\right) \rightarrow W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)
$$

of Gelfand-Tsetlin modules, such that $\psi_{\lambda}=\varphi_{\lambda}$ if we realize the Gelfand-Tsetlin module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ for $\lambda \in \mathfrak{h}^{*}$ as $\mathcal{A}_{\mathfrak{\mathfrak { n }}}^{\mathfrak{g}} / \mathcal{J}_{\mathrm{GT}} \simeq \mathbb{C}\left[\partial_{x}, \partial_{y}, z\right]$. As $\psi_{\lambda}$ is not surjective, we obtain that $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is not a simple $\mathfrak{g}$-module. By a similar argument, we prove it in the case $\lambda_{2} \in \mathbb{N}$ or $\lambda_{1}+\lambda_{2} \in \mathbb{N}$. If $\lambda_{2} \in \mathbb{N}$, then there exists a homomorphism

$$
\varphi_{\lambda}: M_{\mathfrak{b}}^{\mathfrak{g}}\left(s_{2}(\lambda+\rho)-\rho\right) \rightarrow M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)
$$

of Verma modules with $\varphi_{\lambda}=\left(\partial_{y}-\frac{1}{2} y \partial_{z}\right)^{\lambda_{2}}$. Finally, if $\lambda_{1}+\lambda_{2} \in \mathbb{N}$, then there exists a homomorphism

$$
\varphi_{\lambda}: M_{\mathfrak{b}}^{\mathfrak{g}}\left(s_{1} s_{2} s_{1}(\lambda+\rho)-\rho\right) \rightarrow M_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)
$$

of Verma modules with $\varphi_{\lambda}=\prod_{j=0}^{k-1}\left(\left(\partial_{x}+\frac{1}{2} y \partial_{z}\right)\left(\partial_{y}-\frac{1}{2} x \partial_{z}\right)-\frac{1}{2}\left(\lambda_{1}-\lambda_{2}-k+2 j\right) \partial_{z}\right)$, where $k=-\lambda_{1}-\lambda_{2}$.

Therefore, the Gelfand-Tsetlin module $W_{\mathfrak{b}}^{\mathfrak{g}}(\lambda)$ is a simple $\mathfrak{g}$-module if and only if $\lambda_{1}, \lambda_{2} \notin \mathbb{N}$ and $\lambda_{1}+\lambda_{2} \notin \mathbb{Z}$.

## Appendix A Generalized eigenspace decomposition

For the reader's convenience, we summarize and prove several important facts concerning the generalized eigenspace decomposition.

Let $V$ be a complex vector space and let $T: V \rightarrow V$ be a linear mapping. For each $\lambda \in \mathbb{C}$ we set

$$
\begin{equation*}
V_{\lambda}=\left\{v \in V ;(\exists k \in \mathbb{N})(T-\lambda \mathrm{id})^{k} v=0\right\} \tag{A.1}
\end{equation*}
$$

and call it the generalized eigenspace of $T$ with eigenvalue $\lambda$. When $V_{\lambda} \neq\{0\}$, we say that $\lambda$ is an eigenvalue of $T$ and the elements of $V_{\lambda}$ are called generalized eigenvectors with eigenvalue $\lambda$. Further, let us note that

$$
\begin{equation*}
\sum_{\lambda \in \mathbb{C}} V_{\lambda}=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda} \tag{A.2}
\end{equation*}
$$

however it does not hold, in general, that $V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda}$.
Let $V=\bigoplus_{r \in \mathbb{N}_{0}} V_{r}$ be an $\mathbb{N}_{0}$-graded complex vector space. Then we denote by $p_{r}: V \rightarrow V_{r}$ for $r \in \mathbb{N}_{0}$ the canonical projection with respect to the direct sum decomposition. Furthermore, we define

$$
\begin{equation*}
F_{k} V=\bigoplus_{r=0}^{k} V_{r} \tag{A.3}
\end{equation*}
$$

for all $k \in \mathbb{N}_{0}$, which gives us an increasing filtration $\left\{F_{k} V\right\}_{k \in \mathbb{N}_{0}}$ on $V$.
Lemma A.1. Let $V=\bigoplus_{r \in \mathbb{N}_{0}} V_{r}$ be an $\mathbb{N}_{0}$-graded complex vector space and let $\operatorname{dim} V_{r}<\infty$ for all $r \in \mathbb{N}_{0}$. Further, let $T: V \rightarrow V$ be a linear mapping satisfying

$$
\begin{equation*}
T\left(F_{k} V\right) \subset F_{k} V \tag{A.4}
\end{equation*}
$$

for all $k \in \mathbb{N}_{0}$. Then we have a decomposition

$$
\begin{equation*}
V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda} \tag{A.5}
\end{equation*}
$$

called the generalized eigenspace decomposition of $V$ with respect to $T$.
Proof. We already know that $\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda} \subset V$. Let us assume that $v \in V$. Then there exists $k \in \mathbb{N}_{0}$ such that $v \in F_{k} V$. Since $T\left(F_{k} V\right) \subset F_{k} V$ and $\operatorname{dim} F_{k} V<\infty$, we have the generalized eigenspace decomposition of $F_{k} V$ with respect to $T$. Therefore, we obtain a decomposition $v=\sum_{\lambda \in \mathbb{C}} v_{\lambda}$, were $v_{\lambda} \in V_{\lambda} \cap F_{k} V$, which gives us the required statement.
Theorem A.2. Let $V=\bigoplus_{r \in \mathbb{N}_{0}} V_{r}$ be an $\mathbb{N}_{0}$-graded complex vector space and let $\operatorname{dim} V_{r}<\infty$ for all $r \in \mathbb{N}_{0}$. Further, let $T_{s}, T_{n}: V \rightarrow V$ be linear mappings satisfying

$$
\begin{equation*}
T_{s}\left(V_{r}\right) \subset V_{r} \quad \text { and } \quad T_{n}\left(F_{r} V\right) \subset F_{r-1} V \tag{A.6}
\end{equation*}
$$

for all $r \in \mathbb{N}_{0}$. Then there exists an isomorphism

$$
\begin{equation*}
\varphi: V \rightarrow V \tag{A.7}
\end{equation*}
$$

of vector spaces such that

$$
\begin{equation*}
\varphi\left(V_{\lambda}^{s}\right)=V_{\lambda}^{s+n} \tag{A.8}
\end{equation*}
$$

for all $\lambda \in \mathbb{C}$, where

$$
\begin{equation*}
V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda}^{s} \quad \text { and } \quad V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda}^{s+n} \tag{A.9}
\end{equation*}
$$

are the generalized eigenspace decompositions of $V$ with respect to $T_{s}$ and $T_{s}+T_{n}$, respectively.
Proof. Since $T_{s}\left(F_{k} V\right) \subset F_{k} V$ and $\left(T_{s}+T_{n}\right)\left(F_{k} V\right) \subset F_{k} V$ for all $k \in \mathbb{N}_{0}$, as follows immediately from (A.6), we obtain by Lemma A. 1 the generalized eigenspace decompositions

$$
V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda}^{s} \quad \text { and } \quad V=\bigoplus_{\lambda \in \mathbb{C}} V_{\lambda}^{s+n}
$$

of $V$ with respect to $T_{s}$ and $T_{s}+T_{n}$, respectively.
Now, we construct a linear mapping $\varphi: V \rightarrow V$. Since we have the direct sum decomposition

$$
V=\bigoplus_{r \in \mathbb{N}_{0}} \bigoplus_{\lambda \in \mathbb{C}}\left(V_{r} \cap V_{\lambda}^{s}\right)
$$

it is enough to define a linear mapping $\varphi$ on $V_{r} \cap V_{\lambda}^{s}$, which we shall denote by $\varphi_{r, \lambda}$, for all $r \in \mathbb{N}_{0}$, $\lambda \in \mathbb{C}$ and then extend linearly to $V$. To define $\varphi_{r, \lambda}$, let $w \in V_{r}$ be a generalized eigenvector of $T_{s}$ with eigenvalue $\lambda \in \mathbb{C}$. As $w \in F_{r} V$ and $\left(T_{s}+T_{n}\right)\left(F_{r} V\right) \subset F_{r} V$, we get a decomposition

$$
w=\sum_{\mu \in \mathbb{C}} w_{\mu}^{s+n}
$$

were $w_{\mu}^{s+n} \in F_{r} V \cap V_{\mu}^{s+n}$ for all $\mu \in \mathbb{C}$. Applying the projection $p_{r}: V \rightarrow V_{r}$ on the previous equation, we obtain

$$
w=\sum_{\mu \in \mathbb{C}} p_{r}\left(w_{\mu}^{s+n}\right)
$$

since $p_{r}(w)=w$. As $w_{\mu}^{s+n} \in F_{r} V \cap V_{\mu}^{s+n}$, there exists $k \in \mathbb{N}$ such that $\left(T_{s}+T_{n}-\mu\right)^{k} w_{\mu}^{s+n}=0$ and therefore we may write

$$
0=p_{r}\left(\left(T_{s}+T_{n}-\mu\right)^{k} w_{\mu}^{s+n}\right)=p_{r}\left(\left(T_{s}-\mu\right)^{k} w_{\mu}^{s+n}\right)=\left(T_{s}-\lambda\right)^{k} p_{r}\left(w_{\mu}^{s+n}\right),
$$

where we used (A.6), which gives us that $p_{r}\left(w_{\mu}^{s+n}\right)$ is a generalized eigenvector of $T_{s}$ with eigenvalue $\mu$ for all $\mu \in \mathbb{C}$. Hence, the decomposition $w=\sum_{\mu \in \mathbb{C}} p_{r}\left(w_{\mu}^{s+n}\right)$ implies that $p_{r}\left(w_{\mu}^{s+n}\right)=0$ for $\mu \neq \lambda$ and $p_{r}\left(w_{\lambda}^{s+n}\right)=w$. Therefore, we may set

$$
\varphi_{r, \lambda}(w)=w_{\lambda}^{s+n}
$$

for all $w \in V_{r} \cap V_{\lambda}^{s}$. The previous construction ensures that $\varphi_{r, \lambda}: V_{r} \cap V_{\lambda}^{s} \rightarrow F_{r} V \cap V_{\lambda}^{s+n}$ is a linear mapping. Moreover, we have $\varphi\left(V_{\lambda}^{s}\right) \subset V_{\lambda}^{s+n}$ for all $\lambda \in \mathbb{C}$.

Further, since $\varphi\left(F_{r} V\right) \subset F_{r} V$ for all $r \in \mathbb{N}_{0}$, we obtain a linear mapping

$$
\operatorname{gr}_{r} \varphi: F_{r} V / F_{r-1} V \rightarrow F_{r} V / F_{r-1} V
$$

for all $r \in \mathbb{N}_{0}$. As $\operatorname{gr}_{r} \varphi=\operatorname{id}_{F_{r} V / F_{r-1} V}$ by construction, we get that $\varphi: V \rightarrow V$ is an isomorphism of vector spaces.
