# Optimal investment and consumption for pairs trading financial markets on small time interval

#### Abstract

In this paper we consider a pairs trading financial market with the spread of risky assets defined by the Ornstein-Uhlenbeck (OU) process. We implement an optimal strategy for power utility functions for investment/consumption problem. Through the Feynman-Kac (FK) method, we study the Hamilton-Jacobi-Bellman (HJB) equation for this problem. Moreover, the existence and uniqueness has been shown for classical solution for the HJB equation. In addition, the numeric approximation for the solution of the HJB equation has been studied and the convergence rate has been established and it is been found that the convergence rate is extremely explosive.

## 1 Introduction

This paper deals with an optimal investment/consumption problem during a fixed time interval $[0, T]$ for a financial market generated by risky spread assets defined through the Ornstein-Uhlenbeck (OU) processes. Such problems

[^0]are of prime interest for practical investors such as electricity gas markets. Also in other sectors like the microstructioe level within the airline industry (see, for example, [3]) as well it is known in many hedge funds [3]. Usually, for such model, one uses a dynamical programming method (see, for example, [10]. Unfortunately, we can not use the Hamilton-Jacobi-Bellman (HJB) analysis method developed for the Black-Scholes market since for the OU model in the HJB equation there is an additional variable corresponding to the risky asset. Note that in [2] for the pure investment problem, they found the HJB solution in explicit form. Unfortunately, we can not apply this method to the general investment/consumption problem in view of an additional strongly nonlinear term due to the consumption. Moreover, even in the pure investment problem, (see, for example, [2]) the HJB solution is extremely explosive, i.e. it goes to infinity in a squared exponential power $\left(e^{s^{2}}\right)$ rate as the variable corresponding to the risky assets $(s)$ goes to infinity in this financial market. By this reason, we can not use the analytical tool of Black-Scholes model to proof the verification theorem for spread market. In this paper we develop a new method for the probabilistic analysis of the parabolic PDE. Similarly to [1], we study the HJB equation through the Feynman-Kac (FK) representation. To this end we introduce a special metric space in which the FK mapping is contracted. Taking this into account we show the fixed-point theorem for this mapping and we show that the fixed-point solution is the classical solution for the HJB equation in our case. Moreover, by using the verification theorem we find the optimal financial strategies. It turned out that the optimal investment and consumption strategies depend on the solution of a nonlinear parabolic partial differential equation. Therefore, to calculate the optimal strategies one needs to study numerical schemes.

The rest of the paper is organized as follows. In Section 2 we introduce the financial market. In Section 3 we define all necessary parameters. In Section 4 we write the HJB equation. In Section 5 we state the main results of the paper. In Section 6 we study the properties of the FK mapping. In Section 7 we study the properties of the fixed-point function. The proofs of the main results are given in Section 8. The corresponding verification theorem is stated in the Appendix with some auxiliary results.

## 2 Market model

Let $\left(\Omega, \mathcal{F}_{T},\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}, \mathbf{P}\right)$ be a standard filtered probability space with $\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}$ adapted Wiener processes $\left(W_{t}\right)_{0 \leq t \leq T}$. Our financial market consists of one
riskless bond $\left(\check{S}_{t}\right)_{0 \leq t \leq T}$ and risky spread stocks $\left(S_{t}\right)_{0 \leq t \leq T}$ governed by the following equations:

Here the constant $\kappa>0$ is the market mean-reverting parameter from $\mathbb{R}$ and $\sigma>0$ is the market volatility. We assume that the interest rate $r \leq \kappa$. Let now $\check{\alpha}_{t}$ be the number of riskless assets $\check{S}$ and $\alpha_{t}$ be the number of risky assets in the moment $0 \leq t \leq T$, and the consumption rate is given by a non negative integrated function $\left(c_{t}\right)_{0 \leq t \leq T}[10]$. Thus the wealth process is

Using the self financial principle from [10] we get

We define the financial strategy as

where $c_{t} \geq 0$ is the consumption rate and $\alpha_{t}$ is the investment position in the risky asset. So, replacing now in Eq. (2.2) the differentials $\mathrm{d} \breve{S}_{t}$ and $\mathrm{d} S_{t}$ by their definitions in Eq. (2.1) we obtain the differential equation for the wealth process

where $\kappa_{1}=\kappa+r>0$.
Definition 2.1. The financial strategy $v=\left(v_{t}\right)_{0<t<T}$ is called admissible if this process is adapted and the equation Eq. (2.3) has a unique strong nonnegative solution.

We denote by $\mathcal{V}$ the set of all admissible financial strategies. For initial endowment $x>0$, admissible strategy $v$ in $\mathcal{V}$ and the state process $\varsigma_{t}=$ ( $X_{t}^{v}, S_{t}$ ), we introduce for $0<\gamma<1$ the following value function

where $\varpi>0$ is some fixed constant, $\mathbf{E}_{\varsigma, t}$ is the conditional expectation with respect to $\varsigma_{t}=\varsigma=(x, s)$. We set $J(\varsigma, v)=J(\varsigma, 0, v)$.
Our goal is to maximize the value function Eq. (2.4), i.e.

To do this we use the dynamical programming method. Therefore, we need to study the problem Eq. (2.4) for any $0 \leq t \leq T$.

Remark 2.1. The coefficient $0<\varpi<\infty$, explains the investor preference between consumption and pure investment problem. Therefore, we did not consider the case where $\varpi=0$, as in reality the trader is more interested in the terminal wealth than consumption.

## 3 Main Parameters

First we introduce the following ordinary differential equation

Note that $g(t)$ is decreasing, i.e., $\max _{0 \leq t \leq T} g(t)=g(0)$. Taking into account that $r \leq \kappa$, we get $\check{\gamma}_{2}^{2} \geq \check{\gamma}_{3}$. Furthermore, we set

where $q_{1}=g(0) \sigma^{2} / 2+r \gamma+(1-\gamma) \varpi^{\frac{1}{\gamma-1}}$. We denote by $C_{+}^{1,0}(\mathbb{R} \times[0, T])$ the set of all positive functions from $C^{1,0}(\mathbb{R} \times[0, T])$, i.e. the set of all $\mathbb{R} \times[0, T] \rightarrow$ $\mathbb{R}_{+}$continuous partial derivatives with respect to the first variable $s$ and continuous functions in the second variable $t$. Now we introduce the following set

where $g_{1}(t)=\gamma_{1} g(t)-\gamma_{2}$ and $\left(\breve{W}_{u}\right)_{u \geq 0}$ is a standard Brownian motion. It is clear that $\eta_{u}^{s, t} \sim \mathcal{N}\left(s \mu(u, t), \sigma_{1}^{2}(u, t)\right)$, with

Remark 3.1. Note that we use the FK mapping to study the HJB equation which will be defined in the next section.

## 4 Hamilton-Jacobi-Bellman equation

Denoting by $\varsigma_{t}=\left(X_{t}, S_{t}\right)$, we can rewrite equations Eq. (2.1) and Eq. (2.3) as,

In order to find the solution to the value function Eq. (2.5) we need to solve the HJB equation which is given by

As we will see later, that the equation Eq. (4.7) has a solution in $\mathbf{C}^{2,0}(\mathbb{R} \times$ $[0, T]$ ) which can be represented as a fixed point for the FK mapping

Remark 4.1. Note, the main difference in the HJB equation Eq. (4.5) from the one in [2] is the last nonlinear term as we see we can not use the solution method from [2]. One can check that the solution for pure investment problem from [2] can be obtained in Eq. (4.11) as $\varpi \rightarrow \infty$.

## 5 Main results

First we study the HJB equation.
Theorem 5.1. Assume that $0<T<T_{0}$, with $T_{0}$ is given in Eq. (3.11), then equation Eq. (4.3) is the solution defined by Eq. (4.6), where $Y$ is the unique solution of Eq. (4.7) in $\mathcal{X}$ and is the fixed point for the FK mapping, i.e., $Y=\mathcal{L}_{Y}$.

Theorem 5.2. Assume that $0<T<T_{0}$, Then the optimal value of $J(t, \varsigma, v)$ is given by

where the optimal control $v^{*}=\left(\alpha^{*}, c^{*}\right)$ for all $0 \leq t \leq T$ is given in Eq. (4.11) with the function $Y$ defined in Eq. (4.8). The optimal wealth process $\left(X_{t}^{*}\right)_{0 \leq t \leq T}$ is the solution to Eq. (4.10).

Let us now define the approximation sequence $\left(h_{n}\right)_{n \geq 1}$ for $h$ as $h_{0}=0$, and for $n \geq 1$, as

In the following theorems we show that the approximation sequence goes to the fixed function $h$, i.e. $h=\mathcal{L}_{h}$.

Remark 5.1. Note that the convergence rate is super geometrical.
Now we define the approximation. We set

\sup _{\substack{\varsigma \\ 0 \leq t \leq T}}\left(\left|\alpha^{*}(\varsigma, t)-\alpha_{n}^{*}(\varsigma, t)\right|+\left|c^{*}(\varsigma, t)-c_{n}^{*}(\varsigma, t)\right|\right) \leq O\left(n^{-\delta n}\right), \quad \text { as } \quad n \rightarrow \infty .
$$

Remark 5.2. As it is seen from Theorem 5.1 the approximation scheme for the HJB equation implies the approximation for the optimal strategy with super geometrical rate. i.e. more rapid than any geometrical ones.

## 6 Properties of the Feynman-Kac mapping

We need to study the properties of the mapping (3.8).
Proposition 6.1. The space $(\mathcal{X}, \rho)$ is the completed metrical space.
Proposition 6.2. Assume that $T \leq \pi / 16$. Then $\mathcal{L}_{h} \in \mathcal{X}$ for any $h \in \mathcal{X}$, i.e. $\mathcal{L}_{h}: \mathcal{X} \rightarrow \mathcal{X}$.

Proof. The function $\mathcal{L}_{h}(s, t)$ is given in Eq. (3.8) and can be written as

\end{aligned}

with $G(s, t, y)$ is given in Eq. (3.10).
Therefore,

+(1-\gamma) \varpi^{\frac{1}{\gamma-1}}(T-t) \leq \mathbf{B}_{0} \tag{6.1}
\end{array}
$$

where $\mathbf{B}_{0}$ and $\mathbf{B}_{1}$ are given in Eq. (3.3). Then by taking the derivative with respect to $s$, we get

Recall that $f$ and $h$ belong to $\mathcal{X}$, i.e. the difference for the squares of their derivatives can be estimated as $\left|h_{s}^{2}(z, u)-f_{s}^{2}(z, u)\right| \leq 2 \mathbf{B}_{1}\left|h_{s}(z, u)-f_{s}(z, u)\right|$, therefore,

where $\varrho(s, t, z, u)=\partial \varphi(s, t, z, u) / \partial s$ and $\varphi(s, t, z, u)$ is given in Eq. (6.3). Therefore, for $u>t$ and for some constant $\mathbf{c}^{*}>0$

Proof. We want to show that the approximation sequence $\left(h_{n}\right)_{n \geq 1}$ converge to a fixed point $h$, where $h_{0}=0$ and $h_{n}=\mathcal{L}_{h_{n-1}}$ for $n \geq 1$. Using here Proposition 6.3, we obtain that $\rho\left(h_{n}, h_{n+1}\right)=\rho\left(\mathcal{L}_{h_{n-1}}, \mathcal{L}_{h_{n}}\right) \leq \lambda \rho\left(h_{n-1}, h_{n}\right)$. Therefore,

## 7 Properties of the fixed-point function $h$

In this section we study some regularity properties for the function $h$. First we study the smoothness with respect to the variable $s$.

Proposition 7.1. If $h \in \mathcal{X}$ is a fixed point for $\mathcal{L}$ i.e. $h=\mathcal{L}_{h}$, then for any $0<\beta<1$,

If $\delta>1$ then,

\frac{1}{\delta^{\beta}}\left|\frac{\partial}{\partial s} h\left(s_{1}, t\right)-\frac{\partial}{\partial s} h\left(s_{2}, t\right)\right| \leq & \int_{t}^{T}\left(\int_{\mathbb{R}}\left|\varrho\left(s_{1}, t, z, u\right)\right| \mathrm{d} z\right) \mathrm{d} u \\
& +\int_{t}^{T}\left(\int_{\mathbb{R}}\left|\varrho\left(s_{2}, t, z, u\right)\right| \mathrm{d} z\right) \mathrm{d} u<+\infty
\end{aligned}
$$

For $0<\delta=\left|s_{1}-s_{2}\right|<1$, Then,

where from Eq. (6.1), $\int_{t}^{T} \Psi_{h}(z, u) \mathrm{d} u \leq \boldsymbol{B}_{0}$, and $\boldsymbol{B}_{0}$ is given in Eq. (3.3). Let

I(\delta) \leq \frac{\sqrt{2}}{\sqrt{\pi}}+\frac{1}{\delta^{\beta}} \int_{t+\delta_{1}}^{T} \int_{\mathbb{R}}\left|\varrho\left(s_{1}, t, z, u\right)-\varrho\left(s_{2}, t, z, u\right)\right| \mathrm{d} z \mathrm{~d} u .
$$

Then

$$
I(\delta) \leq \frac{\sqrt{2}}{\sqrt{\pi}}+\frac{1}{\delta^{\beta}} \int_{t+\delta_{1}}^{T} \int_{s_{1}}^{s_{2}}\left(\int_{\mathbb{R}}\left|\varrho_{s}(v, t, z, u)\right| \mathrm{d} z\right) \mathrm{d} v \mathrm{~d} u
$$

where

$$
\varrho_{s}=\frac{\partial}{\partial s} \varrho(v, t, z, u)=\frac{\mu^{2}}{\sqrt{2 \pi} \sigma_{1}^{3}} \mathrm{e}^{\frac{-K^{2}}{2}}\left(K^{2}-1\right),
$$

where $K=K(s, z, u)$ is given in Eq. (6.3). Thus

$$
\left|\varrho_{s}\right| \leq \frac{1}{\sqrt{2 \pi} \sigma_{1}^{3}} \mathrm{e}^{\frac{-K^{2}}{2}}\left(K^{2}+1\right)
$$

and

$$
\int_{\mathbb{R}}\left|\varrho_{s}(v, t, z, u)\right| \mathrm{d} z=\frac{1}{\sigma_{1}^{2}} \int_{\mathbb{R}}\left|K^{2}+1\right| \mathrm{e}^{\frac{-K^{2}}{2}} \mathrm{~d} K \leq \frac{\mathbf{c}^{*}}{\sigma_{1}^{2}} .
$$

Taking into account that $\sigma_{1}^{-2} \leq \mathbf{c}^{*}(u-t)^{-1}$ for some $\mathbf{c}^{*}>0$, we get

Now we need to study the smoothness property with respect to $t$. We show now that the function $f$ and its derivatives are Höldarians.

Proposition 7.2. Let $h=\mathcal{L}_{h}$, with $h \in \mathcal{X}$. Therefore, for all $t$, for all $N \geq 1$, and $0<\beta<1 / 2$,

Let now $\delta=t_{2}-t_{1}$ and $\delta_{1}=\delta^{2 \beta}$ for some $0<\beta<1 / 2$. Talking into account that $\Gamma$ is bounded, we obtain that for some $\mathbf{c}^{*}>0$

where $I(\delta)=\int_{t_{2}}^{T} \int_{\mathbb{R}}|\Omega(z, u)| \mathrm{d} z \mathrm{~d} u$ and $\Omega(z, u)=\varphi\left(s, t_{2}, z, u\right)-\varphi\left(s, t_{1}, z, u\right)$.
We reprent this term as $I(\delta)=I_{1}(\delta)+I_{2}(\delta)$, where

I_{1}(\delta)=\int_{t_{2}}^{t_{2}+\delta_{1}} \int_{\mathbb{R}}|\Omega(z, u)| \mathrm{d} z \mathrm{~d} u \quad \text { and } \quad I_{2}(\delta)=\int_{t_{2}+\delta_{1}}^{T} \int_{\mathbb{R}}|\Omega(z, u)| \mathrm{d} z \mathrm{~d} u

It is clear that $I_{1}(\delta) \leq 2 \delta_{1}$. To estimate the term $I_{2}(\delta)$ note that

\varphi_{t}(s, \theta, z, u)=\frac{\partial}{\partial t} \varphi(s, t, z, u)=\left(\frac{\sigma_{2}(u, t)}{2 \sqrt{2 \pi} \sigma_{1}^{3}(u, t)}-\frac{K K^{\prime}}{\sqrt{2 \pi} \sigma_{1}}\right) \mathrm{e}^{-\frac{K^{2}}{2}}
$$

the prime ' is the derivative with respect to $t$ and $\sigma_{2}=\left(\sigma_{1}\right)^{\prime}$. Denoting by $\mu_{1}=\mu^{\prime}$ we obtain that

K^{\prime}=\left(\frac{z-s \mu}{\sigma_{1}}\right)^{\prime}=\frac{s \mu_{1}}{\sigma_{1}}-\frac{z-s \mu}{\sigma_{1}^{2}}\left(\sigma_{1}\right)^{\prime}=-\frac{s \mu_{1}}{\sigma_{1}}-\frac{1}{2} K \frac{\sigma_{2}}{2 \sigma_{1}^{2}}
$$

Taking into account that, $\mu_{1}$ is bounded, we obtain that for some $\mathbf{c}^{*}>0$

\left|\frac{\partial}{\partial t} \varphi(s, t, z, u)\right| \leq \mathbf{c}^{*}(1+|s|) \mathrm{e}^{-\frac{K^{2}}{2}} \frac{\left(K^{2}+|K|+1\right)}{\sigma_{1}^{3}} .
$$

Therefore, for some $\mathbf{c}^{*}>0$ and $u>t$

\int_{\mathbb{R}}\left|\frac{\partial}{\partial t} \varphi(s, t, z, u)\right| \mathrm{d} z \leq \frac{\mathbf{c}^{*}(1+|s|)}{u-t}

and we get

\left|I_{2}(\delta)\right| & \leq \mathbf{c}^{*}(1+|s|) \int_{t_{1}}^{t_{2}}\left(\int_{t_{2}+\delta_{1}}^{T} \frac{1}{u-\theta} \mathrm{d} u\right) \mathrm{d} \theta \\
& \leq \mathbf{c}^{*}(1+|s|) \delta \int_{t_{2}+\delta_{1}}^{T} \frac{\mathrm{~d} u}{u-t_{2}} \leq \mathbf{c}^{*}(1+|s|) \delta\left|\ln \delta_{1}\right|
\end{aligned}
$$

Therefore, for some $\mathbf{c}^{*}>0$

\limsup _{\delta \rightarrow 0} \frac{1}{\delta^{\beta}}\left|h\left(s, t_{2}\right)-h\left(s, t_{1}\right)\right| \leq \mathbf{c}^{*}(1+|s|) .

Now to prove the second part we firstly take the partial derivative of the function $h$ which may represented by

\frac{\partial}{\partial s} h(s, t) & =\int_{t}^{T} \frac{\mu(u, t)}{\sigma_{1}(u, t)}\left(\int_{\mathbb{R}} \Psi_{h}\left(s \mu+\sigma_{1} K, u\right) K \frac{\mathrm{e}^{-\frac{K^{2}}{2}}}{\sqrt{2 \pi}} \mathrm{~d} K\right) \mathrm{d} u \\
& =\int_{t}^{T} \frac{\mu(u, t)}{\sigma_{1}(u, t)}\left(\mathbf{E} \Psi_{h}\left(s \mu(u, t)+\sigma_{1}(u, t) \xi, u\right) \xi\right) \mathrm{d} u
\end{aligned}
$$

where $\xi \sim \mathcal{N}(0,1)$. So, we can represent the derivative Eq. (7.2) as

Now we recall, that the function $\Psi_{h}$ is bounded, i.e. $|\mathbf{q}(t, u)| \leq \mathbf{c}^{*} / \sqrt{u-t}$ for some $\mathbf{c}^{*}>0$. Therefore,

& \leq I_{1}^{*}(\delta)+I_{2}^{*}(\delta)+2 \mathbf{c}^{*} \sqrt{\delta}
\end{aligned}
$$

where

I_{1}^{*}(\delta)=\int_{t_{2}}^{t_{2}+\delta_{1}}\left|\mathbf{q}_{3}(u)\right| \mathrm{d} u \quad \text { and } \quad I_{2}^{*}(\delta)=\int_{t_{2}+\delta_{1}}^{T}\left|\mathbf{q}_{3}(u)\right| \mathrm{d} u
$$

Similarly, for $0<t_{1}<t_{2}$

I_{1}^{*}(\delta) \leq \mathbf{c}^{*} \int_{t_{2}}^{t_{2}+\delta_{1}}\left(\frac{1}{\sqrt{u-t_{2}}}+\frac{1}{\sqrt{u-t_{1}}}\right) \mathrm{d} u \quad \leq 4 \mathbf{c}^{*} \sqrt{\delta_{1}}
$$

To estimate $I_{2}^{*}(\delta)$, note that

\left|\mathbf{q}_{3}(u)\right| & =\left|\mathbf{q}_{1}\left(u, t_{2}\right) \mathbf{q}_{2}\left(u, t_{2}\right)-\mathbf{q}_{1}\left(u, t_{1}\right) \mathbf{q}_{2}\left(u, t_{1}\right)\right| \\
& \leq\left|\mathbf{q}_{2}\left(u, t_{2}\right)\left(\mathbf{q}_{1}\left(u, t_{2}\right)-\mathbf{q}_{1}\left(u, t_{1}\right)\right)\right|+\left|\mathbf{q}_{1}\left(u, t_{1}\right)\left(\mathbf{q}_{2}\left(u, t_{2}\right)-\mathbf{q}_{2}\left(u, t_{1}\right)\right)\right| .
\end{aligned}
$$

Moreover, noting that

\mathbf{q}_{2}(u, t)=\frac{\mu(u, t)}{\sigma_{1}(u, t)} \leq \frac{1}{\sigma_{1}(u, t)} \leq \frac{\mathbf{c}^{*}}{\sqrt{u-t}},

From the definition of $q_{1}$, we can obtain that for some $\mathbf{c}^{*}>0$

\left|\mathbf{q}_{2}\left(u, t_{2}\right)-\mathbf{q}_{2}\left(u, t_{1}\right)\right| \leq \int_{t_{1}}^{t_{2}} \frac{1}{(u-\theta)^{\frac{3}{2}}} \mathrm{~d} \theta \leq \frac{\delta}{\left(u-t_{2}\right)^{\frac{3}{2}}}
$$

and

$$
\left|\mathbf{q}_{3}(u)\right| \leq \frac{\delta}{\left(u-t_{2}\right)^{\frac{3}{2}}}+\frac{\mathbf{c}^{*}}{\sqrt{u-t_{1}}}\left|\mathbf{q}_{1}\left(u, t_{2}\right)-\mathbf{q}_{1}\left(u, t_{1}\right)\right| .
$$

It should be noted that Proposition 7.1 implies that for any $0<\beta<1$ and for some $\mathbf{c}^{*}>0$,

\left|\Psi_{h}\left(s_{2}, t\right)-\Psi_{h}\left(s_{1}, t\right)\right| \leq \mathbf{c}^{*}\left|s_{2}-s_{1}\right|^{\beta} . \tag{7.3}

We recall that $\left|\sigma_{1}\left(u, t_{2}\right)-\sigma_{1}\left(u, t_{1}\right)\right| \leq \delta / \sqrt{u-t_{2}}$. Therefore,

& \leq\left(\frac{\delta}{\sqrt{\delta_{1}}}+\delta^{\beta}\left(\delta_{1}\right)^{\frac{1-\beta}{2}}\right)\left(1+|s|^{\beta}\right) .
\end{aligned}
$$

Therefore, for any $0<\beta<1 / 2$

\varlimsup_{\lim _{\delta \rightarrow 0}} \frac{I_{1}^{*}(\delta)+I_{2}^{*}(\delta)}{\delta^{\beta}}<+\infty
$$

Hence, Proposition 7.2.

## 8 Proofs

### 8.1 Proof of Theorem 5.1

Let $h \in \mathcal{X}$ be the fixed point for the mapping $\mathcal{L}$, i.e. $h=\mathcal{L}_{h}$. Consider now the following equation

where $g_{1}(t)=\gamma_{1} g(t)-\gamma_{2}>0$ and $\Psi_{h}(s, t)$ is given in Eq. (3.8). Then we change the variables as $u(s, t)=Y(s, T-t)$, so we get

u_{t}(s, t)-\frac{\sigma^{2} u_{s s}(s, t)}{2}-s g_{1}(t) u_{s}(s, t)-\Psi_{h}(s, t)=0, \quad u(s, 0)=0 \tag{8.2}

We can rewrite the previous equation as

where $a(s, t, u, p)=-s g_{1}(t) p-\Psi_{h}(s, t)$. Taking into account that

In view of Propositions 7.1 and 7.2 , the function $\Psi_{h}$ satisfies the Hölder condition $C_{5}$ ) for any $0<$ $\beta<1 / 2$. By using Theorem A. 2 we obtain that Eq. (8.2) has a bounded solution. Therefore, there exists a solution of Eq. (8.1). In order to prove this proposition we use the probabilistic representation. Now, we define a stopping time $\tau_{n}$

& -\int_{t}^{\tau_{n}} Y_{s}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} \check{W}_{u}+Y\left(\eta_{\tau_{n}}^{s, t}, \tau_{n}\right)
\end{aligned}
$$

taking into account the equation Eq. (4.7) we obtain that

$$
Y(s, t)=\int_{t}^{\tau_{n}} \Psi_{h}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u-\int_{t}^{\tau_{n}} Y_{s}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} \check{W}_{u}+Y\left(\tau_{n}, \eta_{\tau_{n}, t}^{s, t}\right) .
$$

Taking into account that $\mathbf{E} \int_{t}^{\tau_{n}} Y_{s}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} \check{W}_{u}=0$, we obtain

$$
Y(s, t)=\mathbf{E} \int_{t}^{\tau_{n}} \Psi_{h}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u+\mathbf{E} Y\left(\tau_{n}, \eta_{\tau_{n}}^{s, t}\right)
$$

Note here that the solution of the equation Eq. (8.1) is bounded. So, by Dominated Convergence theorem and in view of the boundary condition in Eq. (8.1) we obtain that

$$
\lim _{n \rightarrow \infty} \mathbf{E} Y\left(\eta_{\tau_{n}}^{s, t}, \tau_{n}\right)=\mathbf{E} \lim _{n \rightarrow \infty} Y\left(\eta_{\tau_{n}}^{s, t}, \tau_{n}\right)=\mathbf{E} Y\left(\eta_{T}^{s, t}, T\right)=0
$$

Moreover, taking into account that $\Psi_{h} \geq 0$, by the Monotone Convergence theorem we obtain

Y(s, t)=\mathbf{E} \lim _{n \rightarrow \infty} \int_{t}^{\tau_{n}} \Psi_{h}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u=\mathbf{E} \int_{t}^{T} \Psi_{h}\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u,
$$

i.e. $Y(s, t)=\mathcal{L}_{h}(s, t)=h$. Hence Theorem 5.1.

### 8.2 Proof of Theorem 5.2

To proof this theorem we use the verification theorem (A.1) and find the solution to the HJB equation using FK mapping with $h$ a fixed point for the mapping $\mathcal{L}$. Therefore, the function

is the solution of the HJB equation Eq. (4.5). By using this function we calculate the optimal control variables in Eq. (4.9) and we obtain the strategies Eq. (4.10) - Eq. (4.11). Hence $\mathbf{H}_{3}$ ). Now we want to check condition $\mathbf{H}_{4}$ ). First note that the equation

is identical to the equation (4.1). By the assumptions on the market parameters, all the coefficients of (4.1) are continuous and bounded. so the usual integrability and Lipschitz conditions are satisfied, this implies $\mathbf{H}_{4}$ ).

Lemma 8.1. There exists some $\check{\delta}>1$ such that for any $0 \leq t<T<T_{0}$,

Lemma 8.1 yields condition $\mathbf{H}_{5}$ ), where $z(\varsigma, t)=\varpi x^{\gamma} \exp \left\{s^{2} g(t) / 2+Y(s, t)\right\}$. Now, the Verification Theorem A. 1 implies Theorem 5.2.

where $\mathbf{B}_{0}$ and $\mathbf{B}_{1}$ are defined in Eq. (3.3) and $H(\lambda)=\tilde{\mathbf{B}}_{2} T / \lambda^{2}+n \ln n-$ $\ln (1-\lambda)$.
If we take $\lambda=1 / \sqrt{n}$ and $\varkappa=n\left(\tilde{\mathbf{B}}_{2}\right)^{2}$ then we obtain

$V_{2}$ ) for every deterministic vector $v \in \Theta$ the stochastic differential equation

Here $z_{t}$ denote the partial derivatives of $z$ with respect to $t, z_{\varsigma}(\varsigma, t)$ the gradient vector with respect to $\varsigma$ in $\mathbb{R}^{N}$ and $z_{\varsigma \varsigma}(x, t)$ denotes the symmetric hessian matrix, that is the matrix of the second order partial derivatives with respect to $\varsigma$.
We assume the following conditions hold:

Theorem A. 2 ( See Theorem 8.1, p. 495 of [13] ). Assume that the conditions $\left.\mathbf{C}_{1}\right)-\mathbf{C}_{5}$ ) hold. Then there exists at least one solution $u(x, t)$ of Cauchy problem (A.4) that is bounded in $R^{N} \times[0, T]$ which belongs to $\mathcal{H}^{2+\beta, 1+\beta / 2}\left(\Gamma_{N}\right)$ for any $N \geq 1$.

& \leq \frac{\mu(u, t)}{\sqrt{2 \pi} \sigma_{1}(u, t)} \int_{|y|>N_{1}}|y| \mathrm{e}^{-\frac{y^{2}}{2}} \mathrm{~d} y \rightarrow 0 \quad \text { as } \quad N \rightarrow \infty .

\int_{t}^{T}\left|a^{*}(u)\right| \mathrm{d} u \leq 2 \kappa_{2} \int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u+\mathbf{c}^{*}
$$

Let us show now that

$$
\mathbf{E} \exp \left\{\tilde{\kappa}_{2} \int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right\}<+\infty
$$

where $\tilde{\kappa}_{2}=2 \delta_{2} \kappa_{2} /\left(1-\delta_{2}\right)=\left(2(3+\gamma) \kappa_{1}^{2}\left(1 / \sigma^{2}+1 / 2+g(0) / \kappa_{1}\right)\right) /(1-\gamma)$.

$$
\mathbf{E} \exp \left\{\tilde{\kappa}_{2}\left(\int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right)\right\}=\sum_{m=0}^{\infty} \frac{\tilde{\kappa}_{2}^{m}}{m!} \mathbf{E}\left(\int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right)^{m}<+\infty
$$

Moreover, note that in view of the Hölder inequality

$$
\mathbf{E}\left(\int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right)^{m} \leq(T-t)^{m-1} \int_{t}^{T} \mathbf{E} \xi_{t, u}^{2 m} \mathrm{~d} u
$$

Taking into account that $\xi_{t, u} \sim \mathcal{N}\left(0, \int_{t}^{u} \mathrm{e}^{-2 \varkappa(u-v)} \mathrm{d} v\right)$, we obtain that

$$
\mathbf{E} \xi_{t, u}^{2 m}=(2 m-1)!!\left(\int_{t}^{u} \mathrm{e}^{-2 \varkappa(u-v)} \mathrm{d} v\right)^{m} \leq \frac{m!}{\kappa^{m}}
$$

and

$$
\mathbf{E}\left(\int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right)^{m} \leq m!\frac{T^{m}}{\kappa^{m}}
$$

Therefore,

$$
\mathbf{E} \exp \left\{\check{\kappa}_{2} \int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right\}=\sum_{m=0}^{\infty} \frac{\check{\kappa}_{2}^{m}}{m!} \mathbf{E}\left(\int_{t}^{T} \xi_{t, u}^{2} \mathrm{~d} u\right)^{m} \leq \sum_{m=0}^{\infty}\left(\frac{\check{\kappa}_{2}}{\kappa} T\right)^{m} .
$$

In view of the definition of $T_{0}$ in Eq. (3.11) we obtain that the condition $T<T_{0}$ implies that $T<\kappa / \check{\kappa}_{2}$, i.e. this series is finite. Moreover, by Proposition A. 4 , we have that $\mathbf{E} \xi_{t, \tau} \leq m!\left(2 \sigma^{2} T\right)^{m}$ for all $m \geq 1$, and for any $\tau \in \mathcal{M}_{t}$, So

$$
\begin{aligned}
\mathbf{E}_{\varsigma, t} \exp \left\{q \check{\delta}_{1} \xi_{t, \tau}^{2}\right\} & =1+\sum_{m=1}^{\infty} \frac{\left(q \check{\delta}_{1}\right)^{m}}{m!} \mathbf{E} \xi_{t, \tau}^{m} \\
& \leq 1+\sum_{m=1}^{\infty} \frac{\left(q \check{\delta}_{1}\right)^{m}}{m!} m!\left(2 \sigma^{2} T\right)^{m} \leq 1+\sum_{m=1}^{\infty}\left(2 q \check{\delta}_{1} \sigma^{2} T\right)^{m}<+\infty
\end{aligned}
$$

for $T<1 / 2 q \sigma^{2} \check{\delta}_{1}=\gamma(1-\gamma) /(3+\gamma)(1+\gamma) \sigma^{2} g(0)$, which is true due to the condition $T<T_{0}$. Hence Lemma 8.1.

## A. 6 The smoothness properties for the function $\mathrm{E} Q\left(\eta_{u}^{s, t}, u\right)$

Lemma A.3. For any bounded function $Q$ in $\mathcal{X}$ and for $u>t$

$$
\left|\frac{\partial}{\partial s} \int_{t}^{T} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u\right| \leq Q_{t}^{*} \frac{2}{\sigma} \sqrt{\frac{2(T-t)}{\pi}}
$$

where

$$
Q_{t}^{*}=\sup _{\substack{s \in \mathbb{R} \\ t \leq u \leq T}}|Q(s, u)| .
$$

Proof. By Fubini theorem if a function $Q>0$ then

$$
\frac{\partial}{\partial s} \mathbf{E} \int_{t}^{T} Q\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u=\frac{\partial}{\partial s} \int_{t}^{T} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u
$$

As

$$
\mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)=\frac{1}{\sigma_{1}(u, t)} \int_{\mathbb{R}} Q(y, u) \varphi\left(\frac{y-s \mu(u, t)}{\sigma_{1}(u, t)}\right) \mathrm{d} y
$$

where

$$
\varphi(\theta)=\frac{1}{\sqrt{2 \pi}} \mathrm{e}^{-\frac{\theta^{2}}{2}} \quad \text { and } \quad \theta=\frac{z-x \mu(u, t)}{\sigma_{1}(u, t)}
$$

Then we have that,

$$
\mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)=\frac{1}{\sqrt{2 \pi} \sigma_{1}(u, t)} \int_{\mathbb{R}} Q(y, u) \exp \left\{-\frac{(y-s \mu(u, t))^{2}}{2 \sigma_{1}^{2}(u, t)}\right\} \mathrm{d} y
$$

Thus by deriving the last expression with respect to $s$,
$\frac{\partial}{\partial s} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)=\frac{\mu(u, t)}{\sqrt{2 \pi} \sigma_{1}^{3}(u, t)} \int_{\mathbb{R}} Q(y, u)(y-s \mu(u, t)) \exp \left\{-\frac{(y-s \mu(u, t))^{2}}{2 \sigma_{1}^{2}(u, t)}\right\} \mathrm{d} y$.
Then by letting

$$
\begin{gathered}
v=\frac{y-s \mu(u, t)}{\sigma_{1}(u, t)} \\
\frac{\partial}{\partial s} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)=\frac{\mu(u, t)}{\sqrt{2 \pi} \sigma_{1}(u, t)} \int_{\mathbb{R}} Q\left(s \mu(u, t)+v \sigma_{1}(u, t), u\right) v \mathrm{e}^{-v^{2} / 2} \mathrm{~d} v
\end{gathered}
$$

By taking the absolute value for both sides we get

$$
\begin{aligned}
\left|\frac{\partial}{\partial s} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)\right| & \leq \frac{\mu(u, t)}{\sqrt{2 \pi} \sigma_{1}(u, t)} \int_{\mathbb{R}}\left|Q\left(s \mu(u, t)+v \sigma_{1}(u, t), u\right) \| v\right| \mathrm{e}^{-v^{2} / 2} \mathrm{~d} v \\
& \leq Q_{t}^{*} \frac{\mu(u, t)}{\sqrt{2 \pi} \sigma_{1}(u, t)} \int_{\mathbb{R}}|v| \mathrm{e}^{-v^{2} / 2} \mathrm{~d} v \\
& =Q_{t}^{*} \sqrt{\frac{2}{\pi}} \frac{\mu(u, t)}{\sigma(u, t)\left(\int_{t}^{u} \mu^{2}(u, z) \mathrm{d} z\right)^{1 / 2}}
\end{aligned}
$$

where $Q_{t}^{*}=\sup _{y \in \mathbb{R}, u \geq t}|Q(y, u)|$. Therefore,

$$
\left|\frac{\partial}{\partial s} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)\right| \leq Q_{t}^{*} \sqrt{\frac{2}{\pi}} \frac{\mu(u, t)}{\sigma_{1}(u, t)}
$$

Since the integral

$$
\begin{aligned}
\int_{t}^{T} \frac{\mu(u, t)}{\sigma_{1}(u, t)} \mathrm{d} u & =\int_{t}^{T} \frac{\mathrm{e}^{-\int_{t}^{u} g_{1}(v) \mathrm{d} v}}{\sigma \sqrt{\int_{t}^{u} \mathrm{e}^{-2 \int_{z}^{u} g_{1}(v) \mathrm{d} v} \mathrm{~d} z}} \mathrm{~d} u \\
& \leq \int_{t}^{T} \frac{1}{\sigma \sqrt{u-t}} \mathrm{~d} u=\frac{2}{\sigma} \sqrt{T-t}
\end{aligned}
$$

Therefore,

$$
\begin{equation*}
\left|\frac{\partial}{\partial s} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right)\right| \leq Q_{t}^{*} \sqrt{\frac{2}{\pi}} \frac{1}{\sigma \sqrt{u-t}} . \tag{A.10}
\end{equation*}
$$

Therefore by taking the integral from $t$ to $T$,

$$
\begin{equation*}
\left|\frac{\partial}{\partial s} \int_{t}^{T} \mathbf{E} Q\left(\eta_{u}^{s, t}, u\right) \mathrm{d} u\right| \leq Q_{t}^{*} \sqrt{\frac{2}{\pi}} \int_{t}^{T} \frac{1}{\sigma \sqrt{u-t}} \mathrm{~d} u \leq Q_{t}^{*} \frac{2}{\sigma} \sqrt{\frac{2(T-t)}{\pi}} \tag{A.11}
\end{equation*}
$$

Hence Lemma A.3.
We need the following Proposition from [7].
Proposition A.4. Let $y$ be the solution to the following equation

$$
\begin{equation*}
\mathrm{d} y_{t}=f\left(y_{t}, t\right) \mathrm{d} t+G_{t} \mathrm{~d} W_{t}, \quad y_{0}=0 \tag{A.12}
\end{equation*}
$$

where $y f(y, t) \leq-\kappa y^{2}$ for all $y$ and for $\kappa>0$, and

$$
\sup _{0 \leq t \leq T}\left|G_{t}\right| \leq M, \quad \text { for all } \quad M>0 .
$$

Then for any stopping time $0 \leq \tau \leq T$

$$
\mathbf{E}\left|y_{\tau}\right|^{2 m} \leq m!\left(2 M^{2} T\right)^{m} .
$$
