# Prior Distributions for the Bradley-Terry Model of Paired Comparisons

#### Abstract

The Bradley-Terry model assigns probabilities for the outcome of paired comparison experiments based on strength parameters associated with the objects being compared. We consider different proposed choices of prior parameter distributions for Bayesian inference of the strength parameters based on the paired comparison results. We evaluate them according to four desiderata motivated by the use of inferred Bradley-Terry parameters to rate teams on the basis of outcomes of a set of games: invariance under interchange of teams, invariance under interchange of winning and losing, normalizability and invariance under elimination of teams. We consider various proposals which fail to satisfy one or more of these desiderata, and illustrate two proposals which satisfy them. Both are one-parameter independent distributions for the logarithms of the team strengths: 1) Gaussian and 2) Type III generalized logistic.

## 1. Background

### 1.1. Paired Comparison Experiments and the Bradley-Terry Model

A paired comparison experiment is a set of binary comparisons between pairs out of a set of $t$ objects. The Bradley-Terry model (Zermelo, 1929; Bradley and Terry, 1952) assigns to each object $i(i=1, \ldots t)$ a strength parameter $\pi_{i}$, and defines

$$
\begin{equation*}
\theta_{i j}=\frac{\pi_{i}}{\pi_{i}+\pi_{j}} \tag{1.1}
\end{equation*}
$$

as the probability that object $i$ will be preferred in any given comparison with object $j$. Note that $\theta_{j i}=1-\theta_{i j}$. If $n_{i j}$ the number of comparisons between $i$ and $j$, the probability of any particular set of outcomes $D$ which includes object
$i$ being chosen over $j w_{i j}$ times is

$$
\begin{equation*}
p\left(D \mid\left\{\theta_{i j}\right\}\right)=p\left(D \mid\left\{\pi_{i}\right\}\right)=\prod_{i=1}^{t} \prod_{j=i+1}^{t} \theta_{i j}^{w_{i j}}\left(1-\theta_{i j}\right)^{n_{i j}-w_{i j}} \tag{1.2}
\end{equation*}
$$

The model has been used in a number of contexts, ranging from taste tests between different foods to games between chess players. In the context of the present paper, we are interested in sporting competitions, so we will henceforth refer to the objects as "teams" and the comparisons as "games". $w_{i j}$ is thus the number of games won by team $i$ against team $j$, and $n_{i j}=w_{i j}+w_{j i}$ is the number of games between them.

### 1.2. Bayesian Approach

A typical problem is to make inferences about the strengths $\left\{\pi_{i}\right\}$, or equivalently the log-strengths $\left\{\lambda_{i}\right\}$, given the results $D$. Under a Bayesian approach, in terms of the vector $\boldsymbol{\pi}$ of team strengths $\left\{\pi_{i} \mid i=1, \ldots, t\right\}$, the posterior probability distribution will be, up to a $\boldsymbol{\pi}$-independent normalization constant,

$$
\begin{equation*}
f_{\boldsymbol{\Pi} \mid D}(\boldsymbol{\pi} \mid D, I) \propto p\left(D \mid\left\{\pi_{i}\right\}\right) f_{\boldsymbol{\Pi}}(\boldsymbol{\pi} \mid I) \tag{1.3}
\end{equation*}
$$

We are concerned with choices of the prior distribution $f_{\boldsymbol{\Pi}}(\boldsymbol{\pi} \mid I)$, with a given choice represented symbolically by $I$.

It is useful to define $\lambda_{i}=\ln \pi_{i}$ and note that

$$
\begin{equation*}
\ln \frac{\theta_{i j}}{1-\theta_{i j}}=\lambda_{i}-\lambda_{j}=: \gamma_{i j} \tag{1.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\theta_{i j}=\left(1+e^{-\gamma_{i j}}\right)^{-1}, \quad\left(1-\theta_{i j}\right)=\left(1+e^{\gamma_{i j}}\right)^{-1} \tag{1.5}
\end{equation*}
$$

Since the parameters are continuous, the probability density functions transform as follows:

$$
\begin{align*}
f_{\Lambda_{i}}\left(\lambda_{i}\right) & =e^{\lambda_{i}} f_{\Pi_{i}}\left(e^{\lambda_{i}}\right)  \tag{1.6}\\
f_{\Pi_{i}}\left(\pi_{i}\right) & =\frac{1}{\pi_{i}} f_{\Lambda_{i}}\left(\ln \pi_{i}\right) \tag{1.7}
\end{align*}
$$

and likewise

$$
\begin{gather*}
f_{\Gamma_{i j}}\left(\gamma_{i j}\right)=\left(1+e^{-\gamma_{i j}}\right)^{-1}\left(1+e^{\gamma_{i j}}\right)^{-1} f_{\Theta_{i j}}\left(\left[1+e^{-\gamma_{i j}}\right]^{-1}\right)  \tag{1.8}\\
f_{\Theta_{i j}}\left(\theta_{i j}\right)=\theta_{i j}^{-1}\left(1-\theta_{i j}\right)^{-1} f_{\Gamma_{i j}}\left(-\ln \left[\theta_{i j}^{-1}-1\right]\right) \tag{1.9}
\end{gather*}
$$

Note that the $t$ strengths $\left\{\pi_{i}\right\}$ are only relevant in their use to determine the probabilities $\left\{\theta_{i j}\right\}$ (of which $t-1$ are independent), so we consider two probability distributions $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$ and $f_{\Pi}\left(\boldsymbol{\pi} \mid I_{2}\right)$ equivalent if they produce the same marginalized distribution for the $\left\{\theta_{i j}\right\}$.

Definition 1.1. Let $\gamma$ represent a $t$-1-dimensional vector of linearly independent combinations of the log-odds-ratios $\left\{\gamma_{i j}\right\}$ from which all $t(t-1)$ can be constructed according to

$$
\begin{equation*}
\gamma_{i j}=\sum_{\alpha=1}^{t-1} C_{i j, \alpha} \gamma_{\alpha} \tag{1.10}
\end{equation*}
$$

Possible choices are

$$
\begin{equation*}
\gamma_{12}, \gamma_{23}, \ldots, \gamma_{(t-1), t} \tag{1.11}
\end{equation*}
$$

or

$$
\begin{equation*}
\gamma_{1 t}, \gamma_{2 t}, \ldots, \gamma_{(t-1), t} \tag{1.12}
\end{equation*}
$$

or

$$
\begin{equation*}
\frac{1}{\sqrt{2}} \gamma_{12}, \frac{1}{\sqrt{6}}\left(\gamma_{13}+\gamma_{23}\right), \ldots, \frac{1}{\sqrt{t(t-1)}}\left[\gamma_{12}+\gamma_{23}+\ldots-(t-1) \gamma_{(t-1), t}\right] \tag{1.13}
\end{equation*}
$$

The advantage of working with the $\left\{\gamma_{i j}\right\}$ is that we need not specify which basis we are using for $\gamma$ because the Jacobian determinants for transformations between different bases are constant.

Definition 1.2. Two probability distributions are equivalent, $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right) \cong f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{2}\right)$ (or $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{1}\right) \cong f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{2}\right)$ ) if and only if $f_{\boldsymbol{\Gamma}}\left(\gamma \mid I_{1}\right)=f_{\boldsymbol{\Gamma}}\left(\gamma \mid I_{2}\right)$.
Lemma 1.1. A sufficient condition for $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right) \cong f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{2}\right)$ is that there exists a scalar function $C(\boldsymbol{\pi})$ such that the transformation

$$
\begin{equation*}
\boldsymbol{\pi}^{\prime}=\boldsymbol{\pi} C(\boldsymbol{\pi}) \tag{1.14}
\end{equation*}
$$

converts the probability density $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$ into $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{2}\right)$, i.e.,

$$
\begin{equation*}
f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{1}\right)=\frac{f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)}{\operatorname{det}\left\{\frac{\partial \pi_{i}^{\prime}}{\partial \pi_{j}}\right\}}=f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi}^{\prime} \mid I_{2}\right) \tag{1.15}
\end{equation*}
$$

Proof. The transformation leaves $\theta_{i j}$ unchanged

$$
\begin{equation*}
\theta_{i j}^{\prime}=\frac{\pi_{i}^{\prime}}{\pi_{i}^{\prime}+\pi_{j}^{\prime}}=\frac{\pi_{i} C(\boldsymbol{\pi})}{\pi_{i} C(\boldsymbol{\pi})+\pi_{j} C(\boldsymbol{\pi})}=\frac{\pi_{i}}{\pi_{i}+\pi_{j}}=\theta_{i j} \tag{1.16}
\end{equation*}
$$

and therefore $\gamma_{i j}^{\prime}=\gamma_{i j}$ and the transformation $\gamma \rightarrow \gamma^{\prime}$ leaves $f_{\Gamma}(\gamma \mid I)$ unchanged, and

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{2}\right)=f_{\Gamma}\left(\gamma^{\prime} \mid I_{2}\right)=f_{\Gamma^{\prime}}\left(\gamma^{\prime} \mid I_{1}\right)=f_{\Gamma}\left(\gamma \mid I_{1}\right) \tag{1.17}
\end{equation*}
$$

### 1.3. Motivation and Desiderata

The primary interest motivating this work is design of rating systems to evaluate teams based on the outcome of games between them. To that end, prior information which distinguishes between the teams is inappropriate, as it would be considered "unfair" to build such information into the rating system. We are interested in rating systems which obey as many as possibly of the following desiderata.

Desideratum 1.1. Invariance under interchange of teams. A transformation $\boldsymbol{\pi} \rightarrow \boldsymbol{\pi}^{\prime}$ which, for some $i$ and $j$, obeys $\pi_{i}^{\prime}=\pi_{j}, \pi_{j}^{\prime}=\pi_{i}, \pi_{k}^{\prime}=\pi_{k}$ for all other $k$, should transform $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$ into an equivalent distribution $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{2}\right) \cong f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$.

Desideratum 1.2. Invariance under interchange of winning and losing. The transformation $\forall i: \pi_{i} \rightarrow \pi_{i}^{\prime}=\frac{1}{\pi_{i}}$, which corresponds to $\boldsymbol{\lambda}^{\prime}=-\boldsymbol{\lambda}, \forall i, j$ : $\theta_{i j}^{\prime}=1-\theta_{i j}$, and $\gamma^{\prime}=-\gamma$, should transform $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$ into an equivalent distribution $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{2}\right) \cong f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{1}\right)$. A distribution obeying this desideratum will satisfy $f_{\Gamma}\left(\gamma \mid I_{1}\right)=f_{\Gamma}\left(-\gamma \mid I_{1}\right)$.
Desideratum 1.3. Normalizability. $f_{\Gamma}(\gamma \mid I)$ should be a proper prior, which can be normalized to $\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma f_{\Gamma}(\gamma \mid I)=1$.
Desideratum 1.4. Invariant under elimination of teams. This desideratum assumes that a given principle can be used to generate prior distributions for any number of teams. Let $t>2$, and define $\boldsymbol{\pi}$ to be the vector of $t$ strengths, and $\boldsymbol{\pi}^{\prime}$ to be the $(t-1)$-element vector with $\pi_{i}^{\prime}=\pi_{i}$ for $i=0, \ldots, t-1$. Suppose the principle generates priors $f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{t-1}\right)$ when there are $t-1$ teams and $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{t}\right)=f_{\Pi^{\prime}, \Pi_{t}}\left(\boldsymbol{\pi}^{\prime}, \pi_{t} \mid I_{t}\right)$ when there are $t$. The prior associated with $I_{t-1}$ should be equivalent to that associated with $I_{t}$, marginalized over $\pi_{t}$, i.e.

$$
\begin{equation*}
f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{t-1}\right) \cong \int_{0}^{\infty} d \pi_{t} f_{\boldsymbol{\Pi}^{\prime}, \Pi_{t}}\left(\boldsymbol{\pi}^{\prime}, \pi_{t} \mid I_{t}\right)=\int_{0}^{\infty} d \pi_{t} f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{t}\right) \tag{1.18}
\end{equation*}
$$

### 1.4. Comparison via Prior Predictive Distribution

A convenient way to quantify the effects of a prior, and thus to compare different priors, is to construct the prior predictive distribution
$p(D \mid \mathbf{n}, I)=\int_{0}^{\infty} \cdots \int_{0}^{\infty} d^{t} \pi p(D \mid \boldsymbol{\pi}, \mathbf{n}) f_{\boldsymbol{\Pi}}(\boldsymbol{\pi} \mid I)=\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma p(D \mid \boldsymbol{\gamma}, \mathbf{n}) f_{\boldsymbol{\Gamma}}(\gamma \mid I)$
where the second equality holds because the $t-1$ log-rating differences in $\gamma$ determine the sampling distribution $p(D \mid \boldsymbol{\pi}, \mathbf{n})$.

Lemma 1.2. For any $\mathbf{n}, p(D \mid \mathbf{n}, I)=p\left(D \mid \mathbf{n}, I^{\prime}\right)$ is a necessary condition for $f_{\boldsymbol{\Pi}}(\boldsymbol{\pi} \mid I) \cong f_{\Pi}\left(\boldsymbol{\pi} \mid I^{\prime}\right)$.
Proof. Assume $f_{\boldsymbol{\Pi}}(\boldsymbol{\pi} \mid I) \cong f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I^{\prime}\right)$. Then, by definition $f_{\boldsymbol{\Gamma}}(\gamma \mid I)=f_{\boldsymbol{\Gamma}}\left(\gamma \mid I^{\prime}\right)$. By (1.19), $p(D \mid \mathbf{n}, I)$ can be constructed from $f_{\boldsymbol{\Gamma}}(\gamma \mid I)$ and $p(D \mid \gamma, \mathbf{n})$, and therefore $f_{\Gamma}(\gamma \mid I)=f_{\Gamma}\left(\gamma \mid I^{\prime}\right)$ implies $p(D \mid \mathbf{n}, I)=p\left(D \mid \mathbf{n}, I^{\prime}\right)$.

We can use the prior predictive distribution to check the desiderata.
Lemma 1.3. Given a $\mathbf{n}$ where $n_{k \ell}=n$ for all $k \neq \ell$, desideratum 1.1 implies $p(D \mid \mathbf{n}, I)=p\left(D^{\prime} \mid \mathbf{n}, I\right)$ where $D$ and $D^{\prime}$ differ only by the interchange of a pair of teams $i$ and $j$, i.e., $w_{i j}^{\prime}=w_{j i}, w_{i k}^{\prime}=w_{j k}$, and $w_{j k}^{\prime}=w_{i k}$, for all $k \notin\{i, j\}$.
Proof. Defining $n_{k \ell}^{\prime}=w_{k \ell}^{\prime}+w_{\ell k}^{\prime}$ we see that for all $k \neq \ell, n_{k \ell}^{\prime}=n=n_{k \ell}$, i.e., $\mathbf{n}^{\prime}=\mathbf{n}$. If we define $\boldsymbol{\pi} \rightarrow \boldsymbol{\pi}^{\prime}$ as in the statement of desideratum $1.1\left(\pi_{i}^{\prime}=\pi_{j}\right.$, $\pi_{j}^{\prime}=\pi_{i}, \pi_{k}^{\prime}=\pi_{k}$ for all $\left.k \neq i, j\right)$, we can see $p\left(D^{\prime} \mid \gamma^{\prime}, \mathbf{n}, I\right)=p\left(D^{\prime} \mid \boldsymbol{\pi}^{\prime}, \mathbf{n}, I\right)=$ $p\left(D^{\prime} \mid \boldsymbol{\pi}^{\prime}, \mathbf{n}^{\prime}, I\right)=p(D \mid \boldsymbol{\pi}, \mathbf{n}, I)=p(D \mid \gamma, \mathbf{n}, I)$ where as usual $\gamma_{i j}^{\prime}=\ln \left(\pi_{i}^{\prime} / \pi_{j}^{\prime}\right)$. If desideratum 1.1 holds, we have $f_{\Gamma^{\prime}}\left(\gamma^{\prime} \mid I\right)=f_{\boldsymbol{\Gamma}}(\gamma \mid I)$ and so

$$
\begin{align*}
p\left(D^{\prime} \mid \mathbf{n}, I\right) & =\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma^{\prime} p\left(D^{\prime} \mid \gamma^{\prime}, \mathbf{n}\right) f_{\boldsymbol{\Gamma}}\left(\gamma^{\prime} \mid I\right) \\
& =\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma^{\prime} p(D \mid \gamma, \mathbf{n}) f_{\boldsymbol{\Gamma}}(\gamma \mid I)  \tag{1.20}\\
& =\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma p(D \mid \gamma, \mathbf{n}) f_{\boldsymbol{\Gamma}}(\gamma \mid I)=p(D \mid \mathbf{n}, I)
\end{align*}
$$

because the change of variables $\gamma \rightarrow \gamma^{\prime}$ has unit Jacobian determinant and leaves the range of the integration variables unchanged.
Lemma 1.4. For any $\mathbf{n}$, desideratum 1.2 implies $p(D \mid \mathbf{n}, I)=p\left(D^{\prime} \mid \mathbf{n}, I\right)$ where $w_{i j}^{\prime}=n_{i j}-w_{i j}$.
Proof. Since $w_{i j}^{\prime}=n_{i j}-w_{i j}=w_{j i}, n_{i j}^{\prime}=w_{i j}^{\prime}+w_{j i}^{\prime}=w_{j i}+w_{i j}=n_{i j}$. The rest of the proof proceeds as with lemma 1.3, but with the appropriate definitions of $D \rightarrow D^{\prime}$ and $\boldsymbol{\pi} \rightarrow \boldsymbol{\pi}^{\prime}$.

Lemma 1.5. For any $\mathbf{n}$, desideratum 1.3 implies $p(D \mid \mathbf{n}, I)>0$ if $D$ is a set of results consistent with $\mathbf{n}$.

Proof. Since $p(D \mid \boldsymbol{\theta}, I)>0$ for all $\boldsymbol{\theta}$ with $0<\theta_{i j}<1$, and $p(D \mid \boldsymbol{\gamma}, I)=p(D \mid \boldsymbol{\theta}, I)$, we have $p(D \mid \gamma, I)>0$ for all $\gamma$ with $-\infty<\gamma_{i j}<\infty$. Since $f_{\Gamma}(\gamma \mid I) \geq 0$ and $\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma f_{\Gamma}(\gamma \mid I)=1$, we must have

$$
\begin{equation*}
p(D \mid \mathbf{n}, I)=\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma p(D \mid \gamma, \mathbf{n}) f_{\Gamma}(\gamma \mid I) \geq 0 \tag{1.21}
\end{equation*}
$$

Lemma 1.6. Given $t$ teams and $a \mathbf{n}$ with $n_{i t}=0$, desideratum 1.4 implies $p\left(D \mid \mathbf{n}, I_{t}\right)=p\left(D \mid \mathbf{n}, I_{t-1}\right)$ if $D$ is a set of results consistent with $\mathbf{n}$.

Proof. If $n_{i t}=0, \pi_{t}$ is irrelevant to the sampling distribution, and $p(D \mid \boldsymbol{\pi}, \mathbf{n})=$ $p\left(D \mid \boldsymbol{\pi}^{\prime}, \mathbf{n}\right)$ where $\boldsymbol{\pi}^{\prime}$ is the $(t-1)$-element vector with $\pi_{i}^{\prime}=\pi_{i}$ for $i=0, \ldots, t-1$,
as in the statement of desideratum 1.4. Thus

$$
\begin{align*}
p\left(D \mid \mathbf{n}, I_{t}\right) & =\int_{0}^{\infty} \cdots \int_{0}^{\infty} d^{t} \pi p(D \mid \boldsymbol{\pi}, \mathbf{n}) f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{t}\right) \\
& =\int_{0}^{\infty} \cdots \int_{0}^{\infty} d^{t-1} \pi^{\prime} p\left(D \mid \boldsymbol{\pi}^{\prime}, \mathbf{n}\right) \int_{0}^{\infty} d \pi_{t} f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{t}\right)  \tag{1.22}\\
& =\int_{0}^{\infty} \cdots \int_{0}^{\infty} d^{t-1} \pi^{\prime} p\left(D \mid \boldsymbol{\pi}^{\prime}, \mathbf{n}\right) f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{t}\right)
\end{align*}
$$

Desideratum 1.4 says that $f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{t}\right) \cong f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{t-1}\right)$, and lemma 1.2 states that this implies $p\left(D \mid \mathbf{n}, I_{t}\right)=p\left(D \mid \mathbf{n}, I_{t-1}\right)$.

## 2. Choice of Prior Distribution

### 2.1. General Considerations for Special Cases

### 2.1.1. Two Teams

When $t=2$, there is only one independent probability $\theta_{12}=\frac{\pi_{1}}{\pi_{1}+\pi_{2}}$, so any distribution $f_{\Pi}\left(\pi_{1}, \pi_{2}\right)$ reduces to a function $f_{\Theta_{12}}\left(\theta_{12}\right)$ via marginalization

$$
\begin{equation*}
f_{\Gamma_{12}}\left(\gamma_{12}\right)=\int_{-\infty}^{\infty} d \lambda_{2} f_{\Lambda}\left(\gamma_{12}+\lambda_{2}, \lambda_{2}\right) \tag{2.1}
\end{equation*}
$$

where the transformation (1.6) means

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\lambda_{1}, \lambda_{2}\right)=e^{\lambda_{1}+\lambda_{2}} f_{\boldsymbol{\Pi}}\left(e^{\lambda_{1}}, e^{\lambda_{2}}\right) \tag{2.2}
\end{equation*}
$$

and (1.9) means

$$
\begin{equation*}
f_{\Theta_{12}}\left(\theta_{12}\right)=\theta_{12}^{-1}\left(1-\theta_{12}\right)^{-1} f_{\Gamma_{12}}\left(-\ln \left[\theta_{12}^{-1}-1\right]\right) \tag{2.3}
\end{equation*}
$$

For the case of two teams, desiderata 1.1 and 1.2 are equivalent, as both transformations reduce to $\theta_{12} \rightarrow 1-\theta_{12}$, or equivalently $\gamma_{12} \rightarrow-\gamma_{12}$. They will be satisfied if and only if $f_{\Gamma_{12}}\left(\gamma_{12}\right)$ is an even function, or equivalently if $f_{\Theta_{12}}\left(\theta_{12}\right)=$ $f_{\Theta_{12}}\left(1-\theta_{12}\right)$. Desideratum 1.3 will be satisfied if and only if

$$
\begin{equation*}
\int_{0}^{1} d \theta_{12} f_{\Theta_{12}}\left(\theta_{12}\right)<\infty \tag{2.4}
\end{equation*}
$$

or equivalently

$$
\begin{equation*}
\int_{-\infty}^{\infty} d \gamma_{12} f_{\Gamma_{12}}\left(\gamma_{12}\right)<\infty \tag{2.5}
\end{equation*}
$$

Suppose $f_{\Theta_{12}}\left(\theta_{12}\right)$ belongs to the family of beta distributions (which is the conjugate prior family for the likelihood (1.2)),

$$
\begin{equation*}
f_{\Theta_{12}}\left(\theta_{12}\right) \propto \theta_{12}^{\alpha-1}\left(1-\theta_{12}\right)^{\beta-1} \tag{2.6}
\end{equation*}
$$

then $f_{\Gamma_{12}}\left(\gamma_{12}\right)$ is a generalized logistic distribution of Type IV (Prentice, 1976; Nassar and Elmasry, 2012)

$$
\begin{equation*}
f_{\Gamma_{12}}\left(\gamma_{12}\right) \propto\left(1+e^{-\gamma_{12}}\right)^{-\alpha}\left(1+e^{\gamma_{12}}\right)^{-\beta} \tag{2.7}
\end{equation*}
$$

Included in this family are

1. The Haldane prior (Haldane, 1932; Jeffreys, 1961) $\alpha=\beta=0$, which is uniform $\gamma_{12}$. This improper prior corresponds to "total ignorance".
2. The Jeffreys prior (Jeffreys, 1961, 1946) $\alpha=\beta=\frac{1}{2}$.
3. The Bayes-Laplace prior $\alpha=\beta=1$, which is uniform in $\theta_{12}$. This is also the maximum entropy prior, if we assume a measure uniform in $\theta_{12}$.

For the beta family, desiderata 1.1 and 1.2 will be satisfied if $\alpha=\beta$. Desideratum 1.3 will be satisfied if $\alpha, \beta>0$.

With $t=2$, the prior predictive probability for a set of results which include $w_{12}$ wins for team 1 and $w_{21}=n_{12}-w_{12}$ wins for team 2 will be

$$
\begin{equation*}
p\left(D \mid n_{12}\right)=\int_{0}^{1} d \theta_{12} \theta_{12}^{w_{12}}\left(1-\theta_{12}\right)^{w_{21}} f_{\Theta_{12}}\left(\theta_{12}\right) \tag{2.8}
\end{equation*}
$$

If $f_{\Theta_{12}}\left(\theta_{12}\right)$ is in the Beta family (2.6), it will be

$$
\begin{equation*}
p\left(D \mid n_{12}, I_{\alpha, \beta}\right)=\frac{\Gamma(\alpha+\beta)}{\Gamma(\alpha) \Gamma(\beta)} \frac{\Gamma\left(\alpha+w_{12}\right) \Gamma\left(\beta+w_{21}\right)}{\Gamma\left(\alpha+\beta+n_{12}\right)} \tag{2.9}
\end{equation*}
$$

In particular, for the Bayes-Laplace prior,

$$
\begin{equation*}
p\left(D \mid n_{12}, I_{1,1}\right)=\frac{\Gamma\left(1+w_{12}\right) \Gamma\left(1+w_{21}\right)}{\Gamma\left(2+n_{12}\right)}=\left(\left(n_{12}+1\right)\binom{n_{12}}{w_{12}}\right)^{-1} \tag{2.10}
\end{equation*}
$$

For the Jeffreys prior,

$$
\begin{equation*}
p\left(D \mid n_{12}, I_{1 / 2,1 / 2}\right)=\frac{\Gamma\left(\frac{1}{2}+w_{12}\right) \Gamma\left(\frac{1}{2}+w_{21}\right)}{\pi \Gamma\left(1+n_{12}\right)}=\frac{\left(2 w_{12}-1\right)!!\left(2 w_{21}-1\right)!!}{2^{n_{12}} n_{12}!} \tag{2.11}
\end{equation*}
$$

Viewing the Haldane prior as a limiting case, $p\left(D \mid n_{12}, I_{1 / 2,1 / 2}\right)=0$ unless $w_{12}=$ $n_{12}$ or $w_{21}=n_{12}$. The prior predictive probabilities for $w_{12}=n_{12}$ and $w_{21}=n_{12}$ depend on the order in which the limits $\alpha \rightarrow 0$ and $\beta \rightarrow 0$ are taken.

### 2.1.2. Three Teams

In the case $t=3$, the $\left\{\theta_{i j}\right\}$ are related by $\theta_{j i}=1-\theta_{i j}$ as well as

$$
\begin{equation*}
\theta_{13}^{-1}-1=\left(\theta_{12}^{-1}-1\right)\left(\theta_{23}^{-1}-1\right) \tag{2.12}
\end{equation*}
$$

Although each $\theta_{i j}$ is confined to the finite range $[0,1]$, the surface defined by (2.12) is curved, which makes it difficult to display the two-dimensional probability distribution $f_{\boldsymbol{\Theta}}(\boldsymbol{\theta})$ while preserving its intuitive interpretation. On the other hand, in terms of the $\left\{\gamma_{i j}\right\}$ the constraints are $\gamma_{j i}=-\gamma_{i j}$ and

$$
\begin{equation*}
\gamma_{13}=\gamma_{12}+\gamma_{23} \tag{2.13}
\end{equation*}
$$

An especially convenient set of coördinates for displaying probability distributions $f_{\boldsymbol{\Gamma}}(\gamma)$ is

$$
\begin{equation*}
x=\frac{1}{\sqrt{3}}\left(\gamma_{12}+\gamma_{13}\right), \quad y=\gamma_{23} \tag{2.14}
\end{equation*}
$$

which can be inverted to give

$$
\begin{equation*}
\gamma_{12}=\frac{\sqrt{3}}{2} x-\frac{1}{2} y, \quad \gamma_{23}=y, \quad \gamma_{13}=\frac{\sqrt{3}}{2} x+\frac{1}{2} y \tag{2.15}
\end{equation*}
$$

These two-dimensional coördinates on the space of log-odds-ratios $\gamma$ are also two of the three coördinates on the space of strengths $\boldsymbol{\lambda}$, according to

$$
\begin{equation*}
x=\frac{1}{\sqrt{3}}\left(2 \lambda_{1}-\lambda_{2}-\lambda_{3}\right), \quad y=\lambda_{2}-\lambda_{3}, \quad z=\sqrt{\frac{2}{3}}\left(\lambda_{1}+\lambda_{2}+\lambda_{3}\right) \tag{2.16}
\end{equation*}
$$

In these coördinates, to go from a distribution $f_{\boldsymbol{\Lambda}}(\boldsymbol{\lambda})$ to $f_{\boldsymbol{\Gamma}}(\gamma)$ one simply converts $f_{\boldsymbol{\Lambda}}(\boldsymbol{\lambda})$ into $f_{X Y Z}(x, y, z)$ (which involves a constant Jacobian determinant) and then marginalizes over $z$. An example of such a plot is shown in Fig. 1.

### 2.2. Evaluation of Prior Distributions

We now consider several families of prior distributions which have been proposed, and evaluate them according to the desiderata in Sec. 1.3.

### 2.2.1. Haldane Prior

Perhaps the simplest prior that can be chosen is the improper prior

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{0}\right)=\text { constant } \tag{2.17}
\end{equation*}
$$

uniform in all of the log-strengths, which is the generalization of the Haldane prior considered in Sec. 2.1.1. Then the marginalized prior probability distribution for the log-odds-ratios is $f_{\Gamma}\left(\gamma \mid I_{0}\right)=$ constant. This prior obviously satisfies desiderata 1.1 and 1.2 , as well as desideratum 1.4. Of course, since the prior $f_{\Gamma}\left(\gamma \mid I_{0}\right)$ is improper, it violates desideratum 1.3. The mode of the posterior $f_{\boldsymbol{\Lambda} \mid D}\left(\boldsymbol{\lambda} \mid D, I_{0}\right)$ will be the maximum likelihood solution, and the posterior will be normalizable under the conditions given by Ford (1957) for the existence of the maximum likelihood solution.

Note that while the improper prior $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{0}^{\prime}\right)=$ constant produces a different prior on the individual strengths, since

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{0}^{\prime}\right) \propto \exp \left(\sum_{i=1}^{t} \lambda_{i}\right) \tag{2.18}
\end{equation*}
$$

the two are equivalent, $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{0}^{\prime}\right) \cong f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{0}\right)$, because $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{0}^{\prime}\right)$ depends only on the sum of the log-strengths.


FIG 1. Contour plot of the prior probability distribution $f_{\Gamma}\left(\gamma \mid I_{S 3}\right)$ arising from the Maximum entropy prescription of Sec. 2.2.2 when $t=3$. The coördinates for the plot are the $x$ and $y$ defined in (2.14), which determine all of the $\left\{\gamma_{i j}\right\}$ and thus the predicted probabilities. The orthogonal direction $z=\sqrt{\frac{2}{3}}\left(\lambda_{1}+\lambda_{2}+\lambda_{3}\right)$ defined in (2.16) is irrelevant to the predictions of the model.

### 2.2.2. Maximum Entropy

The next prior of interest is one which maximizes the Shannon entropy. For the case $t=2$, we defined the entropy as

$$
\begin{equation*}
S_{2}=-\int_{0}^{1} d \theta_{12} f_{\Theta_{12}}\left(\theta_{12}\right) \ln f_{\Theta_{12}}\left(\theta_{12}\right) \tag{2.19}
\end{equation*}
$$

which made the maximum entropy prior $f_{\Theta_{12}}\left(\theta_{12} \mid I_{\mathrm{S} 2}\right)=$ const. In order for the entropy of a continuous distribution $f(x)$ to be invariant, it needs to be defined with a measure $\mu(x)$ which transforms as a density under reparametrization. Thus we can write

$$
\begin{equation*}
S_{2}=-\int_{0}^{1} d \theta_{12} f_{\Theta_{12}}\left(\theta_{12}\right) \ln \frac{f_{\Theta_{12}}\left(\theta_{12}\right)}{\mu_{\Theta_{12}}\left(\theta_{12}\right)}=-\int_{0}^{1} d \gamma_{12} f_{\Gamma_{12}}\left(\gamma_{12}\right) \ln \frac{f_{\Gamma_{12}}\left(\gamma_{12}\right)}{\mu_{\Gamma_{12}}\left(\gamma_{12}\right)} \tag{2.20}
\end{equation*}
$$

where we have assumed that $\mu_{\Theta_{12}}\left(\theta_{12}\right)=$ constant and thus, using (1.8) to transform the measure,

$$
\begin{equation*}
\mu_{\Gamma_{12}}\left(\gamma_{12}\right) \propto\left(1+e^{-\gamma_{12}}\right)^{-1}\left(1+e^{\gamma_{12}}\right)^{-1} \tag{2.21}
\end{equation*}
$$

If we maximize the entropy of a continuous distribution with normalization as the only constraint, the probability density is proportional to the measure, so

$$
\begin{equation*}
f_{\Gamma_{12}}\left(\gamma_{12} \mid I_{\mathrm{S} 2}\right) \propto\left(1+e^{-\gamma_{12}}\right)^{-1}\left(1+e^{\gamma_{12}}\right)^{-1} \tag{2.22}
\end{equation*}
$$

which is indeed of the form (2.7) with $\alpha=\beta=1$.
For general $t$, we could define by analogy a measure uniform in the $\left\{\theta_{i j}\right\}$, $\mu_{\boldsymbol{\Theta}}(\boldsymbol{\theta})=$ constant, and then minimize the entropy

$$
\begin{equation*}
S_{t}=-\int_{0}^{1} \cdots \int_{0}^{1} d^{t(t-1) / 2} \theta f_{\boldsymbol{\Theta}}(\boldsymbol{\theta}) \ln f_{\boldsymbol{\Theta}}(\boldsymbol{\theta}) \tag{2.23}
\end{equation*}
$$

subject to the constraints that the probability density vanishes unless the arguments satisfy

$$
\begin{equation*}
\theta_{i j}^{-1}=\left(\theta_{i k}^{-1}-1\right)\left(\theta_{k j}^{-1}-1\right) \quad i=1, \ldots, t ; j=i+1, \ldots, t ; k=i+1, \ldots, j-1 \tag{2.24}
\end{equation*}
$$

It is equivalent, and more straightforward, to confine the distribution to the constraint surface by writing it in terms of the $t-1$ unique $\gamma_{\alpha}$ parameters:

$$
\begin{equation*}
S_{t}^{\prime}=-\int_{-\infty}^{\infty} \cdots \int_{-\infty}^{\infty} d^{t-1} \gamma f_{\Gamma}(\gamma) \ln \frac{f_{\Gamma}(\gamma)}{\mu_{\Gamma}(\gamma)} \tag{2.25}
\end{equation*}
$$

where the measure is

$$
\begin{equation*}
\mu_{\boldsymbol{\Gamma}}(\gamma) \propto \prod_{i=1}^{t} \prod_{j=i+1}^{t}\left(1+e^{-\gamma_{i j}}\right)^{-1}\left(1+e^{\gamma_{i j}}\right)^{-1} \tag{2.26}
\end{equation*}
$$

As before, the maximum entropy distribution is $f_{\Gamma}\left(\gamma \mid I_{S t}\right) \propto \mu_{\Gamma}(\gamma)$, or

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{S t}\right) \propto \prod_{i=1}^{t} \prod_{j=i+1}^{t}\left[1+\exp \left(-\sum_{\alpha=1}^{t-1} C_{i j, \alpha} \gamma_{\alpha}\right)\right]^{-1}\left[1+\exp \left(\sum_{\beta=1}^{t-1} C_{i j, \beta} \gamma_{\beta}\right)\right]^{-1} \tag{2.27}
\end{equation*}
$$

We can see from the form of $(2.26)$ that desiderata 1.1 and 1.2 are satisfied. It is also easy to see that $f_{\Gamma}\left(\gamma \mid I_{\mathrm{S} t}\right)$ is exponentially suppressed as any linear combination of the $\left\{\gamma_{\alpha}\right\}$ goes to infinity, and therefore desideratum 1.3. For example, as $\gamma_{\alpha} \rightarrow \infty$,

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{S} t}\right) \rightarrow \prod_{i=1}^{t} \prod_{j=i+1}^{t} e^{-\left|C_{i j, \alpha}\right| \gamma_{\alpha}}=\exp \left(-\gamma_{\alpha} \sum_{i=1}^{t} \sum_{j=i+1}^{t}\left|C_{i j, \alpha}\right|\right) \tag{2.28}
\end{equation*}
$$

However, we can see that desideratum 1.4 is not satisfied by considering the case $t=3$ and showing that the marginal distribution

$$
\begin{equation*}
f_{\Gamma_{23}}\left(\gamma_{23} \mid I_{\mathrm{S} 3}\right) \neq f_{\Gamma_{23}}\left(\gamma_{23} \mid I_{\mathrm{S} 2}\right) \tag{2.29}
\end{equation*}
$$

Explicitly. using the coördinates (2.14), in which $y=\gamma_{23}$,

$$
\begin{align*}
f_{\Gamma}\left(x, y \mid I_{\mathrm{S} 3}\right) \propto & \left(1+e^{\frac{\sqrt{3}}{2} x} e^{-y / 2}\right)^{-1}\left(1+e^{-\frac{\sqrt{3}}{2} x} e^{y / 2}\right)^{-1}\left(1+e^{-y}\right)^{-1}\left(1+e^{y}\right)^{-1} \\
& \times\left(1+e^{\frac{\sqrt{3}}{2} x} e^{y / 2}\right)^{-1}\left(1+e^{-\frac{\sqrt{3}}{2} x} e^{-y / 2}\right)^{-1} \tag{2.30}
\end{align*}
$$

which is plotted in Fig. 1. The marginalization integral can be done by partial fractions to give

$$
\begin{equation*}
f_{\Gamma_{23}}\left(\gamma_{23} \mid I_{\mathrm{S} 3}\right)=\int_{-\infty}^{\infty} f_{\Gamma}\left(x, \gamma_{23} \mid I_{\mathrm{S} 3}\right) d x \propto \frac{e^{\gamma_{23}}\left[2\left(1-e^{\gamma_{23}}\right)+\gamma_{23}\left(1+e^{\gamma_{23}}\right)\right]}{\left(e^{\gamma_{23}}-1\right)^{3}\left(1+e^{-\gamma_{23}}\right)\left(1+e^{\gamma_{23}}\right)} \tag{2.31}
\end{equation*}
$$

which is manifestly different from

$$
\begin{equation*}
f_{\Gamma_{23}}\left(\gamma_{23} \mid I_{\mathrm{S} 2}\right) \propto \frac{1}{\left(1+e^{-\gamma_{23}}\right)\left(1+e^{\gamma_{23}}\right)} \tag{2.32}
\end{equation*}
$$

by more than just a normalization constant.

### 2.2.3. Jeffreys Prior

The Jeffreys prior construction (Jeffreys, 1946) can be carried out using the likelihood (1.2), to produce a prior

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{J}}\right) \propto \sqrt{\mathcal{I}(\boldsymbol{\lambda})} \tag{2.33}
\end{equation*}
$$

where $\mathcal{I}(\boldsymbol{\lambda})$ is the Fisher information associated with the likelihood. Since the likelihood is written in terms of the $\left\{\theta_{i j}\right\}$, or equivalently in terms of the $\left\{\gamma_{i j}\right\}$, it is simpler to generate

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{J}}\right) \propto \sqrt{\mathcal{I}(\gamma)} \tag{2.34}
\end{equation*}
$$

directly. If we write the $t-1$ independent elements of $\gamma$ as

$$
\begin{equation*}
\gamma_{i j}=\sum_{\alpha=1}^{t-1} C_{i j, \alpha} \gamma_{\alpha} \tag{1.10}
\end{equation*}
$$

we can write

$$
\begin{equation*}
\mathcal{I}(\gamma)=-E\left[\operatorname{det}\left\{\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{\alpha} \partial \gamma_{\beta}}\right\}\right] \tag{2.35}
\end{equation*}
$$

where

$$
\begin{equation*}
\ell(\boldsymbol{\gamma} ; D)=\ln p_{D \mid \gamma}(D \mid \gamma)=\sum_{i=1}^{t} \sum_{j=i+1}^{t}\left(w_{i j} \gamma_{i j}-n_{i j} \ln \left[1+e^{\gamma_{i j}}\right]\right) \tag{2.36}
\end{equation*}
$$

The linear form of (1.10) allows us to determine the Fisher information matrix for the $\left\{\gamma_{\alpha}\right\}$ from that for the $\left\{\gamma_{i j}\right\}$ as

$$
\begin{equation*}
\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{\alpha} \partial \gamma_{\beta}}=\sum_{i=1}^{t} \sum_{j=i+1}^{t} \sum_{i^{\prime}=1}^{t} \sum_{j^{\prime}=i^{\prime}+1}^{t} C_{i j, \alpha} C_{i^{\prime} j^{\prime}, \beta} \frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{i j} \partial \gamma_{i^{\prime} j^{\prime}}} \tag{2.37}
\end{equation*}
$$

Since the log-likelihood is relatively simple written in terms of the $\left\{\gamma_{i j}\right\}$, we can write

$$
\begin{equation*}
\frac{\partial \ell(\gamma ; D)}{\partial \gamma_{i j}}=w_{i j}-n_{i j} e^{\gamma_{i j}}\left(1+e^{\gamma_{i j}}\right)^{-1}=w_{i j}-n_{i j}\left(1+e^{-\gamma_{i j}}\right)^{-1} \tag{2.38}
\end{equation*}
$$

and
$\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{i j} \partial \gamma_{i^{\prime} j^{\prime}}}=-\delta_{i i^{\prime}} \delta_{j j^{\prime}} n_{i j} e^{-\gamma_{i j}}\left(1+e^{-\gamma_{i j}}\right)^{-2}=-\delta_{i i^{\prime}} \delta_{j j^{\prime}} n_{i j}\left(1+e^{-\gamma_{i j}}\right)^{-1}\left(1+e^{\gamma_{i j}}\right)^{-1}$
so

$$
\begin{equation*}
-\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{\alpha} \partial \gamma_{\beta}}=\sum_{i=1}^{t} \sum_{j=i+1}^{t} C_{i j, \alpha} C_{i j, \beta} n_{i j}\left(1+e^{-\gamma_{i j}}\right)^{-1}\left(1+e^{\gamma_{i j}}\right)^{-1} \tag{2.40}
\end{equation*}
$$

We can see by inspection of (2.40) that the Jeffreys prior always satisfies desideratum 1.2 . We can verify that in the case $t=2$, for which there is only one independent $\gamma_{\alpha}$, the Jeffreys prior becomes

$$
\begin{equation*}
f_{\Gamma}\left(\gamma_{12} \mid I_{\mathrm{J} 2}\right) \propto\left(1+e^{-\gamma_{i j}}\right)^{-1 / 2}\left(1+e^{\gamma_{i j}}\right)^{-1 / 2} \tag{2.41}
\end{equation*}
$$

which is of the form (2.7) with $\alpha=\beta=\frac{1}{2}$ as before.
If we write

$$
\begin{equation*}
-\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{\alpha} \partial \gamma_{\beta}}=\sum_{i=1}^{t} \sum_{j=i+1}^{t} C_{i j, \alpha} C_{i j, \beta} n_{i j}\left(e^{\gamma_{i j} / 2}+e^{-\gamma_{i j} / 2}\right)^{-2} \tag{2.42}
\end{equation*}
$$

Note that if we make the specific choice $\gamma_{\alpha}=\gamma_{\alpha, \alpha+1}$, we have

$$
\begin{equation*}
\gamma_{i j}=\sum_{\alpha=i}^{j-1} \gamma_{\alpha} \tag{2.43}
\end{equation*}
$$

which makes

$$
C_{i j, \alpha}= \begin{cases}1 & i \leq \alpha \leq j-1  \tag{2.44}\\ 0 & \text { otherwise }\end{cases}
$$

and then the Fisher information matrix (2.40) is

$$
\begin{equation*}
-\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{\alpha} \partial \gamma_{\beta}}=\sum_{\substack{i, j \\ i \leq \alpha \leq j-1 \\ i \leq \beta \leq j-1}} n_{i j}\left(e^{\gamma_{i j} / 2}+e^{-\gamma_{i j} / 2}\right)^{-2} \tag{2.45}
\end{equation*}
$$

For $t>2$, the Fisher information matrix (2.40) depends on the number of games $n_{i j}$ to be played between each pair of teams. However, in order to satisfy desideratum 1.1, we need to have the same $n_{i j}$ for each pair of teams, in which case this $n_{i j}$ becomes a constant which can be absorbed into the normalization, and the prescription becomes unique.

By explicitly examining $t=3$, we will show that the Jeffreys prior with all $\left\{n_{i j}\right\}$ equal fails to satisfy desideratum 1.4. ${ }^{1}$ In the case $t=3$, the vector of independent log-odds-ratios $\gamma$ is two-dimensional, and the elements of the Fisher information matrix are

$$
\begin{gather*}
-\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{1} \partial \gamma_{1}}=M_{12}+M_{13}  \tag{2.46a}\\
-\frac{\partial^{2} \ell(\gamma ; D)}{\partial \gamma_{1} \partial \gamma_{2}}=M_{13}  \tag{2.46b}\\
-\frac{\partial^{2} \ell(\boldsymbol{\gamma} ; D)}{\partial \gamma_{2} \partial \gamma_{2}}=M_{13}+M_{23} \tag{2.46c}
\end{gather*}
$$

where

$$
\begin{equation*}
M_{i j}:=n_{i j}\left(e^{\gamma_{i j} / 2}+e^{-\gamma_{i j} / 2}\right)^{-2}=: n_{i j} m_{i j} \tag{2.47}
\end{equation*}
$$

The Fisher information is the determinant of this matrix

$$
\begin{equation*}
\mathcal{I}(\gamma)=\left(M_{12}+M_{13}\right)\left(M_{13}+M_{23}\right)-M_{13}^{2}=M_{12} M_{13}+M_{12} M_{23}+M_{13} M_{23} \tag{2.48}
\end{equation*}
$$

so the Jeffreys prior is

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{J} 3}\right) \propto \sqrt{M_{12} M_{13}+M_{12} M_{23}+M_{13} M_{23}} \propto \sqrt{m_{12} m_{13}+m_{12} m_{23}+m_{13} m_{23}} \tag{2.49}
\end{equation*}
$$

We can show that the Jeffreys prior fails to satisfy desideratum 1.4 by using the posterior predictive distribution and Lemma 1.6. Suppose $n_{12}=2$ and $n_{i 3}=0$. Then (2.11) implies

$$
p\left(D \mid \mathbf{n}, I_{\mathrm{J} 2}\right)= \begin{cases}0.125 & w 12=1  \tag{2.50}\\ 0.375 & w 12=0 \text { or } 2\end{cases}
$$

We can evaluate $p\left(D \mid \mathbf{n}, I_{\mathrm{J} 3}\right)$ numerically, and find

$$
p\left(D \mid \mathbf{n}, I_{\mathrm{J} 3}\right) \approx \begin{cases}0.108 & w 12=1  \tag{2.51}\\ 0.392 & w 12=0 \text { or } 2\end{cases}
$$

showing explicitly that $p\left(D \mid \mathbf{n}, I_{\mathrm{J} 3}\right) \neq p\left(D \mid \mathbf{n}, I_{\mathrm{J} 2}\right)$ and therefore desideratum 1.4 is violated.

### 2.2.4. Dirichlet Distribution

Chen and Smith (1984) discuss Bayesian estimators for the Bradley-Terry model starting with a Dirichlet distribution

$$
\begin{equation*}
f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{\mathrm{D} t}\right)=\frac{\Gamma\left(\sum_{i=1}^{t} \alpha_{i}\right)}{\prod_{i=1}^{t} \Gamma\left(\alpha_{i}\right)}\left(\prod_{i=1}^{t} \pi_{i}^{\alpha_{i}-1}\right) \delta\left(1-\sum_{i=1}^{t} \pi_{i}\right) \tag{2.52}
\end{equation*}
$$

where $\delta(x)$ is the Dirac delta function. In particular, they note that the marginal distribution for any of the $\left\{\theta_{i j}\right\}$ is a beta distribution with parameters $\alpha=\alpha_{i}$ and $\beta=\alpha_{j}$ :

$$
\begin{equation*}
f_{\Theta_{i j}}\left(\theta_{i j} \mid I_{\mathrm{D} t}\right)=\frac{\Gamma\left(\alpha_{i}+\alpha_{j}\right)}{\Gamma\left(\alpha_{i}\right) \Gamma\left(\alpha_{j}\right)} \theta_{i j}^{\alpha_{i}-1}\left(1-\theta_{i j}\right)^{\alpha_{j}-1} \tag{2.53}
\end{equation*}
$$

The Dirichlet prior satisfies desideratum 1.3 as long as all of the $\left\{\alpha_{i}\right\}$ are positive; it also satisfies desideratum 1.1 if all of the parameters $\left\{\alpha_{i}\right\}$ are equal to a the same value $\alpha$. Although the delta function enforcing the constraint $\sum_{i=1}^{t} \pi_{i}^{\alpha_{i}}=1$ means that the different $\left\{\pi_{i}\right\}$ are not independently distributed under $I_{\mathrm{D} t}$, we can see that desideratum 1.4 is satisfied by defining a change of variables

$$
\begin{equation*}
\pi_{i}^{\prime}=\frac{\pi_{i}}{1-\pi_{t}} \quad i=1, \ldots, t-1 \tag{2.54}
\end{equation*}
$$

under which the probability density (2.52) becomes
$f_{\Pi^{\prime}, \Pi_{t}}\left(\boldsymbol{\pi}^{\prime}, \pi_{t} \mid I_{\mathrm{D} t}\right)=\frac{\Gamma\left(\sum_{i=1}^{t} \alpha_{i}\right)}{\prod_{i=1}^{t} \Gamma\left(\alpha_{i}\right)}\left(\prod_{i=1}^{t-1} \pi_{i}^{\prime \alpha_{i}-1}\right) \delta\left(1-\sum_{i=1}^{t-1} \pi_{i}^{\prime}\right)\left(1-\pi_{t}\right)^{\sum_{i=1}^{t-1} \alpha_{i}-1} \pi_{t}^{\alpha_{t}-1}$
which, when we marginalize over $\pi_{t}$, gives

$$
\begin{equation*}
f_{\boldsymbol{\Pi}^{\prime}}\left(\boldsymbol{\pi}^{\prime} \mid I_{\mathrm{D} t}\right)=\frac{\Gamma\left(\sum_{i=1}^{t-1} \alpha_{i}\right)}{\prod_{i=1}^{t-1} \Gamma\left(\alpha_{i}\right)}\left(\prod_{i=1}^{t-1} \pi_{i}^{\prime \alpha_{i}-1}\right) \delta\left(1-\sum_{i=1}^{t-1} \pi_{i}^{\prime}\right) \tag{2.56}
\end{equation*}
$$

which is a Dirichlet distribution with the same parameters $\left\{\alpha_{1}, \ldots, \alpha_{t-1}\right\}$.
However, desideratum 1.2 is not satisfied, which we can see explicitly by considering $t=3$ and assuming $\alpha_{1}=\alpha_{2}=\alpha_{3} \equiv \alpha$, so that

$$
\begin{equation*}
f_{\Pi}\left(\pi_{1}, \pi_{2}, \pi_{3} \mid I_{\mathrm{D} 3}\right) \propto\left(\pi_{1} \pi_{2} \pi_{3}\right)^{\alpha-1} \delta\left(\pi_{1}+\pi_{2}+\pi_{3}-1\right) \tag{2.57}
\end{equation*}
$$

or equivalently

$$
\begin{equation*}
f_{\Lambda}\left(\lambda_{1}, \lambda_{2}, \lambda_{3} \mid I_{\mathrm{D} 3}\right) \propto e^{\alpha\left(\lambda_{1}+\lambda_{2}+\lambda_{3}\right)} \delta\left(e^{\lambda_{1}}+e^{\lambda_{2}}+e^{\lambda_{3}}-1\right) \tag{2.58}
\end{equation*}
$$

If we write

$$
\begin{gather*}
\pi_{1}+\pi_{2}+\pi_{3}=\left(\pi_{1} \pi_{2} \pi_{3}\right)^{1 / 3}\left(\left(\frac{\pi_{1}}{\pi_{2}} \frac{\pi_{1}}{\pi_{3}}\right)^{1 / 3}+\left(\frac{\pi_{2}}{\pi_{1}} \frac{\pi_{2}}{\pi_{3}}\right)^{1 / 3}+\left(\frac{\pi_{3}}{\pi_{1}} \frac{\pi_{3}}{\pi_{2}}\right)^{1 / 3}\right) \\
=e^{\lambda_{1}}+e^{\lambda_{2}}+e^{\lambda_{3}}=e^{\frac{\lambda_{1}+\lambda_{2}+\lambda_{3}}{3}}\left(e^{\frac{\gamma_{12}+\gamma_{13}}{3}}+e^{\frac{-\gamma_{12}+\gamma_{23}}{3}}+e^{\frac{-\gamma_{13}-\gamma_{23}}{3}}\right) \tag{2.59}
\end{gather*}
$$

we can see
$\delta\left(e^{\lambda_{1}}+e^{\lambda_{2}}+e^{\lambda_{3}}-1\right) \propto \delta\left(\lambda_{1}+\lambda_{2}+\lambda_{3}+3 \ln \left[e^{\frac{\gamma_{12}+\gamma_{13}}{3}}+e^{\frac{-\gamma_{12}+\gamma_{23}}{3}}+e^{\frac{-\gamma_{13}-\gamma_{23}}{3}}\right]\right)$
and so marginalizing over the combination $\lambda_{1}+\lambda_{2}+\lambda_{3}$ leaves a prior distribution

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{D} 3}\right) \propto\left(e^{\frac{\gamma_{12}+\gamma_{13}}{3}}+e^{\frac{-\gamma_{12}+\gamma_{23}}{3}}+e^{\frac{-\gamma_{13}-\gamma_{23}}{3}}\right)^{-3 \alpha} \tag{2.61}
\end{equation*}
$$

We see that, for non-zero $\alpha, f_{\Gamma}\left(\gamma \mid I_{\mathrm{D} 3}\right) \neq f_{\Gamma}\left(-\gamma \mid I_{\mathrm{D} 3}\right)$. This is illustrated explicitly for $\alpha=\frac{1}{2}$ in Fig. 2. Another way of expressing this asymmetry if we'd started with an "anti-Dirichlet" prior, i.e., requiring $\left\{1 / \pi_{i}\right\}$ to be Dirichlet distributed, we'd have got the distribution

$$
\begin{equation*}
f_{\boldsymbol{\Gamma}}\left(\gamma \mid I_{\mathrm{D}^{\prime} 3}\right) \propto\left(e^{\frac{-\gamma_{12}-\gamma_{13}}{3}}+e^{\frac{\gamma_{12}-\gamma_{23}}{3}}+e^{\frac{\gamma_{13}+\gamma_{23}}{3}}\right)^{-3 \alpha} \tag{2.62}
\end{equation*}
$$

### 2.2.5. Conjugate Prior Families

Davidson and Solomon (1973) construct a conjugate prior family of the form

$$
\begin{equation*}
f_{\Pi}\left(\boldsymbol{\pi} \mid I_{\mathrm{C}}\right) \propto\left(\prod_{i=1}^{t} \pi_{i}^{v_{i}^{0}}\right)\left(\prod_{i=1}^{t} \prod_{j=i+1}^{t}\left(\pi_{i}+\pi_{j}\right)^{-n_{i j}^{0}}\right) \delta\left(1-\sum_{i=1}^{t} \pi_{i}\right) \tag{2.63}
\end{equation*}
$$

where $n_{i i}^{0}=0$. In order to satisfy desideratum 1.1 (interchange of teams), we require that $v_{i}^{0}=v^{0}$ and $n_{i j}^{0}=n^{0}$ for all $i$ and $j \neq i$, so the prior becomes

$$
\begin{equation*}
f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{\mathrm{C}}\right) \propto\left(\prod_{i=1}^{t} \pi_{i}\right)^{v^{0}}\left(\prod_{i=1}^{t} \prod_{j=i+1}^{t}\left(\pi_{i}+\pi_{j}\right)\right)^{-n^{0}} \delta\left(1-\sum_{i=1}^{t} \pi_{i}\right) \tag{2.64}
\end{equation*}
$$

Note that Davidson and Solomon (1973) motivate $v_{i}^{0}$ and $n_{i j}^{0}$ as coming from a matrix $w_{i j}^{0}\left(\right.$ with $\left.w_{i i}^{0}=0\right)$ via $v_{i}^{0}=\sum_{i=1}^{t} w_{i j}^{0}$ and $n_{i j}^{0}=w_{i j}^{0}+w_{j i}^{0}$, which means that in particular $\sum_{i=1}^{t} \sum_{j=1}^{t} n_{i j}^{0}=2 \sum_{i=1}^{t} v_{i}^{0}$, which in the case of single $n^{0}$ and $v^{0}$ parameters would require $v^{0}=(t-1) n^{0} / 2$. We will not impose that condition at this stage, however.

To convert $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{\mathrm{C}}\right)$ into $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{C}}\right)$, we note that

$$
\begin{equation*}
\sum_{i=1}^{t} \pi_{i}=\left(\prod_{k=1}^{t} \pi_{k}\right)^{1 / t} \sum_{i=1}^{t}\left(\prod_{j=1}^{t} \frac{\pi_{i}}{\pi_{j}}\right)^{1 / t}=\exp \left(\frac{1}{t} \sum_{k=1}^{t} \lambda_{k}\right) \sum_{i=1}^{t} \exp \left(\frac{1}{t} \sum_{j=1}^{t} \gamma_{i j}\right) \tag{2.65}
\end{equation*}
$$

and since, for $t>0$,

$$
\begin{gather*}
\delta\left(1-e^{u / t}\right)=\frac{\delta(u)}{\frac{1}{t} e^{u / t}}=t \delta(u)  \tag{2.66}\\
\delta\left(1-\sum_{i=1}^{t} \pi_{i}\right)=t \delta\left(\sum_{k=1}^{t} \lambda_{k}+t \ln \sum_{i=1}^{t} \exp \left(\frac{1}{t} \sum_{j=1}^{t} \gamma_{i j}\right)\right) \tag{2.67}
\end{gather*}
$$

Similarly, we can write

$$
\begin{align*}
\prod_{i=1}^{t} \prod_{j=i+1}^{t}\left(\pi_{i}+\pi_{j}\right) & =\frac{1}{\prod_{k=1}^{t} 2 \pi_{k}} \sqrt{\prod_{i=1}^{t} \prod_{j=1}^{t}\left(\pi_{i}+\pi_{j}\right)} \\
& =\frac{1}{2^{t} \prod_{k=1}^{t} \pi_{k}} \sqrt{\left(\prod_{k=1}^{t} \pi_{k}\right)^{t}\left[\prod_{i=1}^{t} \prod_{j=1}^{t}\left(1+\frac{\pi_{i}}{\pi_{j}}\right)\right]}  \tag{2.68}\\
& =\frac{1}{2^{t}} \exp \left(\left(\frac{t}{2}-1\right) \sum_{k=1}^{t} \lambda_{k}\right)\left(\prod_{i=1}^{t} \prod_{j=1}^{t}\left[1+e^{\gamma_{i j}}\right]\right)^{1 / 2}
\end{align*}
$$

which makes the prior (recalling (1.6))

$$
\begin{align*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{C}}\right) \propto & \exp \left(\left[v^{0}+1-n^{0}\left(\frac{t}{2}-1\right)\right] \sum_{k=1}^{t} \lambda_{k}\right)\left(\prod_{i=1}^{t} \prod_{j=1}^{t}\left[1+e^{\gamma_{i j}}\right]\right)^{-n^{0} / 2} \\
& \times \delta\left(\sum_{k=1}^{t} \lambda_{k}+t \ln \sum_{i=1}^{t} \exp \left(\frac{1}{t} \sum_{j=1}^{t} \gamma_{i j}\right)\right) \tag{2.69}
\end{align*}
$$

When we marginalize over $\sum_{k=1}^{t} \lambda_{k}$, the Dirac delta function sets $\exp \left(\sum_{k=1}^{t} \lambda_{k}\right)$ to $\left(\sum_{i=1}^{t} \exp \left(\frac{1}{t} \sum_{j=1}^{t} \gamma_{i j}\right)\right)^{-t}$ and the prior becomes

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{C}}\right) \propto\left[\sum_{i=1}^{t} \exp \left(\frac{1}{t} \sum_{j=1}^{t} \gamma_{i j}\right)\right]^{-t\left(v^{0}+1-n^{0}[t / 2-1]\right)}\left(\prod_{i=1}^{t} \prod_{j=1}^{t}\left[1+e^{\gamma_{i j}}\right]\right)^{-n^{0} / 2} \tag{2.70}
\end{equation*}
$$

The quantity in large square brackets is in general not symmetric under the transformation $\gamma \rightarrow-\gamma$, while the remainder of the expression is. This means, to satisfy desideratum 1.2 (win-loss inversion), we should have $v^{0}=(t-2) n^{0} / 2-1$. Note that this is not the same as the condition $v^{0}=(t-1) n^{0} / 2$ implied by Davidson and Solomon (1973)'s conditions on $v_{i}^{0}$ and $n_{i j}^{0}$. The precise form of their restriction, however, comes from the fact they wrote down a "natural" conjugate prior family for $f_{\boldsymbol{\Pi}}\left(\boldsymbol{\pi} \mid I_{\mathrm{C}}\right)$; if they had started with $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{C}}\right)$, they would have ended up with, in the present notation, $v^{0}+1=(t-1) n^{0} / 2$, which would also not satisfy desideratum 1.2. However, if we hadn't imposed the constraint $\sum_{i=1}^{t} \pi_{i}=1$ (which is clearly not invariant under $\pi_{i} \rightarrow 1 / \pi_{i}$ ) in the first place, the marginalization over $\sum_{k=1}^{t} \lambda_{k}$, would have rendered $v^{0}$ irrelevant and left us with

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{C}}\right) \propto\left(\prod_{i=1}^{t} \prod_{j=1}^{t}\left[1+e^{\gamma_{i j}}\right]\right)^{-n^{0} / 2} \tag{2.71}
\end{equation*}
$$

in any event. We therefore take (2.71) as the form of the conjugate prior $f_{\Gamma}\left(\gamma \mid I_{\mathrm{C}}\right)$, and note that if $n^{0}=2$, this reduces to the maximum entropy distribution (2.27) [see also (2.26)] considered in 2.2.2.

We can show that (2.71) violates desideratum 1.4 for any $n^{0} \in(0, \infty)$ by considering the prior predictive distribution and invoking Lemma 1.6. First, note that for $t=2$, (2.71) becomes

$$
\begin{equation*}
f_{\Gamma}\left(\gamma \mid I_{\mathrm{C} 2}\right) \propto\left(\left[1+e^{\gamma_{12}}\right]\left[1+e^{\gamma_{21}}\right]\right)^{-n^{0} / 2} \tag{2.72}
\end{equation*}
$$

which is just the beta/generalized logistic prior (2.7) with $\alpha=\beta=n^{0} / 2$. Therefore, if we define $D$ to be a set of results for which $w_{12}=1=w_{21}$, and let

$n_{12}=2$ and $n_{i 3}=0,(2.9)$ implies

$$
\begin{equation*}
p\left(D \mid \mathbf{n}, I_{\mathrm{C} 2}\right)=\frac{\Gamma\left(n^{0}\right) \Gamma\left(\frac{n^{0}}{2}+1\right) \Gamma\left(\frac{n^{0}}{2}+1\right)}{\Gamma\left(\frac{n^{0}}{2}\right) \Gamma\left(\frac{n^{0}}{2}\right) \Gamma\left(n^{0}+2\right)}=\frac{1}{4\left(1+\frac{1}{n^{0}}\right)} \tag{2.73}
\end{equation*}
$$

We evaluate $p\left(D \mid \mathbf{n}, I_{\mathrm{C} 3}\right)$ numerically for a range of $n^{0}$ values, plotted in Fig. 3, and find that for any $0<n^{0}<\infty, p\left(D \mid \mathbf{n}, I_{\mathrm{C} 3}\right)>p\left(D \mid \mathbf{n}, I_{\mathrm{C} 2}\right)$

### 2.2.6. Multivariate Gaussian Distribution

Leonard (1977) proposed a multivariate Gaussian prior on the $\left\{\lambda_{i}\right\}$ of the form

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{G}}\right) \propto \exp \left(-\frac{1}{2} \sum_{i=1}^{t} \sum_{j=1}^{t}\left(\lambda_{i}-\mu_{i}\right)\left[\sigma^{-2}\right]_{i j}\left(\lambda_{j}-\mu_{j}\right)\right) \tag{2.74}
\end{equation*}
$$

where $\left\{\left[\sigma^{-2}\right]_{i j}\right\}$ are the elements of the inverse of a positive semi-definite covariance matrix with elements $\left\{\left[\sigma^{2}\right]_{i j}\right\}$.

Desideratum 1.3 will be satisfied if the covariance matrix $\left\{\left[\sigma^{2}\right]_{i j}\right\}$ is positive definite, so that the prior is normalizable.

Desideratum 1.1 requires that all of the $\left\{\mu_{i}\right\}$ have the same value $\mu$, all of the variances $\left\{\left[\sigma^{2}\right]_{i i}\right\}$ have the same value $\sigma^{2}$, and all of the cross-covariances
$\left\{\left[\sigma^{2}\right]_{i j} \mid i \neq j\right\}$ have the same value $\rho \sigma^{2}$. In order for the matrix $\left\{\left[\sigma^{2}\right]_{i j}\right\}$ to be positive definite we must have $\sigma^{2}>0$ and $-\frac{1}{t-1}<\rho<1$.

These conditions guarantee that desideratum 1.2 is satisfied.
Since the distribution $f_{\Gamma}\left(\gamma \mid I_{\mathrm{G}}\right)$ is unchanged by the transformation $\lambda_{i} \rightarrow$ $\lambda_{i}-\mu$, we can assume without loss of generality that $\mu=0$. We are thus left with $\rho$ and $\sigma^{2}$ as the adjustable parameters of the distribution. However, if we make the transformation $\lambda_{i} \rightarrow \lambda_{i}+a \sum_{j=1}^{t} \lambda_{j}$, which leaves $f_{\Gamma}\left(\gamma \mid I_{\mathrm{G}}\right)$ unchanged, $f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{G}}\right)$ becomes a multivariate Gaussian with covariance matrix

$$
\begin{equation*}
\sigma^{2}\left[\rho+\delta_{i j}(1-\rho)+a(2+a t)(t+1-\rho)\right] \tag{2.75}
\end{equation*}
$$

if $a=-\frac{1}{t}\left(1+\sqrt{\frac{1-\rho}{t \rho+1-\rho}}\right)$ or $a=-\frac{1}{t}\left(1-\sqrt{\frac{1-\rho}{t \rho+1-\rho}}\right)$ the covariance matrix becomes diagonal, with a variance equal to $(1-\rho) \sigma^{2}$. Either value for $a$ is guaranteed to be real by the conditions on $\rho$ which ensure a positive definite correlation matrix. Thus $f_{\Gamma}\left(\gamma \mid I_{\mathrm{G}}\right)$ is equivalent to a product of independent Gaussian distributions for each $\lambda_{i}$. For simplicity, we refer to the variance of each of these distributions as $\sigma^{2}$ rather than $(1-\rho) \sigma^{2}$.

Since the prior $f_{\Gamma}\left(\gamma \mid I_{\mathrm{G}}\right)$ is equivalent to independent distributions on the $\left\{\lambda_{i}\right\}$, it is invariant under elimination of teams, and satisfies desideratum 1.4.

### 2.2.7. Separable Priors

Thus far, the only prior considered to satisfy all four of our desiderata is the Gaussian prior which is equivalent to

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}\left(\boldsymbol{\lambda} \mid I_{\mathrm{G}}\right)=\frac{1}{\left(2 \pi \sigma^{2}\right)^{t / 2}} \exp \left(-\sum_{i=1}^{t} \frac{\lambda_{i}^{2}}{2 \sigma^{2}}\right) \tag{2.76}
\end{equation*}
$$

This is an example of a separable prior of the form

$$
\begin{equation*}
f_{\boldsymbol{\Lambda}}(\boldsymbol{\lambda} \mid I)=\prod_{i=1}^{t} f_{\Lambda_{i}}\left(\boldsymbol{\lambda}_{i} \mid I\right) \tag{2.77}
\end{equation*}
$$

A prior of this form, which assigns prior pdfs to the strengths (or log-strengths) of the teams is guaranteed by its construction to satisfy desideratum 1.4 (invariance under team-elimination). It will also satisfy desideratum 1.1 (interchange) if the distributions for the different $\left\{\boldsymbol{\lambda}_{i}\right\}$ are identical $\left(f_{\Lambda_{i}}\left(\boldsymbol{\lambda}_{i} \mid I\right)=\right.$ $f_{\Lambda}\left(\boldsymbol{\lambda}_{i} \mid I\right)$ ), desideratum 1.2 (win-loss interchange) if the distribution $f_{\Lambda}\left(\boldsymbol{\lambda}_{i} \mid I\right)$ is even $\left(f_{\Lambda}\left(-\boldsymbol{\lambda}_{i} \mid I\right)=f_{\Lambda}\left(\boldsymbol{\lambda}_{i} \mid I\right)\right)$ and desideratum 1.3 (normalizable) if $f_{\Lambda}(-\boldsymbol{\lambda} \mid I)$ is a proper prior.

### 2.2.8. Beta-Separable Priors

One family of separable priors can be constructed by defining

$$
\begin{equation*}
\zeta_{i}=\frac{\pi_{i}}{1+\pi_{i}}=\left(1+e^{-\lambda_{i}}\right)^{-1} \tag{2.78}
\end{equation*}
$$

and assuming that $\zeta_{i}$ obeys a Beta distribution. Explicitly,

$$
\begin{equation*}
f_{\mathrm{Z}_{i}}\left(\zeta_{i} \mid I_{\mathrm{B}}\right) \propto \zeta_{i}^{\alpha_{i}-1}\left(1-\zeta_{i}\right)^{\beta_{i}-1} \tag{2.79}
\end{equation*}
$$

Since $\zeta_{i}=\operatorname{logistic}\left(\lambda_{i}\right)$, just as $\theta_{i j}=\operatorname{logistic}\left(\gamma_{i j}\right)$, the prior on $\lambda_{i}$ is a generalized logistic distribution of Type IV (Prentice, 1976; Nassar and Elmasry, 2012):

$$
\begin{equation*}
f_{\Lambda_{i}}\left(\lambda_{i} \mid I_{\mathrm{B}}\right) \propto\left(1+e^{-\lambda_{i}}\right)^{-\alpha_{i}}\left(1+e^{\lambda_{i}}\right)^{-\beta_{i}} \tag{2.80}
\end{equation*}
$$

To enforce desideratum 1.2, we require $\alpha_{i}=\beta_{i}$, and for desideratum 1.1, we require that all $\alpha_{i}$ and $\beta_{i}$ parameters are the same, $\alpha_{i}=\beta_{i}=\eta$, which makes the prior a generalized logistic distribution of Type III.

$$
\begin{equation*}
f_{\Lambda_{i}}\left(\lambda_{i} \mid I_{\mathrm{B}}\right) \propto\left(1+e^{-\lambda_{i}}\right)^{-\eta}\left(1+e^{\lambda_{i}}\right)^{-\eta} \tag{2.81}
\end{equation*}
$$

An appealing feature of Beta-separable prior is that its functional form is similar to the likelihood

$$
\begin{equation*}
p(D \mid \boldsymbol{\lambda})=\prod_{i=1}^{t} \prod_{j=i+1}^{t}\left(1+e^{-\gamma_{i j}}\right)^{-w_{i j}}\left(1+e^{\gamma_{i j}}\right)^{n_{i j}-w_{i j}} \tag{2.82}
\end{equation*}
$$

In particular, the posterior is proportional to the likelihood function which would arise by adding to the actual game results a set of "fictitious games" corresponding to $\eta$ wins and $\eta$ losses for each actual team against a fictitious team assumed to have a strength of 1 . So any method for obtaining maximum likelihood estimates such as that of Ford (1957) could be adapted to obtaining maximum a priori estimates with this prior. This method, with $\eta=\frac{1}{2}$, has been used by Buttler (1993) to ensure regularity of the estimates of Bradley-Terry strengths. Another "obvious" choice is $\eta=1$, which is equivalent to a uniform prior on $\zeta_{i}$. (The Haldane prior is $\eta=0$.)

## 3. Conclusions

We have considered various families of prior distributions for team strengths in the Bradley-Terry model. Motivated by the application of a Bayesian BradleyTerry model to rate teams based only on their game results, we have evaluated these priors according to the desiderata of invariance under interchange of teams (1.1), interchange of winning and losing (1.2) and elimination of irrelevant teams from the model (1.4), as well as normalizability (1.3). A Haldane-like prior of complete ignorance is not normalizable (violation of 1.3), although it satisfies the other desiderata. A prior based on maximum entropy arguments, as well as one from the conjugate family of Davidson and Solomon (1973) which is required to obey the other desiderata, will depend on the number of teams for which it was constructed (violation of 1.4). The same is true for the Jeffreys prior. A Dirichlet prior on the team strengths (Chen and Smith, 1984) can be made to satisfy the other desiderata, but will not be invariant under interchange of the definitions of winning and losing (violation of 1.2). Distributions can
be constructed which satisfy the desiderata by imposing independent priors on the strengths of all of the teams. In particular, a multivariate Gaussian in the log-strengths (Leonard, 1977) which satisfies the desiderata is equivalent to identical independent Gaussian priors on each of the log-strengths. Another simple family of separable prior distributions imposes independent generalized logistic distributions on the log-strengths. In each of these last two cases, a single parameter remains. Phelan and Whelan (2017) consider the relationship between the two, and propose a hierarchical method to estimate these parameters rather than assuming values for them.
