# The null hypothesis of common jumps in case of irregular and asynchronous observations

#### Abstract

This paper proposes novel tests for the absence of jumps in a univariate semimartingale and for the absence of common jumps in a bivariate semimartingale. Our methods rely on ratio statistics of power variations based on irregular observations, sampled at different frequencies. We develop central limit theorems for the statistics under the respective null hypotheses and apply bootstrap procedures to assess the limiting distributions. Further we define corrected statistics to improve the finite sample performance. Simulations show that the test based on our corrected statistic yields good results and even outperforms existing tests in the case of regular observations.

## 1 Introduction

A key issue of the statistical analysis in continuous time is to understand the fine structure of the underlying processes based on discrete observations. Tools are needed in order to answer fundamental questions about suitable models for these processes, and probably the most basic ones are concerned with whether the processes evolve continuously in time or exhibit jumps. Within the class of semimartingales several statistical tests on this topic have been proposed in recent years, both in one and in several (usually two) dimensions and under various null hypotheses. For an overview see for example Sections 11.4 and 15.3 in Jacod and Protter (2012) or Chapters 10 and 14 in Aït-Sahalia and Jacod (2014).

In this work we are interested in the null hypothesis that common jumps of a bivariate process exist. In fact this question was tackled and solved prominently in Jacod and Todorov (2009), but only under the additional assumption that observations come in at equidistant and synchronous times. Both assumptions are rarely justified in practice, which is why practitioners usually ignore a lot of observations (and then work with one-minute observations, for example) in order to artificially

[^0]construct a sampling scheme which is close enough to justify the assumptions of regularity. Both from a theoretical and a practical point of view this is unsatisfactory, and one would like to understand what happens when the underlying observations come in randomly at irregular and asynchronous times. This is precisely what we aim at in this paper, and our study complements the previous work Martin and Vetter (2017) in which a test for the presence of common jumps (so under the opposite null hypothesis of no common jumps) was constructed.

It has turned out that the construction of a test in two dimensions is difficult unless one properly understands the univariate situation. For this reason we provide two statistical procedures: First, we want to decide whether or not jumps are present in a realized path of a stochastic process in one dimension, based on discrete irregular observations of the process and under the null hypothesis that jumps exist. Second, we want to decide whether common jumps are present or not in two realized processes, based on irregular and asynchronous observations and under the null hypothesis that there exist common jumps. Thus, this work can not only be understood as a generalization of the results in Jacod and Todorov (2009), but it also complements the univariate discussion from Aït-Sahalia and Jacod (2009).

In the following let $\widetilde{X}$ be a one-dimensional process observed at times $\tilde{t}_{i, n}$ and let $X=\left(X^{(1)}, X^{(2)}\right)$ be a bivariate process where $X^{(l)}$ is observed at times $t_{i, n}^{(l)}, l=1,2$, all over the time interval $[0, T]$. Then for some $k \geq 2$ our tests are based on the ratio statistics

The common feature of both statistics is that they have a different asymptotic behaviour, depending on whether, for the first one, $\widetilde{X}$ has jumps in $[0, T]$ or not, or whether, for the second one, $X^{(1)}$ and $X^{(2)}$ have common jumps in $[0, T]$ or not. In this paper we investigate the asymptotics of these statistics both under the null hypothesis that (common) jumps are present and under the alternative that (common) jumps do not exist. We will see that the limits are similar in structure to those in the setting of equidistant observation times. Further we will develop central limit theorems using techniques from Bibinger and Vetter (2015) and Martin and Vetter (2017) for both statistics under the null hypothesis that (common) jumps are present. Unlike in the setting of equidistant observation times the limiting variables in the central limit theorem are not mixed normal but have a more complicated distribution. We use the bootstrap method introduced in Martin and Vetter (2017) to estimate the quantiles of this limit distribution and to construct a feasible testing procedure.

Finally we conduct a simulation study to check the finite sample performance of our tests. As in Martin and Vetter (2017) we use the models from Jacod and Todorov (2009) to compare our results with the results from similar tests in the setting of equidistant observations. Compared to these results we find that the finite
sample performance of our tests is rather poor, especially under the null hypothesis, which is due to a rather large contribution of terms which vanish asymptotically in the central limit theorem. To improve the performance of our tests we therefore construct an estimator which (partially) corrects for those asymptotically vanishing terms. Using this estimator we get a huge improvement in the performance of our tests. In particular, our results become even better than the corresponding results for the tests from Aït-Sahalia and Jacod (2009), Jacod and Todorov (2009) and Aït-Sahalia and Jacod (2014) in the setting of equidistant observation times.

The remainder of the paper is organized as follows: As the structure of the results and the formal arguments are simpler in the setting where we test for jumps in a onedimensional process we first derive in Section 2 two statistical tests for jumps within a stochastic process. The formal setting and the estimator $\Phi_{k, T, n}^{(J)}$ is introduced in Section 2.1. In Section 2.2 we derive the consistency of this estimator under both hypotheses, we cover the asymptotics of the estimator in the form of a central limit theorem in Section 2.3, and in Section 2.4 we use a bootstrap method to derive two feasible tests, one using the original statistic $\Phi_{k, T, n}^{(J)}$ and one using a corrected estimator $\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)$ based on the central limit theorem. Building on the results from Section 2 we proceed similarly in Section 3 to derive two statistical tests for deciding whether or not two processes jump at a common time. In Section 4 we examine the finite sample properties of the tests derived in Sections 2 and 3 by means of a simulation study. The appendix containing the proofs is split into two parts: Section 5 contains the main structure of the proofs, leaving out most technical arguments. Section 6, available online, contains all proofs in details and thus fills the gaps left in Section 5.

## 2 A test for the absence of jumps

In this section we will derive a statistical test based on high-frequency observations which allows to decide whether an observed path of a process contains jumps or not.

### 2.1 Settings and test statistic

First we specify the mathematical model for the process and the observation times. Let $X$ be a one-dimensional Itô semimartingale on the probability space $(\Omega, \mathcal{F}, \mathbb{P})$ of the form

Here, $W$ denotes a standard Brownian motion, $\mu$ is a Poisson random measure on $\mathbb{R}^{+} \times \mathbb{R}$ whose predictable compensator satisfies $\nu(d s, d z)=d s \otimes \lambda(d z)$ for some $\sigma$-finite measure $\lambda$ on $\mathbb{R}$ endowed with the Borelian $\sigma$-algebra, $b$ and $\sigma$ are adapted processes and $\delta$ is a predictable function on $\Omega \times \mathbb{R}^{+} \times \mathbb{R}$. For a more detailed discussion of the components of $X$ consult Section 2.1 of Jacod and Protter (2012). We write $\Delta X_{s}=X_{s}-X_{s-}$ with $X_{s-}=\lim _{t}{ }_{s} X_{t}$ for a possible jump of $X$ in $s$.

Further we define a sequence of observation schemes $\left(\pi_{n}\right)_{n \in \mathbb{N}}$ via

\pi_{n}=\left(t_{i, n}\right)_{i \in \mathbb{N}_{0}}, n \in \mathbb{N}
$$

where the $\left(t_{i, n}\right)_{i \in \mathbb{N}_{0}}$ are increasing sequences of stopping times with $t_{0, n}=0$. By

$$
\left|\pi_{n}\right|_{T}=\sup \left\{t_{i, n} \wedge T-t_{i-1, n} \wedge T \mid i \geq 1\right\}
$$

we denote the mesh of the observation times up to some fixed time horizon $T \geq 0$.
Formally we will develop a statistical test which allows to decide whether a realized path $X(\omega)$ contains jumps in a given time interval $[0, T]$ or not. Specifically we want to decide based on the observations $\left(X_{t_{i, n}}(\omega)\right)_{i \in \mathbb{N}_{0}}$ to which of the following two subsets of $\Omega$

$\omega$ belongs. Here, $\Omega_{T}^{(J)}$ is the set of all $\omega$ for which the path of $X$ up to $T$ has at least one jump and $\Omega_{T}^{(C)}$ is the set of all $\omega$ for which the path of $X$ is continuous on $[0, T]$.

All our test statistics are based on the increments

$$
\Delta_{i, k, n} X=X_{t_{i, n}}-X_{t_{i-k, n}}, \quad \Delta_{i, n} X=\Delta_{i, 1, n} X
$$

and we denote by $\mathcal{I}_{i, k, n}=\left(t_{i-k, n}, t_{i, n}\right], i \geq k \geq 1, \mathcal{I}_{i, n}=\mathcal{I}_{i, 1, n}$, the corresponding observation intervals. For convenience we set $\mathcal{I}_{i, k, n}=\emptyset$ and accordingly $\Delta_{i, k, n} X=0$ for $i<k$.

Further we define for $k \in \mathbb{N}$ and a function $h: \mathbb{R} \rightarrow \mathbb{R}$ the functionals

Considering these functionals for $g: x \mapsto x^{4}$ and $k \geq 2$ we build the statistic

$$
\Phi_{k, T, n}^{(J)}=\frac{V\left(g,[k], \pi_{n}\right)_{T}}{k V\left(g, \pi_{n}\right)_{T}}
$$

whose asymptotics we use to construct a statistical tests for the absence of jumps.
Remark 2.1. In the setting of equidistant observation times $t_{i, n}=i / n$ our statistic becomes

\Phi_{k, T, n}^{(J)}=\frac{\sum_{i=k}^{\lfloor n T\rfloor} g\left(\Delta_{i, k, n} X\right)}{k \sum_{i=1}^{\lfloor T / n\rfloor} g\left(\Delta_{i, n} X\right)} \tag{2.2}

On the other hand in Aït-Sahalia and Jacod (2009) a test is constructed based on the statistic

where at the lower observation frequency $n / k$ only increments over certain observation intervals $\mathcal{I}_{i k, k, n}$ enter the estimation. Intuitively it seems that using the statistic (2.2) should be better than using (2.3), because in (2.2) we utilize the available data more exhaustively by using all increments at the lower observation frequency. This intuition is confirmed by Proposition 10.19 in Ait-Sahalia and Jacod (2014) where central limit theorems are developed for both (2.2) and (2.3) and it is shown that (2.2) has a smaller asymptotic variance.

### 2.2 Consistency

In order to derive results on the asymptotic behaviour of $\Phi_{k, T, n}^{(J)}$ we need to impose certain structural assumptions on the Itô semimartingale $X$ and the observation scheme. Further we introduce the notation

and abbreviate $G_{n}(t)=G_{1, n}(t)$.
Condition 2.2. The process $b_{s}$ is locally bounded and the process $\sigma_{s}$ is càdlàg. Furthermore, there exists a locally bounded process $\Gamma_{s}$ with $|\delta(\omega, s, z)| \leq \Gamma_{s}(\omega) \gamma(z)$ for some deterministic bounded function $\gamma$ which satisfies $\int\left(\gamma(z)^{2} \wedge 1\right) \lambda(d z)<\infty$, and the process $\sigma$ fulfills $\int_{0}^{T}\left|\sigma_{s}\right| d s>0$ almost surely. Additionally the following assumptions on the observation scheme hold:
(i) The sequence of observation schemes $\left(\pi_{n}\right)_{n}$ is exogenous, i.e. independent of the process $X$ and its components, and fulfills

(ii) The functions $G_{n}(t), G_{k, n}(t)$ convergence pointwise on $[0, T]$ in probability to strictly increasing functions $G, G_{k}:[0, T] \rightarrow[0, \infty)$.

The structural assumptions on $b, \sigma, \delta$ are not very restrictive and occur elsewhere in the literature in similar form. The assumption that $\sigma$ almost surely does not vanish on $[0, T]$ and Condition 2.2 (ii) are only needed to derive the asymptotic behaviour of $\Phi_{k, T, n}^{(J)}$ on $\Omega_{T}^{(C)}$. $\Phi_{k, T, n}^{(J)}$ converges on $\Omega_{T}^{(J)}$ also without these assumptions.

We will see in the proof of Theorem 2.3 that

which yields the asymptotic behaviour of $\Phi_{k, T, n}^{(J)}$ on $\Omega_{T}^{(J)}$. On $\Omega_{T}^{(C)}$ we have $B_{T}^{(J)}=0$ and we expand the fraction by $n$ to get an asymptotic result. To describe the limit in that case we define

C_{T}^{(J)}=\int_{0}^{T} 3 \sigma_{s}^{4} d G(s), \quad C_{k, T}^{(J)}=\int_{0}^{T} 3 \sigma_{s}^{4} d G_{k}(s) .
$$

Theorem 2.3. Under Condition 2.2 it holds

\Phi_{k, T, n}^{(J)} \xrightarrow{\mathbb{P}} \begin{cases}1, & \text { on } \Omega_{T}^{(J)},  \tag{2.4}\\ \frac{k C_{k, T}^{(J)}}{C_{T}^{(J)}}, & \text { on } \Omega_{T}^{(C)} .\end{cases}
$$

Remark 2.4. We obtain

G_{n}(t)-G_{n}(s)+O\left(\left|\pi_{n}\right|_{t}\right) \leq k G_{k, n}(t)-k G_{k, n}(s) \leq k G_{n}(t)-k G_{n}(s)
$$

for all $t \geq s \geq 0$ from the series of elementary inequalities

$$
\begin{equation*}
\sum_{i=1}^{k} a_{i}^{2} \leq\left(\sum_{i=1}^{k} a_{i}\right)^{2} \leq k \sum_{i=1}^{k} a_{i}^{2} \tag{2.5}
\end{equation*}

which holds for any $a_{1}, \ldots, a_{k} \geq 0, k \in \mathbb{N}$. Here, the second inequality follows from the Cauchy-Schwarz inequality. Equality in (2.5) holds for $a_{1} \geq 0, a_{2}=\ldots=a_{k}=0$ respectively $a_{1}=\ldots=a_{k}>0$. The relations of $G_{n}$ and $G_{k, n}$ are preserved in the limit which yields

G(t)-G(s) \leq k G_{k}(t)-k G_{k}(s) \leq k G(t)-k G(s)
$$

for all $t \geq s \geq 0$. Hence we get

\frac{k C_{k, T}^{(J)}}{C_{T}^{(J)}} \in[1, k]

Based on the fact that $\Phi_{k, T, n}^{(J)} \xrightarrow{\mathbb{P}} 1$ on $\Omega_{T}^{(J)}$ and that $\Phi_{k, T, n}^{(J)}$ converges on $\Omega_{T}^{(C)}$ to a random variable which is strictly greater than 1 if $k C_{k, T}^{(J)}>C_{T}^{(J)}$ by Remark 2.4, we will construct a test with critical region

for an appropriate series of decreasing random positive numbers $c_{k, T, n}^{(J)}, n \in \mathbb{N}$.
In the following we illustrate the result from Theorem 2.3 by looking at two prominent observation schemes: first Poisson sampling which is truely random and asynchronous and second equidistant sampling for which results exist in the literature and which will serve as a kind of benchmark.

Example 2.5. Consider the observation scheme where $t_{i, n}-t_{i-1, n}$ are i.i.d. $\operatorname{Exp}(n \lambda)$, $\lambda>0$, distributed. We will call this observation scheme Poisson sampling as the observation times $t_{i, n}$ correspond to the jump times of a Poisson process with intensity $n \lambda$. In this setting Condition 2.2 (ii) is fulfilled as shown in Proposition 1 from Hayashi and Yoshida (2008) with

G(t)=\frac{2}{\lambda} t
$$

and as proved in Section 6.3 with

$$
\begin{equation*}
G_{k}(t)=\frac{k+1}{k \lambda} t . \tag{2.7}
\end{equation*}

This yields that the limit under the alternative is $(k+1) / 2$.

Remark 2.6. In the case of equidistant synchronous observations, i.e. $t_{i, n}=i / n$, it holds $G(t)=G_{k, n}(t)=t$ which yields

Hence in this setting $\Phi_{k, T, n}^{(J)}$ converges to a known deterministic limit on $\Omega_{T}^{(C)}$ as well which also allows to construct a test using $\Phi_{k, T, n}^{(J)}$ for the null hypothesis of no jumps (compare Section 10.3 in Ait-Sahalia and Jacod (2014)). This is not immediately possible in the irregular setting, unless the law of the generating mechanism is known to the statistician.

### 2.3 Central limit theorem

In this section we derive a central limit theorem for $\Phi_{k, T, n}^{(J)}$ which holds on $\Omega_{T}^{(J)}$. Denote by $i_{n}(s)$ the index of the interval $\mathcal{I}_{i, n}$ associated with $s \in \mathcal{I}_{i, n}$ and define

\xi_{k, n,-}(s)=n \sum_{j=1}^{k-1}(k-j)^{2}\left|\mathcal{I}_{i_{n}(s)-j, 1, n}\right|, \quad \xi_{k, n,+}(s)=n \sum_{j=1}^{k-1}(k-j)^{2}\left|\mathcal{I}_{i_{n}(s)+j, 1, n}\right| .
$$

$\xi_{k, n,-}(s)+\xi_{k, n,+}(s)$ is the $\sigma\left(\pi_{n}: n \in \mathbb{N}\right)$-conditional variance of

n \sum_{j=-(k-1), j \neq 0}^{k-1}|k-j| \Delta_{i_{n}(s)+j, 1, n} W=n \sum_{j=0}^{k-1} \Delta_{i_{n}(s)+j, k, n} W-n k \Delta_{i_{n}(s), 1, n} W .

This identity is illustrated in Figure 1.
The following condition summarizes the assumptions we need additionally to Condition 2.2 to derive a central limit theorem.

Condition 2.7. The process $X$ and the sequence of observation schemes $\left(\pi_{n}\right)_{n}$ fulfill Condition 2.2. Further the following additional assumptions on the observation schemes hold:
(i) We have

(ii) The integral

\int_{[0, T]^{P}} g\left(x_{1}, \ldots, x_{P}\right) \mathbb{E}\left[\prod_{p=1}^{P} h_{p}\left(\xi_{k, n,-}\left(x_{p}\right), \xi_{k, n,+}\left(x_{p}\right)\right)\right] d x_{1} \ldots d x_{P}
$$

converges for $n \rightarrow \infty$ to

$$
\int_{[0, T]^{P}} g\left(x_{1}, \ldots, x_{P}\right) \prod_{p=1}^{P} \int_{\mathbb{R}} h_{p}(y) \Gamma\left(x_{p}, d y\right) d x_{1} \ldots d x_{P}
$$

for all bounded continuous functions $g: \mathbb{R}^{P} \rightarrow \mathbb{R}, h_{p}: \mathbb{R}^{2} \rightarrow \mathbb{R}, p=1, \ldots, P$, and any $P \in \mathbb{N}$. Here $\Gamma(\cdot, d y)$ is a family of probability measures on $[0, T]$ with uniformly bounded first moments and $\int_{0}^{T} \Gamma(x,\{(0,0)\}) d x=0$.

Part (i) of Condition 2.7 guarantees that $\left|\pi_{n}\right|_{T}$ vanishes sufficiently fast, while part (ii) of 2.7 yields that the $\left(\xi_{k, n,-}(s), \xi_{k, n,+}(s)\right)$ converge in law in a suitable sense.

Because of the exogeneity of the observation times we may assume in the following that the probability space has the form

(\Omega, \mathcal{F}, \mathbb{P})=\left(\Omega_{\mathcal{X}} \times \Omega_{\mathcal{S}}, \mathcal{X} \otimes \mathcal{S}, \mathbb{P}_{\mathcal{X}} \otimes \mathbb{P}_{\mathcal{S}}\right) \tag{2.9}
\end{equation*}
$$

where $\mathcal{X}$ denotes the $\sigma$-algebra generated by $X$ and its components and $\mathcal{S}$ denotes the $\sigma$-algebra generated by the observation scheme $\left(\pi_{n}\right)_{n}$.

To describe the limit in the upcoming central limit theorem we define

$$
\begin{equation*}
F_{k, T}^{(J)}=4 \sum_{p: S_{p} \leq T}\left(\Delta X_{S_{p}}\right)^{3} \sqrt{\left(\sigma_{S_{p}-}\right)^{2} \xi_{k,-}\left(S_{p}\right)+\left(\sigma_{S_{p}}\right)^{2} \xi_{k,+}\left(S_{p}\right)} U_{S_{p}} . \tag{2.10}
\end{equation*}
$$

Here, $\left(S_{p}\right)_{p \geq 0}$ denotes an enumeration of the jump times of $X$ and the $\left(\xi_{k,-}(s), \xi_{k,+}(s)\right)$, $s \in[0, T]$, are independent random variables which are distributed according to $\Gamma(s, d y)$ and the $U_{s}, s \in[0, T]$, are i.i.d. standard normal distributed random variables. Both the $\left(\xi_{k,-}(s), \xi_{k,+}(s)\right)$ and the $U_{s}$ are independent of $X$ and its components and defined on an extended probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$. Note that $F_{k, T}^{(J)}$ is well-defined because the sum in (2.10) is almost surely absolutely convergent and independent of the choice for the enumeration $\left(S_{p}\right)_{p \geq 0}$; compare Proposition 4.1.3 in Jacod and Protter (2012).

Theorem 2.8. If Condition 2.7 holds, we have the $\mathcal{X}$-stable convergence

\sqrt{n}\left(\Phi_{k, T, n}^{(J)}-1\right) \xrightarrow{\mathcal{L}-\mathcal{s}} \frac{F_{k, T}^{(J)}}{k B_{T}^{(J)}} \tag{2.11}

on $\Omega_{T}^{(J)}$.
Here, the limit $F_{k, T}^{(J)} /\left(k B_{T}^{(J)}\right)$ in (2.11) is defined on the extended probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$. Further the statement of the $\mathcal{X}$-stable convergence on $\Omega_{T}^{(J)}$ means that we have

$$
\mathbb{E}\left[g\left(\sqrt{n}\left(\Phi_{k, T, n}^{(J)}-1\right)\right) Y \mathbb{1}_{\Omega_{T}^{(J)}}\right] \rightarrow \widetilde{\mathbb{E}}\left[g\left(F_{k, T}^{(J)} /\left(k B_{T}^{(J)}\right)\right) Y \mathbb{1}_{\Omega_{T}^{(J)}}\right]

for all bounded and continuous functions $g$ and all $\mathcal{X}$-measurable bounded random variables $Y$. For more background information on stable convergence in law we refer to Jacod and Protter (2012), Jacod and Shiryaev (2002) and Podolskij and Vetter (2010).

Example 2.9. Condition 2.7 is fulfilled in the setting of Poisson sampling introduced in Example 2.5. Part (i) is fulfilled by Lemma 8 from Hayashi and Yoshida (2008) which states

for all $q \geq 1$ and $\alpha<q$. That 2.7(ii) is fulfilled is proved in Section 6.3.1.

### 2.4 Testing procedure

In this section we develop a statistical test for testing the null hypothesis that $t \mapsto X_{t}(\omega)$ has jumps in $[0, T]$ (i.e. $\omega \in \Omega_{T}^{(J)}$ ) against the alternative that $t \mapsto X_{t}(\omega)$ is continuous on $[0, T]$ (i.e. $\omega \in \Omega_{T}^{(C)}$ ). To employ Theorem 2.8 for this purpose we have to estimate the distribution of the limiting variable $F_{k, T}^{(J)}$ and therefore the distribution of $\xi_{k}\left(S_{p}\right)$ for the jump times $S_{p}$. Because the distribution of $\xi_{k}\left(S_{p}\right)$ depends on the unknown observation scheme around $S_{p}$, of which we observe only a single realization, we use a bootstrap method to estimate the distribution from the realization of the observation scheme close to $S_{p}$. For this method to work we need some sort of local homogeneity which will be guaranteed by Condition 3.11(i).

To formalize the bootstrap method let $L_{n}$ and $M_{n}$ be sequences of natural numbers which tend to infinity. Set

for $m=1, \ldots, M_{n}$ where the random variable $V_{n, m}(s)$ attains values in $\left\{-L_{n}, \ldots, L_{n}\right\}$ with probabilities

\begin{equation*}
\mathbb{P}\left(V_{n, m}(s)=l \mid \mathcal{S}\right)=\left|\mathcal{I}_{i_{n}(s)+l, n}\right|\left(\sum_{j=-L_{n}}^{L_{n}}\left|\mathcal{I}_{i_{n}(s)+j, n}\right|\right)^{-1}, l \in\left\{-L_{n}, \ldots, L_{n}\right\} \tag{2.14}
\end{equation*}
$$

Here, $\left(\hat{\xi}_{k, n, m,-}(s), \hat{\xi}_{k, n, m,-}(s)\right)$ is chosen from the $\left(\xi_{k, n,-}\left(t_{i_{n}(s)+i, n}\right), \xi_{k, n,-}\left(t_{i_{n}(s)+i, n}\right)\right)$, $i=-L_{n}, \ldots, L_{n}$, which make up the $2 L_{n}+1$ realizations of $\left(\hat{\xi}_{k, n,-}(t), \hat{\xi}_{k, n,-}(t)\right)$ which lie 'closest' to $s$, with probability proportional to the interval length $\left|\mathcal{I}_{i_{n}(s)+i, n}\right|$. This corresponds to the probability with which a random variable which is uniformly distributed on the union of these intervals $\mathcal{I}_{i_{n}(s)+i, n}, i=-L_{n}, \ldots, L_{n}$, but otherwise independent from the observation scheme would fall into the interval $\mathcal{I}_{i_{n}(s)+i, n}$. Due to the structure of the predictable compensator $\nu$ the jump times $S_{p}$ of the Itô semimartingale $X$ are also evenly distributed in time. This explains why we choose such a random variable $V_{n, m}(s)$ for the estimation of the law of $\left(\hat{\xi}_{k, n, m,-}\left(S_{p}\right), \hat{\xi}_{k, n, m,-}\left(S_{p}\right)\right)$.

Using the estimators (2.13) for realizations of $\xi_{k}(s)$ we build the following estimators for realizations of $F_{k, T}^{(J)}$

& \widehat{F}_{k, T, n, m}^{(J)}=4 \sum_{i: t_{i, n} \leq T}\left(\Delta_{i, n} X\right)^{3} \mathbb{1}_{\left\{\left|\Delta_{i, n} X\right|>\beta\left|\mathcal{I}_{i, n}\right|^{\infty}\right\}} \\
& \quad \times \sqrt{\left(\hat{\sigma}_{n}\left(t_{i, n},-\right)\right)^{2} \hat{\xi}_{k, n, m,-}\left(t_{i, n}\right)+\left(\hat{\sigma}_{n}\left(t_{i, n},+\right)\right)^{2} \hat{\xi}_{k, n, m,+}\left(t_{i, n}\right)} U_{n, i, m}, \tag{2.15}
\end{align*}
$$

$m=1, \ldots, M_{n}$, where $\beta>0$ and $\varpi \in(0,1 / 2)$. Here an increment which is large compared to a given threshold is identified as a jump and the local volatility is estimated by

$$
\begin{align*}
& \left(\hat{\sigma}_{n}(s,-)\right)^{2}=\frac{1}{b_{n}} \sum_{i: \mathcal{I}_{i, n} \subset\left[s-b_{n}, s\right)}\left(\Delta_{i, n} X\right)^{2}, \\
& \left(\hat{\sigma}_{n}(s,+)\right)^{2}=\frac{1}{b_{n}} \sum_{i: \mathcal{I}_{i, n} \subset\left[s, s+b_{n}\right]}\left(\Delta_{i, n} X\right)^{2} \tag{2.16}
\end{align*}
$$

for a sequence $\left(b_{n}\right)_{n}$ with $b_{n} \rightarrow 0$ and $\left|\pi_{n}\right|_{T} / b_{n} \rightarrow 0$. Further the $U_{n, i, m}$ are i.i.d. standard normal distributed random variables which are independent of $\mathcal{F}$ and defined on the extended probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$.

Denote by

$$
\widehat{Q}_{k, T, n}^{(J)}(\alpha)=\widehat{Q}_{\alpha}\left(\left\{\widehat{F}_{k, T, n, m}^{(J)} \mid m=1, \ldots, M_{n}\right\}\right)
$$

the $\left\lfloor\alpha M_{n}\right\rfloor$-th largest element of the set $\left\{\widehat{F}_{k, T, n, m}^{(J)} \mid m=1, \ldots, M_{n}\right\}$.
We will see that $\widehat{Q}_{k, T, n}^{(J)}(\alpha)$ converges on $\Omega_{T}^{(J)}$ under appropriate conditions to the $\mathcal{X}$-conditional $\alpha$-quantile $Q_{k}^{(J)}(\alpha)$ of $F_{k, T}^{(J)}$ which is defined via

\widetilde{\mathbb{P}}\left(F_{k, T}^{(J)} \leq Q_{k}^{(J)}(\alpha) \mid \mathcal{X}\right)(\omega)=\alpha, \quad \omega \in \Omega_{T}^{(J)} \tag{2.17}

and we set $\left(Q_{k}^{(J)}(\alpha)\right)(\omega)=0, \omega \in\left(\Omega_{T}^{(J)}\right)^{c}$. Such a random variable $Q_{k}^{(J)}(\alpha)$ exists if Condition 2.10 is fulfilled because the $\mathcal{X}$-conditional distribution of $F_{k, T}^{(J)}$ will be almost surely continuous on $\Omega_{T}^{(J)}$ under Condition 2.10.

Condition 2.10. Assume that the process $X$ and the sequence of observation schemes $\left(\pi_{n}\right)_{n}$ satisfy Condition 2.7 and that the set $\left\{s \in[0, T]: \sigma_{s}=0\right\}$ is almost surely a Lebesgue null set. Further, let the sequence $\left(b_{n}\right)_{n}$ fulfill $\left|\pi_{n}\right|_{T} / b_{n} \xrightarrow{\mathbb{P}} 0$ and suppose that $\left(L_{n}\right)_{n}$ and $\left(M_{n}\right)_{n}$ are sequences of natural numbers converging to infinity and $L_{n} / n \rightarrow 0$. Additionally,
(i)

$$
\begin{aligned}
\widetilde{\mathbb{P}}\left(\mid \widetilde{\mathbb{P}}\left(\left(\hat{\xi}_{k, n, 1,-}\left(s_{p}\right), \hat{\xi}_{k, n, 1,+}\left(s_{p}\right)\right)\right.\right. & \left.\leq x_{p}, p=1, \ldots, P \mid \mathcal{S}\right) \\
& \left.-\prod_{p=1}^{P} \widetilde{\mathbb{P}}\left(\left(\xi_{k,-}\left(s_{p}\right), \xi_{k,+}\left(s_{p}\right)\right) \leq x_{p}\right) \mid>\varepsilon\right) \rightarrow 0
\end{aligned}
$$

as $n \rightarrow \infty$, for all $\varepsilon>0$ and any $x \in \mathbb{R}^{2 \times P}, P \in \mathbb{N}$, and $s_{p} \in(0, T)$, $p=1, \ldots, P$.
(ii) The volatility process $\sigma$ is itself an Itô semimartingale, i.e. a process of the form (2.1).
(iii) On $\Omega_{T}^{(C)}$ we have $k C_{k, T}^{(J)}>C_{T}^{(J)}$ almost surely.

Part (i) of Condition 2.10 guarantees that the bootstrapped realizations

$$
\left(\hat{\xi}_{k, n, m,-}(s), \hat{\xi}_{k, n, m,+}(s)\right)
$$

consistently estimate the distribution of $\left(\xi_{k,-}(s), \xi_{k,+}(s)\right)$ and thereby that $\widehat{Q}_{k, T, n}^{(J)}(\alpha)$ yields a valid estimator for $Q_{k}^{(J)}(\alpha)$ on $\Omega_{T}^{(J)}$. Part (ii) is needed for the convergence of the volatility estimators $\hat{\sigma}_{n}\left(S_{p},-\right), \hat{\sigma}_{n}\left(S_{p},+\right)$ for jump times $S_{p}$, and part (iii) guarantees that $\Phi_{k, T, n}^{(J)}$ converges under the alternative to a value different from 1 , which is the limit under the null hypothesis.

Theorem 2.11. If Condition 2.10 is fulfilled, the test defined in (2.6) with

has asymptotic level $\alpha$ in the sense that we have

\end{equation*}

for all $F^{(J)} \subset \Omega_{T}^{(J)}$ with $\mathbb{P}\left(F^{(J)}\right)>0$.
The test is consistent in the sense that we have

$$
\begin{equation*}
\widetilde{\mathbb{P}}\left(\Phi_{k, T, n}^{(J)}>1+c_{k, T, n}^{(J)} \mid F^{(C)}\right) \rightarrow 1 \tag{2.20}
\end{equation*}
$$

for all $F^{(C)} \subset \Omega_{T}^{(C)}$ with $\mathbb{P}\left(F^{(C)}\right)>0$.

Note that to carry out the test introduced in Theorem 2.11 the unobservable variable $n$ is not explicitly needed, even though $\sqrt{n}$ occurs in the definition of $c_{k, T, n}^{(J)}$. This factor actually cancels as it also enters as a linear factor in $\widehat{Q}_{k, T, n}^{(J)}(1-\alpha)$. What remains is the dependence of $b_{n}$ and $L_{n}$ on $n$, though, but for these auxiliary variables only a rough idea of the magnitude of $n$ usually is sufficient. Similar observations hold for all tests constructed later on as well.

The simulation results in Section 4.1 show that the convergence in (2.19) is rather slow, because certain terms in $\sqrt{n}\left(\Phi_{k, T, n}^{(J)}-1\right)$ which vanish in the limit contribute significantly in the small sample. Our goal is to diminish this effect by including estimates for those terms in the testing procedure. The asymptotically vanishing terms stem from the continuous part which is mostly captured in the small increments. To estimate their contribution we define

A_{k, T, n}^{(J)}=n & \sum_{i \geq k: t_{i, n} \leq T}\left(\Delta_{i, k, n} X\right)^{4} \mathbb{1}_{\left\{\left.\left|\Delta_{i, k, n} X \leq \beta\right| \mathcal{I}_{i, k, n}\right|^{\varpi}\right\}} \\
& -k n \sum_{i \geq 1: t_{i, n} \leq T}\left(\Delta_{i, n} X\right)^{4} \mathbb{1}_{\left\{\left|\Delta_{i, n} X\right| \leq \beta\left|\mathcal{I}_{i, n}^{(l)}\right|^{\varpi}\right\}}
\end{aligned}
$$

using the same $\beta, \varpi$ as in (2.15). It can be shown that $A_{k, T, n}^{(J)}$ is a consistent estimator for $k^{2} C_{k, T}^{(J)}-k C_{1, T}^{(J)}$. We then define for $\rho \in(0,1)$ the adjusted estimator

where we partially correct for the contribution of the asymptotically vanishing terms.

Corollary 2.12. Let $\rho \in(0,1)$. If Condition 2.10 is fulfilled, it holds with the notation from Theorem 2.11

for all $F^{(J)} \subset \Omega_{T}^{(J)}$ with $\mathbb{P}\left(F^{(J)}\right)>0$ and

\widetilde{\mathbb{P}}\left(\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)>1+c_{k, T, n}^{(J)} \mid F^{(C)}\right) \rightarrow 1 \tag{2.22}
\end{equation*}
$$

for all $F^{(C)} \subset \Omega_{T}^{(C)}$ with $\mathbb{P}\left(F^{(C)}\right)>0$.
The closer $\rho$ is to 1 the faster is the convergence in (2.21), but also the slower is the convergence in (2.22). Hence an optimal $\rho$ should be chosen somewhere in between. Our simulation results in Section 4.1 show that it is possible to pick a $\rho$ very close to 1 without significantly worsening the power compared to the test from Theorem 2.11.

Example 2.13. The assumptions on the observation scheme in Condition 2.10 are fulfilled in the Poisson setting. That part (iii) is fulfilled has been shown in Example 2.5 and that part (i) is fulfilled is proved in Section 6.3.2.

In fact for our testing procedure to work in the Poisson setting we do not need the weighting from (2.14). All intervals could also be picked with equal probability. This is due to the fact that the interval lengths $\left(n\left|\mathcal{I}_{i_{n}(s)+V_{n, m}(s)+j, n}\right|\right)_{j=-(k-1), \ldots,-1,1, \ldots, k-1}$ and hence $\xi_{k, n, m,-}(s), \xi_{k, n, m,+}(s)$ are (asymptotically) independent of $n\left|\mathcal{I}_{i_{n}(s)+V_{n, m}(s), n}\right|$. However the weighting is important if the interval lengths of consecutive intervals are dependent as illustrated in the following example.

Example 2.14. Define an observation scheme by $t_{2 i, n}=2 i / n$ and $t_{2 i+1, n}=(2 i+$ $1+\alpha) / n, i \in \mathbb{N}_{0}$, with $\alpha \in(0,1)$ (compare Example 33 in Bibinger and Vetter (2015)). Let us consider the case $k=2$. The observation scheme is illustrated in Figure 2. It can be easily checked that Condition 2.2 holds with $G(t)=\left(1+\alpha^{2}\right) t$ and $G_{2}(t)=t$. Further it can be shown similarly as in Bibinger and Vetter (2015) that Condition 2.7 is fulfilled for $\Gamma$ defined via

$$
\Gamma(s,\{(1+\alpha, 1+\alpha)\})=\frac{1-\alpha}{2}, \quad \Gamma(s,\{(1-\alpha, 1-\alpha)\})=\frac{1+\alpha}{2}
$$

for all $s>0$. Hence in order for the distribution of $\hat{\xi}_{k, n, 1}(s)$ to approximate $\Gamma(s, \cdot)$ the variable $i_{n}(s)+V_{n, m}(s)$ has to pick the intervals of length $(1+\alpha) / n$ with higher probability than those with length $(1-\alpha) / n$, because it holds

& n\left|\mathcal{I}_{i_{n}(s)+V_{n, m}(s), n}\right|=1+\alpha \Rightarrow \hat{\xi}_{2, n, m,-}(s)=\hat{\xi}_{2, n, m,+}(s)=1-\alpha \\
& n\left|\mathcal{I}_{i_{n}(s)+V_{n, m}(s), n}\right|=1-\alpha \Rightarrow \hat{\xi}_{2, n, m,-}(s)=\hat{\xi}_{2, n, m,+}(s)=1+\alpha
\end{aligned}

## 3 A test for the absence of common jumps

In this section we will derive a statistical test based on high-frequency observations which allows to decide whether two processes jump at a common time or not. The methods we use are similar to those in Section 2. However, the form of the occuring variables and the proofs will be different because of special effects due to the asynchronicity of the data.

### 3.1 Settings and test statistic

As a model for the stochastic process we again consider an Itô semimartingale $X=\left(X^{(1)}, X^{(2)}\right)^{*}$, which is now two-dimensional, defined on the probability space $(\Omega, \mathcal{F}, \mathbb{P})$ and of the form

\begin{align*}
X_{t}=X_{0}+\int_{0}^{t} b_{s} d s+\int_{0}^{t} \sigma_{s} d W_{s}+\int_{0}^{t} \int_{\mathbb{R}^{2}} & \delta(s, z) \mathbb{1}_{\{\|\delta(s, z)\| \leq 1\}}(\mu-\nu)(d s, d z) \\
& +\int_{0}^{t} \int_{\mathbb{R}^{2}} \delta(s, z) \mathbb{1}_{\{\|\delta(s, z)\|>1\}} \mu(d s, d z), \tag{3.1}
\end{align*}
$$

where $W=\left(W^{(1)}, W^{(2)}\right)^{*}$ is a two-dimensional standard Brownian motion and $\mu$ is a Poisson random measure on $\mathbb{R}^{+} \times \mathbb{R}^{2}$ whose predictable compensator satisfies $\nu(d s, d z)=d s \otimes \lambda(d z)$ for some $\sigma$-finite measure $\lambda$ on $\mathbb{R}^{2}$ endowed with the Borelian $\sigma$-algebra. $b$ is a two-dimensional adapted process,

\sigma_{s}=\left(\begin{array}{cc}
\sigma_{s}^{(1)} & 0  \tag{3.2}\\
\rho_{s} \sigma_{s}^{(2)} & \sqrt{1-\rho_{s}^{2}} \sigma_{s}^{(2)}

is a $(2 \times 2)$-dimensional process and $\delta$ is a two-dimensional predictable process on $\Omega \times \mathbb{R}^{+} \times \mathbb{R}^{2} . \sigma_{s}^{(1)}, \sigma_{s}^{(2)} \geq 0$ and $\rho_{s} \in[-1,1]$ are all univariate adapted.

The observation scheme

$$
\begin{equation*}
\pi_{n}=\left\{\left(t_{i, n}^{(1)}\right)_{i \in \mathbb{N}_{0}},\left(t_{i, n}^{(2)}\right)_{i \in \mathbb{N}_{0}}\right\}, n \in \mathbb{N}, \tag{3.3}
\end{equation*}
$$

here consists of two (in general different) increasing sequences of stopping times $\left(t_{i, n}^{(l)}\right)_{i \in \mathbb{N}_{0}}, l=1,2$, with $t_{0, n}^{(l)}=0$. By

\left|\pi_{n}\right|_{T}=\sup \left\{t_{i, n}^{(l)} \wedge T-t_{i-1, n}^{(l)} \wedge T \mid i \geq 1, l=1,2\right\}
$$

we again denote the mesh of the observation times up to $T \geq 0$.

Formally we will develop a statistical test which allows to decide to which of the following two subsets of $\Omega$ the $\omega$ which generated the observed path $t \mapsto X_{t}(\omega)$ belongs

& \Omega_{T}^{(C o J)}=\left\{\exists t \in[0, T]: \Delta X_{t}^{(1)} \Delta X_{t}^{(2)} \neq 0\right\}, \\

Further we define the following functionals for $k \in \mathbb{N}$ and $h: \mathbb{R}^{2} \rightarrow \mathbb{R}$

which are generalizations of the famous estimator for the quadratic covariation based on asynchronous observations from Hayashi and Yoshida (2005). Computing these functionals for $f:\left(x_{1}, x_{2}\right) \mapsto\left(x_{1} x_{2}\right)^{2}$ we build the statistic

Remark 3.1. In the setting of equidistant observation times $t_{i, n}^{(l)}=i / n, l=1,2$, the statistic $\Phi_{k, T, n}^{(C o J)}$ is equal to

where at the lower observation frequency $n / k$ only increments over the intervals $\mathcal{I}_{k i, k, n}^{(l)}, l=1,2$, enter the estimation. Further in Section 14.1 of Aït-Sahalia and Jacod (2014) a test for common jumps based on

is discussed. As argued in Remark 2.1 it seems advantegeous to use the statistic (3.6) over (3.5). However, in the asynchronous setting it is a priori not clear which observation intervals should be best paired, because there is no one-to-one correspondence of observation intervals in one process to observation intervals in the other process as there is in the synchronous situation. To use the available data as exhaustively as possible we therefore decided to include products of squared increments over all overlapping observation intervals at the lower observation frequency in the numerator of $\Phi_{k, T, n}^{(C o J)}$.

### 3.2 Consistency

In this section we investigate under which conditions $\Phi_{k, T, n}^{(C o J)}$ converges to a certain limit. The following structural assumptions which are similar to those in Condition 2.2 are needed to obtain an asymptotic result for $\Phi_{k, T, n}^{(C o J)}$ on $\Omega_{T}^{(C o J)}$.

Condition 3.2. The process $b_{s}$ is locally bounded and the processes $\sigma_{s}^{(1)}, \sigma_{s}^{(2)}, \rho_{s}$ are càdlàg. Furthermore, there exists a locally bounded process $\Gamma_{s}$ and a deterministic bounded function $\gamma$ which satisfies $\int\left(\gamma(z)^{2} \wedge 1\right) \lambda(d z)<\infty$ such that $\|\delta(\omega, s, z)\| \leq \Gamma_{s}(\omega) \gamma(z)$. The sequence of observation schemes $\left(\pi_{n}\right)_{n}$ fulfills

The random variables $U_{-}(s), U_{+}(s)$ are i.i.d. standard normal and defined on $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ as well. They are also independent of $\mathcal{F}$ and of $\left(\Lambda^{(l)}(s), \Lambda_{k}^{(l)}(s)\right)$.

From Theorem 3.3 we know that $\Phi_{k, T, n}^{(C o J)}$ converges to 1 under the null hypothesis and from Theorem 3.5 we can conclude that $\Phi_{k, T, n}^{(C o J)}$ converges under the alternative to a limit which is almost surely different from 1 if $k C_{k, T}^{(C o J)} \neq C_{1, T}^{(C o J)}$, or under mild additional conditions if there is at least one jump in one of the components of $X$ on $[0, T]$. Indeed if we have $k C_{k, T}^{(C o J)} \neq C_{1, T}^{(C o J)}, \Phi_{k, T, n}^{(C o J)}$ has to be different from 1 because $C_{k, T}^{(C o J)}, C_{1, T}^{(C o J)}$ are $\mathcal{F}$-conditionally constant and $D_{k, T}^{(C o J)}$ and $D_{1, T}^{(C o J)}$ are either zero or their $\mathcal{F}$-conditional distributions admit densities. If $k C_{k, T}^{(C o J)}=C_{1, T}^{(C o J)}$ holds mild conditions guarantee $D_{k, T}^{(C o J)} \neq D_{1, T}^{(C o J)}$ almost surely which also yields $\Phi_{k, T, n}^{(C o J)} \neq 1$. Hence we will construct a test with critical region

for a (possibly random) sequence $\left(c_{k, T, n}^{(C o J)}\right)_{n \in \mathbb{N}}$.
As in Section 2 we will consider the situation where the observation times are generated by Poisson processes as an example for a random and irregular sampling scheme which fulfills the conditions we need for the testing procedure to work.

Example 3.6. Consider the extension of the setting from Example 2.5 to two dimensions where the observation times of $X^{(1)}$ and $X^{(2)}$ originate from the jump times of two independent Poisson processes, i.e. the $t_{i, n}^{(l)}-t_{i-1, n}^{(l)}$ are $\operatorname{Exp}\left(n \lambda_{l}\right)$-distributed with $\lambda_{l}>0$ and independent for $i, n \geq 1$ and $l=1,2$.

That Condition 3.4(i) is fulfilled in this setting follows from (2.12). The convergences of $G_{1, n}$ and $H_{1, n}$ have been shown in Proposition 1 of Hayashi and Yoshida (2008), the convergences of $G_{k, n}$ and $H_{k, n}$ are proved in Lemma 6.5. That Condition 3.4(iii) is fulfilled in the Poisson setting is proved in Section 6.3.1.

### 3.3 Central limit theorem

Before we start to derive a central limit theorem for $\Phi_{k, T, n}^{(C o J)}$ on $\Omega_{T}^{(C o J)}$, we restrict ourselves to the case $k=2$. This simplifies notation, and also from the simulation results in Section 4.1 for the test from Section 2 it seems to be optimal to choose $k$ as small as possible.

First we introduce the following notation to describe intervals around some time $s$ at which a common jump might occur

Limits of these variables will occur in the central limit theorem. To ensure convergence of the $Z_{n}(s)$ we need to impose the following assumption on the observation scheme.

Here $\Gamma(\cdot, d y)$ is a family of probability measures on $[0, T]$ with uniformly bounded first moments and $\int_{0}^{T} \Gamma\left(x,\{0\}^{6}\right) d x=0$.

Using the limit distribution of $Z_{n}(s)$ implicitly defined in Condition 3.7 we set

Here, $\left(S_{p}\right)_{p \geq 0}$ is an enumeration of the common jump times of $X^{(1)}$ and $X^{(2)}$, $\left(\mathcal{L}^{(1)}, \mathcal{R}^{(1)}, \overline{\mathcal{L}}^{(2)}, \mathcal{R}^{(2)}, \mathcal{L}, \mathcal{R}\right)(s)$ is distributed according to $\Gamma(s, \cdot)$ and the vectors $\left(U_{s}^{(1),-}, U_{s}^{(1),+}, U_{s}^{(2)}, U_{s}^{(3)}, U_{s}^{(4)}\right)$ are standard normally distributed and independent for different values of $s$. Similarly as for (2.10) we obtain that the infinite sum in the definition of $F_{2, T}^{(C o J)}$ has a well-defined limit. Using $F_{2, T}^{(C o J)}$ we are able to state the following central limit theorem.

Example 3.10. Condition 3.7 is also fulfilled in the setting of equidistant observation times $t_{i, n}^{(1)}=t_{i, n}^{(2)}=i / n$. In that case we have

In this section we will develop a testing procedure based on Theorem 3.8 for which we have to estimate the law of the limiting variable $F_{2, T}^{(C o J)}$. Therefore we need to estimate the law of

Because we are in a two-dimensional setting, we have to simultaneously choose observation intervals of $X^{(1)}$ and $X^{(2)}$ around which the intervals used for simulating $Z(s)$ lie. Here we choose the intervals $\left(\mathcal{I}_{i, n}^{(1)}, \mathcal{I}_{j, n}^{(2)}\right)$ by a probability which is proportional to the length of the overlapping parts of those two intervals. As in Section 2.4 this corresponds to the probability with which a jump time $S_{p}$ uniformly distributed in time would fulfill $S_{p} \in \mathcal{I}_{i, n}^{(1)}$ and $S_{p} \in \mathcal{I}_{j, n}^{(2)}$.

Part (ii) is a technical condition needed in the proof of Theorem 3.12. Further part (iii) provides that $\hat{\sigma}_{n}^{(l)}\left(S_{p},-\right), \hat{\sigma}_{n}^{(l)}\left(S_{p},+\right), \hat{\rho}_{n}\left(S_{p},-\right), \hat{\rho}_{n}\left(S_{p},+\right)$ are consistent estimators for $\sigma_{S_{p}-}^{(l)}, \sigma_{S_{p}}^{(l)}, \rho_{S_{p^{-}}}, \rho_{S_{p}}$, and part (iv) guarantees that the limit under the alternative is almost surely different from 1.

for all $F \subset \Omega_{T}^{(\text {DisJ })}$ with $\mathbb{P}(F)>0$, and even for all $F \subset \Omega_{T}^{(n C o J)}$ with $\mathbb{P}(F)>0$ if we have $2 C_{2, T}^{(\text {CoJ })}>C_{T}^{(C o J)}$ almost surely.

To improve the performance of our test in the finite sample we adjust the estimator $\Phi_{2, T, n}^{(C o J)}$ similarly as for the test in Corollary 2.12 by (partially) subtracting terms that contribute in the finite sample but vanish asymptotically. Therefore we define for $\beta, \varpi$ as above the quantity

Using this expression we then define for $\rho \in(0,1)$ by

for all $F \subset \Omega_{T}^{(\text {DisJ })}$ with $\mathbb{P}(F)>0$, and even for all $F \subset \Omega_{T}^{(n C o J)}$ with $\mathbb{P}(F)>0$ if we have $2 C_{2, T}^{(C o J)}>C_{T}^{(\text {CoJ })}$ almost surely.

Example 3.14. The assumptions on the observation scheme from Condition 3.11 are fulfilled in the setting of Poisson sampling introduced in Example 2.9. That part (i) holds is shown in Section 6.3 .2 and that Condition 3.7 is fulfilled is proven in Section 6.3.1. That part (ii) of Condition 3.11 is fulfilled can be proven in the same way as $\widetilde{G}_{k, n}(t) \xrightarrow{\mathbb{P}} \widetilde{G}_{k}$ and $\widetilde{H}_{k, n}(t) \xrightarrow{\mathbb{P}} \widetilde{H}_{k}$ were shown; compare Lemma 6.5.

Similarly as discussed in Section 2.4 after Example 2.13 we can omit the weighting in (3.12) for obtaining a working testing procedure also within the two-dimensional

Poisson setting. However, in the setting where both processes $X^{(1)}$ and $X^{(2)}$ are observed at the observation times introduced in Example 2.14 with different $\alpha_{1} \neq \alpha_{2}$ it can be easily verified that the weighting in (3.12) is necessary and leads to a correct estimation of the distribution of $F_{2, T}^{(C o J)}$.

## 4 Simulation results

We conduct simulation studies to verify the effectivity and to study the finite sample properties of the developed tests.

### 4.1 Testing for jumps

In our simulation the observation times originate from a Poisson process with intensity $n$ which corresponds to $\lambda=1$ in Example 2.5 and yields on average $n$ observations in the time interval $[0,1]$. We simulate from the model

where $X_{0}=1$ and the Poisson measure $\mu$ has the predictable compensator

This model is a one-dimensional version of the model used in Section 6 of Jacod and Todorov (2009).

We consider the parameter settings displayed in Table 1 with $\sigma^{2}=8 \times 10^{-5}$ in all cases. We choose $n=100, n=1,600$ and $n=25,600$. In a trading day of 6.5 hours

this corresponds to observing $X^{(1)}$ and $X^{(2)}$ on average every 4 minutes, every 15 seconds and every second. Further we set $\beta=0.03, \omega=0.49$ and use $b_{n}=1 / \sqrt{n}$ for the local interval in the estimation of $\sigma_{s}$ and $L_{n}=\lfloor\ln (n)\rfloor, M_{n}=\lfloor 10 \sqrt{n}\rfloor$ in the simulation of the $\hat{\xi}_{k, n, m,-}(s), \hat{\xi}_{k, n, m,+}(s)$. For the choice of these parameters see Section 5 of Martin and Vetter (2017). The cases I-j to III-j correspond to the presence of jumps of diminishing size. When there are smaller jumps we choose a situation where there are more jumps such that the overall contribution of the jumps to the quadratic variation is roughly the same in all three cases. The fraction of the quadratic variation which originates from the jumps matches the one estimated in real financial data from Todorov and Tauchen (2011). In all three cases where the model allows for jumps we only use paths in the simulation study where jumps were realized. In the fourth case Cont we consider a purely continuous model. The
parameter values are taken from Jacod and Todorov (2009).
We applied the two testing procedures from Theorem 2.11 and Corollary 2.12 for $k=2,3,5$ and the results are displayed in Figures 5 and 6 . In Figure 5 the results from Theorem 2.11 are presented. In the left column the empirical rejection rates are plotted against the theoretical value of the test and in the right column we show estimated density plots based on the simulated values of $\Phi_{k, T, n}^{(J)}$. In Figure 6 we present the results from the test in Corollary 2.12 for $\rho=0.9$ (for the choice of $\rho=0.9$ see Figure 4) in the same way. The density plots here show the estimated density of $\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)$.

In Figure 5 we observe in the case Cont that the power of the test from Theorem 2.11 is very good for $n=1,600$ and $n=25,600$. Further the empirical rejection rates match the asymptotic values rather well for all considered values of $k$ in the cases I-j and II-j at least for the highest observation frequency corresponding to $n=25,600$. However in the case III- $j$ there is a severe over-rejection even for $n=25,600$. In general we observe over-rejection in all cases. The empirical rejection rates match the asymptotic values better in the cases where there are on average larger jumps. Further the results are better the smaller $k$ is. Note that for $n=100$ the cases III-j and Cont are not distinguishable using our test as the rejection curves for $n=100$ in those two cases are almost identical. The density plots show the convergence of $\Phi_{k, T, n}^{(J)}$ to 1 in the presence of jumps and to $(k+1) / 2$ under the alternative as predicted from Example 2.5.

In Figure 6 we immediately see that the observed rejection rates from the test from Corollary 2.12 match the asymptotic values much better than those from Theorem 2.11. Hence adjusting the estimator has a huge effect on the finite sample performance of the test. Here the observed rejection rates match the asymptotic values quite well in the case III- $\mathbf{j}$ at least for $n=25,600$ and in the cases $\mathrm{I}-\mathrm{j}$ and II-j we get already for $n=1,600$ very good results. The results in the case Cont show that the power remains to be very good. The density plots show that under the presence of jumps $\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)$ is more centered around 1 than $\Phi_{k, T, n}^{(J)}$. Under the alternative $\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)$ clusters around the value $1+(1-\rho)(k-1) / 2$ which is much closer to 1 than $(k+1) / 2$, but the observed values of $\widetilde{\Phi}_{k, T, n}^{(J)}(\rho)$ still seem to be large enough such that they can be well distinguished from 1 as can be seen from the high empirical rejection rate.

Figure 4 illustrates how the performance of the test from Corollary 2.12 depends on the choice of the parameter $\rho$. For this purpose we investigate for $k=2$ the empirical rejection rates in the cases III-j and Cont with $n=25,600$ for the test with level $\alpha=5 \%$ in dependence of $\rho$. We plot for $\rho \in[0,1]$ the empirical rejection rate under the null hypothesis in the case III-j which serves as a proxy for the type-I error of the test together with one minus the empirical rejection rate under the alternative hypothesis in the case Cont which serves as a proxy for the type-II error of the test. Finally we plot the sum of both error proxies to obtain an indicator for the overall performance of the test in dependence of $\rho$. As expected we observe a decrease in the type-I error as $\rho$ increases and an increase in the type-II error. While we observe an approximately linear decrease in the type-I error, the type-II error is equal to zero until 0.8 , then slightly increases and starts to steeply increase at $\rho=0.9$. As expected from the theory the type-II error converges to $1-\alpha$ for
$\rho \rightarrow 1$. In this example the overall error is minimized for a relatively large value of $\rho$ close to $\rho=0.9$.

Further we carried out simulations for the same four parameter settings based on equidistant observation times $t_{i, n}=i / n$. In this specific setting the test from Theorem 2.11 coincides with tests discussed in Ait-Sahalia and Jacod (2009) and in Chapter 10.3 of Aït-Sahalia and Jacod (2014). The simulation results are presented in Figures 7, 8 and 9 in the same fashion as in Figures 5, 6 and 4 for the irregular observations. We observe that the results both from Theorem 2.11 and Corollary 2.12 based on irregular observations are not significantly worse than those obtained in the simpler setting of equidistant observation times. Especially we can conclude that the adjustment technique introduced for Corollary 2.12 cannot only be used to improve the finite sample performance of our test based on irregular observations, but also can be used to improve existing tests in the literature which are based on equidistant observations.

### 4.2 Testing for disjoint jumps

We simulate according to the model used in Section 6 of Jacod and Todorov (2009), since by using the same configurations as in their paper we can compare the performance of our approach to the performance of their methods in the case of equidistant and synchronous observations. The model for the process $X$ is given by

where $\left[W^{(1)}, W^{(2)}\right]_{t}=\rho t$ and the Poisson measures $\mu_{i}$ are independent of each other and have predictable compensators $\nu_{i}$ of the form

where $0<l_{i}<h_{i}$ for $i=1,2,3$, and the initial values are $X_{0}=(1,1)^{T}$. We consider the same twelve parameter settings which were discussed in Jacod and Todorov (2009) of which six allow for common jumps and six do not. In the case where common jumps are possible, we only use the simulated paths which contain
common jumps. For the parameters we set $\sigma_{1}^{2}=\sigma_{2}^{2}=8 \times 10^{-5}$ in all scenarios and choose the parameters for the Poisson measures such that the contribution of the jumps to the total variation remains approximately constant and matches estimations from real financial data; see Huang and Tauchen (2006). The parameter settings are summarized in Table 2; compare Table 1 in Jacod and Todorov (2009).

The first six cases in Table 2 describe situations where common jumps might be present, the other six cases situations where there exist no common jumps. In the cases $\mathrm{I}-\mathrm{j}$, II-j and III-j there exist only common jumps and no disjoint jumps and the Brownian motions $W^{(1)}$ and $W^{(2)}$ are uncorrelated. In the cases I-m, II-m and III-m we have a mixed model which allows for common and disjoint jumps and also the Brownian motions are positively correlated. In the cases I-d0, II-d0 and III-dO the Brownian motions $W^{(1)}, W^{(2)}$ are uncorrelated while in the cases I-d1, II-d1 and III-d1 the processes are driven by the same Brownian motion $W^{(1)}=W^{(2)}$. The prefixes I, II and III indicate an increasing number of jumps present in the observed paths. Since our choice of parameters is such that the overall contribution of the jumps to the quadratic variation is roughly the same in all parameter settings, this corresponds to a decreasing size of the jumps. Hence in the cases I-* we have few large jumps while in the cases III-* we have many small jumps.

As a model for the observation times we use the Poisson setting discussed in Examples 2.5 and 2.9 for $\lambda_{1}=\lambda_{2}=1$ and we set $T=1$. As in Section 4.1 we choose $n=100, n=1,600$ and $n=25,600$. We set $\beta=0.03$ and $\varpi=0.49$ for all occuring truncations. We use $b_{n}=1 / \sqrt{n}$ for the local interval in the estimation of $\sigma_{s-}^{(l)}, \sigma_{s}^{(l)}, \rho_{s}$ and $L_{n}=\lfloor\ln (n)\rfloor, M_{n}=\lfloor 10 \sqrt{n}\rfloor$ in the simulation of the $\widehat{Z}_{n, m}(s)$. For an explanation for the choice of these parameters see again Section 5 of Martin and Vetter (2017). We only use paths in the simulation where $\mu_{i}([0,1], \mathbb{R}) \neq 0$ whenever $\alpha_{i} \neq 0, i=1,2,3$.

In Figures 10-13 we display the results from the simulation for the testing procedures from Theorem 3.12 and Corollary 3.13. First we plot in Figure 10 for all twelve cases the empirical rejection rates from Theorem 3.12 in dependence of $\alpha \in[0,1]$ as for the plots in the left column of Figure 5. The six plots on the left show the results for the cases where the hypothesis of the existence of common jumps is true. Similarly as in Figure 5 we observe that the empirical rejection rates match the

postulated asymptotic level of the test better if $n$ is larger or if common jumps are larger on average. In all six cases where common jumps are present and for all values of $n$ the test overrejects. This is due to the fact that the asymptotically negligible terms in $\Phi_{2, T, n}^{(\mathrm{CoJ})}$ (terms which are contained in $\Phi_{2, T, n}^{(\mathrm{CoJ})}$ but do not contribute in the limit) tend to be positive, hence $\Phi_{2, T, n}^{(C o J)}$ is on average systematically larger than 1 (see Figure 11) which yields the bias. However, at least for $n=25,600$ the observed rejection rates match the asymptotic level quite well. Only in the cases III-j and III-m where the jumps are on average very small the empirical rejection rates are still far higher than the asymptotic level. The results are worse in the mixed model than in the model where there are only common jumps, because idiosyncratic jumps contribute to the asymptotically vanishing error. The test has very good power against the alternative of idiosyncratic jumps as can be seen in the six plots on the right hand side which correspond to the cases where there are no common jumps.

Figure 11 shows density estimations for $\Phi_{2, T, n}^{(C o J)}$ in all twelve cases. If there are common jumps it is visible in the density plots that $\Phi_{2, T, n}^{(C o J)}$ converges to 1 as $n \rightarrow \infty$. However for $n=100, n=1,600$ in the cases II-j, II-m and for $n=100, n=1,600$, $n=25,600$ in the cases III-j, III-m the density peaks at a value significantly larger than 1 which corresponds to the overrejection in Figure 10. Under the alternative of

disjoint jumps $\Phi_{2, T, n}^{(C o J)}$ tends to cluster around 1.5 which corresponds to the results obtained in Example 2.5 for the one-dimensional setting.

Our simulation results from Theorem 3.12 are worse than the results in the equidistant setting displayed in Figure 4 of Jacod and Todorov (2009) while the power of our test is much better. This effect is partly due to the fact that, contrary to our approach, in Jacod and Todorov (2009) idiosyncratic jumps, although their contribution is asymptotically negligible, are included in the estimation of the asymptotic variance in the central limit theorem. Hence they consistently overestimate the asymptotic variance which yields lower rejection rates. Further the asymptotically negligible terms in $\Phi_{2, T, n}^{(C o J)}$ are larger relative to the asymptotically relevant terms in the asynchronous setting than in the setting of synchronous observation times which increases the rejection rates in the asynchronous setting.

The test from Corollary 3.13 outperforms the test from Theorem 3.12 in the simulation study. This can be seen in Figures 12 and 13 which show the results from the Monte Carlo simulation for the test from Corollary 3.13 with $\rho=0.75$ (for the choice of $\rho=0.75$ see Figure 14) in the same fashion as for Theorem 3.12 in Figures 10 and 11. In the cases where common jumps are present we observe that the empirical rejection rates match the asymptotic level much better than in Figure 10. In Figure 12 we see that in the cases I-j, I-m, II-j, II-m we get good results already for $n=1,600$ and in the cases III-j, III-m at least for $n=25,600$.


Figure 12: Empirical rejection curves from the Monte Carlo simulation for the test derived from Corollary 3.13. The dotted lines represent the results for $n=100$, the dashed lines for $n=1,600$ and the solid lines for $n=25,600$. In each case $N=10,000$ paths were simulated.

The power of the test from Corollary 3.13 is practically as good as for the test from Theorem 3.12. Hence using the adjusted statistic $\widetilde{\Phi}_{2, T, n}^{(C o J)}(\rho)$ instead of $\Phi_{2, T, n}^{(\text {CoJ })}$ allows to get far better level results while the power of the test remains almost the same.

Figure 13 shows that the adjusted estimator $\widetilde{\Phi}_{2, T, n}^{(C o J)}(\rho)$ is much more centered around 1 than $\Phi_{2, T, n}^{(C o J)}$ if there exist common jumps which can be seen e.g. in the cases III-j and III-m. Further $\widetilde{\Phi}_{2, T, n}^{(C o J)}(\rho)$ clusters around a value very close to 1 also if there exist no common jumps. However, in the cases $*-\mathrm{d} 0$ and $*-\mathrm{d} 1$ the peak of the density still occurs at a value which is noticeably larger than 1.

Figure 14 illustrates similarly as Figure 4 for the test for jumps the performance of the test from Corollary 3.13 in dependence of $\rho$. We choose the cases III-j and III-d0 as representatives for the null hypothesis and the alternative. As expected the level as well as the power of the test decrease as $\rho$ increases. Here we get the lowest overall error for a value of $\rho$ close to 0.75 .


Figure 13: Density estimations for $\widetilde{\Phi}_{2, T, n}^{(C o J)}(\rho)$ from the Monte Carlo. The dotted lines correspond to $n=100$, the dashed lines to $n=1,600$ and the solid lines to $n=25,600$. In all cases $N=10,000$ paths were simulated.


Figure 14: This graphic shows for $\alpha=5 \%$ and $n=1,600$ the empirical rejection rate in the case III-j and 1 minus the empirical rejection rate in the case III-d0 from the Monte Carlo simulation based on Corollary 3.13 as a function of $\rho \in[0,1]$.

## 5 Structure of the proofs

Throughout the proofs we will assume that the processes $b_{s}, \sigma_{s}$ and $\Gamma_{s}$ are bounded on $[0, T]$. By Conditions 2.2 and 3.2 they are all locally bounded. A localization procedure then shows that the results for bounded processes can be carried over to the case of locally bounded processes (see e.g. Section 4.4.1 in Jacod and Protter (2012)).

Further we introduce the decomposition $X_{t}=X_{0}+B(q)_{t}+C_{t}+M(q)_{t}+N(q)_{t}$ of the Itô semimartingale (2.1) or (3.1) with

Here $q$ is a parameter which controls whether jumps are classified as small jumps or big jumps.

As we have already applied most of the techniques used in the upcoming proofs in Martin and Vetter (2017), we keep the discussion of similar parts brief and add references to Martin and Vetter (2017) for more detailed arguments. Parts in the proofs which are new or specific to the tests introduced in this paper will be discussed in full detail.

### 5.1 Proofs for Section 2

& \quad \times \mathbb{1}_{\left\{\mathcal{I}_{k i+l_{1}, k, n} \cap \mathcal{I}_{k j+l_{2}, k, n} \neq \emptyset\right\}}
\end{aligned} \quad \begin{aligned}
& \xrightarrow{\mathbb{P}} \sum_{l_{1}, l_{2}=0}^{k-1} B_{T}^{(C o J)}=k^{2} B_{T}^{(C o J)},
\end{aligned}
$$

which yields (3.7).
Proof of Theorem 3.5. It holds

$$
\Phi_{k, T, n}^{(\text {CoJ })}=\frac{n / k^{2} V\left(f,[k], \pi_{n}\right)_{T}}{n V\left(f, \pi_{n}\right)_{T}}
$$

and the proof of

$$
\left(n / k^{2} V\left(f,[k], \pi_{n}\right)_{T}, n V\left(f, \pi_{n}\right)_{T}\right) \xrightarrow{\mathcal{L}-s}\left(D_{k, T}^{(C o J)}+k C_{k, T}^{(C o J)}, D_{1, T}^{(C o J)}+C_{1, T}^{(C o J)}\right)
$$

is similar to the proof of Theorem 3.2 in Martin and Vetter (2017). This yields (3.8) because by Condition 3.7 we have $\int_{0}^{T}\left|\sigma_{s}^{(1)} \sigma_{s}^{(2)}\right| d s>0$ which together with the fact that $H_{1}$ is strictly increasing guarantees $C_{1, T}^{(\text {CoJ })}+D_{1, T}^{(\text {CoJ })} \geq C_{1, T}^{(C o J)}>0$.

The proof of Theorem 3.8 has the same structure as the proof of Theorem 2.8.
Proof of Theorem 3.8. We prove

from which (3.10) easily follows.
Step 1. We introduce discretized versions $\tilde{\sigma}(q, r), \widetilde{C}(r, q)$ of $\sigma, C$ as in Step 1 in the proof of Theorem 2.8 with the only difference that by $\left(S_{q, p}\right)_{p}$ we denote an enumeration of the jump times of $N^{(1)}(q) N^{(2)}(q)$ and not of $N(q)$. Thereby we turn the focus to the common jumps. We then show

& \widetilde{R}^{(l)}(n, q, r)=\sqrt{n} \sum_{i, j \geq 2: t_{i, n}^{(l)} \wedge t_{j, n}^{(3-l)} \leq T} 2\left(\Delta_{i-1,1, n}^{(l)} N^{(l)}(q) \Delta_{i, 1, n}^{(l)} \widetilde{C}^{(l)}(r, q)\right. \\
& \left.\quad+\Delta_{i-1,1, n}^{(l)} \widetilde{C}^{(l)}(r, q) \Delta_{i, 1, n}^{(l)} N^{(l)}(q)\right)\left(\Delta_{j, 2, n}^{(3-l)} N^{(3-l)}(q)\right)^{2} \mathbb{1}_{\left\{\mathcal{I}_{i, 2, n}^{(l)} \cap \mathcal{I}_{j, 2, n}^{(3-l)} \neq \emptyset\right\}}, l=1,2 .
\end{aligned}

The proof for (5.17) will be given in Section 6.2.
Step 2. Next we will show

& \times\left[\Delta X _ { S _ { q , p } ( 2 ) } ^ { ( 2 ) } \left(\tilde{\sigma}^{(1)}(r, q)_{S_{q, p}-} \sqrt{\mathcal{L}\left(S_{q, p}\right)} U_{S_{q, p}(1)-,}^{(1)}+\tilde{\sigma}^{(1)}(r, q)_{S_{q, p}} \sqrt{\mathcal{R}\left(S_{q, p}\right)} U_{S_{q, p}}^{(1),+}\right.\right. \\
& \left.+\sqrt{\left(\tilde{\sigma}^{(1)}(r, q)_{S_{q, p}-}\right)^{2}\left(\mathcal{L}^{(1)}-\mathcal{L}\right)\left(S_{q, p}\right)+\left(\tilde{\sigma}^{(1)}(r, q)_{S_{q, p}}\right)^{2}\left(\mathcal{R}^{(1)}-\mathcal{R}\right)\left(S_{q, p}\right)} U_{S_{q, p}^{(2)}}^{(2)}\right) \\
& +\Delta X_{S_{q, p}}^{(1)}\left(\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}-} \tilde{\rho}(r, q)_{S_{q, p}-} \sqrt{\mathcal{L}\left(S_{q, p}\right)} U_{S_{p}}^{(1),-}+\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}} \tilde{\rho}(r, q)_{S_{q, p}} \sqrt{\mathcal{R}\left(S_{p}\right)} U_{S_{q, p}^{(1),+}}\right. \\
& +\left(\left(\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}-}\right)^{2}\left(1-\left(\tilde{\rho}(r, q)_{S_{q, p}-}\right)^{2}\right) \mathcal{L}\left(S_{q, p}\right)\right. \\
& \left.\quad+\left(\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}}\right)^{2}\left(1-\left(\tilde{\rho}(r, q)_{S_{q, p}}\right)^{2}\right) \mathcal{R}\left(S_{q, p}\right)\right)^{1 / 2} U_{S_{q, p}}^{(3)} \\
& \left.\quad+\sqrt{\left(\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}-}\right)^{2}\left(\mathcal{L}^{(2)}-\mathcal{L}\right)\left(S_{q, p}\right)+\left(\tilde{\sigma}^{(2)}(r, q)_{S_{q, p}}\right)^{2}\left(\mathcal{R}^{(2)}-\mathcal{R}\right)\left(S_{q, p}\right)} U_{S_{q, p}^{(4)}}^{(4)}\right] .

Here $\tilde{\sigma}^{(1)}(r, q), \tilde{\sigma}^{(2)}(r, q), \tilde{\rho}(r, q)$ are discretized versions of $\sigma^{(1)}, \sigma^{(2)}, \rho$ which are obtained in the same way as $\tilde{\sigma}(r, q), \widetilde{C}(r, q)$ above. The proof of (5.18) will also be sketched in Section 6.2.

Step 3. Finally we consider

for all $\varepsilon>0$ and any $\alpha \in[0,1]$. Hence it remains to prove (5.20) for which we give a proof in Section 6.2.

For proving (3.16) we observe that $\Phi_{2, T, n}^{(C o J)}$ converges on the given $F$ to a random variable which is under Condition 3.11 (iv) almost surely different from 1 by Theorem 3.5. Note to this end that $C_{k, T}^{(C o J)}, C_{1, T}^{(C o J)}$ are $\mathcal{F}$-conditional constant while the $\mathcal{F}$ conditional distribution of $D_{k, T}^{(C o J)}, D_{1, T}^{(C o J)}$ is continuous. Hence $k C_{k, T}^{(C o J)} \neq C_{1, T}^{(C o J)}$ or $D_{k, T}^{(C o J)} \neq D_{1, T}^{(C o J)}$ almost surely imply

& \hat{\rho}_{n}\left(S_{p},-\right) \mathbb{1}_{\left\{S_{p}<T\right\}} \xrightarrow{\mathbb{P}} \rho_{S_{p}-} \mathbb{1}_{\left\{S_{p}<T\right\}}, \tag{5.23}
\end{align*} \hat{\rho}_{n}\left(S_{p},+\right) \mathbb{1}_{\left\{S_{p}<T\right\}} \xrightarrow{\mathbb{P}} \rho_{S_{p}} \mathbb{1}_{\left\{S_{p}<T\right\}} .

Proposition 5.4. Suppose Condition 3.11 is fulfilled. Then it holds

\widetilde{\mathbb{P}}\left(\left\{\left|\frac{1}{M_{n}} \sum_{m=1}^{M_{n}} \mathbb{1}_{\left\{\widehat{F}_{T, n, m}^{(C o J)} \leq \Upsilon\right\}}-\widetilde{\mathbb{P}}\left(F_{2, T}^{(C o J)} \leq \Upsilon \mid \mathcal{X}\right)\right|>\varepsilon\right\} \cap \Omega_{T}^{(J)}\right) \rightarrow 0 \tag{5.24}
\end{equation*}
$$

for any $\mathcal{X}$-measurable random variable $\Upsilon$ and all $\varepsilon>0$.

The proof of Proposition 5.4 requires Lemma 5.3 and will be given in Section 6.2. The proof for (5.20) based on Proposition 5.4 is then identical to the proof of (5.10) based on Proposition 5.2 and is therefore omitted here.

Proof of Corollary 3.13. Using arguments from the proof of Theorem 3.5 and the proof of (A.26) in Martin and Vetter (2017) we derive

on $\Omega_{T}^{(C o J)}$. Replacing (3.10) with (5.26) in the proof of (3.15) yields (3.17).
Under the alternative we obtain using Theorem 3.5 and (5.25)

& \quad \xrightarrow{\mathcal{L}-s}(1-\rho) \frac{\left(2 C_{2, T}^{(C o J)}-C_{1, T}^{(C o J)}\right)+\left(D_{2, T}^{(\text {CoJ })}-D_{1, T}^{(C o J)}\right)}{C_{1, T}^{(C o J)}+D_{1, T}^{(C o J)}} \mathbb{1}_{\Omega_{T}^{(n C o J)}}
\end{aligned}
$$

where the limit is almost surely different from zero by Condition 3.11 (iv). We then obtain (3.18) as in the proof of Theorem 3.12 because of $\boldsymbol{c}_{2, T, n}^{(C o J)} \mathbb{1}_{\Omega_{T}^{(n C o J)}}=o_{\mathbb{P}}(1)$; compare (5.21).

## 6 Online-Appendix: Proofs for the arguments omitted in Section 5

We will make repeatedly use of the following estimates. Throughout the upcoming proofs $K$ and $K_{q}$ will denote generic constants, the latter dependent on $q$, to simplify notation.

Lemma 6.1. If Condition 2.2 or Condition 3.2 is fulfilled and the processes $b_{t}, \sigma_{t}, \Gamma_{t}$ are bounded there exist constants $K_{p}, K_{p^{\prime}}, K_{p, q}, \widetilde{K}_{p, q}, e_{q} \geq 0$ such that

& \left\|B(q)_{s+t}-B(q)_{s}\right\|^{p} \leq K_{p, q} t^{p},  \tag{6.1}\\
& \mathbb{E}\left[\left\|C_{s+t}-C_{s}\right\|^{p} \mid \mathcal{F}_{s}\right] \leq K_{p} t^{p / 2},  \tag{6.2}\\
& \mathbb{E}\left[\left\|M(q)_{s+t}-M(q)_{s}\right\|^{p^{\prime}} \mid \mathcal{F}_{s}\right] \leq K_{p^{\prime}} t e_{q},  \tag{6.3}\\
& \mathbb{E}\left[\left\|N(q)_{s+t}-N(q)_{s}\right\|^{p} \mid \mathcal{F}_{s}\right] \leq \widetilde{K}_{p, q} t+K_{p, q} t^{p},  \tag{6.4}\\
& \mathbb{E}\left[\left\|X_{s+t}-X_{s}\right\|^{p^{\prime}} \mid \mathcal{F}_{s}\right] \leq K_{p^{\prime}} t, \tag{6.5}
\end{align*}
$$

for all $s, t \geq 0$ with $s+t \leq T$ and all $q>0, p \geq 1, p^{\prime} \geq 2$. Here, $e_{q}$ can be chosen such that $e_{q} \rightarrow 0$ for $q \rightarrow \infty$. For $p \geq 2$ the constant $\widetilde{K}_{p, q}$ may be chosen independently of $q$.

Proof of Lemma 6.1. The inequalities (6.1)-(6.5) follow from Condition 2.2 respectively 3.2 and inequalities (2.1.33), (2.1.34), (2.1.37), (2.1.41) in Jacod and Protter (2012).

The following elementary statement will be used frequently in the upcoming proofs.

Lemma 6.2. Let $\left(Y_{n}\right)_{n \in \mathbb{N}}$ be a sequence of real-valued integrable random variables on $(\Omega, \mathcal{F}, \mathbb{P})$ and $\mathcal{G} \subset \mathcal{F}$ a sub- $\sigma$-algebra. Then it holds

Proof. For $\varepsilon<1$ it holds by Markov's inequality and Jensen's inequality
$\mathbb{P}\left(\left|Y_{n}\right|>\varepsilon\right)=\mathbb{P}\left(\left|Y_{n}\right| \wedge 1>\varepsilon\right) \leq \frac{\mathbb{E}\left[\left|Y_{n}\right| \wedge 1\right]}{\varepsilon}=\frac{\mathbb{E}\left[\mathbb{E}\left[\left|Y_{n}\right| \wedge 1 \mid \mathcal{G}\right]\right]}{\varepsilon} \leq \frac{\mathbb{E}\left[\mathbb{E}\left[\left|Y_{n}\right| \mid \mathcal{G}\right] \wedge 1\right]}{\varepsilon}$.
This estimate yields the claim as a sequence of random variables $\left(\widetilde{Y}_{n}\right)_{n \in \mathbb{N}}$ converges in probability to zero if and only if $\mathbb{E}\left[\left|\widetilde{Y}_{n}\right| \wedge c\right] \rightarrow 0$ for any $c>0$.

### 6.1 Proofs for Section 2

Proof of (5.5). We will give the proof for $k^{\prime}=1$ only as the proof for general $k^{\prime}=k$ is identical. It holds $X_{t} \mathbb{1}_{\Omega_{T}^{(C)}}=\left(B_{t}+C_{t}\right) \mathbb{1}_{\Omega_{T}^{(C)}}$ with

since $\int_{0}^{T} \int \delta(s, z) \mu(d s, d z) \equiv 0$ on $\Omega_{T}^{(C)}$.

On $\Omega_{T}^{(C)}$ we obtain using (6.1) and (6.2)

& \leq n K \sum_{i: t_{i, n} \leq T}\left(\mathbb{E}\left[\left(\Delta_{i, n} B\right)^{4} \mid \mathcal{S}\right]+\mathbb{E}\left[\left|\Delta_{i, n} B\right|^{3}\left|\Delta_{i, n} C\right| \mid \mathcal{S}\right]\right. \\
& \left.\quad+\mathbb{E}\left[\left(\Delta_{i, n} B\right)^{2}\left(\Delta_{i, n} C\right)^{2} \mid \mathcal{S}\right]+\mathbb{E}\left[\left|\Delta_{i, n} B\right|\left|\Delta_{i, n} C\right|^{3} \mid \mathcal{S}\right]\right) \\
& \leq n K \sum_{i: t_{i, n} \leq T}\left(K\left|\mathcal{I}_{i, n}\right|^{4}+K\left|\mathcal{I}_{i, n}\right|^{7 / 2}+K\left|\mathcal{I}_{i, n}\right|^{3}+K\left|\mathcal{I}_{i, n}\right|^{5 / 2}\right) \\
& \leq n K \max \left\{T^{3 / 2}, 1\right\}\left(\left|\pi_{n}\right|_{T}\right)^{1 / 2} \sum_{i: t_{i, n} \leq T}\left|\mathcal{I}_{i, n}\right|^{2}
\end{aligned}
$$

which vanishes as $n \rightarrow \infty$ by Condition 2.2(i) and (ii). (5.5) then follows from Lemma 6.2.

Proof of (5.7). To simplify notation we set $\Delta_{i, k^{\prime}, n} X=0, \mathcal{I}_{i, k^{\prime}, n}=\emptyset, k^{\prime}=1, k$, whenever $t_{i, n}>T$ in this proof.
Step 1. We first prove

The statement for general jump times $S_{p}$ is obtained by letting $\varepsilon \rightarrow 0$. Consult Step 6 in the proof of Theorem 9.3.2 from Jacod and Protter (2012) for more details.

where the $E_{i, n}^{(l)}, i, n \in \mathbb{N}$, are i.i.d. random variables with values in $\mathbb{R}_{\geq 0}$ and $\alpha^{(l)}(n)$ are positive functions with $\alpha^{(l)}(n) \rightarrow \infty$ as $n \rightarrow \infty$.

If $E_{1,1}^{(l)} \in L^{2}(\Omega)$ it holds

Because further $Y_{m_{1}}, Y_{m_{2}}$ become asymptotically independent as $\left|m_{1}-m_{2}\right| \rightarrow \infty$, compare (A.51) in Martin and Vetter (2017), it is possible to conclude $\operatorname{Cov}\left(Y_{m_{1}}, Y_{m_{2}}\right) \rightarrow 0$ as $\left|m_{1}-m_{2}\right| \rightarrow \infty$. We then obtain by a law of large numbers for stationary processes, compare Theorem 7.1.1 in Brockwell and Davis (1991),

For proving (6.73) observe that it holds $Z_{n}^{(l)}(x) \stackrel{\mathcal{L}}{=} Z_{1}^{(l)}(n x)$. Since the Poisson processes generating the observation times in $\pi_{1}$ and the Brownian motion $\bar{W}^{(l)}$ are independent stationary processes the law of $Z_{1}^{(l)}(n x)$ depends on $n$ only through the fact that all occuring intervals are bounded to the left by 0 . Hence if $\Omega(n, m, x)$ denotes the set on which all intervals needed for the construction of $Z_{1}^{(l)}(m x)$ are within $[m x-n x, \infty)$, it follows that all members of the sequence $\left.\left(Z_{1}^{(l)}(m x) \mathbb{1}_{\Omega(n, m, x)}\right)\right)_{m \geq n}$ have the same law. This yields because of $\mathbb{P}(\Omega(n, m, x))=\mathbb{P}(\Omega(n, n, x)), m \geq n$, and

By the stationarity of the processes the law of the limit, which we denote by $\Gamma^{(l)}$, does not depend on $x$. Finally we obtain the uniform convergence in (6.73) because of $\mathbb{P}(\Omega(n, n, x)) \leq \mathbb{P}(\Omega(n, n, \varepsilon))$ for $x \geq \varepsilon$.

Hence if the limit law would admit a part which is singular to the Lebesgue measure, this would also be true for the law of the $Z_{n}^{(l)}(s)$ with $n$ sufficiently large. In all three cases considered in this paper it can be shown that $Z_{n}^{(l)}(s)$ has no atom. Hence in Condition 2.7(ii) and Condition 3.7 we obtain $\Gamma(x,\{0\})=0$.

Further by Theorem 6.7 from Billingsley (1999) there exist random variables $\left(\widetilde{Z}^{(l)},\left(\widetilde{Z}_{n}^{(l)}\right)_{n \in \mathbb{N}}\right)$ defined on a probability space $\left(\Omega^{\prime}, \mathcal{F}^{\prime}, \mathbb{P}^{\prime}\right)$ with

for $p \geq 0$. For the cases in Condition 2.7(ii), 3.4(iii) and 3.7 it can be shown that the supremum is finite for all $p \geq 0$ and hence $\Gamma^{(l)}$ has finite moments. This yields the requirement of uniformly bounded first and second moments in Condition 2.7(ii), $3.4(\mathrm{iii})$ and 3.7.

### 6.3.2 Proof of Condition $2.10(\mathrm{i})$ and $3.11(\mathrm{i})$ in the Poisson setting

Note that it holds

Hence the proof of Condition 2.10(i) in the Poisson setting is identical to the proof of (4.3) in Martin and Vetter (2017). The same holds true for Condition 3.11(i) as $\widehat{Z}_{n, 1}(s) \stackrel{\stackrel{\mathcal{L}_{\mathcal{S}}}{=}}{Z_{n}}\left(V_{n}(s)\right)$ with
