# Distribution Regression

#### Abstract

Linear regression is a fundamental and popular statistical method. There are various kinds of linear regression, such as mean regression and quantile regression. In this paper, we propose a new one called distribution regression, which allows broad-spectrum of the error distribution in the linear regression. Our method uses nonparametric technique to estimate regression parameters. Our studies indicate that our method provides a better alternative than mean regression and quantile regression under many settings, particularly for asymmetrical heavy-tailed distribution or multimodal distribution of the error term. Under some regular conditions, our estimator is $\sqrt{n}$-consistent and possesses the asymptotically normal distribution. The proof of the asymptotic normality of our estimator is very challenging because our nonparametric likelihood function cannot be transformed into sum of independent and identically distributed random variables. Furthermore, penalized likelihood estimator is proposed and enjoys the so-called oracle property with diverging number of parameters. Numerical studies also demonstrate the effectiveness and the flexibility of the proposed method.

## 1 Introduction

Linear regression is an important tool to explore the relationship between the response and predictors in statistics, with much existing work including mean regression and quantile regression.

To study regression, we start with $\left\{\left(x_{i}, Y_{i}\right), i=1, \ldots, n\right\}$, a random sample from population $(x, Y)$, where $x$ is a p-dimensional predictor, $Y$ is a univariate response, and $\left(x_{i}, Y_{i}\right)$ 's satisfy:

$$
\begin{equation*}
Y_{i}=\nu+x_{i}^{\top} \beta+\varepsilon_{i}, \quad i=1, \ldots, n . \tag{1.1}
\end{equation*}
$$

Here $\beta=\left(b_{1}, \cdots, b_{p}\right)^{\top}$ is a p-dimensional vector of unknown parameters, $\nu$ is the intercept term, and the error terms $\varepsilon_{i}$ 's are independent and identically distributed (i.i.d.) with unknown density function $f$, and are assumed to be independent of $x_{i}$ 's.

The commonly used method to estimate $\beta$ is to find $\widehat{\beta}$ which minimizes the objective function:

$$
\begin{equation*}
n^{-1} \sum_{i=1}^{n} \phi\left(Y_{i}-\nu-x_{i}^{\top} \beta\right) . \tag{1.2}
\end{equation*}
$$

If $\phi(t)=t^{2}$, then $\widehat{\beta}$ is the mean regression or least square estimator. If $\phi_{\tau}(t)=t(\tau-I(t<0))$ with $0 \leq \tau \leq 1$, then $\widehat{\beta}$ is the quantile regression estimator; see Koenker and Bassett (1978). On the other hand, if the density function $f$ is known, the maximum likelihood is the best approach to estimating $\beta$. Clearly the maximum likelihood function is

\begin{equation*}
\prod_{i=1}^{n} f\left(Y_{i}-\nu-x_{i}^{\top} \beta\right) \tag{1.3}
\end{equation*}
$$

As we known, if the error term follows a normal distribution, the maximum likelihood estimator is equivalent to the mean regression estimator, and if $f$ is the Laplace density, the maximum likelihood estimator is the same as the quantile regression estimator Geraci and Bottai (2006)). There is a huge body of literature about the semiparametric models. The semiparametric efficiency for the estimation of the parametric part can be established, provided that the density of the error is symmetric about zero and absolutely continuous with respect to the Lebesgue measure (Bickel et al. (1993)). However, in reality, we do not know how the distribution of the error term looks like. We might have to test whether it is symmetric or not, unimodal or multimodal. This motivates us to apply nonparametric techniques to estimate $f$ as a first step. After this we plug our estimated $f$ into (1.3) and find the minimizer $\widehat{\beta}$. This is the method we propose in the article. We call it the distribution regression, which is a distribution free regression and can be considered as generalizations of both mean regression and quantile regression.

We show that our distribution regression estimator is robust and possesses nice finite and large sample properties. The establishment of our asymptotic theories is very challenging because our nonparametric likelihood function cannot be transformed into sum of i.i.d. random variables. Numerical studies indicate that the distribution regression is much better compared to existing methods under many settings, particularly for asymmetrical heavy-tailed distribution or multimodal distribution of the error term. Our procedure essentially can be applied to other models,
such as single or multiple index models, partial linear model and varying coefficient model. As a general robust approach, it has potentials to be used in testing the goodness of parameter estimation of mean regression.

Another popular and powerful tool in the linear regression is the penalty. This idea may date back to Tibshirani (1996), who studied the mean regression via LASSO. Later on, the adaptive LASSO (Zou (2006), SCAD (Fan and Li (2001)), MCP (Zhang (2010)) and many others were proposed. Other related works to our paper are: SCAD and adaptive LASSO in the quantile regression (Wu and Liu (2009)), local quadratic approximation (LQA, Fan and Li (2001)) and local linear approximation (LLA, Zou and $\mathrm{Li}(2008)$ ). In this article, we combine adaptive LASSO with our method under the high dimensional setting and adopt LQA in the numerical estimation. Under regular conditions, our penalized likelihood estimator has the so-called oracle property with diverging number of parameters. Furthermore, a new iterative coordinate descent algorithm is suggested for our estimator, which is an extended version of coordinate descent algorithm (Wu and Lange (2008)).

The rest of this article is organized as follows. In Section 2, we propose the distribution regression and establish its theoretical property. Sparse estimation in the high dimension setting is presented in Section 3. In Section 4, we examine the finite sample performance of the proposed method via Monte Carlo simulations, and also illustrate the effectiveness through several empirical examples. All technical proofs of the main results are given in Appendix.

## 2 Distribution Regression

Given a set of i.i.d. observations $\left\{z_{i}\right\}_{i=1}^{n}$, the classical kernel density estimator of $f(z)$ is

$$
\tilde{f}_{n h}(z)=\frac{1}{n h} \sum_{i=1}^{n} K\left(\frac{z-z_{i}}{h}\right)
$$

where $K(\bullet)$ is the kernel function, and $h$ is the bandwidth. Technically it may happen that $\tilde{f}_{n h}(z)=0$ if $f(z)$ is close to 0 . In order to avoid such annoying situation, we define the kernel density estimator of $f(z)$ in this article as

$$
\begin{equation*}
f_{n h}(z)=\frac{1}{n h} \sum_{i=1}^{n} K\left(\frac{z-z_{i}}{h}\right)+n^{-1000} . \tag{2.4}
\end{equation*}
$$

The reason to have the extra term $n^{-1000}$ is that we have to deal with log-likelihood function in the theoretical development. In the numerical studies, this term is ignorable. The nonparametric likelihood function is given by

$$
\begin{equation*}
L_{n h}(\beta)=\prod_{j=1}^{n} f_{n h}\left(\varepsilon_{j}\right) \tag{2.5}
\end{equation*}
$$

The estimator $\widehat{\beta}$ can be found by maximizing 2.5. Since it is based on the estimated joint distribution of error terms, we call $\widehat{\beta}$ the distribution regression estimator. For simplicity, we denote the $\log$-likelihood function $\log L_{n h}$ by $\ell_{n h}$.

Combining (2.4) and (2.5), we have

$$
\begin{align*}
& \ell_{n h}(\beta)=\sum_{j=1}^{n} \log \left[\frac{1}{n h} \sum_{i=1}^{n} K\left(\frac{\varepsilon_{j}-\varepsilon_{i}}{h}\right)+n^{-1000}\right] \\
& =\sum_{j=1}^{n} \log \left[\frac{1}{n h} \sum_{i=1}^{n} K\left(\frac{\left(Y_{j}-\nu-x_{j}^{\top} \beta\right)-\left(Y_{i}-\nu-x_{i}^{\top} \beta\right)}{h}\right)+n^{-1000}\right] \\
& =\sum_{j=1}^{n} \log \left[\frac{1}{n h} \sum_{i=1}^{n} K\left(\frac{\left(Y_{j}-Y_{i}\right)-\left(x_{j}-x_{i}\right)^{\top} \beta}{h}\right)+n^{-1000}\right] \tag{2.6}
\end{align*}
$$

Clearly, $(2.6)$ is a nonlinear objective function. This is more complicated to handle than other ones. However, maximizing the nonlinear function as above is not as difficult as it looks. In the article, we adopt the algorithm of Varadhan and Gilbert (2009), which optimizes a highdimensional nonlinear objective function, and achieves fast computation.

Remark 1. The bandwidth $h$ is a tuning parameter. Many bandwidth selection methods can be used here since our estimate is essentially the same as the usual kernel estimation. In the simulations, we use the plug-in method of Wand and Jones (1994) to select the bandwidth, which performs well in our numerical studies.

Remark 2. The intercept term $\nu$ of regression model disappears in (2.6). So our method can't directly provide one estimator of the intercept term. However one can use other methods, such as mean regression, to get the estimator of the intercept term after obtaining $\widehat{\beta}$. From now on, we assume that $\nu=0$ in our model. This assumption doesn't have any influence on $\widehat{\beta}$.

In order to state our main results, we need the following notation. Denote by $\Omega$ the parameter space of $\beta$, $\beta_{0}$ the true value of $\beta$, and $\widehat{\beta}$ the estimator of $\beta_{0}, B(\kappa)=\left\{\beta:\left\|\beta-\beta_{0}\right\| \leq \kappa\right\}$, a ball centered at $\beta_{0}$ with radius $\kappa$. Its boundary will be denoted by $\partial B(\kappa)$. Set $U=(x, Y)$, $U_{i}=\left(x_{i}, Y_{i}\right), i=1, \ldots, n$. Let $\ell(\beta)$ be the log-likelihood function of the observations $U_{1}, \ldots, U_{n}$. To facilitate asymptotic properties of our proposed estimator, we assume the following conditions.

## Condition 1.

$$
\|K\|_{\infty}:=\sup _{z \in R}|K(z)|<\infty, \quad \int_{z \in R}|K(z)|^{2} d z<\infty, \quad \lim _{|z| \rightarrow \infty}|z K(z)|=0
$$

The first derivative $K^{\prime}(z)$ is piecewise continuous and

$$
\left\|K^{\prime}\right\|_{\infty}:=\inf \left\{C \geq 0:\left|K^{\prime}(z)\right| \leq C \text { for almost all } z \in R\right\}<\infty .
$$

Condition 2. There exists a positive constant $\alpha<1 / 2$ such that $n^{1-\alpha} h / \log n \rightarrow \infty$ and $n^{\alpha} h^{2} \rightarrow$ 0 as $n \rightarrow \infty$.

Condition 3. The probability density function $f(z)$ of the error term is uniformly continuous; the first and second derivatives $f^{\prime}(z), f^{\prime \prime}(z)$ exist a.e., and $\left\|f^{\prime}\right\|_{\infty}<\infty,\left\|f^{\prime \prime}\right\|_{\infty}<\infty$; there exist constants $\kappa_{0}$ and $k \geq 1$ such that $\sup _{p \geq 1} P_{\beta_{0}}\left(\min _{\beta \in B\left(\kappa_{0}\right)} f\left(Y-x^{\top} \beta\right) \leq n^{-k}\right)=o(1 / n)$ and $\sup _{p \geq 1} P_{\beta_{0}}\left(\min _{\beta \in B\left(\kappa_{0}\right)} f\left(Y-x^{\top} \beta\right) \leq n^{-\alpha}\right)=o(1 / \log n)$ as $n \rightarrow \infty$. (Here $P_{\beta_{0}}$ means the true parameter is $\beta_{0}$. So does $E_{\beta_{0}}$.)

Condition 4. $U_{1}, \ldots, U_{n}$ are i.i.d. with probability density $f(U, \beta)$ satisfying $\sup _{1 \leq p<\infty} E\|x / p\|<$ $\infty$. Note that $f(U, \beta)=f\left(Y-x^{\top} \beta\right) h(x)$, where $h(x)$ is the marginal density of $x$. The model is identifiable, i.e. $\forall \beta \neq \beta^{\prime},\left\{U: f(U, \beta) \neq f\left(U, \beta^{\prime}\right)\right\}$ is not a Null-set. There exists an open subset $\omega$ of $\Omega$ that contains the true parameter point $\beta_{0}$ for almost all $U$. Moreover, $\sup _{\beta \in B\left(\kappa_{0}\right), p \geq 1} E_{\beta_{0}}\left|\log f\left(Y-x^{\top} \beta\right)\right|<\infty$, and for any $\kappa \in\left(0, \kappa_{0}\right]$

$$
\begin{equation*}
\sup _{p \geq 1} \sup _{\beta \in \partial B(\kappa)} E_{\beta_{0}} \log \frac{f\left(Y-x^{\top} \beta\right)}{f\left(Y-x^{\top} \beta_{0}\right)}<0 . \tag{2.7}
\end{equation*}
$$

Condition 5. For almost all observed $(Y, x)$, there exists a function $M(U)$ such that

$$
\sup _{\beta \in B\left(\kappa_{0}\right)}\left\|\frac{\partial}{\partial Y} \log f\left(Y-x^{\top} \beta\right)\right\| \leq M(U)
$$

where $\sup _{p \geq 1} E(M(U)\|x / \sqrt{p}\|)<\infty$. If $p \rightarrow \infty$,

$$
\sup _{p \geq 1} E(M(U)\|x / \sqrt{p}\|)^{3}<\infty .
$$

Remark 3. Conditions 12 are regular in the literature of kernel density estimator, which are used to prove the consistency of the kernel density estimator. Condition 3 is actually very mild. Almost all the commonly seen distributions, such as (mixed) normal, double exponential, Cauchy distributions, satisfy it. Conditions 4 requires that $E_{\beta_{0}}\left|\log f\left(Y-x^{\top} \beta\right)\right|<\infty$ if $\beta \in B\left(\kappa_{0}\right)$. This implies that $Y-x^{\top} \beta$ is $a . s$. in the support of $\varepsilon$. So the support of $\varepsilon$ should be the whole real line.

Theorem 1. Let $U_{1}, \ldots, U_{n}$ be i.i.d. from one population with the density function $f(U, \beta)$.

1. Suppose $p$ is fixed. Under Conditions 15, $\widehat{\beta} \rightarrow \beta_{0}$ in probability as $n \rightarrow \infty$.
2. Suppose $p=o\left(n^{1-\alpha} h / \log n\right)$ as $n \rightarrow \infty$, and

$$
\begin{equation*}
\sup _{\beta \in B\left(\kappa_{0}\right), p \geq 1} E_{\beta_{0}} \exp \left(\psi\left|\log f\left(Y-x^{\top} \beta\right)\right|\right)<\infty \tag{2.8}
\end{equation*}
$$

for some positive $\psi$. Under Conditions 1 5 5, $\widehat{\beta}-\beta_{0} \rightarrow 0$ in probability as $n \rightarrow \infty$.
Theorem 1 shows that the distribution regression estimator is consistent under regular conditions.

In order to derive the central limit theorem for $\widehat{\beta}$, we need more conditions. Let $C(\kappa)=\{\beta$ : $\left.\left\|\beta-\beta_{0}\right\| \leq \kappa\right\}$, a complex ball in $\mathbf{C}^{p}$ centered at $\beta_{0}$ with radius $\kappa$. Here each coordinate of $\beta$ is complex. We also need to extend the domain of $f(z)$ from the real line to the complex plane.

Here we take the double exponential distribution as one example to see how to define $f(z)$ in the complex plane. In this case, $f(z)=e^{-|z|} / 2$. For complex $\beta$, we define

$$
f\left(Y-x^{\top} \beta\right)= \begin{cases}e^{-\left(Y-x^{\top} \beta\right)} / 2 & \text { if } \Re\left(Y-x^{\top} \beta\right) \geq 0 \\ e^{\left(Y-x^{\top} \beta\right)} / 2 & \text { if } \Re\left(Y-x^{\top} \beta\right)<0 .\end{cases}
$$

Condition 6. There exist constants $\kappa_{0}>0$ and $k \geq 1$ such that $P\left(\min _{\beta \in C\left(\kappa_{0}\right)}\left\|f\left(Y-x^{\top} \beta\right)\right\| \leq\right.$ $\left.n^{-k}\right)=o(1 / n)$ and $P\left(\min _{\beta \in C\left(\kappa_{0}\right)}\left\|f\left(Y-x^{\top} \beta\right)\right\| \leq n^{-\alpha}\right)=o(1 / \log n)$ as $n \rightarrow \infty$, and $E_{\beta_{0}} \log f(Y-$ $\left.x^{\top} \beta\right)$ is an analytic function of each coordinate of $\beta$ in $C\left(\kappa_{0}\right)$; for any $\beta \in C\left(\kappa_{0}\right), f^{\prime}(Y-$ $\left.x^{\top} \beta\right)$ and $f^{\prime \prime}\left(Y-x^{\top} \beta\right)$ exist for almost all observed $(Y, x) ; \sup _{\beta \in C\left(\kappa_{0}\right)}\left\|f^{\prime}\left(Y-x^{\top} \beta\right)\right\|_{\infty}<\infty$, $\sup _{\beta \in C\left(\kappa_{0}\right)}\left\|f^{\prime \prime}\left(Y-x^{\top} \beta\right)\right\|_{\infty}<\infty$, where

$$
\begin{aligned}
\left\|f^{\prime}\left(Y-x^{\top} \beta\right)\right\|_{\infty} & =\inf \left\{C>0: P\left(\left\|f^{\prime}\left(Y-x^{\top} \beta\right)\right\| \leq C\right)=1\right\} \\
\left\|f^{\prime \prime}\left(Y-x^{\top} \beta\right)\right\|_{\infty} & =\inf \left\{C>0: P\left(\left\|f^{\prime \prime}\left(Y-x^{\top} \beta\right)\right\| \leq C\right)=1\right\}
\end{aligned}
$$

for almost all observed $(Y, x), \log f\left(Y-x^{\top} \beta\right)$ is an analytic function of each coordinate of $\beta$ in $C(\kappa)$ if $\kappa$, which may depend on $(Y, x)$, is sufficiently small and positive.

Condition 7. The first and second derivatives of $\log f\left(Y-x^{\top} \beta\right)$ satisfy the equations

$$
E_{\beta_{0}}\left[\frac{\partial}{\partial b_{j}} \log f\left(Y-x^{\top} \beta_{0}\right)\right]=\frac{\partial}{\partial b_{j}} E_{\beta_{0}}\left[\log f\left(Y-x^{\top} \beta_{0}\right)\right]=0 \quad j=1, \ldots, p
$$

and

$$
\begin{aligned}
\boldsymbol{I}_{j k}\left(\beta_{0}\right) & =E_{\beta_{0}}\left[\frac{\partial}{\partial b_{j}} \log f\left(Y-x^{\top} \beta_{0}\right) \cdot \frac{\partial}{\partial b_{k}} \log f\left(Y-x^{\top} \beta_{0}\right)\right] \\
& =E_{\beta_{0}}\left[-\frac{\partial^{2}}{\partial b_{j} \partial b_{k}} f\left(Y-x^{\top} \beta_{0}\right)\right] \\
& =\frac{\partial^{2}}{\partial b_{j} \partial b_{k}} E_{\beta_{0}}\left[-f\left(Y-x^{\top} \beta_{0}\right)\right] .
\end{aligned}
$$

The Fisher information matrix

$$
\boldsymbol{I}(\beta)=E_{\beta}\left\{\left[\frac{\partial}{\partial \beta} \log f\left(Y-x^{\top} \beta\right)\right]\left[\frac{\partial}{\partial \beta} \log f\left(Y-x^{\top} \beta\right)\right]^{\top}\right\}
$$

is finite and positive definite at $\beta=\beta_{0}$.
Condition 8. $\sup _{\beta \in C\left(\kappa_{0}\right), p \geq 1} E_{\beta_{0}}\left|\log f\left(Y-x^{\top} \beta\right)\right|<\infty$. Condition 5 still holds if one replaces $B(\kappa)$ by $C\left(\kappa_{0}\right)$.

Theorem 2. Let $U_{1}, \ldots, U_{n}$ be i.i.d. from one population with the density function $f(U, \beta)$. Under Conditions 18 , if $p$ is fixed, $\sqrt{n}\left(\widehat{\beta}-\beta_{0}\right)$ is asymptotically normal with mean zero and covariance matrix $\left[\boldsymbol{I}\left(\beta_{0}\right)\right]^{-1}$.

Remark 4. Under Conditions 18 . Theorem 2 tells us that $\widehat{\beta}$ is not only $\sqrt{n}$ consistent, but also asymptotically efficient.

## 3 Sparse Estimation in High Dimension

When the true underlying model has a sparse representation, meaning that most of the true unknown parameters are zero, variable selection is necessary. In this section, we study the penalized likelihood estimator via adaptive LASSO. In other words, we find our sparse estimator by minimizing the penalized likelihood function

$$
\begin{equation*}
-\frac{1}{n} \ell_{n h}(\beta)+\sum_{j=1}^{p} p_{\lambda_{n}}\left(\left|b_{j}\right|\right) . \tag{3.9}
\end{equation*}
$$

where $p_{\lambda}(\bullet)$ is the penalty function, which includes four popular choices: LASSO (Tibshirani (1996)), adaptive LASSO (Zou (2006)), SCAD (Fan and Li (2001)) and MCP (Zhang (2010)). In this article, we use adaptive LASSO. So, (3.9) can be written as

$$
\begin{equation*}
-\frac{1}{n} \ell_{n h}(\beta)+\lambda_{n} \sum_{j=1}^{p} \hat{w}_{j}\left|b_{j}\right| . \tag{3.10}
\end{equation*}
$$

where $\hat{w}_{j}=1 /\left|\hat{b}_{j}\right|^{\gamma}, \gamma>0, \hat{b}_{j}$ is the our distribution regression estimator of the $j$ th coordinate of $\beta$ without any penalty.

To solve the minimization problem in (3.10, we implement iterative coordinate descent algorithm combined with local quadratic approximation. Given $b_{1}^{(k)}, \ldots, b_{p}^{(k)}$, we can find

$$
\begin{equation*}
b_{j}^{(k+1)}=\arg \min _{b_{j}}\left\{-\frac{1}{n} \ell_{n h}\left(b_{j}\right)+\lambda_{n} \frac{1}{2\left[b_{j}^{(k)}\right]^{2}} b_{j}^{2}\right\} \tag{3.11}
\end{equation*}
$$

An iterative coordinate descent algorithm is as follow.
Step 1 Input an initial value $\beta^{(0)}$
Step 2 For $k \geq 0$
Step 2.1 For $j \in 1, \ldots, p$, update $b_{j}^{(k+1)}$ by 3.11
Step 2.2 Repeat Step 2.1, until $b_{j}^{(k+1)}$ converges.
Step 3 Update $k \leftarrow k+1$. Repeat Step 2 until convergence. Then output $\beta^{(k+1)}$.
The selection of the tuning parameter $\lambda_{n}$ is important in real applications. Cross-validation is a very common method, however it is time-consuming when $p$ is large. In the article, we use the generalized information criterion (GIC) for high dimensional penalized likelihood Fan and Tang (2013); Lin et al. (2014)). The GIC is defined by

$$
\operatorname{GIC}\left(\lambda_{n}\right)=\log \widehat{\sigma}^{2}+s_{\lambda_{n}} \frac{\log \log n}{n} \log (p \vee n)
$$

where $\widehat{\sigma}^{2}=\sum_{i=1}^{n}\left(Y_{i}-x_{i}^{\top} \widehat{\beta}_{\lambda_{n}}\right)^{2} / n, \widehat{\beta}_{\lambda_{n}}$ is the estimator which minimizes (3.10), $p \vee n=\max (p, n)$, and $s_{\lambda_{n}}$ is the number of nonzero coefficients in $\widehat{\beta}_{\lambda_{n}}$. So $\lambda_{n}$ is selected as

$$
\hat{\lambda}_{n}=\arg \min _{\lambda_{n}} G I C\left(\lambda_{n}\right)
$$

Now we study the large sample properties of the proposed penalized likelihood estimators. Let $x_{i}=\left(x_{i 1}^{\top}, x_{i 2}^{\top}\right)^{\top}, x_{i 1} \in R^{s}, x_{i 2} \in R^{p-s}, \beta=\left(\beta_{1}^{\top}, \beta_{2}^{\top}\right)^{\top}$. The true nonzero coefficients are $\beta_{10}$, and the zero coefficients are $\beta_{20}$. The corresponding estimator is $\widehat{\beta}_{0}=\left(\widehat{\beta}_{10}^{\top}, \widehat{\beta}_{20}^{\top}\right)^{\top}$. We rewrite (3.10) as

$$
\begin{equation*}
Q(\beta)=-\ell_{n h}(\beta)+n \lambda_{n} \sum_{j=1}^{p} \hat{w}_{j}\left|b_{j}\right| . \tag{3.12}
\end{equation*}

Theorem 3 (Oracle properties). In addition to the conditions in Theorem 2, we assume that $\liminf _{n \rightarrow \infty} \lambda_{n} \sqrt{n}>0$. If $p \rightarrow \infty$ and $s$ is fixed, we further assume that $p=O\left(\lambda_{n} n^{1 / 2}\right), p=$ $o\left(n^{1-\alpha} h / \log n\right)$ as $n \rightarrow \infty, \sup _{p \geq 1}\left\|\boldsymbol{I}\left(\beta_{0}\right)\right\|<\infty$, and $\sup _{\beta \in C\left(\kappa_{0}\right), p \geq 1} E_{\beta_{0}} \exp \left(\psi\left|\log \left(Y-x^{\top} \beta\right)\right|\right)<$ $\infty$ for some positive $\psi$. Then we have
(a) Sparsity: $\widehat{\beta}_{20}=0$ with probability tending to one as $n \rightarrow \infty$.
(b) Asymptotic normality: $\sqrt{n}\left(\widehat{\beta}_{10}-\beta_{10}\right) \xrightarrow{d} N\left(0,\left[\boldsymbol{I}_{11}\left(\beta_{0}\right)\right]^{-1}\right)$, where

Theorem 3 states that the distribution regression with adaptive LASSO estimator have oracle properties in the sparse linear models with diverging number of parameters.

## 4 Simulation and application

### 4.1 Simulation

In this section, we evaluate the finite sample performance of our proposed distribution regression with two existing methods (mean regression and quantile (median) regression) through two sets of simulation examples. We set $n$ to be 100 , and repeat 200 times. $x=\left(x_{1}, \ldots, x_{p}\right) \sim N(0, E)$, where $E$ is a $p \times p$ identity matrix. The error term $\varepsilon$ is generated from seven distributions: (1) the mixed normal distribution: $0.5 N\left(-2,5^{2}\right)+0.5 N\left(2,0.5^{2}\right)$; (2) the normal distribution $N(0,1)$; (3) $t(3)$; (4) the standard Laplace distribution: $\operatorname{Lap}(0,1)$; (5) the Gamma distribution $G(2,2)$; (6) the standard Cauchy distribution $\operatorname{Cau}(0,1) ;(7)$ the exponential distribution: Exp $(1)$. Among these, $t(3)$ and $\operatorname{Cau}(0,1)$ are symmetric heavy-tailed distributions; the mixed normal distribution is multimodal; $G(2,2)$ and $\operatorname{Exp}(1)$ are asymmetric.

Example 1. In this example, we consider three linear models:
Case 1: $Y=3 x_{1}+3 x_{2}+3 x_{3}+\varepsilon$
Case 2: $Y=\left(3-Q_{1}\right) x_{1}+\left(3-Q_{2}\right) x_{2}+\left(3-Q_{3}\right) x_{3}+\varepsilon$
Case 3: $Y=\left(3-Q_{1}\right) x_{1}+\cdots+\left(3-Q_{6}\right) x_{6}+\varepsilon$
where $Q_{j}$ is generated from a uniform distribution on $[0,1]$. We evaluate the performance through the following two criteria:
(1) bias $_{j}=\frac{1}{200} \sum_{m=1}^{200}\left|\hat{b}_{j}^{(m)}-b_{j}\right|, \quad j=1 \ldots, p$
(2) $M S E=\frac{1}{200 p} \sum_{m=1}^{200} \sum_{j=1}^{p}\left(\hat{b}_{j}^{(m)}-b_{j}\right)^{2}$.

Here $\hat{b}_{j}^{(m)}$ is the estimator of $b_{j}$ based on the $m$ th sample.
Tables 1 and 2 summarize the simulation results. We can draw the following conclusions:

1. When the error term follows the normal distribution, the mean regression (MR) performs the best and the distribution regression (DR) has almost the same performance as the quantile regression (QR). However, the difference of their performance is not big. When the error term follows other distributions, the mean regression becomes worse as the population is moving away from the normal.
2. When the error follows the standard Cauchy distribution, the quantile regression is the best.
3. When the error term is asymmetric or heavy-tailed or multimodal, the performance of our distribution regression is the best and the performance of mean regression is the worst.

Example 2. In this example, we study the performance of variable selection. Consider the following linear model:

$$
Y=3 x_{1}+1.5 x_{2}+2 x_{3}+0 x_{4}+\cdots+0 x_{p}+\varepsilon
$$

We set the dimension $p$ as 10 and 50 . Besides bias, we also use the following criteria to evaluate the performance:
(1) Correct-fit: the proportion of including all three significant variables.
(2) Over-fit: the proportion of including all three significant variables and some zero coefficients.
(3) Under-fit: the proportion of excluding any significant variables.
(4) $M E=\left(\widehat{\beta}-\beta_{0}\right)^{\top} E\left(x x^{\top}\right)\left(\widehat{\beta}-\beta_{0}\right)$
(5) C: the average number of nonzero coefficients correctly estimated to be nonzero.
(6) IC: the average number of zero coefficient incorrectly estimated to be nonzero.

Tables 3 and 4 summarize the simulation results. Under the criterion $M E$, the mean regression performs well in the case of $N(0,1)$, and the quantile regression performs well in cases of $t(3), \operatorname{Lap}(0,1)$ and $\operatorname{Cau}(0,1)$. However, for the other distributions, the distribution regression is superior to the mean regression and quantile regression, especially for mixed normal distribution and $\operatorname{Exp}(1)$. Under the criterion of variable selection, distribution regression outperforms mean and quantile regression.

### 4.2 Real Data Analysis

In the section, we first illustrate the usefulness of the proposed method in the criterion of prediction error via three real data sets: airmay, aircraft and eyedata. The data set airmay is used to study the relationship between ozone concentration and three explanatory variables: radiation level, wind speed, and temperature. It was collected from May 1 to September 30 in 1973. The aircraft is used to analyse the relation between cost and four explanatory variables: aspect ratio, lift-to-drag ratio, weight and thrust, and deals with 23 single-engine aircraft built over the years 1947-1979. The eyedata is used to find the genes whose expressions are associated with the expression level of TRIM32 gene (Scheetz et al. (2006)). The sample size is 120 and the number of predictors is 200 ( 120 rats with 200 gene probes).

The missing values of airmay are removed. The airmay and aircraft can be obtained in R package "robustbase". The third data can be found in R package "flare". Since the sample size is less than the number of the predictors in eyedata, we use adaptive LASSO to select variables. In order to eliminate the effect of scale, we have scaled and centered each of the explanatory variables of airmay and aircraft such that they have mean 0 and variance 1 . We compare the performance of our distribution regression with the mean regression and quantile regression via the following criteria.
(1) We divide the data into the training set and test set. Test set consists of the last $\lceil n / 9\rceil$ numbers of the data set, where $\lceil a\rceil$ denotes the smallest integer not less than $a$.
(2) We use the prediction error, $P E=\lceil n / 9\rceil^{-1} \sum_{i=n-\lceil n / 9\rceil+1}^{n}\left(Y_{i}-\widehat{Y}_{i}\right)^{2}$ to evaluate their performance, where $\widehat{Y}_{i}$ is the estimated $Y_{i}$.

Table 5 summarizes the results. The distribution regression performs better than the other two because the PE of distribution regression is smaller than the corresponding mean and quantile regression ones. In fact, the empirical densities of these data sets are either asymmetrical or multimodal. This observation is consistent with our simulation results. Furthermore, for the eyedata, the distribution regression, mean regression and quantile (median) regression select different variables, which are $\left(x_{153}, x_{180}\right),\left(x_{87}, x_{153}\right)$ and $\left(x_{153}, x_{181}\right)$ respectively.

We then study Coleman data in diagnosis. This data contains information on 20 schools from the Mid-Atlantic and New England States, drawn from a population studied by Coleman et al.【 (1966). Following Rousseeuw and Leroy (1987), the response and explanatory variables are as follows:
$Y:$ verbal mean test score (all sixth graders).
$x_{1}$ : staff salaries per pupil.
$x_{2}$ : percent of white-collar fathers.
$x_{3}$ : socioeconomic status composite deviation: means for family size, family intactness, father's education, mother's education, and home items.
$x_{4}$ : mean teacher's verbal test score.
$x_{5}$ : mean mother's educational level, one unit is equal to two school years.

Table 6 shows the estimated coefficients of $x_{1}, \ldots, x_{4}$ are not much different for all three methods. However, the DR estimate of $x_{5}$ is positive, while the others are negative. We believe the former estimate is more reasonable because the higher the mother's educational level is, the higher test score should be in a general way. This indicates that DR makes more sense in this particular data. Moreover, Figure 1 shows that the response $Y$ and three regression residuals seems multimodal distributed.

## Appendix section

To prove Theorem 1, we need three lemmas as a first step.

For any $\epsilon>0$, let $\left\{\beta_{1}, \cdots, \beta_{M}\right\}$ be an $\epsilon / \sqrt{p}$-net of $B\left(\kappa_{0}\right)$, where $M=$ $\left(\left[2 \kappa_{0} \sqrt{p} / \epsilon+1\right]\right)^{p}$. Since $n^{-1} l_{n h}$ and $E_{\beta_{0}} \log f(Y-$ $x^{\top} \beta$ ) are analytic functions of each coordinate of $\beta$ in $C\left(\kappa_{0}\right)$, it follows from convergence of analytic functions and Theorem 1 that

$$
A_{j k n} \rightarrow a_{j k}=\frac{\partial^{2}}{\partial b_{j} \partial b_{k}} E_{\beta_{0}} \log f\left(Y-x^{\top} \beta\right)=-\boldsymbol{I}_{j k}\left(\beta_{0}\right)
$$

in probability as $n \rightarrow \infty$. It remains to show the asymptotic normality of $\left(T_{1 n}, \ldots, T_{p n}\right)$. We will only consider $T_{1 n}$. The general case can be handled by linear combinations of $T_{1 n}, \ldots, T_{p n}$.

Jensen's inequality shows that $E_{\beta_{0}} \log f\left(Y-x^{\top} \beta_{0}\right)<0$. By Lemma 3, there exists $\delta>0$ such that

$$
\inf _{\beta \in C\left(\kappa_{0}\right)}\left|n^{-1} \sum_{i=1}^{n} \log f\left(Y_{i}-x_{i}^{\top} \beta\right)\right| \geq \delta \text { a.s. }
$$

as $n \rightarrow \infty$. Hence by Lemma 3 again, we have

$$
\sum_{i=1}^{n} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta\right)=\sum_{i=1}^{n} \log f\left(Y_{i}-x_{i}^{\top} \beta\right)\left(1+u_{n}(\beta)+\mathrm{i} v_{n}(\beta)\right)
$$

when $\beta \in C\left(\kappa_{0}\right), \mathrm{i}^{2}=-1$, and

$$
\begin{equation*}
u_{n}(\beta)+\mathrm{i} v_{n}(\beta)=o_{p}(1) \tag{A.11}
\end{equation*}
$$

is uniform in $\beta \in C\left(\kappa_{0}\right)$ as $n \rightarrow \infty$. Here both $u_{n}(\beta)$ and $v_{n}(\beta)$ are real functions of $\beta$. Note that Cauchy's residue theorem gives

$$
T_{1 n}=\frac{1}{\sqrt{n}} \frac{1}{2 \pi \mathrm{i}} \oint_{\mathcal{C}_{1}} \frac{\sum_{i=1}^{n} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta_{1}\right)}{\left(b_{1}-b_{10}\right)^{2}} d b_{1}
$$

where $\beta_{1}=\left(b_{1}, b_{20}, \cdots, b_{p 0}\right)$, and $\mathcal{C}_{1}$ is the counterclockwise oriented contour $\left\{b_{1} \in \mathbf{C}:\left\|b_{1}-b_{10}\right\|=\right.$ $r\}$ with $r<\kappa_{0}$. (Here $r$ may depend on the sample $\left\{\left(x_{i}, Y_{i}\right): i=1,2, \cdots, n\right\}$. However we only require that $r$ be positive so that we can apply Cauchy's residue theorem.) So

$$
\begin{equation*}
T_{1 n}-S_{1 n}=\frac{1}{\sqrt{n}} \frac{1}{2 \pi \mathrm{i}} \oint_{\mathcal{C}_{1}} \frac{\sum_{i=1}^{n} \log f\left(Y_{i}-x_{i}^{\top} \beta_{1}\right)\left(u_{n}\left(b_{1}\right)+\mathrm{i} v_{n}\left(b_{1}\right)\right)}{\left(b_{1}-b_{10}\right)^{2}} d b_{1} \tag{A.12}
\end{equation*}
$$

where, $u_{n}\left(b_{1}\right)=u_{n}\left(\beta_{1}\right), v_{n}\left(b_{1}\right)=v_{n}\left(\beta_{1}\right)$, and

$$
S_{1 n}=\frac{1}{\sqrt{n}} \frac{1}{2 \pi \mathrm{i}} \oint_{\mathcal{C}_{1}} \frac{\sum_{i=1}^{n} \log f\left(Y_{i}-x_{i}^{\top} \beta_{1}\right)}{\left(b_{1}-b_{10}\right)^{2}} d b_{1}
$$

Denote the real part and imaginary part of $n^{-1 / 2} \sum_{i=1}^{n} \log f\left(Y_{i}-x_{i}^{\top} \beta_{1}\right)$ by $R_{n}\left(b_{1}\right)$ and $I_{n}\left(b_{1}\right)$ respectively. Since the left-hand side of A.12) is real, we consider the real part of the right-hand side of A.12, which is equal to,

$$
\begin{equation*}
\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{\left(R_{n} \cos \theta+I_{n} \sin \theta\right) u_{n}+\left(R_{n} \sin \theta-I_{n} \cos \theta\right) v_{n}}{r} d \theta \tag{A.13}
\end{equation*}
$$

where $R_{n}, I_{n}, u_{n}, v_{n}$ are actually $R_{n}\left(b_{10}+r e^{\mathrm{i} \theta}\right), I_{n}\left(b_{10}+r e^{\mathrm{i} \theta}\right), u_{n}\left(b_{10}+r e^{\mathrm{i} \theta}\right), v_{n}\left(b_{10}+r e^{\mathrm{i} \theta \theta}\right)$ respectively. By the mean value theorem, we have

$$
\begin{equation*}
\text { A.13) }=\frac{\left(R_{n 0} \cos \theta_{0}+I_{n 0} \sin \theta_{0}\right) u_{n 0}+\left(R_{n 0} \sin \theta_{0}-I_{n 0} \cos \theta_{0}\right) v_{n 0}}{r} \tag{A.14}
\end{equation*}
$$

where $\theta_{0} \in[0,2 \pi), R_{n 0}=R_{n}\left(b_{10}+r e^{\mathrm{i} \theta_{0}}\right), I_{n 0}=I_{n}\left(b_{10}+r e^{\mathrm{i} \theta_{0}}\right), u_{n 0}=u_{n}\left(b_{10}+r e^{\mathrm{i} \theta_{0}}\right), v_{n 0}=$ $v_{n}\left(b_{10}+r e^{\mathrm{i} \theta_{0}}\right)$. On the other hand,

$$
\begin{equation*}
S_{1 n}=-n^{-1 / 2} \sum_{i=1}^{n} \frac{\partial}{\partial b_{1}} \log f\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)=-\frac{\partial}{\partial b_{1}}\left(R_{n}\left(b_{10}\right)+\mathrm{i} I_{n}\left(b_{10}\right)\right) \tag{A.15}
\end{equation*}
$$

By A.13), we also have

$$
\mid\left(\widehat{\mathrm{A} .12}| | \leq 2\left(\left|R_{n 0} / r\right|+\left|I_{n 0} / r\right|\right)\left(\left|u_{n 0}\right|+\left|v_{n 0}\right|\right) .\right.
$$

Letting $r \rightarrow 0$ in the above inequality and noticing A.11, A.15) and the central limit theorem of $S_{1 n}$ (Condition 7), we have

$$
\mathrm{A} .12=o_{p}(1)
$$

as $n \rightarrow \infty$. Again using the central limit theorem of $S_{1 n}$, we can complete the proof.
Proof of Theorem 3. Let $\beta=\beta_{0}+\frac{\alpha}{\sqrt{n}}$, where $\alpha=\left(\alpha_{1}^{\top}, \alpha_{2}^{\top}\right)^{\top}, \alpha_{1}=\left(a_{1}, \ldots, a_{s}\right)^{\top}$ and $\alpha_{2}=$ $\left(a_{s+1}, \ldots, a_{p}\right)^{\top}$. Define $Z_{n}(\alpha)$ by

$$
\begin{equation*}
Z_{n}(\alpha)=Q\left(\beta_{0}+\frac{\alpha}{\sqrt{n}}\right)-Q\left(\beta_{0}\right) . \tag{A.16}
\end{equation*}
$$

Note that

$$
\begin{equation*}
Z_{n}(\alpha)=-\ell_{n h}\left(\beta_{0}+\frac{\alpha}{\sqrt{n}}\right)+\ell_{n h}\left(\beta_{0}\right)+n \lambda_{n} \sum_{j=1}^{p} \hat{w}_{j}\left[\left|b_{j 0}+\frac{a_{j}}{\sqrt{n}}\right|-\left|b_{j 0}\right|\right] . \tag{A.17}
\end{equation*}
$$

Using the Taylor expansion of $\ell_{n h}\left(\beta_{0}+\alpha / \sqrt{n}\right)$ at $\beta_{0}$, we have

$$
\begin{aligned}
& -\ell_{n h}\left(\beta_{0}+\frac{\alpha}{\sqrt{n}}\right)+\ell_{n h}\left(\beta_{0}\right) \\
& =-\frac{1}{\sqrt{n}} \alpha^{\top} \nabla \ell_{n h}\left(\beta_{0}\right)-\frac{1}{2 n} \alpha^{\top} \nabla^{2} \ell_{n h}\left(\beta^{*}\right) \alpha
\end{aligned}
$$

where $\beta^{*}$ lies between $\beta_{0}$ and $\beta_{0}+\alpha / \sqrt{n}$.

## 1. Fixed $p$.

From the proof of Theorem 2, we have

$$
\begin{aligned}
& -\frac{1}{\sqrt{n}} \nabla \ell_{n h}\left(\beta_{0}\right) \xrightarrow{d} N\left(0, \boldsymbol{I}\left(\beta_{0}\right)\right), \\
& \frac{1}{n} \nabla^{2} \ell_{n h}\left(\beta^{*}\right) \xrightarrow{p}-\boldsymbol{I}\left(\beta_{0}\right)
\end{aligned}
$$

as $n \rightarrow \infty$. Hence

$$
-\ell_{n h}\left(\beta_{0}+\frac{\alpha}{\sqrt{n}}\right)+\ell_{n h}\left(\beta_{0}\right) \xrightarrow{d} \alpha^{\top} W+\frac{1}{2} \alpha^{\top} \boldsymbol{I}\left(\beta_{0}\right) \alpha,
$$

where $W$ follows $N\left(0, \boldsymbol{I}\left(\beta_{0}\right)\right)$.
Now, we consider the limiting behavior of the third term in A.17). If $b_{j 0} \neq 0(j=1, \ldots, s)$, then $\hat{w}_{j} \rightarrow\left|b_{j 0}\right|^{-\gamma}$, and $\sqrt{n}\left(\left|b_{j 0}+a_{j} / \sqrt{n}\right|-\left|b_{j 0}\right|\right) \rightarrow a_{j} \operatorname{sign}\left(b_{j 0}\right)$. So we have

$$
n \lambda_{n} \hat{w}_{j}\left(\left|b_{j 0}+a_{j} / \sqrt{n}\right|-\left|b_{j 0}\right|\right)=O\left(\lambda_{n} n^{1 / 2}\right) .
$$

If $b_{j 0}=0$ and $a_{j} \neq 0$ for $j=s+1, \ldots, p$,

$$
n \lambda_{n} \hat{w}_{j}\left(\left|b_{j 0}+\alpha_{j} / \sqrt{n}\right|-\left|b_{j 0}\right|\right)=\lambda_{n} n^{1 / 2}\left(\left|\hat{b}_{j}\right|\right)^{-\gamma}\left|a_{j}\right| \rightarrow \infty .
$$

Note that $\hat{b}_{j}=o_{p}(1)$. Hence we get

$$
Z_{n}(\alpha) \xrightarrow{d} Z(\alpha)=\left\{\begin{array}{cl}
\alpha_{1}^{\top} W_{1}+\frac{1}{2} \alpha_{1}^{\top} \boldsymbol{I}_{11}\left(\beta_{0}\right) \alpha_{1} & \text { if } a_{j}=0 \text { for } j=s+1, \ldots, p, \\
\infty & \text { otherwise },
\end{array}\right.
$$

where $W_{1}$ follows $N\left(0, \boldsymbol{I}_{11}\left(\beta_{0}\right)\right)$. Since $Z_{n}(\alpha)$ is convex, and has a unique minimizer $\sqrt{n}\left(\widehat{\beta}-\beta_{0}\right)$, it follows from the epi-convergence results of Geyer Geyer (1994) that

$$
\hat{\alpha}_{10} \xrightarrow{d} \boldsymbol{I}_{11}\left(\beta_{0}\right)^{-1} W_{1} .
$$

Hence we proved the asymptotic normality part.

## 2. Divergent $p$.

Note that

$$
\frac{1}{\sqrt{n}} \alpha^{\top} \nabla \ell_{n h}\left(\beta_{0}\right)=\frac{1}{\sqrt{n}} \sum_{i=1}^{n} \sum_{j=1}^{p} a_{j} \frac{\partial}{\partial b_{j}} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)
$$

and

$$
\operatorname{Var} \sum_{j=1}^{p} a_{j} \frac{\partial}{\partial b_{j}} \log f\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)=\alpha^{\top} \boldsymbol{I}\left(\beta_{0}\right) \alpha<\infty
$$

In the proof of Theorem 2, after replacing $\frac{\partial}{\partial b_{1}} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)$ by

$$
\sum_{j=1}^{p} a_{j} \frac{\partial}{\partial b_{j}} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)
$$

and following the same proof, we can obtain that

$$
\begin{aligned}
\frac{1}{\sqrt{n}} \alpha^{\top} \nabla \ell_{n h}\left(\beta_{0}\right) & =\frac{1}{\sqrt{n}} \sum_{i=1}^{n} \sum_{j=1}^{p} a_{j} \frac{\partial}{\partial b_{j}} \log f\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)+\sqrt{p} o_{p}(1) \\
& =O_{p}(1)+\sqrt{p} o_{p}(1)
\end{aligned}
$$

as $n \rightarrow \infty$. Lemmas 1, 2 and Cauchy's residue theorem imply that

$$
n^{-1} \sum_{i=1}^{n} \frac{\partial^{2}}{\partial b_{j} \partial b_{k}} \log f_{n h}\left(Y_{i}-x_{i}^{\top} \beta^{*}\right) \rightarrow E_{\beta_{0}}\left[\frac{\partial^{2}}{\partial b_{j} \partial b_{k}} \log f\left(Y_{i}-x_{i}^{\top} \beta_{0}\right)\right]
$$

in probability as $n \rightarrow \infty$ uniformly in $j, k$. Hence

$$
\frac{1}{2 n} \alpha^{\top} \nabla^{2} \ell_{n h}\left(\beta^{*}\right) \alpha=O(1)+p O_{p}(1)
$$

Now following the proof of fixed $p$ case and noting that $p=O\left(\lambda_{n} n^{1 / 2}\right)$, we can complete the asymptotic part for divergent $p$.

Next we show the consistency. Let $\eta_{n}=C n^{-1 / 2}$, where $C$ is a constant. It is sufficient to show that with probability tending to 1 as $n \rightarrow \infty$, for any $\beta=\left(\beta_{1}^{\top}, b_{s+1}, \cdots, b_{p}\right)^{\top}$ satisfying $\beta_{1}-\beta_{10}=O_{p}\left(n^{-1 / 2}\right)$, we have , for $j=s+1, \ldots, p$,

$$
\begin{align*}
& \frac{\partial Q(\beta)}{\partial b_{j}}<0 \text { for } 0<b_{j}<\eta_{n}  \tag{A.18}\\
& \frac{\partial Q(\beta)}{\partial b_{j}}>0 \text { for }-\eta_{n}<b_{j}<0 . \tag{A.19}
\end{align*}
$$

To show A.18), by Taylor expansion,

$$
\begin{aligned}
\frac{\partial Q(\beta)}{\partial b_{j}} & =-\frac{\partial \ell_{n h}(\beta)}{\partial b_{j}}+n \lambda_{n} \hat{w}_{j} \operatorname{sign}\left(b_{j}\right) \\
& =-\frac{\partial \ell_{n h}\left(\beta_{0}\right)}{\partial b_{j}}-\sum_{l=1}^{p} \frac{\partial^{2} \ell_{n h}\left(\beta^{*}\right)}{\partial b_{j} \partial b_{l}}\left(b_{l}-b_{l 0}\right)+n \lambda_{n} \hat{w}_{j} \operatorname{sign}\left(b_{j}\right)
\end{aligned}
$$

where $\beta^{*}$ lies between $\beta$ and $\beta_{0}$.
From the proof of Theorem 2, we have

$$
\frac{1}{n} \frac{\ell_{n h}\left(\beta_{0}\right)}{\partial b_{j}}=O_{p}\left(n^{-1 / 2}\right)
$$

and

$$
\frac{1}{n} \frac{\partial^{2} \ell_{n h}\left(\beta^{*}\right)}{\partial b_{j} \partial b_{l}} \xrightarrow{p}-\boldsymbol{I}_{j l}\left(\beta_{0}\right)
$$

as $n \rightarrow \infty$.
By the assumption that $\beta_{1}$ satisfies $\beta_{1}-\beta_{10}=O_{p}\left(n^{-1 / 2}\right)$, we have uniformly in $j$

$$
\frac{\partial Q(\beta)}{\partial b_{j}}=n\left[\lambda_{n} \hat{w}_{j} \operatorname{sign}\left(b_{j}\right)+p O_{p}\left(n^{-1 / 2}\right)\right]
$$

with $\hat{w}_{j} \xrightarrow{p}\left|b_{j 0}\right|^{-\gamma}$. So the sign of the derivative is completely determined by that of $b_{j}$, noting $p=O\left(\lambda_{n} n^{1 / 2}\right)$ Hence, A.18 and A.19 follow. This completes the proof.
